Atishi resigns as Delhi Chief Minister

Delhi Chief Minister Atishi on Sunday (February 9, 2025) met Lieutenant Governor V.K. Saxena and submitted her resignation to him at the Delhi Secretariat.L-G Saxena received the resignation and asked her to continue in her position till the formation of the new government. Even though Ms. Atishi retained her seat in Kalkaji, defeating Bharatiya Janata Party (BJP) candidate Ramesh Bidhuri by 3,521 votes, the Aam Aadmi Party (AAP) lost the Delhi Assembly election getting just 22 seats against BJP's mighty 48. The result of the Delhi Assembly election that was held on Wednesday (February 5, 2025) was declared on Saturday (February 8, 2025) by the Election Commission of India (ECI). In a gazette notification dated February 7, Delhi L-G Saxena dissolved the Seventh Legislative Assembly of the National Capital. The order was made public today. The notification said, "In exercise of the power conferred upon me by sub-section (2)(b) of section 6 of the Government of National Capital Territory of Delhi Act, 1991, I, Vinai Kumar Saxena, Lieutenant Governor of Delhi, hereby dissolve the Seventh Legislative Assembly of the National Capital Territory of Delhi with effect from 08th February, 2025.



Girl student ends life after mother denies mobile phone in Asifabad

Kumram Bheem Asifabad: A Class X girl student died, allegedly by suicide, after her mother refused to give her a mobile phone for preparing a project in Koutala mandal centre on Saturday night.

Spurthi was reportedly depressed when her mother denied her a mobile phone for downloading study material online. She ended her life when none was present.

We will make Delhi a capital that we can all be proud of."Verma, a two-time Member of Parliament from West Delhi, comes from a strong political lineage. His father, Sahib Singh Verma, served as Delhi's Chief Minister, and his uncle, Azad Singh, has held key municipal positions. Sahib Singh Verma was also one of the only three BJP Chief Ministers Delhi has had.His victory over Kejriwal marks a major shift in Delhi politics, further strengthening the BJP's presence in the national Capital.

Twelve Maoists, two police personnel killed in exchange of fire in Chhattisgarh's Bijapur

Kothagudem: In a massive operation against naxals, as many as 12 Maoists and two security personnel were killed in an exchange of fire in Bijapur district of Chhattisgarh on Sunday.Two security personnel were also injured in the exchange of fire that took place in Indravati National Park in the district. Bodies of 12 uniformed Maoists have been danger and they were being treated in a hospital. Additional forces have been sent for reinforcement. Search operations are continuing in the area. Heavy arms and ammunition were recovered from the spot.Bastar range Inspector General of Police, Sundarraj P told the media that based on information about the presence of Maoists in the area, search operations were launched. Intermittent firing has been going on since morning. Bijapur District Reserve Guard (DRG), Special Task Force (STF) and Bastar Fighters have been taking part in the operation.Over 35 Maoists have been killed in encounters in the past couple of months.

It might be noted that eight Maoists were gunned down by the security forces in an anti-Naxal operation in Chhattisgarh's Bijapur district on February 1 while a naxal was killed in an encounter with security forces in Chhattisgarh's Kanker district on Feb 3.As many as 12 Maoists were killed in a massive encounter in Bijapur district on January 16 while top leaders escaped. 16 Maoists were killed in a joint operation in Gariaband district of

Harish Rao blames Revanth Reddy for real estate crisis in Telangana

Hyderabad: Former Minister and senior BRS MLA T Harish Rao blamed Chief Minister A Revanth Reddy for the deteriorating real estate sector in Telangana, citing a series of suicides linked to financial distress. He pointed to the recent deaths of Kompally real estate businessman Venugopal Reddy and Adibhatla-based Narasimha Goud, stating that the crisis was spreading rapidly, leaving families devastated.

Reacting to the realtors' suicides, Harish Rao charged the Congress government with stalling Hyderabad's growth, calling its poor governance a major obstacle to the city's real estate progress. He criticised the administration for ignoring warnings from multiple survey agencies that have indicated a downturn in the sector over the past year and a half.Blaming policy missteps on projects such as HYDRAA demolitions, Musi Riverfront Development, Pharma City cancellation, and Hyderabad Metro line changes, he stated that these decisions have directly impacted investors and businesses. He suggested that Revanth Reddy, who has a background in real estate, to acknowledge the crisis and



take corrective action before Telangana's decade-long progress is reversed.Harish Rao also demanded immediate financial support for the bereaved family of Narasimha Goud, emphasising the urgent need for government intervention to prevent further tragedies.

BRS delegation meets Chief Secretary, pushes for 42 per cent quota for BCs

Wrong to send illegal immigrants in shackles: Union Minister Athawale

Union Minister Ramdas Athawale has said it was wrong to deport illegal immigrants from America to India in shackles and the U.S. government should have avoided such a treatment. The Minister of State for Social Justice and Empowerment made the comments on Saturday (February 8, 2025) during a press conference, where he also shared details of the Union Budget. On the treatment of undocumented immigrants who were deported from the U.S. to India earlier this week, Mr. Athawale said it was wrong to send them in shackles. A U.S. military aircraft carrying 104 illegal Indian immigrants landed in Amritsar on February 5.

It was the first such batch of Indians deported by the Donald Trump administration as part of a crackdown against illegal immigrants. Some of the deportees claimed their hands and legs were cuffed throughout the journey and they were unshackled only after landing in Amritsar. "The U.S. government should have avoided such treatment," Mr. Athawale, who heads the Republican Party Of India (A), said adding the issue would be discussed during the PM's visit to the U.S. next week. India on Friday (February 8, 2025) said it has registered concerns with the U.S. over the deportation of illegal immigrants in shackles and conveyed that this kind of treatment could have been avoided.

HYDERABAD: A delegation of Bharat Rashtra Samithi (BRS) MLAs, MLCs and former Ministers submitted a representation to Chief Secretary A Santhi Kumari demanding implementation of 42 per cent reservation to BCs in local body elections and wanted the elections to be conducted only after fulfilling the promise made to the community. It has been 14 months since the Congress government came to power but the Kamareddy Declaration was yet to be implemented. The Planning Department conducted the Socio, Economic, Educational, Employment, Political and Caste Survey in an unscientific manner, depriving the rightful share of the BCs, they said in the representation. Leader of Oppositon in the Legislative Council Madhusudhana Chary slammed that the Congress government was not committed towards the welfare and development of the BCs. If it was committed, a re-survey should be conducted and implement the reservations to the BCs as was being done in Tamil Nadu, he said at the Secretariat media point on Saturday.

Former Minister V Srinivas Goud said after having failed in fulfilling the guarantees assured to the people, the Congress government was ruining all sectors in the State. Farmers, builders and weavers were committing suicides, and the poor were struggling to make both the ends meet, he said.

Glaring disconnect

THE National Education Policy (NEP) lays stress on interactive teaching and learning instead of rote nemorisation so that the knowledge acquired in the classoom can be applied to real-life situations. The focus is supposed to be on preparing the student to face the world with confidence. How much progress has been made on his front in recent years? A study co-authored by Nobel aureates Abhijit Banerjee and Esther Duflo shows that being good at mathematics on the go, as witnessed in ndian kids working in the marketplace, does not often ranslate into classroom arithmetic, and vice versa. Simply put, there is a big gap between intuitive and formal styles of learning that needs to be bridged by fine-tuning he curriculum.

Mastering mathematics is a challenge for schoolhildren from low-income backgrounds worldwide, and ndia is no exception. Poverty and deprivation force milons of families across the country to make their kids – nostly those who have never been to school — do odd obs, such as working as street vendors. According to he study, such children can do complex calculations in econds, and that too unaided, but find it hard to deal with impler abstract maths taught in schools. Their choolgoing peers excel at academic maths but fail at asic real-world calculations. The Annual Status of Eduation Report (ASER) 2024 shows that arithmetic levels f children in the age group of 6-14 years have improved n government as well as private schools. This is a good ign, but it is no less important to encourage kids to go eyond textbooks and hone their skills in practical calcuations. Such an approach can go a long way in ensuring uccessful implementation of the NEP. It can also help in mproving the students' employability and competency by making them street-smart rather than mere bookvorms or exam warriors

1948 | The first full budget of free India

"From August 15, 1947, the chains of our bondage have been broken and we are free to translate our dreams into reality. The plans are there, but we find that our freedom was born in an era so fluid and fastchanging that any predetermined step otheithan the next became obsolete before it could be taken. We feel like the pilgrim who drags his weary limbs finally to the mountain top, only to find higher peaks stretching before his eyes."

So spoke R.K Shanmukham Chetty (alternatively spelled Chettiar), the first Finance Minister of free India, as he presented the newly independent nation's first full budget to the Indian Parliament on February 28, 1948, channelling the vision of the Nehru-led Congress government. This budget was also the first after the partition that seared the land, and the assassination of Mahatma Gandhi. It was cautious, yet struck a hopeful note for the future of newlyindependent India.

With revenue at Rs. 230.52 crore, on the basis of existing taxation, and the expenditure at Rs. 257.37 crore, Mr, Chetty estimated a deficit of Rs. 26.85 crore for the year 1948-49. The aim of the budget proposed by him then, was to bring down the deficit to one crore rupees. The Budget provided for a defence expenditure of Rs. 121 crore, and set aside Rs. 165 crore for development schemes. This included Rs. 30 crore in grants and Rs. 34 crore in loans to the Provinces, while a provision of Rs. 20 crore was made for food subsidies."Our financial position...is good and if stan proved a reliable debtor, it might eve Mr Chetty announced, as he introduced the Budget in the Indian Parliament. In 1948, India had just attained freedom and was negotiating its place in a world newly scarred by the second World War. The country was reeling from the effects of Partition and ironing out financial arrangements with its new neighbour Pakistan. The interim budget had been announced in November 1947, soon after the nation "had been shaken to its very foundations by the great Punjab tragedy," as Mr. Chetty described it. "Thousands of our people had been brutally butchered, and millions of innocent men, women and children driven out of their ancestral homes and forced to make a dusty, deadly trek in search of a new home. Our crying concern then was to dress the wounds of uprooted humanity, and to mobilise all our financial resources to set aright an unhinged economy." Right as the time approached to announce the first full budget however, suddenly calamity struck again in the form of the assassination of Mahatma Gandhi on January 30, 1948. The world too was limping back slowly after a devastating war. "The third year after war finds the world still in the meshes of those economic maladjustments which are the inevitable aftermath of total war-the nemesis that inexorably pursues the victor and the vanquished alike," Mr. Chetty noted.

Fadnavis-Shinde 'discord' has hit Maharashtra's progress, claims Sanjay Raut

Shiv Sena (UBT) MP Sanjay Raut on Sunday (February 2, 2025) claimed the "strained relation" between Maharashtra Chief Minister Devendra Fadnavis and Deputy CM Eknath Shinde was hindering the State's progress. In his weekly column Rokhthok in the Shiv Sena (UBT) mouthpiece 'Saamna', Mr. Raut further claimed Mr. Shinde was yet to come to terms with the fact that he was not reinstated as Chief Minister after the November 2024 Assembly polls and was desperately trying to regain the position, which Mr. Fadnavis fully understands.

In the last year's Assembly elections, the Mahayuti, comprising the BJP, Shinde's Shiv Sena and the NCP led by Ajit Pawar, won 230 of the 288 seats in the state."Our Chief Minister Devendra Fadnavis and the BJP-backed Deputy Chief Minister Eknath Shinde have almost no real communication anymore, which has turned into a source of entertainment for the public," the Rajya Sabha member charged.Mr. Raut claimed this ongoing "discord" has affected the Maharashtra government's functioning.

"Despite having a majority, the administration remains paralysed. Those who rise through treachery often fall by it. The attacks on Shinde have begun, and Maharashtra has been left in a state of uncertainty and disorder," he said.Mr. Raut also claimed that Mr. Shinde's control over his political turf Thane was being systematically undermined by the BJP.The appointment of BJP minister Ganesh Naik as the guardian minister of neighbouring Palghar district is reportedly part of this strategy, he charged."Naik was already a minister in the first Shiv Sena-BJP government when Shinde was just a municipal councillor. He will not take orders from Shinde," Raut wrote in his column.Notably, Naik last week said he wants the saffron party to flourish in Thane, indicating there could be a tussle between the two allies.Naik had also said he would be holding public grievance meetings in Thane too, triggering speculation that the BJP was preparing to challenge the dominance of Shinde's party in the area.According to Mr. Raut, Mr. Shinde's role in the government has diminished significantly. He is often absent from crucial cabinet meetings, and when he does attend, he is noticeably late."On January 30, he arrived two-and-ahalf-hours late for a District Planning Committee meeting at the World Trade Centre," he claimed.Mr. Raut alleged that Shinde feels betrayed by the BJP leadership.

Quoting a senior MLA from the Shiv Sena, Raut claimed Union Home Minister Amit Shah had assured Shinde that the 2024 Assembly elections would be fought under his leadership and that he would continue as CM.Encouraged by the promise, Shinde is believed to have spent enormous amounts of money during the campaign. However, when the time came, Shah allegedly did not keep his word, leading Shinde to feel deceived and politically cornered, Raut claimed quoting the legislator.Mr. Raut said the MLA also told him that Mr. Shinde now suspects his phone calls are being monitored and that central agencies are tracking his movements."An MLA told me that Shinde is convinced that surveillance is being conducted on him and his associates," the Sena (UBT) leader claimed.A senior BJP minister recently dismissed the reports of tensions, stating there were no "major differences" between Mr. Fadnavis and Mr. Shinde. However, Mr. Raut countered that argument, pointing out that similar claims were made before the Shiv Sena split (in June 2022). "What happened after that is something the entire country witnessed," he said.Mr. Raut further claimed that many MLAs in Shinde's faction were now "uneasy", with some contemplating switching over to the BJP under Fadnavis' leadership, while others wanting a return to the Thackeray-led Sena (UBT). But the fear of central agencies has left them hesitant to act, he added."Shinde's leadership is no longer secure," Raut further claimed, alleging that even the BJP was working against him. The RSS has deployed its own people as personal assistants to ministers from both the Shinde and Ajit Pawar (NCP) camps to monitor their activities and curb corruption, he charged. Unlike Shinde, Deputy Chief Minister Ajit Pawar is in a much more stable position, Mr. Raut said." Ajit Pawar understands his limitations and has built a stronger working relationship with Fadnavis," he said.Mr. Pawar joined hands with the BJP to avoid action by the Enforcement Directorate (in some cases), to recover attached assets of Rs 1,000 crore and gain the deputy CM's post as an additional benefit, Mr. Raut claimed.Unlike Mr. Shinde, Mr. Pawar has no aspirations of becoming Chief Minister and is content with a "politically safer" position, he Bihar appears to have got bonanza, why Andhra Pradesh so cruelly ignored, asks Jairam Ramesh

Bihar remained in focus in the presentation of the Union Budget for the fiscal 2025-26 with Finance Minister Nirmala Sitharaman making several announcements for the State, including setting up of a Makhana Board, financial support for western Kosi canal and support for enhancing capacity of IIT Patna. Presenting her record eighth Union Budget in the Lok Sabha, the Finance Minister also announced that the Centre will establish a National Institute of Food Technology, entrepreneurship and management in Bihar and also facilitate greenfield airports there to meet the future needs of the State.Congress general secretary in-charge communications Jairam Ramesh said Bihar appears to have got a bonanza of announcements."It is natural since elections are due there later in the year. BJP's Dhas alleges fraudulent withdrawals

during Munde's tenure as Beed guardian minister

The MLA alleged ?37.70 crore was withdrawn without any work done, while another ?73.36 crore was funnelled via fraudulent invoices between December 2021 and March 2022. He singled out executive engineers from the Zilla Parishad and Public Works Department (PWD), accusing them of colluding in a "modus operandi" to divert funds. Notably, Mr. Dhas questioned the mysterious disappearance of Sanjay Munde, a deputy engineer allegedly promoted unlawfully to oversee transactions.Mr. Dhas linked the financial scandal to public health. "At least 500 people in Beed have slipped into coma since I exposed this," he said. While not elaborating on causation, the claim amplifies pressure on Mr. Munde, already embroiled in a separate political crisis following the murder of sarpanch Santosh Deshmukh. Mr. Munde's close aide, Walmik Karad, was recently arrested in an extortion case tied to the killing.Mr. Munde, a Nationalist Congress Party-Ajit Pawar (NCP-AP) leader, has denied all allegations, terming them "baseless". The Opposition, however, has demanded his ouster from the Cabinet. Mr. Dhas said he would pursue the matter, stating he would formally alert Chief Minister Devendra Fadnavis and PWD officials, adding, "The issues of Deshmukh's murder and Sanjay Munde's role won't be ignored."Nationalist Congress Party-Sharadchandra Pawar (NCP-SP) MP Supriva Sule on Thursday criticised the Maharashtra government for its handling of the investigation into the murder of Massajog sarpanch Santosh Deshmukh, questioning why one of the prime accused remained at large 51 days after the crime. Ms. Sule said she planned to raise the issue in Parliament and would seek a meeting with Union Home Minister Amit Shah to apprise him of the deteriorating law and order situation in the State."We, as [part of] MVA (Maha Vikas Aghadi alliance), will be highlighting all these issues...extortion, corruption...in Parliament during the Budget session. On a regional level, it was not merely India dealing with the after-effects of a prolonged colonial rule. As the Finance Minister noted, there was "serious economic dislocation in many Asian countries owing to violent internal struggles or fight for freedom from foreign domination." Rising prices, inflation and reduced production, sometimes even lower than pre-war production, posed a global quandary, while there was also increased food insecurity. The standards of living of many across the world and India were quite low in this post-war period.

Before the war, India's balance of trade was in her favour, with a surplus of export over imports. This became even more favourable during the war years due to restrictions on imports due to war-time conditions and "large payments which accrued to her on account of supplies and services to the allied nations and the Defence Expenditure Plan."Circumstances changed post the war though, and India was left with a substantial adverse balance in external payments. This was both to the renewed buying of necessities and material in the post war period, as well as increased foodgrain procurement. In 1946-47, the amount spent on importing food grains was Rs. 89 crore, along with a further Rs. 15 crore for the import of supplementary food articles. The estimates for 1947-48 had been pegged at Rs. 110 crore.

A final settlement was reached between Pakistan and India following the Partition, with the two nations dividing outstanding debt between them. Pakistan was to commence its first repayment only in 1952. I'm excited for Blake to crack open her creative piggy bank with someone as dynamic as you. This is conna be INCREDIBLE. ... I happen to adore you, Justin."Lively's team has pushed back against Baldoni's online strategy, calling it an attempt to sway public opinion. They have requested a gag order to keep the case within the legal system, arguing that the leaked information could influence a future jury. The voter can download the form and fill it to get their names added again with submitting correct details and declaration. Those who have not yet

enrolled can apply for enrolment by filing Form-6 along with supporting documents In case voters want to make changes or do some modification in their voter list such as name change, shifting of address, correction entries in existing electoral roll, issue of replacement of EPIC without correction, they will have to file Form-8 with supportive documents. The forms are available on the national voters portal Officials said that voters cannot have a name in the electoral roll in more than one constituency or in any constituency more than once. It is a punishable offence u/s 17 & 18 of the Representation of People Act, 1950. Stolen PAN card used on gaming site: Karnataka HC stays police probe against online gaming firm

The Karnataka High Court has stayed an investigation by the Bengaluru police against an online gaming site over the use of a stolen PAN identity card for gaming.The court passed the order on November 26 on the grounds that it was the gaming firm, Winzo Games, that alerted the victim about his PAN identity featuring among hundreds of stolen PAN IDs posted on the internet.

The Bengaluru Central CEN police station had registered a case of identity theft and cheating under the Information Technology Act and the Indian Penal Code against Winzo Games in July based on the complaint of a Bengaluru resident. The 38-year-old man filed the police complaint against Winzo Games, Real 11 Fantasy Sports, and Scribd.com on July 4, stating that his PAN card had been leaked on the internet as part of a document with 500 PAN IDs on scribd.com and that the card details were used by unidentified people for gaming on Winzo and Real 11 Fantasy Sports. Winzo Games approached the Karnataka HC in October this year seeking the quashing of the criminal investigation launched against the firm for the alleged usage of the stolen PAN ID for gaming on the site by unidentified persons. The HC stayed the probe against the online

Farm leaders say no dialogue with Punjab govt till Dallewal 'released'

Farmers protesting at the Khanauri border point Wednesday said they will not engage in any dialogue with the Punjab government till Samyukta Kisan Korcha (nonpolitical) leader Jagjit Singh Dallewal was released and brought back to the protest site. A Punjab Police team in the wee hours of Tuesday picked Dallewal (70) from a temporary hut at Khanauri and took him to Dayanand Medical College and Hospital (DMCH) in Ludhiana for a check-up, hours before he was to begin a fast unto death in support of farmers' various demands, including a legal guarantee for MSP. Since then Dallewal has remained admitted to the DMCH under heavy security, with his son claiming that police were not allowing anyone to meet or talk to the farmer leader.

Deputy Inspector General (Patiala Range) Mandeep Singh Sidhu and Senior Superintendent of Police Dr Nanak Singh Wednesday met a group of farmer leaders at the Khanauri border point. Sidhu said, "It was like an ice-breaking exercise. We listened to their (farmers') concerns and will convey their demands to the right quarters". The DIG didn't say speak about Dallewal even as he had Tuesday said that the administration was concerned about the age and health of the farmer leader, who is also a prostrate cancer patient, in the wake of his fast-unto-death call. Addressing the media after the meeting, farmer leader Kaka Singh Kotda asked the AAP government to clarify its stand on the forcible removal of Dallewal from the protest site. "We have asked them (police officials) to release Pradhanji (Dallewal). Send him to the protest site. Until he comes here, there will be no further discussion," said Kotda, who is also the general secretary of BKU (Ekta Sidhupur), the union that Dallewal heads.Kotda said the police officials have said that they will discuss their demand with the senior officials.Another farmer leader Gurinder Singh Bhangu said that Dallewal was in the "custody" of the state government and the police were not allowing anyone to meet him. Those denied permission include Faridkot MP Sarabjeet Singh Khalsa who reached DMCH Tuesday evening but wasn't allowed to meet him. "The police team at the spot told me that they have got orders from higher ups not to allow anyone to meet Dallewal," Khalsa told the Indian Express.

Dallewal's son Gurpinder Pal Singh, told the Indian Express that they had sent a person, one Balpreet Singh from Fatehgarh Sahib, Tuesday evening to handover some Ayurvedic medicines that his father takes. "Even he has been detained in the hospital and is with my father as of now. My father talked to me using Balpreet's phone, which the Punjab Police later took in its custody," claimed Gurpinder. Earlier in the day, Kisan Mazdoor Morcha leader Sarwan Singh Pandher said they were not aware of Dallewal's condition. "What is his condition? Nobody is making it clear," he said.Pandher said the state government has not yet given any clarification regarding the forcible removal of Dallewal from Khanauri border point. "The Punjab chief minister should tell people of the state about yesterday's incident (taking away Dallewal) and why it was done," he said, adding that the state government remained unsuccessful in its attempt to "fail" their agitation by taking away Dallewal.Pandher said Sukhjit Singh Hardojhande, president of Punjab Kisan Mazdoor Morcha, is sitting on a fast unto death in place of Dallewal. "Sukhjit's fast unto death enters the second day," he said, a asking people to reach the Khanauri border point in large numbers. Farmer leaders had earlier claimed that Dallewal was observing a hunger strike in the Ludhiana hospital, saying he was not having anything. Pandher raised apprehension that police may force feed Dallewal. Pandher also said they will see whether MPs raise the issues of giving a legal guarantee to MSP on crops, farm debt waiver in the ongoing Parliament session.Farmers are demanding from the Centre to hold talks with them within 10 days to resolve their issues. They said that the union government has not held any talks with them regarding their issues since February 18.

Karnataka HC refuses bail to Sri Guru Raghavendra Cooperative Bank founder in multi-crore fraud case

karnataka KarnatakaIn this bail petition, Ramakrishna's counsel had argued on the basis of Section 479(1) of the Bharatiya Nagrik Suraksha Sanhita (BNSS) that deals with the maximum period for undertrial detention. The Karnataka High Court has refused to grant bail to K Ramakrishna, founder of the Sri Guru Raghavendra Cooperative Bank in Basavanagudi, for the third time in a money laundering case regarding the misappropriation of hundreds of crores of rupees. The order was passed on November 23 by a bench comprising Justice H P Sandesh and was made available recently.Ramakrishna was arrested in 2022 for his alleged role in the fraud of Rs 1,553 crore involving the creation of fictitious documents and persons to disburse loans. It was also alleged that out of this, a sum of Rs 928 crore had been disbursed to 24 people. The latest attempt for bail was rejected on an appeal by the Supreme Court. The Indian Express had previously reported on the scale of the alleged fraud.

In this bail petition, Ramakrishna's counsel had argued on the basis of Section 479(1) of the Bharatiya Nagrik Suraksha Sanhita (BNSS) that deals with the maximum period for undertrial detention. It was argued that despite a detention of two years and seven months, the trial had not yet commenced. The counsel of opposite party argued against the bail based on the scale of the alleged fraud, while also pointing out that there were two cases under Prevention of Money Laundering Act (PMLA) and by the Enforcement Directorate (ED). Hence since there were different



trials, that section of the BNSS would not be applicable, the lawyer said. The bench observed that when the offences are different as well as when more cases are registered against the petitioner, he cannot invoke the provision under Section 479 of BNSS seeking relief on the ground of onethird punishment."The court has to take note of the gravity of the offence and multiple cases against the petitioner and more than Rs 1,544 crore fraud has been committed, that too this petitioner being a founder chairman of the said bank," the bench said. The court pointed out that when one is facing an inquiry or trial in more than one offence or in multiple cases pending against a person, then the court cannot grant bail to that individual under Section 479 of BNSS."It is important to note that the second proviso to Section 479(1) of BNSS empowers the court to order the continued detention of a person for a period longer than one half of the period. BJP's first list to be out soon; former MPs, state unit presidents in the fray

GNS News Agency, Feb 9The BJP has begun finalising its candidates for the Delhi Assembly elections next year and is likely to release its first list of 35 to 40 names in early December, according to party sources. While the entire list is likely to include "several young leaders" compared to its picks from the 2020 Assembly elections, its choice for the New Delhi Assembly constituency is likely to be the "most high-profile" among candidates for the city's 70 constituencies, sources said.

Party insiders said the finalisation of names had picked up with discussions around them led by Baijayant Panda, the BJP in-charge for Delhi, the state leadership led by state unit president Virendra Sachdeva, and the local unit of the RSS. "Two former Delhi MPs and a senior NDMC [New Delhi Municipal Council] member are in the contention from the New Delhi seat represented by AAP convenor Arvind Kejriwal as well as the Greater Kailash seat which AAP minister Saurabh Bharadwaj represents," an insider said.

"Former mayors, presidents of the BJP's Delhi unit and ex-NDMC members are being considered for other seats which AAP ministers or senior leaders represent as current MLAs. The first list is likely to be out before December 15," the insider added. According to sources, former MPs Parvesh Verma, Meenakshi Lekhi and Ramesh Bidhuri, former NDMC chairperson Satish Upadhyay, and ex-mayor Arti Mehra are among the names being discussed as po-



tential candidates."After the names have been finalised, they will be discussed in the state election committee, then the core committee — which has a mix of local and national leadership from the BJP and RSS — and then finally the Central Election Committee chaired by Prime Minister Narendra Modi," a source said"Several young faces will also be part of the list which will be announced relatively early this time to give such candidates time to prepare and have a strong campaign," the source added. As temperatures drop, Hyderabad witnesses rise in seasonal ailments

Hyderabad: With temperatures dropping significantly, physicians are reporting a surge in seasonal ailments, especially upper respiratory tract infections, in Hyderabad.Most of the surge is related to cases of influenza, upper respiratory tract infections, lung diseases and viral fevers in Hyderabad. There is also a significant rise in cases of allergies, as winters are known to trigger allergies. Based on the data available with Allergy and Asthma Network of India (AANI), winters are known to cause 40 percent rise in cases of allergies. Doctors are also reporting a significant rise in bouts of Asthma among patients who already were diagnosed with the ailment. "During winters, up to 80 per cent of allergic reactions are caused due to house dust mite and moulds. Essentially, during winter airways of the lungs tighten, resulting in more aggressive unpredictable Asthmatic attacks," says CEO of AANI and allergy

specialist, Dr. Vyakaranam Nageshwar.Family Physician and Diabetologist, Apollo Clinic Nizampet, Dr. Soujanya Manthripragada, in a press release said that she has noticed a rise in respiratory tract infections among patients."In the past few weeks, the number of cases has risen significantly. About 40-50% of patients are visiting with respiratory symptoms. Upper and Lower respiratory tract infections, Acute exacerbations of Bronchial asthma and COPD have also been observed. Circulation of respiratory pathogens is leading to more people becoming sick requiring Hospitalizations."Dr. Manthripragada has said that amongst the most common complaints in patients, cold, cough, fever and shortness of breath were reported. "Patients less than 16 years old and the elderly especially with comorbidities like diabetes and chronic diseases are complaining about these issues.

Noting that "in majority of the cases, the police officials either hold inquiry in every complaint received in police stations or keep the complaint pending for several days, just to extort money from the poor and innocent victims of crimes in the state of Punjab", the Punjab and Haryana High Court has directed the DGP (Punjab) to ensure that the FIRs are registered without any delay.

The directions were issued by a bench of Justice N S Shekhawat while hearing a petition filed by one Jaswant Singh, seeking protection of his life & liberty and action against the accused who had beaten him up mercilessly. While the incident with the petitioner took place on September 25, 2024, the FIR against the accused was registered only on November 22, 2024.On previous hearing, the high court had directed Senior Superintendent of Police (SSP) and DGP, Punjab, to ensure that in all the cases, where cognisable offences are made out, the FIRs are registered promptly, in view of the judgment passed by the Supreme Court in Lalita Kumari versus Government of UP and others (2013). When the matter came up for hearing on Monday, the state counsel told the high court that an FIR No. 0237 dated November 22, 2024, has been registered at Ajnala police station against the accused in the present case

Even SHO, Ajnala police station, submitted in the court that 10 complaints received from various complainants are pending for the last more than 15 days and 20 complaints are pending at the police station for the last two weeks.Justice Shekhawat noted that it appears that the complaints are kept pending at various police stations in Punjab and the mandate of the Supreme Court is not being followed strictly. On earlier occasions also, this court had taken serious view of the matter and had directed the DGP, Punjab, to issue instructions to all the police officials in Punjab to ensure that the FIRs are promptly registered in the cases where a cognisable offence is made out, apparently from the perusal of the complaint itself, said the high court."However, in majority of the cases, the police officials either hold inquiry in every complaint received in police stations or keep the complaint pending for several days, just



to extort money from the poor and innocent victims of crimes in the State of Punjab. Even in the present case, the occurrence had taken place on September 25, 2024, where a person was seriously injured and the FIR was registered on November 22, 2024," noted the high court. Attacks on minorities in Bangladesh: Indian-American body urges Biden, Trump to intervene

An influential Indian-American organisation has urged U.S. President Joe Biden and President-elect Donald Trump to call on the government of Bangladesh to protect the minority Hindu community in the country. In separate letters to Biden and Trump, the Foundation for India and Indian Diaspora Studies (FIIDS) on Wednesday (November 27, 2024) expressed grave concern over the escalating human rights violations against religious minorities in Bangladesh and the recent arrest of Hindu spiritual leader Chinmoy Krishna Das Brahmachari. Bangladesh's minority Hindus have faced over 200 attacks, including those on their temples, since the fall of Sheikh Hasina's Awami League government on August 5, according to the FIIDS.

Das was arrested on Monday in a sedition case and later denied bail by a court, triggering protests by community members in various locations, including the capital Dhaka and the port city of Chattogram.He was a member of the International Society for Krishna Consciousness (ISKCON) and was recently expelled. Calling for an independent inquiry into the violence against minorities, Khanderao Kand, President and Chief of Policy and Strategy, FIIDS requested Biden to urge Bangladesh Chief Advisor Yunus Mohammed to release Das, provide protection to minority communities and publicly commit to upholding secular principles."Bangladesh's progress as a democratic and inclusive society depends on safeguarding the rights of all its citizens, including its most vulnerable populations. We trust that your leadership will champion these values and help restore hope for those who continue to face oppression and displacement," he said. In his letter to Trump, Kand said, "As the incoming leader of the free world, you have the unique opportunity to prioritise the protection of vulnerable communities and reinforce America's commitment to religious freedom and human rights." He urged Trump to appeal to the interim government to ensure Das' release, safeguard ISKCON's operations and protect mi-



"I strongly condemn Bangladesh for its atrocities against minorities, the arrest of a Hindu monk and its shocking attempt to ban the humanitarian religious minority organisation, ISKCON, while ignoring jihadi extremist organisations," Kand told PTI."Bangladesh is rapidly descending into a radicalised Islamic state, all under the watch of the US, the State Department, and the UN who must act now to restore democracy and protect minorities. I request not only President Biden but would urge President Trump and his transition team to give priority to restoration of peace and protect minorities in Bangladesh," he said.Instead of taking action against radical Islamist groups, the Bangladeshi government has shockingly labelled ISKCON, a globally respected humanitarian organisation, a "religious fundamentalist organisation", Kand said. Landscape fires account for 2.5 million deaths from air pollution in India: Lancet



Between October and December, India's northern plains are choked by air pollution arising from cool temperature, vehicular emissions and burning of farm stubbleAt least 2.5 million people in India have died on account of health issues arising from air pollution caused by so-called landscape fires (such as those caused by the burning of farm stubble) between 2000 and 2019, according to a study published by Lancet The study added that the world saw at least 30 million deaths in the same period attributable to health issues arising from landscape fires, with at least 90% of these deaths occurring in low- and middle-income countries, with the highest burdens in China, India, the Democratic Republic of the Congo, Indonesia, and Nigeria. China, according to the study, saw a little over 2.81 million deaths.

Landscape fires are fires that occur in natural and cultural landscapes, including both wildfires and humanplanned fires. Between October and December, India's northern plains are choked by air pollution arising from cooler temperatures (a phenomenon called inversion), vehicular emissions, and, also, the burning of farm stubble, especially in Punjab.While these fires can result in direct fatalities, the majority of deaths associated with them stem from the air pollution they generate, which contributes to longterm health issues such as cardiovascular and respiratory diseases. For instance, according to the study, there were 221 direct deaths reported globally in 2018. However, the health risks from landscape fires are much greater, as landscape fire-sourced (LFS) air pollution (particularly fine particulate matter with a diameter of $2.5 \ \mu m$ or less [PM2.5] and ozone [O3]) often travels hundreds and even thousands of kilometres away from the source and affects much larger populations than the flames and heat do, according to the authors.

The authors claimed the study is the largest and most comprehensive assessment to date of the health risks associated with air pollution from landscape fires. It found an increasing number of global cardiovascular deaths associated with pollution from landscape fires with approximately 450,000 deaths per year attributed to cardiovascular disease, and 220,000 deaths attributable to respiratory disease. The total number of deaths attributable to air pollution from landscape fires in India rose from 117781 a year in the decade between 2000 and 2009 to 137711 a year in the decade between 2010 and 2019, according to the study. The researchers said they calculated country-specific population-weighted average daily and annual fine particulate matter (PM2·5) and surface ozone (O3) arising from landscape dires during 2000 -19 from a validated dataset.Annual mortality, population, and socio-demographic data for each country or territory were extracted from the Global Burden of Diseases Study 2019. These data were used to estimate country-specific annual deaths attributable to LFS air pollution using standard algorithms. The authors also concluded that "immediate climate actions to limit the magnitude of climate change" could help with a modelling study suggesting that 60-80% of the increase in landscape fires by 2100 could be avoided if the global mean temperature increase could be limited to 2.0°C or 1.5°C over pre-industrial levels."Air pollution is a major health hazard, impacting almost all vital organs adversely upon prolonged exposure. Even short-term exposure leads to several health conditions such as sore throat, aggravated asthma, watery eyes etc," said Dr GC Khilnani, former head of Pulmonology and sleep medicine department, Aiims.

SC calls for reforms to empower elected female representatives

GNS News Agency, Feb 9The Supreme Court has underscored the urgent need for reform in governance structures to empower elected female representatives and safeguard their autonomy. In a scathing critique of the regressive mindset entrenched in administrative systems, the Supreme Court has underscored the urgent need for reform in governance structures to empower elected female representatives and safeguard their autonomy.

Highlighting how women in leadership roles are often subjected to systemic discrimination and treated as subordinates to bureaucrats, a bench of justices Surva Kant and Ujjal Bhuyan called for introspection and significant structural changes to promote gender equality in governance.Delivering a judgment reinstating a young woman sarpanch in Chhattisgarh, the court noted that the bureaucratic machinery often undermines women in elected positions, disregarding their democratic mandate and imposing undue accountability upon them. The judgment, delivered on November 19, was released on Wednesday. The judgment focussed on the entrenched gender bias within governance systems that disproportionately affects female leaders, particularly those in rural and remote areas. Women in leadership roles are frequently subjected to selective accountability, discriminatory practices, and systemic harassment, discouraging their participation in governance.In a particularly strong rebuke, the court held: "There is a recurring pattern of similar cases, where administrative authorities and village panchayat members collude to exact vendettas against female sarpanches. Such instances highlight a systemic issue of prejudice and discrimination. The removal of an elected female representative, especially in rural and remote areas, is frequently treated as a casual matter, wherein disregarding principles of natural justice and democratic processes is treated as a time-honoured tradition." This pervasive bias, the Court noted, reflects a failure of governance structures to adapt to the aspirations of a modern, progressive democracy. "It is disheartening that despite our nation's aspirations to become an economic powerhouse, these incidents of discrimination against women in governance continue unabated, bearing striking similarities across geographically distant regions. Such practices normalise regressive attitudes and must be met with serious introspection and reform," asserted the bench. Underscoring the broader need for systemic change, the court called upon administrative authorities to act as enablers of women's empowerment rather than obstacles to their leadership."Administrative authorities, being custodians of actual powers, should lead by example, making efforts to promote women's empowerment and support female-led initiatives in rural and remote areas. Instead of adopting regressive attitudes that discourage women in elected positions, they must foster an environment that encourages their participation and leadership in governance," it noted.

It pointed out that the bureaucratic apparatus frequently imposes itself on elected representatives, undermining their authority and autonomy. This is particularly pronounced in cases involving women leaders, who are systematically marginalized and subjected to unfair treatment."The administrative authorities, with their colonial mindset, have regrettably failed yet again to recognize the fundamental distinction between an elected public representative and a selected public servant. Elected representatives like the appellant are often treated as subordinate to bureaucrats, compelled to comply with directives that serve to encroach upon their autonomy and impinge their accountability," the court maintained.Such practices, the bench emphasised, distort the democratic process, reducing the credibility and influence of those elected to represent the public. "This misconceived and self-styled supervisory power is asserted with an intention to equate elected representatives with public servants holding civil posts, completely disregarding the democratic legitimacy conferred by election," it noted. The judgment came in the case of a 27-year-old woman sarpanch from Sajbahar Gram Panchayat in Chhattisgarh, who was removed from office under what the court termed as baseless and discriminatory allegations. The sarpanch, elected in 2020 with a significant mandate, had undertaken several development projects aimed at improving infrastructure and economic self-sufficiency in her village. Despite her commitment, she faced systemic hurdles, including delayed issuance of work orders and subsequent accusations of delays in project execution. Bureaucrats, allegedly in collusion with panchayat members, initiated proceedings that culminated in her removal, lamented the court, adding she was also denied the opportunity to defend herself, violating the principles of natural justice."This appears to be a classic case of administrative imperiousness, where the authorities penalized a young, dedicated sarpanch for baseless and unwarranted reasons. Rather than supporting her developmental initiatives, they sought to undermine her credibility and obstruct her work," the court said. It quashed the orders for her removal, reinstating her as sarpanch and awarding ?1 lakh as compensation for the harassment she faced. It also directed the state government to initiate action against the erring officials responsible for her ordeal.

Investors return to new-look Middle East, but Trump causes some concern

LONDON/JERUSALEM, GNS News Agency, Feb 9 A historic shake-up of the Middle East is starting to draw international investors, warming to the prospects of relative peace and economic recovery after so much turmoil.President Donald Trump's proposal that the U.S. takeover Gaza may have thrown a curveball into the mix, but the fragile ceasefire there, Bashar al-Assad's ouster from Syria, a weakened Iran and a new government in Lebanon have fed hopes of a reset.Egypt, the region's most populous country and a key negotiator in the recent peace talks, has just managed its first dollar debt sale in four years. Not too long ago it was facing economic meltdown.

Investors have started buying up Israel's bonds again, and those of Lebanon, betting that Beirut can finally start fixing its intertwined political, economic and financial crises."The last few months have very much reshaped the region and set in play a very different dynamic in a bestcase scenario," Charlie Robertson, a veteran emerging market analyst at FIM Partners, said. The question is whether Trump's plan for Gaza inflames tensions again, he added.Trump's call to "clean out" Gaza and create a "Riviera of the Middle East" in the enclave was met with international condemnation. Credit rating agency S&P Global has signalled it will remove Israel's downgrade warning if the ceasefire lasts. It acknowledges the complexities, but it is a welcome possibility as Israel readies its first major debt sale since the truce was signed. Share dropped from 15% to below 9%, debt load has risen from 540 bln to almost 720 bln

Michael Fertik, a U.S. venture capitalist and CEO of artificial intelligence firm Modelcode.ai, said the easing of tensions had contributed to his decision to open an Israeli subsidiary.He is eager to hire skilled local software programmers, but geopolitics have been a factor too."With Trump in the White House, no one doubts the United States has Israel's back in a fight," he said, explaining how it provided predictability even if the war re-ignites.Having largely stayed away when Israel ramped up spending on the war, bond investors are also starting to come back, central bank data shows.Economy Minister Nir Barkat told Reuters in an interview last month that he will be seeking a more generous spending package focusing on "bold economic growth."

Earth bids farewell to its temporary 'mini moon'

Florida: Planet Earth is parting company with an asteroid that's been tagging along as a "mini moon" for the past two months. The harmless space rock will peel away on Monday, overcome by the stronger tug of the sun's gravity. But it will zip closer for a quick visit in January. NASA will use a radar antenna to observe the 33-foot (10-meter) asteroid then. That should deepen scientists' understanding of the object known as 2024 PT5, quite possibly a boulder that was blasted off the moon by an impacting, craterforming asteroid.

While not technically a moon — NASA stresses it was never captured by Earth's gravity and fully in orbit — it's "an interesting object" worthy of study.

The astrophysicist brothers who identified the asteroid's "mini moon behavior," Raul and Carlos de la Fuente Marcos of Complutense University of Madrid, have collaborated with telescopes in the Canary Islands for hundreds of observations so far. Currently more than 2 million miles (3.5 million kilometers) away, the object is too small

and faint to see without a powerful telescope. It will pass as close as 1.1 million miles (1.8 million kilometers) of Earth in January, maintaining a safe distance before it zooms farther into the solar system while orbiting the sun, not to return until 2055. That's almost five times farther than the moon.

China hold military-level talks

Military officials of Pakistan and China held talks on counter-terrorism and regional security amid unease following the recent attacks on Chinese nationals."General Zhang Youxia, vice-chairman of the Central Military Commission (CMC) China and one of China's two top military leaders, is visiting Pakistan along with a high-level delegation," according to a military statement. General Zhang held a one-on-one meeting with Army Chief Gen Asim Munir on Wednesday (November 27, 2024), followed by the delegation-level discussions. According to the statement, the engagements focussed on "matters of mutual interest, regional security dynamics, measures for regional stability and enhancing bilateral defence cooperation." General Zhang spoke about Pakistan's ongoing counter-terrorism efforts, which remain a key topic of discussion between the two countries owing to the rising frequency of attacks targeting Chinese nationals working in Pakistan.Newspaper Dawn reported that there have been media reports that Beijing is seeking a more proactive role in ensuring the safety of its citizens in Pakistan, but the Foreign Office has emphasised that counter-terrorism cooperation between the two countries is based on mutual respect for each other's sovereignty."Under the regional stability head, the two sides

exchanged views about the Indian role in the region and the developments in Afghanistan, particularly the presence of terrorist groups," Dawn added. The CMC vice-chairman's visit follows a trip by Gen Li Qiaoming, commander of the People's Liberation Army Ground Forces, to Pakistan in late August. Additionally, more than 300 Chinese troops arrived in Pakistan to take part in the joint China-Pakistan anti-terrorism exercise, Warrior-VIII, amid escalating militant attacks in the country. The opening ceremony for the drills was held on Wednesday (November 27, 2024), a report posted on the Chinese Defence Ministry's official website said. Running until mid-December, the drills aim to joint counter-terrorism operational enhance capabilities. During the talks on Wednesday (November 27, 2024), General Munir highlighted the resilience of Pakistan-China relations, noting their ability to withstand shifts in international and regional dynamics. He expressed gratitude for China's unwavering support for Pakistan."General Zhang, in turn, praised Pakistan's dedication to the strategic partnership and reaffirmed China's commitment to strengthening the enduring bilateral relationship," the statement added.82 killed in three days of Pakistan sectarian violenceThe two generals last met in Beijing in April 2023, where General Zhang pledged to deepen and expand practical cooperation, elevate military-to-military ties, and jointly safeguard the common interests of both countries while promoting regional peace and stability, reported Dawn. He said he would impose a 25% tax on all products entering the U.S. from Canada and Mexico as one of his first executive orders.But Mr. Trump posted Wednesday evening on Truth Social that he had a "wonderful conversawith new Mexican President Claudia tion" Sheinbaum."Mexico will stop people from going to our Southern Border, effective immediately. Application for a warrant of arrest filed in ICC for Myanmar Acting President Min Aung Hlaing

The International Criminal Court has reached the conclusion after an "extensive, independent and impartial investigation" that Senior General Min Aung Hlaing, the Acting President of Myanmar is criminally responsible for "crimes against humanity" against the Rohingya community of Rakhine. Based on its finding ICC Prosecutor's office has filed an "application for a warrant of arrest" before the Pre-Trial Chamber I of the International Criminal Court, a statement from the ICC declared on Wednesday, November 27, 2024.

"After an extensive, independent and impartial investigation, my office has concluded that there are reasonable grounds to believe that Senior General and Acting President Min Aung Hlaing, Commander-in-Chief of the Myanmar Defence Services, bears criminal responsibility for the crimes against humanity of deportation and persecution of the Rohingya, committed in Myanmar and in part in Bangladesh," declared a statement from the ICC on Wednesday, November 27, 2024. This is the first time that the Acting President Min Aung Hlaing has drawn such sharp and definite observations from the International Criminal Court since the beginning of the Rohingya crisis. ICC said the application "draws upon a wide variety of evidence from numerous sources such as witness testimonies, including from a number of insider witnesses, documentary evidence and authenticated scientific, photographic and video materials."Myanmar's Ethnic Armed Organisations and the rebel National Unity Government have held a round of meetings in New Delhi earlier this month as internal conflict has created difficult humanitarian situation for most the provinces and regions. The Rohingya crisis started in the monsoon of 2017 with the eviction of more than a million Rohingya citizens of Myanmar who were forced to seek refuge across the boundary in Bangladesh's Chittagong.

Making sense of the Israel-Hezbollah ceasefire

When Prime Minister Benjamin Netanyahu decided to launch a military invasion of Lebanon on October 1 — Israel's fourth invasion of the neighbouring country — he said his main objective was to let the over 60,000 northern Israelis, who were displaced by Hezbollah rockets, return to their homes. Almost two months later, he accepted a ceasefire with Hezbollah, agreeing to withdraw all Israeli troops to the south of the Lebanese border. The future of the displaced residents remains uncertain. Hezbollah still possesses thousands of drones and rockets and the capability to fire them. Then why did Mr. Netanyahu accept the ceasefire?

Let's first look at the ceasefire deal, which was mediated by the U.S. and France. According to the agreement, Hezbollah would withdraw its troops and weapons to the north of the Litani River, and Israel would withdraw its troops from southern Lebanon. Israel's war on Gaza continues, and the ceasefire is a climb-down for Hezbollah.Yet, Israel failed to meet its declared objectives in Lebanon. Mr. Netanyahu had earlier said Israel would continue fighting against Hezbollah until its objectives were met. But on December 24, a few days before the ceasefire was announced, Hezbollah had fired more than 250 rockets into Israel. Israeli troops did not make much territorial gains in southern Lebanon even after two months of fighting. Worse, they failed miserably in destroying or deterring Hezbollah's rocket capabilities. The high-security locations hit by Hezbollah rockets and drones included a private residence of Prime Minister Netanyahu and a military base in Binyamina. Israel was also taking heavy casualties in Lebanon. In October alone, Israel lost some 35 soldiers in southern Lebanon. So unlike in Gaza, where the remainder of Hamas is operating like a loose insurgency from the ruins of the strip, Israel was facing intense heat in Lebanon. The Biden administration, which fully backed Israel's war on Gaza, had also heaped up pressure on Israel over Leba-

When the Israel-Hezbollah war of 2006 came to an end, the UN Security Council Resolution 1701 demanded a full withdrawal of the Israeli troops from Lebanon and Hezbollah from the south. It had also demanded the deployment of the Lebanese army in the south and c the disarmament of Hezbollah. The latest ceasefire agree ment is rooted in Resolution 1701. Israel withdrew in 2006, but Hezbollah only grew stronger, by stockpiling more weapons, deepening its presence in the south and building itself as a powerful political and social actor in Lebanon's fractious polity. Today, Hezbollah has been weakened, but is far from being defeated. Expecting the Lebanese army, which is an inferior fighting force to Hezbollah, to enforce the ceasefire would be myopic, given the past experiences. Mr. Netanyahu might try to sell the ceasefire as a victory for Israel. But facts on the ground offer a different picture.

Taiwan holds air defence drill ahead of President's Pacific trip

Taiwan's military held an early morning air defence drill on Thursday (November 28, 2024) to test its response and engagement procedures, ahead of a trip by President Lai Ching-te at the end of the week to the Pacific that will include U.S. stopovers. China is likely to launch military drills in the coming days near Taiwan, using Mr. Lai's upcoming trip to the Pacific and scheduled U.S. transit as a pretext, according to assessments by Taiwan and regional security officials.China claims democratically governed Taiwan as its own territory and says Mr. Lai is a "separatist". Mr. Lai says only Taiwan's people can decide their future and has repeatedly offered talks with Beijing that have been rebuffed.Taiwan's air force command said in a statement that made no mention of Mr. Lai's overseas trip that for a two-hour period starting from 5 a.m. (2100 GMT Wednesday) aircraft, ships and missile systems were involved in an "overall air defence battle plan exercise". The drill was to "strengthen the overall effectiveness of air defence operations and to test the response and engagement procedures of the air defence forces", it added."In the face of changes in the enemy situation, we will continue to enhance defence

resilience through various practical training to anticipate potential threats and challenges and ensure air defence security," the command said. The Defence Ministry told Reuters separately that it was a regular drill carried out quarterly.Reuters correspondents in the northern Taipei suburbs reported seeing and hearing fighter jets in the skies as dawn broke. China has carried out two rounds of major war games around Taiwan so far this year, and on a daily basis flies aircraft and sends ships into the skies and waters around Taiwan. Taiwan has also complained of Chinese balloons flying near the island in what the government says is a pattern of harassment by Beijing. On Thursday, the Ministry said the previous day it had spotted two Chinese balloons flying out at sea to the north of Taiwan, at distances of 60 nautical miles (111 km) and 88 nautical miles (163 km) from the port city of Keelung.Mr. Lai will leave on Saturday (November 30, 2024). A formal announcement of his U.S. stopovers could come as soon as Friday (November 29, 2024), according to sources.Late Wednesday (November 27, 2024), the presidential office said that if China were to use Mr. Lai's trip as an excuse to launch military exercises, "it would be a blatant provocation of the status quo of peace and stability in the region".

Air India tops up its mega 470-aircraft order with another 100 Airbus jets

air india aircraft orderUnder government control, Air India faced significant financial stress, which did not allow the airline to meaningfully expand or modernise its fleet.In what may be seen as the Tata group's growing confidence and ambition in India's high-potential aviation sector, Air India has topped up its \$70-billion order for 470 aircraft placed last year with another 100 Airbus jets, taking the cumulative order size to 570 planes. New aircraft orders are critical to Air India's fleet expansion and modernisation plan, which the airline embarked upon after the Tata group acquired it from the government in January 2022.

Air India's 470-plane order with both major aircraft manufacturers Airbus and Boeing also included options to acquire up to 370 additional aircraft. In large aircraft orders, purchase options allow carriers to buy additional planes in future at a previously agreed-upon price and schedule. The airline did not divulge financial details of the latest 100-aircraft order. The 100 new Airbus aircraft ordered by Air India include 10 wide-body A350 planes and 90 narrow-body A320 family jets, including the A321 neo. The 470-aircraft order, the world's largest aircraft order at the time of its announcement in February 2023, was made up of 250 Airbus planes and 220 Boeing planes. With the latest top-up, Airbus now makes up for 350 of the 570 planes that will be deployed by Air India and its no-frills arm Air India Express.

"With India's passenger growth outpacing the rest of the world, its significantly improving infrastructure and an aspirational young population increasingly going global, we see a clear case for Air India to expand its future fleet beyond the firm orders of the 470 aircraft placed last year. These additional 100 Airbus aircraft will help to position Air India on the path to greater growth and contribute to our mission of building Air India into a world-class airline that connects India to every corner of the world," said Tata Sons Chairman Natarajan Chandrasekaran, who is also the chairman of Air India.Under government control, Air India faced significant financial stress, which did not allow the airline to meaningfully expand or even modernise its fleet. The Tata group wants to transform the airline into a carrier of global repute by significantly expanding its fleet and network and sprucing up the product offering. These large aircraft orders are set to play a pivotal role in that journey.

Air India has so far received six aircraft-all A350sfrom its Airbus order, and the airline's order book now at 344 planes. Of the 250 Airbus aircraft ordered by Air India last year, 40 were A350s, while the remaining 210 were A320 family jets. Of the 220 Boeing aircraft ordered by Air India, 35 737 MAX jets have already been delivered. Air India on Monday also announced it has selected Airbus' Flight Hour Services-Component (FHS-C) to support the maintenance requirements of its growing A350 fleet. The new materials and maintenance contract will help Air India to optimise the reliability and performance of its A350 fleet, with comprehensive engineering services and integrated component services including on-site stock at Delhi provided by Airbus. Over the past couple of years, Indian airlines—Air India, IndiGo, and Akasa Air—grabbed global attention by placing orders for hundreds of new aircraft. A few months after Air India announced its 470-aircraft order, India's largest airline IndiGo wrested the title of placing the world's largest commercial aircraft order from Air India by ordering 500 Airbus A320 family planes. Then in April this year, IndiGo placed an order for 30 A350 aircraft. In January this year, Akasa Air placed a firm order for 150 Boeing 737 MAX family planes, taking its total order size for the aircraft to 226.In all, Indian airlines are now estimated to have nearly 1,300 aircraft on order. These are likely to be delivered till the mid-2030s. India is the world's third-largest aviation market and is also among the fastest-growing major aviation markets globally. As compared to large mature aviation markets, the penetration of air travel in India is still insignificant, reflecting massive growth potential in the years

New income-tax bill gets Cabinet nod; to be tabled in Parliament next week

The Union Cabinet on Friday cleared the new income-tax bill that is proposed to replace the existing sixdecade old Income-tax Act, sources said. The new income-tax bill is now likely to be introduced in Parliament on Monday, they said. The new income-tax bill is aimed to make the language and implementation of the income tax legislation simpler for taxpayers. On Thursday, Finance Secretary Tuhin Kanta Pandey had said that the new income-tax bill will not have long sentences, provisos and explanations and will mark a different way of engagement with citizens, with no aim to put any new tax burden

The Bill will include the recent changes in income tax rates, slabs and TDS (Tax Deducted at Source) provisions will also be reflected in it, he had said. While presenting the Union Budget for 2025-26 on February 1, Union Finance Minister Nirmala Sitharaman had stated that a new income tax legislation will be introduced by the government next week in the ongoing Budget session of the Parliament.In her Budget speech, Sitharaman had said that the government had earlier ushered in Bharatiya Nyaya Sanhita replacing Bharatiya Danda Sanhita. "I am happy to inform this August House and the country that the new income-tax bill will carry forward the same spirit of "Nyaya". The new bill will be clear and

In October last year, the Income Tax department had announced the formation of an internal committee to review the Income-tax Act and invited public inputs and suggestions on four key areas - simplification of language, litigation reduction, compliance reduction, and obsolete provisions. The Bill, after review by the Standing Comstand for taxpayers and tax administration, leading to tax mittee, was then revised twice, in 2012 and 2014, but lapsed with the dissolution of the 15th Lok Sabha.

'We are hardly married': Javed Akhtar's take on relationships highlights how bonds can thrive outside conventional frameworks

or civil unions, "the first step is to have an honest conversation about what they truly want from their relationship.' It's important to explore how they both view the idea of partnership and why the conventional framework of marriage might not feel like the right fit.

Discussing what they value most in their relationship is equally important. Do they prioritise autonomy, equality, or flexibility over the societal recognition marriage provides? Are they comfortable navigating a relationship without the formal "security" that marriage often symbolises? While some thrive in the freedom of non-traditional arrangements, others may realise that the lack of structure makes them feel uneasy or insecure.

Baruah states, "From an anthropological perspective, marriage has always been a reflection of cultural, economic, and social needs. Historically, it wasn't about love but about alliances and stability. In today's world, where individualism and personal fulfillment have become central, it's natural for some to rethink these traditional structures. But even in redefining partnerships, couples still interact with societal norms, whether they choose to embrace or resist them."Ultimately, she mentions, the decision to step away from marriage is deeply personal. It's not about rejecting marriage for the sake of it but crafting a relationship that feels authentic and meaningful for the people involved. "At the heart of it all is connection, and whether that comes with a marriage license or not depends entirely on the individuals in the relationship."

Expect durable recovery in private investment following rate cut, tax relief: FM Sitharaman

A durable recovery is expected in private investment as the signs of a pickup in consumption-driven cycle are already visible on the back of the government's income tax relief and the repo rate cut by the Reserve Bank of India (RBI), Union Finance Minister Nirmala Sitharaman said after the post-Budget RBI Board meeting on Saturday. RBI Governor Sanjay Malhotra echoed the Finance Minister's sentiment by stating that the repo rate cut delivered by the central bank should boost consumption.Many in the private sector are already looking at reviewing capacity utilisation, as per anecdotal inputs, Sitharaman said. "The orders for fast moving consumer goods (FMCG) for the period April-June are already getting booked and the industry is clearly seeing the signs of a possible recovery of consumption. And, as a result, many of them are looking at reviewing their capacity utilisation itself. From these limited anecdotal inputs that you're getting, you can safely see that the triggers for a consumption-driven cycle are very clearly being felt by those who have to make the investment decisions. So, I see it as a positive sign with yesterday's (Friday's) decision of the RBI (of a repo rate cut), I am sure together things can move in alignment and in the required traction that we need in this course," she said.

Referring to the recent fiscal and monetary policy measures, Sitharaman said whether it is growth or inflation, both the policies are like "two tyres of a car" and by working together and in coordination, the economy will gain."Whether it's inflation or growth, particularly plugs for growth, it is appropriate for the RBI and the government to have coordination on this. Neither of them encroaches on each other's territory, I don't think that has existed in the last 10 years and I don't see that existing even in the future. There has been good coordination between the RBI and the government...in the coming days also, the RBI and the government will work in a well-coordinated fashion keeping our growth impulses in mind," Sitharaman said.

Malhotra said the RBI is alert to all pressures on inflation and the impact of rupee depreciation on imported inflation. "As per our calculations and estimates, a 5 per cent depreciation in the Indian rupee leads to about 30-35 basis points of inflation. That has been kept in mind (in RBI's February monetary policy). We'll be watchful on that account." he said. The RBI Governor said that most of the depreciation in the rupee is driven by the "global uncertainties, and the Trump-related tariff announcements". "Hopefully, that should settle down and that will help us in the downward movement of inflation," he said. The Indian rupee has hit record lows over the last few days going past the level of



87 against the dollar due to foreign fund outflows and a stronger US dollar. Globally, there have also been concerns around an escalating tariff war between major economies, with the US, under its new President Donald Trump, detailing its intent to impose higher tariffs on three of its largest trading partners — Canada, Mexico and China. While Canada and Mexico have got a month's breather, China has retaliated with its own set of tariff measures against the US on February 4. Sitharaman pointed out that India's move to rejig its import tariffs on key items in the Budget was not a "knee-jerk response" to the recent tariff measures undertaken by Trump, adding that the rationalisation of customs duties has been in the works since the last two years. "These kinds of steps have been happening since the last two years, so whatever steps were announced in the Budget in terms of BCD (basic customs duty), its regulations and rationalising, is not in any knee-jerk fashion to any development globally. This is an ongoing process. We want to make India a lot more investment friendly, trade friendly and at the same time balance it with Atmanirbhar Bharat." she said.

However, the government will provide tariff protection to certain industries, especially MSMEs in the manufacturing sector. She also clarified that protection through anti-dumping duties will be limited to exceptional situations. "...so that the protection does not become a perpetual protection," she said. When asked about the absence of deep liquidity infusion measures in the latest monetary policy, Malhotra listed out several steps taken by the RBI to support transient as well as durable liquidity. He further said going forward, the RBI will be "very very watchful, alert, and very nimble and agile in whatever are the requirements of the banking system to provide liquidity, both transient, overnight, as well as more durable liquidity."The deficit in the banking system liquidity had widened to over Rs 3 lakh crore last month.

But what does this phenomenon reveal about the way humans process information, and how could it influence professional areas?Dr Arun Kumar, consultant psychiatrist at Cadabams Hospitals, tells indianexpress.com, "The boubakiki effect highlights how our senses - specifically vision and hearing - interact to form coherent interpretations of the world. The soft, rounded phonemes in 'bouba' align with the visual perception of curves, while the sharp consonants in 'kiki' resonate with angular shapes."

He adds, "This effect suggests that language is not arbitrary but rooted in sensory experiences. The way we produce sounds involves physical sensations (e.g., rounded lips for 'bouba') that align with visual patterns, shaping our perception." According to research published in Psychological Science, Dr Kumar states, this phenomenon may explain how humans develop abstract linguistic symbols. Early humans likely relied on such sensory associations to assign meaning to words, which evolved into structured languages.

How universal is this phenomenon?

The bouba-kiki effect is largely universal, transcending linguistic and cultural boundaries. "Studies conducted across diverse populations have consistently shown that most individuals intuitively associate "bouba" with rounded shapes and "kiki" with angular shapes," notes Dr Kumar.According to him, "Research published in PNAS found that speakers of languages as diverse as Tamil, English, and Himba (a Namibian language) exhibit similar sound-shape associations. The effect has been observed in young children, indicating that this association is intuitive rather than learned. Even infants as young as four months display a preference for congruent sound-shape pairings,



India completed the formalities in quick time, claiming the doubles match to take an unassailable lead in its Davis Cup tie against Togo and seal its place in the World Group 1 at the DLTA Stadium on Sunday (February 2, 2025). Karan Singh then made his Davis Cup debut with a fighting 6-2, 6-3 victory against Hod'abalo Isak Padio to wrap up the tie 4-0.

N Sriram Balaji and Rithvik Choudary Bollipalli won 6-2, 6-1 in 57 minutes against the late pairing of M'lapa Tingou Akomlo and Padio, the former stepping in as replacement for Thomas Setodji, Togo's best player but struggling with an arm injury that saw him put up a below-par performance in his singles game on Saturday.Led by the experienced Balaji, who lost just one point on his serve through the match, and buoyed by the constantly improving serve of Bollipalli, the Indians were in control all the time, continuing from where the singles left off on Day One. In contrast, while Padio, the youngest in the Togo team, largely responsible for giving a semblance of fightback, Akomlo was erratic, both with his serves and his returns.

The Indians got their first break when Akomlo served in the fourth game, hitting one over the baseline to go ahead 3-1. It soon became 5-2 before Akomlo handed over Game 8 and the set to India with two consecutive double faults. The second set was more of the same, India racing to 5-1 before Bollipalli, serving for the match, finished it off with an ace.Later Karan, stepping in to play the reverse singles, started strongly to justify the team's faith in him, winning in an hour and 12 minutes against Padio. The two youngsters put up the best competition of the tie, Padio constantly engaging Karan in long rallies and mixing his shots to keep the Indian alert but eventually paid the price for his inability to control the pace and angle of his shots, repeatedly hitting wide and over to cede control. Winning the first set 6-2, Karan raced to a 4-0 lead in the second but Padio finally found his groove, breaking him in Game 5 for the only serve taken off an Indian player in the tie. He held his own thereafter before Karan closed out at 6-3 and the 5th dead rubber was called off.

They have the passion to play for the country and deliver for the country," he added.Gambhir said the team cannot relax even for a moment in the Champions Trophy because they have just three league matches, as compared to the 50-over World Cup."Champions Trophy is a completely different challenge as compared to the 50-over World Cup because literally every game is a makeor-break, so you can't stop anywhere in this tournament."So hopefully we're going to start off really well, because ultimately, if you want to go on and win the competition, you have to win five games," he said.

Gambhir also played down the hype surrounding the India vs Pakistan match, which is scheduled to be played at Dubai on February 23. "Look, we don't go to the Champions Trophy thinking that the 23rd is the most important game for us. I think five games, all the games are important. The mission to go to Dubai is to win the Champions Trophy, not only win one particular game. "But yes, if that is one game in the middle of winning the Champions Trophy, we're going to try and take it as seriously as possible.



So, there's no time for you to take the foot off the pedal. You always want to be ready for that challenge. We recently finished the T20 World Cup, which was superb for us. Now, we look forward to another one." Everyone's getting prepared in their own fashion. A lot of the guys are playing domestic cricket, a lot of guys are playing international cricket as well. So, yeah, when the time comes, it's all about just getting your mind right and focusing on what lies ahead." said Rohit. The 'Hitman' also did not want to think too much about India's match against Pakistan, terming it as just another game.

"I think in the past two or three years, I've spoken a lot about that game. It's just a game for us. We will try and do what is required for any cricket team to do on that particular day. We just want to show up there and show up well."A collective decision: SuryaIndia's T20 International skipper Suryakumar Yadav said the team's aggressive approach in the format is the result of a "collective" decision by the management and the players."It's a collective effort. We've decided that we want to play a brand of cricket going forward, irrespective of what position we are in. In T20s, by the time you blink your eyes, the game is over. But everyone needs to have their own plan. But we have to be on the same page." Praggnandhaa and Gukesh in joint lead at Tata Steel Masters

World Champion D. Gukesh played out a draw with Jorden van Foreest of Holland, while Grandmaster R. Praggnanandhaa beat Alexey Sarana of Serbia as the two Indians shared the lead after a thrilling day at the Tata Steel Masters Wijk Aan Zee, The Netherlands.Praggnanandhaa notched up his third consecutive win to take his tally to a commendable 8.5 points, the same as his compatriot Gukesh after the 12th and penultimate round.

The two Indians are now poised for an exciting finish in the prestigious tournament, with the remarkable prospect of one of them potentially clinching the title-a first in Tata Steel Masters history. Eying the top spot after the 11th round, Nodirbek Abdusattorov of Uzbekistan was outdone by Arjun Erigaisi and is all but out of title contention on 7.5 points.Praggnanandhaa was involved in another Queen's gambit declined opening. Only this time he was playing with white pieces. It was quite a contrast from his previous round game against Caruana as Sarana went for an early advance of king side pawns and then castled on the queen side. It was time to launch an attack against the black king and Praggnanandhaa did not disappoint. In tactical complications, Praggnanandhaa was at his best as he sacrificed a piece to rip apart the black's king position and what followed thereafter was a pleasure to watch."At that point I realized it could be a long game, but then I saw this piece sacrifice," said Praggnanandhaa after the game. The game ended through a queen sacrifice resulting in force checkmate.Gukesh played a game of fluctuating fortunes against Foreest, who has the ability to play the spoiler on any given day.

Foreest declared his peaceful intentions early in the Queen pawn game as white when he appeared ready for a repetition. However, Gukesh declined the offer and the game

was still equal with many pieces on board. Foreest sacrificed a Rook for a knight but on the 39th move Gukesh returned the favour with his clock ticking away. It was a won position for Gukesh but precise calculation was needed and it was right here that the Indian faltered allowing his opponent a huge comeback. Foreest had suddenly turned the tables down but did not quite realise it and decided to go for perpetual checks in the heavy piece endgame. Arjun Erigaisi finally proved his mettle against Nodirbek Abdusattorov, whose ambitions of claiming the top spot came to an end. The game featured a Nimzo-Indian Defense, wherein the Indian had white pieces and his choice of Capablanca variation gave little chances for Abdusattorov to disturb the balance.

In the early middle game, Abdusattorov went for unwarranted complications and ended up blundering on the king side. Arjun won a pawn first and later won two bishops for a rook. Lifetime award for Sachin Tendulkar, Bumrah is best men's cricketer

The legendary Sachin Tendulkar, whose batting records and impact on international cricket have stood the test of time, was on Saturday conferred with the Col CK Nayudu Lifetime Achievement Award, while current India pace spearhead Jasprit Bumrah was honoured with the Polly Umrigar Award for Best Men's International Cricketer of 2023-24. The 51-year-old Tendulkar, who played 664 international games for India, holds the record for the highest number of Test and ODI runs in the history of the game.

"Deeply honoured to receive the Col. C. K. Nayudu Lifetime Achievement Award, My cricketing journey, which spanned 24 years was never mine alone. It belonged to every coach's guidance, every teammate's trust, every fan's unwavering support and my family's belief, love and sacrifices," Tendulkar tweeted."This award is a reminder to keep giving back to the sport and the people that gave me everything. To the @BCCI and every cricket lover: thank you for letting me bat for India with an open heart and limitless boundaries."From his debut as a 16-year-old prodigy to becoming the first batsman to score a double century in ODIs. Tendulkar's journey was one of relentless pursuit of excellence and remains the only cricketer to have featured in 200 Tests."Always value your game and take care of your game. I realised on that final day (2013) that I will never walk onto the field as a current India cricketer. The 31-year-old was also the Player of the Series against Australia in the Border-Gavaskar Trophy. bagging 32 wickets across five Tests. Elegant batter Smriti Mandhana walked away with the Best International Cricketer of 2023-24 in women's category.Mandhana, who was the ICC Women's ODI Cricketer of the Year, made 747 runs in the 2024 calendar year with four centuries. She had previously won the award in 2017-18, 2020-21, and 2021-22. The 28-year-old's runs came at an average of 57.86 and an impressive strike rate of 95.15. Spin great Ravichandran Ashwin, who retired from international cricket in December 2024 as India's second highest wicket-taker in Tests with 537 dismissals and overall eighth highest, was bestowed with a special award."My fingers still itch as I realised when I came down the field for training because there is an IPL for me. The whole career has been a huge high for me actually, and it was a privilege to share the stage with Sachin Tendulkar, a dream for a boy who played street cricket in Chennai," Ashwin said after receiving the award.

Wijk Aan Zee: World Champion D Gukesh played out a draw with Jorden van Foreest of Holland, while Grandmaster R Praggnanandhaa beat Alexey Sarana of Serbia as the two Indians shared the lead after a thrilling day at the Tata Steel Masters here.

Praggnanandhaa notched up his third consecutive win to take his tally to a commendable 8.5 points, same as his compatriot Gukesh after the 12th and penultimate round. The two Indians are now poised for an exciting finish in the prestigious tournament, with the remarkable prospect of one of them potentially clinching the title-a first in Tata Steel Masters history. Eying the top spot after the 11th round, Nodirbek Abdusattorov of Uzbekistan was outdone by Arjun Erigaisi and is all but out of title contention on 7.5 points. Praggnanandhaa was involved in another Queen's gambit declined opening. Only this time he was playing with white pieces. It was quite a contrast from his previous round game against Caruana as Sarana went for an early advance of kingside pawns and then castled on the queenside. It was time to launch an attack against the black king and Praggnanandhaa did not disappoint.

In tactical complications, Praggnanandhaa was at his best as he sacrificed a piece to rip apart the black's king position and what followed thereafter was a pleasure to watch. "At that point, I realized it could be a long game, but then I saw this piece sacrifice," said Pragg after the game.
