## PM Modi likely to meet Elon Musk, Starlink's entry in India to be discussed

Prime Minister Narendra Modi will meet Elon Musk during his visit to the United States and Starlink's entry in the South Asian Market could be discussed during the meeting, Reuters reported, citing two people familiar with the plans.Mr. Musk is likely to hold a meeting with PM Modi and the Indian government expects these could include Starlink's plans to start satellite broadband services in In-

dia, according to the report citing two sources, who did not want to be named as the plans are private.Starlink wants to start operations in India. The Indian government has backed Mr. Musk's idea that spectrum should be assigned rather than auctioned. However, Starlink's licence application is still being reviewed."Musk is agreeable to give assurances on India security concerns, which includes storing data locally," one of the sources told Reuters.Earlier in December, Mr. Musk announced Starlink satellite internet was inactive in India after authorities seized two of the company's devices, one in an armed conflict zone and another in a drug smuggling bust, according to Reuters report. It was not clear whether Tesla's entry into India would come up for discussion between PM Modi and Musk, Reuters reported, citing sources. However, increased sourcing of electric vehicle components from India is likely to be discussed during the meeting.PM Modi is set to meet U.S. President Donald Trump during his two-day visit to the US. PM Modi is travelling to the US after concluding his three-day visit to France. This will be the first visit of Prime Minister Modi to the United States since the inauguration of the second presidential term of President Donald Trump.

# Kavitha demands separate Bills for BC reservations, accuses Congress of deception

#### **President's rule imposed in Manipur**

The Centre on Thursday (February 13, 2025) announced that President's rule has been implemented in Manipur, four days after CM N. Biren Singh's resignation on Sunday(February 9, 2025). A Union Home Ministry notification said that the Manipur Assembly has been put under suspended animation. Announcing the proclamation of the central rule, a notification issued by the Union Ministry of Home Affairs said President Droupadi Murmu is of the opinion that "a situation has arisen in which the government of that state cannot be carried on in accordance with the provisions of the Constitution".

"Now, therefore, in exercise of the powers conferred by Article 356 of the Constitution, and of all other powers enabling me in that behalf, I hereby proclaim that I - assume to myself as President of India all functions of the Government of the State of Manipur and all powers vested in or exercisable by the Governor of that State," the notification said. The announcement comes amid the BJP in Manipur continued to struggle to find a successor to Mr. Singh.Sambit Patra, the BJP's in-charge of Manipur, had met Manipur Governor Ajay Kumar Bhalla for the third time in as many days. However, there was no information from the Governor's office or the BJP on what transpired during their meeting for more than an hour. However, BJP legislator Karam Shyam had dismissed speculations about the imposition of the President's Rule. "Contrary to the hypotheses, there will be no constitutional crisis. We have reasons to believe our central leaders will resolve the matter in consultation with the party's State unit," the MLA representing the Langthabal constituency said.

Meanwhile, the Congress on Thursday (February 13, 2025) said Article 174 of the Constitution, which stipulates that there cannot be more than a six month gap between two Assembly sessions, has been "violated" in Manipur and alleged that this is a "deliberate contempt of the Constitution."Congress leader Jairam Ramesh said the breakdown of constitutional machinery in Manipur and the agony of the people of the State continues as they still await a visit by Prime Minister Narendra Modi "who goes everywhere but Manipur.""Article 174 of the Constitution of India states: 'The Governor shall from time to time summon the House or each House of the Legislature of the State to meet at such time and place as he thinks fit, but six months shall not intervene between its last sitting in one session and the date appointed for its first sitting in the next session'," Mr. Ramesh said on X."The Governor of Manipur had convened the Assembly session to begin on February 10, 2025 and a no-confidence motion submitted by the Congress was to be taken up," he pointed out. "The CM resigned the previ-



ous night and the session was later declared "null and void", Mr. Ramesh noted.Earlier in the day, Mr. Bhalla was briefed on the deployment and operational activities of the Central Reserve Police Force (CRPF) during a meeting with officials of the paramilitary force at the Raj Bhavan in Imphal.The outgoing Inspector General of the Manipur and Nagaland Sector, CRPF, Dr. Vipul Kumar, and the newly designated IG, Rajendra Narayan Dash, held a meeting with Mr. Bhalla, a statement said.

#### FM Sitharaman introduces new Income Tax Bill in Lok Sabha

New Delhi: Finance Minister Nirmala Sitharaman introduced the new Income Tax Bill, 2025, in the Lok Sabha on Thursday as part of the tax reforms to streamline and simplify the provisions so that they are easier to understand and reduce the scope for legal disputes.The legislation will replace the Income Tax Act, 1961, which has grown extensively due to numerous modifications carried out over six decades.

The Bill will be sent to the Select Committee of Parliament before it comes up for final approval in Parliament. The new law is expected to take effect on April 1, 2026. The first part of the Budget Session of Parliament also came to an end on Thursday and the second part of the session will resume on March 10. The Budget Session is being held in two parts – from January 31 to February 13 and between March 10 and April 4. The primary objective of the new Income Tax Bill is to simplify the tax laws, ensuring that they are more transparent, easier to interpret, and taxpayer-friendly.

### Harish Rao blames Congress for neglecting primary healthcare

Hyderabad: Former Minister and senior BRS MLA T Harish Rao criticised the Congress government for crippling the State's primary healthcare system and neglecting the poor. He blamed the government over its failure to support Palle and Basthi Dawakhanas, leaving underprivileged communities without basic medical services.

"The credit for opening these hospitals goes to the previous BRS government, while the current Congress government has turned public healthcare worse," he said, demanding immediate intervention from Chief Minister A Revanth Reddy and Health Minister Damodar Rajanarasimha to strengthen Palle and Basthi Dawakhanas and the Telangana Diagnostic Services.In a full throttle attack, Harish Rao pointed to the locked Keesara Health and Wellness Centre in Medchal Malkajgiri district as a glaring example of mismanagement. He questioned why the government was ignoring failing Basthi Dawakhanas across Hyderabad, Nizamabad, Adilabad, and Mahabubnagar districts.

"Out Patient services in these Palle Dawakhanas have drastically declined, while the Basthi Dawakhanas are being shut down depriving free primary healthcare to the poor and the needy under Congress rule," he said. The former Health Minister reminded that under former Chief Minister K Chandrashekhar Rao's leadership, Telangana's healthcare system was a national model, with over 500 Basthi and Palle Dawakhanas, as well as 134 free diagnostic tests through T-Diagnostics. However, these institutions were now struggling due to staff shortages, lack of medicines and mismanagement."Even after 14 months in power, the Congress government hasn't conducted a single review meeting on healthcare," he said, warning that the poor were now forced to pay at private hospitals. He accused the government of ignoring medicine shortages and failing to pay salaries on time, pushing Telangana's once-thriving public healthcare sector into crisis.

## Indian Chronicle English Daily Justice delayed

OVER four decades have passed, but for the vicims of the 1984 anti-Sikh riots, time has not dulled the vounds of injustice. The Supreme Court's remarks on Nonday guestioning the Delhi police's laxity in prosecutng cases — especially their failure to challenge acquittals - highlight a troubling reality: justice for the victims renains elusive. Out of the 650 registered cases, chargeheets were filed in only 362 cases, and convictions secured in a mere 39. The rest — more than 300 — resulted n acquittals, many unchallenged by the prosecution. The pex court's observation that "prosecution must be caried out seriously, not just for the sake of it" underscores a ecades-long pattern of neglect. When the Justice Dhingra Committee – which was set up following a PIL filed by ormer Shiromani Gurdwara Parbandhak Committee nember Gurlad Singh Kahlon — found in 2020 that several investigations had been derailed, there was a flicker of hope for accountability. Yet, even now, the appeals gainst acquittals seem more perfunctory than purposeful. For survivors, the trauma is not just about the orror they witnessed but also the systemic betrayal that ollowed. Statements given in court paint a grim picture – amilies torn apart, homes burned and a justice system hat remains indifferent. The Supreme Court's intervenion offers a chance to correct past wrongs, but will it amount o real action? The Delhi police's excuse of "lack of evience" after nearly four decades is an indictment of their wn inefficiency, if not complicity.

Justice cannot be an afterthought or a delayed fornality. The court's scrutiny must translate into concrete steps — proper legal representation, fresh investigations where needed, and, above all, an unwavering commitment o ensuring that the guilty do not walk free. Until then, the victims of 1984 will continue to wait for a closure that seems forever out of reach.

### Contractual workers of Navi Mumbai civic body to launch strike for equal pay, threatening essential services

Thousands of contractual workers in Navi Mumbai, employed by the Municipal Corporation (NMMC), are poised to launch an indefinite strike on February 10, demanding equal pay for equal work. Around 8,000 workers, covering vital services such as sanitation, water supply, and healthcare, argue that despite their efforts, wage disparities persist, with protests dating back months, including hunger strikes since December. The strike threatens to disrupt essential civic services, including sanitation, water supply, and healthcare. The workers have been protesting wage disparities for several months, with some participating in a hunger strike outside the municipal headquarters since December.

The strike, led by the Samaj Samata Kamgar Sangh union, emphasizes the urgency of wage parity across municipal departments. "We work across essential services, and if our demands are not heard, we will progressively cease operations," said Mangesh Lad, the union's secretary.NMMC, however, has refuted these claims, stating that it has consistently ensured fair wages, bonuses, provident fund contributions, and other statutory benefits



as per the Minimum Wages Act. The civic body also emphasized that it sought guidance from the Maharashtra government regarding wage parity for contractual workers, but no additional funds were allocated for this purpose by the state. Following this, the municipal commissioner appointed a special committee, led by an additional commissioner, to examine the legal and financial feasibility of the workers' demands. The committee's report, based on legal provisions and past court rulings, was shared with labour unions, which were then rejected by them. While NMMC continues talks with union leaders and has pledged to protect workers' rights, the union remains steadfast, escalating concerns over potential service disruptions.

### Toto driver arrested for New Town girl's rape and murder in 'den of anti-socials'

new town rape murder caseOn Saturday, police arrested Soumitra Roy, a 22-year-old Toto driver, in a Protection of Children from Sexual Offences (Pocso) Act case registered over the incident. A minor girl from Gouranganagar, New Town, near Kolkata, was found murdered early on Friday, around 6 km from her home, which she left after an argument with her mother and sister late on Thursday. Her body was discovered in a bush next to a canal, close to a premium housing complex. On Saturday, police arrested Soumitra Roy, a 22-year-old Toto driver, in a Protection of Children from Sexual Offences (Pocso) Act case registered over the incident.

According to police, they learnt after reviewing CCTV footage from several cameras that around 11.30 pm, the girl approached the three-wheeler driver, who agreed to drop her off after other passengers. The driver then drove around with the girl before taking her to an isolated location, where he allegedly assaulted her sexually around 12.30 am. When she attempted to scream, he allegedly strangled her and fled the scene.CCTV footage captured the girl walking nearly 2 km from her home before she was seen speaking to a biker who slowed down upon noticing her, the police said, adding that only the arrested accused was involved in the crime. Around 6.30 am on Friday, morning walkers discovered the girl's body with multiple bruises and scratch marks on a 1.7-acre plot owned by the West Bengal Infrastructure Development Finance Corporation. Although the area is secured by steel mesh, the police discovered a section that had been cut. Locals say the lack of lighting in the area contributes to numerous anti-social activities after dark.

Because the accused was not using a mobile phone, tracking him was challenging for the police. Eventually, they located his wife, who revealed that he was at the Kolkata Book Fair, leading to his arrest from there. It was only when it began to get late that the girl's mother raised an alarm and began searching for her daughter with neighbours. A missing-person report was filed at the New Town police station at 5.30 am on Friday. Within an hour, the police received a call about the body next to the canal. According to the police, the accused has confessed to the crime. They plan to request his custody for further investigation when he is presented in court.

### Men posing as 'CBI and RBI directors' dupe woman of Rs 95 lakh: Punjab police

The woman told the police that "the accused identified themselves as a CBI Director and an RBI Director to gain her trust."Following their instructions over the phone, the woman transferred large sums of money from her accounts. However, later she realised that she had been cheated and lodged a formal complaint," police said.

A police officer said the investigation into the case is in progress, and the account details and mobile numbers of the accused were being verified to trace them.Based on the complaint, an FIR was registered at the Cyber Crime police station, police said.Meanwhile, in another case of cheating, a retired Army officer was duped of Rs 10 lakh, police said. 'One seat doesn't matter; you give it to them'. So we gave them the seat with the candidate," he added. Thackeray later requested a meeting with Shah before a press conference, where they spoke privately for around 10 minutes. After this meeting, Fadnavis said, he spoke at press conferences as agreed to by both parties, but Thackeray later claimed at another press conference that "all their options were open". Almost a year after the NITB's inauguration, the wait is finally over, and the Digi Yatra service has been rolled out in the presence of Mohol, BJP Working President MLA Ravindra Chavan, State General Secretary Rajesh Pandey, and Pune Airport officials. The new terminal, inaugurated by Prime Minister Narendra Modi in March 2024, spans 22,000 square metres and has an annual passenger handling capacity of ten million. #### The lessons from a spectrum of areas

The 2004 tsunami affected a number of countries, making it a truly global disaster. There are six critical lessons we must consider. First, the importance of mangroves in providing natural protection to coastal areas - they serve as vital buffers against waves. Unfortunately, the significant destruction of mangroves in India and other countries to promote shrimp farming, meet basic wood and fuel needs, and for tourism - has disrupted the natural ecosystem. In many cases, the construction of artificial barriers (brick and mortar walls), may actually increase people's susceptibility to the damaging effects of waves.Social changesSecond, keeping common resources such as beaches in the public domain is crucial. In Thailand, the privatisation of coastlines during the 1980s and 1990s allowed private interests to develop hotels and leisure activities, displacing local communities. This led to significant changes in labour, including the rise of the sex industry. Additionally, a large section of the population transitioned to informal sector jobs. Thailand's economy became highly vulnerable to global fluctuations, and is a lesson for India.

Third, the tsunami created winners and losers in the market. Rents, the price of land, goods, and services all rose, benefiting only asset owners and service providers. The disruption of local markets led to the replacement of local products with externally sourced goods, disrupting interdependent local economies. A number of people transitioned from traditional livelihoods to casual, low-paid labour. The push for mechanised fishing became particularly noticeable, displacing traditional artisanal fishing practices using catamarans. The degradation of natural resources intensified, leading to over-fishing, waste accumulation, loss of fish breeding areas, and further erosion of beaches and soil. Addressing these economic processes of production, consumption, and exchange - aggravated by privatisation and liberalisation — is a challenge. Unfortunately, no studies exist to measure these patternsA worsening of inequalitiesFourth, there are lessons to be learned about relief efforts and long-term rehabilitation. It is not surprising that the social structures that create and sustain discrimination, injustice, and exclusion in society continue doing so during and after disasters. In a highly stratified society such as India, relief and rehabilitation efforts can often reinforce and even exacerbate pre-existing inequalities, discrimination, and marginalisation. Evidence from tsunamiaffected countries suggests that social divisions significantly affected access to relief and rehabilitation services. There was a notable tendency to overlook the needs of vulnerable groups, including labourers, Dalits, tribes, immigrants, ethnic minorities, widows, and single women, in the distribution of relief and rehabilitation unless some vocal groups advocated their cause. In Thailand, undocumented Burmese or Lao migrants, many of whom suffered serious injuries and required urgent medical attention, had to go into hiding to avoid arrest. In Sri Lanka, Tamil minorities in the east and northern regions received significantly less assistance despite suffering much greater devastation. Furthermore, asset-based damage assessment tended to favour betteroff segments of the affected. Within India's fishing community, labourers engaged in fishing, retail businesses, and ancillary activities continued to suffer until fishing activity resumed but received little compensation. In some communities, the relief provided barely met basic subsistence needs, while others experienced excessive aid.

Fifth, gender-insensitive relief and rehabilitation policies often accentuated the vulnerability of women. In Indian fishing communities, women are typically involved in activities related to the processing and marketing of fish or in non-fishing jobs such as collecting shells or running food stalls. They rarely own property or assets in their name. During the relief and rehabilitation, in many cases, their livelihood needs were overlooked. Relief and rehabilitation packages were distributed based on lists of affected persons prepared by the fish worker panchayats, leading to women lacking access to relief measures. Widows from fish worker communities faced difficulties in receiving assistance, as they did not possess identity cards issued by the Fisheries Department. The important takeaway is that social divisions must be carefully addressed at every stage of relief and rehabilitation. Engagement with local structuresSixth, it is crucial for relief agencies to respect community-based local institutions, especially in coastal communities where organisation revolves around the concept of commons. Unlike agrarian or urban areas, democratic practices in fishing communities, such as kuppams. rely on active debate rather than elections. The tsunami revealed that outside agencies often imposed their own notions of democracy, which undermined local capacities and resilience by fostering individualism and dependence. While issues such as gender insensitivity exist within these communities, a critical and long-term engagement with local structures would be more effective in addressing these concerns rather than demonising them. # Sweeping policy decisions, controversies that reshaped India's education sector in 2024

India's education sector witnessed a year of major changes in 2024, marked by sweeping policy decisions, controversies, and efforts to streamline processes. From the Union Cabinet's ambitious 'One Nation One Subscription' initiative to reforms in the structure of national entrance exams, these developments reflect a transformative phase for the nation's education ecosystem. Here's a look at the major events that defined this year: In a move set to revolutionise access to academic resources, the Union Cabinet approved a budgetary allocation of Rs 6,000 crore for the 'One Nation One Subscription' (ONOS) scheme. Aimed at centralising journal subscriptions for nearly 6,300 government-run higher education institutions (HEIs), the initiative promises equitable access to 13,000 scholarly journals under a single platform. Currently, HEIs rely on fragmented library consortia, such as the UGC-Infonet Digital Library Consortium managed by the INFLIBNET Centre in Gandhinagar. This disaggregated approach often creates barriers to accessing vital academic material. Set to launch on January 1, 2025, ONOS will consolidate journal access for state and central government institutions, fostering a uniform academic environment. By simplifying access to critical resources, the scheme aspires to elevate research output and academic excellence across India. The year's most contentious issue arose from allegations of irregularities during the National Eligibility cum Entrance Test (Undergraduate) (NEET-UG), the gateway to India's medical colleges. Held on May 5, the examination was marred by claims of question paper leaks and malpractice. Social media was rife with accusations, prompting swift denials from the National Testing Agency (NTA). However, arrests in Bihar and Gujarat corroborated concerns. In Bihar, 13 individuals, including four examinees, were detained for allegedly paying exorbitant sums to access the question paper in advance. Meanwhile, a raid in Godhra uncovered a

teacher facilitating cheating at an exam centre, leading to multiple arrests and a subsequent CBI investigation. The controversy deepened when the NTA's decision to award grace marks to 1,563 students sparked criticism. Although Union Education Minister Dharmendra Pradhan dismissed allegations of corruption, the incident raised questions about the integrity of national examinations.CUET revamp: Streamlining admissionsAnother major reform came in the form of changes to the Common University Entrance Test (CUET) for undergraduate admissions. Responding to feedback and logistical challenges from previous years, the University Grants Commission (UGC) announced that the 2025 CUET-UG will be entirely computer-based. Additionally, the number of subjects offered will be reduced from 63 to 37, with admissions for dropped subjects relying on a General Aptitude Test (GAT).

"We aim to provide a more efficient and student-friendly examination process," said UGC Chairperson M Jagadesh Kumar. An expert panel's recommendations, which addressed test structure, duration, syllabus alignment, and operational logistics, shaped these changes. The reforms reflect an effort to ensure fairness and accessibility in university admissions, streamlining the process for millions of aspirants.JNU's admission exam debateJawaharlal Nehru University (JNU) faced its own challenges this year. After the UGC National Eligibility Test (NET) was cancelled in June over concerns about compromised integrity, JNU proposed a return to in-house PhD entrance exams. However, the plan has stalled due to a lack of consensus among school deans and faculty members. While faculty claim they submitted written feedback over a month ago, university officials state no formal responses have been received. This impasse underscores the broader uncertainty surrounding PhD admissions in the wake of the cancellation of NET, which had long served as a critical qualifier for teaching and research positions. Scrapping the no-detention policyIn a landmark decision, the Central government scrapped the no-detention policy for students in classes 5 and 8 in schools under its jurisdiction. This policy reversal impacts approximately 3,000 institutions, including Kendriya Vidyalayas, Jawahar Navodaya Vidyalayas, Sainik Schools, and Eklavya Model Residential Schools (EMRs). The move follows a 2019 amendment to the Right to Education Act, 2009 which allowed states and Union Territories to decide on retaining students in these grades. With 18 states and UTs having already abolished the no-detention policy, the Ministry of Education's recent notification aligns Central schools with this trend. Proponents argue that the decision will improve academic rigor and accountability, though critics warn it may exacerbate dropout rates.

On Tuesday, the Crime Branch arrested Arvind Vyas, a resident of Lunva village in Mehsana district, for an alleged theft of 31 motorcycles, amounting to Rs 6.85 lakh in 29 cases registered across police stations in the city. According to the police, Vyas has more than 50 previous cases of vehicle theft against him in Ahmedabad, Palanpur, Surat, Dahod, and Godhra.He added that police "successfully detected all 29 cases of murder" that took place in the city, ncluding one of a senior citizen in Tarsali earlier this year. in which the "culprit" was arrested within 48 hours. Komar said, "The case of gang rape, which occurred (on the outskirts) during Navratri and was technically under Vadodara Rural police, was also successfully detected by the city crime branch as a part of inter-district coordination as is our duty."The city had not registered a single case of dacoity in 2024. "Out of the total 16 cases of robbery, all have been detected and eight were detected by the Crime Branch, including one big heist in October 2024, during the rumour mongering about thieves attacking... We also registered 43 cases of chain snatching, of which 37 have been detected, which is an 87 percent detection rate and the highest success in the state this year," Komar said. The city police have also detected 90 of the 236 cases of house break-ins and nabbed 168 offenders who jumped parole and furlough, including a murder convict, who was on the run for over seven years, Komar said. Komar added that four accused nabbed had been on the run for 18, 20, 21 and 23 years, respectively.

### How Mumbai police traced autorickshaw driver and recovered jewellery worth lakhs left behind by passenger

The Mumbai police Monday traced an auto-rickshaw driver and recovered 250 gram of gold and silver jewellery belonging to a woman who forgot the items in the vehicle on December 20. According to the police, the woman reported the incident at the Bangur Nagar Police Station in Goregaon, saving she had forgotten her bag containing her jewellery in the auto-rickshaw.The Bangur Nagar police handed the jewellery to Brinda Rai, 48, Monday. "The woman and her family were planning to travel to Gujarat for a wedding. She had retrieved the jewellery from her bank's safe and was taking it home. To ensure its safety, the woman kept the bag full of jewellery in the vacant area behind her seat," said a police officer. The police said they analysed footage from more than 100 CCTV cameras and conducted inquiries with several passengers to trace the driver plying at Poisar in Borivali. "It occurred late at night and due to the high beam of lights on the rickshaw, it posed difficulty in tracing the driver. We went through over 100 CCTV cameras in the vicinity because the registration number was not easily discernible from the footage," said the officer."While the case was originally registered as a lost property incident, we treated it as a serious crime, dedicating significant time and resources to ensuring the woman's

### Pune to have 4,000 women-driven autorickshaws in 2025 under pink e-rickshaw scheme

Pune could see as many as 4,000 pink erickshaws on its roads in 2025 under a scheme implemented by Maharashtra's women and child development department. So far, 566 women have applied for the scheme and 353 of the applications have been approved.

The Government has an objective of introducing 10,000 women-driven electric autorickshaws across the state, with 1,400 initially allocated to Pune. Manisha Biraris, district women and child development officer, said the number of beneficiaries in Pune was increased first to 2,800 and later to 4,000. Nevertheless, she clarified that the overall statewide target remains unchanged at 10,000 beneficiaries.

Biraris said the scheme aims to uplift women drivers and empower them economically. "The pink e-rickshaw scheme has been introduced to promote employment op-

portunities for women, enabling them to become self-reliant and independent. Earlier, Pune's allocation was 1,400 e-rickshaws, but now it has been revised to 4,000. We will do our best to recruit all eligible beneficiaries this year," she said.Biraris explained that there will be no educational requirements to apply for the scheme. However, the department has revised the eligibility age from 18-35 to 20-40 to provide educational opportunities to women who do not complete their studies by the age of 18.Applicants must also have a valid driving licence and a family income not exceeding Rs 3 lakh per annum. They must be domiciled in the state. Documents such as Ladki Bahin Yojana certificates, birth certificates, school certificates, and ration cards will be considered for this purpose.Biraris said many applications are now coming from women in their late 30s. The beneficiaries will have to bear only 10 per cent of the cost of the e-rickshaws initially. The state government will cover 20 per cent of the cost, while the remaining 70 per cent will be financed through a government-facilitated loan that beneficiaries must repay within five years.

Additionally, the commissioners of the Pune and Pimpri-Chinchwad municipal corporations are invited to be part of the initiative. "We urge more women to apply. Some motorists were asked to walk, coordinating the front toe and heel on the white divider strips on the street.

Deputy Commissioner of Police Zone 2 Abhay Soni, told The Indian Express, "The FST is an accepted primary test to detect a drunk or intoxicated state in motorists, even if blood levels are low and the breath analysers are unable to detect the intoxication. In the West, it is an accepted test and even admissible in a court of law. But, in India, we use it for a preliminary exam and then proceed for blood tests to gather evidence."Soni added that while the motorists in Vadodara were asked to walk in foot coordination on the white dividing lines, other tests include the horizontal gaze test, which involves asking the drivers to watch objects move slowly from side to side. Soni said that while the police teams did not find any suspected cases on Tuesday, the sobriety tests could come in handy to find offenders under the prohibition law or NDPS during the New Year's deployment.

### Mancherial collector says efforts on to control illegal mining, transportation of sand

Mancherial: Collector Kumar Deepak said that steps were being taken to strictly control illegal mining and transportation of sand. He addressed the media persons here on Tuesday.

### **On India's international obligations** towards Rohingya refugees | Explained

The story so far: A recent study examining the plight of Rohingya refugees detained in India, conducted jointly by The Azadi Project, a U.S.-registered non-profit, and Refugees International, an American organisation advocating for displaced populations, has highlighted "gross violations of constitutional and human rights" and criticised India's "failure to uphold its obligations under international human rights treaties." Based on interviews with detainees, their families, and legal representatives, the report reveals that "a significant number of Rohingya refugees continue to be incarcerated even after serving their prescribed sentences."

How are Rohingya refugees protected under international law?

The Rohingya of Myanmar constitute the world's largest stateless population, estimated to number approximately 2.8 million. Denied citizenship and subjected to decades of persecution by Myanmar's military authorities, the majority of the Rohingya have been compelled to flee their homeland due to genocidal violence. At present, they are dispersed across multiple countries. According to the United Nations High Commissioner for Refugees (UNHCR), nearly 22,500 Rohingya refugees currently reside in India. The 1951 Refugee Convention and its 1967 Protocol enshrine the principle of non-refoulement, which prohibits states from expelling individuals under their jurisdiction when substantial evidence suggests they would face persecution, torture, or other severe human rights violations upon return. This principle is a cornerstone of human rights, humanitarian, and refugee law. Moreover, its status as customary international law imposes binding obligations on states regardless of formal assent. The Office of the United Nations High Commissioner for Human Rights has reiterated that "the principle is characterized by its absolute nature without any exception". Additionally, in a 2007 advisory opinion, the UNHCR affirmed that non-refoulement constitutes customary law and is binding on all states, including those not parties to the Refugee Convention or the 1967 Protocol.

#### What is India's stand?

As India is neither a signatory to the Refugee Convention nor a party to key international instruments such as the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment and the International Convention for the Protection of All Persons from Enforced Disappearance, it maintains that it bears no legal obligation to provide asylum or adhere to the principle of nonrefoulment. India continues to detain Rohingya refugees under archaic domestic legal frameworks, notably the Foreigners Act, 1946, and the Passport Act, 1967. These legislations confer sweeping executive powers to regulate the presence of foreigners and enable authorities to categorise Rohingya refugees as "illegal migrants."In response to a public interest litigation (PIL) in the Supreme Court seeking the release of detained Rohingya refugees, the Union government clarified in March that while they are entitled to the right to life under Article 21 of the Constitution, they do not possess the right to reside or settle in India. In 2021, the top court in Mohammad Salimullah and Anr. v. Union of India, rejected a plea to prevent the deportation of 170 Rohingya refugees detained in Srinagar accepting the Centre's national security concerns. In October 2024, the Delhi High Court dismissed a PIL seeking directions to the authorities to admit Rohingya refugee children in local schools. The court noted that the matter involved international implications and required a policy decision to be taken by the Union government.

What are India's international obligations?

The International Covenant on Civil and Political Rights, to which India is a party, implicitly obligates member states under Article 7 to refrain from refouling individuals to places where they may face torture or cruel, inhuman, or degrading treatment. The U.N. Human Rights Committee has unequivocally affirmed this interpretation. Similarly, the principle of non-refoulement is enshrined in other significant international instruments, including the International Convention on the Elimination of All Forms of Racial Discrimination and the Convention on the Rights of the Child, both of which India has ratified.Further, the Convention Against Torture makes an express mention of non-refoulement under Article 3. While India's position as a signatory but not a ratifier renders its provisions non-binding, any deviation from the convention's principles would compromise the commitment India demonstrated by signing the treaty. Although India lacks a domestic refugee law, the Supreme Court in landmark rulings such as Vishaka & Ors. v. State of Rajasthan (1997) and National Legal Services Authority v. Union of India (2014), has affirmed that in the absence of domestic legislation on a matter, international conventions and norms must be applied by municipal courts to ensure the dignity of human life. Additionally, Article 51(c) of the Constitution mandates that the State must strive to promote respect for international law and treaty obligations. Several High Courts in India have also interpreted the principle of non-refoulement as integral to Article 21 of the Constitution, which guarantees the right to life and personal liberty. Notable examples include the Gujarat High Court's decision in Ktaer Abbas Habib Al Qutaifi v. Union of India (1998) and the Delhi High Court's ruling in Dongh Lian Kham v. Union of India (2015), both of which involved refugees from different countries seeking protection from deportation.

#### What are the existing concerns?

The absence of a standardised refugee policy has led to disparate treatment of different refugee populations, driven by India's shifting geopolitical and diplomatic interests. While groups such as Tibetans, Sri Lankans, and Afghans are granted refugee certificates or long-term visas by the government, most Rohingya refugees -despite being registered with the UNHCR - often face arbitrary detention and criminal imprisonment. Further, the controversial Citizenship Amendment Act, 2019, excludes persecuted Muslim minorities, such as the Rohingya, from its ambit. The lack of legal representation and aid for detained Rohingya refugees also poses a severe concern. The report by Azadi Project and Refugees International highlights that civil society organisations working on behalf of Rohingya refugees in India are starved of funding as most Foreign Contribution (Regulation) Act (FCRA) licenses that allow for the receipt of foreign funding have been revoked. This has made lawyers reluctant to take on cases involving the Rohingya, fearing unfavourable outcomes and potential repercussions. Moreover, detention centres housing Rohingya refugees, including pregnant women and children, are plagued by dehumanising living conditions. In light of the appalling conditions at the Matia Transit Camp, the Supreme Court in October, directed the Assam State Legal Services to conduct surprise visits and evaluate the conditions in which the refugees are living

### IMD issues orange alert for fog and cold wave in 22 districts of Punjab and Haryana; visibility likely to be down to zero


The India Meteorological Department (IMD) has issued an orange alert for fog and cold wave in 22 districts of Punjab and Haryana for Monday due to an ongoing cyclone circulation in the region. Visibility could be severely affected, with some areas potentially experiencing fog so thick that visibility may drop to zero, as per the weather department.IMD Chandigarh reported that the impact of ongoing snowfall in the mountains will extend to Punjab and Chandigarh, leading to a significant drop in temperatures across the region. Some of the Punjab and Haryana districts where orange alert has been issued are as follows: PunjabMeanwhile, due to fog, a yellow alert has been issued for the rest of the 23 districts of the states and their joint capital, Chandigarh.

According to the weather department, these conditions are expected to persist until January 3, with temperatures in Punjab potentially dropping to 3 degrees Celsius over the next five days. However, Chandigarh is unlikely to see drastic temperature changes. In the last few days, rain was reported in several areas of Punjab, Haryana, and Chandigarh. Two western disturbances are expected to impact the region between January 1 and January 6. These disturbances will bring rain to the western Himalayan range and may also extend to Jammu and Kashmir, Himachal Pradesh, and the plains. As a result, temperatures in Punjab and Chandigarh are likely to drop again. In Haryana, the aver-



age maximum temperature fell by 1.2 degrees on Sunday However, this was still appreciably below normal by 4.5 degrees. The highest maximum temperature recorded in the state on Sunday was 22.5 degrees Celsius.On Sunday, the average maximum temperature in Punjab rose by 2 degrees, but it remained 2.3 degrees below normal. The highest maximum temperature recorded in the state was 21.3 degrees Celsius at Sri Anandpur Sahib. The meteorological department has urged the public to stay updated with weather warnings and advisories. It advised them to take necessary precautions, especially while travelling, due to the reduced visibility caused by dense fog.

I also had the chance to see K Lal and his 'maya jaal' (web of illusion), another celebrated magician who left audiences spellbound. Both Sorcar and Lal earned not just fame but respect as true craftsmen of magic.

## sprawling Vidhan Sabha complex in Tapovan

Efforts are underway to make the sprawling Himachal Pradesh Vidhan Sabha, covering approximately 35,000 square feet in the foothills of the Dhauladhar range at picturesque Tapovan, more accessible and economically viable. Authorities are exploring various options, including the opening of a museum, a cafeteria, and a residential complex. The residential complex would be available for use by legislators during the annual winter session and by the general public for the rest of the year, a senior officer privy to the development said. As per the proposal, the cafeteria and residential complex are planned outside the Vidhan Sabha premises near Gate Number 2, while the museum, showcasing the rich heritage of the hill state, will be located inside the Vidhan Sabha grounds. The state assembly is situated adjacent to Swami Chinmayananda's Chinmaya Tapovan Ashram, a renowned destination for inner peace seekers from across the globe.

Constructed and inaugurated in February 2006, the assembly has hosted 18 winter sessions since then. The first assembly session in Dharamshala was held at Prayas Bhawan, Government College, in 2005. The most recent session was held from December 18 to December 21."All new constructions, except for the museum near Gate Number 1, will be outside the Vidhan Sabha premises. A nominal fee will be charged for visitors to enter the museum. Currently, visitors, including school students, NCC cadets, private individuals, and tourists, are allowed to visit the Vidhan Sabha premises at Tapovan free of cost. The residential complex, designed like hotels, will address accommodation issues faced by legislators and government officials during the winter session. Unlike the Vidhan Sabha in



Shimla, there are no residential facilities for legislators here who stay in government guest houses or private hotels at the state's expense," a senior official privy to the development The officer further stated, "A letter from the Vidhan Sabha Secretariat has been sent to the district administration in Kangra to transfer the required revenue land. A committee under the supervision of Additional District Magistrate (ADM) Harish Gajju has been formed to complete the groundwork." On December 22, Vidhan Sabha Speaker Kuldeep Singh Pathania, along with Kangra Deputy Commissioner Hemrai Bairwa, ADM Harish Gajju, and other district officials, inspected the proposed sites for the new facilities. Yashpal Sharma, Secretary, Vidhan Sabha, said, "The assembly at Tapovan is a vast area, and we aim to use it constructively while maintaining its sanctity. The local district administration has also provided suggestions for its development. Plans for a cafeteria and residential complex for legislators are under consideration. However, we want to proceed cautiously and not rush into decisions.'

### **Government Railway Police recovers 870 stolen** mobile phones, seizes Rs 3.4 cr in property in 2024

GNS News Agency, Feb 13Hyderabad: The Government Railway Police (GRP) have traced a total of 870 mobile phones and handed them over to their owners in 2024. The gadgets which were either lost or stolen were traced using the Central Equipment Identity Register (CEIR) portal

During this year, a total of 901 cases were reported, of which only 142 cases were solved by arresting 121 offenders and recovering Rs 37.1 lakh worth valuables.Speaking at the annual press meet, GRP Superintendent of Police, Chandana Deepthi on Monday said during this year, 56 drug related cases were registered, of which 38 were solved and 53 drug suspects were arrested. A total of 1194.3 kgs of marijuana worth Rs 2.9 crore was seized.

Officials said total worth of Rs 3.4 crore worth property was lost and Rs 37 lakh worth property was recovered, with a recovery percentage of 10.81 per cent.Apart from this, the GRP teams rescued as many as 84 children including 25 girls from the railway premises as part of Operation Smile and Muskaan in 2024."The children were handed over to the Child Welfare authorities for their safe custody and reuniting them with their parents. In this regard, cases were booked at the GRP Hyderabad and Warangal," Chandana Deepthi said.

### South Korean president faces impeachment after martial law debacle



SEOUL, GNS News Agency, Feb 13 South Korean lawmakers submitted a bill on Wednesday to impeach President Yoon Suk Yeol after he declared martial law and reversed the move hours later, triggering a political crisis in Asia's fourth-largest economy. The surprise declaration of martial law in the major U.S. ally late on Tuesday caused a standoff with parliament, which rejected Yoon's attempt to ban political activity and censor the media, as armed troops forced their way into the National Assembly building in Seoul.

The main opposition Democratic Party (DP) called for Yoon, who has been in office since 2022, to resign or face impeachment.Six South Korean opposition parties later submitted a bill in parliament to impeach Yoon, with voting set for Friday or Saturday."We couldn't ignore the illegal martial law," DP lawmaker Kim Yong-min told reporters. "We can no longer let democracy collapse."There were deep divisions in Yoon's ruling People Power Party as well, as its leader called for Defence Minister Kim Yong-hyun to be fired and the entire cabinet to resign. Kim has offered to resign, the defence ministry said. Yoon told the nation in a television speech late on Tuesday that martial law was needed to defend the country from pro-North Korean antistate forces, and protect the free constitutional order, although he cited no specific threats.

Chaotic scenes ensued as troops tried to seize control of the parliament building, although they stood back when parliamentary aides sprayed them with fire extinguishers while protesters scuffled with police outside. The military said activities by parliament and political parties would be banned, and that media and publishers would be under the control of the martial law command. But lawmakers defied the security cordon and within hours of the declaration, South Korea's parliament, with 190 of its 300 members present, unanimously passed a motion for martial law be lifted, with 18 members of Yoon's party present. The president then rescinded the declaration of martial law, just about six hours after its proclamation.

Protesters outside the National Assembly shouted and clapped. "We won!" they chanted, and one demonstrator banged on a drum. "There are opinions that it was too much to go to emergency martial law, and that we did not follow the procedures for emergency martial law, but it was done strictly within the constitutional framework," a South Korean presidential official told Reuters by telephone. There has been no reaction yet from North Korea to the drama in the South.Despite the overnight drama, Seoul appeared normal on Wednesday, with the usual morning rush hour traffic in trains and on the streets. However, more protests were expected with South Korea's largest union coalition, the Korean Confederation of Trade Unions, planning to hold a rally in Seoul and vowing to strike until Yoon resigns. The U.S. embassy urged citizens in South Korea to avoid areas where protests were taking place, while some major employers, including Naver Corp

falling about 1.3% and the won stable but close to a two-year low. Dealers reported suspected intervention by South Korean authorities to stem the won's slide.Finance Minister Choi Sang-mok and Bank of Korea Governor Rhee Chang-yong held emergency meetings overnight and the finance ministry promised to prop up markets if needed.

Sales of canned goods, instant noodles and bottled water had soared overnight, said a major South Korean convenience store chain, which sought anonymity."I'm deeply disturbed by this kind of situation, and I'm very concerned about the future of the country," 39-yearold Seoul resident Kim Byeong-In told The National Assembly can impeach the president if more than two-thirds of lawmakers vote in favour. A trial by the constitutional court follows, which can confirm the motion with a vote by six of the nine justices. If Yoon resigned or was removed from office, Prime Minister Han Duck-soo would fill in as leader until a new election was held within 60 days.

"South Korea as a nation dodged a bullet, but President Yoon may have shot himself in the foot," Danny Russel, vice president of the Asia Society Policy Institute think tank in the United States, said of the first martial law declaration in South Korea since 1980.U.S. Secretary of State Antony Blinken said he welcomed Yoon's decision to rescind the martial law declaration.

"We continue to expect political disagreements to be resolved peacefully and in accordance with the rule of law," Blinken said in a statement. South Korea hosts about 28,500 American troops as a legacy of the 1950-1953 Korean War.Planned defence talks and a joint military exercise between the two allies were postponed amid the broader diplomatic fallout from the overnight turmoil.South Korea's political situation is an "internal matter" for the country. China's Foreign Minister Wang Yi told reporters.Sweden's prime minister postponed a visit to South Korea, a spokesperson said, and Japan's lawmaker group on Korean affairs cancelled a trip to Seoul set for mid-December.NATO Secretary General Mark Rutte said the alliance was monitoring the current situation in South Korea, but added that its relationship with Seoul "was ironclad". Russia said it was following the "tragic" events in South Korea with concern. Yoon, a career prosecutor, squeezed out a victory in the tightest presidential election in South Korean history in 2022, riding a wave of discontent over economic policy, scandals and gender wars.But he has been unpopular, with his support ratings hovering at around 20% for months. His People Power Party suffered a landslide defeat at a parliamentary election in April this year, failing to wrest control from opposition parties that captured nearly two-thirds of the seats. There have been more than a dozen instances of martial law being declared since South Korea was established as a republic in 1948.In 1980, a group of military officers forced then-President Choi Kyu-hah to proclaim martial law to crush calls for the restoration of democratic government. ## World Food Program's troubles in Sudan hurt hunger relief, alienated donors - internal report



NAIROBI, GNS News Agency, Feb 13Serious problems in the United Nations World Food Program's response to the Sudan crisis are hampering the organization's ability to alleviate hunger in the war-torn country and damaging its reputation with donors, according to a recent internal report seenThe U.N.'s main food-aid distributor, the WFP is struggling to feed millions of people in the African country, which is suffering one of the world's worst hunger crises. The report identifies a range of problems in the WFP's Sudan response, including an inability to scale up its operations, missed funding opportunities and what it describes as "antifraud challenges."

The report is the result of an assessment in July and August by the WFP's Regional Emergency Coordination (REC) team, which was tasked with helping to expand the U.N. body's operations in Sudan and neighboring countries. The team's findings are detailed in a five-page "REC Diagnostic Report," marked confidential and dated August 30. The report calls Sudan the WFP's largest emergency.News of the report comes as the WFP is struggling to secure billions of dollars for hunger hot spots around the world and is battling a crisis of confidence among the United States and other top donors. In Sudan, roughly half the population of 50 million is estimated to be suffering from severe hunger amid the civil war that has ravaged the country since April 2023. Hundreds are believed to be dying from starvation and hunger-related disease each day."WFP's reputation for rapid emergency response has been damaged," the report says of its Sudan operation. "Key stakeholders, including key donors, are now demanding concrete progress before committing additional funding."Asked about the report, WFP Deputy Executive Director Carl Skau didn't address its specifics but told Reuters that the WFP and other humanitarian agencies weren't prepared for the sudden crisis in Sudan. "It took us too long to actually get back on our feet and deliver in an effective and efficient and principled way," Skau said in an interview in Cairo on Monday. "I'm confident the WFP is there now and that we are doing everything possible.

## Ukraine gives absconding soldiers second chance as forces dwindle

KYIV, GNS News Agency, Feb 13As Ukraine's military struggles to find enough troops, particularly infantry, to hold off Russia's much larger army, some units are giving a second chance to those who have absconded from service.Data from the prosecutor's office shows nearly 95,000 criminal cases have been opened since 2022 against soldiers going "absent without leave" (AWOL) and for the more serious crime of battlefield desertion.The number of cases has risen steeply with each year of the war: almost two-thirds of the total are from 2024. With many tens of thousands of troops killed or wounded, it is a depletion that Ukraine can ill afford.A bar graph showing a more than six-



WASHINGTON, GNS News Agency, Feb 13Advisers to Donald Trump publicly and privately are floating proposals to end the Ukraine war that would cede large parts of the country to Russia for the foreseeable future, according to a Reuters analysis of their statements and interviews with several people close to the U.S. president-elect. The proposals by three key advisers, including Trump's incoming Russia-Ukraine envoy, retired Army Lieutenant-General Keith Kellogg, share some elements, including taking NATO membership for Ukraine off the table. Trump's advisers would try forcing Moscow and Kyiv into negotiations with carrots and sticks, including halting military aid to Kyiv unless it agrees to talk but boosting assistance if Russian President Vladimir Putin refuses. Trump repeatedly pledged during his election campaign to end the nearly three-yearold conflict within 24 hours of his Jan. 20 inauguration, if not before then, but has yet to say how. Analysts and former national security officials voice grave doubts Trump can fulfill such a pledge because of the conflict's complexity. Taken together, however, his advisers' statements suggest the potential contours of a Trump peace plan. Ukrainian President Volodymyr Zelenskiy, facing manpower shortages and growing territorial losses, has indicated that he may be open to negotiations. While still intent on NATO membership, he said this week that Ukraine must find diplomatic solutions to regaining some of its occupied territories.But Trump may find Putin unwilling to engage, analysts and former U.S. officials said, as he has the Ukrainians on the back foot and may have more to gain by pursuing further land grabs."Putin is in no hurry," said Eugene Rumer, a former top U.S. intelligence analyst on Russia now with the Carnegie Endowment for International Peace think tank. The Russian leader, he said, shows no readiness to drop his conditions for a truce and talks, including Ukraine abandoning its NATO guest and surrendering the four provinces Putin claims as part of Russia but does not fully control, a demand rejected by Kyiv.Putin, Rumer said, likely will bide his time, take more ground and wait to see what, if any, concessions Trump may offer to lure him to the negotiating table.Reuters reported in May that Putin was ready to halt the war with a negotiated ceasefire that recognized current front lines but was ready to fight on if Kyiv and the West did not respond. Russia already controls all of Crimea, having unilaterally seized it from Ukraine in 2014 and has since taken about 80% of the Donbas - which is comprised of Donetsk and Luhansk - as well as more than 70% of Zaporizhzhia and Kherson, and small parts of the Mykolaiv and Kharkiv regions. As of last week, Trump had yet to convene a central working group to flesh out a peace plan, according to four advisers who requested anonymity to describe private deliberations. Rather, several advisers have pitched ideas among themselves in public forums and - in some cases - to Trump, they said.Ultimately, a peace agreement will likely depend on direct personal engagement between Trump, Putin and Zelenskiy, the advisers said.Kremlin spokesman Dmitry Peskov said it was "not possible to comment on individual statements without having an idea of the plan as a



whole."Trump spokesperson Karoline Leavitt noted that Trump has said he "will do what is necessary to restore peace and rebuild American strength and deterrence on the world stage." A Trump representative did not immediately respond to a follow-up question about whether the president-elect still plans to resolve the conflict within a day of taking office. The Ukrainian government did not immediately respond to a request for comment. One former Trump national security official involved in the transition said there are three main proposals: the outline by Kellogg, one from Vice President-elect JD Vance and another advanced by Richard Grenell, Trump's former acting intelligence chief.Kellogg's plan, co-authored with former National Security Council official Fred Fleitz and presented to Trump earlier this year, calls for freezing the current battle lines. Trump would supply more U.S. weapons to Kyiv only if it agreed to peace talks. At the same time, he would warn Moscow that he would increase U.S. aid to Ukraine if Russia rejected negotiations. NATO membership for Ukraine would be put on hold.Ukraine also would be offered U.S. security guarantees, which could include boosting weapons supplies after an accord is struck, according to that proposal. In a June interview with Times Radio, a British digital station, Sebastian Gorka, one of Trump's incoming deputy national security advisers, said Trump had told him he would force Putin into talks by threatening unprecedented weapons shipments to Ukraine if Putin refused.Gorka, reached by phone, called Reuters "fake news garbage" and declined to elaborate.Vance, who as a U.S. senator has opposed aid to Ukraine, floated a separate idea in September.He told U.S. podcaster Shawn Ryan that a deal likely would include a demilitarized zone at the existing front lines that would be "heavily fortified" to prevent further Russian incursions. His proposal would deny NATO membership to Kyiv.Representatives for Vance did not make him available for comment, and he has yet to offer additional details.Grenell, Trump's former ambassador to Germany, advocated the creation of "autonomous zones" in eastern Ukraine during a Bloomberg roundtable in July but did not elaborate. He also suggested NATO membership for Ukraine was not in America's interest.

Now, some units are replenishing their ranks by accepting soldiers previously declared AWOL.One of them is Ukraine's elite 47th Brigade, which published a social media post last month inviting soldiers who had absconded to join."Our aim is to give every soldier the opportunity to come back into the fold and realise his potential," the post announced. In the first two days, the brigade said, over a hundred applications came in."There was a tsunami of applications; so many that we still aren't able to process them all before new ones come in," Viacheslav Smirnov, the 47th's head of recruitment, said two weeks after the announcement. Two military units Reuters spoke to said they were only recruiting soldiers who had gone AWOL from their bases, rather than those who had deserted from combat. The former is seen within the Ukrainian military as a lesser offence. A bill recently signed into law has in effect decriminalised a soldier's first disappearance, allowing them to return to service.

THOUSANDS OF UKRAINIAN SOLDIERS REJOIN AFTER ABSCONDINGColonel Oleksandr Hrynchuk, deputy head of Ukraine's military police, told reporters on Tuesday that 6,000 AWOL soldiers had returned to service in the last month, including 3,000 in the 72 hours since the law was signed.Mykhailo Perets, an officer from the K-2 battalion of Ukraine's 54th Brigade, said his battalion had already hired over 30 men who had gone AWOL from other units."The reasons [for absconding] are very different: for

some people it was too tough a transition straight from civilian life, others served for a year or two as gualified [drone] pilots but were then sent to the front line because there wasn't enough infantry."Perets said those who had applied also included men who had become exhausted and run away after being at war for seven or eight years, having fought Russian-backed forces in eastern Ukraine before 2022.Gil Barndollar, a non-resident fellow at the U.S.-based Defense Priorities think tank, said the increase in unauthorised absences was most likely driven by exhaustion.Ukrainian service personnel have previously said how the lack of replacements for lost soldiers puts an unbearable strain on those remaining, exhausting them physically and mentally.Barndollar also highlighted their average age as an additional strain."An army of men, often in poor health, in their 40s, all else being equal, is going to get exhausted sooner and is going to have morale problems faster than a reasonably fit army of 20- or 25-yearolds."Zelenskiy has responded to questions about the manpower problem by arguing that Ukraine lacks weapons rather than people, and pushed back against U.S. pressure to lower the minimum draft age to 18 from 25.He said in an interview with Sky News last week that Kyiv's allies had been able to provide the necessary equipment for only a quarter of the 10 new brigades Ukraine had formed over the past year.

### Daily life in Seoul ticks on, but in shock, after six hour martial law drama

SEOUL. South Koreans went to offices, businesses and schools as usual on Wednesday with scarcely any visible signs in the capital Seoul that six hours of surprise martial law and high political drama overnight had spilled into everyday life. The city of 9 million started the day normally with the usual morning rush hour in trains and on the streets after President Yoon Suk Yeol lifted his abortive attempt at banning political activities and censoring news media just before dawn.But many were in shock at such a sudden turn of events, which pushed stocks down and South Korea's currency to multi-year lows during a time of already faltering economic growth. There have been more than a dozen instances of martial law being declared in South Korea since it became a republic in 1948, but the last time was more than four decades ago when Gen. Chun Doohwan staged a coup and ruled from 1980 to 1988. Seoul resident Gang He-Soo, 50, said she woke from sleep by chance and saw the news.

"At first, I was scared and very confused. I kept thinking, 'What is going on? Is this something that could actually

happen in this era?' I couldn't sleep until the martial law was lifted because I was so frightened," Gang said, walking in Seoul's main commercial and tourist district Gwanghwamun. Yoon declared martial law in a live TV address at around 10:30 pm (1330 GMT) on Tuesday, only to reverse course after parliament defied police and special forces cordons around the National Assembly to vote, forcing him to lift the declaration.

The president's office said the declaration of martial law was done at night to "minimize damage to the national economy and people's lives".South Korean soldiers, equipped with rifles, body armour and night-vision equipment, were seen entering the parliament building in Seoul through smashed windows."

It was an experience that I've only seen in movies, and I realised how much more serious it is than I had imagined," said 39-year-old Seoul resident Kim Byeong-In, who said he was concerned about the impact on the economy."I'm deeply disturbed by this kind of situation, and I'm very concerned about the future of the country,"

### Rate cut would help revive economy without worsening inflation, says MPC member Nagesh Kumar

Nagesh Kumar, one of the three new external members of the Reserve Bank of India's (RBI) Monetary Policy Committee (MPC), said that the slowdown in GDP growth during Q2FY2025 was transient and the economy is likely to a pick-up in the second half of the current fiscal.Kumar, who voted for a 25 basis points (bps) cut in the repo rate in the last two consecutive monetary policies, told Hitesh Vyas and George Mathew that a rate cut would revive economic growth without worsening the inflationary situation. If the RBI does not follow the process of normalisation when most other central banks have moved forward, it runs the risk of currency appreciation, said Kumar, who is Director and Chief Executive of the Institute for Studies in Industrial Development (ISID). Excerpts:

Given that the growth has been sluggish, do you believe a 50 bps reduction in the repo rate at this point in time would be a more effective step to stimulate the economy? Do you think RBI is behind the curve in cutting rates and boosting growth?To some extent the sharp growth slowdown in Q2 was transient. We should expect an improvement in growth in the coming two quarters. The government capex, which saw a squeeze in the first guarter, has begun to revive in the second guarter and should gain momentum in the third and fourth quarters. The government capex should, therefore, help to lift the growth rate in the second half of the year. Yet, there is a slowdown from the earlier projections of growth around 7 per cent or higher to around 6.5 per cent. I believe that it needed a policy response because it largely reflected the slow-down of the manufacturing sector. The agriculture growth rate actually improved from 2 per cent in Q1 to 3.5 per cent in Q2 and the services sector was still posting a robust growth rate of 7 per cent (even though slight moderation from 7.7 per cent). The deceleration of manufacturing growth from 7 per cent to just 2.2 per cent was rather sharp.A reduction of the cost of capital through a reduced repo rate could help to revive the growth of private investment besides consumer demand. Keeping in mind the deceleration of the manufacturing sector, I made a case for a 25-basis point cut in the repo rate to start the cycle of normalizing the monetary policy. In addition I made a case for a 50-basis point cut in CRR, to help enhance liquidity. Expanding the manufacturing sector could also help in containing inflationary pressures by enhancing the supply capacity. You said monetary policy has limitations in addressing inflation largely driven by a supply-side

shock. What measures can address supply-side shocks?

The inflation hitting a high rate of 6.2 per cent is also a challenge. However, the bulk of the inflation is accounted for by the food, especially those of vegetables, namely tomatoes, onions, and potatoes (TOP). Excluding food, the CPI headline comes down to just 3.1 per cent in October 2024. Keeping in mind the easing of vegetables and edible oil in November, food inflation should be easing further in the coming months. I have argued in my statement that while looking at the policy options for reviving growth and containing inflation, one should factor in their determinants. This is because monetary policy instruments such as interest rate changes have more to do with demand management and have limitations in addressing the rising vegetable prices, which are primarily due to a supply-side shock, namely seasonal demand-supply mismanagement, which was beginning to correct itself in November. However, the inflationtargeting framework of MPC is currently focused on addressing the headline inflation based on CPI, which includes food as well as non-food items. Therefore, I believe that a rate cut would help in reviving economic growth without worsening the inflationary situation, which may soften with seasonal correction in prices.

Rupee has breached 85 level. How big a concern is a depreciating currency?

The Indian rupee is depreciating vis-à-vis the US Dollar, which is strengthening against different currencies in nominal terms. In real terms, the rupee is actually appreciating, as a recent RBI paper has shown.

If the US Fed slows down rate cuts, will it impact emerging economies like India?

We are living through highly uncertain times with upcoming changes in the economic and trade policy in the US with the change of administration in January, the ongoing geopolitical conflicts, which have a bearing on the oil prices, exchange rates, etc. The MPC will factor in the trends of the past months and projections for the future when it meets next to arrive at its decisions. We look at the trends in monetary policy over the past two months. The impact of the transition in the US government is a guess as of now. One has to wait and see how the new government will act. The MPC meeting in February will take stock of how the inflation-growth balance was shaping up between now and then against the backdrop of global trends. Most central banks around the world, barring a few, have embarked on a cycle of normalizing the monetary policy in recent months. The US Fed has cut the policy rate by 100 basis points in three rounds. While we do not have to follow what other central banks do. But if we do not follow the process of normalisation when most others have moved forward, we run the risk of currency appreciation. India needs to guard against the risks of currency appreciation in real terms as it would hurt the competitiveness of Indian products.

There is a debate on the exclusion of food from the inflation-targeting framework? Can you please share your views on this?

There is indeed a debate on whether food should be excluded. It was raised in the Economic Survey 2024, besides several economists expressing their opinions.

### Food spending rises in rural areas, gap with urban centres shrinks

REVERSING A DECLINING trend from over a decade, the share of food in monthly expenditure of households in rural as well as urban areas went up in 2023-24, according to the Household Consumption Expenditure Survey (HCES) 2023-24 fact sheet released by the Ministry of Statistics and Programme Implementation (MoSPI) on Friday. This probably reflects the impact of higher food prices; given that the figures are in nominal terms, the share of food in the consumption basket of rural households went up to 47.04 per cent in 2023-24 from 46.38 per cent in 2022-23, while that for urban households inched higher to 39.68 per cent in 2023-24 from 39.17 per cent in the previous year. The HCES data also showed that the difference in average monthly consumption expenditure between rural and urban households narrowed further to 69.7 per cent in 2023-24 from 71.2 per cent in 2022-23, and 83.9 per cent 11 years ago in 2011-12, which implies that rural consumption spending continued to rise more than urban consumption spending over the last one year."The urban-rural gap in MPCE has declined to 71 per cent in 2022-23 from 84 per cent in 2011-12. It has further come down to 70 per cent in 2023-24 that confirms sustained momentum of consumption growth in rural areas," the Ministry said in a statement. Rural average monthly consumption spending per person increased to Rs 4,122 in 2023-24, an increase of 9.3 per cent from Rs 3,773 in 2022-23. It had stood at Rs 1,430 in 2011-12. This increase in rural spending over the one-year period was higher than the urban average monthly consumption expenditure per person at Rs 6,996 which increased from Rs 6,459 in 2022-23. The urban average monthly consumption expenditure per person had stood at Rs 2,630 per person in 2011-12. This seems to suggest that the pace of spending is more in rural India compared with the urban population, which seems to be cutting down on its consumption. A closer look at the fractile data reveals that the top 5 per cent of the rural and urban population saw a decrease in consumption spending in 2023-24, even as all other segments of the population, including the bottom 5 per cent, registered an increase in spending. Experts pointed out that this is in contrast to evidence from other datasets that show a rise in spending by top segment, especially on premium goods. "Every fractile class has shown an increase in consumption except the top fractiles which is opposite to the trend being seen in other datasets," an economist, who did not wish to be named, said.Former Chief Statistician of India Pronab Sen said the deviant trend in the top fractiles may be a result of the change in methodology. "The household consumption surveys were earlier done once every five years but after the change in methodology, the back-to-back surveys were conducted to see if the revised methodology is stable. The change in methodology needs to be validated, otherwise it may show results which are not explainable," he said. "It's also possible that while conducting the survey, the respondent is not the same during subsequent visits and it is no longer the same category of the people from whom you were getting responses," he told The Indian Express. The monthly per capita expenditure (MPCE) of the top 5 per cent of the rural and urban population stood at Rs 10,137 and Rs 20,310, respectively, in 2023-24 lower than Rs 10,501 and Rs 20,824 in 2022-23. The MPCE of bottom 5 per cent for rural and urban population increased to Rs 1,677 and Rs 2,376, respectively, in 2023-24 from Rs 1,373 and Rs 2,001 in 2022-23. In fact, the increase in average monthly per person spending in percentage terms was the highest in 2023-24 for bottom 20 per cent in rural and urban areas at Rs 6,276 (19.2 per cent increase from 2022-23)

The share of egg fish and meat in total MPCE inched higher to 4.92 per cent and 3.56 per cent in rural and urban areas, respectively, in 2023-24 from 4.91 per cent and 3.57 per cent. Beverages, refreshments and processed food continued to have the highest share of expenditure in 2023-24 at 9.84 per cent and 11.09 per cent in the consumption basket of rural and urban households, respectively, compared with 9.62 per cent and 10.64 per cent in 2022-23.

The share of expenditure on non-food items stood at 52.96 per cent and 60.32 per cent in rural and urban households, respectively, in 2023-24 as against 53.62 per cent and 60.83 per cent in 2022-23. Consumption expenditure on non-food items in rural India was driven by conveyance, medical expenses, clothing, bedding and footwear. In urban India, the spending on non-food items was mainly on account of conveyance, miscellaneous goods and entertainment, durable goods and rent.

State-wise data also showed a divergent trend between consumption patterns of high spending by western and northern states and lower spending by eastern and central states of India. For instance, the average spending per person was lower than the national average in rural and urban areas of West Bengal, Bihar, Assam, Odisha, Uttar Pradesh, Madhya Pradesh, Jharkhand, Chhattisgarh in 2023-24. 



### Badminton's needless itch to tinker with scoring system

Badminton's latest bee in the bonnet, is a scoring system that needs no tinkering. But it is almost expected that those who govern the sport will get the score-changing itch every few months, and the experimentation will get carried out in a bewildered tournament, with no perceivable change to either footfall or TV broadcast enthusiasm. There's a litany of problems confronting the sport, not racquet's most popular – that's tennis by a mile. But the 21 points over 3 sets, was one of the least bothersome things in that headache-inducing mix of troubles.

Higher prize money, better scheduling with rest days, expansion beyond Asia and Denmark, protecting players from internet trolls, better broadcast packaging all need actionable responses. The  $21\times3$  was coasting along just fine.At best, older shuttlers might reckon they can prolong their careers if matches snap shut quicker. But at worst, the game becomes a lottery – a drawn out penalty shootout, with no real build-up, or core, or a smooth flow and anticipation of a crescendo that the  $21\times3$  offered. It's perhaps a difference between 50 minutes and 80 minutes – not significant enough to drastically aid recovery, nor ensure better quality due to concentration of intensity.

All that 15×3 does is shorten the game for the sake of shortening. And with all due respect, if a TV watcher has someplace else to be for the additional 20-30 minutes, then give viewing it a Skip for the day, and be some place else happily.Why tinker and trample upon the drama of a sport, where a lilt of the early points can culminate into a zenith in just a few minutes. It is unclear if top active players desired this format because the cumulative exhaustion of the Tour calendar would have them pleading off any extra time that could be sheared. Or if the governing brains got this brainwave to make every point, start to finish, very very important. Trained shuttlers will adjust to anything assigned to them. But the 15×3 can kill the drama of a big lead conceded nearing the endgame, and a cool cat plotting a comeback and relishing the opponent's nerves when finishing.Could it happen between Point 10 & 15? Sure. But the BWF seriously undermines the skill and temperament of shuttlers, by turning it into an anyone-can-win-randomly format. Tennis' decision in doubles for a third-set tiebreak,



was abject, and based solely on the disdain the sport had for doubles practitioners, with the monopolising attention devoted to The Big Four and their beautiful, but attention-hogging men's singles battles. So, just like that, one day, the doubles was reduced to very unserious. Not too long after, with the star-Slam universe becoming the be-all, Davis Cup was unthinkingly truncated.

TT, cricket, hockey have all suffered this mad urge to make it shorter, because people allegedly have no time. There's the mobile phone and OTT and politics blow-horning and a million other things, including negotiating traffic and working long hours to cram into the 24 hours.But can and should sport scrunch its essence for the sake of those in a perennial rush? India might be the only country at the intersection of cricket and badminton popularity. The country's billions have no qualms about watching 5-day Test matches, and deriving serious distractions and delights from watching that sport. Even amongst badminton followers, Sindhu's Glasgow World Championship silver playing Nozomi Okuhara in a match of unbelievable excitement for 110 minutes, might rank as most memorable.Sport is unscripted drama. And largely honest and among the only things left that's not playing out like Reality TV or realistic blood and gore portrayals. The tribalism is toxic, but mostly till the last minute, both sets of fans stay invested in hope, and the possibility of their favourite winning. Those that are busy, don't watch, and needn't be catered to. But ruining a consistent scoring system and fiddling too much with the ebb and flow of the game, only loses any sport supporters. Football has mercifully eschewed all attempts to scrunch 90 minutes, tennis stays 5 sets and Isner-Mahut grab themselves a nice slice of history.

# Why Jadeja and Axar are better ODI options than Varun Chakaravarthy

Ravindra Jadeja and Axar Patel possess cricket skills that get labelled similarly. But that's like confusing tomato sauce for ketchup. Or a crow for a raven. It needs an expert eye and nose for nuance to appreciate the difference between the all-format multi-skilled cricketers. They have the same font but Jadeja is italicized. To bracket them as a fastish spinner is to dovetail Jasprit Bumrah and Mohammad Shami as identical 140 plus quicks. The taller Axar banks on bounce and drift. Jadeja, easily the better-skilled tweaker, also has the drift but possesses a bigger break, deadlier skidder and a more surprising armer.

Of the two, the older and far more experienced Jadeja is the more classical red-ball run-getter. As for Axar, captains these days play him as a white-ball pinch-hitter, a role that fits his style perfectly. This doesn't mean Jadeja, the present day trusted rear-guard, isn't equipped to jump up the order for any urgent kamikaze operation. They seem like peas from the same pod but they aren't. Both are incredible catchers, swift and measured movers around the field but the power and accuracy of his throws gives Jadeja the fielder, the edge. However, they have a few common under-publicised, less-appreciated traits that do justify that 'spin-twins' label. They are Indian cricket's indefatigable survivors, their careers a study in the sort of perseverance that cannot be taught. Over the years whenever there has been a question mark over their place in the Indian side, they have bounced back to underline their relevance.

Case in point is the ongoing England series. Days before the first ODI at Nagpur, the selectors drafted in Varun Chakravarthy, the 'variety shop of spin-bowling'. The newage 'six-variations per over' wicket-taker had enjoyed great success against English batsmen in the T20 series and so the selectors and the team management wanted him around for the ODIs. After India's Champions Trophy squad was announced there was some chatter about India lacking middle-overs wicket-takers - the 50 overs game-changers. Those in the know also say that at the selection committee meeting, there were voices that had backed Chakravarthy and didn't whole-heartedly support the inclusion of two left-armers in the squad. Very early in the Nagpur game, Jadeja would remind the world of his indispensability in any format of the game. It is one thing to get wickets in a T20 game when batsmen are always ready to throw caution to the wind, or even a mild breeze, and another to get Joe Root in a 50 overs game after he has been at the crease



for 40 minutes. That too when the master batsman was setting the mid-overs base for an all-out assault later.

Jadeja would showcase his practised art of getting wickets when the batsman isn't attacking. It was an armer that drove into the right-hander Root like a trunk. It hit the pads in front of the stumps. This wasn't the case of a basher mistiming a slog but one of the game's top batsmen being beaten while on the back foot. To pull that off, one needs someone with Jadeja's body of work.Axar would get Jos Butler in the 36th over - another crucial middle-over strike. There aren't many in Indian cricket like Axar. Who except Jadeja can do an Axar - first come up with a spell of 7-0-38-1 and later turn up at No.5 to score a 52 from 47 balls after a mini-collapse.Axar Patel India's Axar Patel makes an unsuccessful appeal during the first One Day International (ODI) cricket match between India and England at Vidarbha Cricket Association (VCA) Stadium, in Nagpur, Maharashtra. It's their Test match expertise that makes Axar and Jadeja the ideal middle-order batsmen in 50-overs cricket too. In the recent tour of Australia, Jadeja stood out with his batsmanship in a line-up that repeatedly succumbed to pace. Go back to the tapes, see how Jadeja, with his piercing eyes, would get into the line and at the last minute move his bat like a well-oiled sliding door giving the ball a clear passage to the 'keeper. It was the tour when even the best in business spent over a month in search of their offstump. With a highest of 77 his average was better than most frontline batsmen. Before that when Australia had toured India, it was Axar who played a few series-changing knocks. It was the same in the T20 World Cup that India won last year. Axar getting wickets, scoring runs and holding on to blinders. Despite their numbers and deep understanding of every aspect of the game, Axar and Jadeja don't shout about their achievements from rooftops nor are they angsty about being unsung.

sensational Test debut in the first Test against Pakistan with a great all-round showing. He took a wicket with his first ball, on his way to fine figures of four for 63. He



then counter-attacked smartly with the bat, coming in at 191 for seven and refusing to be pinned down despite being under massive pressure in difficult conditions for batting. His 81 not out at number nine was a terrific inning and hugely significant in the thrilling outcome of the match as it made up the bulk of the Proteas' 90-run first-innings lead.

### Why anti-caste films bother you, Gautham Vasudev 'Menon'? Because no takers for your movies glorifying extrajudicial killings, stalking and toxicity anymore?

Over the decades, Tamil cinema has given birth to numerous exceptional filmmakers like CV Sridhar, A Bhimsingh, BR Panthulu, Krishnan–Panju, J Mahendran, Bharathiraja, K Balachander, Singeetam Srinivasa Rao, Balu Mahendra and Kamal Haasan. However, not all of them have succeeded in inspiring the masses on a transformative level. Not that their films lacked impact; but, inspiring the masses on a large scale — to make them dream of cinema and pursue that dream steadfastly — is a feat that not all have achieved. From Mani Ratnam and S Shankar to Vetrimaaran and Pa Ranjith, that list is small.

Even so, it's doubtful if any of them — perhaps with the exception of Mani Ratnam — managed to influence an entire generation in the way Gautham Vasudev Menon did. Beyond captivating audiences with his movies and aesthetics, Gautham redefined trends too, making things like engineering, guitar, Tanglish, filmmaking, train journey and youthful romance fashionable; so much so that for scores of youths, filmmaking became the default dream after engineering

However, once a trendsetter, Menon has struggled to regain his footing in the industry over the past few years. Even setting aside the troubled journey of his delayed Dhruva Natchathiram, it's no secret that his career has been on a downward trajectory, with his recent film Dominic and The Ladies' Purse too failing to resonate. Moreover, even his once-celebrated films have come under scrutiny in recent years for their problematic themes and representations.Amidst all this, the filmmaker also stirred controversy with some comments in a recent interview. In a conversation with Behindwoods TV, Gautham Menon, without naming anyone, stated that films addressing casteism are no longer relevant. Implying that the discriminatory practice no longer exists, he 'explained' that this is why such films are often set in the '80s or '90s. "These are not the stories we are looking for. I don't think those stories need to be told anymore," he stated, before claiming in the same interview that his surname Menon was his family name and not his caste location, an absurd argument.

His words not only expose the typical hypocrisy of caste-blind elites — who deny the existence of casteism while proudly using their savarna identities as surnames — and his intentional oblivion to societal issues but also highlight why he has become a declining figure as Menon seems unable to grasp that people have evolved and that their societal sensibilities and political awareness advanced. Therefore, one cannot blame those who feel that Menon's frustration — with films addressing casteism — stems from a sense of desperation, as there is no longer a large fan base for his stories that glorify stalking, staring, impersonation, extrajudicial killings, homophobia, transphobia and toxicity.

Since Menon said, "These are not the stories we are looking for," it's worth examining the kind of stories he has told. Long before Raanjhanaa (2013) romanticised highly toxic male behaviour — such as stalking and manipulation — peddling it as love, the filmmaker's Minnale (2001) sympathised with young men who engaged in such practices. Not only does the film's protagonist, Rajesh (R Madhavan), stalk Reena Joseph (Reema Sen) after falling for her at first sight, but he also gathers personal details about her without her knowledge and impersonates her fiancé, Rajiv (Abbas). However, when his deception is exposed, he plays the victim, expecting sympathy under the pretext of 'true love'. Despite cheating her outright and committing identity theft, he also wonders why Reena doesn't understand his 'love' for her.

Under the guise of the age-old adage "all's fair in love and war", which men have long used to justify immoral actions without scrutiny, GVM, too, reinforced the notion that resorting to illegal behaviour was acceptable if one had 'true love'. And with Harris Jayaraj's ethereal music in the background, everything would look too cute.



Vettaiyaadu Vilaiyaadu also highlighted just how deeply flawed Gautham Vasudev Menon's idea of romance is, with Raghavan proposing to a woman (who later becomes his wife) just two hours after meeting her at a wedding. And no, he doesn't even ask her out first, but jumps straight to marriage simply because "I knew from her eyes that she loved me." For a senior cop, his ignorance to running even a basic background check on this complete stranger, before asking her to spend the rest of her life with him, speaks volumes about his judgement, raising doubts about whether such an impulsive officer and his "Raghavan instincts" should be trusted blindly. In fact, though this detail added little to the narrative beyond providing some insight into his background, even Raghavan is portrayed as having a preference for vegetarianism, as evident in one of his dialogues.

Interestingly, Pachaikili Muthucharam (2007) is his only film where characters face rightful consequences for their actions, but its technical shortcomings and box office failure left it largely forgotten. (Credit: IMDb)In his semi-autobiographical Vaaranam Aayiram (2008), Gautham Vasudev Menon took creepiness to another level by introducing a father-son duo whose go-to means of expressing love is through obsessive stalking. In the first instance, Krishnan (Suriya) wins over the 'love of his life' Malini (Simran) after stalking her for a week — never revealing himself at first but ensuring people around her inform her of his love. Years later, their son Suriya (also played by Suriya), inspired by his father's tactics, takes things further, making them as creepy as possible and it begins with him staring unnervingly at a stranger woman, Meghna (Sameera Reddy), on a train. Norse still, the film portrays her finding it immediately endearing

Encouraged by her reaction, Suriya goes out of his way to track down her address, follows her home, and later, in an even more unsettling turn, flies from Chennai to California — where she later enrolls in a course — to locate her, all without her knowledge, and confess his 'love'. Given how frequently women experience stalking and harassment in real life, Gautham Menon's romanticisation of such behaviours reflects his deeply problematic understanding of women and love. The fact that many crimes begin with a man stalking a woman under the guise of love only reinforces how dangerous this portrayal is.Gautham's glorification of toxic relationships peaked with Vinnaithaandi Varuvaayaa. Despite Karthik (Silambarasan) and Jessie (Trisha) being walking red flags and their relationship extremely unhealthy, the film was met with widespread im and is still revered as a modern masterpiece. From stalking and non-consensual physical advances (as seen in the song "Omana Penne") to emotional manipulation, the film normalised and romanticised deeply problematic behaviours. Though the script lacked depth and the characters only superficially developed, Gautham elevated the movie through stunning visuals, strong dialogues and the contributions of a skilled technical team - all of which helped cement its iconic status. While the film claims that Karthik and Jessie are truly in love, by the end, one can't help but wonder: did they actually love each other, or were they simply drawn to the toxicity of one another and the strange gratification they found in mistreating and being mistreated by one another? Caste makes its way into this film as well. While Jessie (Trisha) is depicted as belonging to the upper-caste Syrian Christian community, the movie states clearly that Karthik is a Veerakodi Vellalar. Although Menon could have framed the conflict in their relationship from a religious angle, his un/conscious decision to emphasise caste instead suggests that it remains a significant factor even today. Notably, when the film was remade in Hindi as Ekk Deewana Tha (2012), Karthik's character was reimagined as a Marathi Brahmin, and here too, caste is explicitly mentioned.Meanwhile, his psychological thriller Nadunisi Naaygal was nothing more than a dampened experiment, where neither the psychological depth nor the thriller aspects held together and the film ultimately ended up as a middling effort, simply featuring elements not usually found in mainstream Tamil cinema.Although Neethaane En Ponvasantham/Yeto Vellipoyindhi Manasu (2012) is arguably Gautham Vasudev Menon's most realistic romance film, tracing the evolution of an on-again, off-again relationship from childhood to adulthood, its flawed execution significantly weakened its impact. Despite Ilaiyaraaja's remarkable soundtrack and Samantha's compelling performance, the film struggled to leave a mark, with Gautham failing to even add his signature touch to the toxic moments in the narrative.He returned to the police genre with Yennai Arindhaal (2015). While this film showcased greater maturity in storytelling and was a notable improvement over his previous two cop movies, his long-standing obsession with glorifying uniformed officers remained unchanged. The film, like its predecessors, overlooked the crimes committed by law enforcement officers and also the systemic issues cops faced and focused merely on an idealised, morally upright police officer, placed as the ultimate force against societal evils. Though his later films Achcham Yenbadhu Madamaiyada (2016) and Enai Noki Paayum Thota (2019) were less problematic — at least on the surface — Gautham Menon's fascination with uniformed forces was evident in them as well. Moreover, both films were overwhelmingly male-centric, with the women having little to no influence on the course of events, despite being just as affected by their consequences. The back-to-back setbacks of these films, despite featuring Gautham's signature elements and more, highlighted the diminishing impact of his once-effective formula.

Recently, the Hollywood superstar, known for executing his own stunts, shared a behind-the-scenes video from the film's shoot, where he is seen hanging from an upside down plane. In a recent interview, Cruise revealed that he passed out due to a lack of oxygen while filming the dangerous sequence.

Sharing the thrilling video on social media, the actor wrote, "Hang on..." The clip features director Christopher McQuarrie filming the stunt from another plane while Cruise struggles to hold on to the aircraft mid-air. In an interview with Empire, Tom Cruise explained how the lack of oxygen made it difficult to breathe during the stunt. He said, "When you stick your face out [of an airplane], going over 120 to 130 miles an hour, you're not getting oxygen. So I had to train myself how to breathe. There were times I would pass out physically; I was unable to get back into the cockpit."Christopher McQuarrie shared how Mission: Impossible – Final Reckoning continues the tradition of pushing boundaries in the Mission: Impossible franchise. "There



are stunts in this movie that will melt your brain. There would be a day in Africa — any day in Africa — where Tom would go out and do something that topped any-thing he had ever done before," he said. The filmmaker also revealed that the stress of shooting these stunts made him want to puke. Mission Impossible: Final Reckoning will release in 2025 and also stars Hayley Atwell, Ving Rhames, Simon Pegg, Vanessa Kirby, Esai Morales, Pom Klementieff, Henry Czerny, Angela Bassett, and Rolf Saxon in pivotal roles.

### Allu Arjun calls himself the 'biggest fan' of Pushpa director Sukumar: 'I could perform so well because...'

Following a massively successful theatrical run, during which it emerged as the third highest-grossing Indian film of all time, director Sukumar's Allu Arjun-starrer Pushpa 2: The Rule recently debuted on OTT, drawing more audiences. At the Thank You meet on Saturday, Arjun heaped praise on Sukumar, crediting him for the recognition every team member received for their work on the film.

"The reason I could perform so well is that Sukumar loves performances. Any actor becomes a bad actor without good guidance, no matter how great a performer they are. Thank you for guiding all of us and making us do a 'reasonably good' job," he said, urging everyone to give the filmmaker a standing ovation. "We are all characters in his dream and images in his projection. It's the director who communicates directly with the audience," the actor added.

While the movie grossed Rs 1,742.1 crore worldwide, as per industry tracker Sacnilk, its India nett collection stood at Rs 1,234.1 crore.

Vicky Kaushal calls Chhaava 'toughest role'; reveals Laxman Utekar refused to shoot until he perfected his look: 'I refuse to cheat'

Despite Menon's claim that casteism is a thing of the past, it is emphasised in Minnale that Rajesh is a vegetarian Brahmin. In one scene, he also remarks, "There were many girls in our college. Have I ever talked about any of them? There were two gorgeous lyer girls from Chidambaram and even a stunning Kerala girl. But I never pursued them." Out of countless ways, Menon's choice to invoke caste while discussing beauty reveals much about him. Notably, the caste-highlighting surname absent in Minnale suddenly appeared when Menon remade the film in Hindi as Rehnaa Hai Terre Dil Mein, where the hero was named Madhav Shastri, fully embracing his Brahmin identity. The story that Gautham Vasudev Menon deemed compelling enough to share with the world next romanticised extrajudicial killings. At a time when Tamil cop dramas were becoming increasingly formulaic, he revolutionised the "righteous officer with a no-holds-barred attitude" archetype with Kaakha Kaakha (2003), introducing ACP Anbuselvan IPS (Suriya), an advanced encounter specialist who deliberately avoids romantic relationships to maintain a lone-wolf persona, keeping rivals from gaining leverage. The film's appeal was also heightened by the protagonist's constant voiceover, presenting the narrative as his life flashing before his eyes. Centred around a specialised police unit led by Anbuselvan, where rules hold little significance in their fight against organised crime in Chennai, Kaakha Kaakha glamorised police officers, portraying them as infallible, with no moral ambiguity, and this portrayal contributed to the heightened admiration for encounter specialists as it conveniently ignored the atrocities committed by police, including custodial murders, wherein the victims are mostly Bahujans. Let's also not forget that the name of Menon's cameo role in the movie, which he himself penned, was Vasudevan Nair.

In his next original directorial Vettaiyaadu Vilaiyaadu, Gautham Vasudev Menon once again centred the story on a righteous cop, DCP Raghavan IPS (Kamal Haasan), who, though not an encounter specialist per se, is also shown engaging in extrajudicial killings of those responsible for his wife's murder and a serial killer duo. Towards the end, Raghavan also, for absolutely no reason, delivers an extremely homophobic line, as if the characters' sexual orientation was (illogically) related to their criminal actions. Meanwhile, the film's graphic depiction of rape further fuelled a disturbing trend that continues in cinema even today.

Despite facing criticism for glorifying police brutality and extrajudicial killings — especially in the wake of incidents like the Thoothukudi case where two men were "allegedly" sexually assaulted, tortured and killed — GVM expressed no regret about creating these films. When The Hindu questioned him about it, he gave a bizarre response, saying, "I have had policemen walk up to me and say, 'Naanga police aanadhe unagalala dhan' (We joined the police force inspired by your films)."

Vicky Kaushal is currently busy with the promotions of his upcoming film Chhaava. The actor plays the fearless Maratha warrior Chhatrapati Sambhaji Maharaj, the eldest son of Chhatrapati Shivaji Maharaj, who took over the throne after his father's passing. During a recent interaction, Vicky revealed that director Laxman Utekar was so particular about his look in the film that he refused to begin shooting until Vicky achieved the appearance of a real warrior.

Speaking on Radio Nasha, Vicky shared, "Chhaava has been the toughest role of my life physically and it is because it wasn't easy to gain 25 kg of muscles. It was very difficult for me. It took me 7 months to gain that. Laxman sir was very clear that till the time you don't get that look, learn horse riding, complete sword training and acting fighting, I won't start the film. He told me, 'I refuse to cheat. I won't use VFX."

He added, "I had to grow my hair, beard and build the body and that took time before we even began the shooting of the film. If you see 2000 people on set, there were actually 2000 people on set. We had 2000 junior artists, 500 of the best stuntmen of the country. It has been shot in a very raw and gritty way."In Chhaava, Akshaye Khanna plays the role of Aurangzeb. Speaking about Akshaye's menac-



ing transformation for the role, Vicky said, "I was shown photos of his look and I was totally surprised and I couldn't believe. When I actually saw him in the look on the set, with his demeanour and all, it was incredible. I was surprised. He has almost made the character alive. His evilness will translate so perfectly that people will be surprised."Rashmika Mandanna plays Maharani Yesubai, Sambhaji Maharaj's wife, in Chhaava, set to release in theatres on February 14.

## Racist accent joke on Keralites triggers criticism against Samay Raina's 'India's Got Latent' show



Hyderabad: A video excerpt from comedian Samay Raina's 'India's Got Latent' has triggered criticism on social media over what is being alleged as racism.

The excerpt shows one of the judges on the show making fun of a contestant's opinion on politics and voting, after she said she had not voted and was not interested in politics. The judge's comment, supposedly intended to be a joke went like "Kerala, Saar.. 100 percent literacy Saar..."However, many are pointing out that the joke was completely off the mark and that it was not proper to make fun of the contestant's personal choice. Several netizens also pointed out that the "Saar" accent was not actually from Kerala and that it was being wrongly attributed to Malayalis just to make fun of them.

Many also pointed out that it was racist for Indians to make fun of each other's accent, especially when every State in India had different accents depending on the language spoken there. They also pointed out that Indian accent was made fun of in other countries and those who complained about that were making fun of their own people back in India. There was also criticism that the show was targeting non-BJP ruled States like Bengal and Kerala based on "rotten racist stereotypes propagated by the BJP IT Cell".
