#### Panic at Rajiv Gandhi International Airport in Hyderabad after bomb hoax over email

Hyderabad: Panic prevailed at the Rajiv Gandhi International Airport (RGIA) and its surroundings when a bomb threat mail was received by the airport authorities on Friday. Following information from the airport authorities, the Central Industrial Security Force (CISF) personnel, local police and bomb squad reached the airport and took up checking for the presence of any explosive substances. As per available information, the administrative wing officials had received a threat email on the official ID from an unidentified person claiming to be a terror sleeper cell. The caller threatened to blow up the airport at any moment and dared to inform the state government.

### Securing own skies, breaching enemy airspace with ease: India's overhauled air defence system under Modi.

New Delhi: The unprecedented face-off at the Line of Control (LoC) and the border areas, after India destroyed nine terrorist camps in Pakistan-occupied-Kashmir (PoK) and Pakistan, saw a barrage of missiles, drones and other munitions being fired from across the border on Thursday night, but India intercepted and shot all of them in the air. Not a single missile could land on Indian territory, failing to reach intended targets. Days ago, the Indian armed forces carried out targeted and precision strikes on key terror hubs across the border, hitting and destroying them with clinical efficiency. This sent a clear message to the world - India was not only securing its skies but also had the capability to breach enemy airspace with clinical precision. The credit for India's overhauled air defence ecosystem goes to the Narendra Modi government, which has kept its thrust on revamping the security apparatus by phasing out the depleting war reserves and inducting a new, world-class arsenal. The Russian S-400 systems and Rafale jets, largely, accounted for India's success in countering Pakistan's multipronged attack. Interestingly, both of these became part of India's defence system under the NDA government and that, too, apparently at the insistence of Prime Minister Narendra Modi. The rapid, coordinated response that the armed forces showcased was because of the air defence ecosystem — built painstakingly over the past 11 years under the Modi government. The Integrated Counter-Unmanned Aerial System (UAS) Grid, S-400 Triumf systems, Barak-8 missiles, Akash Surface-to-Air Missiles, and DRDO's anti-drone technologies came together seamlessly to create an aerial shield that thwarted all Pakistani attempts to hit military installations in India. When India hit terror hubs under 'Operation Sindoor', the security forces destroyed a Chinese-supplied HQ-9 air defence unit in Lahore, also damaging key radar infrastructure. The level of preparedness didn't materialise overnight. Since 2014, the government under PM Modi has systematically upgraded India's air defence architecture, made key Defence acquisitions and modernised



its warfare.In 2024, Man Portable Counter Drone Svstems (MPCDS) were installed by the Army to jam and disable hostile UAVs.In 2018, a Rs 35,000 crore deal was struck for five S-400 Triumf squadrons. Three squadrons are now operational along the borders with China and Pakistan.In 2017, India got Barak-8 Medium-Range Surface-to-Air Missiles (MR-SAM) as part of a \$2.5 billion deal with Israel. They are now guarding frontline bases like Bhatinda. The induction of indigenous Akash missile batteries and DRDO-developed counter-drone systems gave more ammo. Loitering munitions (kamikaze or suicide drones) were ordered in 2021 and are now manufactured in India. These drones executed simultaneous, precision strikes across sectors, taking Pakistan's defences by complete surprise. Additionally, Israeli-origin Harop drones — now locally built — were deployed to target and destroy air defence assets in Karachi and Lahore. These platforms, combined with the strategic deployment of Rafale fighter jets equipped with SCALP and HAMMER missiles, demonstrated India's capability to project power with surgical precision. Notably, 'Operation Sindoor' sent a clear message to the world that India is not just capable of defending its skies, it now controls them. And, it is the result of the consistent and persistent approach of the government to build a resilient, multi-

### India-Pakistan conflict: Nadda reviews emergency health systems preparedness

New Delhi: In the wake of rising conflict between India and Pakistan, Union Health Minister J P Nadda on Friday chaired a high-level meeting to review emergency health systems preparedness to ensure uninterrupted healthcare services. Nadda called for a "a 24x7 control and command centre to monitor ongoing efforts and support states in the present times". "All medical emergency response health systems must be adequately equipped and functional at all times," the Union Health Minister said, stating that the Health Ministry is closely monitoring the situation. "Ensure that ground-level linkages with all state governments particularly at the district levels, especially border states, be effectively established to ensure immediate emergency healthcare, if required," he said.

During the meeting, senior officers of the Health Ministry updated Nadda about the current status of medical preparedness for handling emergency cases. The Union Minister was also "apprised of the actions taken regarding deployment of ambulances; ensuring adequate availability of medical supplies including equipment, medicines, supply of blood vials and consumables; hospital readiness in terms of beds, ICU and HDU; deployment of BHISHM Cubes, advanced mobile trauma care units, etc," the Health Ministry said. Further, the Ministry has advised hospitals and medical institutions "to ensure availability of essential drugs, adequate supply of blood, oxygen, trauma care kits, etc". "AIIMS New Delhi and other central government hos-



pitals have mobilised doctors and nurses with supplies for ready deployment," it added. To strengthen the emergency response networks collaboratively, the hospitals have also been advised to coordinate with state and district administration, armed forces, and regional associations of doctors, nurses, paramedics, private sector hospitals, charitable institutions, etc.In addition, nationwide mock drills for disaster preparedness have been conducted at AIIMS, PGIMER, JIPMER, and other premier hospitals. For capacity building in emergency healthcare, additional training modules for CPR, first aid, and basic life support are also being rolled out with support from the Indian Red Cross Society, National Institute of Health and Family Welfare (NIHFW), AIIMS New Delhi, and Integrated Government Online Training (iGOT).



### Modi Chairs High-Level Security Meeting To Review National Preparedness Amid Regional Tensions

In response to escalating regional tensions, Prime Minister Narendra Modi convened a high-level meeting with Union Secretaries on Thursday, May 8, 2025, to assess India's security preparedness and strengthen inter-ministerial coordination. During the meeting, the Prime Minister emphasized the critical importance of maintaining vigilance, enhancing institutional collaboration, and establishing clear communication channels as India navigates through this sensitive security period. He reaffirmed the government's steadfast dedication to national security, operational readiness, and public safety. This strategic review follows the devastating April 22 terrorist attack in Pahalgam that resulted in 26 civilian casualties, and India's subsequent military response on May 7 targeting terrorist facilities in Pakistan and Pakistan-occupied Kashmir. Security forces have heightened surveillance and preparedness measures under the ongoing Operation Sindoor initiative. According to the official government statement, "All Ministries are fully prepared to respond to emerging situations," with departments identifying specific action points related to the conflict and strengthening institutional protocols accordingly.

The comprehensive meeting addressed various critical issues including enhancing civil defense systems, combating misinformation, and protecting vital infrastructure. Ministries were instructed to maintain close cooperation with



state governments and local agencies. Prime Minister Modi stressed the necessity of seamless coordination among government departments to ensure operational continuity and institutional strength. Secretaries have been directed to thoroughly evaluate their respective departments to guarantee uninterrupted essential services, with particular focus on emergency response capabilities and internal communication frameworks. The meeting was attended by the Cabinet Secretary, senior officials from the Prime Minister's Office, and Secretaries from key departments including Defense, Home Affairs, External Affairs, Information and Broadcasting, Power, Health, and Telecommunications.

### Revanth Reddy's remarks on state finances spark discord within Telangana Congress

Hyderabad: Chief Minister A Revanth Reddy's repeated remarks about the State's financial distress have not only drawn flak from various quarters but also sparked internal dissent within the Telangana Congress. Except for a few Cabinet Ministers who made an unconvincing effort to defend the Chief Minister's statements, most Congress leaders are distancing themselves from his remarks. Jittery Revanth Reddy slams Telangana government employees for protest plans, claims State is bankruptWhile there is consensus that the State's finances are strained, party insiders say the situation is not as dire as projected. "To convince employees' unions, he exaggerated certain aspects," a senior leader from Gandhi Bhavan observed."In trying to exert emotional pressure on employee unions, the Chief Minister became overly emotional. Statements like banks treating elected representatives as thieves are inappropriate," the leader added.

When asked how the party high command might react, the senior leader said the AICC could privately express disapproval over the remarks. "The high command has been lauding Telangana's caste census and encouraging the Centre to emulate it. At such a time, such statements on the State's finances could embarrass the AICC." the leader noted. Sources indicated that the Chief Minister's frustration was visible. Apart from dissent within the party, senior bureaucrats, particularly IAS officers, are reportedly not



responding to his directives-a fact he himself has acknowledged on multiple occasions. Recent reshuffles within the Chief Minister's Office and transfers of senior IAS officers in key departments also point to administra-

The Chief Minister had earlier instructed MLAs and other public representatives to undertake an extensive grassroots outreach campaign from April 16 to June 2, aimed at publicising the Congress government's achievements. At the Congress Legislative Party meeting, he also announced plans to begin district tours from May 1. However, only a few MLAs complied. While the scorching summer is a factor, many legislators reportedly fear public backlash for unfulfilled electoral promises.

#### Strikes to strategy

IN the immediate aftermath of Operation Sindoor — ndia's precision strikes on terror camps across Pakistan and Pakistan-occupied Kashmir — the government on Thursday projected unity and resolve, even as tensions emain high and retaliatory hostilities continue. In response o attempted strikes by Pakistan, India pre-emptively neutralised missiles aimed at 15 major cities and destroyed a key air defence system in Lahore.

Prime Minister Narendra Modi's high-level review neeting underscored the gravity of the situation. Terming his a "sensitive period", he called for institutional synergy and citizen safety as top priorities. The Whole-of-Governnent approach — focussing on civil defence, countering disinformation and safeguarding critical infrastructure – signals readiness beyond the battlefield. The directive to ninistries to ensure emergency response protocols and perational continuity reflects a sober understanding of nybrid threats, including cyberattacks and misinformation ampaigns. Lending equal weight to the day was Defence Minister Rajnath Singh's detailed briefing to an all-party neeting, where he confirmed the neutralisation of at least 00 terrorists. The Opposition, notably the Congress and he AIMIM, displayed commendable maturity, putting aside political divisions to rally behind the national interest. This are moment of bipartisan consensus sends a strong nessage to both domestic and international audiences: vhen India's sovereignty is challenged, its political fabric

However, the larger picture remains fraught. With ndia stating that it has no intent to escalate but is fully prepared to retaliate, strategic restraint must continue to be balanced with credible deterrence. The emphasis must low shift from tactical victories to strategic stability. In the lays ahead, civilian protection, diplomatic messaging and nternal security will demand unwavering focus.

#### Government Must Sanction Financial Benefits Dues to Employees and Teachers: APTF 257"



""May 9,Indian Chronicle, Rayalaseema coordinator ""The Andhra Pradesh Teachers' Federation (APTF) district president, Muralikrishna, demanded that the government immediately sanction the financial benefits due to employees and teachers, as the government has been showing negligence in this regard for the past few years. He also demanded the appointment of the 12th PRC Commission, which should have come into effect in 2023, the immediate announcement of a 30% interim relief, the re lease of thousands of crores of rupees in pending 11th PRC arrears, and the issuance of pending Dearness Allowances (DAs). He made these demands during a protest held in front of the District Collectorate on Friday. "Speaking at the demonstration, district honorary advisor S. Venkata Muni stated that while the previous government established six types of schools, the current government has introduced nine types, pushing the education system into chaos. He demanded that the government reconsider the new policy and take measures to prevent the weakening of primary schools. He pointed out that the previous government merged classes three, four, and five in high schools, and now this government is attempting to merge classes one and two as well. In the same village, they claim they will continue a separate school for classes one and two under the name of a foundation school, which he termed a completely unscientific approach. He urged the government to continue primary schools from classes one to five, as they have been operating in villages for decades. He requested the establishment of model primary schools with a minimum of two teachers regardless of the number of students, and an increase in the number of teachers as student numbers rise, along with the provision of Primary School Headmaster (PSHM) posts in these schools. He also argued that the student-teacher ratio should not vary for each type of school and that pre-primary education should be integrated with primary schools. He called for the continuation of the policy of having four School Assistant posts where classes six and seven are present in upper primary schools, and six School Assistant posts where classes six, seven, and eight are present. He further demanded the establishment of schools in municipalities, corporations, and newly developed residential areas in line with the increased population. He appealed to the government to continue the mother tongue as the medium of instruction in all schools, as mentioned in the National Education Policy and the Right to Education Act, and to abolish CPS and GPS. "District General Secretary Balasubrahmanyam stated that OPS should be immediately implemented for the 2003 DSC candidates as per Memo No. 57. He also urged the immediate appointment of the 12th PRC Commission and the announcement of a 30% IR, along with the payment of all types of financial arrears owed by the state government to employees, including the 11th PRC arrears, and the regularization of MTS teachers. "State Audit Committee member Venkatadri emphasized that the mother tongue in schools is like the soul of a ???? (jati - meaning community or nation), and its complete removal should be condemned by language enthusiasts and mother tongue lovers in a democracy. He also called for the protection of minority languages such as Urdu, Kannada, Tamil, and Oriya, demanding the continuation of their respective mediums of instruction, as well as the continuation of the Telugu medium in schools. "District executive members Bhuvaneshwari, Lakshmamma, Madan Mohan, Gopal, Chenchu Raja Sheikh, Lakshmi Narayana, Sridhar, Jayaramaiah, state executive members, and presidents and general secretaries of various mandal branches, along with teachers, par-

### Three jawans killed in bomb blast

Constables Pawan Kalyan and Sandeep were among the constables involved in the bomb blast. During the Kagar operation carried out by the Central and Chhattisgarh state security forces in the Karreguttala area, the police and Maoists came face to face and exchanged fire. Following the encounter that took place on the Telangana-Bijapur border, tense conditions prevailed in Bijapur district on the Chhattisgarh border since morning. The Kagar operation, which has been ongoing by the security forces for the past 17 days, has caused a lot of damage to the Maoists and the security forces. "- Ten key leaders killed ..? ### Early Teen Stress Tied to School and Identity, Study FindsEducation New Zealand - Media Release

Hyderabad:Teens starting high school and navigating their self-identity need more access to support and resources, says University of Canterbury researcher Dr Valerie Sotardi. A study of child health and wellbeing has revealed that starting high school and self-identity are the biggest causes of stress for young teens, and a University of Canterbury (UC) | Te Whare Wananga o Waitaha researcher hopes the results will shape future support services

The 'Our Voices' study sought responses directly from approximately 1000 13-year-old participants about their experiences navigating adolescence in Aotearoa and has already released a series of findings as part of its Summer Snapshot series. Their families are participating in the Growing Up in New Zealand longitudinal study that aims to better understand the diverse and complex journey young people experience growing up in New Zealand.

The latest report to come from the Our Voices study, 'Navigating Rough Waters: Support Networks for Youth' led by UC Senior Lecturer Dr Sotardi, identifies key stressors and how teens overcome tough times. Dr Sotardi, a leading educational psychology researcher in New Zealand, helped identify the most common emotional, social and academic challenges 13-year-olds face, and what help mechanisms they use to overcome those challenges.

"What we found was interactions at school and un-

derstanding who you are, and self-acceptance were the most commonly reported challenges," she says. The significance of the high school transition was reflected in the teens' responses. Workload or getting good grades, making new friends, and trying to fit in were the most common sources of stress. The teens were asked what helped them get through tough times, with nearly three quarters emphasising the importance of family and whanau support, friends, mentors and even social media influencers as key coping mechanismsMany of the teens regularly used more than one coping strategy, with a quarter of participants using activities such as gaming to provide a distraction from the stress they were experiencing.

"We found that key social relationships were how the teens coped best, but also distraction and escapism were legitimate forms of coping as well - reading, music and gaming all helped regulate emotion and helped create space for teens to pause and reflect," Dr Sotardi says.

By showing adolescence as a critical developmental stage that is marked with commonly experienced challenges, educators, community organisations and policy makers can make more informed decisions about future support services. "There is now the potential to develop programmes that promote positive relationships and reinforce how safe school environments contribute to stronger emotional wellbeing for young people across Aotearoa."



### Operation Sindoor: Pakistani media twisting the truth, says I&B Ministry

"Operation Sindoor was launched as a response to the attack that took place in Pahalgam, on April 22, killing 26 civilians. During the press briefing on May 7, India clarified its response as focused, measured and non-escalatory. It was specifically mentioned that Pakistani military establishments had not been targeted. It was also reiterated that any attack on military targets in India will invite a suitable response," it said. The Ministry said: "What should have been a moment of international reckoning against terror has instead been manipulated into a disinformation war, where truth is the first casualty". Flagging the "grossly exaggerated claims", it said nearly all major Pakistani news channel such as "Geo News, Dunya News, ARY News, and SAMAA TV have been repeating the same unverifiable, inflated claim: that the Pakistan Air Force has shot down Indian drones". "For instance: Geo News alleges 25-29 drones were intercepted without providing visual evidence or independent verification. Duniya News inflated that number to 32 drones. ARY News claimed 25 drones were

shot down, and also added drama by naming Israeli-made Harop drones allegedly used by India," the Ministry said. "With no neutral tone and gross misrepresentation of facts, these are coordinated attempts to portray Pakistan as both the victim. There is no mention that these drones were targeting terrorist launchpads, not civilian zones," it said.

The Ministry accused Pakistani networks of repeatedly emphasising "civilian casualties" "without offering concrete details or differentiating between civilian zones and terror camps""HUM News and SAMAA TV extensively highlight emergency room visuals and civilian interviews from cities like Karachi and Lahore. Not a single channel admits that many of the targeted structures were identified Indian-designated terror facilities- the home to Jaish-e-Mohammed elements and Lashkar-e-Taiba remnants," it said. The Ministry alleged that Dawn News "outrightly denied Pakistan launching any attacks or harboured militants involved in terror strikes inside India. ARY News and Duniya News call Indian media reports of Pakistani activity in Jammu & Kashmir 'fake news' and 'propaganda'. "None of these channels mention terrorists reported killed during Operation Sindoor. These deaths would validate the strike's strategic importance, yet completely censored in Pakistani coverage. "Express News ran dramatic segments alleging Indian missile strikes on the Karachi Port, claiming Pakistan Navy installations were targeted. Yet, no verified information is provided. Instead, terms like 'shameful attack' and 'inevitable clash' are used by the DG ISPR, Pakistan," said the Ministry. In a stark contrast, the Ministry said the Indian army officially released a video confirming the shooting down of Pakistani drones along the western border, "in response to multiple coordinated attacks by Pakistan armed forces using drones and other munitions". The Indian Army's statement outlined that Pakistan launched a barrage of drone and missile attacks across the western frontStating that there were numerous ceasefire violations along the Line of Control (LoC) in Jammu & Kashmir and drone/missile attacks launched from Pakistan, the Ministry said: "the real evidence, including military footage, and official updates, shows that Pakistan started the attacks, and India responded in a controlled but strong manner".

### We are at war with terrorists: Indian Ambassador to U.S. Vinay Kwatra

India is at war with the terrorists and will bring justice to victims of the Pahalgam attack by holding the "lowlifes, subhuman monsters" accountable, Indian Ambassador to the U.S. Vinay Kwatra has said, underscoring that in no world would these terrorists be allowed a free pass. "The frame and the template in which we look at is the terror template. April 22 was the most heinous terrorist act," Mr. Kwatra said in an interview to CNN on Thursday "It is nobody's case to say that these terrorists should be given a free pass, and that's precisely what we did day before yesterday, held them accountable, brought them to justice," Mr. Kwatra said. "We are at war with the terrorists, and we will, as I said, bring justice to the victims and hold them accountable," he added. "Our foremost objective in this was (to) hold these lowlifes, subhuman monsters accountable and bring justice to the victims."India launched 'Operation Sindoor on May 7, striking terror factories at nine locations in Pakistan and Pakistan-occupied Kashmir in retaliation for the Pahalgam terror attack that killed 26 civilians and for which The Resistance Front (TRF), a front for the UN-proscribed Pakistani terrorist group Lashkar-e-Taiba, had claimed responsibility. Underscoring the fact that four terrorists backed by Pakistan killed 26 civilians, Mr. Kwatra said "in no world would you allow such terrorists to be given a free pass. And that is precisely what we did the day before yesterday

'We carried out very precise, calibrated, measured response to these terrorists, to their factories, to their integrated facilities, which they run out of Pakistan and Pakistan-occupied Kashmir.... It is nobody's case to say that such terrorists should be given a free pass, wherever they are located."He added that from a large number of Congressmen, Senators to the whole world, they all appreciate that India should respond and bring accountability for these terrorists and justice for the victims.Mr. Kwatra asserted that the original escalation and the original breakout of tension happened on April 22, when four terrorists backed by Pakistan carried out brutal killings, subhuman, monstrous kind of killings of 26 civilians, including a Nepali national. He said the terrorists killed the civilians on the basis of religion, identifying and killing "all non-Muslims". "So what we did day before yesterday was essentially our response to terror," he said, adding that India's response has been very measured, calibrated and proportionate.

'Pakistan stands with terrorists' Responding to a question on explosions being heard in Kashmir, Mr. Kwatra said



Pakistan has again decided to stand with the terrorists. "Rather than take action against them, they are essentially lending them support," he said. "We wouldn't be surprised if they are themselves involved in this, but that's what is the message," which Pakistan is telling the world that it is with terrorists, it is not with the rest of the civilised world, the rest of humanity. "Pakistan's belief lies in perpetrating these proxies of terror killings, brutal killings of innocent civilians," he said. 'Denial and obfuscation'To a comment that Pakistan has denied involvement in the attacks, Mr. Kwatra said that "denial and obfuscation" has always been the first part of Pakistan's strategy. "They have this unique characteristic where they assume responsibility of their past actions in future, not in the present moment," he said as he asked "where was" Al Qaeda leader Osama bin Laden, who plotted the September 11 attacks in the U.S., found, the killer of American journalist Daniel Pearl or perpetrators of the 26/11 Mumbai terror attacks found.Responding to a question, Mr. Kwatra said that with Operation Sindoor, "we, from our perspective, had brought a certain finality to it, but it was, of course, subject to whether Pakistan has brought finality to it. Pakistan chose to escalate it further. Now it's duty-bound for us to respond to that."When asked how concerned the world should be that the tensions between India and Pakistan could escalate into a nuclear war, the Indian envoy said, "I think the world should be concerned about the fact that Pakistan's support to terrorism and terrorist activities continues. I think that's what the world should be concerned about. And I think that's what the world should tell Pakistan — to stop supporting terrorism. I think that's the crux of the question.""That's for you to ask Pakistan for that," he said when asked if he thinks it could get to the point of nuclear weapons.

### If I can do anything to help, I will be there: U.S. President Trump on tensions between India, Pakistan



Mr. Trump's remarks came after the Indian military carried out strikes against terror targets in Pakistan-occupied Kashmir (PoK) and Pakistan's Punjab province on Wednesday. Pakistan army carried out one of the most intense artillery and mortar shelling in years targeting forward villages along the LoC in Jammu and Kashmir. "Oh it's so terrible. My position is I get along with both. I know both very well and I want to see them work it out. I want to see them stop and hopefully they can stop now. They have gone tit for tat, so hopefully they can stop now. I know both, we get along with both the countries very well. "Good relationships with both and I want to see it stop. And If I can do anything to help, I will be there," Trump said in response to a question on the "war" between India and Pakistan. He was speaking on Wednesday (May 7) in the Oval Office after the swearing-in ceremony of David Perdue as U.S. Am-

bassador to China. Earlier, hours after the Indian strikes. Trump had said that India and Pakistan have been fighting for a long time and people knew "something was going to happen"."It's a shame, we just heard about it just as we were walking in the doors of the Oval (Office). Just heard about it. I guess people knew something was going to happen based on a little bit of the past. They've been fighting for a long time. "They've been fighting for many, many decades and centuries, actually, if you really think about it," Mr. Trump said when asked about the attacks between India and Pakistan. When asked if he has any message for the two countries, he said, "No, I just hope it ends very quickly. Meanwhile, a top American military commander has said that the US is "watching the situation very closely" after Indian military strikes. "It's right now too early to opine on any of that. We're watching the situation very closely. We're nested with our higher headquarters and USINDOPACOM as the information about these strikes becomes more clear," U.S. Army Pacific Commanding General, General Ronald Clark said during a digital press briefing Wednesday.India launched Operation Sindoor early Wednesday, hitting nine terror targets in Pakistan-occupied Kashmir (PoK) and Punjab province of Pakistan in retaliation for the April 22 terror attack that killed 26 people in Jammu and Kashmir's Pahalgam.Pakistan Army spokesman Lt Gen Ahmad Sharif Chaudhry said 31 people were killed and 57 others injured in the Indian missile strikes launched shortly after

### Not revenge or retaliation, but a paradigm shift

The Pahalgam terror attack (April 22) has put Delhi and Islamabad into a different trajectory from the past, and is one that should alert the entire strategic community. This was the first such incident on this scale targeting civilians since the Mumbai 2008 attacks. The barbarity in Pahalgam, segregating men from women, identifying them by religion and then executing them is aimed not just at terrorising Indians, and crushing a slowly reviving Kashmiri economy but also of instigating a communal rift in the rest of the country. Unlike the "fidayeen" attacks of the past, where terrorists were sent in as cannon fodder, to continue to kill until eliminated by security forces, this attack seemed more precise, with an exfiltration plan in place. While a deeper inquiry into the lapses that allowed the attack to take place and for the terrorists to leave unchallenged is awaited, the government has announced diplomatic measures, which include the suspension of the Indus Waters Treaty (IWT). It has also given the defence forces the green light to plan a

How does one craft a more long-term response, that does not just seek revenge or retaliation, but works as a deterrent in the short term and seeks to change patterns of cross-border behaviour in the long term?

To begin with, it is necessary to analyse India's varied responses to attacks of a similar magnitude over the past few years for what was, relatively speaking, more effective in securing India's security interests. While most analyses look at the responses to the Uri (2016) and Pulwama (2019) attacks, at least five different responses should be studied: this includes 2001, after the Parliament attack, when the Indian Army was mobilised during Operation Parakram. After the Mumbai attacks, the government launched an international campaign that pushed Pakistan to admit that terrorists had been raised and trained on its territory, and Pakistan was first put on the Financial Action Task Force (FATF) grey-list for terror financing and money laundering. In 2007 after the Samjhauta Express train attack and in January 2016 after the Pathankot attack, India asked Pakistan to join the investigation, and a Pakistani team was even invited to visit the Pathankot air force base in March 2016. After the Uri attack, the government okayed cross-Line of Control (LoC) surgical strikes to attack terror camps in Pakistan Occupied Kashmir (PoK). And in 2019, the Indian Air Force bombed a terror camp in Balakot, outside PoK, which then saw a counter-mobilisation by the Pakistan Air Force, the capture of an Indian pilot, and a helicopter accidentally shot down on the Indian side.

Given that the Pahalgam attack appears to have been a deliberately planned provocation, another similar response from India will be expected, and would have been war-gamed already. This narrows strategic options for a strike that catches the other side unawares. Planners will not only need to eliminate the responses already tried in the past but they also must produce three separate strategies: a counter-terror strategy, a strategy for retaliation, and a strategy to manage Pakistan's counter-retaliation as well.

Three other areas of misadventure and miscalculation must also be factored in, beginning with Pakistan Army Chief General Asim Munir's apparent desire to escalate matters with India. A clear indicator of this were two recent speeches: calling for Pakistan to become a "hard state", underlining religious differences between Hindus and Muslims that fomented the "Two-nation theory", and the reference to Kashmir as a "jugular vein". It must be kept in mind that Gen. Munir was commissioned in the Pakistani Army

in 1986 during Gen. Zia-ul-Hag's tenure as the President of Pakistan when the ideological purpose of the Pakistan Army was changed from "Ittehad, Yaqeen, Tanzeem (unity, faith and discipline") to the more radicalised "Iman, Taqwa, Jihad fi Sabeelillah (faith, obedience of god and struggle for the path of Allah"), and this is likely to have left a lasting imprint. Gen. Munir has been under pressure not only to avenge the Jaffar Express attack in Pakistan in March this year in which, coincidentally or otherwise, 26 hostages, all men, were killed. Another pressure point is the continued popularity of Imran Khan, his biggest critic, who has been in jail for nearly two years. Even so, Gen. Munir, who will remain in the saddle until at least 2027 due to a change in Pakistani law last year, has few challenges to his will at present, and New Delhi must factor this in as well. The role of China is another wild card, particularly if India's response to Pahalgam hurts well-entrenched China-Pakistan Economic Corridor interests in any way. The third room for error could come from any hastily -prepared Indian response to the attacks, led by calls by some in New Delhi that it is time for a "definitive war", and that the time for "map-making" or "cartological changes" by capturing and holding parts of PoK is nigh. The diplomatic road ahead

At the same time, India's diplomacy has to double efforts to keep those counselling restraint, internationally, at bay, with the United States, the United Kingdom, the European Union, the United Arab Emirates and Saudi Arabia joining the chorus and attempting to mediate by calling on Delhi and Islamabad to "de-escalate". Such calls will only get louder if there is a retaliatory strike by India. In addition, India's decision to suspend the IWT could see a diplomatic pushback from the World Bank and others including upper riparian states such as China, and lower riparian Bangladesh.

At the UN Security Council (UNSC), India had to suffer a "watered-down" statement issued last month, that omitted references to The Resistance Force (TRF), the group linked to the Lashkar-e-Taiba (LeT) that initially claimed responsibility for the Pahalgam attack, and to the "Government of India" as the relevant authority to cooperate with, as Pakistan is a current member of the UNSC Despite that, India must bring a listing request for a UNSC designation of the TRF and its leadership — as it did for the LeT after the Mumbai attacks and the Jaish-e-Mohammed after Pulwama — and convince the U.S. and others to list the TRF as a Foreign Terrorist Organisation (FTO) in their countries. The FATF's strictures on Pakistan have been an effective tool in the past and must be revisited. A diplomatic campaign for the Comprehensive Convention on International Terrorism (CCIT) that India first proposed in the 1990s could also be re-energised, possibly using Opposition leaders and the Jammu-Kashmir leadership to head delegations abroad to defend India's responses, in the manner Prime Ministers Indira Gandhi (1971) and P.V. Narasimha Rao (1994) once did.LoC as the borderFinally, it is time to reconsider an idea that was prematurely discarded nearly two decades ago — of sealing the LoC into a more formal border. For too many years, Pakistan's military has used the LoC as a convenient conduit to bring over recruits for training and send over terrorists to carry out attacks in India — using both its permeability as well as its impermanence as a pretext to continue a proxy, asymmetric war. The TRF's initial telegram message, claiming responsibility for the Pahalgam massacre, was that the attack was aimed at stopping "demographic changes" in Jammu-Kashmir. On its side of the LoC in PoK however, Pakistan has completed demographic change, settling non-Kashmiris, army officers and others in the areas, and hiving off Gilgit-Baltistan into a federally administered area. These areas would be virtually ungovernable by India, even if they were to be taken over coercively. It is, therefore, vital to call 'time of death' on Rawalpindi's 'jugular vein' theory and dreams of unifying the nowsparate regions of Jammu-Kashmir and somehow annexing the Kashmir Valley. New Delhi must revisit the LoC agreement proposals of 2007, that sought to turn the LoC or ceasefire line, into a de-facto border, with a view to making it a permanent International Border in the future. The role of the international community, if at all, would be in ensuring that Pakistan commits to it — if it wishes to ensure a lasting equilibrium in the region.

### WB govt issues notification of leave cancellation, warns against black marketing of goods

A day after the West Bengal government announced the cancellation of leave of all government employees, Chief Minister Mamata Banerjee on Thursday (May 9, 2025) warned the State administration and business community about black marketing of essential commodities in the wake of the Pahalgam situation. "A situation has arisen after the Pahalgam attack. Everyone, keep your stock ready. If something happens here, people should be prepared," Ms. Banerjee said during a meeting with government departments cold storage associations and traders of various departments.

The Chief Minister urged the traders that this is not a time of making profits. "No one should do hoarding and black marketing at this point. Do not supply our produce through the borders to earn more money at this juncture. Keep eyes on the borders. The DGP should hold a virtual meeting," Ms. Banerjee said. During the meeting the Chief Minister directed that the number of stores of Sufal Bangla (outlets providing essentials at subsidised rates) be increased. "In total, there are around 700 outlets and we will have 100 more. They have a store presence in many places and are doing a good job," she added. The Chief Minister directed the Ministers and officials to monitor the markets regularly and reactivate the task force to control the price of essential commodities. "If there is a crisis, we will have a meeting again. Think of the nation as your home and take care of it. The ministers and the police should be vigilant," she added.

On Wednesday the West Bengal Chief Minister extended full support to the Union government after 'Opera-

tion Sindoor' and added, "We are together in the war on terror". Trinamool Congress representatives also participated in the all party meeting at Delhi on Thursday and expressed support to the Union government. The Chief Minister on Wednesday announced the cancellation of the leaves of all state government employees until further notice. A notification issued by the West Bengal finance department on Thursday cited the "current situation" as the reason behind the decision. The order applies to all categories of state government employees, and even those who had been sanctioned leave earlier will now have to report back to duty. Only employees on medical leave will be exempt from the directive, the notification clarified. "No official shall leave their headquarters without the written permission of their respective heads of the department," it stated. The State government has urged private schools to declare holidays after

### Dispute between neighbours over Instagram message ends in brutal murder of man in Pune's Indapur

A man in the Indapur taluka of Pune allegedly banged his neighbour's head against a rock and strangled him Saturday following a dispute over an Instagram message in which the accused had sent a photo of the victim's sister. The brutal murder took place around 7.30 pm in the Anthurne village of Indapur taluka, located around 130 km from Pune city. The police identified the deceased as Akash Musa

Chougule, 25, a resident of Anthurne, whose family runs a small stationery business. A First Information Report (FIR) in the case was registered based on the complaint of Chougule's mother, Shantabai Chougule, 45.

The police arrested the accused, Rajesh Saybu Pawar alias Tatya, 21, who lives very close to Akash and works as a labourer, in the early hours of Sunday. He has been remanded in police custody until May 7.According to the FIR, Akash came to Shantabai Saturday evening and showed her an Instagram message from Pawar with a photo of her daughter. Shantabai and Akash then went to Pawar's house to confront him about the message at around 7.30 pm. she told the police. When Akash confronted Pawar about the message, a heated argument occurred between the two, per the FIR. Pawar then allegedly dragged Akash out of the house and took him to an open space in front. Pawar allegedly banged Akash's head against a rock on the ground and strangled him. Akash started bleeding profusely from the head injury, and moments later, he stopped moving, Shantabai told the police, adding that Pawar fled from the

Shantabai said she raised an alarm and called some neighbours to him. Akash was then taken to a local hospital, where he was pronounced dead. "The incident was reported to the police late in the evening on Saturday. After the post-mortem and inquest examination, an offence of murder was registered in the early hours of Sunday," an officer from the Walchandnagar police station saidThe police invoked Section 103 (murder) of the Bharatiya Nyaya Sanhita (BNS) against Pawar.

### 'Lost Rs 3 crore in fire. How will I deliver bridal wear due for this month?': fashion designer Riyaz Gangji of Mumbai's Libas

Early on Monday morning, Libas Riyaz Gangji, a designer brand housed inside the Sukh Shanti Building at Peddar Road in Mumbai, caught fire. While no injuries have been reported yet, fashion designer and executive director of the brand Riyaz Gangji said that he faces a loss of Rs 3 crore. "I have lost everything, either it was burnt down or it has been soiled during the rescue operation by firefighters," Gangji, 56, told The Indian Express over a phone call.

The Mumbai Fire Brigade (MFB) contained the fire by 8.10 am as it pressed six fire engines, eight jumbo tankers, and one turntable ladder, amongst other equipment. Mumbai Libas store fire Even though Gangji is waiting for the official report about the source of the fire, he said it seems to be "a short circuit or something in the electrical board".

The incident, he says, must have happened at about 6.30 to 7 am. "I was sleeping at my home in Andheri and couldn't be reached on the phone. My manager came home and woke me up around 8.30 am. I reached the store by 10.30 am and by then, everything was turned into ashes," he shared. Even though he is waiting for the official report

While Libas is a popular ready-to-wear brand, the 30-year-old Pedder Road store spread across 2,000 sq ft, specialised in custom-made and wedding couture. "Since Libas is a publicly listed company, the store and its stock were insured, but I am worried about deliveries. How will I make delivery of bridal wear for those getting married this month?" he asked, and added that it is very difficult to redo all the work.

### Internal reservation in mind, Karnataka launches survey of SC sub-castes

caste survey, schedule caste, karnataka news, indian expressThe ongoing survey will ensure that members of these communities are enumerated properly under the correct SC sub-categories. The Karnataka Government has launched a survey of Scheduled Caste (SC) communities to enumerate the sub-castes within each parent group. The exercise is being carried out based on the recommendations of an interim report by the Justice Nagamohan Das Commission which was formed to submit a report on internal reservation for SCs in the state. The survey will be carried out in three phases: the first phase will be from May 5 to 17, during which door-to-door surveys will be done to collect empirical data, Chief Minister Siddaramaiah told a news conference on Monday. The second phase will have special camps for those who have not been enumerated in the first phase, and it will be held from May 19 to 21. The government will also open an online mode in the third phase of the survey from May 19 to 23, under which members of SC communities can self-declare their sub-castes and respond to other queries in the survey questionnaire.

The handbook on 'Comprehensive Survey of Scheduled Castes - 2025' says that it will collect data on the number of members of an SC family, educational details including reasons for discontinuing studies, employment details, annual income, benefits derived from reservation policy in the education sector, assets owned by the family surveyed, source of drinking water, and nature of dwelling area among others. These details will be compiled under the 101 subcastes listed in the SC category. "After getting exact data, we have asked the Commission to submit details in 60 days. Recommendations (on internal reservation) will be made after that," Siddaramaiah said. Across the state, 65,000 teachers appointed by the deputy commissioners of respective districts will serve as enumerators. The survey was required as the state government did not have exact details on the population of Adi Dravida, Adi Karnataka and Adi Andhra communities, which was crucial to provide internal reservation. The ongoing survey will ensure that members of these communities are enumerated properly under the correct SC sub-categories, he said. The one-man Commission was formed in November last year, following a Supreme Court decision which empowered states to provide internal reservation for SC communities. States such as Telangana and Haryana have announced quotas within the SC category since the decision. After the Commission was set up, the government also decided to withhold issuing a fresh notification for government jobs from the Karnataka Public Service Commission until the issue of internal reservation for SC communities was settled.

The SC community, numbering around 1.3 crore in Karnataka, is classified under four heads: SC Left, consisting of the most backward communities; SC Right, who are less backward; communities such as Banjaras and Bhovis; and other minor communities. Towards the end of its tenure, the previous BJP government had in March 2023 announced internal reservation for SC communities which was not implemented. Under the scrapped policy, the SC Left community was given 6 per cent of the 17 per cent reservation quota for SCs, while SC Right got 5.5 per cent, com-



munities such as Banjaras and Bhovis got 4.5 per cent and other SC groups got 1 per cent. The announcement back then was met with violent protests in parts of the state.

# Maharashtra HSC 2025 results out, pass percentage drops to 91.88% from 93.37% last year

This year, the Maharashtra state board examinations witnessed over 31 lakh registrations. The Konkan division topped all nine divisions with a pass percentage of 96.74 per cent. Maharashtra State Board of Secondary and Higher Secondary Education (MSBSHSE) declared the Higher Secondary Certificate (HSC) Class 12 exam results Monday. The pass percentage dropped considerably from last years's 93.37 per cent to 91.88 per cent this year. While some attribute this gap to the stringent anti-copying measures taken during the exams, according to the Maharashtra State Board, this drop is insignificant. Chairman Sharad Gosavi said, "With just 1.49 per cent, this is a very minimal drop. In fact, the HSC exam held in March 2023 had a recorded pass percentage of 91.25, which indicates that with a marginal gap, the result remains in a similar bracket this year, too."But there are no students with perfect scores of 100 per cent this year. Last year, one student from Chhatrapati Sambhajinagar scored 100 per cent in HSC 2024. This year, 4,500 students across Maharashtra scored more than 90 per cent. As many as 2,0943 students received additional marks for excellence in Sports or Scout and Guide activities. As many as 14,27,085 students registered for the exam, which took place between February 11 and March 11, 2025. Of those, 14,17,969 students appeared for the exam, and 13,02,873 of them passed. As is often the case, girls performed better, achieving a pass percentage of 94.58 per cent, while boys recorded a pass percentage of 89.51 per cent. While the Konkan division topped all nine divisions with a pass percentage of 96.74 per cent, the Latur division ranks the lowest with 89.46 per cent. After consecutively ranked lowest among all nine divisions for three years, the Mumbai division jumped to third spot with a 92.93 per cent pass percentage this year.

### Mumbai's water stock goes below 25%, BMC to decide on implementing water cut later this week

The average water stock in the seven lakes that supply drinking water to Mumbai was 22.66 per cent on Monday morning – roughly 8 per cent lower than the reading of 30 per cent taken on April 15.However, Monday's level was still higher than the combined water level of 17.54 per cent recorded on May 5, 2024. While the water stock stood at 23.01 per cent on the same day in 2023.

Issuing a statement, the Brihanmumbai Municipal Corporation (BMC) on Monday (May 5) said that the current stock is adequate to last till July 31 and at present, the authorities are monitoring the usage. The BMC has also urged Mumbaikars to use water cautiously. Being an island city, Mumbai draws its water from seven lakes – Tulsi, Vihar, Bhatsa, Tansa, Upper Vaitarna, Middle Vaitarna, and Modak Sagar. While two of these lakes are located within Mumbai, the rest are in the neighbouring districts of Thane, Palghar, and Nashik. The catchment area of these lakes gets filled during the monsoon, and the water is transported through tunnels to the Brihanmumbai Municipal Corporation's (BMC) filtration plant. After filtration, water is supplied to every household and commercial establishment through pipelines and reservoirs.

The seven lakes hold a total quantum of 14.4 lakh mil-

lion litres of water, and considering that the BMC supplies 3,850 million litres daily (MLD), the overall stock is supposed to last for 375 days. As of May 5, the water stock in the seven lakes is 3.28 million litres, and the stock is expected to last for 60 days. Officials, however, have flagged that due to rapid evaporation because of heat, the water levels are dipping faster than usual in the lakes. "The rate at which the stock is dipping shows that the overall percentage of water stock may hover around 15 per cent by the second week of May. The rapid dipping of stock is happening due to evaporation due to a rise in temperature, and considering the IMD (India Meteorological Department) officials have announced a rainfall alert this month for several parts of Maharashtra, we are hoping that there will be a respite and fast evaporation may not happen," said an official. The official also informed that the BMC will hold a review meeting this week with IMD officials to ascertain the arrival of monsoon and decide if a cut in water supply should be implemented. "Usually, every one per cent of the overall stock leads to three days of supply. However, in the last two weeks, the stock came down by eight percentage points, which indicates that the water stock meant to last for 24 days got over in just 15 days. This is happening because of the heat, which is leading to faster evaporation, and the gap will widen when the temperature increases further as the month progresses," the official added. The monsoon usually arrives in Mumbai on June 15. However, over the last few years, the city has witnessed delayed monsoon onsets, with rain picking up pace only during the last week of June. More importantly, catchment areas of these lakes are located in the districts of Palghar, Thane, and Nashik, where intense rainfall begins not before the middle of July.In the last week of March, the Maharashtra government allowed the BMC to use a reserve stock of 1.81 lakh million litres, which is expected to last roughly 48 days, considering the civic body maintains its normal quota of supply. However, if a water cut is imposed, the stock may last for a few

### Mamata appeals to Centre to 'bring arrested BSF jawan back from Pakistan'

Speaking on the way to Berhampore, she said, "It is indeed very sad news. Our MP Kalyan Banerjee is in contact with his family. Our government is also in contact with his family. We want him to be brought back as early as possible."Banerjee visited Berhampore on Monday and will go to Dhulian and Suti on Tuesday to see the violence-hit areas of Murshidabad. The riots, which took place in the wake of the new Wagf law, claimed three lives - a man in police firing and a father and son in mob violence. The family of the father and son duo from Jafrabad who died in the violence is currently in Kolkata. Murshidabad police allegedly came to Kolkata to talk with the family, but the family refused to return to Murshidabad during the Chief Minister's visit.Speaking on the issue, she said, "I have heard that



two family members went away. I have no problem with that. I will meet the families who come. They (BJP) may have given them money. The government also has plans to give them monetary help. I am supposed to give that. Those who come, I will give them money to build a house. Then, I will go to Suti. There will be a government distribution programme."She also denied the Governor's report about Murshidabad and his suggestion to impose Article 356 in West Bengal. "I don't have such information. He is ill and I pray for his speedy recovery," said Banerjee.

A controversy has also emerged over the newly inaugurated Digha Jagannath idol being made with wood from the original Puri temple idol. When asked about it, the Chief Minister said, "Don't do this. We always respect the Puri temple. But there are many more Jagannath temples. Is there only one Shiv mandir in India? Why are people (BJP) so jealous of the Jagannath Dham in Digha?"

### 'My son has failed in exams but not in life': parents celebrate son after he scores 32% in Karnataka SSLC papers

However, here is a story of parents celebrating their son's failure in the Class 10 or Karnataka Secondary School Leaving Certificate (SSLC) exams.

Abhishek Cholachagudda, 17, a student of Basaveshwar English Medium School in Bagalkot, Karnataka, failed all six subjects and scored 200 out of 600 marks in his Class 10 board exams. While friends mocked him for securing only 32 per cent, Abhishek's father, Yellappa Cholachagudda, decided to cut cakes to celebrate his son's performance.

Speaking to the media, Yellappa said, "When Abhishek was one year old, he sustained severe burn injuries on his feet. It took him to a shock and he lost his memory. Since then, his memory levels have been very low. It is indeed an achievement that he has studied till Class 10. My son has failed in examinations, but not in life. I am very happy that he has secured 200 marks. I wanted to give him a message that the entire family is with him." I decided to celebrate and bought two cakes which mentioned his score. We are happy. I see a lot of graduates sitting at home without a job or work. But my son is strong and is willing to fight, which means a lot," said Yellappa, who owns a small business.

Abhishek said he was happy that his family had been "a strong support". "I will appear for examinations again. Even if I fail, I will not stop until I achieve something in my life," he added. The Karnataka School Examination and Assessment Board (KSEAB) released the results of the SSLC Exam-1 last Friday. This year, 62.34 per cent of students passed their SSLC exam, which is 9 per cent higher than the previous year. As many as 8,96,447 students appeared for the SSLC exams, including 4,61,563 boys and 4,34,884 girls, this academic year. As many as students scored full marks — out of which two are from Karnataka government schools — and 75 per cent of them secured first class by getting more than 60 per cent marksThe Karnataka SSLC exams were conducted at 2,818 centres, with 65,000 assessors deployed across 240 evaluation venues.

# BJP says Congress demoralising Indian armed forces after Ajay Rai calls for using Rafale jets 'parked with nimbu-mirch'

BJP Accuses Congress on Rafale: Accusing it of demoralising the Indian armed forces, the BJP on Monday took on the Congress after its Uttar Pradesh chief, Ajay Rai, exhibited a toy aeroplane with lemons and chillies, supposed to exemplify Rafale fighter jets kept in hangars, and questioned when India would take the next step against Pakistan following the Pahalgam terror attack. Rai accused the BJP-led Centre of merely "talking big" and questioned when the Rafale jets, which were "sitting adorned with nimbu and mirch (to ward off the evil eye according to Hindu rituals)" would be pressed into service. "You brought the Rafale, which is parked with nimbu-mirch... I have not put the nimbu and mirch on them, the Central government did so, the Raksha Mantri has adorned them with nimbu mirchi. When will these be used, when will you wipe out terrorists and those who support terrorism?" Rai asked

"The country wants to know this, those whose families were wiped out, whose children were martyred, their family members... want to know. This is why I have exhibited this (toy plane), to underline that it is time to use them and not to keep them parked with nimbu-mirchi," he had added. Underlining tensions on the Line of Control, where the Pakistan Army is committing ceasefire violations on every opportunity, BJP national spokesperson Sudhanshu Trivedi accused leaders from the Congress and those from its INDIA bloc allies of "continuously targeting the Indian Army through the ammunition of their statements" from within the country's borders. Trivedi also compared the INDIA bloc of Opposition parties with Pakistan, which officially maintains that it is "peace-loving" but carries out anti-India activities.

"If the Pakistan Army believes that it can demoralise the Indian Army through such incidents, I believe that with the same intention, the INDI alliance and Congress leaders take to bombarding the Indian Army with their statements," he told a press conference. "On the one hand, the Congress and INDI alliance leaders wear the mask of standing united with the government (of India), on the other, one after the other, their leaders give statements which are anti-India and seek to demoralise the Indian Army... I say with sorrow that this is similar to Pakistan undertaking its activities here but officially maintaining the stand that it has nothing to do with such actions, that it wants peace," he added.

Similarly, he alleged that the INDIA bloc's stand was that it was united with the government but their senior leaders—including Karnataka Chief Minister Siddaramiah, former Punjab CM Charanjit Singh Channi and now UP Congress president Ajay Rai—were giving such statements. During its tenure, there had not been a single instance of the Manmohan Singh-led UPA government cancelling bilateral

conversations with Pakistan over terrorist incidents, he alleged. On the other hand, there has not been a single instance of the Narendra Modi-led government opting bilateral peace talks with Pakistan. "This is proof of how differently both think. I am pained by the statements being given by the Congress... Ajay Rai ji...tried to poke fun by showing a toy plane with Rafale written on it and nimbu mirchis... I want to tell the people of the country that just a few days before this, in the same Uttar Pradesh, the Rafale landed and took off from the Ganga Expressway—which was a direct answer to Pakistan and the enemies of our nation," he said.

"Sitting on the same banks of the Ganga, the Congress party's state chief makes fun of the same Rafale jet. This proves what the mentality of the Congress is...yes, it is believed in the Hindu tradition that nimbu-mirchi wards off the evil eye. But today, the Indian Army does not need protection from Pakistan's evil eye; Pakistan's Army is looking at the Indian Army with fear, but these INDI alliance and Congress leaders are doing so with an evil eye," he added. While Pakistan was experiencing fear due to the roar of the Rafale, such statements were seeking to demoralise the Indian Armed forces, he alleged. Recalling that Defence Minister Rajnath Singh had drawn the traditional Hindu symbol of the Swastika on the Rafale after these had been purchased in France, Trivedi added that such rituals were part of proceedings in the Indian Armed forces.

"Perhaps they do not know that in the Indian Army, procedurally, religious teachers are appointed. When our soldiers go to war, whatever their religious traditions and rituals allow for and practices in line with their religious beliefs are followed...I want to ask the Congress, what is it that you are actually making fun of?" he asked. "Are you making fun of the Hindu faith?...they should know that each regiment has a traditional religious war cry...today, the Congress and the INDI alliance have become like the fifth columnists of the Spanish Civil War...Pakistan is stronger than us in only one respect - that not even a single one of their leaders is trying to demoralize their forces, but there is string of such statements from our leaders here," he added. The Pakistani media, he also alleged, was naming not only Indian political parties but specific leaders as those who were "not with Modi". Asking the Opposition to mend its ways, Trivedi cited instances such as PM Modi, who was then Gujarat CM, taking on the then Pakistan PM, Nawaz Sharif, for his comments against former Indian PM Manmohan Singh in 2011-12. In 1995, when Pakistan had sought to bring in a proposal against India in the United Nations, Atal Bihari Vajpayee, as Leader of Opposition, went to the United Nations General Assembly as the head of the Indian delegation against it and in favour of the Narasimha Rao government. "Benazir Bhutto had expressed surprise at the fact that Indian was one such nation where the Opposition was supporting the government...today, whether it is the (Pakistani) government or the Opposition, both are supporting their army but in India, the Opposition in trying to demoralise the Indian armed forces," Trivedi alleged."What is happening is sad...worthy of condemnation. We want to assure the nation, that under the leadership of Prime Minister Narendra Modiji, as he has said, the criminals behind this incident (the Pahalgam attack) will be hunted down to every corner of the world and will be punished in a way that it is unprecedented," Trivedi said, appealing to the Opposition not to seek to "lower the morale of the defence forces

### How a man's grudge over his son's death led to the murder of 7 members of a family

In January 2023, the bodies of seven members of a family were fished out of the Bhima River in Pune's Daund taluka. Investigation by the Pune Rural police indicated that they were murdered by relatives. Subsequently, five people were arrested and a minor was apprehended for their alleged role in the murders. As per the First Information Report (FIR) lodged at Yavat police station on January 25 that year, Sub-Inspector Sanjay Nagargoje found the body of an unidentified woman in the river in Pargaon village around 12.30 pm on January 18. Subsequently, on January 20, the body of a man was found near the same spot. On January 22, two more bodies were detected, including that of a woman. A mobile phone found on the woman's body led the police to determine that she was Sangita Mohan Pawar, 40, a resident of Gevrai in Maharashtra's Beed district. Officers contacted her family members and the other three bodies were identified as that of Sangita's husband Mohan Uttam Pawar, 45, their son-in-law Shamrao Pandit Fulaware, 28, and daughter Rani Fulaware, 24. The Fulawares resided in Hatole village, Washi, in Osmanabad district. The family informed the police that Shamrao and Rani had three children and they were missing. Further search led the officers to find the bodies of Ritesh, 7, Chotu, 5, and Krushna, 3, in the river on January 24. The probe revealed Mohan's mobile phone was active at Nighoj in Ahilyanagar district on January 17 and at Pargaon on January 18. It also revealed that Sangita's mobile phone was active in Nighoj on January 17 and at Shirur in Pune on January 18.

Meanwhile, family members expressed doubts regarding Mohan's relative Ashok Kalyan Pawar's involvement in the murders. As stated in the FIR, Ashok had lost his son Dhananjay Pawar in an accident but he believed that the youth was murdered by Mohan. Relatives told the police that Ashok used to talk about killing Mohan and his family. On being questioned, Ashok and his family claimed to be present at their residence in Nighoj on January 17 and January 18, and said they had no clue about the what led to the murders, officers said. The tower location of their mobile phones, however, placed the family members in Shirur on January 18 and, according to investigators, the mobile phones of the deceased and the suspects were active around the same locations in Nighoj and Shirur.

The police then arrested Ashok Pawar, Sham Kalyan Pawar, Shankar Kalyan Pawar, Prakash Kalyan Pawar and Kantabai Sarjerao Jadhav, all residents of Nighoj, under sections 302 (murder), 120 B (conspiracy), 506 (criminal intimidation), and 34 (common intention) of the Indian Penal Code. Officers said Ashok's son Dhananjay had died in a road accident in Wagholi a few months before the murders and a case was registered in this regard with the Pune City police. However, suspecting the role of Mohan and his son Anil in Dhananjay's death, Ashok and his family allegedly decided to take revenge and committed the murders. A minor member of Ashok's family, who was apprehended for his alleged role in the murder, was produced before the Juvenile Justice Board and sent to an observation



home. Shishir Hiray, Special Public Prosecutor in the case, said, "As per the police probe, the accused strangulated the victims and threw their bodies in the river. The case is on before a court in Baramati, and its trial is expected to begin soon." The investigators led by Rahul Dhas, Assistant Commissioner of Police, also seized a four-wheeler allegedly used by the accused to transport the bodies to Bhima River. As part of the probe, the police also exhumed the bodies of Sangita, Rani and Shamrao in the presence of the Daund tehsildar for re-postmortem.

### India's mineral production rises to all-time high in 2024-25

New Delhi: The production of key minerals such as iron ore, manganese ore, bauxite and lead in the country has recorded a robust growth in financial year 2024-25 after reaching record production levels in FY 2023-24, according to a statement issued by the Ministry of Mines on Monday. The output of iron ore, which accounts for 70 per cent of the total mineral production by value, increased to 289 million metric tonnes (MMT) in FY 2024-25, breaking the earlier production record of 277 MMT achieved in FY 2023-24, registering a 4.3 per cent growth. Similarly, the production of manganese ore has also surpassed the production record of 3.4 MMT achieved in FY 2023-24, with an 11.8 per cent jump to 3.8 MMT in FY 2024-25. The production of bauxite has risen by 2.9 per cent to 24.7 MMT in FY 2024-25 from 24 MMT in FY 2023-24. During the same period, lead concentrate production rose from 381 thousand tonnes (THT) to 393 THT, with a 3.1 per cent growth. In the non-ferrous metal sector, primary aluminum production in FY 2024-25 has also broken the production record of FY 2023-24. Primary aluminium production increased from 41.6 lakh ton (LT) in FY 2023-24 to 42 LT during FY 2024-25. Besides, refined copper production saw a robust growth of 12.6 per cent, increasing from 5.09 LT in FY 2023-24 to 5.73 LT in FY 2024-25.

### Uncertainty grips Kolkata rooftop restaurant owners following closure order



Rooftop restaurant owners across Kolkata are reeling from the Kolkata Municipal Corporation's (KMC) sudden order to shut down all their establishments. Many are left in a state of uncertainty as they grapple with a "lack of official communication", while fearing for their businesses and the livelihoods of their employees

Following the fire at Rituraj Hotel in Burrabazar that killed 14 people on April 29, the Kolkata Municipal Corporation (KMC) had ordered the immediate closure of all rooftop eateries in the city. However, in the "absence" of official notices, several restaurants claim they are still operating while adhering to all safety rules and regulations. The clo-

sure announcement was made verbally by Mayor Firhad Hakim, who said rooftop restaurants would need to shut down to ensure emergency access, adding that action would be taken against those who fail to comply.

The Indian Express spoke to a few owners across the city who have raised concerns about the sudden move. Rudresh Agarwal, owner of OLTERRA restaurant and bar, said, "There is still no official notice. Whatever we heard was based on speculation, but we expect a notice soon. We were told to close the open area." Meanwhile, WhatsUp Café (check/confirm spelling) representatives said they initially learned of the order through media reports but received an official notice later. "We were told to shut the outdoor section. The fire department has allowed indoor sections to remain open. We'll follow further instructions."Varun Mimani partner at WCH-O-ZARA, said, "The government should first check which outlets are legal or illegal instead of placing a blanket order. Many people depend on this café for their livelihood. We hope those who follow safety norms are allowed to operate."Representatives of Serra Rooftop Café claimed that while no official notice was received, police told them to close down. "We were shocked. Many rely on us for employment. We hope for a fair response and are ready to follow all orders," said the manager. The KMC's order has caused concern among rooftop restaurant owners trying to balance safety with their businesses. Many now seek clearer guidelines and support to comply without

### Who's afraid of AI? Not these young professionals from Pune as they embrace it as a tool

A growing number of young professionals no longer see Al as a looming threat but as a dynamic tool reshaping their careers and creative possibilities. They see it as something that can support their efforts, speed up their tasks, and even improve the quality of their work.Instead of worrying, these youths focus on learning the Al tools, understanding how they function, and finding ways to make them part of their work. For them, Al will not lead to losing their relevance but will offer an opportunity to evolve purposefully. "Al is a tool, not a threat," says Anuj Pravin Baghan, a Computer Science student at College of Engineering, Pune "Al might automate repetitive, entry-level tasks, but it can't replace real skills. As engineers, we are taught to constantly adapt. New technologies come and go; that is just the nature of this field."

Anuj believes the fear surrounding AI mostly stems from those outside the tech world or from misconceptions shaped by sci-fi movies. "If you understand how AI models work, you will know they are not magical solutions; they are tools that still need human intelligence to guide them."

His final-year project focuses on training AI models to enhance real-world applications like smarter web systems. He thinks learning AI is not about flashy tools, but understanding its fundamentals and integrating them meaningfully. "The truth is, AI won't replace you. But a person who understands AI just might," he says with a smile.Prajwal Gaikwad, a design student at Fergusson College, says the age of AI is not a threat but an opportunity. "In the age of AI, designers will survive not by resisting, but by coexisting,

where human creativity and machine speed merge to turn days of work into minutes, making us not competitors of AI, but its most powerful collaborators," he says.

While Prajwal admits the competition has increased, he believes AI opens new doors for those willing to master it. "Designers who embrace this partnership become not just creators, but curators of meaning, blending technology's efficiency with human emotion, context, and cultural awareness," he says. In the medical field, too, there are those who see Al as an enabler. Sushil Satishrao Deosarkar, an MBBS student at MIMER Medical College, says, "Al should not be seen as a replacement but as a powerful support system. It can help doctors make more accurate diagnoses, especially when symptoms are complex or direct intervention is not feasible."He says how AI can function as a vast, evolving database, offering updated insights on drug interactions, patient response trends, and micro-level data analysis. "Medicine is guided by experience and empathy. Al turns data into helpful guidance. When a diagnosis is difficult, it brings information closer and supports the healing process, not by replacing doctors, but by helping them."Meanwhile, in the humanities, Sadiya Rehmat, who recently completed her master's in English Language and Literature at MIT World Peace University, offers a more nuanced perspective. "Al cannot truly capture emotional depth when it comes to literature. It operates based on prompts, it doesn't feel, it doesn't reflect, and it certainly can't craft meaning from lived experiences."She believes creativity in literature and content creation is deeply human. I don't see AI replacing a content creator or strategist even a decade from now." She says creativity is not just about structure or words, but about insight, empathy, and intuition; only a human mind can bring them.

Concurring with her from the world of finance is Ved Mahesh Ingale, a BCom student at Brihan Maharashtra College of Commerce and an ACCA candidate. "I'm aiming for fields like private equity and consulting, these demand human thinking, decision-making, and people skills. Al can't replace that." While he acknowledges that Al may handle tasks like bookkeeping or data entry, he believes core finance roles are far too complex and people-driven. He says that every company's finances are unique, and while Al can assist, it can't understand everything or make high-level decisions the way humans can.

#### In Badlapur custodial death case, Supreme Court modifies Bombay HC order; Maharashtra Police chief to probe matter now

While hearing the appeal filed by the Maharashtra Government against the High Court order, the apex court directed that the SIT be supervised by Rashmi Shukla, Director General of Police, who can then consti-

tute the SIT to probe the Hearing the appeal, a bench of Justices Bela M Trivedi and PB Varale stated that being aggrieved by the order based by the Bombay HC to the extent of constituting the SIT under the supervision of Gautam, Solicitor General Tushar Mehta has submitted that the state has no objection with an SIT but asked for it to be constituted under the supervision of DGP, having regards to the litigations made.The bench said, considering the nature and seriousness of

the order, and directed that SIT be constituted by Shukla, and officers selected by the DGP as deemed fit. The bench said if the complainant had any grievance, they could approach the competent authority while disposing of the appeal. The Bombay High Court had earlier come down heavily on the Maharashtra Criminal Investigation Department (CID) and the Mumbai police SIT for refusing to register a First Information Report (FIR) in the Badlapur custodial death case, even though the magistrate's report stated that it was a fake en-

### Israeli leadership votes to expand Gaza ground offensive consultations on Indo-Pak situation



JERUSALEM, GNS News Agency, May 9, Prime Minister Benjamin Netanyahu's security cabinet voted to scale up the offensive against Palestinian militant group Hamas in Gaza to the point of seizing the entire enclave and holding its territories, an Israeli official said on Monday.A report by Israel's public broadcaster Kan, citing officials with knowledge of the details, said the new plan was gradual and would take months, with forces focusing first on one area of the battered enclave.

Such a timeline could leave the door open for a ceasefire and hostage release deal talks ahead of a visit by U.S. President Donald Trump to the region next week, according to security cabinet minister Zeev Elkin.

"There is still a window of opportunity until President Trump concludes his visit to the Middle East, if Hamas understands we are serious," Elkin told Kan on Monday. Already in control of around a third of Gaza's territory, Israel resumed ground operations in March after the collapse of a U.S.-backed ceasefire that had halted fighting for two months. It has since imposed a total blockade of aid

Elkin said that rather than launching raids in specific areas and then leaving them as the military had done so far, the Israeli forces will now hold the territories they seize, until Hamas is defeated or agrees to disarm and leave

Gaza. Hamas has ruled out such calls. Israel has yet to present a clear vision for post-war Gaza as it faces international pressure to end a campaign that has displaced most of Gaza's 2.3 million population and left it depending on aid supplies that have been dwindling rapidly since the blockade. The Israeli official said that the newly approved offensive plan would move Gaza's civilian population southward and keep humanitarian aid from falling into Hamas hands, though the blockade will not be lifted yet. The United Nations on Sunday rejected what it said was a new plan for aid to be distributed in what it described as Israeli hubs.On Monday, Jan Egeland, Secretary-General of the Norwegian Refugee Council, said on X that Israel was demanding that the U.N. and non-governmental organisations shut down their aid distribution system in Gaza."They want to manipulate and militarize all aid to civilians, forcing us to deliver supplies through hubs designed by the Israeli military, once the government agrees to re-open crossings. NRC will stand by our humanitarian principles and will, with all our peers, refuse to take part in this new scheme." Israel's Chief of Staff Lieutenant General Eyal Zamir said on Sunday that the military has already begun issuing tens of thousands of call-up orders for its reserve forces, looking to expand the Gaza campaign. He later warned ministers that aid must be let into Gaza soon, according to Kan. The war was triggered by the Hamas October 7, 2023 attack on Israel, that killed 1,200 people, mostly civilians, according to Israeli tallies, and saw 251 taken hostage into Gaza in the deadliest day for Israel in its history. Israel's ground and air campaign in Gaza has since killed more than 52,000 Palestinians, most of them civilians according to local health authorities, and left much of Gaza in ruins. Up to 24 of the 59 hostages still held in Gaza are believed to be alive. Families fear that the fighting will endanger their loved ones while critics say Israel risks being drawn into a long guerrilla war with limited gains and no clear strategy. Successive surveys have shown dwindling public support for the war among Israelis, many of whom prefer to see a ceasefire deal reached and more hostages released. Hamas says it will release hostages only as part of a deal that will end the war and see Israeli forces withdraw from all of Gaza. ### With militaries upgraded, risks multiply in any potential India-Pakistan conflict

ISLAMABAD/NEW DELHI, GNS News Agency, May 9, India and Pakistan have significantly upgraded their military capabilities since the nuclear-armed neighbours clashed in 2019, posing increased risks of escalation even in a limited conflict, former military officers and experts say. Pakistan says India plans a military incursion after New Delhi blamed Islamabad for a deadly attack on domestic tourists in Indian Kashmir last month. India's Prime Minister Narendra Modi has vowed to punish the backers of the attack "beyond their imagination". Pakistan has denied involvement in the attack but has warned it will hit back if it is targeted.

In 2019, India carried out air strikes inside Pakistan after the bombing of an Indian military convoy in Kashmir and said it destroyed "terrorist camps". Pakistani jets conducted a retaliatory air strike and shot down an Indian aircraft during actions spread over two days. The neighbours have fought three wars - in 1948, 1965 and 1971 - and clashed countless times since gaining independence, mostly over the Kashmir region which both claim. Both acquired nuclear weapons in the 1990s and Kashmir is considered one of the most dangerous flashpoints in the world

Military experts say neither side will consider nuclear weapons unless pushed to the wall, but even a limited conflict would carry high risks of escalation. They say such a conflict is likely to involve aircraft, missiles or drones, where India and Pakistan are considered closely matched, although India's far greater resources would come into play over a longer period."Decision makers in both states now have a higher risk appetite for conflict initiation and escalation than prior to 2019," said Frank O'Donnell, a non-resident fellow at the South Asia Program at the Stimson Center, a thinktank in Washington, as they had managed then to clash without nuclear weapons being used.

"But without a clear mutual sense of the precise actions, that could trigger inadvertent escalation," he added.Both sides have acquired new military hardware since 2019, opening up new conventional strike options."Each side will think they are in a better position than last time," said Muhammad Faisal, a South Asia security researcher based at the University of Technology, Sydney. "It is only when we see actual combat that we will find out."In particular, India believes that it was at a disadvantage in 2019 because it had to rely mainly on ageing Russian jets. It has since inducted 36 French-made Rafale fighter jets, a top Western aircraft, with more on order for its navy. To counter, Pakistan got one of China's most advanced war planes, the J-10, a rough equivalent of the Rafale, in batches since 2022. It has at least 20 of the aircraft, according to the London-based International Institute for Strategic Studies.

The planes carry advanced capabilities, with the Rafale armed with Meteor air-to-air missiles that operate beyond visual range. The J-10 is armed with the comparable PL-15 missile, according to a Pakistani security official who declined to be identified because they were not authorised to brief the media. To plug the gaps in air defences exposed on both sides in the 2019 conflict, India secured Russia's battle-tested S-400, a mobile anti-aircraft missile system. Pakistan obtained the HQ-9 from China, which is based on Russia's S-300, one notch down.

"Most certainly in some respects we are better off (than 2019)," said Anil Golani, a former air vice marshal in the Indian Air Force, and the director general of the Delhi-based Centre for Air Power Studies think tank."There's a lot of clamour for action in the country but, in my personal assessment, both India and Pakistan are not looking for an all-out conflict," he added. Hanging over any conflict is China, India's rival and Pakistan's close ally and biggest supplier of military equipment. Although the U.S. has urged India and Pakistan to ease tensions, it will closely watch any conflict for insights on Beijing's aerial strength. The Chinese plane and its PL-15 missile have not previously been tested in

"It could be a contest between Western and Chinese technology," said Faisal, adding "for India, there is the dilemma of how many air squadrons to commit to the Pakistan front, as it must also guard against China. "China and India fought a brief border war in 1962 and the two armies have clashed, most recently in 2022, along their tense Hi-



malayan frontier. Pakistan has a fleet of F-16s, the U.S. aircraft acquired decades back when ties with Washington were stronger. These F-16s were deployed in the 2019 tussle, leading India to lodge protests with the U.S., although New Delhi now enjoys far closer ties with Washington.

This time, to avoid the political fallout with the F-16 and to take advantage of having a more advanced aircraft, Pakistan will likely spearhead with the Chinese J-10, experts said. But a drone or ground-launched missile strike is considered more likely since neither would risk a pilot being shot down. India has turned to Israel for combat-capable drones, getting the Heron Mark 2, and it has U.S. Predator drones on order. Pakistan has acquired Turkey's Bayraktar TB2 - used by Ukraine in its war with Russia - and the Akinci, also from Turkey, according to the Pakistani security official. Amid the standoff, Pakistan tested a surface-to-surface ballistic missile with a range of 450 km (280 miles) on Saturday, to show that the armed forces were ready to "safeguard national security against any aggression," according to a statement from the country's military. Pakistan also has a range of short-range and medium-range missiles, capable of being fired from ground, sea and air.

There was no immediate comment from India on the test. India's capabilities include the BrahMos supersonic cruise missile of about 300 km range as well the Agni series of intercontinental ballistic missiles. The 2019 skirmish almost spiralled out of control, with multiple missile strikes threatened before U.S. intervention calmed the situation down.Kaiser Tufail, a former fighter pilot in the Pakistani air force, said that India did not manage to establish deterrence in 2019, so it would aim for a more incisive strike this time, bringing more risks in its wake. Modi said following the 2019 skirmishes that the country had felt the lack of Rafale fighters at the time, which were on order, and suggested that the results of the clash could have been different if it had the French fighter." If you go beyond what we saw in 2019, it is very risky," said Tufail. "Nuclear-armed countries slugging it out is extremely dangerous.

#### Organs of 75-year-old brain dead housewife donated

Hyderabad: The family members of a 75-year-old home maker, Peruka Padma, a resident of Vinoba Nagar, Ibrahimpatnam in Hyderabad, who was declared brain dead by a team of attending doctors, have decided to donate her organs to needy patients as part of the Jeevandan organ

On April 30, due to the sudden onset of weakness, Peruka Padma fell down at home. With no improvement in her health, the attending team of doctors declared Padma brain dead ..

The daughter of the brain-dead victim, Janaki, gave consent to donate the organs of her mother to needy patients under Jeevandan organs donation initiative. The doctors retrieved 2 kidneys and 2 corneas (in all 4 organs) and allocated them to transplant centres based on the organ donation guidelines.

### **UNSC** to hold closed

United Nations: The UN Security Council will hold closed consultations on Monday on the situation between India and Pakistan after Islamabad sought an emergency meeting amid tensions between the two nations following the Pahalgam terror attack. Pakistan currently sits as a nonpermanent member of the powerful 15-nation Security Council, which is being presided over by Greece for the month of May. Islamabad "requested closed consultations" on the tensions between the two countries and the Greek Presidency has scheduled the meeting for May 5 in the

Apart from the five veto-wielding permanent members China, France, Russia, the UK and the US — the 10 non-permanent members in the Council are Algeria, Denmark, Greece, Guyana, Pakistan, Panama, South Korea, Sierra Leone, Slovenia and Somalia. Amid rising tensions between the nuclear-armed South Asian neighbours following the April 22 Pahalgam terror attack, Permanent Representative of Greece to the United Nations and President of the Security Council for the month of May Ambassador Evangelos Sekeris had last week said that if a request comes for a meeting to discuss the situation between India and Pakistan. "As I said before, as a position of principle, we strongly condemn any act of terrorism and this is what we did" on the "heinous terrorist attack" that took place in Pahalgam in which innocent civilians died, Sekeris had said. In the weeks following the Pahalgam terror attack in Jammu and Kashmir in which 26 civilians were killed, External Affairs Minister S Jaishankar spoke with all Council members, with the exception of China and Pakistan.

In his calls, Jaishankar underlined that "its perpetrators, backers and planners must be brought to justice." He also spoke with UN Secretary-General Antonio Guterres, Russian Foreign Minister Sergey Lavrov, US Secretary of State Marco Rubio, UK Foreign Secretary David Lammy, French Foreign Minster Jean-Noel Barrot and South Korean Foreign Minister Cho Tae-yul, among others. Last Friday, Pakistan's Permanent Representative to the United Nations Ambassador Asim Iftikhar Ahmad said at a press conference at the UN that his country has the right to convene a meeting when "we feel appropriate". "We see that all of this that is happening is in the context, in the backdrop of the situation in Jammu and Kashmir," Ahmad had said. He said that the situation that evolved after the attack is a real threat to regional and international peace and security. The Pakistani envoy had last week met Guterres and briefed him about the security situation in the region. Ties between the two neighbouring countries plummeted following the April 22 attack that killed 26 people, mostly tourists. India announced a raft of punitive measures against Pakistan including suspension of the Indus Waters Treaty, shutting down of the only operation land border crossing at Attari and downgrading of diplomatic ties following the terror attack. Prime Minister Narendra Modi said India is committed to taking "firm and decisive" action against terrorists and their backers. PM Modi also told the top defence brass that the armed forces have "complete operational freedom" to decide on the mode, targets and timing of India's response to the attack.

#### Trump orders 100% tariff on foreign-made movies to save 'dying' Hollywood

WASHINGTON, GNS News Agency, May 9, U.S. President Donald Trump on Sunday announced a 100% tariff on movies produced outside the country, saying the American movie industry was dying a "very fast death" due to the incentives that other countries were offering to lure filmmakers. "This is a concerted effort by other Nations and, therefore, a National Security threat. It is, in addition to everything else, messaging and propaganda," Trump said on Truth Social. Trump said he was authorizing the relevant government agencies, such as the Department of Commerce, to immediately begin the process of imposing a 100% tariff on all films produced abroad that are then sent into the United

He added: "WE WANT MOVIES MADE IN AMERICA, AGAIN!"Commerce Secretary Howard Lutnick said on X: "We're on it."Neither Lutnick nor Trump provided any details on how the tariffs would be implemented. It was unclear if the tariffs would apply to movies on streaming services as well as those shown in theaters, or if they would be calculated based on production costs or box office revenue. Hollywood executives were trying to sort out details on Sunday night. The Motion Picture Association, which represents the major studios, had no immediate comment. In January, Trump appointed Hollywood veterans Jon Voight, Sylvester Stallone and Mel Gibson to bring Hollywood back "bigger, better and stronger than ever before." Movie and TV production has been exiting Hollywood for years, heading to locations with tax incentives that make filming cheaper. Governments around the world have increased credits and cash rebates to attract productions and capture a greater share of the \$248 billion that Ampere Analysis predicts will be spent globally in 2025 to produce content.

, leaders in Australia and New Zealand responded to Trump's tariff announcement by saying they would advocate for their local industries. Some Marvel superhero movies have been filmed in Australia, while New Zealand was the backdrop for "The Lord of the Rings" films.

The British media and entertainment union Bectu called on the government to move swiftly to protect the country's "vital" film industry. "These tariffs, coming after COVID and the recent slowdown, could deal a knock-out blow to an industry that is only just recovering," said Bectu head Philippa Childs. She said they would also threaten tens of thousands iobs of freelancers who make films in the UK. Film and highend TV production in the UK was worth 5.6 billion pounds (\$7.45 billion) in 2024, a 31% increase on 2023, according



to the British Film Institute. In 2023, about half of the spending by U.S. producers on movie and TV projects with budgets of more than \$40 million went outside the U.S., according to research firm ProdPro.Film and television production has fallen by nearly 40% over the last decade in Hollywood's home city of Los Angeles, according to FilmLA, a non-profit that tracks the region's production.

The January wildfires accelerated concerns that producers may look outside Los Angeles, and that camera operators, costume designers, sound technicians and other behind-the-scenes workers may move out of town rather than try to rebuild in their neighborhoods.

A ProdPro survey of executives found California was the sixth most preferred place to film in the next two years behind Toronto, Britain, Vancouver, Central Europe and Australia. Hollywood producers and labor unions have been urging Governor Gavin Newsom to boost the state's tax incentives to better compete with other locations. Trump's proposed movie tariff follows a series of trade conflicts initiated by his administration, which have roiled markets and led to fears of a U.S. recession. Former senior Commerce official William Reinsch, a senior fellow with the Center for Strategic and International Studies, said retaliation against Trump's film tariffs would be devastating."The retaliation will kill our industry. We have a lot more to lose than to gain," he said, adding it would be difficult to make a national security or national emergency case for movies.

#### US seeks to weaken global development finance efforts, UN document shows

BRUSSELS/LONDON, The United States is seeking to weaken a global deal aimed at helping developing countries struggling with the impacts of climate change and other issues, an internal United Nations document seen by Reuters showed. The Trump administration opposes draft reforms of the world's financial system intended to help developing countries, including around taxation, credit ratings and fossil fuel subsidies. It also wants mentions of "climate," "gender equality" and "sustainability" stripped out. The Reuters Daily Briefing newsletter provides all the news you need to start your day. Sign up here. The previously unreported document sheds light on how the Trump administration is seeking to imprint an "America First" agenda, including opposition to efforts to slow climate change and promote diversity, on the institutions at the heart of fixing global systemic crises. The once-a-decade, 4th International Conference on Financing for Development (FFD4) in Seville, Spain, in June aims to influence the strategic direction of the world's development finance institutions. Countries agreed at FFD3, for example, to broaden tax cooperation efforts so that developing countries could help set the rules and as of last May more than 140 countries were involved."This conference is about bringing the world's leaders together and setting the underlying rules and priorities for financing development goals over the next decade," Tom Mitchell, executive director of the International Institute for Environment and Development, told Reuters.

Compiled by the permanent representatives to the U.N. of Mexico, Nepal, Norway, and Zambia, with help from the U.N. secretariat, the April 11 negotiating draft is annotated with the positions of the 193 nations involved in the

discussions. With ongoing changes at the World Bank and International Monetary Fund in the fight against climate change already facing pushback from U.S. Treasury Secretary Scott Bessent, the document showed it was seeking to water down further reform efforts. Among specific points in the text that refer to the systemic reform, the document shows the U.S. wants to remove a reference to a "package of reforms" for sustainable development. It wants to replace a line promising to "commit to reform the international financial architecture" with a pledge to "recognize the need to enhance its resilience and effectiveness in responding to present and future challenges and crises. "Such changes in language signal the degree of shared commitment that can then be used as support for action or inaction in future talks.U.N. Secretary-General António Guterres has acknowledged the need to overcome multiple challenges ahead of the conference, but urged "all countries to be at the table in Sevilla focused on solutions," spokesperson Florencia Soto Niño said in an email to Reuters. The White House and Treasury Department did not respond to requests for comment. The State Department declined to comment. While the U.S.' position on development has become tougher under Trump, the negotiating document shows it remains supportive of efforts that include developing countries working more closely with the private sector, and fostering innovation and financial literacy. A key goal of the global reforms is to better help poorer nations cope with weather disasters, which are worsening due to climate change, and to boost economic development using lowcarbon energy rather than traditional fossil fuels.U.S. foreign development aid by more than 80% as part of a government overhaul led by billionaire Elon Musk and embarked on a trade war that is hurting many poorer nations.

### How coffee agroforests can play a role in ecological restoration



In 2019, when the Narmada Estate, a coffee plantation in Karnataka's Chikkamagaluru district, decided to go organic, it began diversifying the coffee-cropping system to reduce pests. "The reason something becomes a pest is because you have too much of the same thing," explains Sohan Shetty, the estate's general manager. "So, we needed to plant as many trees as possible."

To find suitable plants to grow alongside organic coffee, he began scouting for the best-priced plant sources, including the Karnataka Forest Department's nurseries and seed suppliers in Chikkaballapur. During his search, Shetty discovered that the Nature Conservation Foundation (NCF) had been actively restoring rainforests in Valparai, Tamil Nadu, for years, and so he reached out to them. "They were amazed at the scale with which I was thinking of starting nurseries and asked me what species I was working on." So he shared with them the list of trees and seeds available with both the Forest Department and the seed supplier. "The botanist looked at it and said, a week later, that only three of these species are native to the Western Ghats," he says. "That shook me. I realised that we are just planting trees for the sake of planting trees, but we are completely messing up the ecosystem."

"It was quite impressive, 5000-odd plants of different varieties," remembers Shetty, who, on seeing this, thought it would be a good idea to further collaborate with NCF. "By that time, I had set up a nursery with 1.2 lakh bags, which could accommodate that many saplings," he says. "So, I told them that I was happy to grow plants for you. That is how the whole partnership began," recalls Shetty, who, along with other owners and managers of agroforests in Hassan and Chikkamagaluru districts, was part of a study spearheaded by conservation scientists from the NCF titled Shade coffee agroforests as native plant sources for restoration.

Planting trees as part of ecological restoration in a degraded forest in the Western Ghats, India. | Photo Credit: Vijay KumarAccording to Anand Osuri, a scientist with NCF and the paper's lead author, the study, which has just been published in the Journal of Applied Ecology, really took off in 2023. A year earlier, Vedika Dutta, also a co-author, had come to Osuri as a master's student, wanting to study birds in coffee agroforests, with a focus on frugivorous or fruiteating birds. "In the course of her work, we spent time in coffee estates, watching birds and the trees in which they foraged in these coffee plantations," he says, adding that they were struck by the large numbers and wide variety of native tree seeds and seedlings on the coffee estate floor. "These seeds and seedlings were not just of the trees fruiting overhead, but also other species carried in from further afar by seed-dispersing birds and mammals.

Around the same time, NCF was also thinking about a forest restoration project in the coffee-growing landscape of the hilly Malnad region by partnering with local residents and landowners. According to him, these landowners had different motivations to restore forests, ranging from an interest in conservation to entering carbon and biodiversity

markets or attracting birds to their homestays. "There are a number of opportunities where interested landowners are keen to restore forests in areas where coffee is not being cultivated," says Osuri, who has been participating in efforts to restore forests for nearly a decade and believes that the availability of diverse native plants, sourced locally and ethically, is critical to do so. "So, there was this restoration project that we were trying to develop, for which we needed to develop native plant nurseries, and the bird work was also going on." As part of the restoration project, researchers from NCF needed to collect seeds and seedlings that could be raised in nurseries. But "we?didn't want to be collecting lots of seeds from the forests themselves because that reduces the seed availability there, impacting the resources of animals, birds and insects," says Osuri. "And so, we put both these pieces together to see if we could do more to harness the potential of coffee farms as a source of seeds for restoration."

Coffee in India is largely shade-grown, making coffee plantations a potential "refuge for biodiversity," says Osuri. "For a substantial set of native species important for restoration, we often find adults of those trees in the coffee estates." However, most seeds that fall and germinate in coffee estates are weeded out because of the possibility of them competing with the coffee bushes for light and other resources, representing a loss for biodiversity conservation. "So, we thought we should make a more systematic effort to rescue their seeds and seedlings before they get weeded outAs part of the study, the team documented the diversity of native tree species found within the coffee estates, recording over 90 native tree species relevant for forest restoration in the region. Clarifying that the word "native", in this instance, refers to "that particular eco-region of the Western Ghats, the wet evergreen rainforests" and not just plants "native to India," he says that they were particularly interested in documenting species not only those native to the Western Ghats but also endemic to the region, those "found nowhere else on earth and some of which are classified by the IUCN as being threatened."

The NCF team also connected with farmers who were "willing to give us permission to visit their farms, collect seeds, and also, in the monsoon season, collect small seedlings which were growing along the roadside." Between 2023 and 2024, around 18,000 seeds and seedlings of 56 native tree species were rescued and are currently being raised in the two restoration nurseries established through collaborations between NCF and agroforest owners. "We are trying to encourage and enable people to take up such projects to plant the right native species in the right places."Currently, the restoration project is in a pilot stage with the NCF team focusing on two collaborative initiatives: expanding the network of seed source coffee farms and developing more native plant nurseries. "The idea we are proposing is that we should not just view coffee agroforests as refuges for biodiversity, but also acknowledge their potential to contribute to conservation in the wider landscape by being a source of native plants for restoration."In Osuri's opinion, more collaborations and experimentation are now needed. "A few more things will need to be worked out before one can talk about substantially scaling up, since, at the moment, one of the limiting factors is nursery resources, he says. One potential partner, who can play a key role in expansion, he believes, is the Karnataka Forest Department. "We plan to discuss our findings with department officers to see if there is a workable model for this," he says. "If we can develop models for connecting seed sources in coffee farms with nurseries of the forest department, then the scale and potential really go up because the department already has an excellent network of nurseries."Osuri also hopes to strengthen and scale up their efforts in the Malenadu region, since nearly 70% of India's coffee production comes from the Malenadu region, mainly from the Baba Budan Hills in Chikkamagaluru to Kodagu in the south. "This is also an important region for biodiversity conservation and restoration," he says. His long-term goal is to continue to explore opportunities and collaborate with coffee farmers and landowners for restoration, experiment with different approaches to restoration, and contribute in any other way he can to biodiversity in the region, he says. "And we would love to connect and exchange learnings with others interested in exploring similar models in different land-

#### Kim Jong Un's Latest Gift to Russia Is Migrant Workers

A lack of workers ranks among Putin's biggest problems—one created by the country's sliding birthrate and exacerbated by the war. Hundreds of thousands of Russians have died in the fighting, according to Western estimates, and countless others have fled the country. The shortfall could swell to 2.4 million by 2030, according to Russia's Labor Ministry, from 1.5 million today.

Now, North Korean laborers are pouring into Russia, prized by local employers for their low wages and willingness to work 12-hour days without complaint.

North Korea has dispatched around 15,000 workers to Russia, South Korea's spy agency told lawmakers on Wednesday. Many are believed to have entered the country on student visas. In 2024, the number of North Koreans entering Russia jumped 12-fold from the prior year, according to Moscow figures. For now, they are largely confined to Russia's Far East, but Russian industry leaders and officials have expressed a hope that more North Korean workers could soon arrive in major cities, including Moscow. The United Nations Security Council bars the use of overseas North Korean migrant workers.

But in recent years, Moscow and Pyongyang have flouted those rules, as well as many others aimed at penalizing Kim for his nuclear-weapons program.

North Korea sent 12,000 soldiers to support Russia's war on Ukraine last year, South Korean officials say, and an additional 3,000 this year following mass casualties. The soldiers were decisive in Russia's efforts to expel Ukrainian forces that had occupied a region in southern Russia. Pyongyang is also sending lethal weapons to Russia, including a ballistic missile that Ukraine said killed 12 people and injured almost 90 in Kyiv in late April. The two countries are boosting cross-border trade. Putin even gifted Kim a luxury limousine.

In recent days, Putin hailed Russia's friendship with North Korea as one "forged on the battlefield." Even with a dramatic uptick in numbers, North Koreans won't be able to fill Russia's labor deficit alone. But the Kim regime can offer significant help in Russia's Far Fast, an area border-



ing North Korea that Putin has long envisioned as an industrial base. Russia has sought for years to revive the area, handing out free land to reverse depopulation in a region rich in timber, minerals and oil that has also drawn interest from Chinese investors. The initiative has had limited success. Russia has said it abides by the U.N. restrictions on the Kim regime, while advocating for sanctions on Pyongyang to be relaxed. Putin took aim at the U.N.'s ban on North Korean overseas workers last June, just weeks before he traveled to Pyongyang and struck a mutual-defense pact with Kim. "These are our neighbors," Putin told state media in Moscow. "We will develop our relations whether people like it or not."The rise of North Korean workers in Russia summons memories of the past. For decades, Pyongyang sent tens of thousands of laborers who largely worked in construction and logging. The regime pockets more than 90% of workers' wages, North Korean defectors say, but the remaining salary of between \$100 and \$200 is still a significant sum in a country where people earn just a few dollars a month, they add. When the U.N. ban took effect in late 2019, thousands of the 30,000 North Koreans then working in Russia returned home, dealing a blow to Russia's migrant workforce. In recent years, Russia has leaned on overseas laborers from former Soviet republics in Central Asia, who earn far more working in Russia and support their home economies through remittances.

#### What are the key objectives of caste count?



The story so far: The Union Cabinet has decided that the next Census will include questions on caste to its enumeration of India's population, for the first time in almost a century. The decision, a reversal of the ruling Bharatiya Janata Party's (BJP) stance so far, comes ahead of the crucial Bihar elections, and throws up myriad challenges.

Have Indians been counted by caste before?

When the British first started counting India's population in 1881, caste data was included in the information gathered. For the next half-century, the decennial censuses collected caste information. The last time that data was published was from the 1931 census, which counted 4,147 castes and sub-castes across the country. Though the wartime 1941 census also collected data on individual castes, it was never released. After India gained Independence, the government decided to avoid the question of caste in the census, only counting Scheduled Castes and Tribes (SCs/STs).

In his report on the 1931 census, then-Census Commissioner J.H. Hutton dismissed the arguments of those who did not wish to collect caste and religion data on the grounds that they would perpetuate divisions, noting that "the census cannot, however, hide its head in the sand like the proverbial ostrich, but must record as accurately as possible facts as they exist." He struck down previous British attempts to list a hierarchy of castes, in accordance with their perceived ranks in society, instead choosing to use occupations as the basis of classification, though this did not account for the fluidity of caste identities and the variations in caste names across time and geographies. The 1931 census data was also the basis for reservation efforts half a century later; its finding that 52% of the country's population belonged to castes later grouped under the Other Backward Class (OBC) category became the basis of the Mandal Commission's recommendation for a 27% quota for OBCs in education and government jobs.

In 2011, the Union Ministry of Rural Development kicked off a different kind of caste-counting exercise as part of its Socio-Economic and Caste Census (SECC). The data collected was meant to be used for research and policy making and to effectively design and implement development and welfare schemes. Though parts of the data were published in 2016, the raw data on specific caste populations was not included. As the SECC left its questions on caste open-ended rather than making them choose their caste from a set list, respondents often entered their surnames, meaning that the SECC enumerators counted more than 46 lakh different castes.

At least three States have conducted caste censuses. Bihar Chief Minister Nitish Kumar led the effort to survey the State's caste break-up in 2023, finding that OBCs and Extremely Backward Classes (EBCs) accounted for more than 63% of the State's population, stirring the political pot with demands for higher representation for these castes in politics, education, and employment. The Congress rode

to power in Telangana in 2023, partly on the basis of its promise to conduct a caste survey, which was published in 2024 and showed that backward classes make up more than 56% of the State's population. Karnataka's caste survey was also commissioned by a Congress government, in Chief Minister Siddaramaiah's first term in 2015. The results, however, were published only a decade later, and showed that the State's OBC population stood at almost 70%.

What will this data be used for?

Apart from its use in academic research and policy making, the key import of caste data from a public and political viewpoint is what changes it will drive in affirmative action or reservation policies. The 27% OBC quota for education and government jobs was set on the basis of a projection from the 1931 census; a new caste count could well upend those estimates. In Karnataka, for instance, where the caste survey found that the OBC population is significantly higher than estimated, there have been demands to increase their quota in the State from 32% to 51%. The clamour for more reservation, backed by caste population data, is also likely to lead to a challenge of the Supreme Court-mandated 50% cap on reservation.

The BJP-led government's decision came as a surprise given that the demand for a caste census has been a major plank of the Opposition's poll campaigns. The BJP has long resisted the demand, accusing the Congress of using caste to divide Indians. Minister of State for Home Nityanand Rai even responded to questions in Parliament insisting that there were no plans to include caste in the next Census, terming it a "matter of policy". The Bihar caste survey, however, set off a political tinderbox that carried over into the 2024 general election campaign. The Opposition, in its campaign for social justice also stoked fears among sections of voters that the BJP was seeking a large majority in order to be able to remove reservations and amend the Constitution, which led to lower vote counts for the BJP in many constituencies.

The decision to conduct a caste count "steals the thunder" from the Opposition's campaign just ahead of the Bihar Assembly elections, where it is sure to become a poll issue. The BJP is seeking to reframe the narrative, claiming that the Congress is all talk and no action, as it had never conducted a caste census at the national level while in power at the Centre. Though the Opposition is seeking to claim credit for pressuring the government into taking this decision, it is also pivoting to the logical next step, of demanding that reservations be hiked in response to the caste census findings, seeking to breach the Supreme Court's 50% cap.

The catch in the Centre's announcement is that no dates have yet been notified for the next Census. The last Census was held in 2011, with the 2021 Census being delayed indefinitely, initially due to the COVID-19 pandemic. The addition of a caste component involves more work for Census officials. The next step will be to draft a code directory of castes to be used in the Census. Unlike the SECC which had an open-ended query on the respondent's caste, the Census is likely to provide a drop-down list of castes for respondents to choose from. How castes will be listed is a thorny political question, given that the Centre and States have differing, and often contentious OBC lists. Linguistic and regional diversity in caste names, splitting of castes into sub-castes over time, and disagreements on whether specific castes fit into SC, OBC, or general categories, are likely to complicate the process. Religion adds another factor into the mix, with questions about how non-Hindu groups will be recognised and whether they will get benefits on the basis of the caste census.

### Hubble's 35-year journey is a blueprint to understand the cosmos

From breathtaking snapshots of distant galaxies to game-changing discoveries about the universe's expansion, the Hubble Space Telescope (HST) has dazzled humankind for 35 years. After launching on April 24, 1990, Hubble overcame early flaws to become one of NASA's greatest triumphs. Its vivid images and countless scientific breakthroughs have reshaped our understanding of the cosmos, inspiring new generations of telescopes and astronomers. To celebrate Hubble's majestic journey for more than three decades, NASA recently released a collection of striking images captured by the HST.

The US astronomer Lyman Spitzer proposed the idea of the Large Space Telescope in the 1940s. NASA and the US Congress approved the project in 1969 but faced budget pressures. Then the European Space Agency chipped in with 15% of the LST's cost in exchange for 15% of its observation time. The HST, named for astronomer Edwin Hubble, was planned in 1979 and built by 20 companies, universities, and the European Space Agency. It was initially scheduled to be launched in 1986 but that was delayed until 1990 due to technical difficulties and the Space Shuttle Challenger disaster.

Astronauts launched in 1993 implemented this fix on the HST, by that time in earth orbit. They removed the highspeed photometer to make way for COSTAR, as well as replaced the WFPC with the WFPC 2, among other upgrades. The telescope experienced a similar problem in 1997. The analysis of light is of great importance in space research. Blue light has a shorter wavelength and red light has a longer wavelength. If the frequency of incoming light bluer, it means the light source is moving towards the observer. If the frequency is becoming redder, the object is moving away. The HST's GHRS and FOS devices, which perform this analysis, worked well until 1997. NASA subsequently replaced them with the Space Telescope Imaging Spectrograph that year. This device can analyse frequencies of light from the ultraviolet to the infrared. The telescope's antenna transmits approximately 150 Gb of data a week. According to NASA, the HST has observed almost 52,000 stellar objects in 1.6 million observations since launch. One of the HST's most significant achievements was to get scientists the data with which they estimated the universe's age. Before the telescope came along, astronomers didn't know if the universe was 10 billion years old or 20 billion. To get the answer, astronomers looked at the Cepheid variable stars — a type of star that pulsed in a steady way, its brightness varying over periods of days or months. Astronomers could determine the distance to such a star using its luminosity and pulsation rate. Based on that measurement, they could then estimate the distances to various other, more distant celestial objects.

#### After rough start, gold, silver cool off



Precious metals price behaviour turned volatile last month. After initial weakness, precious metals managed to claw their way back during the middle of the month. Comex gold edged past the psychological \$3,500 mark to scale a fresh all-time high of \$3,509 on April 22. The prices have since cooled in the past few days. Hope of a possible deescalation in the U.S.-China tariff war played a key role in pulling the precious metals to lower levels in the past few days. Comex gold posted a 4.5% gain in April to end the month at \$3,299.2. Comex silver remains a relative underperformer in comparison with gold and lost 5.6% in April to

Mirroring the trend in the global markets, the MCX gold price gained 4.3% to settle at 94,611 per 10-gram at the end of April. Reflecting weakness in international markets, MCX silver too closed 5.8% lower at 96,833 a kg.

As observed last month, the price of precious metals is overextended from the mean and therefore, a cool-off is likely. Unless Comex gold price crosses above the resistance level at the \$3,400-\$3,410 zone, there is a strong possibility of a slide to the next support zone at \$3,140-\$3,150. The long-term trend, however, remains positive, and the price could resume its uptrend on the completion of the anticipated short-term cool-off. Comex silver price remained weak last month and dropped to a low of \$27.55 on April 7 and managed to recover thereafter. The prices, however, have turned weak in the past few days. The short-term outlook for Comex silver stays weak, and the price could head to the next support zone at \$26-\$26.50. Only a move past \$34.5 would invalidate the short-term negative outlook. From a medium-term perspective, Comex silver price may oscillate in a broad range of \$25-\$35.

MCX gold price moved closer to the psychological ?1,00,000 level in April but receded to lower levels in the past few trading sessions. The short-term outlook for MCX gold is weak, and the price could drop to the next target zone of ?84,500-?85,000. Unless the price moves above ?99,000, there would be a strong case for an easing off to the 86,500-?88,500 zone. As observed last month, the shortterm outlook for MCX silver is negative. The price could drop to the immediate support 90,500-91,500 zone. Only a move above ?1,05,000 would trigger further upside momentum. To summarise, precious metal prices are in a cool-off phase and prices could remain subdued in the near term. The long-term trend, however, remains positive. #### Clean hands, safe lives: how the small act of washing your hands can have a huge impact



Each year on May 5, the world observes World Hand Hygiene Day, reminding us of one of the simplest and most powerful ways to protect our health—washing our hands. In a country like India, where the burden of infectious diseases remains high, hand hygiene is not just a matter of personal cleanliness—it is a critical public health tool. According to a 2023 report by the Indian Council of Medical Research (ICMR), healthcare-associated infections affect up to 12% of hospitalised patients in India. Many of these infections are preventable, and a large number are transmitted through unclean hands. In rural health centres and urban hospitals alike, poor hand hygiene is a silent contributor to complications and extended hospital stays.

India has seen improvements in sanitation and hygiene through initiatives like Swachh Bharat Abhiyan, but the gap between infrastructure and awareness remains. A UNICEF study from Tamil Nadu found that less than 40% of schoolchildren regularly washed their hands with soap before meals and after using the toilet. This directly contributes to diseases like diarrhoea, which still claims the lives of over 1,00,000 children under five each year in India. This year's theme by the World Health Organization, 'Clean Hands, a Shared Responsibility', holds special relevance here. In

local markets, or hospital outpatient departments-transmission risks are high. Clean hands are a shared shield.

In hospitals, the stakes are very high. As a clinical microbiologist, I regularly encounter antibiotic-resistant bacteria-so-called "superbugs"-that thrive when infection control lapses. Studies from the All India Institute of Medical Sciences (AIIMS) and other leading hospitals reveal that hand hygiene compliance among healthcare workers varies widely, often dropping during night shifts or in high-pressure situations. But the solution doesn't always need highend technology. It starts with consistent habits. Using soap and water or an alcohol-based hand sanitiser can reduce the transmission of germs by over 50%. Schools, hospitals, and public spaces must ensure easy access to hand washing facilities, while also reinforcing the practice through

We have seen, especially during the COVID-19 pandemic, how something as simple as hand hygiene can slow the spread of a virus across communities and States. The lesson is clear: infection prevention starts with our hands.

Hand hygiene is not just a habit; it's a mind-set. It's about understanding that the invisible germs on our fingers can pose real risks—especially to children, the elderly, and those with weak immune systems. Making hand hygiene a routine part of our lives is not just about staying clean—it's about being responsible.

This World Hand Hygiene Day, let us look beyond slogans and take small, meaningful steps. Talk to your children about it. Remind your co-workers. Ask your hospital or clinic if they promote hand hygiene among staff. After all, clean hands aren't just for doctors—they are everyone's responsibility. India has made great strides in public health, but the battle against preventable infections continues. From schoolchildren to surgeons, everyone has a role to play. This World Hand Hygiene Day, let us pledge to take that role seriously. Because the smallest of acts-washing your India's densely populated settings—be it crowded trains, hands—can have the biggest of impacts

#### Demise of foreign aid in India

Indian attitude to official and private foreign aid has always been ambivalent - sometimes welcoming, at other times hostile. With U.S. President Donald Trump's targeting of USAID, the death knell, at least for official aid, seems to have been rung. Other European countries may follow suit, thanks to continuing global conflicts, anti immigration sentiments, and the slowing of economic development in the aid-offering countries. The writing on the wall could not be clearer. In fact, for India, the writing has been clear for several years now, much before Mr. Trump's action. Western aid-giving nations no longer see India as a country needing aid, given its high growth rate, its oft-vaunted claim of becoming the fifth largest economy by 2047, and the prevailing political and religious ideologies within the country.

India sought international aid soon after Independence to assist in its task of catching up with the developed world. Most of the aid went to the government, as it was believed that the government should be the lead change agent. The peak period was from 1955 to 1965, and most of it came from Western nations. Some official development aid also went to private organisations, especially from bilateral aid organisations, for both humanitarian and development

However, official developmental aid has shown an almost constant decline, especially from 1970 onwards. After 1990, Official Development Assistance (ODA), as a proportion of either Gross National Product or public investment, became insignificant partly due to the success of India's growth story. What India seeks now is Foreign Direct Investment (FDI) and global cooperation in trade, climate change, and technological developments. Thus, declining official aid is not as great a concern as declining private aid to non-government agencies, though it too will have downsides such as unemployment in aid-giving organisations in both donor and recipient countries, wastage of stockpiled food and medicines, and reduced global collaboration in health and environment.

Private non-governmental organisations engaged in development work — referred to as NGOs — will be more affected by a decline in aid, both official and private. NGOs not only take up the slack in government provision at the bottom but also hold up a mirror to the truth in governance. While public donations sustained Indian NGOs in the pre-Independence period and for some years afterward, since the 1960s onwards, the two major sources for NGOs in development have come to be government grants and foreign aid. It is only since 2013, when corporate social responsibility contributions became mandatory, that corporate money has become somewhat significant. External aid to NGOs, both from official and private sources, increased continuously, but slowly the amounts received from both have been coming down. Between 2017-18 and 2021-22, NGOs received ?88,8820 million, but though correct estimates of Foreign Contributions Regulation Act (FCRA) aid



are difficult to get, approximate figures indicate that the amount has gone down considerably. Probable reasons The reason for the decline is less about the reluctance of foreign donors and more about the ambivalent attitude of the Indian government towards the receipt of foreign aid by Indian NGOs. While allowing NGOs to accept aid, government regulations have hedged it in with several restrictions since 1976, when the FCRA was passed. Even before the declaration of Emergency in 1975, the "foreign hand" had become a bogey phrase. The government began to blame it for anti-government sentiments and activities. The antinational activities purportedly holding up development included religious conversions to Christianity or Islam, protests against development projects, and various policies of the government. The FCRA required those receiving or wishing to receive foreign money to register themselves with the Ministry of Home Affairs, and to use the funds strictly according to the rules. This Act and its rules have been amended in 2010, 2011, 2020, 2023, and again in 2024. Each time, the rules have been made more and more stringent, and several NGOs have lost their FCRA registrations. Certain private foreign donors, such as the Soros Foundation and others, have also been actively discouraged. These factors pushing out aid will slowly but surely toll its death knell. While foreign aid may have had some drawbacks, such as bringing in ideas not entirely or always suited to India, it has played a valuable role for NGOs. Where government grants are meagre, not easily available, and lacking the flexibility to meet changing conditions on the ground, foreign aid was more generous and allowed more flexibility in use, opened windows to the world outside in terms of new ideas and practices, and built the capacity of Indian NGOs. It also allowed NGOs to play a valuable watchdog role on abuses by the government or market forces by voicing dissent against policies and actions detrimental to poor and vulnerable constituencies. If foreign aid ceases entirely, not only will there be unemployment in the voluntary sector, but also unfinished projects or shelving of new projects, and a slowing down of social sector development, but more importantly, no correction to government over-

Even if you have to opt for this, you should make sure to repay the amount as soon as possible to minimise additional charges. Overspending on card

Credit cards provide users with a higher purchasing power. Access to more funds, combined with the convenience of an interest-free period, can sometimes lead to impulse purchases. Consistently spending beyond your means can accumulate a high credit card balance, which can potentially spiral into unmanageable debt. This raises the risk of late payments and additional costs in the form of late payment penalties and finance charges on outstanding as well as new transactions. To avoid this, the best approach is to make a monthly budget and stick to it by only spending as much as you can afford to repay at the end of the statement cycle. Minimum due amount

If you cannot clear the total dues on a card by the due date, you can have the option to pay a minimum amount due. While this helps avoid late payment fees and negative impact on your credit score, it comes with a cost. When you pay only the minimum due, as remaining balance, as well as any new transaction made with the card, starts attracting finance charges. Credit card finance charges can be as high as 45% p.a. or even more in certain cases, significantly increasing your debt burden. Hence, it is advised to pay the total amount due on your credit card every month. If you cannot afford to clear the dues in full, you should consider EMI conversion or balance transfer on EMI to manage your debt more effec-

Reward points/benefitsMost credit cards come with their unique reward programmes, cashback offers, and other lifestyle-related benefits. However, some users fail to optimise the benefits largely due to a lack of awareness around card benefits. Choosing the right card for specific purchases is crucial. For example, if you are booking movie tickets, a card that offers movie discounts would be more beneficial than a general rewards card. To maximise savings, you must select a card that complements your lifestyle, actively review the card benefits along with their validity, and understand how to make the most of it. While earning rewards is important, maximising their redemption value is crucial. For example, with an HDFC Regalia Gold credit card, redeeming points for statement credit gives you a value of ?0.20 per point, while redeeming for items in the Gold catalogue or travel bookings can yield a value-back of ?0.65 and ?0.50 a point, respectively. #### India must rethink its Arctic outlook

As conflict zones multiply globally, another frontier is quietly slipping into turmoil — the Arctic. Long seen as a realm of scientific cooperation and environmental protection, the polar north is becoming a theatre of military and geopolitical competition. With Russia more assertive, China expanding its Arctic ambitions, and Washington renewing interest in Greenland, the region appears set for a renewed phase of strategic contestation. In a curious way, the Arctic's movement from the margins of international politics to the heart of great power competition is an outcome of more than just clashing geopolitical ambitions. Climate change has been decisive, opening new maritime corridors and resource frontiers, and spurring a scramble for access. The Northern Sea Route (NSR), once passable only during narrow summer windows, is now virtually an open sea lane. Traffic is rising, potentially redrawing global trade patterns. Alongside this commercial promise lies a more concerning development: the steady militarisation of the high north. With Arctic states reopening old military bases, deploying submarines, and reinforcing claims through visible shows of force, the stakes for control and influence in the region are higher than ever. To be sure, the militarising impulse of Arctic powers is not new. Nor is the tendency to leverage polar presence for wider strategic manoeuvering. United States President Donald Trump was the first to drop pretences when he proposed buying Greenland in 2019. Far from the absurdity many deemed it, the idea had clear geopolitical merit; behind Mr. Trump's theatrics lay a deeper instinct — a recognition that the Arctic was no longer peripheral to global power play, but central to it. For non-Arctic powers such as India, the implications of a militarised Arctic are serious, prompting many to reassess their regional postures. Even so, New Delhi remains curiously insulated from the region's shifting realities. Faced with complex challenges closer to home, India appears oddly impassive to the dangers taking shape in the high north. India's 2022 Arctic Policy offers a thoughtful road map focused on climate science, environmental protection and sustainable development. It draws strength from the parallels between the Arctic and the Himalayan "Third Pole" — anchored in the belief that glacial melt and atmospheric shifts in the far north have cascading effects on South Asia's water security and monsoon cycles. Yet, the policy underplays the Arctic's rapidly evolving strategic landscape. As regional actors pivot from cooperative science to geopolitical contestation, India's restrained posture risks relegating it to the margins. The predisposition to remain apolitical — justifiable in an earlier era now appears increasingly anachronistic. Besides being absent from conversations reshaping access and governance, India remains detached from the emerging politics of influence in the Far North. This is not to say that India lacks a presence in the Arctic. It operates a research station in Svalbard, contributes to polar expeditions, and holds observer status in the Arctic Council. But these mecha-

nisms were designed for a more benign order — one built



on consensus and mutual trust. With the existing order visibly fraying, scientific diplomacy no longer seems fit-forpurpose. A constructive role for India The stakes for India are far from hypothetical. As the NSR becomes more viable, trade flows may shift northwards, potentially undercutting the relevance of the Indian Ocean sea lanes. Should Russia and China consolidate control over Arctic sea routes, India's aspirations to be a connectivity hub in the Indo-Pacific — articulated through initiatives such as Security and Growth for All in the Region (SAGAR) and the Indo-Pacific Oceans Initiative (IPOI) — could face serious headwinds. More concerning for New Delhi is the blurring of boundaries between the Arctic and the Indo-Pacific. Growing Russia-China strategic coordination in the Arctic and China's expanding naval presence in the Indian Ocean are making it harder for India to focus solely on its maritime interests in the south. An added challenge is the growing unease among Nordic states over India's long-standing ties with Russia, particularly as Moscow's brazenness in the Ukraine war deepens.India has yet to reassure its Arctic partners that an approach guided by strategic autonomy, rather than alignment, can still be beneficial for all sides.A more purposeful engagementNew Delhi, then, needs a recalibration — one that retains its climate-conscious ethos but builds sharper strategic focus. This calls for a threepart strategy. First, India must institutionalise Arctic engagement beyond science, with dedicated desks in the Foreign and Defence Ministries, regular inter-agency consultations, and collaboration with strategic think tanks. Second, New Delhi should partner with like-minded Arctic states on dualuse initiatives - polar logistics, maritime domain awareness, and satellite monitoring — that enhance India's credibility without raising red flags. Third, India must claim a seat at the table as new Arctic governance forums emerge on infrastructure, shipping regulation, digital standards, and the blue economy. India must also approach the Arctic's political landscape with sensitivity, avoiding an extractive mindset and engaging local communities with restraint and respect.India's current Arctic posture is not without merit, but it is no longer adequate. It rests on the hope that scientific cooperation and climate diplomacy can smooth over growing geopolitical fault lines.

### World Bank ED Parameswaran Iyer to represent India at IMF board



Parameswaran lyer, Executive Director at the World Bank, has been temporarily entrusted with the responsibility of being India's nominee director on the board of International Monetary Fund (IMF) ahead of a crucial May 9 meeting, sources said. Iyer's nomination was necessitated to fill a vacancy created with the termination of services of K V Subramanian as the executive director at the IMF, six months ahead of his three-year tenure.

The government's decision assumes significance as the IMF Executive Board will meet on May 9, to take a call on a new USD 1.3 billion loan under a climate resilience loan programme, along with the first review of the ongoing USD 7 billion bailout package for Pakistan. It is to be noted that India is making efforts to corner Pakistan diplomatically and at various global fora as New Delhi believes its involvement in the Pahalgam terror attack that led to killing of 26 tourists last month. According to sources, had India not nominated lyer, the alternate executive director Harischandra Pahath Kumbure Gedara of Sri Lanka would have discharged duties of ED as per the rules of the Washington-based multilateral funding agency.

The Appointments Committee of the Cabinet has terminated Subramanian's services effective April 30, 2025. The reasons for Subramanian's exit have not been officially announced. According to the sources, Subramanian is learnt to have raised questions about the IMF's datasets, which did not go down well in the corridors of the multilateral agency. In the past too, the IMF has been unhappy with some of the statements made by Subramanian, especially related to India's debt situation. Besides, the sources said, concerns were raised over an "alleged impropriety" relating to the promotion and publicity of his latest book, 'India@100: Envisioning Tomorrow's Economic Powerhouse'. The executive board of the IMF is composed of 25 directors (executive directors or EDs) elected by the member countries

### Bhushan Power saga: Why did Supreme Court reject JSW Steel takeover bid and order liquidation?



The Supreme Court on Friday rejected steel major JSW Steel Ltd's Rs 19,350 crore bid to acquire Bhushan Power and Steel Ltd (BPSL) through the Corporate Insolvency Resolution Process (CIRP) route, and ordered the liquidation of the company. While ordering the liquidation, the biggest in the corporate history, a bench of Justice Bela Trivedi and Justice Satish Chandra Sharma lambasted the delay on the part of JSW Steel to implement the resolution plan and said the Committee of Creditors (CoC) failed to exercise its commercial wisdom while approving the Resolution Plan.JSW Steel, controlled by Sajjan Jindal, and lenders are likely to go for appeal against the SC order as both the parties will suffer a setback if liquidation of BPSL is implemented

The liquidation of BPSL is set to be the biggest in the history of the corporate sector in terms of the size of the debt. Supreme Court of India earlier ordered the liquidation of Jet Airways, a once prominent Indian airline, due to the failure of a resolution plan and the inability of the Jalan-Kalrock Consortium (JKC) to fulfil its financial obligations. While Jet Airways was estimated to have owed its financial creditor around Rs 7,800 crore, a total of around Rs 15,723 crore was admitted as claims by the National Company Law Tribunal when the airline was first grounded in 2019. The number of cases ending in liquidation in FY24 was 2,476 involving total claims of Rs 11 lakh crore, according to Insolvency and Bankruptcy Board of India (IBBI). However, the liquidation value is just Rs 69,634 crore, just 6.33 per cent of admitted claims.

SC said JSW even after the approval of its plan by the NCLAT, wilfully contravened and not complied with the terms of the said approved Resolution Plan for a period of about two years, which had frustrated the very object and purpose of the IBC, and consequently had vitiated the CIR proceedings of the corporate debtor-BPSL. "In the instant case, JSW did not implement the Resolution Plan for about two years since its approval by the NCLAT, though there was no legal impediment in implementing the same. Such flagrant violation of the terms of the Resolution Plan, has frustrated the very object and purpose of the Code," the Supreme Court said.

After obtaining the approval of its Resolution Plan from CoC by presenting a rosy picture, misguiding the CoC, and defeating the rights of other resolution applicants, JSW did not respect and honour the said commitments, the SC said. On the contrary, it tried its level best to delay the implementation of the Resolution Plan without any cogent reason or justification, the order said. Though the said plan was got approved from the NCLT by the Resolution Professional (who was overseeing the resolution process) without confirming the compliance of Section 30(2) and the Regulations 38 and 39, JSW instead of complying with the terms and clauses of the approved Resolution Plan filed the company appeal before the NCLAT, just to delay the implementation of the Plan, the order said. "This is nothing but a misuse of process of law and a fraud committed by JSW with the CoC and other stakeholders," the order said.

According to SC, it is pertinent to note that though all throughout from the date of order passed by the NCLT till March, 2021, the stand of the JSW evidenced through an affidavit was that it was not obliged to implement the plan because of the pendency of these appeals. However, JSW played smart by making part payment to the financial creditors in March, 2021, realising the beneficial market trend of the steel, it said. It also surreptitiously got the effective date extended to March 31, 2021 from the so-called core group of CoC, which had already become functus officio and which had no authority to extend the said effective date, the court said. The net result is that the upfront payments as agreed to be made in the Resolution Plan within 30 days of the approval of the plan by NCLT was delayed by 540 days in respect of payment to the financial creditors and by 900 days in respect of payment to the Operational Creditors. "The equity commitment as per clause 2.3 of the Resolution Plan with regard to the infusion of equity into the company for an amount aggregating Rs 8,550 crore, to be infused upfront on the effective date, was also not complied with by JSW," the order said.

The Supreme Court said the Committee of Lenders (CoC) had failed to exercise its commercial wisdom while approving the Resolution Plan of the JSW, which was in absolute contravention of the mandatory provisions of IBC and CIRP Regulations. The CoC also had failed to protect the interest of the creditors by taking contradictory stands before the court, and accepting the payments from JSW without any demurer, and supporting JSW to implement its ill-motivated plan against the interest of the creditors, SC

said. The Resolution Professional (RP) had utterly failed to discharge his statutory duties contemplated under the IBC and the CIRP Regulations during the course of entire CIR proceedings of the corporate debtor (BPSL), SC said. "Just as the Resolution Professional had failed to examine and confirm the compliance of mandatory provisions of the Code, to secure the interests of all the stakeholders involved in the process, the CoC also did not discharge its duty to carefully examine the feasibility and viability of the plan, and the capacity and resources of the Resolution Applicant-JSW for the implementation of the plan proposed by it," SC said. There was a dishonest and fraudulent attempt made by JSW, misusing the process of the court by not making the upfront payments as committed by it for about two and a half years and thereby enriching itself unjustly, and thereafter considering the rising prices of steel in the market, JSW sought to comply with the terms of Resolution Plan at a very belated stage, in collusion with the CoC and the Resolution Professional, SC said.BPSL which came under the JSW fold in 2021 has been contributing to JSW's revenue and profit. The BPSL plant made a profit of Rs 11 crore in third quarter of FY25, loss of Rs 93 crore in Q2 of FY25 and a profit of Rs 300 crore in Q1. JSW is likely to face a decline of around 8-10 per cent in EBITDA (earnings before interest, tax, depreciation and amortisation) and revenue for FY26 if BPSL is liquidated, said an analyst

Further, JSW will have to recover Rs 19,300 crore given to the lenders if the liquidation is implemented. BPSL had expanded (Phase-II) of its plant from 3.5 MTPA to 5 MTPA. BPSL is a leading manufacturer of flat and long products and has state-of-the-art plants at Chandigarh, Derabassi, Kolkata and Odisha in India. Liquidation means end of the road for BPSL. When BPSL is liquidated, its assets are sold to settle debts, often at distressed prices, leaving less money for banks. This could result in significant losses for lenders, who have already taken a huge haircut. The unwinding of this transaction is expected to have farreaching consequences for the banking sector and IBC cases.

However, JSW Steel and lenders are likely to go for an appeal against the SC order on liquidation, banking sources said. The court battle is expected to continue as JSW and lenders have odds stacked against them. "We are yet to receive the formal copy of the order to understand the grounds for rejection in detail and its implications. Once we receive the order and are able to review the same along with our legal advisors, we will decide on our further course of action," JSW Steel said in a stock exchange filing on Friday. A senior bank official with a nationalised bank said banks are studying the SC order. "There could be some appeals against the SC verdict. There's a possibility that JSW might also appeal against the order," he said.

Bhushan Power, which was the top bank defaulter listed by the Reserve Bank of India (RBI), which went through the insolvency process under IBC, was acquired by JSW Steel after a four-year long process. The petition filed by the Punjab National Bank (PNB) against the company was admitted on July 26, 2017 and CIRP was initiated. It took 771 days to complete the resolution process, with JSW steel Limited becoming the successful resolution applicant, as National company law tribunal (NCLT) approved the resolution plan on September 5, 2019 and the National Company Law Appellate Tribunal (NCLAT) upheld JSW's resolution plan. After a two-year delay, JSW finally acquired BPSL in March 2021 under the Insolvency and Bankruptcy code. According to the resolution plan, the financial creditors were to be paid upfront a sum of Rs 19,350 crore on pro-rata basis against the admitted claims of Rs 47,157.99 crore. Accordingly, the resolution plan provided for a recovery of Rs 41.03 per cent to the financial creditors. As far as operational creditors are concerned, the resolution plan provided for the payment of 47.69 per cent of their admitted claims of Rs 621 crore. No claims were received from workmen/employees and other creditors.

### Govt. high school in Hassan secures 100% results in SSLC examination for eighth consecutive year



The government high school at Attavara in Hassan taluk has set a record by continuously registering 100% results in the SSLC examination for the last eight years. Since the academic year 2017-18, no student of the school has failed in the examination. All 25 students who appeared for the exam earlier this year had passed. While seven of them secured distinction, 14 scored a first-class score. The quality weightage percentage stands at 86.95, which is measured based on the number of students who secured distinction and first-class score.

Since 2017, as many as 210 students have appeared for the SSLC examination, and all of them have passed. The school has been maintaining a good pass percentage because of the activities the teaching faculty began eight years ago. K.P. Narayan, who is now the Block Education Officer of Arakalgud taluk, was the headmaster then. The teachers began to conduct unit tests every month, make house visits, interact with parents regularly, hold parents meetings on the school campus, conduct group studies, take extra classes early in the day and also in the evening, and give away prizes to those who score the highest in the unit tests. Such efforts yielded results.

G.M. Prakash, who teaches English in the school, said,

since 2017, the school has followed certain measures to achieve 100% results. "We have been continuing the same steps all these steps now that has helped us in retaining the same results. Headmaster H.P. Rajashekhar and other staff members have made sincere efforts for the current result". he said. The teachers felt the need to take the parents into confidence and involve them in the efforts. "We regularly meet the parents, and that helps us ensure the students give attention to studies when they are at home. We identified the slow learners at the beginning of the year and gave them extra attention. With the support of parents, we conducted extra classes till late in the evenings," Mr. Ashok said.Lakshmi of Channammaanahalli, who scored the highest mark in the school, 599 marks out of 625, said, "The teachers played a prominent role. They conducted surprise tests to check if we had understood the concepts well, which helped us concentrate on topics that needed more attention," she said. As the school has been maintaining an impressive pass percentage, many parents enroll their children in the school for Class 10. "Normally, some private schools insist that slow learners leave the schools at Class 10. We admit such students and make them clear the examination," Mr. Prakash added.

### Unhealthy lifestyles may be ageing your heart too fast

New Delhi: Unhealthy lifestyles are dramatically accelerating the ageing of the heart, contributing to a global rise in several cardiovascular diseases, finds a study, led by Indian-origin researchers in the UK. Using a new Cardiac magnetic resonance (CMR) imaging technique, also known as cardiovascular MRI scan, researchers from the University of East Anglia (UEA) uncovered the "true age" of a heart. The MRI scan revealed how unhealthy lifestyles can dramatically accelerate the heart's functional age. While among healthy people, the heart's age was found to be similar to the chronological age, for patients with diabetes, hypertension, obesity, and atrial fibrillation, the functional heart age was significantly higher. "For example, a 50-year-old with high blood pressure might have a heart that works like it's 55," said lead researcher Dr Pankaj Garg, from UEA's Norwich Medical School and a consultant cardiologist at

the Norfolk and Norwich University Hospital. "People with health issues like diabetes or obesity often have hearts that are ageing faster than they should – sometimes by decades. So, this could help doctors step in early to stop heart disease in its tracks," he added. The findings could transform how heart disease is diagnosed — offering a lifeline to millions by catching problems before they become deadly, said the researchers who called their cutting-edge technique a "game changer for keeping hearts healthier, longer". "It could also be the wake-up call that people need to take better care of themselves - whether that's eating healthier, exercising more, or following their doctor's advice. It's about giving people a fighting chance against heart disease," Garg said. The team collaborated with hospitals in the UK, Spain, and Singapore and studied MRI scans from 557 people, of which 191 were healthy individuals, while 366 had conditions like high blood pressure, diabetes, or obesity

# If PSG beat Inter, coach Luis Enrique will recreate this ritual in memory of deceased daughter Xana who passed away from cancer

The complex, brilliant and demanding coach of Paris Saint-Germain, Luis Enrique, who turned 55 on Thursday, wants to relive a poignant moment from the past in the memory if his daughter, Xana. It is a quiet, added motivation for PSG when they taken Inter Milan in the final of the UEFA Champions League on May 32.At age 9, Xana passed away after as a result of osteosarcoma, a type of cancer that attacks the bones and particularly affects children. Back when Xana was detected, Lucho stepped away from the national team for a while "for family reasons". In his autobiographical miniseries "You Have No F... Idea", produced in Spain and currently playing on Prime Video, Lucho has looked back on the tough times around the death of his 9-year-old daughter. He was already a champion with Messi's Barcelona in 2015, and while seeking glory in Paris against Inter, he declared with a smile, that should PSG win in Munich, he will repeat the ritual from Barca win for his daughter. "I have incredible memories, because my daughter loved parties, and I'm sure she's still having them wherever she is," he was quoted by Clarin. He continued: "I remember an incredible photo I have with her at the Champions League final in Berlin, after winning the Champions League in 2015, planting a Barcelona flag on the pitch. I wish I could do the same with PSG," he added.Barca of 2015 was the legendary MSN-era, of Messi, Suárez, and Neymar, who won everything they played in the 2015 season. Winning with PSG, no longer a side of Galacticos after Messi, Neymar and Mbappe left, but coherent with Donnarumma, Dembele and Fabi Ruiz, will also be an opportunity to pay tribute to his daughter.

Luis Enrique Martínez García, known and adopted by the football world as Luis Enrique, is described by Clarin as "a warrior on the pitch, as well as a fierce goalscorer, de-

spite the fact that he stood out playing in the midfield with the shirts of Barcelona, ??Real Madrid and the Spanish national team, the only three he wore as a player, in addition to that of Gijón, his city. That imprint carried over into his career as a coach, and it is clear that it also guides his life." After eliminating Arsenal 3-1 aggregate by winning both matches in the semi-finals, Lucho hasa chance to become European champion again. Lucho also coached Qatar at the World Cup and surprised fans by running marathons and triathlons when he was considered the best coach in the world, as per Clarin. Having played in three World Cups in the 1990s he went to Qatar 2022 as a coach, where he was known for his bike rides. His live streams gained a huge following for elucidating on his adventure in the Middle East, in a relaxed and cheerful manner despite the fact that he had to analyze his team's inconsistent campaign, losingbin pre quarters. In the miniseries "You Have No F... Idea", Lucho looks back at Xana's death: "I consider myself lucky, I am very lucky. My daughter came to live with us for nine wonderful years," he expressed.

"We have a thousand memories of her, videos, incredible things. My mother couldn't have photos of Xana. Until I came home and said to her, 'Why aren't there any photos of Xana, Mom?"Mom, you have to put up photos of Xana, Xana is alive,' I replied," he recounts in his miniseries. "She's not here physically, but she is here spiritually. Because every day we talk about her, we laugh and remember her. Because I think Xana still sees us. How do I want Xana to think that we lived through this...?"Lucho's time with PSG has been memorable beyond the persistet success in Europe. His press conferences have endeared him to Parisians. In the first, he tried to learn French and mocked his difficulties, Clarin writes. Recently, he congratulated a journalist who was doing an internship for the guestion she had asked him. And in another moment, he spoke about a topic that is natural and everyday for him but that leaves a lump in his throat: his memory of Xana. "My daughter won't be there, she won't be there physically, but she'll be there spiritually, and that's very important to me. I'm motivated to continue moving forward with what life gives me, sharing it with my family," the Spaniard said recently. Lucho, with his wife, Elena Cullel, and his two oldest children, Pacho and Sira, has committed himself to the fight against cancer and decided to create the "Xana Foundation" in March 2024. Its main objective is to offer comprehensive care and support to children and young people affected by serious illnesses and to provide support to their families. In addition, it has its own programs and collaborates with and funds external projects related to the cause. On his Twitch channel, Clarin quoted him as saying, "The Xana Foundation was created with the purpose of helping all those people who, unfortunately, go through these experiences and do not have the resources to support their children. In our case, we were lucky enough to be able to leave our jobs and dedicate ourselves 100% to Xana in her process. We want to help these families and accompany them."

in Berlin. Bayer 04 are ready for the future. The positive path will continue and I will be excited to follow it," he added. Alonso, a Champions League winner with Real and a World Cup hero with Spain, began his coaching journey with Real Madrid's youth teams before rising through the ranks at Real Sociedad B. Since taking over a struggling Leverkusen side in October 2022, he's transformed them into one of Europe's most feared outfits, losing just once in 53 matches last season. There have been recent rumours that the Spaniard could succeed Carlo Ancelotti as the next coach of Real Madrid. The Spanish giants have already been eliminated from the Champions League this season while they are now in a close La Liga title race against Barcelona.

There's a strong foundation to build on, and I believe we have what it takes to achieve something special," said Conrad.If all goes as per plans Conrad will oversee two major white ball events — T20 World Cup 2026 in India and the 50-over World Cup 2027 on home soil. "During this period, planning will be key for us as we look to manage our player base to ensure that the strongest teams can be fielded in every format. We want to obviously be the best in the world in all three forms of the game and that is no doubt my number one target and goal for the Proteas," he added.

### 'The body will adapt and take its own time': Mayank Yadav on his dropped pace post injury

Lucknow Super Giants (LSG) ace pacer Mayank Yadav returned to action in the Indian Premier League 2025 after recovering from a lower back injury, which kept him away for more than six months. He made his comeback against Mumbai Indians and picked two wickets — big scalps of Rohit Sharma and MI skipper Hardik Pandya — in his first game. However, the speed merchant has lost significant pace and has been quite expensive in the two outings he has had in this IPL.But, the Delhi pacer believes that the drop in his speeds after returning from an injury layoff "is normal", and said that he needs to give his body time to return to the same match intensity and fitness standards.

"This is normal. I had a major injury because of which I was out of cricket for five to six months. The body will

adapt and take its own time. I will have to give some time to my body and my bowling to get those speeds back. There have been no changes in my bowling technique," said Mayank ahead of LSG's game against Royal Challengers Bengaluru (RCB) in Lucknow on Friday.

There is no drastic change in my strategy. I will continue to do what I used to. My body is taking a little time. I have not seen the intensity (and) the match pressure for a while now. So it is very normal that the body is responding a little differently after a major injury. I don't have a different mindset or intent. That remains the same. But I need to read the wickets and the batsmen quicker," Mayank was quoted by ESPNcricinfo. Mayank came into the limelight during IPL 2024, where he was impressive for LSG. He bowled the fastest delivery of the tournament, clocking 156.7 kmph and was fast-tracked for the national team as well.LSG are struggling in the standings after their campaign seemed to have derailed in the latter half of the league. Mayank accepted that LSG have made mistakes in the tournament so far, but backed his skipper Rishabh Pant, who is having a terrible tournament, to bounce back. "We have been a little late in assessing the grounds and the wickets. We have made mistakes there; I'll accept that. But we have three matches, and if we win that, there might be a chance we can make the playoffs," said Mayank."I have known Rishabh bhaiya for a while now because we play for the same club in Delhi," he said. "Whenever I have spoken to him, I have not felt that he is under pressure. He is confidently talking to me about the game, about the situation, (and) about the

### Yashasvi Jaiswal does a U-turn, wants to continue playing for Mumbai

So I sincerely request MCA to allow me to play for Mumbai this season! I have not submitted the NOC to BCCI nor to Goa Cricket Association," Jaiswal wrote in email to MCA, assessed by In April, Jaiswal had taken MCA officials by surprise when he sought an NOC to move to Goa. Jaiswal had cited personal reasons behind the reason to shift base. Goa had qualified for the knockout stage of the Ranji Trophy. If Jaiswal had gone ahead with his plan to represent Goa, he would have followed the likes of Arjun Tendulkar and Siddhesh Lad, this generation Mumbai players who have also represented Goa.

The India opener, who has had a splendid start to his Test career and was the best Indian batsman during the last Border-Gavaskar Trophy series in Australia with a hundred and two half-centuries, said getting a leadership role with Goa was the reason for making the switch.



"Goa has thrown me a new opportunity and has offered me a leadership role. My first goal will be to do well for India and whenever I'm not on national duty, I will be playing for Goa and try to make them go deep into the tournament. This was an (important) opportunity which came my way and I just took it," Jaiswal had told The Indian Express. Jaiswal had moved from Suriyawan in Uttar Pradesh's Bhadohi to Mumbai at the age of 11 to pursue cricket. He has represented India since his Under-19 days and burst onto the scene with a double century in the Vijay Hazare Trophy a few seasons ago. It was his exploits for Mumbai that got him on the national selectors' radar and a contract with the Rajasthan Royals in the IPL.

### 'It's hard to describe what it's like to be manager of Man Utd': Manchester boss Ruben Amorim after reaching Europa League final

Manchester United thrashed Athletic Bilbao 4-1 at Old Trafford in Manchester on Thursday to set up a final clash against another Premier League club, Tottenham Hotspur, in the Europa League. For Man Utd or Tottenham, a miserable campaign will end in Europa League glory.

Despite both teams languishing in the bottom half of the Premier League, the Champions League is now just one game away. However, United manager Ruben Amorim believes nothing less than a silverware matters for them, "If we don't win the final, it means nothing for us," said Amorim after the match. "It's hard to describe what it's like to be manager of this club. You want to give them (the fans) something, because we've been so disappointing in the Premier League." United came back 1-0 behind at halftime against Bilbao, with Mason Mount coming off the bench to score twice after the break. Casemiro and Rasmus Hojlund were also on target. They beat Bilbao 7-1 on aggregate, while Tottenham won 2-0 away at Bodø/Glimt to seal a 5-1 aggregate victory. This also sets up an all-English Europa League final for the second time in six years after Chelsea



beat Arsenal to lift the trophy in 2019. United sit 15th in the standings, having lost a club record 16 games in the Premier League. It is also certain to record its worst-ever points total in the modern era, as well as its lowest finish. In head-to-head, Spurs won all three of the previous encounters — twice in the league and also in the English League Cup. "We are struggling, both of us, so I don't know what is going to happen," Amorim said on the final vs Spurs. "

"He had stopped helping himself and was inflicting further damage on himself and I couldn't stay there and watch him do that. He was taking seven painkillers a day. At the end, his kidneys did pack up and this was after I had opted out. When I left, I still cared. I have no guilt because I am sure 99 percent women wouldn't have lasted as long and as honestly as I did.'

Infact I have revered my Kannada songs way more than my songs in other languages including Hindi. There are 100s of videos circulating on social media as a testimony. I have more than hour of Kannada songs that I prepare for every concert when in Karnataka."

He added, "However, I am not a young lad to take humiliation from anyone. I am 51 years old, in the second half of my life and am entitled to take offence for someone as young as my son threatening me directly in front of thousands in the name of language that too Kannada which is my second language when it comes to my work. That too right after my first song of the concert!"The singer shared this behaviour by the young student provoked others too who joined him in demanding songs in Kannada. "Their own people were embarrassed and were asking them to shut up. I told them very politely and lovingly the show has just started, it's my first song and that I will not let them down, but they have to let me continue with the concert the way I have planned. Every artiste has a song list prepared so the musicians and technicians are in sync. But they were hell bent on creating ruckus and threatening me wildly. Tell me who is at fault?"Sonu explained, "Being a patriot that I am, I loathe anyone trying to create hate in the name of language, caste or religion especially after what transpired in Pahalgam. I had to school them, and I did, and thousands of students and teachers cheered me for it. The matter got over and I sang Kannada for more than an hour. It's all there on social media."He concluded his post by showing trust in the people and police of Karnataka. He wrote, "I leave it upto the sensible people of Karnataka to decide who is at fault here. I will accept your verdict gracefully. I fully respect and trust the law agencies and Police of Karnataka and will comply with whatever is expected from me. I have received divine love from Karnataka and will cherish it always with no malice whatsoever irrespective of
