New Delhi: India on Monday reiterated that Operation Sindoor was a targeted response against terrorism and its support infrastructure, lamenting that Pakistan chose to stand with terrorists rather than remain neutral, prompting a necessary military retaliation."We have also reiterated that our fight was against terrorism and their support infrastructure and not with the Pakistan military. However, it is a pity that the Pakistani military chose to intervene and that for terrorists, which compelled us to respond," said Director of Air Operations Air Marshal A.K. Operations, during a joint DGMO press briefing.He clarified that India's strikes on May 7 targeted only terrorist hideouts, but Pakistan's direct military

Since the beginning of Operation Sindoor, several international stakeholders have reached out to India and Pakistan calling for deescalation, but India has officially maintained that the two sides had not severed diplomatic contacts as both countries continued to host each other's diplomatic missions despite escalating mili-

Airports Authority of India (AAI) on Monday (May 12, 2025) announced that civilian flight operations will resume at 32 airports that were temporarily shut last week in view of the military standoff between India and Pakistan. Security measures were enhanced, and at least 32 airports in northern and western parts of the country were temporarily shut in view of the conflict.On Saturday, India and Pakistan reached an understanding to stop all firings and military actions on land, air and sea with immediate effect.

In a statement on Monday, state-owned AAI said the 32 airports that were closed for civilian aircraft operations till 0529 hours of May 15 are now available for operations with immediate effect. Flight services restored at 32 airports amid easing tensions between India and Pakistan

"It is recommended for travellers to check flight status directly with Airlines and monitor airlines' websites for regular updates," the statement said. Civilian flight operations from the 32 airports across northern and western India, including Srinagar and Amritsar, were suspended from May 9 to

India on Monday said all its military bases and systems continue to remain fully operational and ready to undertake any mission if the need arises. At a press briefing in New Delhi, Director General of Air Operations, IAF, Air Marshal A.K. Bharti said India's robust air defence system effectively thwarted Pakistani attempts to target Indian installations. India launched Operation Sindoor on early May 7 to destroy nine terror infrastructures in Pakistan and Pakistan-occupied Kashmir (PoK) in retaliation to the Pahalgam terror attack. All subsequent retaliations to Pakistani offensives were carried out under 'Operation Sindoor'. THE Indian Premier League (IPL), the biggest cash ow in world cricket, has finally been suspended amid an escalation in India-Pakistan hostilities. The decision was aken hours after Thursday's match in Dharamsala was alled off midway following air raid alerts in neighbouring ities of Jammu and Pathankot. It's unpardonable that the natch was allowed to begin in the first place, considering he increasingly volatile situation after the launch of Operation Sindoor. The security of everyone who was present nere — players, officials, spectators, etc — was brazenly compromised. It was a huge lapse for which the IPL broanisers and the local administration owe an explanaon. A floodlit stadium with thousands inside could have een an ideal target for Pakistani drones; it's hard to imagne the scale of the tragedy that could have happened Moreover, the evacuation led to chaos outside the stalium, with blinding car lights making a mockery of the plackout.War clouds were looming large after the April 22 Pahalgam terror attack, but it remained business as usual n the IPL, which is organised by the Board of Control for Cricket in India (BCCI) — one of the richest sports boards n the world. Matches continued to be held with trademark anfare in packed stadiums, disregarding not only the panndia anger and grief over the massacre but also the bor ler tensions that were worsening by the day.Unfortunately his is not the first time that the BCCI has allowed comnercial interests to override safety concerns for as long s possible. In 2021, IPL matches continued for four weeks even as cases of Covid-19 infections and deaths rose larmingly across the country in April. It was decided to ostpone the tournament only in the first week of May afer several players and support staff tested positive for coronavirus. Sport is one of the most popular modes of ntertainment in India and abroad, but it is insensitive and riminally negligent to organise matches when an armed

He directed that the entire town be aesthetically illuminated to create a festive atmosphere throughout the 12-day Pushkaram period. He specifically instructed that the idol of Goddess Saraswati be tastefully decorated with flowers.""Highlighting the incomplete status of the pindapradana mandapam, the Minister expressed strong displeasure towards the officials of the Endowments Engineering Department. He emphasized the need for robust security arrangements to facilitate smooth viewing of the Harathi ritual by devotees. Temporary access roads and coir mats must be installed to ensure safe access to the river, while barricades and warning signs should be placed to avoid accidents.""The Minister directed that 50 trained swimmers be deployed and country boats kept ready for emergency response. He announced that, for the first time, a tent city was being established at Kaleshwaram to accommodate pilgrims. A detailed, minuteto-minute schedule must be prepared to ensure efficient coordination of events. Special officers from the Endowments Department are to be assigned for supervision of key ceremonies. "He confirmed the Chief Minister's participation in the inauguration and noted the expected visits of the Governor and other state ministers. Therefore, he emphasized the need for comprehensive security arrange-



ments. The installation of streetlights and strip lighting along roads from Mahadevpur was instructed, along with repairs to all damaged roads by the Roads & Buildings and National Highways departments.""Temporary lighting and sanitation facilities, including mobile toilets, are to be established at the temporary bus stand. The Minister stressed the importance of maintaining public hygiene and cleanliness throughout the town. He ordered that public toilets be cleaned every 30 minutes and that adequate supervisory staff be deployed.""The Minister cautioned contractors to maintain high standards of quality and warned that strict action would be taken in cases of negligence. Nodal officers are to remain on-site and take full responsibility for their assigned tasks. 

#### **Kavitha exposes Congress govt's attempt** to convert TGIIC to public company

Hvderabad: After its decision to sell land in Kancha Gachibowli ending up in the Supreme Court, the Congress government is now betting on nearly 1.75 lakh acres under the control of Telangana Industrial Infrastructure Corporation (TGIIC). Accordingly, the government is now reportedly conspiring to convert the corporation into a public limited company. The government issued GO No.12 on April 15, authorising the change in TGIIC's status from a private limited company to a public limited entity. This shift is meant to facilitate larger borrowings by enabling access to capital markets through bonds, debentures, or even a potential

Releasing the GO at a press conference at Telangana Bhavan on Monday, BRS MLC K Kavitha charged the Revanth Reddy government with conspiring to mortgage Telangana lands on the stock exchange to raise massive loans. She demanded the immediate withdrawal of the GO, questioning the secrecy behind the move."I have specific evidence. Why was this change hidden from the public? What will happen to Telangana's lands if there is a loss in the market? This is a betrayal of the people's trust," she

Kavitha reminded that the Revanth Reddy government had borrowed over Rs 1.8 lakh crore in just 16 months, with no major welfare scheme fully implemented. "While part of its was spent for administration and repayment of loans, nearly Rs 1 lakh crore was paid to big contractors, of which Rs 20,000 crore was paid to Revanth Reddy as commission," she claimed, demanding a white paper on State finances. According to the GO, the number of shareholders has been increased from the existing four to seven, fulfilling the legal criteria for the conversion. The vice chairman and managing director of TGIIC has been directed to take necessary action in this regard.



Sources said consequent to change of status of TGIIC to a public company, status of all its subsidiaries also would change to deemed public companies. The change in status would also result in wider participation of investors in secondary markets for bonds and debentures, enabling the company to raise more loans. Public companies often find it easier to secure future financing i.e. enable them to borrow larger funds. Public companies face stringent reporting, disclosure, and compliance requirements, increasing operational costs and administrative burden, and must disclose financial and operational information to the public. However, public shareholders can influence company decisions, potentially impacting founder control and strategic direction. Such traded companies are vulnerable to hostile takeover attempts as well.

#### Dalit Bandhu beneficiaries stage dharna for second installment in Karimnagar



GNS News Agency, May 12

Karimnagar: Dalit Bandhu beneficiaries from Huzurabad constituency on Monday staged a dharna in front of the Collectorate here demanding the release of the second installment of the scheme. The beneficiaries, who came to the district headquarters to submit a representation during the Prajavani programme, staged a protest, stating officials were not releasing the amount even three months after the proceedings were issued by the State government for completion of grounding of units with the second installment. As the amount has not been released, they were facing troubles to run units established with the first installment, they said, asking the Collector to take the initiative to release the installment.

After 13 months of struggle by the beneficiaries, the State government had on January 27 issued orders unfreezing Dalit Bandhu accounts, which were frozen soon after the Congress government came to power in December 2023. The government had instructed for grounding of units with Rs 324.75 crore pertaining to 9,937 beneficiaries under Dalit Bandhu-I and Rs.9.88 crore pertaining to 471 beneficiaries under DB-II. Though the government gave its nod, the money was not released due to the Graduates and Teachers MLC election code. Even after that, beneficiaries were unable to withdraw the amount from their accounts. Enquiry about grounding and functioning of the units sanctioned in the first phase was stated to be the reason for the stalemate. It is learnt that a few beneficiaries had closed their units due to various reasons. The government was enquiring into that too. Speaking to Telangana Today, Dalit Bandhu Sadana Samithi member Kalukuri Naresh said though the government issued orders unfreezing Dalit Bandhu accounts on January 27, it had not been implemented due to MLC election code. ## Delhi govt approves Rs 107-crore e-bus charging project for 4 Dwarka depots



GNS News Agency, May 12

As the Delhi government plans to operate only electric buses for public transport in the national capital, its transport department has approved a charging infrastructure project for four bus depots in Dwarka. With an estimated cost of Rs 107 crore, the project is expected to be completed within 18 months, aiming to support the growing fleet of e-buses and promote sustainable urban mobility. According to officials, the power infrastructure will be set up by BSES Rajdhani Power Limited at Cluster Depot I, Cluster Depot II in Sector 22, ISBT in Sector 22, and DTC Depot in Sector 8 in Dwarka, exclusively for electric buses

"The Delhi government has decided to replace the existing fleet of CNG buses of DTC and the cluster scheme  $\,$ 

with electric buses in a phased manner. Charging infrastructure is required to charge electric buses being introduced by the transport department. The proposal has also been approved by EFC (Expenditure Finance Committee) for sanction," said a senior official. Officials said that as per guidelines of the Delhi Electricity Regulatory Committee, it is the responsibility of the respective discoms to provide electric connection up to the metering point at bus depots. "BSES Raidhani Power Limited will finalise vendors to carry out civil works of the grid and to supply electrical equipment and cables to establish the grid," said an official. Officials said the government is keen on having financially viable, long-lasting and permanent charging infrastructure. "The transport department has also been advised to undertake a detailed study and to explore the best practices adopted in other countries having robust EV charging infrastructure. Now, after due deliberations and considering the recommendations from the department, the finance department has approved the project," said an official. The finance department has directed the transport department to complete the project at the sanctioned cost within the stipulated period. No cost escalation will be considered in future. Officials said the work would be completed within 18 months from the receipt of payment by BSES Rajdhani Power Limited. Around 7,000 public transport buses ply in Delhi and 1,600 of them are electric buses. On average, approximately 87 lakh passengers use the public transport system in the national capital daily-25.02 lakh on DTC buses, 16.39 lakh on cluster buses, and 46 lakh on Delhi

#### **Heatwave to hit South Bengal**

The India Meteorological Department (IMD) in Kolkata has said an impending heatwave is likely to affect several districts of South Bengal from May 8. The condition is expected to persist until May 12. The forecast indicates a significant rise in both temperature and humidity, with deviations expected to be around 4 to 6 degrees above the seasonal average.

According to the special IMD bulletin, the worst-affected districts will be Paschim Bardhaman, Purulia, Bankura, and Birbhum, where maximum temperatures are likely to soar to 40 degrees Celsius or higher. The region is also expected to experience elevated humidity levels. The maximum relative humidity in coastal districts could range between 80-90% while interior districts may record levels around 70-80%. These combined factors are expected to result in sultry and uncomfortable weather conditions, increasing the risk of heat-related illnesses.

"The upcoming heatwave may severely impact vulnerable sections of the population, including infants, the elderly, individuals with chronic illnesses, and those exposed to the sun for prolonged periods such as construction workers, farmers, and traffic personnel. There is a heightened risk of heat exhaustion, cramps, heatstroke, dehydration, and heat-related skin ailments like heat rash," the regional meteorological centre stated in its bulletin.



As part of its advisory, the IMD has urged the public to take necessary precautions. People are advised to avoid stepping outdoors between 11 am and 4 pm, which are the peak hours of heat exposure. It is recommended to stay indoors in well-ventilated or shaded areas as much as possible, wear lightweight, loose-fitting, light-colored cotton clothing, and keep heads covered when stepping outdoors. Doctors have also weighed in with additional health advice. "It is essential to consume a lot of mineral-rich fruits, vegetables, water, and natural juices to beat the heatwave," said Dr Arindam Biswas of R N Tagore Hospital. Echoing this, Dr Pratim Sengupta of Bellevue Clinic said, "Always carry a bottle of water during the heatwave and keep yourself hydrated."

#### 'We should keep politics aside': Sharad Pawar hails India's Operation Sindoor strikes in Pakistan, PoK

NCP (SP) Chief Sharad Pawar, Operation Sindoor, Pune"At a time like this, we should keep politics aside. We stand by the action taken early this morning by the Indian Air Force," says Sharad Pawar. #### 'Their souls will be in peace': Families of Pahalgam terror attack victims from Gujarat's Bhavnagar, after Operation Sindoor



"My son's dream was to join the Army and fight for the nation but now, look at God's will — it became the opposite," says 45-year-old Kajalben Parmar who lost her 17-year-old son Smit and 46-year-old husband Yatishbhai in the April 22 Pahalgam terror attack, when the family was a trip to Jammu and Kashmir. She demands "much more" than Operation Sindoor: "This should only be a jhalak (glimpse) of the action taken by India against the terrorists who took away sindoor (husbands) and lives of their sons."

Kajalben told The Indian Express, "Modi saheb (Prime Minister Narendra Modi) is like God to us. We won't forget what the country and Army did for us. With the action taken by the Army and Modi saheb within 15 days of the attack, we are really feeling good. The terrorists who took away our husbands have been taught a lesson. The loss and grief cannot be forgotten for life but at least their soul will be in peace. Yatishbhai Sudhirbhai Parmar's seven-member family left for Srinagar on April 16 to attend a Ram Katha by spiritual leader Morari Bapu. The family was set to return to Gujarat in a day or two, but the Pahalgam terror attack brought their trip to Jammu and Kashmir to a tragic end as Yatishbhai and his 17-year-old son Smit were among the 26 people killed by terrorists. The family, originally from Palitana, lives in the Nandanvan Society in Kaliyabid area of Bhavnagar city."I am not able to look at the photo of Smit on my phone now. He really wanted to join the Army and had also joined NCC in school. I wanted to see him in an Army uniform. The loss is forever," Kajalben told Bharatbhai Parmar (38), cousin of Yatishbhai, said, "We are happy that the terrorists have got a befitting reply. This is absolutely correct, it is very good. We are a little relieved that the In-

dian Army has avenged the lives of our family members."

Revealing the incidents of April 22, Kajalben told this



paper, "We only heard Allah hu Akbar and daudo bhago. My husband and son were at some distance from us. What happened after that, we are clueless. It was only my 15-year-old nephew Sarthak Manojbhai Nathani who pulled me and the other family members from the scene and sought help from the Army and we could return safely. Only his bravery could bring us back alive." Kajalben's elder son Abhishek who works in a private laboratory in Bhavnagar too expressed his satisfaction over the action, terming it to be a swift action within 15 days.

Gujarat Chief Minister Bhupendra Patel has paid tributes to the late father-son of Bhavnagar at their residence. The bodies of the father and son killed in the terrorist attack were brought from Srinagar to Mumbai and from Mumbai to Ahmedabad. From Ahmedabad, both the bodies were brought to Bhavnagar by road at midnight. While Yatishbhai owned a salon and restaurant, his son Smit was a Class 11 student at Vidhyadhish School. They had gone to Jammu and Kashmir to attend Morari Bapu's Katha at Sher-i Kashmir International Convention Centre in Srinagar from April 19 to 27. The Parmars, along with four members from Yatishbhai's in-laws' side, left for Srinagar on April 16.

#### 'Not an iota of evidence': Karnataka HC acquits senior citizen accused of growing cannabis in backyard

Karnataka high court acquits senior citizen accused of growing cannabis in backyardThe senior citizen petitioner's counsel argued that for there to be a case of cultivation, there had to be an intentional raising of the plants. The Karnataka High Court has acquitted a senior citizen accused of growing cannabis in his backyard, observing that there was no proof that he had been actively cultivating the plants.

The order was passed on April 29 by a single-judge bench of Justice M Nagaprasanna and was recently made available. As per the case, in January 2023, the house of the senior citizen in Bengaluru was searched based on a tip-off that cannabis was being cultivated. Criminal proceedings were later initiated against the senior citizen under the Narcotic Drugs and Psychotropic Substances Act. The se-

nior citizen petitioner's counsel argued that for there to be a case of cultivation, there had to be an intentional raising of the plants. The five cannabis plants, which were seized, the counsel said, were growing amongst other weeds in the backyard. The counsel also stated that it might at best have been a case of cross-pollination, causing the plants to sprout, as there was no evidence of cultivation. He further argued that the plants were not properly segregated and the 27.3 kg weight stated by the police was taken by including the roots, stems, leaves, and buds. On the other hand, the prosecution argued that the petitioner was prima facie guilty and the matter should go to trial. The court concurred regarding the issue of segregating the plant material and pointed out that growth in nature is not cultivation. "If what was seized and the summary of the charge sheet are read in tandem, it would become an admitted fact that roots, stems, leaves, buds including plastic bag were put to weight. Whether this could be done is what is required to be noticed.... While it is a crime to permit cultivation of a cannabis crop in the residential premises, in the case at hand it is in the backyard amongst other weeds, general in nature,' the court said. Several cases, including statements by the Supreme Court to this effect, were cited. Dismissing the case, the bench stated, "The prosecution has not placed an jota of evidence to demonstrate that the petitioner was cultivating ganja...segregation of leaves and the actual ganja is not made prior to weighing the same and the charge sheet is filed. Therefore, the charge sheet is filed blatantly con-

## Target \$1-trillion economy: At UP cabinet meet, nod to policy to make state a 'global service centre'

As part of its efforts to attract global investment, Uttar Pradesh government has rolled out the Global Capability Centres (GCC) Policy, which was cleared by the Cabinet .The policy is aimed at making the state the next "global service centre" of the country and also helping UP achieve its \$1-trillion dollar economy mark, officials said.

Officials said that with the incentives offered in the policy, which has been prepared after studying similar policies in other places, it is expected to attract global companies working in IT, banking, healthcare, engineering as well as next generation technologies towards UP for "large-scale investment". Elaborating further, Principal Secretary, Industrial Development, Alok Kumar, informed that the state has a large talent pool in many sectors including science, law, engineering. He said, "To get better quality work at less cost, many multinational companies are setting up their offshore development centres in Uttar Pradesh..."Kumar said software and IT companies are establishing such GCCs, which include machine learning, cloud computing, robotic process automation, Al-driven development, cyber security, engineering development etc. He said there are many elements of engineering design as well which are expensive and timeconsuming but this work can be done at lesser prices and with high quality with the help of these centres in UP. "multinational companies are coming to India to outsource work in banks, financial services and insurance sector," he explained, adding that companies from the automotive sector, electronics and semiconductor manufacturing sectors have also come to the state.

Officials said that at present there are nearly 1700 GCCs in India and this number is expected to grow rapidly. "Microsoft has just laid the foundation stone of a 10,000seater development centre in Noida. MAQ has also set up a 3,000-seater engineering development centre. We have to make arrangements to bring these centres in cities such Kanpur and Prayagraj along with NCR and Noida," said Alok Kumar. Under the new policy, investors will get comprehensive assistance at every level from operations to skill development. As per the policy, under operational subsidy, 20 per cent subsidy on rent, electricity, bandwidth and data service, assistance of up to Rs 180 crore can be received. At the same time, under payroll subsidy, the benefit of reimbursement of up to Rs 1.8 lakh per annum on the salary of employees residing in UP will be available. Under fresher and intern subsidy, assistance of up to Rs 20,000 will be received on recruiting new gradu-



ates and Rs 5000 per month on internship. Special provision has been made for socially backward classes under EPF, training and R&D grants.

Apart from these incentives, exemption in land and stamp duty, subsidy on capital and interest, as well as reimbursement of SGST has also been offered under the new policy. Officials claimed that the policy would help generate high-salaried employment opportunities in the state. Finance Minister Suresh Khanna said that most of the provisions of the previous policy have been retained in the new policy and that by June 2025, the officers of Group A and B who have completed three years of service in a district will be transferred to other districts and the officers and employees who have completed seven years in the division will be transferred. The transfer will be a maximum of 20 per cent of the number of officers working cadre wise in Group A and B and 10 per cent respectively in Group C. For Group B category, it will be done on the basis of a merit-based online system. In this sequence, the parents of physically challenged children and completely disabled children will be deployed at such places where there will be proper arrangement for proper care and medical care.

Two major steps have been announced to tackle unplanned parking problems of both lightweight vehicles as well as heavy vehicles and at the same time create a source of income. The Cabinet gave nod to UP Municipal Corporation (Construction, Maintenance and Operation of Parking Space) Rules 2025. Urban Development and Energy Minister A K Sharma informed that due to the huge increase in private vehicles in the state, pressure is increasing on the roads as well as parking spaces. He said that in such a situation, these rules would ensure implementation of uniform parking rules in the municipal corporations of UP that will increase the revenue generated from parking and prevent

## Punjab questions Centre apathy on exploration of potash reserves

Punjab Mines Minister Barinder Kumar Goyal Tuesday accused the Centre of "discriminating" against the state by not taking up exploration of potash in state, despite the AAP government raising the issue several times. "Despite discovery of substantial potash reserves near Muktsar and Abohar regions, an area bordering Rajasthan where similar deposits have been found, the Union government has consistently withheld necessary approvals for further exploration and development," Goyal said.

Stating that discrimination is evident in the allocation of exploration efforts, he said while 158 drilling sites have been set up in the adjacent area in Rajasthan to determine location, quality, and quantity of potash deposits, merely nine drilling sites have been permitted in Punjab. "This glaring disparity was formally raised during a recent all-India mining and geology ministers' conclave in Odisha. I brought this critical matter to the attention of Union Minister G Kishan Reddy, who invited me to visit the site and subsequently meet him in Delhi for comprehensive discussions," he said. "For the past two and a half months, I have been diligently requesting the Union Minister, but have not yet received a confirmed appointment. While political considerations have their place, this transcends partisanship and represents a matter of profound national importance," he added. "Potash is a crucial mineral that is not found elsewhere in the country. Currently, India imports 100 per cent of its potash requirements, which significantly depletes our foreign exchange reserves," he said, adding with reserves found in Punjab, huge money can be saved. "But this is their treatment. They do not want to extract it from Punjab. We can generate substantial revenue if we start mining Potash."In February, Goyal had said extensive surveys led to the discovery of large potash reserves in three mining blocks in southwest Punjab. The locations where potash deposits have been found include Kabarwala block (Muktsar Sahib), Sherewala and Ramsara block (Fazilka), Shergarh and Dalmir Khera block (Fazilka), he had said. Sources in the department said Kabarwala block has reserves of 5.98 million tonnes of Potash and its average grade was 3.9 per



cent. Sherewala-Shergarh-Kikrawali area has reserves of 194.58 million tonnes having average grade of 4.69 per cent while Shergarh- Dalmir Khera block has reserves of 202.45 million tonnes, with average grade of 3.42 per cent. He explained that potash extraction would occur about 450 metres below the surface, with minimal disruption to agricultural activities. The test drilling required only a negligible portion of land, one evaluation site utilised just a fraction of a 25acre agricultural plot, he pointed out. The survey in Punjab was conducted by Geological Survey of India (GSI) in 2021. However, after that no step was taken towards extraction. A geological expert however said that the average grade of Potash found in Punjab was below 10 per cent. It was not economical to drill 450 meters to extract Potash which had thin grade. "This is not economical. It would require a huge wherewithal to dig so deep. And the reserves will have low grade. Hence, the extraction was put on hold," said a Geologist. Meanwhile, Punjab Finance Minister Harpal Singh Cheema said the new mining policy fundamentally shifts the control of sand and gravel resources directly into the hands of the people, effectively curbing corruption and significantly increasing state revenue. Cheema, along with Goyal, unveiled standardised online application forms for landowner mining sites and crusher mining sites on the official Punjab mining portal. Cheema said the key highlight of the new policy is the empowerment of landowners as under this revamped framework, landowners will now have the direct right to mine sand and gravel on their own land without the need for auctions."

#### Digital services start at 4 Ayushman Arogya Mandir centres

Punjab Governor and Chandigarh Administrator Gulab Chand Kataria visited the upgraded Ayushman Arogya Mandir (AAM) centres at Maloya, Sector 35, Makhan Majra, and Raipur Kalan Kataria's visit was part of the nationwide observance marking the transformation of health and wellness centres into Ayushman Arogya Mandirs under the Ayushman Bharat initiative. The day also marked the launch of digital services at these centres for enhanced efficiency and patient care. "We will cover all 19 centres in phases, as we conduct training and update hardware, as part of this important initiative, that will gradually help us go paperless and the system will ensure efficiency and reduce the waiting time of patients," shared Dr Suman Singh, director, Health Services. As part of the effort, e-registration will be done and a token number generated for the patient. "Now we have posts of staff nurses that were recently approved for all the 19 centres, which will screen all patients who register for diabetes and hypertension, and after taking all the vitals of the patients, will send them to the doctor here, as per the token number," shares Singh, adding that this will reduce crowding outside the room of doctors and save time. With this system, all details of the patients will be on the computer of the doctor in charge, as filled by the staff nurse, and details of investigations, prescription, follow-up date and time will be given to the patients on only one pa-

This paper will be shown to the pharmacist for getting medicines and soon an electronic system that will display the token number will be introduced so that patients do not have to stand in line. "On a slot basis, specialised services



like gynaecology etc, and consultancy of medical officers will be available here at these centres. On average, one doctor sees around 100 patients, and so we need more doctors, and staff, and we hope this initiative will also reduce the number of patients here at GMSH-16, which sees around 3,000 patients daily in the OPD. We have floated a tender for LAN internet connection for better connectivity to increase and improve digital services here at GMSH-16, as this is the need of the hour," explains Singh. The administrator also reviewed the infrastructure, service delivery, and digital health integration at the centres, and interacted with several patients who had come for routine check-ups and consultations, and inquired about the quality, accessibility, and overall experience of services at the centres. He spoke to community health officers and staff to understand the range of free services being provided, including noncommunicable disease screenings, telemedicine consultations, maternal and child healthcare, and provision of essential medicines and diagnostics.

#### 2 from Rajasthan arrested in stock market scams

The Cyber Crime Cell of Chandigarh has arrested two alleged cyber criminals from Rajasthan in connection with two high-profile stock market investment scams. In the first case, the accused, Mukesh Kumar Gujar, 33, a resident of Rampura Papat, Jaipur, Rajasthan, was apprehended for his involvement in a sophisticated cyber scam, according to the police. The police team said that Gujar had opened a bank account in Rajasthan Marudhara Gramin Bank and handed over the account kit to other fraudsters. The account was used to receive Rs 36 lakh obtained through fraudulent act and subsequently funnelled via RTGS and IMPS to other accounts.

The victim, Ashok Kumar of Sector 35, Chandigarh, reported being lured into fake stock market trading via an app presented as IBKR (Interactive Broker). He was first contacted by a woman named Rekha Aggarwal and later by an alleged client manager, Rajiv Mehta. After investing a total of Rs 56 lakh, he was removed from the group and denied access to the app. According to the second case, another accused, Lalit Saini, 23, from Prem Nagar Vistar, Sanganer, Jaipur, Rajasthan, was nabbed for a similar modus operandi. The cyber police found that Lalit had opened a UCO Bank account and handed over the credentials, which was used to receive Rs 2 lakh from the fraudu-



lent activities. The money was later routed through elec-

Complainant Vinod Handa of Sector 49-A, Chandigarh, revealed that he was duped of Rs 10.5 lakh after joining a WhatsApp group (Zerodha-VIP.com) linked to an online stock trading promotion he found on Facebook. After seeing an initial small return, he was persuaded to invest larger amounts. His funds were later frozen, and further payments were demanded before he realised it was a scam. Police said that both accused are currently in police custody, and investigations are ongoing to identify other accomplices and bust the larger cyber fraud network.

#### Mohali MC disconnects water connections of 9 eateries after complaints of sewage overflow

In a crackdown following repeated complaints of sewage overflow in the Phase 5 market of Mohali, the Municipal Corporation (MC) has taken a stern action against nine restaurants by disconnecting their water and sewage connections. Officials revealed that multiple eateries in the market had been continuously dumping leftover food and waste directly into the sewer lines despite warnings, leading to frequent blockages and dirty water overflow into nearby residential areas, severely threatening public health.

During a joint inspection conducted on May 6, it was found that prominent outlets including Amrit Sweets, Kulcha Theka, Taste Da Adda, Walk N Talk, Awin Kartik, Khalsa and Liquor Wine & Beer Shop, 6, did not install grease chambers, resulting in leftover food flowing directly into the sewer system, leading to blockages nearly every alternate day.

Officials recalled a similar scenario on March 28, 2025, when challans were issued, but no improvement was observed. The situation has now deteriorated to the point where sewage has started flooding into residential zones, posing a grave health risk. Taking serious note of the matter, the Municipal Commissioner ordered that all water and sewer connections of non-compliant restaurants be disconnected on Tuesday. The operation was executed in coordination with the Public Health Department and field teams from the MC.Reaffirming the commitment to cleanliness and public welfare, officials stated, "no compromise will be tolerated when it comes to public health and sanitation. Any future negligence will lead to strict legal action under environmental and municipal laws". Phase 5 Market president Rajpal Singh Chaudhary said that the outlet owners argued that when the sewer pipes were initially laid behind the shops, the shopkeepers had requested the department to install wider pipes, which was ignored. Rajpal also mentioned that during a meeting with the former Municipal Commissioner, the shopkeepers had agreed to bear the cost of regular pipe cleaning by the department, but the initiative was left incomplete. Restaurants, who faced the action, criticised the move as "arbitrary and a case of pick and choose".

#### Bulldozer action at Taimoor Nagar: What's the story behind this Delhi locality by the Yamuna?

One could surmise it was a derivation of Turkish-Mongol conqueror Timur or Tamerlane, founder of the Timurid Empire, who invaded India in the 14th Century. But history records do not confirm this. Today, Taimoor Nagar is better known as a densely populated locality in Southeast Delhi, near the upscale neighbourhoods of New Friends Colony and Maharani Bagh. And it found itself in the spotlight this week for all the wrong reasons. On Monday, illegal structures near the Taimoor Nagar drain — which feeds into the Yamuna and is choked with garbage — were razed. The action was carried out by the Delhi Development Authority on the orders of the Delhi High Court. The HC Saturday refused to stay the demolition of encroachments around the drain and attributed the flooding in various parts of the Capital — including in South Delhi — last Friday following showers and thunderstorms to the inability of the drain to discharge rainwater downstream due to the encroachments. The neighbourhood's proximity to the Yamuna has meant the area has often been in the news for encroachments on floodplain land and poor drainage infrastructure. It has also faced several eviction and demolition drives over the years, particularly those linked to environmental concerns or court orders regarding illegal construction. The settlement in Taimoor Nagar came up when people were displaced from Rajghat in 1986, said

Biswajit Mohanty, Professor of Political Science at Deshbandhu College, Delhi University. "The people were mostly from Bihar and Uttar Pradesh — three-fourth of the population is Muslim, while the rest are Hindus." According to Mohammad Tazeem, who teaches history at the Senior Secondary School in Jamia Millia Islamia, Taimoor Nagar is constructed on the lands of two villages, Kilokari and Khizarabad. "Kilokari and Khizarabad were established during the Sultanate period, he said. "Before that, these were small settlements of Gujjars and Ahirs."He added, 'Khizarabad is named after the son of Alauddin Khilji — Khizr Khan. As for Kilokari, it is named after Kaikubad, the grandson of Sultan Balban. These villages became populated in the 13th and 14th century." It is also believed that the earliest documented Sufi presence in Delhi can be traced to Khwaja Qutbuddin Bakhtiyar Kaki, the successor of Khwaja Moinuddin Chishti of Ajmer, who is believed to have first settled in Kilokari — then a quiet riverside hamlet near the present-day Ashram area. With the Yamuna flowing beside it, Kilokari offered the solitude and natural setting ideal for a Sufi mystic's meditation and spiritual practice. British civil servant and historian H C Fanshawe, in his 1902 book, Delhi: Past and Present, described Kilokari as a scenic riverside village that once served as a royal retreat. He noted that it was frequented by Mughal prince Humayun and known for its gardens and proximity to the Yamuna.

#### Over 5,000 homeless as Chandigarh administration razes 2,500 shanties in Janta Colony

As the Chandigarh administration conducted the demolition of nearly 2,500 shanties at Janta Colony on Tuesday, around 5,000 dwellers turned homeless. The demolition drive was conducted at 10 acres of prime government land, which was illegally occupied by the dwellers, in Sector 25. This land, as per Estate officials, is valued at around Rs 350 crore. Two weeks ago, the administration also demolished 1,000 makeshift structures in Sanjay Colony, Industrial Area Phase 1, which saw encroachment of nearly six acres of prime land.

The drive on Tuesday began at 5 am in the presence of nearly 1,500 police personnel and 1,500 officials from the municipal corporation and UT Estate Office. With the latest demolition, only two small slums — Shahpur in Sector 38 and another one in Sector 54 - remain, which the Chandigarh Administration also plans to take down soon. The UT administration has been working on making the city slum-free since the early 2000s. In 2006, it came up with a plan to replace slums with alternative housing. In 2013, it razed colony numbers 5 and 4 in 2022. These slums had occupied over 165 acres of government land. Apart from this, it had razed Mazdoor Colony, Kuldeep Colony, Pandit Colony, Nehru Colony, Ambedkar Colony, Kajheri Colony and Madrasi Colony over the years. Sunita Chautala, a dweller at Sector 25, Janta Colony has been living here with her family for the last 20 years in the area. She mentioned how politicians made false promises of rehabilitation in ex-

"The local leaders used to come to us asking us to cast our vote for a party, and in return, we were promised that we would be allotted a dwelling unit in the city area as a part of the rehabilitation," Chautala said. "No one turned up today for our help while our houses were demolished. We are forced to move from here and live in a rented house."Another resident Monu Devi, whose house was also demolished, said she had arrived in the area 25 years ago after she got married. She was living here with her in-laws.



"Last night (Monday), we had shifted to a rented property in Dhanas, which has a rent of Rs 5,000 per month. My husband is ill and I work as a maid in the city, earning Rs 10,000 per month. How does the administration think we will be able to survive on rent? Neither the administration nor any local political party came to help us," Devi said. Sumit Kumar, who had been living in Janta Colony with his 11 family members, said, "After our house has been demolished, we aren't able to find a house on rent. Since our family is big, the landlord says he cannot allow us to stay for a rent of Rs 7,000."Sandeep Kumar, who works as a waiter in a hotel at Mohali, said, "The government should have thought about allocating another space to us, before conducting the demolition." Chandigarh Congress has condemned the demolition, terming it a "heartless act against the poor". Party spokesperson Rajiv Sharma criticised the "BJP-led administration" for "neglecting" the welfare of economically weaker and middle-class residents via a lack of housing schemes in the last 11 years and "continuous harassment" via penalties and taxes. Part president HS Lucky called the move "utterly inhumane," highlighting the plight of children, women, and the elderly left homeless. He demanded immediate rehabilitation for the affected families and urged the administration to act with compassion, rather than following what he termed as "dictatorial and anti-people orders" of the BJP

#### Sharp decline in special needs children enrolling in Kerala schools, Centre urges state to act

"There is a significant decline in the percentage share of CwSN (children with special needs) in secondary grades and only 39% of teachers have been trained in inclusive education," the ministry said in a review of the Samagra Shiksha, or inclusive education, programme in Kerala for the last academic year. A report on the review was released on May 2. According to the report, children with special needs make up just 2% of the total student enrolment in schools in the state. The report advised the state to use the PRASHAST app — an application developed by NCERT for schools to screen students for potential disabilities — to identify children with special needs providing assistance accordingly. On the infrastructure front, the report pointed out several gaps, which the state was told to rectify. It said that out of 15,864 schools, 13,029 (82%) are equipped with — state is also making an automated permanent academic ramps, but only 4,504 (29%) have CwSN-friendly boys toi-



lets, and 4,102 (26%) have CwSN-friendly girls toilets. The report said, "There are six schools without provision of electricity, nine without drinking water, 21 without girls toilets, 41 without boys toilets." The state was told to ensure I00% coverage of these facilities in all government schools in 2025-26. Out of the total 1,310 secondary and senior secondary schools, 29 do not have ICT lags and 70 don't have smart classrooms. Besides, out of 851 senior secondary schools, 37 don't have Physics labs, 31 don't have Chemistry labs, and 67 don't have Biology labs. The Union ministry also raised concern about the reduction in the total number of enrolments in government and aided schools, from 46.37,701 in 2022-23 to 45,50.822 in 2023-24. #### After Ziddi Girls controversy, Miranda House is coming up with a filming policy

Delhi University's Miranda House is in the final stages of adopting a formal policy to regulate filming on its campus, The Indian Express has learnt. The move comes in the aftermath of the controversy linked to Ziddi Girls, an Amazon Prime series accused of portraying a fictional college, "Matilda House", bearing an "unmistakable resemblance" to Miranda House. With the proposed regulations, DU's prestigious women's college aims to ensure that future creative projects do not distort or damage its public image, said people in the know.

Directed by Miranda House alumna Shonali Bose, the series sparked protests from students and alumni who said the similarities were too stark to ignore, including the shortform reference. The college had issued a legal notice to the show's makers in February, demanding the removal of the short-form reference, "MH", and seeking a pre-release preview of the series by the administration and the students' union. A faculty-student committee then proposed a filming policy in April. "Teachers and students have come up with a policy, and the college is looking into it," Principal Bijayalaxmi Nanda told The draft, which is yet to be finalised by a committee, "reviewing the use of college space by outsiders", lays out a detailed approval process requiring filmmakers to submit a written request at least 15 days in advance. The proposal must include the script, project overview, and a clear explanation of how the college will be depicted. "The college administration will review the script and decide whether the project aligns with the values and reputation of Miranda House," the draft states. "Any content that misrepresents the college or negatively impacts its image will not be approved." Once approved, the production team must sign a formal contract. "Filming must be done in a way that does not disturb classes, students, or faculty," reads a clause. Any damage to college property must be compensated by the production team, it said.

An administrative official involved in the drafting process emphasised that commercial gain has never been the motivation behind granting access. "It is never a matter of money coming in for this college through the shooting of films and ad films. The college has always given permission only to a few very important projects, like those driven by its alumni. The effort through this policy is to make sure film shooting takes place vigilantly, under supervision, and without disturbing the academic spaces for students.""Before release, the college reserves the right to view the final footage to ensure it aligns with the agreed

portrayal," the guidelines note. If any changes are needed,

the team will be required to make the necessary edits. "The college name and logo must not be used in credits, promotions, or any form of branding unless explicitly approved." The guidelines also focus on legal accountability. "Any violation of this policy may result in legal action or a permanent ban on future filming requests. The contract will outline legal consequences in case of policy violations," the document states. The college also insists on a complete preview of the final product: "After completion of the shoot and before launching, it should be seen by the administration." Perhaps most significantly, the policy prohibits filmmakers from deviating from the agreed script under the pretext of artistic freedom. "The overview of the script provided to the college authorities should not contrast with the actual story to be streamlined. The use of 'creative license' as an excuse for the same will not be entertained," it reads. Once adopted, the policy is expected to set a precedent for other academic institutions too. Earlier, in a statement before the release of the series, the Miranda House Students' Union said: "MHSU expresses its deep outrage and profound condemnation over the recent release of the 'Ziddi Girls' trailer on Amazon Prime. The circulating trailer contains content that raises serious objections, particularly regarding the dignity of our esteemed institution. It tarnishes, defames, and demeans the 77-year-old legacy of Miranda House, a college renowned for its commitment to women's education and emancipation.

## Israeli strikes kill 15 in Gaza school housing displaced families, medics say



CAIRO/GAZA -GNS News Agency, May 12, Israeli strikes on a school housing displaced families in northern Gaza killed 15 Palestinians on Wednesday, local health authorities said, as Israeli forces continued to demolish homes and buildings in Rafah in the south of the enclave. Medics said two strikes targeted the Karama School in Tuffah, a suburb of Gaza City. Among those killed was a local journalist, Nour Abdu, Palestinian media said. Two Israeli airstrikes on another school, housing displaced people in Bureij camp in central Gaza, killed at least 33 people, including women and children, on Tuesday, local health authorities said. The Israeli military said it struck "terrorists" operating from a command center in the compound. The strike, which smashed classrooms and destroyed furniture, caused a large crater in the school campus, where the displaced people who had sought shelter there on Wednesday sifted through rubble to look for some of their belongings. "What happened is an earthquake. The Israeli occupation hit a school housing children. They are children, "said eyewitness Ali Al-Shaqra. He said the school housed 300 families.

"Here is the building; it was razed to the ground. We cannot find the gas cylinder, the flour bag we had, the kilo of rice, or the meal we got from the Tukkiyah (community kitchen). Thank God we are left with the clothes we had on," Shaqra added.In Rafah in the southern Gaza Strip, near

the border with Egypt, residents and Hamas sources said Israeli forces, who have taken control of the city, continued to blow up and demolish houses and buildings. Al-Qassam Brigades, the military wing of the Palestinian militant group Hamas, said on Wednesday their fighters had detonated a pre-planted minefield targeting an Israeli armoured force east of Khan Younis in the south. They said they inflicted casualties, followed by mortar shelling of the area. Israel resumed its offensive in March after the collapse of a U.S.backed ceasefire that had halted fighting for two months. It has since imposed an aid blockade, drawing warnings from the UN that the 2.3 million population faces imminent famine.Israeli troops have already taken over an area amounting to around a third of Gaza, displacing the population and building watchtowers and surveillance posts on cleared ground the military has described as security zones.

Israeli Prime Minister Benjamin Netanyahu has said he will expand the offensive against Hamas after his security cabinet approved plans that may include seizing the entire Gaza Strip and controlling aid. But an Israeli defence official said on Monday the operation would not be launched before U.S. President Donald Trump concludes his visit next week to the Middle East, and there was a "window of opportunity" for a ceasefire and hostage release deal during Trump's visit. A senior Hamas official said on Wednesday Hamas would not agree to any interim truce in return for a resumption of aid for a few days, and insisted on a full ceasefire deal to end the war.

Basem Naim said Hamas would not accept "desperate attempts before Trump's visit, through the crime of starvation, the continuation of genocide, and the threat of expanding military action to achieve a partial agreement that returns some (Israeli) prisoners in exchange for a few days of food and drink. "The war began on October 7, 2023, when Hamas killed 1,200 people and took 251 hostage, according to Israeli tallies. Israel's campaign has killed more than 52,000 Palestinians, mostly civilians, according to Hamasrun health authorities, and reduced much of Gaza to ruins. The Hamas-run Gaza government media office said the death of Nour Abdu on Wednesday raised to 213 the number of Palestinian journalists killed by Israeli fire since the war began. ## Cardinals set to enter conclave to decide who follows Pope Francis

VATICAN CITYGNS News Agency, May 12, Roman Catholic cardinals will begin the task on Wednesday of electing a new pope, locking themselves away from the world until they choose the man they hope can unite a diverse but divided global Church. In a ritual dating back to medieval times, the cardinals will file into the Vatican's frescoed Sistine Chapel after a public Mass in St. Peter's Basilica and start their secret conclave for a successor to Pope Francis, who died last month.

No pope has been elected on the first day of a conclave for centuries, so voting could continue for several days before one of the red-hatted princes of the Church receives the necessary two-thirds majority to become the 267th pontiff. There will be only one ballot on Wednesday. Thereafter, the cardinals can vote as many as four times a day. They will burn their ballots, with black smoke from a chimney on the roof of the chapel marking an inconclusive vote, while white smoke and the peeling of bells signalling that the 1.4 billion member Church has a new leader.

The pope's influence reaches well beyond the Catholic Church, providing a moral voice and a call to conscience that no other global leader can match.At a Mass in St. Peter's Basilica on Wednesday morning before entering the conclave, the cardinals prayed that God would help them find a pope who would exercise "watchful care" over the world

In a sermon, Italian Cardinal Giovanni Battista Re told his peers they must set aside "every personal consideration" in choosing the new pontiff and keep in mind "only ... the good of the Church and of humanity". Re, the dean of the College of Cardinals, is 91 and will not enter the conclave, which is reserved for cardinals under the age of 80.

Cardinals in recent days have offered different assessments of what they are looking for in the next pontiff. While some have called for continuity with Francis' vision of greater openness and reform, others have said they want to turn the clock back and embrace old traditions. Many have indicated they want a more predictable, measured pontificate. Salvadoran Cardinal Gregorio Rosa Chavez said he did not think the cardinals would retreat from Francis' vision for the Church.Item 1 of 5 Members of the clergy gather on the day the Dean of the College of Cardinals, Cardinal Giovanni Battista Re presides over the Holy Mass, celebrated for the election of the new pope, in St. Peter's Basilica, at the Vatican, "There will not be a step backwards," Rosa Chavez, aged 82, told the Corriere della Sera newspaper. "It is not possible.""Whoever is chosen, I think it will be a pope who continues the work begun by Francis," he



said.

A record 133 cardinals from 70 countries will enter the Sistine Chapel, up from 115 from 48 nations in the last conclave in 2013 -- growth that reflects Francis' efforts to extend the reach of the Church to far-flung regions with few Catholics. However, if it quickly becomes obvious that neither can win, votes are likely to shift to other contenders, with the electors possibly coalescing around geography, doctrinal affinity or common languages. Among other potential candidates are France's Jean-Marc Aveline, Hungary's Peter Erdo, American Robert Prevost and Italy's Pierbattista Pizzaballa.

Re suggested the cardinals should look for a pope who respected the diversity within the Church. "Unity does not mean uniformity, but a firm and profound communion in diversity," he said in his sermon. As in medieval times, the cardinals will be banned from communicating with outsiders during the conclave, and the Vatican has taken hightech measures to ensure secrecy, including jamming devices to prevent any eavesdropping. The average length of the last 10 conclaves was just over three days and none went on for more than five days. A 2013 conclave lasted just two days. The cardinals will be looking to wrap things up quickly again this time to avoid giving the impression that they are divided or that the Church is adrift. Some 80% of the cardinals who enter the Sistine Chapel on Wednesday were appointed by Francis, increasing the possibility that his successor will in some way continue his progrespolicies despite strong pushback from traditionalists. Among their considerations will be whether they should seek a pope from the global south where congregations are growing, as they did in 2013 with the Argentinian Francis, hand back the reins to Europe or even pick a

#### Why is end to war in Gaza so elusive?

Tel Aviv: The war in Gaza may be on the cusp of a new phase after Israel approved plans over the weekend to intensify its operations. Which raises the question: After 19 months of bloodshed and destruction, why is there still no end in sight? Israel and Hamas appear to only be growing further apart. Israel unleashed fierce strikes in March, shattering a truce that had freed hostages and sent in badly needed aid. Israel's new plans include seizing the strip, forcibly displacing hundreds of thousands of Palestinians and asserting greater control over the distribution of aid in the territory, according to Israeli officials. Mounting Israeli public support for an end to the war has not swayed Prime Minister Benjamin Netanyahu from his stance that Hamas must be destroyed first. The military pressure, vast destruction in Gaza and rising death toll have so far not budged Hamas from its position demanding an end to the war and a full Israeli withdrawal from Gaza

The war began on October 7, 2023, when Hamas militants attacked southern Israel, killing 1,200 and taking 251 hostages. Israel's massive retaliation has killed over 52,000 people in Gaza, according to local health authorities, whose count does not differentiate between militants and civilians. The Hamas attack upended Israel's longstanding security doctrine. For years, Israel weathered threats along its borders, launching periodic operations to contain them.

Hamas' surprise assault broke that cycle. Israel says it is no longer willing to accept a reality where such an attack can reoccur. It has gone to great lengths to reshape the region according to that new doctrine. Israeli forces have seized areas in Lebanon and Syria and cracked down in the West Bank, displacing tens of thousands. In Gaza, they intend to remain in the territory in a bid to eliminate Hamas' ability to regroup. Israel shows no sign of relenting, despite war crimes accusations at international courts. Experts say Hamas no longer has the capacity to stage an October 7style attack — yet it cannot be easily stamped out, either. The drive to dismantle Hamas' military and governing capabilities by force has so far proven incompatible with Israel's other war aim: freeing hostages. The captives' relatives fear any escalation in fighting endangers them. Netanyahu has said he is prepared to end the war if Hamas gives up power, disarms and leaves Gaza. But even after that, Israel appears poised to keep troops in corridors carving up Gaza effectively a new form of occupation. Hamas has offered to release all hostages in return for a full Israeli withdrawal from Gaza and an end to the war. It says it's willing to cede power in Gaza to other Palestinians but has refused to disarm, offering instead a long-term truce with Israel. Netanyahu has rejected the notion of Gaza being run by the more moderate Palestinian Authority, but has offered no concrete al-

## US, China to hold ice-breaker trade talks in Geneva



WASHINGTON/BEIJING, U.S. Treasury Secretary Scott Bessent and chief trade negotiator Jamieson Greer will meet China's economic tsar He Lifeng in Switzerland this weekend for talks that could be the first step toward resolving a trade war disrupting the global economy. News of the planned Geneva meeting, first announced by Washington late Tuesday, sent U.S. equity index futures higher. Stock markets in China and Hong Kong followed suit during Asian trading The Reuters Tariff Watch newsletter is your daily guide to the latest global trade and tariff news. Sign up here.

The talks come after weeks of escalating tensions that have seen duties on goods imports between the world's two largest economies soar well beyond 100%, amounting to what Bessent on Tuesday described as the equivalent of a trade embargo. The impasse, alongside U.S. President Donald Trump's decision last month to slap sweeping duties on dozens of other countries, has upended supply chains, roiled financial markets and stoked fears of a sharp downturn in global growth.

The negotiating teams convening in Switzerland, known for its neutrality, are expected to discuss reductions to the broader tariffs, two sources familiar with the planning said. The talks should also cover duties on specific products, export controls and Trump's decision to end de minimis exemptions on low-value imports, one of the sources added. China's State Council did not immediately reply to a faxed request for comment. "My sense is this will be about de-escalation," Bessent told Fox News after the announcement. "We've got to de-escalate before we can move forward."A Chinese commerce ministry spokesperson later confirmed that China had agreed to meet the U.S. envoys."On the basis of fully considering global expectations, China's interests, and the appeals of U.S. industry and consumers, China has decided to re-engage the U.S., the spokesperson said, citing a proverb about actions speaking louder than words. This is the first meeting between senior Chinese and U.S. officials since U.S. Senator Steve Daines met Premier Li Qiang in Beijing in March. Beijing has largely adopted a fiery rhetoric as tensions with Washington have ratcheted up, repeatedly saying it would not engage in negotiations unless the U.S. withdrew its tariffs. Signaling a change in tack, however, China's commerce ministry on Friday said it was "evaluating" an offer from Washington to hold talks.

Asked about the apparent U-turn on Wednesday, China's foreign ministry spokesperson Lin Jian told a daily press conference that Beijing's "position of firmly opposing U.S. abuse of tariffs has not changed". The stakes for China's economy are high, with its vast factory sector already bearing the brunt of the tariffs. Many analysts have downgraded

their 2025 economic growth forecast for the Asian giant, while investment bank Nomura has warned the trade war could cost China up to 16 million jobs. China's central bank on Wednesday announced fresh monetary stimulus, flagging rate cuts and a liquidity injection into the banking system aimed at countering the economic impact of the duties. Analysts described the move as measured and tactical."There's almost certainly also an element of signaling to the U.S. government ahead of the upcoming meeting," said Christopher Beddor, deputy China research director at Gavekal Dragonomics. "The message is that Chinese officials are not panicked or scrambling to shore up economic growth, and they're not going to be negotiating from a position of weakness."U.S. officials have held a flurry of meetings with trading partners since the president announced a 10% tariff on most countries on April 2, along with higher tariff rates that will kick in on July 9, barring separate trade agreements. Trump has also imposed 25% tariffs on autos, steel and aluminum, 25% levies on Canada and Mexico, and 145% tariffs on China, with further duties expected on pharmaceuticals in coming weeks. China retaliated by boosting its tariffs on U.S. goods to 125%. The European Union is also readying countermeasures.

While Saturday's talks are aimed at easing tensions, it remains unclear how substantive they could prove, said Bo Zhengyuan, partner at Shanghai-based policy consultancy Plenum."For more comprehensive geopolitical negotiations to be possible, tariffs would need to be lowered first - the key is whether both sides can agree on the extent and scope of tariff rollbacks, as well as on follow-up talks," Bo said. Bessent told Fox News the two sides would work out during their meeting on Saturday "what to talk about.""Look, we have a shared interest that this isn't sustainable," Bessent said. "And 145%, 125% is the equivalent of an embargo. We don't want to decouple. What we want is fair trade."Trump and his trade team have sent mixed signals over progress in talks with major trading partners rushing to cement agreements with Washington and avoid the imposition of hefty import taxes on their goods. Bessent told lawmakers earlier in the day that the Trump administration was negotiating with 17 major trading partners and could announce trade agreements with some of them as early as this week.

Trump told reporters before a meeting with Canadian Prime Minister Mark Carney that he and top administration officials will review potential trade deals over the next two weeks to decide which ones to accept.U.S. and Britain have made progress towards a trade deal, a British official said, while Bessent has said many other countries including Indonesia have made good offers to reduce tariffs and nontariff barriers, such as subsidies. Trump's moves on tariffs, which he says are aimed in part at reducing the U.S. trade deficit, are so far having an opposite effect, with the gap hitting a record in March as businesses rushed to import goods ahead of the levies. ADEN,GNS News Agency, May 12, The Israeli military carried out an airstrike on Yemen's main airport in Sanaa on Tuesday, its second attack in two days on Iranaligned Houthi rebels, after the group launched a missile attack near Israel's Ben Gurion Airport. Three people were killed in the latest Israeli strike, according to Houthi-run Al-Masirah TV. The Reuters Tariff Watch newsletter is your daily guide to the latest global trade and tariff news. Israel warned people to leave the area around Sanaa International Airport before Tuesday's attack, which it said targeted Houthi infrastructure and "fully disabled the airport". Witnesses later reported four strikes in the capital. Tensions have been high since the Gaza war began, but have risen further since a Houthi missile landed near Israel's Ben Gurion Airport on Sunday, prompting Israeli airstrikes on Yemen's Hodeidah port on Monday." A short while ago, IDF (Israel Defence Forces) fighter jets struck and dismantled Houthi terrorist infrastructure at the main airport in Sanaa, fully disabling the airport," the Israeli military said. "The strike was carried out in response to the attack launched by the Houthi terrorist regime against Ben Gurion Airport. Flight runways, aircraft, and infrastructure at the airport were struck," it said referring to the Yemen airport. The airport's general director said on Wednesday that all flights to and from the airport have been suspended until further notice. The Israeli strikes resulted in "extensive damage" to the airport, Khaled al-Shaief added in a post on X. Three airport sources had told Reuters that the strikes targeted three civilian airplanes, the departures hall, the airport runway and a military air base under Houthi control. The Israeli military said the airport had been "a central hub for the Houthi terrorist regime to transfer weapons and operatives.""The operations of our armed forces will continue and the support by Yemen to Palestine will only end with the end of the aggression and siege against Gaza."

The United Nations Special Envoy to Yemen Hans Grundberg said on X that the latest hostilities "mark a grave escalation in an already fragile and volatile regional context". An official at Yemen's flag carrier Yemenia Airways told Reuters that three of its aircraft were destroyed according to an initial assessment. The Houthis have been firing at Israel and at shipping in the Red Sea since Israel began its military offensive against Hamas in Gaza after the Palestinian militant group's deadly attack on Israel on October 7, 2023. The Houthis say they are doing so in solidarity with the Palestinians and have pressed on with attacks in response to Israel expanding its military operations in the Gaza Strip. The Houthis said on Sunday they would impose a "comprehensive" aerial blockade on Israel by repeatedly targeting its airports. Sixty percent of Yemenis live under the control of the Houthis, a resilient group that withstood years of Saudi-led bombing during the country's devastating civil war. The Houthis are part of Iran's "Axis of Resistance" against Israeli and U.S. interests in the Middle East, which also includes Hamas and Lebanon's Hezbollah. While Israel has weakened those groups by assassinating top leaders and destroying military infrastructure since the Gaza war began, the Houthis are still a force to be reckoned with. The Israeli strikes around Hodeidah on



Monday killed four people and wounded 39, the Houthi-run health ministry said. Israeli Prime Minister Benjamin Netanyahu had vowed to retaliate after the missile launched by the Houthis landed near Ben Gurion Airport and led to European and U.S. airlines cancelling flights. #### India destroys JeM's Markaz Subhan Allah terror camp in Pakistan's Bahawalpur

Lucknow: In a major counter-terrorism offensive, India on Wednesday destroyed 'Markaz Subhan Allah,' the Jaish-e-Mohammed (JeM) terror headquarters and training facility in Bahawalpur, Pakistan.

Once a key base for terrorist operations, the site has been reduced to rubble, signalling a strong response to ongoing cross-border threats. Videos show the extent of damage caused to the terrorist base. The morning visuals show the building reduced to rubble with gaping holes in the roof and concrete lying all around. Although bodies could not be seen in the available video but fallen slabs could be seen. The video also shows a few men scurrying around the fallen building. The video was shot in the day's light after the airstrikes by the Indian Air Force and exhibits the precision power of the force. Bahawalpur is deep inside Pakistan and is the 12th largest city, and serves as the nerve centre of Jaish-e-Mohammed. The JeM has been responsible for multiple attacks on Indian soil over the past two decades.Located around 161 km from the India-Pakistan border, Bahawalpur houses the group's operational headquarters at the Jamia Masjid Subhan Allah, also known as the Usman-o-Ali campus. India successfully destroyed terrorists' hideouts here and exposed the total failure of the Pakistan air defence.

#### Before Russia-Ukraine war, Western oil firms 'cut deals' to favour Moscow's allies



FOR all the current discourse on global sanctions and censure, before the Russian invasion of Ukraine in 2022, Western oil giants, including affiliates of Chevron, Shell and Exxon Mobil, signed off on allegedly inflated budgets, rigged bids, and gave lucrative contracts worth hundreds of millions of dollars to allies of Russian President Vladimir Putin and the Kazakhstan elite. This is one of the key revelations of Caspian Cabals, an investigation by the International Consortium of Investigative Journalists, of which The Indian Express is a partner, into the 1500-km Caspian Pipeline Consortium (CPC), one of the world's largest crude oil pipeline systems used by both Russia and Kazakhstan. The CPC takes crude from large oil fields in western Kazakhstan and also from Russian producers to Russia's Black Sea port of Novorossiysk, from where it is transported to buyers globally through tankers. In 2023, CPC carried 63.5 million tons of oil to international markets — around 10 per cent of CPC crude is Russian, the rest is from Kazakhstan's large oil fields Kashagan and Karachaganak. Since the start of the Ukraine war in 2022, CPC paid at least \$816 million to shareholders Transneft and Rosneft, Russia's biggest oil company - and \$321 million in taxes to Russian authorities. Western companies, led by Chevron Corp., made payments to subcontractors who didn't perform the work. In one case, they authorized a \$48-million advance payment for work — including building electricity lines to a new pumping station in southern Russia — that went missing as soon as it was paid. Western oil companies — affiliates of Chevron, ExxonMobil, Italy's Eni S.p.A. and Shell — sought to curry favor with Putin allies and the politically influential Kazakh elite by granting them hefty contracts CPC cut corners on safety and downplayed the severity of a 2021 oil spill that didn't just lead to environmental damage but also to allegations of financial corruption. The consortium ultimately lost a Russian court case and paid a \$98.7-million fine for environmental damageAt least five whistleblowers alleged that Western oil companies' dealings in Russia or Kazakhstan included improper payments in violation of the Foreign Corrupt Practices Act, a US law that prohibits bribes to foreign officials. Although the Russian government effectively controls the pipeline, since the war on Ukraine, Kazakhstan hired a US lobbying firm for a nearly \$4-mn annual contract, to help the pipeline remain sanctions-free.

Caspian Cabals Caspian Cabals is an investigation by the International Consortium of Investigative Journalists into the 1500-km Caspian Pipeline Consortium (CPC), one of the world's largest crude oil pipeline systems used by both Russia and Kazakhstan. In a statement to ICIJ, Sally Jones, a senior media adviser for Chevron, said Chevron and international oil companies "have sought to provide critical technical support to enable safe and reliable operations of the Caspian Pipeline Consortium." "Chevron is committed to ethical business practices, operating responsibly, conducting its business with integrity and in accordance with the laws and regulations of each of the jurisdictions in which it operates," she said. She did not respond directly to ques-

tions about Chevron's role in the pipeline or complaints about overpriced contracts, alleged kickbacks or conflicts of interest. Exxon did not respond to requests for comment, nor did the governments of Kazakhstan or Russia. A spokesman for Shell said the company does not tolerate bribery in any form. An Eni spokesperson said, "We are committed to upholding the highest standards of transparency, ethical conduct and environmental responsibility." Eni referred questions about the pipeline to CPC, which did not respond to multiple requests for comment. Notably, India did not feature on the destination map for CPC oil — Kazakh as well as Russian — until early 2022. Now, India has emerged as the biggest market for CPC-Russia (CPC-R) oil, followed by Turkey and China. Tanker data from commodity market analytics firm Kpler shows that nearly 67 per cent of CPC-R crude made its way to India in the first nine months of 2024, while the figure for 2023 was even higher at 83 per cent. Consider this: Between March 2022 and March 2024, 82 of the 117 oil tankers carrying CPC-R oil, that set sail from the Black Sea loading terminal, discharged the oil at Indian ports.Between January 2021 and February 2022, just five of the 72 tankers hauling CPC-R had undertaken the long journey to Indian ports. The reason, industry insiders and experts say, is rather simple. When Russian oil was allowed to flow freely globally, it made little sense financially and logistically for Indian refiners to buy crude from a faraway geography like Russia. The discounts, however, have turned that argument on its head.

While India's private sector refining giant Reliance Industries (RIL) has been the biggest buyer of CPC-R crude, public sector players Indian Oil Corporation (IOC), Bharat Petroleum Corporation (BPCL), Hindustan Petroleum Corporation (HPCL), and Mangalore Refinery and Petrochemicals (MRPL) have also been buying this oil, vessel tracking data shows. In the first nine months of 2024, Indian refiners cumulatively imported over 30 million barrels of CPC-R crude, with shipments coming in every month, vessel data shows.In all, 45.56 million barrels of CPC-R crude were shipped globally during the period, the other notable importers being Turkey and China, while some volumes went to Pakistan. CPC-R accounted for over 6 per cent of India's overall oil imports from Russia for the period. Russia accounts for over 40 per cent of India's total oil imports.

In contrast, the CPC-Kazakhstan (CPC-K) crude purchases by Indian refiners have been few and far between, with isolated cargoes coming to India sporadically, just as the case was with CPC-R oil before Russia invaded Ukraine. "The Kazakh part (of CPC oil going to India) is still minimal. The CPC-K is really mostly traded in the Mediterranean region. So, it would be going towards the Mediterranean refiners," said Viktor Katona, head of crude analysis at Kpler.RIL, IOC, BPCL, HPCL, and MRPL did not respond to The Indian Express's request for comments. But officials in the Indian government and refining sector The Indian Express spoke to underlined that Indian oil and gas companies are neither part of the CPC project nor its stakeholders, but they are its customers. "We buy oil from many countries and many companies. As customers, we can only ensure that our deals are clean. What happened or what may happen internally in a supplying company or country is something beyond our control and most often also beyond our knowledge," an oil industry source in India said. India is the world's third-largest consumer of crude oil and depends on imports to meet over 85 per cent of its requirement. New Delhi has time and again emphasised that its priority is to secure its energy supplies and that the country is willing to buy oil from any country or company that is not under sanctions. Russian oil is technically not under any sanction by the US or its allies, and is only subject to the

#### The road to gender-equal pay

into the fabric of society, manifesting itself in all aspects of life. In November 2024, India spoke on its commitment to gender equality in the UN Asia-Pacific Ministerial Conference on the Beijing+30 Review. The statement by the Women and Child Development Ministry highlights the progress made since 2019. This year, India boasts an allocation of \$37 billion to gender equality budgeting and has the highest proportion of women in STEM disciplines globally. However, the Ministry's statement also acknowledges that many issues have yet to be addressed, such as the gender pay gap. Indeed, a key component of gender inequality is a global gender pay disparity. Closing India's gender wage gap is the first step towards gender equality in India, allowing women to equally contribute to, and benefit from, India's economic growth. What is India's progress on the fight for gender-equal pay, and what measures will it take to reach such equality?

Regarding the wider global context, the fight for gender equality has greatly progressed around the world with key milestones such as the international Suffrage Movements of the 17th and 18th centuries, which fought for women's right to vote, and the 1979 Convention on the Elimination of All Forms of Discrimination Against Women (CEDAW), which defined gender-based discrimination and committed signatories to increase gender equality. Furthermore, the UN Sustainable Development Goals from 2015 included global women's empowerment and gender equality within its agenda. Despite the UNSDGs' 2030 target, however, the gender gap remains significant. A 2024 report by Focus2030 says it would take a staggering 131 years to achieve worldwide gender equality.

Falling participationOverall, women's global workforce participation has reduced compared with previous years, with a World Economic Forum (WEF) analysis of 2024 LinkedIn data showing that women account for 42% of the global workforce and 31.7% of senior leaders. A factor that perpetuates gender inequality in the workplace is the notion that women bear the responsibilities of the house (especially regarding childcare); this affects promotions and negotiation outcomes and restricts access to high-paying professions. Additionally, as women's careers advance, the wage gap between them and men in the same position

While India has ratified a number of conventions relating to women in the workplace, such as the International Labour Organisation (ILO) Employment and Occupation Convention recognising discrimination as a "violation of rights", it still has a long way to go. The WEF's Global Gender Gap Report, 2024 places India at 129th out of 146 countries, with 64.1% of its gender equality gap closed. A 2023 report by Azim Premji University indicates that salaried women in India still earn an average of 76% of what salaried men do per year, with self-employed women earning 40% of what self-employed men do. While Azim Premji's 2023 report found that wage equality for women has been improving since 2004, they also uncovered cause for concern. Controlling for factors such as caste and class re-

vealed increasing discrimination against women that hin-

Gender inequality is a global phenomenon ingrained dered full attainment of gendered wage equality. Maternal pay gapDespite improvements in recent years, women often occupy lower-paying jobs and mothers are subject to a maternal pay gap as they often earn less than women without children. This was made worse by the COVID-19 pandemic as women took on increased caregiving responsibilities to the extent that the pay gap grew by 7% from 2019 to 2021. World Bank estimates put the percentage of Indian women working and seeking jobs at 33% of all women in 2023, rising from 26% in 2020; Indian men, contrastingly, had rates of 77% and 74%, respectively. Moreover, the digital gender divide in India remains another obstacle to women's economic participation. The Annual Status of Education (ASER), 2023 Report highlights how girls, especially in rural areas, have less access to technology than boys and their technical skills are resultantly worse than those of their male counterparts. This means women have unequal access to jobs requiring digital skills which is detrimental in today's increasingly digital world.

> As such, attaining gender equality in India — starting with the gender wage gap - requires a multifaceted approach that both breaks down social norms while concurrently implementing legal frameworks to create more equitable work environments. Changes to education, care, and architectural infrastructure can address the systemic barriers that perpetuate gender inequality. For instance, investments in the completion of secondary education and softskill acquisition can equip women for diverse employment opportunities. This is especially relevant in India as high rates of child marriage in rural areas mean many girls drop out of school. Furthermore, access to high-quality, low-cost childcare through government incentives and tax breaks enhances economic development as by reducing the burden of childcare on women. Commutes to work and school can be made safer through improvements to public infrastructure such as lighting and security. Women and girls would thus have better access to education, support for childcare, and safe travel to work and school without fear.Social, cultural barriers

> Underpinning these infrastructure changes would be efforts to reduce social and cultural barriers to gender equality, such as using community-based initiatives such as equality-focused collectives to address negative stereotypes about women's contributions in the workforce, provide the childcare and schooling help listed above, or awareness campaigns about women's safety and bystander intervention. Corporate-facing legislation and revamped corporate processes are crucial in closing the gender pay gap. Enhancing anti-discrimination laws in India and implementing pay transparency systems are critical in instilling a sense of security and value among woman employees, while inclusive workplace policies that support recruitment and caprogression ensure equal access to opportunities. Moreover, conducting regular gender pay audits can detect and resolve compensation discrepancies alongside providing data for action plans aimed at solving these disparities. Companies which publicly commit to these action plans also demonstrate their dedication to gender equality, presenting them as desirable employers to talented woman workers. #### Why do we have Governors in every State? | Explained



The Supreme Court on April 8, 2025 delivered a significant verdict delineating the powers of the President and the Governors, on the issue of grant of assent to Bills passed by State legislatures, under Articles 201 and 200 respectively of the Constitution. The judgement has sparked a debate across the country and therefore, it becomes imperative to look into the history of the institution of Raj Bhavans in every State. Interestingly, the 415-page judgement of the top court itself provides a valuable insight into the past.

When did the office of Governor come into existence?

In their exhaustive verdict, Justices J.B. Pardiwala and R. Mahadevan point out that the administration of country transitioned from the East India Company to the British Crown with the enactment of the Government of India (GoI) Act of 1858 which brought about a new administrative framework in which the Governor, as an agent of the Crown, operated under the general supervision of a higher authority titled as Governor General. Though this structure prevailed for quite a few years, the Montagu-Chelmsford Reforms of 1919 aimed at increasing increased Indian participation in governance, led to the enactment of the Gol Act of 1919. Even after the enactment of the new law, the Governor remained central to the provincial administration in the country and continued to wield significant authority. Subsequently, the Gol Act of 1935 ushered in the era of provincial autonomy and formally required the Governor to act on the advice of the Ministers. Yet, the 1935 law too safeguarded the discretionary powers of the Governor such as vetoing a Bill passed by a legislative council. When the country was nearing Independence, almost every other document including the Commonwealth India Bill of 1925, the Nehru Report of 1928 and the Constitution of Hindustan Free State Act, an aspirational document prepared by the All India Hindu Mahasabha in 1944, advocated for adopting the westminster style of polity and insisted on retaining the office of the Gov-

What were the changes made to the office of Gover-

Justice Pardiwala points out that the declaration of Independence brought about a fundamental transformation in the role of the Governor. Until the Constitution came into effect in 1950, the provisions of the Gol Act of 1935 as modified by the India (Provisional Constitution) Order of 1947 governed the administration of the country. Significantly, the 1947 Order omitted the expressions 'in his discretion,' 'acting in his discretion,' and 'exercising his individual judgment' from the Act, signaling a departure from the colonial framework. One of the key decisions that the framers of the Constitution had to take was to decide whether the Governor should be elected by way of a direct election or selected from a panel of names suggested by the State legislature or nominated by the President. While in the early days, the Constituent Assembly leaned towards having an elected Governor; as the framing of the Constitution neared its conclusion, there was increasing support in favour of having a Governor nominated by the President.Pandit Jawaharlal Nehru attributed this shift of opinion to the bitter experience of partition, which, according to him, opened the eyes of the Constituent Assembly to the dangers of separatism and the need for having a political structure which focused more on the character of the nation as a Union of States rather than

How did the Constitutent Assembly deal with the office of Governor?

Constitutent Assembly memeber H.V. Kamath argued that an elected Governor, being a partisan figure, would inevitably clash with the Chief Minister, thereby disrupting the functioning of a cabinet style government. According to him, the role of a constitutional head should be impartial and symbolic, and therefore, the nomination system was better suited to uphold these principles. Hukam Singh treaded a middle path by acknowledging the difficulties inherent in both pure election and pure nomination for the purpose of appointment of Governors. Recognising the high costs involved in conducting elections, he proposed a balanced alternative, suggesting that a panel of candidates be nominated by the State legislature and a Governor be chosen from the said panel.

Rohini Kumar Chaudhari was prophetical in his argument before the Constituent Assembly. He opposed the nomination of Governors by cautioning that a Governor appointed by the Centre and belonging to a different political party than the provincial government, could lead to discord between him and the provincial governments and thereby undermine provincial autonomy. While many other members too expressed their opinions. Nehru felt that an elected Governor could exacerbate provincial divisions and weaken ties with the Centre. "I feel that if we have an elected Governor that would to some extent encourage separatist provincial tendency more than otherwise. There will be far fewer common links with the Centre," he told the Constitutent Assembly which finally agreed upon appointment of Governor through Presidential nomination.

Does the Governor enjoy discretionary powers?

Article 163 of the Constitution states that the Governor shall exercise his functions on the aid and advise of a council of ministers headed by the Chief Minister "except in so far as he is by or under this Constitution required to exercise his functions or any of them in his discretion."When the Constituent Assembly debated the necessity for providing such discretion to the Governor, B.R. Ambedkar said, the discretion was of limited nature and could be exercised only within the parameters of the constitutional provisions. He pointed out that the words intended to be included in Article 163 (then numbered as draft Article 143) were 'except in so far as he is by or under this Constitution' and not except wherever he thinks that he should exercise this power of discretion against the wishes or against the advice of the ministers.'When the discussion turned towards Article 200 (then numbered as draft Article 175), which mandates Governor's assent to a Bill passed by the legislature for it to become an Act, Ambedkar himself moved an amendment on July 30, 1949 to remove the expression 'in his discretion' from the Article. He felt that "in a responsible government, there can be no room for the Governor acting on discretion." The amendment was successfully carried out after a debate and the expression was removed.

What has the Supreme Court held now?

It is by relying upon the Constituent Assembly debates to understand the intent behind the framing of Article 200, the Bench comprising Justices Pardiwala and Mahadevan have now held that the Governors do not enjoy either the power to veto (witholding assent to a Bill indefinitely without assigning reasons) or pocket veto (keeping a Bill pending without taking any decision for an indefinite period) a legislation passed by an elected legislature. Since neither Article 200 nor 201 lays down timeline for grant of assent, the court has prescribed timelines for the President as well as the Governor when it comes to granting assent to Bills. The judges took note that the first Administrative Reforms Commission established by the Union Home Ministry in 1966 as well as the Raiamannar Commission set up by the Tamil Nadu government in 1969 had recommended framing of guidelines on the discretionary powers of the Governor. Similarly, the Sarkaria Commission established in 1983 and the Punchi Commission constituted in 2007 had recommended adoption of definite timelines for processing State

What is difference between prescribing and reading in

Taking a cue from those recommendations as well as a February 4, 2016 office memorandum of the Union Home Ministry which insists on clearing State legislations sent for President's assent within three months, the judges ordered that the President must take a decision on grant of assent within three months. Similarly, they prescribed a time line of one to three months for the Governors to either grant assent, withold assent or refer the Bill to the President. The judges made it clear that they were only prescribing timelines and not reading them into Article 200 since the latter course would amount to amending the Constitution. Explaining the need for prescribing the timelines, the judges said, failure to adhere to these timelines would enable the State government concerned to approach the court for an appropriate remedy and also provide an opportunity for the office of the Governor to explain the delay thereby enabling the court to take a decision on a case-by-case basis. "Any deliberate inaction on part of the Governor in assenting to Bills or reserving them for the consideration of the President, thus, has to be viewed as a serious threat to the federal polity of the country and the aggrieved governments cannot be left remediless, desperately waiting for a decision at the hands of the Governor," the Bench said thereby bringing in a new dimension to the functioning of the age-

#### As malaria cases fall, a look at Tamil Nadu's strategies for elimination

Reports from the World Health Organization and the Commonwealth Malaria Report have indicated that India is set to eliminate malaria by 2030. The number of deaths from malaria has significantly fallen, with better surveillance and access to diagnosis and medicines, the reports add. Malaria, the WHO says, is a life-threatening disease spread to humans by some types of mosquitoes. It is mostly found in tropical countries. It is preventable and curable. The infection is caused by a parasite and does not spread from person to person. Malaria can be prevented by avoiding mosquito bites and with medicines. Treatments can stop mild cases from getting worse.

In Tamil Nadu, for the past two years, only around 340 cases were reported, says Director of Public Health T.S. Selvavinayagam. This turnaround was made possible due to steady surveillance, he adds. "When fever is reported the entire area is brought under surveillance. All institutions must be notified of fever surveillance. This enables the Health Department to get details of where the fever has occurred, who is affected and in which location," he explains. Dr. Selvavinayagam goes on to detail: "Once we identify the location where there has been a fever case, the environmental factors are identified. These could be water stagnation or issues with water storage containers. Then we expand the periphery of surveillance and we continue to monitor intensively, undertake anti-vector activities etc. We rapidly search for hidden cases as we know what the precipitating factor is. The idea is to explore the hidden cases and bring them to light.'

The Health Department then takes up routine antimalarial activities. "We continue to monitor the area for years together if it is a high risk area," he says. The female Anopheles mosquitoes that spread malaria breed in fresh water, coastal and dirty water. Four types of malaria are commonly found in the country: Plasmodium vivax, plasmodium falciparum, plasmodium ovale and plasmodium malariae. "In

Tamil Nadu we see two varieties of malaria commonly -

vivax and falciparum. The latter is imported," says former DPH K. Kolandaisamy. "Uncovered overhead tanks, wells, riverine areas and quarries are breeding sources," he explains. Other areas include coconut groves and places of religious congregations such as Rameswaram. Symptoms of malaria can be mild or life-threatening. Because some malaria symptoms are not specific, getting tested early is important. The most common early symptoms of malaria are fever, headache and chills. Severe symptoms include extreme tiredness and fatique, impaired consciousness. multiple convulsions, difficulty breathing, dark or bloody urine, jaundice (yellowing of the eyes and skin), abnormal bleeding. Infants, children under 5 years, pregnant women and girls, travellers and people with HIV or AIDS are at higher risk of severe infection. Malaria elimination strategy includes taking a peripheral blood smear of the patient, "A health inspector should carry with them a needle and a slide box to collect the blood smear; a ladle, and a torch," says Dr. Kolandaisamy. The last two items would help the inspector identify the disease-causing mosquitoes. They should also have a chloroscope to check for chlorine in water body, he adds. All fever is tested for suspicion of malaria. If the malaria is suspected to be imported (travel-related), we ask for travel history to help control the spread of the disease, Dr. Kolandaisamy says. Healthcare workers are deployed to spray insecticides. Years of surveillance and publicising the requirement to cover overhead tanks and wells has resulted in eliminating mosquito breeding spots, the doctor says. Malaria is introduced into the State by travellers however, says the public health expert. The Falciparum variety of malaria spreads through travel. The challenge lies in identifying the source of the infection, he points out."The biggest challenge is lack of health and sanitary inspectors. The number of posts have been reduced. These are 'invisible jobs' of the public health sector. This invisible force, if not maintained, could increase the burden on staff and lead to a surge in the disease, Dr. Kolandaisamy avers.

#### Tiny farmers: Ants began farming fungi 66 million years ago, says new study



Long before humans planted crops like wheat or rice, ants were already farming. These tiny animals have been cultivating fungi for millions of years, developing a system that rivals our own agriculture in complexity. New research led by entomologist Ted Schultz from the Smithsonian's National Museum of Natural History traces this practice back 66 million years, right after the asteroid that wiped out the dinosaurs.

In a study, published earlier this month in Science, Schultz and his team used genetic data to uncover the early stages of this farming relationship. After the asteroid impact ended the Cretaceous period, plants across the globe began dying. But fungi thrived, feeding on decaying plant material. For ants, this provided the ideal conditions to start cultivating fungi as a reliable food source. Schultz explained that the aftermath of the asteroid impact created ideal conditions for fungi to flourish. While it was a disaster for plants and dinosaurs, it created new opportunities for the organisms studied by the researchers.

The study revealed that 66 million years ago, ants began collecting organic debris to fuel fungal growth. This was the beginning of ant farming. Over time, their agriculture became more specialised. Around 27 million years ago, as the planet's climate cooled, ants domesticated certain fungi. These species became fully dependent on the ants for survival, while the ants relied on them for food. Similar to humans domesticating crops, ants took their fungi from tropical forests into drier environments. These isolated fungi became reliant on the ants' care in the new, more arid habitats. Leafcutter ants, for example, now grow a specific fungus that produces nutritious food bodies called gongylidia,

which are used to feed their young. Ants also practice many behaviours that mirror human farming. They weed their fungal gardens, use bacteria on their bodies to apply antibiotics, and even pass down their crops to future generations. When a new queen establishes a colony, she carries a piece of her mother's fungal garden to start the next farm. Currently, there are 247 species of fungus-farming ants found across the Americas. These species are all descended from the first ants that began farming after the asteroid impact. Leafcutter ants were first observed farming fungi 150 years ago by naturalists, and Schultz's study adds new depth to this discovery, using advanced genetic tools to map out their evolutionary history. Why did ants start farming? Schultz believes the asteroid played a major role. When the dust and debris from the impact blocked out the sun, many plants and the animals that fed on them died off. Fungi, however, thrived in the dead vegetation. Ants, already familiar with fungi, began farming them, setting off a relationship that has lasted for millions of years.

The research also highlights a key moment 27 million years ago, when ants began practicing "higher" agriculture, fully domesticating fungi that could no longer live independently. This advanced farming allowed ants to thrive in new environments where their crops depended on carefully controlled conditions. Despite facing challenges that human farmers also face, such as managing disease in their monocultures, ants have maintained a stable farming system. Schultz points out that while human monocultures are vulnerable to crop failure, ants have somehow managed to avoid this, possibly through their use of antibiotics. Researchers are still investigating how ants maintain this balance. Ant agriculture offers a glimpse into a system that has survived mass extinctions, climate change, and infectious diseases. Schultz believes there is still a lot to uncover about these tiny farmers.

He highlights the vast diversity among fungus-farming ants, many of which are still waiting to be discovered. "Ants have been practicing agriculture and fungus farming for much longer than humans have existed, "says Schultz, adding that "we could probably learn something from the agricultural success of these ants over the past 66 million years." ### As climate talks enter uncertainty, can countries deliver in 2025

The Nationally Determined Contributions (NDCs) Synthesis Report and United Nations Emission Gap report comes have the same old story to tell --- climate change is a discussion for ballrooms over expensive food and drinks, and not for real change on the ground. Even 26 years after the first climate protocol was enforced, the emission trajectory continues to grow and has not slowed down to the level, which can save the world from warming two degrees more than the pre-industrial level. The context for the reports -which highlight the collective failure of the world towards achieving climate change goals -- is that by next year countries have to submit fresh NDCs to the United Nations Framework Convention on Climate Change (UNFCCC). Climate scientists and activists are asking policy makers to substantially increase country-wise targets under the NDCs to reduce emissions and for quicker transition towards net zero, latest by 2040. The synthesis report's findings are stark but not surprising - current national climate plans fall miles short of what's needed to stop global heating from crippling every economy, and wrecking billions of lives and livelihoods across every country. Current plans combined - if fully implemented - would see emissions of 51.5 gigatonnes of CO2 equivalent in 2030 - a level only 2.6% lower than in 2019. Greenhouse gas pollution at these levels will guarantee a human and economic wreck for every country, without exception. The Intergovernmental Panel on Climate Change has said that that greenhouse gas emissions (GHG) need to be cut 43% by 2030, compared to 2019 levels. By 2035, net global greenhouse gas emissions need to be cut by 60% compared to 2019 levels. This is critical to limiting global heating to 1.5°C this century to avert the worst impacts of climate change. Every fraction of a degree matters, as climate disasters get rapidly worse. The UN Emission Gap Report said the GHG emissions increase will lead to temperature rise by 2.6 to 3.1 degrees Celsius by turn of the century as emissions have risen two times compared to the pre-industrial level and 43% since 1990, when the first conference of climate change was held in Rio De Janeiro, leading to signing of UNFCCC. It also said that emission cut of 42% by 2030 and 57% by 2035 to get on track for 1.5°C. It remains technically possible to get on a 1.5°C pathway, with solar, wind and forests holding real promise for sweeping and fast emissions cuts, the emission gap report said, stating that

sufficiently strong NDCs need to be backed urgently by a

whole-of-government approach, measures that maximise

socio-economic and environmental co-benefits, enhanced international collaboration that includes reform of the global financial architecture, strong private sector action and a minimum six-fold increase in mitigation investment. The UNFCCC has urged nations to deliver on the next round of national climate plans and to have enough "ambition" to drastically cut emissions rather than just slowing down the emission trajectory and need to pass the ABC test: new emissions cut targets should be economy-wide, covering all greenhouse gases; keeping 1.5 degrees alive; must be broken down into sectors and gases and must be credible, backed up by substantive regulations, laws, and funding to ensure goals are met and plans implemented.? The UN has called on nations to ensure that the new NDCs detail adaptation priorities and investments to protect critical sectors, infrastructure and people from climate impacts, and align with National Adaptation Plan processes. They should have a time horizon until 2035, with much stronger 2030 targets to drive the deep emissions cuts needed globally this decade, the UN said, while releasing the synthesis report. The COP29 conference to be held in November in Baku, Azerbaijan, is expected to frame the contours for NDCs, providing enabling economic frameworks for the needs of developing countries and more accountability from the developed world, which is responsible for 80% of the collective emissions. The COP29 comes at the time when there is a war in the middle-east with United States backed Israel on side and Iran-backed Hamas on the other and the impending United States presidential elections. If former President Donald Trump wins, the future of climate talks will be uncertain. In 2016, when Trump won for the first time, US walked out of the Paris climate deal, to return only when Democrats led by Jim Biden returned to power. In wake of these uncertainties, not much should be expected from Baku climate conference. However, if the countries agree on a robust and "real" emission reduction NDC framework, it would be an achievement as the first NDC framework under the Paris Agreement was weak as it aimed to bring as many countries on board of the voluntary global regime.It would be interesting to see whether Baku agrees to voluntary emission reduction targets for emerging economies such as China and India, the clamour for which is rising globally as the two countries progress to enter the club of developed nations. With India setting a target to become a developed country by 2047, beating this clamour will not

easy on the global climate stage.

## Why is the rupee weakening against the dollar? | Explained



The story so far: In the last week of December, 2024, the rupee breached the 85 mark against the U.S. dollar, touching an all-time low of 85.81. The currency depreciated about 3% in 2024, continuing its long-term trend of gradually but consistently losing value against the dollar.

What causes a currency to depreciate?

The price of any currency in the foreign exchange market is determined by the demand for the currency visa-vis its supply. This is similar to how the price of any other product is determined in the marketplace. When the demand for a product rises while its supply remains constant, this causes the price of the product to rise in order to ration the available supply. On the other hand, when the demand for a product drops while its supply remains constant, this causes sellers to drop the price of the product in order to attract sufficient buyers. The only difference between the goods market and the forex market is that currencies are exchanged for other currencies rather than for goods in the foreign exchange market. A currency depreciates against a foreign currency when the demand for it (in terms of the foreign currency) drops compared to its available supply in the market. When the currency's value depreciates, the value of the foreign currency automatically appreciates on the other side. This is similar to how the purchasing power of your money depreciates or appreciates when the price of goods in the marketplace rise or fall, respectively. There are various factors that determine the demand for and the supply of any currency in the foreign exchange market.

One of the most important determinants of the supply of a currency in the market is the monetary policy of a country's central bank. A central bank adopting looser monetary policy compared with other central banks will cause the supply of its currency in the market (for both goods trade

and investment purposes) to rise relative to other currencies, causing the currency's value to drop. Central banks adopting relatively tighter monetary policy, on the other hand, are likely to see their currencies appreciate in value. A crucial factor that determines the demand for any currency, on the other hand, is the demand among foreigners for the goods and assets of the country. Since foreigners will first have to purchase the local currency before they can purchase a country's goods and assets, high demand for a country's goods and assets translates to high demand for its currency and which in turn leads to a rise in the value of the currency. A fall in demand for a country's goods or assets, on the other hand, will cause the value of its currency to fall.

What is behind the rupee's fall?

The current bout of rupee depreciation is seen as driven primarily by the exit of foreign investors from India, which has put pressure on the rupee. Global investors have been shuffling their investments across countries as central banks recalibrate their monetary policies to varying degrees. High inflation in the aftermath of the coronavirus pandemic led to monetary tightening by central banks which is now being reversed as inflation comes more under control. This has pushed investors to withdraw money from markets like India and invest in more advanced markets. Meanwhile, the longer term trend of the rupee's depreciation against the dollar is attributed to higher inflation in India than in the U.S. due to the Reserve Bank of India's looser monetary policy compared to the U.S. Federal Reserve. India's traditional demand for high-value imports such as crude oil and gold (which boosts demand for the dollar and weakens the rupee) to keep its economy going and its inability to boost exports (which can help boost demand for the rupee) have also contributed to the lackluster performance of the rupee The RBI has been using its dollar reserves to prop up the value of the rupee by artificially increasing the supply of dollars in the foreign exchange market, and thus the dollar demand for rupees. As a result, the value of India's foreign exchange reserves dropped to an eight-month low of \$640 billion as of the last week of December from over \$700 billion in September. Analysts believe the rupee's depreciation would have been far worse if not for the RBI's intervention to support the rupee against the dollar. The RBI's traditional stance has been to manage the rupee's exchange value in such a way as to allow for a gradual depreciation in its value without too much volatility that could disrupt the

#### India needs to prioritise preventive care

India is facing a healthcare crisis that is growing both in scope and cost. We face an alarming dichotomy today: while life expectancy of Indians is expected to increase further, many are facing disease burden earlier. As the country sees an alarming rise in non-communicable diseases (NCDs) such as heart disease, stroke, diabetes, and cancer, the financial burden on individuals and the healthcare system continues to escalate.NCDs accounted for about 65% of all deaths in 2022, up from about 50% in 2010-13, as per the National Family Health Survey-5. The prevalence of risk factors for NCDs is worryingly high. One in four adult men are hypertensive. One in eight are diabetic. Further, breast, lung, and cervical cancer are on the rise, with the median age of diagnosis occurring earlier than global averages.

Millions of people who are facing these conditions could have been managed better, at often lower costs, had they been diagnosed earlier. In this context, shifting the focus from reactive treatment to proactive prevention is crucial, not only to improve health outcomes but also to control the ever-increasing healthcare expenses A growing economic

The Union Budget for 2024 allocated ?87,657 crore to the Ministry of Health and Family Welfare, marking a 13% increase from the previous year. While this is a step forward, experts agree that this allocation remains insufficient given the scale of India's health challenges. The National Health Accounts show the total current health expenditure estimate in 2021-22 as ?7.9 lakh crore, growing at a rate more than overall inflation. The share of household health expenditure, including insurance contributions, while decreasing over time, still drives nearly 50%+ of the spend. This remains one of the highest globally. The World Health Organization (WHO) projects that the economic burden of NCDs in India will surpass ?280 lakh crore by 2030 — a cost equivalent to ?2 lakh per household. This escalating cost, driven by rising healthcare expenses and productivity losses, poses a severe threat to financial stability, particularly for middle and lower-income families. Regular screenings, especially for high-risk individuals, could significantly reduce the incidence of serious, life-threatening and debilitating conditions and its resultant cascading economic and social effects. In a large hospital network, for every 1,000 people screened, at least three people are identified for preemptive cardiac or cancer interventions. Targeted but periodic screening investigations for individuals such as mammograms for breast cancer, pap smears for cervical cancer, X-ray or low-dose computed tomography for lung cancer, ultrasound for liver disease, echo cardiography and treadmill stress test for heart disease beyond the physical blood tests intervention. Unfortunately, comprehensive health checks (which can cost anywhere between ?8,000 and ?15,000 in metro cities today) are perceived as expensive. If the government were to enable a step change in preventive health services adoption, it could significantly reduce the overall financial burden on individuals and the healthcare system. Tax incentives, subsidised screenings, and public awareness are key policy tools that can enable this. As part of the Finance Act, 2013, the Union government made efforts to encourage preventive healthcare by offering a ?5,000 tax deduction under Section 80D of the Income Tax Act for health checks. However, this amount has remained stagnant for the last decade, despite the 12-14% estimated healthcare inflation rate and the rising cost of healthcare services. Thus, it would be prudent for our policymakers to consider revising the tax deduction limit to at least ?15,000 in the Union Budget for 2025-26. This would incentivise more individuals to undergo preventive health checks, potentially saving the nation several thousand of crores ifn uture healthcare costs. The incremental tax foregone to the exchequer from such a measure is estimated to be less than ?5,000 crore, a worthy investment towards improving the health of the nation.

The path forwardWe need to prioritise preventive care to mitigate the increasing economic and financial burden of chronic diseases. A three-pronged approach can potentially drive a change in the adoption of preventive health services. First, we need to strengthen early intervention capabilities through the Ayushman Health and Wellness Centres, including capturing trends effectively and enabling

risk-driven targeted screening using Al-enabled imaging



modalities to offer lower cost screenings at-scale. Second, we need to improve the adoption of screening at private centres by encouraging insurers and private health providers to offer a subsidised minimum screening programme for every individual between 40-60 years. For example, for women after the age of 40, a mammogram is necessary annually or once in two years, based on her risk factors. Exploring part funding through allocations from proceeds from the healthcare cess or the proposed 35% GST slab on tobacco and sugar products can help reduce funding needs. Finally, the increase in tax deduction limit can further incentivise people to complete comprehensive health checks. By prioritising preventive care over reactive treatments, India can pave the way for a healthier and more economically resilient future.

## SEBI bars Synoptics Technologies, promoters for siphoning off IPO funds



Synoptics TechnologiesThe regulator has prohibited First Overseas Capital Ltd, which acted as the lead manager to the IPO of STL, from taking up any new assignment relating to merchant banking The Securities and Exchange Board of India (SEBI) on Tuesday barred Mumbai-based Synoptics Technologies Ltd (STL) and its promoters from trading in securities market for siphoning away funds raised through the initial public offering (IPO). The regulator has prohibited First Overseas Capital Ltd, which acted as the lead manager to the IPO of STL, from taking up any new assignment relating to merchant banking activities in the securities market till further directions.

"The facts brought out during the examination reveal a well laid out plan of the Company and the Lead Manager, FOCL, to siphon away funds raised in the IPO," SEBI said in the interim order.STL came out with a Rs 54.04 crore IPO and got listed on the SME Platform of NSE Ltd on July 13, 2023. Of the Rs 54.04 crore, Rs 35.08 crore was raised through a fresh issue of shares and the remaining Rs 18.96 crore was through an offer for sale of shares made by two promoters — Jatin Shah, also the company's Managing Director, and Jagmohan Manilal Shah.

As per the disclosures made in the Red Herring Prospectus (RHP) filed by STL, issue-related expenses amounted to Rs 80 lakh, of which Rs 50 lakh was to be paid from the proceeds of the fresh issue, while the remain-

ing Rs 30 lakh was to be met by the selling shareholders under the offer for sale. Net of these expenses, STL was projected to receive Rs 34.58 crore from the public issue, to be utilized for repayment of borrowings (Rs 5 crore), working capital (Rs 17.58 crore), investment in strategic acquisition/joint venture (Rs 5.3 crore) and general corporate purpose (Rs 6.7 crore). In its investigation, SEBI found that Rs 19 crore from the issue proceeds was transferred out of the escrow account on July 12, 2023 - a day prior to the listing of the shares of the company and the grant of trading approval. These transfers were effected based on an instruction issued by FOCL to HDFC Bank on July 12, 2023, for release of issue-related expenses. The order said that the amount transferred ostensibly for meeting issue related expenses -Rs 19 crore-was grossly disproportionate to the Rs 80 lakh disclosed as issue expenses in the RHP, and accounted for more than 54 per cent of the total proceeds raised by Synoptics through the fresh issue of shares and 35 per cent of the total issue size. "The actions of FOCL in giving instructions for the transfers to HDFC Bank, Fort Branch, Mumbai, are shocking and stunning at the same time," the order said.

When asked for a clarification, STL said the payments were not related to issue expenses and were instead for working capital (payment made to Dev Solutions) and strategic investment/joint venture objects (payment made to CN IT Solution and ABS Tech Services). STL had disclosed that the target entities for the proposed strategic investment had not yet been identified. However, within 20 days of the RHP filing—and on the very day the IPO proceeds were credited to the issue account-funds earmarked for strategic investment and general corporate purposes were transferred to CN IT Solutions and ABS Tech Services toward the object of strategic acquisition. SEBI said during a site visit conducted by NSE, it was found that neither of the entities was present/located at the stated address.In respect of Rs 6 crore transferred to Dev Solutions, a site visit by NSE revealed that no such business existed at the stated

#### Long-delayed Free trade Agreement: Amid Trump tariff pressure, India-UK bridge divide after 'round-the-clock negotiations'

India and the UK appeared close to signing a trade deal on several occasions—first under former UK Prime Minister Boris Johnson, who had set a Diwali 2022 deadline, and later under Indian-origin British Prime Minister Rishi Sunak—but the agreement was ultimately concluded against the backdrop of tariff pressures from US President Donald Trump.

A statement released by the UK suggested that the agreement was finalised after "round-the-clock negotiations" that continued until last week, when Business and Trade Secretary Jonathan Reynolds and Commerce Minister Piyush Goyal held the final round of talks in London. Negotiations had first begun in 2013 but were abandoned due to differences. Despite continuing differences on environmental and labour-related issues, both countries seized a historic geopolitical opportunity—amid growing anti-China sentiment in the West and India's increasing openness to integrating more fully into global supply chains, something that India lagged a decade ago.

The India—UK agreement is particularly significant as it marks India's first full-fledged trade deal with a Western nation. While India has signed a partial agreement with Australia, negotiations for a comprehensive deal have yet to be concluded. The Trump-era tariffs have reignited political momentum for trade agreements. Trade deals are now increasingly viewed through a geo-strategic lens, with greater involvement from the Ministry of External Affairs and the Prime Minister's Office—apparently aimed at countering China and positioning India as an alternative manufacturing hub.Indian government officials have said the UK deal will better position India to negotiate an FTA with the European Union, which could offer broader benefits—not only for labour-intensive sectors but also for industrial goods.

The UK deal comes at a time when US tariffs on Chi-



nese imports have surged to record highs. However, the US is not alone in seeking to reduce import dependence on China; the UK and EU have also introduced a range of antidumping measures to protect their domestic markets. India signalling openness to trade deals amid US—China tensions could help attract greater foreign investment, as global supply chains are being realigned in response to US tariffs.

Richard Baldwin, Professor of International Economics at IMD Business School, told The Indian Express that as the US and China drift apart in a tariff war, third countries such as India are becoming more attractive trade partners. "The EU is increasingly interested in signing agreements with India," he said. "Remember, the US accounts for less than 15 per cent of world imports—85 per cent of the global market remains accessible. Maintaining access through smart FTAs while managing dumping risks is crucial," he added. The trade deal with the UK is particularly significant for India's rapidly growing services sector, as integration with the UK—where 80 per cent of output comes from services—could boost India's growth. However, the fine print of the deal will provide a more accurate picture.

# Most comprehensive trade deal India has negotiated, to be the template for future engagements: Commerce Ministry

The India-UK trade deal is significant in being the most comprehensive free trade deal that New Delhi has entered into so far and could serve as the template for future trade engagements, including the multiple bilateral deals currently under negotiation. These include the complex trade deal under discussion with the 27-nation European Union and the fast-tracked deal being negotiated with the US.

The impetus to wrap up the trade deal comes against the backdrop of the US catalysing a major reset in global trade order after the series of protectionist measures rolled out by the Donald Trump administration. While full details of the India-UK agreements are awaited, negotiators on the Indian side have been cognizant of the fact that any concessions, tariff or otherwise, made in this FTA would have to be potentially replicated in the ongoing trade deal negotiations, especially with the US and the EU. Also, a contentious bilateral investment treaty between India and the UK continues to hang fire, with both sides finding it difficult to ease out differences related to some of the clauses of the investment pact. This bilateral trade deal was also slightly complicated given that both India and the UK are services hubs and there was much less complementarity on issues, as compared to, for instance, the pact negotiated earlier with Australia. Also, London was explicitly clear about it not wanting an early harvest deal, of the kind that India had signed with Australia.

After the signing of the UK deal, India's Ministry of Commerce and Industry said Tuesday that the trade deal will open up export opportunities for labour-intensive sectors such as textiles, marine products and leather, among others, as around 99 per cent of Indian exports will benefit from zero-duty access to the UK market. The India-UK Free Trade Agreement (FTA), it said, ensured "comprehensive market access for goods across all sectors, covering all of India's export interests" and that India will gain from tariff elimination on approximately 99 per cent of tariff lines. This will cover "almost 100 per cent of trade value" — offering



opportunities to increase bilateral trade between India and the UK. The Ministry also said that India has secured "significant commitments on digitally delivered services for Indian service suppliers", especially in professional services such as architecture and engineering, computer-related services, and telecommunications services, a major area of concession for the Indian side. While both governments are expected to release the official text of the trade deal in due course, New Delhi's view is that an exemption secured for Indian workers temporarily in the UK — and their employers — from paying social security contributions for a period of three years under the Double Contribution Convention is a net positive for India. This, Ministry officials said, will result in "significant financial gains for Indian service providers". The Ministry said that the FTA eases mobility for professionals, including contractual service suppliers; business visitors; investors; intra-corporate transferees; partners and dependent children of intra-corporate transferees with the right to work; and independent professionals such as yoga instructors, musicians and chefs. "This agreement sets a new benchmark for equitable and ambitious trade between two large economies. It will benefit Indian farmers, fishermen, workers, MSMEs, start-ups, and

## Drinkable sunscreen is the new rage; here's all you need to know about this 'liquid supplement'



With an increased awareness of skin health and the need to protect it from harmful UV rays, drinkable sunscreen has become a new trend in the wellness industry. But what exactly is it, and can this liquid supplement provide internal defense against damaging UV rays, potentially replacing conventional topical sunscreens? We asked experts. The most common type of drinkable sunscreen is a liquid supplement that includes antioxidants, plant extracts such as Polypodium leucotomos, and occasionally vitamins like astaxanthin or beta-carotene, said Dr Karuna Malhotra, an aesthetic physician and cosmetologist from Cosmetic Skin and Homeo Clinic in Rajouri Garden, New Delhi. "These ingredients are believed to support the skin's ability to fight UV-induced oxidative stress from the inside out," added Dr Malhotra. Unlike topical sunscreens, which physically block or absorb UV rays, drinkable sunscreens work on a systemic level. "They don't create a physical barrier on the skin. Instead, they aim to enhance your skin's resilience by reducing the cellular damage caused by sun exposure, albeit from the inside," said Dr Malhotra.

Are they effective

These supplements are typically taken orally once daily, ideally before exposure to the sun. However, Dr Malhotra said that the absorption and effectiveness can vary from person to person. "And it won't work instantly," said Dr Malhotra.Concurred Dr Shareefa Chause, dermatologist, Dr Shareefa Skin Care Clinic, Mumbai, and said that drinkable sunscreens work from within and take time to build protection. "They are not a substitute for topical sunscreen," she emphasised. Dr Malhotra noted that while there is some scientific backing for ingredients like Polypodium leucotomos in reducing sunburn risk, she cautioned against seeing drinkable sunscreen as a standalone solution. "Since the research is limited, the evidence is still evolving, and it should never replace your SPF lotion or sunblock. It can supplement your skincare routine, but relying solely on it could leave your skin unprotected," said Dr Malhotra.Dr Malhotra said not everyone is a good fit for drinkable sunscreen. "It is typically safe for adults, but without a doctor's approval, it might not be appropriate for children, expectant mothers, or those with specific medical concerns, she advised. "Drinkable sunscreen might support skin health, but it's not a shortcut. Think of it as an internal antioxidant boost, not a shield. Traditional sunscreen is still your first line of defense. Relying solely on these supplements can give a false sense of security, especially during peak UV hours. For optimal protection, always combine internal care with external sun safety practices," said Dr Malhotra.Dr. Chause mentioned that it's safer to continue using proven methods, such as broad-spectrum SPF creams, hats, and shade, while treating drinkable sunscreens only as a possible supplement, not a replacement. "Don't just blindly use a sunscreen because it has been promoted on social media. Speak to the expert before trying out any product," said

# The temperature-asthma link: increasing heat is worsening symptoms in asthma patients, causing new cases among the healthy

Asthma in India has a disproportionately high death rate, representing three times greater mortality and over two times greater Disability-Adjusted Life Years (DALYs) than the global share of the asthma burden. While asthma is recognised by a multitude of symptoms including shortness of breath, wheezing, coughing, and tightness in the chest, in the wake of rising temperatures, unprecedented heat, and the relentless progress of climate change, it is becoming an underappreciated threat to respiratory health, especially for those who already have asthma. Aside from the unpleasantness of the blistering heat, environmental changes can aggravate asthma symptoms and, worse, seem to be causing new cases among healthy people.

Patients with severe asthma have an enhanced sensitivity of their airways to dry air. This dryness causes a reduction in water content of the airway, which evokes an inflammatory response. This inflammation, in turn, makes the airways narrowed, a process also referred to as airway constriction, which further restricts breathing. The already vulnerable respiratory system cannot handle the additional load of intense heat and therefore, has more episodes of asthma attacks. The scenario is further compounded by the synergistic effects of increasing temperatures and intensifying air pollution - a direct fallout of urbanisation and industrialisation driving climate change. This causes injury to the epithelial cells of the airway, the defensive lining of the respiratory tract. This makes the respiratory system more vulnerable to high temperatures, and also enhances the allergenicity of current pollutants. The twin burden of heat and pollution results in a more reactive and susceptible respiratory bed.

Clinicians are now seeing an increase in patients with asthma-like symptoms who have no previous history of respiratory ailments. Although severe temperatures can cause mild respiratory symptoms even in normal individuals, the growing frequency and duration of heat waves, combined with increased levels of allergens, could be tipping some over an edge, precipitating the onset of asthma. Interestingly, when asked about new or unforeseen environmental irritants within their practice that were not widespread a few years ago, there was a negative response. This indicates that as the intensity and effect of current irritants intensify, completely new triggers are perhaps not yet the main issue.

There are particular groups of patients at risk of asthma exacerbations when the weather is very hot or unstable. As medical officers have pointed out, the extremes of age: very young children and the old are especially at risk. Their physiological reserve and regulatory capacity might be less, and so they are less capable of coping with acute or sustained temperature stress. In terms of geographical patterns in weather-related asthma severity, the general opinion is that the risk is more or less similar in urban and rural settings, mainly as a result of the general influence of industrialisation and related pollution. Although urban areas tend to have greater levels of pollutants, rural settings may also be influenced by agricultural activities and long-range transport of air pollutants.

With these escalating dangers, proactive measures are important for asthma patients on extremely hot or smoggy days. Physicians advise proper hydration to offset the dehydrating properties of dry air. Staying indoors during the most intensely hot part of the day is also necessary to avoid heat and pollutants. Wearing a clean mask can serve as an immediate physical shield against airborne allergens. Importantly, patients need to follow their physician's instructions carefully regarding the use of regular inhalers to control their baseline inflammation and keep quick-relief medication handy. For those who do not have asthma but have seasonal respiratory symptoms that may be climate-related, the recommendation is slightly different. Although routine preventative inhaler use is not usually advisable in the absence of a proper asthma diagnosis, seeing a healthcare provider to determine specific triggers and create an individualised management plan is recommended. This may involve such strategies as avoiding known allergens or taking over-the-counter medication for mild symptoms.

The long-term health impacts of deteriorating climate trends are becoming a major concern. Physicians are highlighting the imperative for community action to reverse climate change. Actions like reforestation to enhance air quality and fostering a healthier environment are crucial. A priority of making a "breathful India" through sustainable environmental management is viewed as vital to protect the respiratory health of all individuals. Finally, a focus on the underlying causes of climate change is critical to protecting



vulnerable groups and helping everyone breathe easily and safely in the future. This is especially significant, as India has a heavy asthma burden. Estimates are difficult to get, but the Global Burden of Disease study (1990-2019) has estimated approximately 34.3 million individuals with asthma in India, which represents about 13.09% of the worldwide burden. A high proportion of asthma cases in India are not diagnosed. It has been estimated by experts that more than 80% of the cases of asthma in India may go undiagnosed, and this can progress over a period of time. There are differences in prevalence among regions and populations. There is evidence of increased prevalence in rural locations and in females. Childhood asthma is a significant reason for emergency department visits, hospitalisations, and school absence. Higher temperatures are likely to intensify air pollution, notably ground-level ozone, which is a confirmed asthma inducer. Heatwaves also have the potential to aggravate respiratory diseases. Climate change can result in longer pollen seasons and higher pollen production. impacting people with allergic asthma. Alterations in rainfall patterns and higher humidity can foster the development of mould and dust mites, indoor allergens that induce asthma Severe weather conditions such as wildfires, increasingly caused by global warming, emit particulate matter and smoke that can lead to asthma attacks. While the impacts of climate change are now increasingly being felt, air pollution still remains a severe environmental and health emergency in India. The recent statistics from the World Air Quality Report 2024 indicate that India was the fifth most polluted nation in the world, with a mean PM2.5, more than ten times the World Health Organization safe threshold. Particulate pollution (PM2.5) is a significant issue. Between 1998 and 2021, the Indian average annual particulate pollution grew by 67.7%, lowering average life expectancy by roughly 2.3 years. An estimated 59.1% of the world's growth in pollution between 2013 and 2021 originated from India. Protecting vulnerable populations, especially children and the elderly, requires proactive strategies at both individual and societal levels. Ultimately, safeguarding the right to breathe clean air necessitates a concerted effort to mitigate climate change, implement stringent pollution control measures, and prioritise public health to prevent a future where respiratory distress becomes the norm.

#### Gaganyaan mission pushed to first quarter of 2027

New Delhi: The launch of India's maiden human space flight — Gaganyaan — has been pushed to the first quarter of 2027, nearly five years later than the original schedule as it races to ace technologies for such complex projects.

The first uncrewed mission of the Gaganyaan project is expected to be launched later this year, which will be followed by two similar missions in 2026, Indian Space Research Organisation (ISRO) Chairman V Narayanan said at a press conference. "The first crewed mission is targeted for the first quarter of 2027," Narayanan said and added ISRO would send a half-humanoid robot — Vyommitra — as part of the uncrewed mission before sending astronauts into low-Earth orbit.

"The Gaganyaan programme represents India's rise as a global space power, built on indigenous technology, fiscal prudence and visionary political leadership," Union Science and Technology Minister Jitendra Singh said.

Prime Minister Narendra Modi announced the Gaganyaan project during his Independence Day address in 2018 and set a target of 2022 for achieving India's maiden human space flight.

#### Selectors to remove Rohit Sharma from Test captaincy

The national selectors have decided to remove Rohit Sharma as captain of India's Test team, and go with a new leader for the tour of England that starts next month. It remains to be seen if Rohit travels to England as a specialist opening batsman. learns that the Indian cricket board will back the selectors' decision. It's a move not driven by a need for transition or to cull out aging players, but understood to be based on Rohit's performances and his form in red-ball cricket. It is learnt that the 38-year-old will continue to be in India's ODI plans.

This newspaper had reported in March how the board was keen on Rohit to lead on the England tour after his success in the ICC Champions Trophy. Rohit, too, on a recent appearance on former Australian captain Michael Clarke's podcast, 'Beyond 23', had talked about his excitement in leading an attack with Jasprit Bumrah, Mohammed Shami and Mohammed Siraj in England. The selectors had a series of discussions last month over Rohit's future in the Indian Test team, and also deliberated on the issue in Mumbai on Tuesday, before sharing their vision with the BCCI.

"The selectors' thought process is clear. They want a new leader for the England tour and Rohit doesn't fit in as a captain, especially considering his red-ball form. They want to groom a young leader for the next Test cycle and the selection committee has informed the BCCI that Rohit won't lead the team," a source in the Indian board informed this newspaper. It is understood that the decision-makers don't want to repeat the lack of stability seen during India's tour

of Australia. Rohit had struggled in that series, averaging just 6.20 in five innings and also dropped himself for the final Test. In the Test series prior to that, against New Zealand at home late last year, he averaged just 15.16 in three Tests. Considering his red-ball form, the selectors are hesitant in making him the captain. As a specialist batsman, he can be dropped from the playing XI if performances don't stack up, but it gets complicated if he is the captain. It also can have an adverse effect on the team, those in the know say, as it was felt on the Australia tour. Rohit didn't travel to Australia last year for the first Test in Perth due to the birth of his second child and Yashasvi Jaiswal and KL Rahul opened the innings. When he returned for the second Test, Rohit demoted himself in the batting order, then returned as opener for the Boxing Day Test in Melbourne, before dropping himself from the match in Sydney. India had won the first Test under Bumrah's captaincy but went on to lose the Border-Gavaskar Trophy. India had also lost the home series to New Zealand 0-3 under Rohit.Rohit averages 40.57 from 67 Tests. That drops to 31.01 in Tests outside India. He averages 24.38 in Australia and 16.63 in South Africa but the average jumps to 44.66 in England, where India play next. As an opener, he averages nearly the same (44.54) in Tests in England., head coach Gautam Gambhir had said any decision regarding Rohit's future in the team would be taken by the selectors. "First things first, a coach's job isn't selecting the team. It is the job of the selectors to select. The coach only selects the 11 who will play a match. Neither those who coached before me were selectors nor am I a selector," Gambhir said at ABP News' 'India At 2047' Summit. When pressed further about the veterans' (Rohit and Virat Kohli) future, Gambhir said no player should be pressed into retirement.

"Till the time they are performing, they should be a part of the team. When you start and when you end is your individual decision. No coach, no selector, no BCCI can tell you when you should call it quits. If you perform, then why 40, you can jolly well play till 45, who's stopping you?" he said. "That (playing the 2027 ODI World Cup) will depend on their performance. Only that can ensure their selection. And what should I say about their performance? The world saw how they performed in the Champions Trophy," Gambhir had said

"I am disappointed, but not with my team. They tried everything. It's the way it is. We are out, but next year we will try again to make the fans happy. It makes me sad ... My team did an excellent job. I don't like talking about the referee ... Four more players will qualify through the Last Chance Qualifier event later.

What is the Esports World Cup?

The Esports World Cup brings together top esports clubs across 24 popular titles. EWC 2025 will run in Riyadh from July 7 to August 24, featuring chess as an online event for the first time. The inaugural 2024 edition spanned eight weeks, while the 2025 event will be history's largest multititle esports tournament with 2,000+ players, 200+ teams, and a \$70 million (~?602 crore) prize pool.



Which tournaments determine EWC qualification?

Chess players hoping to qualify for the Esports World Cup will have to secure a spot via the 2025 Champions Chess Tour (CCT), the primary pathway for EWC. The two online Champions Chess Tour events — the completed Chessable Masters (Feb 16-21) and Champions Chess Tour Leg 2 (May 18-23) — will offer players opportunities to compete on the world's biggest esports stage. The top 12 players from CCT will make the cut and will be joined by four more players from a "Last Chance Qualifier" (LCQ) event. 16 chess players will be in action at the finale in Saudi Arabia later this year.

What is the Champions Chess Tour?

Champions Chess Tour is an online chess event that started in 2020 and was named the Magnus Carlsen Chess Tour. The \$1 million prize pool Magnus Carlsen Chess Tour had four super tournaments, and the winners of each tournament played in the finals for the prize money. The event evolved over time with a lot of invitations being handed out and qualification paths created to make it a more open tournament where anyone can have a shot at playing the tournament. The standard four tournaments with one final setup continued till 2024 before it was tweaked to accommodate the qualification path for Esports World Cup 2025. This time, only two legs will be played in the Champions Chess Tour 2025 instead of four legs, with the Esports World Cup acting as a replacement for the Tour Finals of CCT. 12 players will qualify for the EWC from these two online events.

I can start working on it)."

# If implemented, Trump's 100 per cent tariff threat will impact business of Indian films in US: producers



Mumbai: US President Donald Trump's announcement threatening 100 per cent tariff on movies produced outside and coming to the US will impact the box office business of Indian films and may lead to an increase in ticket prices for Indian films, say producers in India. Though there is little clarity just yet, the fear is that it will impact the footfall for Indian movies screened in the US, according to a section of industry insiders, including Shibasish Sarkar, president of the Producers Guild of India, filmmaker Vivek Agnihotri and exhibitor-distributor Akshay Rathi. "It is a little early to comment on this because whatever kind of tariff got announced in the last 30 to 45 days is going through various changes and discussions... But if it gets implemented, the first impact I foresee is on the theatrical business of our films in the US market," Sarkar told . Indian films gross around USD 100 million (over Rs 800 crore) at the US box office, he said.

"If this tariff is implemented, exhibitors will increase ticket prices and make it expensive for consumers because of which even footfalls will drop dramatically. If the exhibitors want to absorb the price, they will pass on that loss to producers, so their share will also come down drastically. Either way, there will be an impact on the producer's share from a theatrical point of view," Sarkar explained. In a post on his Truth Social platform, Trump said on Sunday that he has authorised the Department of Commerce and the Office of the US Trade Representative to slap a 100 per cent tariff "on any and all Movies coming into our Country that are produced in Foreign Lands".

Agnihotri, known for films such as "The Kashmir Files" and "The Tashkent Files", agreed with Sarkar and said ticket prices of Indian movies will increase in the US if these tariffs come into effect. "The diaspora market, which is price sensitive, became a revenue source for Indian films. Movies such as 'Jawan' and 'Baahubali' did good business outside of India. If ticket prices are doubled (in the US), I don't think anybody will watch them in theatres, especially when the films will be available on Netflix, Amazon, etc. Films such as 'RRR' and 'The Kashmir Files' did great numbers

in non-diaspora markets," Agnihotri told PTI.Sarkar added that other than an impact on the theatrical releases of local films in the US, these tariffs will have a bearing on global digital and pay TV deals for Indian producers.

"If US consumers are seeing Indian content and identified cost (price increase) towards that, then it will have an impact. From plain reading, it seems any revenue of Indian content, which is generated in the US, will attract the tariff, so that will have an impact on us." Indian films releasing in the US will face higher taxation so the contribution from the North American box office of Indian films will reduce, said exhibitor-distributor Rathi. "The way he played the tariff war on various countries, it was different tariffs for different countries. For all you know, it may be a more fluid thing given India's good relations with the US and vice versa, so it may be a little more favourable for India than other countries," Rathi said. However, Trump's tariff threat may not influence the movie production as most Indian producers find US an expensive location to shoot. "The primary objective of President Trump is that if US films are getting shot outside the US, then they're losing the opportunity. Some films do come to India to shoot. That also will be impacted," Sarkar said. In his view, Trump's new announcement will have little impact on Indian movie shoots and business in the US as the country is just one of the many markets for diaspora audi-

"There's a presence of Indians in the UK, the Middle East, Singapore, Australia, and all over the world. If my film doesn't release in one market (the US), it doesn't make that much of a difference. It is a ridiculous thing he is doing. He doesn't even realise he is killing Hollywood. We are talking for a reciprocal time, and this has happened," Bhatt told PTI.According to the veteran filmmaker, most Indian films are not even shot in the US because it's an expensive affair. "Hindi films are usually shot in the UK because they give us a subsidy, and in other places around the world," he added. Another major Indian producer, who didn't wish to be named, echoed Bhatt. "Our films are not shot in the US. Indian films are usually shot in the UK, Mauritius or Malaysia, and other countries. Wherever we get a subsidy, we go and shoot there," he said. According to director Shekhar Kapur, Trump's move could backfire and instead push Hol-Ivwood filmmakers to leave the country. Kapur, known for films such as "Mr India", the "Elizabeth" franchise starring Cate Blanchett and "What's Love Got to Do with It?", said over "75% of box office" of Hollywood films comes from outside the US. "And significant part of the budget of those films are spent outside the US. President Trump's imposition of 100% tarif on all films imported into the US may encourage Hollywood to move outside the US! Quite the opposite of what he intended. #Hollywood #tarrif #DonaldTrump #tarrifonfilm (sic)" the director wrote on X.
