### Child trafficking racket busted in Telangana's Suryapet; 10 kids rescued, 18 arrested

Suryapet: In a major crackdown, police in Suryapet district have busted a child trafficking racket that was allegedly involved in selling infants brought from other States. The gang primarily targeted childless couples, offering babies for sale at prices ranging from Rs 3 lakh to Rs 7 lakh. Authorities confirmed that the gang had sold 28 children so far, with transactions taking place discreetly. During the operation, police successfully rescued 10 children and placed them under the care of child welfare officials. A total of 18 individuals linked to the trafficking network have been taken into custody by Suryapet Town police.

# Cabinet approves two multi-tracking railway projects in Maharashtra, Madhya Pradesh

The Cabinet Committee on Economic Affairs (CCEA) chaired by Prime Minister Narendra Modi approved two multi-tracking railway projects to ensure faster transportation of both passengers and goods, the government said on Wednesday It added that these projects include the third and fourth line between Ratlam-Nagda and fourth line between Wardha-Balharshah.According to a government statement, the total estimated cost of the projects is ?3,399 crore and will be completed by 2029-30. "The projects are result of PM-Gati Shakti National Master Plan for multimodal connectivity which have been possible through integrated planning and will provide seamless connectivity for movement of people, goods and services," the press note said.

It added, "The two projects covering four districts across the States of Maharashtra, and Madhya Pradesh, will increase the existing network of Indian Railways by about 176 km. The proposed multi-tracking project will enhance connectivity to approx 784 villages having a population of about 19.74 lakh." Railway Minister Ashwini Vaishnaw said that these two projects will give a boost to infrastructure in the country in the Delhi-Mumbai and Delhi-Chennai economic corridors, removing the traffic bottlenecks.He added that during the third term of the Modi government, projects worth more than ?4.5 lakh crore have been approved in the transport and infrastructure sector in the country. The government said that these are essential routes for transportation of commodities such as coal, cement, clinker, gypsum, fly ash, containers, agriculture commodities, and petroleum products etc, hence the capacity augmentation work will result in additional freight traffic of magnitude 18.40 MTPA (million tonnes per annum).

Outlining the environmental benefits, it said that the



railways, being environment-friendly and energy-efficient mode of transportation, will help in achieving climate goals and minimising logistics cost, reduce oil import (20 crore litres) and lower CO2 emissions (99 crore kg) which is equivalent to plantation of 4 crore trees."The projects will also generate direct employment for about 74 lakh humandays during construction. These initiatives will improve travel convenience, reduce logistic cost, decrease oil imports and contribute to lower CO2 emissions, supporting sustainable and efficient rail operations," the government said."The projects would also enhance logistical efficiency by augmenting line capacity along critical routes for transportation of containers, coal, cement, agricultural commodities, and other goods. These improvements are expected to optimise supply chains, thereby facilitating accelerated economic growth," it added. Talking about other benefits, the press statement said that the increased line capacity will significantly enhance mobility, resulting in improved operational efficiency and service reliability for railways."These multitracking proposals are poised to streamline operations and alleviate congestion," the press note said.

### Lokpal gives clean chit to former SEBI chief Madhabi Puri Buch



ported by any verifiable material and do not attract the ingredients of the offences... so as to direct an investigation therefor". Accordingly, these complaints are disposed of, said the order by a six-member bench headed by Lokpal chairperson Justice AM Khanwilkar.Buch, who took over as the chief of the Securities and Exchange Board of India (SEBI) on March 2, 2022, demitted office on February 28, this year after the completion of her tenure.Referring to an earlier order in this regard, the said the Hindenburg report by itself cannot made the sole basis to escalate action against Buch. "The complainant(s) being conscious of this position advisedly attempted to articulate allegations independent of the stated report but the analysis of the allegations by us, ended with a finding that the same are untenable, unsubstantiated and bordering on frivolity," the order said. The Lokpal had on November 8, last year sought Buch's "explanation" on the complaints filed by Moitra and two others.Buch, the former chairperson of capital markets regulator Securities and Exchange Board of India (SEBI), was asked to submit her response within four weeks. Buch had filed her response by way of an affidavit sworn on December 7, 2024, raising preliminary issues as well as giving an explanation allegation-wise. The Lokpal had on December 19 last year decided to give an opportunity of oral hearing to both Buch and the complainants to clarify their positions taken in the complaints or the affidavit.Hindenburg Research's founder announced its closure in January this year. Meanwhile, the Lokpal took the matter for oral arguments on April 9. after further documents and affidavits-cum-written-submissions were filed. "The advocate for the complainant in the second complaint made exhaustive oral submissions. The proxy counsel appearing for the complainant in the third complaint opted to file written submissions. Although the complainant in the third complaint has been represented by an advocate, neither the complainant nor the advocate appeared to make oral submissions," the order said.

### HYDRAA frees park land worth Rs 40 crore from land sharks in Hyderabad's Chandanagar

Hyderabad: Responding to a complaint received in Prajavani, HYDRAA authorities retained one-acre park land worth Rs 40 crore at Mytrayee Nagar in Chandanagar. Residents of Mytrayee Nagar had approached HYDRAA and complained that park land had been encroached upon, converted into plots, and sold. As the issue was under court litigation, the park land was filled with shrubs, resulting in poisonous snakes entering the colony.

HYDRAA Commissioner AV Ranganath on verification of the layout identified the one-acre land earmarked for the park and deployed men and machinery and retained the park land.

# S Ccollegium recommends transfer of Chief Justices of Rajasthan, Tripura, Jharkhand and Madras High Courts

The Supreme Court Collegium has recommended the transfers of four Chief Justices from the High Courts of Madras, Rajasthan, Tripura and Jharkhand. The Collegium headed by Chief Justice of India has proposed the transfer of Madras High Court Chief Justice K.R. Shriram to Rajasthan. In return, Rajasthan Chief Justice Manindra Mohan Shrivastava was recommended to head the Madras High Court. The May 26 resolution of the Collegium published on Wednesday (May 28, 2025) recommended the transfer of Tripura High Court Chief Justice Aparesh Kumar Singh to Telangana. Jharkhand High Court Chief Justice M.S. Ramachandra Rao was proposed for transfer to Tripura. The Collegium, in a separate resolution, has recommended the transfer of Telangana High Court judge, Justice Tadakamalla Vinod Kumar, to the Madras High Court.

The Collegium has also recommended the transfer and repatriation of 21 other High Court judges across the country. These proposed transfers span across the High Courts of Telangana, Karnataka, Madras, Kerala, Andhra Pradesh, Bombay, Delhi, Rajasthan, Calcutta, Allahabad, Punjab and Haryana, Gauhati, Orissa, Madhya Pradesh



and Patna. This is one of the largest proposed shuffle of High Court judges in recent months. The Collegium had recommended five senior High Court judges for appointment as Chief Justices of the High Courts of Madhya Pradesh, Karnataka, Gauhati, Patna and Jharkhand. The Collegium had separately proposed Justice N.V. Anjaria, Chief Justice, High Court of Karnataka; Justice Vijay Bishnoi, Chief Justice, Gauhati High Court; Justice A.S. Chandurkar, judge, Bombay High Court; to the apex court.

New Delhi: Anti-corruption ombudsman Lokpal on Wednesday disposed of complaints alleging impropriety and conflict of interest against former SEBI chief Madhabi Puri Buch based on a Hindenburg Research report, terming the charges as "presumptions and assumptions" not supported by any verifiable material. The Lokpal said that the complaints, including the one by TMC MP Mahua Moitra, filed last year were essentially founded on the report "by a known short seller trader whose focus was to expose or corner Adani Group of Companies". In its report published on August 10, 2024, Hindenburg Research alleged that Buch and her husband had stakes in obscure offshore funds used in the alleged money-siphoning scandal involving the Adani Group.

They had denied the allegations saying the short-seller was attacking the capital markets regulator's credibility and attempting a character assassination. The Adani Group had also termed the allegations as malicious and manipulation of selective public information. In its Wednesday order, the Lokpal "concluded that the allegations in the complaint(s) are more on presumptions and assumptions and not sup-

### **BRS MLC Kavitha charges Congress govt with forcing Gurukul students to clean toilets**

Hyderabad: BRS MLC K Kavitha came down heavily on the Congress government in Telangana, calling it "antipoor" and "anti-Dalit" policies. She was reacting to an alleged audio clip of a senior officer of the Telangana Social Welfare Residential Educational Institutions, could be heard asking teachers and staff to make students clean toilets and manage kitchens.She demanded for the immediate removal of the officer and start releasing the required funds every month to run the social welfare schools effectively.

Sharing the audio clip on X, BRS MLC K Kavitha lashed out at the Congress government, stating that such behavioor is discriminatory, exploitative, and violates basic principles of child rights and dignity. "It only reflects the Revanth Reddy government's contempt for the marginalised," she remarked. The BRS MLC reminded that under the previous BRS regime, each Gurukul school was allocated Rs 40,000 per month for hiring four sanitation workers. These positions were scrapped by the Congress government in August 2023. Moreover, the role of assistant caretakers in 240 schools has reportedly been eliminated, leaving the burden of sweeping, toilet cleaning, and hostel maintenance duties on the students. "Now, the officer is forcing children to clean toilets in schools," she

said, adding that the statements alleged made by an IAS officer, goes against the very concept of establishing Gurukuls to protect students from marginalised communities from caste and class bias. "This is not teaching dignity of labour, but making children work as labourers and indulging in caste-based exploitation," she remarked.Kavitha reminded a recent tragedy in Bhikkanur, Kamareddy district, where a watchman died while cleaning a water tank, and another was seriously injured. "Instead of hiring essential staff, the government is shifting dangerous and degrading responsibilities onto children," she said. She took strong objection to the officer's remarks in the audio clip, stating that just because children at Gurukul schools do not come from posh families, they cannot be treated differently. "Cleaning blackboards in classrooms and common toilets is not same. Will the said officer would make her children clean the common toilets at their school?" she asked.Kavitha argued that Gurukul schools, which were established to empower SC/ST students and protect them from caste discrimination, are now becoming centres of forced labour and humiliation under the Congress government. "We cannot allow institutions meant for social justice to turn into platforms of oppression," she asserted.

Approving the entry of foreign universities into the counry is one of the key areas of educational reforms that is ong overdue. Union Education Minister Dharmendra Pradhan's announcement that 15 foreign universities are expected to establish their campuses by 2025-26 is a velcome development. With the recent approval from the Iniversity Grants Commission (UGC) to establish its first verseas campus in Bengaluru, the UK-based Univerity of Liverpool has joined a growing list of international nstitutions showing eagerness to launch their operations n India. It is the second member of the prestigious Russell Group to launch a campus in India, after the University of Southampton in Gurugram. Two Australian universities ave already commenced operations in Gujarat. Any stablished institution that offers an exceptional learning experience, with a strong research culture, is a welcome ddition to India's burgeoning but flawed educational landcape. In 2023, the UGC unveiled draft norms for allowng, for the first time, foreign universities to set up cambuses in India with autonomy to decide the admission procedure, and fees structure and even repatriate funds back home. Political posturing and fear-mongering had elayed the much-needed reforms. The last attempt, made y UPA-II in 2010 in the form of the Foreign Educational nstitutions Bill, had failed to pass muster in Parliament and lapsed in 2014 because the BJP, which was then in he opposition, had opposed it along with the Left and Samajwadi Party. In power for the last ten years, the safron party has realised the importance of restructuring he higher education sector. Given the inadequate oppornities and poor quality of higher education at hor

Hyderabad: Unseasonal rain and hailstorms have taken a big toll on Rabi crops in the State for the last twoand-half months, from the second week of March to the end of May. The crop losses were extensive in several districts.

Farmers of paddy, maize and mango crops have borne the brunt of the losses. They have reported distress due to premature fruit drop and soaked paddy stocks at procurement centres. Several districts have been impacted, with Siddipet alone seeing nearly 20,000 acres of crop damage following heavy rain on May 4-5. Multiple districts, including Mulugu, Adilabad, Nirmal, Mancherial, Karimnagar, Nizamabad, Kamareddy, Siddipet, Warangal, Hanamkonda, Sangareddy, Medak, Rangareddy, Suryapet, Yadadri Bhongir and Mahabubabad, have reported major losses. Paddy stocks at procurement centres in Mulugu, Jayashankar Bhupalpally, Mahabubabad and even some parts of Suryapet were rendered unfit for sale due to moisture exposure. At some places, even standing crops were flattened by strong winds.

Organisations such as the Rythu Swarajya Vedika and Telangana Rythu Sangham have been making efforts to prevail on the government for a comprehensive enumeration of crop losses and payment of compensation to the affected farmers. But their efforts too did not bear fruit so far. The government had indicated a compensation package at the rate of Rs 10,000 per acre for the affected farmers across 29 districts.But a majority of farmers are not covered in the first spell of the enumeration exercise. The crop losses suffered in the current month are even more extensive. But there is no full-fledged assessment of the damage assessment so far, Rythu Swarajya Vedika leader Kondal Reddy said, stressing that the administration needs to have a serious approach to this issue. Even as the government assured to compensate at the rate of Rs 10,000 per acre, the need for crop insurance must be realised at this stage at least, he insisted. Incomplete surveys and exclusion of tenant farmers have been key issues to be addressed. Farmers, in view of the worst experience they had this year in the absence of prompt response from the government, have been demanding the implementation of a state-backed crop insurance scheme.

### **Chronicling milestones in the wild: The story** of a Telangana forester with a steely resolve

Hyderabad: For someone who has undertaken the arduous task of chronicling some of the milestones, challenges and the occupational hazards of being a forester since the early '50s, K Buchiram Reddy, retired IFS officer, proves that age is just a number when it comes to this documentation, starting with his first one -- 'Forest Martyrs' -published in 2012. The 93-year-old Reddy, a graduate in Science and Law, and a member of the Indian Forest Service, has penned down the challenges and occupational hazards of being a forester since the early 1950s. He was often referred to as an official with integrity and a walking encyclopedia on Forest Law,

Only a few months ago, when his 'Compilation of Legal Notes for Forest Officers' was released by PK Jha, president, Association of Retired Forest Officers of Telangana and Andhra Pradesh, it was a recognition and acknowledgement of his contribution in the field.And, Reddy's latest publication, 'Memorable Musings of a Nonagenarian Forester', released a couple of days ago, is essentially a compilation of his articles over the years and a generous donation to the Telangana State Forest Academy, Dulapally, Hyderabad.

For the record, Reddy is a founding editor of 'Vana Premi', a retired foresters' magazine, which was his brainchild founded in 1994, thanks to the help from selfless officials such as late Narayanaswamy, JV Sharma and late Lohit Reddy.Reddy's autobiography, 'Journey of My Life in The Wilderness' (2013) and 'Oka Vana Premi Jeevana Yanam' in Telugu during the pandemic (2019) were also widely appreciated by family, friends and fellow foresters.

Continuing his steely determination, Reddy came up 'Smaraka Vartha Vahini' in Telugu four years later, on the ghastly murder of FRO Ch Srinivas Rao who was trying to prevent forest encroachment. "I am grateful to Messrs Nagabhushanam and Thirupathaiah, both of whom were my collaborators and esteemed colleagues from the Indian Forest Service," Reddy insists."Those were the days when

### India or the US: Fintech professional's social media post comparing living costs triggers debate

Hyderabad: Given the craze for many Indians to migrate to the United States, the question of is life better in India or in the US has been a long-standing debate. A LinkedIn post by fintech professional Shivani Gera, for the same reason, has gone viral on social media. Gera wanted to say that if one was earning Rs.25 lakh per annum in India, that was like earning Rs.70 lakh to Rs.75 lakh in the US. Attributing this to purchasing power parity (PPP), she claimed this changed everything."If you're earning Rs 25 LPA in India, that's like earning Rs 70-75 LPA in the US. It's due to Purchasing Power Parity (PPP) - and it changes everything. Because it's not just what you earn, it's what that money lets you afford," she said.

Going on, she gave her own version of how this worked out, and reasoned that in India, Rs.25 LPA gave one a lifestyle most people abroad pay a fortune for." A good home, meals out, convenience services, even help at home - without burning out. So next time someone flexes a dollar salary, ask this: What's their lifestyle really like? Because in the real world, how far your money goes matters way more than how big the number looks," she said, also adding that however, her figures did not factor in tax deductions.But even if there were deductions, the core point still stands, she argued, reiterating that PPP wasn't about precise math, but about relative cost of living. Her post triggered mass reactions, literally, with more than 300 people responding to the post on LinkedIn, while several hundreds responded to wherever the same was shared."To be honest, this comparison doesn't really make sense. I've seen many people working abroad in the US or Europe, and they're way ahead of us in terms of savings. My landlord, for example, lives in the US and owns three flats in Bangalore. So if you ever get



the opportunity to move to the US, don't think twice-just go. What you might save in 5 years here, you'll probably save there in just 1-2 years," was how one responded.Another netizen, a United States resident, partially agreed."Even though taxes are high in the U.S., let's assume we save about 50% in India after all expenses, which amounts to Rs.12.5 lakhs. In the U.S., we might save around 35%, which equals Rs.26.25 lakhs. Even then, we have a profit of Rs.13.75 lakhs - and this is a conservative estimate. Then, the work culture in the U.S. and India is completely different. It's well known that in India, employees often work beyond regular hours, whereas in the U.S., that is generally not the case," he said."We often chase the currency without questioning the capacity it offers. Rs.25 LPA in India isn't just a figure—it's access to time, convenience, comfort, and quality of life that many abroad can't afford without serious trade-offs. It's not about how much you earn-it's about how much life your money can buy," said another.

### **British American Tobacco sells 2.5 per** cent stake in ITC for Rs 12,927 crore

New Delhi: British multinational BAT Plc on Wednesday trimmed its ownership in conglomerate ITC by divesting a 2.5 per cent stake for Rs 12,927 crore (USD 1.51 billion) through a block deal, according to a revised term sheet accessed by PTI.Following the stake sale, shares of ITC went lower by 1.15 per cent to trade at Rs 421.15 apiece on the NSE. British American Tobacco (BAT), through its arm Tobacco Manufacturers (India) Ltd, sold the stake in Kolkata-based ITC.Before the latest transaction, BAT through its affiliates - Rothmans International Enterprises, Mvddleton Investment Company and Tobacco Manufacturers (India) Ltd - owned a combined 25.44 per cent stake in ITC Ltd.

Following the completion of the block trade, BAT will remain a significant shareholder of ITC, with less than 23 per cent stake in FMCG-to-hotel conglomerate ITC.As per the latest block deal, up to 31.3 crore equity shares of ITC were sold at a final price of Rs 413 per share. This represents a discount of about 4.8 per cent to ITC's closing price of Rs 433.90 on the National Stock Exchange (NSE) on Tuesday, as per a revised term sheet seen by PTI.

Goldman Sachs (India) Securities Pvt Ltd and Citigroup Global Markets India are the placement agents for the transaction, sources said. The total number of shares has been raised from the initial 290 million (29 crore shares) as mentioned in the earlier term sheet. The sources said 31.3 crore shares amount to around 2.5 per cent stake in ITC, and the offer size, based on the final price, is pegged at USD 1.51 billion or about Rs 12,927 crore. The shares sale executed through multiple tranches on the BSE and NSE under the bulk sale route. The share sale is entirely secondary in nature, meaning that ITC will not receive any proceeds from the deal, and the stake is being sold solely by the Tobacco Manufacturers (India) Ltd. The seller and



stakes in ITC Ltd. The transaction will provide BAT with increased financial flexibility as it delivers on its commitment to invest in transformation, deleverage and sustainable shareholder returns.BAT's initial investment in ITC dates back to the early 1900s, and the two companies have a longstanding, mutually beneficial relationship. ### Rowdy sheeters turn to ganja trade in Hyderabad as lucrative drug business attracts hardcore criminals

GNS News Agency, May 28Hyderabad: With the law and with help of his associates was smuggling ganja to the enforcement agencies tightening its grip over the notorious ganja smugglers and peddlers, and trade on other hand being lucrative, a new set of criminals are trying to make their way into the illegal yet 'profitable' business. The emerging trend is of rowdy sheeters, who are basically involved in robberies, murders, dacoities, extortion and property offenses, turning to ganja business. In the last two months, the Hyderabad police caught eight rowdy sheeters who were actively pursuing the weed business. Hyderabad: Notorious chain snatcher, ganja smuggler Syed Sayeed Hussain alias Lamba arrested with associates

In mid May, the Special Team of the Detective Department seized 21 kg of ganja from Syed Sayeed Hussain alias Lamba and his four associates. A notorious chain snatcher Lamba, is involved in more than 250 offenses. "Lamba came in contact with some persons from Nagpur

city," said D Bikshapathi, Inspector Special Team.In April, the Task Force (west) team caught Mohammed Sofiyanuddin (24), a rowdy sheeter of Masab Tank police station, and seized 2 kg of ganja. Sofiyanuddin along with his three other associates brought the ganja from Taj Bagh Darga in Nagpur. The ganja is routed to Nagpur from Odisha and Andhra Pradesh. "Rowdy sheeters while in the jail are coming in contact with ganja smugglers and peddlers. After coming out of the jail, they are sourcing the weed as they see huge money in the business," said an official of the Task Force.Ganja is sourced at Rs. 4000 to Rs. 7000 a kg and is sold at a price of Rs. 20,000 to Rs. 25,000 a kg in loose quantity to customers. The huge profits are luring the rowdy sheeters who are no novice to the crime world into the trade. Almost eight of ten rowdy sheeters are addicted to some form of drug abuse.

Pro-Kannada groups demanded an apology from Kamal Haasan even as they held protests in Bengaluru and Belagavi against the actor for hurting the Kannada sentiments. Angry fans on social media threatened to boycott the movie, set to release on June 05, 2025. Addressing the row, Karnataka chief minister Siddaramaiah told reporters that "Kannada language has a very long history...he (Kamal

Haasan) doesn't know."The BJP too joined the backlash, demanding an apology from the star. Karnataka BJP president B.Y. Vijayendra condemned Kamal Haasan's remarks as "uncultured" and "insulting" to Kannada and its 6.5 crore speakersKamal Haasan, addressing the media in Thiruvananthapuram as part of the film's promotions, said people "have confused the issue." "My statement was said out of love," said the National Award-winning actor. He added that politicians "are not qualified to talk about it" (history of languages). "They don't have the education to talk about it, including me. Let's leave the discussions to historians, language experts, and archeologists. People will take care of Thug Life and Kamal Haasan," he said. Speaking about his controversial statement, Kamal Haasan said, "It was a statement of love to Mr Shivanna (Kannada star Shivarajkumar). His father (Dr Rajkumar) is like my father. We are a family, and so are the other languages."If you look at it from the Northern point of view, what they say is right. If you look at it from Thenkumari, then what I say is right. There is a third angle to it, that's where the language experts come into play.



### **Over Rs 3.17-crore 'fraud': ED searches residence of Bajwa Developers' chief**

The Enforcement Directorate (ED) conducted a raid on the residence of Jarnail Singh Bajwa, owner of Bajwa Developers, on Wednesday afternoon in Mohali in connection with a financial fraud amounting to approximately Rs 3.17 crore. According to officials, the ED had obtained permission from the Mohali District Court in April to interrogate Jarnail Singh Bajwa. Following this, ED officers visited him at Ropar Jail for questioning. Based on the information gathered during that session, the agency launched a raid today at his Mohali residence.

The ED had initiated an investigation against Jarnail Singh Bajwa, Managing Director of Bajwa Developers, based on multiple FIRs filed by Punjab Police under various sections of the Indian Penal Code (IPC), 1860. The investigation revealed that Bajwa was allegedly involved in a financial fraud amounting to approximately Rs 3.17 crore. The scam includes charges of collecting money from unsuspecting buyers without allotting plots and registering the same plots in the names of other individuals. In 2023, the ED had already begun probing Bajwa under the Prevention of Money Laundering Act (PMLA) and had attached assets worth Rs 54.16 lakh, which were later seized.

## Reduced supply, muddy water: The reality of 24×7 water access project hits hard months after launch in Manimajra

Despite the launch of a 24×7 water supply pilot project in Manimajra aimed at ensuring round-the-clock water access, residents are facing increasing difficulties due to reduced water pressure and limited supply.The severity of the crisis can be understood from the fact that even residents of Indira Colony are grappling with the problem of muddy and discoloured water.To provide uninterrupted water supply to households in Manimajra, the UT administration had launched a 24×7 water supply pilot project in August last year.

Initially, residents welcomed the move with the hope that water would now reach every floor of their homes without the need for motor pumps. However, since the project began, residents are complaining of severe water shortages.Naveen Sharma, a Manimajra resident, said that previously, residents used to receive water for 3 to 4 hours every morning and evening, which they managed with motor pumps.But now, even motor pumps aren't sufficient, and water reaches only limited parts of homes. "The summer season has further intensified the crisis. Under the project, canal water was supposed to be stored in two underground

reservoirs (UGRs) with a total capacity of 4 million gallons, built opposite Shivalik Garden. This stored water was meant to be distributed with adequate pressure across Manimajra. However, due to limited canal water availability, the system is running on reduced capacity," added Sharma.Pooja Bhajni of Dhera Sahib, Manimajra said that initially when the project started, water used to reach even the fourth floor of buildings without any motor.Now, water doesn't even reach the first floor. She said his neighbours are also facing severe shortages and despite repeated complaints, project plumbers only inspect the water meters and pipelines without resolving the core issue. In Indira ColonyIn Indira Colony, residents are dealing with a different but equally troubling issue — muddy and contaminated water. According to Subhash Dhiman, chairman of the Indira Colony Welfare Association, houses in the area are receiving muddy water. However, Colonel (retired) Gursewak Singh, President RWA of Modern Housing Complex, said the situation is better than earlier, there is improvement in the water supply after the 24×7 water supply pilot project. On the muddy water sometimes in the area, he said that the internal pipes were though replaced with new ones by the authorities concerned, but at few areas the main pipes have not been replaced — which are nearly 25 years old — and when they are to be repaired sometimes, the ground has to be dug, to reach to the pipes and in the process, certain amount of mud goes in water, and then for sometime the supply of water gets muddy. The problems related to water supply are occasional, the Colonel (retired) added.Mayor Harpreet Kaur Babla, however, said that the issue was raised before the Municipal Commissioner too. The expert teams are working on the problem, and soon the issue will be resolved, she added. Residents, however, remain dissatisfied and are urging the administration to take immediate action to restore clean and adequate water supply across Manimajra and Indira Colony.

### **'Prof Jayant Narlikar believed in nurturing children with love of science from young age': Educator remembers astrophysicist**

GNS News Agency, May 28 Astrophysicist Prof Javant Narlikar believed children should be nurtured with the love of science from a yound age, and he realised his dream to set up a children's science centre at the Inter-University Centre for Astronomy and Astrophysics (IUCAA) in Pune in 2004, said Prof Arvind Gupta, a science educator and toy inventor. Prof Gupta, 71, a Padma Shri awardee, well known for turning trash into toys that children can make themselves while learning the basic principles of science, recalled his association with Prof Narlikar, who passed away at the age of 86 Tuesday. His mortal remains were kept at the Bhaskara foyer at IUCAA Wednesday morning for the public to pay their final respects. "In 2003, I was invited by JVN (Prof Narlikar) to work in the IUCAA's children's science centre (Muktangan Exploratory Science Centre). Initially, I was reluctant to work in a government institute. But JVN assured me that I could help shape the science centre, and if I did not like it, I could quit after six months. So, I initially joined for six months, but ended up working there for 11 years," he said.Prof Narlikar was the founder-director of the IUCAA in Pune and was known for his seminal works in cosmology and most importantly, for believing in an alternate model to the popular Big Bang theory for the origin of the universe. In 1988, Prof Narlikar founded the IUCAA within the Savitribai Phule Pune University (SPPU). Professor Narlikar was India's most celebrated astrophysicist, having received the second highest civilian award, the Padma Vibhushan in 2004. Two decades earlier, he was honored with the Kalinga Award, UNESCO's highest recognition for science popularisation. A large donation from Sunita Deshpande, the wife of his late friend Pu La Deshpande, a cultural icon of Maharashtra, turned this dream into reality and the children's exploratory science centre was inaugurated in 2004 by Prof Yash Pal, a fellow Kalinga awardee who shared his vision of science."Right from its inception, IUCAA had an active public outreach programme. Every second Saturday, there was a popular science lecture/demonstration for some 1,000 students and teachers from over 100 schools in Pune. This tradition still continues. JVN started the students' summer internship programme. During summer holidays, children would work with scientists on some projects. That gave children a feel for what goes into doing science," Prof Gupta said Prof Gupta also spoke about Dr Vidula Mhaiskar, who is now with Garware Bal Bhavan, Pune; and Ashok Rupner, now with Indrani Balan Science Centre, IISER, who had joined him at IUCAA's children's science centre."In 2004, we set up the popular website arvindguptatoys.com. We started uploading science projects - photographs, videos, and popular books on the website. We made over 8,700 videos in 15 languages and uploaded them on YouTube. We had 3.7 lakh subscribers, and we were the secondlargest YouTube channel from India at one stage. Today, 12 crore children worldwide have viewed our 2-minute 'toys from trash' videos," Prof Gupta said.Dr Gupta also recalled that the anti-superstition activist Dr Narendra Dabholkar often collaborated with Prof Narlikar. "Prof JVN was a renaissance scientist. He wrote prolifically in his mother tongue, Marathi, and was a pioneer of science fiction writing. He was a rationalist and consistently debunked pseudoscience. Dr Narendra Dabholkar often collaborated



### Amid Punjab-Haryana standoff, Centre clears 296 CISF personnel for Nangal Dam security

The Centre Wednesday sanctioned a contingent of 296 armed CISF personnel for providing security cover to the Nangal Dam, the move coming on a day when the ruling Aam Aadmi Party (AAP) in Punjab organised a Fateh (victory) Rally for not letting extra water to flow to Haryana till May 20.

Meanwhile, water was released from the dam to Haryana as fresh distribution cycle kicked in Wednesday. The Bhakra Beas Management Board (BBMB), which regulates the water quota, in a meeting last week decided that Punjab will get 17,000 cusecs, Haryana 10,300 cusecs, and Rajasthan 12,400 cusecs of water in the new distribution cycle that will remain in effect till May 20, 2026. In a communication to BBMB, the Union Ministry of Home Affairs said that 296 posts of CISF personnel have been created for manning the "Bhakra Dam Project, Nangal (Punjab)". The has been asked to provide boarding, lodging and other logistics for the personnel.

The communication has quoted a security deposit of Rs 2,90,100 per head and has asked the BBMB to transfer Rs 8,58,69,600 (for 296 personnel) to CISF headquarters.Punjab will also have to bear part of the cost of deployment, being a partner state of BBMB.Meanwhile, the AAP workers who had been staging a sit-in at the Nangal dam, situated downstream of the Bhakra dam, for the past 20 days to prevent release of extra water to Haryana, lifted the 'dharna' after Chief Minister Bhagwant Mann reached there and addressed the Fateh rally.

Mann said the he will flag the issue of reconstitution of the BBMB in the meeting of Niti Aayog, to be chaired by Prime Minister Narendra Modi and slated for Saturday. Mann, who has chosen not to attend Niti Aayog meetings in the past, he will attend the meeting this time and flag the issue.He said as the level of water is changing frequently, every water agreement should be reviewed after every 25 years. Punjab is a landlocked border state which has already over explored its only available natural resources in terms of water and fertile soil to feed the country, he said.Mann bemoaned that the manner in which BBMB "became a party to snatch" the legitimate share of waters of the state was unfortunate and highly condemnable. He said Haryana exhausted its share of water in the March, but the BBMB acted as a "puppet of the Centre and Haryana government" to "snatch" Punjab's waters. Mann said, in an unprecedented manner, BBMB chairman Manoj Tripathi himself came to Nangal to "steal" the state's share of water, a move which was "thwarted" by the people of the state.Centre's move to deploy CISF comes days after Tripathi was locked up at BBMB rest house in Nangal. He was released after the intervention of Punjab Police.Mann said that new cycle of water has now begun but water will be released to Harvana only after releasing 3.000 cusecs for Punjab farmers."I again want to ask Haryana officials to use water judiciously. Do not expect more water from Punjab," Mann said, adding Haryana was allocated 15.06 lakh cusecs of water in the previous water cycle but it utilized 16.48 lakh cusecs.

Mann claimed that the BBMB, which had taken Rs 32 crore from Punjab for its very existential projects, never returned the money.Punjab is owed nearly Rs 150 crore from BBMB, he claimed, adding that the state government will soon stake a claim for recovery of this money.The CM called BBMB a "white elephant" and termed it unacceptable in the present form.He said 3,000 posts of Punjab's quota have deliberately not been filled by BBMB so as to "weaken" the state's claim over the waters.Mann said even the townships like Nangal that were aesthetically designed, have been "ruined" due to the "neglect" of the BBMB.He said Punjab has a glorious history of making sacrifices to protect the 553 kilometres long border with Pakistan.

He said this time Punjabis were at the forefront while giving a befitting reply to the Pakistani Army and on the other hand they saved the share of their water too. He said that for years, Punjab's water has been diverted to other states through the BBMB adding that hands of Congress, Akalis and BJP were drenched with blood of Punjabis as these parties have backstabbed them by ignoring the water rights of the state for vested interests. He said that a former Chief Minister got a plot in Gurgaon, where they have a hotel now, for planning the Sutlej Yamuna Link (SYL) canal and issuing its survey order.Mann also said that self proclaimed savior of Punjab waters and former chief minister had presented silver spade to the then Prime Minister for the ground breaking ceremony of SYL at Kapoori.Mann said that despite being smaller in area, Haryana is getting more water than Punjab.Today, nearly 60 per cent of the state's farmlands are irrigated through canals, which makes every drop of Punjab's water extremely valuable, he said.On the occasion Cabinet Minister Harjot Singh Bains welcomed Mann and other dignitaries. Meanwhile, Cabinet Minister Barinder Goyal thanked all the dignitaries and people who had attended the rally.

### YouTuber Jyoti Malhotra was in contact with people knowing that they were Pak intel operatives: Haryana Police

The Harvana Police Wednesday said that till now no such fact has come to light to show that YouTuber Jyoti Rani Malhotra had access to any military, defence or strategic information or that she was in contact with any terrorist organization. The 33-year-old vlogger from Haryana was arrested on May 16 for allegedly spying for Pakistani intelligence agencies. Hisar Superintendent of Police Shashank Kumar Sawan said that the accused was in contact with some people knowing that they are Pakistan Intelligence Operatives (PIOs). "But till now no such fact has come to which can be said that the a contact with any terrorist organization. No fact has come to light so far regarding the accused's involvement in any terrorist incidents," added the SP. The SP said the police seized three mobile phones, a laptop and some other electronic devices from the accused.

From TDI to Aerocity, residents face daily power outage this summer

Unscheduled power cuts have left Mohali residents in a lurch with temperatures soaring over 42°C. Areas like TDI City (Sectors 117, 118, 119, 74A, and 92) are facing daily outages, especially at night, leaving hundreds sleepdeprived and frustrated. The TDI Residents' Rights Protection and Welfare Society has submitted a complaint to PSPCL and local authorities, demanding urgent intervention. It highlights recurring issues like transformer failures, cable faults, and feeder overloads, claiming conditions are worsening. However, the crisis is not limited to TDI, Aerocity, New Sunny Enclave, Phase 9, sectors 80, 66, 67, and 68 are also battling 2-3 hour daily cuts. In rural areas like Balongi, Bar Majra, Jujharnagar and Badi, residents report going entire days without power. Office-goers in phases 7 and 8 say even inverters can't keep up.A senior PSPCL official blamed it on overloaded grid stations in Phase 9, Sector 80, Industrial Area Phase 7, and Sunny Enclave. The official said power cuts are inevitable, also citing the ongoing staff strike, which is delaying fault repairs, worsening the crisis

Along with this, Harkirat, a resident of Kurukshetra, was also called for questioning. Harkirat provides visa services. Police seized two mobile phones from Harkirat. "No facts have yet emerged about the accused having access to any military, defence or strategic information. In-depth analysis of the accused's 4 bank accounts is going on. No comment can be made about the money transactions as of now," he added.

Malhotra has a YouTube channel called Travel with Jo with over 3,77,000 subscribers and an Instagram account with over 1,32,000 followers."She visited Pakistan multiple times and also went to China once. We are analysing her financial transactions and travel details. She was in touch with PIOs (Pakistan Intelligence Operatives). She did not



have direct access to military or defence information, though Hisar is a strategic location," the SP had stated earlier.Sawan said one of her Pakistan visits was "sponsored". "She met some high-profile persons during the visit. Why and what information was shared; all these things are being probed."The police also said she possibly "fell into a trap for views and likes" and "her travel details show more expenses than her known sources of income".

Malhotra is among 12 people who have been arrested from Punjab, Haryana and Uttar Pradesh over the past two weeks on charges of espionage, with investigators suspecting the presence of a Pakistan-linked spy network operating in north India.Meanwhile, YouTuber Navankur Chaudhary, another person under scrutiny for espionage, has said that he was ready to fully cooperate with any investigation agency and asserted that a fake narrative was being spread against him. Chaudhary, who hails from Rohtak, has also claimed that Malhotra had met him as a fan at an event at Pakistan High Commission."I did not know Jyoti personally before that day. I had never met her earlier," he said. In a video on X, Chaudhary, who runs the YouTube channel 'Yatri Doctor', said he has visited Pakistan just once. His father said on Wednesday, "A media trial is going on. Our entire family is going through a tough time. I am a bank employee, but have been unable to attend office due to this. Both me and his (Navankur) mother have not had food for the past two days." The man added, "So far, he has visited 144 countries and his objective is to visit the entire world and he visited Pakistan once. At present, he is in Ireland.

### TTD to employ AI, facial recognition tech to enhance pilgrimage experience

Tirupati: The Tirumala Tirupati Devasthanams (TTD), the official custodian of the famous Venkateswara temple here, is exploring the use of Artificial Intelligence (AI) and facial recognition technology to enhance the pilgrimage experience, said an official on Thursday.TTD executive officer (EO) J Syamala Rao said the temple body will employ these technologies to authenticate genuine pilgrims for ensuring a smooth darshan (visit to deity), prevent impersonation and fraudulent activities and ease accommodation. access control and other operations."TTD envisioned adopting the latest technological solutions available in the market including Artificial Intelligence to improve the overall pilgrimage," said Rao in a press release. As part of these futuristic initiatives, the EO said pilgrims will be provided with time slotted darshan tokens, which will capture their facial features using facial recognition technology.On capturing a pilgrim's image, he said it will be sieved through data from the past 30 days or about 10 lakh images to root out duplicate bookings and thereby enable servicing more number of pilgrims.By implementing this solution, token issue and

verification process becomes quick and hassle-free while impersonation and fraudulent activities can be prevented, said Rao. Al and facial recognition technology are also contemplated to track pilgrim numbers at various locations such as queue lines, compartments and inside the Tirumala temple, among others. The installation of AI-powered facial recognition cameras are expected to power this facial detection, said Rao. "This solution leverages TTD management to exactly assess the probable darshan time expected for the pilgrims who are waiting and also can assess the darshan time for pilgrims joining queue lines," he said. Powered by this tech, the temple body will be equipped to notify pilgrims of the expected darshan time so as to empower them to properly plan their pilgrimages.Installed across darshan paths in the temple, TTD can estimate the time taken to complete darshan under various categories and also fix gaps in operations. Further, AI and facial recognition cameras will come in handy to track and identify intruders in Tirumala at exact locations. Eventually, the EO observed that facial recognition technology will be extended to all possible TTD services.

### Never misbehaved with any woman: Principal suspended for 'misbehaving' during Singapore tour pleads innocence

Placed on suspension on Monday for his alleged misbehaviour with a lady tour guide during a visit to Singapore for an official teachers' training programme, the accused principal of a Fazilka school has pleaded his innocence. "I am being defamed without knowing details of the full incident. As a teacher, I never think of misbehaving with a woman."Speaking to The Indian Express, Gautam Khurana, principal of the School of Eminence, Jalalabad, Fazilka district, said that he had only objected to an extra class on Chinese language, because even teachers had undergone an eight-hour-long full-day exhaustive training session. "Just because I objected to an extra class after a full-day exhaustive training session from 9 am to 5 pm, as I was feeling nauseous and tired, it has been projected as misbehaviour with a lady guide. I did not even speak to the tour guide directly.'

According to the suspension order, the action was being taken as Khurana "misbehaved with a lady tour guide during the teachers' training programme in Singapore". The suspension order by Mitra came close on the heels of Punjab Director of Education (Secondary) Gurinder Singh Sodhi's May 9 order, stating that Khurana was "being let off with a stern warning to be careful in future after he replied to the show-cause notice and the matter was being treated as "daakhil daftar" (meaning no further action will be taken on it)". The suspension orders went viral on social media.

"We went to Singapore in March," Khurana told The Indian Express. "On that day, we had a 9 am to 5 pm training session. In the evening, we were taken on a jungle safari. All teachers were exhausted. On the way back from the jungle safari, our bus broke down. Within a few minutes, the atmosphere inside the bus turned humid, and I started feeling nauseous. In such a situation, some teachers started requesting the tour guide, a Singaporean, to teach them the Chinese language. It continued for some minutes, but some teachers, like me, sitting in the back seats, got irritated. I objected to it and said that when we had already completed the day's training, why were we taking an extra class on Chinese on the bus? That's all," Khurana said."I commented on teachers, not the lady guide. I did not speak to her directly, but the SCERT director, Madam, who was leading us, objected and asked, 'Who said this?' I got a little scared and realised I should not have said this. Since I was feeling nauseous, I moved out of the bus and started moving around to feel better. As the new bus came, we reached the hotel, and no discussion was held that day. I did not misbehave with the guide even once," Khurana claimed.Khurana said the next day, the matter was again raised by the SCERT director and some teachers, stating that the incident should not have happened. "I immediately sensed the gravity of the situation and apologised to the SCERT director and the entire group of teachers. I told them that I never meant to hurt anyone and had only objected to the extra class as I was feeling unwell, suffocated and nauseous in that broken bus. As we returned from the tour. I received a show-cause notice on March 25, to which I replied," Khurana said. "The lady guide has not filed any complaint against me, and I did not speak to her directly. So, how could this be misbehaviour with her," he questioned.

Notably, Government Senior Secondary School (Boys), Jalalabad, is now a School of Eminence, headed by Khurana as the principal. However, the secretary's suspension order avoided mentioning the School of Eminence and addressed Khurana as the principal of GSSS, Jalalabad. "This was possibly done to avoid tarnishing the image of the Aam Aadmi Party (AAP) government's ambitious School of Eminence project," said a teacher.Khurana said that he was shocked to see the suspension order giving "misbehaviour with a lady guide" as the reason for his suspension. "As a routine practice, the reason for suspension is never mentioned in the letter until the inquiry is completed and the chargesheet is not issued. I have been declared an accused without a chargesheet. I never misbehaved with any woman. Expressing one's discomfort and health issues is not misbehaviour. Despite that, I apologised," he said."There is not a single blot on my teaching career. I have earned this respect by sheer hard work. I don't have any political connections to save myself," he added.Mitra, however, said the action against the principal was initiated based on the complaint received from the SCERT director.

## FOSTTA's application receives over 3,000 complaints on default payments within a month of launch

FOSTTA app receives over 3,000 complaints on default payments within a month of launchAs per the complaints received on the app, buyers allegedly defaulted on payments amounting to a total of Rs 170 crore. The Federation of Surat Trade and Textile Association (FOSTTA), which had launched a mobile application, FOSTTA FORUM, to register complaints from traders who have been cheated or have their payments due from buyers, has received over 3,000 complaints within a month of the launch, it said As per the complaints received on the application, buyers allegedly defaulted on payments amounting to a total of Rs 170 crore. The association also said that it has hired 20 college students as telecallers who will be trained to and tasked with resolving various issues faced by complainants.

The application was launched around 30 days ago to control the menace of fly-by-night firms, which default on payments.



GSTN and address, and also submit details of the firm and owner who default on payments. The complainant also has to upload the details of textile fabrics sold and the amount due from buyers."As per sources in FOSTTA, textile factory owner Surat Harsh Hakim received a call through a broker who wanted to purchase grev bales (each bale consists of 100 metres of unprinted fabric). The broker introduced Hakim to a buyer, also a textile trader from Surat. The buyer placed an order for around 20 grey bales. Hakim, who had already downloaded FOSTTA FORUM application on his mobile phone, entered the name of the buyer and found that different textile traders from Surat had registered three complaints of "default payments" against his firm on the app. Hakim cancelled the order and shared details of the buyer firm with the FOSTTA office. "Once the complaints are generated, our team gets in touch with the buyer firm, which has allegedly defaulted on a payment and tries to resolve the issue through conversations. Over 80 per cent of such issues are generally resolved through conversations. Complaints which are not resolved have to go to arbitration. Out of the 3,000 complaints, which have been received in a month, we have resolved 20, and working on around 300 others," Hakim added. Talking about the college students hired as telecallers, Hakim said, "We will pay them based on the hours they work. We will train them, starting Thursday. We have selected these students after visiting different colleges. Once a defaulter receives a call from FOSTTA, he would surely want to mutually settle the matter. We are short of hands, and once these students start working, they will be able to work on more pending complaints.'

#### UT Excise Dept registers 35% surge in revenue, earns Rs 526 crore from liquor contracts so far

The UT Excise and Taxation Department has achieved 35% increase in revenue from liquor contracts this year, with Rs 526 crore from the auction of 85 vends so far - a significant rise compared to Rs 413 crore earned during the same period last year. The jump comes after key policy changes introduced in the new excise policy, which officials say have helped drive the surge. The department is in the process of auctioning 97 liquor contracts for the current fiscal.With 85 vends already sold, the administration is optimistic about crossing Rs 600 crore in total revenue - a near 50 per cent increase over last year's earnings. This increase in revenue marks a sharp departure from the previous two years, where the growth had remained limited to just 6-7 per cent annually. The excise department attributes this success to strategic changes in its policy framework, which included revised reserve prices, flexible payment terms, and streamlined auction processes to attract more bidders.Meanwhile, the department has faced challenges in the ongoing sixth round of e-auctions. In the latest round held on Monday, only one out of the 11 liquor vends up for auction managed to find a bidder. The vend, located in Industrial Area, Phase I, fetched Rs 4.50 crore against a reserve price of Rs 4.38 crore.

On May 14, during the fifth round of e-auction, only six out of 17 vends were successfully auctioned, generating Rs 39.60 crore against a reserve price of Rs 24.32 crore.

## Visitor visa approvals to Canada pick up under new govt, tourists from Punjab heave a sigh of relief

From July to August of last year, there was a surge in refusals, even for well-qualified individuals—professionals, government officials, and those with substantial financial



The highest bid came in at Rs 10.95 crore for the Sector 22-C market vend, followed by Rs 10.50 crore for the vend opposite the Sector 17 bus stand, and Rs 6.21 crore for the Sector 40-C vend.Earlier, in the fourth round held on May 8, the department auctioned 11 of the 21 vends, collecting Rs 60.76 crore. In the third round on April 29, only 7 out of 28 vends were sold. On April 21, the department re-auctioned 48 vends — previously cancelled due to non-payment of guarantees — and sold 20, earning Rs 131 crore. The initial auction held on March 21 had seen a high success rate with 96 out of 97 vends allotted, raising Rs 606 crore. However, 48 licences were later cancelled, and the department recovered Rs 23 crore by forfeiting earnest money and security deposits from defaulters.



Sources in the textile industry say there are over 170 textile trading markets in Surat city, with 30,000 traders having Goods and Services Tax Number (GSTN) and others who run businesses without it. The FOSTTA, which has around 1,100 registered members from Surat, also started an awareness drive to get textile traders in the city registered on FOSTTA FORUM.Talking about the application, FOSTTA President Kailash Hakim said, "Every year, the textile industry faces losses worth hundreds of crores due to fly-by-night firms who default on payments to textile traders, weavers, embroidery unit owners, and dyeing and printing factory owners. The firms purchase finished and unfinished (unprinted) fabrics from traders and default on payments. Out of 100 such firms, over 70 are from other states, and the rest are locals. We have tied up with 146 'kapda mandis' across the country so that the cross-verification of textile businessmen from other cities and states can be done. We will also ask the textile traders of these 'kapda mandis' to download FOSTTA FORUM.

### Sons held in MGNREGA 'scam' | 'Preparing for PM's Dahod visit': Minister Khabad explains absence from Cabinet meeting

Gujarat Minister of State Panchayat and Agriculture and MLA from Devgadh Baria in Dahod district, Bachubhai Khabad, who is facing the heat after the arrest of his two sons - Balvantsinh and Kiran - for their alleged involvement in a Rs 71 crore MGNREGA scam, earlier this week, clarified that he had skipped the weekly Cabinet meeting presided over by Chief Minister Bhupendra Patel as he was busy in making arrangements for the upcoming public meeting of Prime Minister Narendra Modi in Dahod district. Khabad added that he had 'sent a report of absence' to the CM in this regard. In a video statement recorded at his office in Dhanpur, in Dahod, by his aides and circulated on social media platforms, Khabad Wednesday lashed out at "critics for accusing him of being underground" due to the ongoing investigations against his sons.Khabad said, "Prime Minister Narendra Modi is arriving in Dahod on May 26 and so I did not attend the Cabinet meeting (in Gandhinagar). I am here to hold meetings in Devgadh Baria, Dhanpur and Dahod to ensure numbers... and arrangements for the Prime Ministers' event".

"I will be visiting the venue (of the public address)... I have even given my report of absence to the Chief Minister

Visitor visa approval rates have improved in the past few months since the new government was expected to take charge. Visas are now being processed faster compared to previous timelines. "From April 28 to May 15, I received four visitor visa approvals. In one case, there were three refusals in the past, but this time, visa approvals came within two weeks after application," said Tirath Singh of Pinnacle Immigration in Jalandhar. He added that since the new government took office, visitor visa approval rates have increased by about 50 to 60 per cent, reversing the sharp declines seen last year. From July to August of last year, there was a surge in refusals, even for well-qualified individuals-professionals, government officials, and those with substantial financial assets-without clear reasons for the rejections."The change, however, came with the arrival of the new government, which has worked to alleviate some of the frustrations caused under previous policies. Under the leadership of the current government, the visitor visa process has improved, reversing long delays and rejections without explanation," said Tirath Singh.

Gurpreet Singh of iCan Immigration Consultancy noted that the success rate for visitor visas has improved in recent weeks, now hovering around 50 per cent. "We hope this will continue to improve. The new government has focused on streamlining visa processing times, which has allowed for a smoother experience for applicants," he added.Experts point out that while it is still early to make definitive conclusions, they believe the new government's policies strike a better balance between controlling immigration and fostering global tourism, something that was increasingly difficult under the previous administration. As a result, the system is still selective but more predictable, with fewer unexpected rejections and clearer reasoning. Experts also suggest that Indian applicants who are granted visitor visas should avoid overstaying in Canada and ensure they leave before their visa expires. This will help maintain a good record for Indian tourists and further

improve the approval rate for visitor visas. Experts also caution applicants against illegal employment and ask them to clearly state their intent to return after their visit. They also advise that visitors should not use Canada as a gateway to the United States. The decision to discontinue the automatic 10-year tourist visas is still in effect, but experts believe that the new government may lead to an improved success rate for the six-month tourist visas.

### Indian man stabs another Indian in Texas for "resembling his uncle"

Hyderabad: A 30-year-old Indian was stabbed to death by another Indian man in a public bus in Austin, Texas.

According to the Austin Police Department (APD), the victim, Akshay Gupta, was travelling in a bus on the evening of May 14, when he was stabbed by a fellow passenger, later identified as Deepak Kandel, 31.

APD said its officers and emergency medical services responded to a "Shoot/Stab" call of someone being stabbed on a CapMetro bus in South Lamar Boulevard. When officers arrived on the scene, they located Gupta with trauma to his body.

Though life-saving measures were attempted, Gupta was pronounced dead on the scene at 7.30 pm. Investigation revealed that Kandel was sitting next to Gupta on the bus when, without provocation, he stabbed Gupta in the neck.

"Once the bus stopped, Mr. Kandel calmly exited the vehicle with the other passengers. APD patrol officers were able to locate and detain Mr. Kandel a short time later," the APD statement said.

Kandel then admitted to stabbing "Gupta due to him resembling his uncle." He was booked into the Travis County Jail and has been charged with 1st Degree Murder.

According to local media reports, Gupta had graduated from Penn State University, and was an entrepreneur on O1 visa (given to extraordinary individuals). His LI profile shows many laurels, reports said.Kandel was identified as a "homeless man", with previous criminal records.

## Multilingualism key to preserving linguistic diversity

Language domination and linguistic imposition have always been an issue of political debate in India. In a linguistically diverse country, such debates are inevitable. However, the concern is not the debate itself but its nature. The current discourse on language debate gives an impression that the debate is not towards promoting regional languages but creating conflict between the various linguistic identities. Most of the commentary expressed apprehension regarding the growth and survival of regional languages with the imposition of Hindi. However, both perspectives are misplaced. First, there is no explicit policy or attempt to promote Hindi at the expense of regional languages. Second, concerns about the survival of regional languages with Hindi's expansion lack empirical support — census data do not indicate a decline in the number of regional language speakers

Language is the primary means of communication, and individuals often learn languages other than their mother tongue to facilitate broader interactions. In a linguistically diverse country where States and regions are identified based on specific language, the mother tongue differs from one place to another. Learning an alternative language suitable for communication becomes important with the evolving reality of the rising mobility of individuals from their State to another in search of livelihood and various other reasons. However, as inter-State mobility increases due to economic opportunities and social factors, learning an additional language becomes essential. Now the issue is that if a person moves to a place where her mother tongue is not spoken, which language should she learn? A person who frequently moves across States or regions is likely to learn a language widely used for mass communication. Alternatively, she may choose to learn the local language of each new State if she stays for a longer stint.

Major spoken languagesHindi and English are the two most spoken languages in India. According to the 2011 Census, Hindi was the mother tongue for 528.3 million people, which constitutes 43.6% of the population of the country. In addition, 138.9 million people reported Hindi as their second language of communication and 24.3 million as the third language. Overall, 691.5 million people, or 57.1% of the total population, can communicate in Hindi. In 2011, only 2,59,678 people reported English as their mother tongue, but there are 128.5 million people speaking English as second or third language, constituting 10.6% of the total population of the country. Since English is the medium of higher education in India, nearly all academic activities, such as writing research papers and participating in seminars and conferences, use English as the mode of communication. However, this remains limited to the educated class and does not serve as a popular means of communication.Language adoption

The Census estimates indicate that the percentage of bilingual and trilingual speakers is significantly higher among individuals residing in States where the native language differs from their mother tongue. For instance, 37.5% of Assamese residing in Assam know a second language. However, this percentage rises to approximately 71% when they live outside Assam. Similar trends are observed for other languages, such as Bengali (10.8% vs 54.2%), Gujarati (39.8% vs 83.5%), Punjabi (47.6% vs 70.8%), Hindi (8.3% vs 51.2%), Kannada (23.1% vs 73.4%), Malayalam (23.4% vs 80.7%), Tamil (22.2% vs 73.2%), Telugu (17.9% vs 75.1%), and Kashmiri (43.3% vs 79.7%). On average, among those speaking 13 mother tongues, while 30% of the native population knows a second language in their home State, this rises to 72% when they move outside their

State. The second stylised fact is that the proportion of trilingual speakers is also much higher among migrants. For instance, only 2.5% of Bengalis in West Bengal know a third language, but this increases to 15.1% when they live outside the State. Similar trends are observed for other languages such as Gujarati (13.1% vs 46.9%), Punjabi (29.8% vs 25.7%), Hindi (0.9% vs 9.2%), Kannada (7.3% vs 21.1%), Malayalam (9.3% vs 45.7%), Tamil (1.6% vs 29.1%), Telugu (6.5% vs 19.8%), and Kashmiri (14.4% vs 40.8%). On average, among those speaking 13 mother tongues, 9.7% of the native population knows a third language in their home State, whereas this increases to 26.3% when they reside in other States.

Third, this data underscores the impact of migration and linguistic diversity in fostering multilingualism in India. Furthermore, it clearly shows that rather than a decline, the number of regional language speakers has actually increased.Fourth, this data is 14 years old. Over the past decade-and-a-half, inter-State migration has surged, alongside the rapid expansion of information technology, entertainment media, and intercultural interactions through inter-State marriages. Since these factors have significantly contributed to breaking cultural and linguistic barriers, the number of natives speaking a second or third language would have risen substantially. While regional languages must be actively promoted, a country as diverse as India - with significant inter-State migration - inevitably develops a common language for nationwide communication. Historically, languages with the largest number of speakers tend to gain wider acceptance for cross-regional communication. Therefore, any person who needs to communicate with someone speaking a different mother tongue must learn a language they both understand.

However, when individuals frequently interact with people from multiple linguistic backgrounds, it becomes impractical to learn every language. In such cases, people tend to adopt a widely spoken language that allows them to communicate with the largest number of people. The choice of this secondary language may vary based on individual communication needs. For instance, a person from Gujarat working in Tamil Nadu may need to communicate in Tamil regularly. This necessity will naturally motivate her to learn Tamil. The State governments should facilitate language learning for such individuals. Promoting language education in this manner will encourage bilingualism and strengthen interregional communication across the country. Learning a language is a time-consuming process that cannot be achieved through imposition or force. No one will learn a language that is not useful to them, while people will be naturally motivated to learn a language that facilitates their communication with a larger number of people.In a multilingual society, besides the regional language, a second language will always emerge as a common means of communication among a large majority. When such a language gains widespread adoption, it naturally attains the status of a national language — not as a means of cultural imposition but as a tool for broader communication.

The Census data suggest that the perceived conflict between regional language and Hindi is largely exaggerated. Regional languages serve an essential role within their respective States, while a common language facilitates nationwide interaction. Thus, instead of viewing language through the lens of political and cultural contestation, it should be seen as a medium of communication. The ideal way to promote the regional language is to establish language learning centres for the people with varying linguistic backgrounds. Establishing centres where people can learn different regional and national languages will bridge communication gaps. Another approach is to promote multilingual education at the school level by implementing a structured multilingual curriculum to enhance linguistic diversity. Finally, breaking linguistic barriers lies in embracing and promoting multilingualism rather than engaging in divisive debates over linguistic imposition.

### North Korea's second naval destroyer is damaged in a failed launch at a ceremony attended by President Kim Jong-un

North Korea's second naval destroyer was damaged in its failed launch to the water this week, state media reported on Thursday, in an embarrassment for leader Kim Jong-un as he pushes to modernise his naval forces.It's not common for North Korea to acknowledge military-related setbacks, but observers say the disclosure of the failed ship launch suggests that Mr. Kim is serious about his naval advancement program and confident of ultimately achieving its objectives.During a launching event at the northeastern port of Chongjin on Wednesday (May 21, 2025), the newly built 5,000-ton-class destroyer became unbalanced and was punctured in its bottom sections after a transport cradle on the stern section slid off first and became stuck, according to the Korean Central News Agency (KCNA).

KCNA didn't provide details on what caused the problem, the severity of the damage or whether anyone was injured.According to KCNA, Mr. Kim, who was present at the ceremony, blamed military officials, scientists, and shipyard operators for a 'serious accident and criminal act caused by absolute carelessness, irresponsibility, and unscientific empiricism'. Mr. Kim called for a ruling Workers' Party meeting slated for late June to address their 'irresponsible errors'."It's a shameful thing. But the reason why North Korea disclosed the incident is it wants to show it's speeding up the modernization of its navy forces and expresses its confidence that it can eventually build a greater navy," said Moon Keun-sik, a navy expert who teaches at Seoul's Hanyang University.

Mr. Moon suspected the incident likely happened because North Korean workers aren't yet familiar with such a large warship and were rushed to put it in the water.The damaged vessel was likely in the same class as the country's first destroyer, unveiled April 25, which experts

### Why did Madras High Court stay laws taking away T.N. Governor's power to appoint Vice-Chancellors? | Explained

The Tamil Nadu Legislative Assembly passed a series of Bills for amending the laws applicable to various State-run universities. The primary aim of the amendments was to transfer from the Governor (in his/her capacity as the Chancellor) to the State government, the power to appoint Vice Chancellors to those universities. When the Governor sat over the Bills, without granting assent, for long, the State government approached the Supreme Court and obtained an order on April 8, 2025. Taking serious note of the enormous delay in grant of assent, the top court orbe deemed to hav assent. By virtue of the Supreme Court's order, the amendment Bills became Acts.Subsequently, Kutty alias K. Venkatachalapathy, an advocate based in Tirunelveli, filed a public interest litigation petition before the Madras High Court on May 12, 2025, challenging the constitutional validity of those amendment Acts. A summer vacation Bench of Justices G.R. Swaminathan and V. Lakshminarayanan entertained the PIL petition and passed an interim order on May 21, 2025. The Bench stayed the operation of the amendment Acts to the extent to which they take away the power of appointment of Vice Chancellors from the hands of the Chancellor and vest the same in the State government.

assessed as the North's largest and most advanced warship to date. Mr. Kim called the first vessel, named Choe Hyon — a famed Korean guerilla fighter during the Japanese colonial period — a significant asset for advancing his goal of expanding the military's operational range and nuclear strike capabilities.State media described that ship as designed to handle various weapons systems, including anti-air and anti-ship weapons as well as nuclear-capable ballistic and cruise missiles. Mr. Kim said, "The ship was expected to enter active duty early next year, and later supervised test-firings of missiles from the warship".

Lee Sung-joon, spokesperson for South Korea's Joint Chiefs of Staff, said on Thursday (May 22, 025) "the damaged vessel was likely equipped with similar systems and remains toppled over in the sea". The North Korean report came after recent commercial satellite images indicated that the country was building its second destroyer at a shipyard in Chongjin.Beyond Parallel, a website run by the Center for Strategic and International Studies think tank, said "the satellite imagery of Chongjin's Hambuk shipyard on May 12 showed that a second vessel in the Choe Hyon-class of guided missile destroyers was under construction".A report by the North Korea-focused 38 North website assessed last week that the destroyer built at the Chongjin shipyard was being prepared to be launched sideways from the quay, a method that has been rarely used in North Korea. The report said the previous destroyer launched at the western shipyard of Nampo, in contrast, used a floating dry dock.

South Korean officials and experts say "the Choe Hyon destroyer was likely built with Russian assistance as the two countries' military partnerships are booming. While North Korea's naval forces are considered inferior to South Korea's, analysts still view the destrover as a serious security threat, as it could enhance the country's offensive and defensive capabilities.Mr. Kim has framed the arms buildup as a response to perceived threats from the United States and its allies in Asia, who have been expanding joint military exercises amid rising tensions over the North's nuclear programme. He says the acquisition of a nuclearpowered submarine would be his next big step in strengthening his Navy. Hours after releasing the report on the damaged destroyer, North Korea fired multiple cruise missiles from an area near the northeastern town of Sondok, according to South Korea's military. The launches were a continuation of a streak of weapons-testing activities by North Korea in recent years. South Korea's Joint Chiefs of Staff didn't immediately say how far the missiles flew, noting the launches were being analyzed by South Korean and U.S. intelligence authorities

India's linguistic diversity is an asset, not a liability. The best way to preserve this diversity is to encourage multilingualism rather than restrict linguistic interactions. In the age of inter-State hypermobility, multilingualism is going to be the norm. Thus, the focus should be on inclusivity, accessibility, and practical communication, ensuring that no language is sidelined while maintaining an effective system for nationwide interaction.

### After Delhi High Court, Celebi moves Bombay High Court against India security clearance revocation, airport contract cancellations

Turkey-headquartered airport ground handling services major Celebi has moved the Bombay High Court against the revocation of its security clearance by the Centre and the consequent termination of its contracts with Mumbai International Airport Ltd (MIAL), the operator of Mumbai's Chhatrapati Shivaji Maharaj International Airport. The lawsuits—three in total—have been filed by the Celebi's subsidiary Celebi Nas Airport Services India, which operated at the Mumbai airport.The lawsuits follow a case filed by two other Celebi subsidiaries—Celebi Airport Services India and Celebi Delhi Cargo Terminal Management India—before the Delhi High Court against the security clearance revocation and the resultant cancellation of Celebi contracts by the Delhi airport operator. The matter is being heard by the Delhi High Court.

"Now, regarding our Mumbai operations; our subsidiary Celebi Nas Airport Services India Private Limited ('Celebi Nas') in which our Company holds 59% of the capital filed three different lawsuits before the High Court of Judicature at Bombay, Mumbai on 21.05.2025," parent company Celebi Hava Servisi said in a regulatory filing in Turkey on Thursday. The three cases include a lawsuit seeking the suspension and annulment of the security clearance cancellation by the Bureau of Civil Aviation Security (BCAS), and two arbitration applications against Adani group-owned MIAL seeking the annulment of its termination of contracts with Celebi Nas, and urgent interim measures to restrain MIAL to conclude the tenders for selection of new ground handling agency for the Mumbai airport. The first case has been filed against the Union of India, BCAS, Directorate General of Civil Aviation (DGCA), Airports Authority of India (AAI), and the regional office of the Ministry of Civil Aviation (MoCA).

Amid the backlash in India over Turkey's support for Pakistan in the India-Pakistan conflict. India's aviation security regulator BCAS last Thursday revoked the security clearance of an Indian arm-Celebi Airport Services Indiaof Celebi on grounds related to "national security" with immediate effect. The revocation also applies to other associate entities of Çelebi in India. This led to Indian airports where Celebi group operated terminating their contracts with group companies. Defending itself, Çelebi Airport Services India said that it is "truly an Indian enterprise" led and managed by Indian professionals, and is "not a Turkish organisation by any standard". The airports and airlines that were working with Çelebi are turning to the other major ground handling players in India's aviation sector like AI Airport Services, Air India SATS Airport Services, and the Bird group. Ground handling refers to operations that are critical for flights to be prepared and operated. These include passenger handling and check-in, baggage handling, cargo handling and management, aircraft servicing and maintenance, ramp services, and catering. India is a key market for Celebi. According to the company's regulatory filings, in its consolidated revenue of around \$585 million in 2024, its five Indian arms-Celebi Airport Services India, Celebi GH India, Celebi Nas Airport Services India, Celebi Delhi Cargo Terminal Management India, and Celebi GS Chennai cumulatively accounted for a 33.8 per cent share, which comes out to over \$195 million. Çelebi operated at nine Indian airports-Mumbai, Delhi, Kochi, Kannur, Bengaluru, Hyderabad, Ahmedabad, Chennai, and Goa (Mopa)-and its operations at these airports were distributed among the five subsidiaries, the biggest being Celebi Airport Services India that was operating at six Indian airports. Celebi Airport Services India said that it is a globally operated aviation services company with no political links or affiliation, and is majority-owned by international institutional investors

What is the reasoning given by the Division Bench for staying the amended laws?

Authoring the verdict for the Division Bench, Justice Swaminathan pointed out that the amendment Acts do not make any change to the position of the Governor being the Chancellor of State universities. They only take away the Chancellor's power to appoint Vice Chancellors to the Tamil Nadu Dr. M.G.R. Medical University, Anna University, Tamil Nadu Dr. Ambedkar Law University, Tamil Nadu Agricultural University and so on. The Bench found the amendment Acts to be repugnant to Regulation 7.3 of the University Grants Commission Regulations on Minimum Qualifications for Appointment of Teachers and Other Academic Staff in Universities and Colleges, 2018. It pointed out that the UGC Regulations clearly state that only the Visitor/Chancellor could appoint a Vice Chancellor from among names recommended by a search-cum-selection committee and therefore, the amendment Acts conferring such a power on the State government, instead of the Governor, were directly in conflict with 2018 Regulations.

#### Can UGC Regulations prevail over State Acts?

The Division Bench said, the Supreme Court had already confirmed the primacy of the UGC Regulations over the State laws. In Gambhirdhan K. Gadhvi versus State of Gujarat (2022), the top court had said: "It cannot be disputed that the UGC Regulations are enacted by the UGC in exercise of powers under Sections 26(1)(e) and 26(1)(g) of the UGC Act, 1956. Even as per the UGC Act every rule and regulation made under the said Act, shall be laid before each House of Parliament. Therefore, being a subordinate legislation, UGC Regulations become part of the Act."A Bench of Justices M.R. Shah and B.V. Nagaratna of the Supreme Court had also observed: "In case of any conflict between the State legislation and the Central legislation, the Central legislation shall prevail by applying the rule/principle of repugnancy as enunciated in Article 254 of the Constitution as the subject 'education' is in the Concurrent List (List III) of the Seventh Schedule to the Constitution. Therefore, any appointment as a Vice-Chancellor contrary to the provisions of the UGC Regulations can be said to be in violation of the statutory provisions, warranting a writ of guo warranto."The ruling was subsequently followed by former Chief Justice of India D.Y. Chandrachud and Justice Hima Kohli in State of West Bengal versus Anindya Sundar Das wherein they wrote: "In view of the decision in Gambhirdan K. Gadhvi, even if the provisions of the Act allowed the apthe operation of laws passed by the legislature, Justice Swaminathan said, the answer lay in Supreme Court's 2021 decision in Dr. Jaishri Laxmanrao Patil versus State of Maharashtra. In that judgement, the Supreme Court had said: "Normally an interim order is not passed to stultify statutory provisions. However, there is no absolute rule to restrain interim orders being passed when an enactment is ex facie unconstitutional or contrary to the law laid down by this Court."Justice Swaminathan also recalled that the Supreme Court itself had on January 12, 2021 stayed the operation of the three farm laws, passed by the Parliament, which led to a national outcry. "Interestingly, Shri P.Wilson (senior counsel representing the Tamil Nadu Higher Education department in the present PIL petition), who is now opposing the grant of interim relief was the counsel for a set of petitioners therein and welcomed the proposal to stay the implementation of the farm laws," the judge wrote.

Raman as well as Mr Wilson had urged the Division Bench to grant suffiicient time for the State government to file its counter affidavit and not take up the stay application for hearing during summer vacation sitting, the Division Bench rejected their plea."It is true that the High Court is on vacation and that we are sitting as Vacation Bench Judges. To us, it should not make any difference. The Hon'ble Chief Justice of India has observed that court vacation sittings should be rechristened 'partial working days'. We take inspiration from the said observation. Judges can be on vacation, courts should not be on vacation. Access to justice should always be available. When an advocate complains that an unconstitutional legislation has been passed, we cannot shut our eyes. That is why we propose to intervene then and there," the Bench said.Pointing out that they had granted a week's time for the State to file its written response, the Bench observed: 'The unconstitutionality and repugnancy vitiating the impugned (under challenge) amendment Acts is so glaring and obvious that we cannot shut our eyes. We are convinced that the impugned amendments are ex-facie unconstitutional. If an unconstitutional process is allowed to proceed, it would cause irreparable injury and public interest would suffer."

Does the High Court order amount to reviewing Supreme Court's verdict in Governor's assent case?

The Division Bench, further, took strong exception to an argument that the High Court's interference with the amendment Acts would virtually amount to reviewing Supreme Court's April 8, 2025 verdict in Governor's assent case. "Shri P.Wilson made a preposterous submission that we were virtually reviewing the decision of the Hon'ble Supreme Court rendered in State of Tamil Nadu versus The Governor of Tamil Nadu. No submission can be more outrageous than this. We are mindful of our position. We know that we have to give the highest respect to any decision of the Hon'ble Supreme Court. We do not need lectures from Shri P.Wilson on this score. We believe in judicial discipline. The Hon'ble Supreme Court in the said decision was not concerned with the constitutionality of the impugned provisions."

## Israeli politician critiques the Gaza war's toll on Palestinians and sparks an outcry

It is some of the harshest language against Israel's wartime conduct in Gaza and it came this week from a prominent Israeli politician, sparking a domestic uproar as the country faces heavy international criticism. It is not uncommon for politicians to criticize Prime Minister Benjamin Netanyahu's war strategy, especially his failure to free all the hostages held by Hamas. What made the comments by center-left opposition party leader Yair Golan rare — and jarring to officials across the political spectrum — was their focus on the plight of Palestinians. The ensuing controversy underscored how little the war's toll on Gaza's civilians has figured into the public discourse in Israel — in stark contrast to the rest of the world.

Speaking to the Israeli public radio station Reshet Bet, Golan — a former general — said Israel was becoming a pariah state and cautioned that "a sane country doesn't engage in fighting against civilians, doesn't kill babies as a hobby and doesn't set for itself the goals of expelling a population."After the outcry, he said he was referring to the conduct of Israel's far-right government, not of its soldiers, in his remarks. Golan's words were a shock to the system because, outside of the country's politically marginalised left, criticism focused on Palestinian civilian suffering and deaths has rarely been spoken publicly in Israel. The reasons for this include: the trauma Israelis still feel over Hamas' deadly attack on Oct. 7. 2023, Jewish citizens' deep faith in the righteousness of the military, dozens of hostages remain in Gaza and soldiers are dying to rescue them.Criticism of the war has focused overwhelmingly on Netanyahu. His opponents believe his own political motives have dictated war strategy and his failure to reach a deal with Hamas to release all the hostages — an accusation he denies."Part of the Israeli public and media outlets are still trapped in an obsession over the initial shock that started this war," said Ehud Olmert, a former prime minister and fierce critic of the current government. "But this is changing and it's just a matter of time." Israelis on ending the warPublic opinion polls show that most Israelis support ending the war in exchange for the release of the remaining 58 hostages held by Hamas, around a third of whom are said to be alive.Opponents of the war have tended to focus on concerns over the fate of the remaining hostages and the risk of soldier casualties in a campaign that many feel has run its course. While Olmert disputed Golan's choice of words, he said the essence of his remarks "reflects what many people think.

After Hamas' 2023 attack, in which 1,200 people were killed and 251 taken hostage, Israelis rallied behind the military. They saw the war as a just response to the deadliest attack in Israel's history. Many Israelis cannot imagine a future where Hamas remains intact.Israel's retaliatory war in Gaza has killed more than 53,000 people, mostly women

and children, according to local health authorities, whose count doesn't differentiate between combatants and civilians. The fighting has displaced 90% of the territory's roughly 2 million population, sparked a hunger crisis and obliterated vast swaths of Gaza's urban landscape. While international media coverage has largely focused on the war in Gaza and its toll on civilians there, in Israel, the media still devotes heavy attention to the Oct. 7 attack itself and the hostage crisis. Photos of those still held captive line the streets.Stories about the plight of Palestinian civilians are less prominent and largely avoid the harshest images emanating from Gaza. Most outlets repeat the official line that Hamas is solely to blame for the civilian toll. Politicians on Reshet Bet Golan's commentsFor many Jewish Israelis, it is hard to fathom that their own children, most of whom must enlist in Israel's military, could be committing the crimes that Golan described.All that has helped solidify a national narrative that views the war as an existential struggle."When you fight a war of existence, you don't much think about the suffering of the enemy," said Shmuel Rosner, a senior fellow at the Jewish People Policy Institute, a Jerusalem think tank.A former deputy chief of staff of the military, Golan's words have sparked outcry in the past. The most notable occasion was a 2016 speech marking Israel's Holocaust remembrance day, when he compared what he said was an increasingly illiberal atmosphere in Israel to that of Nazi-era Germany.On Oct. 7, Golan donned his uniform and grabbed a gun to help battle militants during Israel's flailing first response to Hamas' assault. Olmert called him "one of Israel's greatest warriors." Golan is not the first public figure to have made such remarks about Israel's conduct in Gaza

Former defense minister and military chief of staff Moshe Yaalon accused Israel of ethnic cleansing during a major operation last year. Zehava Galon, a former leader of a dovish political party, highlighted the deaths of thousands of children at a recent protest in Tel Aviv.But unlike them, Golan has his political future at stake, lending more weight to his words.Netanyahu said Golan's words "echoed disgraceful antisemitic blood libels." Benny Gantz, an opposition leader, said Golan's remarks were extreme and false and called on him to recant and apologize, which he did not do.Cabinet minister Amichay Eliyahu suggested Golan's words inspired an attacker in Washington, who killed two Israeli embassy employees and yelled "Free, free Palestine" after he was arrested. "Yair, the blood of the embassy employees is on your hands," he wrote on X. Golan, in response, said it was Netanyahu's far-right government that "gives fuel to antisemitism and Israel hatred." Rosner said Golan's wording on the Palestinian toll was "uncareful" and that instead of triggering introspection, they prompted a media debate over Golan himself and the damage his remarks might cause to Israel. But they could resonate among the steadfast anti-war protest movement, said Alma Beck, an activist who is part of a small contingent of demonstrators who have been holding up pictures of Palestinian children killed in Gaza ever since Israel ended a ceasefire in March. She said the group began as 20 people and has grown to 600, still just a fraction of the thousands attending the broader anti-government protests. Beck said the protest movement has been receptive to messages that focus on the Palestinian toll, and more signs with that message have been held up by demonstrators in recent weeks. Their main criticism remains that Netanyahu is continuing the war to appease his governing partners and ensure his own political survival."I think there is a shift. I think people are starting to connect the dots," she said, while noting that the bulk of Israeli society hasn't changed. "I hope that it will only grow."

### Use international law to take on Pakistan-backed terror

### Indus Waters Treaty will remain in abeyance till Pakistan stops cross-border terrorism: India

India on Thursday once again asserted that the Indus Waters Treaty with Pakistan will remain in "abeyance" until Islamabad "credibly and irrevocably" abjures support to cross-border terrorism as "water and blood" cannot flow together.External Affairs Ministry spokesperson Randhir Jaiswal also said that any bilateral talks with Islamabad will only be on vacation of illegally occupied territories of Kashmir by Pakistan."You are well aware of our position that any India-Pakistan engagement has to be bilateral," he said in response to a question on U.S. President Donald Trump showing interest in helping India and Pakistan in resolving the Kashmir issue."I would like to remind you that talks and terror don't go together," Mr. Jaiswal said."On terrorism itself, we are open to discussing the handing over to India of terrorists whose list was provided to Pakistan some years ago," he said.

Mr. Jaiswal added: "I would like to underline that any bilateral discussion on Jammu & Kashmir will only be on the vacation of illegally occupied Indian territory by Pakistan." Asked about the Indus Waters Treaty, it will remain in abeyance till Islamabad stops supporting cross-border terrorism."It will remain in abevance until Pakistan credibly and irrevocably abjures its support for cross-border terrorism. As our prime minister has said, 'Water and blood cannot flow together'," he added. India on April 23 announced a raft of punitive measures against Pakistan including suspension of the Indus Waters Treaty. The measures were announced a day after the Pahalgam terror attack that killed 26 civilians. India carried out precision strikes on nine terror infrastructures early on May 7 in response to the Pahalgam terror attack.Following the Indian action, Pakistan attempted to attack Indian military bases on May 8, 9 and 10. The Pakistani attempts were strongly responded to by the Indian side by inflicting heavy damages to a number of key Pakistani military installations including air bases air defence systems, command and control centres and radar sites. Foreign Secretary Vikram Misri on May 10 announced that India and Pakistan reached an understanding to stop all firings and military actions on land, air and sea, with immediate effect.

#### A silent burden: Thalassaemia patients in Karnataka battle disease with hope and hardship

Her day begins with a quiet prayer and a glance at the faded calendar, marked with yet another hospital appointment. For over two decades, Gowramma's life has revolved around needles, blood bags, prescriptions, and silent strength.Gowramma is the mother of two grown-up children — Tarun and Santosh — both living with thalassaemia, an inherited blood disorder characterised by reduced haemoglobin production. Every few weeks, the children need blood, life-saving transfusions that keep them alive, but slowly poison their bodies with iron. The medicine to fight this iron overload is expensive, and the bills never stop. The family has a small garment shop at Peenya, an industrial area in the northern part of Bengaluru, and is struggling to meet an avalanche of medical expenses. Gowramma has not been able to get the free medicines from the government-run Victoria Hospital for the last four months.

At Sunkadakatte, a semi-urban locality in west Bengaluru, life is a daily struggle for 19-year-old Mubeena Ruqsar, who lives with her parents. She was diagnosed with beta-thalassaemia major at just six months. Since then, blood transfusions every three weeks, countless needles, and a growing pile of medical records have all been part of her routine.Her father, Rahmathulla, works as a mechanic in a local garage. Her mother, Sakina Banu, once dreamed of becoming a teacher but now dedicates every waking hour to managing Ruqsar's health - tracking her transfusion schedules and watching for signs of fatigue, fever, or distress. They live in a rented two-room house, and save every extra rupee for hospital visits and medicine. is impacting our social, professional, and personal lives leading to feelings of isolation, discrimination, and difficulty finding employment or establishing relationships. It is difficult to get leave for regular transfusions, making life difficult," says Chandok.Naveen Bhat Y., State Mission director, National Health Mission, says the government is committed to providing iron chelation drugs for free to increase the life expectancy, ensure a pain-free life, reduce disability, and uplift the standard of living of people with thalassaemia and their families. "There is no shortage of drugs. The centres need to submit an indent and take the drugs from the warehouse," he says."It is a matter of concern if the drugs currently being provided to patients are not effective. If patients are developing any side effects or complications, they can inform their doctors at our ICHHs. While we have not received any complaints in this regard from patients or doctors in any of our centres, we will look into this issue and get the potency and efficacy of the drugs tested," Bhat savs.He savs that six labs in the State - IGICH in Bengaluru, K.R. Hospital in Mysuru, Wenlock District Hospital in Mangaluru, Gadag Institute of Medical Sciences, Ballari District Hospital, and Kalaburagi District Hospital have been upgraded into nodal centres for blood disorders where high-performance liquid chromatography (HPLC) tests are done to detect thalassaemia. Bhagya PrakashBone marrow transplant Sunil Bhat, director and clinical lead, Paediatric Haematology, Oncology and Blood and Marrow Transplantation, Narayana Health, says bone marrow transplant (BMT) offers the only permanent curative option for children with thalassaemia, but access remains limited due to financial and logistical barriers. Although the Karnataka State Cabinet approved the inclusion of BMT under Ayushman Bharat-Arogya Karnataka in January this year, it has not yet become operational. However, free BMT is being offered to eligible children from the Scheduled Caste and Scheduled Tribe families. Last year, a seven-year-old son of a farmer from Kalaburagi underwent a sibling donor allogeneic BMT at the State-run Kidwai Memorial Institute of Oncology for thalassaemia. This is the only BMT done for thalassaemia here so far. The cost of an autologous BMT ranges from ?7 lakh to ?15 lakh in private hospitals, and allogeneic BMTs are even more expensive. The stem cells in autologous transplants come from the same person who will get the transplant, so the patient is his/her own donor. The stem cells in the allogeneic transplants are from a person other than the patient, either a matched related or unrelated donor. To improve access to transplantation for patients in need, DKMS Foundation India is funding a BMT centre operated by Sankalp India Foundation with the medical advice from Cure2Children on the premises of the Bhagwan Mahaveer Jain Hospital (BMJH) in Bengaluru. All the three are non-profit organisations.D.M. Mohan Reddy, programme director, Sankalp-BMJH Centre for Paediatric Haemato-oncology and Bone Marrow Transplant, says that overall, 520 free BMTs have been done since 2013 under the programme. "We were earlier running the facility at People Tree Hospital and moved it to BMJH in 2021. Here, we have conducted 230 transplants so far with funding from the DKMS Foundation. For the last six months, we are also getting funds through the COAL India Project," Reddy says. India CEO of DKMS Patrick Paul says the country faces a shortage of stem cell donors, the core of bone marrow transplants. "Of the total 2,07,553 blood stem cell donors as per our database till April, as many as 42,939 are from Karnataka. Stem cell transplants play a vital role in treating blood cancers and blood disorders, including thalassaemia. However, because of genetic diversity, the chances of finding a perfect match within Indian registries are relatively low, emphasising the need for more donors," he says. Consanguineous marriagesVasundhara Kailasnath, paediatric haematologist and BMT physician at Kidwai, says consanguineous marriages significantly increase the risk of a child inheriting thalassaemia. "This is because both parents are more likely to be carriers of the disease. Thalassaemia is inherited as an autosomal recessive trait, meaning a child needs to inherit two copies of the faulty gene (one from each parent) to develop the condition," she says.

Operation Sindoor has powerfully demonstrated India's intent to use kinetic measures to tackle terrorism emanating from Pakistan. In addition to executing "hot pursuits". India possesses other potent non-kinetic strategies. going beyond regular diplomacy, to ensure that Pakistan is held accountable for its continued support of terrorism directed against India. An impactful approach that India has not effectively employed so far is the strategy of "lawfare", or leveraging international law to confront adversaries to accomplish strategic and diplomatic objectives.Leverage terrorism conventionsA key element of a lawfare strategy against Pakistan should be to deploy international law to highlight Pakistan's sponsorship of cross-border terrorism. This is especially important as India has led the process of adopting a Comprehensive Convention on International Terrorism (CCIT) at the global level. India and Pakistan are parties to numerous terrorism conventions at the regional and international levels. The primary regional treaty is the SAARC Regional Convention on Suppression of Terrorism, while key international treaties include the International Convention for the Suppression of the Financing of Terrorism (ICSFT) and the International Convention for the Suppression of Terrorist Bombings (Terrorist Bombing Convention).

These conventions obligate that states not only criminalise acts of terrorism under their domestic laws and prosecute the perpetrators but also refrain from financing such activities. For instance, Article 2(1) of the ICSFT explicitly classifies terror financing as a crime. Similarly, Article 6 of the Additional Protocol to the SAARC terrorism convention requires states to take measures to prevent, suppress, and eradicate the financing of terrorism. Pakistan has a long history of sponsoring, abetting, and funding terrorism against India. Following the terror attacks in Mumbai in 2008, India meticulously gathered evidence to demonstrate Pakistan's active involvement in those attacks, which Islamabad later acknowledged, albeit reluctantly. India needs to consistently publicise proof of Pakistan's role, which includes the Pahalgam terror attack on April 22. Further, India should utilise all international forums to build a solid legal case against Pakistan for its violations of international law regarding terrorism suppression. India's move to have all-party parliamentary delegations travelling abroad to present India's case on Operation Sindoor is an ideal opportunity to do this. India should identify specific provisions in terrorism conventions, along with various United Nations Security Council Resolutions that sanction terrorism, and customary international law that Pakistan is violating, and highlight these publicly.Rather than mere diplomatic hyperbole, a clear and compelling narrative entrenched in international law, grounded in indisputable facts and supported by irrefutable evidence will significantly benefit New Delhi's fight against cross-border terrorism.A critical aspect of many terrorism conventions is that they grant jurisdiction to the International Court of Justice (ICJ) to enforce the treaties. For example, Articles 20(1) and 24(1) of the Ter-



rorist Bombing Convention and the ICSFT, respectively, empower a country to refer disputes to the ICJ. These provisions, known as compromissory clauses, help circumvent jurisdictional obstacles in international law, which is based on consent. Thus, countries that are signatories to these treaties are bound by ICJ jurisdiction unless they make specific reservations. Ukraine, for instance, invoked such a clause when it sued Russia before the ICJ for violating the ICSFT. Given that Pakistan has been sponsoring and abetting terrorism against India and has not taken any action against terror groups operating from its territory, New Delhi has a compelling case against Islamabad under these terrorism conventions, which it can present to the ICJ just as it did in the Kulbhushan Jadhav case. Hurdles to overcomeHowever, there are two significant hurdles. First, Pakistan has not accepted the ICJ's jurisdiction under the ICSFT due to a reservation, which could hinder efforts to hold Pakistan accountable. Nevertheless, India can still file a case with the ICJ to draw global attention to the issue. India should put the ball in the ICJ's court to address Pakistan's jurisdictional argument. Second, and perplexingly, India has adopted a reservation about the ICJ's jurisdiction under the Terrorist Bombing Convention, while Pakistan has accepted the ICJ's jurisdiction for this convention. This obstacle can be overcome if India withdraws its reservation, allowing it to initiate proceedings against Pakistan at the ICJ for terrorism. The ICJ may likely interpret the provisions of the ICSFT and the Terrorist Bombing Convention narrowly, similar to its approach in the Ukraine vs Russia case decided last year. Therefore, India should have foolproof evidence and devise its legal strategy accordingly. The dissenting opinion of judges such as Hilary Charlesworth in Ukraine vs Russia can come in handy for India. In any case, India should not be overly concerned about the outcome of the legal dispute. Instead, it should utilise the legal proceedings to assiduously promote a global narrative against Pakistan-sponsored terrorism, aligning it with its national objectives. In sum, international law and courtrooms can also be used to combat terrorism. However, despite the growing burden, public health mechanisms remain fragmented. The State established the Karnataka State Blood Cell for the treatment of patients with blood disorders (haemophilia, thalassaemia, and sickle cell anaemia) in 2017. While this Blood Cell — operating under the National Health Mission (NHM) — is coordinating treatment and providing free transfusions in government hospitals, access to quality iron chelation drugs and specialised care remains uneven.

Although the State is providing thalassaemia drugs for free, short supply and lack of access to standardised drugs are proving costly for patients. Patients, who had been dependent on branded drugs by known manufacturers, are now getting only generic medicine manufactured by smaller pharma companies at the government centres. This is because there has been no response from big players to the tenders floated for procuring the drugs post- the COVID-19 pandemic. Officials, who expressed helplessness, said according to norms, the tender has been allotted to the lowest bidder among those who participated. According to data from the State Health Department, as many as 2,288 thalassaemia patients are registered with the 36 Integrated Centres for Haemoglobinopathies and Haemophilia (ICHH) run under the NHM. These centres, which also run day care centres, provide free iron chelation drugs and blood transfusion services. Nearly half of the total registered patients have enrolled at the Indira Gandhi Institute of Child Health (IGICH) in Bengaluru, which is the nodal centre. While free transfusion services are also provided in all government blood banks, in Bengaluru, Rotary TTK Blood Bank's Bangalore Medical Services Trustand a centre run by Sankalp, an NGO working for thalassaemia, are the two larger transfusion centres. Sankalp also runs a day-care for children at the IGICH and another one at Vasanthnagar. in the central part of the city, where blood transfusions are also done.Patients from impoverished families, however, do not have sufficient information regarding the free treatment centres. They do not even know where to go to collect free medicines. Gagandeep Singh Chandok, president of the Thalassaemia and Sickle Cell Society of Bengaluru, says there is a need for quality drugs to be made available freely by the government."The availability of free iron chelation drugs is limited to one particular brand in government centres. However, this drug does not suit all patients. Although the Centre's guidelines on haemoglobinopathies clearly say that options such as Desferal injection with infusion pumps should be made available, this is not happening," he says."With the available drugs not effective, most patients have stopped taking them from the government centres. Several patients have developed side effects such as gastritis and a burning sensation in the throat, with no reduction in iron load. As these expensive drugs need to be taken every day, patients are forced to shell out around ?20,000 every month. Many cannot afford this," says Chandok.Apart from the financial burden, thalassaemia patients also face stigma in their day-to-day lives. "This stigma





## Understanding the social, cultural and geographical contexts of Buddhism



The world is increasingly getting obsessed with selfpromotion and the thinking that it alone can bring about peace and progress. The growing selfie culture is a manifestation of this daily obsession, backed by the technology of the day. Often, a 'perfect' identity is carefully curated on social media with a focus on the self.Swayed by the glitter of social media, there appears to be no actual pursuit of knowing the inner self. Eventually, this relentless self-promotion is leading to distress. The fear of having less and the desire for more have contributed to a balance sheet of unhappiness.

It's perhaps the right time to re-read the teachings of the Buddha, who argued thousands of years ago that the self is an illusion -- and that our belief in it is the cause of most, if not all, of our sufferings. Poring over ancient Buddhist texts, Jay L. Garfield, Maria Heim, and Robert H. Sharf have teamed together to dismantle notions of the self in How To Lose Yourself: An Ancient Guide to Letting Go .Their suggestion? "Better to lose your self!" The writers contend that Buddha had argued for letting go of the self, which allows us to see more clearly the innumerable causes and conditions that come together to create our experience and that make us who we are. "When we allow our fantasies of self to dissolve, we discover instead the radically interdependent nature of our existence."

Opening up another flank of study on the ancient religion, Douglas Ober contests the commonly held belief that Buddhism "all but disappeared" from India after the 13th and 14th centuries, and saw a revival only in the mid to late 19th century. In his book, Dust on the Throne (Navayana), he notes that Buddhism had always been there, and that two centuries of archaeological excavation and textual scholarship now point to a long, enduring, and "unarchived" Indian Buddhist afterlife that extends to the modern day. Ober's exhaustive research told him that Buddhism had an indelible influence on shaping modern India. As he writes in the Introduction, 'A Dependent Arising', the theory of Buddhism's "disappearance" from the subcontinent is "little more than a useful fiction, deployed to wash over a more complicated historical terrain involving periodic Buddhist resurgences and trans-regional pilgrimage networks." He shows that Indian's modern Buddhist revival began nearly a century before 1956, when the Indian government celebrated "2,500 years of Buddhism" and when B.R. Ambedkar led half a million followers to convert to Buddhism.Backstory of a re-

#### vival

Ober argues that the "revival of Buddhism" in colonial and postcolonial India led to a slew of movements, from Hindu reform movements, the making of Hindu nationalism, Dalit and anti-caste activism, as also Nehruvian secular democracy. He tells the stories of individuals and communities that kept Buddhism alive, not least the incredible account of J.K. Birla, eldest son of entrepreneur B.D. Birla, who financed major Buddhist constructions in pilgrimage centres like Rajgir, Sarnath, Bodh Gaya, and also in new centres of "urban Buddhist activity", including Calcutta, Bombay, and New Delhi.While Ghanashyam Birla, J.K. Birla's younger brother, sided with Gandhi and Congress, J.K. and his father firmly supported the extreme Hindu right and the Hindu Maha Sabha, although as Ober notes, "they never stopped supporting Gandhi either."Efforts to resurrect Buddhist archaeological heritage are an ongoing process to help connect its monumental past with its philosophy.

In his book, Casting the Buddha (Pan Macmillan India), Shashank Shekhar Sinha traces the Buddhist heritage sites and the cities they are located in to understand their larger geographical, sociocultural, and historical contexts. It is an illustrated history of Buddhist monuments in India, spanning 2,500 years. For the purposes of this book, Sinha writes in the Introduction, 'monumental history' plays on the word 'monument' and discusses Buddhist edifices, sites, and connected histories.Lives of monuments' resonated with the people and communities around them, including monks, laity, kings, traders, guilds, landlords, agriculturalists, and villagers.

Over time, these structures have acquired different forms and meanings, and have also become important "sites of social and cultural interactions." The buildings are "complex ecosystems" which capture the changing times and give an idea about belief systems, rituals, stories, and folkore. For instance, writes Sinha, the sculptured panels on the gateways of Sanchi not only depict events from the life of the Buddha but also the Jataka tales and the mythical bodhisattvas.Ober contends that Buddhism was an indispensable part of the daily lives of Indians from many walks of life. "They pent their days reading and reinterpreting Buddhist scriptures, attending and delivering dhamma talks, building and rebuilding Buddhist shrines." The lives of Ambedkar, Birla, Kosambi, Mahavir, Sankritayan, and many other figures "help us realise that there is no one single identity at the heart of modern Indian Buddhism ... [it] continues to have an important but often unacknowledged role in Indian society."As Indians relived the past to find a better present and future, "a classless, casteless, egalitarian society," they found the Buddha, writes Ober. That as a society we have not yet been able to eradicate discrimination and poverty means the debates on issues like "caste, inequality, morality, social order, and belonging" are not over. The quest to grasp the historical Buddha and understand his 'inherent mission' must continue, and this says a lot about our modern times and predicament.

## Discounted to death: the silent slide of India's kirana shops

A bottle of Pepsi for ?50 and delivered in 10 minutes. For most urban Indians, that sounds like convenience. However, for the small family-run kirana store, once the lifeblood of everyday commerce, it sounds like extinction.Vineet Kumar's shop has been a mainstay in Delhi's Malviya Nagar for over half a century, for most of which the 69-year-old has been at the helm. His trademark cooler, brimming with bottles of unbranded banta soda, remains a hit among regulars.

tion next year.Praveen Khandelwal, secretary general of the Confederation of All India Traders and now BJP MP for Central Delhi, has long decried the dominance of e-commerce giants and their impact on physical retailers. He argues that foreign-funded platforms use deep pockets to subsidise discounts that are impossible to match. "Around 20% of mobile phone shops are shut in India," Khandelwal told The Hindu.While foreign direct investment rules bar ecommerce platforms from selling inventory they own,

### Bengaluru under water yet again



The monsoon is yet to hit the western coast of India. However, the pre-monsoon showers this week have brought Bengaluru, the IT capital of the country, to its knees. Major arterial roads were flooded, Hosur Road in the south was closed for traffic, and in several inundated residential localities, including Sri Sai Layout at Horamavu in the northeastern part of the city and S.T. Bed Layout in the south east, boats were deployed to rescue people. The scenes were reminiscent of the floods in the city in 2015, 2017, 2020, and 2022, all of which were during the peak monsoon season or in the post-monsoon period. But this time, the pre-monsoon showers have led to floods and mayhem. Four people have lost their lives in tree-fall, compound wall collapse, and electrocution incidents.

It is mostly in April that the civic body, the Bruhat Bengaluru Mahanagara Palike (BBMP), wakes up to the monsoon, which usually hits the city in the first or second week of June. On May 5 this year, Additional Chief Secretary Tushar Giri Nath, who also holds the charge as Administrator of the BBMP, and the new Chief Commissioner M. Maheshwar Rao, held a meeting to review "monsoon preparedness". Civic officials were directed to pull their socks up and carry out works ahead of the onset of the monsoon. As per a statement issued after this meeting, of the 209 flood-prone spots, interventions were carried out at 166 and zonal officials were asked to visit and attend to 43 other flood-prone spots, dredge drains along 82 road stretches that were flagged as prone to flooding by the traffic police, and finish the annual maintenance work along 175-km-long storm-water drains (SWDs).A tree that crashed following heavy rain being cleared by civic workers at Banashankari 2nd Stage in Bengaluru on May 19, 2025. The fact that annual maintenance work of the crucial SWDs is still under way, just days ahead of the onset of monsoon, indicates that it is "business as usual".

Need for a paradigm shift As the city prepares for the monsoon, the pre-monsoon showers — often accompanied by squalls and thunderstorms — wreak more damage. In May 2023, a woman died when the car she was travelling in got submerged in the K.R. Circle underpass, a stone's throw away from the Vidhana Soudha in the city centre. Experts have called for "a paradigm shift" and said the authorities should focus on preparing for pre-monsoon showers so that by April every year, the city is "rain-ready".

Data from the India Meteorological Department (IMD), Bengaluru, for 1990-2020 shows that rain begins to pick up in the city from April. During this period, while the mean total rainfall for March is 14.7 mm, it increases to 61.7 mm in April. Traditionally, the first rain is expected around Holi festival and later around Ugadi (March-April). These are called the mango showers as well. The first big rain of the year often ends up wreaking big damage as the civic administration has barely taken any measures to dredge drains along the roads and identify dangerous trees for removing or pruning them. The first rain is like a shock to the system.IMD data shows that Bengaluru receives more rainfall in May (total mean 128.7 mm) than in the monsoon months of June (110.3 mm) and July (116.4 mm). The rainfall further peaks in August, September, and October, the wettest period of the year in Bengaluru. There are two peaks

— May and later September.C.S. Patil, Director of IMD, Bengaluru, says they consider March 1 to May 31 as the pre-monsoon period, June 1 to September 30 as the monsoon period, and October 1 to December 31 as the postmonsoon period. "Heavy rain begins by May and contintypically seen as beneficial, has become a source of fear." The flooding disrupts daily life and causes significant property damage, making each rainstorm increasingly perilous for those living in the neighbourhood.

Despite the recurring nature of these floods, residents report a lack of effective drainage solutions and inadequate infrastructure. The BBMP Chief Commissioner, who visited the flooded locality in a tractor, promised a "permanent solution", something the residents have been hearing from the authorities for years. Since 2020, the BBMP has been promising to drill two big vents at a railway bridge in the locality to drain out water. Rao also promised to speed up the process. During the recent city rounds of the Chief Minister, residents vented their ire at local MLA and former Urban Development Minister Byrathi Basavaraj for alleged "apathy". The story is no different at S.T. Bed Layout, which has been developed on a tank bed, and Trinity Fortune Layout at Geddalahalli in north Bengaluru, the two other flood-prone areas. Sandra Noel, a resident of Trinity Fortune, says, "We were scared until the BBMP authorities arrived, as the water level kept rising after the nearby drains were flooded This was one of the worst floods the layout has seen and if the drain problem is not fixed, it will continue for years". The story is no different with flood-prone road stretches. Motorists, citing this week's rain, say the flood-prone roads identified by the civic body have not seen any transformation. "The roads under the Hebbal flyover and Veerannapalya stretch on the adjoining Outer Ring Road have been flooding with every rain for years. Water gets stagnated even on the flyover. Multiple delegations of heads of all civic agencies have visited the flyover and these areas and carried out some interventions. But why does the area still flood during the rains?," Sandeep Kumar, who takes the road to work every day, sought to know.

In the May 5 monsoon preparedness review meeting Giri Nath and Rao said the Bengaluru Traffic Police (BTP) had flagged 82 road stretches that often get flooded during the rains.Sources say the BTP has flagged a total of 137 stretches that get inundated, of which they have also reportedly pointed out 14 stretches that are worse off and result in traffic disruptions. Problems with most of these 14 stretches have been persistent for over two years. For instance, the Veerannapalya stretch of the Outer Ring Road, the service road under the Hebbal flyover, Panathur underpass, Silk Board junction, Hosur Road, Electronics City flyover, Marathahalli, Agara 14th Main Road, and HSR Layout have been flooding with every rain for years. The same stretches were the worst affected during the recent rain."The primary problem at most of these stretches is clogged drains, which need regular maintenance. Most of these drains are clogged with garbage, plastic bottles, dry leaves, and such materials. But in some of these places, there is also a need for engineering interventions," says a senior traffic police official.

B.S. Prahlad, Engineer-in-Chief of the BBMP, says that the civic body had carried out interventions at most of these places. "There will always be a run-off on the road surface during the rain. We cannot avoid that altogether. What we are working on is to reduce the time it takes for the water to drain out," he says. Rain has made it difficult for people to cross this road at Chamarajpet in Bengaluru, where civic works have been taken up.What has worsened the situation this year is the many ongoing roadworks across the city, including white-topping of roads being taken up even in the central business district ahead of the rains. Karnataka Power Transmission Corporation Ltd. has also dug up several key roads to push electricity cables underground, but the work is yet to be completed. Are drains and lakes prepared to mitigate floods? Meanwhile, activists point out that neither the city's drains nor the lakes are prepared for flood mitigation.

"By now, we should have ensured our lakes are only half full so that they can take in rainwater. But there seems to be no coordination between the BBMP, the agency with custody of these lakes, and the Bangalore Water Supply and Sewerage Board, which is filling the lakes with treated water. If the lakes are filled with treated water and are not desilted, their carrying capacity will be severely compromised. Our lakes are wonderful flood-mitigation barriers if used properly, but they are not," says Ramprasad. The carrying capacity of our SWDs is also severely compromised, he says. "The carrying capacity of our drains has been reduced by at least 50%, due to the build-up of silt and flow of sewage, which is never accounted for. Naturally, they will overflow," he says.Kathyayini Chamaraj of CIVIC, a citizen collective, says the civic body is concretising all drains and not building enough percolation pits. "There is no way the water will seep in. It stands there, taking away the drain's carrying capacity and also becoming a breeding ground for mosquitoes," she says. Not just the SWDs, but even the shoulder drains and culverts are not being desilted regularly, leading to flooding. We need to redesign our drain system to manage our kind of monsoon, she says. Prahlad who also holds charge as Chief Engineer, SWD, BBMP, says they are removing silt and carrying out maintenance work of SWDs at a war pace by deploying excavators, tractors, and tippers, and the drains will be ready by the onset of monsoon.

While he brushes off probing questions about business pressures, a steady stream of customers stops by to buy loose cigarettes, soft drinks, and candy. "It's impacted me very little," Kumar says of the yellow-jacketed 10-minute delivery agents criss-crossing the neighbourhood all day. "From a business point of view, there has been a difference, but I'm satisfied," he says.Kumar estimates that around a tenth of his business has been affected, but he is still hopeful. "We have milk and cigarettes, and we offer delivery," he adds, highlighting the service and convenience he continues to provide over quick commerce platforms like Blinkit, Zepto, and Swiggy Instamart.

Just around the corner, Anuradha Taneja feels the blow more acutely. The 54-year-old, who has run her store for 25 years, says business is down by 30%. "I used to have all these young students and working people who came to buy their supplies. Now they just sit at home and order, and it reaches them in?10?minutes,"?she says.Unlike some other kiranas, Taneja does not stock fresh vegetables, so casual grocery buyers are fewer. Instead, she depends more on passersby – a demographic that is increasingly vanishing.

To understand what exactly is under threat, it's important to define what a kirana store is. Simarjit Singh, Professor of Finance and Accounting at the Gurugram-based Great Lakes Institute of Management, describes it as a "pureplay brick-and-mortar store that has created an inventory of daily household items", or fast-moving consumer goods (FMCG) "that offer ease of access, credit, and free delivery for a limited period". That model is now under intense pressure, particularly in India's tier-1 cities."Typically, the investment required to set up a?kirana?store ranges between ?5 and ?15 lakh, depending on the city," Singh says, with much of that going towards renting space. About 65% of such stores operate out of rented premises, and monthly rents range from ?5,000 to ?1 lakh. "These are generally middle-class people, bootstrapping their investment with help from family and friends," he adds. And it's a business that already runs on razor-thin margins. Any sustained drop in sales, like the kind being triggered by quick commerce platforms, can pose an existential threat. "Ideally, rent should not exceed 20% of gross profit, or 3% of total sales turnover. That is the threshold," Singh says. 'Taking away business' Naresh Raghuvanshi, 41, runs a kirana store in Bhopal's Chuna Bhatti locality and has seen this threat materialise first-hand. He and his brother split a single shop after their respective marriages, turning half into a hardware outlet. "My brother and I had rented this shop from a friend. We've relied on the residential societies nearby for years," he says.But now, he blames online platforms for "taking away the businesses" of small shopkeepers. "We can't match their prices and offers. It's not a fair competition. My business has been down at least 30-35% in the past two years," he says. Though Raghuvanshi still takes phone orders and delivers personally, rising rent, thinning margins, and fewer walk-ins have taken a toll. "Even though it's my friend's shop, I have to pay rent. Many shopkeepers like me have shut their kirana shops and moved to other businesses," he adds, voicing worry over how he will fund his daughter's college educa-

Khandelwal accuses them of circumventing the rules through local partnerships in the "marketplace" model - indistinguishable in practice from selling their own goods.Embracing changeEarlier, kiranas were largely protected from this because their low-ticket FMCG items weren't a priority for platforms like Amazon and Flipkart that focused on electronics and appliances. That changed with the advent of guick commerce, which is transforming how urban India shops, and is rapidly making its way into smaller towns. To stay relevant, kirana shop owners are innovating. Kumar in Malviya Nagar offers delivery and credit, services still valued by older customers. Singh mentions one shop that diversified into toys to widen its customer base.Urban retail is often run by those with some access to capital, giving them room to pivot. Taneja points to a nearby store that shut down last year and reopened as a hardware outlet. But even relatively larger players are feeling the squeeze. Budget Bazaar, a grocery chain that opened an outlet in Malviya Nagar last July, ironically, in a space previously occupied by a Blinkit delivery hub, had to shut down within 10 months. "It is very disheartening," says Yash Goyal, a partner in the chain. He blames quick commerce platforms. "They are killing us, because they are offering way more than what the customer expects - discounts and snappy delivery," he says.

That's great, but I'm only getting that bottle for ?85," says Goyal. With little room to compete on pricing, he warns that if this trend continues, local stores may disappear altogether. "There will be no nearby stores left to service you, and you will be bound to buy from these platforms," he says, adding that then the prices will rise.

Even kiranas that stay afloat face steep operating costs. There's capital expenditure, rent or deposits, initial inventory, as well as labour. While some store owners rely on family, most still hire two or three workers."It costs somewhere around ?7,000 to ?15,000 per worker," says Singh, a steep cost for a low-margin business trying to offer free delivery to keep up. "Ultimately, quick commerce operators are not just killing the trade. They are killing the consumer spirit... 30% of the kirana business has already been taken away," says Khandelwal.In Bhopal, 23-year-old Tushar Singh runs a paan shop near the city's bustling No. 10 Market. After his father passed away in early 2022, Tushar took a gap year from school to manage his father's shop. "Earlier, online stores didn't stock many of the brands I sell. They also used to shut by 11 p.m. But now they're open till 1 or 2 a.m.," he says, adding that the change in timing has hit the core business of late-night customers."Markets in Bhopal shut by 10 or 11 p.m. People would come here, have tea, and sit with friends. They'd buy cigarettes from my shop. Now, many come with whole packets bought online

ues till October in Bengaluru," he says. The pre-monsoon showers in the April-May period are thunderstorms, accompanied by high-speed winds that can go up to 50 kmph and lightning, he says. "Many trees fall during the pre-monsoon showers, mainly due to high-speed winds. During monsoon also we may see some tree-falls and thunderstorm events," he says.

B.L.G. Swamy, Deputy Conservator of Forests, BBMP, says, "Not just old and brittle trees, even many healthy green trees have also fallen during the recent rain.' The civic body cut down several trees and pruned many as a preventive measure in the last two months, he says. Despite a special drive from April to prune trees, the city has reported over 60 tree-fall incidents and one death in one such incident during the pre-monsoon showers in May.In the last two years, the Bangalore Electricity Supply Company too has reported damage to over 9.000 electricity poles and around 1,000 transformers during the pre-monsoon months. An official from the power utility says, "We lose more infrastructure in the pre-monsoon months because of the tree-fall incidents. Our poles can withstand up to 250 kg of weight, but when bigger trees fall, a breakdown is inevitable. Before the monsoon, we also take up pruning of trees and aerial bunching of cables."

S. Vishwanath, water conservation activist, says, "Anyone who observes the rain pattern in Bengaluru will realise that we need to be rain-ready before April. But there is a disconnect with this ground reality and the work taken up by the city administration, which wakes up to the monsoon by April, if we are lucky. We need to change the way we look at this and work backwards to the April deadline. What we do in April-May, has to be done in February-March."Chief Minister Siddaramaiah, who visited rain-affected areas in the city on May 21, pulled up officers for not being prepared for the showers. Citizen activists point out patterns that show that many stretches of roads and certain pockets of the city, despite being flagged by multiple agencies and prior experience, get flooded every time it rains. "Why does the same set of places get flooded every year? This only shows laxity of the civic administration. Either the civic body is not working towards practical workable interventions at these points, or unplanned development of the city seems to have made it impossible to avoid flooding," says V. Ramprasad from Friends of Lakes, a citizen collective working to conserve the city's lakes.

#### Why do the same points get flooded every year?

For the past many years, Sri Sai Layout and S.T. Bed Layout, both developed by the Bangalore Development Authority (BDA), get flooded with even light rains, exposing not only the BBMP's laxity, but also the government's own skewed development model. ### It's globalisation, my love: 25 years of 'Kaho Naa... Pyaar Hai'



It was a moment of national swooning. The Bollywood film Kaho Naa... Pyaar Hai released on January 14, 2000. At the dawn of the new millennium, it put the country into overdrive. Bolstered by an aggressive publicity blitz, word had already spread about its otherworldly star. He had hazel eyes and a silvery smile. His Stallone-like build betrayed a schoolboy's charm. He was 27 years old. And, it was rumoured, he could dance. It's been 25 years since Hrithik Roshan's star-making debut in his father's musical. Families hoarded theatres. 'Ek Pal Ka Jeena' played on loop. Young boys and girls had found their new pin-up god. Some, with embarrassing mileage, aped the Hrithik handshake, flicking the palm horizontally. Manoj Desai, executive director of G7 Multiplex (then Gaiety Galaxy) in Mumbai, remembers running packed shows round the clock. "The film ran for 25 weeks non-stop at my theatre. From children to grown-ups, everyone went crazy about Hrithik's dancing. When he returns in a new avatar after the interval, the seetis (whistles) were boundless."The buzz overseas was just as strong. By the mid-1990s, India had one of the largest diaspora populations in the world, concentrated in North America, UK, the Gulf countries and Australia-New Zealand. Bollywood, its boundaries broadened by liberalisation, began reaching out to them. Films like Dilwale Dulhania Le Jayenge, Dil Toh Pagal Hai and Pardes successfully rode the wave of globalisation. The movement reached its apotheosis with Kaho Naa... Pyaar Hai. Its star-crossed lovers danced on cruise ships, got stranded on the sands of Krabi, Thailand. Hrithik and his co-star, Ameesha Patel, rode a hot air balloon in Christchurch, New Zealand. Everything about the film was calibrated to sing an international tune. Its dual-hero storyline was a frank allegory of free-market aspirations: After Rohit, a penniless car salesman turned popstar, dies, his NRI doppelgänger Raj rolls up in a BMW and Honda Hurricane

The film had a curious genesis. Hrithik's father, director Rakesh Roshan, had initially intended it for Shah Rukh Khan, the reigning knight of the Hindi diaspora film. The 90s were a wild era of remakes and rejigs; French Kiss, the Meg Ryan comedy about a missing diamond necklace, was remade in Hindi as Pyaar To Hona Hi Tha (1998). A year before that, James Cameron's Titanic had set the bar for the sweeping romantic epic. Cruise ships, aquatic deaths, ill-fated lovers from across the class divide... Kaho Naa Pyaar Hai was like Titanic filtered through Karz (1980). Another oft-cited inspiration is the Kannada film Ratha Sapthami (1986), remade in Tamil as Love Birds (1996). In both, the hero seemingly dies in an accident, the heroine takes a healing trip somewhere far and scenic, and the lovers are fortuitously reunited (the grungy discotheque number recurs in all versions).

World-view"Toh hass kyun ki duniya ko hai hassana (smile, so you can make the world smile)," Hrithik sings in the film. It became a motto of the times. The language of globalisation is threaded throughout Kaho Na... Pyaar Hai. Rohit's bedroom wall has a poster of the Backstreet Boys. Though he dresses casually, he wears a shirt and tie to work, the dress code of the IT generation. There are product placements for Lexus, Mercedes, Ferrari, Yokohama tyres, and Coca-Cola. The multiracial, tropical-themed nightclub Raj dances at is called Club Indiana. He reads Cosmopolitan magazine on a flight. A year before Peter Jackson's The Lord of the Rings: The Fellowship of the Ring, the film boosted tourism and migration interests in New Zealand, highlighting attractions like Lake Wakatipu and The Remarkables ski resort outside Queenstown. In 2004, Helen Clark, the former Prime Minister of New Zealand, wrote to Rakesh Roshan: "Your film captured the imagination of Indian audiences and portrayed a rich and vibrant image of New Zealand."Diaspora films tend to reflect the dualities of immigrant life, its characters caught between tradition and modernity. But Raj - an assault of soft power charm, in a netted vest and sunglasses - seemed perfectly at home in the wider world. Kaho Naa Pyaar Hai is not a reincarnation story, unlike Karz, and poor Rohit, searching for 'saadgi' (simplicity) in a capitalistic world, meets a dark end. Written by Honey Irani and Ravi Kapoor, the screenplay has silly contrivances that most audiences happily ignored at the time, but which do not survive a rewatch. Rohit's younger brother is frozen mute by his passing. Sonia's fashion sense changes every 15 minutes. A lovelorn Raj follows her back to Mumbai, happily abandoning his aging parents (returning NRIs were a fiscal asset, and were granted tax benefits). Though a parade of pretty people in pretty places - Krabi also featured in Danny Boyle's The Beach the same year, becoming a major tourist hotspot — Kaho Naa... Pyaar Hai is also a film of sounds. There are lines, at times mere words, that are permanently stuck in our heads: Tannaz Irani's nasal "Sonias ... ", for instance, or Raj tooting, "Isse kehte hai ittefaag. Ittefag No. 3." Rajesh Roshan, Hrithik's uncle, composed the film's songs, appropriating - not his first time - tunes from Greek composer Vangelis. The film's cultural legacy is inextricably linked to its soundtrack. Lucky Ali blessed it with his vocals, belting out two diametrically opposite hits, the electronic headrush of 'Ek Pal Ka Jeena' soothed out by 'Na Tum Jaano Na Hum', with its tranquil guitar strums and melancholic outro

Off-shoringKaho Naa Pyaar Hai was the antithesis of all the raucous energies shaping Hindi cinema at the time. Ram Gopal Varma's Satya and John Matthew Matthan's Sarfarosh had nudged Bollywood into gritty, challenging directions. But Roshan, with his escapist blockbuster set aboard a big boat, steered it back on course. Anurag Kashyap, the lead writer of Satya, mocked this apparent regression in a line of dialogue in Nayak: The Real Hero, released the following year. Reluctant to join politics and change his country's course, Anil Kapoor's character remarks, "I want to live the easy life... watch Kaho Naa Pyaar Hai on Sundays."

There was a shocking, Satya-like coda to the Kaho Naa Pvaar Hai wave. On January 21, 2000, a week after the film's release, Rakesh Roshan was shot at by two unidentified gunmen outside his office. In a bleeding state, he drove to Santa Cruz police station, scared more for his son's life than his own. It emerged that the shooters belonged to Mumbai's Budesh gang, who had tried extorting the director over the film's overseas earnings. Bollywood was corporatizing and bringing in the big bucks, and the underworld, its uneasy ally since the 90s, wanted a piece of the pie.Over the last 25 years, Kaho Naa Pyaar Hai has turned up in popular culture in amusing ways. Na Tum Jaano Na Hum became a full-length film with Hrithik, Saif Ali Khan and Esha Deol. Raj flipping through photographs of his dead lookalike is a meme. During the surreal early weeks of COVID-19, someone registered the film title 'Corona Pyaar Hai,' inviting the wrath of Rakesh Roshan. Canadian YouTuber Lilly Singh made Hailey Bieber dance to the film's title track, and, in 2021, while campaigning for the Trinamool Congress in Asansol, West Bengal, Ameesha Patel sang a few lines from the same song — an apparent dig at Babul Supriyo, a singer on the film, who was fielded from the BJP in the assembly elections.

Hindi blockbusters today have moved past the candied nothingness of Kaho Naa... Pyaar Hai. They have become more strident and unabashed. Curiously, even their internationalism now feels parochial. Hrithik's most recent smash was Fighter, a politically-slanted actioner from 2024, inspired by the Top Gun franchise. In a disappointing scene, Hrithik's combat pilot, bashing up a terrorist, yells the words 'India-Occupied Pakistan' — the kind of triumphalist coinage that has become depressingly commonplace. It makes one long for the easygoing Sundays, when life was less hectic and charged, and we all watched Kaho Naa... Pyaar

### How does BJP elect its party President?



The story so far: For the past year, J.P Nadda, the incumbent president of the Bharatiya Janata Party (BJP), has been on an extended tenure as the party sought to maintain stable leadership during a Lok Sabha election year. With its most recent membership drive crossing the 100 millionmark, the BJP is currently holding polls for its State party units. Following this, a new party President will be elected, as per tradition — unanimously and with the approval of the Rashtriya Swayamsevak Sangh (RSS).

Since its inception, the BJP has always chosen its president after a 'co-ordination' meeting with the RSS where a suitable candidate who has majority support on both sides is selected. However, during the Lok Sabha campaign, Mr. Nadda's assertion that the BJP was 'capable to run on its own' had ruffled the feathers of the RSS top brass, and RSS largely stayed away from the poll campaign. The poll result, which saw BJP form a coalition government at the Centre, forced it to re-enlist the RSS' help for State elections. A fivehour meeting was held in August 2024 at Defence Minister Rajnath Singh's residence with Mr. Nadda, Home Minister Amit Shah, RSS second-in-command Dattatreva Hosabele and its joint general secretary Arun Kumar in attendance. The RSS would prefer someone with strong organisational skills, while the BJP prefers someone who ensures seamless coordination between the high command and the president's office, reported

How are organisational polls held by the BJP?

During its membership drive, BJP enrolls 'active' members who are tasked with bringing in at least 50 persons as party members in a booth or an assembly seat. Only active members can take part in the party's organisational elections. An 'active' member can take part in elections to BJP's mandal committees and above – district, regional, State and central committees. All these committees have a three-year term. The primary unit of the BJP is its local committee, which comprises of up to 300 members. A member who has been part of the BJP for at least a year can be elected as president of a local committee along with a stipulated number of committee members depending on the strength of the local committee.

Many such local committees together constitute a mandal – whose committee members are elected by the president of these local committees. There are three types of mandal committees based on categorisation of the States according to the number of Lok Sabha seats they have - (a) three or less Lok Sabha seats; (b) four to twenty Lok Sabha seats; and (c) more than 20 Lok Sabha seats. These committees have an elected president and up to 60 elected members, as decided by the State executive. The mandal president has the power to nominate four vice-presidents, two general secretaries, one treasurer and not more than five secretaries. There are reserved quotas for women and Scheduled Caste/Tribe (SC/ST) members in these mandal committees. Similar to the mandals, the district committees are based on the State categories and the president of such a committee is elected by the mandal committee presidents. An active member can be nominated as district president if nominated by one-third of the elected mandals. A district president must be a primary member for at least six years and can appoint a general secretary (organisation) even from outside the committee. The BJP State unit has two bodies - State Executive and State Council. Mandal committee members can elect members to the State Council proportional to strength of the State Assembly. Other members in the Council include 10% each of the party legislators and party parliamentarians, former State presidents, State executive members, leaders of the party in the State Assembly and Council, members nominated by State President, allied morchas and chiefs of cells, district committee presidents and general secretaries. The State executive is also classified according to the categroies of States and is headed by a president who is elected by members of the elected State council members from district units, parliamentarians and legislators. Any active member can be nominated to the president's post if nominated by one-third of the elected district committees. The president can nominate members from different State executive categories as vice-presidents, general secretaries, general secretary (organisation), secretaries and treasurers. All the above committees have reserved quota for women and SC/ST members National levelOn the national stage, the BJP has the national council, national executive and the plenary session. Similar to the State council and executive, the national council members are elected by State council members in proportion with the Lok Sabha seats in the State. Other members are similar to those State council - former national presidents, all State presidents, party leaders in State assemblies, councils, Lok Sabha, and Rajya Sabha, 10% of the Parliamentarians, members nominated by the national president, all national executive members and allied morchas and chiefs of cells. The national executive is headed by the party president and has no more than 120 members, of

which at least 40 must be women and 12 must belong to SC/ST communities, nominated by the party president. One general secretary (organisation), one treasurer, nine general secretaries, fifteen secretaries, and thirteen vice-presidents are nominated by the party president. Only members active for at least three terms can be nominated to the executive body. Exceptions to these criteria can be granted by the party chief to not more than 15 members. Any twenty members of the electoral college can propose an active member who has been a member for at least fifteen years, for the post of national president. This proposal should come from at least five States where national council elections have been concluded. The party president's term is for three years, and any person can hold the post for two consecutive terms.

History of BJP presidents and pollsThe BJP's first Party President was Atal Bihari Vajpayee, one of its cofounders. In the 1980 general election, the BJP fared poorly, winning only two seats. After a critical appraisal of its party functioning, the party's National Executive in 1985 decided to make BJP a cadre-based party and the responsibility was passed on to L.K. Advani – Mr. Vajpayee's deputy. The veteran BJP leader channeled the party's efforts into the Ram Janmabhoomi movement, making it an official resolution in the 1989 National executive meeting.

After two consecutive terms with Mr. Advani at the helm, most other party chiefs were chosen unanimously and lasted only a single term, or less. Mr. Advani's successors - Murli Manohar Joshi, Jana Krishnamurthy, M Venkaiah Naidu, Bangaru Laxman, Kushabhau Thakre were all deeply-rooted RSS leaders who had risen politically among the BJP ranks. Of these, only Mr. Joshi and Mr. Thakre completed a full term. In 2003, the BJP amended its constitution to introduce a consecutive term limit, clarifying that "any member can hold the post of president for more than one term but not consecutively." Subsequently, in 2004, after the BJP-led coalition NDA failed in its re-election bid, Mr. Naidu took moral responsibility and resigned from his post, allowing Mr. Advani to once again take over the party reins. In his address, he blamed his own government's failure to "pay heed to BJP's ideological and organizational constituency," signalling BJP's renewed focus on its core ideology. However, his term was cut short in 2005 when he was asked to step down as BJP chief after he eulogised Pakistan's founder Mohammed Ali Jinnah as 'secular' during a personal trip to Karachi, Since then, his ties with the RSS have remained strained.In 2012, RSS once more pressed the BJP to amend its constitution to enable continuity in leadership. The resulting amendment, passed by the BJP national executive in Mumbai in May that year, stated that any eligible active member can hold the post of president for three years for two terms. The RSS felt that Mr. Gadkari, who had improved the party's prospects and functioning since its poor performance in 2009, would need a second term to comete the overhauling of the BJP. However, it was as Mr. Advani continued to criticise Mr. Gadkari's style of running the BJP and voiced his opposition to giving Mr. Gadkari a second term when he met him along with RSS General Secretary Suresh Bhaiyyaji Joshi in Mumbai. Faced with tough opposition and an income tax department raid on companies related his Purti group, Mr. Gadkari suddenly opted out of the presidential polls on January 22, 2013. He was succeeded by 61-year-old Uttar Pradesh BJP veteran Rajnath Singh. ## We are balancing welfare outgo with prudent fiscal management: Thangam Thennarasu

Since mid-2021, the Tamil Nadu government has rolled out several women-oriented welfare schemes that involve a significant annual financial outgo. At the same time, the State was unable to announce a cash component for Pongal festival this year. In an interview with The Hindu, Finance Minister Thangam Thennarasu says the government is managing the situation through prudent fiscal management. He also highlights the Centre's passive approach to the State's request for funds to handle natural calamities such as the recent Cyclone Fengal. Excerpts:

The State government has introduced numerous welfare schemes, such as Vidiyal Payanam (costless bus travel for women), Kalaignar Magalir Urimai Thogai and Pudhumai Penn, which have significantly benefited women and involved substantial financial outlay. How is the state managing to balance its finances while implementing these initiatives?

This state has been a pioneer in rolling out landmark schemes which have then paved the way for the entire country to follow. Today, what is globally acclaimed and recognised as the Mid-Day Meal programme was introduced in 1920s in the Madras Municipal Corporation- run schools. This government, under the leadership of our Chief Minister M.K.Stalin, is continuing this illustrious legacy. Each of these schemes are showing remarkable results. While we are implementing these schemes for the welfare of the people, we are also ensuring prudent fiscal management. We have been taking concerted efforts to ensure a sound growth in revenues in all sectors, be it GST, stamps and registration, motor vehicle taxes, etc. We have also introduced the Tamil Nadu Public Fund Tracking System to ensure a just-in-time fund release for schemes. This is helping us to save the interest costs by efficient cash and debt management.Recently, at the Pre-Union Budget meeting, you reiterated the request to the Centre to release funds for cyclone relief and the Chennai Metro Rail project. How confident are you that the Centre will allocate these funds? What impact has the non-release of funds had on the State's finances?This is an issue of major concern for the state. The funds from Union Government have not been released for Cyclone Fengal (2024). Even for Cyclone Michaung (2023) and the unprecedented rainfalls in southern districts, the Union Government had released a meagre sum of ?276 crore, against an amount of ?37,907 crore sought by the State. For Samagra Shiksha Scheme, disbursal of ?2,152 crore is pending. These funds are meant for salary of teachers, maintenance of schools and RTE Act reimbursement.

As a result of non-receipt of funds, the State is having to bear these expenditures from their own budgetary resources, causing a severe strain on the finances.

Given the significant impact of Cyclone Fengal across several districts, affecting daily life and assets, will there be any implications for the State's Own Tax Revenue (SOTR)?

Definitely. All such natural disasters have an adverse impact on the economy and thus revenues of the state. Despite our best efforts at planning and mitigation, there is a significant loss of livelihoods and property of the people and substantial damage to the infrastructure. This poses a double blow to state finances - One one hand, we are not able to receive the revenues and on the other, the expenditure for providing the necessary relief increases suddenly. This has become a major challenge for the state and its economy, especially because Chennai and surrounding areas which are more prone to such disasters, contribute about 33% of our State's GDP. (Gross Domestic Product). This is why we are consistently seeking funds from the union aovernment under the NDRF window. While the revenue collections have been in double digits, there has also been increase in revenue expenditure? Will this affect the capital expenditure? Will the State be able to meet the capital expenditure targets? There has been a setback to the growth of capital expenditure due to the onslaught of Cyclone Fengal. However, we are continuously following up to ensure that the pace of implementation of projects is fast. We will make our best efforts to achieve the capital expenditure targets in the budget.

How has the growth in the State's Own Tax Revenue progressed so far in the current fiscal year 2024-25?

The growth in State's Own Tax Revenue up till November has been 13.96%. This has been primarily owing to a good growth in the Goods and Services Tax (GST) component driven by higher Integrated Goods and Services Tax (IGST) settlements. The government has been taking active measures to ensure that the transactions are correctly recorded and the amount of revenue due to the state is timely received. Further, several technological measures and use of data analysis tools is helping us to improve the tax collection efficiency. Apart from GST, the effects of rate revision in Tamil Nadu State Marketing Corporation Limited (TASMAC) and motor vehicle taxes have also shown a positive impact on the revenues. However, the sales volume in these sectors continue to be a cause of concern amidst a general economic slowdown in the country.

### **RBI's risk buffer seen rising with Economic Capital Framework review, may dent dividend to govt in future**



As the Reserve Bank of India's central board of directors meets today, all eyes would be on its decision regarding the Economic Capital Framework (ECF) — a rule-based system for the provisions the central bank must make against the risks it faces. While an increase in the risk buffer is likely due to the rising geopolitical tensions and global trade disruptions, this decision is being keenly watched as it could lead to a significant fiscal fallout — a reduction in the dividend the government gets from the RBI going ahead.

The RBI's Central Board of Directors met last week to review the regulator's Economic Capital Framework. The meeting of the board now comes after an internal review of the framework which was earlier outlined by the expert committee led by former governor Bimal Jalan in August 2019. The committee had suggested the framework be examined every five years. "Nevertheless, if there is a significant change in the RBI's risks and operating environment, an intermediate review may be considered," it had added. The review of the framework is crucial as it can potentially dent a key source of revenue of the central government: the annual dividend from the RBI. The dividend for 2024-25 is expected to be transferred to the government this month and economists think it could be as high as Rs 3.2 lakh crore, or 6.3 per cent of the Indian government's budgeted expenditure for 2025-26.

The Economic Capital Framework provides a rulebased system for the provisions the RBI must make against the risks it faces. These provisions are to be made from the revenue the apex bank generates in the normal course of its operations and after it has met its expenses. A key recommendation of the Jalan committee was that the RBI should set aside 5.5-6.5 per cent of its balance sheet as a Contingent Risk Buffer to meet the credit, operational, and financial and monetary stability risks it faced. This means, if the RBI's balance sheet grows by Rs 100 in any given year, the central bank would have to provide an additional Rs 5.5-6.5. After maintaining a Contingent Risk Buffer of 5.5 per cent for three years after the Jalan committee's recommendations were accepted, the RBI increased it to 6.0 per cent in 2022-23 and further to 6.5 per cent in 2023-24. It is this key ratio, among other aspects, that would have been reviewed in recent months. What would a hypothetical increase in the Contingent Risk Buffer to 7.0 per cent from 6.5 per cent mean for the dividend? Considering its balance sheet expanded by around 7.0 per cent in 2024-25, the RBI would have to provide nearly Rs 70,000 crore to ensure its Available Realised Equity is equal to 7.0 per cent of its balance sheet.

As at the end of 2023-24, the Available Realised Equity - the sum of the RBI's Contingency Fund, Asset Development Fund, capital, and Reserve Fund ---- stood at Rs 4.58 lakh crore, or 6.5 per cent of its balance sheet. Should the buffer be retained at 6.5 per cent for 2024-25, then the Available Realised Equity would have to be increased by around Rs 32,000 crore given a 7.0 per cent expansion of the balance sheet. While a hike in the Contingent Risk Buffer from 6.5 per cent would no doubt dent the dividend the government would get, it may still exceed last year's Rs 2.11 lakh crore largely on account of the RBI's gains from its foreign exchange transactions."While there are discussions that the RBI may tweak the economic capital framework and widen the contingent risk buffer (realised capital), we do not think this would impact the RBI's profit this year," Madhavi Arora and Harshal Patel, economists at Emkay Global Financial Services, said in a note on Thursday. The duo sees the RBI's dividend for 2024-25 around Rs 3.2 lakh crore, higher than the Rs 2.56 lakh crore estimated in the 2025-26 Union Budget as dividend from the central bank and public sector banks and financial institutions. In 2024-25, the RBI's gross foreign currency sales rose to an alltime high of \$398.71 billion. To put this figure into perspective, its gross sales of \$153.03 billion in 2023-24 helped generate an exchange gain of Rs 83,616 crore - or 30 per cent of the RBI's total income that year. According to Gaura Sen Gupta, IDFC FIRST Bank's chief economist, the RBI's gains from foreign exchange transactions may have more than doubled in 2024-25 to Rs 1.73 lakh crore. The RBI makes an exchange gain on its foreign exchange transactions when the price at which it sells a foreign currency is higher than the historical acquisition cost. According to Sen Gupta, the historical cost of the RBI's gross dollar purchase is currently tracking at Rs 68.4. The rupee ended 2024-25 at around 85.5 per dollar after having fallen to an all-time low of 87.95 per dollar in early February 2025.

### Why bitcoin has touched all time high of \$110k following a key crypto bill in US

Bitcoin has reached a new all-time high as it breached the \$110,000 cap for the first time, following the advancement of a key crypto bill in the United States Senate, which has received bipartisan support, and is expected to aid those running crypto businesses.

The bill, called the Guiding and Establishing National Innovation for US Stablecoins (GENIUS) Act, has advanced in the US Senate, after some Democrat members who had initially opposed it, joined their Republican colleagues in supporting the bill, which regulated primarily stablecoin.Bitcoin has fallen last month briefly over geopolitical uncertainties following Trump's tariff-induced assault on many countries, triggering fears of a global economic turmoil. However, with some of those concerns reducing, after events like the US signing a trade deal with China, the digital currency has been gaining momentum. The GENIUS Act played a further role in its upward surge.

## Fatty liver to cirrhosis: Why can't you see the silent damage?

A person in his late 30s came to us reporting a lack of appetite, bloating and yellowing eyes that indicated jaundice. "Doctor, I haven't been feeling well before. I have been losing weight steadily, get a mild abdominal pain from time to time, my legs swell up and I am constantly fatigued. Could I be suffering from something else," he asked. These were all early symptoms of cirrhosis, where his liver was damaged by chronic inflammation. He had an undiagnosed fatty liver, where fat accumulation keeps damaging the organ. This led to scarring, which eventually disrupted the liver's structure and blood flow, resulting in cirrhosis — a more advanced and potentially irreversible stage of liver damage. His abdominal obesity and diabetes had compounded movement and light-impact activity help slow down agerelated bone loss, reducing risk of osteoporosis. They also enhance cognitive functions such as strategic thinking, reaction time and hand-eye coordination.

In many cases, liver biopsy or advanced imaging techniques like elastography are required to detect and stage fibrosis accurately - tools that are not routinely used unless there is a strong clinical indication.

#### What are triggers of cirrhosis?

Certain factors can accelerate the progression from fibrosis to cirrhosis. These include co-existing conditions such as diabetes, obesity, high cholesterol, and continued exposure to liver toxins like alcohol or medications with side effects.

### **Mohammed Shami unlikely for England Test** series; ability to bowl long spells a concern

WITH just few days left before the Board of Control for Cricket in India (BCCI) picks its squad for the five-match Test series against England, it is learnt that the senior selection committee is likely to leave out ace pacer Mohammed Shami from the tour.BCCI's medical team has informed the Indian board that the 34-year-old pacer won't be able to bowl longer spells. Chances of him playing all the five Test matches are bleak too, going ahead. There were deliberations over taking Shami along with the Indian team and playing him in few games. However, with Jasprit Bumrah already informing the board that his body can't take the toll of more than three Tests matches, the selection committee were known to be in a dilemma on whether to fly out with a similarly iffy bowler, who might only play few games. It hampers the planning of the Indian side too.It is understood that selectors want fit bowlers flying with the Indian side, who can bowl longer spells if needed."Shami is bowling four overs in IPL for Sunrisers Hyderabad but the board and selectors don't know whether he can bowl more than 10 overs in a day. Test matches in England may demand his recovery.

longer spells from the pacers and we can't take chances," a source in the board informed.

Shami's last Test match appearance came during the 2023 India vs Australia World Test Championship final at the Oval.Shami's possible omission could open up a slot for left-arm pacer Arshdeep Singh or Haryana right arm seamer Anshul Kamboj, who has 74 wickets from 22 first class games. Arshdeep could be the dark horse especially given his county cricket experience last season where he represented Kent. The selection committee had already picked Kamboj for the India A squad due to travel to Enaland

The five-man committee is expected to meet in a few days when they will officially announce their new captain for Test cricket. The Indian Express had earlier reported that Shubman Gill is a frontrunner to lead the Indian Test team going ahead. It is learnt that Gill had a meeting with Indian team coach Gautam Gambhir and chairman of selection committee Ajit Agarkar. Shami had undergone ankle surgery in 2024 which halted his cricket for nearly a year. He made his comeback earlier this year through the T20 format and was later part of Champions Trophy too. The Bengal pacer had missed key events for India, including last year's T20 World Cup in Australia and the West Indies, and also the Border-Gavaskar Trophy in Australia in recen months."I waited for an entire year and I worked very hard. ### 8 Test hundreds vs 8 countries: **England's Ollie Pope sets world record** with century against Zimbabwe



England No. 3 Ollie Pope set a new world record after the Bazballers had a field day on the first morning of the cricket summer at home against Zimbabwe on Thursday.Batting first on Day 1 of the four-day Test at Trent Bridge, Nottingham, England piled on a massive 498 for three in 88 overs with the top-3 of the Ben Stokes-led side all gathering centuries. While opener Ben Duckett slammed a century in as many balls on his home ground, a struggling Zak Crawley got some runs under his belt with relatively slower 124 off 171 balls.But it was England's No. 3 Pope who set the headlines after his senior batting partner Joe Root nudged past 13,000 Test runs.Pope waltzed to his eighth Test century in 109 balls and set multiple records as he crossed the three-figure mark. Despite his middling Test average, Pope recorded his seventh hundred at No.3, putting him level with Jonathan Trott among English batters in the spot. Only legends Wally Hammond, Ken Barrington and David Gower have racked up more Test centuries for England at No. 3. More curiously, Pope's eight centuries have all come up against different oppositions. The 27-yearold extended his own world record to become the first batter to record his first eight Test hundreds against different countries. Pope became the 30th Test batter to record centuries at least against eight different countries and could even equal the record should he hit a century in the Ashes later this year.

Although, after the Club World Cup, I will no longer wear this shirt on the pitch, I will always be a Madridista.

Modric arrived at the club from Tottenham Hotspur in 2012. While he was initially seen as a surprise buy, with some sections of the Madrid fanbase questioning the signing, Modric quickly established himself in the Real Madrid starting lineup as a reliable playmaker who also had an incredible work rate defensively. He was an integral part of the team that won the club their long-awaited 10th Champions League crown in his second season.When Zinedine



Zidane took over as coach, Modric became the centre piece of the squad that won three Champions League titles in a row between 2015-16 to 2017-18. After his 2018 World Cup exploits when he guided Croatia to their first final, Modric won the Ballon d'Or for the best player in the world to break a 10-year duopoly between Lionel Messi and Cristiano Ronaldo." I arrived in 2012 with the illusion of wearing the shirt of the best team in the world and with the ambition to do great things, but I couldn't imagine what came next," he added. She was flanked by her sherpas, Dandu Sherpa and Om Gurung, and Army veteran Lt Col Romil Barthwal (retired), the expedition team leader.

metres Friendship Peak. She followed this up by climbing multiple peaks in Ladakh and went on to become a part of Operation Blue Freedom, an expedition of specially-abled persons to Siachen Glacier, led by an Armed Forces veterans' group, Team Claw, in 2021. With every climb, Angmo's passion increased. It was a meeting with Skalzang Rigzin, who became the first Indian civilian mountaineer to scale Mt Everest without supplemental oxygen, that she began dreaming of conquering higher peaks.

Rigzin, who met Angmo in Leh through her school mate and mountain guide Tsewang Norbu, was impressed with her "willpower and willingness". "Through Norbu, Angmo showed me pictures of her Siachen trip and I could sense that she had the willpower to conquer higher mountains. Tagda chalti thi (She walked with a strong gait). That's my first memory of seeing her climb in Ladakh," Rigzin, 43, said. "The way she would rope up with the guide and use her senses to judge things was commendable. She scaled Kang Yatse 2 (6,250 metres) in less time than a normal mountaineer," he said.Rigzin, also the president of the Ladakh Mountain Guide Association, said that Angmo used the fixed rope route, a tried-and-tested method when climbers attempt to scale 8,000 metres-plus peaks."I would tell her about the Jumar technique while ascending on a fixed rope line using coordination of body, hands and ascender to climb the rope... Before Mt Everest, she called me asking, 'yeh equipment theek hai (is this equipment right)?' I wished her luck, she inspires people like us through her willpower," Rigzin said. Last year, Angmo, who is employed with the Union Bank of India, received the National Award for Empowerment of Persons with Disabilities. In April this year, after the Union Bank of India decided to sponsor her expedition, her preparations to conquer Everest got underway with mountaineering firm Boots & Crampons, based in Delhi-Hyderabad, along with Pioneer Adventures of Nepal.Boots and Crampons CEO Romil Barthwal and founder Bharath Thammineni met Angmo in April and, for the four weeks that followed, she first scaled Mt Lobuche (6,119 metres), before starting the acclimatisation cycles from Camp 1 (6,065 metres) to Camp 2 (6,400 metres) at Mt Everest and back. When we met her in the first week of April, the first thing that impressed us was how she knew the basics of mountaineering like an expert," Thammineni, who has scaled eight 8,000 metres-plus peaks including Everest, said."Of course, she required the assistance of the sherpa and me or Romil, but then she had to do the climb herself. Sometimes, she would judge from the tension in the rope and the step impressions in the ice or rocks," Thammineni said. With challenges like the Khumbu Icefall and multiple ladder crossings over crevasses during the climb, the team devised some in-house signages for Angmo. "The ladder crossings are done by a single climber... We would guide her using trek poles to tell her where to put her feet," Thammineni said.As she mounted her final assault, Angmo's elder brother, Lama Karma Yeshey, a monk at the Sherabling Monastery at Baijnath in Himachal Pradesh, immersed himself in pravers, "Whenever she goes for a summit, she takes prayer flags with her and tells me to pray for her too," Yeshey said. Upon her return, a simple — yet special — treat awaits Angmo. "She will ask our mother to get her the best apples from our small orchard," Yeshey said.

Centuries from Ben Duckett, Zak Crawley and Ollie Pope helped England plunder a record 498 runs on Thursday, the first day of the one-off four-day Test against Zimbabwe at Trent Bridge in Nottingham. 498 is the most runs scored by any team on the first day of the Test on England's soil, bettering Australia's previously-held record of 475 scored against England during the fifth Test at the Oval in London in 1934. The most runs scored by any team on the first day of a Test also belong to England. During the first Test against Pakistan in 2022, England amassed 506 runs on Day 1 to break Australia's record set in 1910, where they managed 494 against South Africa. The most runs scored in a day in Test cricket is 588, managed by England and India on Day 2 of the Manchester Test in 1936.On Thursday, Zimbabwe's decision to bowl first after winning the toss turned costly right from the get-go when the openers stitched a fifty-run partnership in just 10.2 overs.



In the next 10 overs, they managed 50 more runs. The pair added 231 for the opening wicket before Duckett was dismissed for 140 off 134. Crawley also snapped his poor run in the Test — managing just 212 runs in his last eight Tests while averaging just 15.14 - scoring his fifth century in 54 Tests. He scored 124 off 171 and added 137 for the second wicket with Pope.

The third wicket partnership was also above 100 between Pope and Joe Root, who became the fastest to 13000 Test runs during his 34-run innings.

### Novak Djokovic's eventful 38th birthday in Geneva: Angry racket smash, injury and return to 'playing good tennis'

On the night of his 38th birthday, Novak Djokovic returned to his feisty best at the Geneva Open to record a win over Italy's Matteo Arnaldi in the quarter-final on Thursday.While the eventual 6-4, 6-4 scoreline may not reflect the Serb's struggles, Djokovic brushed past his opponent after an eventful tide of frustrations and injury scare to even possibly reunite with the confidence he has lacked throughout the 2025 season. Making up for his Madrid Open defeat to Arnaldi wasn't easy. As the 38-year-old Djokovic handed a break and a 3-1 lead early on in the second set, the emotions led him to smash his racket. Soon after the wavering service game, the 24-time Grand Slam champion suffered a knee injury scare after Arnaldi expertly wrong-footed him to extend the lead to 1-4.But the inimitable Djokovic immediately flipped the scales and denied Arnaldi any further inroads to win the next five games in succession and a berth in the semi-final before announcing that he's slowly getting back in the groove.Djokovic had recently announced his split from long-time rival Andy Murray's coaching, and had undergone a tepid run of results since an injury-forced exit at the Australian Open."It's great to be in the semifinals again. Last year, I played semifinals. Hopefully, this year I can go a step further. That's the goal. You know I think I'm playing really, really good tennis.



Today was, as I said, a lot of tension on the court, straightset win but it was much closer than the score indicates, Diokovic said as he builds up to the French Open. What made Angmo's feat even more special was that she became the first visually impaired person from India and only the fifth such mountaineer in the world - to conquer Everest.Before her, there was Erik Weihenmayer from the United States — the first visually impaired person who scaled Everest in 2001 — Austrian Andy Holzer (from North Col route in Tibet) in 2017, Chinese Zhang Hong in 2021 and American Lonnie Bedwell (2023). Angmo, however, is the first visually impaired woman summiteer.

"Stepping on the summit of Mt Everest, my first thought was how each step counts in our journey, whether one is abled or specially-abled. This is only a step in my dream to instill willpower in every specially-abled person. If we have the willpower, nothing can stop us and my next target will be the highest peaks in each continent," Angmo told

"My role model is Helen Keller, whose books and biography I read as a student. My father, too, is a role model... There were times when people would taunt me for being visually impaired. But my father and my family supported me in this journey. Our daughter is like the oasis in our world, and to see her climbing Mt Everest was a special moment for the whole village," Chand, 76, said. Angmo's younger sister Kesang Yangchen, who lives in Mohali, was quick to add: "The yellow hills above our village are called Moonland by the tourists and locals, too. The second youngest among five siblings, Angmo was in Class 3 when her vision got severely impaired following a "medicine allergy", according to her family. Chand's brother, Gopal, said the family only got to know when her school teacher brought it to their attention after noticing that Angmo was struggling to write. "The next day, we rushed to a hospital 210 kilometres away, at Rampur Bushahr, which referred us to another hospital in Shimla," Gopal recalled.But there was no relief. As the years passed, Angmo lost vision in both her eyes completely.

"We visited Chandigarh, Dehradun and other cities to find a cure but Angmo slowly lost her vision. There were financial struggles, too, but the family did whatever it could to support Angmo," Gopal said. In 2005-06, Chand and his wife Sonam Chhomo got Angmo enrolled at Leh's Mahabodhi School and Hostel for Visually-Impaired Children, run by the Mahabodhi International Meditation Centre. She later completed her graduation from Miranda House in Delhi.In 2016, Angmo completed a basic climbing course from the Atal Bihari Vajpayee Institute of Mountaineering and Allied Sports, Manali, where she climbed the 5,289-





### Bhool Chuk Maaf movie review: Rajkummar Rao, Wamiqa Gabbi film feels like poor man's Brahmastra

For a long time, Bhool Chuk Maaf looks and feels like the poor man's Brahmastra (remember that one?). A couple prancing up and down Varanasi's ghats and gullies, surrounded by gais, gendas, gurus and the Ganga, and few raised eyebrows. Everytime you start to forget that this is supposed to be Benaras, come aerial shots to convince us that it is. And yet, this film need not have been staged in the eternal city at all. In fact, it would be difficult to place the Rajkummar Rao-Wamiqa Gabbi starrer anywhere – which is not a crime exactly, except how much Bhool Chuk Maaf wants to belong.

It's not just to a place either. The film has so many ideas, people, strands, plots jostling about that it is obvious director Karan Sharma struggled to fill even its 121-minute length. The songs, one worse than the other, don't help. Nor the fact that lovers Ranjan Tiwari (Rao) and Titli Mishra (Gabbi) seem to operate on different planes. The central strand is that the unemployed Ranjan and the spoiled Titli are desperate to get married. Titli's dad (Zakir Hussain) lays down one condition: that Ranjan get a government job within two months. After suggesting that it might go into the interminable wait for a job in a country where recruitment exams are at the mercy of sarkaar or scamsters, Bhool Chuk Maaf slithers into jugaad territory. It as easily sidles in, and

skips out of, problematic issues such as dowry, for laughs, as you wonder more and more what Titli, with at least money and looks going for her, sees in Ranjan – who, she herself points out more than once, has little, if anything, going for him.

That could be a story too, as the free-spirited Titli threatens to upset Ranjan's world, with his mother an enterprising breadwinner with a business in pickles. But just when you are digging into your popcorn, the film takes its most ambitious turn, and stumbling, swerving and somersaulting - even as you wish it would just keep lying down for once - finds a moral centre! There is even a mild stab at communal harmony, while Karan Sharma (also the cowriter) is at it. Yet, this need not have been such a stew of Ghat meets Groundhog Day. There are very many good actors in Bhool Chuk Maaf, starting with Rao, and including several usual suspects that Bollywood casts when it comes to Uttar Pradesh. They serve their own roles well. Gabbi is pretty and proficient, but, sadly, the most half-baked of them. There are also very many scenes which work on their own, and even evoke some laughs. Ultimately, Bhool Chuk Maaf may end up being remembered for all that happened off screen - the confusion between its theatrical and OTT release, and a "compromise" (which has worried many in the industry) that means that within two weeks, it will be showing on a TV near you.

### Fountain of Youth movie review: We never got a third National Treasure movie, and thanks to Guy Ritchie, we still haven't

After he directed Aladdin - the anonymous 2019 remake that you'd forgotten made over \$1 billion at the box office - Guy Ritchie became extremely prolific almost overnight. He made another movie that same year. But more importantly, Aladdin marked a major stylistic evolution for the famously flashy filmmaker: he got really into clothes. Nowadays, you find yourself admiring the tailoring in his films more than the films themselves. is little, for instance, to like about Operation Fortune: Ruse de Guerre. But, boy, was Cary Elwes dressed smartly. Unfortunately, the costumes in Ritchie's recent films are inversely proportional to their quality. The worse the movie, the better the clothes. The clothes in his latest, Fountain of Youth, are excellent. Starring John Krasinski and Natalie Portman as estranged siblings who go on an epic adventure to locate the fabled Fountain of Youth, the movie comes across as a third copy of Indiana Jones. Even Nicolas Cage's two National Treasure films had more spark than Ritchie's overwritten, bloated, and unevenly paced new adventure film. Fountain of Youth has a tremendously fun pre-titles sequence, where Krasinski's character, an adventurer named Luke, steals a valuable painting in Bangkok and evades capture from a gang of goons and a mysterious woman played by Eiza Gonzalez. The sequence is tactile, slick, and, most importantly, filmed not on a soundstage, but on location in the streets of Bangkok. Unlike most streaming tent poles these days, which have a certain flatness that invariably hurts their final score, Fountain of Youth has the look and feel of a big screen spectacle. The Bangkok sequence opens on the streets, and ends on a train. In the middle, Luke gives his adversaries the slip by running into a market and commandeering a street food cart. It's fun stuff, but the thrills end the moment the titles roll. Fountain of Youth turns into a plodding affair; you realise that James Vanderbilt's screenplay could easily have been fashioned from a discarded script for an Uncharted adaptation.Not that Ruben Fleischer's actual Uncharted movie was any better, but at least it featured two actors - Tom Holland and Mark Wahlberg - who seemed to have real chemistry. Krasinski, for no fault of his own, is grossly miscast as the swashbuckling (yet earnest) Luke. His relaxed line delivery and generally laid-back demeanour is a poor fit for Luke, who, it is suggested, has the brash charm of Harrison Ford and the sincerity of Nic Cage. Fountain of Youth is the kind of movie that would've benefited greatly from another draft of the screenplay, and a thorough look at who's playing who. It has the whiff of something that was made on the fly, which is odd, considering the resources that must've gone into it. They obviously filmed across the world, on real locations - the climax is shot in and around the Great Pyramids, which is where the treasure our heroes are trying to locate has been resting for thousands of years. Luke and Charlotte — that's Portman's more proper character — are hired by a wealthy billionaire who says that he is dying of cancer. He needs them to join hands and locate the mythical fountain, whose water, it is believed, can give the drinker immortality.



### Coldplay's Ahmedabad show boosted economy by Rs 700 crore, Gujarat being dry state was a concern, says BookMyShow CEO: 'Show's budget was...'

The idea to perform at the Narendra Modi Stadium in Gujarat was Coldplay's idea, said Ashish Hemrajani, the founder and CEO of BookMyShow. The band played five shows in India earlier this year, three in Mumbai and two in Ahmedabad. There were concerns about whether the Gujarat capital was infrastructurally capable of hosting such a massive live event, which saw over 2 lakh people in attendance, booked out local hotels, and fuelled an unregulated spike in ticket resales. In an interview with Raj Shamani, the BookMyShow CEO opened up about putting the events together, and the help and support that he received from top government ministers."To play in the world's largest cricket stadium, as a thought, came from the band," he said, adding that work began a year prior to the actual show. Not only did they have to figure out how audiences will travel to and from the city, they also had to make sure that Gujarat being a dry state wouldn't hamper their enjoyment. He had to reach out to the Railway Minister to arrange for special trains from Mumbai, which was a tall ask at the time, seeing as the Mahakumbh was also taking place.

He said that he received an enthusiastic response from Jay Shah, who happily agreed to loan out the Narendra Modi Stadium. "So, I had a partner in crime, and we went back to the band and said that it's happening," he said, adding that the Ahmedabad shows contributed Rs 700 crore to the Gujarat economy. "Ahmedabad's infrastructure has really improved... But getting into the city, there aren't enough flights. And around 75% of the people were coming from



out of Gujarat. It was mathematically impossible to transport as many people into the city," he said, adding that special support was necessary from the Indian Railways.He also addressed the potential losses from food and beverages. "Gujarat has prohibition, so will people even come? Will people enjoy themselves? But it became the world's largest concert. Everybody came safely, they left safely. They didn't miss alcohol... Employment, hotel, airlines, food, travel, merchandise, spends in the city, we calculated what the average spend per-person in Ahmedabad was. The GST impact was Rs 72 crore, the overall impact was around Rs 700 crore, the direct impact was around Rs 250 crore," he said, adding that the Ahmedabad show probably cost between Rs 30 crore to Rs 40 crore, minus artiste fees.

### Will there be Dear Hongrang season 2 based on the original novel Tangeum's ending? Netflix keeps the possibility open



Lee Jae Wook and Jo Bo Ah's new historical mystery K-drama Dear Hongrang ended its 11-episode run on May 17 after debuting the same day on Netflix. If you've already watched it, you're probably aware of the bittersweet ending and may have even found yourself scrolling through a fan thread, trying to piece it all together. Now, fans are wondering if Dear Hongrang will follow in the footsteps of Lee Jae Wook's previous historical fantasy Alchemy of Souls and return with a Part 2 to continue the story. While there's no official word from the streamer yet, it's worth noting that the series is based on the 2021 novel Tangeum: Swallowing Gold, which also inspired a webtoon under the same name. So, whether the show expands or stops here depends a lot on how the novel wrapped things up.

#### Is Dear Hongrang based on a book?

Yes, the story is inspired by Tangeum by the renowned Korean author Jang Da Hye. Just as shown in the Netflix adaptation, the story is set in the late Joseon Dynasty, where a young boy, the only son of a powerful whole life while living in a suffocating home, filled with opium smoke and betrayal. Then there's Mu Jin, the adopted son of the Min family. He grew up with Jae Yi. Once, he may have seen her as a sister. Now, his feelings have twisted into love.

#### Why Tangeum?

Tangeum translates to "swallowing gold." It's a poetic Korean phrase used to describe suicide, especially among "noblewomen or courtesans driven by despair." The story focuses less on uncovering Hong Rang's identity and more on the characters themselves, each broken in a different way, and how one incident fractures every bond — three people, caught in a web of memory, pain, desire, and guilt.

#### What's the possibility of Dear Hongrang season 2

The possibility of Dear Hongrang getting a renewal is quite low, or even a complete no, given the current series has wrapped up all the arcs written in the novel, and Hongrang's character met the same fate as Lee Jae Wook's: taking his last breath in the arms of Jae Yi. The series covered everything, including the brutal history of the soul reaper, how he was poisoned in childhood, which slowly led his body and organs to give up.. The villain meets a tragic end after Hongrang chops off the same arms that claimed the lives of so many innocent kids. According to author Jang Da Hye, she painstakingly rewrote her characters' emotional arcs multiple times before publishing. The book is drenched in symbolism and emotion.However, when adapted on screen, writer Kim Jin Ah (The Devil Judge) and director Kim Hong Sun (The Guest, The Witch's Diner) leaned harder into the political intrigue and suspense, though the story and character arcs largely stayed true to the source. What's surprising is that Netflix still hasn't marked the series as Limited, leaving the door slightly open. But if the story expands, it'll likely go beyond the book, into completely original fiction.If you can read Korean, or even if you're semi-fluent and willing to work through it with tools, Tangeum is 100% worth it. There's no official English translation yet, but the demand has skyrocketed. There's also a webtoon version on Ridibooks.

For the tech giant to spend however many millions on Fountain of Youth - to be clear, the movie looks expensive — is like you or I not thinking twice before buying a bag of potato chips. The small one. Ritchie is always at his best when he's making standalone capers that bear his unmistakable stamp, not when he's trying to appease masters by churning out potential franchisestarters.Fountain of Youth falls in the second category. Despite the handsome production values and infrequent bursts of fun, it's a by-the-numbers experience that is way more serious than it should've. Here's a movie in which the protagonists are hunting down a magical underground spring that has the power to change the world as we know it; medicine, governance, economies could all be on the line here. And yet, Fountain of Youth has the tone of an overdue library assignment. Ah, well, at least the cardigans and shawls are pretty
