The space station has seven astronauts - Nicole Ayers, Anne McClain, and Jonny Kim from NASA, Takuya Onishi from the JAXA (Japan Aerospace Exploration Agency), and Roscosmos cosmonauts Kirill Peskov, Sergey Ryzhikov, and Alexey Zubritsky.

Hyderabad: BRS working president KT Rama Rao on Wednesday held the Congress government responsible for the failure of Gate No. 9 at the Priyadarshini Jurala Project, stating that the incident was a direct consequence of the government's negligence in undertaking timely maintenance works.Operational issues were reported at the Jurala project on Thursday when crest gate No. 9 failed to open after one of its two rope cables snapped, even as inflows into the reservoir rose steadily to 53,000 cusecs. The project has 62 crest gates in total. Taking to X, Rama Rao lashed out at Chief Minister A Revanth Reddy, saying he had not laid "a single brick" in building irrigation projects, yet had failed to ensure basic maintenance at crucial infrastructure points like the Jurala spillway, despite annual flood threats. He also expressed concern over the condition of other gates at the project."The government must immediately alert people in downstream areas and take urgent preventive measures as flood levels continue to rise. All efforts must be made to protect the Jurala project and ensure the safety of downstream habitations," he said.Rama Rao further criticised the Congress government for a series of infrastructure failures, listing incidents such as the collapse of the SLBC tunnel that killed eight people, flooding of 16 villages following the Peddavagu breach, the submergence of the Vattem pump house, and the collapse of the Sunkishala retaining wall.Each of these incidents stemmed from negligence and administrative failure, resulting in substantial public loss, he said.

Rajnath Singh refuses to sign joint statement

In response to the terrorist attack in Pahalgam on April 22, 2025, in which 26 people died, India on May 7, 2025 launched 'Operation Sindoor' to dismantle cross border terrorist infrastructure. In this address in SCO, Mr. Singh mentioned that on April 22, 2025, the terror group 'The Resistance Front' (TRF) carried out a "dastardly and heinous attack" on innocent tourists at Pahalgam in Jammu and Kashmir.

The report also claimed that violators could face penalties of up to Rs 2,000. This comes just days after Gadkari announced a new annual FASTag pass worth Rs 3,000 for private four-wheelers, aimed at simplifying toll payments and reducing congestion.Set to launch on August 15, the pass will be valid for one year or 200 trips — whichever comes first — and can be activated via the Rajmarg Yatra app or official websites of the NHAI and the MoRTH.

The government has significantly expanded its highway infrastructure in the last decade, with the total length of national highways increasing from 91,287 km in 2014 to



1,46,204 km in 2024 - a rise of over 60 per cent. The pace of highway construction has also tripled from 11.6 km/day in 2014 to 34 km/day in 2024.

As of now, 1,366 highway projects covering 32,366 km are under construction across the country, many of which are expected to be completed in phases by FY 2028. With a 570 per cent increase in the road transport and highways budget over the last decade, the Centre continues to prioritise infrastructure development - but for now, two-wheeler riders can rest assured that tolls are not on the horizon

Komatireddy flags off anti-drug march



Nalgonda, June 26 As part of the Anti-Drug Awareness Week, Minister for Roads and Buildings Komatireddy Venkat Reddy flagged off a rally at NG College in Nalgonda town on Thursday. While speaking to the crowd at Clock Tower Circle afterward, the Minister voiced significant worries regarding the increasing prevalence of drug use among students, particularly in the aftermath of COVID-19. He remarked that substance abuse is wreaking havoc on the lives of young people and earnestly urged students to avoid drugs. "Drugs have no place in Telangana," he stated emphaticallyReaffirming the State government's commitment to youth development, Komatireddy announced that a Skill University is being established for students, with a Rs.34 crore Skill Centre coming up in Nalgonda. He said it would be inaugurated soon by Chief Minister Revanth Reddy. He urged students to focus on education, sports, and yoga at least until the age of 20 and asked them to avoid unnecessary use of mobile phones.

"Study well, appear for competitive exams, and secure government jobs," he advised, adding that students must treat this phase of life as a turning point. He also warned drug peddlers and addicts, stating that the government is taking strict measures in Hyderabad and across the state to curb drug abuse. He even encouraged citizens to physically confront drug users if needed and inform the police immediately.

The Minister also revealed that a new school with digital classrooms and all modern amenities is being constructed at Prakasham Bazaar in partnership with Prateek Foundation. He assured full support from the government and himself as a Minister for any student welfare initiative taken up through the foundation. With precision and audacity, burglars are zero-

ing in on locked residences, breaching them effortlessly and making away with high-value assets-seemingly unfazed by the town's surveillance infrastructure.""The most recent episode unfolded on Monday night in Vasavi Nagar, where the home of Illandula Venkateshwarlu was ransacked in his absence. Having traveled to Hyderabad on official duty, Venkateshwarlu returned only to discover that miscreants had broken the locks, looted valuables including a television, laptop, tablet, silverware, and ?20,000 in cash-totaling an estimated loss of ?1 lakh. A formal complaint has been submitted to the local authorities.""In a separate incident, burglars broke into the residence of a woman from the Budhha community in Gaddalapelli village, escaping with two tolas of gold and other valuables. Merely days earlier, the Krishna Mandir in Manthani was also targeted, with essential kitchen items reported stolen.""This spate of breakins has reignited memories of a chilling crime wave from February 16, 2022, when five homes were looted in a single night. Among the victims was retired MPDO Muddu Prakash, who suffered a significant loss of cash and precious metals. Despite CCTV footage capturing the suspects, no arrests were made, and the case remains unresolved. Similarly, the burglary on November 17, 2022, yielded no investigative breakthroughs.""The frequency and boldness of these incidents have stirred widespread frustration. Locals are openly questioning the efficacy of law enforcement, highlighting a deepening crisis of public trust. Many victims lament the inertia of police investigations and are calling for enhanced patrolling, improved surveillance, and swift justice to deter further criminal activity.""Unless decisive steps are taken, residents fear Manthani may continue to be a soft target for criminal networks, undermining the town's safety and social fabric.

Still mopping it old school: Dyson study reveals India's obsession with clean homes, but we could be making our floors dirtier



Hyderabad:Dyson announced the results of its first Global Wet Cleaning Study, to investigate wet cleaning habits and behaviours, frustrations people face with their wet cleaning tools, and why our best intentions might not be delivering the hygienic homes we expect.The global study uncovers that despite frequent cleaning by Indian households, current tools and habits could be making homes less hygienic, not cleaner. The study finds that hard floors dominate Indian homes, with 94.5% of people having floors made of tiles, stone, or wood—materials that attract dirt easily and require frequent wet cleaning. However, popular cleaning methods including traditional mops, buckets, and cloths, may be spreading dirt rather than removing it.

Indians are obsessed with cleaning: Is that enough?

Unlike South Korea or Australia, where wet cleaning happens more reactively, occasionally or for specific messes, in India, wet cleaning is part of the daily routine. Traditional wet floor cleaning methods remain the most preferred choice for many Indian households, with mops, cloths, or wet sweepers in constant use. Yet, despite their popularity, these tools bring their own set of challenges:1 in 3 Indians say wet cleaning is simply too time-consuming. In fact, 75% spend over an hour on their cleaning routines, with nearly 35 minutes devoted to wet cleaning floors. Indian use of mops, brooms, and wet cloths is the highest in APAC-yet only 33% finds cloths or sponges truly effective for hard floors.49% admit they don't change the cleaning water for every room. This means dirty water, and the germs in it, are spread from one part of the house to another, defeating the purpose of cleaning.

45% cite stubborn stains as their top cleaning challenge, and 31% worry about slipping on wet floors. With hard floors so prevalent, this becomes more than a minor grievance.Seeking Solutions: What Do Indians Want in a Wet Cleaner?Despite a strong cleaning culture, India ranks lowest in the APAC region in terms of awareness around modern wet cleaning machines. While 62% of Indians believe that vacuum cleaners with wet functionality are the best solution for floor cleaning, adoption remains low.

Hyderabad, June 26 CII (Confederation of Indian Industry) Telangana organised a day-long maiden Conference on Pillars of Protection - Forging a Safer Future for Pharma and Chemical Manufacturing on Wednesday in the Hotel Park, Necklace Road in Hyderabad. The initiative supports Telangana's vision to double its life sciences ecosystem and establish Hyderabad as Asia's foremost pharma hub.Chief guest of the conference, Y Nagi Reddy, IPS, Director General, Telangana Fire Disaster Response, Emergency & Civil Defence Dept., Govt of Telangana said, "Safety in any industry, whether pharma or other industry, comes at three different levels: planning, execution, and operation and maintenance" while emphasizing the critical importance of safety in the pharmaceutical industry. He emphasised that safety should be integrated from the initial planning stage, citing examples of potential hazards such as improper building design and non-functional safety systems. Y. Nagi Reddy called for mandatory annual Fire Safety Audits, especially in the Pharma sector. "Industries must take proactive responsibility by getting audits done and submitting them online. We will trust and don't verify," he said, adding that Telangana witnessed 102 major fire incidents in pharma units over the last decade, resulting in losses exceeding ?100 crore. A tragic incident at one factory saw property loss worth ?30 crore and six casualties, he shared. The department saved property worth ?4,035 crore last year, though ?1,223 crore was still lost. Telangana currently operates 147 fire stations, including 38 in the city of Hyderabad. Three firefighting robots have been deployed in Hyderabad, Rangareddy, and Medchal, with more to come. The department is also exploring drone capabilities and plans to induct women into fire services, following models in Maharashtra and Tamil Nadu.

Handling fire in the pharmaceutical industry is difficult due to the different kinds of gases and chemicals used. He explained the Telangana Fire Service Act 1999. Section

13 of this act requires that buildings and hazardous industries must get an NOC from the Fire Department. According to another section, 19, the owner or the occupant is responsible for the fire system in the establishment. While addressing the conference, Nikhil Chakravarthi, IA&AS, Director, Commissionerate of Industries, spoke about Hyderabad's leadership in pharma and biotech, noting that around 40-50% of global FDA facilities are in the city. He stressed that compliance should be part of the industry's DNA, not just a one-time rule.B. Raja Gopala Rao, Director of Factories, touched upon the critical importance of safety in pharmaceutical and chemical manufacturing. He stressed that safety is a fundamental pillar of any organisation, comparable to production, quality, and customer satisfaction. K Raja Bhanu, Director General, Pharm excil and Dr Vinay Kumar Gupta, Assistant Drugs Controller (India), CDSCO Zonal Office, Hyderabad, Ministry of Health & Family Welfare, Government of India, emphasised the critical importance of safety in pharmaceutical and chemical manufacturing. Investment fraud: victim cheated of Rs 74 lakh

Hyderabad, June 26 : Victim, a 50-year-old resident of Saidabad, was contacted on WhatsApp on May 18, 2025 by individuals claiming to represent "Citadel" and "Axis Securities," who shared investment links promising daily returns of 8% to 20%. Trusting their claims, victim initially invested ?1,00,000 each in both platforms via IMPS and received profit of ?8,000 on May 20, 2025, which led the victim to believe the scheme as genuine. Subsequently, victim was lured into making larger investments under the pretext of high returns from IPO stocks—claiming profits of up to 240% and 320%. Between May 23, 2025 and June 13, 2025, victim transferred ?31.00 lakh to Citadel and ?43.30 lakh to Axis Securities, totalling ?74.30 lakh. Later, they demanded further investments of ?83 lakhs and ?70.70 lakhs, falsely promising returns of ?7.5 crores. Victim refused and soon realized it was a fraud. Though the fake apps now show inflated balances (?1.26 crore in Citadel and ?2.62 crore in Axis Securities), victim is unable to withdraw any funds. Victim has been cheated through a well-organized scheme involving multiple bank accounts and false representations by individuals impersonating reputed financial entities. Hyderabad, June 26 Telangana Jagruti president and BRS party MLC Kalvakuntla Kavitha today said CM Revanth Reddy was the king of corruption. Harish flags massive land mortgage scam; Seeks SEBI probe against Telangana Govt

Hyderabad, June 26 : Former minister Harish Rao has written a letter to the Chairman of the Securities and Exchange Board of India (SEBI), seeking an urgent investigation into serious irregularities and potential violations of SEBI regulations by the Telangana State Industrial Infrastructure Corporation (TGIIC) and the Government of Telangana.

In the letter, Harish Rao raised strong objections over the mortgaging of 400 acres of land in the Kancha-Gachibowli region, land which has been flagged by a Supreme Court-appointed Empowered Committee as "forestlike" and environmentally sensitive. The same land has reportedly been used to raise large sums through Non-Convertible Debentures (NCDs), allegedly without disclosing its legal and environmental status to lenders or investors. "This is not just a financial violation; it is a betraval of public trust and a misuse of natural resources for questionable financial engineering," Harish Rao stated. The complaint outlines likely violations of the following SEBI provisions: SEBI (Prohibition of Fraudulent and Unfair Trade Practices) Regulations, 2003; SEBI (Issue and Listing of Non-Convertible Securities) Regulations, 2021; SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015; SEBI (Merchant Bankers) Regulations, 1992. Harish Rao also flagged the financial capacity of TGIIC, noting that its annual turnover is reportedly less than ?150 crore, while it is raising thousands of crores through NCDs, a move that raises red flags over repayment ability and disclosure norms. He further questioned the recent conversion of TGIIC from a private limited company to a public limited company, alleging that this structural change may have been carried out without full regulatory transparency or compliance with

Global energy CO2 emissions reached record high last year, report says

Global carbon dioxide emissions from the energy sector hit a record high for the fourth year running last year as fossil fuel use kept rising even as renewable energy reached a record high, the Energy Institute's annual statistical review of world energy showed on Thursday (June 26, 2025).

Why it's importantThe report's figures highlight the challenge of trying to wean the world economy off fossil fuels at a time when conflict in Ukraine has redrawn oil and gas flows from Russia and fighting in the West Asia raises concern about security of supplies.Last year was the hottest year on record, with global temperatures exceeding 1.5 C (34.7 F) above the pre-industrial era for the first time. "Last year was another turning point for global energy, driven by rising geopolitical tensions," Romain Debarre of consultancy Kearney, one of the authors of the report, said in a release.By the numbersThe world saw a 2% annual rise in total energy supply in 2024, with all sources of energy such as oil, gas, coal, nuclear, hydro and renewable energy registering increases, which last occurred in 2006, the report said. This led to carbon emissions increasing by around 1% in 2024 and exceeding the record level set the previous year at 40.8 gigatonnes of carbon dioxide equivalent. Of all the global fossil fuels, natural gas saw the biggest increase in generation, growing 2.5%. Meanwhile, coal grew by 1.2% to remain the largest source of generation globally, while oil growth was under 1%. Wind and solar energy expanded by 16% in 2024, nine times faster than total energy demand, the report showed.



"COP28 set out a bold vision to triple global renewables by 2030, but progress is proving uneven and despite the rapid growth we have seen globally we are still not at the pace required," said Wafa Jafri, a partner at KPMG.COP28 was the United Nations Climate Change Conference that took place in Dubai in 2023, at which countries signed a pact to transition away from fossil fuels in energy systems to achieve net-zero emissions by 2050.ContextIndustry body the Energy Institute, which comprises energy professionals across levels, together with consultancies KPMG and Kearney, took over from BP last year to author the report.Analysts tracking progress have said the world is not on course to meet a global goal of tripling renewable energy capacity by 2030 despite record amounts being added. the Companies Act and SEBI guidelines.

In the letter, Harish Rao stated that merchant bankers were paid over 169 crore plus GST to structure these transactions, despite the questionable status of the land used as collateral. "This issue concerns not only regulatory compliance, but also environmental responsibility and public interest," he wrote, urging SEBI to investigate the entire chain of transactions and hold all parties accountable. The complaint was accompanied by supporting documents, including government orders, Assembly records, and a Supreme Court case reference. Harish Rao urged SEBI to act without delay, warning that continued silence could set a dangerous precedent for the misuse of public assets. (

Despite holding a village-level panchayat in the presence of elders, the opposing party reportedly failed to present any valid proof of ownership."

Dental surgeons lack formal surgical training to perform hair transplants, Telangana Medical Council clarifies

Hyderabad: Telangana Medical Council on Thursday issued a notice to the general public stating that dentists (Bachelor in Dental Surgery), dental surgeons, oral and maxillofacial surgeons (Master in Dental Surgery) lack the formal surgical knowledge and training to perform aesthetic procedures and hair transplants.

The Council said that hair transplant should preferably be undertaken only by those who have surgical grooming like formal surgical training such as MCh/DNB Plastic Surgery, MD/DNB Dermatology with adequate grooming in dermatological surgical procedures."It is also noted that the above named specialities have Hair Transplantation as a core topic in their curriculum," the notice said.

The Council also said that aesthetic procedures should be undertaken only by those RMPs (Registered Medical Practitioners) who have adequate training to perform these procedures as per their curriculum. "So, curriculum of various specialties should be the guiding principle for all RMP's while undertaking any procedure including aesthetics and hair transplant procedures."









Brazil auctions off several Amazon oil sites

Brasilandia: Brazil auctioned off several land and offshore potential oil sites near the Amazon River on Tuesday as it aims to expand production in untapped regions despite protests from environmental and Indigenous groups. The event came months before Brazil is to host the UN's first climate talks held in the Amazon. The protesters outside venue warned of potential risks that oil drilling poses to sensitive ecosystems and Indigenous communities in the Amazon.A luxury Rio de Janeiro hotel hosted the auction conducted by the National Oil Agency. Most of the 172 oil blocks for sale are located in areas with no current production, such as 47 offshore locations close to the mouth of the Amazon River and two sites inland in the Amazon near Indigenous territories.Nineteen offshore blocks were awarded to Chevron, ExxonMobil, Petrobras and CNPC. The oil companies see the area as highly promising because it shares geological characteristics with Guyana, where some of the largest offshore oil discoveries of the 21st century have been made

This region is considered to have high potential risk due to strong currents and the proximity to the Amazon seashore. Under public pressure from President Luiz Inácio Lula da Silva, the Brazilian Institute of the Environment and Renewable Natural Resources, known as IBAMA, approved an emergency plan allowing state-run Petrobras to conduct exploratory drilling in a block near the mouth of the Amazon River, the last step to grant an environmental license. "It's regrettable and concerning that blocks are being acquired in a basin that has not yet received environmental licensing," Nicole Oliveira, executive director of the environmental nonprofit Arayara, which tried to block the auction in court.

"This is an irresponsible move by the National Oil Agency and a very risky one for the companies involved," Oliveira said. "We will continue litigating to prevent the contracts from being signed and the blocks from being explored."The auction wrapped up with only 34 oil blocks awarded. Brazil's oil agency noted that the signing bonuses — one-time payments made by the winning companies totaled \$180 million, a record for auctions of this kind.

An agency representative said the highest premium was for a block located near the mouth of the Amazon River, which drew a nearly 3,000% markup. Oliveira took part in a peaceful protest that gathered about 200 people outside the auction site, from environmentalists to Indigenous leaders."We came to Rio to repudiate the auction." said Giovane Tapura of the Manoki, an Amazon tribe. "We would have liked to be consulted and to see studies on how the oil drilling could affect us. None of this has been done."In a recorded opening statement at the start of the event, Brazil's National Oil Agency said the auctions are part of the country's energy diversification strategy aimed at transitioning to a low-carbon economy and that contracts signed with the winning companies include measures to reduce carbon intensity in production activities, as well as mandatory investments in energy transition projects.Brazil has increased crude oil production, which became the country's top export for the first time last year, surpassing soybeans. The auction is part of the federal government's goal to maintain and even expand output beyond 2030, when production from current oil blocks under exploration is expected to decline. Brazil gets most of its electricity from hydropower and other green energies. The UN climate talks will be held in the city of Belem, close to the mouth of the Amazon.Critics say it's a contradiction that Brazil's president is pushing for increased fossil fuel production while trying to cast himself as an environmental champion. Claudio Angelo, head of international policy at Climate Observatory, a coalition of 133 environmental, civil society and academic organizations, told reporters ahead of the auction that Brazil is both undermining its own standing ahead of the climate talks and

tions to mitigate civilian harm."On Tuesday, Gaza's health ministry said 397 Palestinians among those trying to get food aid had been killed and more than 3,000 wounded since aid deliveries restarted in late May.Some in Gaza expressed concern that the latest escalations in the war between Israel and Hamas that began in October 2023 would be overlooked as the focus moved to Israel's five-day-old conflict with Iran."People are being slaughtered in Gaza, day and night, but attention has shifted to the Iran-Israel war. There is little news about Gaza these days," said Adel, a resident of Gaza City."Whoever doesn't die from Israeli bombs dies from hunger. People risk their lives every day to get food, and they also get killed and their blood smears the sacks of flour they thought they had won," he told Reuters via a chat app.Israel has been channelling much of the aid it is now allowing into Gaza through a new U.S.- and Israeli-backed group, the Gaza Humanitarian Foundation, which operates a handful of distribution sites in areas guarded by Israeli forces. It has said it will continue to allow aid into Gaza, home to more than 2 million people, while ensuring aid doesn't get into the hands of Hamas. Hamas denies seizing aid, saying Israel uses hunger as a weapon against the population in Gaza.

The Gaza war was triggered when Hamas-led militants attacked Israel in October 2023, killing 1,200 and taking about 250 hostages, according to Israeli allies.U.S. ally Israel's subsequent military assault on Gaza has killed nearly 55,000 Palestinians, according to Gaza's health ministry, displaced almost all the territory's residents, and caused a severe hunger crisis. The assault has led to accusations of genocide and war crimes, which Israel denies.Palestinians in Gaza have been closely following Israel's air war with Iran, long a major supporter of Hamas."We are maybe happy to see Israel suffer from Iranian rockets, but at the end of the day, one more day in this war costs the lives of tens of innocent people," said 47-year-old Shaban Abed, a father of five from northern Gaza."We just hope that a comprehensive solution could be reached to end the war in Gaza, too. We are being forgotten," he said.

When Israel launched an all-out air war against Iran on June 13, it said the attack was aimed at destroying Iran's nuclear programme. On day one, Israel bombed Iran's Natanz nuclear facility and several ballistic missile sites, besides assassinating the country's top Generals, including the chief of the armed forces. In the subsequent days, Israel bombed the nuclear facility in Isfahan, Iran's command centres, missile launchers, civilian locations and even the headquarters of the state TV. Israel has established air superiority over Iran. In retaliation, Iran launched close to 400 missiles, hitting several targets in Israel, including an oil refinery in Haifa and a top research institute near Tel Aviv.

While the air war is escalating, there are questions about Israel's endgame. What does Prime Minister Benjamin Netanyahu want?

If it is the destruction of Iran's nuclear programme, Israel is far from achieving it. The International Atomic Energy Agency (IAEA), the UN's nuclear watchdog, said on June 16 that Israel's attack "severely damaged if not entirely destroyed" the centrifuges at the Natanz facility. The Israeli strike had "completely destroyed" the above-ground facility at Natanz, according to IAEA chief Rafael Grossi. The underground hall housing the centrifuges that enrich uranium was not directly hit. "However, the loss of power to the cascade hall may have damaged the centrifuges there," he said. Mr. Grossi also said four buildings were destroyed at the Isfahan Nuclear Technology Centre - a chemical lab, a uranium conversion plant, a fuel manufacturing plant, and a facility to convert uranium hexafluoride to uranium metal. But there was no major damage to the Fordow enrichment plant, which is Iran's most fortified facility that has been built deep under a mountain. As Israel has aerial superiority, it can continue to bomb Iran. But there are two problems. One, Israel doesn't have the kind of bunker buster bombs or strategic bombers that can carry such bombs to destroy heavily fortified facilities such as Fordow. Therefore, Israel's offensive is not going to be concluded any time soon. And two, despite Israel taking out most of Iran's chain of command in the initial strike, Tehran is hitting back with drones and ballistic missiles. Israel's air strikes in Iran have not reduced the intensity of Iranian missile barrages. At least 24 people have been killed so far in Israel. The Ben Gurion airport in Tel Aviv, the country's main airport, remained shuttered. If Israel's air strikes do not blunt Iran's fire power, Mr. Netanyahu could come under greater pressure at home to

wrap up the war quickly. And if Israel accepts a ceasefire without destroying Iran's nuclear facilities, it could be seen as defeat.

What is Netanyahu's endgame in Iran?

One is to continue the relentless bombing of Iran, destroying state institutions and infrastructure, decapitating the regime and pushing for a state collapse or regime change in Tehran. On June 15, while speaking to Fox News, Mr. Netanyahu said Israel's attack could lead to regime change in Iran. The next day, he refused to rule out assassinating Ayatollah Ali Khamenei, Iran's Supreme Leader, saying killing him would end the conflict. But there is a grey area. Before starting the war, Mr. Netanyahu had urged the Iranians to rise against their government. But when Israel started widespread bombing across the country, killing hundreds of Iranians, it was an 'I-told-you' moment for the Iranian government, who always warned the public of the threats from "the Zionist entity". So it is to be seen whether the Israeli bombings would weaken or strengthen the political and social roots of the regime. Even after the Israeli strike began, U.S. President Donald Trump said he was open for a deal with Iran. On June 16, there were reports that Iran had sent feelers to America through Gulf Arab countries that it was ready to return to talks if Israel stopped bombing. Mr. Trump's initial posts suggested that he wanted to use the Israeli strikes as an added layer of pressure on the Iranians to get the deal he wanted. While Iran is ready to scale back the programme, it is not ready to give up its capabilities. Mr. Trump wants Iran to completely abandon its nuclear programme. Even if Iran is ready to seriously consider Mr. Trump's offer, will they return to talks when the country is under attack? So far Iran has said no. So the next question is whether Mr. Netanyahu will stop his attacks to facilitate talks between the U.S. and Iran? If that would be the case, why did Mr. Netanyahu start the war in the first place, three days ahead of a sixth round of talks between the U.S. and Iran? This indicates that a nuclear deal between the U.S. and Iran has never been Israel's priority. The third option is to drag the U.S. into the war. Mr. Trump has so far maintained that America is not involved in the war. But he admitted that he was aware of Israel's attack plans even when he publicly voiced opposition to them. Israeli officials say they went ahead after getting "a clear green light" from the U.S. Mr. Trump has warned Iran not to target American bases or soldiers. And Iran has been careful not to escalate the war beyond Israel. But Israeli officials, according to Axios, are pressing the U.S. to join the war because Israel needs American military involvement to meet their objectives - total destruction of Iran's nuclear facilities either through direct strikes or through regime change. If Tehran falls, that would be an added boost for Israel's efforts to reshape West Asia. The Assad regime in Syria is already gone. Iran's network of militants has been weakened. Gaza lies in ruins. In the West Bank, Israel is free to do whatever it wants to do. Arab nations voice protests meekly. If Iran is weakened, Russia's remaining strategic influence in West Asia will shrink further. China will be more dependent on America's Gulf Arab allies for oil. Mr. Trump's position, as of now, is to let Israel continue the bombing. He will not call for a ceasefire. But as the war drags on, with both Israel and Iran hitting each other, Mr. Trump will come under greater pressure to join the war.

Hypersonic missiles Fattah-1 fired at Israel, says Iran

Iran said early GNS News Agency, June 26, it fired hypersonic missiles at Israel in the latest round of overnight strikes between the archfoes, hours after Donald Trump demanded the Islamic republic's "unconditional surrender". The U.S. president insists Washington has played no part in ally Israel's bombing campaign, but also warned Iran his patience is wearing thin as the conflict enters a sixth day. Israeli warplanes targeted the Iranian capital before dawn Wednesday after the military issued a warming for civilians to leave one district for their safety.

Zelenskiy leaves G7 with no Trump meeting or fresh arms support from US

KANANASKIS, Alberta, GNS News Agency, June 26, Ukrainian President Volodymyr Zelenskiy left the Group of Seven summit on Tuesday with new aid from host Canada for its war against Russia but said diplomacy is in "crisis" having missed the chance to press U.S. President Donald Trump for more weapons. The G7 wealthy nations struggled to find unity over the conflict in Ukraine after Trump expressed support for Russian President Vladimir Putin and left a day early to address the Israel-Iran conflict from Washington. A Canadian official initially said Ottawa had dropped plans for the G7 to issue a strong statement on the war in Ukraine after resistance from the United States. Emily Williams, director of media relations for Prime Minister Mark Carney, later said no proposed statement on Ukraine had ever been planned.

Carney had started the day by announcing Ottawa would provide C\$2 billion (\$1.47 billion) in new military assistance for Kyiv as well as impose new financial sanctions.Zelenskiy said he had told the G7 leaders that "diplomacy is now in a state of crisis" and said they need to continue calling on Trump "to use his real influence" to force an end to the war, in a post on his Telegram account.Although Canada is one of Ukraine's most vocal defenders, its ability to help it is far outweighed by the United States, the largest arms supplier to Kyiv. Zelenskiy had said he hoped to talk to Trump about acquiring more weapons.

After the summit in the Rocky Mountain resort area of Kananaskis concluded, Carney issued a chair statement summarizing deliberations. "G7 leaders expressed support for President Trump's efforts to achieve a just and lasting peace in Ukraine," it said. "They recognized that Ukraine has committed to an unconditional ceasefire, and they agreed that Russia must do the same. G7 leaders are resolute in exploring all options to maximize pressure on Russia, including financial sanctions."Canada holds the rotating G7 presidency this year. Other leaders do not need to sign off on G7 chair statements.Trump did agree to a group statement published on Monday calling for a resolution of the Israel-Iran conflict."We had a declaration given the exceptional, fast moving situation in Iran," Carney told a closing



news conference

A European official said leaders had stressed to Trump their plans to be hard on Russia and Trump seemed impressed, though he does not like sanctions in principle. Three European diplomats said they had heard signals from Trump that he wanted to raise pressure on Putin and consider a U.S. Senate bill drafted by Senator Lindsey Graham, but that he had not committed to anything."I am returning to Germany with cautious optimism that decisions will also be made in America in the coming days to impose further sanctions against Russia," German Chancellor Friedrich Merz said.G7 leaders agreed on six other statements, about migrant smuggling, artificial intelligence, critical minerals, wildfires, transnational repression and quantum computing. Trump said on Monday he needed to be back in Washington as soon as possible due to the situation in the Middle East, where escalating attacks between Iran and Israel have raised risks of a broader regional conflict. A White House official on Tuesday said Trump explained that he returned to the U.S. because it is better to hold high-level National Security Council meetings in person, rather than over the phone. Upon arriving at the summit, Trump said that the then-Group of Eight had been wrong to expel Russia after Putin ordered the occupation of Crimea in 2014.

The Israeli military later said it struck weapons manufacturing sites and a facility used to make centrifuges in Tehran.Iran told residents of Tel Aviv to prepare for an attack, with the Islamic Revolutionary Guard Corps claiming its hypersonic Fattah-1 missiles were "repeatedly shaking the shelters" in the commercial hub. US pulls out from vaccines alliance from Gavi, says it has lost public trust

London: US Health Secretary Robert F Kennedy Jr said the country is pulling its support from the vaccines alliance Gavi, saying the organisation has "ignored the science" and "lost the public trust."A video of Kennedy's speech was shown to participants at a Gavi meeting in Brussels on Wednesday, where the vaccines group was hoping to raise at least USD 9 billion for the next five years.Gavi is a public-private partnership including WHO, UNICEF, the Gates Foundation, and the World Bank. It has paid for more than 1 billion children to be vaccinated through routine immunisation programmes, saving an estimated 18 million lives. The US has long been one of its biggest supporters; before Trump's re-election, the country had pledged USD 1 billion through 2030.

Kennedy called on Gavi "to re-earn the public trust and to justify the USD 8 billion America has provided in funding since 2001," saying officials must "consider the best science available, even when that science contradicts established paradigms."Kennedy said until that happens, the US won't contribute further to Gavi. Kennedy, a longtime vaccine sceptic, said he and President Trump were concerned about how Gavi and the World Health Organisation partnered together during the COVID-19 pandemic to work with social media companies "to silence dissenting views, to stifle free speech and legitimate questions" during a time when many people had questions about vaccine safety.

Kennedy said Gavi continues to make "questionable recommendations," like advising pregnant women to get immunized against COVID-19 and funding the roll-out of a vaccine against diphtheria, tetanus, and pertussis in poorer countries.WHO and other health authorities have recommended that pregnant women get vaccinated against COVID-19, saying they are at higher risk of severe disease. Kennedy said he has seen research that concluded that young girls vaccinated against diphtheria, tetanus, and



pertussis were more likely to die from all other causes than children who weren't immunized.Gavi said in a statement Thursday that its "utmost concern is the health and safety of children." The organisation said any decision it makes on vaccines to buy is made per recommendations issued by WHO's expert vaccine group."

This ensures Gavi investments are grounded in the best available science and public health priorities," it said. Gavi said scientists had reviewed all available data, including any studies that raised concerns, and that the diphtheria, tetanus, and pertussis vaccine has "played a key role in helping halve childhood mortality."The British government said Wednesday it would give 1.25 billion pounds (USD 1.7 billion) between 2026 and 2030 to Gavi. It said the money would help Gavi protect up to 500 million children in some of the world's poorest countries from diseases including meningitis, cholera, and measles.

Two existing drugs offer hope to cure Russell's viper bites



Studies carried out in mice have demonstrated that two approved drugs — varespladib and marimastat — were effective in countering systemic and lethal effects of Russell's viper (Daboia russelii) venom either individually or in combination. The two drugs were tested against Russell's vipers venom sourced from different States across India. Russell's vipers are responsible for over half of India's snakebite cases. The study led by Dr. Kartik Sunagar, Professor, Centre for Ecological Sciences at IISc, Bangalore, was published recently in the journal Communications Medicine.

Dr. Sunagar and his team are now working with ICMR to design a human clinical trial to test the two drugs. "During the trial, the drugs will be used as an ancillary treatment to determine how effective they would be in treating snakebites," he says. The control group control will receive only the antivenom but not the drugs.Phospholipase A2 (PLA2), and Snake Venom Metalloproteinase (SVMPs) are two main components of Russell's viper snake venom. These toxins interfere with components of the blood clotting cascade to induce anticoagulant and haemorrhagic effects in humans. While the varespladib drug inhibits PLA2, the marimastat drug inhibits SVMP. Venom influencing factors

"In a 2021 study, we found differences in venoms of Russell's vipers from across India depending on the biogeography where they were found. In a follow-up study, we showed that diet and development probably had a major influence in dictating the differences in the venom of Russell's viper," says Dr. Sunagar. "Another study published recently [April 2025] found that climatic conditions, such as temperature and rainfall, can also indirectly have a small effect on venom variation.""In the Western Ghats, characterised by heavy rainfall and dense forests, a rich variety of amphibians and arthropods thrive, providing snakes with a diverse diet. In contrast, arid regions experience limited rainfall and sparse plant cover, resulting in reduced diversity of prey available for snakes," Dr. Sunagar says. "Temperature can also influence gene expression, though the extent to which this affects venom variation remains unclear. However, it is likely that temperature changes indirectly alter venoms by affecting the availability of prey composition in the region."Differences in venom

In the latest study, Russell's viper venom from Puniab and Tamil Nadu exhibited the highest PLA2 activity, followed by other regions - Kerala, Maharashtra, Goa, and Madhya Pradesh. Russell's viper snake venom from all other regions exhibited minimal PLA2 activity. Proteinase activity was highest in Karnataka followed by the Rajasthan, Madhya Pradesh, Goa, and Andhra Pradesh regions. In contrast, venom from Tamil Nadu exhibited little to no activity, while venom samples from other regions exhibited modest proteolytic activity. Effectiveness of drugs The PLA2 inhibitor varespladib was found to neutralise even the high PLA2 activity of the venom found in Tamil Nadu and Punjab. The varespladib drug effectively inhibited the modest PLA2 activity of the venom from other Indian regions. In the case of the matrix metalloprotease-inhibiting drug, marimastat, the drug effectively inhibited the venom in a concentration-dependent manner. The drug was effective even when the proteolytic activity was high, as seen in Karnataka. As expected, the drug exhibited highly potent inhibitory effects against the venom with moderate activity, as seen in Madhya Pradesh, Rajasthan, and Goa.

Overall, the drugs varespladib and marimastat when used individually or in a therapeutic drug combination were found to be very effective in reducing venom-induced cytotoxicity, venom-induced coagulopathy, and fibrinogenolysis. When used individually, the drugs were effective in reducing the venom-induced cytotoxicity by snake populations from some regions while being less effective in the case of venom from some other regions. However, the therapeutic combination of varespladib and marimastat nearly completely inhibited these activities. To replicate the real-world scenario and to test the effectiveness of the drugs after the venom challenge, the researchers administered the drug 30 minutes after venom delivery.

Rescue experiments involving PLA2-rich snake venom from Punjab revealed that the varespladib drug conferred complete protection against venom-induced lethality even when the drug was administered 30 minutes after venom injection. In contrast, marimastat was ineffective in rescue experiments even when the drug was administered soon after venom delivery. In the case of venom from Karnataka, the Marimastat drug provided only 40% survival rate against the SVMP-rich venom at the end of 24 hours even when the drug was administered soon after venom injection.In the case of venom from Madhya Pradesh, which is rich in both SVMP and PLA2, varespladib and marimastat individually provided only 60% and 40% protection, respectively, when dosed immediately after venom challenge. But a therapeutic combination of the two drugs conferred complete protection from venom-induced lethality even when the drugs were administered 30 minutes after venom injection. According to Dr. Sunagar, since the body size of mice is extremely small, where they weigh between 18-22 grams, 30 minutes delay in administering the drug is perhaps equivalent to many hours delay in treating patients bitten by a Russell's viper. Even in a single State, the snakes might be producing a different type of toxin in different parts of the State. For instance, in Karnataka, one drug is effective in the southern part of the State, while the other drug is effective in the northern part of the State. "Given this stark variation in venoms, clinical trials must be conducted across various regions of India. Initially, we will begin the clinical trials in select regions and gradually expand them to cover most areas throughout the country. Once the trials are completed, we will determine which drug(s) are necessary for treatment in each specific region," Dr. Sunagar says. The targeted approach will help in treating patients with a single effective drug or the drug combination instead of blindly using the two drugs in combination across the country and thereby reducing dose effectiveness.

The story so far: On June 16, the Ministry of Defence said in a statement that IIT-Delhi scientists together with the Defence Research and Development Organisation (DRDO) demonstrated quantum communication over a distance of more than 1 km in free space. The development was hailed as a breakthrough in quantum cybersecurity.

What is quantum communication?

When two or more photons, the subatomic particles of light, are created in just the right way, measurements made on one photon will instantly determine the result for the partner photon, too - even if the photons are far apart. This phenomenon is called quantum entanglement. Ordinary or classical physics can't explain this correlation, it's a purely quantum phenomenon. Quantum communication is an umbrella term for any scheme that uses the concepts of quantum physics, but especially entanglement, to make a given communication channel leak-proof. In one scheme, like the one the IIT-Delhi team demonstrated, entangled photons carry information from a source to two stations. If any third party intercepts one of the photons, the other photon will immediately be disturbed as well and the channel will be revealed as insecure. In short, quantum communication can be used to create communication channels that are protected against computational attacks since any attempt to tap the quantum channel will itself be revealed. Thus they have great value in defence settings. An important method in quantum communication is quantum key distribution (QKD).

How does QKD work?

If Bala has a message for Selvi that he wants only Selvi to receive, a simple way is to send a letter. At the address, the postal worker will deposit the letter into a letterbox. The location of the letterbox is public knowledge, but only Selvi will have the key to access it. The key is private knowledge. Receiving email works similarly: Bala will send an email to Selvi's email ID (public knowledge) and Selvi will use her password (private knowledge) to access it.QKD is a specialised form of quantum communication whose sole purpose is to help Bala and Selvi possess identical secret keys. Once they both have the key, they can unlock and read the messages they send each other.

Note that QKD doesn't encrypt the message itself: that's achieved using traditional algorithms like AES. Instead QKD helps both parties acquire the key to unlock that encryption in a secure way. There are two kinds of QKD. In the classic prepare-and-measure way, Bala prepares single photons in some predetermined states and Selvi measures them. In entanglement-based QKD, a source creates entangled photon pairs and sends one photon to Bala and the other to Selvi.

What did the IIT-Delhi team do?

What is IIT-Delhi's quantum

communications breakthrough? | Explained

The IIT-Delhi team, led by Prof. Bhaskeri Kanseri transmitted keys through the air using entanglement-based QKD, across a distance of 1 km in the IIT campus. This is a step up from transmitting photons through an optical fibre. The greater goal here is to establish reliable QKD between a ground station and a satellite orbiting the earth hundreds of kilometres up. This way the satellite can distribute keys to receivers anywhere in India by beaming photons through the atmosphere.Notably, the test demonstrated "a secure key rate of nearly 240 bits per second with a quantum bit error rate of less than 7%". When the photons reach Bala and Selvi, they will measure each particle. Since they're entangled, the measurements have to match up. In this case the measurements disagreed <7% of the time, which is considered acceptable for the present scheme. Common sources of error include turbulence in the air, detector noise, and artificial lighting. Previously, Prof. Kanseri's team had demonstrated a guantum communications link between Vindhyachal and Prayagraj in Uttar Pradesh in 2022. The year after, they increased the distance to 380 km with a spool of standard telecom fibre and a quantum bit error rate of 1.48%. In 2024, they established a QKD scheme through more than 100 km of an optical fibre link.

What next?

The IIT-Delhi team demonstrated the technology in the presence of dignitaries from the DRDO, the institute, and the Directorate of Futuristic Technology Management, including the director of the DRDO-Industry-Academia Centre of Excellence at the IIT.After the event, Minister of Defence Rainath Singh said India had "entered into a new guantum era of secure communication which will be a gamechanger in future warfare." These changes entail a quantum network with multiple nodes maintaining quantum communications. In 2021, China created the world's first quantum network with two ground-to-satellite links and optical fibres together covering 4,600 km.Quantum communications has important civilian applications too, especially in the banking and telecom sectors. A future 'quantum internet' of the sort the U.S. expects to possess by the mid-2030s could also enable distributed quantum computing, ultra-precise sensing, and network-wide secure time synchronisation in addition to secure messaging. To help scientists develop such technologies, the Indian government approved the National Quantum Mission in 2023 with an outlay (2023-2031) of Rs 6,000 crore.

The future of Abujhmad

Abujhmad, a dense and nearly impenetrable forest region, is the only largely unsurveyed area in the country. In a world that idolises perfection, vitiligo tells a strikingly different story — one of resilience, uniqueness, and rediscovered beauty. Vitiligo is a skin condition where the body loses its pigment in patches, turning areas of the skin white due to the loss of melanin. India is home to one of the highest populations affected by vitiligo globally, with studies showing a prevalence ranging from 0.46% to 2.16%. That means that millions live with this condition — often silently, and sometimes, undiagnosed, in the shadows of misconceptions.

What causes it?

Vitiligo is an autoimmune condition where the body's immune system mistakenly attacks its own pigment-pro-

ducing cells. It can also be triggered by genetics, thyroid dvsfunctions, or skin trauma. It can occur at any stage in life - across genders, ages, and skin tones. There is no permanent cure for vitiligo as yet; however, several treatments can help to manage and reduce progression of the condition. These include: topical creams to encourage repigmentation; phototherapy (UVB light therapy). Surgical options such as mini punch grafting, blister grafting and splitthickness skin grafting give excellent re-pigmentation in stable cases. There are also options for cosmetic coverage for those who choose it and certain oral medications including immunosuppressants, as well as multivitamins, to arrest progression and for repigmentation. Consulting a dermatologist is essential to decide what is best for each individual. Emotional support and counselling often prove just as important as medical care.Fact: It is a skin condition that requires treatment as it impacts emotional and mental well-being.Working on normalisation and empowermentTo date, many react to vitiligo with curiosity or stigma - simply because they do not understand it.

World Vitiligo Day, observed every year on June 25, reminds us that awareness can lead to acceptance. And acceptance is the first step towards empowerment.Let us start conversations that celebrate differences. Let us raise children who see contrast as character. Let us create a society where no one has to hide their skin to feel seen. Because every shade tells a story — and sometimes, the brightest stories are written in white.

Dopamine makes it hard to put down our phone. Here's why

Ever find yourself unable to stop scrolling through your phone, chasing that next funny video or interesting post? Or maybe you've felt a rush of excitement when you achieve a goal, eat a delicious meal, or fill your online shopping cart.Why do some experiences feel so rewarding, while others leave us feeling flat? Well, dopamine might be responsible for that. Here's what it does in our brains and bodies.Dopamine is a neurotransmitter - a chemical messenger that facilitates communication between the brain and the central nervous system. It sends messages between different parts of your nervous system, helping your body and brain coordinate everything from your movement to your mood.Dopamine is most known for its role in short-term pleasure, and the boost we get from things such as eating tasty foods, drinking alcohol, scrolling social media or falling in love.Dopamine also assists with learning, maintaining focus and attention, and helps us store memories. It even plays a role in kidney function by regulating the levels of salt and water we excrete. Conversely, low levels of

dopamine have been linked to neuro-degenerative disorders such as Parkinson's disease.Dopamine is not just active when we do pleasurable things. It's active beforehand and it drives us to pursue pleasure. Say I go to a cafe and decide to buy a doughnut. When I bite into the doughnut, it tastes fantastic. Dopamine surges and I experience pleasure. The next time I walk past the cafe, dopamine is already active. It remembers the doughnut I had last time and how delicious it was. Dopamine drives me to walk back into the cafe, purchase another doughnut and eat it. From an evolutionary perspective, dopamine was incredibly important and it ensured survival of the species. It motivated behaviours such as hunting and foraging for food. It reinforced the pursuit of finding shelter and safety and keeping away from predators. And it motivated people to seek out mates and to reproduce. However, modern technology has amplified the effects of dopamine. leading to negative consequences. Activities such as excessive social media use, gambling, consuming alcohol, drug use, sex, pornography and gaming can stimulate dopamine release, creating cycles addiction and compulsive behaviours

The Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, gives special rights to forest-dwelling communities. Abujhmad also produces what is possibly the purest form of organic food. Will there be efforts to leverage this unique opportunity? In the sal forest of Abujhmad, mahua trees flourish. Like many other Adivasi women, Abujhmadiya women also collect mahua flowers and make liquor out of it. Will there be efforts to establish an Abujhmad Mahua Union Limited, akin to Amul, so that Abujhmadiya mahua liquor can be sold worldwide and the profit can go to Abujhmadiya mahua collectors? If liberation means only opening a mahua liquor factory, that may not help the Abujhmadiyas much.CGnet Swara, an NGO I founded, is trying to start a platform called Abujhmad AI-R (Artificial Intelligence Radio). This will have an AI agent which will ask hundreds of Abujhmadiyas about their problems and what development they wish to see in their region. A radio programme will be made from this and taken to government officials. Will the officials listen to their voices?Deep inside Abujhmad, an Adivasi Maoist once told me, "We are not 'terrorists'; we are journalists like you. We use guns to make loud noises like Bhagat Singh because the media does not listen to us. Can you come up with a media that is not owned by a few and gives equal respect

The rich repository of Tamil heritage and culture has largely remained invisible to the wider world, said Nirmala Lakshman, Publisher and Chairperson of The Hindu Group of Publications, speaking at a discussion on her book The Tamils, at the Bangalore International Centre here.Ms. Lakshman described how it took her four years of multiple journeys across Tamil Nadu, studying, researching and listening to stories of people, to come up with the book."I spoke to epigraphists, historians, experts as well as ordinary people who generously shared their experiences, their sense of culture and tradition, and I discovered that multiple narratives coexisted," she noted. It was during this journey, Ms. Lakshman said, that she realised how a large part of it still remained unknown to the larger world."Many expert voices had not been heard outside of Tamil Nadu and Tamil world which led me to realise that the wealth of knowledge of the rich repository of Tamil heritage and culture has not been visible to larger world, and the nuanced and better-informed reading of Tamil history and society as seen through their eyes could be highlighted in my book.""Through The Tamils, I hope to convey my personal insights to what I have learned about Tamil culture, history and literature to an audience of not just Tamil people, but also to non-Tamil speaking people everywhere," she further added. The discussion, moderated by Ranvir Shah, founder of Prakriti Foundation, and introduced by Ramachandra Guha, writer and historian, delved into multiple aspects that have shaped the Tamil identity."The Tamil diaspora is as strong in Tamil as people in Tamil Nadu are. In places like Malaysia, there is a thirst to know more about one's roots," said Ms. Lakshman, who further added that the research for the book was a journey of discovery for her too. According to her, Tamils, as with many other communities, are a complex demographic and carry with them a weight of history that goes back several millennia. Pointing out that there are about 90 million people across the world who identify themselves as Tamil, she recollected how, when she visited places like Malaysia, the diaspora there expressed a strong desire to know more about their roots, despite having migrated at least three generations ago."In this book, I tried to find that Tamil essence as I weave through history and story, talking to a wide spectrum of people. What is the procedure for removing judges? | Explained

Articles 124 and 217 of the Constitution provide that a judge of the Supreme Court/High Court shall be removed by the President, on the grounds of 'proved misbehaviour' or 'incapacity' after a motion is passed in each House of Parliament by a majority of the total membership of that House and by a majority of not less than two thirds of the members of that House present and voting (special majority) in the same session. The Constitution does not define the terms 'proved misbehaviour' or 'incapacity.' The Supreme Court has opined in various cases that wilful misconduct in office, corruption, lack of integrity or any other offence involving moral turpitude would constitute misbehaviour. Incapacity here means a medical condition that may include physical or mental incapacity.

The detailed procedure for removal is provided in the Judges (Inquiry) Act, 1968. It stipulates that a notice of motion for removal should be signed by not less than 50 members in the Rajya Sabha and 100 members in the Lok Sabha. The Chairman or Speaker may after due consideration and consultation admit or refuse to admit the motion. If admitted, a three-member committee will be constituted consisting of Supreme Court/High Court judges and a distinguished jurist. If the Committee, after investigation, absolves the judge of any misbehaviour or incapacity, the motion pending shall not be proceeded with. If found guilty

of misbehaviour or suffering from incapacity, the committee report will be taken up in the Houses of Parliament which would then need to pass the motion with special majority.

What is the current issue?

Justice Yadav made communally-charged remarks while speaking at an event organised by the Vishwa Hindu Parishad. He is reported to have said the country would be run according to the wishes of the majority. The 'Reinstatement of Values of Judicial Life' adopted by the Supreme Court in 1997, and followed by all the High Courts, mandates that behaviour and conduct of members of the higher judiciary must reaffirm people's faith in the impartiality of the judiciary. The judges should not commit any act of omission or commission that is unbecoming of the high office they occupy. Notably, though the Judges (Inquiry) Bill, 2006 was not passed by the Parliament, it defined 'misbehaviour' to include violation of code of conduct for the judges. This bill proposed imposition of 'minor measures,' like issuing warnings, public or private censure, withdrawal of judicial work for a limited time etc., for misconduct that does not warrant removal

What is required?

The Blackstone's ratio in criminal jurisprudence that 'it is better that ten guilty persons escape than that one innocent suffer' can be applied even when it comes to the removal of judges. The stringent process with the requirement of special majority in both houses has resulted in the non-removal of judges even after having been found guilty of misbehaviour by the inquiry committee. This is nevertheless essential to protect the independence of judges while discharging their duties. The Chairman of the Rajya Sabha, against whom himself a notice of motion for removal has been submitted, is unlikely to admit the present motion. The Supreme Court has issued a notice seeking details of the controversial speech made by Justice Yadav. The Judge is likely to appear before the Supreme Court Collegium to explain his stand. It is cardinal that Judges display behaviour that behoves the high constitutional office they hold.

How does La Niña affect India's climate? | Explained

La Niña, a phase of the El Niño Southern Oscillation (ENSO), occurs when the region of the Pacific Ocean between Indonesia and South America is cooler than usual. Its counterpart, El Niño, represents a warming of the same region. These two phases significantly influence global atmospheric circulation and weather patterns. During La Niña years, India receives normal or above-normal rainfall during the monsoon season. Yet the same phenomenon causes droughts in Africa and intensifies hurricanes over the Atlantic Ocean. Conversely, the El Niño brings extreme summers and droughts in India while increasing rainfall in the southern United States. While the La Niña was expected to emerge by July this year, it is yet to. The India Meteorological Department now expects a La Niña to set in by late 2024 or early 2025, plus a milder winter due to this delay. This decade began with three consecutive La Niña events (2020-2022), a rare occurrence known as Triple Dip La Niña, followed by an El Niño in 2023. Climate change may increase the frequency and intensity of both La Niña and El Niño events, as rising sea and land temperatures disrupt the Pacific's balance. This could also amplify extreme La Niña events, which generally lead to harsh winters in India.

Will a La Niña emerge this winter?

2024 is different: the U.S. National Oceanic and Atmospheric Administration in fact called it "spooky". The La Niña has not emerged as expected. Historically, the La Niña has usually formed during the monsoon or the pre-monsoon period, and it has formed only twice between October and December since 1950. Global forecasts had also predicted its emergence this monsoon. But in December, there remains only a 57% chance of it forming in 2024. It will be weak if it still does but it could affect global weather. The onset of La Niña or El Niño can be declared on the basis of many indices. For instance, the oceanic Niño index (ONI) compares the three-month average sea surface temperatures in the East-Central Tropical Pacific with the 30-year average. When the difference between the two is 0.5° C or higher, it is an El Niño, and when it is -0.5º C or lower, it is a La Niña. Currently, it is around -0.3º C. To be classified as a full-fledged La Niña or El Niño, ONI values need to exceed the thresholds at least five times consecutively.



sis of meteorological data over 35 years by researchers at the Council on Energy Environment and Water, New Delhi, has revealed that while La Niña winters feature colder nights compared to El Niño, daytime temperatures tend to be higher. Meteorological parameters like wind speed and planetary boundary layer height (PBLH) — the lowest atmospheric layer directly influenced by land-atmosphere interactions — also vary during ENSO phases, affecting air quality. The team found the average wind speed is higher throughout the day during La Niña winters. Faster winds help reduce air pollution by transporting pollutants away. They also found that the average PBLH is slightly lower during La Niña winters. If La Niña sets in, lower tempera-

Solely blaming stubble burning for Delhi's pollution is incorrect

Delhi's air quality has turned extremely bad again with the Air Quality Index (AQI) hovering between severe and very severe category. This deterioration took place over the weekend without the burning of any stubble in the farm fields of Punjab and Haryana. The Delhi AQI on Tuesday crossed 430 and is expected to move upwards this week as the minimum temperature is expected to remain below 5 degrees Celsius range and because wind speed, which helps in disbursal of pollutants, is slow. These facts raise critical guestions for policymakers and scientists who have blamed the farmers in Punjab and Haryana for Delhi' and National Capital Region's (NCR) air pollution. Let's discuss some facts about the annual phenomenon of stubble burning.Normally the period between September and November 30 is considered the stubble burning period in Punjab and Haryana when farm fields are cleared for the winter crop. Stubble burning incidents in Punjab has come down from 81,042 in 2016, from when the data is available, to 10,909 in 2024, an eight-fold fall in eight years. The yearwise data shows that stubble fire incidents increased during Covid-19 pandemic years of 2020 and 2021 even though the air pollution level in Delhi did not spike as it happened in 2023 and 2024: This clearly indicates a delink between stubble fire incidents and Delhi poor air quality. Similarly, stubble burning incidents recorded in Haryana, where paddy stubble burning is 20% of the crop remains that are burnt, also dipped by almost 90% since 2016. In 2024, Haryana reported only 559 incidents of farm fires. Moreover, the department of science and technology's air appropriation analysis cannot distinguish between stubble and non-stubble contribution to air pollution as the measurement is through carbon (soot) content in air and comes under bio-mass burning category. Even satellites cannot distinguish between stubble and non-stubble burning. So, if someone is burning leaves or burning wood for cooking or body warmth in Delhi or anywhere in northwestern India, it will count as biomass burning and will be clubbed with stubble burning. If one drives through Delhi in winter nights, one can see many poor and homeless people burning dry wood or grass to keep themselves warm. The data and historical perspective provide enough evidence that stubble burning is not a major contributor to Delhi's air pollution levels. So, why is Delhi-NCR so polluted in winter? The two primary reasons are the region's very high self-generated air pollution load, which is increasing every year, and very poor dust management by the local authorities. The particulate matter air pollution on whose basis AQI is measured is primarily related to dust and vehicle/industry exhaust. According to a study done by non-government organisation, the Centre for Science and Environment (CSE), the contribution of vehicular exhaust to the air pollution load in Delhi between October 12 to November 3, 2024, was 51.5%. The neighbouring districts such as Gurugram, Sonipat, Rohtak and Faridabad in Haryana and Gautam Budh Nagar in Uttar Pradesh contributed 34.97%. The contribution from neighbouring districts was also on account of vehicles. The study said that the farm fires, read total biomass, contribution was 8.19% and dust particles made up 3.7% of the total air pollution in the city. The analysis was derived from data provided by the Decision Support System for Air Quality Management in Delhi, developed by the Indian Institute of Tropical Meteorology in Pune. Industrial emissions, including sulphur dioxide, nitrogen oxides, and volatile organic compounds, lead to the formation of secondary pollutants like ozone. Vehicle emissions, particularly from heavy traffic, release carbon monoxide, nitrogen oxides, and hydrocarbons, intensifying pollution in congested areas, the study said. Given the government's inability to mitigate pollution levels, the Supreme Court intervened to address the crisis and a bench of Justices Abhay S Oka and Augustine George Masih issues slew of measures including prohibition of polluting vehicles from entering Delhi and not to remove Graded Response Action Plan (GRAP) without its approval. The top court ordered the Delhi government and police to ensure effective enforcement of the firecracker ban and action against polluting vehicles on road. The Delhi-NCR region has been under GRAP since the first week of November but its impact on controlling the pollution levels is not much. It is because the vehicular load is still very high and there is poor disbursal of pollutants generated, especially in the morning when there is a heavy traffic. Hence, the weather plays an important role for high density of pollutants in the city in winters unlike other months when higher temperatures and faster wind speed helps in disbursal of pollutants. The administration would not be able to combat Delhi-NCR's high winter air pollution levels until the region has a year-around action plan that includes fixing responsibility of officials in local authorities for carrying out any air management plan throughout the year. Pollution management should be turned into a people's movement with resident welfare associations held responsible for greening of parks and open areas. Littering should be made a cognizable offence, road and street cleaning should be fully mechanised and penalties should be imposed on municipal officials for failing to lift garbage. The government should work on phasing out of industries out of the region to new modern industrial belts with proper air and water pollution management systems, which would ease pollution and population load. For this, a revenue sharing model with Delhi needs to be worked out as the capital will lose the most from such an arrangement. Another way to fix the air pollution problem is by redeveloping a green corridor across the national capital that acts as barrier for dust blowing in with westerly winds.

The hidden cost of green washing the Indian Railways

According to a recent report published in this daily, RITES Ltd., the consultancy arm of the Indian Railways, has won two contracts for the repurposing of six broad gauge diesel electric locomotives for export to some African railways. These locomotives will be converted for use on railways that use the Cape Gauge of 1,067 mm as against the 1,676 mm used on the broad gauge of the Indian Railways. While the Indian Railways, in collaboration with its consultancy public sector undertakings such as RITES and IRCON, has exported locomotives to countries in Asia and Africa in the past, this is probably for the first time that second-hand (used) locomotives are proposed to be exported after "gauge conversion". While there is no doubt that this is a commendable effort in re-engineering that involves virtually rebuilding the locomotives on a narrower platform,

Meteorology of a La Niña winter

Cities in southern India like Bengaluru and Hyderabad are experiencing a colder than usual winter this year, while north India is witnessing a delayed winter with above-normal temperatures. Some reports have linked the southern chill to a La Niña, but the current ONI values suggest otherwise. Had a La Niña developed already, north India would likely be experiencing a colder winter than usual.An analytures in north India may lead people to burn more biomass for heating, worsening air pollution. A lower PBLH could also trap more pollutants near the ground. But higher wind speeds could disperse the pollutants, potentially leading to better air quality.

La Niña and the monsoonsEl Niño summers are relatively harsher, as was the case in April this year, when India experienced intense, record-breaking heat waves. If a La Niña arrives and persists into the summer of 2025, it may offer relief from high heat. Additionally, an El Niño often disrupts monsoons, with India historically receiving below-average rainfall during at least half of all El Niño years since 1871. But the same figures also indicate evolving patterns since 1980. Both north and south India, for instance, have received less rainfall during more intense El Nino events while central India has been barely affected. A La Niña, on the other hand, promotes robust monsoons as evidenced by the "normal" or "above-normal" rainfall in the La Niña years of 2020, 2021, and 2022. There were "below normal" rains in the El Niño year of 2023. Thus it would be a welcome development if a La Niña forms now or early next vear and continues until the monsoon season. This would mean a less intense summer and more rains for India

Try India's first Christmas cake from Mambally's Royal Biscuit Factory in Kerala

On the ground floor of the Harbour City Mall, around 210 metres away from the Old Bus Stand Junction in Thalassery, Kannur, is a dark green board with capital neon letters that spells out Mambally's. Behind its glass door, biscuits and cakes are neatly arranged on a glass shelf jostling for space with boxes of plum cakes that whisper a legacy of more than a century. Believed to be one of India's first bakeries, Mambally's Royal Biscuit Factory in Thalassery, established in 1880, is also reportedly the birthplace of the beloved plum cake, an assured presence on the dining table beside a glass of red wine at Christmas feasts.

The history of Mambally's Royal Biscuit Factory can be traced back to five generations when Thalassery-native Mambally Bapu was approached by a British merchant Murdoch Brown to bake a cake for Christmas in 1883. He gave Bapu a cake from England to taste, asking him to replicate it and also provided some ingredients such as dry fruits. Brown also suggested Bapu to soak the fruits in a French brandy.Bapu had started his bakery on the main road opposite the Thalassery police station which moved to the Harbour City Mall a few years back. Following his training in Burma, he started the bakery which sold around 40 varieties of biscuits, buns and rusks initially.

For preparing the cake, the baking doyen procured spices and replaced the brandy with local arrack made from cashew apples and bananas. He also had a blacksmith from Dharmadam, Thalassery, prepare a custom-made mould. As Murdoch returned to taste the cake, he was spellbound

and called it one of the best he had ever eaten. This incident which eventually contributed to Thalassery being branded the City of Three C's - Cricket, Cakes and Circuses - is so popular that there is even an Amar Chitra Katha comic about it. As years progressed, the Mambally family branched out to different parts of the State, continuing to be a notable presence in the baked good industry. "In Thiruvananthapuram, Santha bakery is well-reputed in the business. We have got Best Bakery in Kottayam and Modern Bakery in Kottayam and Kozhikode. Then we have a Cochin Bakery, which is spread across Kerala and Karnataka. There are multiple bakeries and each one has created a legacy for itself. But everything started from Thalassery," says Renuka Bala, a fifth-generation member of the family who joined the business two years ago. "I was just trying to help my uncle MM Prakash who runs the shop. Along the way, I realised that we have such a legacy and no one from my generation was taking the business forward," she says. Today, the Mambally plum cake contains dry fruits and nuts such as raisins, walnuts and figs as well as candied fruits, ginger, and orange peel. (Renuka says the family used to have documents from Japan regarding the procurement of these items in the past.) They don't use alcohol anymore, but the fruits are still stewed in a bell metal uruli. a traditional wide-mouthed, shallow cookware. This mixture is stored in batches for months and is added to the cake batter which contains spices, sourced locally or grown in the Mambally plantations. The batter is baked in a traditional wood fire oven that uses coconut shells

the story that lies hidden is a sordid saga of the humongous wasting of costly assets and profligacy unmatched in the annals of railways anywhere in the world, in pursuit of a wholly fictitious goal.

The report mentions "soon to be redundant diesel locomotives'. The fact is that even as far back as March 31, 2023, according to information obtained by this writer under the Right to Information Act (RTI) more than a year ago, there were 585 diesel locomotives stabled (kept idling/ stored) in various locations across the Indian Railways' network due to electrification. Further over 60% of those locomotives had a residual life of more than 15 years. Today, the figure is reported to be about 760 locomotives. How and why did the Indian Railways end up in a situation where hundreds of diesel electric locomotives in good working order with years of service still left in them became redundant? The answer lies with the policy of the government to electrify the entire broad gauge network of Indian Railways in mission mode, at a frenetic pace. Railway electrification in India has long ago transcended mundane considerations such as economic and financial viability and joined the pantheon of universal desiderata such as world peace and universal brotherhood (Vasudeiva Kutumbakam). Today, railway electrification is generally justified broadly on two grounds: a saving of foreign exchange by reducing the import of crude oil and reducing environmental pollution, and, as a corollary of the second point, the adaptability to switch over to renewable sources of energy such as solar and wind. In fact in an official pamphlet issued by the Ministry of Railways in February 2021, entitled 'Mission 100% Electrification - Moving Towards net zero carbon emission', the objectives of the mission have been spelt out thus: to provide environment friendly, green and clean mode of transport to the people; and to unleash its potential to use of renewable energy, especially solar, by making use of the huge land parcel available along the railway tracks.Let us examine these justifications in greater detail. The benefit of saving in foreign exchange is true in absolute terms. But viewed in the context of the total consumption of high speed diesel (HSD) oil in the country, the consumption for railway traction is minuscule. According to a study conducted by AC Nielsen and published by the Ministry of Petroleum and Natural Gas (January 2014), when electrification of the Indian Railways was proceeding at a sedate "conventional" pace, 70% of of total diesel oil consumption in the country was by the transport sector. Out of this, the share of the Railways was just 3.24%. In comparison, trucks consumed 28% and agricultural sector consumed 13.2%. The share of the Railways reduced further to about 2% in 2021-22. So, 100% rail electrification will eliminate one of the smallest segments of diesel consumption, leaving the elephants in the room to roam free. Truth about environmental considerationsThe claim of environmental benefits is even more untenable in the Indian context. Consider the following facts. Electricity is a secondary source of energy, except when generated by lightning. It needs to be generated by expending a primary source of energy from fossil fuels such as coal, oil and natural gas, nuclear energy or the kinetic energy of water stored at a height (as in hydroelectric projects), or through solar or wind power.

tricity generated today in the country is through coal-fired thermal plants and the Indian Railways plays a crucial role in transporting the coal from the pit heads to the thermal power plants. In fact, nearly 50% of the Railways' total freight earnings of about ?1.7 lakh crore in 2023-24 (revised estimates) was generated by transporting coal for various purposes of which 80%, i.e., 40% of total freight earnings was generated only by transporting coal to thermal generating plants.Replacing diesel locomotives with electric locomotives will only result in electric locomotives powered by electricity — about 50% of which is generated by burning coal being used to move more coal to coal-fired thermal plants to generate more electricity, to transport more coal. Coal is considered the dirtiest fuel, environmentally, on the planet. A complete switchover by the Indian Railways to electric traction merely shifts the pollution caused by diesel locomotives near the railway tracks to the source of power generation in a more concentrated form, ultimately polluting the same atmosphere. Unless and until about 80% of the total electricity generated in the country comes from non-fossil fuels — and that day seems far off — any claim of 100% electrification of the Indian Railways, making it a "Green Railway", is in the realm of fantasy. Incidentally, before that situation becomes a reality, the Railways will have to find alternative commodities to coal - which, today, is the single highest freight earner — to avoid a financial meltdown. This article is not intended to reopen the time-worn debate of electric traction versus diesel traction. The issue is about chasing a mirage of converting the Indian Railways into a "green railway", and, in the process, rendering a large number of serviceable diesel locomotives redundant. If all the locomotives already stabled are lined up today end to end. they will stretch for a length of almost 16 kilometres, a majority of them heading prematurely to the scrapyard.

'Disaster management, strategic purposes'Mission 100% electrification of the Railways will also result in a dichotomy in the near term. The Indian Railways today has more than 4,000 diesel locomotives. With the impending 100% electrification of the system, all of them will not become redundant overnight. According to a recent news report in a reputed financial daily, quoting a senior official, 2,500 diesel locomotives are proposed to be retained by the Railways for "disaster management and strategic purposes". It is beyond comprehension what disaster will require such a large number of diesel locomotives to be set aside, unless this is a ruse to avoid sending locomotives with considerable residual service life prematurely to the scrapyard. Further, it is reported that another nearly 1,000 locomotives will continue in service for the next few years to meet traffic commitments. In other words, a 100% electrified "green" railway will continue to use about 3,500 "dirty diesels" in the foreseeable future, financially sustained to a large extent by transporting a not-so-green commodity: King Coal. That raises the question: what was the ultimate purpose of the tearing hurry to electrify 100%?The Indian Railways' Mission 100% electrification is a sterling example of what happens when headline-grabbing slogans promoting vanity projects substitute for well-thought out policies, finally resulting in colossal wastage of tax-payers' money.

Made-in-India business jet by 2028: JV of France's Dassault, Anil Ambani-led company to manufacture Falcon 2000 planes in Nagpur



In what may be seen as a big push for the aerospace manufacturing ecosystem in India, French military aircraft and business jet maker Dassault Aviation will manufacture its best-selling business executive jet—the Falcon 2000 at Nagpur in partnership with the Anil Ambani-led Reliance Group company Reliance Aerostructure Ltd (RAL). The two companies announced a strategic partnership for this purpose at the Paris Air Show on Wednesday, announcing that the first made-in-India Falcon 2000 jet should be ready by 2028.

The announcement comes barely two weeks after Dassault and Tata Advanced Systems announced that the latter will set up a facility in Hyderabad to manufacture the fuselage of the Rafale fighter aircraft. The French company has had a long-standing relationship with India, most notably through its fighter jets Mirage 2000 and Rafale that are part of the Indian Air Force's fleet of fighters.

"Dassault Aviation will manufacture Falcon 2000 jets outside of France for the first time in its storied history. This pioneering initiative will see India emerge as a strategic centre for high-end business jet manufacturing. It marks a historic moment for Indian aerospace and manufacturing industry, as the landmark agreement paves way for India's entry into the elite club of countries producing next-generation business jets, alongside the United States, France, Canada, and Brazil," the two partners said in a joint release, adding that the made-in-India jets will cater to rising business jet demand in India and international markets. The release did not spell out the capacity of the Falcon 2000 production facility, but sources in the know indicated that it could be up to 24 aircraft a year.

This would be the first-ever instance of a foreign aircraft manufacturer setting up a final assembly line (FAL) in India for civilian aircraft. European aerospace major Airbus, which has a minority stake in Dassault, will be setting up an FAL in India in partnership with the Tata group, but that will be for manufacturing helicopters. In a post on X, Patel said that Singapore Airlines – a key commercial and maintenance partner of Air India – seems to be "in hiding", an apparent reference to the lack of a public statement from the airline in the aftermath of the crash.Following Patel's post, Singapore Airlines said that it has been in close contact with Air India and its owner, Tata Sons, and continues to offer its full support and necessary assistance to them.An Air India Boeing 787-8 aircraft, operating flight AI-171 from Ahmedabad to London Gatwick, crashed moments after take-off on Thursday. The aircraft had 242 people on board; only one survived the accident. There were several casualties on the ground as well.

To increase car loading in Railways, Union minister Vaishnaw inaugurates largest automobile in-plant railway siding in Manesar

In a significant step to increase the transportation of passenger vehicles or cars by Indian Railways, Union Minister for Railways, Information & Broadcasting and Electronics & Information Technology, Ashwini Vaishnaw Tuesday inaugurated the country's largest automobile Gati Shakti Multi-Modal Cargo Terminal (MMCT) at Maruti Suzuki India Ltd facility in Manesar, Haryana.

Haryana Chief Minister Nayab Singh Saini and Maruti Suzuki India's CEO and managing director Hisashi Takeuchi were also present at the inauguration.Maruti Suzuki is the biggest manufacturer for car loading in Indian Railways. The Manesar in-plant railway siding has a total dispatch capability of 4,50,000 vehicles annually at full capacity. It is company's second in-plant railway siding facility. Vaishnaw said the Railways undertook major reforms in 2021 to strengthen multi-modal logistics, resulting in the construction of 108 MMCT in a short span of time. "The terminal in Haryana, where the announcement was made, is spread over 45 acres and has a cargo handling capacity of up to 4.5 lakh cars... Legacy problems accumulated in Railways over the years are now being eliminated one by one. Stations, trains, toilets, tracks, cleanliness, technology - every sector has been improved comprehensively. New facilities are being provided to passengers and integrated development is being given priority in collaboration with the industry," said Vaishnaw while addressing the gathering. The Manesar plant is connected to Patli railway station through a 10 km dedicated rail link. It is part of 121.7 km Haryana Orbital Rail Corridor (HORC), which is being developed by the Haryana Rail Infrastructure Development Corp (HRIDC). Officials said that the 10 km railway line was developed at a cost of Rs 800 crore, of which Rs 684 crore was paid by HRIDC and the remaining by Maruti Suzuki. HRIDC is a joint venture of the Government of Haryana (51 per cent) and the Ministry of Railways (49 per cent).HORC is being developed to decongest the Delhi Railway Network by diverting the railway traffic not meant for Delhi.

"On June 17, the vehicles were dispatched to 17 hubs or railway slidings to cater to 380 cities. The siding at the Maruti Suzuki's Manesar plant comprises four lines and two loading platforms. The biggest benefit of new siding will be the direct loading of the car consignment from the plant. It will end the need for transportation by road to Farukhnagar, Bawal, Palhawas or Gurugram stations. In all, it will reduce a total of. 65,000 truck trips per annum, reducing the congestion on road and saving fossil fuels," said a senior official at the Ministry of Railways.

"The Rail Coefficient of India Railways has increased from 1.2 per cent in 2013-14 to 20.6 per cent in 2024-25. It means out of total car production in India, 20.6 per cent is being transported by the railways. In 2024-25, the total car production was 50.61 lakhs and out of this, 10.41 lakhs were transported by railways. It is mostly for domestic sales. Almost 50 per cent of total car loading is done by Maruti Suzuki," said the official quoted above.Maruti Suzuki's Manesar facility was inaugurated in February 2007. Apart from this, India's largest car manufacturer has three more plants in Gurugram, Gujarat and Kharkhoda."The project (in-plant railway siding) underscores our strong commitment to India's Net Zero emissions target 2070. It will contribute to avoiding 1,75,000 tonne of CO2 emissions, saving 60 million litre of fuel annually at full capacity, and reducing road congestion. Lowering carbon emissions remains a top priority at Maruti Suzuki and we aim to achieve this, by increasing the share of vehicle dispatches through railways to 35 per cent by FY 2030-31," said Hisashi Takeuchi, MD & CEO, Maruti Suzuki India Ltd.

Unlike many awareness days that focus on deficits or challenges, Autistic Pride Day stands apart: it is about empowerment, acceptance, and embracing neurodiversity.

What is autism?

Autism Spectrum Disorder (ASD) is a developmental condition that affects communication, social interaction, and how individuals process information. But to define autism solely in terms of challenges is a limited and incomplete view. Many autistic individuals possess remarkable abilities in fields like mathematics, music, memory, design, and pattern recognition. The term "spectrum" reflects the wide range of experiences from individuals requiring substantial support in daily life to those living independently and thriving in their careers and relationships.

Why take pride in autism?

To some, the word "pride" might seem unusual when

We have been in close contact with our

full support and all necessary assistance to them during this difficult time."

Singapore Airlines holds a 25.1 per cent stake in Air India as a result of the merger of Air India and Vistara. Singapore Airlines held a 49 per cent stake in Vistara, while 51 per cent was held by Tata Sons. After the Tata group acquired Air India from the government in January 2022, it was decided that Vistara would be merged into Air India, giving Singapore Airlines a fourth of the merged airline's stake. To be sure, while Air India CEO Campbell Wilson was a Singapore Airlines group executive, he was technically not a nominee of the airline in Air India. Wilson had joined Air India in 2022, when Singapore Airlines had no direct stake in the former.

Singapore Airlines is a key strategic partner for Air India under the Tata ownership. Singapore Airlines CEO Goh Choon Phong is also on the board of Air India. Apart from other existing partnerships and synergies, Air India had in May 2024 appointed SIA Engineering Company (SIAEC) – a Singapore Airlines group company – as the strategic partner for the development of Air India's base maintenance facilities in Bengaluru. Projected to be ready in 2026, the facilities will comprise both wide-body and narrow-body hangars, including associated repair shops, to support the growing Maintenance, Repair and Overhaul (MRO) needs of the aircraft fleet in the Air India Group.

SEBI restrains former IIFL director Sanjiv Bhasin from markets for stock manipulation

The Securities Exchange Board of India (SEBI) on Tuesday barred Sanjiv Bhasin, a former director at IIFL Securities Ltd (IIFL) and 10 other entities from the securities market for alleged stock manipulation by providing recommendations on news channels and social media platforms.In the interim order, the regulator also directed to impound a total amount of Rs 11.37 crore gained by these entities through unlawful activities.

Others who have been restrained from markets include Lalit Bhasin, cousin of Sanjiv Bhasin, Ashish Kapur, Rajiv Kapoor, Jagat Singh, Praveen Gupta, Venus Portfolios Private Ltd, Gemini Portfolios Pvt Ltd, HB Stockholdings Ltd, Leo Portfolios Pvt Ltd and Babita Gupta. "Sanjiv Bhasin, a (former) director at IIFL Securities Ltd, traded through a broker viz. RRB Master Securities Delhi Limited wherein he used to first buy securities himself, then used to recommend the same securities to the public on news channels like "Zee Business" and "ET Now", and/or IIFL Telegram channel, to buy the same securities," SEBI said in the interim order.

Once prices of securities increased after his recommendations, Bhasin used to sell the securities, thereby making a profit. Accordingly, Sanjiv Bhasin manipulated the price of securities and made ill-gotten gains, the order stated.Sanjiv Bhasin was employed with IIFL from April 1, 2017 to November 30, 2022 as 'Director' of IIFL. Subsequently, from December 1, 2022 to June 17, 2024, he was once again associated with IIFL as a consultant wherein, he used to give trading/investment views on stocks, which used to be circulated/broadcasted to all clients of IIFL.

When contacted, IIFL Securities said that Sanjiv Bhasin was associated with the company as a consultant on contractual basis. His term was to end on June 30, 2024. However, due to health reasons, his contract has been discontinued prematurely with effect from June 17, 2024. "Sanjiv Bhasin informed us about SEBI's enquiry but the details of the same was not disclosed to us," IIFL said, adding that he was not a member of the board of directors of IIFL Securities Ltd or any other group company or affiliates.

SEBI's investigation revealed that, prior to his appearances on media channels, Sanjiv Bhasin would take positions—primarily buy orders—in the trading accounts of Gemini Portfolios Ltd, Venus Portfolios Ltd, and HB Stock Holdings Ltd, through dealers of the trading member RRB Master Securities Ltd., Delhi.Given the significant viewership of these channels, his stock recommendations had a considerable impact on the price and volume of the recommended scrips. Capitalizing on this influence, Bhasin would then execute opposite trades (sell orders) in the same accounts—contrary to his public buy recommendations to profit from the surge in prices of the recommended scrips. associated with a diagnosis. All you need to know about: clinical trials

In 1747, Scottish naval surgeon James Lind conducted what is now considered the world's first controlled clinical trial aboard HMS Salisbury. Scurvy, a deadly disease causing bleeding gums and fatigue, was devastating for sailors. Unaware of vitamins, at that stage, Lind divided 12 affected sailors into six pairs, each receiving a different treatment. Only those given oranges and lemons recovered. Though vitamin C wouldn't be identified for another century, Lind's use of comparison and observation led to a medical breakthrough. His experiment laid the foundation for modern clinical trials—structured studies on humans to assess the safety and effectiveness of treatments, vaccines, or preventive interventions.

What is a trial?

A clinical trial begins with a question and ends with a verdict- the outcome is effectiveness or failure. A clinical trial is an organised method of determining whether one approach to treatment is better than another. These trials evolved greatly during the 20th century. In 1948, British epidemiologist Sir Austin Bradford Hill introduced the randomised controlled trial, testing the efficacy of streptomycin in pulmonary tuberculosis. Randomising participants to different groups-one receiving the experimental drug and another a placebo-reduced bias and improved inference quality. Randomisation, blinding, and controlled comparisons became the cornerstones of modern clinical research.Clinical trials vary in design based on the research question. In a parallel trial, different groups receive different treatments throughout. In a crossover trial, each participant receives both treatments in sequence. Other designs include factorial trials, testing multiple interventions simultaneously, and cluster trials, randomising groups rather than individuals. Blinding and placebos help reduce bias and isolate true treatment effects. Before human testing, new drugs undergo preclinical studies in labs and animals. Phase 1 assesses safety in healthy volunteers through microdosing. Phase 2 evaluates early effectiveness in patients. Phase 3



compares with standard care in large, multi-centre trials. Phase 4, after approval, monitors long-term safety in realworld settings. These phases ensure scientific rigour and public safety at every step.Yet, for all the rigour in conducting these studies, a problem persisted: selective reporting. Often, only favourable results found their way into journals, while unfavourable or inconclusive trials were quietly buried. This distorted the evidence landscape, misled clinicians, and led to wastage of resources due to the repetition of unsuccessful and unpublished trials.To improve, the concept of clinical trial, registries was born. These registries act as public ledgers, documenting the intention to conduct a trial and the protocol, methods, and outcomes regardless of whether the study sees the light of publication.

The making of Shubman Gill the Test captain, through the eyes of coaches and a trainer

What caught India's junior coach Abhay Sharma's attention when he first saw a 14-year-old Shubman Gill was the consistency of his conduct. Shubman had hit eight straight centuries for Punjab but there was nothing about his demeanour to suggest that. "His behaviour remained consistent whether he scored 100 or 10. His mindset was excellent, he knew he was good but always wanted to improve," Sharma says. Two years later, Shubman, now 16, was at Dharamshala in the middle of a net session with his talented Punjab junior team of that time. WV Raman, former India opener and reputed coach, was on the sidelines. Shubman was facing a variety of bowlers, one of them an express pacer.

While judging a young batsman, Raman has relied on an old method. "What I look to see is the kind of time that he has when batting and how composed he is when up against real fast bowlers." Shubman would get the coach's nod. "He played the fastest bowler like any other bowler, he had a lot of time and he didn't play the fastest bowler any differently," recalls Raman.

Soham Desai, Team India's trainer till very recently, too has a Shubman tale, this one too is about his poise and composure. It's from his 200 against New Zealand in an ODI at Hyderabad. That was 2023, Shubman was 23 then. "He didn't accelerate till the 47th over as he was following the team plan. Then he asked the dressing room for permission to accelerate or not. Once he got the go ahead, he did and scored his 200. This for a guy who wasn't even 25," he says. Shubman doesn't get carried away, be it the starting of an inning or when he is nearing a 100 or even 200. It is that consistency of conduct again. Leadership gurus value consistency of character. So do Indian selectors. Shubman has had lean patches, significant form dips and also chronic technical batting flaws. So why was he preferred over the other captaincy candidates? At the crux of the observations made by Sharma, Raman and Desai lies the answer. What gave Shubman an edge over others was his leading-man looks and a reassuring persona. He has a face that exudes calmness. He hasn't had a rousing start to his Test career, he doesn't have a phenomenal captaincy record but strangely his cricketing fabric has captaincy material.Shubman looks the part for sure. But can he deliver the lines on the big stage? Can he handle the swing in England? Can the young captain take on the Bazballers, handle the seniors in his team and work with the coach with an aura of authority around him?

Beyond his sparkling numbers and temperament, Shubman's strength in his commitment to his craft, aversion to peacockery and that finely tuned sense of his own self-importance. Many of his peers were earmarked for greatness before him, a few he had played under, but they faltered and were left behind. At the junior level, Shubman was denied captaincy. At Punjab, he played under his friend and present-day T20 basher Abhishek Sharma. In the Under-19 World Cup, it was Prithvi Shaw who led the team. He didn't see it as a setback, it didn't compel him to change his character. He wasn't an eager beaver. Shubman didn't try to catch the attention of the coaches, he didn't try to show that 'he too can lead.'Coach Raman remembers the bright batsman who kept to himself but it wasn't because he didn't have much to say. "He was not the captain or a vice-captain, maybe he felt it was better not to really try and impose himself on the team management. Whenever he was asked, he would always be very keen to give his views. He was not what I would call a forthcoming guy, who would venture into volunteering to suggest things at meetings," recalls Raman. His early days in the senior Indian team too were similar. On the field, he wasn't in the captain's ear all the time. Now, it has come to light that he was busy watching, listening and imbibing. The other day, in a Skysports interview, he said he picked a few captaincy attributes from his seniors - Virat Kohli's proactiveness and Rohit Sharma's tactical nuance

Sachin Tendulkar on telly and try to bat like him. In the courtyard of his sprawling ancestral home, Shubman would chuck the ball against the wall and quickly take guard to hit it straight, just like Tendulkar. He was self-driven but having a cricket-obsessed farmer father, who didn't believe that academics was the only path that leads to success and wisdom, helped. The family moved to Chandigarh for Shubman's cricket. From the age 8 to 14, every day of his life, the batting prodigy batted for close to 6 hours. Such was his family's backing that Shubman couldn't understand why his fellow juniors complained that their parents wanted them to leave cricket and focus on studies. Who does that? the boy would wonder. Though, there would be occasional moments of weakness. What if cricket doesn't work out? That's when he would tell himself that there was always the family's large swathes of land in his village to fall back on. There was always the option of being a landed farmer, like his grandfather and father.

Unlike his peers, the ones with modest means traveling on train from Virar to Churchgate or Roorkee to Delhi in a bus, Shubman was at peace. He had a Plan B but he was fully-committed to Plan A. He was never anxious, defensive or insecure. In a crowd of hopefuls, he stood out because of his confidence to make it big. This wasn't wishful thinking but a process-driven pursuit."From the beginning, he was disciplined. He understood his game, maintained routines, was punctual for the gym, and focused on his skills. He is confident, not overconfident. You can see that focus in his eyes. This is very important as a leader. International cricket will bring different pressures, but I'm sure he'll handle it," he says. And then he says those magical words: "He knows how to conduct himself, he is also consistent which is why everyone likes him."Trainer Soham speaks about how Team India benefited from getting a ready-made complete cricketer. "He is very clear about what he wants. He had a desire to be a complete package when he gets into the Indian team. He is system-oriented about his diet, training, and recovery. With him it's never like, 'okay I am here now, what do I need to do?"Indian cricket's ultimate committed man Virat Kohli too had drifted from the path after success at the junior level. He had his moment of realisation when one day, in his early 20s, he stood in front of the mirror and saw his puffed up face and much-abused body. There have been a few stray rumours and gossip magazine speculations but Shubman has broadly walked the straight line that has taken him to the top. India captain at 25 - is a testimony of the consistency of his conduct.

The English shores aren't new for Shubman. He has been there and even done it too. Starting from the India Under-19 days. Sharma and Raman recall two different innings in England that have stayed in their minds. First Raman and his memories of a hundred at Kent. This was the tour when the coach had given simple advice to the batsman. "He was too keyed up to do well, so I had asked him to relax a bit," he says. The English bowlers would suffer at the hands of a relaxed Gill. "I remember the 100 he got in one of the one-dayers in England. The first 80 runs, the domination that I saw from him, I don't think that's ever been seen by entire sides. Everybody went absolutely gaga over his ability and his talent," he said.Raman would follow the career of his one-time ward at the senior level. He would cheer his highs, observe his lows and appreciate his ability to bounce back. "He's grown in confidence both as a cricketer and also as a person. Along the way, he's also understood what it is that he can do, what he shouldn't do," he says

So what is it that Shubman the batsman should not do in England? "Not trust the pitch," says Raman with a laugh. "By that I mean he should try and ensure that his eyes are glued on the ball since there's bound to be a little bit of lateral movement. He's got to try and play a little bit late. In England, you've got to start moving a trifle late because of the moisture, because of the heavy atmosphere, the ball may not come as quickly as it comes in other places in the air."Raman also gives the weather warning. "There's no guarantee as far as English weather is concerned. So ev ery session is going to be different, every half an hour is going to be different," he says. Shubman's other coach Sharma is confident that he can do all that. He too banks on his memories for his prediction. Sharma remembers his under-19 days and his hundred at Brighton. That was the tour, Sharma had backed him to play at No.3 and had spent long hours giving him throwdowns. The two had formed a bond."I still remember after he got the man of the match award, while everyone was on the ground, he walked towards me, thanked me and touched my feet. It was an emotional moment," he says."Years later, we met again, by then he had become an India team regular. This was Jaipur during the Ranji season. I was coaching Delhi and he was playing for Punjab. Both teams were having nets, the ground was full. Just as Shubman spotted me."

he's played, he's had a huge impact. He is clearly going to be a big threat. We have

Bollywood's biggest hairstylist died penniless, family was left with 'nothing to eat' despite counting Bachchans, Kapoors as friends



Celebrity hairstylist Aalim Hakim painted a disappointing picture of the Hindi film industry, where his late father made a name for himself as the go-to hairstylist for A-list stars such as Amitabh Bachchan and Vinod Khanna. He even did the hair of international stars such as Bruce Lee and Richard Harris. In fact, it was while he was cutting Bachchan's hair that Aalim's father felt a pain in his chest. He died the next day, at the age of 39. Aalim said that he was just nine years old at the time, and that his family was left with only Rs 13. They asked several film industry personalities for help during this difficult time, but Aalim said that nobody really showed up to support them.

Appearing in an interview with Hindi Rush, he said, "My father was doing Mr Bachchan's hair on a film called Mard. He felt a pain in his chest, and Mr Bachchan immediately told him to get a flight and go to a hospital near his

house. He died the next day. I was only nine years old. We had no idea what to do. In those days, people didn't really save money. They spent whatever they earned. I remember we had only Rs 13 to our name when he died."Asked if anybody from the industry stepped forward to help out, or take Aalim under their wing, he said, "We didn't get any help. We got help from unexpected people. It's not like people from the film industry showed up. Some of them did, yes, but very shortly. Nobody stays with you. Bolte hain na, chadhte sooraj ko salaam. That was the situation. All the stars who used to come home every day, they stopped coming by. Nobody stayed. My mother would go around asking for help, telling them that we didn't have anything to eat. They did what little they could, but they help to a degree.'

Aalim said that the experience made him world-weary. "They're all self-centred, and let me tell you one thing, even today they're the same. They meet you nicely, they're friendly, but you have to work for yourself. As a child, all I wanted to do was earn my father's respect back, to keep his legacy going." He said that he had learned nothing of the trade when his father passed, and had to train himself. "I would be inspired by newspaper cuttings of him... He worked with them all; not only Mr Bachchan, but also Shatrughan Sinha, Vinod Khanna, Jeetendra, Shashi Kapoor. He would travel with them. He was iconic." Asked if any of these people offered a helping hand, Aalim said, "Let me tell you what this in-dustry is like. They're all nice to you, but the second you make a flop movie, nobody will speak to you. A hero will party with you, share meals with you, but he will never work with you if you've made flops." Aalim has created a successful business of his own, and continues to work with the Bachchans. He has also styled the who's who of the film industry, from Ranbir Kapoor and Rajinikanth to Hrithik Roshan and Allu Arjun.

Aamir Khan rejects Rs 120 crore OTT deal for Sitaare Zameen Par; stands firm on 9 am FDFS, fair ticket rates: 'No blockbuster pricing'



Aamir Khan has turned down a massive offer from Amazon Prime Video, choosing instead to give Sitaare Zameen Par a full theatrical run without rushing a digital premiere.Helmed by RS Prasanna, the sports comedydrama Sitaare Zameen Par is billed as a spiritual successor to Aamir Khan's directorial debut Taare Zameen Par.

Despite not being a big-ticket, action-oriented star vehicle typical of this era, Bollywood superstar Aamir Khan's Sitaare Zameen Par is generating massive hype. Helmed by RS Prasanna, known for the Tamil romantic comedy Kalyana Samayal Saadham (2013) and its Hindi remake Shubh Mangal Saavdhan (2017), the sports comedy-drama is billed as a spiritual successor to Aamir's directorial debut Taare Zameen Par (2007). Interestingly, social media is abuzz with expectations that the film will offer a breath of fresh air amidst the current flood of mindless actioners.With the movie's release just around the corner, Aamir Khan, who also serves as the film's co-producer, has made some bold decisions regarding its theatrical and OTT premieres, including its first-day-first-show (FDFS) timing. In a significant and gutsy move, the actor-producer has reportedly turned down a massive offer from a major OTT platform. choosing instead to give the movie a full theatrical run without rushing a digital premiere.

According to trade analyst Komal Nahta, Amazon Prime Video offered Rs 120 crore for the digital rights to the film, but Aamir declined the deal. While many might assume this was a tactic to attract higher offers from other platforms. Nahta clarified in Film Information that Aamir made the decision "to try and change the game". In recent times, Aamir has frequently voiced concerns about the standard eightweek window between theatrical and digital releases, calling it a "faulty business model".With this, the Bollywood biggie has once again proven that he isn't one of those "all talk and no action" stars and that he has decided to lead by example and be the change he wishes to witness around him. Nahta pointed out that if Aamir's strategy works and the film's absence of an OTT release drives up box office revenue, it could be a revelation for the industry. On the flip side, if the strategy backfires, Sitaare Zameen Par could end up losing Rs 120 crore in easy revenue.

Meanwhile, ahead of the film's release on June 20 (Friday), Aamir has also issued a series of instructions to exhibitors regarding show timings. According to Bollywood Hungama, the makers have requested not to begin shows before 9 am. They've also asked theatres to maintain popular weekend pricing, rather than inflating ticket rates as per the blockbuster pricing technique.While single-screen theatres wishing to screen Sitaare Zameen Par have been instructed to dedicate all shows exclusively to the film, without alternating titles, cinema halls with two screens have been asked to allot a total of eight shows per day for the sports comedy drama. "Multiplexes with 3, 4, 5 and 6 screens need to play 11, 14, 16 and 19 shows a day, respectively. For 7-screen multiplexes, 22 shows are a must while for 8-screen plexes, 25 shows are mandatory in a day. There should be 28 shows in 9-screen cinemas and for multiplexes with 10 screens and more, the requirement is 31 shows," Bollywood Hungama quoted a source as say
