## Article 370 opposed Ambedkar's one Constitution vision; says CJI Gavai

Nagpur: Chief Justice of India B R Gavai on Saturday said Dr B R Ambedkar envisioned one Constitution for the country to keep it united and never favoured the idea of a separate constitution for a state. Speaking at the inauguration of the Constitution Preamble Park here, the CJI said the Supreme Court drew inspiration from Dr Ambedkar's vision of a united India under a single constitution while upholding the Centre's decision to abrogate Article 370 that

granted special status to Jammu and Kashmir.Gavai was part of a five-judge Constitution bench, headed by then Chief Justice DY Chandrachud, that unanimously upheld the Centre's decision to abrogate Article 370, which bestowed special status to the erstwhile state of Jammu and Kashmir."When Article 370 was challenged, it came before us, and when the hearing was underway, I recalled Dr Babasaheb's words that one Constitution is suited for a country... If we want to keep the country united, we need only one Constitution," he said, while addressing the gathering in Marathi. On August 5, 2019, the Centre decided to strip Jammu and Kashmir of its special status and divide it into two Union Territories. Gavai said Dr Ambedkar had been criticised, saying the Constitution provides for too much federalism, and in times of war, the country may not remain united. However, he had responded, saying the Constitution would suit all the challenges and keep the nation united, the CJI said. "See the situation in the neighbouring countries, be it Pakistan, Bangladesh or Sri Lanka. Whenever our country faces challenges, it has remained united," Gavai said. Speaking on the occasion, Union Minister Nitin Gadkari said he was happy that CJI Gavai inaugurated the Constitution Preamble Park and unveiled a statue of Dr Ambedkar.Freedom, equality and brotherhood were Dr Ambedkar's valuable gift to the country in the form of the Constitution, he said.

## India has done well by not signing the SCO joint statement

By not signing a tendentious joint statement at the hanghai Cooperation Organisation (SCO) meet, India as made it clear that it will never allow Pakistan and its upporters to peddle their narrative at international forums. The draft statement did not have any reference to the Pahalgam terror attack in which 26 innocent lives were ost, but it did mention the Jaffar Express hijacking in Pakistan in March. Addressing the SCO gathering, Deence Minister Rajnath Singh spoke about the Pahalgam ttack and the ensuing Operation Sindoor. He articulated Delhi's stand on terrorism in unambiguous terms: "Peace and prosperity cannot co-exist with terrorism and prolifration of Weapons of Mass Destruction in the hands of on-state actors and terror groups. Dealing with these hallenges requires decisive action... Some countries use ross-border terrorism as an instrument of policy and rovide shelter to terrorists. There should be no place for such double standards. SCO should not hesitate to riticise such nations." The double standards continue ecause China, the wannabe superpower, keeps suporting and abetting Pakistan to chafe and fret India by vhatever means possible, including jihad.

Over the decades, China has provided Pakistan with nilitary hardware, financial bailouts, nuclear assistance, and diplomatic cover on the world stage. This is not born put of altruism or ideological affinity—neither exists—but of a deliberate maneuver to keep India perpetually engaged in regional skirmishes, border tensions, and secuity concerns, thereby slowing down its strategic and economic ascent. Beijing's strategy is part of a broader geopolitical playbook often referred to as the 'String of Pearls' or the policy of 'encirclement.'

It observed that several of these outlets have been engaging in deliberate misinformation campaigns, often portraying distorted facts about central and state governments, while exploiting constitutional freedoms in an unethical manner.""""Official Gazette Notification and Mandatory Compliance""Through its recent notification, the PRGI has declared that any publication operating without statutory registration under the RNI Act shall not be deemed authentic or legitimate for public communication. ## Faculty crisis deepens in Telangana's teaching hospitals despite recruitment efforts

Hyderabad: It's not just Professors, the State-run teaching hospitals in Hyderabad and peripheral areas are also struggling due to a severe shortage of Assistant Professors, who are vital for bedside patient care. This shortage is severely impacting not only medical education but also patient care in government hospitals, a point that was raised on multiple occasions during the National Medical Commission (NMC) inspecting teams' visit. The health department has hoped to plug the faculty shortage by transferring senior Professors to districts. However, the strict oversight of NMC inspecting teams and the threat to cancel existing MBBS medical seats have now forced the State government to seriously consider undertaking recruitment,

#### senior doctors on Friday said.

For the past one year or so, junior doctors and senior residents have been consistently demanding that the State government immediately begin recruiting Assistant Professors for peripheral hospitals."Every year, approximately 1,100 postgraduate (PG) doctors complete their training in Telangana. However, due to irregular in job notifications, many are forced to seek employment in Andhra Pradesh, Tamil Nadu, Karnataka and Maharashtra," says Dr K Brahmeshwar, president of the Healthcare Reforms Doctors Association (HRDA). In the past, the health department had attempted to fill 1,450 Assistant Professor posts across 26 new Government colleges. "You need to address the core issues that contribute to the chronic shortage. The compensation packages offered in government teaching hospitals often don't match what a doctor can potentially earn in the private sector. Unless attractive future prospects are provided, talent cannot be retained," a senior doctor said. The junior doctors' association, on its part, has been raising the issue of undertaking recruitment of doctors at mid and low level and emphasizing the importance of retaining talent."Frequent revision of stipends and strengthening of faculty positions in medical colleges to ensure better working conditions and training facilities, have been a long pending demand for us. On Thursday we met the Health Minister, and he has assured us to take-up the issue with the Chief Minister," Dr Ajay Kumar, general secretary, Telangana Junior Doctors Association (TJUDA), said.

## 'Cannot go on like this': Punjab-Rajasthan tussle over Gang Canal water escalates as MLAs continue stir, meet Governor Kataria

The long-standing issue of water-sharing through the Gang Canal has snowballed into a political and inter-state flashpoint as Congress MLAs in Rajasthan launched an indefinite sit-in protest and chain hunger strike on Monday in Sriganganagar district, which borders Punjab's Fazilka district. The protest, backed by local farmers, is being spearheaded by the Kisan Sangharsh Morcha with the active involvement of Karanpur Congress MLA Rupinder Singh Kooner and other Opposition leaders.

The protesters have accused both the BJP-led Rajasthan government and the Aam Aadmi Party (AAP)led Punjab government of negligence. "The protest is not just against Punjab. It is also against our own BJP government in Rajasthan, which has failed to represent farmers' interests effectively. Punjab is playing 'gimmicks' and denying our rightful share of water," Kuldeep Indora, Congress MP from Sriganganagar, told The Indian Express.Indora said, "Rajasthan and Punjab share water from the Gang Canal, sourced from the Harike Barrage on the Sutlej River. As per the Bhakra Beas Management Board (BBMB), both states were allocated 2,500 cusecs each for June 2025. But until June 10, Rajasthan was receiving just 600-700 cusecs. We objected, and the share was later increased to 1,800 cusecs, and finally to 2,000 cusecs from June 18. Still, we are not getting the full 100 per cent share."He added, "It cannot go on like this, where Punjab arbitrarily increases or decreases the flow. We demand our rightful share - not a drop more, not a drop less. The Centre must intervene as BBMB is under its control.

The hunger strike began with MLA Rupinder Kooner who was later joined by Raisinghnagar MLA Sohan Lal Nayak. MP Indora is also set to join the chain hunger strike from 6 pm on Friday to 6 pm on Saturday. "The chain hunger strike is being observed for 24 hours by each person, starting from 6 pm onwards," said Kooner.Farmers claim the ongoing shortfall has crippled irrigation and delayed sowing of cotton and cottonseed, putting thousands of livelihoods at risk. Protesters have also raised concerns about water theft by Punjab farmers along the route of the canal from Harike to Sriganganagar, a problem allegedly ignored by both governments.In a significant development, Gurveer Singh Brar, the BJP MLA from Sadulshahar, which falls in Sriganganagar district, met Punjab Governor Gulab Chand



Kataria at the Raj Bhavan in Chandigarh on Thursday and raised the matter. The legislator also submitted a memorandum requesting immediate release of Rajasthan's allocated share.Brar stated that even though the BBMB has allocated 2,500 cusecs to Rajasthan, "Punjab is not releasing the full amount. Water levels in the Gang Canal have been continuously falling, putting farmers in distress. While the Rajasthan government has taken up the matter repeatedly, the supply has improved, but still remains insufficient."Following Brar's intervention, the Punjab Governor reportedly issued directions to Punjab Chief Minister Bhagwant Mann and the chief secretary to resolve the issue urgently. "With the Governor's positive intervention, I am hopeful that this sensitive issue will be resolved soon and farmers will get relief," the MLA added.

ICommissioned in 1927 by Maharaja Ganga Singh of Bikaner, the Gang Canal is one of India's oldest irrigation projects. Originally constructed to bring water from the Sutlej River (via the Harike Barrage in Punjab's Ferozepur) to the arid lands of northern Rajasthan, especially Sriganganagar and Hanumangarh, the canal stretches over 450 km, with 215 km being within Rajasthan. The canal irrigates nearly 3.5 to 4 lakh hectares of fields and supports crucial crops such as cotton, wheat, mustard, and sugarcane. The water-sharing is governed by interstate agreements, monitored by BBMB, which is under central jurisdiction. With a designated capacity of 2,500 cusecs, the Gang Canal is a lifeline for farmers in a region which gets scarce rainfall. However, recent disruptions in the water supply have reignited the debate over interstate water rights, political accountability, and the need for intervention from the central government to ensure fair distribution of essential resources.

More than 500 years ago, in the lush forests of Sindhudurga district, two villages, Dhamapur and Kalse, came together and constructed an earthen dam, creating a water reservoir that acted as a flood mitigation measure. The Dhamapur lake, which is a World Heritage Irrigation structure of the International Commission on Irrigation and Drainage, is now under threat from immersed Ganesha idols. A public interest litigation (PIL) was filed at the National Green Tribunal (NGT) in Pune on June 10 against the immersion of idols and washing of utensils and clothes in Dhamapur lake, and to urge authorities to take greater ownership."If you take a bird's eye view of Dhamapur village, you will see that there is a Karli creek on one side and a plateau on the other. The region receives heavy rainfall, around 3,000 mm, and we can understand that there would have been flooding in those days. The earthen dam was built to stop the water flow, and a huge lake was created. After creating the lake, the villagers realised that the water could be channelled through the farm fields and then connected to the Karli creek. We see that the dynamics of this engineering were compatible with the biodiversity and ecosystem," said Sachin Desai of the University of Life, a centre for sustainable livelihood and lifelong learning run by Syamantak Trust in Dhamapur.

He further said that the canal that winds from the field is connected to the creek. "So, the salinity of the creek water is reduced because fresh water continuously flows into it from the field," Desai added.Around 15 years ago, the Syamantak Trust realised that the dynamics of the lake were not well-known among the local people, largely due to migration. "We saw that they were constructing a skywalk inside the lake. This was something abnormal, and a stu-

dent from our organisation, who went on to become a lawyer, filed a petition in the NGT against the skywalk," said Desai, adding that they did a complete documentation of the entire village at the time. The result was that the court gave a stringent order against the skywalk. It was during this time that the organisation observed that over 200 idols were immersed in the lake. "At one point, the villagers and even the people of Malvan town were complaining that there was significant siltation in the lake, which was reducing its water-carrying capacity. According to the Gazetteer of the Bombay Presidency - Vol. X, published in 1880, and old scriptures, the lake's depth was around 38 feet. In its history of 500 years, the lake has never shrunk. In 2019, for the first time, the water reached the dead level. We see the wisdom of old engineering and how modern techniques and technology have been harmful to the water body," said Desai.

A further survey revealed that the clay for Ganesh idols was being brought to the Konkan from Gujarat and Rajasthan. Ganeshotsav is a major festival in the Konkan, and though the use of Plaster of Paris in making idols is not allowed by law, shadu mati was not helping either. Yet, truckloads of the clay were coming to the region. "Then second thing we found was that the idol makers were putting some kind of hard plastic to create the ornamentation for the idols. All this was being immersed in the lake," said Desai."The collector sanctioned around Rs 10 lakh to the irrigation department, and an immersion tank was constructed. But which authority would ensure that idols were immersed in the tank? For the last two years, local volunteers have been trying to encourage villagers to immerse the idols in the tank. "We have some statistics; Around 70 per cent of idols are going into the immersion tank. The rest are still going into the lake," added Desai.

On the request of the organisation, a few eminent Marathi actors like Anand Ingle, Parna Pethe, Pratima Kulkarni, Suhas Paranjpe, Umesh Jagtap, and the late Atul Parchure made video bites to appeal to villagers to immerse their idols only in the designated tank. The organisation also removed the clay and encouraged a local idol maker to recycle it into another idol. "He made some miniature small clay idols and earned around Rs 70,000 from that," said Desai. "Our petition in the NGT is based on the fact that the irrigation department and the district collector are the trustees of the water bodies and all the natural resources. As a trustee, they have to protect this natural wealth and take steps to conserve it, which they are not doing," Desai further said. There are eight tonnes of clay immersed in the lake. Desai said they are hoping that the irrigation department will take steps to stop further deterioration of the lake, and barricades and security personnel will be installed at the lake to prevent people from immersing idols in the wa-

### After viral video prompts inspection, Delhi Metro says no snake found in ladies' coach

After a video showing passengers shouting after reportedly spotting a snake inside a coach went viral, the Delhi Metro Rail Corporation (DMRC) Friday said a baby lizard was found during inspection. The video shows women passengers shouting, and lifting their legs to keep them above the floor. The passengers could also be seen jumping onto the seats. When someone asks why everyone is scared, a passenger claims there is a cobra in the coach. Another passenger can be heard telling someone to knock on the driver's door and ask him to stop the metro.However, DMRC said while no snake was visible in the footage, it took swift action once an alert was received from passengers. The train was halted at Akshardham Metro station, evacuated, and sent to the depot for detailed checks."Although the snake is not visible in the video, it is being purportedly claimed that a snake was spotted in a ladies' coach. Immediate action was taken upon receiving the alert," Anuj Dayal, Principal Executive Director (Corporate Communications), DMRC, said."Despite a meticulous check of the train footage and the coach at the depot by the concerned team, no snake was found. However, a baby lizard was spotted during the inspection," Dayal said. He said DMRC prioritises passenger safety and that standard operating procedures were followed to ensure there was no threat. "We urge passengers to remain vigilant and report any such concerns to our staff for prompt action," he added.

## How BMC is planning to tackle waterlogging in Mumbai

BMC, waterlogging, IoT sensors, dewatering pumps, MumbaiThis year, the BMC has installed 514 pumps across locations in the island city as well as the suburbs. With the May 26 flooding serving as a wake-up call, the Brihanmumbai Municipal Corporation (BMC) is set to install Internet of Things (IoT) sensors on the dewatering pumps being set up in low-lying areas in the island city. Every year, ahead of the monsoon, the civic body identifies lowlying areas and installs dewatering pumps there. This year, the BMC has installed 514 pumps across locations in the island city as well as the suburbs. These pumps channel out the accumulated water from a particular area to the nearby drainage outlets and creeks. On May 26, following a heavy spell of rain, Mumbai almost came to a standstill due to waterlogging. Civic officials attributed this to the non-functionality of a majority of the water pumps."Last year, in one such incident at Mumbai's Chunabhatti, we saw that despite pumps being installed in a particular area, there was huge flooding. Later, during our investigation, we found out that the pumps were fully ready, but the contractor responsible for operating the pumps did not turn them on, and this led to severe waterlogging in the area. Therefore, as a preventive measure against such incidents, we are installing sensors in the dewatering pumps," Abhijit Bangar, Additional Municipal Commissioner, Projects, told The IoT sensors will be motion-based and will be installed on the belts of the

pumps. These belts record a high-speed motion whenever a pump is turned on, and the sensors will be able to detect when a pump is switched on from the motion of the belt.Close to the pump, a receptor will be placed by the civic authorities, which will record the signals sent by the sensor. This receptor will transmit the recorded data from the sensor, which will have IoT chips in it, and transmit the data to the civic body's war room."The sensors are motionbased devices. They will record the time when the pump is switched on and will transmit information about the entire duration for which the pump operates. So, for example, if rainfall starts at 11 am, we can clearly identify when the operator has switched on the pump and whether he did that on time. Any delay in operation will be caught as a result...these pumps will also increase accountability amongst the contractors," Bangar added. Officials said that by the end of this week, sensors will be installed in as many as 100 pumps and by the end of the next few weeks, the numbers will be augmented.

## How Mallanna Sagar, Kaleshwaram's largest reservoir irrigated 12 lakh acres, lifted Manjeera river

Siddipet: Mallanna Sagar reservoir, the largest reservoir constructed under the Kaleshwaram Lift Irrigation Project (KLIP), near Thoguta in Siddipet district, had become a key component in Telangana's ambitious irrigation and water supply plan.Mallanna Sagar played a crucial role in KLIP's integrated water network, as it supplied water to Kondapochamma Sagar, Gandhamalla, Baswapur and Singur reservoirs, reviving the Manjeera river system, and provided 30 TMCft of water for Hyderabad's drinking and industrial needs.

While the reservoir directly irrigated 1.65 lakh acres, it also helped stabilise irrigation across 12 lakh acres, including its own command area. It supported numerous minor

irrigation tanks across Siddipet, Medak, Sangareddy, Yadadri-Bhongir and Rajanna Sircilla districts.Constructed at an elevation of 550 metres above sea level, water had been pumped into Mallanna Sagar from Ranganayaka Sagar using eight pumps. The project included two major canals, Dubbak Canal and Ramayampet Canal, which carried water to agricultural lands in Siddipet, Medak and Rajanna Sircilla districts. While the main canal works were completed, the construction of distributary canals was still in progress.

The irrigation department had proposed to fill nearly 400 minor irrigation tanks under the project. However, due to pending canal work, only 170 tanks were filled during the last Yasangi season. Despite this, water was supplied to 40,000 acres and released into Kudavelly Vagu, Haldi Vagu and other streams, leading to improved groundwater levels across the ayacut. Since its inauguration in 2022, Mallanna Sagar had impounded 19.50 TMCft of water in 2024. Authorities aimed to impound 30 TMCft this year, although the current storage stood at 10.37 TMCft against a full capacity of 50 TMCft. Water lifting operations were scheduled to begin in August, once the Godavari started flowing, with irrigation releases to follow.Likewise, Ranganayaka Sagar at Chandlapur in Siddipet had a command area of 50,000 acres and a storage capacity of 3 TMCft. Konda Pochamma Sagar, built near Markook, had a capacity of 15 TMCft and served 2.85 lakh acres directly and indirectly. At present, it held 5 TMCft of water.

### How the Kaleshwaram project boosted fish and prawn production in Telangana

Hyderabad: Telangana witnessed a remarkable surge in fish and prawn production between 2014–15 and 2023– 24, particularly after the commissioning of the Kaleshwaram Lift Irrigation Project (KLIP) in 2019. The fisheries sector, once underutilised, had emerged as a significant contributor to rural livelihoods and State revenue. With the third-largest inland water spread in the country, covering 5.73 lakh sq km across tanks, lakes, and reservoirs, Telangana ranked fifth in inland fish production nationally.

Fish output rose from 1.93 lakh tonnes in 2016–17 to 4.39 lakh tonnes in 2023–24, marking a growth of 127 per cent. The value of fish production nearly tripled during this period—from Rs 2,111 crore to Rs 6,514 crore. Prawn production also recorded a 98 per cent jump, from 5,189 tonnes in 2016–17 to 16,532 tonnes in 2023–24, while its value grew from Rs 142 crore to Rs 545 crore. The turnaround began in 2017–18, when the Telangana government launched large-scale releases of fishlings and shrimp seed into water bodies. Fish production spiked to 2.62 lakh tonnes that year and continued its upward trajectory, aided by the increased water availability due to KLIP. Water pumped into tanks and reservoirs through KLIP helped boost aquatic cultivation. The number of fishlings released rose sharply



from 27.85 crore in 2016–17 to 85.6 crore in 2023–24, across more than 26,000 water bodies. Around 10 crore shrimp seedlings were released in 2023–24 alone. Fishermen Cooperative Societies across the State benefited significantly, with higher incomes and increasing memberships reflecting the success of targeted government interventions and sustained water resource development. However, the sector had recently seen setbacks, with a decline in water availability and reduced support for fishling and shrimp seed releases under the Congress regime, affecting overall production.

A purported audio clip has further revealed a rift between two of India's most notorious gangsters - Lawrence Bishnoi, who is lodged in Gujarat's Sabarmati Jail, and his once-close aide Goldy Brar.Sources recently told The Indian Express that Central intelligence agencies and state police have said Bishnoi and Brar have parted ways after Bishnoi got upset with Brar and Azerbaijan-based gangster Rohit Godara over their handling of his brother Anmol's case in the US.Central intelligence agencies received information that Brar and Godara did not help Anmol file the reguired bail bond. Anmol was later released but with an ankle bracelet tracker," a source said.Lawrence Bishnoi's brother was arrested by US immigration authorities in November last year for allegedly travelling with fake documents. The latest clip, purportedly released by Goldy Brar and going viral on social media, further suggests the two are no longer on the same page, despite having previously claimed responsibility for the murder of Punjabi singer Sidhu Moosewala. The Punjab Police said they are looking into the audio's authenticity. "Goldy Brar is booked in several terror-related cases. We are examining the audio. But it won't matter what he says. Law will take its own course," said a Punjab Police officer.

The Commission for Air Quality Management (CAQM) in NCR and Adjoining Areas has issued a request for proposals (RFP) inviting scientists, researchers, academicians, non-government organisations, community-based organisations, consortia or individuals to submit innovative ideas and technological solutions for the prevention, control and abatement of air pollution in the National Capital Region (NCR).

Proposals must be coordinated by an academic, research or scientific institution recognised by the Government of India, and are to be submitted by July 31, 2025. Eligibility for submission is confined to scientists or experts working through government-recognised institutions; nongovernmental organisations, community-based organisations, consortia and individuals must submit their proposals via such institutions. Under Sections 12(2)(vi) and 12(6)(c)(iii) of the CAQM Act, the Commission is empowered and mandated to carry out research and development on air pollution. The apparent fallout between Brar and the Bishnoi, combined with the denial of ISI links, has added a new dimension to the ongoing gang conflict.

Expressing deep concern over the "alarming and disturbing situation" of fatalities on Mumbai's suburban railway system, with nearly 10 deaths occurring daily, the Bombay High Court Friday suggested that the railways consider installing automatically closing doors on local trains to prevent commuters from falling off. The court said that the "unfortunate" Mumbra train accident reported earlier this month, in which five commuters lost their lives after falling off overcrowded trains, should not have happened. It pointed out that as per an earlier response by the railways, nearly 3,588 deaths took place on the Central Railway (CR) and Western Railway (WR) suburban systems in 2024, and said that measures taken so far are insufficient. The high court was hearing a Public Interest Litigation (PIL) filed by one Yatin Jadhav, a daily commuter who raised concerns over the high rate of fatalities in the second busiest suburban railway system in the world and sought the formation of an expert panel to recommend measures to eliminate deaths due to untoward incidents. Additional Solicitor General Anil Singh, representing the Centre, informed the division bench of Chief Justice Alok Aradhe and Justice Sandeep V Marne that the railways have a high-level monitoring committee which has a "zero death mission" in place, and a multi-disciplinary committee headed by a senior divisional safety officer has now been formed to examine what led to the accident in Mumbai.

The court then directed the concerned committees to consider the suggestions by the petitioner, represented by senior advocate Rohan Shah and advocate Surabhi Prabhudesai, and place their recommendations on record within three weeks, along with the timelines within which such measures can be implemented."What disturbs us is that in 2024, 3,588 deaths took place on CR and WR, which averages to 10 deaths per day. So every day, 10 Mumbaikars die while travelling on the train. And these numbers of deaths are due to falling down from a train, (being) hit by a pole or (due to) gap between the footboards and the platform. This is an alarming situation. This is your data. Though you (railways) have projected that there is a reduction of deaths by 46 per cent compared to 2009, it is still not sufficient," Justice Marne remarked orally.CJ Aradhe added, "This (Mumbra incident) should not have happened. But, obviously, these measures which you (railways) have taken are not sufficient... The local train (doors) should not be open so that there is no scope for overcrowding. You should provide automatic doors which close. Why can't you do that to achieve your goal? This is one of the suggestions as a layperson. We are not experts in rail safety, but prob-

ASG Singh submitted that railway authorities were taking steps under its "zero death mission", including construction of boundary walls and fencing walls near the tracks, along with partitions between tracks to avoid trespassing and crossing, besides removing some stalls on platforms which become overcrowded, and said the authorities will continue to take further steps. He further submitted that while the authorities are taking steps to improve the system, there are constraints as they can construct such walls or fences only during late-night hours as trains cannot be halted, else the entire city will come to a standstill. Singh added that the multidisciplinary committee examining the causes of the Mumbra incident shall soon suggest remedial measures, which will be produced before the court along with timelines to implement them.

### Delhi Police unveil emblems for Finger Print Bureau and Bomb Disposal Squad

The Delhi Police Thursday unveiled the official emblems of the Finger Print Bureau (FPB) and the Bomb Disposal Squad (BDS) to honour the two units. According to Delhi Police officers, these emblems will be prominently displayed on official jackets and documents. The unveiling ceremony, held at the Police Headquarters, was led by Delhi Police Commissioner Sanjay Arora in the presence of senior officers. According to police officers, both FPB and BDS are the backbone of Delhi Police's forensic and tactical operations."They are elite units of Delhi Police and have remained instrumental in solving several crimes and the arrest of criminals, and ensuring public safety," said Devesh Srivastava, Special Commissioner of Police (Crime). Established in 1983, the Finger Print Bureau operates under the Delhi Police Crime Branch and is instrumental in forensic crime investigations. With a database of over five lakh criminals, the Bureau uses techniques like powder and UV light to match crime scene fingerprints with stored data, said police officials.

Officers said modern software systems such as Automated Fingerprint and Palmprint Identification System (AFPIS), National Automated Fingerprint Identification System (NAFIS), and Computerised Remote Identification of Suspects (CRIS) have significantly enhanced the capabilities of the Finger Print Bureau. Since the nationwide launch of NAFIS in 2022 by Union Home Minister Amit Shah, the



system has led to the identification and arrest of numerous offenders through crime scene prints, they added.Equally critical is the Bomb Disposal Squad, founded in 2002, which handles bomb threats, suspicious packages, and explosive devices across Delhi's crowded and sensitive locations.BDS and its counterpart, the Bomb Detection Team (BDT), conduct 24×7 surveillance, sanitise venues for VIP visits, and are equipped with state-of-the-art technology.Trained alongside the National Security Guard (NSG), Border Security Force (BSF), Central Reserve Police Force (CRPF), and DPA, these teams use vapour detectors, sniffer dogs, and other advanced tools for anti-sabotage checks and rapid response.

## Iran says no nuclear talks under Israeli fire, Trump considers options



JERUSALEM/DUBAI/WASHINGTON, GNS News Agency, June 28 - Iran said on Friday it would not discuss the future of its nuclear programme while under attack by Israel, as Europe tried to coax Tehran back into negotiations and the United States considers whether to get involved in the conflict. A week after it began attacking Iran, Israel's military said it had carried out new strikes on dozens of military targets overnight, including missile production sites and a research organisation involved in nuclear weapons development in Tehran.

Iran launched at least one new barrage of missiles early on Friday, striking near residential apartments, office buildings and industrial facilities in the southern city of Beersheba. The White House said on Thursday that President Donald Trump would decide on "whether or not to go" with U.S. involvement in the conflict in the next two weeks, citing the possibility of negotiations involving Iran in the near future. Iranian Foreign Minister Abbas Araqchi said on Friday there was no room for negotiations with Israel's superpower ally the United States "until Israeli aggression stops".But he was due to meet European foreign ministers in Geneva later on Friday for talks at which Europe hopes to establish a path back to diplomacy over Iran's nuclear programme. Two diplomats said before the meeting involving France, Britain, Germany and the European Union's foreign policy chief that Araqchi would be told the U.S. is still open to direct talks. Expectations for a breakthrough are low, diplomats say.Israel began attacking Iran last Friday, saying its longtime enemy was on the verge of developing nuclear weapons. Iran, which says its nuclear programme is only for peaceful purposes, retaliated with missile and drone strikes on Israel. Israel is widely assumed to possess nuclear weapons. It neither confirms nor denies this. Israeli air attacks have killed 639 people in Iran, according to the Human Rights Activists News Agency, a U.S.-based human rights organisation that tracks Iran. The dead include the military's top echelon and nuclear scientists.Israel has said at least two dozen Israeli civilians have been killed in Iranian missile attacks.Reuters could not independently verify the death toll from either side. Details of casualties in the latest strikes were not immediately known.

Both sides say they are attacking military and defencerelated targets, but civilians have also been caught in the crossfire and each has accused the other of hitting hospitals. An Iranian news website said a drone had struck an apartment in a residential building in central Tehran on Friday, but did not give details. Israel's strikes on Iran's nuclear installations so far pose only limited risks of contamination, experts say. But they warn that any attack on the nuclear power station at Bushehr could cause a nuclear disaster. Israel says it is determined to destroy Iran's nuclear capabilities but that it wants to avoid any nuclear disaster in a region that is inhabited by tens of millions of people and produces much of the world's oil.

The meeting in Geneva was due to start on Friday afternoon. The Swiss city is where an initial accord was struck in 2013 to curb Iran's nuclear programme in return for sanctions being lifted. A comprehensive deal followed in 2015. Trump pulled the U.S. out of the agreement in 2018. A new series of talks between Iran and the U.S. collapsed when Israel launched what it called Operation Rising Lion against Iran's nuclear facilities and ballistic capabilities on June 12. Trump has alternated between threatening Tehran and urging it to resume nuclear talks. His special envoy to the region, Steve Witkoff, has spoken to Araqchi several times since last week, sources say. The Middle East has been on edge since the Palestinian militant group Hamas attacked it in October of 2023, triggering the Gaza war, and Israel has been fighting on several fronts against Iran's regional allies. Israeli Foreign Minister Israel Katz warned on Friday of further action against Iranian ally Hezbollah, a day after the Lebanese militant group suggested it would come to Iran's aid.Western and regional officials say Israel is trying to shatter the government of Supreme Leader Ayatollah Ali Khamenei

Prime Minister Benjamin Netanyahu said on Thursday "the downfall of the regime ... may be a result, but it's up to the Iranian people to rise for their freedom."Iranian opposition groups think their time may be near, but activists involved in previous protests say they are unwilling to unleash mass unrest with their nation under attack, and Iranian authorities have cracked down hard on dissent."How are people supposed to pour into the streets? In such horrifying circumstances, people are solely focused on saving themselves, their families, their compatriots, and even their pets," said Atena Daemi, a prominent activist who spent six years in prison before leaving Iran. ## US court lets Trump keep control of California National Guard for now

WASHINGTON,GNS News Agency, June 28 - A U.S. appeals court let Donald Trump retain control on Thursday of California's National Guard while the state's Democratic governor proceeds with a lawsuit challenging the Republican president's use of the troops to quell protests in Los Angeles.Trump's decision to send troops into Los Angeles prompted a national debate about the use of the military on U.S. soil and inflamed political tension in the country's second most-populous city.The Reuters Tariff Watch newsletter is your daily guide to the latest global trade and tariff news. On Thursday, a three-judge panel of the San Frano-based 9th U.S. Circuit Court of Appeals extended its pause on U.S. District Judge Charles Breyer's June 12 ruling that Trump had unlawfully called the National Guard into federal service. Trump probably acted within his authority, the panel said, adding that his administration probably complied with the requirement to coordinate with Governor Gavin Newsom, and even if it did not, he had no authority to veto Trump's directive."And although we hold that the president likely has authority to federalize the National Guard, nothing in our decision addresses the nature of the activities in which the federalized National Guard may engage," it wrote in its opinion.Newsom could still challenge the use of the National Guard and U.S. Marines under other laws, including the bar on using troops in domestic law enforcement, it added. The governor could raise those issues at a court hearing on Friday in front of Breyer, it said. In a post on X after the decision, Newsom vowed to pursue his challenge."The president is not a king and is not above the law," he said. "We will press forward with our challenge to President Trump's authoritarian use of U.s. military soldiers against our citizens."Trump hailed the decision in a post on Truth Social. "This is a great decision for our country and we will continue to protect and defend law-abiding Americans," he said."This is much bigger than Gavin, because all over the United States, if our cities, and our people, need protection, we are the ones to give it to them should state and local police be unable, for whatever reason, to get the job done."Breyer's ruling was issued in a lawsuit against Trump's action brought by Newsom. Breyer ruled that Trump violated a U.S. law governing a president's ability to take control of a state's National Guard by failing to coordinate with the governor. It also found that the conditions set out under the statute to allow this move, such as a rebellion against federal authority, did not exist.Breyer ordered Trump to return control of California's National Guard to Newsom. Hours after Breyer acted, the 9th Circuit panel had put the judge's move on hold temporarily. Amid protests and turmoil in Los Angeles over Trump's immigration raids, the president on June 7 took control of California's National Guard and deployed 4,000 troops against Newsom's wishes. Trump also ordered 700 U.S. Marines to the city after sending in the National Guard. Breyer has not yet ruled on the legality of the Marine Corps mobilization At a court hearing on Tuesday on whether to extend the pause on Breyer's decision, members of the 9th Circuit panel questioned lawyers for California and the Trump administration on what role, if any, courts should have in reviewing Trump's authority to deploy the troops. The law sets out three conditions by which a president can federalize state National Guard forces, including an invasion, a "rebellion or danger of a rebellion" against the government or a situation in which the U.S. government is unable with regular forces to execute the country's laws. The appeals court said the final condition had probably been met because protesters hurled items at immigration authorities' vehicles, used trash dumpster as battering rams, threw Molotov cocktails and vandalized property, frustrating law enforcementThe Justice Department has said once the president determines



## Thai PM faces call to step down to avert coalition revolt



BANGKOK, GNS News Agency, June 28 Thailand's embattled Prime Minister Paetongtarn Shinawatra was facing the prospect of losing her government's majority on Friday as a vital coalition partner looked set to demand her resignation after just 10 months in power. Paetongtarn, the politically inexperienced daughter of divisive tycoon and former premier Thaksin Shinawatra, is fighting fires on multiple fronts, struggling to breathe life into a stagnant economy facing steep U.S. tariffs and under pressure to take a tougher stand on a territorial row with Cambodia that has seen their troops mobilise at the border. We have to wait for the party leader to inform the prime minister first," he said.weakened for a fifth consecutive session on Friday and was on course to log its worst week since late February.Paetongtarn's battle to stay in power demonstrates the declining strength of Pheu Thai, the populist juggernaut of the billionaire Shinawatra family that has dominated Thai elections since 2001, enduring military coups and court rulings that have toppled multiple governments and prime ministers.But Paetongtarn is facing domestic anger and the prospect of an internal revolt over Wednesday's embarrassing leak of a phone call between her and Cambodia's influential former leader Hun Sen - once seen as a Shinawatra family ally - which her critics say posed a threat to Thailand's sovereignty and integrity.During the conversation, Paetongtarn called for a peaceful resolution of the border dispute and disparaged an outspoken Thai army general who she said "just wants to look cool", a red line in a country where the military has a high profile and significant political clout.

Political activists met on Friday to schedule a major protest in Bangkok starting on June 28 to demand Paetongtarn resign and coalition partners leave the government. Those included groups with a history of crippling rallies against Shinawatra administrations. Paetongtarn has not commented on the turmoil in her government and has tried to present a united front on the Cambodia issue, appearing on Thursday alongside military chiefs and vowing to defend sovereignty. The premier will make a morale-boosting visit to military units at the Cambodia border on Friday, where she is due to meet Lieutenant General Boonsin Padklang, the regional commander whom she criticised in the leaked call.Paetongtarn's options for staying in power are limited unless her allies can succeed in behind-thescenes horse-trading to keep her alliance from crumbling.A snap election could damage Pheu Thai at a time of dwindling popularity and play into the hands of the progressive opposition People's Party, the largest force in parliament. Two Pheu Thai sources told Reuters the party is confident Paetongtarn can avoid resigning or dissolving parliament and her government is considering a major cabinet reshuffle to fill vacant positions.

## Leaders of China, New Zealand discuss trade, Pacific security

BEIJING/SYDNEY, June 20 (Reuters) - The leaders of China and New Zealand discussed on Friday the role of trade in boosting ties, while New Zealand also pressed its interests for peace and security in the Pacific, government statements showed. President Xi Jinping and Prime Minister Christopher Luxon met in the capital's Great Hall of the People as China's influence grows in the Pacific, challenging the traditionally stronger security foothold many Western nations have had there. Sign up here.On his first visit to China since taking office in November 2023, Luxon discussed the need for stability, less tension in the Indo-Pacific and New Zealand's "enduring support for Pacific-led priorities", his government said in a statement.Luxon's meeting with the leader of New Zealand's biggest trade partner was "constructive", he said in a post on X."We discussed the depth of the New Zealand-China relationship - from trade and people-to-people ties to our shared global responsibilities," he said. "In a complex world, open dialogue is more important than ever."

The remarks came after New Zealand aired concerns Islands with which it ha tional ties, signed pacts with China without first consulting it, including one for cooperation on the economy, infrastructure and seabed mining.Luxon also backed up the role of the Pacific Islands Forum, an inter-government body seeking to foster cooperation among Oceanic countries and territories.Without making specific reference to any issue, Xi called for both countries to seek common ground and view differences "accurately", state news agency Xinhua said."There are no historical grudges or conflicts of interest between China and New Zealand, so we should respect each other, seek common ground," Xi told Luxon, it said, adding that both must accurately look at and tackle disagreements. During his four-day visit to the commercial hub of Shanghai and the capital, Beijing, Luxon has championed an agenda of boosting business, travel and educa-



tion for New Zealand.MORE BUSINESSXi also talked about deepening trade and investment ties, as well as scope to work on science and technology, climate change response and infrastructure along with education exchanges - echoing most of Luxon's goals.Luxon documented his meetings on Instagram, posting video messages to fellow citizens reinforcing his mission of getting "money into your back pocket".He clinched travel-related pacts and pushed New Zealand's tertiary education as well as its exports of meat, a key item of trade with China after dairy. Its exports to China were NZ\$20.85 billion (\$12.51 billion) in 2024, comprising goods worth NZ\$17.75 billion and services of NZ\$3.1 billion, the foreign ministry said on its website.Chinese tourists are New Zealand's third-largest group of international visitors, though official data show their numbers are still nearly a fifth lower than in 2019, before the COVID-19 pandemic.China Eastern Airlines will launch more flights with New Zealand from December, the New Zealand government said on Wednesday. Days before the visit, New Zealand unveiled a 12-month trial of visa waivers from November for Chinese passport holders arriving from Australia with valid visas from its neighbour.

## Australia deploys military assets to safeguard citizens amid Middle East crisis

Canberra: The Australian government has deployed military assets to the Middle East amid escalating tensions to help evacuate its citizens from Iran and Israel. The Australian Defence Force (ADF) has positioned personnel and aircraft in the region as part of contingency plans should the currently closed airspace reopen. "We are sending defence assets to help Australians. They are not there for combat," Foreign Affairs Minister Penny Wong said while addressing reporters in South Australia. In a further move to support the evacuation efforts, a crisis response team from the Department of Foreign Affairs and Trade (DFAT) is being dispatched to Azerbaijan. This team will assist Australians who manage to leave Iran without direct government aid. As of Friday, more than 2,000 Australian citizens in Iran and 1,200 in Israel have registered with DFAT

for evacuation assistance. Wong strongly urged any Australian able to leave Iran safely to do so immediately, advising those who cannot or choose not to, to shelter in place.Amid the deteriorating security situation, the Australian government has suspended operations at its embassy in Tehran and ordered the departure of all officials and their dependents from Iran. However, the country's Ambassador to Iran will remain in the region to coordinate and support the response to the crisis, supported further by consular staff scheduled for deployment to Azerbaijan. In a related development, Italy has opted to maintain operations at its embassies in both Tehran and Tel Aviv while organizing charter flights for Italian nationals wishing to leave the conflict zones. Meanwhile, the Israel Defence Forces announced that it had carried out a series of overnight airstrikes in Tehran targeting sites linked to Iran's missile and nuclear weapons programmes.

History and literature are replete with references to not 'shooting the messenger' for bringing bad news. In Shakespeare's Antony and Cleopatra, the Egyptian queen assaults a messenger and threatens to have him "whipped with wire and stewed in brine, smarting in ling'ring pickle", for bringing her the news that the Roman General Mark Antony has married another. "I that do bring the news made not the match," the messenger replies, before making a hasty exit. Over the past two months, India's 'diplomatic messengers' too have faced an ire that is unprecedented — criticised not for the message they bring, but for failing to convey effectively enough, the message New Delhi has sent out after Operation Sindoor (May 7-10, 2025).

Public commentary that is critical of the Ministry of External Affairs and its missions has focused broadly on three counts. First, that India received condolences and statements condemning the Pahalgam terror attack from all quarters, but not the kind of unequivocal support, especially from the neighbourhood, for retaliatory strikes on Pakistan, of the kind seen in 2016 (post-Uri) and 2019 (post-Pulwama). In 2016, Bangladesh, Bhutan, Afghanistan, Sri Lanka and the Maldives backed India's decision to stay away from the South Asian Association for Regional Cooperation summit in Pakistan after the Uri attack. In 2019, global solidarity with India forced even China to back a United Nations Security Council (UNSC) terror designation for Jaish-e-Mohammad chief Masood Azhar. Earlier, in 2008, there was international consensus in India's favour after the Mumbai attacks, when Hafiz Saeed and a number of Lashkar-e-Taiba terrorists were designated by the UNSC, and Pakistan was put on the Financial Action Task Force (FATF) grey list for the first time. Instead, this time, unfavourable comparisons have been made to Pakistan for the lines of support it received from China, Turkiye, Azerbaijan, Malaysia and the Organisation of Islamic Cooperation (OIC). Second, the perception is that Pakistan has scored some diplomatic wins, despite widespread global understanding that Pakistan uses terrorists as state proxies. In April, Pakistan, a non-permanent member of the UNSC, managed to amend the resolution on Pahalgam to delete any reference to The Resistance Front (TRF), that claimed responsibility for the heinous attack

Earlier this month, Pakistan was chosen as chair of the Taliban Sanctions Committee and vice-Chair of the Counter-Terrorism Committee at the UNSC, and secured loans from the International Monetary Fund and Asian Development Bank despite New Delhi's opposition. Next was the White House's lunch invitation to Pakistan Army chief (now Field Marshal) General Asim Munir, despite the belief in India that his "jugular vein" speech was a virtual green signal for the Pahalgam attack. In July, as Security Council President for the month, Pakistan will try to schedule meetings on the India-Pakistan conflict and Kashmir, even as India accelerates efforts to designate the TRF at the UNSC, and place Pakistan on the FATF greylist. India's diplomats will be tested again. The third aspect pertains to United States President Donald Trump, who, despite official denials from India, has chosen to muddy the narrative of how the May 10 ceasefire was achieved, hyphenating India and Pakistan in more than a dozen public statements, and offering to mediate on Kashmir. His latest iteration of the comments this week, just hours after a telephone conversation with Prime Minister Narendra Modi, and just before his meeting with Gen. Munir, was possibly the most blatant. Thus far, Mr. Trump's statements, post-ceasefire, have not had a single word on the scourge of terrorism itself, showing just far apart the understanding between Delhi and Washington is at this time. A flurry of diplomacy does not seem to have moved the needle on these criticisms. After Operation Sindoor, special delegations of Members of Parliament and former diplomats travelled to 32 countries. The most time (six days) was spent in the United States. After the G-7 meet, Mr. Modi has meetings ahead with BRICS leaders. External Affairs Minister S. Jaishankar is visiting the U.S. for the Quad Foreign Ministers Meeting soon, after several visits to European capitals recently. The government had not essayed such a campaign after the 2016 or 2019 actions against Pakistan, indicating that it too feels that diplomatic efforts by the Ministry of External Affairs and missions abroad have been found wanting and need bolstering.But much as the messenger in Shakespeare says, India's diplomats do not decide the message that India wishes to send after Operation Sindoor, and cannot be held responsible for its resonance. It is necessary for the government to study the contents of that message, the shift in geopolitical narratives and in how India is perceived, in order to build a more realistic assessment of how far international diplomacy can ensure the outcomes New Delhi desires vis-à-vis Pakistan.

The 'new normal'With reference to the content of the message, Mr. Modi's three-pronged "New Normal" has raised eyebrows in some capitals. The first prong - 'Any act of terror is an act of war' - lowers the threshold for future conflicts, passing the trigger for Indian strikes into the hands of any terrorist, acting on orders on their own. The second — 'India will not bow to nuclear blackmail' — is not necessarily new, but has been left unarticulated thus far because it gives the appearance of a heightened nuclear risk for the region. The third - India will not distinguish between state and non-state actors henceforth - sends out an escalatory message, indicating that the next terror attack could well invoke 'Armageddon', rather than the controlled four day conflict in Operation Sindoor. While India's partners have not asked for evidence of Pakistan's links to Pahalgam, they look askance at other aspects - like why India has been unable to trace the terrorists responsible yet.Next, it is necessary to note that global shocks in the past few years have changed how the world views India's tough messaging. Take for example, a growing number of statements by Indian Ministers about "taking back Pakistan occupied Kashmir" by force if necessary. These make many of India's interlocutors uncomfortable, given the current number of conflicts over territorial aggression underway, from West Asia, to Ukraine to the South China Sea. In the light of Israel's retaliation for the October 7, 2023 terror attacks, few wish to give any state a free hand for "retribution". New Delhi's refusal to criticise Russia for its invasion of Ukraine in 2022 and to raise its oil imports from Russia in the face of sanctions, lost it some support in the western world, especially Europe. The Modi government's silence on Israel's devastation of Gaza has also been met with disappointment in the Global South.India, as Mr. Modi told Mr. Trump this week, views terrorism emanating from Pakistan, "not as a proxy war, but as a war itself". India's diplomats have been left explaining why their stock responses that "this is not an era of war" and that "dialogue and diplomacy" are the only way forward do not apply to India and Pakistan. Thus, it may be necessary for New Delhi to rethink how it frames its message in view of these changes, notwithstanding the global double standards inherent in the expectations from India. Finally, there is need for introspection over how the Modi government's image itself has altered in the world since 2019, leading to diplomatic challenges on a number of fronts. These range from concerns abroad over laws such as the Citizenship (Amendment) Act, the amendment of Article 370, Internet bans and summary arrests in different parts of the country, and accusations against Indian government agents of involvement in transnational attacks in the U.S. and Canada. Questions over the broader decline in democracy and the status of minorities within India have also increased in the past few years. India's delegations abroad (Operation Sindoor) had to field some of those questions during their travels. India's right to defend itself from decades of Pakistan-backed, trained and funded terrorists is unassailable. But carrying a tough message on terror is easier for the diplomats tasked with the role, if in a strife-roiled world, the government plays to India's advantages, and what differentiates it from Pakistan — as a secular, stable, pluralistic, rule-abiding democratic and economic power.

# Indian students and the death of the American Dream



Kabir has spent the past few months running. Every morning, before the California sun begins to glare on the cracked sidewalks, he slips on his shoes and bolts out the door. The run, he says, is what keeps him sane. "It's the only time I can make a plan. What to say to the lawyer. Which papers to organise. Who to call for help." How not to fall apart.Kabir (name changed on request), who had arrived from Pune to study at the University of California, had his student visa revoked along with thousands of others across the country. The email had come without warning. It had given him no time to prepare. Just a sudden vanishing of the ground beneath his feet. He hasn't stopped running since. "I got this news on April 2, just a day after Eid. I had wanted to go home, but couldn't in these circumstances," he says.

And now, it may be a long while before he can. His Eid kurta and suit are still on the hanger, waiting to be worn. His apartment still carries the remnants of a celebration that didn't last. A few half-deflated balloons cling to the ceiling — a bittersweet memory, as just a few days before his visa revocation, he had won the H-1B lottery (a random selection process by which a limited number of H-1B visas are allotted every year). Many Indian students have been targeted as a part of the Trump administration's actions against universities and immigrants.

In the weeks that followed, Kabir's days became a blur - mornings on the pavement, afternoons in legal and immigration offices, evenings in community centres where other students like him sat huddled on plastic chairs, comparing legal notes, wondering what they had done wrong. Each time, the same questions, the same uncertainty, hung like static in the air." I run, I walk, I travel. Anything to escape my thoughts," says Kabir. And yet, they are everywhere. In the faces of the other students who are caught in the same dragnet. In a mural stretched across a wall in Los Angeles that says, 'My brother and I are my parents' American Dream.'In the eye of the stormKabir's story is not his alone. Thousands like Kabir have been left in limbo, their futures upended by the shifting tides of immigration law and political mood in the United States. #### A larger ideological campaign

The Trump administration's move to ban international students has been unfolding alongside a systematic rollback of diversity, equity, and inclusion (DEI) programmes across the country. In January 2025, an executive order directed all federally funded institutions to terminate all raceor gender-based diversity programmes, claiming they were in violation of meritocratic ideals and civil rights law. Soon after the order, the Department of Education launched investigations into 45 colleges for "race-exclusionary practices". The Department of Homeland Security also imposed stricter limitations on student visas: narrower Optional Practical Training (OPT) eligibility, intensive background checks, and increased scrutiny of STEM graduates, most of whom are from countries like India and China.

#### Solidarity with Harvard

The cloudy skies on Harvard's graduation day on May 29 were not new for Boston summer. But the bright blue globes held against the darkening sky were. These globes belonged to Harvard graduates who had raised them as a sign of solidarity with the international student body at the institution. Alan Garber, president of Harvard, echoed the sentiment as he opened his speech: "To the class of 2025, from down the street, across the country, and around the world. Around the world — just as it should be."

As his words drew a standing ovation, just eight kilometres away, a judge was working to extend a court order allowing Harvard to enrol international students. Only a week earlier, on May 22, the Department of Homeland Security had revoked that ability. This had come on the heels of billions frozen in funding by the government and threats to strip Harvard of accreditation and tax-exempt status. The administration cited concerns over campus activism and alleged antisemitism.

Even as Harvard fought back, arguing that these were retaliatory moves undermining institutional autonomy and academic freedom, Trump issued another proclamation on June 4 barring Harvard-bound international students for six months. This time, when the federal judge granted a temporary restraining order to halt enforcement, she also acknowledged "immediate and irreparable injury" - a phrase that is more than just legalese for the thousands of international students caught in the dragnet. According to the Community Explainer by the South Asian American Policy Working Group, a network of organisations that address policy issues affecting South Asian communities, "More than 1,800 students from nearly 250 colleges have had their visas revoked and their SEVIS records terminated without notice or due process. Only about half of them received actual notice of their visa revocations, so many might not even be aware of their visa termination." SEVIS, or the Student and Exchange Visitor Information System, maintained by the U.S. Department of Homeland Security, keeps an electronic record of the immigration status of international students and exchange visitors."A lot of students got nervous and self-deported. Who knows when they will be able to come back now. At the same time, there are others who are not leaving the U.S. for that very reason. It is a double-edged sword. They are afraid to go, they are afraid to stay." Indian students, the largest single group of foreign students in the United States, have been hit especially hard. Asian youth to drive political change. What began as visa revocations of students who participated in or supported pro-Palestine protests had metastasised by April. Suddenly, hundreds of international students had their visas revoked. Denying student visas based on social media vetting is the latest step in this quickly unravelling saga.

## Why India should address its propulsion gap

The story so far: There has been growing excitement in military and industrial circles over the fast-tracked indigenous fifth generation stealth Advanced Medium Combat Aircraft (AMCA). Touted as a multi-role fighter with supercruise capability, internal weapons bays, advanced avionics, and diverter-less supersonic intakes enhancing stealth and reliability, the AMCA is being hailed as a milestone in Indian aerospace history. However, a dose of historical realism is warranted particularly since India has a persistent propulsion gap, and is overly reliant on imported engines. Nearly seven decades of fighter development reveal cautionary lessons, starting with India's first indigenously designed fighter jet, the HF-24 Marut (Spirit of the Tempest).

What happened to the HF-24 Marut?

Launched in the 1950s by Hindustan Aeronautics Limited (HAL) under famed German engineer Kurt Tank - designer of several WWII Luftwaffe fighters - the twin-engine, swept-wing Marut was, like the AMCA, an ambitious project of its time. Sleek and capable of transonic speeds, it embodied post-colonial India's drive for self-reliance and entered service amid high hopes in the late 1960s. However, the Marut never reached its full potential, not because of design flaws, but entirely due to its underpowered British Bristol Siddeley Orpheus 703 turbojets. Although Tank had envisioned a more powerful engine, it never materialised, leaving the Marut's performance underwhelming. And, while it performed reasonably well in ground-attack roles during the 1971 war on the western front, its propulsion limitations ultimately proved crippling. HAL produced only 147 of these high-maintenance, low-output fighters, which were eventually 'number-plated' or retired by 1990.Indian Air Force (IAF) veterans who flew the Marut consistently cited the lack of a powerful engine as its Achilles' heel - highlighting the enduring reality that high-end fighters live or die by propulsion technology. Engines, after all, are not mere technical parts but the core of sovereign aerospace capability, shaping a combat aircraft's power, range, and mission effectiveness.

Did India develop its own engines?

Following the Marut's disappointing engine performance, the Defence Research and Development

Organisation (DRDO) assigned its Gas Turbine Research Establishment (GTRE) laboratory in 1989 to develop the Kaveri GTX-35VS afterburning turbofan for the Light Combat Aircraft (LCA), which had been under design development since 1981-82. Over the next 35 years. GTRE spent around ?2032 crore, as of 2020, on the project, but without success. Despite producing nine full-scale prototypes and four core engines - logging over 3,000 hours of ground testing and 73 hours of flight trials on an Ilyushin IL-76 flying test bed in Russia - the Kaveri failed to meet the LCA's performance benchmarks. It struggled with thrust-to-weight ratio, reliability, and thermal management under sustained high-performance conditions. Though spinoff versions were proposed for tanks, ships, and locomotives, none have so far entered operational use. A revival attempt in 2016, in collaboration with French engine-maker Snecma (linked to offset obligations from the IAF's Rafale deal) also collapsed. A parallel proposal by its partner Safran to co-develop a new engine for the Tejas MkII and AMCA met a similar fate, reportedly rejected by the DRDO due to institutional pride.

Meanwhile, Kaveri's failure forced the Aeronautical Development Agency (ADA), responsible for the LCA's design, to adopt the U.S.-made General Electric (GE) F404-IN20 afterburning turbofan engine (producing 78-80 kN of thrust) around 2004. Although barely adequate — restricting Tejas' payload and high-angle-of-attack capabilities the engine was eventually approved by the IAF, which inducted two Mk1 squadrons from 2015 onwards, with one squadron operating without full operational clearance, nearly 34 years after the LCA programme's inception.

How is India affected by engine dependency?

India's engine dependency issues resurfaced recently when GE delayed delivery of 99 F404 engines by 13 months for the upgraded LCA Mk1A — a lighter, more capable variant equipped with an Active Electronically Scanned Array (AESA) radar, advanced electronic warfare suites, and midair refuelling capability. Under a \$716 million contract signed in 2021, engine deliveries were scheduled to begin by March 2024, but the first power pack arrived only in April 2025,

## **OpenAI and Microsoft: A partnership under strain**

A 'head over heels' relationship between a tech titan and an AI startup that began over six years ago is turning sour. Microsoft and OpenAl's pact powered the startup's artificial intelligence engine to build generative pre-trained models and de-aged the software maker for the AI era.Now after cumulative investments swelling to \$13 billion the couple is battling between mutual reliance and burgeoning autonomy. This recalibration carries weighty implications for both firms. Recent reports suggest Microsoft is prepared to halt discussions over the future contours of its OpenAI alliance if disagreements on critical terms — like Microsoft's future equity stake - persist. The Windows software maker would then rely on its existing commercial contract, ensuring access to OpenAI's technology until 2030. This marks a potential inflexion point in a relationship that saw Microsoft's capital and cloud infrastructure propel OpenAI to the vanguard of AI.At the heart of the current negotiations are fundamental differences in strategic outlook. OpenAI has been overtly seeking to lessen its dependency on Microsoft for cloud computing, a move underscored by new partnerships. Notably, OpenAI finalised a deal in May to use Google Cloud's infrastructure, a significant step to diversify its computing resources beyond Microsoft's Azure ---its current exclusive provider. It has also partnered with CoreWeave and is exploring arrangements with Oracle as part of Project Stargate to further expand its compute capacity. Such diversification provides OpenAI with technical alternatives and, presumably, greater negotiating leverage. The shifting personal ties between the firms' leaders, Satya Nadella of Microsoft and Sam Altman of OpenAI, mirror these corporate recalibrations. Once in near-constant communication, with Mr. Nadella reportedly texting Mr. Altman five or six times a day, their interactions have become more formalised, primarily consisting of scheduled weekly calls, per news reports. This devolution from spontaneous chats to structured exchange began after Mr. Altman's brief ousting from OpenAI in late 2023 – an event that led Mr. Nadella to rearchitect his company's Al future. While Mr. Nadella backed Mr. Altman, the Microsoft CEO also made his controversial decision to bring DeepMind's Mustafa Suleyman on board. At that point, Mr. Suleyman was running Inflection AI. And as part of the deal. the entire team at Inflection AI joined the software maker. Despite these undercurrents, public pronouncements



remained diligently choreographed. Earlier this year, Mr. Altman posted a picture with Mr. Nadella on X, announcing the next phase of their partnership to be "much better" than anyone is ready for. Mr. Nadella echoed the optimistic sentiment. Such displays were aimed at reassuring investors amidst intricate private negotiations and mounting competition from other AI players, as well as increasing regulatory scrutiny globally. A pivotal point of disagreement between the duo is OpenAI's corporate structure. In May, OpenAI announced it would restructure into a Public Benefit Corporation (PBC), while keeping its non-profit parent in control retaining the authority to appoint board members . This was a significant shift from earlier considerations of a more conventional for-profit transition that might have diluted the nonprofit's oversight and authority. The move, amidst criticism from OpenAI early investor and Tesla CEO Elon Musk, was aimed to better align its operational structure with its stated mission of developing AI for humanity's benefit, while still attracting substantial investment. This restructuring requires Microsoft's assent as a key stakeholder - with the tech giant having provided billions of dollars in funding. Microsoft is said to be negotiating the size of its own potential stake in this new PBC, with discussions reportedly ranging from 20% to 49%. Failure to finalise this restructuring by year-end could jeopardise funding from other investors, including a significant investment from SoftBank.Microsoft, for its part, is not standing still. Its AI strategy is visibly broadening beyond its OpenAI relationship. At its Build 2025 conference, Microsoft showcased integrations of models from Anthropic and Musk's xAI, signalling a move towards a more diversified AI portfolio.



## A liberal arts degree is worth much more than realised



We are all too familiar with the recession of 2008 and its subsequent impact on the decline of the humanities and more generally, the liberal arts, in North America and Europe. In the context of the 'existential crisis' facing classic liberal arts programmes, questions have often centred on their relevance and whether they offer tangible 'real-world' skills, resulting in a diverse range of outstanding career outcomes. An article in The New Yorker, The end of the English major, published in 2023 argued that traditional liberal arts study has become the 'quaint province of a privileged elite, comprising students who do not expect a return on their investment and can afford to spend time on unremunerative pursuits

The 'getting a job' concernAs a result, liberal arts degrees face increasing criticism in policy discussions for failing to equip students with the knowledge and the skills valued in the labour market, often leading to inadequate financial returns on their educational investments. Given the discursive link between higher education and job prospects, domain-specific experts and counsellors advise aspiring high school graduates to pursue degrees in business, finance and economics, in order to secure jobs. The statistics are striking: in 1966, 14% of all college graduates in the United States were majors in the humanities (central to the liberal arts); by 2010, that figure dropped by half to only 7%. The discourse is not simply limited to the low likelihood of finding jobs after a liberal arts degree, but also suggests that associated majors are concerned only with abstract ideas. This might have something to do with the context within which liberal arts emerged in early modern Europe, as a means of avoiding manual labour or working with hands. A liberal arts education that combined humanities with science was thought to produce a 'thinking' individual. In many ways, the idea of a liberal arts education seems antithetical to expectations of regional development that involves some technical training and knowledge. Despite its beginning, liberal arts have evolved in practice to be so much more

Liberal arts enable students to comprehend those things that quite literally make us human. The skills that they cultivate in reasoning and critical thinking are every bit as important to future success in the workplace as learning to code, calculate, or raise capital. To paraphrase the longest serving President of Harvard University, Charles Eliot, a liberal arts education teaches a student a little bit of everything, and a great deal of one thing. Given such a powerful approach to generating scholars possessed of allround disciplinary, and indeed, life skills, it appears peculiar that anyone would want to quibble with the exciting possibilities of such an outcome. Let us also note that while liberal arts is experiencing a decline in North America, it has seen a re-emergence in Europe and shows no sign of abating. Only five years ago, the University of Nottingham, U.K., opened a new liberal arts programme, promising that this new initiative will enable students to explore what it means to be human. Today more than 20 universities in the U.K. offer some form of liberal arts and sciences programme.

For some, this re-emergence has arisen partly as a corrective to the region's more recent over-specialisation in education. Towards the east, a decade ago, in Hong Kong, a major educational overhaul saw numerous institutions move from a British-style three-year degree model to a U.S.-style four-year model, with the aim of incorporating the greater breadth evident in a 'liberal arts' approach. This compromise between the full breadth of a liberal arts degree and the specialised approach of a traditional British-style bachelor has also been taken up in other parts of Asia, where liberal arts is often seen as a component of a specialised degree, rather than being offered as a degree in its own right. The idea is that specialised education can be supplemented with a humanistic approach to produce a well-rounded individual who practises critical thinking.

The world versus IndiaSo, as an international phenomenon, the promotion of liberal arts education emerged within countries usually as a combination of indigenous educational reform movements and inchoate transnational advocacy networks. Of course, now there is universal consensus that liberal education prepares students well for life in a globalised, multicultural, society - one that makes them more aware of a variety of cultures and the need to communicate effectively across cultural differences; teaches them to evaluate new ideas with evidence; and formulate opinions, not make assumptions. Today's students also want an education that will address their desires for justice, service and self-expression, while equally wanting to develop the non-cognitive skills that will allow them to be successful in a globally competitive job market. India offers an intriguing case in point. For a nation where higher education has traditionally focused on professional courses, including engineering and medicine, the last couple of decades has witnessed a sudden interest in liberal arts education. Businesses, nongovernmental organisations, and government entities increasingly recognise that a discipline-specific technical education alone is not sufficient for the wholesome growth of the country's economy and society. 'Soft skills', which can be honed through a classical liberal arts education, are crucial in this context. While the rapid development of liberal arts in India has been welcomed by several, others ask and, quite rightly - whether students will get jobs after liberal arts training; whether liberal arts is suitable for a developing country; whether critical thinking skills help students solve India's societal problems - poverty, hunger, caste, and class inequalities. Preparing students to be global citi-

Even for parents without the experience of studying for a degree, it does not take too much imagination to produce a 'usefulness' argument in favour of encouraging their children to take a scientific or technological subject. Even pure science holds out the prospect of a practical application one day. But for the liberal arts, the arguments are much more nuanced. The liberal arts impart the so-called soft skills associated with how to think for yourself, how to research and find things out for yourself, and how to communicate the results to other people. And there is a lot of truth in this. It is for these reasons that the new generation of liberal arts institutions in the country pioneered a model of education that appeals to several stakeholders. Employers highlight the communication skills and the creativity that liberal arts students bring to their workplaces and praise their ability to engage with multidisciplinary teams for effective problemsolving and creative thinking. The technique of threading different kinds of content, conversations, and curriculum is the genius of the faculty in liberal arts institutions, who curate and incorporate the best of substance and knowledge in terms of interdisciplinary and experiential learning, the use of technology, and mentorship to attract young minds towards the best educational experience and to prepare them to be global citizens.

## The Constitution of India, beyond its text



In his book, Founding Mothers of the Indian Republic: Gender Politics of the Framing of the Constitution, Achyut Chetan mentions an interesting anecdote; of a cultural theorist seemingly influenced by the skewed post-structuralist notion of the text telling him that the Constitution is all we have and that there is nothing outside its text. How do you imagine the Constitution beyond its text? What value does a constitution hold beyond its text? As we celebrate the 75th anniversary of the enactment of the Constitution of India, these questions prompt us to reflect on its broader significance. Testament to an aspirational citizenship

The text of the Constitution, undoubtedly, holds greater significance. It gives institutions a tool to interpret and implement policy decisions. But the Constitution is not merely a legal document. It represents a living framework that transcends its textual boundaries. It holds the aspirations, struggles, and collective dreams of a diverse nation. Therefore, while the Constitution serves as the foundation of our administrative framework, it is, equally, a testament to aspirational citizenship. But where do we locate the place of citizens while assessing the Constitution?Citizenship is often understood as a concept derived from statutes or the text of the Constitution. However, in the journey of India's constitutional history, the people themselves have played a pivotal role in shaping and redefining the notion of citizenship beyond what is written in the document. Through various movements, they have actively invoked constitutional principles to challenge inequalities and claim rights and spaces that were historically monopolised by caste and class elites.

For instance, the Dalit movement used the Constitution as a powerful tool to assert its equality and dignity. The Constitution became a site of emancipation and to defy the odd social norms. Article 17 of the Constitution, which abolishes untouchability, became a rallying point for the marginalised communities to fight against caste-based discrimination. Similarly, movements for land reforms, right to education, right to information and even environmental rights movements have consistently used constitutional provisions to demand inclusivity and justice, thereby expanding the scope of citizenship from a legal status to a lived reality of equality and empowerment. In his book, A People's Constitution, Professor Rohit De documents compelling stories of individuals who harnessed the Constitution not only to assert their rights but also to place ordinary citizens at the heart of the constitutional discourse. This engagement by ordinary citizens in applying the Constitution to their daily lives persists. Indeed, it has grown even more robust and strategic, empowering them to claim their rightful place in the republic. Dialogue between the Constitution, citizensThe story of the Constitution is the story of its people. Social activist Aruna Roy, in her recent memoir. The Personal is Political, argues that if democracy is by and for the people, the 'people' are the mainstream - the power elite and its periphery defined by money and power. Therefore, it is necessary to dismantle this mainstream of 'power' and bring those who are at the margin to the centre of our democratic journey. Thus, the purpose of the Constitution would be served. The enactment of the Constitution marked a significant turning point for marginalised groups, including women, minorities, and persons with disabilities. While their direct representation in the Constituent Assembly was minimal, their concerns were thoughtfully discussed and debated, ensuring that the document aimed to be inclusive and accommodative. However, despite these progressive efforts, the Constitution is not without flaws. There have been instances where it has inadvertently become a tool of exclusion.A collective responsibilityAs we commemorate 75 years of its adoption, it is imperative to ensure that the Constitution extends its promise beyond public institutions and into private spheres. This involves empowering citizens to challenge both the authority of a mighty state and the power of private citizens when they act unjustly. ## contraceptive responsibility

Indians need to share

In 1952, India pioneered a national programme for family planning, whose focus has since changed - from improving maternal and child health to stabilising the population. As this programme evolved, so too did permanent methods of contraception.During 1966-70, about 80.5% of all sterilisation procedures in India were vasectomies. This percentage declined every year due to changing policies that, together with other factors, placed less and less of an emphasis on vasectomies. The five rounds of the National Family Health Survey (NHFS) also show the use of male sterilisation, especially in the last three decades, to be steadily decreasing in all States. In fact, the vasectomies percentage remained constant at around 0.3% in NFHS-4 (2015-16) and NFHS-5.

Gender and the disparityThis trend goes against Section 4.8 of the National Health Policy 2017, which aimed to increase the fraction of male sterilisations to at least 30%. Even today, India is far from meeting this target. Official data also show a large disparity between the rates of female and male sterilisation — 37.9% and 0.3%, respectively. Such huge differences indicate that women continue to bear virtually all of the burden of sterilisation, which in turn poses a challenge for India to achieve Sustainable Development Goal 5 — 'gender equality and empowerment of all women and girls by 2030' — among others. In one attempt to bridge this gap, the world observes Vasectomy Day on the third Friday of November (it was on November 15 this year). In 2017, India observed a 'vasectomy fortnight' as well. The initiative is to revitalise the procedure by increasing awareness, generating demand among men, and debunking misconceptions. In the end, the goal is for people already looking for contraceptives as well as those who would if they knew about safe options to consider vasectomies more favourably.But for these concerted efforts, policies still overlook multiple issues on the ground, keeping them ineffective and allowing the gap between male and female sterilisation rates to persist. The ground reality, solutionsFor example, two of the three writers of this article surveyed a village in Chhatrapati Sambhaji Nagar, Maharashtra, in March 2024 as part of a field exercise. The women said sterilisation was their responsibility and that the men do not believe they need to have vasectomies. Most of them also expressed a belief that men should not be "burdened" by it because they already work hard to make ends meet, and that undergoing the procedure could rob the men of their day's wages, worsening their hardship. These women were also unaware of the Indian government's cash incentives to those who undergo vasectomies to offset the loss of wages. In fact, many studies in India have suggested that illiteracy, male egos, misconceptions about its impact on libido, and family opposition have led to the poor acceptance of vasectomies. Many men are not aware of their role in ensuring the safe passage of reproductive years in the lives of their female partners. The unavailability of skilled providers has aggravated the situation, especially in rural areas. To make matters worse, many



trained community health workers themselves know little about no-scalpel vasectomies. As things stand, with increasing awareness of gender equality and rights, it is certainly possible to build a society in which male sterilisation is accepted as normative through proper and timely course correction. As a first step, sensitisation should begin during early adolescence in schools, where awareness programmes and monitored peer-group discussions can lay the foundation for accepting sterilisation as a shared responsibility. Sustained social and behaviour change communication initiatives will be instrumental in debunking myths around and destigmatising vasectomies. Vasectomy is a safe and simple procedure compared to tubectomy, the corresponding surgical procedure for women involving their fallopian tubes. Second, these information, education and communication activities should be supplemented with greater conditional cash incentives for vasectomies with the goal to improve male participation. A study in Maharashtra in 2019 showed that more men in rural tribal areas opted for vasectomies after being offered a conditional cash incentive. Madhya Pradesh's move in 2022 to increase this incentive by 50% is appreciable in this light. An international comparisonThird, India should draw from the lessons from other countries that have increased vasectomy uptake. South Korea has the highest prevalence of the procedure worldwide, and has reported that men are more likely to shoulder contraceptive responsibilities as a result of progressive societal norms and greater gender equality. Similarly, Bhutan has popularised vasectomy among its men by making the procedure socially acceptable, availing good-quality services, and organising government-run vasectomy camps. Brazil increased vasectomy uptake by running awareness campaigns on mass media. The prevalence rate has risen, from 0.8% in the 1980s to 5% in the last decade. Greater public awareness of vasectomies allows both partners in a union to make informed family planning decisions. In tandem, the government must strengthen the national health system to align with policy objectives, invest in training more health professionals to perform the procedure, and promote technical advancements to increase the use of non-scalpel vasectomies.

My friend in Los Angeles helped me find Pearle since we wanted a girl who has an American accent. Abhishek met both of them before the shoot.As Arjun, Abhishek goes through different stages of life and physicality.Since it was shot in the US, we could not break the schedule. We staved there for three months. In some sequences, we used make-up and prosthetics while in others, we used bodysuits. We combined several elements and processes to get the

right look. Let me tell you, Abhishek worked as a good assistant director of mine. Whatever I needed, he ensured it was done. He would say: 'I will act and assist Shoojit da'. He contributed a lot to get the look right. You often lean towards characters who are nonmainstream. Do your theatre days influence your choice?Sometimes what drives you is what's inside you. Arjun gave me a lot of hope and resilience. He is on a journey not to give up. Theatre teaches you every aspect of life. My guru NK Sharma, in Delhi, taught me all that. He respected every job in theatre. If someone is

doing costumes, he would

give that person more respect than, maybe, the actors. A lot of scenes, breakdowns and preparations that I do are all from theatre.

What's the story behind casting Johny Lever to play the character Johny?

When we were writing the script, Ritesh wrote the character's name Johnv. Later, I thought let's cast Johny Lever in that role, who is straight-faced and a bit bizarre. I was not sure he would do it. When we met, he said that he is a 'healer' and is involved in a lot of social activities. He wanted to be a part of it. He is effortless as an actor.

Do you think movies like I Want To Talk, which are more indie in spirit, have less space today?It may appear less if you compare it with other movies. But Vicky Donor (2012) and Piku (2015) found the right audience. I am confident mv producers, Ronnie and Sheel Kumar, will ensure I Want To Talk finds that too.

The humour in the film is understated compared to Piku. Was that deliberate?It is not the kind of film where I can have Piku's humour. This was more of a satire on life, philosophical humour. ## Role of fortified rice in India's nutritional strategy



India has made remarkable progress in addressing food insecurity, transitioning from severe food shortages to becoming a major food producer. The country now stands as a leading producer of cereals and for the first time in decades, the gross value added from fruits and vegetables has surpassed that of cereals, indicating a diversification in agricultural production. Additionally, India is the largest producer of milk and ranks among the biggest producers of poultry. These achievements, coupled with well-designed and implemented social safety net programs such as the National Food Security Act, which guarantees subsidised cereals to 67% of the population, have significantly reduced food insecurity. However, the focus has now shifted from simply ensuring food availability to improving the quality of the diet consumed. Poor diets lead to both undernutrition and overnutrition. India faces the 'double burden of malnutrition', where both undernutrition and over-nutrition coexist. This is further exacerbated by widespread micronutrient deficiencies, often referred to as 'hidden hunger,' which affect both undernourished and overweight or obese individuals. Achieving optimal nutrition requires addressing various factors such as access, affordability, and behaviour changes, ensuring that the population consumes a diverse and nutrient-rich diet. Micronutrients are essential vitamins and minerals (e.g., iron, iodine, vitamin A, and zinc etc) which are crucial for growth and development. Since the human body cannot produce most micronutrients, these must be obtained through the food we eat. Deficiency of these micronutrients, largely due to unbalanced diets, has become a global health issue, affecting nearly five billion people worldwide. In India, micronutrient deficiencies are a major public health concern - with high prevalence of anaemia among women and children being one example. Promoting a diverse, nutrient-rich diet is vital for overall health and well-being

A recent working paper from the Prime Minister's Economic Advisory Council, titled Changes in India's Food Consumption and Policy Implications, analysed Household Consumption Expenditure Survey (HCES) for 2022-23 and 2011-12. The findings reveal rising per capita household expenditure nationwide, though disparities remain. Notably, for the first time, food expenditure has fallen below 50% of total spending across states and consumption classes, including the bottom 20%. Consumption of fruits, vegetables, dairy products, meat, eggs, and fish has increased across all states, including among the bottom 20%. However, intake levels remain below recommended amounts for most people. Cereal consumption has decreased across rural and urban areas and among all consumption classes. Despite this, an provement in the diversity of food consur indicating better availability, access, and affordability, likely due to food security programmes that have enabled households to save on cereals and spend more on other food items. The study underlined that despite increased intake of essential vitamins and minerals, the consumption of micronutrients remains inadequate compared to 2011-12. Iron deficiency is particularly concerning, as intake in most states is less than the average requirement. This is worrying because cereals, the major iron source for most of the population, especially the bottom 20%, are consumed less. This downward trend in cereal intake could further reduce dietary iron intake in these households. Anaemia, largely caused by iron deficiency, is also linked to other nutrient deficien-

cies, such as folate and vitamin B12. The study found inadequate consumption of these nutrients contributes to the high prevalence of nutritional anaemia in the country.

Addressing micronutrient deficiencies requires a clear strategy, including dietary diversification, supplementation for high-risk groups, and fortification of staple foods. These strategies are complementary and often used together. As shown in the HCES, dietary diversity is improving, but reaching the required level may take time. Addressing anaemia has always been a high priority in India. The revamped Anaemia Mukt Bharat programme is comprehensive and includes iron and folic acid supplementation for high-risk groups, behaviour change communication, and fortified foods in social safety-net programmes. As part of the comprehensive strategy to address anaemia, the Government of India has decided to fortify rice with iron, folic acid, and vitamin B12. This decision was made after careful consideration of available options. Rice was chosen as the vehicle for fortification because it is consumed by about 65% of the population and is the dominant cereal distributed through the public distribution system (PDS). Although the efficacy and effectiveness of rice fortification are proven, the government implemented the programme in phases. Large pilots were conducted in 15 districts across 15 states as a learning exercise to ensure the feasibility of integrating fortified rice into the PDS. The cost-effectiveness and evaluation of these pilots was documented. Encouraged by the positive results, the government proceeded to scale-up the distribution of fortified rice nationwide. In addition to fortified rice, nutrientrich foods like pulses and millets have been included in the PDS in many states as part of efforts to diversify and improve dietary intake. Fortification is not a new concept in India – we have a long history of food fortification, starting in 1953 with the fortification of vanaspati ghee with vitamin A. One of independent India's significant achievements is salt iodisation, which has nearly eliminated goitre and cretinism. Studies on iron, folate, and vitamin B12-fortified rice have shown positive results in addressing anaemia. For example, a United Nations World Food Programme study in Odisha and Uttar Pradesh demonstrated a decrease in anaemia among children and women who received fortified rice through the PDS and school meals. Similarly, a study in Gujarat noted improved haemoglobin levels, reduced anaemia prevalence, and better cognitive performance among schoolchildren who consumed fortified rice. These studies not only show the biological impact but also prove that fortified rice can be easily integrated into the existing

## Sewer gas deaths: the science behind fatalities and protective gear

In July 2025, the Government informed the Rajya Sabha that 377 people had died between 2019 and 2023, while they were involved in the hazardous task of cleaning sewer and septic tanks. Just a few years ago in Chennai, at a prominent mall, a worker lost his life while cleaning a septic tank -- and this is despite manual scavenging being banned in the country. Ironically, two national surveys (in 2013 and 2018) claimed that manual scavenging no longer existed in India. The challenge therefore, lies in identifying manual scavengers, as their work is often informal employment or outsourced contracts. While there is undeniable sociopathic negligence with regard to this practice, the conversation often focuses solely on its sociological aspects. It is also critical however, to understand how sewer gases are formed, their impact on the human body, and the mechanisms of fatality and consequences of exposure to these gases

#### What is sewer gas?

Sewer gas is a generic name for a mixture of toxic and non-toxic gases. Sewer gases are formed through the microbial decomposition of organic matter in anaerobic or oxygen-deprived environments. Organic waste serves as the fuel for bacterial activity, breaking down into harmful gases such as hydrogen sulfide (H2S), methane (CH4), ammonia (NH3), carbon dioxide (CO2), and carbon monoxide (CO). H2S is produced when sulphate-reducing bacteria break down sulphates in organic matter. Methanogenic bacteria generate methane and are odourless but highly flammable, posing a risk of explosions. Ammonia is formed from nitrogenous waste and can cause severe irritation to the respiratory system. Carbon dioxide and carbon monoxide arise from organic matter degradation and incomplete combustion.H2S is the most hazardous sewer gas. In nature, it originates from volcanic eruptions, hot springs, and the decay of organic matter in environments like swamps, marshes, and coal pits. Industrially, H2S is prevalent in sectors such as oil and gas refining, mining, tanning, pulp and paper processing, rayon manufacturing, and wastewater treatment. The formation of sewer gases, especially H2S, depends on a high concentration of organic waste, long and thick sewer pipes with little airflow, stagnant water, acidic environments and warm temperatures. H2S is infamous for its distinct rotten egg odour, a warning signal at low concentrations (<0.03 ppm). However, this warning mechanism fails due to olfactory fatigue at dangerously high levels (>100 ppm). When a human being is exposed to elevated concentrations of H2S, the gas paralyses the olfactory nerve, disabling a person's ability to detect its smell. This is why workers, even if initially alerted by the odour, may suddenly stop noticing it as they inhale more of the gas.

The effect of H2S on humansIn sewer pipelines, the H2S concentration can vary depending on the conditions. However, levels capable of causing death are common in poorly-ventilated and stagnant systems. H2S concentrations in such environments can range from 100 ppm to over 1000 ppm. At concentrations above 100 ppm, the gas, apart from paralysing the olfactory nerve, can cause severe eye and respiratory irritation. When levels exceed 500 ppm, exposure can result in rapid loss of consciousness and respiratory distress within minutes. At concentrations greater than 1000 ppm, H2S can lead to immediate respiratory arrest and death due to its ability to block cellular oxygen utilisation. At high concentrations, the gas disrupts cellular respiration by inhibiting enzymes in the cytochrome oxidase pathway, depriving cells of oxygen despite the body's abil-

ity to breathe. This can lead to dizziness, loss of consciousness, and collapse within moments. For workers exposed to such high levels, the progression from alertness to unconsciousness is rapid, resulting in death. Imagine your body as a car, with oxygen as the petrol powering its engine. Inside the car, the fuel system is self-contained—the tank (lungs) have the petrol and pipelines (blood vessels) deliver it. The engine (cells) use it to produce energy through an ignition system. The cytochrome oxidase pathway acts like this ignition, helping cells use oxygen effectively. When hydrogen sulfide enters the body, it clogs this ignition system, preventing the engine from burning the fuel. Even though the car has petrol, it can't run. Hydrogen sulfide stops cells from using oxygen, causing the body to "stall" and shut down.

At low concentrations, hydrogen sulfide and ammonia irritate the respiratory system, causing symptoms like coughing, wheezing, and strained breathing. Prolonged exposure, even at low levels, can lead to long-term lung damage, putting workers at risk of chronic respiratory illnesses. H2S and carbon monoxide also affect the nervous system, causing headaches, dizziness, confusion, and, over time, issues like memory loss and cognitive decline. Ammonia and other acidic substances in sewer gases irritate the eyes, leading to redness, watering, and discomfort. Meanwhile, prolonged skin contact with contaminated sewer water often causes rashes and dermatitis. The importance of safety gearMany sanitation workers in South Asia enter poorlyventilated sewer systems without adequate training or protective equipment. In developed nations, stringent safety measures protect sewer workers from exposure to toxic gases. Advanced ventilation systems ensure fresh air circulation, minimising the buildup of hazardous gases. Portable multi-gas detectors monitor air quality in real-time, alerting workers to unsafe conditions. Workers are equipped with self-contained breathing apparatuses (SCBA) and chemical-resistant suits to protect them against gas exposure. Robotics and automation have further transformed sewer maintenance. In the movie The Shawshank Redemption, Andy Dufresne crawled through 500 yards of sewage to escape from a U.S. prison in the 1940s. That scene set nearly 80 years ago, portrayed the triumph of resilience and hope as Andy emerged alive, unscathed, and free to rebuild his life. In the United States, even then, sewer systems weren't the deadly gas chambers they could have been. Fast forward to 2024, and the reality in South Asia is depressing. Even today, sewer lines in this part of the world remain death traps, filled with lethal gases like hydrogen sulfide, turning them into execution chambers. Workers sent into these pipelines don't crawl toward freedom like Dufresne did, but are pulled out as lifeless bodies, victims

ally provide necessary nutrients, unfortunately, this is not always the case due to factors, like availability, access, affordability, and food habits. Despite efforts to encourage people to diversify their diets, it is essential to ensure that they consume optimal levels of micronutrients. Public health authorities have formulated a combination of strategies to meet the nutrient requirements of the population, including rice fortification programme. The strategy should be viewed as part of a broader strategy to address dietary gaps in iron, folate, and vitamin B12, rather than a standalone solution. These measures, combined with disease control efforts such as improved water, hygiene, and sanitation, are likely to result in a much faster reduction in anaemia among women and children.

The right spotAccording to Verma, people usually prefer the forearm and side of the wrist for a tattoo because these areas are less painful and offer a smaller surface area for smaller tattoos. Meanwhile, Yaduvanshi feels that tattoo placement and design are highly subjective, but some areas are more popular than others.



Common placements include the forearm, upper sleeve, and back, as these offer ample space and relatively low pain levels. As for designs, many people opt for minimalist symbols, floral motifs, meaningful quotes, or geometric patterns. He states that the choice ultimately depends on personal style, body shape, and the significance of the tattoo.

#### Should it be visible to you?

"The idea that people should get tattoos in places they can't see often is subjective and depends on personal preference and psychological reasoning," shares Lokesh Verma.While many prefer tattoos in open areas, some people do not, and the reason may be to avoid overexposure, which could lead to boredom or reduce emotional intensity, or even for reasons related to professional and social acceptance. Yaduvanshi agrees and says that the idea that tattoos should be placed where they aren't visible often comes from the belief that one might grow bored with them over time.However, this couldn't be further from the truth for most individuals, as tattoos often serve as cherished reminders, symbols of self-expression, or personal stories of HIV in India, the nation was unprepared for the scale of the crisis to come. As the very important task of spreading awareness continues, traditional awareness campaigns must be reimagined to reach younger populations and high-risk groups. Introducing pre-exposure prophylaxis (PrEP) offers new possibilities, but widespread adoption in the country requires increased awareness, affordability, and accessibility. Virtual interventions are the big game changers in this area, due to their reach across the younger population in the current internet era. This has to be fully leveraged through innovative approaches specific to HIV care continuum. It is also very important to integrate HIV and broader health systems. As HIV increasingly intersects with non-communicable diseases such as diabetes and hypertension, integrating HIV care into primary healthcare systems is crucial. This holistic approach ensures comprehensive care and long-term sustainability, addressing co-morbidities while advancing the fight against HIV.

Achieving viral suppression remains the ultimate goal. This involves ensuring treatment adherence, monitoring viral load effectively, and providing mental health support to people living with HIV. Empowering individuals with consistent care and community-driven solutions can reduce transmission rates and improve their quality of life. YRGCARE, in observance of World AIDS Day 2024, and to remind people that HIV continues to be an infection that should not be ignored, has displayed the red ribbon in three prominent locations in Chennai. This initiative is a powerful awareness symbol, encouraging citizens to reflect on the epidemic and its ongoing impact. Suniti Solomon believed in the power of hope and humanity to drive progress. She once said, "Hope is our greatest ally in the fight against HIV." ## Socio-economic factors influence dementia risk and recovery, study finds

New Delhi: Not just genes, a new study has found that socio-economic factors such as education, occupation and wealth can also impact the likelihood of developing cognitive impairment or dementia in later life and whether a person is likely to recover.By estimating the time spent in each cognitive state and the likelihood of transitions to neuro-cognitive disorders such as cognitive impairment and dementia, the researchers from University College London (UCL) were able to gain a comprehensive understanding of how socioeconomic factors impact the progression of a person's disorder, as well as the duration spent within each cognitive state over time. Lead author Aswathikutty Gireesh from UCL Epidemiology and Health Care said that it is possible that education and intellectually demanding jobs provide more mental stimulation and help to build a stronger brain reserve to help protect individuals against cognitive impairment and dementia.

The study, published in the journal Scientific Reports, highlights the critical role of wealth, education, and occupation not only in reducing the risk of transitioning from mild cognitive impairment to dementia but also in increasing the likelihood of reversing cognitive impairment to a healthy cognitive state, which is promising, said senior author Dr Dorina Cadar from UCL Department of Behavioural Science and Health and Brighton and Sussex Medical School.The researchers tracked how people moved between various states: healthy, mild cognitive impairment and dementia. They also considered the possibility of reversals, where individuals improved from a mild cognitive impairment state to a healthy one.

## US Senate clears GENIUS Act: What the draft stablecoin regulation means for the global crypto landscape



The US Senate passed the GENIUS Act Bill on Wednesday with a vote of 68-30 in a major boost for stablecoins - reserve-backed cryptocurrencies that have received an impetus from the Donald Trump administration in America. The next stage for the GENIUS Act will be passage in the US House of Representatives, where members have readied their own version of a stablecoin regulation bill, the STABLE Act. Challenges notwithstanding, the GENIUS Act's passage in the US Senate led to a surge in the price of crypto exchange operator Circle. According to exchange data, Circle Internet Group's share price was up 33.82 per cent at market closing on Wednesday. In premarket activity, Circle's share price was up another 24.75 per cent to \$211.87 apiece at 1:35 pm IST on Friday. Stablecoins, or commodity-backed cryptocurrencies have witnessed a surge in market capitalisation to \$251.7 billion so far in 2025, marking a 22 per cent rise this year, Reuters reported on Wednesday, citing industry data. The passage of the GENIUS ACT Bill in the US Senate is backed by multiple actions taken by the administration of US President Donald Trump - from the announcement of a strategic crypto reserve to the promotion of cryptocurrency sympathiser Paul S Atkins as chairperson of the US markets regulator, the Securities and Exchange Commission. Trump's family interests in cryptocurrency are well known and were mentioned in the Senate discussions after the tabling of the GENIUS Act. In the run-up to the passage of the GENIUS Act bill in the US Senate, US Treasury Secretary Scott Bessent said in a social media post on X that "stablecoins could grow into a \$3.7 trillion market by the end of the decade". Elaborating on how this may work, Bessent gave the example of how "all of a sudden if you are using a stablecoin in Nigeria backed by the USD, you don't actually have to have dollars it's on your phone, you can transact (using dollar-backed stablecoins) ... " Crypto is not a threat to the dollar. In fact, stablecoins can reinforce dollar suprema Digital assets are one of the most important phenomena in the world right now, yet they have been ignored by national governments for far too long."There's a very good chance that crypto is actually one of the things that locks in dollar supremacy," Bessent added. The Guiding and Establishing National Innovation for U.S. Stablecoins (GENIUS) Act was passed by the US Senate on Wednesday with a 68-30 vote. The bill sets guardrails for stablecoins with proposals for compliance to ensure prevention of money laundering, full backing of cryptocurrencies by reserves and monthly BC reported The GENIUS Act will be tabled nex in the US Representatives House which has its own version of the stablecoin regulation bill, the STABLE Act. The Stablecoin Transparency and Accountability for a Better Ledger Economy (STABLE) Act places oversight of stablecoins, or reserve backed cryptocurrency under the purview of the Office of the Comptroller the Currency in the US, similar to the GENIUS Act. However, STABLE Act differs from the GENIUS Act in terms of limiting reserve backing requirements to a clutch of assets such as US Treasuries apart from restricting who can issue stablecoins, according to Jeff Reundlet, head of accounting strategy at Cryptio, provider of ledger services for cryptocurrencies. However, the STABLE Act bill may not go far enough, according to a paper written by partners at the law firm Orrick.While the bill aims to create a single regulatory framework for prospective issuers, and excludes payment stablecoins from federal securities laws, it may allow state regulators the power to monitor which stablecoins may be supported by exchanges of licensed intermediaries, wrote Nathaniel Reisenburg, managing associate, and Joseph Perkins and Ignacio Sandoval, partners at Orrick.US President Donald Trump took to his social media platform Truth Social after the US Senate passed the GENIUS Act bill, stating it "going to make America the UNDISPUTED Leader in Digital Assets - Nobody will do it better, it is pure GENIUS!"

"Digital Assets are the future, and our Nation is going to own it. We are talking about MASSIVE Investment, and Big Innovation," Trump added.In his podcast interview, Bessent reiterated the Trump administration's commitment to digital assets, while adding that "because there are so many other things that happen around digital assets... it's one of the most important phenomenons happening around us in the world and the US just ignored it (under the Biden administration)."Trump reversed his stance on crypto assets from his first term, and even released his own namecoin to burnish his credentials as a backer of virtual digital assets. Cryptocurrency backers also contributed generously - around \$20 million —into electing what is considered a pro-crypto Congress during the 2024 cycle, CNBC reported.In a recent declaration, Trump disclosed earnings of over \$600 million from interests including crypto, golf clubs, and licensing deals apart from other ventures. According to the public disclosure, the US President has earned an estimated \$320 million from his \$TRUMP memecoin. Trump also pulled in \$400 million from the World Liberty Financial platform for cryptocurrencies which is backed by his children. The US President earned \$57.35 million from the sale of digital tokens at WLF. He also reportedly held over 15 billion governance tokens in WLF. Other crypto ventures related to Trump include exchange traded funds held via Truth Social's crypto vertical Truth.Fi, and crypto mining firm American Bitcoin, CNBC reported.Hacker group Gonjeshke Darande, Persian for 'Predatory Sparrow', with potential links to Israel, wiped off \$90 million from Iran's largest crypto exchange Nobitex, Reuters reported, citing a Telegram post by the group. The attack was confirmed in the app by Nobitex, according to the report.

Hackers wiped the exchange clean of a range of digital coins from Bitcoin to Ethereum and Dogecoin, said Andrew Fierman, head of national security intelligence at Chainalysis, the newswire reported.Last month, Trump family-linked WLF inked a pact with the Pakistan Crypto Council to boost cryptocurrency adoption in the country, days after it agreed to a ceasefire with India in the aftermath of Operation Sindoor, which was launched by New Delhi to target terror camps across the border in response to a terror attack in Pahalgam, Kashmir which killed 26 Indian touriate

Apart from these instances of cryptocurrencies playing a key role in diplomacy as well as hostilities, digital tokens are also being used to reinforce the US dollar's supremacy, as pointed out by Bessent above. By formalising stablecoin issuance, backed by the dollar, the US is seemingly hedging its bets in a world where key economies are switching to commodities such as gold as they intend to de-risk their holdings from USD-related volatility. The US sanctions on Russia in the aftermath of the declaration of war on Ukraine involved the freezing of Russian foreign exchange worth \$300 billion, triggering a risk-off approach among countries across the world. In 2023, Russian President Vladimir Putin gave a call for de-dollarisation, urging the BRICS grouping to promote settlements in national currencies and expand bank-to-bank cooperation.Trump warned the BRICS against such a move which could potentially hurt the dollar. In a statement in February Trump boasted he had warned BRICS nations of desisting from de-dollarisation or face outsized tariffs. The stablecoin route is expected to energise the dollar by promoting the use of cryptocurrency pegged to the greenback. It remains to be seen whether this will be adopted across the globe.



A nine-hour surgery, emergency and bleeding on the table, anxious patients spilling out of the OPD and a dying patient's relative clinging on to hope - doctors have a tough time holding on to so many lifelines and processing collective anxiety. Little wonder then that a 2021 study showed that 75 per cent of doctors in India were under severe stress. And if there is one solution that takes care of both their physical and mental well-being without eating into their schedule, it is yoga. As a neurosurgeon, I have to be on my feet for about seven to eight hours at a stretch. And since there's little focus on ergonomics in neurosurgery, the operating room environment and surgical techniques aren't designed to minimise physical strain. So I cannot imagine any day without my morning yoga, which keeps my knee joints stable and my spine supple. In fact, if I go without yoga for a week, I get a neck pain so severe that I have to be on pain relievers and muscle relaxants

Since I have to bend over the patient, twist my torso and assume awkward postures for an extended time period, my lumbar spine gets stressed. Certain surgical instruments and procedures require repetitive hand and wrist movements. Brain surgeries are particularly demanding as they require the surgeon to look through the endoscope continuously without moving and simultaneously keeping their arms extended to use tools like drills and retractors. Such surgeries strain the muscles and tendons in my neck and back. More than physical strain, I need to focus sharp, something that pranayama helps me with. I give myself an hour every day for my exercise routines, five times a week. I do yoga at least thrice a week, more if I am not lined up for early morning surgery. But I do it in combination with cardio exercises and strength training. Yoga itself can be considered a form of strength training. I begin my routine with 10-15 minutes of yoga and then 45 minutes of other drills. In the evenings, I play badminton to unwind. I do eight to 10 sets of surya namaskar daily. I usually follow it up with the cobra pose or Bhujangasana, which opens up the shoulder blades, neck and collar bones. It improves circulation, lung function, massages and regulates the adrenal and thyroid glands. The table top pose, or Bharmanasana, is another of my favourites as it strengthens the wrists, arms, shoulders and core while stretching and lengthening the spine. Additionally, it can improve posture, balance and focus while relieving stress. The cow pose or Bitilasana is a good spine arch routine that straightens the spine, improves abdominal and diaphragmatic breathing capabilities and opens up stiff shoulders.

I have made yoga a part of my patient recovery protocol. Convalescents who need screws to stabilise the spine and help bones heal are recommended yoga after three months. Those without screws can take it up in six weeks. Yoga is best for them in strengthening their core. I try to do yoga at least four times a week and combine it with my cardio and strength training. Surya namaskar is my all-inone routine and helps me when I am travelling and find limited windows to exercise. In fact, yoga has many stretches that can rival those of Pilates. But it doesn't require gadgets.Whatever happens, I never give up on pranayama. Breath exercises are good for metabolism. They help lower cortisol levels and keep me calm, so that my decision-making is more judicious.Laparoscopic surgery strains your shoulders and neck muscles. But as a robotic surgeon sitting at a console, where both my neck and hands are flexed and I need to operate the joystick for every precise movement, pressure builds up in my elbows and wrists. Sometimes you need to take quick action, so your hands need to be flexible and agile. Only yoga poses allow wrist-focussed stretches, rotations and fingertip grips. I prescribe yoga to all my patients, particularly recently diagnosed ones, so that they can retain their positivity and body confidence. For those in chemotherapy, yoga helps increase their strength and muscle mass so that they can complete their cycles.

One hour, six days a week. That's my yoga routine, no matter how busy my OPD is. It improves my mood, sleep quality and sense of satiety. It helps me develop a positive attitude, relieving stress and fatigue. At one time I was into stress eating. With yoga, my craving for snacking has gone down. I sleep well now. I started practising yoga consistently since last year and have lost 13 kg.When I started out, it was tough to get into the flow. Being overweight, stretching was not easy. But in just a month, I could feel my body loosen up, become flexible and full of energy. Apart from pranayama, my favourites include Tadasana, Chakrasana, Sarvangasana, Halasana, Bhujanasana and Dhanurasana, all of which strengthen the core, firm up the abdomen, reduce anxiety and improve organ functions. In fact, after I noticed the fat-busting effects of yoga,

I wrote a thesis on the efficacy of yoga in improving fatty liver. We found that yoga with dietary calorie restriction is not inferior to exercise with dietary calorie restriction. In fact, we were able to control liver inflammation and fibrosis in our test subjects within six months.As a doctor, I have developed an Obesity Yoga Protocol for patients, which consists of a series of asanas, pranayama and meditation, along with dietary and lifestyle interventions. We also have a Y-Break protocol at PGI of about five to seven minutes, where healthcare workers do a specific set of relaxation techniques during lunch or tea break. That helps us jump right back in I have been practising yoga for the last five years, 6 am to 7 am, five days a week. Two days I reserve for other intense exercises. Surya namaskara can be a full body workout when you do it at a faster pace. Other than that I do a lot of forward-bending asanas because they improve flexibility, stretch the spine and hamstrings, massage abdominal organs and can help relieve back pain and stiffness. These also reduce stress and improve digestion.

## AAIB to decide where to analyse black boxes of crashed Air India plane after assessing 'technical, safety, security' considerations

The Aircraft Accident Investigation Bureau (AAIB) will take a call on where the black boxes of the crashed AI flight 171 will be decoded after assessing all technical, safety, and security considerations, the Ministry of Civil Aviation (MoCA) said Thursday, indicating that a decision is yet to be taken on whether the data recorders will be analysed in India or will be sent abroad. The ministry's remarks came amid reports and speculation that the black box — flight data recorder and cockpit voice recorder — may be sent to the US as AAIB's black box lab might not be fully equipped to handle damaged units.

'It has been reported in certain media outlets that the CVR/DFDR (cockpit voice recorder/digital flight data recorder) from the ill-fated Al171 flight is being sent abroad for retrieval and analysis. The decision regarding the location for decoding the flight recorders will be taken by the AAIB after due assessment of all technical, safety, and security considerations. The Ministry of Civil Aviation urges all stakeholders to refrain from speculation on such sensitive matters and to allow the investigative process to proceed with the seriousness and professionalism it warrants," MoCA said in a release."The AAIB investigation is progressing steadily with all necessary support from local authorities and agencies. Key recovery work, including site documentation and evidence collection, has been completed, and further analysis is now underway," MoCA said, giving an update on the probe.Boeing 787 aircraft have two combined black box sets, each with the joint functions of CVR and DFDR. According to industry insiders, the combined black box is called an Enhanced Airborne Flight Recorder (EAFR), and regulations require two units to be located in the aircraft - one at the front and one at the aft, or rear section — for redundancy, in case one unit is significantly damaged or never recovered. The first EAFR was recovered on June 13 from the crash site in Ahmedabad while the second was recovered on June 16. The government has so far not commented on the extent of damage to the black boxes.Sources indicated that deliberations are underway on whether to send the units to the National Trans

portation Safety Board (NTSB) Vehicle Recorder Laboratory in the US for data extraction and analysis, or perform the exercise at the AAIB's new black box lab in Delhi. The NTSB is already assisting the AAIB in the probe since Boeing, an American company, was the aircraft manufacturer.

"It will depend on the condition. The investigators will have to ascertain the absolute integrity of the black boxes, and if they are confident about it, they would like to analyse them at the new lab instead of sending it to an overseas facility," a source had earlier told "The new (AAIB) lab is a world-class facility but there are highly specialised labs in a few countries that may be superior. If the investigators feel that the DFDR or the CVR are not in a state that the AAIB lab can handle, or if the extent of data analysis that they require for the probe is beyond its capability, then they might decide to send it to an even more advanced facility, most likely in the US as the aircraft involved was a Boeing plane," said another source, adding that if the units are sent abroad an AAIB team will accompany them to ensure their "safety, security, and integrity". The DFDR records flight data on numerous parameters of aircraft operations, while the CVR records the flight crew's voices, as well as other sounds inside the cockpit, including engine noise, stall warnings, landing gear extension and retraction, and other clicks and pops.Communications with air traffic control, automated radio weather briefings, and conversation between the pilots and ground or cabin crew are also recorded. The new AAIB lab, built with the support of Hindustan Aeronautics Ltd (HAL) and inaugurated in April, has enhanced the agency's ability to repair damaged black boxes, retrieve data, and conduct thorough analyses of accidents with high accuracy.Earlier, a black box lab under the Directorate General of Civil Aviation (DGCA) was being used by the AAIB, but the facility was old and lacked a few key capabilities needed for thorough and accurate data retrieval and analysis, said a source. This was one of the reasons a number of black boxes from aircraft in serious accidents were sent to overseas labs, said a source.

#### What is Lenacapavir?

Lenacapavir is an anti-retroviral medication that can be used to treat as well as prevent HIV. As Sunlenca, it is used in combination with other antiretroviral drugs for the treatment of people who have been on pills for a very long time and are resistant to multiple drugs. As Yestugo, it is a pre-exposure prophylaxis (PrEP) to prevent the infection.The drug works by binding with the HIV capsid a protein shell that protects the virus' genetic material. It then disrupts crucial steps needed for the virus to replicate and infect new cells.

#### What is PrEP?

PrEP or pre-exposure prophylaxis is a drug or injectable meant to prevent HIV infection in people at a higher risk of contracting the disease. These medicines can reduce the risk of acquiring HIV infection through sexual activity by 99% and through injection drug use by 74%.At present, there are several types of PrEP available - pills such as Truvada or Descovy, Dapivirine vaginal ring and the injectable Cabotegravir that has to be taken every two months.It is important to be tested for HIV before taking PrEP. While these medicines are also used in the treatment of HIV, they are prescribed in combination with other antiretrovirals. Given alone to a patient with HIV, they might develop resistance to the drugs.PrEP is usually recommended for people living with an HIV positive partner, those who frequently change partners, those who have sex with people with unknown HIV status, those who work in the sex industry, and those who use injectable drugs. Medicines for post exposure prophylaxis are also available to be used as an emergency measure in cases such as inadvertent exposure in a hospital setting, after condom failure, or during sexual assault.

#### Is PrEP available in India?

While generic versions of the PrEP pills are approved in India — Cabotegravir injection is also available through a sub-licensing contract — they are not widely used. This is mainly owing to the cost of the medicines and the fact that they are not yet part of the country's national programme,

which already provides life-long treatment to all who have been diagnosed with HIV. The new injectable will cost USD 28,218 annually, remaining out of reach for many.Even in the US, usage remains low. Only 36% of the 1.2 million people who would have benefited from the medicine were prescribed it.

## What's difference between food poisoning, gastro?

If you've got a dodgy tummy, diarrhoea and have been vomiting, it's easy to blame a "tummy bug" or "off food." But which is it? Gastro or food poisoning? What's the difference anyway?

#### What's gastroenteritis?

Gastroenteritis, or gastro for short, is a gut infection caused by a virus, bacterium or other microbe. The gut is teeming with cells including healthy microbes and the cells lining the gut. But when viruses, bacteria and other microbes start to invade your gut, they colonise, build up in large numbers and eventually cause the cells lining the gut to inflame.The "-itis" at the end of gastroenteritis means inflammation. Gastroenteritis is extremely common.So where do these gastro-causing microbes come from? Eating contaminated food is often the source. However you can acquire these microbes in other ways. For example, if you touch a surface where someone sick from viral gastroenteritis had vomited on, that virus could transfer to your hands. And if your hands touched your mouth, you in turn could contract viral gastroenteritis.

#### What's food poisoning?

Food poisoning refers to getting sick from eating food contaminated with chemicals, microbes or toxins. For example if you ate food contaminated with insecticides or methyl alcohol (methanol) that would count as food poisoning. If you ate puffer fish or poisonous mushrooms that would count too. But food poisoning doesn't include the effects of eating a food you're allergic to. The vast majority of food poisonings are as a result of food contaminated by microbes and their toxins. When you eat or drink them it's like a missile strike. The toxins in particular can rapidly cause inflammation and damage the lining of the gut. To add to the confusion, food poisoning is often referred to as foodborne gastroenteritis.

#### How can we tell the two apart?

Both gastroenteritis and food poisoning have symptoms such as diarrhoea, vomiting, nausea, abdominal cramps, fever and headaches. But these symptoms can come on in different ways.

Indian captains in England, win-loss record: Newly anointed Indian Test captain Shubman Gill will face perhaps his biggest challenge in his very first tour as India is all set to play England in a five-match Test series starting from Friday, with the Headingley in Leeds. Gill was made the Test captain after Rohit Sharma announced that he would hang up his boots in this format. The development was then succeeded by the shock retirement of one of the greatest players of this generation, Virat Kohli. The void left by these two batting greats will be a tough one to fill, as India have gone on with young talents to face mighty England. India holds a poor record in Tests in England. Out of 67 Tests between the two nations in England, India have only managed to win just nine of them. Gill will be the 18th Indian to lead his side in England.

Before Gill, 17 different players have led the Indian side in England, with only six of them leading the side to a win. CK Nayudu was the first Indian captain to tour England. Virat Kohli and MS Dhoni (both nine Tests) have captained



India for the most time in England. Under Kohli, India have won three Tests, the highest under any Indian skipper.1983 World Cup-winning captain Kapil Dev holds the best winning percentage among any Indian captains in England. Under Kapil, India won two out of three Tests, resulting in a win percentage of 66.66. Among all six Indian captains who have won a Test in England, Dhoni has the worst winning percentage of just 11.11. Under Dhoni, India have lost eight out of nine Tests there. The Indian side has only won three series in England. The first one came under Ajit Wadekar in 1971, when India beat England 1-0 in the three-match Test series. In 1986, India handed England a 2-0 defeat in a threematch series under Kapil before winning their last series on England's soil in 2007 under Rahul Dravid.

## Kuberaa movie review: Dhanush, Nagarjuna shine bright in Sekhar Kammula's mindful 'massy' film



Kuberaa Movie Review, Rating and Release: From the very outset, Kuberaa was going to be defined by the choices made by writer-director Sekhar Kammula. The decision to tell a story starkly different from his trademark intimate and subdued style, for starters, caught everyone's attention ahead of the release. The move to lend that story a considerably larger canvas than before became another defining facet of the film, as did the promotional tour he embarked on to discuss it. Amidst all this, the spotlight was always going to be on Kammula's storytelling approach and how he would "adjust" his perspective for an endeavour of this scale.

Yet, with Kuberaa now in theatres, the film doesn't feel entirely removed from what the filmmaker has done before. Although it tackles the sophisticated subject of corporate power-play and its apathetic worldview, the intricate manner in which the narrative unfolds remains resonant with Kammula's past work. It carries his refreshing treatment of everyday people, their true-to-life essence, his simplicity - and also the signature quality of treating audiences with dignity and not doubting their intelligence. Take, for instance, how Dhanush's homeless character, Deva, is etched. Without diving into too much detail, the film traces how a destitute man is drawn into the world of the ultra-rich before he rises to the occasion and begins to control the game. This trope is familiar territory in cinema, and while Kammula uses it to his advantage, he refrains from going overboard with Deva's heroism. Deva (thanks to Dhanush's measured performance) is meek, functionally illiterate, and ill-equipped in every conceivable way - but the film doesn't force him to act implausibly against his nature during pivotal moments.

The same applies to how Akkineni Nagarjuna and Rashmika Mandanna's roles are handled. Nagarjuna plays a high-level fixer for a corporate conglomerate (run by Jim Sarbh's cold-blooded Neeraj Mithra and his father), while Mandanna plays Sameera, a commoner girl (comically)

dealing with life's many struggles. Kuberaa understands the importance of these archetypes, but also takes care to humanise them and draw the viewer into their world. The choice of locations (the film is largely set in Mumbai), the dialogues penned by Kammula and Chaithanya Pingali (also the co-writer), and the overall tone of the performances greatly support the film's emotional core. At the same time, Kuberaa is keenly aware of being a 'pan-Indian' project, and carries a strange duality throughout its 182-minute runtime. As in Anand (2004), Godavari (2006), and Fidaa (2017), there is space allotted for natural and emotionally grounded moments which mostly play out between Deva and Sameera. Simultaneously, however, nearly every scene is packed with an intent to continually raise the stakes, which makes the narrative feel uncharacteristically high-pitched for a Sekhar Kammula film. The filmmaker, known for his restraint (and occasional cheesiness) even in heightened drama, doesn't mind dialling up the sentimentality here and it's clear this too is a conscious choice to match the film's scale. One conspicuous shift in Kuberaa is Devi Sri Prasad's background score, which veers sharply from the "gentleness" of someone like Mickey J Meyer. The film is heavily underscored, and the music becomes overbearing - even manipulative — at times. Niketh Bommireddy's cinematography is serviceable, while Karthika Srinivas' editing does well to hold the dense screenplay together.Still, the burden of juggling multiple responsibilities occasionally gets the better of the film. The first half hits the ground running and efficiently stacks a range of moments - the way Nagarjuna's Deepak kickstarts the story, the way Deva and Sameera stumble into the fray, and the intricate world of Benami banking, business moguls, politicians and capitalists (with Sarbh's character anchoring much of it) — all of it is well-organised and absorbing. In contrast, the second half begins to meander, searching for the perfect moment to land its final punch. Kuberaa wears its bleeding heart on its sleeve for the marginalised, and while several scenes are effective, a few others feel repetitive and yank the pacing. On one hand, they stretch the runtime beyond a threshold and test the viewer's patience. On the other, they dilute the sprightly momentum the film had built - a momentum that could have benefited from tighter reins in the final act. If the bloated duration of the film could be overlooked, Kuberaa stands apart from all the cacophony around as a one-of-akind 'mass' experience. It could have used a more deft hand, yes — but it remains a rare film that asks difficult questions of its audience, and then trusts them to sit with the discomfort. Most importantly, it features a filmmaker orchestrating his cast with discernment. The actors - Dhanush, most notably - are all committed, and none of them overstep their boundaries. Watch the film to witness how a storyteller takes on power machinery with softness.

Golden age star, who worked with Sanjeev Kumar, Uttam Kumar, didn't appear in public for 36 years on a holy man's suggestion; rejected Raj Kapoor's 'personality'

Hollywood actor Great Garbo was one of the biggest stars of the silent films in the 1920s and 1930s. But once she left the movies, she retired from public life and turned into a recluse. No one knew why and people often wondered what prompted a star of her stature to live a lonely life, despite having many fans around the world. Closer home, actor Suchitra Sen went through something similar when she decided to lead a secluded life in the city of Kolkata, where she was widely known and loved. In her heyday, Suchitra was known as Paro from Dilip Kumar-starrer Devdas, the protagonist of Gulzar's Aandhi (who was compared to former PM Indira Gandhi), and her on-screen camaraderie with Uttam Kumar was often compared to the chemistry between Raj Kapoor and Nargis. Suchita primarily worked in Bengali films but she reached a wider audience when she appeared in Hindi films, although she only appeared in a handful of them. But, after her last release in 1978, Pranay Pasha, Suchitra took a retirement from public appearances fully. Many have wondered why she chose to live as a recluse and while some suggest that she never wanted anyone to see her grow old, some have also theorised that there was a deep sadness within her that she did not wish to share with the world

Suchitra was one of the highest paid female actors of her time but as per author Gopal Krishna Roy, who wrote four books on her life, she turned her back on living in a regular society after a holy man told her to do so. Roy shared, in a 2014 chat with NDTV, that after Pranay Pasha flopped, Suchitra was deeply upset about it and headed to Ramakrishna Mission's headquarters near Kolkata. She met a holy man named Bharat Maharaj there and wept for hours. "I later heard she sat at his feet and wept and wept," he said and added, "And Bharat Maharaj told her, 'Ma, ghridho, lobh koro na, don't be greedy. And that, I think, Mrs Sen translated into her own life by becoming a recluse."

Director Buddhadeb Dasgupta, who was an admirer of the actor, told Mint in 2014 that Suchitra, perhaps, wanted



to "remain beautiful for her fans." "Maybe, she wanted to remain beautiful for her fans and I see a likeness to Greta Garbo. What surprises me is that she didn't react to anything that happened around the world. Had Satyajit Ray got her to act in his proposed film Debi Chaudhurani maybe we would have seen a different Suchitra Sen, more so because Ray had the ability to get the best acting out of his characters. Maybe she wanted to remain a matinee idol. She did strong, women-centric roles and directors would shape the characters like that. But to be a great actor, you have to come out of that," he said. Suchitra was one of the few actors who was offered the chance to work with Ray, and chose not to take it and she did something similar with Raj Kapoor as well. With Ray, when he offered her Debi Chaudhurani, she couldn't commit because he wanted to block a bunch of her dates. She couldn't do that as it would hamper her schedule and the other commitments she had made. Unfortunately, they never got a chance to work together again. In the case of Raj Kapoor, she refused to work with him because she "did not like his personality.'
