In a release here on Wednesday, Harish Rao condemned the Congress government for its disregard for the education sector within just 20 months and its failure to provide midday meals to students according to the established menu.

The BRS MLA stated that students in government schools are now left hungry or forced to eat only Sambar or a mixture of chili powder and oil due to unpaid mid-day meal bills that have been overdue for over three months. He emphasised that the government's indifference has resulted in students not receiving the nutritious meals they are supposed to have."It's absurd for a Chief Minister who fails to provide proper meals for children to talk about a bright future," Harish Rao said. The former minister raised concerns over the lack of an active Education Minister in the Congress cabinet, pointing out that the department seems neglected as the Chief Minister focuses on trips to Delhi and political distractions. He called for an urgent evaluation of the education department and the disbursement of outstanding mid-day meal payments to prevent students from going

hungry."While the Chief Minister promotes the idea of unified schools and vocational universities, his inattention has resulted in a loss of faith in government schools and has damaged the reputation of Gurukul residential schools," Harish Rao added.

Families shy away from govrnment hospitals, public schools, and transport services. But the moment someone in the family secures a governnent position, even a low-ranking one, the mood shifts. Sweets are distributed, social media status updates are osted, and one phrase echoes across households: "Now ife is settled.

Government hospitals are often treated as the last esort. Even in urban centres, most people prefer to pay or private clinics, despite free and sometimes competent are being available at public hospitals. The reason? Pereption. While public hospitals house experienced docors, and are often better equipped than assumed, they emain crowded, bureaucratic, and under-trusted.

The same is true for public education. # Young Women in Andhra Pradesh Experiencing Rise in Overactive Bladder Cases by 2025

Hyderabad:A growing number of young women in Andhra Pradesh are being diagnosed with Overactive Bladder (OAB), a condition marked by sudden, uncontrollable urges to urinate, often resulting in urge incontinence. Recent data suggests that 33% of women presenting with urinary incontinence are experiencing OAB-related symptoms, with 15% suffering severe cases that disrupt their social and emotional well-being. This trend is especially concerning among women aged 21 to 30, where past studies have already recorded 20.14% prevalence of stress urinary incontinence. As Andhra Pradesh's population continues to urbanize and lifestyle patterns shift, specialists are calling attention to the urgent need for early diagnosis, targeted intervention, and specialized care infrastructure to address this burden.

Dr. A. Harsha Vardhan, MCh Urologist based in Kakinada, emphasized the need to break the silence around bladder health in younger populations. "There is a common misconception that urinary issues only affect the elderly, but we are increasingly seeing young, otherwise healthy women struggling with Overactive Bladder. Many of them endure symptoms in silence, believing it is a passing issue or too embarrassing to discuss—even with a doctor. What they don't realize is that OAB is a medical condition with effective treatment options. Early diagnosis is crucial, as it can prevent worsening symptoms and reduce the psychological toll that often accompanies chronic bladder issues. We must foster a culture where women feel comfortable seeking help and where healthcare systems are equipped to respond with empathy and expertise."

The multifactorial causes of OAB-ranging from neurological, lifestyle, and pelvic floor dysfunction-demand a comprehensive approach to care. Despite growing cases, awareness remains low, and many women normalize the condition or delay seeking care due to social embarrassment.Experts warn that if left unaddressed, the prevalence may rise sharply by 2025, further straining limited urological resources in the region. Research from national sources indicates that urge incontinence due to OAB makes up a significant share of total urinary incontinence cases, affecting both physical and emotional health.Healthcare professionals are urging policymakers to fund more awareness campaigns, especially in Tier 2 and 3 cities like Kakinada, and to establish dedicated pelvic floor rehabilitation programs for younger populations. These efforts could reduce long-term complications, prevent progression, and empower women to seek timely care without hesitation. As awareness grows and the clinical understanding of urinary incontinence in young women deepens, Andhra Pradesh must prioritize the silent but significant issue of Overactive Bladder-before the statistics outpace

## Why South Mumbai is recording heavier showers this monsoon season

Since the onset of the southwest monsoon on May 26-its earliest in the past 75 years-Mumbai's island city division has been experiencing very heavy spells of rainfall, even as its suburban district has remained relatively drier. In May, the coastal observatory in Colaba recorded 504 mm of rainfall-making it the station's wettest May in over a century since 1918. Yet again, on June 19, it was the island city division that received record-breaking rain, with the Colaba station clocking in 146 mm within 24 hours, its highest 24-hour rainfall in June since 2023 and second highest in the last seven years. Overall, since May, the Colaba station in the island city has recorded 981 mm of rainfall until Sunday, while the Santacruz observatory has received only 803 mm of rainfall. This is in stark contrast to the average monsoon patterns, during which the Santacruz station in the suburbs registers more wet spells.

According to meteorologists, the southwest monsoon in Mumbai typically kicks off with heavy spells at the tip of South Mumbai in Colaba owing to intense rainfall in Raigad and monsoon winds from that direction. This year too, when the monsoon onset was announced in May, it was the Colaba station that received the heaviest downpour, with some areas like Nariman Point, Byculla, Colaba, and Do Taki, among others, recording over 200 mm of rainfall within a 24-hour window.Speaking to The Indian Express, Athreya Shetty, an independent weather forecaster, said, "When the IMD announced the onset of monsoon on June 26, the winds were aligned in such a way that they pushed more rain to the small stretch of island city while the suburbs and the further districts such as Thane experienced lesser rainfall."Meanwhile, explaining the heavy showers in the island city division between June 15 – 19, Shetty added, "Even last week, there was an offshore trough which was much more active towards the south central Konkan region and it edged up until the Colaba area. Owing to this, it was observed that Raigad district received very heavy rainfall alongside Colaba in Mumbai, while the suburbs received less rainfall comparatively."However, experts alluded that such heavy spells in the island city are not atypical. In 2024 as well, for instance, Colaba received 507 mm of rainfall in June while Santacruz station received 347 mm.

In the city, rainfall in Mumbai's suburban district is gauged by the IMD's recording station in Santacruz, while the Colaba coastal observatory records the total rainfall in the Mumbai city district. Typically, it is the suburban district that records heavier rainfall. Data furnished by the IMD shows that the suburban Santacruz station receives an average of 542 mm of rainfall in June, while the Colaba station receives 537 mm of rainfall in the month. Overall, the city's Santacruz observatory receives a higher average of 2,318 mm of rainfall during the monsoon season that spans between June and September month, whereas the Colaba station records 2,095 mm of average rainfall. This June, however, the Colaba station has received 477 mm of rainfall- which is over 130 mm above normal - whereas the Santacruz observatory has received relatively less rainfall at 425 mm. Even as observers like Shetty stated that there are no active systems at present, Mumbai will continue to experience spells of moderate to heavy rainfall in the next week.Stating the likelihood of heavy rainfall in isolated pockets, the IMD has placed Mumbai district under a yellow alert between Monday and Thursday, barring Wednesday. Not only Mumbai but the neighbouring districts of Thane, Palghar and Raigad have also been placed under alerts. While a yellow warning has been issued in Thane and Palghar until Thursday, an orange alert has been sounded in Raigad and Ratnagiri districts on Monday and Thursday.As of now, next week looks like the monsoon will run on its own strength with an active system. From Monday, moderate to heavy rainfall will continue.

The investigators also seized 127 fake Bisleri Stickers, 55 fake Bisleri bottle caps, 387 counterfeit barcodes, and seven heater guns and lighters. On Thursday, representatives of mineral water giant Bisleri paid an unusual visit to the Subhash Nagar police station. Their bottled water was everywhere in the North West Delhi region, reportedly even where they had not supplied it. The police team talked to vendors and, using manual and technical surveillance, got to know about a factory in the Shakarpur area from where a large number of Bisleri bottles were allegedly being supplied.

"The team collected all the necessary information and after verifying the authenticity of the information, conducted raid at the premises in Shakarpur. # Rajkot Fort in Maharashtra shut again 41 days after Shivaji statue inauguration, ground cave-in sparks safety fears

Barely 41 days after the inauguration of a newly rebuilt 91-foot statue of Chhatrapati Shivaji Maharaj, the refurbished Rajkot Fort in Malvan, Sindhudurg district, has once again been shut to the public for urgent repairs. The closure was prompted by a partial cave-in near the statue's platform last week, raising concerns about the structural integrity and safety of the site. The Public Works Department (PWD) has issued a notice stating that the fort will be closed to tourists starting Sunday, with repair work expected to continue for several days.

The damage was visible last week after heavy rains when a large crater emerged on the left side of the pathway around the statue. While the statue itself remains intact, viral videos showing the sunken ground have sparked widespread public criticism.Anil Patil, Collector, Sindhudurg, had attributed the incident to recent heavy rains. Although authorities initially claimed that the issue had been rectified, the decision was later made to suspend public access to carry out comprehensive repairs. The 91-foot bronze statue, depicting the sword-bearing Maratha warrior, was inaugurated on May 11, just eight months after the earlier 35-foot version collapsed in August 2024 amid heavy rainfall and strong winds. That statue was unveiled by Prime Minister Narendra Modi in December 2023. The incident led to the arrests of both the statue's sculptor and its structural consultant amid a political firestorm, prompting the government to build a new structure. Constructed at a cost of Rs 31.75 crore, the new statue was unveiled by Chief Minister Devendra Fadnavis. However, this second structural failure has revived criticism from Opposition leaders, including former Shiv Sena UBT Kudal MLA Vaibhav Naik."The state has so far spent over Rs 100 crore on this project, yet the ground around the statue has caved in. This raises serious questions about the quality of construction. Forts built

during Shivaji Maharaj's reign have stood strong for centuries, yet structures built today with a supposed 100-year guarantee are failing. A thorough investigation must be conducted." Naik said.

# 2 nabbed at Mumbai airport while smuggling weed worth Rs 12 crore from Bangkok

The Mumbai Customs department officers Saturday nabbed two Indian air passengers as they attempted to smuggle in hydroponic weed (marijuana) worth nearly Rs 12 crore from Bangkok. The accused had concealed the drugs in their trolley bags. Investigators suspect they could be part of a larger smuggling group. Hydroponically grown marijuana or weed is a highly potent variant and is much more expensive. According to the customs department, officers received specific intelligence regarding the two passengers. Acting on it, Zone III officers intercepted the two as they arrived at the Chhatrapati Shivaji Maharaj International Airport from Bangkok.

Their checked-in baggage was examined and multiple vacuum-sealed packets containing a greenish substance, purported to be hydroponic weed, were recovered weighing a total of 11.881 kg, customs officers stated on Sunday, adding that it had a market value of Rs 11.88 crore. The contraband was concealed inside pillow covers kept in the trolley bag, officers said. On questioning, the two accused admitted to have smuggled the substance in lieu of hefty commission despite knowing that smuggling marijuana is banned in the country and can attract strict legal punishment. Both were subsequently arrested under relevant provisions of the Narcotics Drugs and Psychotropic Substances (NDPS) Act, 1985. They were charged with sections pertaining to smuggling commercial quantities of marijuana, which once proved may attract 20 years of imprisonment. Customs officers are further investigating the matter and trying to find out more details of the racket operating behind the smuggling.

In the same batch as Karanjkar was Dattatray Sadashiv Warunkar, then in his 40s, who completed all three levels of the Japanese course between 1997 and 1999. He also credited Damale's teaching for shaping his understanding of the Japanese language and values. "We got the chance to interact with many native Japanese speakers who visited the department. Through conversations with them, I learned so much about their discipline, dedication, humility, and above all, their love for their country. These are qualities I think Indian citizens can benefit from adopting," he said.

Warunkar went on to serve as Vice President of the Japanese Language Teachers' Association of Pune (JALTAP) for 15 years after completing the course. He fondly recalled how being in the classroom with younger students gave him a fresh outlook on life. "I loved talking with them. They had so much energy and joy. It inspired me to take life lightly, to laugh more, and live happily. I learned as much from the students around me as I did from the curriculum," he added. # Ray of hope for HIV patients, as Hyderabad-based pharma giants secure nod for game-changing HIV drug

Hyderabad: In a ray of hope for HIV patients, particularly for the significant burden in the two-Telugu speaking States of Telangana and Andhra Pradesh, several India pharmaceutical companies have secured green light to manufacture Lenacapavir, a ground-breaking drug, administered as injection just twice a year, offering a promising alternative for management of the disease. The HIV drug Lenacapavir, originally developed by Gilead Sciences and marketed as Sunlenca, offers a new weapon in the fight against HIV for Indian patients. They will no longer have to worry about the complexities of taking oral pills and the difficulties in adhering to the strict anti-retroviral therapy. A few days ago, Gilead received USFDA approval for Yeztugo (lenacapavir) for twice-yearly use to reduce the risk of sexually acquired HIV. Gilead has also granted permission to Hyderabad-based Dr Reddy's Laboratories and Hetero Healthcare, Pune-based Emcure Pharmaceuticals and Mylan, through non-exclusive, royalty-free voluntary licensing agreements.Dr Ishwar Gilada, the president Emeritus of the AIDS Society of India (ASI), has been quoted by several news agencies on the significance of this development. "The voluntary licenses give hope that the medicine may cost less than 100 US dollars, which is 0.3 percent of the innovator's cost. India needs to lead from the front for lenacapavir's equitable





# Himachal minister Anirudh Singh booked for 'assaulting' NHAI officials hours after building collapses in Shimla

Himachal Pradesh Panchayati Raj Minister Anirudh Singh was booked on Monday for allegedly assaulting and threatening two officials of the National Highways Authority of India (NHAI) in Shimla. The alleged incident took place soon after a multi-storeyed building collapsed at Chamyana in Shimla, allegedly due to ongoing four-lane construction work.Leader of Opposition (LoP) and former chief minister Jai Ram Thakur has sought Singh's resignation in the wake of the allegations. "The BJP condemns the minister's attack on NHAI officials. Chief Minister Sukhvinder Singh Sukhu should remove Anirudh Singh from his Cabinet. The minister should resign," he said. The First Information Report (FIR) in this regard was lodged at Dhalli police station based on a complaint filed by NHAI manager Achal Jindal. Singh is a Congress MLA from Kasumti and the scion of the erstwhile Koti royal family in the state. The assault reportedly took place near Bhattakuffer in Chamyana where the building collapsed on Monday. Singh had visited the site along with other officials. Jindal claimed that he and site engineer Yogesh Verma were summoned under the pretext of a meeting but were instead assaulted. According to the complaint, "The minister took both of us to a nearby room and started assaulting us in front of others. He hit a water earthen pot on my head, causing bleeding. When my colleague Yogesh Verma tried to intervene, the minister attacked him too. We somehow managed to escape and reached IGMC, Shimla."

Both men were admitted to Indira Gandhi Medical College and Hospital (IGMC) in Shimla. Their medical reports are awaited. A senior police officer associated with the probe said, "We have acted on the complaint. The matter is under investigation, and the medical examination reports will further aid the probe. The FIR was registered last night. Achal Jindal has been discharged from the hospital. Yogesh Verma is still admitted there."The police have registered the case under several sections of the Bharatiya Nyaya Sanhita (BNS), including section 121(1) (assault or use of criminal force to deter a public servant from discharging official duty), 126(5) (wrongful restraint or confinement by a public servant or in the course of official proceedings), 132 (voluntarily causing hurt), 352 (assault or criminal force otherwise than on grave provocation, and 3(2) (liability of abettors when the act is committed by several persons in furtherance of common intention). Despite repeated attempts to contact him, the minister was unavailable for comment. Calls and messages to his office remained unanswered.

# 'We all lead strenuous lives. But we need to stop, just for a while, and listen to our bodies': Dr Rani Bang's appeal on Doctors' Day

July 1 is Doctors' Day. On the occasion, Dr Rani Bang, a Padma Shri awardee known for her exceptional contributions to public health in Maharashtra's tribal district of Gadchiroli, reflected on a life-altering experience she had two years ago—she suffered a severe brain stroke that left the right side of her body paralysed.Dr Bang was unconscious for a week, and her family feared the worst— but against the odds, she made a remarkable recovery. As Dr Bang turns 75 this September, the eminent doctor appealed to doctors to take care of their own health. "We all lead strenuous lives. But we need to stop—just for a while—and listen to our bodies," Dr Bang told The Indian Express.

A brain stroke on November 14, 2022, forced her to take a break from her outpatient services. She received emergency care in Nagpur for three weeks, followed by an intensive rehabilitation programme in Mumbai. She continues her physiotherapy at Maa Danteshwari Hospital, run by SEARCH (Society for Education, Action and Research in Community Health) in Chatgaon village, Gadchiroli.

However, within just two months of her illness, Dr Bang resumed her OPD services in January 2024. Every day, she arrives at the hospital exactly at 11 am, assisted by a nurse, and attends her OPD, where Dr Bang typically sees around 30 patients daily, working until 3 pm. She prefers to nave ner physiotherapy sessions and lunch in the OPD to avoid interruptions and politely declines all invitations during her OPD hours. Her consultation room is lined with a collection of gynaecology books, which she continues to reference regularly. After returning home at 3 pm, she rests and later joins the evening prayer on the SEARCH campus at 6.40 pm, often being the last to leave. Dr Bang admits that the physical rehabilitation process has been of immense importance."I had put on a lot of weight and was so engrossed in my work that I neglected my health," Dr Bang recalled while she made a strong case for exercise and



nutrition.Equally important is mental therapy. "I would read medical books, talk to my patients, listen and understand them. The constant effort is to keep learning," she said. "All this keeps me mentally active and despite the challenges, I have decided to continue my medical practice."Dr Bang also exhorted doctors to provide medical care with honesty, sensitivity, and the highest ethical standards.

"In recent times, we have seen instances where doctors face anger and frustration from patients and their families. I believe the main reason for this is often a breakdown in communication on both sides. I understand that many doctors work in resource-constrained settings, but despite these challenges, it is our responsibility to provide medica care with honesty, sensitivity, and the highest ethical standards," she said.Dr Anand Bang, Joint Director of SEARCH and the elder son of Dr Abhay and Dr Rani Bang, said there was agreement in the family that she should continue her medical practice. "She has always loved it. For the brain, it is important to remain engaged in intellectual and professional work. Despite some physical limitations, her routine life continues as it always has. She also participates in public programmes and remains involved in scientific work," he added.

Senior Congress leaders, including Vijay Wadettiwar, Aslam Shaikh, Jyoti Gaikwad, and Patole, approached the Speaker's chair to seek a retraction of Lonikar's remarks and a formal apology from Chief Minister Devendra

Fadnavis."Babanrao Lonikar and Agriculture Minister Manikrao Kokate have been continuously insulting farmers. This insult to farmers will not be tolerated. The chief minister must apologise to the farmers in the Assembly. (Prime Minister Narendra) Modi may be your father, but he can never be the father of farmers," Patole, a former Maharashtra Assembly speaker, said.Speaker Narwekar warned Patole for using unparliamentary language. Nevertheless, Patole approached the Speaker's chair and began arguing. As the House got chaotic with sloganeering from the Opposition, Speaker Narwekar suspended the proceedings for five minutes in an attempt to restore order. However, when the proceedings resumed, the Opposition began chanting slogans such as "apologise, apologise, apologise to the farmers". Despite repeated warnings from Speaker Narwekar, Patole continued to argue near the Speaker's chair. At this point, CM Fadnavis intervened and demanded an apology from Patole."Expressing emotions on an issue is one thing, but charging on toward the Speaker is inappropriate. It is as if the Speaker himself is being blamed. We are witnessing this kind of behaviour for the first time in this House. Yes, members have approached the Chair before, but physically charging at the Speaker is not acceptable. Nana Patole himself has served as Speaker. His conduct is not befitting of that position. He should apologise," said Fadnavis.Moments later, Patole once again approached the Well of the House and climbed the Speaker's podium, following which Narwekar ordered his suspension for the remainder of the day. The order triggered a fresh wave of protests, culminating in a walkout by the entire Opposition, which boycotted the rest of the day's proceedings. Speaking to the media later, MVA leaders slammed the government for "insulting the farming community" and accused the ruling BJP of shielding its members who make "irresponsible and inflammatory remarks".

# Storage in dams supplying water to Pune reaches 50% after continuous rainfall

**Chaos in Maharashtra Assembly: Congress MLA Nana**

Storage in dams supplying water to Pune reaches 50% after continuous rainfallOn Tuesday, the amount of water discharged into the river was increased from 340 cusecs to 1,440 cusecs as the water level rose in the dams following the rain in the catchment area, officials said. After continuous rainfall in the catchment areas of dams upstream of the Mutha river, the four main dams supplying water to Pune city have filled to half their capacity despite the water being released into the river over the last two weeks.

The total storage capacity of the four dams– Khadakwasla, Panshet, Varasgaon, and Temghar–is 29 thousand million cubic feet (TMC). "The good rainfall in June has enabled the increase of storage in the four dams. The water storage is 14.52 TMC, which is around 50 per cent of the total storage capacity," said an officer of the Maharashtra water resources department.On Tuesday, the amount of water discharged into the river was increased from 340 cusecs to 1,440 cusecs as the water level rose in the dams following the rain in the catchment area, officials said. The water storage in the Khadakwasla dam is 1.21 TMC, which is 61.51 per cent of its capacity, while the water storage in



the Varasgaon dam has reached 6.99 TMC–54.50 per cent of its capacity. The water storage in the Panshet dam is 4.96 TMC, which is 46.56 per cent of its capacity. In the Temghar dam, the water storage is 1.36 TMC–36.73 per cent of its capacity.On Monday, the catchment areas of the dams received rainfall of 24 mm (Temghar), 18 mm (Varasgaon), 16 mm (Panshet), and 2 mm (Khadakwasla).The administration expects more rain in July and has put the disaster management system on alert to handle any eventuality, officials said.

# How a couple moved to the Himalayas and became one of India's homestay pioneers

More than two centuries ago, the poet William Blake wrote, "Great things are done when men and mountains meet; this is not done by jostling in the street." In the misty, green landscape of Landour, Uttarakhand, a hotel entrepreneur from a bustling peth area of Pune realises each day that he has taken the right kind of risk to set up a business – and his life – under the gaze of the changeless Himalayas rather than a familiar, fast-moving city. In the process, he has shown that it is possible to marry enterprise with serendipity. Amarjeet Kudle and his wife, fellow hotelier Sunita Kudle, had not wanted to raise their infant daughter in a metropolitan city. They wanted to give her an upbringing rooted in a small and quiet place. The couple was on holiday in Landour, Mussoorie, in November 2009, when they came across "this very beautiful and quaint 106year-old house" that was available on the block.

The house had been built by a 27-year-old medical missionary during the colonial era. "We didn't have the bandwidth to buy so we shared our vision for the property with the religious organisation that owns it, and they agreed to lease it to us for 33 years," says Amarjeet. "We decided to quit our jobs and move into the mountains, to the Himalayas," he adds. With this property, La Villa Bethany, the Kudles became pioneers; one of the first businesses to register under the Incredible India Homestay Scheme, which the Government of India launched in October 2010. The Kudles wanted to offer a slice of the tranquility that they had found in the hills to visitors from across the world without disrupting the historic charm of Landour.

From its start in May 2011, La Villa Bethany carved out its revenue model as carefully as it refurbished its interiors and fashioned its aesthetics. "We try to attract likeminded people who will respect the environment. They will value the sanctity and privacy of the other guests who are staying, appreciate the surroundings and Landour's history as a convalescent depot for British officers who were suffering from tropical diseases, and be curious about why the town is called the Peanut Butter Capital of India," says Amarjeet.It was a tall order to sustain a fledgling business without opening up to commercial tourists from Delhi and

Amritsar, among others. But, the Kudles reached the right people. The niche traveller - including a lot of single women gravitated towards the Enid Blyton-esque appeal of the property and the bow to JRR Tolkien in The Hobbit Home and Uncle Tom's Cabin in the log cabin. House guests eat at least one meal together at the dining table, where strangers become friends. La Villa Bethany's insistence on solar energy for cooking and heating water and its 80,000 litre capacity of rain water harvesting (that is being increased) strikes a chord with guests. The homestay is not only booked but also winning awards globally.Today, the Kudles has eight homestays in a 25 km radius, such as Purkul, Dhanaulti, and Buranskhanda. When the business started, procurement used to be a challenge but e-commerce has solved that. What remains a task is to get labour in a region where communities are small and people value respect and dignity."If an entrepreneur develops a reputation for being difficult or hostile, local people would not want to work for you. The mountain teaches you oodles of patience. The thumb rule is that the mountains don't change for you; you have to change for the mountains. You have to give in to their pace; you have to slow down," says Amarjeet. Though he visits Pune regularly, he looks forward to returning. "I am a ghati who got promoted to being a pahadi," he says.

The Maharashtra Housing and Area Development Authority (MHADA) has appointed Keystone Realtors under the Rustomjee Group as the agency for redeveloping 20 residential buildings at GTB Nagar in Mumbai's Sion Koliwada to house Sindhi refugee families who migrated to India during the Partition and their descendants.MHADA Vice-President and CEO Sanjeev Jaiswal transferred the Letter of Intent (LOI) to the realtor on Monday, paving the way for the construction of new buildings on 11.20 acres.Around 1,200 Sindhi families had to shift to temporary accommodation in 2020 after the apartments, which were built in 1958, were declared unsafe by the Brihanmumbai Municipal Corporation (BMC).

The buildings were subsequently demolished, and the Maharashtra government approved a redevelopment scheme after repeated pleas by tenant societies, although the land is in private ownership.As per the redevelopment proposal, all 1,200 eligible families will be given a free flat of 635 square feet, with MHADA paying Rs 20,000 monthly rent until they get their possession and pay maintenance expenses for five years after redevelopment.The State Cabinet cleared the proposal on February 14, 2024, and a resolution was issued on February 23, 2024, authorising MHADA to be the Special Planning Authority."It is for the first time that MHADA is redeveloping on private land as a chosen development agency. A 5-7 member committee of society representatives would be constituted to oversee the



project and MHADA will give complete support so that the rehabilitation is done on time," Jaiswal said, adding that the project shall be carried out under the Development Control and Promotion Regulations (DCPR) Regulation 33(9).

The scheme permits a minimum Floor Space Index (FSI) of 4.5, including a fungible area. MHADA will get 25,700 square metres of the built-up area as housing stock.According to MHADA officials, legal actions in the Bombay High Court and the Supreme Court had delayed the project.A final ruling by the Supreme Court in 2024 permitted MHADA to go ahead, establishing a precedent for such future redevelopments.Upon approval from Chief Minister Devendra Fadnavis in February last year, MHADA moved on the orders to bring the project on track.

### **Indian Navy contains fire on board Palau-flagged tanker with 14 Indian crew**

The Indian Navy contained a fire on board a Palauflagged tanker in the North Arabian Sea and ensured safety of 14 of the vessel's Indian crew members. The vessel reported a major fire in its engine room while operating approximately 80 nautical miles east of Fujairah in the United Arab Emirates (UAE). "The Indian Navy undertook a highrisk fire fighting and rescue operation on-board Palau-flagged tanker MT Yi Cheng 6 on June 29 in the North Arabian Sea, successfully stabilising the situation and ensuring the safety of 14 Indian crew members," according to an Indian readout. The Navy deployed its warship INS Tabar to assist the vessel.

"Responding swiftly, INS Tabar proceeded at maximum speed to provide assistance," the Navy said in the readout. It said seven crew members were immediately evacuated to INS Tabar using the ship's boats."No injuries were reported, and all crew were examined by Tabar's medical team. The remaining crew members, including the master, stayed on board to assist with fire containment," it added.A six-member team of fire fighters from INS Tabar was deployed to contain the fire."Initial fire fighting efforts from the Indian Naval personnel and ship's crew resulted in



considerable reduction in intensity of the fire with smoke restricted to the engine room," the Navy said."The fire fighting effort was further reinforced with 13 additional Indian Navy personnel (5 officers and 8 sailors)." "Sustained efforts by the Indian Navy's firefighting team along with crew members have successfully brought the fire under control," it said. The Navy said INS Tabar remains in the vicinity of the vessel for continued support."The valiant effort of Indian Naval personnel has ensured safety of the ship along with all Indian crew members.









# Jaishankar refutes Trump's claim of using trade to force India-Pakistan ceasefire

New York: With his firsthand account of the talks between New Delhi and Washington, External Affairs Minister (EAM) S. Jaishankar has dismissed the claims of US President Donald Trump that he used trade to force India and Pakistan to accept a ceasefire. He said on Monday that he was with Prime Minister Narendra Modi when US Vice President JD Vance spoke to him by phone, and there was no linking of trade and ceasefire as far as India was concerned."I can tell you that I was in the room when Vice President Vance spoke to Prime Minister Modi on the night of May 9, saying that the Pakistanis would launch a very massive assault on India," he said. "We did not accept certain things," he said, "and the Prime Minister was impervious to what the Pakistanis were threatening to do.""On the contrary, he (PM Modi) indicated that there would be a response from us," he said, giving the chronology of interactions. "The Pakistanis did attack us massively that night, (and) we responded very quickly," he recalled.

The next contact with Washington was between the EAM and US Secretary of State Marco Rubio. "And the next morning, Mr. Rubio called me up and said the Pakistanis were ready to talk," he said.Pakistan's Director General of Military Operations, Major General Kashif Abdullah, directly called his Indian counterpart, Lieutenant General Rajiv Ghai, that afternoon to ask for a ceasefire. "So, I can only tell you from my personal experience what happened," Jaishankar said while speaking at a fireside chat here with Newsweek's CEO Dev Pragad.

He was asked about Trump's repeated claims that he used trade to get the neighbours to agree to a ceasefire after the escalation of India's Operation Sindoor in May.Last Wednesday, at a news conference in The Hague, Trump said again, despite India's denials, "I ended that with a series of phone calls on trade." "I said, 'Look, if you're gonna go fighting each other ... we're not doing any trade deal, he said. They responded that "You have to do a trade deal," the US President asserted.Jaishankar said that was not what happened, and diplomacy and trade were not interlinked and operated independently of each other. "I think the trade people are doing what the trade people should be doing, which is negotiate with numbers and lines and products and do their tradeoffs," he said. "I think they're very professional and very, very focused," he added. Operation Sindoor was launched by India against terrorist bases in Pakistan in retaliation for the Pahalgam terrorist attack by The Resistance Front, an outfit linked to Pakistan-supported Lashkar-e-

# 74 killed in Gaza as Israeli forces strike a cafe and fire on people seeking food

Cairo: Israeli forces killed at least 74 people in Gaza on Monday with airstrikes that left 30 dead at a seaside cafe and gunfire that left 23 dead as Palestinians tried to get desperately needed food aid, witnesses and health officials said.One airstrike hit Al-Baqa Cafe in Gaza City when it was crowded with women and children, said Ali Abu Ateila, who was inside. "Without a warning, all of a sudden, a warplane hit the place, shaking it like an earthquake," he said.Dozens were wounded, many critically, alongside at least 30 people killed, said Fares Awad, head of the Health Ministry's emergency and ambulance service in northern Gaza.

Two other strikes on a Gaza City street killed 15 people, according to Shifa Hospital, which received the casualties. A strike on a building killed six people near the town of Zawaida, according to Al-Aqsa hospital. The cafe, one of the few businesses to continue operating during the 20-month war, was a gathering spot for residents seeking internet access and a place to charge their phones. Videos circulating on social media showed bloodied and disfigured bodies on the ground and the wounded being carried away in blankets.Meanwhile, Israeli forces killed 11 people who had been seeking food in southern Gaza, according to witnesses, hospitals, and Gaza's Health Ministry. Nasser Hospital in the southern city of Khan Younis said it received the bodies of people shot while returning from an aid site associated with the Israeli and US-backed Gaza Humanitarian Fund.It was part of a deadly pattern that has killed more than 500 Palestinians around the chaotic and controversial aid distribution program over the past month.The shootings happened around 3 km from the GHF site in Khan Younis, as Palestinians returned from the site along the only accessible route.Palestinians are often forced to travel long distances to access the GHF hubs in hopes of obtaining aid.Nasser Hospital said an additional person was killed near a GHF hub in the southern city of Rafah. Another person was killed while waiting to receive aid near the Netzarim corridor, which separates northern and southern Gaza, according to Al-Awda hospital. Ten other people were killed at a United Nations aid warehouse in northern Gaza, according to the Health Ministry's ambulance and emergency service. One witness, Monzer Hisham Ismail said troops attacked the crowds returning from the GHF hub in Khan Younis. "We were targeted by (the Israeli) artillery," he said. Yousef Mahmoud Mokheimar was walking with dozens of others when he saw troops in tanks and other vehicles racing toward them. They fired warning shots before firing at the crowds, he said. "They fired at us indiscriminately," he said, adding that he was shot in a leg, and a man was shot while attempting to rescue him. He said he saw troops detaining six people, including three children. "We don't know



#### whether they are still alive," he said.

The Israeli military said it was reviewing information about the attacks. In the past, the military has said it fires warning shots at people who move suspiciously or get too close to troops including while collecting aid.Israel wants the GHF to replace a system coordinated by the United Nations and international aid groups. Along with the United States, Israel has accused the militant Hamas group of stealing aid and using it to prop up its rule in the enclave. The UN denies there is systematic diversion of aid. The Israeli military said it had recently taken steps to improve organization in the area, including the installation of new fencing and signage and the opening of additional routes to access aid.Israel says it only targets militants and blames civilian deaths on Hamas, accusing the militants of hiding among civilians because they operate in populated areas. The military intensified its bombardment campaign across Gaza City and the nearby Jabaliya refugee camp. On Sunday and Monday, Israel issued widespread evacuation orders for large swaths of northern Gaza. Palestinians reported massive bombing overnight into Monday morning, describ-

# **'Without subsidies, Elon would have to head** back to South Africa'; Trump suggests DOGE look at Musk's companies to save money

U.S. President Donald Trump suggested on Tuesday (July 1, 2025) that his efficiency Department should take a look at the subsidies that Tesla CEO Elon Musk's companies have received in order to save the Federal Government "BIG" money.Mr. Trump's comments come after billionaire Elon Musk renewed his criticism on Monday (June 30) of Mr. Trump's sweeping tax-cut and spending bill, vowing to unseat lawmakers who backed it after campaigning on limiting government spending.

"Elon may get more subsidy than any human being in history, by far, and without subsidies, Elon would probably have to close up shop and head back home to South Africa. No more Rocket launches, Satellites, or Electric Car Production, and our Country would save a FORTUNE. Perhaps we should have DOGE take a good, hard, look at this? BIG MONEY TO BE SAVED!!!," Mr. Trump said in a post on Truth Social.In response to Mr. Trump's post, Mr. Musk, in his own social media platform X, said "I am literally saying CUT IT ALL. Now." After weeks of relative silence following a feud with Mr. Trump over the legislation, Mr. Musk rejoined the debate on Saturday as the Senate took up the package, calling it "utterly insane and destructive" in a post on social media platform X.From bros to foes: How a bill drove a wedge between Trump, MuskOn Monday, he ramped up his criticism, saying lawmakers who had campaigned on cutting spending but backed the bill "should hang their heads in shame!""And they will lose their primary next year if it is the last thing I do on this Earth," Mr. Musk said.Musk renews call for new political party

The Tesla and SpaceX CEO called again for a new political party, saying the bill's massive spending indicated "that we live in a one-party country – the PORKY PIG PARTY!!""Time for a new political party that actually cares about the people," he wrote. Mr. Musk's criticism of the bill has caused a rift in his relationship with Mr. Trump, marking a dramatic shift after the tech billionaire spent nearly \$300 million on Mr. Trump's re-election campaign and led the administration's controversial Department of Government Efficiency (DOGE), a federal cost-cutting initiative.

Mr. Musk, the world's richest man, has argued that the legislation would greatly increase the national debt and erase the savings he says he has achieved through DOGE.It remains unclear how much sway Mr. Musk has over Congress or what effect his opinions might have on the bill's passage. But Republicans have expressed concern that his on-again, off-again feud with Mr. Trump could hurt their chances to protect their majority in the 2026 midterm congressional elections. The rift has also led to volatility for Tesla, with shares of the company seeing wild price swings that erased approximately \$150 billion of its market value, though it has since recovered.

# **Iran-linked hackers threaten to release Trump aides' emails**

Iran-linked hackers have threatened to disclose more emails stolen from U.S. President Donald Trump's circle, after distributing a prior batch to the media ahead of the 2024 U.S. election.In online chats with Reuters on Sunday (June 29, 2025) and Monday (June 30, 2025), the hackers, who go by the pseudonym Robert, said they had roughly 100 gigabytes of emails from the accounts of White House Chief of Staff Susie Wiles, Mr. Trump's lawyer Lindsey Halligan, Mr. Trump's Adviser Roger Stone and porn starturned-Mr. Trump antagonist Stormy Daniels.

Robert raised the possibility of selling the material but otherwise did not provide details of their plans. The hackers did not describe the content of the emails.U.S. Attorney General Pam Bondi described the intrusion as "an unconscionable cyber-attack."The White House and the FBI responded with a statement from FBI Director Kash Patel, who said: "Anyone associated with any kind of breach of national security will be fully investigated and prosecuted to the fullest extent of the law."Ms. Halligan, Mr. Stone, a representative for Ms. Daniels and the U.S. cyberdefense agency CISA did not respond to requests for comment. Iran's mission to the United Nations did not return a message seeking comment. Tehran has in the past denied committing cyberespionage.Robert materialized in the final months of the 2024 presidential campaign, when they claimed to have breached the email accounts of several Mr. Trump allies, including Mr. Wiles. The hackers then distributed emails to journalists.

Reuters previously authenticated some of the leaked



won. The U.S. Justice Department in a September 2024 indictment alleged that Iran's Revolutionary Guards ran the Robert hacking operation. In conversations with Reuters, the hackers declined to address the allegation. After Mr. Trump's election, Robert told Reuters that no more leaks were planned. As recently as May, the hackers told Reuters, "I am retired, man." # Barcelona records hottest June in over 100 years as heat wave grips Europe

Barcelona has recorded its hottest month of June since records started over a century ago, Spain's national weather service said. The Can Fabra Observatory, located on a hill overlooking Barcelona, reported an average temperature of 26°C (78 degrees Fahrenheit), breaking records since 1914. The previous hottest average for June was 25.6°C in 2003. The same weather station said that a single-day high of 37.9 C (100 F) for June was recorded on Monday, June 30.

Barcelona is usually spared the worst heat in Spain, thanks to its location between hills and the Mediterranean in Spain's northeastern corner. But most of the country has been gripped by the first heat wave of the year.Europe burningFrance and the rest of Europe were still in the grips of the first major heat wave this summer with health warnings in effect Tuesday (July 1, 2025), even as conditions began to improve in some parts of the region.Punishing temperatures were forecast to reach 40°C in Paris and to stay unusually high in Belgium and the Netherlands. In contrast, temperatures were falling in Portugal, where no red heat warnings were issued.

In France, the national weather agency Météo-France placed several departments under the highest red alert, with the Paris region particularly hard hit. The heat wave — defined as consecutive days of very high temperature — is expected to intensify Tuesday and more than 1,300 schools were expected to be partially or fully closed, the Education Ministry said. Visitors to the Eiffel Tower without tickets were told to postpone their visits, and the summit of the city's landmark was closed until Thursday.Farther south, 17 of Italy's 27 major cities were experiencing a heat wave, according to the Health Ministry.Météo-France also warned of the heightened risk of wildfires due to the drought-stricken

# **Over 14 million people could die from U.S. foreign aid cuts: study**

More than 14 million of the world's most vulnerable people, a third of them small children, could die because of the Trump administration's dismantling of U.S. foreign aid, research projected on Tuesday (July 1, 2025). The study in the prestigious Lancet journal was published as world and business leaders gather for a U.N. conference in Spain this week hoping to bolster the reeling aid sector.

The U.S. Agency for International Development (USAID) had provided over 40% of global humanitarian funding until Donald Trump returned to the White House in January. Two weeks later, Mr. Trump's then-close advisorand world's richest man- Elon Musk boasted of having put the agency "through the woodchipper". The funding cuts "risk abruptly halting— and even reversing— two decades of progress in health among vulnerable populations," warned study co-author Davide Rasella, a researcher at the Barcelona Institute for Global Health (ISGlobal)."For many low- and middle-income countries, the resulting shock would be comparable in scale to a global pandemic or a major armed conflict," he said in a statement.Looking back over data from 133 nations, the international team of researchers estimated that USAID funding had prevented 91 million deaths in developing countries between 2001 and 2021.

They also used modelling to project how funding being slashed by 83%- the figure announced by the U.S. government earlier this year-could affect death rates. The cuts could lead to more than 14 million avoidable deaths by 2030, the projections found. That number included over 4.5 million children under the age of five- or around 700,000 child deaths a year. For comparison, around 10 million soldiers are estimated to have been killed during World War I.Programmes supported by USAID were linked to a 15% decrease in deaths from all causes, the researchers found. For children under five, the drop in deaths was twice as steep at 32%. USAID funding was found to be particularly effective at staving off preventable deaths from disease. There were 65% fewer deaths from HIV/AIDS in countries receiving a high level of support compared to those with little or no USAID funding, the study found. Deaths from malaria and neglected tropical diseases were similarly cut

### in half.'Time to scale up'

After USAID was gutted, several other major donors including Germany, the U.K. and France followed suit in announcing plans to slash their foreign aid budgets. These aid reductions, particularly in the European Union, could lead to "even more additional deaths in the coming years," study co-author Caterina Monti of ISGlobal said. But the grim projections for deaths were based on the current amount of pledged aid, so could rapidly come down if the situation changes, the researchers emphasised. Dozens of world leaders are meeting in the Spanish city of Seville this week for the biggest aid conference in a decade. The U.S., however, will not attend. "Now is the time to scale up, not scale back," Mr. Rasella said.

Before its funding was slashed, USAID represented 0.3% of all U.S. federal spending."U.S. citizens contribute about 17 cents per day to USAID, around \$64 per year," said study co-author James Macinko of the University of California, Los Angeles."I think most people would support continued USAID funding if they knew just how effective such a small contribution can be to saving millions of lives."









# Thirumullaivoyal, a fast-developing suburb, struggles with poor roads and water woes



Sandwiched between Avadi and Ambattur, Thirumullaivoyal - a rapidly developing locality abutting the Chennai-Tiruvallur High Road — grapples with some deeprooted civic challenges that remain unresolved beneath the surface of its real estate boom.Like several other areas on Chennai's fringes, Thirumullaivoyal, located on the western periphery of the city and falling under the Avadi Municipal Corporation, continues to lack comprehensive underground drainage and water supply systems in some of its residential localities. The lack of infrastructure is reflected in the pathetic state of its vital waterbodies, which cry out for attention. Arafath Eri, which abuts C.T.H. Road on the eastern side and is located amidst residential areas, is a classic example. According to the lake records, the waterbody, which feeds Ambattur lake in the downstream, originally had a water spread area of nearly 61 hectares; it shrunk to 13.02 hectares over the past decades owing to rapid urbanisation and encroachments

A recent inspection by Minister for Minorities Welfare and Non-Resident Tamils Welfare S.M. Nasar and Tiruvallur Collector M. Prathap has sparked hopes of revival of the lake as a source of groundwater recharge.S. Sundaramurthy, president, Puzhal Eri Arafath Eri Padhukappu Makkal Iyakkam, a citizens' group dedicated to the conservation of lakes, said "the lake was a key resource for drinking and agrarian needs for the neighbourhood until 1980s. Sewage from areas like Manigandapuram and Balaji Nagar get disposed off into open rainwater canals that are linked to the lake. It is also covered with a layer of water hyacinth."Unless the area is covered with an underground drainage scheme and the two sewage treatment plants are put to proper use, the lake would continue to be misused, he said.'Clear encroachments'

Residents wanted the municipal authorities and the Water Resources Department to clear encroachments and rejuvenate the lake, besides setting up recreational facilities.While the main bund of the Red Hills reservoir, one of the city's major drinking water sources, remains in the spotlight, the rear portion of the lake near Thirumullaivoyal, is not cared for. The boundary of the lake, particularly near the Arikambedu-Thirumullaivoyal junction, is treated like a makeshift dumpyard, complained residents.P. Logeswaran, a resident of Srinagar Colony, said many areas, including Srinagar Colony and Senthil Nagar, are still waiting for water connections despite remitting the deposit amount a decade ago. Even those localities that are covered by the drinking water network have not been receiving adequate water supply. Several people relied on the groundwater source, and localities such as Saraswathi Nagar and M.G.R. Nagar have been waiting for an underground sewer network for many years now.

Though well-connected by public transport and rail links, damaged roads are another issue plaguing Thirumullaivoyal. Residents noted that several areas like Sakthi Nagar, Venkatachalam Nagar, and Saraswathi Nagar lacked blacktopped roads.Chozhambedu Main Road, which is a key stretch connecting traffic from C.T.H. Road to several residential areas of Thirumullaivoyal, incuding Tamarai Nagar, is riddled with potholes and uneven patches, said Manoharan K., a resident of Venkatachalam Nagar.Listing out the various measures being implemented for the area's development, Amudha Babysekar, Zone 2 chairman, Avadi Municipal Corporation, said a proposal is being prepared to restore Arafath lake as an eco-park on the lines of Paruthipattu lake in Avadi. The lake would be improved with various facilities, such as pavements and a children's play area. It would also serve as a recreational space for residents with several amenities like boat rides.Measures are being taken to ensure the functioning of the two sewage treatment plants in Manikandapuram 9th Street and C.T.H. Road to reduce sewage pollution into Arafath lake. Work to provide underground drainage network is also in progress.Nearly 80% of Thirumullaivoyal has been covered by drinking water lines, and work is in progress to provide connections to the remaining areas. A new overhead tank in Nagammai Nagar would provide water supply to the leftout streets.As for Chozhambedu Main Road, she said, the stretch, which was dug up to execute various infrastructure projects, would be restored in 10 days. Relaying of damaged roads, including in Manikandapuram, is being carried out at a cost of ?2 crore.

# Boeing faces headwinds from crashes and competition

Earlier this month, a London-bound Air India plane crashed soon after take off in Ahmedabad, killing all but one of the 242 people aboard. This was one of the deadliest disasters involving a passenger aircraft in India in the last two decades. While this was the first Boeing 787 Dreamliner to crash, data shows that this is the latest in a litany of problems that Boeing faces. Only weeks before the crash in Ahmedabad, Boeing had agreed to pay \$1.1 billion in a deal with the U.S. Department of Justice to avoid prosecution over two crashes - one in 2018 and the other in 2019 involving 737 Max airliners. In total, 346 people died in these incidents. Lawyers of the victims of these crashes criticised the payout deal as "morally repugnant". Boeing's stock prices plummeted after the crash in Ahmedabad, but have recovered since. Data show that Boeing's stock prices had fallen steeply after other crashes as well. For instance, in October 2018, when Lion Air Flight 610, a Boeing 737 MAX airliner, crashed killing 189 people, the company's stock fell sharply. On March 10, 2019, Ethiopian Airlines Flight 302, a Boeing 737 MAX 8, crashed minutes after take off. The company's stock dropped again — this time more steeply than what Boeing had ever seen. That incident claimed 157 lives. The company also suffered setbacks when its 787 variants were grounded by the U.S. after these accidents, and during the COVID-19 pandemic

in the 2020-2021 period.Last week, the National Transportation Safety Board (NTSB) criticised Boeing's safety culture for the mid-air blowout of a 737 MAX 9 flight operated by Alaska Airlines in January 2024. It said that Boeing had failed to provide adequate training and oversight to prevent a mid-air cabin panel blowout.The NTSB is now working with India's Aircraft Accident Investigation Bureau to extract data from the black box of the plane that crashed in Ahmedabad. In the ongoing investigation of the incident, no aircraft-related problems have been reported yet.

According to data from the Aviation Safety Network, a high incidence of accidents, as well as a high number of fatalities, involved Boeing-manufactured aircraft between 2019 and 2024. The chart shows the share of fatalities in aviation accidents that occurred between 2019 and 2024, globally.In the last five years, 26.2% of all aviation accidents have involved a Boeing plane. This is much higher than the share of accidents involving other aircraft manufacturers such as Airbus whose revenues mimic those of Boeing.

Also, close to 43% of all fatalities in aviation accidents between 2019 and 2024 involved a Boeing plane. The company is financially struggling now as investors and operators have gravitated towards companies such as Airbus.Fleet statistics from 2023, published by the Directorate General of Civil Aviation, show that a majority of India's fleet was manufactured by Airbus. The chart shows the manufacturer-wise share of aircraft owned/leased by various Indian airlines as of 2023. Only 22% of the fleet were manufactured by Boeing. Only some Indian airlines such as SpiceJet and Akasa Air relied more on Boeing. Company reports from Airbus and Boeing show a huge difference in the number of aircraft delivered by the two dominant aircraft manufacturers, globally. The chart shows the number of aircraft delivered globally by Airbus and Boeing. Last year, Airbus delivered 766 aircraft, while Boeing delivered 348. The number of deliveries by Airbus has steadily grown since 2020 as opposed to Boeing's.Parliament data on orders placed by Indian airlines in 2023 and 2024 also suggest an increasing reliance on Airbus. The chart shows the number of orders placed by select Indian airlines to Airbus and Boeing in 2023 and 2024. In the last two years, IndiGo has placed 510 new orders with Airbus. tions including particular antibiotics, latex, contrast agents used in imaging studies etc. Some people can have anaphylaxis with food items such as peanuts, prawns or mushrooms. Anaphylaxis is a medical emergency, and the person needs immediate help and treatment. Avoidance of exposure to such drugs or food items is the best preventive strategy against anaphylaxis. However, to deal with cases of emergency, doctors sometimes train the patient and relatives to administer ready-prepared injections of epinephrine. Allergic diseases are on the rise. But a healthy life routine, daily exercise, balanced diet, avoiding obesity, taking respiratory vaccines and maintaining a list of substances a person is allergic to and avoiding them are the best strategies to prevent allergic disorders.

viduals (7.9 crore-3.16 crore) need to submit their documents. This figure is very similar to our 4.76 crore estimate based on population projections. The ECI requires this staggering magnitude to prove its eligibility to vote within a month.

What is this proof of eligibility? The ECI says a copy of one document in a list of 11 needs to be presented. Seems simple? Perhaps for some other State, but certainly not for a document-scarce State such as Bihar. Let us list the 11 documents and look at the data that is publicly available for our demographic of 18-40 years. The first is identity card/ pension card of State government/ Central government/ public sector undertaking. As per the 2022 caste census, 20.47 lakh Biharis have government jobs. Fewer than half of them will be from the 18-40 age group and pertain to less than 2% of this group.

The second is an identity card issued before July 1, 1987. This is not applicable. The third is a birth certificate. As per the National Family Health Survey-3, 2.8% of Bihar's population born between 2001 and 2005 possess a birth certificate. Much of our age group of interest was born before 2001, so a negligible proportion possesses this document. The fourth is a passport. Around 2.4% of Bihar's population possess a passport. The share would be higher in the 20-40 age group but would not reach double digits. The fifth is a matriculation certificate. Deriving from the National Family Health Survey-2 and National Family Health Survey-5, around 45-50% of 18-40-year-olds are matriculate. As of 2019-20, there is a 10% point gap overall between male matriculates and female matriculates: females are at a definite disadvantageThe sixth is domicile. In-migrants in Bihar are an insignificant proportion of the population. The seventh is a forest rights certificate. The share of Scheduled Tribes (ST) in Bihar is 1.3%, according to the 2011 Census. Of them, those living in forests form a much lower share. The eighth is an Other Backward Classes (OBC)/ Scheduled Castes (SC)/ST certificate. Data from the India Human Development Survey-2, analysed by Professor Ashwini Deshpande and Rajesh Ramachandran in The India Forum, notes that around 20% of SCs, 18% of OBCs, and 38% STs had a caste certificate. Considering that almost no upper castes possess caste certificates, around 16% of Biharis possessed a caste certificate in 2011-12 when this survey was conducted. Those eligible individuals who are 30-40 years of age today would already have obtained a caste certificate by 2012 had they wished; even if the rest obtain caste certificates in a higher proportion, overall not more than one in four households are likely to possess this document. The ninth is the National Register of Citizens. This is applicable solely to Assam.

An allergy is the excessive reaction of our body's immune system to a substance that is harmless for most human beings. Our immune system is our primary protective mechanism against harmful invaders - bacteria, viruses and parasites. This system, developed over millions of years of evolution helps provide adequate protection to our bodies. But sometimes, our immune system may identify a harmless substance as harmful and can react strongly, causing harm to our own bodies. Understanding respiratory allergiesRespiratory allergies are a reaction of our immune system against substances such as pollen, cold air, dander of pet animals, dust mites, exercise, fungal spores etc. Respiratory allergies manifest in mainly three ways: allergic rhinitis, which causes a runny nose and nose blockages; bronchial asthma, which causes cough and breathlessness and allergic conjunctivitis which causes itching, redness and watering of eyes. Rising prevalence

The incidence and prevalence of respiratory allergies have been on the rise over the past century. Changing lifestyles and diets, including the consumption of processed and junk food, bidi and cigarette smoking, exposure to biomass fuel smoke, exposure to environmental pollution such as vehicle smoke and exposure to pesticides are some of the major drivers of the increase in respiratory allergies. About 35 million people in India suffer from bronchial asthma, but only 30% get a correct diagnosis. Only a few people develop respiratory allergies due to genetic predisposition; however, obesity is a major risk factor, and in many cases, obesity-related allergies are also difficult to control.Identification and diagnosisPeople with symptoms of respiratory allergies should consult a respiratory physician or an allergy clinic. A comprehensive analysis of the patient's symptoms, history of exposure to trigger factors and history of recurrent symptoms with exposure provides enough clues towards the diagnosis of a respiratory allergy. Many times however, the immune system of a person with a respiratory allergy reacts against a variety of different innocuous stimuli, and so, it becomes difficult to pinpoint one trigger factor causing the person's symptoms. However, simple tests like the skin prick test, blood tests of specific immnunoglublins can help the physician and patient to identify a major trigger factor, for instance, dust mites. A mere positive allergy skin test report though, is not enough to blame a particular antigen or trigger factor -- the rest reports need to be correlated with exposure history and the patient's symptoms by a trained respiratory physician to confirm the diagnosis. Once a particular antigen correlating with a patient's symptoms and exposure is identified, hyposensitisation with immunotherapy can be done for a few antigens. In immunotherapy, the same substance that causes the allergy, is introduced to the patient's body in very low doses, gradually, in the form of a tablet or subcutaneous injection. Most respiratory allergies can be prevented by following few general lifestyle changes such as:Anaphylaxis is a very severe form of an allergic reaction to a variety of substances such as bee stings, medica-

# Why is the ECI de-listing political parties? | Explained

The story so far: The Election Commission of India (ECI) has initiated steps to de-list 345 Registered Unrecognised Political Parties (RUPPs) that have not contested elections in the last six years and whose offices could not be physically located.

### What are registered parties?

The right to form an association is a fundamental right guaranteed under Article 19(1)(c) of the Constitution to all citizens. Political parties are an association or body of individuals that can be formed by citizens. Section 29A of the Representation of the People Act, 1951 (RP Act) lays down the requirements for registration of a political party with the ECI. Any political party that seeks registration should submit a copy of its memorandum/constitution within 30 days of its formation. Such a document should contain a provision that the party shall bear true faith and allegiance to the Constitution of India. It should also bear allegiance to the principles of socialism, secularism and democracy, and uphold the sovereignty, unity and integrity of India. The ECI reviews the memorandum/constitution of the political party to verify that it contains provisions for internal democracy like periodic elections for its office bearers. The ECI thereafter registers them as a RUPP. The RUPPs enjoy the following benefits — (a) tax exemption for donations received under Section 13A of the Income Tax Act, 1961, (b) a common symbol for contesting general elections to the Lok Sabha/State Assemblies, and (c) 20 'star campaigners' during election campaigns. RUPPs are required to maintain the details of individual donors who have donated above ?20,000 in a financial year and submit these details to the ECI every year. As per Section 29C of the RP Act, failure to furnish these details will result in losing income tax exemption. The RUPPs under the Income Tax Act, 1961, are further required to accept donations in excess of ?2000 only through cheque or bank transfers. What are the issues?

As per ECI notification, there are more than 2,800 RUPPs in India as of May 2025. However, only around 750 of them contested the 2024 general elections. It has resulted in the moniker — 'letter pad parties' — for the rest of the RUPPs. The RP Act does not confer explicit powers on the ECI to de-register any political party if it fails to contest elections, conduct inner-party elections or lodge requisite returns. The Supreme Court in Indian National Congress versus Institute of Social Welfare & Ors (2002) had held that the ECI does not have the power to de-register any political party under the RP Act. It may de-register only under exceptional circumstances such as the registration being obtained by fraud or the political party ceasing to have allegiance to the Indian Constitution or if it is declared unlawful by the Government.

The Election Commission of India (ECI) recently issued an order for holding Special Intensive Revision of Electoral Rolls for Bihar. This exercise will then be carried out in all the States. The order is antithetical to the tradition of this august institution. From the first election held in independent India, the ECI has played a heroic role in seeding democracy through active voter enrolment and protection of the right to vote of the disadvantaged. Though the ECI is facing a credibility crisis of late, this initiative is surprisingly radical. And unless it is substantially modified, it will disproportionately disenfranchise the poor and deprived electors irrespective of their party preference. We will leave the thorny questions of legality to the experts and just focus on the scale of the venture and its practicability within the proposed timeline. As per the directive, all individuals who have not been featured in the electoral rolls of 2003 need to prove their citizenship as per the Citizenship (Amendment) Act, 2003, and Rules. Broadly, if the 2003 electoral roll features nearly all individuals who were 18 years or older then, these individuals, now 40 years and older, get a direct entry into the proposed electoral roll. How many then have to go through the hoops?

In 2020, the Ministry of Health and Family Welfare published a report, Population Projections for India and States 2011-36. The report estimates the current voting age population of Bihar to be 8.08 crore. About 59% of this population (4.76 crore individuals) is 40 years old and under. The ECI, from July 1 to July 31, requires this staggering number to prove citizenship.In its press note of June 28, the ECI stated that the electorate count in Bihar is 7.9 crore. As per the ECI, as "4.96 crore of the 7.9 crore already have their names in the last intensive revision of electoral rolls" in 2003, just 2.94 crore individuals will need to submit their eligibility documents. This is clearly an oversight. The electoral roll of 2003 for Bihar did have around 4.96 crore individuals. By our calculations from the reports of the Sample Registration System, around 1.1 crore of them are dead. The ECI has taken them off the rolls.

Plus, there is sizeable number of people who have permanently migrated out of Bihar. As per a paper by Pinak Sarkar, Professor at the Tata Institute of Social Sciences, deriving from the Census, 93 lakh people permanently migrated out of Bihar between 2001 and 2011. Even if migration has slowed a bit after 2011, an average of 8 lakh outmigrants a year from Bihar in the period 2003-24 would mean a total of 1.76 crore out-migrants. If the share of those over 18 years of age in the 1.76 crore group is the same as the proportion in the Bihar population, this amounts to 94 lakh voters who have migrated out of Bihar permanently. If even one fourth of them remain electors in Bihar, 70 lakh are no longer electors in Bihar and are voting elsewhere in India. The ECI would have taken them off the Bihar electoral rolls.Hence, of the 4.96 crore electors in the 2003 list, if we remove those who are dead and those who have migrated from Bihar permanently, around 3.16 crore electors remain in the present count of Bihar's electorate. These 3.16 crore people who were also on the 2003 list do not need to submit any eligibility documents. The rest of the 4.74 crore indi-

The last is a land/house allotment certificate by the government. There is no data available on land allotment certificates. House allotment certificates seem applicable to government employees availing government housing. No such certificate is given to beneficiaries of schemes such as the Pradhan Mantra Gram Awas Yojana.

Most people without a matriculation certificate are unlikely to apply for a passport, a government job, or a caste certificate. By the ECI's new rule, the matriculation certificate has effectively become the main eligibility proof for voters aged 18 to 40. This shifts us from adult franchise to a system that favours only matriculates. As a result, around 2.4 crore-2.6 crore people who had to leave school due to poverty may now be left out of the voters' list. The final number of people disenfranchised will be even larger than this if we add the over 40-year-olds who have been missed in the 2003 voters' list and those over 40 whose present names don't match with those in the 2003 voting list. These hundreds of lakhs of people will lose their constitutional right to vote not because they are illegal migrants but because they are illegible to a State which lacked the capacity to issue birth certificates, render basic education, or issue caste certificates to the deprived castes. A State cannot penalise so many people for its own shortcomings. This also begs a simple question: if the ECI allows for OBC/SC/ST certificates, why is Aadhaar not allowed if the proof of identity document for a caste certificate is Aadhaar? It should not be that Aadhaar's major flaw is that it is more available ---around 9/10th of the Bihar population possess it. Does the ECI believe that it has issued voter cards to non-citizens? Also, why not allow ration cards?

# Jungles of Chhattisgarh drenched in red



Under a muted October sky, 31 bodies of alleged Naxals lie in the open in Karli police lines, a sprawling campus in Chhattisgarh's Dantewada town, in the district of the same name. They were gunned down a day ago by security forces in what has been the biggest anti-Naxal operation in the Maoist-affected State, since Chhattisgarh's creation in 2000. The police would later revise the estimate of the number of dead to 38, based on a Naxal statement.

For a scene that reeks of death, there is a strange upbeat chaos: policemen high-five each other, journalists quiz them, there are some clipped voices about the possibility of rain. As the day progresses, the stench gets stronger because the bodies lie in the open. Many of the facilities in the Karli police complex are named after policemen who were killed by Naxals. Now, it is the scene of photo ops with the bodies. From the 1960s, forest-dwelling marginalised communities, mostly tribal, have waged an armed struggle against the state, in a communist-led separatist movement that originated in West Bengal.A policeman says blithely, "Is se bhi bada karenge (We will go even bigger the next time)." This operation was conducted near Thulthuli and Gawadi villages in adjoining Narayanpur district. Here, phone networks are sketchy and only dirt tracks through dense jungles lead to the villages.

Last year, the Bharatiya Janata Party was voted into the State to form the government. This year, the crackdown has been unprecedented: the bodies of 192 people allegedly Maoists - 125 men and 67 women - have been recovered. Up to 762 have been arrested, 745 have surrendered, and 207 weapons seized in 2024 alone. In 2023, there were 20 killings; 30 in 2022, 51 in 2021, and 41 in 2020. In April this year 29 Maoists were gunned down in Kanker district, considered a major anti-Naxal operation - ANO, in police jargon.Earlier this year, Union Home Minister Amit Shah said in Naya Raipur, a new township adjoining Chhattisgarh's capital, that Naxalism will be ended in the State by March 2026. The Inspector General of Police (Bastar Range) Sundarraj P. feels this is realistic. "This year so far has been one of the biggest operational years. Now that the monsoon is over, we will restart operations on a major scale."Behind his confidence is a new strategy: about 190 camps have been set up in Naxal strongholds, ensuring "deeper penetration" in the dense jungles of Bastar, in Chhattisgarh's south, bordering Andhra Pradesh, Odisha and Maharashtra. The camps obstruct Maoist movement and meetings, and disrupt crucial supply routes. Set up in a 7- to 8-kilometre radius of villages, these camps hamper recruitment efforts and weaken their organisational reach.Action and attention

Gawadi village is about 20 km from Orchha block that has a police station and a lone bus stop. Like most villages embedded in forests, it takes at least four hours on a twowheeler and on foot, to reach. It lies across seven rivulets and muddy, rocky paths. For villagers, even accessing basics such as a ration shop or health facilities could mean a challenging trail that takes a whole day. There is provision for children to study in residential schools in the district headguarters or a development block, but many drop out.Jira Usendi, in his late 20s, is back in Gawadi after working as a labourer in Maharashtra's Nagpur for a few months. He is one of the few who has lived outside the village. "My heart was in the Abujhmad forests," he says. He hopes the violence will end, so that his six-year-old child can have a better future. Usendi is against setting up new camps near the village. "From my childhood, I have heard in ghotuls (tribal youth dormitories run by the community) that if security forces make a base here, they will take our lands away. Also, the police come here and torture us when they guestion us for having links with Naxals; the Naxalites also torture us."Jira Usendi, a resident of Gawadi village, which is close to the October 4 encounter site, says villagers wants a resolution to the conflict but they are often tortured by both police and Naxals. He is now a gardener in the city's municipal corporation. Previously called Badranna, he says, "The influence of the Maoists is waning, but the government's penetration in the forest will only lead to deforestation and mining. The existing inequality will become worse."There is rudimentary development around the areas of the camps. In some villages there are Jal Jeevan Mission water tanks equipped with solar pumps. The administration and the police say that new camps for security forces will also act as development centres for the villagers, making it easier for them to access basic amenities. These camp sites will turn into hubs for basic healthcare and supplies of daily needs. They also say that it is local support and intelligence they are receiving that has contributed to the crackdown.However, in villages, people still visit Naxal memorials that resemble tomb stones, and there are painted slogans appealing to people to boycott elections. The People's Union for Civil Liberties, founded

by socialist and political leader Jayaprakash Narayan, and the Chhattisgarh Bachao Andolan question the scale of operations. They have put out a statement questioning the number of killings, arrests, and surrenders, saying that "the government itself estimates that the number of Maoists is only 1,500..." which would "indicate that Naxalism has been wiped out". Girish Kant Pandey, the principal of a government college in Bemetara district, who is known in Chhattisgarh for his research work on the Maoist conflict, says that while the government's latest approach might prevent Naxalism from spreading, only dialogue can bring about a resolution. "The people being killed are low-rung Maoists. The top leaders are either in jail in different parts of the country or are underground. The government will have to shift all of them to a common jail and then begin talks," he says. He also advocates a surrender policy, involving livelihoods and better living conditions. While one such policy is in the works in Chhattisgarh, details have not been revealed yet.

A senior police officer in Dantewada, a district known for its ancient temples and ponds, talks about the year-long strategy that went into the capture and killing of the alleged Maoists. He cites the term Chakravyuha, the details of which he cannot disclose. He does say that at its core, "It involves assigning a clear role to every person. This keeps the operation organised with a structured form." This has reduced casualties of jawans too. He also cites a technology upgrade, such as the adoption of long-range drones which can survey an area up to 25 km in tree-covered terrain, and send real-time inputs. This year, security forces in Bastar have received sophisticated weapons from the Central Armed Police Forces. He says there is now joint, coordinated action with neighbouring Andhra and Odisha, also a part of the red corridor. In August this year, in a response to a question in Parliament, the Central government said left-wingextremist (LWE)-affected districts had reduced from 126 across 10 States in 2013 (the year before the BJP government came in for the first time) to 38 districts across nine States, in April 2024. Up to June 2024, LWE violence was reported from 89 police stations across 30 districts.

Sundarraj talks about the locally raised District Reserve Guards, surrendered Naxals who now lead operations, and are familiar with the terrain, and language and customs of the tribes. "To strengthen this expertise, the CRPF has also recruited a dedicated Bastar Battalion, made up of local recruits. Additionally, we have established a jungle warfare training centre in Kanker, where forces undergo rigorous preparation tailored for combat in dense forest environments."Another senior police officer points out that there is now more funding under the Special Central Assistance to support tribal development, and Security Related Expenditure budgets given to combat areas and special States. "Also, there is alignment between the Centre and the State." Previously, the Congress was in power in Chhattisgarh, with the BJP returning in its fourth stint since the State's formation in 2000. "Funds matter because human intelligence is a cost-intensive process. We have seen Maharashtra and Telangana [that also see LWE] benefitting by pumping in additional money," he says. While senior officers are upbeat, even boastful, those closer to the action feel it is difficult to put a date to the end of the Naxal movement that began as a tribal peasant uprising against landlords in 1967, in Naxalbari in West Bengal. A junior officer from one of the affected districts, says, "There are many more challenging areas to reach, in terms of terrain. There, even setting up camps close by may take years."Pandey dismisses the 2026 date, saying such deadnes have been given in the past too. "The problem is multipronged and military successes are only a small part of it. The government will need to set up smaller goals, such as by this day we will free up this police station area or this district, and then move accordingly. Otherwise such deadlines are only vague assertions. Encounters may only check their spread," he says.Some encounters have been mired in controversy. In Pidia village, Bijapur district, family members of 12 alleged Maoists killed have vehemently questioned the killings. They have alleged that innocent villagers collecting tendu leaves, for their livelihood, were among those killed by the police. Dantewada-based social activist and lawyer Bela Bhatia had accompanied the family members of some of those killed to the police station to file an FIR, but the police refused to file one. Bhatia is one of the few who still speaks out against the state. Many activists who raised their voices for the tribals earlier are now reluctant, fearing a crackdown. There are allegations from other areas too. In Bijapur's Lendra village, Kamli Kunjam, in her early 20s, was shot dead in an encounter on April 2. Her family says she could neither hear nor speak."My daughter was not a Maoist. She was undergoing medical treatment. I have a son who has the same condition. On the day of the encounter, a group of men came to our house and took Kamli away after ransacking the house. When I protested, they said they would bring her back. The next day we were informed by the police that she was killed," says Somli Kunjam, Kamli's mother.Sundarraj denies all these allegations and says that her presence with other Maoists - there were 12 killed in that encounter - and the recovery of her body with a uniform, established her links with the banned outfit, the Communist Party of India (Maoist), one of several socio-political organisations banned in India. Many alleged Maoists carry rewards on their heads, cumulatively amounting to nearly ?9.6 crore, a sum most wouldn't have seen in their lifetime.

# From Panipat to Balochistan: Tracing the Maratha community's journey through history



In the early 19th century when the British were attempting to expand in the Indian subcontinent, they were faced with just one major regional power capable of destroying their emerging empire - the Marathas. Spread across several small kingdoms, from modern-day Tamil Nadu in the south to Gwalior in the north and Odisha in the east, the Marathas, at one point, were said to have occupied a third of the subcontinent. Though the regime set in place by Chhatrapati Shivaji Maharaj dissipated by the early 1800s, in Maharashtra, the Marathas continue to have a resounding presence. Ever since the birth of Maharashtra in 1960, 12 of the state's 20 chief ministers have been Marathas, including the incumbent Eknath Shinde. Issues related to the Maratha community, including the heavily debated demand for reservation, consistently frame electoral narratives in the state's polls.

In this four-part series, we will take a deep dive into the multi-faceted history of the Marathas and unravel some remarkable and unknown facets of the community's evolution over the centuries. In 2023, Baloch, a Marathi film directed by Prakash Pawar premiered on Amazon Prime. The movie sheds light on a forgotten chapter of history the Maratha captives taken to Balochistan following the Third Battle of Panipat in 1761. In a more contemporary setting, Karachi-based social media influencers Sameer Kay and Vishal Rajput have been documenting Pakistan's Marathi community, particularly its vibrant Ganpati celebrations. Through their detailed YouTube videos, the duo offer an intimate view into the community's rich traditions, from festive feasts of halwa-puri-modak to the poignant immersion ceremonies. The Marathi-speaking diaspora in Karachi, though significant, is not the first from Maharashtra to have established roots in Pakistan. So who were the earliest settlers? How did they navigate life in a foreign land? And, perhaps most intriguingly, do they still cling to their original identities? The answers reveal a fascinating tapestry of migration, captivity, and resilience.Marathas, Ahamd Shah Durrani, and the battle for controlAfter the death of Emperor Aurangzeb and the decline of the Mughal Empire, the Maratha Confederacy expanded rapidly, posing a threat to Ahmad Shah Durrani's (also known as Ahmad Shah Abdali) Afghan Empire. To counter this, Ahmad Shah launched a campaign, capturing large parts of Punjab and aiming to starve the Maratha forces. In response, the Marathas assembled a large army under Sadashivrao Bhau, who managed to reclaim Delhi.Ahmad Shah sought to trap the Maratha forces in Punjab, cutting off their supplies while moving troops southward. Surrounded by the enemy and starving, Sadashivrao Bhau attempted to break the siege, leading to a confrontation at Panipat in 1761. In part II of his book, Medieval India, historian Satish Chandra observes that "the Bhau would not have been able to prevail over the Abdali, saddled as he was with heavy artillery and womenfolk." He contends that while the Maratha soldiers primarily relied on lances and swords, the Afghan forces held a significant advantage with skilled musketeers equipped with quick-loading flintlock guns and mounted on "swift, welltrained horses." This technological and tactical superiority, combined with internal rivalries within the Maratha ranks, ultimately weakened their forces. The smaller but unified Ahmad Shah army decisively overwhelmed the Marathas. The third battle of Panipat on January 14, 1761, devastated the Maratha army, ended their ambition to succeed the Mughals, and plunged northwestern India into decades of instability. "The ultimate beneficiaries were not the Maratha sardars and erstwhile Mughal nobles who stood for regionalism, but the English who brought in centralism of a new-kind, the colonial type," notes Chandra. Narratives of early communitiesFollowing the crushing defeat at Panipat, only a few hundred of the Peshwa's army survived, seeking refuge in the jungles of Haryana. Today, they are known as the Rod Marathas, a community of nearly seven to 10 lakh people, spread across Karnal, Rohtak, and Bhiwani. Yet, as history buff and co-author of Travels with Nandighosh Yashwant Marathe writes in his blog, for 22,000 other men, women, and children, fate was far harsher. Captured as prisoners, they were marched to Afghanistan alongside Ahmad Shah's forces. While many women and children were rescued by Sikh warriors during the army's passage through Punjab, Marathe argues that those who crossed into Balochistan's Dera Bugti region faced a grim future. In the gripping opening of the film Baloch, the narration vividly captures the captives' fear: "Every step was taking them away from their home, with the fear that they would never see it again."In gratitude for his Baloch allies' support, Ahmad Shah 'gifted' the Maratha prisoners to Mir Nasir Khan Noori, the Baloch ruler. However, this was less an act of generosity and more a way to rid himself of exhausted captives under the guise of diplomacy.

The Maratha captives were then divided among the tribes of Bugti, Marri, and Gurchani, among others, forming new communities and blending into Balochistan's social fabric. "The Marathas we are discussing are not spread across Pakistan, but are specifically located in Balochistan. Keeping the group together was a risky decision, which led Nasir Khan to implement the policy of dividing them," says engineer and history enthusiast Sudhir Dandekar. In an interview with indianexpress.com, Abhas Verma, author of Third Battle of Panipat, says, "The Maratha Bugtis in Balochistan are an interesting case of what may be a caste forming even under Islamic rule.""The prisoners of war, including children, were sold into slavery and held captive. The group was also forbidden from owning land and forced to convert to Islam," he says. However, Verma emphasises that these narratives remain largely undocumented due to a lack of research and the sentiments within the Maratha community."Regardless of their yearning to return," he continues, "the region was hostile, and the distance of return was a long and uncertain journey they could not think of making." Verma's book mentions the story of a Brahman named Narhari Ranalekar, who, after returning from captivity to his home in Paithan (in present-day Aurangabad district in Maharashtra), sought acceptance from the Brahma Sabha, having been forcibly converted to Islam. After much deliberation, the Sabha agreed to welcome him back.In his book Pakistan A Hard Country, British author and journalist Anatol Lieven recounts an encounter with a local Nawabzada Jamil Bugti in Quetta. Lieven was struck by the "small, thin, dark-skinned" servants accompanying Bugti. Upon inquiring, he learned that they were descendants of the Marathas from central India, "captured in war by the Mughal emperors and given to their Bugti troops as slaves in lieu of wages."Despite enduring forced conversions to Islam and harsh conditions in the arid lands of Balochistan, the Marathas displayed remarkable resilience, preserving their cultural identity for over two centuries. Their heritage is still evident in their customs, surnames, and rituals. The Bugti Marathas, for instance, continue to celebrate weddings with haldi ceremonies, Saptapadi rituals, and Marathi traditions such as crossing a rice bowl to enter a new home.Dandekar also highlights the common custom of ear-piercing, which remains prevalent among the Maratha community in Balochistan. "Another instance that comes to mind is the popularity of the Marathi film Ramshastri in the theatres of Quetta, the capital city of Balochistan, during the mid-20th century. The pride the Marathas in Balochistan take in their roots was evident," he says. The Marhtta Qaumii Itehad, the largest organisation of the Maratha community in Balochistan, garnered significant attention in 2017 when they joined their Indian counterparts in the agitation protests for reservation. The chief, Wadera Din Muhammad Marhtta Bugti, expressed solidarity on a Facebook post, stating, "We fully support the protest in India. We condemn any injustice meted out to the community and agree that there should be a reservation quota for them when it comes to government jobs and education. In Pakistan, the rights of the community have been established. Why can't it be the same in India?"For generations, these Marathas' lives were marked by hardship and displacement. Over time, however, they began to work their way toward prosperity. Today, many have risen to prominent positions in society. Their contributions to agriculture in Balochistan stand as a testament to their endurance. As Dandekar says, "It is thanks to the knowledge and hard work of these Maratha descendants that farming began to flourish in the Baloch region." Years LaterVerma categorises the migration of the Marathi-speaking diaspora to Pakistan into three distinct phases: "After the Battle of Panipat, the other two key events marking the movement of Marathi-speaking groups to Pakistan were the Partition of British India, which caused widespread displacement, and the post-partition migration of merchants from Bombay to Karachi for business purposes."While there were also movements of labourers to Pakistan, most of these were voluntary, starkly contrasting the forced migrations of the early captives to Balochistan. Despite these challenges, the Marathas' resilience endured, and today, the Marhtta Qaumii Itehad proudly continues to uphold this legacy. Its leaders have, on numerous occasions, expressed their pride and solidarity with the broader Maratha communityLieven also noted that "there was no sign of Bugti blood in the faces of the Nawabzada's [Maratha] servants." Though officially made equal citizens of Pakistan after 1947, and despite figures like Nawabzada Bugti claiming that 'they have merged completely with the Bugti and no one can tell their difference anymore,' this group continues to preserve its roots and reclaim its history.Pawar's movie poignantly closes with a line that encapsulates the spirit of the Maratha community: "We have to tell our descendants that the Panipat war was not the last war of Maratha, but the final battle was fought in Balochistan where the Marathas emerged as the winners.<sup>3</sup>

# With 21.2 crore, India tops global diabetes list in 2022, finds study

New Delhi: About 82.8 crore people around the world are estimated to be living with diabetes in 2022, with over a quarter in India, according to an analysis published in The Lancet journal on the occasion of World Diabetes Day observed every year on November 14. The figure of 82.8 crore is over four times the number in 1990, with the largest increase in low and middle-income countries (LMICs), researchers forming the Non-Communicable Disease Risk Factor Collaboration (NCD-RisC) said.Between 1990 and 2022, rates of diabetes treatment stagnated at low levels in many of the same LMICs, where cases of the disease drastically increased, resulting in 44.5 crore adults aged 30 and over with the metabolic condition globally (nearly 60 per cent) who did not receive treatment in 2022, the researchers said.Of the 82.8 crore, India's share formed over a quarter (21.2 crore). Another 14.8 crore were in China, while 4.2 crore, 3.6 crore and 2.2 crore lived in the US, Pakistan and Brazil, respectively, the researchers found.NCD-RisC is a global network, coordinated by the World Health Organization, of over 1,500 researchers and practitioners providing information on risk factors for non-communicable disease across countries.Further, in 2022, almost one third of the 44.5 crore adults (13.3 crore) with untreated diabetes lived in India. "Our findings suggest there is an increasing share of people with diabetes, especially with untreated diabetes, living in low- and middle-income countries," said author Jean Claude Mbanya, University of Yaounde 1, Cameroon. "Most people with untreated diabetes will not have received a diagnosis, therefore increasing detection of diabetes must be an urgent priority in countries with low levels of treatment," he said

# Urban consumers prefer smart snacking over traditional snacks in India: NIQ study

Mumbai: As urban consumers increasingly seek health-oriented products, smart snacking in India has grown 1.2 times faster than traditional snacks, according to a report on Tuesday. About 63 per cent of surveyed consumers seek innovative and healthy snacking options while 50 per cent read ingredient labels to understand nutritional value, according to the report by consumer intelligence company NielsenIQ (NIQ). One in five snacks now has a health connotation in the country. "This segment is growing 1.2 times faster than traditional snacks in terms of value, presenting opportunities for brands to innovate in health-focused products and leverage the consumption trend," said Sonika Gupta, Executive Director, Customer Success' India at NIQ.In consumer tech, the trend toward health-focused products is evident. Fitness wearables experienced a 59 per cent volume growth, while hot air fryers grew by more than 100 per cent, signalling broader health-conscious behaviour.

India's snack and confectionery industry ranks second in market size across Asia-Pacific, is transforming as urban consumers increasingly seek health-oriented products. The rise in lifestyle diseases has driven Indian consumers to opt for snacks that align with their health goals. Study showed that 84 per cent of surveyed urban Indian consumers exercise daily or regularly to keep fit and 48 per cent use a fitness or exercise app.



Smaller, emerging players are challenging established players with competitive offerings, with single-serve packs driving demand and growing 60 per cent faster in smart snacking due to mainstream pricing strategies. The smart snacking segment's growth is fuelled by consumption rates twice that of the general snacks market. The consumption preference is driven by small convenient pack sizes that have demonstrated 60 per cent higher growth compared to traditional small packs in the snacking space. Notably, Smart Snacking has been growing at 16 per cent in terms of value, but recent trends show a slowdown in count of new innovations and product launches, said the report.

# How this digital integration plan hopes to replicate UPI's success in India's power sector



Picture this: Solar panels on your rooftop generate excess power, which you store in a battery at your neighbour's home - and draw back in the evening. In return, a payment for renting the battery is instantly transferred from your bank account to your neighbour's, enabled by a digital public infrastructure (DPI) as seamless as UPI. Now, with the government setting up a task force led by Infosys co-founder Nandan Nilekani, a digitally integrated future for India's power sector is beginning to take shape. The proposed India Energy Stack (IES) aims to do for the power sector what Aadhaar did for identity, and UPI for finance. By digitally integrating India's fragmented power ecosystem - from producers and grid operators to consumers, exchanges, and regulators - the IES will enable peer-topeer energy trading, support aggregated demand-response programmes amid rising renewable integration, and facilitate smoother compliance with carbon offsetting. The 17member task force, constituted by the Ministry of Power on June 27, has Nilekani as its chief mentor and is charged with designing and charting a roadmap for the nationwide rollout of the IES - a process expected to take several years.

### Why is a DPI-style intervention needed?

In India, electricity is a concurrent subject, meaning both the Union and state governments share responsibility for its governance, which has contributed to a highly fragmented sector, leading to "isolated digital islands rather than an integrated national platform". This fragmentation, according to a concept brief by New Delhi-based FSR Global knowledge partner for the IES initiative - "creates significant operational challenges that impede the energy sector's ability to meet India's growing energy demands efficiently". The brief identified four key challenges facing the power sector that the IES could help address. First, there is no unique identifier for consumers, assets, or stakeholders. Second, decision-making is hampered by the lack of access to harmonised, real-time data. Third, those seeking to offer solutions in this space struggle to scale, as they depend on various proprietary digital platforms. And fourth, there is no interoperability between these digital systems, which prevents cross-regional data sharing and crossdiscom transactions."In other words, the challenges faced by India's energy sector resemble those faced by the identity and financial sectors prior to the introduction of Aadhaar and UPI. And, just as these DPIs transformed their respective domains, a similar approach can revolutionise the energy sector," the brief said. Beyond enabling unique identification, full integration, and interoperability, the IES can help unlock an entirely new ecosystem - one where energy fintech, virtual power plants, and peer-to-peer trading can thrive on a standardised, interoperable digital infrastructure.

The possibilities are many. Consumers - and producer-consumers, or prosumers - could instantly buy surplus energy to store in batteries or sell rooftop solar output at peak prices. The IES would deepen the decentralisation of electricity and allow prosumers to manage their assets more actively and efficiently. Grid operators could make far more precise load-balancing and dispatch decisions, while energy producers could reduce curtailment or track carbon offsets using transparent performance data. The utility of IES is based on its ability to maintain the integrity of data, processes, and settlements across the board. A key component of this architecture is the Utility Intelligence Platform (UIP) - a primary application layer built on the IES foundation that would enable all of these services

The government is positioning the IES as a natural extension of its successful DPI projects like Aadhaar and UPI, evident by the selection of individuals included in the task force. Nilekani, the founding chairperson of the Unique Identification Authority of India (UIDAI), will serve as chief mentor. Ram Sevak Sharma, the first director general of UIDAI, will chair the task force, and Pramod Verma, the chief architect of Aadhaar, returns in the same capacity for this initiative.REC Ltd, a central public sector undertaking, will serve as the programme nodal agency for the IES initiative. The 17-member task force will be supported by five expert working groups - on technology, distribution, system operations, generation, policy and regulation, and markets - comprising 35 members in total."The Ministry of Power will undertake a 12-month proof of concept (PoC) to validate the India Energy Stack by implementing its foundational building blocks and demonstrating its value through real-world use cases," the concept brief said. The IES "will be deployed over the coming years", it added. While concept-proofing may be swift, given India's prior experience with DPIs, the timely rollout of the IES will hinge on several factors - including cooperation from state utilities, rapid adoption of smart meters and other digital enablers, and the success of trial runs

# ATF price hiked by steep 7.5%, commercial LPG rate cut by Rs 58.5

Jet fuel or ATF price on Friday was hiked by the steepest-ever 14 per cent -- the third straight increase, while the commercial cooking gas rate was cut by Rs 157.5 per cylinder in line with divergent trends in international benchmarks. The increase in ATF price is in line with the spurt in international oil rates that followed Israel's attack on Iran last month. The price of jet fuel (ATF) was sharply increased by 7.5 per cent on Tuesday, while the cost of LPG used in commercial establishments was reduced by Rs 58.50 per cylinder, reflecting shifts in international benchmark rates

After three rounds of price cuts, aviation turbine fuel (ATF) price was increased by Rs 6,271.5 per kilolitre, or 7.5 per cent, to Rs 89,344.05 per kl in the national capital home to one of the busiest airports in the country, accordstate-owned fuel retailers. The increase amounts to half of the total reduction implemented over three monthly installments since April.ATF price was last reduced by Rs 2,414.25 per kl (2.82 per cent) to Rs 83,072.55 per kl on June 1. Prior to that, rates were cut by 4.4 per cent (Rs 3,954.38 per kl) on May 1 and a steep reduction of 6.15 per cent (Rs 5,870.54 per kl) on April 1.The increase in ATF price is in line with the spurt in international oil rates that followed Israel's attack on Iran last month. This increase will add to the burden on commercial airlines, for whom fuel makes up for almost 40 per cent of the operating cost.No immediate comments could be obtained from the airlines on the impact of price hike. The ATF price in Mumbai was hiked to Rs 83,549.23 per kl from Rs 77,602.73 per kl, while those in Chennai andKolkata were increased to Rs 92,526.09 and Rs 92,705.74 per kl, respectively. Rates differ from city to city depending on incidence of local taxes such as VAT. Alongside, oil firms reduced the price of commercial LPG by Rs 58.5 per 19-kg cylinder. Commercial LPG now costs Rs 1,665 in the national capital and Rs



1,616.50 in Mumbai. This is the fourth straight reduction in commercial LPG rates. Prices were last reduced by Rs 24 per 19-kg cylinder on June 1. Prior to that a Rs 14.50 cut on May 1 and a Rs 41 per cylinder reduction was effected on April 1. In all, prices have been cut by Rs 138 per bottle since April.While oil prices have been on the boil, benchmark LPG rates have softened because of low demand during summer months. Prices of ATF and LPG differ from state to state depending on the incidence of local taxes, including VAT. The rate of cooking gas used in domestic households, however, remained unchanged at Rs 853 per 14.2-kg cylinder. The price of the domestic LPG was hiked by Rs 50 per cylinder in April.State-owned Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL) revise prices of ATF and cooking gas on the first of every month based on the average price of benchmark international fuel and foreign exchange rate. Domestic rates of petrol and diesel continue to remain frozen. Rates were cut by Rs 2 per litre in mid-March last year, ahead of the general elections. Petrol costs Rs 94.72 a litre in Delhi, while diesel is priced at Rs 87 62

# All you need to know about: aneurysms



It's a word that has become almost part of casual parlance, but is still perhaps not fully understood by all. An 'aneurysm' is something many of us have heard about --- and here is a chance to find out what it is. Read on.

### What is an aneurysm?

An aneurysm is a bulge or a ballooning of the wall of a blood vessel. Aneurysms usually occur in arteries. Arteries are the blood vessels that carry oxygenated blood from the heart to other parts of the body. When a section of an artery's wall becomes weak, the blood pumping through it can cause the wall to expand or bulge out, forming an aneurysm. Aneurysms are not usually painful, and you may not even know you have one. However, if an aneurysm ruptures, it can cause bleeding inside the body, which can be extremely dangerous and may even be life-threatening.

### Where do aneurysms occur?

Aneurysms can form in any artery of the body. They can occur in the heart, brain, abdomen, chest, legs, neck, or other parts as well. The most common aneurysm is the aortic aneurysm, which is formed in the aorta, the body's main and largest artery that carries blood from the heart to the other parts of the body. When an aneurysm forms in the part of the aorta that passes through the abdomen, this is known as an abdominal aortic aneurysm. Similarly, when an aneurysm forms in the upper part of the aorta where it runs through the chest, it is called a thoracic aortic aneurysm. An aneurysm that develops in the blood vessels of the brain is a called a cerebral aneurysm. Aneurysms in arteries other than the aorta and brain such as those that form in the blood vessels of the leg, neck or groin are called peripheral aneurysms. Aneurysms can also form in arteries supplying blood to the intestine and spleen.

### What causes an aneurysm to form?

The exact causes behind the formation of aneurysms are not fully known. Some may be congenital (present at birth) and some may be caused due to injury or disease. Risk factors for the development of an aneurysm include: being male, being over the age of 60, a family history of

The study aims to lay the foundation for successful and sustainable drone-based blood delivery programmes in India.

Drone technology provides opportunities for improvement in the healthcare sector, primarily in remote environ-



# Telangana mango farmers face mid-season crisis as prices crash amid oversupply, Chittoor ban

Hyderabad: Telangana's mango farmers are grappling with a mid-season crisis as a bumper harvest, unseasonal weather and Andhra Pradesh's ban on mango imports into Chittoor district have led to a steep fall in prices. With an estimated 12 lakh tonnes of mangoes harvested across 3.06 lakh acres, orchards across the State are overflowing with varieties such as Banganapalli, Badami and Totapuri. The surplus, compounded by limited processing infrastructure and restricted market access, has pushed farmers into distress, threatening their livelihoods and casting a shadow over the State's mango industry.

The situation worsened after Andhra Pradesh imposed restrictions on mango imports from other States into Chittoor, India's mango processing hub, to protect its own farmers, who are also facing an oversupply crisis. Chittoor's pulp industries, which process millions of tonnes annually, have been a vital destination for Telangana's Totapuri mangoes, typically fetching Rs 4 to Rs 6 per kg

Wholesale prices in Telangana reflect the deepening crisis. As of June 27, mandi rates at the Gaddiannaram fruit market in Hyderabad range from Rs 550 to Rs. 3,300 per quintal (Rs 5.5 to Rs 33 per kg), with an average of Rs 1,825 per quintal (Rs 18.25 per kg). In contrast, the average rate on April 28 was significantly higher at Rs 4,390 per quintal (Rs 43.90 per kg), ranging between Rs 2,350 and Rs 7,000 per quintal. Totapuri, in particular, has seen a steep drop, with prices falling as low as Rs 8 per kg in some markets due to high volume and limited processing demand.

Retail prices, too, highlight the distress. In April, mangoes retailed at around Rs 150 per kg for standard varieties and up to Rs 250 for premium ones, driven by early-season demand and limited supply. Now, prices have dropped



sharply to about Rs 33.62 per kg at Gaddiannaram, largely due to the glut and declining consumer interest in weatherdamaged fruit.Erratic weather patterns disrupted flowering and led to premature ripening, resulting in blackened and lower quality fruits that fail to fetch good prices. "My Badami mangoes are selling at Rs 30-40 per kg, barely enough to pay workers," says K Venkateswar Rao, a farmer from Sathupalli in Khammam district. The lack of adequate processing infrastructure in Telangana is compounding the crisis. Though the State is working on facilities like a Rs 8.43 crore mango processing unit in Jagtial and food parks in locations such as Toopran, equipped with cold storage and irradiation plants, these are insufficient to handle the current volume or meet export norms for markets such as the US, Europe and Japan. The absence of local irradiation and treatment facilities compels farmers to depend on distant centres in Karnataka, inflating logistics costs and hurting their competitive edge.

ments and rural areas, by enabling just-in-time delivery of life-saving medical supplies, the study says. However, the transportation of blood and its components is complicated as they need to be stored at a specified temperature, or else their functionality is adversely affected, for example, the oxygen carrying ability of blood is greatly reduced. Conversely, blood exposed to extreme lower temperatures may get haemolysed, which could lead to a fatal transfusion reaction

Maintaining cold chain integrity is essential for compliance and accreditation in the delivery of blood and its components. The study documents the challenges experienced by the team during the drone-based delivery while maintaining the biochemical parameters of blood components.

"During drone-based transportation, the temperature, integrity of blood cells, and other parameters were maintained, while slight changes in few parameters were observed via both [conventional and drone-based] transportation modes. In this study, the drone travelled around 36 kilometres in eight minutes, while the [road transport] van took around 55 minutes to cover the same distance," Sumit Aggarwal, Scientist and Programme Officer, I-Drone lead and in-charge, ICMR, said.Blood banks and transfusion lations, and quality standards that mandate strict temperature control throughout the blood supply chain, from collection to transfusion, Dr. Aggarwal said.

"Climatic conditions are crucial since drone transportation and blood biochemicals can be affected by environmental factors. With India's diverse and distinct topographical variations and geographical spread, the delivery of healthcare supplies faces multiple challenges," he added.Drone trials in other countries, including Italy and Rwanda, have indicated drones are a viable solution for blood transportation, and do not affect the integrity of blood and its components, in spite of occasional accelerations and decelerations en route, the study says.Obstacles for ground vehicles, including geographical distances, challenging topographical features such as mountains and rivers, poor or underdeveloped road systems, can be overcome with drones as a mode of transportation, another Southeast Asian study has suggested."Hence, the drone is a potential alternative to explore in tropical countries as a first response vehicle in emergencies. But more scientific evidence is required about the practicality, operational challenges and impact on the quality of blood after transportation via drone," the ICMR study states. Understanding the operational challenges for the transportation of blood bags via drones is a vital step, the study says.

# New technology in Indian market, MRgFUS, offers non-surgical medical intervention for tremors

Dressed in a hospital gown 55-year-old Rohit Kumar (name changed) remembers the ice-cold, sterile, brightly lit Magnetic Resonance Imaging (MRI) room that he walked into early this year at Sir Ganga Ram Hospital, West Delhi, seeking treatment for his essential tremors that he has been struggling with for nearly half a decade now

Essential tremor (ET) is one of the most common neurological disorders affecting around 1% of the general population worldwide. The prevalence increases with age, with approximately 5% of individuals over the age of 60 experiencing it. Essential tremor can present several challenges, primarily due to the rhythmic shaking it causes, which can significantly impact daily life activities. While not life-threatening, the tremors can make simple tasks like writing, eating, and dressing difficult, leading to embarrassment, frustration and social isolation. In advanced stages, it can affect speech and swallowing. Mr. Kumar is among the three patients to have successfully undergone the relatively new Magnetic Resonance-guided Focused Ultrasound (MRgFUS) procedure for his essential tremors at Sir Ganga Ram Hospital, the first private hospital in North India offering the treatment.

This technology is currently available in select centres across the country including - Royal Care Super Speciality Hospital in Coimbatore (first to offer the technology), KIMS Hospitals (Telangana), and All India Institute of Medi-

cal Sciences, Delhi (first government hospital). An alternative to more invasive surgical procedures like deep brain stimulation (DBS), MRgFUS intervention is a non-surgical procedure that uses focused ultrasound waves guided by MRI to target brain tissue responsible for tremors in patients with Parkinson's disease or essential tremor. Currently approved for Essential Tremor (ET) and Tremor-Dominant Parkinson's Disease (TD-PD), this technique offers new hope for patients whose symptoms significantly disrupt daily life.

This one-time medical intervention costing ?19-23 lakh has on-table procedure duration of 1 to 3 hours, according to doctors at Sir Ganga Ram which started offering the treatment early this year. The procedure allows physicians to monitor the treatment in real-time, and adjust parameters for optimal safety and efficacy. "In simple terms we can see the tremors subsiding as the ultrasound disrupts the abnormal communication that the brain has been sending to the body affected body organs," said Anshu Rohatgi, vicechairperson, neurology, Sir Ganga Ram who has been doing these procedure at the health facility here. Speaking about this technique that has been available in America for over half-a-decade now he added that besides the real-time monitoring, the other benefits include -- no incisions, minimal to no anaesthesia to patients, rapid symptom relief, minimal recovery time (1-2 days) and, one-time treatment with no implants or batteries.





# Ravi Shastri tells Shubman Gill to be 'a little more proactive', reveals key to India bouncing back in 2nd Test vs England

(AP/file)The key to bouncing back from a Test defeat as crushing as the one India suffered at Headingley is to throw the counter-punch immediately, according to former head coach Ravi Shastri. Shubman Gill's Team India were well ahead of England going into the final day of the first Test but the visitors ended up chasing a record target of 371 with five wickets and most of the third session to spare.

India hence lost the match despite centuries from Gill,

KL Rahul, Yashasvi Jaiswal and Rishabh Pant, with the latter hitting one in each innings, and a five-wicket haul for Jasprit Bumrah in the first England essay. "The most important thing for India is to throw the counter punch almost immediately. When you lose a Test match like this where you have dominated most of it and then you lose it on the last day with a big chase and full marks to England for keeping their composure and doing that, it will need a lot of character to come to the fore and to bounce back in the series," Shastri told ICC Review.

While it remains to be seen whether Bumrah will play or not in the second Test, which starts on Wednesday, Shastri said that he hopes the fast bowler does as this match is very important in terms of the series. "Now, whether Bumrah plays or doesn't play, one doesn't know. But let's hope he does because this is a very important Test match and all is not lost. It's just you take it one game at a time. It's a five-match series and India will be hoping to bounce back." Shastri added. The first Test at Leeds was also Gill's maiden Test as a captain. Shastri said that while the 25-year-old made some mistakes, they were those that would be seen from a first-time captain. "People say he was a little reactive and it can happen when you're playing your first Test match (as captain) and especially in such good batting conditions with a fast outfield and things can happen in that way. But he would have learnt a lot from that and will want to be a little more proactive when it comes now, which means the bowlers and the fielders will have to give him that support. They have got to know what their role is and get out there and execute it." Shastri concluded.

It's been a long few days in the world of chess. The issue of cheating in the sport is back in the headlines with a former world champion accusing another grandmaster of being up to no good. Courts have been dragged in to adjudicate with one player suing the other for slander. Only, this time around, there's a twist: unlike the Magnus Carlsen vs Hans Niemann incident, where Niemann sued the former world champion for implying that he had cheated, this time around it's former world champion Vladimir Kramnik who is doing both, the accusing and the suing, after dragging grandmaster David Navara to court. This is the latest step taken by Kramnik in his infamous crusade to weed out cheating in online chess, a fight that the Russian seems to have dedicated significant mindspace to over the last couple of years. Kramnik posts data on his X account implying that there was something fishy in the way many grandmasters were competing in online games. It's a fight that has gained Kramnik no admirers, at least not publicly

The most recent grandmaster to try and coax Kramnik to see the light of reason is Levon Aronian, who's now posted three long emotion-laced posts on X aimed at a man who he calls his "chess parent", each post displaying the delicate tact a hostage negotiator would ideally employ."Volodya, my friend," Aronian exhorts in one of his posts on X aimed at Kramnik using the Slavic name for Vladimir. "Perhaps my letter will seem disrespectful and inappropriate to you. But my goal is one. Let's reduce the intensity of passions... You think you're saving chess from cheaters. But most of us see you as the guy with the hammer who thinks everything is a nail," Aronian says at one point.Over the course of his three posts, Aronian tries multiple tacts. Telling Kramnik that he's a great champion and amateurs do not deserve the attention he's given them in his YouTube breakdowns ("the king of beasts is engaged in catching mice"). Trying to convince Kramnik how much the world would benefit from an analysis of his own tactics from his world championship duels instead. Reminding the Russian how he was himself bullied by Veselin Topalov and his team, who accused Kramnik of being up to no good because he visited the toilet too many times (an incident known popularly as Toiletgate) during their World Championship battle in 2006. Trying to reason with him by saying that the sport is a family and kin cannot go around suing each other. And finally, telling him that no one who's close to him in the sport thinks what Kramnik is doing is "good and pure". (FIDE)"Chess world does not appreciate you enough... I feel the chess world and the new generation need to know about you... about who you are," Aronian writes at one point. "And I want you to remember it as well."There, Aronian praises the Russian for being the "biggest revolutionary when it comes to chess... who challenged every single dogma" in the sport.

That's precisely how chess fans of a certain vintage will remember the Russian. As the man who resuscitated the abandoned Berlin Defence at the 2000 World Champi-

### onship to nullify the attack of Kasparov so completely that the reigning world champion, with a voracious appetite for bulldozing through defences, ended with zero wins. He was the immovable object in front of Kasparov's unstoppable force of an attack. He could fluster Kasparov, the most intimidating man in the sport.Kramnik was built differently. When he first emerged on the global stage at the Manila Olympiad in 1992 rocking long hair, spectacles, a tucked in short-sleeved shirt, the tall Kramnik looked like a rockstar cosplaying as a laboratory assistant. If Kasparov, his predecessor on the world champion's throne, vroomed to a game in a Mercedes, Kramnik probably took the bus. He was always outspoken and an independent thinker, even if it meant rubbing people the wrong way. He was never quite taken in by the trappings that come along with being world champion. Like fame or money. What the world thought about him was also never a concern."For me, what I think of myself is more important than what society thinks. That may sound arrogant, but I have my own views and don't care about the views of the public," Kramnik told the editor of New In Chess magazine before he squared off against Kasparov in 2000. "My approach to chess is different. For most other chess players, chess is purely a sport, for me, it's more of a scientific activity."

It's this ability to stay unmoved by the world's perception of him that helped him retain his title against Topalov when the Bulgarian and his entourage tried to raise questions about his own integrity in the Toiletgate scandal.

It's also what's helping him stay on course with his current allegations of cheating in chess despite the rest of the world disagreeing with him.Before Topalov in 2006, it was the 2000 world championship battle against Kasparov that established Kramnik's place in history. Not just as Kasparov's nemesis or his antithesis. He was Kasparov's kryptonite, a man who would beat the Russian legend, who was actually his mentor at the Botvinnik-Kasparov School, and then shrug it off as no big deal. Unlike others, beating Kasparov was not an achievement for him."It has always surprised me when people get so hung up about a victory over Kasparov," he once told New in Chess when he was just 21, not even a world champion. "Then it seems as if it happened by accident. I don't believe I defeated Kasparov by accident. The idea that Kasparov is so exceptional is a myth created by journalists.'

In the same interview, Kramnik proceeded to go on multiple tirades. There was one rant about chess becoming too commercial. Then, another rant about how the chess players of his generation were playing "substandard" chess. At some point he says that he wasn't a good player, but other players were even worse. Now compare those comments to the ones he made about Gukesh and Ding Liren during last year's world championship, where he excoriated both players for their level of chess. Those criticisms earned him the wrath of the two most populous nations of the world. But for Kramnik, he was probably just measuring both players by the standards he set for himself in his playing days.A few years after that interview about chess becoming too commercial, he finds himself facing Kasparov in that 2000 World Championship where the prize fund is an eye-watering \$2 million. A 24-year-old Kramnik responds to that by declaring that he would have played for free.At another point in his career, when he played Peter Leko in 2004 for the title, Kramnik came under some criticism for playing out short draws. In an interview, it was put to him that the fans would have wanted to see more chess. It was then that he memorably exclaimed: "A painter never asks people what they want to see. He just paints." Even with his chess, as with his opinions and convictions, Kramnik was not playing to the gallery. He was playing chess as he deemed fit. The world may criticise him as a man with a hammer hell-bent on hitting every nail on its head. But there can be no reduction in the intensity of his passions.

With the ongoing Fifa Club World Cup witnessing extreme heat conditions, the global players' union has called for the need to extend the half-time breaks to 20 minutes. The Fifpro says the time has come for additional measures to be put in place to protect the players from the exhaustive conditions.

As of now, in tournaments held during the summer, Fifa protocols are in place to have a three-minute cooling break in each half to protect players from hot conditions. And Fifpro's medical director, Dr Vincent Gouttebarge, has said an extended half-time break would provide a necessary additional tool in helping to keep players' core temperatures within their normal range."A cooling break generally lasts three minutes and they are designed to decrease the [player's] temperature through the use of ice," he said. "But we are lacking the evidence in terms of what is the optimal duration for a cooling break. A half-time of 15 minutes might not be enough to decrease the core temperature. So a lot of research is being done into alternative mitigation strategies and it could be that a half-time of 20 minutes is significant. It has been shown [to work] in the laboratory. Together with the national [players'] union in Portugal, we are going to test this kind of mitigation strategy in August.

At the Club World Cup currently underway in the US, several players and coaches have spoken about the heat factor with the matches being played at 400C. With next year's Fifa World Cup also set to be played during the same period there are concerns about the players well being as the temperatures could be way higher than what it was in Qatar, which hosted the previous World Cup.Fifpro's general secretary, Alex Phillips, said the organisation had been engaging with Fifa over the issue during the past fortnight and that progress had been made. "We are partially happy because Fifa have been quite responsive once the tournament was under way. So they have actually modified how they have been dealing with heat during the matches based on Fifpro's input."Obviously, it would have been better if that

had happened in advance, but it's better that they have adapted and they've put in place various different mitigation measures. There's additional water around the pitch, towels and so on, and the threshold for the cooling breaks has come down. So there has been a positive reaction from Fifa, which is good. "But going forward, it's not just Fifa. It's any competition organiser staging tournaments in this kind of heat. Their protocols [need to] reflect more of the good practice in Australia, US and other countries that deal with this week after week in their national leagues."The MLS which takes in the US doesn't host any fixtures mid-day in Florida and similarly, Down Under in Australia, there are thresholds to delay or postpone the matches. Most of the compliant have come from European teams, which believe the heat conditions give an edge to South American teams. And Philips said European teams have to get used to the weather as football's packed calendar means there is action right through the 12 months. "I think the evolution we've seen in recent years is basically the football is played 12 months of the year," he said. "So winter, summer, European winter, we're going 12 months a year, unfortunately."

Fluminense manager Renato Gaucho stunned Inter Milan, by subverting their own strategy to defeat them and book a place in the Club World Cup quarter-finals. The Brazilian coach raved about his players and in particular, how they adapted to a rare three-centerback formation.

"We weren't used to playing that way, but over the last three days, I got it into my players' heads that it was possible. We respected the opponent, of course, but we showed everyone that we believed. We faced a top team with far more money than us, but once on the pitch, it's one versus one," Renato said, as reported by Brazilian newspaper O Globo. The 3-5-2 combination has a nice ironic twist to it as it's a staple of Inter Milan over the years. Antonio Conte famously employed it to win the 2020/21 Serie A title and his successor Simone Inzaghi also used it a lot to take Inter to champions league final in 2023.

By deploying three central defenders and a back five, Renato effectively shut down Inter's wing attacks. Ignacio and Freytes played vital roles in protecting Thiago Silva, who led the defensive line. The structure was further bolstered by Bernal's positioning as defensive midfielder. And the zone worked more effectively by Nonato at an advanced midfielder position, where he repeatedly pressed Inter's build-ups.Arias and Cano widened the attack at the wings, while Nonato pushed through the center creating constant pressure. And Inter Milan buckled.

The 3-5-2 tactical block has three centre backs, two wingbacks and three central midfielders and two forwards. The centre back provide a numerical advantage when defending and that extra protection allows the wingbacks to attack more without fretting about any defensive responsibility. It's not without risks though as explained by Athletic's Tifo: "Its weakness is space. Without the protection of the fullback, the wide centre backs can be exposed and without unusually athletic and skilful defenders, it becomes unstable."The coach Renato highlighted the group's mentality: "My team gave everything. They stayed focused, dedicated. This group deserves all the credit. And our fans too-what a celebration. People all over Brazil should enjoy this. We're among the final eight, and many didn't believe we could make it."Renato also talked about the disparity between clubs from different continents: "Brazilian football is showing its strength. European clubs have more money and can sign the best players, but on the field, what counts is attitude and commitment. That's what my team showed today."

Ace casting director Tess Joseph first worked with Aamir Khan on AR Murugadoss' 2008 blockbuster action thriller Ghajini, in the capacity of an Assistant Director. Even in a potboiler like that, Tess remembers Aamir as an explorer. But the actor had the deepest impact on her a year prior to that when he turned director with the coming-of-age classic Taare Zameen Par in 2007."I watched Taare Zameen Par when I moved away from home for the first time. It answered a lot of questions for me. It connected me back to home and family in ways that were special," recalls Joseph, explaining that the film's influence went even deeper. "I'm slightly dyslexic. I keep flipping numbers and letters, so it was deeply personal for me," she reveals.Little did Tess know that over a decade later, she'd be roped in as the casting director on RS Prasanna's coming-of-age sports comedy Sitaare Zameen Par, the spiritual sequel to Taare Zameen Par, also starring Aamir. In an exclusive interview with SCREEN, she opens up on casting the titular, neurodivergent Sitaare for the film, working with Aamir, and how the success of this film could open more doors for the community. The casting process of Sitaare Zameen Par was quite long. How did you navigate that? When Prasanna, Aamir, me, and the whole team came together, there was one thing that was really aligned: the intention. When that happens, passion and patience take over. You can have a casting process that's long, layered, and led with love. If there was really auditioning, it was us. We were being auditioned by all the parents. After we did the workshops, the parents came to us and said, "Now, we trust you. Now, we see our kids blossoming." So we didn't really build a cast, we built trust.

What was the common trait that you ware looking for



and authenticity. These should become non-negotiables. Workshopping before we test someone, especially when a community hasn't had access to learning a craft, that's truly elevating for equity rather than equality. You put people at the same level-playing field before you make them play.

Dolly Ahulwalia and Brijendra Kala made for such a lovely pair in the film. How did you cast them?

Aren't they amazing? And aren't they an unlikely couple to see on screen? When you look at them, they should look like a couple you wouldn't traditionally see. I love how 'Sabka Apna Apna Normal' is explored through all these different characters. We were involved in the casting early on. But I have to tip my hat off to Anmol Ahuja and Casting Bay as we passed on the baton to them and they did such an amazing job that you feel like this is what collaboration should look like. From finding Ashish (Sunil), the one missing piece in the Sitaare, to help cast the secondary and tertiary characters, that's all Anmol, Aamir, and Prasanna working together.Like Kareena Kapoor did in Aamir's Laal Singh Chaddha (2022), Genelia D'Souza also auditioned for her part in Sitaare Zameen Par. Do you think this is a health trend of testing even the established actors for leading parts? Aamir loves auditioning! This is the truth. He's always game. This really levels the playing field because this isn't about hierarchy, but harmony and chemistry. Aamir really believes in the story. When he invites established actors to audition, it gives out a very clear message: we're all here to serve the story best. He's very happy to do long auditions. It's a treat also to see someone talk about how he auditions for every film.Many of Aamir's films have boasted of great child actors, from Darsheel Safary in Taare Zameen Par to Zaira Wasim in Dangal (2016) and Secret Superstar (2017).

# When Shefali Jariwala recalled false rumours about her death after Kaanta Laga released: 'People said her brother killed her, she got cancer'

Kaanta Laga girl Shefali Jariwala's sudden death has sent shockwaves in the entire entertainment industry. The actor passed away due to cardiac arrest at the age of 42. Around a year ago, Shefali had opened up about a false rumour of her demise and cancer diagnosis that did rounds when Kaanta Laga released. The iconic 2002 song also led to misinformation that her brother had murdered her. In Paras Chhabra's podcast Abraa Ka Dabra Show on YouTube a year ago, Shefali had revealed how that personal trolling affected her back then.She shared, "I am thick skinned now. I have been in the industry for 20 years now, jo trolling meri Kaanta Laga ke waqt hui thi na. There wasn't social media, that was the real trolling. Back in the days, personal trolling hoti thi. How do you escape that?"

Kaanta Laga was considered way ahead of its time and Shefali Jariwala was a soft target for many people, even her relatives. "When I did that song, it was considered bold. I have seen times when my own relatives said, 'Yeh kya kardia ladki ne, naam kharaab kardiya'. There were rumours that said 'Shefali ke bhai ne usko maar daala'. I don't even have a brother. That was actually trolling. Faceless trolling on social media that happens now doesn't matter to me. Chandigarh mein baitha hua Chintu kya bolta hai, I don't care," she said. Recalling the insensitive rumours, the actor added, "Tattoo kia isne, isko cancer hogaya and yeh marrgayi. It was a national news at that time. News channels had called me. Back then there wasn't no social media, tab ki fan following kuch aur hi hoti thi. Information spreads quickly now. in each Sitaara?

We started with an open call for any young, enthusiastic person from the neurodivergent community to send us something that they love performing on. Simran, who plays Golu Khan, sent us her performing the 'Ek Chutki Sindhoor' monologue (from the 2007 film Om Shanti Om), Aroush (who plays Satbir) sent us a double character Bollywood scene, Rishabh and Vedant (Raju and Bantu respectively) sent us videos of them dancing, and Rishi (Sharmaji) sent us a mime of playing the keyboard. What started as a trickle went on to become a waterfall of tapes, thousands from across the country.We were looking for a spark or a personality. We weren't looking for a character, but just presence. Each actor who came in brought something real and rooted. What united all of them was the joy to perform and try different things. We knew this was a physical film so we needed a certain kind of physicality. But we were never worried about communication because we knew we'd find a way. Their personalities, even their phrases, who they inherently are, have made it to the final cut.

While casting the Sitaare, where all did you look for?

We wrote to institutes, therapists, schools, colleges, and ADAPT (Able Disabled All People Together) across metros and small towns. We also reached out to @bubble.ds, which is a page on Instagram. It was never about geography, but about visibility. So if there was a child in Kerala, Assam, Bihar or Delhi who wanted to be seen, we had to find a way to see them. Gopi (Guddu) is from Kerala, Naman (Hargovind) is from Delhi, and Rishabh is from Bengaluru. It's a cast that truly represents the country.

How involved was Aamir in the casting process?

Aamir was a part of everything. I love how engaged he was. Most production companies won't bring a shortlist down to Mumbai. Here's one that brought in more than who was required to the city so we could do workshops and learn together. He was not only involved, but also present and respectful. He did workshops, saw audition tapes, and gave feedback. What remained the most with me was his trust. He never imposed himself. It's very rare for someone of his stature to say with so much courage, "Go ahead and cast this authentically, I'm here."

When I watched this film, you realize what representation can do. It's not just the Sitaare, but all the kids on screen — whether it's the Nanhe Khiladi, every match, every team — they're all neurodivergent actors. This is when representation isn't a checklist, but a responsibility. I do believe it'll open doors. I'm hopeful, but also watchful because hope has to be followed by habit. We have an audience that's ready, but the question is, are we ready to tell more stories like this? I see Prasanna and Aamir as lighthouses who'll really show the way. Sitaare Zameen Par shouldn't be an exception, but the start of a new standard. When we do something, we should do it with care, time,

Artists go through phases in life and when I started with Breathe, then Ludo, Bob, Be Happy, I Wanna Talk, Kaalidhar Laapata - I understood that paternal emotion in those because I was also witnessing and experiencing that in my real life. I don't know if Aaradhya wasn't around whether I'd still be experiencing those emotions or feel them as acutely. They also happened because that relationship spoke to me because I used to experience that with her.""When Hope, I can call him (Amitabh) my fan," Abhishek said as he discussed the praise that he sees his father write on social media about his films and performances. Speaking about Big B, he said, "I think he's an overzealous, emotional father right now, and that's the one thing I love about him. You know, in the initial parts of my career? We never expressed all that. I think he used to feel scared that 'I don't look like you know ... '. He is doing a lot of it now. You can't blame him, he is 83."He added, "Most people forget that apart from being the great Amitabh Bachchan, he is also a father." Admitting that he feels embarrassed seeing his father write words of praise for him on social media, he said,
