Congress to govern Telangana until 2034: CM Revanth



Hyderabad, GNS News Agency, july 14 Chief Minister Revanth Reddy has exuded confidence that the Congress party will govern Telangana until 2034, ensuring its flag remains prominent throughout the State. He highlighted that the State government is implementing a 42 percent reservation for Backward Classes (BCs) in local body elections and is taking measures to empower these communities.Revanth Reddy officially began the distribution of new ration cards at the Thirumalagiri mandal headquarters in the Thungaturthi Assembly constituency of Suryapet district on Monday. During a subsequent public meeting, the Chief Minister criticised the previous BRS government for not issuing a single ration card in its decade-long tenure. He expressed his anger over their failure to consider providing even a small quantity of rice to those in need.

He sarcastically said that ration shops were not opened during the BRS regime, but belt shops were opened. Revanth Reddy accused opposition parties of attempting to hinder the State government for not providing high-quality rice to the poor through ration shops.He clarified that the State government has issued ration cards to 5.6 lakh new individuals, and the names of 26 lakh new beneficiaries have been added to the ration card registry. During his visit, the Chief Minister also initiated several development projects and inaugurated works valued at Rs. 34.20 crore in the Thungaturthi Assembly constituency.

SC issues notice to Jharkhand HC over long-pending verdict after 10 convicts file petition

New Delhi/Ranchi: The Supreme Court on Monday issued a notice to the Jharkhand High Court while hearing a petition filed by 10 convicts, including six on death row, who alleged inordinate delay in the pronouncement of judgment on their appeals. The petitioners had approached the Jharkhand High Court between 2018 and 2019, challenging their convictions by a lower court. Despite the completion of hearings in 2022-23, the High Court has yet to deliver its verdict, which prompted the convicts to move apex court.Out of the 10 petitioners, six were sentenced to death and the remaining four to life imprisonment. Nine of them are currently lodged in Birsa Munda Central Jail in Hotwar, Ranchi, while one has recently been released on bail from Dumka jail.A bench comprising Justice Suryakant and Justice Joymalya Bagchi observed that the judge who reserved judgment in all these appeals is the same in each case, raising questions about the prolonged delay.

Appearing for the petitioners, advocate Fauzia Shakil argued that withholding a verdict for years after hearings are concluded constitutes a violation of Article 21 of the Constitution, which guarantees the right to life and personal liberty, including the right to speedy justice.Shakil



highlighted the mental anguish faced by the convicts due to the delay, especially those awaiting execution. She cited the Supreme Court's ruling in HPA International vs Bhagwandas, where the court expressed concern over the practice of reserving judgments indefinitely. The petition also referred to the Jharkhand High Court Rules (2001), which mandate that judgments must be delivered within six weeks of the conclusion of arguments. Further, citing previous Supreme Court rulings related to sentence suspension, the advocate pointed out that convicts who have already served eight years of actual sentence are, in most cases, eligible for bail.

Centre calls meeting of Telangana, Andhra CMs on river water disputes

Hyderabad: The Centre has called a meeting of the chief ministers of Telangana and Andhra Pradesh in Delhi on July 16 over river water sharing disputes. The Centre has invited Telangana Chief Minister A. Revanth Reddy and his Andhra Pradesh counterpart, N. Chandrababu Naidu, to meet in the presence of Union Jal Shakti Minister C. R. Patil. The Union Minister has asked both the chief ministers to communicate their availability for the meeting. Andhra Pradesh Chief Minister is visiting Delhi on July 15 and 16. As per the itinerary, he is scheduled to meet C. R. Patil at 2.30 p.m. on July 16. Meanwhile, a statement from the Telangana Chief Minister's Office said a meeting is scheduled with the Union Jal Shakti Minister in Delhi on the 16th of this month, where Telangana will strongly pursue its water share, seek approvals for ongo-

ing projects, push for allocations, and demand clearances for new projects.According to the statement, Revanth Reddy has decided to ensure the optimal utilisation of every drop of water due to the state from the Krishna and Godavari rivers and to intensify pressure on the Central Government to secure Telangana's rightful share of river waters through legal means. He has resolved to urge the Central Government to immediately grant clearances for projects in Telangana on the Krishna River, allocate Telangana's fair share of water, and provide financial assistance for the construction of these projects. Along with protecting Telangana's interests in the Krishna and Godavari waters, the Chief Minister has directed that longstanding injustices be addressed through permanent solutions.On the Chief Minister's instructions. Irrigation Minister Uttam Kumar Reddy has written a letter to Union Jal Shakti Minister C R Patil. Telangana has faced prolonged injustice in the utilisation of Krishna River waters. The previous government accepted a mere 299 TMCs for Telangana, while conceding 512 TMCs to Andhra Pradesh. It remained silent while Andhra Pradesh illegally constructed projects upstream of Srisailam, diverted Krishna waters at will, and encroached on Telangana's rightful share, said the statement.Irrigation projects constructed during the undivided state on the Krishna River were left incomplete, without proper water allocations. On the Godavari side, the Pranahita-Chevella project undertaken near Tummidihatti, after spending Rs 11,000 crore, was shelved. Instead, the Kaleshwaram Project was constructed, leading to the misuse of over Rs 1 lakh crore of public funds, it added.

India can deliver 70% round-the-clock clean electricity by 2030 at lower cost, says TransitionZero report

India can achieve 70% round-the-clock (RTC) clean electricity for commercial and industrial (C&I) consumers by the year 2030 - at a lower cost than traditional annual clean energy procurement - according to a new report released by TransitionZero, a global climate analytics non-profit. The report finds that India can deploy 52 GW (gigawatt) of RTC clean electricity capacity to serve 5% of its projected national demand by 2030, generating cost savings of up to ?9,000 crore (\$1 billion) annually for the grid. Unlike conventional renewable energy certificates that allow annual offsetting of electricity use, RTC clean energy matches every hour of consumption with power from zero-carbon sources such as solar, wind, and battery storage.Irfan Mohamed, South Asia Analyst at TransitionZero, said, "Our model shows that in India, commercial and industrial customers can meet 70% of their hourly electricity demand with carbon-free electricity at a

cost below that of annual renewable energy matching, while driving greater levels of decarbonisation and providing significant benefits to the Indian electricity system."

At the system level, the report shows RTC clean energy could cut emissions by 2.4% under the 70% matching scenario — more than double the 1% emissions reduction achieved under annual matching. When scaled to 100% RTC matching, the potential emissions reduction rises to 7%.Notably, the cost of carbon abatement under the RTC model is significantly lower. The analysis reveals that achieving carbon reductions through 70% RTC clean electricity costs nearly three times less than doing so via annual matching. "RTC clean electricity — also referred to as 24/7 carbon-free energy (CFE) — means matching every hour of electricity use with electricity from carbon-free sources. It ensures clean power is actually available when it is needed, all day, every day, instead of buying annual clean energy certificates. Department. Besides, all colleges across the State were directed to form an internal committee within 24 hours as per the Sexual Harassment of Women at Workplace Act, 2013. The series of actions followed Odisha Governor Hari Babu Kambhampati's direction to authorities to protect the dignity and mental well-being of students and prevent recurrence of such incidents. Shriram has been transferred to the Rajasthan High Court, while Rajasthan High Court Chief Justice, Manindra Mohan Shrivastava will now be the Chief Justice of the Madras High Court.

Also, the Chief Justice of Jharkhand High Court, M.S. Ramachandra Rao, has been made the Chief Justice of Tripura High Court, and the Tripura High Court Chief Justice, Aparesh Kumar Singh, will now be the Chief Justice of the Telangana High Court.As for new appointments, Justice Sanjeev Sachdeva has been appointed as the Chief Justice of Madhya Pradesh High Court, while Justice Tarlok Singh Chauhan will now head the Jharkhand High Court. Justice Vibhu Bakhru has been named the Chief Justice of Karnataka High Court, Justice Ashutosh Kumar as the Chief Justice of Gauhati High Court and Justice Vipul Manubhai Pancholi as the Chief Justice of Patna High Court. These transfers and appointments were recommended by the Supreme Court Collegium headed by Chief Justice of India B.R. Gavai. Meanwhile, the government also transferred Justice Anil Kshetarpal from the Punjab and Haryana High Court to the Delhi High Court, while Justice Suman Shyam has been moved from the Gauhati High Court to the Bombay High Court.

Final report of AI plane crash should be definitive

The preliminary report of the Aircraft Accident Invesigation Bureau (AAIB) probing the Air India flight 171 crash as answered only a few of the many questions. The obectivity and credibility of the report is already being quesioned, thereby casting a shadow over what should have een an impartial and transparent investigation into one of ndia's worst aviation accidents in recent years. The AAIB has clearly stated that information in the report is "prelimiary and subject to change," and this disclaimer is cruial. It reflects the nature of aviation accident investigaions, which often require months of meticulous data gath ring, expert analysis, and testing before definitive conlusions can be drawn. Nevertheless, given the high pubic interest and the gravity of the crash, many had hoped hat the preliminary report would at least offer a coherent arrative of what could have happened in the cockpit in he moments leading up to the disaster. One of the most significant findings in the report is the observation that both ngine fuel cutoff switches "transitioned from run to cutoff osition one after another with a time gap of one second.

This is a vital piece of evidence, as it essentially indicates that both engines stopped receiving fuel in rapid succession, leading to a total loss of thrust. However, the eport stops short of explaining why this happened. Did he transition occur due to manual pilot input or a mechanical failure? This critical question remains unanswered, eaving a major gap in understanding the sequence of events that led to the crash. The report rules out a range of common contributing factors such as adverse weather conditions, bird strikes, incorrect aircraft configuration, contaminated fuel, and pre-existing issues with the engines that were known earlier on.

Actions for Optimal Utilization of Krishna River Water – Bhatti & Ponguleti."





"Khammam, July 14, Indian Chronicle.""Deputy Chief Minister Bhatti Vikramarka Mallu and Minister Ponguleti Srinivasa Reddy emphasized that the Telangana people's government is taking strong measures to ensure the abundant and effective use of Krishna river water. On Monday, during a visit to Kusumanchi mandal along with District Collector Anudeep Durishetty and Khammam Police Commissioner Sunil Dutt, they released irrigation water for the Kharif season from the Palair Reservoir via the Nagarjuna Sagar Left Canal (Lal Bahadur Canal). Bhatti Vikramarka stated that water is being released today from Nagarjuna Sagar Zone 2 to the ayacut of the Palair Reservoir. He stressed that the government is committed to supporting agriculture, electricity and various multipurpose projects. He criticized the previous BRS government's irrational decisions, claiming they caused significant losses and promised to fight for Telangana's rightful share in the Krishna and Godavari rivers and complete pending projects. He further alleged that the past government ignored repeated warnings that construction in Ravalaseema near the Srisailam Project would negatively affect Zones 1 and 2 of Nagarjuna Sagar. Moreover, he accused the Andhra Pradesh government of constructing storage projects to



draw 11 TMC (thousand million cubic feet) of water daily from Srisailam with the support of the former Telangana administration. Since coming to power, the current government has been correcting past errors and progressing with key initiatives. These include completing pending projects on the Krishna River such as Kalwakurthy, Nettempadu, Bhima, Koilsagar and Palamuru-Rangareddy SLBC. They also announced the construction of the new Narayanpet-Kodangal project to maximize Krishna river water utilization. He mentioned that due to last year's heavy floods, the Nagarjuna Sagar Left Main Canal's under-tunnel (UT) at Palair was damaged. It has now been restored through emergency repairs costing 14.2 crore. Alongside providing irrigation water, the government has released 9,000 crore in investment support to farmers in 9 days, waived 21,000 crore in loans for 25 lakh farmers, given 17,500 crore in power subsidies for 29 lakh agricultural pump sets over 18 months and provided a bonus of 500 per guintal for fine rice, in addition to implementing farmer insurance. Bhatti highlighted that these welfare initiatives have significantly increased food grain production in the state, making Telangana a food and seed granary. He reiterated the government's focus on developing the agriculture sector, which supports 65% of the population. Despite financial challenges, they are fulfilling promises to farmers, including completing farm loan waivers in a single phase and raising the investment assistance from 10,000 (given by the previous government) to 12,000, disbursed within 9 days. Finally, he emphasized the government's support for paddy cultivation by offering MSP and a bonus of 500 per quintal. The event also saw participation from Telangana Warehousing Corporation Chairman Rayala Nageswara Rao, Irrigation SE M Venkateshwarlu, R&B SE Yakub, Khammam RDO Narasimha Rao, Palair constituency special officer Ramesh, officials from various departments and local public representatives.

Veteran actress B Saroja Devi passes away at 87

Hyderabad, July 14 :Indian cinema legend B. Saroja Devi passed away on Monday at the age of 87. She had been facing health issues related to aging for some time and died while receiving treatment at Manipal Hospital in Yeshwantpur, Bengaluru. Born on January 7, 1938, Saroja Devi acted in approximately 200 films over a span of seven decades across Tamil, Kannada, Telugu, and Hindi cinema. She was one of the most celebrated actresses in the history of Indian cinema. Recognised as the first female superstar of Kannada cinema, Saroja Devi made her significant debut at the age of 17 in the Kannada film Mahakavi Kalidasa (1955). She entered Telugu cinema with Panduranga Mahatyam (1957) and had a series of hit films until the late 1970s. Her role in the Tamil movie Nadodi Mannan (1958) established her as a leading actress in Tamil cinema. Following her marriage in 1967, she remained the second most sought-after actress in Tamil cinema until 1974. However, she was consistently among the leading actresses in Telugu and Kannada films from 1958 through the 1980s. Saroja Devi was also active in Hindi films until

around the mid-1960s, beginning with Paigham (1959). In Telugu cinema, she found great success, appearing alongside N. T. Rama Rao in notable films such as Seetarama Kalyanam (1961), Jagadeka Veeruni Katha (1961), and Daagudu Moothalu (1964), in addition to Amara Shilpi Jakkanna (1964), which was a remake of a Kannada film. Her collaboration with Akkineni Nageswara Rao in Pelli Kaanuka (1960) was also well-received. The first Telugu film to utilise dubbing was Panduranga Maharyam (1957), where Krishna Kumari provided her voice. However, in the vears that followed. Saroia Devi learned to speak Telugu herself. Remarkably, she holds the record as the only Indian actress to star as the lead heroine in 161 consecutive films over a span of 29 years, from 1955 to 1984. The actress was honored with the Padma Sri, which is the fourth highest civilian award, in 1969, and later received the Padma Bhushan, the third highest civilian distinction, in 1992 from the Union government. Saroja Devi made her final appearance on the silver screen in 2019 in the Kannada movie Nata Sarvabhouma, featuring Puneeth Rajkumar.

Convicted for murdering her father, Telangana HC asks petitioner to pursue LLB from prison

Father murdered by daughter, Telangana High court, LLB student, HyderabadThe senior counsel sought a directive from the court to the college, which was denied by the bench, stating that it could not interfere with the rules of the college. (Source: tshc.gov.in)The Telangana High Court Friday allowed a 23-year-old woman, convicted and currently lodged in Cherlapally Central Prison, to pursue her second-semester LLB course from within the prison using available technologies.The division bench of Justice Moushumi Bhattacharya and Justice B R Madhusudhan Rao was hearing a prayer seeking direction to the authorities of Dr VRK college of Law in Mehdipatnam, Hyderabad, to receive examination fee and examination application form of the petitioner relating to second semester and also to write second semester examination of LLB course scheduled to be held this month.P Prabhakar Rao, the senior counsel appearing for the petitioner, informed the court that the college was not willing to collect the examination fee as well as the examination application form, citing the requirements for physically attending the classes and a mandatory 60 percent attendance.

The senior counsel sought a directive from the court to the college, which was denied by the bench, stating that it could not interfere with the rules of the college. The original application for bail for one month for the petitioner to appear for the exams was also denied by the court. The senior counsel, thereafter, referred to a Kerala High Court judgment permitting an appellant to undergo online classes from prison. Responding to this, the bench said, "Needless to say, there can't be an embargo, in law or equity, from preventing the appellant to pursue her LLB course from inside the prison precincts, the appellant would certainly be entitled to pursue, in coordination with the college authorities.""The appellant still wants to appear for physical classes and our petition for bail is posted for July 28. For now, the court has directed us to find out if the necessary infrastructure for permitting online classes for the petitioner is available in the prison as well as the college," the senior counsel said, when contacted. The appellant, Priyanka Sula, and her siblings Medipalli Tharun, 28, and Anjali Sula, 29, have been lodged in Cherlapally Central Prison since August 2024 after the court convicted them of the murder of their father and sentenced them to life imprisonment.

Woman found dead in central Noida; man she was in relationship with arrested

Two days after a 37-year-old woman was found murdered in her house in central Noida, the police said on Saturday that she was allegedly killed by the man she was in a relationship with. The accused was arrested after he was injured in a shootout with the police.Shabnam, who hailed from Luharli village in Gautam Buddh Nagar's Dadri, was found dead at her house, with her throat slit, in Haibatpur village in central Noida. Following a complaint from her son, the police registered an FIR under Section 103(1) (murder) of the Bharatiya Nyaya Sanhita (BNS) at Ecotech-3 police station. Ajay Kumar Singh, Station House Officer of Ecotech-3 police station, said Shabnam was killed by her partner, Mukeem, as he did not wish to continue their relationship. "Shabnam had been staying away from her husband Shabuddin, for the last eight years. Shabuddin and Mukeem were relatives, and after their separation, a romantic relationship developed between Mukeem and her," Singh said.According to Singh, as Mukeem's children grew older, they objected to his relationship with Shabnam and pressured him to leave her. "He works as a carpenter and got a contract for a house in the Nirman Vihar colony nearly 15 days ago. Muneem had also rented a room nearby and called Shabnam to meet on Thursday," said Singh.After Shabnam reached Mukeem's rented room on Thursday, he brought noodles for her, the police said. "Initially he had planned to shoot her but he feared that the noise from firing would alert the neighbours and therefore he slit her throat and left after locking the room from outside. Later during the night, we received a call from a neighbour after he suspected that what he saw from his window appeared to be a



dead body of a woman," Singh said.

Two police teams were deployed to crack the case, Shakti Mohan Avasthy, Deputy Commissioner of Police (DCP), Central Noida, said, adding that Mukeem was arrested after a brief encounter between the police on Saturday morning."The police team of the Ecotech-3 police station was checking near Chauganpur roundabout when they saw a man on a motorcycle and signalled him to stop. Instead, he turned his motorcycle around. The police team took immediate action and chased him. To escape, he left his motorcycle behind and tried to jump into an empty courtyard. But the police surrounded him. To escape, he fired at the police team. The police retaliated and he was injured," DCP Avasthy said. During interrogation, Mukeem allegedly revealed that he was a resident of Dadri and had been in a relationship with Shabnam for over eight years. His wife and children were opposed to this, he allegedly said, adding that this was the reason why he murdered her.

The Vigilance and Anti-Corruption Bureau of Haryana on Thursday arrested Dr Jai Bhagwan, Chief Medical Officer (CMO) of Palwal, for allegedly accepting a bribe of Rs 1 lakh.The Gurgaon unit of the Vigilance department also recovered an additional Rs 3 lakh in cash from a cupboard at the doctor's official residence in Palwal during a raid.

Dr Bhagwan has been booked under Section 7 of the Prevention of Corruption Act and Section 308(2) of the Bharatiya Nyaya Sanhita (BNS) that deals with punishment for extortion, at the State Vigilance and Anti-Corruption Bureau Police Station in Faridabad. According to the complainant who runs Sunrise Trauma Hospital in Palwal along with three others, Dr Bhagwan had been threatening to shut down their hospital, citing operational deficiencies. The CMO allegedly demanded Rs 15 lakh to allow the hospital to continue functioning, claiming he needed to pay off other officials. The complainant stated that he had already paid Rs 6 lakh about 20 days ago and an additional Rs 1 lakh on Wednesday.Dr Bhagwan then demanded the remaining Rs 8 lakh, of which the complainant arranged Rs 1 lakh for payment Thursday night, leading to the sting operation by the Vigilance Bureau. The Vigilance department has urged the public to report bribe demands by government officials to the toll-free numbers 1800-180-2022 or 1064 for prompt action.In January, the Haryana Anti-Corruption Bureau (ACB) had recovered Rs 3.65 crore and gold worth Rs 6.5 lakh from the residence of a retired Haryana Development and Panchayat department official. The recovery came after the ACB conducted a raid at the Panchkula residence of the official in connection with a scam worth Rs 50 crore and arrested the accused, identified as Shamsher Singh, who had retired on November 30 last year.ACB officials had said that currency notes were found in a bed and almirahs at Shamsher's house at Panchkula Sector 28. The ACB had registered a case on January 24 this year against junior officials of Haryana Development and Panchayat department posted in Faridabad apart from a outsourcing services firm. An audit report of Comptroller of Auditor General (CAG) had earlier found that funds were disbursed to the Palwal District Development and Panchayat Officer for the financial years 2023-24 and 2024-25 without approval of Chief Accounts Officer of the panchayat department.

Takht Patna Sahib declares Sukhbir Badal 'Tankhayia' for defying summons

"This action has been taken in view of the events that began on May 21, 2025, when unauthorised and unconstitutional interference was carried out by the Jathedars of Akal Takht and Takht Sri Damdama Sahib, challenging the established norms, constitution, and authority of Takht Patna Sahib," Takht Patna Sahib Jathedar Giani Baldev Singh said, announcing the decision."Sukhbir Badal was involved in influencing and interfering with the affairs of Takht Patna Sahib, particularly during a series of controversial decisions and actions surrounding the status of ex-Patna Sahib Jathedar Giani Ranjit Singh Gohar. Badal was given two opportunities to appear and present his position, but he failed to do so," Baldev Singh said. "Even after an extension of 20 days-reportedly granted at the request of Shiromani Gurdwara Parbandhak Committee (SGPC) president Harjinder Singh Dhami-Badal did not comply," he added.

"By repeatedly ignoring the summons and undermining the authority of Takht Patna Sahib, Sukhbir Singh Badal has violated the religious code. As a result, he is hereby declared Tankhayia," Baldev Singh said. In August 2024, the Akal Takht Sahib had passed a similar verdict against Badal. Then Jathedar Giani Raghbir Singh had said that Badal had harmed Sikh interests through decisions taken during his 2007–2017 tenure as deputy chief minister. "Until he seeks forgiveness before Guru Granth Sahib in humility, the Tankhayia status shall remain," the Singh Sahibs had said. In December 2024, the Akal Takht hosted a gathering of the five Singh Sahibs to revisit Badal's previous 'tankhah', the punishment for violating the Sikh religious code.



issues, not to create crises within the community. "Under mining the supremacy of Sri Akal Takht Sahib is inappropriate, and such actions could lead to internal discord within the Sikh community," he added.While Takht Sri Patna Sahib holds great respect within the Sikh world, the authority to deliberate on Panthic matters lies solely with Sri Akal Takht Sahib, Dhami said. He further said that there is a longstanding historical tradition of Panthic issues being addressed jointly by the five Singh Sahibs under the leadership of Sri Akal Takht Sahib."It is this very tradition that has uplifted the Sikh community on the global stage," he said, warning that if the supremacy of Sri Akal Takht Sahib starts being challenged by other Takhts, it would severely damage the essence and richness of Sikh traditions. He stressed that, especially in the current matter, the way forward must be through mutual dialogue, so that instead of visible conflict within the community, Sikh strength can be directed towards community interests, the prosperity of the Panth, and the promotion of Sikh values. The present dispute stems from a controversial May 21 decision by the Punjab-based Takhts—Akal Takht, Takht Damdama Sahib, and Takht Keshgarh Sahib-to lift the excommunication of Giani Ranjit Singh Gohar and simultaneously impose sanctions on the current Patna Sahib Jathedar Giani Baldev Singh and priest Gurdial Singh. In response, Takht Patna Sahib retaliated by declaring both Giani Kuldeep Singh Gargaj (acting Jathedar of Akal Takht) and Giani Tek Singh Dhanaula (Takht Damdama Sahib) as 'Tankhayia'. The Takht also summoned Sukhbir Singh Badal, alleging that he played a role in orchestrating the interventions against Patna Sahib's authority.With Badal's continued absence, Saturday's announcement marks a formal escalation in the clash between Sikh religious authorities and political figures, underscoring ongoing tensions between various Takhts and the political leadership of SAD.

Bangalore South MP Tejasvi Surya along with Bangalore Central MP P C Mohan and other BJP MLAs held a citizens' protest rallyBangalore South MP Tejasvi Surya along with Bangalore Central MP P C Mohan and other BJP MLAs held a citizens' protest rallyAmid growing demand to open the Yellow Line of the Bengaluru Metro connecting RV Road and Bommasandra via Electronic City, Maheshwar Rao, the managing director of the Bengaluru Metro Rail Corporation Limited (BMRCL) has assured that the agency is targeting to commission the stretch by August 15.

This comes after Bangalore South MP Tejasvi Surya along with Bangalore Central MP P C Mohan and other BJP MLAs held a citizens' protest rally under the slogan "Yellow Line na open maadi (Open Yellow Line)" at Lalbagh Main Gate on Saturday, urging BMRCL to commission the muchawaited stretch. Additionally, Surya also demanded that the metro rail corporation make public the fare fixation report, which had recommended over 100 per cent hike in Metro fares, triggering public ire.Addressing the gathering at the protest site, Rao said, "Currently, we have three trains, with the third train having arrived last month. Since these are automated train operating systems, an independent safety assessment test is underway which will check the safety controls of these driverless trains. We are expecting the report by July 7."

He added, "Once the report is submitted within next week, we will request regulatory clearance and approvals from CMRS (Commissioner of Metro Rail Safety). The entire regulatory process and necessary approvals will need at least a month's time. Therefore, tentatively, we are targeting to operationalise the stretch by August 15."Rao also stated that due to insufficient train supply, BMRCL is likely to operationalise the stretch using only three trains with a headway of 20 minutes. "The trains will stop at only five to six stations. We will study the ridership patterns, including demand for services, till Bommasandra and streamline the operations accordingly. We are expecting two trains every month from the Titagarh Rail System starting August," he said.

Meanwhile, Rao stated that finalisation of loans for Phase 3 of the Bengaluru Metro is expected by March 2026. Phase 3, which includes two elevated corridors spanning 44.65 km with 31 stations, is estimated to cost Rs 15,611 crore. Japan International Cooperation Agency (JICA) is likely to provide a significant loan, with approximately Rs 7,577 crore (60%) expected to be sourced from it. Rao said that pre-preparatory works will be done by September and tenders will be floated by October, subject to JICA approvals.Slamming the BMRCL in connection with the lack of transparency over the fare fixation report (FFR), Tejasvi Surya said, "Metro and bus services are the two most crucial modes of public transport. Recently, BMRCL hiked Metro fares by up to 100%. Before announcing the revision, a committee had gone on an international tour and submitted a report, based on which fares were increased by as much as 130%. Since the hike, Metro ridership has



dropped by nearly 1 lakh commuters every day."He added, "Several journalists and activists have filed RTI applications seeking details of the report. However, even after three months, the report has not been made public. What is the BMRCL trying to hide? FFR is no national secret that publishing it would help India's enemies." The BMRCL MD said he will respond to Surya in this regard through a letter.Meanwhile, on the status of the Hebbal–Sarjapur Metro corridor, Rao said, "The government of India has asked us to rework the cost. An independent agency has been engaged to explore whether the cost can be brought down. The MP raised concerns about the proposed tunnel road on the same alignment. We will look into it."

500 kg peacock feathers seized from Pune's Somwar Peth, 11 UP natives detained

The Maharashtra Forest Department on Friday detained 11 Uttar Pradesh natives at Pune's Somwar Peth for illegally storing peacock feathers for sale. The officials have seized around 500 kg of feathers from their possession. The forest department stated that plucking, storing, trading, or purchasing peacock feathers are illegal.

"These feathers are often used blindly for religious purposes or home decoration, which threatens the very existence of peacocks," the forest department said in a statement. The police have booked the accused under the Wildlife Protection Act, 1972. "We received a tip-off that large quantities of peacock feathers were in their possession Narpatgiri Chowk," says Manoj Barbole, Range Forest Officer. A forest team sent to the spot found that the 11 accused had purchased peacock feathers for illegal trade, and that other individuals were storing peacock feathers for sale at Sant Gadge Baba Dharamshala, in a residential location. The accused would be produced in court on Saturday, the officer added. Further investigation is being conducted under Mangesh Tate, Assistant Conservator of For-

Central Railway introduces first EMU rake with compartment for senior citizens



Central Railway (CR) has launched its first Electric Multiple Unit (EMU) rake with a redeveloped compartment solely for senior citizens in the Mumbai suburban network. The step was taken on the directions of the Railway Board and is intended to make travel easier for elderly passengers during peak hours.

"This prototype is the first in a series of planned modifications. We will gradually roll out similar changes across the EMU fleet operating on Mumbai's suburban lines. The move aligns with the broader goal of inclusive infrastructure and creating a more commuter-friendly environment for all age groups," the CR spokesperson said. The renovation work was carried out at a Matunga workshop, where a luggage van in the sixth coach from the Mumbai side was redesigned as a separate senior citizen section. The coach now features infrastructure and safety apparatus intended to provide easier boarding and access to elderly passengers. The upgraded compartment has an improved seating arrangement consisting of three three-seater benches and two two-seater ones, giving a total of 13 seating spaces. The design is intended to provide easier and more manageable seating arrangements for elderly passengers, particularly during rush hour. On the structural front, stainless steel tubular partitions have been fitted. The partitions include eye-level panels as well as grab poles incorporated into the design, enhancing visibility within the compartment and providing improved support when standing or moving. Knurled vertical grab poles have also been included

close to the doorways for enhanced grip, and emergency ladders have been installed under both door frames for enhanced safety. The interior of the compartments has also been coated with vinvl wrapping to enhance the visual design and facilitate easier identification by passengers of the reserved area. The officials explained that the utilisation of visual elements aims to differentiate the coach from ordinary compartments but maintain simplicity in design.Railway officials explained that the purpose of this renovation is not only to enhance passenger experience but also to meet accessibility standards and enable public transport to be made more accessible."The senior citizen coach will be tracked for feedback, which will guide design adjustments in subsequent conversions. It is a targeted effort by Indian Railways to meet the mobility needs of elderly citizens while persisting with more flexible initiatives aimed at upgrading suburban railway infrastructure," the spokesperson added.

Cultural appropriation isn't just colonial, it's casteist

When Italian luxury house Prada recently unveiled its version of the Kolhapuri chappal, Indian social media was guick to react. Accusations of cultural appropriation and erasure followed, accompanied by demands for proper attribution and a wider call to "decolonise fashion". But what if the cultural erasure didn't start with Prada, or with the West? What if the deeper, older story is not just about colonial appropriation, but about caste-based appropriation from within? Beneath the Indian diaspora's outrage lies a deeper, more uncomfortable truth: the issue isn't just about what is being borrowed, but who gets to borrow and who doesn't. The Kolhapuri controversy exposes not only colonial legacies but also the casteist dynamics embedded within India's cultural economy. Originating in Maharashtra's Kolhapur region and its neighbouring districts, the Kolhapuri chappal is known for its durability and distinct structure. What is less commonly discussed is who makes them. Historical accounts of Kolhapuri craftsmanship often mention specific sub-castes such as the Chamar, Dhor, and Matang: scheduled caste communities historically assigned the task of leatherwork, a practice stigmatised due to its contact with animal hides. These artisans, often from marginalised backgrounds, tan, dye, and stitch the leather by hand, creating a product celebrated for its durability and aesthetic. Yet, mainstream narratives often generalise Kolhapuris as a "Maharashtrian" or "Indian" craft, erasing the caste-specific labour behind them.

Within India, cultural appropriation often wears the mask of reverence. Many Indian artforms, textiles, jewellery, and crafts originate from Dalit-Adivasi aesthetics, labour, and design but commercialised by upper caste (Savarna) owned businesses. When a luxury Indian label collaborates with artisans, it is seen as uplifting tradition. But these collaborations rarely involve co-authorship or equity. Artisans are paid per piece. Designs are owned by the brand. The origin story is softened into a marketing stunt. While artisans toil for minimal wages, the profits and prestige accrue to brands. Artisans, often from marginalised social backgrounds, form the backbone of India's handicraft sector but lack control over branding or distribution. Savarna designers and brands act as gatekeepers, curating and profiting from these crafts while framing their role as "saviours of craft"

Indian fashion runways feature designers predominantly from Savarna castes. The narratives in Indian fashion are largely shaped by editorials run by upper-caste surnames. The leadership roles in the Indian fashion and textile sector are disproportionately represented by upper castes. Meanwhile, Bahujans remain largely invisible in decision-making roles, often limited to labour roles. Their labour, when filtered through a Savarna designer's lens, becomes "art." When done independently, it remains "ethnic" or "rural." Many traditional artisans lack access to formal design education, capital investment, or English-language fluency. Such barriers make it difficult for Bahujans to participate in the elite circuits of fashion. Bahujans are often reduced to tokenistic roles: a one season's showstopper or a lookbook model, to signal performative inclusivity without ceding power. Bahujans are rarely seen in leadership roles, such as creative directors or brand owners, yet their identity is exploited in marketing campaigns that romanticise their poverty and struggles as "hardwork" or "heritage." This tokenism commodifies Bahujan struggle while denying them agency, perpetuating a cycle where their labour is celebrated, but their voices are silenced. The Indian diaspora's calls to decolonise fashion often overlook these internal caste hierarchies. This blind spot is telling. National pride tends to eclipse caste critique. In calling out foreign appropriation, many forget to examine who within India controls narrative, capital, and authorship. The act is the same. The reaction shifts from outrage to celebration depending on who borrows and who gets to author the narrative.

The question isn't whether Kolhapuris or any Indian craft should evolve. They must. But the more urgent question is: who gets to decide how they evolve? Who profits? Who gets cited in design schools and magazines, and who remains a footnote? True cultural equity is about fair wages, credit, representation in leadership roles and platforms for co-authorship in design and storytelling which rebalance historic exclusion. The Prada-Kolhapuri controversy is more than a clash over sandals; it's a mirror reflecting how global and local systems both flatten the histories of marginalised makers while uplifting those with socio-economic capital. Within the Indian fashion ecosystem, the intersections of caste and class dictate who gets to be the "designer" and who remains the uncredited, underpaid and exploited "artisan." Until credit, compensation, and representation are equitably shared, cultural appropriation — whether by Prada or privileged Indian elites - will remain a form of theft, rooted in both colonial and casteist legacies.

Building awareness around a rare and often misunderstood cancer: sarcoma

Every year in July, Sarcoma Awareness Month brings attention to a group of rare and often misunderstood cancers. Sarcoma is not just one disease: it is a a family of cancers that originate in the bones and soft tissues such as fat, muscles, blood vessels, nerves, and deep skin tissues. While sarcomas account for only about 1% of all adult cancers and 15% of paediatric cancers, their impact is profound, especially due to limited awareness and late diagnosis. Raising awareness is crucial to helping with early detection, advancing research, and supporting those affected. Types of sarcomas Sarcomas are primarily divided into two main categories: soft tissue sarcomas and bone sarcomas. There are more than 70 subtypes, and this complicates both diagnosis and treatment. Examples of common soft tissue sarcomas include liposarcoma (originating from fat tissue), leiomyosarcoma (arising from smooth muscle), and angiosarcoma (developing from blood vessels). Bone sarcomas consist of osteosarcoma (frequently seen in children and young adults), Ewing sarcoma, and chondrosarcoma. A sarcoma typically appears as a painless lump or swelling that may increase in size over time. Since these signs can be confused with non-cancerous conditions such as cysts or injuries, diagnosis is often postponed, permitting the cancer to advance. While sarcoma can affect anyone, certain risk factors increase susceptibility. These include: genetic conditions such as Li-Fraumeni syndrome or neurofibromatosis; previous radiation therapy, especially in areas later affected by sarcoma; chemical exposure to agents like vinyl chloride or dioxins; chronic swelling (lymphedema) or certain inherited syndromes. Children and young adults are more frequently diagnosed with bone sarcomas, while soft tissue sarcomas are more common in older adults. One of the major difficulties with sarcoma is the limited awareness among the public, and even within the clinical community. Some general practitioners might go their entire careers without encountering a sarcoma case, either because they have not come across one, or because they may not be aware of the signs and symptoms, resulting in a missed diagnosis. These situations influence treatment outcomes, as therapies are more effective when administered in the early stages of sarcoma.Management usually consists of surgery, radiation therapy, and chemotherapy. Developments in targeted therapies and immunotherapy provide new optimism, especially for those diagnosed with metastatic or recurrent sarcoma. Nevertheless, because sarcomas are rare and varied, research funding is significantly less than that for more prevalent cancers. This paucity of funding has a negative impact on drug development, clinical trial opportunities, and access to specialised treatment modalities. The importance of awareness Sarcoma Awareness Month is essential to inform the public, legislators, and medical professionals about the distinct difficulties associated with this type of cancer. Heightened awareness can facilitate earlier diagnoses, which in turn create an opportunity to improve survival rates. Additionally, it fosters public backing for research funding and motivates pharmaceutical companies and researchers to creating improved treatment focus on alternatives.Community events, educational webinars, fundraising campaigns, and patient testimonials help amplify the voices of those affected by sarcoma. The yellow ribbon, the symbol of sarcoma awareness, serves as a visual reminder of the need for continued advocacy and support.Supporting patients and familiesA sarcoma diagnosis can be life-changing not just for the patient but also for their families. Given the rarity of the disease, many patients feel isolated or overwhelmed. Connecting with sarcoma-specific support groups and organizations can provide emotional, financial, and informational assistance.Organisations such as the Sarcoma Foundation of America, Children's Cancer Research Fund, and Sarcoma UK offer resources for patients, fund research initiatives, and advocate for better public health policies. These



Kailash Manasarovar Yatra: Pilgrims' progress



Damini Pandya, 68, had taken a vow of silence for eight days before she reached the clear, ice-blue waters of the Manasarovar Lake in Tibet. There, the retired government officer from Ahmedabad in Gujarat gazed at the majestic snow-capped Kailash mountain in the distance. It had taken her 17 days to get there, walking for three days with low oxygen at an average altitude of about 15,000 feet above sea level. Breaking into a wide smile, she splashed cold water over her head — a ritual that Hindu pilgrims believe purifies the body and soul. Eight days after she began her maun vrat (vow of silence), Pandya crossed into India at the Nathu La Pass in Sikkim. Breaking her vow, she said that the silence had helped her absorb the spiritual significance of the yatra. "I did not utter a word for days because I wanted to be with god. I broke my yow after I entered India, but I don't have words to describe the cosmic energy I felt in Lord Shiva's abode," she said.

Pandya and more than 30 other yatris spent a week in Tibet's Ngari prefecture, where they trekked the 52-km circumference of Mount Kailash, called the parikrama or the kora. This was Pandya's second solo trip after 2019. She entered Tibet through the Lipulekh pass in Uttarakhand, which, she said, was a shorter route compared to the journey through Nathu La pass. It may well be her last visit to Mount Kailash, as the Chinese government has restricted the yatra to those under the age of 70, given the high altitude and concerns about illnesses. The youngest member of the group, Arpit Rai, 19, from Varanasi in Uttar Pradesh, who travelled with his father Shashikant Rai, 55, said he is keen to return to Mount Kailash. "Between Kashi (another name for Varanasi) and Kailash, Shivji (Lord Shiva) is the common factor. Perhaps Shivji wanted us to visit together for the first time. It was an unforgettable journey despite the long travel time in altitudes we are not used to," he said. The yatris travelled for 14 days by bus covering nearly 3,000 km and took three days to do the parikrama by foot, covering around 50 km.Geopolitical considerations

Damini Pandya and the Rais were part of the first batch of Indian pilgrims since 2019 who were allowed to cross into Tibet as part of the Kailash-Manasarovar Yatra. organised by the Indian Ministry of External Affairs and the Chinese Ministry of Foreign Affairs. In 2020, the COVID-19 lockdown; the violent clashes between the Indian Army and the People's Liberation Army at Galwan Valley along the Line of Actual Control; and stand-offs at other points such as Demchok, about 250 km from Kailash Manasarovar, ensured the yatra was suspended. Four years later, after talks between Prime Minister Narendra Modi and Chinese President Xi Jinping, Delhi and Beijing began discussions on normalising relations and restoring a number of different mechanisms between them. The vatra, held between June and August each year due to weather conditions, was prioritised, even as other mechanisms, such as direct flights between India and China, are set to restart.Suman Lata, who recently retired as a school teacher in Delhi, said that while crossing over, the group did not feel any of the tensions between the neighbours that have dominated bilateral ties over the past few years."We have no link with politics, so we don't think about such things. I can only say that the Indian government sent us off very well and the Chinese government has received us extremely well too," she said. Lata was among the 13 women on the group. They had to build facilities along the way in a short period of time. These included reviving immigration posts at various entry points for the yatris, providing rest stops, oxygen banks, and medical facilities.

At the hostel in Zhunzhui Pu, near Taklakot, where the pilgrims stopped for a night before beginning the Kailash parikrama, extra tents were set up inside the atrium to accommodate more people. This is a part of Tibet where people live off subsistence farming. Tourism is the only means of making a living, local workers said, adding that the resumption of the yatra has come as a relief for them. According to the Kailash Manasarovar Yatra website, yatris who pay about ?3 lakh for arrangements need to budget about 990 Renminbi or RMB (?12,000) to pay the local porters and 2,370 RMB (about ?29,000) for pony handlers. In addition, many of the porters do odd jobs for the yatris and make some extra cash, just enough to get by during the brutal winters. During the years when the yatra stood suspended, pilgrims came in via Nepali tour groups. They included many people of Indian origin from the U.S. and the U.K. But the yatra, and Indian pilgrims in particular, have been a mainstay for the local workers in Tibet. According to an External Affairs Ministry response in Parliament, the number of pilgrims allowed to join the yatra each year, which is negotiated between the foreign ministries of India and China, has fluctuated every year since the route was reopened in 1981. In 2015, there were 999 pilgrims. By 2019, there were 1,364.Each of the 15 batches of yatris (10 via Nathu-La pass and five via Lipulekh pass) of about 50 pilgrims this time includes two liaison officers - government officials who apply to join the yatra; 2-4 cooks; and a medical officer from the Indo-Tibetan Border Police. Each of the pilgrims is chosen by a computerised lottery. Of about 5,000 applicants, 750 were chosen this year. They then had to undergo strenuous medical tests to be proclaimed fit to undertake the journey.

"Despite the acclimatisation for two days each at two centres in Sikkim - one at 11,000 feet and the other at 13,500 feet — some 30 out of the 33 pilgrims in my batch experienced high-altitude sickness and breathlessness at times," said the medical officer, who did not want to be named. "My job was to monitor the health of the pilgrims and ensure that those with hypertension and diabetes take their medicines regularly. A few experienced cramps, but they were too excited by the experience to let these affect them," he said. One of the cooks, who also did not wish to be named, said it was a challenge to prepare vegetarian food for people from so many different parts of India. But previous experience with the armed forces helped. "When one caters to soldiers with different acquired tastes from all over the country, one finds the formula to make something that appeals to everyone. We focused on pulse-based items and vegetables provided by the Chinese authorities," he said.While many pilgrims praised the arrangements, some expressed discomfort with the sanitation facilities along the way. According to retired Wing Commander of the Indian Air Force Sadanand Jakhare, they were "comparable to public toilets in India". He said, "The Chinese officials were hospitable, although restrictive and not very expressive. They declined to let us explore the countryside, even a little beyond the designated places. We were under constant watch." However, he added that he was "impressed" by the roads and the use of solar power that he saw along the way.Some people were also unhappy about the restrictions on worship. Pilgrims are not allowed to take a full dip in Manasarovar Lake. Officials said the practice was discontinued in 2016 after Indian pilgrims were found using soap to wash themselves in the lake, and leaving items of clothing and jewellery there."The yatra is not for comfort," said Devi Prasad Ketkar, a retired manager from Mumbai, who was on the pilgrimage with his wife Pradnya.Ketkar also served on the organising committees for the group. "There is no place for negative energy or negative comments during our visit here... visiting Mount Kailash and doing the parikrama gives us all the answers we need," he said, as others in the group nodded. After 2001, the Chinese government banned attempts to climb it due to the religious sensitivities of different faiths.

World's largest digital camera starts observing the cosmos

Ever imagined seeing a golf ball on the surface of the moon in an image taken from the earth? This is now possible with the Vera C. Rubin Observatory (VRO), the world's latest astronomy facility, located on one of the peaks of mountain Cerro Pachòn in northern Chile. Jointly funded by the U.S. National Science Foundation and the Department of Energy, this 8.4-metre telescope offers an unprecedented view of the universe.

The 3,200-megapixel (MP) camera installed on the VRO has 67-times more pixels than an iPhone 16 Pro camera. The large mirrors and unique design allow the telescope to capture wide-angle 3.5-degree-diameter images, equivalent to the size of seven full moons in the sky. These unique features will allow the VRO to scan the entire southern hemisphere sky every three nights, which it will do continuously for 10 years. This ultra-high definition, wide angle survey of the sky will thus create the longest astronomical time-lapse movie of all time, allowing for many new discoveries in the solar neighbourhood and deep space alike.

While the future holds endless possibilities for this next generation observing facility, the VRO was constructed to serve four major science goals. One of them is understanding the nature of dark matter, the mysterious substance that makes up 80% of all matter in the universe.But while dark matter can't be seen, it causes galaxies to clump together in specific ways. Astronomers will study the distribution of galaxies near and far in order to understand the properties of dark matter, and figure out what it is made of.Since the VRO will scan the entire southern hemisphere sky over and over again, scientists will also get a pretty good idea of how the sky looks generally. This will allow them to pick up any changes in the sky relative to images taken a few days ago, a few weeks ago, and, eventually, a few years ago. In fact its state-of-the-art technology allows the VRO to compare each image to the 'general' image of that part of the sky within 60 seconds and issue an alert if any changes are detected. When fully operational, the VRO

will generate around 10 million alerts from 20 TB of raw data collected every night. That's equivalent to more than three years of streaming videos. The changing skyWhile most of the changes in the sky are due to fast-moving objects such as comets, there exist other celestial entities whose position and brightness can change over time. For instance, while 1.5 million asteroids - rocky bodies orbiting the sun between Mars and Jupiter - have been discovered, only 30% of those smaller than 140 m are known so far. The VRO is expected to increase this figure to 90%and allow scientists to locate 'killer asteroids', which despite their relatively small size could devastate our planet if they strike it. With its unprecedented resolution, the VRO can raise the count of known solar system objects by 10x, discovering many new comets and asteroids, dwarf planets like Pluto, and even a ninth planet if it exists. All galaxies interact with their neighbours gravitationally. Small satellites are torn apart by the gravity of bigger galaxies as they merge with them. The VRO will map the distribution of stars in the Milky Way, helping astronomers identify 'streams' of stars that once belonged to smaller galaxies that blended with the Milky Way millions of years ago. Given its unique long-term survey capability, the VRO will also discover millions of objects of variable brightness. For instance, dying stars explode as supernovae, which brighten up for a few days before their nuclear furnace is extinguished. Some stars may have planets, or another star orbiting them, blocking their light from reaching us occasionally. Other variable stars may change in brightness because their outer surfaces pulse over a few hours to a few days. The first imagesIn a June 23 press conference, the observatory revealed that the \$473 million facility had already discovered 2,104 asteroids in a week of observations. All other efforts combined currently find around 20,000 asteroids a year.

While one of the initial images displays swirling clouds of dust and gas in the Trifid and Lagoon nebulae 9,000 lightyears from the earth, another shows a section of the Virgo galaxy cluster located 54 million lightyears away. The



giant images captured by the VRO are a journey through space and time: Milky Way stars shining in an array of colours from blue to red in the foreground, groups of galaxies with reddish hues moving away from us in distant space, and a suite of gravitationally interacting galaxies in a nearby cluster sandwiched in between. The VRO is distinguished from its predecessors, including the James Webb Space Telescope: while they are more sensitive, they can only observe a small patch of the sky at a time. The VRO was originally proposed in 2001 and was then called the 'Large Synoptic Survey Telescope' (LSST). It was renamed as the Vera C. Rubin Observatory in 2019. Rubin (1928-2016) was an American astronomer. She was the first to show that spiral galaxies rotated so fast that if their constituents were just stars, they should fly apart. The implication was that there are large amounts of unseen matter holding galaxies together, the substance we call dark matter today. Despite her pioneering work, gender bias denied Rubin a Nobel Prize. Now, the VRO honours her and her colleagues by observing billions of galaxies as part of the 'Legacy Survey of Space and Time', which will help astronomers understand the nature of dark matter, whose existence first came to light in Rubin's work.Smriti Mahajan is an astronomer.







Hamas says it responds to Gaza ceasefire proposal in 'a positive spirit'



CAIRO/TEL AVIV, GNS News Agency, july 4 Hamas said it had responded on Friday in "a positive spirit" to a U.S.-brokered Gaza ceasefire proposal and was prepared to enter into talks on implementing the deal, which envisages a release of hostages and negotiations on ending the conflict.U.S. President Donald Trump had announced a "final proposal" for a 60-day ceasefire in the nearly 21-monthold war between Israel and Hamas, saying he anticipated a reply from the parties in coming hours.The Reuters Daily Briefing newsletter provides all the news you need to start your day. Hamas wrote on its official website: "The Hamas movement has completed its internal consultations as well as discussions with Palestinian factions and forces regarding the latest proposal by the mediators to halt the aggression against our people in Gaza."The movement has delivered its response to the brotherly mediators, which was characterized by a positive spirit. Hamas is fully prepared, with all seriousness, to immediately enter a new round of negotiations on the mechanism for implementing this framework," the statement said. In a sign of potential challenges still facing the sides, a Palestinian official of a militant group allied with Hamas said concerns remained over humanitarian aid, passage through the Rafah crossing to Egypt and clarity over a timetable of Israeli troop withdrawals. Trump said on Tuesday that Israel had agreed "to the necessary conditions to finalise" a 60-day ceasefire, during which efforts would be made to end the U.S. ally's war in the Palestinian enclave.

Israeli Prime Minister Benjamin Netanyahu, who is due to meet Trump in Washington on Monday, has yet to comment on Trump's announcement, and in their public statements the two sides remain far apart. Netanyahu has repeatedly said Hamas must be disarmed, a position the militant group, which is thought to be holding 20 living hostages, has so far refused to discuss. Israeli media cited an Israeli official as saying that Israel had received and was looking into Hamas' response to the ceasefire proposal. Trump expressed optimism late on Friday to reporters aboard Air Force One, who asked about Hamas' response."They said they gave me a positive response? Well, that's good," Trump said, adding that he had not yet been briefed. "There could be a Gaza deal next week."An Egyptian security official told Reuters that Egypt, which along with Qatar is mediating ceasefire efforts, had seen Hamas' response and said: "It includes positive signs that an agreement is near, but there are some demands from Hamas that need to be worked on."Trump has said he would be "very firm" with Netanyahu on the need for a speedy Gaza ceasefire, adding that the Israeli leader wants one as well.ATTACKS OVERNIGHTIsraeli attacks have killed at least 138 Palestinians in Gaza over the past 24 hours, local health officials said.Health officials at the Nasser Hospital in Khan Younis, southern Gaza, said the Israeli military had carried out an airstrike on a tent encampment west of the city around 2 a.m., killing 15 Palestinians displaced by nearly two years of war.The Israeli military said troops operating in the Khan Younis area had eliminated militants, confiscated weapons and dismantled Hamas outposts in the previous 24 hours while striking 100 targets across Gaza, including military structures, weapons storage facilities and launchers.Later on Friday, Palestinians gathered to perform funeral prayers before burying those killed overnight.

"There should have been a ceasefire long ago before I lost my brother," said 13-year-old Mayar Al Farr as she wept. Her brother, Mahmoud, was shot dead in another incident, she said."He went to get aid, so he can get a bag of flour for us to eat. He got a bullet in his neck," she said.In Tel Aviv, families and friends of hostages held in Gaza were among demonstrators who gathered outside a U.S. embassy building on U.S. Independence Day, calling on Trump to secure a deal for all of the captives." Only you can make the deal. We want one beautiful deal. One beautiful hostage deal," said Gideon Rosenberg, 48, from Tel Aviv.Rosenberg was wearing a shirt with the image of hostage Avinatan Or, one of his employees who was abducted by Palestinian militants from the Nova musical festival on October 7, 2023. He is among the 20 hostages who are believed to be alive after more than 600 days of captivity. An official familiar with the negotiations said on Thursday that the proposal envisages the return of 10 of the hostages during the 60 days, along with the bodies of 18 others who had died since being taken hostage. Ruby Chen, 55, the father of 19-year-old American-Israeli Itay, who is believed to have been killed after being taken captive, urged Netanyahu to return from meeting Trump with a deal that brings back all hostages. Itay Chen, also a German national, was serving as an Israeli soldier when Hamas carried out its surprise attack, killing around 1,200 people, mostly civilians, and taking 251 hostage

Israel's retaliatory war against Hamas has devastated Gaza, which the militant group has ruled for almost two decades but now only controls in parts, displacing most of the population of more than 2 million and triggering widespread hunger. More than 57,000 Palestinians have been killed in nearly two years of fighting, most of them civilians, according to local health officials. U.S. President Donald Trump signed his flagship tax and spending Bill into law on Friday (July 4,2025), capping a grandiose White House Independence Day ceremony featuring a stealth bomber fly-by.Mr. Trump also played down criticism by Democrats that the unpopular legislation will slash social welfare programs, saying: "You won't even notice it."With First Lady Melania Trump at his side, Mr. Trump watched from the White House balcony as two B-2 bombers — the same type that recently struck Iranian nuclear sites - roared overhead, accompanied by F-35 and F-22 fighter jets. The 79-year-old's victory lap came a day after Republicans fell into line and passed the sprawling mega-Bill, allowing him to sign it as he had hoped on the Fourth of July holiday. The Bill honours many of Mr. Trump's campaign promises: extending tax cuts from his first term, boosting military spending and providing massive new funding for Mr. Trump's migrant deportation drive. 'Never been anything like it'

The legislation's signing caps two weeks of significant wins for Mr. Trump that have seen him tighten his grip on power and his party alike. The successes include the recent Iran-Israel ceasefire that was sealed after what he called the "flawless" U.S. air strikes on Iran.Pilots who carried out the bombing on Iran were among those invited to the White House event, which included a picnic for military families on the South Lawn."The last two weeks, there has never been anything like it, as far as winning," said Mr. Trump.Mr. Trump had however forced through the tax Bill despite deep misgivings in the Republican Party that it would balloon the national debt.

The legislation is expected to pile an extra \$3.4 trillion over a decade onto the U.S. deficit. It squeezed past a final vote in the House of Representatives 218-214 after Republican Speaker Mike Johnson worked through the night to corral the final group of dissenters.Mr. Trump's billionaire former ally Elon Musk was among the most vocal critics, and he has pledged to set up a new political party to oppose Republicans who backed the Bill.Democrats and many voters have meanwhile expressed concerns that the "big beautiful Bill" will gut health and welfare support. The Bill will force through the largest cuts to the Medicaid health insurance program for low-income Americans since its 1960s launch, while also shrinking federal food assistance programs.Fireworks explode near the Washington Monument during a Fourth of July celebration at the White House in Washington, on July 4, 2025. Up to 17 million people could lose their insurance coverage under the Bill, according to some estimates. Scores of rural hospitals are expected to close as a result.But Mr. Trump played down the concerns."They've developed a standard line, and we can't let them get away with it. 'Oh, it's dangerous. A deliberate strategy to usher in a communal order

On the eve of the 75th anniversary of the Indian Constitution, the Supreme Court of India reaffirmed the foundational character of the Indian Republic by upholding the inclusion of the words "secular" and "socialist" in the Constitution's Preamble. These words, introduced through the Constitution (42nd Amendment) Act, 1976, by the Indira Gandhi-led government during the Emergency, have been the target of repeated political and legal attacks by rightwing forces. Dismissing a batch of petitions challenging these additions, a Bench of the Supreme Court recently upheld the addition of these words, arguing that the mere absence of these terms in the original Preamble adopted on November 26, 1949, cannot invalidate their inclusion. This legal reaffirmation was a powerful signal from the judiciary. But the Rashtriya Swayamsevak Sangh (RSS), the ideological backbone of the Bharatiya Janata Party (BJP), chose to launch a fresh offensive on the very idea of India as enshrined in the Constitution. RSS General Secretary Dattatreya Hosabale made a brazen demand: the removal of "secular" and "socialist" from the Preamble, which, according to him, were alien to Dr. B.R. Ambedkar's constitutional vision.

The Vice-President of India, Jagdeep Dhankhar, went a step further, terming the insertion of these words as "sacrilege to the spirit of Sanatan". It is no coincidence that these statements are being made from some of the highest offices of the land. This is not an intellectual debate. This is a deliberate political strategy to delegitimise the modern, plural, democratic republic of India and to usher in a communal and hierarchical order. An agenda, from fringe to mainstream When the Constitution was being framed, the Constituent Assembly, emphatically and unanimously, supported the idea of a secular state. Not a single member argued for a theocratic state. The idea of India was built on the foundations of unity in diversity - a rejection of colonial divideand-rule, of communal politics, and of caste and religious supremacy. Today, the RSS-BJP establishment is working relentlessly to dismantle that consensus and impose the idea of a Hindu Rashtra. This agenda has moved from fringe rhetoric to the political mainstream. On the day of the consecration of the Ram temple in Avodhva. Prime Minister Narendra Modi made a provocative statement equating 'Ram with Rashtra and Dev with Desh'. This kind of fusion of religion and state is exactly what the framers of the Constitution warned against. It is also directly in contradiction to the Supreme Court's ruling that secularism is a part of the basic structure of the Constitution - something that cannot be amended or erased, even by Parliament. The warnings of our national leaders resonate even more forcefully today. In 1931, Mahatma Gandhi, in his resolution on Fundamental Rights, insisted that the state must remain neutral in religious matters. Dr. B.R. Ambedkar too reflected this in the line, "The State shall not recognise any religion as State religion." What is particularly instructive, and ironic, is that the Hindu Mahasabha, which boycotted the freedom movement and opposed secular nationalism, included a similar provision in its 1944 Hindustan Free State Act. The Constituent Assembly Debates further highlight the intent of India's founding generation. On August 27, 1947, Govind Ballabh Pant posed a direct question: "Do you want a real national secular State or a theocratic State?" He warned that if India became a theocracy, it could only be a Hindu state, raising questions about the status and secu-



rity of those who would be excluded from such a polity. Jaspat Roy Kapoor, on November 21, 1949, noted that Gandhi had made it clear: religion should be a personal matter. On November 22, 1949, Begum Aizaz Rasul called secularism "the most outstanding feature" of the Constitution and expressed hope that it would remain "guarded and unsullied". On October 14, 1949, Sardar Vallabhbhai Patel reassured the nation that the Constitution of free India would not be "disfigured by any provision on a communal basis." And on November 23, T.J.M. Wilson warned that the clouds threatening India's secular character were already forming. These warnings were not alarmist but were deeply perceptive, and speak with urgency to our times. The present RSS-

Trump says Ukraine will need Patriot missiles for its defense, chides Putin

WASHINGTON/KYIV, GNS News Agency, july 14 -U.S. President Donald Trump said Ukraine would need Patriot missiles for its defenses, after speaking with President Volodymyr Zelenskiy on Friday, and voiced frustration over Russian President Vladimir Putin's failure to end the fighting.Trump told reporters aboard Air Force One that he had a good call with Zelenskiy, repeating that he was "very unhappy" about his call with Putin a day earlier, given what he called the Russian leader's refusal to work on a ceasefire.

Asked whether the United States would agree to supply more Patriot missiles to Ukraine, as requested by Zelenskiy, Trump said: "They're going to need them for defense... They're going to need something because they're being hit pretty hard."Trump touted the efficacy of the Patriot missiles, calling the weapon "pretty amazing."

Asked about the prospects for a ceasefire, Trump said, "It's a very tough situation... I was very unhappy with my call with President Putin. He wants to go all the way, just keep killing people - it's no good."Zelenskiy said he had agreed to work on increasing Kyiv's capability to "defend the sky" as Russian attacks escalate, adding in a message on Telegram that he discussed joint defense production, as well as joint purchases and investments with the U.S. leader.Ukraine has been asking Washington to sell it more Patriot missiles and systems that it sees as key to defending its cities from intensifying Russian air strikes.A decision by Washington to halt some shipments of weap-

ons to Ukraine prompted warnings by Kyiv that the move would weaken its ability to defend against Russia's airstrikes and battlefield advances. Germany said it is in talks on buying Patriot air defense systems to bridge the gap.A source briefed on the Trump-Zelenskiy call told Reuters they were optimistic that supplies of Patriot missiles could resume after what they called a "very good" conversation between the presidents.Trump said he also spoke with German Chancellor Friedrich Merz about Ukraine's request for Patriot missiles but that no decision had been made to supply the advanced missiles.U.S. news outlet Axios reported, citing unnamed sources, that the call lasted around 40 minutes and that Trump told Zelenskiy he would check what U.S. weapons due to be sent to Ukraine, if any, had been put on hold.Zelenskiy, in his nightly video address, said he and Trump had agreed to "arrange a meeting between our teams to strengthen air defenses."We had a very detailed discussion on joint production. We need it, America needs it

"The conversation came a day after Trump said he had a disappointing call with Putin.Russia pummeled Kyiv with the largest drone attack of the war across the capital hours after Trump's conversation with Putin on Thursday.Zelenskiy called the attack "deliberately massive and cynical."Kyiv in the past received Patriot batteries and ammunition from the U.S. in the form of aid under then-President Joe Biden.Trump criticized him for sending weapons to Ukraine without getting anything in return, and since taking office has overseen a dramatic shake-up of relations with Kviv. led campaign is also aimed at discrediting and eliminating the socialist orientation of the Constitution. Dr. Ambedkar, in the Constituent Assembly, clearly noted that the Directive Principles of State Policy enshrined in Part IV of the Constitution were rooted in socialist ideals.

The Supreme Court's recent decision, rightly interpreted the term "socialist" in the Preamble as synonymous with a welfare state. This vision resonates with B.R. Ambedkar's own emphasis on the social and economic transformation of India - an end to caste exploitation, landlessness, poverty, and discrimination. Socialism means creating conditions for equality and justice - not the importation of any foreign ideology, but the realisation of the promises of the freedom struggle. In this regard, B.R. Ambedkar issued perhaps the most unambiguous warning ever - in Pakistan or the Partition of India, he wrote: "If Hindu Raj does become a fact, it will, no doubt, be the greatest calamity for this country ... Hindu Raj must be prevented at any cost."That cost is now upon us. The RSS's demand to remove the terms "secular" and "socialist" from the Constitution is part of a long-term project to dismantle the very edifice of the modern Indian Republic and to institutionalise a new order built on religious supremacy, caste hierarchy, market fundamentalism, and political authoritarianism. This must be resisted — through public awareness, legal challenge, political mobilisation, and mass democratic struggle. The Constitution is not just a legal document. It is a political, social, and moral covenant forged in the crucible of our freedom struggle. It embodies the dreams of countless martyrs, revolutionaries, and constitutionalists who envisioned an India that belonged to all its people. To defend secularism and socialism today is to defend democracy itself. It is to defend the right of every citizen - regardless of faith, caste, class, or gender - to live with dignity, equality, and freedom. The Republic must be protected, nourished, and, if necessary, defended against those who seek to destroy it from within. Let us rise to that responsibility, with courage, with clarity, and with collective resolve.

India-Pakistan trade continues in May despite border tensions

Islamabad: Despite a brief military conflict and the continued closure of borders, trade between Pakistan and India persisted in May, primarily through a third country. The official data showed that imports from India reached a three-year high during July-May FY25, Dawn reported quoting the data of the State Bank of Pakistan (SBP). It showed that imports from India totalled USD 211.5 million in the first 11 months of FY25 — surpassing USD 207m in FY24 and USD 190m in FY23. In May alone — when the four-day conflict broke out in the first week—imports stood at USD 15 million, slightly down from USD 17 million in the same month last year.

However, Pakistan's exports to India remained negligible. In May, exports to India were recorded at just USD 1,000, while total exports during July-May FY25 were only USD 0.5 million. In FY24 and FY23, exports stood at USD 3.44 million and USD 0.33 million, respectively—highlighting the highly one-sided nature of bilateral trade.Formal trade relations between Pakistan and India have suffered since 2019. However, after the April 22 Pahalgam terror attack that claimed 26 lives, India took a series of measures, including immediate shutting down of the Attari land-transit post, used for movement of certain kinds of goods.In retaliation, Pakistan too announced that "all trade with India, including to and from any third country through Pakistan, is suspended forthwith." Traders were reluctant to discuss the continuation of imports during the tense period. However, one trader suggested: "It may have come from a third country and the payment for the May imports would have been made before the war."







The need is for domain experts, but within the civil service

In August 2024, the Union Public Service Commission (UPSC) initiated the recruitment process through the lateral entry scheme by issuing a notification for the recruitment of 45 Joint Secretaries, Directors, and Deputy Secretaries as specialists in government departments. The initiative faced significant opposition from various groups, particularly political parties, which argued that the scheme compromised the reservation rights of Other Backward Classes (OBCs), Scheduled Castes (SCs), and Scheduled Tribes (STs). The strong opposition compelled the government to shelve the plan. This was not the first time that the Union Government has recruited specialists through the lateral entry scheme. In 2018, 63 specialists were appointed through lateral entry in various ministries. Currently, around 57 specialists are working with the government. Even then, recruitment through the lateral entry scheme was excluded from the reservation system. The decision to withdraw the notification has reignited the debate on the need for domain experts within the civil service and highlights the necessity of developing an appropriate approach to civil service reform

Need for domain expertsIt has long been recognised that specialised skills are much needed in the civil service In fact, the Second Administrative Reforms Commission (2005) recommended the need for lateral entry into the higher echelons of the government to bring in specialised knowledge and skills, though it did not specify a method of recruitment. The ongoing representation issues of SCs and STs within the civil service further complicate the narrative. Despite existing reservations, the number of SC and ST officers in higher positions remains low. SCs and STs constitute only around 4% and 4.9% of top bureaucratic positions in the Union government at the level of Deputy Secretaries, Directors, Joint Secretaries, and beyond. One reason is that the entry age of officers during the recruitment process is often higher than that of general category candidates, and these officers frequently retire before reaching the top positions.

The lateral entry scheme is likely to further limit the representation of these marginalised communities, as the scheme is unlikely to attract domain experts from these communities due to their limited access to such positions in the private sector. For better or worse, the lateral entry debate has been politicised. With caste-based reservations being significant factors in elections, the government is unlikely to reignite this debate, as doing so could have substantial political repercussions. For now, the discussion around lateral entry appears to have reached an impasse.But there is no denying the reality that there is a need for domain experts in the public sector, as each sector is becoming specialised, requiring close collaboration with technical experts. Civil servants are generally generalists, not specialists. Lateral entry, with or without reservation as it existed, was essentially a short-term solution. The need is for domain experts within the civil service itself. It is these domain experts who would cultivate a resilient and effective civil service. To realise this objective, there is a need to develop long-term strategies that prioritise academic-industry-civil service collaboration, capacity building, and institutional development. Integrated model for domain expertise In order to effectively develop domain expertise within the civil service in India and address the ever more complex needs of governance, a collaborative framework that brings together civil service, academia, and industry is needed. This collaboration would facilitate the exchange of knowledge and best practices, allowing civil servants to engage with the latest developments in their respective fields and develop much-needed domain expertise. Civil servants with public sector experience and decision-making capabilities would imbibe insights from academia and industry about emerging trends, skills, and technologies. But this collaboration must differ from the current refresher and midcareer training offered to civil servants. These training programmes for civil servants often act as temporary fixes. Even though such programmes inculcate valuable skills, they fail to create a robust framework for domain expertise. Domain expertise, unlike training programmes, is not an isolated event but must be an integral part of a civil servant's career trajectory. For domain expertise, an integrated model that aligns with individual career paths and areas of interest is essential. The critical components of an integrated model for developing domain expertise among civil servants include strategic planning, memoranda of understanding (MoUs) with institutions, a rigorous selection process, and

specialised postings with fixed tenures.

Strategic planningDomain expertise starts with the drafting of a strategic plan to create efficient public policy analysts within the civil service, with locus in the public sector and focus on skills and knowledge from the private sector/industry, facilitated by academia. The objective is to enhance the capacity of civil servants in terms of technical expertise and strategic vision to formulate and implement policies efficiently and effectively in specific sectors, contributing to good governance and improved public service delivery. Strategic planning represents a long-term vision for the civil service and requires identifying the number of sector-specific domain experts needed for better alignment of resources and priorities. Academic institutions must be involved in the strategic planning at the initial stages only. This integrated model has significant advantages for academic institutions as well, as they would receive fresh impetus and motivation to contribute richly to public service delivery. One critical aspect of domain expertise is staying focused on ever-changing innovations and technologies in industry and incorporating these into the public sector. Strategic planning would include an element of circular response planning, with feedback and adjustments continuously incorporated. This element promotes flexibility and adaptability in the face of changing circumstances.

MoUs with institutionsThe second component of the integrated model for developing domain expertise is the framing of MoUs with institutions. The Department of Personnel and Training (DoPT) of the Ministry of Personnel, Public Grievances, and Pensions, along with other cadre-controlling ministries, will establish MoUs with premier institutions such as the Indian Institutes of Management, Indian Institutes of Technology, National Institute of Rural Development and Panchayati Raj, Indian Institute of Public Administration, and the top central universities based on the National Institutional Ranking Framework. This collaboration's primary objective is to formulate tailored courses and training programmes laced with industry experience for transforming current mid-level and top-level officers into domain experts. To start with, each ministry of the Government of India could target developing around four to five domain experts in sector-specific areas over the next few years and ensure the smooth and steady infusion of specialised knowledge and skills into the civil service. The MoUs must ensure that these courses are not usual academic courses, but, specifically, domain expert skill courses. The institutions involved must necessarily engage industry experts for the long term and have their own collaboration with them.

Selection process, specialised postingThe third but critical component of developing domain experts within the civil service is the establishment of rigorous selection processes for specialised training programmes. This should be iointly done by the ministries concerned and the institutions concerned. Herein, consideration can be given for adequate representation of SCs, STs and OBCs for domain expertise. The selection process should involve submission of a Statement of Purpose (SoP) detailing their motivations for domain expertise and past experiences and interview process to assess a civil servant's alignment and potential for a domain expertise programme. Through this selection process, and subsequent training, a pool of civil servants would be developed who are not only domain experts but also deeply invested in making a meaningful impact. The last component of the integrated model for domain expertise is specialised posting in their respective areas of expertise, much like the existing lateral entry framework, which appoints personnel based on ministry needs. There should be no transfer of the trained domain experts outside their specialised sector. This targeted approach would address the long-standing issue of "the right minds aren't in the right places" by ensuring that individuals with the most relevant knowledge and skills are assigned to roles where they can make the greatest impact. Further, irrespective of their years left in the service, a fixed tenure system post training should be set up that allows all domain expert officers equal chances to reach senior roles and contribute richly. Transforming the civil service in India through the integrated model for domain expertise is necessary to strengthen governance and improve public service delivery by developing a resilient and responsive civil service. In today's market-based economy, the role of government has shifted from being a service provider to that of a facilitator and regulator. Through a cadre of domain experts, the government can build institutional capacity, enabling civil servants to serve effectively as regulators, facilitators, and even service providers. The model also allows civil servants to step away from the daily grind of government machinery to focus on skill development and specialisation. From a psychological perspective, this break from the routine can significantly reduce monotony. reenergising civil servants and enhancing their motivation. By engaging in capacity-building programmes, civil servants can rejuvenate their professional drive, thereby avoiding the "deadwood" effect that often arises in a prolonged career within the government sector. The history of geopolitical rivalries involving the United States (US) and Russia (also the former Soviet Union) teaches us that tensions and conflicts tend to become protracted. West Asia and eastern Europe have been the theatres of power rivalries during the Cold War and post-Cold War eras. Due to multiple power centres in the post-Cold War, wars and conflicts have become more complicated on at least two fronts: global leadership and "free-raider' countries. The global leadership is contested by countries outside the 'US-Russia' hyphenation. Emerging economies like those in BRICS are strengthening their collaboration on international peace and security matters. Nonetheless, the BRICS countries themselves are unclear about what alternative form of international peace and security structure suits the current global conflict scenarios. The US positions on the Ukraine-Russia war and the Israel-Palestinian conflict are ambiguous in terms of its commitment to international laws. The US policy towards Ukraine supports the United Nations (UN) Charter and international law to the cause of Ukraine's sovereignty and international peace. It voted in favour of the UN General Assembly resolutions, for example, ES-11/1 of March 2, 2022, which condemned Russia's invasion and stood firm, which has been maintained throughout the ongoing conflict, that Russia should withdraw its troops from Ukraine. The Global South has not been on the same footing with the US's policy of isolating Ukraine diplomatically. Some of these countries have maintained special exemptions, like India's oil import from Russia at a discount, from the US sanctions against Russia.

The US policy towards the Ukraine-Russia war has shown consistency and unambiguity in support of Ukraine. The victory of Donald Trump as President in the recent election, who will take charge January 20 next year, might change the policy. He will assume power after the war, which marks the completion of 1,000 days. Trump's focus is on diplomacy and a rapid resolution to the conflict. He showed his confidence to end the war "within 24 hours," talking directly to Russian President Vladimir Putin and Ukrainian President Volodymyr Zelenskyy. He strongly felt that the US aid to Ukraine was at the cost of US interests, and bringing back America First is his priority. Moreover, his explicit criticism of the North Atlantic Treaty Organization's (Nato)'s dependency on US funding cannot go unnoticed in the current war efforts in Ukraine. Thus, it departs from President Biden's strong support for Ukraine. It remains to be seen if his transactional diplomacy will be able to "end" the war, although he has not laid down a concrete strategy yet. Geopolitical experts are observing which direction the US policy might swing under his reign, either towards diplomacy or sanctions to resolve the long-drawn-out war. Experts con-

On the other hand, Trump has shown steadfast support for Israel in the October 2023 Israel-Hamas conflict. The UN General Assembly and the US Security Council are ineffective due to different member States' positions in each body. In these bodies, the US has been supporting Israel while a significant number of countries are supporting Palestinian rights and statehood. Columbia and Turkey recently announced that they would cut ties with Israel. South Africa, Chile, Honduras, Chad, and Jordan withdrew their ambassadors earlier. In 2023, Bolivia and Nicaragua severed relations with Israel.Both the Trump and Biden administration continue to support Israel. The only difference with President-elect Trump is his approval to give Israel greater freedom to act militarily in Gaza without any US pressure. President Biden, in the past, warned the Israeli leadership against excessive use of force and advised Israel to exercise restraint in military operations in Gaza. The possibility of bringing back Trump's "Peace to Prosperity" plan of 2020 is reported. The Peace Plan proposed a two-State solution. It, however, also approved of Israel's annexation of settlements in the West Bank and retained control of the Jordan Valley. The territorial demarcation to create a Palestinian State is not according to the pre-1967 borders. Its control over its security is limited, which would be under Israel.Palestinians rejected the peace plan, while Israelis welcomed it. Although Prime Minister Benjamin Netanyahu welcomed the plan with reservations at the time, the current conflict with Hamas has expanded to include Lebanon and Iran in the fray. It took a more complex turn before Trump's second term began. While Trump's endeavours in both cases seem to pick and choose favourable international laws of peaceful settlement to global conflicts, leveraging his personal connections with global leaders to resolve long-drawn crises is his style of diplomacy. Trump might cut down on US aid to Ukraine and use his personal connection with Putin to bring both to the negotiating table. He insisted that Israel to end the Gaza conflict swiftly. All of this carries his intentions towards global conflicts, which are consistent with his endorsement of withdrawing the US from Nato and the United Nations operations, which, he believed, are financially dependent on the US disproportionately.Nonetheless, Trump's withdrawal from the Iran nuclear deal and imposition of heavy sanctions against Iran is an example of unpredictability in his conflict resolution methods. On the other hand, his significant dip-Iomatic achievement involved the Abraham Accords, which normalised relations between Israel and several Arab nations.President-elect Trump does not fit into the traditional internationalist or pacifist category. His transactional diplomacy and selective engagement define his foreign policy However, the risk of escalation is now even more significant for any US policy without the support and collaboration of Ukraine or Israel and their counterpart actors, alongside emerging economies, in his peace efforts. Although not an easy task, these global conflicts require long-term conflict resolution. It is a difficult task for the US alone to see through the global conflicts without involving other power centres like the BRICS nations, which have appealed for amicable solutions to global conflicts. However, involving the BRICS countries is unlikely if the peace efforts are in

What is the One Nation One **Subscription explained**

The story so far: The Union Cabinet on Monday, November 25, 2024, approved the 'One Nation One Subscription' (ONOS) initiative for centralised access to research articles and journal publication for government higher education institutions and research and development (R&D) laboratories of the central government. The central government has allocated ?6.000 crore for ONOS until 2027. All higher education institutions under central or State governments and R&D institutions of central government can avail the benefits of the initiative through a national subscription.

What is ONOS?ONOS is a plan to consolidate researchers' subscriptions to prominent academic journals and other similar publications. Once in place, the ONOS initiative will provide access to journal articles to all individuals in India for one "centrally negotiated payment". The ONOS will replace individual institutional journal subscriptions. Subscriptions to scientific journals are a costly affair. According to research conducted by S. Chakraborty of the National Institute of Plant Genome Research, New Delhi, and other researchers and published in Current Science in April 2020, India spent around ?1,500 crore on subscription for electronic and print journals in 2018. Institutions also spent around ?30-50 crore on access to SCOPUS and Web of Science, which are popular citation databases."One is looking at very large numbers in terms of financial outlays," the paper noted.In a response to a query raised in the Lok Sabha in August 2023, Subhas

Sarkar, then Minister of State for the Education Ministry, said the Indian government spent around ?995 crore on journal subscriptions in 2022. This included "the spending by the ten library consortia funded by different ministries/departments and self-subscriptions by individual government academic and R&D institutions". Overall, the total expenditure for 2019-2022 was estimated to be around ?2,985 crore, Mr. Sarkar said. The ONOS initiative is also expected to include concessions on fees that authors have to pay to have their work published in open access journals. History of the schemeONOS was recommended as one of the objectives of the Science, Technology, and Innovation Policy 2020 to facilitate knowledge-sharing on an "equal partnership basis".A plan for ONOS was presented at a stakeholder consultation in August 2021, which was endorsed by the concerned ministries. Another round of negotiations for ONOS took place on October 11-12, and October 25, 2023. The negotiations were held with 41 publishers, which included journals and citation databases, according to the Office of the Principal Scientific Advisor. Popular STEM and social science publishers like Elsevier, Springer Nature, Taylor and Francis, and Wiley were a part of the process. In his Lok Sabha response in 2023, Mr. Sarkar said a core committee had been constituted to implement ONOS. This committee consists of a secretary each from the Ministry of Education and the Department of Science and Technology, and a scientific secretary.

Government reduces toll charges by up to 50% on national highways with bridges, tunnels



The government has reduced the toll rates up to 50% for the sections of National Highways that have structures like tunnels, bridges, flyovers or elevated stretches, a move which will lower travelling cost for motorists. User charges at fee plazas on National Highways are collected as per NH Fee Rules, 2008. The Ministry of Road Transport and Highways has made amendment to 2008 rules and notified a new method or formula for calculating toll charges.

"The rate of fee for use of a section of national highway comprising of structure or structures shall be calcu-

lated by adding ten times the length of structure or structures to the length of the section of national highway excluding the length of structure or structures, or five times the total length of section of national highway, whichever is lesser," said the notification dated July 2, 2025. 'Structure' means an independent bridge, tunnel or flyover or elevated highway. To explain the new toll charges, the ministry has cited examples. In one of the examples, it said that if a section of a national highway has a total length of 40km, comprising of structure alone, the minimum length shall be computed: '10 x 40 (ten times length of structure) = 400km or five times the total length of section of a national highway = 5 x 40 = 200km'."User fee shall be calculated on the lesser length i.e. for 200km" and not 400km. In this case, the user charge is only on half (50%) of the road length. According to the extant rules, users pay ten times the regular toll for every km of structure on national highways. A senior official of National Highway Authority of India (NHAI) said the existing toll calculation method was meant to offset higher construction cost associated with such infrastructure."The revised notification issued by the Ministry of Road Transport and Highways reduces the toll rate for stretches such as flyovers, underpasses and tunnels up to 50%," the official said

No trade deal with US under time pressure; national interest supreme, says Piyush Goyal

India does not enter into any trade agreement based on deadlines and will accept the proposed trade deal with the U.S. only when it is fully finalised, properly concluded and in the national interest, Commerce Minister Piyush Goyal said on Friday.He also said that India was negotiating free trade agreements (FTAs) with different countries, including the European Union, New Zealand, Oman, Chile, and Peru.

FTAs are possible only when both sides get benefited and it should be a win-win agreement, he told reporters when asked about the proposed interim trade agreement with the U.S."National interest should always be supreme. Keeping that in mind, if a deal is made then India is always ready to deal with developed countries," Mr. Goyal said.

When asked if an interim trade agreement between the two countries was possible by July 9, he said, "India never does any trade deal based on deadline or time frame. When the deal is done properly, and is completely finalised and is in the country's interest, then we will accept it".July 9



marks the end of the 90-day suspension period of the U.S. President Donald Trump-announced tariffs imposed on dozens of countries, including India. An additional import duty of 26% was announced on Indian goods entering the U.S..He added that at present, there was no plan to visit Washington for the trade talks.

Microsoft closes its Pakistan office after 25 years



Tech giant Microsoft has announced it will shut down its limited operations in Pakistan as part of its global strategy to reduce its workforce, which various stakeholders termed on Friday as a "troubling sign" for the country's economy.Microsoft, while closing its office in Pakistan on Thursday after 25 years, cited global restructuring and a shift to a cloud-based, partner-led model.The move came as the tech giant cut roughly 9,100 jobs worldwide (or about 4 per cent of its workforce) in its largest layoff round since 2023.

Jawwad Rehman, former founding Country Manager of Microsoft Pakistan, urged the government and IT minister to engage with the tech giants with a bold KPI (Key Performance Indicators) driven plan.He said the exit reflected the current business climate. "Even global giants like Microsoft find it unsustainable to stay," he posted on LinkedIn.Former Pakistan president Arif Alvi, in a post on X, also expressed concern over Microsoft shutting down operations.

"It is a troubling sign for our economic future," he wrote.He claimed Microsoft once considered Pakistan for expansion, but that instability led the company to choose Vietnam instead by late 2022.Jawwad explained that Microsoft didn't operate a full commercial base in Pakistan, relying instead on liaison offices focused on enterprise, education, and government clients.Over recent years, much of that work had already shifted to local partners, while licensing and contracts were managed from its European hub in Ireland.

How genetic factors influence the onset and progression of Polycystic Ovary Syndrome



Polycystic Ovary Syndrome (PCOS), a multifaceted endocrine-metabolic condition, is increasingly being recognised as not only a reproductive disorder but also a genetic and lifestyle-driven health challenge that affects a growing number of women across India. While clinical attention has often centred around irregular periods and infertility, recent studies and clinical experiences point to the crucial and often overlooked hereditary nature of this condition.

Affecting an estimated 5 to 20 % of women of reproductive age in India, PCOS is now understood to be a spectrum disorder -- presenting differently across individuals. According to Dakshayani D., head of obstetrics and gynaecology at MGM Healthcare, Chennai, PCOS is a "multisystemic pathology," often seen with irregular cycles, weight gain, hirsutism (excessive growth of dark, coarse hair in women in a male-like pattern, typically on the face, chest and back), acanthosis nigricans (a skin condition characterised by dark, velvety and thickened patches of skin, often found in body folds like the neck, armpits and groin) and in some cases, infertility. She notes that some women may show classical ultrasound findings of multiple peripheral ovarian cysts and increased ovarian volume, while others may have no cysts at all."PCOS is not a uniform disease; it manifests differently from lean PCOS to obese PCOS with symptoms such as male-pattern hair growth, scanty or heavy bleeding and insulin resistance varying in severity," she adds.

The strong familial clustering of PCOS has led clinicians to view genetics as a significant component in its development. "There is strong clinical evidence that the condition runs in families," says R.K. Vidhyalakshmi, lead consultant in obstetrics and gynaecology at SRM Global Hospitals, Chennai. "First-degree relatives -- mothers, sisters and daughters have a significantly increased risk." Genomic studies support these clinical observations. Variants in genes such as CYP11a, CYP17, CYP19, INSR, LHR, FSHR, and DENND1A -- all involved in steroid hormone synthesis and ovarian function have been identified in women with PCOS. "PCOS is a polygenic disorder with no single causative gene," explains Mannan Gupta, chairman, department of obstetrics and gynaecology at Elantis Healthcare, New Delhi. "Instead, several gene variants act together with environmental triggers."Sapna Raina, clinical lead at Narayana Health City, notes that the risk of developing PCOS in women with a family history can be as high as 25-50 %, further underscoring the need for early surveillance in adolescent girls with known familial risk.

Despite its hereditary links, PCOS is highly modifiable through early lifestyle adjustments. "Maintaining a healthy weight, avoiding refined carbohydrates, and engaging in regular physical activity can delay or even prevent the onset of symptoms in at-risk individuals," says Dr. Gupta. He also recommends stress management, sleep hygiene, and periodic hormonal evaluation for adolescent girls with family history."Even a 5-10% weight loss can help regulate menstrual cycles and improve insulin sensitivity," says Dr. Vidhyalakshmi, adding that prevention starts with education and personalised counselling. Dr. Raina stresses early behavioural interventions in families known to carry a genetic risk. "Families often share not just genes but habits. Encouraging healthier food choices, reducing processed food intake and promoting physical activity from adolescence can alter outcomes significantly."Emerging therapies and personalised approachesAs understanding of PCOS deepens, treatment is moving towards individualised care models. "Pharmacogenomics and polygenic risk scoring are being explored to customise treatment based on genetic profiles," notes Dr. Gupta. "This will enable clinicians to predict which patients are likely to respond better to specific hormonal or metabolic therapies."For hirsutism, Dr. Sharona recommends laser hair reduction for long-term improvement, though medications like spironolactone, finasteride and Eflornithine-based topical creams can offer temporary relief.

Therapies such as metformin, myoinositols, oral contraceptives and ovulation-inducing agents like Clomiphene, Letrozole and gonadotrophins are tailored based on whether the primary concern is infertility, metabolic imbalance, or hyperandrogenism."There's no universal treatment for PCOS -- each patient's symptoms and hormonal profile guide the management," emphasises Dr. Sharona.Despite its high prevalence, PCOS remains underdiagnosed and underreported. "The social stigma and silence around menstrual health contributes to delays in diagnosis," says Dr. Raina, "It is time we normalise conversations around PCOS within families and schools."With clinical evidence pointing strongly towards hereditary transmission, clinicians believe that family history must be considered a key diagnostic tool -- not just a background detail. By raising awareness, integrating preventive care early and leveraging advances in genetic research, it may be possible to change the trajectory of PCOS for future generations.



What is U.S. President Trump's One Big Beautiful Bill all about? | Explained

The story so far: U.S. President Donald Trump signed into law the 'One Big Beautiful Bill' on U.S.' Independence Day on July 4, 2025. This happened a day after the House of Representatives cleared the passage of the legislation proposing sweeping tax cuts, altering access to social security programs and doing away with provisioning incentives for clean energy production, among other things. While the Opposing Democrats argue the bill effectively introduces tax breaks for the wealthiest populace offset by cuts in healthcare and food security, the Republicans contend it would unleash "massive economic growth" and avert "waste, fraud and abuse" of federal spending.

At the centre of the contention is the bill proposing to make permanent President Trump's 2017 cuts across several income brackets. This also includes rates for the highest income bracket from the present 39.6% to 37% as per the version of the bill presented to the House of Representatives. Thus, when assessing tax liability for incremental income across successive brackets (say, up to \$11,600 and then from \$11,601-\$47,500, and so forth), reducing rates across the board would translate to lowered tax liability. Conversely, this would also imply that higher earners also benefit with their liability from income across all brackets being reduced. However, the proposed legislation also enhances the standard deduction by \$1,000 for individual taxpayers, \$1,500 for heads of households and \$2,000 for married couples until 2028, that is, until the expiry of President Trump's tenure. Additionally, OBBB seeks individual taxpayer be allowed to forego up to \$25,000 in taxes they earn in tips, and \$12,500 in overtime pay. This is provided the individual income does not exceed \$150,000. The two provisions combined have been suggested to particularly benefit the working class. Broadly, concerns in the realm exist on two fronts, namely, loss of taxable income - especially the wealthier guartile and the potential impact on income, especially the working class. According to the U.S.based Yale School of Management's recent analysis, the budget passed on July 1 would add \$3 trillion in debt between 2025 and 2034. This would be about 0.84% of the GDP. Furthermore, analysing the bill proposed to the Senate, the lab estimated the lowest quartile's income would decrease by 2.5% in contrast to the higher quartile witnessing a 2.4% growth.

What happens to social security schemes for food and medical needs?

Concerns here relate to the introduction of stricter eligibility requirements potentially leading to exclusion from health and food security programmes.U.S.' Medicaid is a joint federal and state health insurance program to help people with limited income and resources cover their medical costs. The OBBB introduces an eighty-hour work requirement to be eligible for the programme. Additionally, reenrolments, which would now also entail establishing eligibility, would now have to be done every six months and not annually. Thus, as observed by U.S.-based health news publication KFF, it would translate enrolees to filing the additional paperwork more often. The White House argues the eligibility requirement would strengthen Medicaid for those who rely on it, such as pregnant women, children, seniors, people with disabilities, and low-income families. Enforcing work requirements, it held, would only eliminate "waste, fraud and abuse". However, a KFF study from 2023 observed that 64% of adults below 65 years enrolled in Medicaid were either working full or part-time. 8% were either retired or unable to find work, whilst the remainder were not working due to caregiving responsibilities, illness or disability, or school attendance. The eligibility requirement thus would be of direct consequence to the latter segment. Furthermore, the bipartisan Congressional Budgetary Office (CBO) estimated the amendment would leave 11.8 million people without insurance in 2034.A similar paradigm extends to the food security programme, the Supplemental Nutrition Assistance Program (SNAP), which helps low-income families to supplement their arocery budgets. At present, the federal government bears the entire cost of facilitating the benefits and splits the cost of administering the program with states, which operate it. Herein, OBBB envisages continued support to states based subject to error rates, or the measure of accuracy of each state's eligibility and benefit determinations, being below 6%. Anything beyond would call for states to bear 5-15% of their costs. Think tank Center for Budget and Policy Priorities' research note (June 30) observes that most of the errors are "unintentional mistakes by state agencies or families". It added, "Error rates fluctuate, sometimes significantly, from year to year. There is also a substantial lag between the end of a fiscal year and when error rates for that year are finalised." The amendment thus has prompted fears about cut in spending in the realm as well. tive Medicine reiterated the need to train healthcare workers to identify the dog bite category and administer rabies immunoglobulin (RIG) appropriately along with anti-rabies vaccine (ARV).Re-emphasising the set of scientific guidelines that healthcare workers should strictly adhere to, the directorate said two boys, who were bitten by stray dogs in Kerala, died despite being vaccinated. The reasons for their deaths could be a delay in starting post-exposure prophylaxis (PEP), improper wound cleaning, skipping of doses, failure to administer RIG for category III exposures (transdermal bites or scratches, licks on broken skin), and improper vaccine storage or administration as recommended by the manufacturer.

In a communication to district and city health officers, T.S. Selvavinayagam, Director of Public Health, said rabies PEP is life-saving only if done properly. Proper wound care, timely and complete vaccination, RIG (if indicated), and the storage of vaccines at proper temperatures are crucial, he said. They should be aware that rabies is a deadly viral infection that affects the brain and nervous system, and is almost always fatal once symptoms appear, for which the PEP must be administered correctly and promptly. Standard guidelines for rabies vaccination after a suspected or confirmed dog bite should be strictly followed. Elaborating the possible reasons for rabies death despite vaccination, the directorate said if a child had deep or bleeding wounds, RIG should be administered along with ARV. RIG neutralises the virus at the site of wound, especially in the

initial days before vaccine-induced antibodies develop. Without RIG, the virus can spread to the nervous system, even if ARV is given later, it said. If there is a delay in starting PEP even by a few days, especially with severe bites near the face or head, the vaccine may not prevent the disease. Missed or delayed dose of the vaccine and incorrect administration (wrong injection site or route of administration) could also be a cause. Improper cleaning of wounds is another possible cause, as the first and most important step is thorough washing with soap and water for at least 15 minutes. The directorate added that children were at a higher risk as the immature immune system might respond less robustly.Listing out the guidelines for PEP, the directorate said the bite should be assessed - category I (touching/ feeding animals, licks on intact skin-no PEP required), category II (minor scratches/abrasions without bleeding-vaccine only) and category III (vaccine and RIG).

No link between Covid vaccines and sudden deaths, confirms ICMR-AIIMS Studies: Health Ministry

New Delhi: Extensive studies undertaken by the Indian Council of Medical Research (ICMR), and All India Institute of Medical Sciences (AIIMS) have conclusively established no link between Covid-19 vaccines and sudden deaths, the Ministry of Health and Family Welfare said on Wednesday.Post the Covid pandemic several cases of heart attack-related death among people, especially the young were reported from across the country, and suggested a link with Covid vaccinations.

The Ministry noted that sudden cardiac deaths can result from a wide range of factors, including genetics, lifestyle, pre-existing conditions, and post-Covid complications, but not from Covid vaccines that have been found safe."Studies by the ICMR and National Centre for Disease Control (NCDC) affirm that Covid-19 vaccines in India are safe and effective, with extremely rare instances of serious side effects," the Ministry said. "The matter of sudden unexplained deaths has been investigated through several agencies in the country".This includes the ICMR and NCDC, which investigated young adults between the ages of 18 and 45 years in two complementary studies — one based on past data and another involving real-time investigation.

The first study, conducted by ICMR's National Institute of Epidemiology (NIE), explored unexplained sudden

deaths among adults aged 18-45 years in India from May to August 2023 across 47 tertiary care hospitals in 19 states and Union Territories. The study looked at individuals who appeared to be healthy but died suddenly between October 2021 and March 2023. "The findings have conclusively shown that Covid-19 vaccination does not increase the risk of unexplained sudden death in young adults," the Ministry said. The second study, currently being conducted by the AIIMS, New Delhi in collaboration with ICMR, aims to determine the common causes of sudden deaths in young adults."Early analysis of data from the study indicates that heart attacks, or myocardial infarction (MI), continue to be the leading cause of sudden death in this age group. Importantly, no major changes in the pattern of causes have been observed when compared with previous years," the Ministry said. The study identified "genetic mutations as a possible cause" in the majority of the unexplained death cases, it added. It has also been revealed that Covid vaccination does not appear to increase the risk, whereas the role of underlying health issues, genetic predisposition, and risky lifestyle choices do play a role in unexplained sudden deaths. The Ministry also called out reports making statements linking Covid vaccination to sudden deaths calling them "false and misleading".



Vivek Oberoi says he raised Rs 8,500 crore for his companies in just one year: 'Marry Silicon Valley with Marwari mindset'



Actor Vivek Oberoi said that he grew disillusioned with the film industry, which prompted him to focus on his business ventures. The actor has worked actively in Bollywood for over two decades, but is now increasingly turning to the entrepreneurial side of his life as his primary source of sustenance. In the last year alone, he said that he has raised around \$1 billion (Rs 8,500 crore) for the 12 companies that he is currently a part of; two of these companies, he said in a new interview, are ready to go public. He is said to be worth Rs 1,200 crore.

Chatting with CNBC TV-18, Vivek said that he was inclined towards business from a very young age, thanks to his father, Suresh Oberoi. "He was always an investor, he was buying and selling land, accumulating land. He made money always. Land was my first introduction. When I was nine or 10, he would suddenly show up with inventory. One year was perfumes, the other year it was electronics... I would fill it up in my backpack, and go door to door. At the end of the day, he would ask me for my 'khata book', and let me keep only the profit. He'd take the cost from me," Vivek said.Vivek said that after spending some years in the film industry, he realised that he was just going around in circles and ending up in the same place that he started. "I didn't enjoy that. It wasn't empowering. I enjoyed being there and collaborating with certain people, but collaboration needs to be a circular give-back. People need to pick people with talent, and give them advice, or a platform, or support. That's something that was missing in the ecosystem," he said, adding, "It was about either going down a spiral of pessimism, or stop banging my head against that door and open an another one instead." This is when he decided to pivot to business

He said, "I'm not averse to obnoxious capital. In the past year itself, across my companies, we would have raised over \$1 billion. That is a substantial sum. That isn't the problem. But where that capital pipeline deploys and how is that growth protected... Somewhere, you have to marry Silicon Valley with a Marwari mindset. That marriage has to happen."Vivek said that even when Bollywood producers and directors would 'copy' international films, they would infuse them with 'desi tadka'. "So, why not in business?" he asked rhetorically. In an earlier chat with SCREEN, Vivek spoke about his decision to move away from films. "It was only around 2009 when I decided I didn't want to be completely dependent on this and built my economic independence. I didn't want to be in a situation where a lobby could decide your future. Somebody could bully you into doing something because they controlled things," he

Ishaan Khatter recalls pulling Amitabh Bachchan's beard on the set of Sooryavansham: 'I was calling Bade Miyan'



On a lazy afternoon, if you flip through TV channels and land on Set Max, chances are you'll find Amitabh Bachchan's Sooryavansham playing. Though the film didn't do well in theatres when it was released in 1999, it has gained a cult following over the years. Those who grew up in the early 2000s watched Big B in a double role in the movie, but for actor Ishaan Khatter, the experience was more personal. He actually visited the sets of the film as a child, thanks to his mother, Neelima Azeem, who was part

of the film's cast. Neelima Azeem played Mrs Varun Singh in the movie, while Ishaan's father, Rajesh Khattar, played her on-screen husband.

In a recent chat with Mid-Day, Ishaan shared a sweet story from his childhood. "I think my mom once did a children's show called Navantara, and I appeared on it too. It was a talk show where she spoke about parenting and motherhood. I've always been fascinated by film sets. She once took me to the sets of Sooryavansham, and apparently, I kept saying 'Bade Miyan, Bade Miyan' to Amitabh Bachchan, because I had seen Bade Miyan Chote Miyan,' he laughed.But what happened next made the memory unforgettable. Ishaan said, "He (Amitabh Bachchan) picked me up! And my mom later told me, 'You were the only kid he lifted, and you pulled his beard!' And he just smiled and said, 'It's okay.' These are the stories I've grown up hearing from my mom."In an earlier chat with Mashable India, Ishaan shared that it was because of Amitabh Bachchan that his mother could secure an admission for him in one of the best schools in the city. "At the time, she was trying to get me admitted into a school and Jamnabai was then one of the nicest schools. She was having trouble getting admission for me there and he very kindly, personally went and spoke to the authorities," he said.

Filmistan Studios, founded by Kajol and Rani Mukerji's grandfather, sold for Rs 183 crore to real estate company

Filmistan Studios, which was one of the earliest studios in Mumbai, became the base for film shoots in the city back in the 1940s, and for decades, it stood tall holding a large part of Indian cinema's history. Now, the studio and the property it stands on, has been acquired by real estate developers Arkade Developers for a whopping sum of Rs 183 crore. The deal for the transaction was officially registered on July 3. Filmistan was founded by Kajol and Rani Mukerji's grandfather Sasadhar Mukherjee along with his brother-in-law, late actor, Ashok Kumar in 1943. Gyan Mukherjee and Rai Bahadur Chunilal were also the founders of the studio. The studio came into being after 1943 when Ashok Kumar left Bombay Talkies, another prolific studio in the city. Back in the day, studios were not just seen as places that provide their services for shoot, but as production companies that made films within the studio. For years, actors were employed by these studios on a salary system.

Known for its sound stages, outdoor sets, and accessibility to filmmakers, Filmistan served as a filming location for numerous Bollywood movies, television serials and commercial shoots for decades. However, in recent years, it saw a gradual decline as other technologically advanced studios started emerging in the city. According to Hindustan Times, Arkade Developers Limited plans to launch a project with luxury apartments having a gross development value of Rs 3000 crore. The project is reportedly scheduled for a tentative launch in 2026. The project will reportedly include 3, 4, and 5 BHK residences along with exclusive penthouses, across two high-rise towers of 50 floors each. Amit Jain, the Chairman and Managing Director of Arkade Developers took to his LinkedIn profile to confirm the news.



He wrote, "Thrilled to share that Arkade Developers has successfully acquired the iconic 4-acre Filmistan Pvt. Ltd. land parcel on SV Road, Goregaon West, for a total consideration of Rs 183 crore." He added, "This strategic acquisition paves the way for an ultra-luxury residential project on one of Mumbai's most storied addresses — popularly known as 'Filmistan Studios'."

Jain told Hindustan Times, "Filmistan Studios holds immense emotional and legacy significance for Mumbai, and we are privileged to be entrusted with shaping its next chapter. This development will go beyond being a premium address, and it will offer a thoughtfully curated lifestyle experience for a discerning few. Jurassic World Rebirth worldwide box office collection hits \$100 million in two days; highest franchise opener yet in India

Jurassic World Rebirth, despite mixed reviews from critics, has earned more than \$104.6 million within the first two days, as per a report in Deadline. The film released two days day before July 4, which kicks of an extended weekend in the US. The seventh film in the franchise kicked off with \$30.5 million on Wednesday in the US and followed it up with \$25.3 million on Thursday, making it one of the biggest midweek openings in the country. In India, the film has become the biggest franchise opener as it made over Rs 9 crore, as per industry tracker Sacnilk.

Jurassic World Rebirth global box office collectionJurassic World Rebirth received mixed reviews but the opening collections suggest that the craze around dinosaur films is far from over. The film is well on its way to becoming one of the biggest box-office successes of the year. In America and in most parts of the world, the movie rolled out on July 2, while in countries like India and France, it was released on July 4. Within two days, the movie managed to cross the \$100 million mark in the domestic market. It's now expected to pull in around \$137-138 million, including \$82 million over Friday–Sunday, according to The Hollywood Reporter. That beats the initial projections of \$100–120 million, and the three-day total is close to the \$145 million opening of Dominion in 2022.By Thursday, Jurassic World Rebirth had already brought in \$104.6 million worldwide, with \$48.8 million from overseas markets. It's now headed for a global opening north of \$260 million, possibly even higher. In China, the movie raked in around \$15.5 million by Friday, leaving Brad Pitt's F1 behind. The movie topped box-office charts with a 50% market share. In South Korea, where Johansson and Bailey personally visited for promotion, it hit \$2.8 million by Friday and stayed #1 for three days. Other strong openings include the UK/Ireland (\$4.5 million), Mexico (\$4.3 million), and Spain (\$2.4 million). In countries like Germany, Brazil, Thailand, Taiwan, and more, it is currently trending at Number 1. According to box office trend tracker Sacnilk, in India, the Gareth Edwards directorial crossed the 9 crore mark on the first day of its



release. On its opening day, the film beat Bollywood films like Kajol's Maa and Anurag Basu's Metro In Dino, alongside Brad Pitt's F1, which was going strong in the country ever since its release. In India, Rebirth has become the highest-grossing Jurassic instalment yet, surpassing the 2022 release Dominion, which grossed Rs 8.15 crore net and Rs 11 crore including paid previews. The movie, made on a budget of \$180 million, also stars Mahershala Ali, Rupert Friend, Manuel Gracia-Rulfo and Ed Skrein in key roles. If compared to the last three Jurassic World movies, all of them opened higher in the US (\$145 million–\$208 million range), but those had the original trilogy factor. With Rebirth, the franchise is entering its new era.

The movie goes back to the Jurassic roots. The story follows an extraction team on a dinosaur-infested island. The mission is to obtain the dinosaur's DNA, which can be a lifesaver for mankind. Meanwhile, Brad Pitt's F1 movie has now entered its second weekend and has already crossed \$200 million worldwide (\$77.4 million from the US and \$125 million from overseas.) On Thursday, it added \$6.1 million, bringing its U.S. total to \$88.5 million. For me, it was definitely a situation that needed to be handled, but it was not a big deal." he said.

"I don't want to sound as if I'm preaching because I have nobody to preach to. But if you don't allow anything to become a big deal, then you will not let anything affect you too much, which is good. Because small, unnecessary things affect us and waste our lives. We don't realise it. So my thought process is a bit like this," he said. dent in Spain on Thursday."I know Wimbledon is usually not very flexible with attire," Borges said. "But I was told we could still do something to pay our respects for what happened, so I think it was a nice gesture. He was a great footballer. It was a tragedy."Borges, who lost a five-set thriller, said his agent had even tried to source a white version of the football shirt to comply with dress rules, but it was not approved."We initially talked about getting a full jersey to walk on court," he said. "I even tried to find one in white, but it was turned down, so we ended up doing something a little smaller." Asked if Wimbledon should have allowed the shirt, he said: "I think that's what makes Wimbledon special and different from every other slam, so I really don't know. Wimbledon relaxed its 148-year-old dress code in light of Jota's death, allowing players to wear black ribbons or armbands.Borges wore that along with fellow Portuguese doubles player Francisco Cabral.Cabral said, "Yesterday the idea of wearing a black strap came up - that was not allowed. I asked for permission to use the black ribbon and they let me play with it. He was an inspiration not only for me but for the country in general. He made so much in the sport and conquered so much in my life. If I helped one per cent for the family I will be super happy."

(X)India's teenage sensation Vaibhav Suryavanshi smashed a blistering century in the India U19 vs England U19 4th Youth ODI match on Saturday as he continued his meteoric ascent. The 14-year old took 52 deliveries in an innings studded with 7 sixes and 10 boundaries.This was the fastest century ever in the history of youth ODIs. The youngster ultimately scored 143 runs off 78 deliveries.

The teenager burst into the scene in October 2024 when he etched his name in the history books as he became the youngest player to score an international century. Vaibhav scored 104 off 62 balls in India Under-19's Youth Test against Australia in Chennai.A month later, Vaibhav Suryavanshi became the youngest player to be signed in IPL history as he ignited a bidding war between Rajasthan Royals and Delhi Capitals, with the former ultimately securing him for a handsome sum of Rs 1.1 crore.During the IPL this year, his fame became stratospheric when he smashed a 35-ball century for Rajasthan Royals against Gujarat Titans – the fastest by an Indian in IPL history and the second-fastest overall. In the last match, Suryavanshi continued to display his belligerent big-hitting capabilities as he lit up India U19's stellar four-wicket win over England U-19 in the third Youth ODI. In a rain-affected contest that was trimmed to 40 overs, England racked up 268 for six on the back of captain Thomas Rew's unbeaten



76 off 44 deliveries. However, it was the Suryavanshi show that dominated the match in the second half as he stormed his way to a 20-ball fifty to get India's chase off to a blistering start. The 14-year-old dashing southpaw smoked nine sixes and six fours before falling short of a sensational century on 86 in only 31 deliveries, his highest score in six youth ODIs for India. Aided by the roaring start, India chased down the 269-run target in only 34.3 overs.Suryavanshi's 20-ball half-century is only bettered by Rishabh Pant among Indian batters in youth ODIs. The current India Test vice-captain had slammed an 18ball fifty against Nepal U19 back in 2016. Suryavanshi's nine sixes also break the Indian record in all youth ODIs, surpassing Raj Angad Bawa and Mandeep Singh's previous joint record of eight maximums each. The Rajasthan Royals batter made 78 of his runs in boundaries, amounting to 90.69 per cent of his total score. Only three other Indians - Pant, Sarfaraz Khan and Manan Vohra - have recorded a higher percentage of runs in boundaries in a

(AP)After India gained a 180-run first innings lead in the second Test at Edgbaston, KL Rahul and Karun Nair ensured that India leads England by 244 run at the end of the third day's play. With two more days remaining in the Test, India will look towards building a huge second innings total before they put England to chase the target. With England scoring 407 runs in their first innings in 89.3 overs at a run-rate of 4.54, former captain Nasser Hussain has termed the shorter recovery time for the bowlers to rest due to Bazball as a negative of England's aggressive approach.

"India know they need time to bowl England out, it's still a very good pitch. That's why I think they've been positive tonight, which is the right approach. Also they're taking advantage of tired bowlers. That's the negative of Bazball, these bowlers hardly get a rest," Hussain told Sky Sports After India had reduced England to 84 for 5 in their first innings, with India posting a mammoth total of 587 in their first innings, Harry Brook and Jamie Smith stitched together a 303-run sixth-wicket partnership in 368 balls. It was also England's second-highest sixth-wicket partnership in Tests. While England lost their last five wickets quickly with their first innings folding at 407 runs and handing a 180-run first innings' lead to India, Hussain praised the quick scoring by Brook and Smith but also found the England bowlers tired due to England batting quickly. "Watching this England team is just so much fun, long may it continue. One of the consequences of Bazball, though, is their bowlers bowl so quickly - on flat pitches in back-toback matches they're coming in tired. They look tired and frazzled." Hussain said.

While Brook scored his ninth Test hundred with his knock of 158, England wicket-keeper Jamie Smith scored his second Test hundred with an unbeaten knock of 184 runs off 207 balls. Hussain termed Smith's knock as 'Bazball with brains'. "He (Jamie Smith) didn't look reckless, it was more Bazball with brains. Anyone who has watched Surrey and England will know he is a man of talent. More than his ability, I like his calmness and attitude. He looks like he is meant to be playing here," Hussain said.

Roger Federer missed most of the 2016 season due to injury, but at the age of 35 he made a miraculous comeback to win the 2017 Australian Open, his first Grand Slam title since 2012. Félix Sánchez, a 400m hurdler was unbeaten for 43 races from 2001 to 2004 winning Olympic and 2 world championship Golds in that period. For 8 years he then struggled and was ranked 7th going into the 2012 Olympics, but against all odds he won a second Gold, 8 years after his first.Sindhu's place in history is already secured by her medal haul at the Majors. And it is certainly possible Sindhu, like Federer and Sánchez, could write yet another chapter in her remarkable career. Because, while circumstances may change, the character and mindset of a champion endures.
