## Genome Valley contributes 33 percent of vaccine production in India: CM Revanth



Hyderabad, July 15 Chief Minister Revanth Reddy has announced that Genome Valley alone contributes to 33 percent of the vaccine production in the country.Revanth Reddy, accompanied by Industries Minister Sridhar Babu, officially laid the foundation stone for

a new ICHOR Biologics facility at Genome Valley in the Medchal-Malkajgiri district on Tuesday. ## Shubhanshu Shukla, Axiom-4 returns to Earth after 18-day stay at ISS

New Delhi: Astronaut Shubhanshu Shukla and three others of the commercial Axiom-4 mission made a fiery return to Earth as the Dragon 'Grace' spacecraft made a splashdown off San Diego coast in southern California on

Tuesday, capping a 22.5-hour journey after an 18-day stay at the International Space Station. The spacecraft carrying Shukla, commander Peggy Whitson, and mission specialists Slawosz Uznanski-Wisniewski of Poland and Tibor Kapu of Hungary, undocked from the space station at 4:45 pm IST on Monday. "Splashdown of Dragon confirmed - welcome back to Earth, @AstroPeggy, Shux, @astro\_slawosz, and Tibi," SpaceX said in a post on X. SpaceX boats of SpaceX, the transporter for the mission, were seen moving towards the spacecraft to bring it to recovery ship Shannon, where the astronauts will be brought out from the capsule. The Axiom-4 crew will undergo a series of medical checks on board the ship before boarding a helicopter for a ride back to the shore. The four astronauts are expected to spend seven days in rehabilitation as they adjust back to life on Earth under the influence of gravity, unlike the weightlessness experienced in orbit.

## UIDAI urges parents of children between five and seven to update Aadhaar biometrics

The Unique Identification Authority of India (UIDAI) on Tuesday (July 15, 2025) urged parents of children between the age of 5 and 7 to update their kids' Aadhaar biometrics. In the periodic reminder, the UIDAI said that the biometric update would be free of cost at enrolment centres, if done before children turned seven. After this period, the authority said it may cancel Aadhaar numbers issued to those who have not done the biometric update. A ?100 fee applies if such an application is made after a child turns seven. Aadhaar with updated biometric facilitates ease of living and ensures seamless usage of Aadhaar in availing services such as school admissions, registering for entrance examinations, availing benefits of scholarships, DBT (Direct Benefit Transfer) schemes, etc wherever applicable," the UIDAI said. "Parents/ guardians are advised to update biometrics of their children/ wards in Aadhaar, on priority," it added. The Aadhaar is-



suer said it has started sending SMS messages to the mobile numbers registered in the Aadhaar of such children for completing the MBU exercise. "The fingerprints and iris biometrics of a child are not captured for Aadhaar enrolment below the age of five because these are not mature at that age," the UIDAI said.

The year was 1961 and the film 'Sasural', a remake of a Felugu film 'Illarikam'. Irrespective of the strong overhang of the Madras- style narration, Bangalore Saroja Devi, vho made her debut in three Dravidian languages in the 950s, (apart from Hindi with 'Paigham' in 1959) made a otable impact across the borders with this L V Prasadroduced, T Prakash Rao directed movie in Bombay. With his, she also became one of the earliest south-based heroines who managed to hit the bull's eye in Hindi, without losing out on her base back home. A striking aspect of this Kannadiga-origin star was that she managed to act in 100 films exclusively in Tamil (out of a total of around 200), accepted and appreciated for her parrot-like tone of he ancient language, which earned her the sobriquet Kannadathu Paingili'....A career which began when she vas barely an adult in 1955 went on to last till 2019, a ecord 64 years overall. Of course, the spotlight had shifted from her in the mid-1960s, when younger herones caught the attention of the then middle-aged heroes of Madras - MGR and Sivaji Ganesan. Even then, till nother Karnataka counterpart J Jayalalithaa overtook er in the southern film industry (of having acted in the naximum number of films with these two titans), Saroja Devi had acted in 45+ films with both of them, many of hem enduring entertainers till date, noted for their torytelling, histrionics and evergreen songs. Having beun with Akkineni Nageswara Rao in 1959 ('Pelli Sandhadi'), she had a good run in her hometown when he was successfully paired with the matchless matinee

#### Telangana refuses to discuss Banakacherla project in Delhi

Hyderabad, July 15: Ahead of the important meeting at the Chief Minister level between Telangana and Andhra Pradesh, set to occur in Delhi on Wednesday with Union Jal Shakti Minister CR Patil present, the Telangana government has declined to engage in discussions regarding the Banakacherla project. Expressing objections to Andhra Pradesh's request to make the Banakacherla project in the Krishna basin the sole agenda item for the July 16 meeting, the Telangana government submitted a letter to the Centre on Tuesday morning, merely 24 hours before the scheduled meeting between Telangana Chief Minister A. Revanth Reddy and Andhra Pradesh Chief Minister N. Chandrababu Naidu. The Telangana government has stated that discussion of the Banakacherla project is unnecessary, labeling it as irrelevant and not authorised. The correspondence emphasised that the project has yet to obtain approvals from crucial regulatory authorities, including the Godavari River Management Board (GRMB), the Central Water Commis-

sion (CWC), and the Expert Appraisal Committee (EAC) Moreover, the State government cautioned that considering such proposals could jeopardize the integrity of the regulatory bodies of the Central Government, as well as that of the Centre itself. Furthermore, the State government reiterated that there is no requirement to address the Banakacherla project during the upcoming meeting led by Union Minister CR Patil. Instead, the proposal has put forward approvals for ongoing projects on the Krishna river. The government has included in its agenda the request for national status for the Palamuru and Dindi initiatives. Additionally, it has called on the Centre to take control of the Ichchampally project and to allocate 80 TMC for the Pranahita project at Thummadihetti. The Telangana government has also suggested a new project designed to utilise 200 TMC of flood water. It emphasised that these matters are longstanding, legitimate, and essential for the fair distribution of water resources between the two States

#### CPI leader Chandu Naik shot dead

Hyderabad, July 15 Senior CPI leader Chandu Naik (43) was fatally shot by unknown persons while he was taking his regular morning walk at Shalivahana Nagar Park in Malakpet on Tuesday morning. Chandu, originally from Narsaipalli in the Balmoor mandal of Nagarkurnool district, had been residing in the Malakpet area and was visiting the park as part of his routine when the tragedy occurred. Upon learning of the incident, South East Deputy Commissioner of Police Chaitanya Kumar promptly arrived at the scene to investigate. Following the inspection, he informed the media that the shooting happened around 7:30 AM and the deceased was identified as Chandu. At the time of the attack, Chandu was reportedly walking on the track with his wife and daughter when a group of four unidentified men arrived in a white Swift Dzire car. They confronted the CPI leader and initially threw chili powder at him.

As Chandu Naik tried to escape the area, they opened fire at him, discharging six shots from close range. He sustained serious gunshot injuries, fell to the ground, and died instantly, according to the police. The police suspect that Chandu's murder is connected to disputes over land. "It has come to our attention that he was implicated in a murder case registered within the jurisdiction of the LB Nagar police station. We are currently verifying the specifics of that case," the police said. Seven bullets were recovered from the scene. Ten teams have been formed to locate the suspects. The forensic team gathered evidence at the site, and DCP Chaitanya Kumar indicated that the bullets found appeared to have been fired from the same firearm. A forensic unit has arrived at the location to gather further evi-

They are reviewing CCTV footage from both the crime scene and nearby areas in an effort to identify and apprehend the perpetrators as quickly as possible. Police believe that a prior rivalry involving property disagreements and financial dealings may have contributed to the murder. Chandu's wife has claimed that he had a longstanding conflict with a man named Rajesh, who is also associated with the CPI (ML) party and hails from Devaruppala. In addition, reports indicate that four individuals have turned themselves in to the police regarding the incident, though officials have not yet verified this information.

#### **Ex-irrigation chief engineer** Muralidhar Rao arrested in DA case

Hyderabad, July 15 Muralidhar Rao, a retired engineer-in-chief of the irrigation department, was arrested by ACB officials in Jubilee Hills on Tuesday on charges of possessing disproportionate assets.

According to ACB officials, a case has been filed against Muralidhar Rao under the Prevention of Corruption Act, following preliminary evidence that indicates he has amassed wealth significantly beyond his recognised income sources during his time in office. He is currently in ACB custody and is being interrogated. Ongoing ACB searches are taking place at the residences of Muralidhar Rao's relatives and close associates in Hyderabad, Karimnagar and Zaheerabad Muralidhar retired in 2013 in undivided Andhra

Pradesh but got multiple extensions. Following the formation of Telangana State, Muralidhar Rao's service was extended for an additional 13 years. He continued to work for a period after the Congress government took office. However, the state government has recently removed Muralidhar Rao following a vigilance report related to the Medigadda project. Recently, the Anti-Corruption Bureau (ACB) has investigated officials involved in the Kaleshwaram irrigation project. It has been reported that the ACB has already apprehended former Kaleshwaram Engineer-in-Chief Hari Ram and Executive Engineer Nune Sridhar. Currently, the ACB is conducting raids at the residence of former Engineer-in-Chief Muralidhar Rao,

### FGG urges CM to Streamline the procedure for quick disposal of ACB cases

Hyderabad, July 15: Forum for Good Governance (FGG) on Tuesday urged the Chief Minister Anumula Revanth Reddy to streamline the procedure for quick disposal of ACB cases. In a letter addressed the Chief Minister, Forum for Good Governance President M. Padmanabha Reddy said rampant corruption in administration is causing lot of sufferings to common man. In Government offices, especially in departments like Municipal Administration, Revenue, Police etc. unless bribes are paid people are not able to get the things done. We see in newspapers regularly the ACB is registering cases against corrupt officials but such cases are a tip of the ice-berg compared to the level of corruption that is prevailing in administration, he added. The cases registered by ACB are not prosecuted quickly. Permission to prosecute from Government is delayed and manipulation take place in concerned department of Secretariat, he added. In the letter cited few examples ie. Jagadeesh Babu Assistant Engineer of Panchayat Raj department working at Kalvarampoor of Peddapally district was caught on July 12, 2025 while taking bribe of Rs.90,000 from a contractor. The same A.E. was caught earlier by ACB in 2017 while taking Rs 1.5 lakhs bribe in Kareemnagar. While ACB case of 2017 is pending, he was given plum posting and caught by ACB second time July 12,2025. This is not an isolated incident. There are number of employees who were caught second time by ACB and nothing is happening to them thanks to Secretariat. In another case, D. Srinivas Reddy Deputy Commercial Tax officer was booked by ACB (FIR No. 04/RCT-ACB-NZB) on July 6, 2018. Since

last 7 years no charge sheet was filed in the Court. When his promotion was due he approached High Court and got orders to consider his promotion to the post of C.T.O. without reference to ACB case as charge sheet was not filed in Court. In the state the employees have no fear of punishment for corruption. In this regard Forum for Good Governance suggests few proposals for quick and successful disposal of ACB cases including once ACB registers the case, inquiry to be completed in three months and sent to Vigilance Commission. The Commission should send the case with their advice within two weeks to the Government. The concerned department in Secretariat should act on the inquiry report of ACB and the advice of Vigilance Commission and take decision within one month. Whenever ACB requests for permission to prosecute the tainted officials and the Vigilance Commission concurs, permission to prosecute must be accorded. The case once filed it should be vigorously pursued in Court to get conviction in a years' time. Now the cases registered are taking eight to 10 years for their logical conclusion. The percentage of success of ACB cases is hardly 60%. It should be improved by quick and proper filing of Charge Sheet and producing evidence and witness. The employees caught by ACB should not be given postings till the case is disposed ACB is registering almost 20 cases per month, due to delay and acquittal of cases people have lost confidence in effectiveness of ACB in controlling the corruption. Forum for Good Governance requests the Chief Minister to streamline the procedure for quick disposal of ACB cases.

#### Delhi court reserves order on Engineer Rashid's plea to attend Parliament

Engineer Rashid interim bail plea, Baramulla MP bail request, Delhi court reserves order Rashid, Rashid monsoon session Parliament, Earlier this year, the Delhi High Court had allowed Engineer Rashid to attend Parliament on two occasions - on March 10 and February 25.A Delhi court Tuesday reserved its order on an interim bail plea by Baramulla MP Engineer Rashid for attending the monsoon session of Parliament starting July 21. Rashid, who defeated National Conference leader Omar Abdullah in the Baramulla seat by over two lakh votes in the 2024 Lok Sabha polls, has been lodged in Tihar jail since 2019 in a 2017 terror funding case. Represented by advocates Aditya Wadhwa, Vikhyat Oberoi and Nishita Gupta, Rashid argued in court that he should either be granted interim bail or permission to attend Parliament in custody, without payment of travel costs. The lawyers also argued that Rashid had been granted interim bail in September last year for campaigning for the elections and since this bail had been extended thrice, he could not be considered a security threat. Opposing his plea, the National Investigation Agency (NIA) argued that Rashid should not be granted bail and if he is allowed to attend Parliament in custody, then he should be made to pay the travel expenses. Rashid's lawyers argued that he shouldn't be made to pay travel expenses as he was seeking to attend Parliament as his public duty and not for some



personal work. After hearing the arguments from both sides, Additional Sessions Judge Chander Jit Singh reserved the order for July 21. Earlier this year, the Delhi High Court had allowed Rashid to attend Parliament on two occasions – on March 10 and February 25. ## Primary cooperative societies should become one stop centres - Minister Tummala

Hyderabad, July 15 State Agriculture Minister Tummala Nageswara Rao today participated in a conference organized by NCDC and Cooperative Union with 311 FPO as the chief guest at Prof. Jayashankar Telangana Agricultural University in the city . Speaking on the occasion, the Minister said that the cooperative credit societies should change their perspective in line with the current needs and the changes taking place in the agricultural sector. "They should not be limited to just one or two services but should contribute to the design of all services related to farmers. In addition to achieving financial prosperity, they can also be beneficial to farmers. On this occasion, mentioning the successes of Mulkanur Cooperative Credit Society, which is in Telangana and has become a role model in the cooperative sector across the country," he said while noting that if cooperative societies carry out their responsibilities ethically and honestly and contribute to the development of the society, there will be opportunities for more cooperative societies like Mulkanur to emerge in our Telangana state.

He said that In the context of the Government of India encouraging the formation of 10,000 Farmers' Producers' Associations, the State Government had come up with the idea of converting the existing Primary Cooperative Credit Societies into 'Farmers' Producers' Associations' and providing them with more financial support. "Accordingly, in collaboration with the 'National Cooperative Development Corporation', the detached Telangana Cooperative Union has been designated as a cluster based business organi-

zation and through it, 311 cooperative credit societies in the State have been selected as FPOs. An equity grant of Rs. 15 lakhs each and a management cost of Rs. 18 lakhs (total Rs. 33 lakhs) i.e., approximately Rs. 167.93 crores (Rs. 21 lakhs given by CBBO / Rs. 40 lakhs with FPO) has been sanctioned to the 311 FPOs. Today, the first tranche of Rs. 9 crores 85 lakhs 40 thousand (per PACS) has been released," he said. He noted that as per the Central Government guidelines, there was a loan guarantee facility of up to Rs. 2 crore for each FPO as part of the Credit Guarantee Scheme and added that the State Government was ready to provide all kinds of support to the cooperative societies to make them financially stable while noting that it is the responsibility of each member to take advantage of them and grow. #### No delay in development works, warns Seethakka; Shabbir Ali urges strict health measures

Hyderabad, July 15 In-charge Minister Dansari Anasuya (Seethakka) and Government Advisor Mohammed Ali Shabbir conducted a detailed review meeting with officials at the Kamareddy District Collectorate on Tuesday, focusing on the progress of various government-led development initiatives. The review covered key sectors such as medical and health services, Indiramma housing, land records (Bhu Bharati), drinking and irrigation water supply, agriculture, fertilisers and seeds, women and child welfare, sanitation, greenery promotion under Vana Mahotsavam, and other public welfare schemes.

Addressing the officials, Shabbir Ali stressed the urgent need for proactive measures to prevent seasonal diseases like dengue and other viral infections during the ongoing monsoon season. He instructed medical and municipal departments to clean and purify all drinking water tanks regularly and ensure that drainage systems are cleared without delay. To contain mosquito breeding, he directed that fumigation and mosquito-control operations be conducted across vulnerable areas. He added that health camps should be immediately set up wherever outbreaks are reported and that officials must offer proper guidance and awareness to the public. Highlighting the risks posed by monsoon-related diseases, he warned that negligence in these matters could lead to serious consequences.

Minister Seethakka took strong exception to delays in developmental works despite the release of funds over six months ago. She expressed displeasure at the slow pace and warned officials that negligence would not be tolerated under any circumstances. She directed that all projects must be completed within their scheduled timelines, and said strict disciplinary action would be taken against any department found responsible for delays. She specifically called for expedited completion of works related to the sup-

plv of safe drinking water, including Godavari water projects AMRUT-1 and AMRUT-2 schemes, sanitation, road and drainage systems, and central lighting. She also reviewed progress under the Indiramma housing scheme and instructed officials to ensure the transparent and uninterrupted supply of free sand to beneficiaries, without scope for irregularities or inconvenien The minister also announced that the construction of new Anganwadi buildings would begin soon. She reiterated that the Congress government was committed to strengthening women and child welfare, and said increased focus would be given to schemes in this sector.On the agriculture front, she assured that the government was taking every step to avoid shortages of seeds and fertilisers. Timely supply would be ensured so that farmers face no disruption in cultivation during the season. Environmental sustainability was also emphasised during the meeting. Seethakka directed officials to actively participate in Vana Mahotsavam activities and take up largescale plantation and greening programmes as part of the government's commitment to improving rural and urban ecosystems. The minister further sought detailed reports on all approved projects, including tender status, fund utilisation, and reasons for delays. She directed officials to immediately clear any pending bills and ensure that no work is held up due to administrative hurdles. She said that the officials must take personal responsibility for progress in their departments, and that any further delays or lapses would invite serious action. ## Cops accused of evidence tampering in Gurgaon school murder case challenge summons, cite absence of prosecution sanction

The Punjab and Haryana High Court on Monday sought responses from the Central Bureau of Investigation (CBI) and Haryana to petitions filed by senior police officers challenging a CBI court's decision to summon them for trial in connection with the 2017 murder of a student at a Gurgaon school. The officers have been accused of tampering with evidence and falsely implicating school bus conductor Ashok Kumar in the murder of a seven-year-old boy on the school campus. The petitions came up before Justice Manjari Nehru Kaul, who issued notices to the CBI and the state government.

Senior advocates Bipan Ghai and Vinod Ghai, along with advocates Nikhil Ghai, Arnav Ghai, Akhil Godara, and R S Bagga, represented the petitioners. They argued that the magistrate's decision to take cognisance of the case against the officers was legally unsound, as the order was passed without obtaining prior sanction for prosecution, which is mandatory under the law when public servants are alleged to have committed offences while discharging official duties. The lawyers pointed out that in an earlier order passed in 2021, the same magistrate had declined to



take cognisance for precisely this reason—the absence of sanction. "Now, without any fresh sanction, and merely on an application by the complainant, the magistrate has reviewed that decision and taken cognisance. This is not legally permissible," they contended The petitioners further argued that the officers, including an assistant commissioner of police, were acting in their official capacity during the initial investigation and are therefore entitled to protection under the law. On the court's direction, Deputy Advocate-General Karan Sharma appeared for Haryana, and advocate Prateek Gupta accepted the notice for the CBI.

A total of 6.3 kg of the drug, valued at approximately Rs 63,000, was found in the bag. To confirm the nature of the substance, the railway police sought assistance from the Forensic Science Laboratory (FSL), a team from which came to conduct an on-spot analysis that confirmed the substance. Following the seizure, a case was registered under the Narcotic Drugs and Psychotropic Substances (NDPS) Act at the Kalupur Railway police station. Further investigation is underway.

Shinde said, "Pune city and Mahatma Gandhi have a historical and deep connection. His 21-month detention in the Aga Khan Palace in Pune during the freedom movement, as well as the fast and agitation he conducted here,



are part of the memories of Gandhian thoughts in the city.""The statue of Gandhi at the railway station area is the centre of faith and national identity for lakhs of citizens. This incident is not only a desecration of the statue, but it is an attack on the progressive ideological heritage of Pune and social harmony," he added. Noting that such incidents are happening frequently, he said, "We demand that the accused not be declared mentally ill and released without consequences. He should receive the strictest punishment." #### 'We will approach court to bring them back': Families of migrants pushed into Bangladesh lodge missing diary with Bengal police

Family members of a husband, wife, and son who were allegedly pushed into Bangladesh after they were detained in Delhi for "being illegal immigrants" dged a missing diary with the Paikar nolice in West Bengal's Birbhum. They plan to approach the Calcutta High Court, seeking the residents' return.

Danish Sheikh, his wife Sunali Khatun, and their eightyear-old son — natives of Paikar village — were allegedly deported to Bangladesh on June 26, days after being picked up by the Delhi Police. The family said they had been working as ragpickers in Delhi for the past 20 years. According to the family, the deportation was carried out despite them allegedly submitting documents to prove their nativity of Ben-

On Sunday, Sunali's father, Bhodu Sheikh, lodged a missing diary at the local police station. He said Danish, Sunali, and their two children had left for Delhi from Paikar on May 5. "Since July 4, we have not been able to contact them," he said. The Migrant Labour Welfare Board in West Bengal said it would help the family move the Calcutta High Court with a habeas corpus plea. "This is happening every day. Our migrant labourers and their families are being targeted as illegal Bangladeshis simply because they speak Bengali... We will appeal to the court to intervene, bring the family back to India and present them before the court," said Samirul Islam, chairman of the board."I have filed a missing diary at the local police station. Tomorrow we plan to go to Calcutta High Court. My daughter, her husband and their eight-year-old son were detained by Delhi Police and pushed into Bangladesh. My daughter has made fran-



tic calls from Bangladesh," said Bhodu Sheikh, speaking to The Indian Express from Birbhum. Family members claimed Danish, Sunali and their minor son were detained on June 18 by the police and taken to the K N Katju Marg police station in Delhi. "All documents, including land deeds, were provided to the police. But they didn't budge," said Sunali's cousin Roshni Bibi, speaking over the phone from Delhi. "Their second child, a girl, was not detained as she was staying with a relative." However, the Delhi Police maintained that the family was deported after due process. "They were deported to Bangladesh on June 26 after proper verification at the local police level and a thorough interrogation by the Foreigners Regional Registration Office. They hail from Bagerhat, Bangladesh," Rajeev Ranjan, DCP (Rohini), told The Indian Express earlier. The case comes amid a spate of similar incidents in Gujarat, Maharashtra, Delhi and Madhya Pradesh. On June 14, seven persons from West Bengal were allegedly detained by Mumbai Police and deported by the BSF at around 3:30 am. Following intervention by the Bengal government, four youths from Murshidabad, one from Purba Bardhaman, and a married couple from North 24 Parganas were brought back from Bangladesh and sent home.

#### Sushant Lok RWA funds borewell pump repair amid 'neglect' by municipal corporation

A resident welfare association in Gurgaon Sector 55 has used its funds to repair a water pump after the municipal corporation allegedly failed to address an acute water shortage that affected over 1,000 families for days. Members of the RWA of Sushant Lok Blocks A and A1 have accused the civic body of neglect and poor contractor oversight. "We have been highlighting our water problem for two years now, but there has been no help. Last month, the contractor installed a pump that failed in just two weeks, used substandard motors and wires, and the Municipal Corporation of Gurugram did nothing. Why hire such contrac-

tors? For five days, families suffered without water. Even now we are struggling and get water only once a day, another pump being maintained by the civic body is also in need of urgent repair," said RWA president Vinita Sinha, adding that the repair, undertaken at a cost of Rs 5,000,

Adding to the residents' woes, the Department of Town and Country Planning (DTCP) issued notices threatening to cut water and sewer lines in the area-a move Sinha described as ironic given the non-functional water supply and overflowing sewers. Residents also face challenges in contacting officials of the municipal corporation, Sinha said. "We do not know who is responsible for our area. The numbers on the website yield no response; for everything we cannot go to the commissioner or a higher official," she added. When contacted, Executive Engineer Sandeep Sihag said he was not aware of the issue as the RWA had not complained to him. "We have resolved such issues fully when concerned RWAs/sectors have recently come forward." he said.

The Indian Express tried reaching out to Subdivisional Officer Kuldeep Kumar for comment. This report will be updated if Kumar comments. Last month, the Gurugram Metropolitan Development Authority (GMDA) directed the municipal corporation to disconnect illegal and direct connections made on master water supply pipelines of the GMDA and the civic body. The move, once implemented, will mean that there will be no direct water supply to households without it being rerouted through the designated boosting stations that regulate pressure and flow. The decision was taken following reports that certain housing societies were installing water pipelines routed from the master water supply lines of the GMDA and the municipal corporation

Over the last two days, dozens of investors have approached the Ramamurthy Nagar police station in east Bengaluru with complaints against A&A Chit Funds, operated by A V Tomy and Shini Tomy. The investors approached the police after finding the chit fund firm's Ramamurthy Nagar office locked and the couple inaccessible on their mobile phones. In one of the cases, the police registered an FIR on July 5 on the basis of a complaint lodged by P T Savio, 64, a Ramamurthy Nagar resident and an investor in the chit fund firm. He alleges that he was defrauded out of Rs 70 lakh by the couple. According to Savio's complaint, the Tomy couple had run the chit fund and finance business in Bengaluru since 2005, attracting hundreds of small and large investors with the promise of



high returns. The funds deposited by the investors were al legedly being collected in the bank accounts of the firm and the private accounts of the couple. "They have collected Rs 70 lakh from me and my family and several crores from others. When we visited the office of the company, we found it closed and the couple were missing. Their phones were also switched off," reads Savio's police complaint. The Ramamurthy Nagar police have registered a case under section 4 of the Chit Funds Act 1982, section 21 of the Banning of Unregulated Deposit Schemes Ordinance 2019, and under sections 318 and 316 of the Bharatiya Nyaya Sanhita for cheating and criminal breach of trust.

#### Delhi HC dismisses Turkey-based firm's plea seeking to set aside order revoking its security clearance

Setback for Celebi: Delhi HC dismisses Turkey-based firm's plea seeking to set aside order revoking its security clearanceAt least seven airports in the country cancelled the services of Celebi and its subsidiaries.

The Delhi High Court on Monday dismissed a plea by Turkey-based ground handling services provider Celebi Airport Services India Private Limited seeking to set aside the Centre's order revoking its security clearance in the aftermath of Operation Sindoor. While the detailed judgment is yet to be made public, Justice Sachin Datta pronounced in open court that the petition stands dismissed. The Centre, through the Ministry of Civil Aviation, had revoked the security clearance granted to the firm on May 15 "with immediate effect in the interest of National Security". The decision came following the backlash in India over Turkey's support to Pakistan during the India-Pakistan conflict.

At least seven airports in the country cancelled the services of Celebi and its subsidiaries. The firm has challenged the contract cancellations before the high courts of Madras, Bombay and Gujarat, besides challenging the security revocation before the Delhi High Court. While the pleas are pending in the Gujarat and Bombay high courts, in light of the orders reserved at the Delhi High Court in May, the Madras High Court had in June granted interim protection to Celebi Ground Services Chennai Pvt Ltd under section 9 of the Arbitration and Conciliation Act, 1996. The firm was



incorporated in India in 2009 as Celebi Ground Handling Delhi Private Limited and subsequently changed its incorporated name to Celebi Airport Services India Private Limited in 2018. The company was granted security clearance in 2022 which was to be valid for five years. The firm, in a communication to several authorities, including the Ministry of Civil Aviation, the Bureau of Civil Aviation Security (BCAS) as well as the Ministry of Home Affairs on May 14, had stated that while its ultimate parent holding company -Celebi Aviation Holding – is incorporated in Turkey, over 65 per cent of its ownership rests with international institutional investors, adding that in India, it is "very much a domestic operation". It also stated that it has invested over \$250 million in India and has been operating in the country for 17

#### Gangster part of Kapil Sangwan's Punjab 'module' arrested for orchestrating shooting of hotelier in Haridwar: Delhi Police

delhi policeOn June 30, the Northern Range of the Special Cell received an input regarding Sunny's presence in the Narela area of Outer Delhi and arrested him. The Delhi Police Sunday said they arrested an 18-year-old man, who is part of gangster Kapil Sangwan's Punjab 'module', for allegedly orchestrating a firing at a hotelier in Haridwar as he was too "close" to members of incarcerated gangster Manjeet Mahal's gang. According to the police, the accused, Sami Khan alias Sunny, was one of the shooters who fired at hotelier Arun alias Sukha, whose cousin is a henchman of Mahal, near Haridwar on June 2."An incident of firing on a hotelier near Sukhi Nadi, Khadkhadi, Haridwar was reported at Kotwali police station in Haridwar. It was found to be the handiwork of gangster Kapil Sangwan aka Nandu, who sent his shooters to eliminate Arun aka Sukha of Rohtak, for being in touch with a key member of rival Manjit Mahal gang," said Amit Kaushik, Deputy Commissioner of Police (Special Cell). The Special Cell was working on the case after the links of the shooter to Kapil Sangwan emerged. The Haryana-Punjab module of UK-based Sangwan is often used to eliminate targets in the Delhi-NCR

and neighbouring states, the police said. "Sources were deployed in Outer Delhi, Haryana and Uttarakhand, which revealed that Sangwan used a Punjab-based module to eliminate targets in Haryana or Delhi. Once Arun was spotted at Haridwar, Sangwan redirected his shooters to reach Haridwar and neutralise the target," DCP Kaushik said.On June 30, the Northern Range of the Special Cell received an input regarding Sunny's presence in the Narela area of Outer Delhi and arrested him. During interrogation, Sunny revealed that he fled to Nepal immediately after the incident and only returned on June 28, ready to take his second assignment. The police said Sunny and another accused Himanshu, both residents of Phagwara village, had enmity with a local resident, and wanted Sangwan's assistance in taking him out. Sangwan agreed, but only if they agreed to do a killing for him first, the police said. "During the daytime on June 2, the assailants allegedly followed Arun and, at around 5.30 pm, attacked him with firearms. Arun sustained bullet injuries and was rushed to a hospital, where doctors were able to save his life. (Source: FileThe Mumbai police on Monday arrested a Delhi man who has two cyber fraud cases against him after he allegedly tried to access the mobile number of Baba Siddique, the NCP leader who was shot dead in Bandra last year.

His family had kept the mobile number of Siddique active as it was linked to certain business accounts. The police are investigating why the arrested accused, Vivek

Sabharwal from Burari in Delhi, tried to access Siddique's number. "On Monday, he was placed under arrest and will be produced before the court to seek his custody," a police officer said.

The officer said that Sabharwal was out on bail in a cybercrime case registered in Borivali. Explaining how the crime came to light, a police officer said that in the last week of June, Siddique's wife Shehzeen received an email from the mobile service provider that it had received an application to transfer Siddique's number to another SIM card. The email also had some fake copies of Shehzeen's personal documents. The email also had Siddiqui's daughter Dr Arshia among the recipients. Realising that something was amiss, his family members approached the Bandra police station, where an FIR was registered against Sabharwal. The police tracked Sabharwal down to Burari and sought Delhi Police's help to detain him on Sunday. After getting his transit remand, the Bandra police team brought him to Mumbai on Monday. An officer said the police suspected Sabharwal was trying to use Baba Siddique's mobile number to commit cybercrime. "He did not realise that in the case of such applications, mobile service providers also notify the applicants by email, due to which the fraud came to light," the officer added. Siddique was gunned down on October 12, 2024, allegedly by the Anmol Bishnoi gang. The Mumbai crime branch has filed a chargesheet against 26 people

### Sudden deaths to be declared notifiable disease in Karnataka amid scare over Covid-19 vaccines

Covid-19"Sudden deaths will be a notifiable disease. If someone dies outside a hospital suddenly, it should be reported to the government. Autopsy will also be compulsory to ascertain the cause of death," Rao said. To ascertain the cause of sudden deaths among individuals below 45 years, the Karnataka government has decided to declare such deaths as a notifiable disease. The decision comes in the wake of speculations over Covid-19 vaccines being responsible for such deaths in the state. Addressing a news conference on Monday, Karnataka Health and Family Welfare Minister Dinesh Gundu Rao said the government would start monitoring sudden deaths reported among those below the age of 45. The decision has been taken based on the recommendations submitted by an expert committee formed under Dr C N Ravindranath, Director, Sri Jayadeva Institute of Cardiovascular Sciences and Research, to investigate sudden cardiovascular events, including heart attacks and cardiac deaths, and their possible links to Covid-19 vaccines. The committee, however, found no causal link between the vaccines and cardiac deaths among the youth

"Sudden deaths will be a notifiable disease. If someone dies outside a hospital suddenly, it should be reported to the government. Autopsy will also be compulsory to ascertain the cause of death," Rao said, adding that the Health and Family Welfare Department would issue directions for the same. On speculation that the vaccines were linked to cardiac deaths, he said that there were complaints about



mRNA vaccines causing myocarditis in some cases. "However, none from the country was administered with it," the minister said, adding that the Covid-19 vaccines helped save lives. Dr Ravindranath, who was also present at the news conference, said that there was a five to six per cent increase in cardiac deaths post-Covid, which he attributed to a change in risk factors for cardiac diseases due to altered lifestyle since the pandemic. "Cardiac deaths are not caused by just one reason. It is multifactorial," he said, adding that more than 50 per cent of the cases were caused due to smoking. Referring to a meta-analysis carried out by scientists on those affected by Covid-19, he said that 20 per cent of the patients who recovered continued to face fatigue, insomnia, depression, anxiety, and breathing problems. "But there were no heart attacks or cardiac-related diseases,"

### Renowned Abohar businessman Sanjay Verma shot dead outside his store, businesses shut down in protest

Reputed businessman Sanjay Verma, co-founder of men's tailoring showroom New Wear Well, was shot dead by three masked assailants near Shaheed Bhagat Singh Chowk in Abohar under Punjab's Fazilka district on Monday morning. The incident occurred at around 10 am when Verma, in his early 50s, arrived at his store in his car. CCTV footage reveals that as he stepped out of the vehicle, three armed men on a motorcycle – who were waiting nearby – opened fire on him at point-blank range before fleeing the scene. In their haste to escape, their motorcycle reportedly slipped, forcing them to snatch another bike from a passerby to continue their escape.

Verma was rushed to the Civil Hospital, but doctors declared him brought dead. His death sparked panic among local residents and traders, leading to the immediate shutdown of markets across Abohar in protest and grief. Traders and local associations have demanded immediate action and a crackdown on organised crime to restore confidence among professionals and entrepreneurs in the region. The slain businessman, known for his impeccable fashion sense, was the creative mind behind New Wear Well, a brand popular not only in North India but among international clients as well. Sanjay Verma's elder brother and founder of the New Wear Well brand, Jagat Verma, was in Chandigarh undergoing treatment for health issues at the time of the incident. He is reported to have rushed back to Abohar upon receiving the news of Sanjay Verma's death. The Fazilka police have appealed to the public to come forward with any information that may help identify the assailants. A First Information Report (FIR) has been registered with murder charges against unknown persons. and further investigations are underway. Senior police officials, Gurpreet Singh, Senior Superintendent of Police, Fazilka, reached the spot to investigate. Police teams are scanning CCTV footage from surrounding areas and have launched a massive hunt to nab the culprits, said police

Meanwhile, one Aarzoo Bishnoi has claimed responsibility for the murder through a social media post written in Hindi. The post, when translated, reads, "We, Goldy Dhillon, Aarzoo Bishnoi, and Shubham Lonker from Maharashtra, take responsibility for the murder that happened at New Wear Well, Abohar. We had called him regarding a matter, but he refused to recognise us, so we shot him dead to make it clear who we are. He used to support our enemies - whoever goes against us will be crushed to dust. Whatever we do, we take full responsibility for it – whether it's a 302 (murder) or a 307 (attempt to murder). Keep watching – we will make fake gangsters bite their fingers in fear."However, the police were yet to comment on this post. Following the shooting, Punjab BJP president Sunil Jakhar - a native of Abohar – strongly criticised the Aam Aadmi Party (AAP) government. "The daylight murder in Abohar is yet another eerie reminder that Punjab's law and order has totally collapsed. The deafening silence of the AAP government after each such killing only emboldens the gangsters. CM Bhagwant Mann must tell Punjabis who is responsible for this blot on Punjab's name," Jakhar said. Echoing similar concerns, Shiromani Akali Dal president Sukhbir Singh Badal termed the murder "a reflection of the prevailing jungle



raj" in the state. "Law and order in Punjab has plummeted to its lowest point. Businessmen, doctors, artists, and athletes are facing grave threats from extortionists. I strongly condemn this brutal killing and offer my heartfelt condolences to the Verma family. The perpetrators must be arrested and brought to justice immediately," Badal added.Amandeep Singh Goldy Musafir, AAP MLA from Balluana constituency, also visited the bereaved family to express his condolences.

Khandelwal wrote that major public institutions and transport hubs across the country are named after national icons, citing the examples of the Chhatrapati Shivaji Maharaj Terminus in Mumbai and the Krantivira Sangolli Rayanna metro station in Bengaluru. "Similarly, New Delhi — the heart of the nation — deserves to honour a leader of Vajpayee ji's stature," he wrote. "Shri Atal Behari Vajpayee ji was a visionary leader who steered India into a new era of economic reform, infrastructure development, and global standing. His inclusive politics, dignified leadership, and commitment to democratic values earned him immense respect across the political spectrum and among the people of India," Khandelwal wrote. In the letter, the MP wrote that "Delhi was not only his political workplace but also a city that held deep emotional and cultural significance for him". "Renaming the New Delhi Railway Station in his memory would be a fitting tribute to his lifelong service to the nation and a gesture that resonates with public sentiment" and that "this renaming would not only pay homage to his immense contributions but also serve as a source of inspiration for future generations who pass through the capital," Khandelwal further

## Karnataka proposes to amend child marriage law, extend punishment for even engagement

The Karnataka government plans to amend the Prohibition of Child Marriage Act to criminalise not only child marriages but also attempts and preparations for child engagements. A draft of the Prohibition of Child Marriage (Karnataka Amendment) Bill, 2025, proposes to insert new sections into the existing Act. "Punishment for attempt and preparation to make child marriage or attempt and preparation to make engagement of a child," reads Section 9A in the draft Bill. As per the Prohibition of Child Marriage Act, 2006, enacted by Parliament, the maximum imprisonment of two years and a fine of Rs 1 lakh are only applicable in cases of child marriage. The proposed Karnataka amendment extends the same provisions to child engagements, too.

"Whoever, make(s) an attempt and preparation to make child marriage, or attempt and preparation to make engagement of a child shall be punishable with rigorous imprisonment which may extend to two years or with fine which may extend to one lakh rupees or both," the draft Bill says. While section 10 of the existing Act relates to "punishment for solemnising a child marriage", the amendments propose to change it to "punishment for preparation and solemnising a child marriage". The draft Bill was based on the directions issued during a meeting of Chief Minister



Siddaramaiah with deputy commissioners and chief executive officers of all districts on May 31. Noting the recurrence of child marriages in Karnataka, as around 700 cases were reported last year, more stringent regulations were proposed during the meeting, according to sources. Other changes include the insertion of section 12A in the parent law, which will render the engagement of a minor child null and void. Section 13(A), another proposed amendment, empowers courts to "issue injunction prohibiting child engagement" to "any person including a member of an organisation or an association of persons prohibiting such engagement".

### Bombay High Court asks BMC to reconsider limiting slaughterhouses' closure to a day during Paryushan Parv

The Bombay High Court on Monday directed the Brihanmumbai Municipal Corporation (BMC) to reconsider its decision to close slaughterhouses in Mumbai for only a day during Paryushan Parv, and not for the entire period of nine days of the prominent Jain festival. A division bench of Chief Justice Alok Aradhe and Justice Sandeep V Marne was hearing Public Interest Litigations (PILs) filed by Sheth Motishaw Lalbaug Jain Charities and Sheth Bherulalji Kanaiyalalji Kothari Religious Trust. They challenged the August 30, 2024, order of the BMC commissioner, which directed slaughterhouses to remain closed for a day during Paryushan Parv instead of all nine days.

The court directed BMC to reconsider its decision after examining representation by the petitioners belonging to the Jain community by August 18, before the commencement of Paryushan Parv on August 20. The court said the Nashik and Pune Municipal Corporations were required to take a reasoned decision on the closure of slaughterhouses during Paryushan Parv. The petitioner claimed that the two civic bodies did not give any reasons for refusing to ban the slaughter of animals during the entire period of the festival. Representing the petitioners, Senior Advocate Darius Khambata and Advocate Abhinav Chandrachud relied on the Supreme Court judgement of March 2008 in Hinsa Virodhak Sangh vs Mirzapur Moti Kuresh Jamat, which noted that the state and every citizen must have compassion for living creatures. Khambata argued that the SC



had found the closure of slaughterhouses for nine days to be a reasonable restriction, and could not be said to be violative of the fundamental rights of persons engaged in the slaughtering of animals. The petitioners claimed BMC misinterpreted the SC decision, and failed to consider that the population of Jains in Maharashtra was greater than that of Gujarat, which was not the case. The lawyers submitted that the Jain community constitutes 1.24 per cent of Maharashtra's population, while they represent 0.95 per cent of Gujarat's population. Chandrachud said that as per the 2011 Census, there were over 14 lakh Jains in Maharashtra, compared to over 5.7 lakh Jains in Gujarat. He also submitted that Mumbai has 5.38 per cent of Jain population compared to 3.64 per cent in Ahmedabad, Gujarat, therefore, the impugned decision was arbitrary.

## How a probe into dating app scam led police to mule accounts, cybercriminals with China links

A Pune-based IT professional in his 40s signed up on a dating platform last year, and he connected with the profile of a woman named Anamika, ironically, a word that means "anonymous". Their online conversations quickly grew into what seemed like a genuine relationship, and soon, talks of marriage followed. But the connection, which appeared to promise a shared future, turned out to be an elaborate cyber scam in which he was allegedly duped of a staggering Rs 1.55 crore over eight months. The investigation revealed that the cybercriminals, operating behind the profile of 'Anamika,' gradually gained the complainant's trust and allegedly requested large sums of money. On the pretence of building a future together, 'Anamika' allegedly convinced him to transfer funds to purchase a house without ever having met. Over time, the scammers further manipulated him into investing in various trading apps, luring him with promises of exceptionally high returns, said the police. After spending nearly all his life savings and facing further demands for more money, he realised he had been deceived. When he tried to recover his funds, 'Anamika' allegedly abruptly stopped all communication with him. The

allegedly abruptly stopped all communication with him. The police filed an FIR in March based on his complaint.

The investigation by the cybercrime police station in Pimpri Chinchwad unearthed an elaborate network of mule account handlers allegedly operating from Solapur and with links to cybercriminals masterminding these scams from China. The police zeroed in on one particular mule account registered in Solapur in June. As the account holder was questioned, he spilled the beans on three others from Solapur who had allegedly told him that his bank account

would be used for taking funds obtained from gaming appli-



cations. As the investigation dug deeper into these three suspects, the police established their identities and roles in the racket. The mule account handlers from Solapur have been identified as Shubham Chandrakant Mantha, 25, a resident of Ashok Chowk; Swapnil Chandulal Baheti, 35, a resident of Hotgi Road; and Prashik Uttam Navghare, 26, a resident of Juna Kumbhani Naka. "Our investigation revealed that Mantha worked for a China-headquartered payment application company, and he and Baheti were in direct contact with the masterminds based out of China. A coordinated search operation was launched for the trio as their roles were confirmed in the probe," an officer who was part of the probe said. In the second week of June, Mantha and Navghare were arrested from Pune International Airport when they were about to flee to Nepal via Patna. Baheti, too, was placed under arrest."Investigation revealed an elaborate mule handling and fund siphoning operation with direct links to China," said an officer. All three suspects are currently in judicial custody.

#### India's diplomacy is measured, not mute



On June 13, Israel struck Iranian targets in several provinces, even as it continued its war against Hamas. Its conflict with Iran in an already unstable West Asia lasted 12 days. India's response to the Israel-Iran conflict was cautious. India called for restraint and de-escalation to maintain peace in the region. Prime Minister Narendra Modi has repeatedly expressed concern for humanitarian losses and has reiterated that this cannot be an era of war. Under his leadership, the Indian government has been quick to provide humanitarian aid when requested; voted in favour of a permanent ceasefire in Gaza at the United Nations General Assembly; and swiftly evacuated its citizens from conflict zones. Most recently, as part of Operation Sindhu, India evacuated citizens, mostly medical students, from Israel and Iran

The world recognises India's growing credibility and diplomatic weight. India's strategic silence is a sign of its growing stature — it speaks when it matters most, acts when it counts, and leads when it is required to. India has strategic interests in West Asia, including close defence co-operation with Israel, energy and trade ties with Iran, and a large diaspora spread across many Gulf countries. One of Prime Minister Modi's diplomatic successes has been to overhaul ties with Arab nations so much so that some of them have become India's largest foreign investors and trading partners. For India, the fourth largest global economy, economic ties have to take centre stage in diplomatic calculations. To unnecessarily intervene in a war which is not ours is against national interests and irresponsible. Being able to maintain an independent stance doesn't betray India's values; rather, it allows the country to engage with all sides and assert its interests more deliberately.

Today's international diplomacy prioritises protecting national interests. The recent Pakistan-led terror attacks in Pahalgam, India's retaliative Operation Sindoor, and the subsequent global response to the India-Pakistan conflict were telling of the changing geopolitical times we live in. Over the years, several nations, particularly western powers and multilateral bodies, which are seemingly against terror, have extended funds and other military support to embolden Pa-

kistan, a known sanctuary to terror groups. The western world, a large part of which has worked overtime to build strategic relationships with India, once again re-hyphenated Pakistan and India, which the Indian government had managed to de-hyphenate in its past two terms. Several countries remain oblivious to Pakistan's official role in sponsoring terror activities, many of which are directed towards India, so that they can obtain access to ports and airbases in Pakistan, which will provide an edge to them in their own conflicts with Iran and China. Pakistan's loyalty, which seems to be on sale to the highest bidder, is being courted with loans from the International Monetary Fund, state-ofthe-art military equipment, and lunches with its leaders. The irony is that the same countries which are often guick to give lectures on democracy and invade nations to "protect democratic values" are eager to engage with Pakistan's unelected military regime because it suits their interests. The Arab world, despite growing ties with India, is also quick to side with Pakistan as it is bound by religious brotherhood with the country. India's foreign policy calculations take into account all these nuances. India's diplomatic position also prioritises its own national interests, security, value system, and growth story. West Asia is one of the most politically unstable regions in the world. There are multiple ongoing and recurring conflicts and a network of non-state actors in the region. In such a highly volatile environment, to be in possession of nuclear weapons would dramatically increase the risk of escalation and unauthorised use. Nuclear weapons could lead to prolonged conflicts and have disastrous consequences on civilians. The Treaty on the Non-Proliferation of Nuclear Weapons is already under pressure. A nuclearised West Asia will embolden other conflict regions such as in parts of Africa and South America to pursue more aggressive nuclear weapons acquisition programmes. A stable West Asia requires arms control, de-escalation, and regional cooperation.

Often, ill-informed preaching, which is often politically motivated, demonstrates a limited understanding of today's evolving global dynamics. India cannot selectively ignore the role of Iran in destabilising the region. Indian diplomats cannot ignore the horrific October 7, 2023, attack by Hamas on Israel or its use of civilian Palestinian infrastructure as a shield in diplomatic response calculations. Selective outrage and heated opinions often disguised as moralistic views run a dangerous undercurrent against the core interests of the country. Many people hold views that are passionate but under-informed. If their opinions are taken seriously, it could lead to dire diplomatic consequences and stall India's strong economic progress. India's strategic autonomy reflects its quiet confidence, conviction, and clarity. We live in an India that is confident of its growth story. This is also an India that is capable of maintaining its own opinions and upholding the ability to engage with both warring sides instead of getting swayed into making public statements due to pressure from any one side during global conflicts.

#### How safe do women in Kolkata feel?

On a cloudy gloomy Friday morning of June 27, Kolkata woke up to the horror of another rape and the arrest of three youths for their involvement in the crime. As the monsoon clouds cleared by the afternoon, more details of the crime emerged. What shook the residents of the metropolis was that the assault was carried out within the protected walls of the West Bengal government-run South Calcutta Law College. For the city still coming to terms with the rape and murder of a postgraduate trainee doctor inside the Staterun R.G. Kar Hospital and Medical College on August 9, 2024, another Friday, the allegations of gang rape inside an educational institution only 11 km south of the medical college, in an upscale south Kolkata neighbourhood, came as nothing short of a nightmare.

Over the past 10 months, the city and its people have spent many sleepless nights converging on the streets and raising their voices demanding the safety of women in public places. Unlike the large campus of R.G. Kar MCH, which attracts thousands of patients and hundreds of doctors every day, the 'new campus' of the South Calcutta Law College stands eight storeys tall in Kasba on Rashbehari Avenue, an arterial east-west connector of the city.

Not far from the college, which was closed after the sexual assault, a crowd of thousands of regular people, unaffiliated with any political party, gathered on July 29, a Sunday evening. They converged near the Rashbehari crossing and started to march in protest of the city increasingly turning unsafe for women. Among the crowd were supporters of Abhaya Mancha and Reclaim the Night, groups that came together after the R.G. Kar rape and murder. Many still remember the rape of a woman in a moving car at Park Street in 2012.A nurse who uses public transport says, "There are no street lights in many pockets of the city. The metro train services stop after 10.30 p.m. There is close to no public transport at night. If I must go out at night, I must have a lot of money and privileges just to feel safe. As a single woman travelling at night in the city, I have never felt safe."In 2023, the annual publication of the National Crime Records Bureau (NCRB) for 2022 showed that the number of crimes against women in Kolkata was the lowest in India. Now, women are speaking up about Kolkata's infrastructure and other safety issues, including the dominance of politically-affilliated 'dadas'.

A few hours into the afternoon of June 27, students associated with the Left parties stormed the gates of the law college and tore posters of Chief Minister Mamata Banerjee and her nephew Abhishek Banerjee hanging in front of the building. However, they could not wipe away the wall graffiti inside the college on the blue boundary wall: 'Monojit Dada is in our hearts' signed off by 'Team MM' with a heart sign. This is a reference to Monojit Mishra, a 31- year-old former student of the college and the prime accused in the gang rape of the student. Credit: Debasish BhaduriIn the four-page complaint filed at Kasba police station a day after the rape, the survivor refers to Mishra as 'J'. The complaint stated that she had come to campus around noon on June 25 and was about to leave at around 6.10 p.m. "...but 'J' stopped me and told 'P' and 'M' (two other accused) by eye contact to go outside and locked the door from outside."At one point, she alleged, she had a panic attack, after which the accused arranged for an inhaler, but when she tried to escape, she found that they had locked the main gate. The security guard did not help. She describes the violence against her, also saying that 'J' was the head of the Trinamool Congress Chhatra Parishad (TMCP), the student wing of the Trinamool Congress (TMC), West Bengal's ruling party. "Everyone listens to him. He was giving everyone a post for TMCP. I was also given a post for the girls' secretary," the complaint said. The rape allegedly took place in the students' union room. Based on the complaint of the survivor, the Kolkata Police has charged Monojit Mishra and two others, 19-year-old Zaib Ahmed and




20-year-old Pramit Mukhopadhyay, with gang rape and wrongful detention among other charges. The security guard of the college was also arrested. Power sans elections

A week after his arrest, it has come to light that there are at least 11 cases against Mishra. Photographs of him with several TMC leaders surfaced, but MPs and MLAs of the party were quick to dissociate themselves from him, saying there was no unit of the party's students' union at the college after 2022. Student union elections are pending in colleges and universities in West Bengal for the past 5-10 years. ## How computers are changing our relationship with the ocean



The ocean has always spoken — in waves, in currents, in silent rhythms beneath its vast surface. For centuries, sailors, scientists, and philosophers have tried to understand its patterns, often relying on observation and instinct. Today, a new listener has emerged: the computer. Armed with data from satellites, ocean sensors, and remote platforms, computers are helping us decode the complex language of the sea. From identifying eddies to predicting ocean temperatures and storm surges, advances in artificial intelligence and computational modelling are transforming how we perceive and interact with marine environments. Becoming indispensable

When computers 'listen' to the ocean, they do more than measure; they reveal. The ocean is not a still body of water: it's a living, breathing system in constant motion. Beneath its surface lie powerful forces: swirling currents, rising and sinking water masses, and temperature gradients that shift with the seasons and climate. These movements influence everything from regional weather patterns to global climate systems and even the migration of marine life. Among the most fascinating of these phenomena are mesoscale eddies: large, rotating bodies of water that can span hundreds of kilometres and persist for weeks or months. Eddies are like underwater storms: they redistribute heat, nutrients, and salinity across vast distances.All these features make the ocean very difficult to study with traditional methods alone. This is where computational tools powered by real-time data are becoming indispensable.Al and visualsTo say computers are 'listening' to the ocean is not a metaphor: it's a shift in how we observe and interpret marine phenomena. The oceans today are monitored by a network of technologies: satellites scan sea surface temperatures and currents from space; floating buoys transmit data about salinity and pressure; and autonomous underwater vehicles glide quietly through deep waters, collecting measurements previously inaccessible to human research-

These instruments generate enormous amounts of data every second, a torrent that humans cannot process manually. Yet computers can detect subtle patterns that may go unnoticed to the human eye: a slightly warmer patch of water, a recurring spiral in current flow, a rapid shift in ocean colour indicating algal blooms. Computers effectively listen by translating physical signals like temperature, salinity, chlorophyll levels, wave height, etc. into structured information. From that information, they learn, predict, and even adapt. The ocean is no longer silent: it speaks in data and computers are the interpreters. As for making sense of

it: artificial intelligence (AI) models, particularly using deeplearning models, are now being trained to recognise patterns in complex ocean datasets. These models can detect and classify eddies, upwelling zones, changes in ocean chemistry, etc. with remarkable accuracy. For instance, convolutional neural networks, originally developed to recognise images, are now used to identify ocean currents from satellite imagery, much like how facial recognition software can spot particular individuals in a photograph. But raw data and AI predictions alone don't suffice: visualisation plays a crucial role in translating this information into knowledge that scientists, policymakers, and the public can grasp. Through interactive dashboards, animated maps, and 3D models, we can now see the ocean in motion: how a warm eddy moves across the Bay of Bengal or how salinity levels change during a monsoon, for example. These visual tools turn millions of data points into stories that humans can understand, investigate, and act on. The health of our oceans is deeply intertwined with the health of our planet. Ocean dynamics influence weather patterns, regulate global temperatures, and support ecosystems that sustain millions of people. As climate change accelerates, rising sea levels, ocean warming, and extreme weather events are becoming more frequent, and more dangerous. In this evolving scenario, the ability to understand and predict ocean behaviour isn't just a scientific curiosity: it's necessary.Aldriven analysis and real-time ocean monitoring can improve disaster preparedness by forecasting cyclones and storm surges more accurately. Fishers can receive timely insights into ocean conditions that affect fish migration. Coastal planners can anticipate erosion and flooding risk. Conservationists can track changes in coral reef health or identify zones of pollution. These aren't futuristic goals: they are already being realised in projects around the world. When computers listen to the ocean, we gain knowledge and also foresight. And in an age of environmental uncertainty, foresight is critical. The ocean doesn't recognise borders and neither should our efforts to understand and protect it. We need more interdisciplinary research: where marine scientists work alongside computer scientists, data engineers and visualisation experts. We need investments in infrastructure that make ocean data more open, accessible, and usable. And we need to train the next generation of researchers who can bridge computer code with climate models. How we respondThe ocean speaks in waves, in winds, in unseen turbulence below the surface. When computers tune in, they don't replace human curiosity: they amplify it. They help us see what was once invisible, understand what was once uncertain, and prepare for what is yet to come. But tuning in is only the first step. The real test lies in how we respond. In a world increasingly shaped by data and digital tools, we should never lose sight of the deep blue truth: that the ocean, vast and ancient, still has much to teach us, if we are willing to pay attention and to act. ### Study links air pollution to preterm births, low birth weight in India

Air pollution, a hazard endured everyday by millions across India in varying degrees, has long been associated with a range of respiratory diseases, heart conditions, and a growing list of health issues. Now, a new study reveals the damaging effects of air pollution extend far beyond the lungs and heart, affecting people before they are even born. Published in PLoS Global Public Health, the study was carried out by researchers from institutions in India, Thailand, Ireland, and the UK, with data from the National Family Health Survey (NFHS) along with satellite data. The team assessed the influence of ambient air quality on birth outcomes, specifically preterm births (PTB) and low birth weight (LBW). The dataset included children aged 0 to 5 years; 52% were female and 48% male.

The results suggest that exposure to fine particulate matter (PM2.5) during pregnancy significantly increases the likelihood of these adverse outcomes. PM2.5 consists of airborne particles less than 2.5 micrometres in diameter. According to the study, mothers exposed to increased levels of PM2.5 had a 70% higher chance of delivering prematurely compared to those who weren't exposed. The odds of giving birth to a baby with low birth weight rose by 40% for mothers who faced higher air pollution levels.

A particularly significant finding in the study is the regional disparity: specifically, Delhi, Punjab, Haryana, Uttar Pradesh, and Bihar bear the brunt of the consequences of air pollution. These regions are known for being heavily industrialised with high vehicular emissions and the widespread use of solid fuels for cooking. This conclusion aligns with previous reports. Another recent study in The Lancet reported that the average PM2.5 concentration in Delhi was 13.8-times higher than that in Kerala.PTB was most prevalent in Himachal Pradesh (39%) and Delhi (17%) while LBW was most common in Punjab (22%) and Delhi (19%). Female children were more likely to be born with LBW (20%) compared to males (17%) — although both conditions were found to be more frequent among children of illiterate and poorer mothers. Households that used solid fuel to cook also reported higher rates of both LBW and PTB. Higher levels of PM2.5 during pregnancy significantly increased the likelihood of both LBW and PTB by 1.37x and 1.67x, respectively, with even a slight rise in temperature linked to an increase in LBW cases, though not PTB. Higher tempera-



tures have previously been linked to maternal dehydration. heat stress, and increased cardiovascular strain, all of which impair placental function and disrupt foetal growth. Conversely, excessive rainfall, especially during the monsoon, raises the risk of waterborne infections, which can further hinder foetal growth, the study suggests. Flooding and displacement associated with heavy rains can also disrupt healthcare access, leading to delayed medical interventions and increasing the likelihood of pregnancy complications. The study's findings clarify that while India has made some progress in tackling air pollution with initiatives like the National Clean Air Programme, more needs to be done to mitigate the risks posed by poor air quality. The study's results suggest the government's target to reduce particulate matter concentrations by 20% by 2024 is a step in the right direction, although it may not be enough to address the public health crisis growing in tandem. The authors call for more comprehensive interventions to reduce exposure to air pollution, particularly in North India, which has been identified as the most vulnerable region. In addition to addressing outdoor air pollution, the study highlights the importance of tackling indoor pollution, particularly from the burning of solid fuels in households. Cleaner cooking technologies and better access to clean energy could significantly reduce the harmful effects of indoor air pollution, especially in rural areas. The research also calls for greater integration of air quality data with health surveillance systems to identify at-risk populations and implement targeted interventions. A more localised approach, focusing on the specific needs of high-risk regions.

## Overweight may influence breast cancer risk in women with heart disease: WHO study

New Delhi: Excess weight may increase the risk of developing breast cancer among postmenopausal women with cardiovascular disease, according to a study by the World Health Organisation (WHO), published on Monday. Higher body mass index (BMI) is a known risk factor for breast cancer in postmenopausal women. The study, published in the peer-reviewed journal of the American Cancer Society CANCER, unravels how the risk differs among women with and without cardiovascular disease or type 2 diabetes. It showed that each 5 kg/m2 increase in BMI was associated with a 31 per cent higher risk of breast cancer in women who developed cardiovascular disease during follow-up and a 13 per cent higher risk in women without cardiovascular disease.

The development of type 2 diabetes did not seem to affect breast cancer risk: women with or without type 2 diabetes had a similarly elevated breast cancer risk related to higher BMI. "The findings of this study could be used to inform risk-stratified breast cancer screening programmes," said a team led by Heinz Freisling, from the WHO's specialised cancer research team, the International Agency for Research on Cancer (IARC).

The team analysed data from the European Prospective Investigation into Cancer and Nutrition (EPIC) and UK Biobank on 168,547 postmenopausal women who did not have, type 2 diabetes, and cardiovascular disease when they agreed to participate. After a median follow-up of 10.7 years in EPIC and 10.9 years in UK Biobank, 6,793 post-

menopausal women developed breast cancer. Further, the study noted that the combination of overweight (BMI=25 kg/m2) and cardiovascular disease was estimated to lead to 153 more cases of breast cancer per 100,000 people per year than expected. "This study should also inspire future research to include women with a history of cardiovascular diseases in weight loss trials for breast cancer prevention," Freisling said. The link between excess weight and increased cancer risk is well established. Being overweight or obese increases your risk for 12 cancers, including uterine, kidney, liver, and colorectal cancer. A recent study, published in the journal Nature Communications, showed that that overweight and obese women are more likely to be diagnosed with larger tumours and more advanced-stage breast

#### Indonesia's Mount Lewotobi Laki Laki volcano erupts, sending ash cloud 18 kilometres in air

Indonesia's rumbling Mount Lewotobi Laki Laki erupted on Monday sending a column of volcanic materials as high as 18 kilometres into the sky and depositing ash on villages. The volcano has been at the highest alert level since last month and no casualties were immediately reported.Indonesia's Geology Agency recorded an avalanche of searing gas clouds mixed with rocks and lava travelling up to 5 kilometres down the volcano's slopes during the eruption. Observations from drones showed lava filling the crater, indicating deep movement of magma that set off volcanic earthquakes.

The column of hot clouds that rose into the sky was the volcano's highest since the major eruption in November 2024 that killed nine people and injured dozens, said Muhammad Wafid, the Geology Agency chief. It also erupted in March. "An eruption of that size certainly carries a higher potential for danger, including its impact on aviation," Wafid told The Associated Press from Switzerland where he was attending a seminar. "We shall reevaluate to enlarge its danger zone that must be cleared of villagers and tourist activities."

After an eruption early last year, about 6,500 people evacuated and the island's Frans Seda Airport was closed. The airport has remained closed since then due to the continuing seismic activity. The 1,584-metre mountain is a twin volcano with Mount Lewotobi Perempuan in the district of Flores Timur.Monday's eruption was one of Indonesia's largest volcano eruptions since 2010 when Mount Merapi, the country's most volatile volcano erupted on the densely populated island of Java. That eruption killed 353 people and forced over 350,000 people to evacuate affected areas. Indonesia is an archipelago of more than 280 million people with frequent seismic activity. It has 120 active volcanoes and sits along the "Ring of Fire," a horseshoe-shaped series of seismic fault lines encircling the Pacific Basin.

#### China's Xi Jinping skips BRICS summit for first time, fuelling speculation about political future

Chinese President Xi Jinping, widely regarded as a leader for life, is beginning to delegate authority to key organs of the ruling Communist Party, a first in his over 12year rule.Mr. Xi's move sparked speculation that he may be laying the groundwork for an orderly power transition or scaling back his role in preparation for possible retirement.

Speculation about Mr. Xi's power transition was rife after state-run Xinhua news agency recently reported that the powerful 24-member Political Bureau of the ruling Communist Party of China (CPC) in its meeting on Jun 30 reviewed a set of new regulations on the work of the party's institutions. The meeting presided over by Mr. Xi himself stressed that the regulations will further standardise the establishment, responsibilities, and operations of the CPC Central Committee's decision-making, deliberative, and coordinating institutions. Such institutions should exercise more effective leadership and coordination over major tasks and focus on planning, discussing, and overseeing major tasks, the Xinhua report said. While the overseas Chinese dissident community in recent months was abuzz with speculation of a power struggle within the secretive and tightly controlled CPC, a China-based political analyst who spoke on condition of anonymity said the regulations on these party bodies could hint at preparations for Xi's retire-

"The rules may be set up to regulate the bodies because it's a key time for power transition," the Hong Kongbased South China Morning Post on Sunday quoted the analyst as saying. Other experts, however, averred that Mr. Xi, regarded as the most powerful leader after CPC founder Mao Zedong, may be delegating some powers to focus on larger issues."It does seem that Xi might pay less attention to day-to-day details, which necessitates a policing mechanism to ensure that his policy priorities are still being carried out by lower-level officials," Victor Shih, a specialist in Chinese elite politics and finance at the University of California San Diego, told the Post.

Mr. Xi also skipped the BRICS summit being held in Rio de Janeiro from Sunday. This is the first time since he became President that he will be missing the summit of the emerging economies. Chinese Premier Li Qiang is heading China's delegation at the summit.Mr. Xi's move of delegating power comes amid U.S. President Donald Trump's



tariff war disrupting China's \$440 billion exports to America, besides major headwinds faced by the Chinese economy, with growth falling due to continued slowdown, and the collapse of the housing market, the mainstay of the economic growth. The crisis was exacerbated by the government's attempts to rein in the corporate sector and the unsuccessful zero COVID policy of shutting down Chinese cities during the height of the pandemic, resulting in the industry and business coming to a grinding halt. Since he took over power, becoming the General Secretary of the CPC in 2012, Mr. Xi. who was previously the Vice President, rapidly consolidated his power hold in the key power centres — the party, the presidency, and the powerful military as the Chairman of the Central Military Commission (CMC) — the overall high command of Chinese armed forces. As he firmed up his grip over power structures, carrying out China's biggest anti-corruption campaign in which over a million officials were punished and dozens of top generals purged, Mr. Xi was declared as "core leader" of the party, a designation that was conferred only on party founder Zedong. Later, the key rule of the President's term of two five-year terms was amended by the legislature, paving the way for him to get elected for an unprecedented third five-year term as the General Secretary of the Party in 2022 and as President of the country in the following year. All of Mr. Xi's predecessors retired after two five-year terms, while he continued in power with no term limits, earning him the label of President for life. Analysts say his plan to remain in power or share power was expected to unravel before or during the next five-year congress of the CPC to be held in 2027, by which

#### Why has Google's 'AI overviews' sparked an antitrust firestorm in the EU? | Explained

Google's Al-powered summaries, known as Al Overviews, are facing a formal antitrust complaint from a coalition of independent publishers in the European Union, as per a report by Reuters. Their complaint, lodged with the European Commission, alleges that Alphabet's Google is abusing its market dominance, siphoning traffic and revenue from publishers, and threatening the viability of independent journalism. The feature, rolled out in over 100 countries, represents Google's major strategic bet on integrating generative Al directly into its core search experience. However, this move has ignited fierce opposition from content creators who claim it undermines the very ecosystem that Google's search engine relies on.

What is Google Al Overviews?

Al Overviews are Al-generated summaries that appear at the top of Google's search results page, positioned above the traditional list of blue links. Their purpose is to provide users with a quick, synthesised answer to their query, drawing information from multiple web sources. These overviews can range from a few paragraphs to lists or tables and often include links to the source websites within the generated text. First introduced as an experiment called Search Generative Experience (SGE) in May 2023, the feature is now a core part of Google Search in many regions.

How do Al Overviews work?

When a user enters a search query, Google's systems determine if generative AI could be particularly helpful in providing a comprehensive answer. If so, it employs a customised version of its advanced Al model, Gemini, to process the request. The system doesn't rely solely on the Al's pre-existing knowledge. Instead, it uses a technique called Retrieval-Augmented Generation (RAG), where it actively fetches and analyses relevant information from its web index. The AI then synthesises this information into a coherent summary. Google states that these overviews are designed to be backed up by top web results, and include links to allow users to "dig deeper."

Why are publishers accusing Google?

The crux of the dispute lies in how these Al-generated answers impact the businesses that create the original content. The Independent Publishers Alliance, alongside groups like the Movement for an Open Web and the legal advo-



cacy non-profit Foxglove, argues that this new feature hurts competition and is causing "serious irreparable harm," as per the Reuters report citing documents it has seen. The publishers' key complaints stem from the concern that their content will be disincentivised because of Google's AI feature. By providing a direct summary at the top of the page, users have less incentive to click through to their websites. This leads to a significant drop in traffic, which in turn slashes advertising revenue and subscriber numbers, the lifeblood of many online publications. Their complaint alleges that Google is "misusing web content" by scraping information from publisher sites to train its Al models and generate summaries without fair compensation. Since May 2024, Google has also begun placing ads within these Al Overviews, meaning it is directly monetising content that publishers have invested in creating. The complaint highlights that there is no way to opt out of having their content used for Al Overviews without also being removed from Google's main search results. Given Google's dominance in search, becoming invisible on the platform is not a feasible option for any publisher.

How are regulators getting involved?

The formal complaint, per the report, was filed with both the European Commission and the U.K.'s Competition and Markets Authority (CMA). The publishers are asking for "interim measures" to stop Google from using the feature while the case is investigated, to prevent further damage.

#### Sheikh Hasina to face tribunal decision on charges in Bangladesh



GNS News Agency, July 15Bangladesh's International Crimes Tribunal on Monday to determine whether charges will be framed against ousted Prime Minister Sheikh Hasina and two of her top aides. Ms. Hasina, former Home Minister Asaduzzaman Khan Kamal and former inspector general of police Chowdhury Abdullah Al-Mamun are accused in the case over alleged crimes against humanity committed during the July uprising last year. Bangladesh wanted good ties with India, but 'something always went wrong':

"The International Crimes Tribunal-1 (ICT-1) set July 10, 2025 to decide whether charges will be framed against Ms. Hasina, Mr. Kamal and Mr. Al-Mamun," The Daily Star newspaper reported. "On that day, the three-member tribunal will hear the petitions filed by the defence counsels, who argued that the charges against their clients are baseless and should be dropped," it said. Ms. Hasina, Mr. Kamal and Mr. Al-Mamun were charged with five counts of crimes against humanity on June 1.Bangladesh's International Crimes Tribunal indicts Sheikh Hasina, orders her to be produced in Dhaka on June 16The prosecution pressed formal charges against the deposed Prime Minister, the former Home Minister, and the former top cop for murder, attempted murder, torture, and use of lethal weapons, among others. On Wednesday last week, Ms. Hasina was sentenced to six months in prison in absentia in a contempt of court case by the ICT. It marks the first time that the 77year-old Awami League leader has been sentenced in any case since she left office in August last year. According to a UN rights office report, up to 1,400 people were killed between July 15 and August 15 last year as Ms. Hasina's government ordered a security crackdown on protesters. Most leaders of the Awami League and Ministers and several officials of the past regime were arrested or were on the run at home and abroad as the interim government initiated their trial for brutal actions to tame the uprising last year, which led to the toppling of the nearly 16year Awami League regime on August 5 and forced Ms. Hasina to leave the country for India. Meanwhile, a Dhaka court has summoned Ms. Hasina, her family members, and several former officials of her administration to appear in six cases over alleged corruption involving plot allocations, news portal bdnews24.com reported on Sunday (July 6, 2025.) Anti-Corruption Commission (ACC) Prosecutor Mir Ahmed Ali Salam said the court had earlier instructed the publication of the gazette notices, which have now been issued. The gazette was signed by Dhaka Metropolitan Senior Special Judge Md Zakir Hossain Galib.

'The court has scheduled July 20 for a hearing in these six cases. If the accused fail to appear before the court by then, the trial will proceed in their absence," Mr. Salam said. The gazette underlines that arrest warrants have been issued against the accused, that the court has reasonable grounds to believe that they have gone into hiding to evade arrest and trial, and that there is no likelihood of their apprehension. If the accused fail to appear by the next scheduled date, the trial will proceed in their absence. Besides Hasina, the gazette includes the names of her children Sajeeb Wazed Joy and Saima Wazed Putul, her sister Sheikh Rehana, and Rehana's children British MP Tulip Rizwana Siddig, Azmina Siddiq Ruponti, and Radwan Mujib Siddiq.

#### Why is Maharashtra debating over Hindi? | Explained

The story so far: The linguistic debate in Maharashtra continues days after the Maharashtra government withdrew two orders introducing Hindi as the third language in primary education across Marathi and English medium State Board schools. The government has appointed a committee under renowned economist Dr. Narendra Jadhav to study the three-language policy.

What is the language debate in Maharashtra?

On April 16, the Maharashtra government issued an order making Hindi mandatory as the third language in all English and Marathi medium schools of the State Board in Maharashtra. The government said that it was as per the provisions of the National Education Policy (NEP), 2020. "At present, two languages are being taught from Grade 1 to Grade 4 in all the English and Marathi medium schools in the State. As per the State Education Framework, 2024, Hindi will be mandatory as the third language in all the English and Marathi medium schools from Grade 1 to Grade 5," the order stated. Till now, third language was introduced only in Grade 5 in English and Marathi medium State Board schools. The other medium schools already have a threelanguage policy in primary education.

What was the reaction?

There was widespread opposition to the government's decision on two grounds — first, that a third language should not be imposed in primary school from Grade 1 to Grade 5. The second ground was about the imposition of Hindi. Regional linguistic groups, academics, civil society members, and prominent literary figures raised their voice against the move which was dubbed as an effort to 'force Hindi', and a move towards 'cultural hegemony'. The Maharashtra government's own language committee wrote to the government seeking its immediate revocation. Experts argued that the NEP, 2020 focussed on R1 and R2, which is the mother-tongue, and an additional second language for primary education. They said that children should not be burdened with learning three languages in primary school. "Why should there be an imposition of Hindi? This is a concerted effort for cultural hegemony. This is in line with the RSS' plan of 'Hindi, Hindu, Hindustan'. In Maharashtra, the Marathi manoos will stand for his linguistic, cultural identity. This is a historic moment since the movement for the reorganisation of States on linguistic basis. The entire State has stood against the government's imposition of Hindi," Deepak Pawar of Marathi Abhyas Kendra said.

How did the government respond?

After a severe backlash, Maharashtra education minister Dada Bhuse promised to revise the government resolution (GR). "Hindi will not be mandatory," he announced. On June 17, the government revised the GR, making Hindi a 'general' third language in schools. It stated that the students had the option to learn any other Indian language as the third language, but that it was mandatory for at least 20 students to come together to make the demand. "The government will make a teacher available or will make provi-



sion for online learning if at least 20 students come together to learn any other Indian language apart from Hindi," the revised GR stated. However, this drew further backlash as academics and regional linguistic political parties called it an effort to impose Hindi through the backdoor. "The whole exercise of the meeting of the steering committee was carried out in secrecy by the government. The language committee of the government itself was never consulted on the move. The decision is illogical. It has no scientific backing by educationists, child psychologists. It has been taken without any consultation with the stakeholders and experts. At a time when the Marathi culture and language is not being respected by its own government, this is an assault on the linguistic identity of the State," said Laxmikant Deshmukh, head of Maharashtra's language committee.

What about political realignments?

The issue provided a fillip to Raj Thackeray's Maharashtra Navnirman Sena, which counts 'Marathi asmita' or linguistic chauvinism as its core ideology, "We are Hindus, not Hindis," he said. It paved the path for the reunification of the Thackeray cousins after two decades. Uddhav Thackeray and Raj Thackeray joined hands against the government's move, even holding a joint rally. Deputy Chief Minister Ajit Pawar too openly expressed his displeasure with the government's decision and said that Hindi should not be imposed till Grade 4. This has led to an unease within the Mahayuti with Eknath Shinde not wanting to be seen as standing against the cause. In the face of upcoming local body elections, the language debate has led to changed political dynamics.

What is the way ahead?

The government has announced the scrapping of the two controversial GRs issued on April 16 and June 17. Chief Minister Devendra Fadnavis announced the formation of a committee under Dr. Narendra Jadhav to look into the threelanguage policy, and said the government will accept his report. Academics have raised questions on Dr. Jadhav's expertise in school education, and have demanded the scrapping of the committee as well as the decision to impose the three-language policy in primary education. Opposition parties have said the government should scrap the three-language policy altogether. "We will not accept the three-language policy," Sanjay Raut, Shiv Sena UBT leader,

#### Typhoon Danas crosses Taiwan, killing 2, injuring over 300

Taipei: Typhoon Danas brought heavy winds and torrential rains to parts of Taiwan early on Monday, killing two people and injuring more than 300 on the island's densely populated west coast. The typhoon lost intensity and was downgraded to a tropical storm as it moved into the Taiwan Strait on a forecast path to China. Danas knocked out power for more than 580,000 households, and schools and offices were closed across southern and central parts of Taiwan. The typhoon made landfall on the west coast late Sunday with maximum sustained winds of 144 kph (89 mph). It dumped more than 60 centimeters (24 inches) of rain in places, causing landslides and flooding.

Two deaths were reported in the southwestern city of Tainan, according to the National Fire Agency. One person died when their vehicle was struck by a falling tree, while another died after his respirator malfunctioned due to losing

power. At least 334 people suffered injuries, while more than 3,400 people were forced to evacuate - mostly from mountainous areas around the southern port city of Kaohsiung. Thousands of tourists were stranded on Taiwan's outlying islands of Penghu, Matsu and Green due to the cancellations of ferry services and flights. Areas of southern and eastern China made preparations ahead of the storm, which is expected to reach the mainland Tuesday afternoon. Authorities in southern Guangdong province called hundreds of vessels to port and evacuated more than 2,000 people from offshore facilities. Two cities in the eastern Zhejiang province suspended ferry services and construction work. Danas earlier intensified seasonal monsoon rains in the Philippines' northern mountains, flooding lowlying villages and forcing more than 3,000 people to flee to emergency shelters.

#### Govt fears trade war may trigger import surge of US farm, Chinese factory goods



AMID ESCALATING global trade tensions, the Commerce and Industry Ministry is assessing the risks of significant trade diversion from other countries to India and is particularly concerned about the likely surge in imports of US farm produce and factory goods from China, Vietnam and Indonesia into the country, a government official said "A recent assessment highlighted the risk of merchandise dumping into India due to reciprocal tariffs amid global trade tensions. Rising US costs may prompt exporters from countries like China, Vietnam, and Indonesia — all facing US trade deficits — to divert goods to India, potentially triggering import surges. Additionally, Chinese retaliatory tariffs on US goods could further increase the inflow of US agricultural products into India," the official said. Unlike other countries, China retaliated against US tariffs, which in turn has raised the risk of trade diversions globally. While the US has imposed a cumulative of 145 per cent tariffs on Chinese products apart from electronic items, Chinese tariffs on US items have also surged to a record 125 per cent. Notably, soybean and corn are the top US agri exports to

To support stakeholders amid shifting global trade conditions, including tariff hikes, import surges, and export-related disruptions, the Directorate General of Foreign Trade (DGFT) under the Commerce Ministry launched the Global Tariff and Trade Helpdesk on April 11, 2025, the Commerce and Industry Ministry said. The Indian Express had reported earlier this month that a high-level meeting had taken place at the Commerce and Industry Ministry to assess possible import surge as a result of trade diversions in the backdrop of the reciprocal tariffs. "With a number of tariff announcements and subsequent pauses, things are in flux. But we are looking at import surges and have identified some countries for more intense monitoring. We have also picked commodities for closer watch because we are

already aware of certain trends, and we are focusing on those commodities," Commerce Secretary Sunil Barthwal said. "Depending upon how the world is moving in terms of tariffs, counter-tariffs, exemptions and other developments, we are monitoring those imports. We are also in touch with our stakeholders. Our commodity divisions within the Ministry of Commerce are in contact with export promotion councils and various ministries. Based on the feedback, inputs, and data we analyse, remedial measures will, of course, be taken," Barthwal said.

Meanwhile, the Commerce Ministry said the Directorate General of Trade Remedies (DGTR), the anti-dumping watchdog, has issued final findings on 13 trade remedy investigations on imports in March alone, particularly from China and other countries such as Japan, Taiwan, and the European Union. Items include Vitamin-A Palmitate, Insoluble Sulphur, and Aluminium Foil up to 80 microns, among others. Economists and trade experts have also raised concerns over a surge in exports from China. A research note by HDFC Bank on Friday stated that apart from the direct impact of US tariffs on Indian exports, India faces a "high risk" of oversupply from China, which could hurt domestic manufacturing. "With the tariff increase on Chinese goods now effectively exceeding 60 per cent, it is more likely that a greater share of China's supply could flow into other markets. This makes domestic manufacturing in countries like India vulnerable to cheaper Chinese oversupply," noted Sakshi Gupta, Principal Economist at HDFC Bank. According to Crisil Ratings, India faces a high risk of indirect impacts from US tariffs, particularly in electronics, machinery, and textiles, as Chinese exporters may divert their shipments to India as part of a geographical diversification strategy. "The top Chinese exports to the US, including electronics, machinery, and textiles, are particularly vulnerable to dumping, and their influx into the Indian market could impact domestic industries. However, the Indian government may impose anti-dumping duties to safeguard Indian exporters and mitigate any potential damage," Crisil Ratings stated. International think tank the Lowy Institute, in a recent research paper, estimated that about 80 per cent of countries traded more with China than with the US in 2023. However, the US remains a key driver of global demand, particularly as it has increased imports from countries such as Vietnam and Mexico, shifting away from China following the first round of Trump-era tariff hikes. "This increase in imports from China is a combination of US tariffs prompting China to diversify into other markets and a redirection of its exports (parts and components) via other countries that ultimately serve the US market," the think tank

## US has big advantages on services, but projects deficits on goods trade; talks will be based on 'true picture', says govt

Commerce Secretary Sunil Barthwal said Tuesday that the Bilateral Trade Agreement (BTA) talks with the US are focused on the exchange of "right facts" and the "true picture" of trade between the two countries. This comes as US President Donald Trump has consistently sought to pressurise trade partners, accusing them of "ripping the US off" on goods trade, but overlooking the advantages that America enjoys in the services sector. "When we engage with the US team, all the facts are on the table, and the negotiations are based on the right facts and the data we exchange with them. That is completely rooted in the true picture which exists between the two countries. So, the BTA progresses on those lines," Barthwal said. Multiple experts in India have also pointed out that the 26 per cent reciprocal tariffs announced by the US on India were based solely on trade, while ignoring services trade the US and other Western countries hold considerable advantages over developing nations.

According to data compiled by the US Bureau of Economic Analysis, which falls under the country's Department of Commerce, services exports from the US to India have consistently grown over the last three years. In 2022, such exports stood at \$26.53 billion, rising to \$33.99 billion in 2023, and \$40.26 billion in 2024. Notably, the US recorded a marginal trade deficit with India in terms of services imports from New Delhi during the same period — with imports recorded at \$33.03 billion in 2022, \$36.4 billion in 2023 and \$40.74 billion in 2024.

India is considered the largest market by user base for several major US tech companies — such as Meta's Facebook, Instagram and WhatsApp, and Alphabet's Google Search and YouTube — owing to its large population and some of the world's lowest internet data rates. As such, beyond direct monetary value, Indian users provide hundreds of millions of eyeballs for American tech products, while also generating vast amounts of data to fine-tune their services. Incidentally, countering concerns over the selective use of goods trade deficit, China, in a white paper released last week, said that services and local sales of domestic enterprises' branches in the other country (i.e., local sales generated through two-way investment) should also be taken into account when discussing trade.



"When the three components — trade in goods, trade in services, and local sales of domestic enterprises' branches in the other country — are considered together, it becomes clear that the economic and trade benefits accrued by China and the US are roughly balanced," the Chinese white paper stated. In India, revenues from major American companies' operations here have been on a steady rise, particularly in online advertising, which has seen substantial growth due to increasing digital adoption in the country. For instance, Meta India's revenue from operations in FY24 grew by 9.3 per cent to Rs 3,034.8 crore, up from Rs 2,775.7 crore in FY23, while its net profit rose by 43 per cent to nearly Rs 505 crore. Meta India also makes royalty payments to Meta USA for the commercialisation of intellectual property, along with infrastructure charges. Similarly, Google India saw its revenues increase by 26 per cent to Rs 5,921.1 crore in FY24, from Rs 4,700 crore in FY23. Microsoft India's FY24 revenue grew by more than 18 per cent year-on-year to nearly Rs 23,000 crore.

The Global Trade Research Initiative (GTRI) said that the US frequently misrepresents trade figures. "For example, Trump claimed that the US trade deficit with India is \$100 billion, whereas India's official data places it at under \$45 billion. Similarly, the White House fact sheet inaccurately stated that India imposes a 100 per cent tariff on Harley-Davidson motorcycles, when the actual tariff was reduced from 50 per cent to 30 per cent on 1 February 2025," the GTRI report stated.

Capital markets regulator SEBI on Tuesday barred Gensol Engineering and promoters — Anmol Singh Jaggi and Puneet Singh Jaggi - from the securities markets till further orders in a fund diversion and governance lapses case. The regulator has also debarred Anmol and Puneet Singh Jaggi from holding the position of a director or key managerial personnel in Gensol until further orders. Further, the markets watchdog directed Gensol Engineering Ltd (GEL) to put on hold the stock split announced by it. The order came after the Securities and Exchange Board of India (SEBI) received a complaint in June 2024 relating to the manipulation of share price and diversion of funds from GEL and thereafter started examining the matter. In a 29-page interim order, SEBI said, "The prima facie findings have shown mis-utilisation and diversion of funds of the company (GEL) in a fraudulent manner by its promoter directors, Anmol Singh Jaggi and Puneet Singh Jaggi, who are also the direct beneficiaries of the di-

verted funds". "The company has attempted to mislead SEBI, the CRAs (credit rating agencies), the lenders and the investors by submitting forged conduct letters purportedly issued by its lenders," the regulator said. The noticees 1. 2 and 3 (GEL, Anmol and Puneet Singh Jaggi) are alleged to have violated the provisions of PFUTP (Prohibition of Fraudulent and Unfair Trade Practices) rules, it added.SEBI noted that the promoters were running a listed public company as if it were a propriety firm. GEL's funds were routed to related parties and used for unconnected expenses as if the company's funds were promoters' piggy banks. The result of these transactions would mean that the diversions at some time need to be written off from Gensol's books. ultimately resulting in losses to the investors of the company."...prima facie evidence of a blatant violation of rules of corporate governance is writ large over the workings of the company. ## After reporting hair loss, Buldhana's Shegaon residents are suddenly losing nails; We ask experts possible causes



Following an alarming trend of sudden hair loss, Shegaon in Maharashtra's Buldhana district is again in the news for yet another health issue – shedding of nails. According to a recent PTI report, nearly 30 individuals in Shegaon have been reported with nail deformities, which may be linked to high selenium levels in their blood. Shegaon had made national headlines in December 2024 and early January this year, following complaints of people experiencing sudden baldness and hair loss, also due to an alleged link between high selenium content in wheat distributed through ration stores. However, the claims remained unconfirmed, with several experts disagreeing.

"Twenty-nine persons have been found with nail deformities in four villages in Shegaon taluka. In some cases, the nails have fallen off. They have been given primary treatment and will be sent to a hospital in Shegaon for further examination," Dr Anil Bankar, Buldhana health officer, told PTI two days ago. As per preliminary information, he attributes this problem to the "presence of high selenium as those who suffered hair loss are also experiencing problems of nail loss," Bankar added. To understand the link between selenium and hair and nail loss, indianexpress.com spoke to dermatologists who confirmed that excess selenium in the body disrupts the normal function of keratin, the key protein that makes up our hair and nails. According to

Dr Priyanka Kuri, dermatology consultant, Aster Whitefield Hospital, Bengaluru, high selenium levels in the body lead to a condition known as selenium toxicity or selenosis.

Chronic intake of selenium above the tolerable limit of 400 mcg/day for adults can result in hair or nail loss, along with fatigue, stomach issues, and a garlic-like breath odour. Overuse of certain supplements or even environmental factors have been known to be the major contributor behind the development of this condition," Dr Kuri explained. Concurring, Dr Seema Oberoi Lall, Consultant Dermatology, CK Birla Hospital Gurugram said that individuals with selenosis may notice symptoms such as thinning hair, loss of hair in patches, and nails that become discolored, fragile, or detached. She warned that a lot of supplements people end up taking randomly without doctor's advice can sometimes have high levels of selenium and other minerals which their body may not require. In such cases, they might end up hitting an excess. She urged patients to exercise caution and follow an expert's medical advice. According to Dr Kuri, the condition is reversible by reducing selenium intake, but it is important to detect the issue early for a better outcome. "Treatment of selenium toxicity primarily involves reducing or eliminating excess selenium intake — this means stopping high-dose supplements, avoiding selenium-rich foods in excess, and managing environmental exposure. Usually, when people reduce exposure, hair and nail loss lessens gradually," said Dr Kuri. Supportive care, including a balanced diet and adequate hydration, can aid recovery. However, in severe cases, medical supervision is necessary to monitor organ function and manage systemic symptoms.

What can you do to prevent it in the first place?

Dr Kuri shared that prevention involves adhering to the recommended dietary allowance (RDA) for selenium and avoiding unnecessary supplementation unless advised by a doctor. Regular blood tests may be recommended for individuals at risk, especially those using supplements for a long term.

#### 'Take patient history, keep your bedside manners as they are still the best medicine,' says Mumbai doctor Farokh Udwadia

For years, Dr Farokh Udwadia has sat by the bedside of his patients at the intensive care unit (ICU) of Mumbai's Breach Candy Hospital, holding hands, listening and talking to them. "That bond often wins battles because it is about the patient's faith that the doctor will get him through and it is the doctor's faith that the patient will use his will to fight back even when their body is broken," says the 93-yearold doctor, who is known for his accurate diagnosis and relied upon by generations of patients. The true art of medicine, he believes, has been submerged by the "hubris of technology." It was precisely to revive the human touch, which he sees fast receding among corporatised young doctors today, that he presented his play 'Oganga' (The Healer), based on the life of his idol Dr Albert Schweitzer (1875 -1965), at the Ambedkar International Centre in Delhi on April 18. The play, featuring Jim Sarbh and directed by Sooni Taraporewala, was a soliloquy on the conflict between ethics and progress and how the twain can meet.

Schweitzer, a polymath who gave up a successful life in Europe to treat patients in the jungles of Africa, epitomizes the kind of ethical dedication Dr Udwadia admires. "You don't have to be an evangelist," he says, "but India needs doctors who are committed to public health." He still keeps Schweitzer's photo in his consultation room. Somewhat of a polymath himself, he wrote the play during the lockdown over four months. He continues to write books on public health, plays Bach on his violin, paints, reads classical literature and gets inspired by Victor Hugo, Somerset Maugham and Rabindranath Tagore. But it's the poetry of TS Eliot that he loves, quoting verses from The Wasteland impromptu. "He talks about finding purpose in the wreckage of despair and as men of medicine, we can find that purpose. I ask doctors to develop many interests as a knowledge of humanities makes a good physician," says the doctor, who reaches his hospital everyday by 8.45 am for his rounds and finishes by 7 pm.

As his students mill around, he educates them about the drill of history-taking, a thorough physical examination and making a clinical diagnosis rather than depending on technology and tests. "If you take a decent history of the patient, then listen to him carefully about his discomfort, read the signs, you will know the path to take," he says. Recalling a case from his early days at KEM Hospital, he tells of an obese patient who suffered seizures. No test revealed the cause until a careful conversation revealed he had used uncertified herbal supplements for a long time. The supplements were laced with arsenic, leading to arsenic encephalopathy. "It was clinical observation and inquiry that solved the mystery," he says.Dr Udwadia advocates for scientifically-backed medicine, including traditional and alternative therapies—so long as they're tested for efficacy. "Nobody is against alternative medicine, but it must be empirically



validated. That benefits everyone."Known to be a hard task master of the basics, he insists how each hospital should keep an antibiogram, a study of bacteria in the laboratory and understanding how resistant it is to antibiotic medicines. As a critical care specialist, Dr Udwadia continues to study the mind-body effect, where the brain and body communicate through neural and hormone pathways. "Thoughts and emotions can trigger physiological responses like changes in heart rate, blood pressure, hormone release and immune function. If you look at the placebo effect of several clinical trials, you will find at least a small number of people getting better despite receiving an inactive treatment due to their belief in its effectiveness rather than its actual properties. This is something that as doctors we have to understand," he says.Like Schweitzer, Udwadia recommends music therapy in calming patient anxieties, citing how studies have proven that Mozart's clarinet concerto in A Major K622 increased muscle strength in stroke patients while undergoing physiotherapy in hospitals.Ramrod straight at 93, Dr Udwadia doesn't use hospital lifts but climbs seven flights of stairs. He exercises thrice a week though he was a champion runner in his student years, breasting the winning tape in 500 m, 800 m and 5,000 m events. He has a frugal diet. "A bowl of porridge for breakfast, three small sandwiches and two tiny yellow bananas for lunch and boiled fish and vegetables for dinner. One scoop of ice cream though is my guilty pleasure. But then I have been moving my body since my youth," he says. In fact, he recommends immediate lifestyle correction for anyone in their 20s. "Move your bodies. You may develop diabetes and high cholesterol because of lifestyle. But once you have them, they will pass to your progeny through your genes. That's why heart attacks and diabetes among the young are increasing. Begin now to save generations after us," he says. "All we need is a bit of mindfulness and a respect for life, not just money,"

## When autism is a greater ability than disability: Bengaluru boy runs YouTube music channel. All he needed was encouragement

Syed Hyder Ali, 20, is a self-taught musician from Bengaluru with an extraordinary gift—he can memorise lyrics in multiple languages, sing verses from the Quran pitchperfect and even run his own YouTube channel. He cleans leafy vegetables at one go in a manner that even his mother cannot emulate and manages household tasks independently. Better than most boys his age. And he does it from his little perch in a room, a quiet achiever under the shadow of his illustrious grandfather and cricketer, Syed Kirmani. As a grandson, he is just a different genius.

What many wouldn't guess is that Hyder lives with autism—a neurodevelopmental disorder marked by restrictive, repetitive behaviours and difficulties in communication. His mother, Nishath Kirmani Ali, recognized the early signs—speech delays, lack of social interaction and hyper-anxiety on flights. Widowed early, she became Hyder's sole caregiver and strongest advocate, even training as a therapist to better support him. "I did not have to teach Hyder life

skills. It is important not to focus on what an autistic child cannot do and instead focus on honing their existing potential. Of course, early intervention helps," she says.

Through the Autism Society of India, Ali now guides other parents, sharing lessons from her journey. She also stays up-to-date on autism research, which remains inconclusive despite decades of study. "Scientists continue to investigate potential links to genetics, environmental toxins, maternal diabetes and hypertension, even exposure to toxins and air pollution," she says. That's why she remains sceptical of US Health Secretary Robert F. Kennedy's claim that new research will pinpoint the cause of autism by September. Kennedy controversially blamed environmental factors and thimerosal, a preservative, in vaccines as triggers of this condition—claims widely rejected by scientific bodies and studies. Kennedy also said the condition might be preventable. Yet autism is not another disease.

### Trump labels BRICS 'anti-American', renews 10% tariff warning



In a fresh threat to the fast-growing BRICS coalition, which now includes 10 nations and was originally represented by Brazil, Russia, India, China, and South Africa, US President Donald Trump said in a social media post that any country aligning itself with the "anti-American policies" of BRICS would face an additional 10 per cent tariff. Trump had threatened BRICS nations of a 100 per cent tariff "if they so much as even think" about reducing the use of the dollar in global trade. Ever since the US weaponised the global financial infrastructure by excluding Iran (in 2012) and Russia (in 2022) from the Society for Worldwide Interbank Financial Telecommunication (SWIFT), countries around the world have sought to reduce their dependence on the US dollar and the US-led global financial system. Most notably, Russia and China began trading in domestic currency.

BRICS now accounts for 45 per cent of the global population and contributes over 35 per cent to the world's GDP At their summit held in Kazan, Russia, in October 2024, the founding five members—Brazil, Russia, India, China, and South Africa—formally admitted Egypt, Ethiopia, Iran, and the United Arab Emirates as new members. Indonesia joined the grouping later in January 2025, bringing the total membership to ten. In June 2022, Russia proposed the creation of a new international reserve currency based on a basket of currencies from BRICS countries. However, according to a BRICS report, member nations said they "do not seek to replace the US dollar as a medium of exchange". Instead, BRICS aims to "offer a viable alternative that will aid the market in its perpetual mission for efficiency" and foster greater prosperity, promoting universally beneficial and inclusive economic globalisation.

Trump's threat coincides with the US dollar hitting a

three-year low this year, after declining by over 10 per cent against a basket of currencies such as the euro and yen, due to expected disruptions in the US economy stemming from proposed tariffs. India's position and dealings in BRICSIn October 2024, External Affairs Minister S Jaishankar clarified that while US policies often complicate trade with certain countries, and India sought "workarounds" in pursuit of its trade interests, it did not "target" the dollar or seek to move away from it. "We have never actively targeted the dollar. That's not part of our economic, political, or strategic policy. Some others may have done so. What I will say is that we have a natural concern. We often have trade partners who lack dollars for transactions. So, we must decide whether to forgo dealings with them or find alternative settlements that work. There's no malicious intent towards the dollar," Jaishankar said in response to a question at the Carnegie Endowment for International Peace, an American think tank in Washington DC.In December 2024, then RBI Governor Shaktikanta Das had said India was not pursuing "de-dollarisation", and that recent measures such as allowing Vostro accounts and entering local currency trade agreements were intended to only "de-risk" Indian trade. While BRICS nations have discussed the possibility of a shared currency, they have reached no decision, Das said. "This is not about de-dollarisation: it is about de-risking our trade," Das said. "The geographical spread of BRICS nations is a factor to consider. Unlike the Eurozone, with its geographical contiguity enabling a single currency, BRICS countries are spread across diverse regions, posing unique challenges," he said. De-dollarisation not in India's interestA key reason why India is not backing de-dollarisation is the rise of the Chinese yuan as a challenger to the US dollar. India has resisted using the yuan for Russian oil imports, even as the currency's acceptance grows in Russia.

Following Western sanctions on Russia, including the freezing of \$300 billion in Russian foreign holdings, the yuan has become Russia's most traded currency. According to the Russian government, more than 90 per cent of trade settlement between the two countries is now conducted in roubles. Ajay Sahai, Director General & CEO of the Federation of Indian Export Organisations (FIEO), the country's top trade promotion body, told The Indian Express earlier that while supporting local currency initiatives, India should ensure the framework does not disproportionately favour China, given the asymmetry in economic power among BRICS nations.

#### The new battlefield: AI-based warfare in the 'agentic' age, multi-domain ops and energy as a big constraining factor



Even before China's DeepSeek model triggered a frenzy in the AI (artificial intelligence) world, its People's Liberation Army had started to deploy AI across its major warfighting functions under a somewhat gawky banner called "intelligentised warfare". Beijing is learnt to be taking a graded approach by starting with applying AI to improve the performance of battlefield equipment such as artillery systems by cutting the interval needed between each shot while improving accuracy, as well as integrating generative AI with military drones to automatically target opponents' radars with better precision as soon as they come on. The DeepSeek advances could only help China build on its military AI diffusions

Should that be a cause for worry for India? Yes, say experts, considering that the Chinese are actively aiding Pakistan with its Centre of Artificial Intelligence and Computing of the Pakistan Air Force that was established in 2020, which now has an elaborate Cognitive Electronic Warfare programme aiming to use AI and machine learning for "effective analytical and tactical decision-making". During the Operation Sindoor, some of this could have been used by that country, given that it was backed by China behind the scenes, as testified to by Lt General Rahul R Singh, Deputy Chief of Army Staff (Capability Development and Sustenance). Pakistan, he said, was aware of vectors being primed on a real-time basis, which meant it was likely getting live satellite updates from China, with some data crunching likely happening at the backend to enable all of this. Gen Singh's emphasis on the importance of C4ISR (Command, Control, Communications, Computers, Intelligence, Surveillance and Reconnaissance) and the need for civil-military fusion translates into the need for a certain expertise on the virtual domains, including the electromagnetic spectrum, and the domains of space and cyberspace. China is clearly a leader here, and a lot to be done in this area by India to catch up. Lt Gen Amardeep Singh Aujla, the Army's Master General Sustenance, said wars are becoming "increasingly intense and complex" due to evolving geopolitical dynamics and rapid technological advancements, which are transforming war-fighting practices and the control over new age technologies. This is being read as a recognition of the multi-domain approach being put into practice by China, and implemented in part by Pakistan.

"Modern armed forces must analyse large volumes of data from even more domains —land, air, sea, space and cyberspace—to decode enemy movements and devise deterrence strategies," according to Alexandr Wang, Founder CEO at Scale AI. The volume of information is all but impossible to handle with current technologies, and the ability to harness data and AI could mean the big difference in the next engagement. And while AI advances are important, there is another limiting factor in all this: energy. Fields such as Big Data analysis, machine learning, predictive analysis, and natural language processing need a lot of energy, including vast spinning reserves of grid power. The electricity grid needs new electricity sources to support Al technologies and countries are increasingly turning to nuclear sources of energy to supply the electricity used by the huge data centres that drive Al.

"At this point, India is clearly short of nuclear power, with (an installed capacity of) only about seven and a half gigawatts... South Korea, a much smaller country that has around three times India's installed nuclear capacity. So while opening up the sector to private participation is the

only way to bring in new technologies into sectors such as nuclear, I think that there is a defence dimension too. Ten years from now, think of the next war... If it were to occur, it will be fought by robots and Al... That means you must have AI; you must have data crunching capability, and the ability to run big data centres... So, the investment in Al data centres and robotics is going to underpin the future defence posture of the country. And for that, the single most important ingredient is enormous amounts of electricity generation. If you don't generate power, all this would not be possible," Kris P. Singh, the Indian-American promoter and CEO of Holtec International told The Indian Express. Camden, New Jersey-based Holtec, one of the world's largest exporters of capital nuclear components and a frontrunner in the emerging small modular reactor (SMR) space, is in the running to set up proposed SMR-based projects in India. "Put the SMRs right next to data centers, and then you have defence capabilities right there. And from there, you can, can do missiles, drones, smart soldiers and robots. And you're not too far away, maybe just 10 years. So, I am basically asking that the country become aware that it needs enormous amounts of energy to clean energy to support the future in defense of the country," Singh said.India's current energy woes have multiple triggers: a focus on rapid expansion of renewables in the absence of energy storage systems, especially over the last decade, that is now resulting in increasing instability in the country's electricity grid. This issue is compounded by a policy decision from roughly ten years ago to scale down thermal expansion, which provides critical baseload support to the grid during evenings in summer months, when solar generation dips and demand remains high. SMR-based nuclear projects of the kind that Holtec International is proposing are now being viewed in India's policy circles as solutions to scale up baseload capacity, alongside renewed efforts to draw the private sector back into thermal generation.On the battlefield use of Al. India's defence establishment was notably an early mover, given that the the Defence Research and Development Organisation's (DRDO) Centre for Artificial Intelligence and Robotics (CAIR) came up in 1986 with the specific objective of developing autonomous technologies in the domains of combat, path planning, sensors, target identification, underwater mine detection, patrolling, logistics, and localisation etc. "They are making progress," a senior government official said about the CAIR project. The problem for India, though, is the combination of China's burgeoning AI prowess and its willingness to help out the PAF with its Centre of Artificial Intelligence and Computing and in possibly meeting that country's energy needs at the backend. In the fast-changing landscape of warfare, the first nation to fully incorporate AI into military decision-making will shape the history of the 21st century. Humanity is entering a new era of "agentic warfare", in which we will see some of the world's strongest armies beaten by rivals that are better at harnessing AI agents—autonomous intelligent systems that can perform a multitude of tasks," Scale Al's Wang said in a piece dated March 4 that he wrote for The Economist. The new AI systems, according to Wang, will allow the most technologically advanced armed forces "to outthink and outmanoeuvre" even very capable opponents by hooking up a military network of sensors, weapons and human decision-makers in a bid to sharply increase the speed at which tactical moves can be proposed, and allow battlefield advantages to be acted upon before humans are even able to survey the situation. All is set to rapidly transform the landscape of warfare, with deep tech being deployed for tasks ranging from autonomous weapons systems to intelligence gathering and cybersecurity, according to a research report by Delhi-based Centre for Joint Warfare Studies, an autonomous think tank raised at the initiative of the Ministry of Defence in 2007. This includes the development of autonomous weapons systems that can select and engage targets without human intervention; analysing vast amounts of data to identify potential threats, tracking enemy movements, and forecasting future attacks; and creating realistic battlefield simulations to enable field evaluation trials as well as allowing soldiers to train in virtual environments to prepare for real-world combat sce-

## Is your brain health at risk from foil food boxes and your wet raincoat? Here's all you need to know about forever chemicals



Is the food that you have from the cardboard/foil box delivered by a food app or the raincoat that's shielding you from the rain affecting your brain health? Many of us may not know this but our everyday items may be leaching compounds into our gut and skin that's insidiously triggering persistent health problems.

This is because most consumer goods contain PFAs (per- and polyfluoroalkyl substances), a group of chemicals that have a powerful ability to repel oil and water and resist heat. For long these have been widely used in various products like non-stick cookware, firefighting foam, water-resistant clothing and food packaging, making them pervasive in everyday life. "These do not get destroyed in the environment or the human body and tend to persist, earning the moniker forever chemicals. However, because of their persistence, they can cause significant health concerns. Many people are exposed to forever chemicals through drinking water, food and even dust," says Dr Praveen Gupta, Chairman-Neurosciences, Marengo Asia Hospitals, GurugramThe worst part, he says, is that they might be stuck in your body for years. A new study by the researchers from the Del Monte Institute for Neuroscience at the University of Rochester recently found that early life exposure to forever chemicals may increase anxiety-related behaviors and memory deficits in male mice.

How do forever chemicals impact your health?

They can interfere with the endocrine system, which regulates hormones, potentially affecting reproductive health and development. Studies have shown associations between exposure to forever chemicals and liver damage and thyroid dysfunction. PFAS can weaken the immune system, potentially reducing the body's ability to fight infections and respond to vaccines. Certain PFAs have been linked to an increased risk of kidney and testicular cancers, according to the National Cancer Institute. But now they are being studied for their impact on brain health?

How neurotoxic are forever chemicals?

This is a relevant concern now because of their ability to penetrate the blood brain barrier. This acts as a protective filter, regulating the movement of substances between the bloodstream and the brain, allowing essential nutrients in while keeping harmful substances out. But now the latest mice study has shown that they are permeating this barrier. This is significant because the damaging effects continued long after the exposure. Once the barrier is breached, these chemicals disrupt key neurotransmitters (chemical messengers that transmit signals across the nervous system) particularly dopamine, which impacts movement, motivation, mood and reward, as well as glutamate, which stimulates nerve cells so that they can pass on signals to each other. It's essential for normal brain function, including learning and memory. Forever chemicals may also destroy nerve cells by interfering with genes. They can also stimulate neuroinflammation and damage brain cells. That's why we have impaired sleep. All of this leads to neurodegenerative processes and impacts cognition and increases the risk of Alzheimer's. They can also be related to behavioural disorders in children like ADHD or lower aca-

### Let's talk about obesity: Why it's not just a health risk but a mental health condition



Sometimes therapy room conversations are an eyeopener. That's where a woman dealing with obesity told Dr Rituparna Ghosh, senior clinical psychologist, Apollo Hospitals, Navi Mumbai, "I know I need to take care of my health. But I just wish people could see me before they see my body." It raised a pertinent point of eliminating stigma and creating a safe space for people just about to take the first step in their weight loss journey. "What most people forget is that obesity is not just a health condition — it's also a deeply emotional experience, shaped not only by biology and environment, but by the way society talks about bodies. We must be honest about obesity as a chronic, complex medical issue. However, we must also discuss it with compassion, nuance and respect. Because words — casual or clinical — can either heal or harm," she says.

How we speak about obesity and other diseasesWhen we refer to someone as "an obese person," it almost defines him from that one prism. "We don't say 'a cancerous person' or 'a diabetic person', do we?

At least say 'a person living with obesity.' These phrases acknowledge the person first — the human, not the health condition," says Dr Ghosh. She feels that even seemingly politically correct labels like "plus-size" tend to be judgmental. "The goal is not to glorify obesity or pretend it's without consequence — the goal is to replace judgment with support so that people can seek help without fear or shame," says Dr Ghosh.

When language matters

Compliments about weight loss, like "You look so much

better now," may seem encouraging but can sting as they allude to a past where you weren't good enough. Similarly, "good for you, picking the salad," can feel patronizing, especially when we wouldn't say it to someone in a thinner body. In fact, Dr Ghosh lays down examples of what some of our words and phrases can mean to the obese person. For example, when we say, "Are you sure you need that second plate," in a well-meaning manner, the person might feel shamed and policed.

Sometimes doctors themselves may unknowingly play the blame game. "When they focus only on weight (which no doubt is a risk factor for diseases) for all their health issues, their patient might feel dismissed. A good strategy would be to talk about the current health issue, then move to weight as a trigger," says Dr Ghosh. She also cautions against normalising fat jokes, no matter how sporting overweight people might be. "Inside, they feel excluded and mocked," she adds. In fact, she has seen many people dealing with obesity discontinue going to the gym only because the trainer pushes them to do more. Instead they should be saying, "Let's do what works for you today."Backhanded compliments, like "You have such a pretty face, only if you had lost some weight," can be demotivating. Instead, saying, "It's so great to see you" is affirmative without conditions. Or when you say, "you're brave for wearing this dress," it might imply that you're making a judgment on a bold style statement and the perover eating an extra piece of cake or jalebi — "I'm being so bad today, I had an extra piece of cake/jalebi," might just make a person struggling with weight issues uncomfortable with the idea of eating anything. Small gestures matter. "Don't offer flimsy and slim chairs in a public setting to your guest. Comfortable seats reassure people dealing with obesity that they are welcome and included," says Dr Ghosh. Fitness ads, too, should be size-inclusive, to create a realm

Difficult conversations don't have to be demeaning The whole idea is to build trust so that people dealing with obesity feel supported, not avoided. "Many people living with obesity already know the risks. What they lack is a safe space to talk about it without being judged, interrupted, or blamed. Praise their energy. Admire their resilience. Acknowledge their humanity," says Dr Ghosh.

### The 'Khelo Bharat Niti' as a beacon for Indian football

Sports, as a whole, has gained immense priority under the leadership and the vision of Prime Minister Narendra Modi, and it is with great hope that we look forward to the next 10 years, when India, under this vision, could become one of the world leaders in the sporting arena. India has successfully expressed its interest in hosting the 2036 Olympics, and in preparation and anticipation of this, the nation will undoubtedly have the honour of hosting various other prestigious international sporting events as well.

The Khelo Bharat Niti 2025 (National Sports Policy), which was passed by the Union Cabinet on Tuesday, July 1, 2025, marks a policy milestone in transforming the role of sports in building a Viksit Bharat. There are several aspects of the policy that, in my view, should result in much appreciation for Mansukh Mandaviya, Minister of Youth Affairs and Sports, particularly from the perspective of football. There is the five-Pillar approach of the policy in the context of football. First, sports excellence — the importance of the national team's standing in the global arena and the work needed on that front. Second, sports for social development — the role of football in sports for development and inclusion. Third, sports for economic development — how football can contribute to industry and growth through events, manufacturing and jobs. Fourth, sports as a people's movement — community sports. Fifth, sports in education — football in schools. When it comes to the performance of the national team, there is one area in the policy which we have worked on actively - access to talent in India's diaspora and I am happy that the policy has refer-

ence to the subject. This is a positive statement of intent and the All India Football Federation (AIFF) will continue to work with the Fédération Internationale de Football Association (FIFA) and the government to do everything possible to strengthen the national team. For some years there has been a vociferous demand for the inclusion of players with Overseas Citizens of India (OCI) cards in the national team. We have seen countries such as Bangladesh, Hong Kong, Malaysia, the Middle Eastern Nations, Singapore, Sri Lanka, Vietnam and those in Europe tap naturalised players with dual citizenship to strengthen their teams. Some clarifications in the Indian context might be helpful at this stage. As in the FIFA Statutes, a player must hold a passport of a nation he or she wishes to represent and must produce it on match day. While an OCI card grants certain social and economic rights to an individual, it is not equivalent to an Indian passport. Given that India's laws do not provide for dual citizenship, it is for India to strategise how it could capitalise on the opportunity to access the talent within the diaspora and integrate these players into the national team according to FIFA regulations as well as Indian citizenship law. The policy direction provides a ray of hope and we are intent on exploring it to its logical conclusion.

At the grass-root level, the AIFF has plans in place to ensure the progress of talented individuals from eight years of age right up to the senior level. At the lowest age category (eight to 10 years) football has been made accessible for children. When they progress to the age group of 12 to 13 years, they are introduced to competitions. As they further move on to the U17 and U18 levels, they get high performance training and then on to the U18 and U20 levels, where the transition from youth to professional level. Such processes would not be possible without the help of facilities of schools, and we thank the Minister for Education, Dharmendra Pradhan, for having facilitated the alignment of the National Education Policy with the National Sports Policy. Through the FIFA Football for Schools (F4S) programme, we have successfully made that link logistically feasible, bringing the beautiful game to over 1,53,000 schools — over 9,26,000 footballs are being distributed. This is how football is being made accessible at the U8 level.I firmly believe that India's National Sports Policy aligns with National Education Policy which will catalyse a new era of transparency, accountability, and inclusivity in Indian sports.


## Laura Siegemund, who made Wimbledon QF at 37 – 'I have game, boldness to take out big names on the other side. In a positive, respectful way I don't care'

Wimbledon witnessed a novelty in a 37-year-old woman making the quarterfinals of the women's singles, and rose in applause as German Laura Siegemund defeated Solana Sierra 6-3, 6-2, with a tricky game. The winner of three Grand Slam titles in doubles (one women's, two mixed), Siegemund was a hoot in her post match after denying Sierra net approaches 15 times out of 19, and lobbying over her cheekily and with an array of passing shots that delighted for their angles. Making Last 8, she was surprised by the popularity coming her way. "It's an honour. I want to say it's not often that you get such a compliment for being old," she chuckled, before slashing at giving undue importance to her academic record. She has a degree in psychology and the interviewer very naturally asked if it helped her in tight situations.

"Oh I've been saying in many, many interviews over many many years that a psychology degree in this kind of moment ...really it's worth absolutely nothing," she said as the Centre Court crowd guffawed. "Everyone that's good at their job and is a pro in whatever they do, they know that knowing something and being able to perform are two completely different things. If not, everyone who knows how to play an amazing forehand would play an amazing forehand. So that's two different things."However, she insisted neither age, nor a formal degree had anything to do with her personality. "But obviously over time I just have that in me, even as a youngster, I am just mentally very tough. And I'm a fighter. And I learn better to stay in the moment. And I said earlier I'm just focussing on me. There's not much more I have to prove but there are some moments where you want to win so bad you get greedy and it's important to let go of that greed. If you are ready to accept the good matches to lose, then you are ready to win. That's what I try to remember in big moments," she said. Siegemund won 5/8 of her breakpoints and 6/9 net approaches, and will run into tournament favourite Aryna Sabalenka next. She told reporters reputations didn't faze her. "I have this game and this maybe boldness—I don't know if that's the right word in English—to take out big names. I've always had that," stated Siegemund. "Just maybe because I don't care who is on the other side. In a positive, respectful way I don't care."

Her reactions post winning were an emoji scroll, the Korean heart, the 'well, can't help being cool' shrug and the first pump as she became the oldest female left in the draw now. Her game is indescribable as much as it is unconventional. 

### Shubman Gill the captain: Not remote controlled but leading in his own way

As for the coach Gautam Gambhir, he hasn't been over-interfering in the proceedings on the field. For long periods of stand-offs where wickets have been hard to come by, the captain has been changing fields, bowlers and tactics without any obvious prompt from the dressing room. When Shubman is batting, the substitutes haven't randomly run on the field with gloves or when the team is fielding, carrying unasked for water bottles. Shubman does his thing, the way he likes. He does have counsel available on the field. Vice-captain Pant, seniors KL Rahul, Ravindra Jadeja, Jasprit Bumrah, and even Mohammed Siraj, too chip in when asked for and even offer unsolicited advice. As the pundits from the commentators box, especially while assessing the new captain during the first Test have said "Shubman is running the team by committee". So if someone fumbles on field, Pant can be heard saying "kya yaar". In the first Test, when a disappointed Bumrah was walking back after yet another brilliant over in which a catch was dropped, the wicket-keeper would walk with him almost till the boundary line. Team's veteran spinner Jadeja would be seen explaining the pivot to Washington Sundar as the two would be walking to the central square after lunch break. And Siraj, while pointing to the mini-crater on the bowling crease, would be heard telling Akash Deep "isko dimag se nikal de, ab hai toh hai, kya kar satke hain. (Just wipe this thing out of your mind, if it's there, what can one do?)". The young captain individually, and the new team collectively, are negotiating the uncharted terrain they all find themselves

on. And credit to the coaches - Gautam Gambhir and Morne Morkel along with the chairman of the selection committee Ajit Agarkar who haven't tried to micro-manage the team. It's being said that it was the captain who had a big say in the team selection - keeping Kuldeep Yadav out for an allrounder wasn't a decision forced on the captain. It was his call. In the first Test at Headingley, the team's only pace allrounder Shardul Thakur was introduced in the attack pretty late. This despite the fact that others weren't getting wickets. Coach Gambhir would later say that it was the captain's call and he didn't mind it. In the first inning of the second Test, Shubman, for a brief while, stuck to a very rigid 'legside heavy field, short-ball' ploy when Harry Brook and Jamie Smith were at the start of their partnership. It didn't work, actually it helped them settle and score freely. Bowling coach, the former South African pacer Morne Morkel, hinted that he wasn't on the same page as the captain. "I thought we moved slightly away from our plans in the first innings, and in a way also with runs on the board you want to take a couple of more risks ... For me personally on this sort of surface, you want to set a field where you can still have both options: using the short ball and try to nick a guy off, he would say. But he did appreciate his captain's thought to find his own solution to the problem at hand. "Credit to Shubman, he took a gamble for a couple of overs to poten-

After getting his Man of the Match award for his aggregate of 430 runs in the second Test, Shubman spoke about his captaincy philosophy. Before the second Test, he had blamed his own casual dismissal after scoring 147 as the reason for the team's loss in the first Test. "I should have scored more, a longer partnership with Pant would have made a difference," he had said. In the very next Test, Shubman didn't leave it for others. He stayed around to take the team to the total he wanted. He had his reasons to lead by example. "Sometimes, especially when you are the captain, I think you need to lead by example so that whenever there is another player in that situation, you can command that player," he said. This was a captain subtly asserting himself, this was a skipper earning the right to be the "commander". Former England captain Nasser Hussain, who had noted during the first Test that Gill "lacked aura" would reassess his verdict at the end of second Test: "He (Gill) is not going to be a Kohli-type character. He's got a low heartbeat, but that can help. Look at this crowd here today. Look at all of India watching on. You may need someone just to calm the team."While he has just led in two Tests, in IPL there are those who have seen him closely for the entire season. Former England captain, the seasoned Jos Butler is seen as the voice of reason. In a recent podcast he was asked to comment on the young man he played under. "He was my captain at Gujarat Titans, a really impressive player, an impressive young man. I think pretty calm and measured when he speaks. I think he's got a bit of firepower, a bit of intensity, quite passionate ... He will do well and have some good people supporting him," he said. Butler also said Shubman's captaincy was a mix of Rohit Sharma and Virat Kohli – a quote that got picked by reel makers and went viral. But Shubman, it seems, is a mix of Shubman and

### Mohammed Siraj is Team India's senior pacer, jester, cheerleader and neo-Jonty Rhodes, all rolled into one

While India's new bowling star Akash Deep was busy giving an interview to broadcasters, talking about his 6/99 and the team's historic 336-run win, his senior pace partner Mohammed Siraj walked in the frame unannounced. "Kuch mera bola, tune? (Did you say anything about me?)," he said, with that goofy smile pasted on his face. Akash Deep mumbled something about his press conference comment but Siraj wasn't listening. "I kept telling him, don't go for wickets, and just concentrate on line and length. After every over I would tell him this."

Till a few months back, no one would have known India had so many leaders in its ranks. In a team with stalwarts like Virat Kohli, Rohit Sharma, R Ashwin and Jasprit Bumrah; there was always too much wisdom and ideas galore on the field. For the juniors, there was nothing much to do, except to loiter around between overs, also known as 'garden mei ghumna'. This England series has been about the arrival of that 'apna time aayega' generation, not just for the new captain but also for new seniors - vicecaptain Rishabh Pant and the leader of the bowling pack in Bumrah's absence, Siraj. Now you can see them on the central square, hear them often on the stump mic - it's their time to have a say in the way the team plays. The apprentices have become the decision-makers and they aren't embarrassed to say that they are loving it. After getting the six wickets in the first innings and showing English bowlers the way to bowl on the pitch where they had conceded 587, Siraj was informed about his unique record by former India player turned commentator Deep Dasgupta. When bowling abroad in Bumrah's absence, Siraj's bowling average dips significantly. From taking a wicket after every 32 balls, he does so in just 23 when he is leading the attack."I love responsibility, I love challenges. Life mei kaafi challenge dekha hu wahan se ubhar ke aaya hu toh pasand hai muihko challenge (I have seen many challenges in life, I have emerged from that tough situation and I love challenges). Whenever there is responsibility on me, I fulfill them very well," he said. Siraj's father was a rickshaw driver and mother a house help. They lived on the other side of the track, struggling to make ends meet. Siraj took up cricket seriously because he wanted his parents to give up their arduous jobs and lead a peaceful retired life. He did so.

(AP Photo)For Siraj, the man of the house after his father's death, what was hand-holding a couple of young pacers? "Akash Deep is playing just his third-fourth Test, same is with Prasidh. I have played 38 Tests, so I knew how to bowl. Since we had scored lots of runs in the first innings, I would have gotten carried away and tried things. But I bowled tight, bowled in partnership so the bowler at the other end also has a chance of getting wickets," he said. Besides being a big-hearted senior, Siraj also wears the hat of the team's on-field bowling coach, game-time mental guru and a strict school teacher. "I told Akash that I will give you 100 marks for the four balls you bowl in the middle of an over. But on the first and last balls he would concede a single or a four. Pant would give his 'shabash' from behind the stumps, Siraj would run to pat his back from mid-on across the field. Ravindra Jadeja, manning the off-boundary as sweeper cover fielder, sprinted across to stop another sure-shot boundary with one hand and threw it perfectly to the keeper. Siraj was now waving frantically to draw Jadeja's attention. Once he did, Siraj raised both his hands and gave a grand bow. Jadeja smiled, leaving the rest of the team in splits.But who puts an arm around Siraj when Bumrah isn't there? It's captain Shubman Gill at mid-on who calms down the emotional player prone to bouts of anger and frustration. It is also Pant. It was the vice-captain wicket-keeper who suggested to Sirai to test Ben Stokes with a first-ball bouncer in the first innings. Stokes got out for a golden duck and Pant and Siraj celebrated like co-conspirators celebrating a heist. The life of this team, Siraj is easily the Mr Congeniality of the Indian dressing room. On Day 5, with India on the threshold of the win the England tailenders were putting on a stubborn late-order partnership. They were getting on the nerves of the Indians. That's when Siraj came up with a stunning full length dive to hold a one-handed catch dismissing England pacer Josh Tongue.

At the time, it seemed like Ranveer's time had truly arrived. But just when things were soaring, the Covid-19 pandemic hit — and with it, a sharp pause hit his career momentum.In 2021, Ranveer Singh returned with 83 — a passion project that saw him transform into cricketing legend Kapil Dev. Ranveer delivered a career-defining performance, but unfortunately, the film was released amid pandemic restrictions and failed to make the kind of cultural or commercial impact it deserved. Despite his brilliance, the performance went largely under-recognised by audiences. If things were different, 83 could have been Ranveer's Chak De India moment. Post Gully Boy, Ranveer tried repeatedly to regain his footing — with films like Jayeshbhai Jordaar and Cirkus — both of which were box office flops. It wasn't until Rocky Aur Rani Kii Prem Kahaani (2023) that audiences once again embraced him. But even then, it was Alia Bhatt who took away most of the praise. Despite Ranveer delivering a fun and emotional performance as Rocky Randhawa, viewers saw the character as an extension of his real-life persona — flamboyant, flashy, and over-thetop. The effort he put into the role largely went unnoticed under the weight of his public image.

When it comes to Ranveer, this isn't a problem exclu-

Despite proving himself to be a versatile actor, he has to face the litmus test and the pressure of being seen as a 'serious' actor almost before every release. Initially, the problem was considered his 'loud outfits', which he admitted took the focus away from his acting skills. During his appearance on Koffee With Karan, he had said, "I felt like I wanted to not wear those clothes. I didn't want people to talk about what I'm wearing. I want you to talk about my films, my acting, I want you to talk about me."He admitted that it was Deepika who had pointed this out to him. He said, "It was Deepika who pointed this out to me. We were having a chat, and she was like, 'You know, you come across as this supremely confident person, but you're actually underconfident'. I was like, 'Acha?' She was like, 'You should stop distracting people from who you are with all these flashy clothes'. That resonated with me."Overexposure was also a key issue. At one point, Ranveer was everywhere — weddings, inaugurations, launches, cricket matches — and his persona became difficult to shake off when audiences saw him on the big screen. The infamous nude photoshoot also didn't help

And while this might have initially worked to build his "larger-than-life" brand — which is now helping him promote his snack label SuperU — it backfired when it came to his acting career. The mystery was gone. Even his most passionate performances — including Rocky

Aur Rani Kii Prem Kahaani and Simmba — were dismissed by many because they couldn't separate the artiste from the star who got all the attention. Also, while Deepika and Ranveer became a brand — 'Bollywood royalty,' as Karan Johar called them — the over-imposition of them as a couple took some agency away from Ranveer. For a brief period, he was only seen as the ideal husband. If you closely examine the filmography of Ranveer Singh's contemporaries, there's no denying that he comes out with flying colours. Ranbir Kapoor may be at the top of his game now after delivering the massive hit Animal, but before Sandeep Reddy Vanga's film, he had a string of underwhelming performances. His last major hit before Animal was Sanju (2018), followed by major disappointments like Shamshera and Brahmastra. Moreover, despite the success of Animal, none of his recent performances have truly resonated with audiences — his last widely acclaimed roles remain Tamasha (2015) and Ae Dil Hai Mushkil (2016). However, the buzz around his upcoming films — Ramayana and Love And War — has certainly added to his growing clout. When it comes to Vicky Kaushal, he did have a major hit this year with Chhaava, but his other recent releases — Bad Newz, Dunki, The Great Indian Family, and Zara Hatke Zara Bachke — failed to make a lasting impact. Still, he has managed to cultivate the image of a 'serious' actor, despite these lukewarm performances.Ranveer, on the other hand, has also had his share of misses with films like Jayeshbhai Jordaar (2022) and Cirkus, but it's impossible to overlook his compelling performances in Rocky Aur Rani Kii Prem Kahaani (2023) and 83 (2021). While his peers are often granted the benefit of the doubt even after flops, Ranveer, in contrast, is repeatedly made to prove himself. After Farhan Akhtar announced Ranveer Singh as the next Don in Don 3, social media erupted with trolls, deeming Ranveer unworthy of stepping into Shah Rukh Khan's shoes. Farhan himself came out in his support, saying, "He is a really good actor. He has proven himself to be a versatile actor. I am not worried about him playing lead in Don 3 and he shouldn't be either. He is going to give a slamming performance."The backlash seemed to have affected Ranveer. But the actor humbly appealed to audiences to give him a chance, citing his solid body of work over the past decade. On Koffee With Karan, he said, "Ek chance dedo, 12-13 saal me thik thak hi kaam kiya hai maine, toh ek mauka toh banta hai (Give me one chance, I have worked decently for 12-13 years so I deserve one chance). "Recently, the actor has gone quiet, no flamboyant appearances, fewer public events — a visible pullback from the limelight. It's a move that has led to a slow build-up of curiosity around him once again. Apart from Don 3, he's also leading a massive action-thriller Dhurandhar, directed by Aditya Dhar, known for making Vicky Kaushal a star with Uri.Ranveer has proven himself to be a director's ac-

I recently learned that some fellow composers have also been involved in spreading labels about me. I didn't know this before. They are all scared of me and stressed that if I keep getting work, their factories will shut down. But no matter how hard you try to suppress a talented person, they'll bounce back like a spring." The elder son of composer-singer Daboo Malik and his wife Jyothi Malik, Amaal made his debut in 2014 by composing three songs for Salman Khan's Jai Ho. His younger brother Armaan Malik is also a well-known musician.

Bengali superstar Prosenjit Chatterjee, fondly called Bumba Da by many, has taken on the producer's role for a Hindi show. In a recent conversation with SCREEN, Prosenjit shared how his experience as an actor has deepened his understanding of a producer's role. Talking about how West Bengal Chief Minister Mamta Banerjee also refers to him as "Bumba Da," Prosenjit shared, "You see the best part is not just in West Bengal, on all the sets when I was doing Jubilee and Khakee, after a certain time, everybody calls me Bumba Da. Even in Mumbai, Manoj, Rajkummar, they all call me Bumba Da. In West Bengal, nobody calls me Prosenjit, even our honorable Chief Minister, Mamta Banerjee, in official meetings also addresses me as Bumba. During the interview, Prosenjit Chatterjee also talked about how his experience as an actor helped him better understand the nuances of production. Not just me, but even Shah Rukh Khan, Salman Khan, Ajay Devgn - when they started entire economy was very different, and as an actor, you need to understand the psyche of the producer. You need to understand the good and bad of the production; otherwise, you are not a producer-friendly actor. We always thought that the producer has to benefit; they should get money, only then will they come to produce the other two films.""That is the way we have grown. I completely understand production, and people in Kolkata say that I am the finest planner for shoots. If I hear a script, within 24 hours, I give them a breakdown on what they should do. We have seen the hard times, so we don't waste. I had produced a show for Star Jalsa, and it was directed by Rituporno Ghosh. Nobody else could bring a Rituporno Ghosh to direct a TV show. To date, it's a cult show that happened in Bengal. So, I always try to do something that I like creatively," he added.

On a parting note, Prosenjit Chatterjee said, "I always say, I am not a producer. I want to remain an actor, I am born to act, and I want to do so till my last breath. As a student of cinema, I have been doing lots of shows and films, mostly with newcomers. That's the way I want to produce. When I act, I try to do so for other producers. It's my psychology that till I don't sign a film, I cannot value myself. That's a habit I don't want to change.'
