Hyderabad: Acting Chief Justice Sujoy Paul and Justice Renuka Yara of the Telangana High Court on Wednesday issued notices to the State Chief Secretary K. Ramakrishna Rao and Principal Secretary of the Municipal Administration and Urban Development Department T.K. Sreedevi in a contempt petition, seeking their explanation for failing to act upon a court direction regarding the implementation of the Indiramma Atmiya Bharosa Scheme in municipal areas. The contempt proceedings arose out of an

earlier public interest litigation, wherein the petitioner sought extension of the Indiramma Atmiya Bharosa



Scheme intended to benefit landless agricultural labourers in rural areas to similarly placed individuals residing in small towns and municipal jurisdictions.

The scheme was introduced through G.O. No. 18 dated January 10, 2024. In its previous order, the High Court had directed the peti-

tioner to submit a representation to the Chief Secretary and the Principal Municipal Secretary, Administration.It had further directed the authorities to take a decision within four weeks of receiving the representation and communicate the same to the petitioner. The Court had made it clear that it was not expressing any opinion on the merits of the scheme or its applicability to urban areas.However, alleging non-compliance with the court's directive, the petitioner returned to the High Court with a contempt petition, asserting that a representation had been duly submitted.

However, no decision was forthcoming from the authorities.Advocate Chikkudu Prabhakar, appearing for the petitioner, submitted that the inaction of the officials constituted a violation of the court's explicit direction.Taking note of the submissions, the bench issued notices to the Chief Secretary and the Principal Secretary, calling upon them to respond to the allegations. The matter was adjourned to

Government to initiate removal motion against Justice Yashwant Varma

The government will begin the process of collecting signatures for a motion to remove Allahabad High Court judge Yashwant Varma soon, as most of the prominent political parties have accepted, in principle, to support the motion. The Government is set to begin the process of collecting signatures for a motion seeking the removal of Allahabad High Court judge Justice Yashwant Varma, with several major political parties having expressed their willingness, in principle, to support the initiative. Union Minister for Parliamentary Affairs Kiren Rijiju on Wednesday (July 2, 2025) said that while the process of obtaining signatures would commence shortly, a decision was yet to be taken on whether the motion would be introduced in the Lok Sabha or the Rajya Sabha. A minimum of 100 Members of Parliament (MPs) is required for the Lok Sabha, and at least 50 MPs for the Rajya Sabha, for such a motion to be admitted. The Monsoon Session of Parliament will begin on July 21 and conclude on August 21, following a last-minute extension of 10 days. President Droupadi Murmu gave assent to the revised schedule earlier in the day. "The Government has enough business to conduct," Mr. Rijiju said, without elaborating on the reasons for extending the session beyond the earlier end date of August 12. Even if the motion is introduced during the upcoming session, it is unlikely to reach a conclusion within the same period. Under the Judges (Inquiry) Act, 1968, once a motion for the removal of a judge is admitted in either House, the presiding officer is required to constitute a three-member committee to investigate the allegations forming the basis of the motion. This committee is composed of the Chief Justice of India (CJI) or a Supreme Court judge, the Chief Justice of a High Court, and a distinguished jurist. The committee must submit its report within three months, though an extension may be granted.

Fire Breaks Out at AIIMS Trauma Centre, Major Disaster Averted

New Delhi: A major fire broke out on Thursday afternoon at the Trauma Centre of the All India Institute of Medical Sciences (AIIMS) in Delhi, causing panic on the hospital premises. The blaze originated in a high-voltage transformer, but swift action by the fire department ensured that the situation was brought under control without any casualties or disruption to hospital services. According to fire officials, the incident occurred around 3:35 p.m. when a 33,000volt electric transformer installed near the Trauma Centre caught fire. The Delhi Fire Service was immediately alerted, and eight fire tenders were rushed to the site. The swift response and efficient coordination of the firefighting team ensured the blaze was quickly brought under control before it could spread to two adjacent 33,000-volt transformers. Officials noted that had the fire reached those units, the outcome could have been far more dangerous. The situation was especially critical, as the doctors' hostel is located just five meters away from the transformer that caught fire. Fire personnel acted promptly to extinguish the flames and secure the area, successfully averting a major disas-

Animals are not for entertainment", warns PETA India

Hyderabad, Out of concern for elephants and after a series of recent incidents in which upset captive elephants turned violent and lashed out killing and hurting people, People for the Ethical Treatment of Animals (PETA) India has offered the organisers of upcoming Bonalu and Muharram events in Secunderbad and Hyderabad innovative lifelike mechanical elephants to use in place of real elephants.

PETA India has written letters to S. Venkata Rao, Director of Endowments Department of Telangana, which organises the Bonalu festival and to Azmet Jah, Chairman, HEH The Nizam's Religious Trust; Mirza Riyaz-ul-Hasan Effendi, Member of Telangana Legislative Council and Syed Azmatullah Huseini, Chairman, Telangana State Waqf Board, who organise the Muharram events offering a lifesize mechanical elephant and pointed out that the use of a mechanical elephant will safeguard animal welfare and protect humans from potential harm by an upset elephant.PETA India also wrote to the Director of Project Elephant and the Chief Wildlife Wardens of Telangana, Andhra Pradesh, Karnataka, Rajasthan, and Delhi, urging them to safeguard elephants from unnecessary pain and suffering by denying any permission for transport and use of an elephant in these processions.

The letter highlights that in 2004, elephant Gajalakshmi who was used in the Muharram caused panic, endangered lives and it serves as a stark reminder of this fact. More recently, elephant Madhuri or Mahadevi, who was used for Bonalu and Bibi-ka-Alam, had killed a temple priest, further underscoring the dangers of using live elephants. Last year, a partially blind elephant, Roopavathi, was brought from Karnataka and was paraded for hours while being controlled with an ankush, amidst thousands of people and loudspeakers' music.PETA India warns that elephants are wild animals, who are unpredictable, especially amid large, noisy crowds and are known to lash out at things that upset them and eventually attack their mahouts and other humans. Mechanical elephants are increasingly being adopted in various temples and at religious events, providing a safe and awe-inspiring experience for all attendees. It has urged the organisers to reflect on the potential risks and suffering involved in using a live elephant. In 2025, at least 20 captive elephants in Kerala used for festival had become upset and killed six people on different occasions, injuring several others, or damaged property. It is also pertinent to note that in 2024, at least fourteen incidents across India in which captive elephants harmed or killed their mahouts or others around them were reported.

Auto estimate software for new HT services: CMD Faruqui

Hyderabad, July 3 : The Southern Power Distribution Company of Telangana has developed an Auto Estimate Software System for 33 kV new HT service applications to provide efficient and transparent services to its consumers swiftly, said Musharraf Faruqui, Chairman and Managing Director, TGSPDCL.Under this system, after applying for a new HT service, the High Tension Consumer Service Connection (HTCSC) system collects GIS coordinates and sends the details directly to the Chief Engineer (Commercial) at the Company's Corporate office through the SASA app.Once the information reaches the corporate office, an estimate is generated directly through the SASA app. After the estimate is approved, a demand notice is automatically generated and sent to the consumer via SMS and email. The approval of the auto estimate is communicated to the relevant ADE, DE, and SE Operations staff via SMS. This single-window process ensures all approvals are issued in the shortest possible time.Speaking on the occasion, Musharraf Faruqui stated that under the leadership of Chief Minister Revanth Reddy and Deputy Chief Minister Bhatti Vikramarka, the state government's initiatives like Future City and industrial expansion are transforming the Telangana Core Urban Region into a hub for economic activities. To facilitate new industries and software company managements, the company has introduced the Auto Estimate Software System for easier access to HT connections. This process ensures complete transparency and quick completion, providing significant convenience to aspiring industrialists, Musharraf Faruqui revealed.

Cyber crime police nab youth in movie piracy racket

Hyderabad, July 3 : The Cyber Crime Police of Hyderabad have apprehended one Jana Kiran Kumar working as AC Technician and residing at NGOs Colony, Vanasthalipuram, Ranga Reddy District. Originally hailing from East Godavari, the accused was found to be actively involved in a high-profile movie piracy racket.

On June 5, 2025 a complaint was filed by Yarra Manindra Babu, representing the Anti-Video Piracy Cell of the Telugu Film Chamber of Commerce (TFCC), Hyderabad. He reported that Telugu film, "#Single" (released on May 9, 2025), was illegally pirated and circulated online on the very day of the movie release. Pirated HD versions were traced to popular piracy platforms like 1TamilBlasters, 5MoviezRulz and 1TamilMV. Preliminary forensic watermarking pointed towards leakage from a theatre. The TFCC estimated a staggering ?3,700 crore loss to the Telugu film industry in 2024 due to piracy, urging swift investigation and action against broader piracy networks.

The accused found a meme mentioning piracy group 1TamilMV and contacted their recruitment email (Proton mail). He sent a proposal via email offering to source pirated Telugu content. He has taken all precautions from being traced by the investigating agency by shifting to Telegram after sharing his Telegram ID.Assignment & Payment Agreement was assigned to record newly released movies, with agreed payments of USD 300–400 (in cryptocurrency) per movie. Some of the movies filmed are: Pellikani Prasad, 14 days Love, Thandel, Game On, Kismat, Rajadhani Files and so on. Booked tickets online and used his mobile phone, concealed in his shirt pocket, to record the movies in theatres and shared the pirated movie files links to handlers on Telegram. He received payments in

Tummala urges Centre to increase import duty on crude palm oil upto 44 percent

Hyderabad, July 3 : Minister for Agriculture Tummala Nageswara Rao has addressed a letter to Union Finance Minister Nirmala Sitharaman, urging her to raise the import duty on crude palm oil back to 44 percent, as it was previously. In a statement released on Thursday, the Minister emphasised his request to Union Minister Nirmala Sitharaman to reevaluate the decision to lower the import duty on crude palm oil and to reinstate it to the previous rate of 44 percent.

He also mentioned that Telangana State aims to cultivate 1,25,000 hectares, having so far initiated cultivation on 78,870 hectares involving 56,231 farmers, which places the state at the top of the national rankings. "The goal for this financial year is to cultivate 50,000 hectares. So far, 18,185 farmers have signed up to grow oil palm on 26,597 hectares. However, the recent cut in import duty on crude palm oil from 27.5 percent to 16.5 percent by the Central Government on May 31 could deter farmers from pursuing palm oil farming, putting the objectives of the National Mission on Edible Oils - Oil Palm (NEMOOP) at risk, as this is a central government initiative aimed at promoting oil palm cultivation," he stated.

The Minister remarked that the Centre's decision to lower import duties on crude palm oil is regrettable, as it will decrease the price received by oil palm farmers and negatively impact domestic oil palm farming in the long run. Tummala indicated that this decision could undermine farmers' confidence.

Many small-time local leaders have encroached on both sides of the canal, causing blockages in water flow. Beyond Khanapuram, the sewage water flow increases. Near the lower part of the bypass road, construction of square-shaped buildings has been undertaken by combining the road with adjacent empty land. By bribing gram panchayat officials and abusing their



power, they obtained permissions. This is clearly evident when looking at the old maps.""Now, in areas prone to flooding, the canal's width is being reduced from 15 meters to 12 meters, and the work has been deliberately delayed for over a year. A hostel has even been set up on the top floor of a four-story building. DK Aruna condemns Congress' propaganda on urea shortage

Hyderabad, July 3: BJP National Vice President and Mahbubnagar MP DK Aruna today said her party strongly condemned the false propaganda being spread by the Congress government and BRS party leaders targeting the Centre to create misconceptions among farmers on the shortage of urea in Telangana. She said the shortage of urea in Telangana had arisen due to the negligence and incompetent governance of the Congress government.

In a statement, she said it was unfortunate that such a situation exists only in Telangana. "The farmers are facing difficulties due to the failure of the Congress government in its supply and storage planning. Telangana farmers should not be under any illusion regarding fertilisers. The Central Government has already supplied more urea than the State needs for this Rabi season. While the State needs 9.5 lakh metric tons, the Centre has sent 12.02 lakh metric tons of urea. Apart from this, all fertilizers like DAP and NPKS have been sent in excess of the State's requirement. An example of this is that while 1.47 lakh tonnes are required for DAP, 1.72 lakh tonnes have been sent," she said.

She also said the Centre had been assessing the State's requirements from time to time and supplying more, but the State government had completely failed to properly manage the distribution system. "This situation is evidenced by the allegations that Markfed has gone bankrupt and is imposing transport charges on farmers and that fertilizers are being stored in some cooperative societies and diverted to the black market. The real problem is the failure of the State government. It is unethical to make false allegations against the Centre to cover it up," she said. Aruna said the Central government was giving a subsidy of Rs. 2,236 for a single urea bag and Rs. 2,422 for a DAP bag to the farmers. She noted that a farmer of one acre was getting a fertilizer subsidy worth Rs. 9,316 for one crop. "If two crops are grown in a year, it is Rs. 18,632. In addition to this, the Centre is providing a total of Rs 24,632 in support through PM Kisan," she said. She alleged that the Congress government was looting the farmers by selling urea, which should be provided at Rs 268, at a higher price and the DAP, which should be provided at Rs 1311, at an additional price. She said that the State Government, which has lost funds from the Finance Commission due to the inability to hold local body elections, was also putting the farmers in trouble by not being able to distribute the fertilizers provided by the Centre effectively.

"The Central Government has spent Rs 12.5 lakh crore in fertilizer subsidy in the last 10 years to support farmers across the country. In particular, the Ramagundam Fertilizer Plant, which was closed in Telangana, was renovated and reopened with a cost of Rs 6,338 crore. All this is evidence of the Modi government's commitment to farmers," she said. (

Youth suicide by hanging



– Was he targeted for questioning on social media?"– Suicide driven by fear of criminal charges"– Tragedy in Chalvai, Govindaraopet Mandal, Mulugu District"– Relatives stage protest""Mulugu Correspondent, Mahipal, Indian Chronicle:"A wave of sorrow swept across Chalvai village in Govindaraopet Mandal, Mulugu district, after a young man, Chukka Ramesh (24), allegedly died by suicide due to police harassment. His relatives claim that Ramesh was targeted for raising his voice against irregularities in the selection of beneficiaries under the Indiramma Housing Scheme. According to family members, Ramesh was orphaned at a young age and was raised by his grandmother. For the past two months, he had been posting messages in a local WhatsApp group criticizing the authorities for delaying allocation of houses to the poor under the scheme. Fol-

lowing this, complaints were lodged against him with the police. On Wednesday, the police allegedly confiscated Ramesh's phone and asked him to report to the police station the next day. Fearing false criminal charges and harassment, Ramesh reportedly died by suicide by hanging himself on Thursday morning when no one was home. The incident triggered tension in the village. Locals and the deceased's family members staged a protest on National Highway 163, demanding justice. They alleged that Ramesh was threatened and driven to suicide simply because he questioned injustice. They demanded strict action against those responsible and a comprehensive investigation into the matter. BRS district in-charge and former ZP Chairperson Bade Nagajyothi demanded that the government immediately respond and initiate a thorough probe. As she attempted to visit the protest site in support of the family, she was stopped by the police at Eturunagaram. She strongly criticized the government, stating that "suppressing voices that question injustice is undemocratic, and calling such governance a people's government is illogical." Nagajyothi demanded legal action against those who mentally harassed Ramesh and drove him to suicide. She also urged the youth not to resort to suicide, but to "live and fight to resolve issues." Once, my father had my horoscope read. The astrologer said I'd stop studying after 10th grade and die at 17. But my father told me. 'Forget all this nonsense. Focus on vourself Improve your abilities. Only by strengthening yourself can you help society discard such blind beliefs'. Those words deeply impacted me. However, after finishing intermediate studies, Pattabhiram suffered a major leg injury in an accident. A surgery left one leg longer than the other, making him extremely self conscious. His father's words during that time were transformative You're sad that a thorn pricked your foot. Be thankful it didn't hit your eye. That thought alone should give you the strength to face the world. Stop worrying about what others think. You can only grow by ignoring their judgments. I believe in your capabilities. Pattabhiram often expressed immense pride in his father's guidance.""He Proved That Horoscopes Don't Define Life.""Despite a horoscope predicting he wouldn't study, Pattabhiram earned two PhDs and completed four post graduate degrees. Due to his accident, he missed opportunities for premier courses, so he joined a BA in Psychology at PR College in Kakinada. Fascinated with personality development from a young age, Pattabhiram was also interested in magic. After earning his degree and MA in Psychology, he began practicing, but people weren't seeking counseling at the time. That's when he turned to his hidden talent magic. His father, however, wasn't pleased with his choice to pursue magic professionally. To fulfill his father's wish, he took a job at the Food Corporation of India, though it didn't last long. Driven by passion, he resigned and committed fully to personality development and magic. He never looked back. One step at a time, his journey grew. CIA says intelligence indicates Iran's nuclear program severely damaged

Central Intelligence Agency Director John Ratcliffe on Wednesday (June 25, 2025) said a body of credible intelligence indicated that Iran's nuclear program was severely damaged by recent U.S. strikes, and that it would take years to be rebuilt. "This includes new intelligence from a historically reliable and accurate source/method that several key Iranian nuclear facilities were destroyed and would have to be rebuilt over the course of years," Mr. Ratcliffe said in a statement. This comes in the wake of President Donald Trump's administration hiting back on Wednesday at accounts Iran may have moved enriched uranium before U.S. bombing, as a row grew on how much the strikes set back Tehran's nuclear program.Mr. Trump, seeking credit for ordering military action and then quickly announcing a ceasefire between Israel and Iran, has lashed out angrily at media accounts of a classified report that doubted the extent of damage to Iranian nuclear sites. Another key question raised by experts is whether Iran, preparing for the strike, moved out some 400 kilogram (880 pounds) of enriched uranium— which could now be hidden elsewhere in the vast country.

"I can tell you, the United States had no indication that that enriched uranium was moved prior to the strikes, as I also saw falsely reported," White House Press Secretary Karoline Leavitt told Fox News."As for what's on the ground right now, it's buried under miles and miles of rubble because of the success of these strikes on Saturday (June 21, 2025) evening," she said.Vice President J.D. Vance, asked about the uranium on Sunday (June 22, 2025), had sounded less definitive and said the United States would discuss the issue with Iran."We're going to work in the coming weeks to ensure that we do something with that fuel," Mr. Vance told ABC News program "This Week."The quantity of uranium had been reported by the UN nuclear watchdog, the International Atomic Energy Agency, with which Iran is considering severing cooperation after the Israeli and U.S. strikes on its nuclear program."The IAEA lost visibility on this material the moment hostilities began," the Agency's Chief, Rafael Grossi, told France 2 television.But he added: "I don't want to give the impression that it's been lost or hidden."Israel is widely known to have nuclear weapons but does not publicly confirm or deny its program. The United States is the only nation to have used nuclear weapons in

'No objection from finance department': As Opposition calls for rethink, Devendra Fadnavis says Shaktipeeth Expressway still on

A day after The Indian Express reported how the Maharashtra finance department had flagged the financial burden on the state over the Rs 20,787 crore loan guarantee given for the land acquisition for the Nagpur-Goa Shaktipeeth Expressway, the Opposition called for a rethink. Chief Minister Devendra Fadnavis, however, maintained that the project will move forward as the finance department has not raised any objections. "There is no objection from the finance department. It has merely done its work of pointing out data and nothing else. Infrastructure across the world is built by availing loans," Fadnavis said, speaking to reporters at the legislative building in Mumbai.

Saying that the construction of highways strengthens and expands the economy, Fadnavis said, "There was opposition to the Samruddhi Expressway as well, but it has changed the face of many districts. The Shaktipeeth Expressway will change the face of Marathwada and the drought-affected region of the state."The Nagpur-Goa Shaktipeeth Expressway is one of the largest road infrastructure projects in the country. The proposed 802kilometre high-speed corridor, officially known as the Maharashtra Shaktipeeth Mahamarg, will connect Pavnar in Wardha district to Patradevi in Sindhudurg, near the Maharashtra-Goa border. The project had been halted due to farmers' protests in 2024.

In a note, the finance department on Tuesday raised questions over borrowing at a higher rate for the project, pointed to the financial status of the state and advised the government to rethink its Build Operate and Transfer policy for mega projects and prioritise projects by the appropriate use of available financial resources. "Maharashtra's finance department has raised several critical points on loan guarantee extended to the Shaktipeeth Expressway. The state is staring at the potential financial mismanagement due to



this project. At a time when farmers are protesting against the land acquisition for the project, such financial burden will damage the financial health of the country. It is time for the state government to rethink the project," Supriya Sule, MP and NCP-SP working president, said. Sule said that the Maharashtra government is facing a financial crunch to provide facilities of education, health and water, but wants to move ahead with a project which would be a financial burden on the state exchequer. "We do not want Maharashtra to get caught in financial bankruptcy. The issue needs to be raised at the national level as well," she said.

Congress MLC Satej Patil, who hails from Kolhapur and is leading the anti-Shaktipeeth expressway agitation, said that the finance department has raised questions on the financial structure of the Maharashtra State Road Development Corporation—it will implement the Shaktipeeth Expressway project—as well. "It clearly shows that all is not well within the state government. There is disagreement within the state government itself over this project," said Patil. He maintained that farmers across the state are opposing the project, and will continue to oppose it.

Bike taxi ban: Denying permit to new entrants fuels monopoly, owners argue before Karnataka High Court

The counsel representing two bike owners in a case challenging the Karnataka High Court order to suspend bike taxi operations argued Wednesday that refusing to register vehicles as transport vehicles or issue contract carriage permits for motorcycles fuels a monopoly for existing operators. "By refusing to register vehicles as transport vehicles or issue contract carriage permits for motorcycles, the state is effectively denying citizens their right to carry on a lawful business. This creates a monopoly for existing operators and stifles competition, contrary to the Motor Vehicles (MV) Act's liberal objectives. The market should determine viability through demand and supply, not state intervention," argued senior advocate Dhyan Chinnappa before the division bench of Justices Kameswar Rao and C M Joshi.

In April, the Karnataka High Court ruled that bike taxis cannot be permitted to operate without proper notification of guidelines under Section 93 of the MV Act. With the order coming into effect on June 16, aggregators Rapido,Uber and Ola have stopped bike taxi operations in the state.The counsel for bike taxi owners also stated that the core issue is whether the state can impose restrictions on the operation of transport vehicles, such as motorcycle taxis, through executive policies or decisions that contradict the statutory framework of the MV Act and violate the fundamental right to trade under Article 19(1)(g) of the Indian Constitution. Article 19(1)(g) guarantees every citizen the right to practice any profession or carry on any trade or business, in-

cluding operating transport vehicles on public roads.

The petitioners also pointed out that the state argues it can restrict the operation of motorcycle taxis based on an unwritten or executive policy, citing reasons such as traffic congestion or protection of existing operators such as autorickshaws. "The state's policy is not formalised through government orders or rules under the Business Transactions Rules. It appears to be based on ad-hoc objections, which cannot override statutory rights," Chinnappa argued. The counsel added that if the state argues that excessive vehicles necessitate restrictions, such measures must be enacted through legislation, not executive fiat. "For example, Singapore's vehicle quota system is legislated, not imposed by policy," he noted.

During Wednesday's proceedings, advocate Shashank Garg, representing the Bike Taxi Welfare Association, argued that bike taxis serve a vital function in alleviating traffic congestion and providing last-mile connectivity. "They are a necessity, not a luxury," he stated.Garg highlighted the Karnataka government's 2021 E-Bike Taxi Policy, which had initially formalised and supported bike taxi operations, as evidence of the state's prior recognition of their utility. He contended that the state's abrupt reversal of this policy in 2024, banning bike taxis, appeared driven by political motives rather than public interest. "The 2021 policy laid a clear framework for bike taxis, acknowledging their role in urban mobility," Garg stated. "The sudden withdrawal smells of political expediency."He further challenged the state's reliance on a 2019 expert committee report that recommended against allowing bike taxis in Bengaluru, arguing that the report was rendered obsolete by the subsequent E-Bike Taxi Rules, which permitted such services until their unexpected revocation. "The state cannot cherrypick outdated recommendations to justify its actions when its own rules have embraced bike taxis," Garg asserted.Addressing the bench's queries on regulation, Garg clarified that the state holds the authority to regulate fares, noting that the current rate for bike taxis is approximately Rs 8 per kilometre. He emphasised their affordability and utility, stating, "In congested areas or remote locations, bike taxis are often the only viable transport option, even for critical services like ambulances.

PMC to enhance sewage treatment capacity to ensure clean water discharge into Mula-Mutha river

The Pune Municipal Corporation (PMC), which is struggling to treat the sewage generated within its jurisdiction and ensure clean water is released into the Mula-Mutha River, is set to enhance the sewage treatment facilities. The initiative that is aimed at meeting the projected demand of 1,092 million litres per day (MLD) for sewage treatment by 2027 will be developed through a Rs 842 crore fund, including Rs 506 crore approved by the Centre under the AMRUT 2.0 scheme.

Currently, around 92 per cent of Pune city is covered through a sewerage network that spans 2,200 kilometres, which includes six intermediate pumping stations and 10 Sewage Treatment Plants (STPs). The cumulative treatment capacity of these plants is 567 MLD. However, the old STP at Naidu Hospital with a capacity of 90 MLD is demolished for the reconstruction of a 127 MLD plant. Hence, the effective treatment capacity is 477 MLD. This capacity will be increased by 396 MLD after the ongoing new STP projects funded by the Japan International Cooperation Agency (JICA) are completed by 2027.

"The PMC plans to increase the capacity further with 10 MLD in the old city area, 12 MLD in the newly merged 11 villages, and 82 MLD in 23 merged villages. This will increase the sewage treatment capacity to 977 MLD by 2027 as against the estimated generation of 1,092 MLD to meet the requirement of the 70 lakh population of the city," said Manisha Shekatkar, Chief Engineer of the PMC. Under the AMRUT scheme, the State and Central Governments are to bear 50 per cent of the expenses. With the

As part of the plans under AMRUT 2.0, he said the existing STP of 130 MLD at Bhairoba, constructed in 2003, will be demolished to develop a new STP of 200 MLD capacity. The STP at Tanajiwadi will be demolished to make way for a new 26 MLD STP and enhancement of 18 MLD STP to 28 MLD STP at Bopodi. Upgrades will also be carried out at 115 MLD STP at New Naidu, 50 MLD STP at Erandwane, and 32 MLD STP at Vithalwadi."The objective is to ensure that the treated wastewater is able to meet the discharge parameters, extend the life of existing STPs, and improves the quality of treated wastewater for reuse and implement green initiatives by developing a compressed biogas system for large capacity STPs," she said. Civic activist Vivek Velankar said there are new standards set for treated sewage water, which has to be maintained by the civic body. He expressed concern over the lack of capacity to treat the entire sewage generated, as the untreated water goes into the river."The city consumes around 1,800 MLD of water. So sewage generated will be at least 1,500 MLD, but the PMC estimate is well below the actual consumption of domestic water in the city. Moreover, the PMC is somehow approaching its estimated wastewater generation in 2027, which means some amount of untreated water will continue to be released into the river and pollute the water body. In reality, water consumption is going to increase with the rise in population. Hence, the PMC should plan for the next 20 years from now rather than for just two years," he said.

A day after the Punjab Vigilance Bureau arrested Shiromani Akali Dal (SAD) leader Bikram Singh Majithia in a disproportionate assets case allegedly involving the laundering of more than Rs 540 crore of drug money, Punjab Chief Minister Bhagwant Mann said on Thursday that more big fish will fall into the police net soon. "All these days, they were saying we are not catching the big fish. Now, they are crying political vendetta. It is sad that those who are opposing our action are also involved. Those who are supporting them are guilty enough. They will be brought to the book. No matter if they are the president of any political party," Mann said, addressing the media in Chandigarh on Thursday.

Mann, who did not name Majithia during the entire press conference, also expressed fear that there could be a threat to his life. "Action will be taken against those guilty. No matter who he is. Chahe who mera bhi koi nuksaan karna chahte ho (No matter if they want to harm me). Even if they see me as a thorn in their flesh, as they are now feeling that our action has broken the cartels and affected their business, I will still come down heavily on them. I will not be scared. I will hold public meetings and go to the public. In the coming days, you will get such news that more big fish have been caught, mansions made from drugs have been bulldozed," he added. Reiterating that he may be harmed, Mann said, "If they want to harm me, I do not care. I have already lived twice as long as Bhagat Singh. If we succeed, it will be good. At least, we will be able to clean the mess.

Mann said that action was taken with "strong evidence in hand". "We are in the process of collecting more evidence, and many big fish will also be caught. Local drug lords have already been brought to book. Almost 90 per cent of those arrested could not even get bail as we have made out strong cases against them. Hawala transactions worth crores have been made. All these skeletons will come out of the closet gradually," he added. "These are the drug lords who are running the business. We have tried to break the mafia and succeeded, but smuggling is still on. I will not be soft on anyone. I owe it to Punjabis because they have elected me to this chair with huge trust and faith. That is why we have taken action with strong evidence," he said. Mann said that he received calls from Punjabis and NRIs abroad, asking him if he had taken action with evidence. "I told them that we have everything. There is every evidence. I want to convey this here that I will not listen to anyone. The police and vigilance will take action, and then the narcotics bureau will also come. Those involved in drugs will not be spared. Our hearts beat for Punjab. This action is a part of our drive to make it 'Rangla Punjab'. Whosoever is responsible for ruining the youth of Punjab will not be spared."Mann said that the anti-drugs campaign, 'Yudh Nasheyan Virudh', had taken the form of a people's movement. "Panchayats are passing resolutions that they are against drugs, saying they will not support anyone involved in the business. Drug smugglers' houses have been bulldozed. We took action legally," he pointed out.

'The 3-4 storey houses constructed on the bodies of drug addicts cannot be allowed to stand erect. We will break the supply line. We have updated the rehab centres. We learnt that some police personnel are having a quid pro quo with drug dealers. We learnt that when our raids failed. Then we transferred several policemen. Now, we get calls from people saying that the cartel has been broken," Mann said."We kept saying that we would not spare anyone. Whosoever it may be, a politician, an officer or anyone having their patronage. We said we will stand by the people. The people had to send their children abroad by selling their properties because they did not want them to fall for drugs. We will reverse this trend," Mann added. Replying to a question on whether the actual war against drugs had started on Wednesday, Mann said, "The war started earlier. Earlier, there were lower rung cops. Now the generals have been caught. Now investigation will be carried out."He said that the basis of the investigation against Majithia was a Narcotic Drugs and Psychotropic Substances Act case, and recently, hawala transfers of crores were detected. "We were getting several complaints, but were waiting for incriminating evidence," he added. Asked if the action against Majithia was vendetta, Mann said, "What is political vendetta in this? SAD got only 8,000 votes in the Ludhiana West bye-election. It is AAP vs all. Had there been a proper investigation, they would have all been in jail...but they were watching each other's backs. That is why no action was taking place...they were taking turns to come to power."

Can India push Pakistan into FATF's 'Grey list'?

Story so far: In a rare show of condemnation, the Financial Action Task Force (FATF), on June 16, 2025, stated that the Pahalgam terror "could not occur without money and the means to move funds between terrorist supporters". FATF's has released such a statement only twice in this decade -- for the Paris terror attack (2015) and the Pulwama attack (2019). The terror watchdog's stern stance has given hope for India to push its case to bring Pakistan back into the 'grey list' for violating the FATF's policy on terror-funding.Apart from condemnation, FATF will release a report next month, which will include state-sponsorship as a separate source of funding for terror. The Hindu reported that the FATF has also developed a Terror Financing Risk & Context toolkit for assessors, so that countries cannot "fool them with lies" on terror financing risks from their jurisdictions. Pakistan has been placed 'thrice' in the 'grey' list of the FATF after it failed to take adequate measures to curb terror financing and money laundering.

FATF first placed Pakistan on the grey list in 2008 after it failed to fight terror financing and money laundering. After cooperating with FATF's mutual evaluations, Pakistan was given an action plan to stop criminalisation of money laundering, identify, freeze and confiscate terrorist assets. It was removed from the list in 2015 owing to its progress but was reinstated in 2018. Failing to fulfill the first FATF plan, Pakistan was prescribed another seven-point action plan. While it completed 32 of the total 34 action items in the two plans in 2021, Pakistan was retained in the grey list. In October 2022, the country was finally removed from the list after it fulfilled all 34 action items by passing laws tackling money laundering, terror-financing, maintaining a database of terrorists and terror groups, and convicting terrorists such as Hafiz Saeed, Zakiur Rehman Lakhvi, Sajid Mir, and Rauf Asghar. However, Islamabad claims it couldn't trace Jaishe-Mohammed chief Masood Azhar, a UN designated terrorist. and the mastermind of the 2019 Pulwama terror attack.

How will FATF's condemnation affect Pakistan?

"FATF has very rarely condemned terror killings. It is only when it is an attack of high intensity or highly political in nature that it has come out and condemned it. However, there are limitations to it. The funding trail has to be established, which is being done by the Government of India, via diplomacy and parliamentary delegations. Maybe the FATF's condemnation, though late, has come out after conversations with these delegations," says Dr. Manish Dabhade, Associate Professor at Jawaharlal Nehru University's Centre for International Politics, Organisation & Disarmament. Aishwaria Sonavane, Research Analyst for Pakistan Studies at The Takshashila Institution, says that FATF's statement strengthens India's case against Pakistan to the global community, but is unlikely to translate into any meaningful action. "While India may sort of leverage FATF condemnation, isolating Pakistan diplomatically is far-fetched," says Ms. Sonavane. Putting Pakistan in the 'Grey' list alone will not suffice, says Mr. Dabhade, stating that this will not put economic sanctions on Islamabad. "Only when they are in the black list will it negatively affect Pakistan. In the grey list the FATF only names and shames the country, so when investors i.e. FDIs flow into Pakistan, they will be acknowledging the risk involved. But when it is in the black list, it is about actually taking steps which will affect investments into Pakistan," suggests Dr. Dabhade

Can India 'push' Pakistan back into 'Grey' List?

In the wake of Operation Sindoor, Mr. Modi warned Pakistan, "Talks and terror cannot go together, terror and trade cannot go together, and water and blood (referring to the suspension of the Indus Waters Treaty) cannot go together. India will not tolerate any nuclear blackmail." The current political climate makes it highly unlikely for Pakistan to be pushed into the 'Grey' list. "The process is a political one. Depending on what sort of member states' support India can garner at the FATF plenary session which will be held in October, what sort of dossiers and financial trails India can establish, it will decide if it is a clear cut case for Pakistan to be put back in the 'Grey' list," says Mr. Dabhade. He adds that India would have to spend its political capital abroad with the 30-odd countries who will decide on the case. The seven all-party delegations sent by India after the Pahalgam terror attack and India's response, covered about half of the FATF member states. Explaining how stakeholders like China and the US are unlikely to support anv punitive action on Pakistan, Ms. Sonavane says, "Beijing has its stakes in Islamabad with its China-Pakistan Economic Corridor. They have time and again supported Pakistan on international platforms. The recent optics also suggest that Pakistan does retain strategic significance for Washington".

Can FATF's new 'toolkit' call Pakistan's bluff?

Both experts don't think the Terror Financing Risk & Context toolkit could deter Pakistan. "It feels like a cosmetic eyewash. Though India can definitely utilise these tools to advance its narrative, and present evidence before the international community as much as possible. Grey-listing will risk Pakistan's economy, which will have a destabilising effect in Afghanistan. This is something that the US cannot afford to do," they observe.

Who does the current political climate favour?

On June 19, US President Donald Trump hosted Pakistan's Chief of Army Staff Field Marshal Asim Munir for lunch at the White House and thanked him for 'not going to war with India'. The unprecedented hosting of an Army chief rather than the Head of the State by a US President has raised eyebrows in India."It is a big bump for India-US ties under Trump, seeing that it was Prime Minister Modi who met Trump earlier in his Presidency, which indicated that things would smoothen out and that they were clinching a trade deal. But in the long term, we (India) know that there are going to allies like US and Israel that are going to be there sometimes and not at other times. We have to make the best use of whatever military equipment we have bought and know that in this fight (with Pakistan) we are own," opines Mr. Dabhade. Drawing parallels to the post-26/11 period, he adds, "India was shouting from the rooftops about how we were being affected by cross-border terrorism. While everyone accepted our concerns, they (global powers) said 'talk about Kashmir' and that has what the case has been reverted to now - the hyphenation of India and Pakistan". However, Ms. Sonavane plays down the impact of the Trump-Munir lunch on India. "There are no surprises that the Pakistani military is strategically important to the US. The Trump-Munir lunch had less to do with India and more with regards to Iran and Afghanistan. Pakistan is seeking to appease the Trump administration in many ways. It is opening up to Bitcoin mining, which has ties to the Trump family," she says, adding that India-US ties will continue to grow in its own irrespective of the Pakistan fac-

AI anxiety rising among managers as frontline roles evolve

As artificial intelligence (AI) tools become more deeply embedded in the workplace, a surprising new pattern is emerging: leaders and managers are now more anxious about AI than their frontline teams. According to BCG global survey of over 10,000 employees across industries, 41% of respondents fear losing their jobs to AI. But contrary to past trends, it's not frontline workers leading that fear, but their bosses. Once seen as the decision-makers and overseers, many managers now find themselves questioning their own relevance. As frontline employees adopt AI tools that help them make faster, more informed decisions, traditional managerial roles are shifting.

"Frontline workers have become managers as a result of the AI tools they operate," said Vinciane Beauchene, BCG's partner who leads the consultancy's talent and skills practice. "Now managers are asking: what is their role as a manager?"The fear of obsolescence is particularly acute in regions with the highest GenAl usage, which includes India, Spain and Middle East. A call to rethink masculinity in India: destigmatising men's mental health

effectively

June, designated as Men's Mental Health Month, offers a vital opportunity to confront a silent epidemic. In India, where cultural norms often equate masculinity with stoicism, men's mental health remains shrouded in stigma, under-discussed and under-addressed. The statistics are sobering: according to the National Mental Health Survey (2015-16), nearly 15% of Indian adults face mental health challenges, with men disproportionately affected by issues like substance abuse and suicide. Globally, men are three times more likely to die by suicide than women, as per World Health Organization (WHO) data. Yet, societal expectations-rooted in phrases like "mard ko dard nahi hota" (men don't feel pain)-continue to stifle conversations about men's emotional struggles.

From boyhood, men are conditioned to embody strength, suppress vulnerability, and prioritise provision over self-care. In India, these expectations are amplified by a patriarchal framework that places men as breadwinners and protectors, often at the cost of their emotional well-being. Take Arjun*, a 32-year-old IT professional from Bengaluru, whose story mirrors countless others. After losing his job during a tech layoff in 2023, Arjun grappled with anxiety and sleeplessness. "I couldn't tell my family," he shared in a session. "They depended on me. Admitting I was struggling felt like failing as a man." Arjun's silence is emblematic of a broader issue: men are taught that emotional expression is weakness, leaving them to internalise pain.

Economic pressures exacerbate this. India's rapid urbanisation and competitive job markets pile stress on men, particularly in metro cities where financial stability is equated with self-worth. Social media posts by young men anonymously venting about burnout abound, with hashtags like #MenToo and #MentalHealthMatters.Yet, these digital cries often don't translate into real-world support. Cultural arratives—bolstered by Bollywood's hyper-masculine he roes-reinforce the idea that men must "tough it out," whether facing workplace stress, relationship breakdowns, or personal loss. Stigma is the biggest roadblock to men seeking mental health support. In rural areas, where mental health literacy is low, men are often dismissed as "weak" or labeled with derogatory terms if they express emotional distress. Urban India fares little better; therapy is still seen as a luxury or a sign of failure. The lack of accessible mental health infrastructure doesn't help. India has just 0.75 psychiatrists per 100,000 people, as per WHO, and mental health services are concentrated in urban centres. For men in tier-2 cities or rural areas, seeking help often means navigating long distances or unaffordable private care. Moreover, mental health campaigns in India rarely target men specifically, focusing instead on women or children. This gap leaves men's issues-like workplace stress, loneliness, or trauma from societal expectations—largely unaddressed. The most alarming consequence of this neglect is the rising male suicide rate. In 2022, the National Crime Records Bureau reported 1.7 lakh suicides in India, with men accounting for nearly 72%. Young men aged 18-30, grappling with unemployment, academic pressure, or relationship issues, are particularly vulnerable. Men's reluctance to seek help, compounds this crisis. Unlike women, who are more



likely to confide in friends or family, men often lack safe spaces for emotional expression. Traditional male friendships in India revolve around banter or shared activities, rarely delving into personal struggles. This isolation drives men toward maladaptive coping mechanisms-alcohol, substance abuse, or aggression. The WHO notes that men in India are twice as likely as women to develop alcohol dependence, often as a response to unaddressed stress.

Breaking this cycle demands a multi-pronged approach, starting with dismantling stereotypes. Media plays a crucial role here. Recent movies have normalised therapy, but we need more narratives showcasing men embracing vulnerability. Male voices on social media platforms are already challenging norms by sharing stories of therapy or burnout. Campaigns like 'Movember', which focus on men's health, could gain traction in India with localised efforts, encouraging men to share their vulnerabilities, and address mental health challenges. Education is another cornerstone. Schools must integrate emotional literacy into curricula, teaching boys that vulnerability is strength, not weakness. Community-level initiatives like men's support groups in

Just outside the walled city at the bustling Ajmeri Gate in Delhi, and across the narrow lanes of GB Road, the capital's red-light district, stands the longest running education institution in a quiet contradiction. The Anglo-Arabic Model School, North India's oldest surviving school, built in the late 1600s, rests here like a relic of forgotten grandeur.Founded by Mir Shihab-ud-Din Siddiqi, a leading military general known by his title Ghaziuddin Khan during the reign of Aurangzeb, this Mughal-era institution is not just a school. It is a symbol of Delhi's complex, layered history. Inside the gates, history breathes through every stone. Red sandstone walls, Persian arches, jharokhas, and intricately carved jalis frame courtyards where pine trees, rare in Old Delhi, sway gently, offering quiet pockets of green against the city's restless buzz. A small mosque stands at the centre, welcoming all who come to offer namaz. Beyond these walls, a different world waits, where women sit behind barred windows, and their children, some bearing names the world hesitates to acknowledge, slip quietly through the gates of the academic institution in the hope of a better future.

Principal Mohd Wasim Ahmed does not flinch about the school's location. "Some of our students come from GB Road. Their mothers are our parents first," he says. His words carry the weight of quiet defiance. The school has produced luminaries such as Sir Syed Ahmed Khan, Muslim educationist and reformist, hockey Olympian Mirza Masood, Congress politician Meem Afzal, and many others who shaped India's intellectual and political movements. The school, notably, remains grounded, not in nostalgia, but in service to whoever walks in through its centuries' old doors.Preservation is a matter of priority here. Although the school has adapted to modern needs, the management is committed to safeguarding its historic character. Over the decades, support from leaders including Atal Bihari Vajpayee and Sheila Dikshit helped maintain both infrastructure and the legacy."Whenever the school needed help, the government was ready to provide it," saysbiology teacher Maqsood Ahmad, teaching here since 1992. What started as a boy's school in 1696 was changed to a co-education school as recent as in 2012. However, out of 1,500 students, only 130 are girls. "It is not even 9%," says the principal. But he remains optimistic.

"With these tall ceilings and Mughal architecture, we don't even need air conditioners. This space is naturally balanced and so are our students," he says with pride.At this historic location, two worlds meet at the edges every day: the world inside, where history breathes with purpose, and the world outside, where women wait behind closed windows, trapped by society's silence. In between stands the school, not as a bystander, but as a quiet force, a place that does not judge, only teaches. In a city that so often



draws lines, this school chooses to hold contradictions together.

Microsoft plans 'substantial' layoffs at Xbox gaming division

Hvderabad: Microsoft is planning to lay off a 'substantial' number of employees from its Xbox division as part of a company-wide restructuring exercise. The company is likely to announce the layoffs early next week, just before the end of its fiscal year on June 30, according to reports.Although the exact number of job losses remains unclear, the layoffs will impact several teams and may also affect employees working in Microsoft's global sales operations, according to a Bloomberg report. The Xbox division oversees Microsoft's gaming consoles, game development studios, and digital services, including Game Pass. This could be the fourth major layoff at the company in the past 18 months. In May, the company announced a headcount reduction affecting 6,000 employees - roughly 3 per cent of its global workforce. The tech giant has reportedly been under severe pressure since it acquired Activision Blizzard in 2023 for USD 69 billion. In January 2024, Microsoft fired 1,900 employees at Activision Blizzard and Xbox, and again cut another 650 jobs in its Xbox gaming unit in September. As of June 2024, Microsoft had 2.28 lakh employees worldwide, with around 45,000 people working in sales and marketing roles. Microsoft CEO Satya Nadella had earlier said that the recent layoffs were not linked to employee performance but due to organisational restructuring. Addressing staff, Nadella said the layoffs were necessary to realign teams in accordance with Microsoft's evolving priorities, particularly its growing focus on artificial intelligence

villages or workplaces, can create safe spaces for dialogue.

This requires collective effort-from policymakers funding mental health services to individuals challenging stereotypes in daily conversations. Let us strive to create a world where that is true for every man. The path forward isn't easy, but it is urgent. Let us break the silence, one story at a time.

Gazans burn plastic waste to cook in makeshift shelters

United Nations: Civilians in Gaza face another deadly hazard, alongside hunger, gunfire, and bombardment burning plastic waste just for cooking, UN humanitarians said. The UN Office for the Coordination of Humanitarian Affairs (OCHA) in a report on Wednesday stated, "Shelling and bombing across the (Gaza) Strip continue to have a devastating impact on civilians, reportedly killing and injuring scores of people, many of whom were seeking aid." "Partners report that in the absence of fuel, cooking gas, and electricity, people are burning plastic waste."

OCHA said that when such fires occur in makeshift shelters or tents, poor ventilation poses tremendous safety and health risks to vulnerable family members, including children and older individuals. The Red Cross Field Hospital in Rafah received a mass casualty influx of 149 cases, as reported by the International Committee of the Red Cross (ICRC), on Tuesday."All responsive patients reported they were wounded while on their way to an aid distribution site," the ICRC said. "Sixteen people were declared dead on arrival, and three more died of their wounds shortly after. The vast majority of patients reportedly suffered gunshot injuries."The casualties among food-seeking Gazans usually occur at distribution centers of the non-UN. US-operated, and Israeli-approved militarised Gaza Humanitarian Foundation. The ICRC reported that it had to activate its

mass casualty procedures 20 times since May 27, adding, "The scale and frequency of these incidents is an alarming testament to the intolerable dangers civilians face as they attempt to access assistance."The UN Population Fund reported that 80 percent of critical care units, including those used for childbirth, are at a risk of shutting down, when there is a daily average of 130 births in Gaza. The humanitarian office said that community kitchens were able to prepare more than 200,000 meals every day this week. However, compared with the over 1 million meals distributed daily at the end of April, it represents a reduction of about 80 percent, a trickle offered to people on the brink of famine.

'To facilitate the orderly distribution of aid, supplies must be channeled daily through multiple crossings and land routes simultaneously, thereby ensuring people that the flow of essential support is steady, sufficient, and reliable," the Office said.OCHA also reported that the world body and its partners attempted to coordinate 15 humanitarian movements inside Gaza on Tuesday, but only four were fully facilitated by the Israeli authorities. Seven other attempts were denied outright, preventing teams from trucking water, retrieving broken trucks, or repairing roads.According to the Office, three other missions were initially approved, which later impeded on the ground, although one was ultimately accomplished on Wednesday.

Why Trump makes fast, furious statements?



Ormskirk: Donald Trump's latest forthright outburst was made as part of his attempts to create a peace deal with Iran and Israel. "I'm not happy with Israel," he told reporters on June 24. "We basically have two countries that have been fighting so long and so hard that they don't know what the fuck they're doing."This came a day after Trump had announced a ceasefire between Israel and Iran. By the next day, the ceasefire had been violated by both Iran and Israel. Trump was clearly furious, and his language showed it. This was not a verbal slip – there was no immediate correction, no apology, no nonverbal indication of embarrassment. He just stormed off, clearly angry.

This is not the kind of language that is normally associated with a president. Some have been reported to use the f-word before, but usually behind closed doors. We expect presidents to be calm, measured, thoughtful, considered. Trump's comment was none of these things. Theodore Roosevelt, the 26th US president, once recommended a foreign policy strategy that was based on speaking softly and carrying a big stick. He was suggesting quiet menace, but Trump showed frustration, barely contained. His furious, aggressive response was like something straight out of an old psychology textbook. In the 1930s, psychologists developed the frustration-aggression hypothesis to explain how aggressive behaviour can arise. The hypothesis suggested that when a person's goal is blocked in some way, it leads to frustration, which then results in aggression. Aggression was considered a "natural" way of releasing this unpleasant state of frustration. They were clearly different times. Over the next few decades, this hypothesis was thought by most psychologists to be a gross oversimplification of complex human behaviour. It assumed a direct causal relationship between frustration and aggression, ignoring all the other situational and cognitive factors that can intervene.

Human beings are more complex than that, psychologists argued — they find other ways of dealing with their frustrations. They use their rational system of thought to find solutions. They don't have to lash out when they're frustrated in this seemingly primitive way.Perhaps, that's why many people feel shocked when they watch this US president in certain situations. To many of us, it all seems so basic, so unsophisticated, so frightening.The Nobel laureate and psychologist Daniel Kahneman, in his book Thinking, Fast and Slow (2011), characterised the two systems that underpin everyday decision-making. His work may help with understanding of what's going on here.

He describes system one as the evolutionary, basic system. It operates unconsciously, automatically and very quickly, handling everyday tasks like reading other people's emotions, without any effort. It is an intuitive system designed to work in a world full of approach and avoidance, scary animals and friendly animals. It is heavily reliant on affect to guide decision-making. In contrast, system two is slower, more deliberative. It requires conscious effort and is used for complex thinking, solving difficult problems, or making careful decisions. The relationship between the two systems is critical, and that may get us thinking about Trump in more detail.Kahneman says that system one is a bit of a "workaholic", beavering away all the time, making "suggestions" for system two to endorse. Good decisions - depend upon system two checking the suggestions of system one. But system one often jumps quickly and unconsciously to certain conclusions. System two should check them, but often doesn't, even when it would be easy. Here is a wellknown example. Answer the following question: "A bat and ball cost one pound ten pence, the bat costs one pound more than the ball. How much does the ball cost?" One answer looks blatantly obvious - but it isn't correct. The correct answer (after a bit of thought) is five pence. About 80 per cent of university students give the very quick and incorrect answer of ten pence because it "looks" right. Their system two never checked. In many people, it seems system two is not used nearly enough. There are striking individual differences in the way that people rely on emotion and gut instinct versus the rational system in making decisions

It appears that Trump makes decisions very quickly (classic system one), often without extensive deliberation or consultation with advisers. Both in his presidency and in his business career, he seemed to prioritise immediate action over any sort of prolonged and thoughtful analysis. That's why he changes his mind so often. His decisions seem to be driven by strong emotions. His response to events, opponents and issues are often passionate and visceral. This could lead to to decisions being unduly influenced by personal feelings, first impressions based on arbitrary cues, and interpersonal perceptions, rather than anything more substantial. Trump's style of decision-making emphasises immediacy and emotional conviction, which can be effective in rallving supporters and creating a sense of decisiveness. However, it also can lead to unpredictable outcomes and, as has been seen again and again, somewhat controversial, impulsive actions. Many suggest that Trump's decision-making style reflects his background in the high-pressure and high-stakes world of business, where quick judgements and gut instinct can be advantageous in these sorts of competitive winner-takes-all environments.But the world at war is a more precarious place, where system one needs to be kept more firmly in check. Gut instincts may have a role to play, but that old lazy system two needs to be more vigilant. Especially, it would seem, in Trump's case

officer, "He's got nothing, but he's dead now. What should we do?" The family's search for accountability was met with intimidation.

The BYC reaffirmed its solidarity with the family and called on national and international human rights organisations, legal bodies, and independent observers to urgently take notice of the systemic violence and repression in Balochistan. The killing of Ehsan Shah comes amid a rising number of human rights violations in the province. According to a recent report by the Human Rights Council of Balochistan, the month of May 2025 alone saw 138 cases of enforced disappearances - 137 male and one female. Of these, 97 people remain missing, 29 were released, and 12 were extrajudicially killed by Pakistani forces. The province has long been the site of an armed independence struggle. Human rights groups have consistently highlighted a pattern of systemic repression, including violent raids on homes, unlawful detentions, enforced disappearances, the 'kill and dump' policy, arbitrary arrests under the Maintenance of Public Order Ordinance, and trumped-up charges against civilians and Baloch leaders. The BYC has repeatedly called upon the international community to urgently intervene and address what it calls "a humanitarian and political crisis" in Balochistan.

Turbulent skies, turbulent minds: the rising fear of flying and how to combat it



In recent months, a series of high-profile airplane incidents-from sudden turbulence to technical malfunctionshave left passengers worldwide feeling uneasy about air travel. While aviation remains one of the safest modes of transportation, the increased media coverage of these events has heightened fear and anxiety among frequent and occasional flyers alike. For passengers, aircrew, and even pilots, fear can be paralysing. However, mental resilience and proven psychological strategies can help individuals not only cope, but thrive in the face of aviation-related stress.Every day, nearly 8 million people take to the skies. Many more travel by road. Airports and stations buzz with announcements, farewells and noise. Somewhere amid the crowd is a familiar face you've seen. Maybe it's your colleague flying to yet another meeting, or a parent waving goodbye before heading off to check in on their ageing parents, a friend leaving on a honeymoon or an uncle for a conference. Maybe ... it's you. When we talk about frequent travellers, we often picture young business executives or carefree travellers. But in reality, a huge number of travellers, particularly air travellers, belong to the 45-54 age group—a stage of life known as middle adulthood. And they're not just travelling more often; they are also carrying a heavier emotional load.

Individuals in this age group are, as the psychologist Erickson put it, in the 'sandwich stage' because they are often caught between two powerful responsibilities: caring for their ageing parents on one side and raising their own children on the other. At the same time, they are trying to keep their careers thriving, marriages strong, friendships alive, and dreams afloat. If they are travelling great distances, then there is an additional dimension: boarding flights, with one eye on the clock, one hand on a phone, and a heart full of everything they are juggling -- pressure, hopes, guilt and deadlines.

What is the psychological toll of air travel anxiety? Emily Carter, an aviation psychologist, explains: "The brain's amygdala processes fear, and when triggered, it can override logic. This is why even seasoned travellers might feel sudden dread despite knowing the safety statistics."Mass cancellations of tours and flight bookings axed, underscore the deep empathy and impact of horrifying airplane accidents. Such mass deaths are deeply disturbing, even if we are not directly involved. This is the manifestation of 'Indirect trauma', and it is completely valid to feel fear, panic and a sense of helplessness. When one's nervous system reacts as if he/she is in danger just by witnessing a shocking event — one is said to be experiencing vicarious trauma. Repeated news about the occurrence and feeds on social media could aggravate the situation. It amplifies these fears, as viral videos of mid-air emergencies create a perception of greater risk than statistics suggest.Sarah Mitchell, a clinical psychologist specialising in anxiety disorders, explains, "Our brains are wired to pay attention to threats, and repeated exposure to alarming news can make flying seem more dangerous than it is. It is important to balance awareness with rational perspective."

Educate yourself on air safety - Understanding the rigorous safety protocols involved in aviation can provide reassurance. Statistically, flying is far safer than driving.Practice mindfulness & breathing techniques - Deep breathing and grounding exercises can reduce in-flight anxiety. Apps like Headspace or Calm offer guided sessions.Limit exposure to alarmist media - Constant news consumption about plane incidents can heighten fear. Stick to credible sources and avoid sensationalized reports. Focus on what you can control - Prepare for your flight by choosing reputable airlines, staying hydrated, and getting adequate rest before travel. Distraction & comfort tools - Audiobooks, calming music, or even stress balls can redirect focus away from anxiety.Seek professional help if needed - If fear of flying becomes debilitating, cognitive behavioral therapy (CBT) has proven effective in treating travel-related anxiety. Pilots rely on "sterile cockpit" rules (minimising nonessential talk during critical phases) and simulator training to prepare for rare scenarios. Flight attendants and crew are trained in "situation awareness"-assessing threats calmly and reassuring passengers through clear communication. A study published in the journal Behavioural Sciences investigated the impact of accidents and incidents on pilots' emotions and situation awareness. The study found that accidents and incidents induced different levels of emotional responses in pilots, with accidents causing more significant changes in happiness and sadness (emotional induction). It also found that the pilots' situation awareness was affected by their emotional state, with high-situation awareness pilots showing better emotional regulation. The pilots' emotional intelligence mediated the effects of accidents and incidents on their emotions and situation awareness, the study revealed. Raj Patel, a commercial pilot with 20 years of experience, shares: "We train for worst-case scenarios so that in real life, muscle memory and logic take over. Fear is natural, but discipline keeps us focused.'

Airlines are increasingly prioritizing mental health through various initiatives including crew support programmes that involve confidential counselling and peer support groups to help aircrew process stress as well as passenger initiatives, with some carriers now offering VRbased exposure therapy to help nervous flyers acclimate. While recent incidents are concerning, they remain rare. Airlines and regulatory bodies continuously improve safety measures to prevent accidents. The key is to stay informed without letting fear dictate decisions. Fear is a natural response, but it doesn't have to control us. Whether you're a passenger white-knuckling through take-off or a pilot navigating rough weather, mental resilience—built through education, preparation, and psychological tools can make the difference between panic and calm.

"Why was my son murdered? He had no charges against him. He was innocent and unarmed; his only crime was being Baloch. Why are state forces allowed to kill our youth with impunity?" she said, holding back tears.

According to her statement, Ehsan had been on his way to Quetta with a friend for Eid shopping when FC personnel stopped their vehicle. Without warning or provocation, Ehsan was shot in the shoulder while still inside the car.Eyewitnesses later told the family that an FC soldier picked up the wounded boy and said to his commanding

Axiom-4 mission: Dragon spacecraft carrying Shubhanshu Shukla and crew docks at International Space Station

Soft capture of the Dragon spacecraft took place when the Space Station was passing over north Atlantic Ocean at 4:01 p.m. IST. A live videolink from NASA showed the spacecraft approaching the space station and the docking sequence was completed at 4:15 p.m. IST.With the docking of the Dragon spacecraft, Indian astronaut Shubhanshu Shukla made history by becoming the first Indian to enter the International Space Station.

Vital chemotherapy drugs used around the world have failed quality tests, leaving cancer patients in more than 100 countries at risk of ineffective treatments and potentially fatal side effects, the Bureau of Investigative Journalism (TBIJ, www.tbij.com) can reveal.The drugs in question form the backbone of treatment plans for numerous common cancers - including breast, ovarian and leukaemia. Some drugs contained so little of their key ingredient that pharmacists said giving them to patients would be as good as doing nothing. Other drugs, containing too much active ingredient, put patients at risk of severe organ damage or even death. "Both scenarios are horrendous," said one pharmacist. "It's heartbreaking." Doctors from multiple countries told TBIJ of the drugs in question not working as expected, leaving patients suddenly unresponsive to treatment. Other patients suffered side effects so toxic that they could no longer tolerate the medicine

The variance found in the levels of active ingredient was alarming. In some cases, pills from the same blister pack contained different amounts. These findings expose huge holes in the global safety nets intended to prevent profitseeking manufacturers from cutting corners, and to protect patients from bad drugs. All the while, patients and governments with stretched resources are paying the price for drugs that don't work. Generic drugs are widely used in all countries but are most crucial in those with fewer resources, where costlier treatments might be beyond reach.

Cancer is one of the biggest killers worldwide, linked to around 10 million deaths every year – roughly one in six. The burden of cancer is growing, particularly in low- and middle-income regions. In sub-Saharan Africa, for example, instances of cancer have doubled in the last 30 years. Much of the global demand for treatment is met by so-called generic drugs. These are versions of a drug that can be made once the original maker's exclusivity rights have expired, and are typically made far more cheaply. The bad drugs described in this investigation were all generics.

Generics are widely used in all countries but are most crucial in those with fewer resources, where costlier treatments might be beyond reach. If generics were not available in sub-Saharan Africa, for instance, "any cancer treatment would be likely inaccessible to most of the population", said Claudia Martinez of the Access to Medicine Foundation*, an NGO.In chemotherapy drugs, the active ingredient – which fights cancer cells – is also highly toxic. Patients need to receive enough of it to treat the cancer but not so much that they overdose and suffer damaging side effects. As such, hospital pharmacists calculate doses carefully – and in doing so, rely on the amount of active ingredient being exactly what's stated on the label.Research from a landmark study published today examined the amount of

Dame, Indiana, analysed drug samples from the four countries. Of 189 samples that had not expired at the time of testing, about one fifth failed. This consisted of 20 different brands of generic drug made by 17 manufacturers. "We were all taken aback when we saw the results," said Marya Lieberman, the professor who led the research.

More than 30 manufacturers made products to a good standard. But for patients receiving the poor-quality drugs, the effects could be devastating. "Once a person has been diagnosed with cancer, there's a limited window of opportunity for treatment to work," said Lieberman. "And if someone is treated with an ineffective product, they can lose that precious window."The majority of failed drugs had too little active ingredient (for most this meant less than 88% of the amount stated on the label) while some contained too much (more than 112%). Both thresholds were decided by researchers based on international standards."Both scenarios are horrendous in my eyes," said Shereen Nabhani-Gebara, vice chair of the British Oncology Pharmacists Association. Over the past six years, these brands of drugs have been shipped to more than 100 countries in every populated continent on the planet. They range from low- and middle-income nations like Nepal, Ethiopia and North Korea, to wealthy countries such as the US, UK and Saudi Arabia. The worst-performing drug in the study is made by Indian manufacturer Venus Remedies. It is a drug called cyclophosphamide, which is often used to treat cancers including lymphoma and breast cancer.

All eight samples of this Venus Remedies drug failed, with six containing less than half the amount of active ingredient claimed by the manufacturer. One contained just over a quarter of the stated dose, which according to several cancer pharmacists would be as effective as no treatment at all. The drug has been shipped to six countries, with its largest importer being Ethiopia.

Wondemagegnhu Tigeneh, a clinical oncologist in the Ethiopian capital Addis Ababa, told TBIJ that he has treated patients with chemotherapy drugs he believes did not work." have a suspicion that the active ingredient was lower than expected," he said, remembering a drug he gave to a recent patient who had responded well to the first three rounds of treatment. But on the next round, their progress suddenly stopped.Because he has no means to test them, Tigeneh can never be sure of the quality of a given drug. But in his 20 years treating cancer, he has learned to notice tell-tale signs. Sometimes, for instance, there is a complete absence of side-effects such as nausea or hair loss. "That makes it difficult to trust that particular drug." he said.

Alienware's GM explains why the brand hasn't launched a handheld gaming PC yet



Dell's high-end gaming brand Alienware is closely looking at the handheld PC space, citing deficiencies in existing portable gaming PCs and the market's potential. "Many customers return these products because the battery life isn't great, or they felt it would be like a PC. The software isn't right—it's too kludgy, and they have to navigate through a very small Windows environment. Due to these elements, we believe the timing isn't right at the moment," explained Matt McGowan, General Manager of Alienware, during a pre-CES 2025 briefing in New York.McGowan added that doesn't mean it won't be right in the future. "I think this market will continue to exist. Whether it grows like the PC category or remains flat due to obvious constraints, such as screen size, remains to be seen. It's still a relatively new space, only a couple of years old, but it's a space we are looking at pretty heavily.""The handheld space is really interesting," accepts McGowan, remembering how Dell had worked on Project UFO as a concept. "Even though it looked very polished, it wasn't actually that mature internally. It was essentially a collection of pieces put together to create the concept. Other competitors have obviously taken that idea, run with it, and sold units."Nintendo's Switch has dominated the handheld gaming space for years, and McGowan acknowledged that existing gaming PCs don't match the elements the Switch has brought to the market. "If I compare the products out there to the Switch, they are very different. But the Switch also has a clear advantage—it's much more affordable. The device is significantly lighter, hyper-portable, and offers a seamless experience. Launching games and navigating the interface is effortless, and the performance meets expectations for the Nintendo ecosystem.'

"They [current portable gaming PCs] don't quite meet all those factors. They do an okay job, but I am not really satisfied with that," he continued. "Sure, there may be a market where people are willing to accept those deficiencies in the product, but it's just not a step we are willing to take yet. We don't want to offer a compromised experience and say, 'Hey, consumer, this is good enough, right?' We don't believe that approach is worthy of the Alienware branding."The success of Valve Corp's Steam Deck has expanded the reach and potential market for portable gaming handhelds, enabling users to play PC games on the go. However, many players have since entered the space, including old guardians in the PC industry. While these handhelds are not replacing traditional gaming PCs, they represent a growing demographic that many companies are keen to capitalise on.McGowan, however, doesn't see PC handhelds as a substitute for gaming PCs, which also explains why Dell hasn't launched a competitor to handhelds from Valve and Asus on the market. "We don't see it as a substitute: it's really an incremental product in the ecosystem, which is a good thing. Its latest lineup, showcased at this year's Consumer Electronics Show in Las Vegas, includes the new Area-51 desktop and Area-51 laptops, both featuring designs reminiscent of the iconic Area-51 debuted in 1998, representing Dell's attempt to appease pro-gamers and enthusiasts who have long been Alienware users, a segment of users that has driven the brand for years.McGowan acknowledged that not everyone can afford a device like the Area-51 desktop, which costs \$4,499 for the launch configuration. This way, all gaming products under Dell Technologies will be Alienware.McGowan said Alienware has also gone through a similar rebranding exercise as Dell, where the mainline series now fall under the Dell, Dell Pro, and Dell Pro Max branding. However, the rebranding within Alienware was more focused on the gaming side, while keeping the brand identity in mind."We did a similar exercise on the gaming side because we had a similar question: Do customers really understand the G, M, and X series? The pretty much unanimous feedback was, 'We really don't understand that. We don't really know what it means.' So, we asked, 'Okay, well, do you know what Area 51 means, even though we didn't have an Area 51 product at the time?' And the feedback was, 'Oh yeah, we know what Area 51 means. That means maximum performance."McGowan is of the view that the type of customers who entered gaming during the pandemic and postpandemic are different from traditional gamers. According to him, the concentration of gamers at more aggressive price points is huge. This is one of the reasons why the company decided to overhaul the lineup, keeping new-age consumers in mind."We thought, is it more valuable for us to service those customers with G Series products and then completely disassociate Dell G from Alienware? McGowan expects the entire transition to happen over the next 18 months, and the company will completely phase out the G, M, and X series, with everything eventually folding into the Alienware brand.



A vigorous debate in the recently concluded Winter session of Parliament has brought into the limelight one of the most important political issues of our times. What is the relationship between Babasaheb Ambedkar, the architect of India's Constitution, and Hindutva?Two contradictory impulses appeared in the debate. The BJP's principal claim was that it had done more than any other major party, targeting the Congress in particular, to restore the justly great status of Ambedkar in the national public realm. However, the speech of Home Minister Amit Shah seamlessly slipped into the claim that the iconisation of Ambedkar had become too much of a political fashion, and if only similar attention was paid to God, one would earn a place in heaven. The former was an attempt to embrace Ambedkar politically, the latter was barely concealed ridicule. Which of the two truly represents the core of Hindu nationalism?

Perhaps one could begin with how the original thinkers of Hindu nationalism saw the relationship, going all the way back to the 1920s and 1930s. For those early years, there is no better guide for us than V D Savarkar, the father of Hindutva.Luckily, a new book — Savarkar and the Making of Hindutva (Princeton University Press, 2024) by Janaki Bakhle, Professor of History, University of California, Berkeley — gives us novel insights into Savarkar's thinking. Ten years in the making, Bakhle's book comprehensively examines Savarkar's voluminous writings in Marathi, including his plays, poems and essays, which are well-known in Maharashtra but not having been translated in English, little known outside. Savarkar wrote copiously about caste, religion and nationhood, and also commented on Mahatma Gandhi and Ambedkar.

As Vikram Sampath's biography of Savarkar had also earlier noted, Bakhle emphasises that Savarkar was a persistent critic of caste. But Savarkar's position was different from both Gandhi and Ambedkar. Gandhi's unrelenting focus was on untouchability, a "sinful" denial of basic dignity to millions of Indians. As for the other castes, hierarchy was the problem, not caste per se. While untouchability required eradication, the four-varna-based caste system simply needed reform. Minus the hierarchy and untouchability, the caste system, according to Gandhi, could simply function as a division of labour, given the historical links of castes with occupations. Ambedkar disagreed. The entire caste system required annihilation, not just untouchability. The caste hierarchy and its horrors were anchored in religious texts, without which Hinduism was inconceivable. Brahminism was as big a problem as untouchability. Ambedkar was born a Hindu, but did not want to die as one. Before his death, he converted to Buddhism with his followers.Bakhle shows that Savarkar's views on caste were located somewhere between Gandhi and Ambedkar. He was constantly critical of Sanatana Dharma. To him, caste was "an enduring struc-

ture of stupidity, naivete and even innocence"; rituals were a mere idiotic superstition; and "the cow, Vedic chants and prayers were themselves not sacred". But Savarkar also believed that Brahmins deserved no special ire for their behaviour. Rather, prejudice and oppression ran through the entire system. Kshatriyas and Vaishyas oppressed evervone beneath them; upper Sudras lorded over the lower Sudras; the "untouchable Mahars", a caste to which Ambedkar was born, did not look kindly at those below them in the hierarchy. These "rules of bad behaviour" can be altered if we change our minds. The "untouchables", according to Savarkar, can and should be given access to Vedic rituals and embraced by all castes.But why should all of this be done? Though critical of caste, Savarkar never argued that the caste system was a centuries-long structure of dominance and oppression, and a birth-based, radically unequal, distribution of group dignity was built into it. Anti-Brahmin arguments, ruling many intellectual and political circles in Bombay and Madras Presidencies at the time, did not draw his sympathy. Indeed, he argued, the project of Hindu unity could be pursued under "enlightened Brahmin leadership". Thus Savarkar "attempted to have it both ways: To enact radical reform without completely alienating the privileged elite".

This equivocation allows Bakhle to make a key argument. Savarkar's criticism of caste was "instrumental". It was "primarily motivated by what he saw as an urgent and immediate need to unite Hindus against Muslims (in marked contrast with Gandhi whose critique of caste was primarily related to the need for a unified nationalist movement against British rule)". Over time, opposing British rule became less important to Savarkar than creating a united Hindu community against the Muslims, who might rise again and dominate the Hindus, but whose disloyalty to India was, to him, far too evident. If the "untouchables" and lower castes are not incorporated in the Hindu family, they "will join forces with the Muslims", whose demographic numbers needed contraction, not expansion by conversion. To put it in modern social science terms, Savarkar's project of Hindu unity meant merging all castes into a singular Hindu ethnicity. To Ambedkar, Hindu unity was exactly the opposite of what his own project sought. He wanted to "annihilate" caste and leave Hinduism altogether. Though Savarkar initially had some sympathy for Ambedkar, the fundamental clash between the two projects became all too obvious. Savarkar's final judgement was unambiguously clear. He called Ambedkar "a man... burning with hatred against Hinduism".

most readThe Home Minister's Ambedkar ridicule is arguably rooted in Savarkar's ultimate judgment of Ambedkar as a Hindu hater. But so is Hindutva's Hindu unity strain embedded in Savarkar. Batenge toh katenge (if divided, we will be decimated), the new political refrain of Hindutva, is a perfect contemporary illustration of Savarkar's Hindu unity project, to be pursued without an attack on caste hierarchy, but with Muslims as an enemy. The electoral significance of Dalits stems from their numbers. They are numerically larger than the estimated demographic size of Brahmins, if not all upper castes together. Ambedkar's status has become so great that large proportions of Dalits not only view him as an icon, but they also see the Constitution, made under his leadership, as an emblematic canon. A fuller incorporation of Dalits into the Hindu unity project is not possible if Ambedkar and "his" Constitution are threatened. However, since Ambedkar had no interest in Hindu unity, Hindutva's Ambedkar ambivalence continues, and is not easily resolvable.

Grave new world: humans are killing the elders species need to survive

So do animals. From elephant matriarchs to shark grandmothers, the elders of the animal kingdom carry a treasure trove of knowledge, having guided, and still guiding, their families through the uncertainties of life in the wild.The earth's life forms are very diverse and unsparingly complex. No two species age the same. Yet there is also a growing body of evidence that older, wiser individuals are crucial in similar ways to many species.

"Because of the diversity in animal social systems, the important position that older individuals often occupy can be a variety of reasons, but often involves them either being particularly dominant individuals who stabilise the social hierarchy in some way through their presence or by acting as repositories of information that they've acquired over their lifetime — which can be particularly important when times get tough," Josh Firth, an associate professor at the University of Leeds, said. "There are a range of potential benefits of older individuals across different types of animals. They are not the same for all species," Keller Kopf, a senior lecturer in ecology at Charles Darwin University, Australia, added. Without these elders, fish may never find their spawning grounds and birds would get waylaid as they flew across continents.

Ageing in the wildA review published in Science on November 21 suggested that the worldwide loss of old individuals due to shrinking habitats, hunting, climate change, and other human-caused disturbances can be particularly detrimental to long-lived species. According to the researchers, protecting a species' elders is important for all its members to be able to pass on their cultures and what they know about adapting to changing weather to their future generations, and to help buffer them against human disturbances.While this may go for both short- and longlived species - the mayfly lives for a day whereas the Antarctic glass sponge can live for millennia — the focus on long-lived species in particular is partly because of data."Evidence for the contributions of older individuals in short-lived species is limited," Kopf, the lead author of the study, said.Scientists have been studying ageing for decades but most of their research has focused on the negative effects of biological ageing on human health. Only recently have they been looking at the benefits of ageing and in wild populations.

"Research on the benefits of old individuals has been happening in different disciplines in silos," Kopf said.What old meansHe and his team analysed more than 9,800 peerreviewed studies from 1900 to 2023, investigating the roles of elderly individuals in several species. These roles included knowledge transmission, assisted parental care, nutrient cycling, and coping with extreme weather."Until now, no study has pulled together data across different taxonomic groups to highlight the range of potential benefits of growing old," according to Kopf.Before the team could analyse the data, it had to agree on what "old" meant. A three-year-old mouse could be considered old whereas a 30-year-old elephant could be considered young, Kopf said. But the lack of data on short-lived species limited the researchers' options to two groups: long-lived mammals and birds (which are often social species that invest significant time and efforts in parenting their offspring) and cold-blooded animals (like fish and reptiles, which continue to grow throughout their lifespan)."Traits such as social behaviour, migration. parental care, and increased reproductive output make older individuals in moderate to long-lived species essential for their ecology and therefore conservation," Kopf said."However, this importance exists on a continuum and is not a binary." Of elephants and orcasClimate extremes and human activities such as habitat destruction can hasten the loss of elders in a species and disrupt the stability of populations. Ecologists have documented a cascade of consequences moving through the population when the elders disappear, altering social structures and behaviour. For example, young elephants of both sexes depend on help from the matriarch, the oldest female and often the largest. One 2011 study of African elephants in the wild found that when they were played recordings of lions roaring, a herd's members would create a defensive formation. Groups led by matriarchs more than 60 years old gathered faster and confronted the threatening calls with more aggression.

"If older individuals are removed from the wild, by capture or unnatural death, younger ones struggle to survive without their knowledge," Anindya Sinha, a professor at the National Institute of Advanced Studies, Bengaluru, said. "Because they are directionless there might be an increased risk of negative interactions with humans.""Our work on Asian elephants in Bandipur and Nagarhole National Parks in Karnataka shows that females in herds [with calves] and fewer experienced individuals exhibited high levels of stress hormone," Sanjeeta Sharma Pokhreal, an assistant professor at Kyoto University in Japan, said. A 2018 study she co-authored suggested that the higher stress could be due to lack of help with parental care, the high energy demands of vigilance, and the responsibility of protecting calves from predators.Studies have also found that older female orcas (Orcinus orca) undergo menopause. According to experts, one compelling explanation for this phenomenon is called the grandmother hypothesis. Grandmother orcas stop being able to reproduce so they can help their daughters care for calves, protect them from predators, and guide them to the best feeding groundsA new conservation paradigmBecause of the great benefits of protecting the older members of a species, the researchers have advanced a new paradigm called longevity conservation."Biodiversity conservation and threatened species policies should protect age structure," Kopf wrote in The Conversation.

is glaring and widely discussed, almost always revolves around entry-level measures that are aimed at ensuring that more women enter the profession as lawyers/judges. While such entry-level measures are necessary, it is crucial to recognise that this is insufficient to ensure the continued support and encouragement and retention of women in the judiciary. The Supreme Court of India's "State of the Judiciary" report (2023) showed 36.3% of women in the district judiciary, which is heartening. In 14 States, more than 50% of candidates successfully recruited into the civil judge (junior) division were women. However, at the higher levels, the representation of women in the judiciary falls short. As of January 2024, only 13.4% of judges in the High Court and 9.3% judges in the Supreme Court are women. Further, the representation of women is uneven across High Courts, with States which include Bihar, Chhattisgarh, Jharkhand, Manipur, Meghalaya, Odisha, Tripura and Uttarakhand having either no women judges or just one woman judge. The situation in the Bar is also bleak. Data published by the Department of Legal Affairs in 2022 show that approximately 15.31% of all enrolled advocates are women. Although comprehensive data in this regard has not been made public by all State Bar Councils, women are drastically under-represented as senior advocates, advocates-on-record, and Bar Council representatives. This results in a funnel effect, creating a smaller pool of candidates who may be able to establish themselves in the system and be considered for elevation.

The under-representation of women in the judiciary is part of a vicious cycle. Women are excluded while even those women who have been included are unable to rise to positions of power to address these concerns. Access for women in the judiciary, therefore, is hindered at two levels: entry and retention. While several States have taken commendable steps in ensuring that women enter the lower levels of the judiciary, direct recruitment continues to be a challenge for female aspirants. The Judicial Service Rules of many States stipulate that advocates must have a minimum period of 'continuous' practice for elevation to the Bench. For women advocates who are required to juggle family responsibilities in the absence of maternity benefits and minimum stipends, meeting this threshold is difficult. However, even when women have managed to enter the system, continued career growth becomes difficult in the face of a discouraging and unsupportive environment which fails to take into account their specific needs. There is a continuously diminishing pool of women judges eligible for elevation to the High Court, and eventually the Supreme Court. This reverse funnel effect is caused by transfer policies which are often harsh and demanding, leaving little room for negotiation or sensitivity towards women's continued responsibilities as primary caretakers in the household. Every day interactions within courts also cause difficulties for women lawyers, judges and staff working in the judiciary, due to the absence of basic infrastructural requirements. A survey in 2019, by the Vidhi Centre for Legal Policy highlighted that nearly 100 district courts have no dedicated washrooms for women. Multiple courts, including prominent High Courts, lack adequate washrooms even for women judges, let alone for female staff, lawyers, or litigants. There are only limited sanitary facilities and hygienic waste disposal systems. The burden of familial responsibilities continues to be the social reality of women in India. With women expected to be primary caretakers, courts must provide family-friendly amenities including feeding rooms and crèches. However, although some courts have taken steps in this regard, the limited availability of resources results in restrictions which render them ineffective. For example, the Delhi High Court's crèche only caters to children younger than six years.for course correctionIt is quite intuitive from the issues above that the twin threshold of entry and retention of women in judiciary as equal stakeholders to access is important, but the solutions have been instituted in silos. The main consequence is that the problem persists as there are fewer women represented in the higher echelons of the judiciary, and far fewer amenities that enable their access to court complexes for their continued retention in the justice delivery system. This is a classic problem of the ever-widening public-private divide espoused by Carole Pateman in her theory wherein she points out that as women increasingly entered the public sphere traditionally occupied by men, there was a lag in the laws as well. She further elaborates that this public-private divide is the main reason why the public sphere does not cater to the specific needs of women upon their transition from the private sphere to the public. This theory can be extended to the design and regulation of the public sphere as well, which is usually not a conducive environment for women to thrive and feel safe.Similarly, it is important to acknowledge that as more women enter courts which have been male-dominant institutions for a long time now, it is all the more necessary to employ a female gaze to implement inclusive policies to enable their entry and retention. Simply put, the female gaze in implementation means the employment of a feminist lens to recognise the differential needs of women and course-correct to diminish the unintended impacts of neutral-yet indirectly discriminatory policies and infrastructural mandates. The employment of a female gaze breaks the male standard view employed by an all-male administrative committee of judges or all-male Bar Councils, particularly in cases where there is no women representation. This helps further in an inclusive visualisation of how 'public spaces' - in this case, courts and their access - are constructed, aiding in the construction of a lens through which gendered impact of policies and mandates can be filtered to enable the entry and retention of women in courts. Prioritising women's needsGreater participation of women in the judiciary must be driven by women-centric perspectives, which identify specific issues hindering future career growth and progress. Former judge, Justice Hima Kohli, one of the few women judges in the Supreme Court recently noted the unconscious gender bias in courts which results in women judges being sidelined in administrative duties. This is highlighted by the fact that according to information published on High Court websites, none of the High Court Building Committees aside from Delhi, Allahabad and Himachal Pradesh currently has even a single woman judge as a member. Infrastructure needs for women are often de-prioritised as a result.





Air India Boeing 787 crash: Black box data extraction, analysis underway at AAIB's new lab in Delhi



Extraction and analysis of data from the black boxes of the ill-fated Air India Boeing 787-8 aircraft that crashed in Ahmedabad on June 12 is being done at the Aircraft Accident Investigation Bureau's (AAIB) new state-of-the-art laboratory in Delhi, according to the Ministry of Civil Aviation (MoCA). The black boxes are critical in aircraft accident investigations as they provide data on scores on parameters and aircraft systems, helping the investigators identify the most likely causes of an accident.

MoCA also said that the AAIB "promptly initiated" an investigation and constituted a multi-disciplinary team following the tragic crash of Air India flight AI171 in Ahmedabad. This team, constituted as per international protocol, is led by AAIB Director General GVG Yugandhar, and includes an aviation medicine specialist, an air traffic control officer. and representatives from the US National Transportation Safety Board (NTSB). The NTSB is assisting the AAIB in the probe as the aircraft was designed and manufactured in the US by an American company-Boeing."On the evening of 24 June 2025, the team led by DG (director general) AAIB with technical members from AAIB and NTSB began the data extraction process. The Crash Protection Module (CPM) from the front black box was safely retrieved, and on 25 June, 2025, the memory module was successfully accessed and its data downloaded at the AAIB Lab," MoCA said Thursday in an official release, providing an update on the recovery and examination of black box data.

"The analysis of CVR (cockpit voice recorder) and FDR (flight data recorder) data is underway. These efforts aim to reconstruct the sequence of events leading to the accident and identify contributing factors to enhance aviation safety and prevent future occurrences. All actions have been taken in full compliance with domestic laws and international obligations in a time bound manner," the ministry added. There were reports and speculation that the black box-FDR and CVR—could be sent to the US as AAIB's black box lab might not be fully equipped to handle damaged units. Sources had indicated that there were deliberations on whether to send units to the NTSB Vehicle Recorder Laboratory in the US for data extraction and analysis, or perform the exercise at the AAIB's new black box lab in Delhi. While the government had earlier said that the decision on where to extract and analyse data would be taken by the AAIB, the NTSB had declined to comment on the possibility of the black boxes being taken to the US."The investigation is being led by India's Aircraft Accident Investigation Bureau. As stipulated by international treaty (ICAO Annex 13) the country leading the investigation is the entity to release any information about the investigation. I'd suggest reaching out to them," an NTSB spokesperson had said on Wednesday in response to queries Boeing 787 aircraft have two combined black box sets, each with the joint functions of CVR and DFDR. According to industry insiders, the combined black box is called an Enhanced Airborne Flight Recorder (EAFR), and regulations require two units to be located in the aircraft—one at the front and one at the aft, or rear section—for redundancy, in case of unit is significantly damaged or is never recovered. The first EAFR were recovered on June 13 from a building rooftop at the crash site in Ahmedabad, while the second was recovered on June 16 from the aircraft debris.

"Standard Operating Procedures were issued for their secure handling, storage, and transportation. The devices were kept under 24×7 police protection and CCTV surveillance in Ahmedabad. Subsequently, the black boxes were brought from Ahmedabad to Delhi by IAF (Indian Air Force) aircraft with full security on 24 June, 2025. The front black box arrived at AAIB Lab, Delhi with the DG, AAIB at 1400 hrs on 24 June, 2025. The rear black box was brought by a second AAIB team and reached AAIB Lab, Delhi at 1715 hrs on 24 June, 2025," MoCA said in its official release. The new and advanced AAIB lab, built by support of government-owned Hindustan Aeronautics Ltd (HAL) and inaugurated in April, has enhanced the agency's ability to repair damaged black boxes, retrieve data, and conduct thorough analyses of accidents with high accuracy. Earlier, a black box lab under the aviation safety regulator Directorate General of Civil Aviation (DGCA) was being used by the AAIB, but the facility was old and lacked a few key capabilities needed for thorough and accurate data retrieval and analysis, said a source. That was one of the reasons why a number of black boxes from aircraft involved in serious accidents were sent to overseas labs

The purpose of the FDR is to record flight data on numerous parameters of aircraft operations, while the CVR records the flight crew's voices, as well as other sounds inside the cockpit, including engine noise, stall warnings, landing gear extension and retraction, and other clicks and pops. Communications with air traffic control, automated radio weather briefings, and conversation between the pilots and ground or cabin crew are also recorded. With the data retrieved from the FDR, investigators can generate a computer animated video reconstruction of the flight. The investigators can then visualise the aircraft's attitude, instrument readings, power settings, and other characteristics of the flight.

This animation enables the investigating team to visualise the last moments of the flight before the accident. "They (FDR and CVR) can provide information that may be difficult or impossible to obtain by other means. When used in conjunction with other information gained in the investigation, the recorders are playing an ever-increasing role in determining the Probable Cause of an aircraft accident," the NTSB says on its website.By regulation, aircraft must monitor at least eighty-eight important parameters such as time, altitude, airspeed, heading, and aircraft attitude. Some FDRs can record the status of more than 1,000 other in-flight characteristics that can aid in the investigation. The items monitored can be anything from flap position to auto-pilot mode or even smoke alarms, the NTSB states.

The blockbuster weight loss drug, semaglutide, now has competition in orforglipron, which is just as safe as injectable alternatives and more effectively lowers HbA1c (average blood sugar count of three months) in patients with type 2 diabetes and obesity. Chronic cough, headaches for no reason? Is your AC making you sick?

(File Photo)Of late I am seeing many patients with chronic cough, breathless bouts and asthma even when they do not have a history of any respiratory condition. Eliminating all risk factors, I zeroed in on one trigger that they didn't know was affecting their lungs — their air-conditioner. Yes, your AC can become a sneaky health hazard in hot and humid conditions, as mould grows inside it.

What is AC mould?

Mould is a fungus that thrives in a dark, humid and wet environment, all of which exist in AC units. Condensation within an AC unit, especially if the AC is not cleaned frequently, is where mould may form on filters, coils or ducts. The mould then deteriorates and releases spores into the air, which you eventually breathe whenever the AC is operational.In patients suffering from asthma, COPD (Chronic Obstructive Pulmonary Disease), bronchitis or even immune-compromised conditions, inhaling mould initiates attacks, increases their frequency and even leads to hospitalisation. Even healthy individuals can experience symptoms such as coughing, wheezing or breathlessness. sore throat, tightness of the chest, sinus congestion, irritation to the eyes or skin. At high exposure levels, when people ntact with noiso nue moulde like l they could become vulnerable to fatigue, headaches, nausea, or even neurological damage. Long-term exposure also increases the risk of getting a respiratory infection or hypersensitivity pneumuonitis, an illness where lung inflammation results from an allergic reaction to mould particles floating in the air.Studies have been few but one of them found that when office air-conditioning systems were irradiated with ultraviolet light to kill bacteria and fungi, fewer

"Previous oral GLP-1s like semaglutide (Rybelsus) are peptide-based and have significant limitations — they must be taken on an empty stomach with minimal water and have much lower bioavailability than injectable form. Orforglipron is a small molecule that doesn't require food or water restrictions, so it is very convenient and is absorbed easily," says Dr Misra.

What about the trial results?

At 40 weeks, all three doses (3 mg, 12 mg, 36 mg) of orforglipron achieved the primary goal of superior HbA1C reduction. Improvements in HbA1C were observed as early as four weeks and were accompanied by similar reductions in fasting serum glucose. "The early onset of glycemic improvement, observed as soon as four weeks, reinforces the therapeutic potential of orforglipron as an effective, oral GLP-1 therapy for early type 2 diabetes treatment. These findings support further investigation in broader populations and longer-duration studies," said Dr Julio Rosenstock, senior scientific advisor for Velocity Clinical Research at Medical City Dallas, clinical professor of medicine, University of Texas Southwestern Medical Center, and lead trial investigator.

What about side effects?

In the study, orforglipron had a safety profile similar to the established GLP-1 class of medication. The most frequently reported adverse events were gastrointestinal-related.

space Monday evening, shortly before Iran launched a volley of missiles at the US military base—Al Udeid Air Base in Qatar-over 90 Qatar Airways flights with more than 20,000 passengers were on their way to its hub Doha, and had to be diverted to airports in various countries, including 15 to India, the airline's chief executive Badr Mohammed Al Meer said in a letter to passengers, detailing how the global airline managed the crisis over the next two days.He described the crisis as "an operational crisis few airlines will ever encounter, and one that "challenged the very core of what it means to run a global airline". The airspace closure snowballed into a major international disruption, given Qatar Airways' extensive network and Doha being a mega hub airport, where thousands of passengers transit daily. Iran's missile attack-in retaliation of American airstrikes at its nuclear facilities-led to other West Asian countries including the UAE, Bahrain, and Kuwait also shutting down their airspaces for a few hours, which deepened the disruption further.

"At the time (of the airspace closure), over 90 Qatar Airways flights carrying more than 20,000 passengers to Doha, were forced to divert immediately. 25 flights diverted into airports across Saudi Arabia, 18 into Turkey, 15 into India, 13 into Oman, and 5 into the United Arab Emirates. The remaining aircraft were re-routed to major hubs including London, Barcelona, and others across Europe, Asia, and the Middle East," wrote Al Meer, terming the Qatari airspace closure as "unexpected and unprecedented"."At around 18:00 local time on Monday, 23 June, an unexpected and unprecedented closure of Qatari airspace forced Qatar Airways to suspend global operations with immediate effect. Shortly after, airspace was also closed in Bahrain, the UAE, and Kuwait. Hamad International Airport (Doha), one of the world's busiest and most connected global hubs, was brought to a standstill, with almost 100 aircraft en route to Doha, several already on approach to our runways, and others lining up for departure," he said.Scale of the disruptionWith all departures from Doha suspended until past midnight (Qatar time), the airline's "routine, seamlessly synchronised global operation" was instantly scattered into dozens and dozens of disrupted flight scenarios across continents, "each with their own complexities and requirements". According to Al Meer, over 10,000 passengers were already in transit at the Doha airport when the disruption began, finding themselves caught in the middle of "one of the most severe and complex operational challenges in modern aviation history"."Around the world, some of our flight crews had timed out of legal operating hours. Most of our fleet, including A380s carrying more than 450 passengers each, were now out of position, some grounded at airports with curfews. Several flights had to wait for clearance to re-enter restricted regional airspace. Aircraft routing plans were rewritten in parallel with passenger itineraries. Over 151 flights were immediately disrupted. Every part of the operation had to adapt in real time - without precedent, and without pause," Al Meer wrote in the letter.He added that the priority for Qatar Airways was clear-to care for passengers impacted by the unprecedented situation, and to restore its global operations "as safely and swiftly as possible". Crisis mitigation efforts in Doha

Once the Qatari airspace reopened shortly after midnight on Tuesday, the diverted aircraft began returning to Doha over the course of several hours. As a result, the number of passengers in transit at the Doha airport ballooned to over 22,000 by 5 am (Qatar time)."As an airline, our business continuity plans were activated, and our teams coordinated on hard resource planning, catering, ground transport, hotel accommodation, and real-time alignment with passenger movements, immigration, customs, and every airport stakeholder. Over 4,600 customers were provided hotel accommodation, using approximately 3,200 rooms across Doha. Many of these passengers received onward boarding passes for their rescheduled flights before even leaving the terminal-allowing for a smoother reentry once our operations resumed," the Qatar Airways CEO said Meanwhile at the Doha airport, Qatar Airways group teams got busy rebooking journeys, and even manually rebuilding complex travel itineraries—some involving other airlines, and even expired visas. The airline also decided to increase capacity to destinations with "high volumes of displaced passengers"."Contact centre resources were scaled up to cope with global demand.

We quickly established a flexible travel policy, allowing passengers who had not yet started their journeys to make changes or refund their bookings without fees. Across our global stations, ground handlers and partners moved quickly, supported by live coordination between our airport and airline operations control centres," Al Meer said.Resumption of normal flight operationsOn Tuesday, Qatar Airways operated a total of 390 flights as it worked to restore the integrity of its flight schedule. Around 20,000 passengers from its disrupted flights were cleared within 24 hours, with more than 11,000 resuming their journeys on the morning of June 24, while the remainder departed through the evening that day and the morning of June 25. According to Al Meer, after that, there were no passengers from diverted flights that were still stranded."Within just 18 hours, our scheduled operations had resumed. Wave by wave, the system began to stabilise. By the end of Tuesday, more than 58,000 passengers had departed Dohamoved not by chance, but by a coordinated effort from across the Qatar Airways Group to fulfil our responsibility during this unprecedented disruption," Al Meer said. The airline's operations stabilised further on June 25 with the operation of 578 flights. According to data from Cirium, an aviation analytics company, Qatar Airways normally has between 523 and 547 daily flights, depending on the day of the week

40-year-old loses 16 kg with novel weight loss drugs: 'My cravings, food noise are gone'

For the first time, 40-year-old Manmeet Bindra feels motivated to exercise and has set up a home gym, cleaned up her diet and has more energy to ride out her 10 am to 7 pm work days and the pressure of deadlines. Tired of seeing the weighing scale needle tipping over the 90 kg mark and her blood sugar levels spiral despite fad diets, gym routines and natural supplements, she is now 74 kg. For the past year, she had been on the oral weight loss drug semaglutide (Rybelsus) but since she couldn't tolerate its side effects well, has had better results with tirzepatide (Mounjaro) this year.

"I needed that one push to get off the weight plateau, steel my mind and focus on getting better and be diseasefree. Mounjaro accelerated the process," says Bindra, who has battled uncontrolled diabetes, PCOS (polycystic ovary syndrome), hypothyroidism and fatty liver because of her weight. Her appetite has now gone down by 30-40 per cent, her binge cravings are zero and she has managed to tame the "food noise" that made her peckish through the day.

Food was not just her pleasure but escapism, something that Dr Jasjeet Singh Wasir, her endocrinologist and diabetologist at Medanta, understood when she consulted him last year. That's why he put her on a new class of weight loss drugs. Her blood sugar readings are better and her HbA1c (average blood sugar count of three months) has gone down from 8 per cent to 7.3 per cent (normal is less than 5.6 per cent). The new drugs are more than a life-saver for people like Bindra as they help them eliminate several obesity-related risk factors. The GLP-1 receptor agonists mimic natural gut hormones responsible for blood sugar and appetite control, such as semaglutide - the active ingredient in Wegovy. It improves secretion of insulin, inhibits glucose production in the liver and slows down digestion. Tirzepatide, sold as Mounjaro, additionally mimics the GIP hormone, primarily by stimulating insulin release from the pancreas. GIP also influences lipid metabolism.

Bindra never realised how a sedentary lifestyle, long work hours, performance anxiety and stress-eating had turned into belly fat. Then she gained weight all over. After developing Covid in 2020 and 2022, her random blood tests showed a blood glucose level of 190 mg/dL and a HbA1c count of 5.8 per cent. In April 2023, during her executive health check-up, she was diagnosed with type 2 diabetes as her HbA1c shot up to 8.4 per cent.Looking at her body weight, family history of diabetes and her dual role as professional and caregiver for her parents, Dr Wasir put her on oral semaglutide or Rybelsus pills, mainly to control her diabetes though it also helps in some weight loss. According to randomised controlled trials, one starts losing weight immediately after taking Rybelsus. After one month, the average weight loss on Rybelsus is around 2 kg; after two months, it's over 3 kg."I constantly had nausea, vomitting, diarrhoea, fatigue, constipation and headaches. My body simply did not take to semaglutide," says Bindra. Then Dr Wasir put her on the injectable tirzepatide. "Around 300 patients of mine on weight loss pills had extreme gastric symptoms. The same patients are tolerating the injectable Mounjaro better," he says.

Since Mounjaro mimics two hormones involved in appetite regulation and glucose control, this dual action may result in more significant weight loss and potentially better blood sugar control. This can indirectly improve overall tolerability. However, Dr Wasir attributes tolerability to the grading of doses. Most of his patients begin from 2.5 or 5 mg, which is a kind of stage one and stage two doses. Then it goes up to 7.5 mg and a maximum dose of 15 mg. "It's still very early for us to arrive at an observation," he says.Bindra started with a low 1.25 mg dose. Once she could tolerate it, Dr Wasir upgraded the dose to 2.5 mg. But at the same time, he insisted she make lifestyle changes, particularly her diet and exercise. "I cut down on junk food, fried items and oily meals. I used to binge-eat when I was stressed and that's significantly reduced now. I am into plant proteins," she adds. Now Bindra focusses on simple, homecooked foods that keep her stomach happy. "Looking back, that kick we seek in our food rather than exercising was the reason I always craved the spicier and heavier chole bhature or rajma rice. This dietary shift has influenced some of my health markers, too," she says.Mounjaro has been an effective appetite suppressant. "I used to eat two rotis but now I'm comfortable with one. I can portion-control. Interestingly, I no longer feel as hungry as before or feel dizzy. I have given up alcohol too, though I was nothing beyond a social drinker," says Bindra. For Dr Wasir, the key challenge remains her protein intake, now that she only has plant proteins. "There's always a risk of muscle loss alongside fat loss, which can be hard to reverse





Jasprit Bumrah likely to miss second Test against England; India look for replacement, new plan



Very early on this long tour, India have a crisis on their hands. After losing the Headingley Test, which they should have won, they are likely to be without their MVP for the next. It could be the call of Lord's or workload management; Jasprit Bumrah, after bowling 44 overs at Headingley, in all probability will sit out for the second Test at Edgbaston. He is expected to return for the third Test at the home of cricket in London on July 10. The Birmingham Test starts in about a week but that's too short a time, and their bowling department needs to get their act together. For starters, India's pacers need to be skilled and that takes time. So do discipline and strategy. After their justified two-day break, India need to hit the nets and keep getting into huddles – rinse, repeat, rinse, repeat until the Headingley memories are washed clean.

If India can't take 20 wickets with Bumrah, how can they do it without their chief wicket-taker? Adversity can bring out the best in players, the burden of responsibility can throw up new leaders but those are template quotes for sports movies. In real life, there are Ben Duckett and Zak Crawley on unresponsive pitches to deal with. On the final day of the Test, the two England openers exposed the limitations of the Indian bowling attack. The two aggressive batsmen didn't beat the living daylights out of the bowlers but meticulously hit them out of the attack. They showed India pacers lacked the skill and tactics that work on these surprisingly batting-friendly pitches in England. Either the coaches didn't plan well or the bowlers weren't skilled to implement them. The bottom line is India are 0-1 as they could not defend 371 in fourth innings on a rainy English day. A close look at the mode of dismissal of key batsmen in the first Test hints at a pattern - the best chance of getting wickets was the full ball. Sachin Tendulkar, speaking to The Indian Express, had also said how Bumrah too needed to aim at the stumps. So the conclusion is it is the full on-the-stumps ball, which the batsmen can't avoid, that can get wickets. This is the ball that brings into play the three common dismissals - bowled, lbw and caught behind the stumps. Duckett, Crawley, Joe Root, Yashasvi Jaiswal, KL Rahul, Karun Nair, Shubman Gill - they all got out to balls pitched up, that moved away or kept the line and hit the stumps. The two Indian bowlers under maximum scrutiny - Prasidh Krishna and Shardul Thakur - failed to stick to that ideal line and length during the crucial first session on the final day when India went wicketless and the England openers started sprinting towards the target. The Headingley pitch was dry and brown that day but Day 5 was mostly cloudy and drizzly. There was moisture in the air, there was swing to avail, stumps to be hit and edges there to be taken. Pundits say that full balls get more swing since they stay in the air longer. Prasidh and Thakur didn't agree to that theory, or they were given alternate plans.

Bumrah and Siraj, though wicketless in their first spell, had at least troubled the openers and kept the run flow in check. But when Prasidh and Shardul bowled, the pressure was off, run-making became suddenly easy.

Go back to the first over that Prasidh bowled. He started with a yorker. It didn't seem like a plan to catch the batsmen by surprise but this was more of a pacer, new to the Test arena too, keen to follow the 'bowling full' theory drilled into him. The next ball he pulled back a bit but it was still over-pitched. Conscious that he wasn't doing what was expected of him, Prasidh ended up bowling a shortish ball to compensate. As luck would have it, Duckett ended up edging the ball and all was forgotten. (AP)Whichever of Arshdeep, Harshit Rana or Akash Deep slot in for Bumrah at Birmingham, will need to make an immediate impact too. They can take inspiration from Tongue or Carse who came in not on the back of too many Tests, but did the needful.

Thakur's first over was the worst. He started with a half volley on legs that was hit straight to the fielder by Duckett. A boundary was saved. But the next ball was similar and got flicked to fine for an easy risk-free boundary. When Prasidh and Thakur bowled together, from 18th to 23rd overs, England scored at close to 6 runs per over. The scoring sequence was 5, 4, 9, 6, 5 and the score climbed from 63/0 to 92/0.England went from a bit more than 50 to approaching 100 – the pressure had lifted and the conditions had been wasted. In the coming days, before the next Test starts, India need to teach their No.3 and No.4 pacers to hit the zone from their first ball.

Siraj, too, needs to recalibrate his pace plan. His nipbacker has troubled batsmen but hasn't proved to be the wicket-taking ball here. His tendency to hit the deck has seen him either miss the stumps or lack the bite to get the outside edge. His other trusted weapon is the scrambled seam ball but in England, at least at Headingley, this hasn't worked. Here India needed a pacer with a proud seam who would keep the ball full and on the off-stump. (AP Photo/Scott Heppell)These are skills and discipline that international bowlers avail after long hours at the nets. But what about the temperament to lead a pace bowling attack? In the absence of Bumrah, Siraj will have to be in that role. There was this small moment on the field that showed how Siraj still needs a senior around to put a hand around his shoulder. In one of his spells, Sirai had bowled well but he was denied a wicket. Catches were also getting dropped. On one fine ball, a Duckett edge flew over the wicket-keeper and Siraj's shoulders dropped, he stood like a statue, staring blankly. Bumrah knew what to do, he patted him on his back and walked him to his field position. Ishant Sharma and Mohammed Shami have done the same to him. In Bumrah's absence, Siraj will have to be the strike bowler, a mentor to others and also a motivator to himself. There is this famous reel of an over-emotional Siraj talking about Bumrah who has just taken India to a magical win. "I only believe in Jassi bhai because he is the only game changer," he says with a goofy look in his eyes and a charming smile. Now, he also needs to be a game-changer.

But I would like to repeat that Rishabh has got a great defence. There is not one shot in the book that he cannot play... Can I request you to make a double 100 next time when you're batting at 130? India grouped with Kuwait, Australia, and Mongolia in AFC Futsal Asian Cup 2026 qualifiers

Hyderabad: India have been drawn alongside hosts Kuwait, Australia, and Mongolia, in Group A of the AFC Futsal Asian Cup Indonesia 2026 qualifiers, the draw for which, was held at the AFC House in Kuala Lumpur, Malaysia, on Thursday.Ranked 135th in the world, India will appear in their second qualification campaign for the AFC Futsal Asian Cup, after losing their three qualifying matches in 2023. Their Group A opponents, Kuwait, Australia, and Mongolia, are placed 40th, 52nd, and 112nd, respectively, in the FIFA rankings. The qualifiers will be held from September 20 to 24 in Kuwait City. The draw, which was held for the first time in accordance with the FIFA Futsal rankings, saw 31 teams divided into eight groups - seven groups of four teams each and one group containing three teams. The eight group toppers, along with the seven best secondplaced finishers, will join hosts Indonesia in the competition proper in January 2026.

Give him that freedom, he will get you more wickets," Rahane reasoned.Jasprit Bumrah picked up five wickets in the first innings of the Test match at Headingly in Leeds.

"Bumrah's five wicket-haul in the first innings was amazing. Apart from his five wickets what I liked about Bumrah was his intent. The way he was running in his runup. His intensity throughout his bowling was amazing. The lines and lengths that he bowled. He was aggressive throughout in his bowling approach," Rahane explained"What I would like to see is support from the other end. Bumrah is obviously bowling his attacking lengths but if he can support from Siraj and Prasidh, that will be great for him. You don't want Bumrah under pressure and start bowling too many overs and the pressure comes on the team. I want to see Siraj taking that responsibility and also Prasidh if he plays that second Test match," he added.

Rohit Sharma puts win against Pakistan in perspective: 'It's not okay if we beat Pakistan and do not win World Cup'

India won the T20 World Cup 2024, which was held in the US and the Caribbean Islands, to win their first ICC trophy in 13 years and beat Pakistan in the group stage en route to their famous win against South Africa in the finals. The 2024 T20 World Cup-winning captain, Rohit Sharma, opened up on the emotions running in the high-octane India vs Pakistan clash at the tournament. Rohit spoke about the much-talked-about stadium in New York and said it looked grand.

"The stadium was beautiful. When we reached the ground for the first time, there was a trophy unveiling ceremony, and that's when I saw the ground for the first time. We were not allowed to train inside the stadium as there was no practice facility," said Rohit to Star Sports. "We could take the feeling of the ground only when we got to play the match. From first glance, Kaafi grand stadium lag raha tha (The stadium looked pretty grand). It was an open stadium, the seating arrangements were good, basically, it was a makeshift stadium. So the things you expect in a normal venue, you won't get there," he added.

Speaking on the tricky pitch of New York, Rohit said, "We played three matches there and we could not figure out what the good total at that venue, where to place the shots, what are the scoring areas, what lines to bowl as a bowler, although it was a bowlers' friendly pitch. So the first thing we did in our group talks was we completely took the

pitch out of the equation."Rohit then runs through the whole India vs Pakistan match, giving the reasoning for his decision. Rohit said India wanted Pakistan to chase. India were bundled out for just 119 in 19 overs, where Rishabh Pant scored 42 off 31.Asked if there was any advice for Rishabh Pant after Virat Kohli fell early. Rohit said, "Nhi, nhi nhi... kuch advice nahi tha (No, there was no advice for him). We just wanted Rishabh to be Rishabh. Do all these kinds of things and try and put the bowlers off, and he did that perfectly. His 42 was more like the 70, considering the conditions."

While defending, Rohit admitted that he felt India were 15-20 runs short after the first innings, but this target would look more like 160 if his bowlers picked early wickets. "Mere paas Bumrah ke saath saath Arshdeep bhi hai (Along with Bumrah I had Arshdeep as well)," he said. India eventually beat Pakistan in a low-scoring humdinger by six runs, but skipper Rohit said it didn't mean anything more than a win."A tick in the box to move ahead in the tournament, nothing else. I know you want to beat Pakistan and there is so much of chatter around it but for us, it's an opposition and we want to come up against and play well and win. Don't need to overthink and think if we win against Pakistan, we win the World Cup. It doesn't work like that," said Rohit." Agar Pakistan ko hara diva aur World Cup nahin jeeta, toh chalega? Nahi chalega (If we beat Pakistan and do not win the World Cup, will it be okay? It's not okay)," Rohit said.

Anyone who has seen the Amitabh Bachchan-starrer Mard would vividly remember the entry of the film's villain, played by Dan Dhanoa. Introduced riding a horse, he delivers the unforgettable line: "Main hoon General Dyer ka beta Danny (I am General Dyer's son, Danny)," a moment that became legendary in Hindi cinema. Dan, who portrayed the evil Danny Dyer in Mard, quickly rose to fame and became a go-to villain for Bombay's film producers. Interestingly, Dan never intended to enter the film industry. His father, Major General Dr. Sardar Singh Dhanoa, had hoped he would follow in his mother's footsteps, and become a doctor. However, since academics didn't interest him, Dan opted for a career in Merchant Navy.

Due to a shortage of job opportunities at the time, he turned to modelling instead. Even then, films were never on his radar. As, during his years at The Doon School, he preferred watching Western films and remained largely unfamiliar with mainstream Hindi cinema. Fate, however, had other plans. In 1984, legendary filmmaker Feroz Khan organized a silver jubilee celebration for his hit film Qurbani. It was at this event that Feroz noticed Dan and, impressed by his looks and personality, approached him with a film offer. In a recent interview on Chai Ke Saath Dil Ki Baat, Dan recounted the meeting: "Feroz Khan came up to me at the party and quickly asked, 'Do you act?' I said, 'Sir, I don't know how to act.' To this, he replied, 'That's my lookout." Feroz Khan even conducted a test shoot with Dan Dhanoa and enrolled him in a short-term acting workshop alongside actresses Mandakini and Reema Kapadia. He also suggested changing Dan's birth name, Indrapreet, to

Dan. However, the original version of Janbaaz, in which Dan was to be launched, was shelved. When the film was eventually revived in 1986 with a different script and cast, there was no role for Dan. Soon after parting ways with Feroz Khan on amicable terms, Dan met director Manmohan Desai, who was casting for Mard. Desai saw potential in him and offered him the role of the main villain opposite Amitabh Bachchan. In an interview for the YouTube channel Chai Ke Saath Dil Ki Baat, Dan Dhanoa spoke fondly of working with Amitabh: "He was very welcoming and supportive. He constantly helped me throughout the shooting process and was a thorough gentleman despite being a superstar." Mard was a massive hit, and Dan's portrayal of Danny Dyer made him a household name. From there, there was no turning back. He went on to appear in several notable films, Shahenshah, Tridev, Toofan, Phool Aur Kaante, Vishwatma, and even worked alongside legends like Dilip Kumar in Karma. Dan witnessed the transition of Hindi cinema from the Bachchan era to the rise of stars like Sunny Deol, Salman Khan, Ajay Devgn, and Akshay Kumar. He also revealed in the same interview that he was once offered a role in Ravi Chopra's Mahabharat television series but turned it down, preferring to stay focused on films. His growing fame also brought with it a massive female fan following. "There used to be instances where women fans would call on my landline just to get a chance to meet or speak with me," he recalled.

However, by the late 1990s, Dan Dhanoa chose to walk away from the industry. Tired of being typecast and disillusioned with the internal workings of the film world, he decided to return to his original profession. "I wasn't a film industry man... I was an outsider. I didn't understand the ways of the industry, like going around asking for work and later asking for payment. That just wasn't for me."Disillusioned by how some producers treated him, Dan Dhanoa left Bollywood around the year 2000, returned to the seas, and resumed his career with the Merchant Navy, where he went on to have an illustrious career as a naval officer, traveling across the globe. Now a full-time sailor, Dan leads a quiet life away from the limelight in Chandigarh. He recently made a comeback to acting after 23 years with a role in the Tamil film Soorarai Pottru. He played a negative character loosely inspired by fugitive businessman Vijay Mallya, marking his return to cinema with the same intensity that once made him a star villain.
