BJP chief Ramachandra Rao condemns BRS activists' attack on media organisations

ing unit. The MPDO was directed to process the request as per guidelines. Justice P C Ghose inquiry into Kaleshwaram project reaches final phase

Hyderabad, July 7 : The investigation led by the Justice Pinaki Chandra Ghose Commission, which is examining the irregularities associated with the Kaleshwaram project, primarily concerning the Medigadda, Annaram, and Sundilla barrages, has reached its concluding phases. Sources indicate that the Commission is expected to present its final report to the State government on July 27. Since last year, the Justice PC Ghosh Commission has been reviewing the shortcomings and failures connected to the three barrages. An extensive investigation has already been carried out regarding their design, construction, quality, and maintenance.As part of its investigation, the Commission has already interviewed former chief minister K Chandrashekar Rao, former irrigation minister Harish Rao, and former finance minister Eatala Rajender. They have

obtained affidavits from engineers and senior officials concerning technical, financial, and policy matters, and have conducted cross-examinations based on these affidavits. In a related development, the Commission has issued fresh summons to former engineer-in-chief of the Irrigation department, M. Anil Kumar. The Commission discovered that there was a concealment regarding the grounding issue at the Medigadda barrage. Reports indicate that Chandra Ghose has expressed displeasure towards Anil Kumar for providing a misleading statement while holding a significant position. Anil Kumar has been requested to appear before the Commission for questioning on July 9. The Commission's office has also stated that it has received the minutes from the cabinet meetings of the previous government related to the Kaleshwaram lift irrigation and associated projects.

TGGENCO setting up 4000 MW Yadadri Thermal Power Station at Veerlapalem

Hyderabad, July 7 TGGENCO is establishing 4000 MW (SX800 MW) Yadedri Thermal Power Station at Veerlapalem Village, Dameracheria, Nalgonda District. The Unit-2 (800 MW) is commissioned in January 2025 and Una-1 (800 MW) is scheduled to be commissioned in July 2025.

The balance three units (3X800 MW) will be commissioned by February 2026. The total coal requirement for all the five units will be around 50,000 Metric Tonnes per day (12-14 railway rakes) from SCCL.TGGENCO has constructed Railway line from Janpahad Take-off point to YTPS site with a cost of Rs 500 crores. Presently, S C. Railways are supplying four (4) rakes per day to YTPS and the requirement will be around 12-14 rakes for all the five (5) units from December 2025 onwards. As per the instructions of Deputy Chief Minister and Principal Secretary, Energy Department, a meeting was conducted on July 7 by Chairman & Managing Director, TGGENCO and reviewed the status of construction works of Railway siding of YTPS and preparedness for movement of 12-14 coal rakes with

TGGENCO and Railway Officials. During the meeting, Chairman & Managing Director has directed all the concerned Officials and contractors of TGGENCO to complete all the pending works of Railway siding of YTPS to receive 12-14 coal rakes at YTPS site from December 2025 onwards. Principal Chief Operations Manager, S.C. Railways has informed that, the Railways are fully prepared for movement of required quantity of coal to YTPS with the existing Rail net work and Railways are also taking up for doubling of railway lines between Domakal-BDCR and Motamarri-Vishnupuram to deal with the increased traffic.

Principal Chief Operations Manager, S. C. Railways has also advised TGGENCO to examine other alternative sources of coal supplies to meet the requirement of YTPS since SCCL may not be in a position to meet the future demand. During the meeting, B. Nagya, IRTS, Director (Coal & Logistics), TGGENCO Srl. A. Ajay, Director (Civil), TGGENCO, K. Padmaja, IRTS, PCOM, South Central Railways and R. Two men who snatched US citizen's phone in Delhi's Amar Colony nabbed after shootout

Around midnight on Thursday, two snatchers looted an American citizen out for a walk in Southeast Delhi's Amar Colony. The duo returned to the same spot on Sunday to execute another robbery — and landed in the police net after a brief exchange of fire, officers said.Police said the snatchers, Jatin (20) and Akshay (20), are undergoing treatment at AIIMS for injuries sustained during the shootout.The American citizen, Aradome Bella Kahn (28), landed in Delhi on June 20 and was staying at Hotel Elegant in East of Kailash. On Thursday, police said, he took a stroll in a DDA park in Astha Kunj and was heading to the hotel when the duo pounced on him."Akshay and Jatin attacked the man and his woman friend with a knife and snatched his mobile phone. He sustained injuries to both his hands and immediately went to Fortis Hospital in New Friends Colony. He was later shifted to Apollo," said DCP (Southeast) Hemant Tiwari.Police received the medico-legal certificate from Fortis in the early hours of Thursday, and a case was registered at Amar Colony police station. Based on descriptions given by Kahn and the inputs received by police, it was learnt that both accused would be back at the same park on Sunday morning."At 1.30 am on Sunday, Inspector Rajender Singh Dagar got inputs about the accused persons moving through the DDA Astha Kunj park from the ISKCON temple side towards Rampyau Kalkaji. At 5.10 am, the accused persons were identified by informers and asked to surrender. However, the duo, carrying one sophisticated pistol and one countrymade katta, fired a total of three rounds at the police party. One bullet stuck Inspector Dagar's bulletproof jacket on the chest, while another hit HC Mahendar's jacket in the same area," DCP Tiwari said.Police fired three rounds in self-defence, and Jatin and Akshay sustained injuries to their right leg.

The accused were arrested, and police seized the US citizen's stolen mobile phone from their possession.During questioning, Jatin told the police that he and Akshay were childhood friends and dropped out of school in Class 5. Jatin, who has previous cases of robbery and cases under the Arms Act lodged against him, persuaded Akshay to join him in what would be Akshay's first robbery, police said. "They were planning to get hold of another victim passing by the park in the early hours of Sunday when we caught them. They are admitted to the AIIMS Trauma Centre. Further investigation is on," DCP Tiwari said.

Culprits will be tried in people's court': Union minister Dharmendra Pradhan attacks Mamata govt over rape at Kolkata law college

While condemning the rape of a student at Kolkaka law college, Union Education Minister Dharmendra Pradhan on Sunday accused West Bengal's Mamata Banerjee-led Trinamool Congress government of "patronising" the perpetrators and making the college authorities helpless."This is not a matter for a CBI inquiry. The culprits will be tried in the people's court of Bengal. They must be thrown outonly then will peace return to Bengal," Pradhan said at an event in North 24 Parganas."What surprises me is that Mamata Banerjee was a student leader. What happened to Didi? She was a student leader and a youth leader herself. How has she left today's student generation in such a condition. Rape, murder... How can all that be given patronage? Does it not pain her? They just remain indifferent to peoples suffering to protect their own," the BJP leader said."Bengal is the place of Ma Saraswati and the place for women's development. Bengal used to be an example for the entire country regarding women's progress in education," he added. Pradhan said the rape at the law college and the rape-murder of a doctor at RG Kar Medical College in Kolkata exposed "the mindset of the ruling party, which is headed by a woman". "This is very dangerous for a democratic society. When saviours become demons. When those in power make criminals members of their party, give these criminals power and post them, such anarchy and crime increase. I condemn this in the strongest way possible," he added. Regarding the college administration's role in ensuring students' safety, Pradhan said, "When the chief minister's office and the ruling party's leadership patronise such people



what will college authorities do?"In Bengal and many other states, many student leaders have joined politics but now antisocial elements and criminals are taking over colleges, the Union minister said. Meanwhile, after spending 14 hours in Kolkata police's custody with other BJP leaders and workers, BJP state president Sukanta Majumdar was released. The BJP leaders were detained while protesting at Gariahat over the law college incident. Majumdar told reporters that he had refused bail on a personal bond. "West Bengal has become a killing field of democracy," he said. "Two incidents of rape inside educational institutions have taken place in the city within eight months, where is the administration?" Majumdar further said that BJP workers and leaders detained during protests would not avail of bail on personal bonds from police stations but would insist on being produced in court. On Saturday the BJP constituted a four-member fact-finding committee to look into the law college rape. Its members are former Union minister Satpal Singh; former Union minister Meenakshi Lekhi; MP Biplab Kumar Deb; and MP Manan Kumar Mishra.

Vadavan port will take care of all north-bound cargo and JNPT will cater to hinterland operations: JNPA Chairman Unmesh Sharad Wagh

The Jawaharlal Nehru Port Authority (JNPA) in Navi Mumbai has become the first port in India to cross 10 million twenty-foot equivalent unit (TEU) container handling capacity following the completion of its latest expansion phase. With five container terminals now offering a combined capacity of 10.4 million TEUs, the Jawaharlal Nehru Port continues to handle over half of container traffic of India.In an interview with The Indian Express, JNPA Chairman Unmesh Sharad Wagh, who is also leading the upcoming Vadhavan Port project in Palghar, shares insights on expansion, logistics and sustainability of the two ports in Maharashtra.

Q: Recently the Jawaharlal Nehru Port achieved a milestone of 10 million TEUs handling capacity. What factors contributed to this achievement?

Unmesh Sharad Wagh: JNPA is mainly a container port operating under the landlord model, where we have roped in private companies to operate under a concession agreement. For this, we have assigned terminals to all global bigger players, which has taken the capacity til 10.4 million TEUs—the largest in all ports in India. Last year we handled a cargo of about 7.3 million TEUs, so assuming 20 per cent growth by the end of this year, our estimation is to reach about 9 million TEUs. So this model of operation has largely contributed.

Q: How does road or highway connectivity play a role here? Are we looking at any expansion of capacity further?

Unmesh Sharad Wagh: For a port, three things are important-marine efficiency, execution efficiency, and evacuation to the hinterland. So if we talk about the evacuation to the hinterland, then connectivity is the key. With an eight-lane highway connectivity, the evacuation, which initially was 2-4 kmph, has now increased to 40-50 kmph. Moreover, JNPA has simplified all the processes involved to reduce the cost and time of doing business and promote the ease of doing business, making it 20-25 per cent cheaper for businesses. And for expansion, there is little scope at JNPA. However, we have the upcoming Vadhavan Port.

Q: Talking about Vadhavan, what is the current status of the Vadhavan project as you are overseeing it as well?

Unmesh Sharad Wagh: The construction work on the Vadhavan Port is going on. Land acquisition for the approach road has been done and the 3D notification from NHAI (National Highway Authority of India) is in process. We are also constructing a service road dedicated to the making of Vadhavan. This road, after serving its purpose for the port, will be like a present from JNPA for the villagers near the port. It will serve as a connecting toll-free road to the Mumbai-Delhi expressway.

Q: There has been resistance by the villagers and locals. How are you dealing with that?

Unmesh Sharad Wagh: There are about 24 villages in the vicinity, but only a few problematic people show resistance even after their demands are considered. Practically, no one is affected in the region. For the people in the influential area the project will only bring many benefits. One of them is a skilling programme for the local youth where we have targeted producing 5,000 sea fares through a collaboration with ITIs. Besides, we are also providing agriculture training for them through Dapoli Agricultural University and the skill development centre at Sahyadri Farms, Nashik. In fact, the only segment that can be seen affected by the port are the fishermen, but they are very positive towards the making of the port. We have ensured to not only give fair compensation to the affected fishermen but also undertake development and skilling activities by deploying CSR funds.

Q: How would the cargo distribution be once the Vadhavan Port begins operations? Any plans to bring in transshipment like at the Vizhinjam port?

Unmesh Sharad Wagh: Cargo distribution will eventually happen even though it's far from sight now. Vadhavan will take care of all the north-bound cargo while JNPT will cater to the hinterland operations. And for transshipment, Vizhinjam is only a transshipment port, while ours is a getaway port with only 1 per cent transshipment capacity. Currently, around 25 per cent of the cargo from India is transshipped and 20 per cent is from the western side. With Vadhavan coming on the western seafront, 100 per cent of this cargo will come to the new port. So we will ensure there is a balance of all the operations amongst both the ports.

Q: What are your plans to make both the ports sustainable and automated–measures already in place at the Jawaharlal Nehru Port and plans for Vadhavan?

Unmesh Sharad Wagh: Sustainability is always at the centre of our port operations. The port already runs on 60 per cent renewable, green energy, which we are planning to take up to 100 per cent. We have started replacing fuel trucks with electric ones with around 500 e-trucks in place today. Besides, all the required infrastructure like battery charging and swapping points are also in place. Although we have a 34 per cent green cover, we are constantly trying to increase the greenery with efforts like Miyawaki plantations. We have also worked towards the rejuvenation of local lakes and temples as an attempt to beautify with sustainability. Automation also is in process and operations at the port are fully digitised, with 5G-enabled systems and cyber security measures.

'She has broken a family of 40 years': Kalyan Banerjee reacts to Mahua Moitra's 'misogyny' jibe as TMC MPs clash over Kolkata rape case

Trinamool Congress MP Kalyan Banerjee Sunday made a personal attack on fellow TMC MP Mahua Moitra after she accused him and MLA Madan Mitra of "misogyny" over their remarks about the Kolkata law college rape case. Meanwhile, the TMC sent a showcause notice to Mitra, seeking a reply within three days."She has returned to India after a honeymoon of one and a half months abroad and has started provoking. I am not a misogynist. I talk a lot in favour of women. In fact, Mahua Maitra is so anti-women that in the Krishnanagar parliamentary constituency, she doesn't let any other women grow. There is one lady hater and that is Mahua Maitra," he added. "She became an MLA when the TMC was already strong, and she is fully leveraging women's issues. I don't need to hear from someone who breaks up a 40-year marriage to marry a 65-year-old man," said Banerjee, who had a public spat in the Lok Sabha with Moitra in April.

Three people reportedly affiliated with the Trinamool Chhatra Parishad, the TMC's student wing, have been arrested in connection with the alleged rape in a Kolkata law college on June 25. After the incident came to light, the TMC held a press conference, vowing to ensure "exemplary punishment" for the culprits. However, the TMC's stance was quickly challenged by comments made by Banerjee and Mitra. Banerjee stirred controversy by stating, "If a classmate rapes a classmate, who will provide security?" He clarified that he wanted to say the impossibility of police ensuring safety inside colleges.Mitra, the Kamarhati MLA, further inflamed the situation with victim-blaming remarks. On Saturday, he told mediapersons, "If that girl had not gone there, this incident would not have happened. If she had told someone when she went, if she had taken her two girlfriends, if she had taken her parents, then this would not have happened. The accused took advantage of the situation."In a post on X, the TMC stated, "The party unequivocally disassociates itself from their statements and strongly condemns the same. These views do not reflect the position of the party in any manner whatsoever. Our stance remains resolute; we have zero tolerance for crimes against women and demand the strictest possible punishment for all those involved in this heinous crime." Moitra publicly criticised Banerjee and Mitra, indirectly labelling them "misogynists". gress vice-president and OBC leader Hirabhai Jotva and his sarpanch son Digvijay in connection with the alleged Rs 7.3 crore MGNREGA scam.A native of Supasi village of Gir Somanth district, 58-year-old Jotva is seen as one of the most popular faces of the Congress in Saurashtra. A farmer by profession, with a degree in Arts from Saurashtra University, Jotva also owns various businesses like transport, animal husbandry, petrol pump and has also dabbled in construction.

Claiming that Jotva's opinion on candidate selection "was always sought by the party's state and central leadership", Junagadh district Congress chief and Jotva's close aide Bharatbhai Hirpara said, "We have been friends since our childhood days. Jotva's father Arjanbhai was also a Congress worker. Jotva began his political career as a sarpanch and went on to win the taluka panchayat and district panchayat elections. He has also served as the Leader of the Opposition in the Junagadh district panchayat." Jotva also unsuccessfully contested the Keshod Assembly seat in the 2022 polls and the Junagadh Lok Sabha seat last year. Digvijay, on the other hand, won the sarpanch polls from Supasi village in Gir Somnath, a post once held by Jotva, just last week. Sources close to the Jotva family said that both Digvijay and his elder brother Abhay completed their studies in London. Dijvijay returned to India only a couple of years ago and joined the family business of public development works. Abhay is also a Congress leader and is currently the Leader of the Opposition in the Gir Somnath district panchayat. "After I completed my studies, I told my father that I wanted to return and join politics. He told me it was very difficult and warned me of legal challenges and said I might even have to go to jail. I told him I was prepared for everything... I am sure my father and brother will come out clean," said Abhay, adding that party workers have approached him, offering their help.Jotva and Digvijay duo are

alleged to be sleeping partners in Jalaram Enterprise and Murlidhar Enterprise, the firms that bagged contracts under the MGNREGA scheme to undertake works in Bharuch, and are accused of direct involvement in the irregularities that are currently being probed.

According to the FIR, between 2021 and 2025, both enterprises secured contracts for road construction and other works across 56 villages of three talukas - Jambusar, Amod and Hansot. The police allege that most of these works were not complete, while poor quality material was used in others. The police said that around 250 people were guestioned and 500 bank accounts were checked before arresting the duo.State Congress spokesperson Manish Doshi said Jothva was a very respectable leader. "He was facing considerable pressure from the Aam Aadmi Party (AAP) and BJP during the recent Visavadar bypoll. BJP MP Mansukh Vasava has alleged the involvement of government officials as well as political leaders in it. The BJP top brass in Bharuch is involved in the scam. After the arrest of Khabad's sons, the police have changed the direction of the probe by targeting Congress leaders. The true nature of the scam will be revealed only if there is a free and fair investigation. We have demanded the setting up of an SIT," he said.

'Tilak took his last breath in my arms': Delhi cop bids farewell to beloved stallion on his 31st birthday

On the morning of June 14, Constable Atul received a call from a colleague at Delhi's Mounted Police Unit. His seven-year-old stallion, Tilak - who had won a medal at a national sports meet earlier this year - was unwell.Atul, who was at home at the time, rushed to the unit - and found Tilak in pain, kicking his legs. These were signs of an abdominal condition called colic, usually caused by problems in the gastrointestinal tract. Atul and other officials from the unit rushed Tilak to a veterinary hospital near Tis Hazari Court for immediate medical attention. The next day, following an initial round of treatment, doctors referred the stallion to the District Veterinary Hospital in Hisar. Tilak underwent surgery there, but did not survive. It was in the early hours of Tuesday (June 17) when Tilak took his last breath. The doctors had asked me to help him walk a few steps, but he soon collapsed. A few minutes later, the doctors said Tilak was dead," Atul told Tilak was one of the most active horses in the Delhi Police and was always eager to play sports, according to Atul. "His nickname was Rocket. He ran very fast and was always excited to play jumping games."In December 2021, Tilak was brought from the Remount and Veterinary Corps (RVC) farm of the Indian Army in Hempur. He was just a four-year-old, then. "He was purchased for Rs 6 lakh, along with a group of 15 horses, from the Army," an officer at the unit said. Following training and practice sessions, Tilak was assigned to sports activities, the officer said. He added that the horses in the Mounted Police unit are often used for ceremonial duties, patrolling, and even sporting events. Tilak had won a silver medal in the All India Police Equestrian Championship and Mounted Police Duty Meet 2024-25 held this March in Panchkula, Haryana. "Tilak successfully qualified in the 'Police Horse Test' category, where he crossed six jump hurdles, a water pond, and a crowd of people and vehicles.

This is considered one of the most difficult tests for a horse to pass," another officer said.With Tilak's death, the number of horses in the Mounted Unit has dropped to 24; the sanctioned strength of the unit is 95. The horses are lodged in the stable yard at the Provisioning and Logistics unit in North Delhi's Civil Lines. They are looked after by 50 staff members, including riders ranging from constables to subinspectors. The horses retire upon reaching the official retirement age of 16. They are then handed over to NGOs for further care. Tilak's post-mortem was conducted at the veterinary hospital in Hisar, and the report is awaited. According to a veterinary doctor, colic is a very common condition in horses. It occurs when the animal overeats and is unable to digest the food properly. Sometimes, food or other indigestible material get stuck in the intestines, which can also lead to colic. "In these conditions, the horse's behaviour changes, and it often starts kicking its legs," the doctor said.

'Forced to downsize': Once hubs for live performances, Gurgaon's BYOB venues hit by new restrictions

"While we are being forced to downsize without being heard, other states are looking at Gurgaon's Bring Your Own Booze (BYOB) joints as an example. Every year, there are new restrictions," complains Gaurav Katyal (31), proprietor, Ebowla, Sector 30. After new restrictions kicked in earlier this month, Gurgaon's BYOB joints like Ebowla – once thriving hubs for live performances and hotspots to have alcohol at prices that are not marked up — have become shadows of their former selves.Referred colloquially as 'ahatas' and as 'taverns' in the excise policy, these joints have been restricted from hosting live events and musical performances. In the new Haryana excise policy, which came into effect on June 12, the licensing fee has also been increased, and the joints cannot expand beyond one floor they have to operate within a 1,000 square metre area.

Not just Katyal, many proprietors across the city are upset. Ebowla, he says, had to reduce its operational area by half, shut down its first floor, and pay Rs 1.8 crore as a licence fee to operate its BYOB unit. For its adjoining liquor store, it had to pay Rs 45 crore as license fees for 21.5 months. Its stage, including a space for the DJ, is now defunct.gurgaon byob Notices from the Excise Department on unpaid dues and pending rent under the previous policy have been pasted at the premises of several joints — Machan in Sector 29, Dakotta in Sector 32, and Where Else in Sector 59.

"We would recover a significant amount of the hefty liquor store license fees through BYOBs. We would have (local) celebrities and dancers perform here to draw crowds. That's no longer the case. With the rise in expenses, our planned expansions in the city are on hold," Katyal adds.According to him, new players would now be apprehensive of entering the sector. "Even we are only in this business because we have a reputation of being solid players in this space. Varna ab kya rakha hain? (Otherwise, what is left now?)," he asks. The scene is no different for such joints at Golf Course Extension Road. "Fifty workers at my joint lost their jobs, and their families are now suffering. If I cannot have music and you're increasing taxes, who will come anymore to even my joint?" says an owner on condition of anonymity. The state government, he adds, has ignored the middle segment of consumers. "Can everyone afford to go to bars and restaurants to drink, with their marked-up prices? Ultimately, it will cause losses to the government in terms of revenue," he says. Notices from the Excise Department on unpaid dues and pending rent under the previous policy have been pasted at the premises of several joints - Machan in Sector 29, Dakotta in Sector 32, and Where Else in Sector 59. "We have been closed since June 11. Things are uncertain. Ab license renew hone ka koi aasha bhi nahi hain (now there is little hope of securing a new license)," says a staff member at Where Else.Amit Bhatia, Deputy Excise and Taxation Commissioner (DETC), Gurugram East, tells The Indian Express that it is common for time to be taken for the renewal of licences and agreements between policies. "The agreements between the liquor store operators and proprietors of taverns take time. Some initial losses and a drop in business with any rise in taxes is natural. Projected excise collections are on course, it is still early days to look too far ahead," Bhatia says. Jitender Dudi, DETC for Gurugram West, says a clearer picture of the revenue impact can be known only once the auctions for vends in the 37 zones remaining are complete. "These places were unregulated. We had got representations from restaurant associations about their business being impacted," he says.

3 'drunk' men pose as Delhi cops, rob bike to experience thrill; arrested

Three men staged a heist in the national capital on Thursday by posing as Delhi Police personnel to allegedly seek a thrill. The police said the trio took away a security guard's bike near Aerocity, claiming that he was driving rashly.The three accused, Garvit Sharma, 25, Aniket Singh, and Prashanth Kumar, were arrested in different parts of Delhi on Friday. The victim, Amarpal Singh, 47, an Etah native and a security guard with GMR RAXA at Worldmark II in Aerocity, made a PCR call around 7.30 pm on Thursday.

"The complainant stated on June 26, 2025, around 7.10 pm, while he was on his way to Aerocity riding his Splendor, he was stopped near the Mahipalpur underpass by three individuals on another motorcycle. These individuals falsely claimed to be police officers and accused him of rash driving," Usha Rangnani, Additional Commissioner of Police (ACP), Indira Gandhi International, said. One of the accused reportedly snatched the key to Amarpal Singh's Splendor bike and hurled abuses at him when he asked the three to show some ID. Aniket Singh then slapped Amarpal Singh as Prashanth Kumar rode away on his bike. The other two, Garvit Sharma and Aniket Singh, followed Prashanth Kumar on the black bike that they arrived on."During the course of the investigation, all available CCTV cameras at and around the scene of the incident were meticulously examined. Three specialised teams were constituted under the leadership of Inspector Sumit, Inspector Satish, and Inspector Avdesh, and an analysis of approximately 250 to 300 CCTV cameras spread across the possible routes of the accused was done," Rangnani said. The police said that CCTV footage



revealed the registration number of the bike on which the robbers came. The bike was found to be registered in the name of a man named Siddharth, a resident of Shakarpur. Siddharth, during the investigation, revealed that he lent his bike about a year ago to his friend, Garvit Sharma. The police raided Sharma's house, but found that he was missing.Based on intelligence, Sharma was finally tracked at his hideout in Palam. Thereafter, Aniket Singh was arrested in Kishangarh, while Prashanth Kumar was nabbed in Dashrath Puri."Garvit and Prashant travelled to Kishangarh on Garvit's motorcycle on June 26 (Thursday). There, they called Aniket, and the three friends decided to consume alcohol together. As per their plan, they purchased a bottle of liquor from a nearby shop and consumed it in a

Southwest monsoon covers the entire country early, but reaches Delhi late

The southwest monsoon covered the entire country on Sunday (June 29), significantly ahead of its normal schedule of July 8. However, in Delhi, its arrival was slightly delayed from the usual onset date of June 27.Last year, the monsoon reached the national capital on June 28, while in 2022 it arrived earlier, on June 25.In recent days, Delhi has witnessed a steady influx of moisture-laden southeasterly winds, which enhanced cloud cover and brought scattered to fairly widespread rainfall across the region.According to the India Meteorological Department (IMD), there have been only a few instances since 1960 when the monsoon has advanced over both Delhi and the entire country on the same day. One such occurrence was on July 2, 1967. Most such instances have taken place in July – in 1968, 1987, 1990, 2003, and 2011. Only once before, in 2013, did the monsoon cover Delhi and the entire country simultaneously in the month of June – on the 16th.

southwest monsoon According to the India Meteorological Department (IMD), there have been only a few instances since 1960 when the monsoon has advanced over both Delhi and the entire country on the same day. Earlier, IMD officials had attributed the delayed arrival over Delhi, despite persistent cloud cover, to an anticyclonic circulation that was temporarily obstructing the monsoon's advance. They noted that the system would weaken soon, allowing the monsoon to progress. Till Saturday, the Northern Limit of Monsoon passed through Jaisalmer, Bikaner, Jhunjhunu, Bharatpur, Rampur, Sonipat, and Anup Nagar, as per the IMD. The Met office has issued a yellow alert for Monday, forecasting light to moderate rain or thunderstorms accompanied by lightning in Delhi and surrounding areas. No alerts have been issued for the subsequent days, but rainfall is still expected. Daytime temperatures are likely to fall and remain between 26 and 31 degree Celsius through the week. In its extended range forecast valid up to July 10, the IMD has predicted above-normal rainfall in Delhi. The normal rainfall for the month is 209.7 mm. Between July 3 and 10, the department stated, "The monsoon trough is likely to be active and near its normal position during most days of the week. As a result, fairly widespread to widespread rainfall with isolated heavy falls is likely over many parts of northwest India.

'Jahan jhuggi, wahan maidan': Arvind Kejriwal targets PM Modi at Jantar Mantar protest against demolitions

The protest saw sharp attacks on both the BJP and the Congress, with the AAP convener accusing the government of betraying Delhi's poor.Addressing the crowd, Kejriwal said, "It's only been five months since they formed the government, and already the situation in Delhi has deteriorated so badly that people have had to gather here today."Referring to a video he had released before the elections, Kejriwal claimed he had warned of mass evictions. "I had said they would demolish jhuggis within a year if they came to power-I didn't think they'd do it in just five months,' he said. The former chief minister lashed out at the ongoing demolitions amid Delhi's sweltering summer. "It's 50 degrees right now. In this heat, they are tearing down homes and leaving people out on the streets," he said. Taking a swipe at Prime Minister Narendra Modi, Kejriwal referred to the BJP's slogan "Jahan jhuggi, wahan makaan" and rephrased it as "Jahan jhuggi, wahan maidan". "Modiji had appealed for your votes with promises of housing. But look at what he meant - not homes, just empty grounds."Kejriwal also mocked the BJP's pre-election outreach to slum-dwellers. "Remember their Jhuggi Ratri Pravas Abhiyan ? Their leaders came to your homes, ate with you, played carroms with your children. And today, those are the very homes they are destroying," he said."The day 40 lakh people come out on the streets, Delhi's jhuggis will be saved," he said, urging those who had gathered to continue their mobilisation. The AAP chief also warned the Congress, whose 15-year reign in Delhi ended with the rise of the AAP after the 2011 anti-corruption movement. "This is the same Jantar Mantar where the Congress was removed from power. If you (BJP) don't stop now, your government won't last more than three years." After loosing the Delhi elections to the BJP, the AAP feared its vote basethe Dalits and minorities-will move back to the Congress, parties they used to vote for before Kejriwal rose to power.Comparing the BJP to the Congress, he said, "Both

Landlord model helped Jawaharlal Nehru Port achieve container handling milestone: JNPA Chairman Unmesh Sharad Wagh

The Jawaharlal Nehru Port Authority (JNPA) in Navi Mumbai has become the first port in India to cross 10 million twenty-foot equivalent unit (TEU) container handling capacity following the completion of its latest expansion phase. With five container terminals now offering a combined capacity of 10.4 million TEUs, the Jawaharlal Nehru Port continues to handle over half of container traffic of India.In an interview with The Indian Express, JNPA Chairman Unmesh Sharad Wagh, who is also leading the upcoming Vadhavan Port project in Palghar, shares insights on expansion, logistics and sustainability of the two ports in Maharashtra.

Q: Recently the Jawaharlal Nehru Port achieved a milestone of 10 million TEUs handling capacity. What factors contributed to this achievement?

Unmesh Sharad Wagh: JNPA is mainly a container port operating under the landlord model, where we have roped in private companies to operate under a concession agreement. For this, we have assigned terminals to all global bigger players, which has taken the capacity till 10.4 million TEUs–the largest in all ports in India. Last year we handled a cargo of about 7.3 million TEUs, so assuming 20 per cent growth by the end of this year, our estimation is to reach about 9 million TEUs. So this model of operation has largely contributed.

Q: How does road or highway connectivity play a role here? Are we looking at any expansion of capacity further?

Unmesh Sharad Wagh: For a port, three things are important–marine efficiency, execution efficiency, and evacuation to the hinterland. So if we talk about the evacuation to the hinterland, then connectivity is the key. With an eight-lane highway connectivity, the evacuation, which initially was 2-4 kmph, has now increased to 40-50 kmph. Moreover, JNPA has simplified all the processes involved to reduce the cost and time of doing business and promote the ease of doing business, making it 20-25 per cent cheaper for businesses. And for expansion, there is little scope at JNPA. However, we have the upcoming Vadhavan Port.

Q: Talking about Vadhavan, what is the current status of the Vadhavan project as you are overseeing it as well?

Unmesh Sharad Wagh: The construction work on the Vadhavan Port is going on. Land acquisition for the approach

road has been done and the 3D notification from NHAI (National Highway Authority of India) is in process. We are also constructing a service road dedicated to the making of Vadhavan. This road, after serving its purpose for the port, will be like a present from JNPA for the villagers near the port for their access to the port.

Q: There has been resistance by the villagers and locals. How are you dealing with that?

Unmesh Sharad Wagh: There are about 24 villages in the vicinity, but only a few problematic people show resistance even after their demands are considered. Practically, no one is affected in the region. For the people in the influential area the project will only bring many benefits. One of them is a skilling programme for the local youth where we have targeted producing 5,000 sea fares through a collaboration with ITIs. Besides, we are also providing agriculture training for them through Dapoli Agricultural University and the skill development centre at Sahyadri Farms, Nashik. In fact, the only segment that can be seen affected by the port are the fishermen, but they are very positive towards the making of the port. And we have ensured to give them fair compensation and many benefits like loan subsidies through JNPA's corporate social responsibility initiatives.

Q: How would the cargo distribution be once the Vadhavan Port begins operations? Any plans to bring in transshipment like at the Vizhinjam port?

Unmesh Sharad Wagh: Cargo distribution will eventually happen even though it's far from sight now. Vadhavan will take care of all the north-bound cargo while JNPT will cater to the hinterland operations. And for transshipment, Vizhinjam is only a transshipment port, while ours is a getaway port with only 1 per cent transshipment capacity. Currently, around 25 per cent of the cargo from India is transshipped and 20 per cent is from the western side. With Vadhavan coming on the western seafront, 100 per cent of this cargo will come to the new port. So we will ensure there is a balance of all the operations amongst both the ports.

Q: What are your plans to make both the ports sustainable and automated–measures already in place at the Jawaharlal Nehru Port and plans for Vadhavan?

Unmesh Sharad Wagh: Sustainability is always at the centre of our port operations. The port already runs on 60 per cent renewable, green energy, which we are planning to take up to 100 per cent.

Kolkata law college rape case: CCTV footage corroborates victim's account, SIT expanded to 9 members

Police sources revealed that more than seven and a half hours of CCTV footage from the college's external gate and premises have been collected and meticulously examined.Police sources revealed that more than seven and a half hours of CCTV footage from the college's external gate and premises have been collected and meticulously examined.

The Special Investigation Team (SIT) probing the Kolkata law college rape case has been expanded from five to nine members to expedite the investigation, police officers confirmed Sunday. The move comes as investigators make significant progress, with collected CCTV footage reportedly corroborating the statement of the first-year student of the law college who was allegedly raped on June 25 in the security guard's room on the campus.Police sources revealed that more than seven and a half hours of CCTV footage from the college's external gate and premises have been collected and meticulously examined. "Yes, the CCTV footage... also corroborates the victim's statement,' a senior police officer, speaking on condition of anonymity, told The Indian Express, specifically referring to the complainant's claim that she was prevented from leaving the college.So far, four people have been arrested in connection with the alleged rape: a contractual staffer and former student of the college, Monojit Mishra, 31; and two students, Zaib Ahmed, 19, and Pramit Mukherjee, 20; and a security guard of the college, Pinaki Banerjee. All four arrested were visible in the CCTV footage obtained by the police from the day of the alleged rape, confirming their presence at the scene, as per the police. The SIT has already applied for the confidential statements of the survivor and her parents.

Bidisha Kalita, Deputy Commissioner of Police, Jadavpur Division, Kolkata, along with Pradeep Kumar Ghoshal, Assistant Commissioner of Police (South Suburbs), who leads the SIT, visited the crime scene on Sunday and began an examination. Investigators have compiled a list of all those who visited the college on June 25, based on CCTV footage and witness statements. All those on this list will be questioned, with some already summoned by the police. The survivor's parents are also expected to record their confidential statements before a magistrate. A crucial development in the investigation was the reconstruction of the crime scene on Saturday for over two hours in the presence of the survivor.

Rainfall deficit hampers Telangana Kharif sowing; paddy output under threat

Hyderabad: Telangana's Kharif sowing has suffered a setback this year, with only 29.9 lakh acres cultivated by the end of June, significantly lower than the 35.93 lakh acres sown during the same period last year. The drop is largely attributed to a 42 per cent rainfall deficit, with the State recording just 56.3 mm of rain against the normal seasonal average of 97.06 mm. The scanty rainfall, combined with dipping reservoir levels and soaring temperatures, has slowed sowing and transplantation activities, especially for paddy, a crucial crop for Telangana. The normal Kharif sown area in the State stands at 132.44 lakh acres, with a target of 152 lakh acres set for 2025, including 66 lakh acres for paddy.As of mid-June, sowing covered 19.16 lakh acres, marginally higher than the expected 19.14 lakh acres but well below last year's 25.27 lakh acres at this time. Cotton led the way with 15.26 lakh acres, followed by soybean (1.04 lakh acres), red gram (50,574 acres), maize (48,766 acres), and paddy (36,300 acres). While the Agriculture Department remains optimistic that sowing will pick up in July if monsoon conditions improve, the outlook remains cautious for now. The challenges are particularly stark for paddy farmers. Telangana achieved a record 153 lakh metric tonnes (LMT) of paddy in Kharif 2024,



US Supreme Court upholds childproofing porn sites



Washington: The US Supreme Court handed down a decision on June 27, 2025, that will reshape how States protect children online. In a case assessing a Texas law requiring age verification to access porn sites, the court created a new legal path that makes it easier for States to craft laws regulating what kids see and do on the internet.In a 6-3 decision, the court ruled in Free Speech Coalition Inc. v. Paxton that Texas' law obligating porn sites to block access to underage users is constitutional. The law requires pornographic websites to verify users' ages – for example by making users scan and upload their driver's license – before granting access to content that is deemed obscene for minors but not adults.

The majority on the court rejected both the porn industry's argument for strict scrutiny - the toughest legal test that requires the government to prove a law is absolutely necessary - and Texas' argument for mere rational basis review, which requires only a rational connection between the law's legitimate aims and its actions.Instead, Justice Clarence Thomas' opinion established intermediate scrutiny, a middle ground that requires laws to serve important government interests without being overly burdensome, as the appropriate standard. The court's reasoning hinged on characterizing the law as only "incidentally' burdening adults' First Amendment rights. Since minors have no constitutional right to access pornography, the state can require age verification to prevent that unprotected activity. Any burden on adults is, according to the ruling, merely a side effect of this legitimate regulation. The court also pointed to dramatic technological changes since earlier similar laws were struck down in the 1990s and early 2000s. Back then, only 2 in 5 households had internet access, mostly through slow dial-up connections on desktop computers.Today, 95 per cent of teens carry smartphones with constant internet access to massive libraries of content. Porn site Pornhub alone published over 150 years of new material in 2019. The court argued that earlier decisions "could not have conceived of these developments,' making age verification more necessary than judges could have imagined decades ago. More importantly for future legislation, the court embraced an "ordinary and appropriate means" doctrine: When states have authority to govern an area, they may use traditional methods to exercise that power. Since age verification is common for alcohol and tobacco, tattoos and piercings, firearms, driver's licenses and voting, the court held that it's similarly appropriate for regulating minors' access to sexual content. The key takeaway: When States are trying to keep kids away from certain types of content that kids have no legal right to see anyway, requiring age verification is an ordinary and appropriate way to enforce that boundary. This decision could resolve a fundamental enforcement problem in child privacy laws. Current laws like the Children's Online Privacy Protection Act protect children only when companies have actual knowledge a user is under 13. But platforms routinely

avoid this requirement by not asking users' ages or letting them enter whatever age they want. Without age verification, there's no actual knowledge and thus no privacy protections.

The Supreme Court's reasoning changes this dynamic. Since the court emphasized that children lack the same constitutional rights as adults regarding certain protections, states may now be able to require age verification before data collection. California's Age-Appropriate Design Code and similar state privacy laws would gain substantially more regulatory power under this framework.Meanwhile, social media platforms could face more restrictions. Several states have tried to limit how social media platforms interact with minors. Florida recently banned kids under 14 from having social media accounts entirely, while other states have targeted specific features such as endless scrolling or push notifications designed to keep kids hooked.

The Supreme Court's reasoning could protect laws that require age verification before kids can use certain platform features, such as direct messaging with strangers or livestreaming. However, laws that try to block kids from seeing general social media content would still face tough legal challenges, since that content is typically protected speech for everyone. The decision also supports state laws regulating how minors interact with app stores and gaming platforms. Minors generally can't enter binding contracts without parental consent in the physical world, so states could require the same online. Proposed legislation such as the App Store Accountability Act would require parental approval before kids can download apps or agree to terms of service. States have also considered restrictions on "loot boxes" – digital gambling-like features – and surprise inapp purchases that can result in massive charges to parents. Since States already require an ID to buy lottery tickets or enter casinos, requiring age verification before kids can spend money on digital gambling mechanics follows the court's logic. But this decision doesn't give states free rein to regulate the internet. The court's reasoning applies to content that children have no legal right to access in the first place, specifically sexually explicit material. For most online content such as news, educational materials, general entertainment and political discussions, both adults and kids have constitutional rights to access

Laws trying to age-gate this protected content would still likely face the strict scrutiny's standard and be struck down, but what online content and experiences underage users are constitutionally entitled to is not settled.Many advocates worry that while the "obscene for minors" standard in this case appears legally narrow, states will try to expand it or use similar reasoning to classify LGBTQ+-related educational content, health resources or community support materials as inherently sexual and inappropriate for minors.

The court also emphasized that even under this more permissive standard, laws still have to be reasonable. Age verification requirements that are overly burdensome, sweep too broadly or create serious privacy problems could still be ruled unconstitutional. The court's decision in this case gives state lawmakers much more room to effectively regulate how online platforms interact with children, but I believe successful laws will need to be carefully written. For parents worried about their kids' online safety, this could mean more tools and protections. For tech companies, it likely means more compliance requirements and age verification systems. And for the broader internet, it represents a significant shift toward treating online spaces more like physical ones, where people have long accepted that some doors require showing ID to enter.



The story so far:At least seven West Bengal residents who were pushed to Bangladesh by the Border Security Force (BSF) on suspicion of being Bangladeshis were brought back to India after the intervention of the State government. Chief Minister Mamata Banerjee said on June 25 that residents speaking in their native Bengali language are being branded as Bangladeshis in some Bharatiya Janata Party (BJP)-ruled States. Several people who were pushed from Assam to Bangladesh also returned as they were found to be Indians or that their citizenship cases were sub-judice.

Why have matters escalated?

After the regime change in Bangladesh in August 2024, the police across the country were asked by the Union Home Ministry to detect Bangladeshis who had illegally entered the country and were living here on forged documents. The drive assumed momentum after the Pahalgam terror attack in April and the subsequent 'Operation Sindoor'. The Ministry has issued instructions to States to deport undocumented migrants but in most cases pushbacks are happening. Around 2,500 suspected Bangladeshis have been pushed back so far. On May 10, Assam Chief Minister Himanta Biswa Sarma said that the government has decided to implement the "pushback" mechanism to check infiltration instead of going through the legal route which is a long-drawn process. Home Minister Amit Shah has asked top intelligence officials to make an example of "infiltrators' by detecting, detaining, and deporting them. In 2022, at an Intelligence Bureau meeting, Mr. Shah had asked officials to identify around 100 illegal migrants in each State, check documents and arrest and deport them. He asked them to continue with the crackdown even if neighbouring countries do not accept the undocumented migrants.

What is the difference between deportation and pushback?

Deportation is a legal process which involves detaining and arresting a foreigner suspected to be living in India without documents or who has entered the country illegally. The case is presented before a court and after exhaustion of all legal avenues, which includes conviction by the court, the country which the foreigner belongs to is contacted and the deportation takes places once the identity is confirmed. Pushbacks are not a legal procedure and there are no stated rules. They happen when a foreigner has been caught by the border security force on the international border and, depending on the intensity of the case or the discretion of the border personnel, they are either arrested, made to face the law here or pushed back. Since citizenship and foreigners are Union List subjects, it is the Home Ministry which delegates powers to deport foreigners to State governments. In 2024, the Ministry told the Jharkhand High Court that since the "Central Government does not maintain a separate federal police force exclusively dedicated to the task of detection and deportation of illegally staying foreigners, action in this regard has been entrusted to the State police.

What is the Immigrants (Expulsion from Assam) Act,

What are the issues around

deportation? | Explained

On June 9, Assam Chief Minister Himanta Biswa Sarma said the State government was likely to enforce a 1950 law to identify and evict illegal foreigners, adding that under the law, district commissioners are empowered to declare individuals as illegal immigrants and initiate eviction proceedings. The 1950 Act was passed by Parliament amid communal disturbance and violence following the Partition of India in 1947 and creation of East Pakistan (now Bangladesh) bordering West Bengal, Assam, Meghalaya, Tripura and Mizoram. The Act says that "it extends to the whole of India", but has Assam-specific provisions. Section 2 of the Act says that if the Union government is of the opinion that any person or class of persons, having been ordinarily resident in any place outside India are detrimental to the interests of the general public of India or any Scheduled Tribe in Assam, the Union government may by order, "direct such person or class of persons to remove himself or themselves from India or Assam within such time and by such route as may be specified in the order"; and "give such further directions in regard to his or their removal from India or Assam as it may consider necessary or expedient".

What are the laws for foreigners?

Till April this year, matters relating to foreigners and immigration were administered through "pre-Constitution period" laws enacted during the First and Second World Wars, which were the Foreigners Act, 1946, Passport (Entry into India) Act, 1920, the Registration of Foreigners Act, 1939 and the Immigration (Carriers' Liability) Act, 2000. In April, Parliament enacted the Immigration and Foreigners Act, 2025 repealing the old laws.

Unlike Pakistan and Bangladesh borders, the rules for movement of people along Nepal and Myanmar are different. Nepal has a free-border agreement with India, and a Free Movement regime (FMR), allowing movement of people residing within 10-km on either side, exists along the India-Myanmar border. Following the May 2023 ethnic violence in Manipur, the Ministry in 2024 decided to fence the entire 1.643-km Mvanmar border in the next 10 years. Post the military coup in Myanmar in February 2021, over 40,000 refugees from Myanmar belonging to the Chin ethnic group who are closely related to the Mizo community crossed over to Mizoram. On March 10, 2021, the MHA sent a letter to the State governments of Nagaland, Arunachal Pradesh, Manipur and Mizoram that the refugees should be identified and deported and that the State Governments have no powers to grant "refugee" status to any foreigner as India is not a signatory to the UN Refugee Convention of 1951 and its 1967 Protocol. The refugees continue to live here.

What is behind this recent drive?

Since the April 22 terror attack at Pahalgam, the police has intensified the drive to detect undocumented migrants. Initially, they were taken by trains to border districts and then pushed to Bangladesh by the BSF. In some instances, migrants after being up picked from Rajasthan, Gujarat, and Maharashtra, were flown by planes to Agartala in Tripura and transported to the Bangladesh border by BSF personnel. The police and the BSF record biometrics and photographs of the undocumented migrants. It is to be noted that the BSF has never acknowledged any of the pushbacks. The Ministry has asked the States to verify the claims of undocumented migrants who claim Indian nationality after which District Magistrates are to send a report within 30 days, failing which the Foreigners Regional Registration Officer would deport them. In 2022, the Unique Identification Authority of India was asked to maintain a "negative list" to stop undocumented migrants from procuring identity documents in the future.

Weddings, interrupted

As men arrange themselves comfortably on a charpoy, Munnish Devi, 50, finds herself a spot on the mud floor of her three-room house at Bhureka village in Uttar Pradesh's Mathura district. Devi, whose husband passed away a few years ago, has four daughters. One of them is Kalpana, 20, who married Akash, 21, in May this year. The only memory Devi has from the wedding is a blood-stained pair of white pyjamas, which she has kept in a stainless steel trunk. It's a reminder of the day a celebration turned violent.

Akash, a member of the Dalit community, was dragged off the chariot he was riding joyously to his bride's house. Many wedding guests were allegedly assaulted by a group of men from the Jat community because members of the Dalit community had organised a wedding procession.In Uttar Pradesh, numerous cases have been reported where Dalit families have faced violence from upper caste communities for organising wedding ceremonies in smaller towns and villages. As many as 15,368 cases of atrocities against Scheduled Castes and five against Scheduled Tribes were registered in the State in 2022, as per the National Crime Records Bureau data. There is no separate data on atrocities against Dalits during celebrations. Every month though, there are incidents of Dalit wedding processions being attacked in the State. On June 21, Arti Kumari, 19, and Vikas Singh, 21, were getting married in Etah district's Dhakpura village. When their baraat reached a Raiput-dominant settlement, they allegedly faced threats and stones were pelted. The wedding ultimately took place under police protection. In Bhureka, where mud houses dot green fields, people primarily engage in farming. Despite being located just off the Yamuna Expressway — the 165km, high-speed road that connects Noida with Agra people in the village have a slow life.

Inside Devi's barely constructed house, open from all sides, men discuss the heatwave. Kalpana's cousin, Anil Kumar, 25, shows videos of the wedding day. He explains how, on May 22, a group of people allegedly from the Jat community in the neighbouring village disrupted the wedding procession. They were upset with the DJ plaving music and Akash riding a chariot, he says. "They hurled casteist abuses and attacked our baraatis (members of the bridegroom's procession). It was shameful. We were all so excited about the wedding. Akash's family had come from Aligarh. When the men started threatening our baraatis, we called the police," Anil says. After the police arrived at the marriage hall, barely a few kilometres away, the couple completed their pheras (seven rounds around the fire) at midnight. The next day at 8 a.m., Anil says, the same group, and 20-25 others, returned to the house, holding weapons. They tore the baraatis' clothes, hit them, and damaged the tent and everything in the vicinity. They hurled casteist abuses and insulted the women and children, he says."We couldn't sit there and see our guests being insulted, so we retaliated, and many of us, including the elderly, got hurt. Look at our stained pyjamas," he says, pointing to a video of the incident. "These were brand new, and now, this is the

only memory we hold." Anil looks away as other family members show their wounds. An FIR has been registered at the Naujheel police station against 20-25 people for rioting, house trespassing, and criminal intimidation under sections of the Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989.

Circle Officer (Mant) Gunjan Singh says six persons from the village have been arrested in connection with the incident. "The allegation that the baraat was stopped is false. Our investigation did not reveal it. The argument took place only because the DJ played loud music at night," he says, adding that only three persons asked for the volume to be turned down.

During the 'bidai (giving away of the bride)', Kalpana's family was at the police station, waiting to give their statements. "The last thing I could have given my daughter was a peaceful goodbye; even that wasn't allowed," Devi adds.

Kalpana studied till Class 8; Akash works as a carpenter. The family felt that their daughter would have a better life in a city. Many young women in the village marry in that hope. Not many have access to higher education. A marriage that will take women to a city is seen as a way out of both poverty and suppression.

Soon after the incident, which was reported across newspapers, Ram Khiladi, 60, a resident of Bhureka village, says his daughter's 'rishta (match)' from Palwal in Rajasthan seems to have fallen through. "The family has stopped responding. They said they wouldn't send their baraat to our village because they would get attacked. This is what the attack has done to our people," he says. While the 'pradhan (village head)' is usually the first to respond to local matters, villagers say it depends a lot on which community they are from and which community is at the receiving end. In Bhureka, the pradhan, Bhuvnesh Sharma, hails from the Brahmin community, and he did not offer any support, they say. Sharma says he did. "I even met the family," he says, though he does not give details of what they spoke about. Sushil Gautam, a Dalit rights activist, who has been working on ground for more than 20 years, believes that even though times are changing, "issues still persist". He talks about how the traditional system of marriage has evolved in the Dalit community over the past few years. "With access to social media and education, people from the Dalit community have understood what the term 'resistance' means. It is about creating a safe space for ourselves and accessing rights, be it marriage, education, or something as small as keeping a moustache," he explains.Gautam says even during wedding ceremonies, photographs of Dalit icons such as Dr. B.R. Ambedkar, Ravidas, and Jyotibha Phule take centre stage. "In several instances, when a Dalit wears bright colours, like yellow or green, casteist slurs are hurled at them." This behaviour was endorsed by the caste system for centuries to make the so-called lowest castes unseen and unheard, he says. "Now, people from the Dalit community dress up and the women wear the bridal red. Nobody can take that away from us," he says.

Where does India lag in

The story so far:India dropped two places in the World Economic Forum's Global Gender Gap Index for 2025, slipping to the 131st rank out of 148 countries. While the gender gap has narrowed or remained stable in the case of three categories — economic participation and opportunity; educational attainment; health and survival — it has worsened in the case of political empowerment. At a time when rising numbers of women are voting in elections, the number of women in the highest halls of power remain stubbornly low. This is set to change in 2029, when mandatory 33% reservation for women in State and national legislatures is set to kick in, but steps need to be taken to ensure the benefits of this law extend to the long term.

What led to the drop?

The Index uses three indicators to assess political empowerment, with India falling in two — the percentage of women in Parliament, which dropped from 14.7% (78 MPs) in 2024 to 13.79% (74 MPs) in 2025 after the general election for the 18th Lok Sabha; and the percentage of women in ministerial positions, which dropped from an already abysmal 6.45% in 2024 to just 5.56% in 2025.

What will change after women's reservation?

The legislation for 33% reservation for women in the Lok Sabha and in State legislatures was passed after a long wait in 2023, but as it is tied to a new Census and delimitation exercise, it can only be implemented from the 2029 general election at the earliest. Women's representation in the Lok Sabha has ranged from 3.4% in 1977 to 14% in 2019. At the time of the passage of the women's reserva-

tion legislation in 2023, women accounted for only 9% of MLAs in State Assemblies, with Chhattisgarh having the highest representation (18% women MLAs), while Himachal Pradesh had just one woman MLA and Mizoram had none. Jacking these figures up to at least 33% will give a significant boost to India's political empowerment scores. The catch is that reservation is only valid for 15 years from the time the law passes, meaning that it is likely to be implemented in only two general election cycles, 2029 and 2034, raising concerns about the sustainability of gains women would make in this period. Also, while more women may become MPs, it remains to be seen if ruling parties also appoint them to ministerial roles in higher numbers, increasing their representation in actual governance. Despite the three-decade old 33% reservation for women at the panchayat and municipality level, which has been increased to 50% in most States, there is no clear pipeline to draw such local leaders into State-level politics

Does the rise in women voters matter?

Back in 1952, 28 lakh women were excluded from voting in the general election as they were listed on the electoral rolls only as someone's mother or wife, with their own names missing. The gender gap among voters has narrowed speedily since then, from 17 percentage points in 1962 to less than two percentage points in 2014. In fact, in the last two general elections, women voters have actually overtaken men, though this can also be partially attributed to rising male migration for employment, leaving men unable to vote in their home States. The rising numbers of women voting has led to political parties wooing women as a votebank, with a slew of welfare schemes aimed at women, ranging from free bicycles for girls to a monthly allowance for poorer women.

How to increase women candidates?

The trend with respect to women voters, however, has not translated into an increase in women's representation. "Political parties continue to give lower representation to women candidates in so-called 'good seats', often citing a lack of winnability," says Rahul Verma, a political scientist at the Centre for Policy Research, noting that many parties field women in seats reserved for Scheduled Caste/Tribe candidates, in a bid to offset that quota."Women voters do not automatically vote for women candidates. Gender is not like caste, where voters may vote on the basis of identity. Women are much more practical, looking for actual programmatic delivery," says Tara Krishnaswamy of Political Shakti, a non-partisan group working to improve women's representation in politics. However, she dismisses parties' excuses that women candidates are not winnable. "In every general election since 1952, women candidates have had a higher winning percentage in comparison to men. The problem is that women do not make it to the candidates list... Women candidates in the lists of recognised parties average about 8% or 9%," she says.



U.S. President Donald Trump calls for deal on Gaza war as signs of progress emerge

U.S. President Donald Trump on Sunday (June 29, 2025) pleaded for progress in ceasefire talks in the war in Gaza, calling for a deal that would halt the fighting in the 20monthlong conflict as the sides appeared to be inching closer to an agreement. An Israeli official said plans were being made for Prime Minister Benjamin Netanyahu to travel to Washington, D.C., in the coming weeks, a sign there may be movement on a new deal. The official declined to discuss the focus of the visit and spoke on condition of anonymity to discuss plans that had not yet been finalized.Mr. Trump raised expectations on Friday (June 27, 2025) for a deal, saying there could be a ceasefire agreement within the next week. Taking questions from reporters, he said, "We're working on Gaza and trying to get it taken care of."Mr. Trump has repeatedly called for Israel and Hamas to end the war in Gaza. Despite an eight-week ceasefire reached just as Trump was taking office earlier this year, attempts since then to bring the sides toward a new agreement have failed.A top adviser to Mr. Netanyahu, Israeli Minister for Strategic Affairs Ron Dermer, was set to travel to Washington this week for talks on a ceasefire. Trump post slams Netanyahu corruption trial

The Gaza message wasn't the only Middle East-related post by Mr. Trump. On Saturday (June 28, 2025) evening, he doubled down on his criticism of the legal proceedings against Netanyahu, who is on trial for alleged corruption, calling it "a POLITICAL WITCH HUNT, very similar to the Witch Hunt that I was forced to endure." In the post on Truth Social, he said the trial interfered with talks on a Gaza ceasefire. "(Netanyahu) is right now in the process of negotiating a Deal with Hamas, which will include getting the Hostages back. How is it possible that the Prime Minister of Israel can be forced to sit in a Courtroom all day long, over NOTHING," Mr. Trump wrote. The post echoed similar remarks Trump made last week when he called for the trial to be cancelled. It was a dramatic interference by an international ally in the domestic affairs of a sovereign state. And it unnerved many in Israel, despite Trump's popularity in the country. Israeli military orders new evacuations in northern Gaza

The Israeli military on Sunday ordered a mass evacuation of Palestinians in large swaths of northern Gaza, an early target of the war that has been severely damaged by multiple rounds of fighting.Col Avichay Adraee, a military spokesperson, posted the order on social media. It includes multiple neighbourhoods in eastern and northern Gaza City, as well as Jabaliya refugee camp. The military will expand its escalating attacks to the city's northern section, calling for people to move southward to the Muwasi area in southern Gaza, Adraee said. After being all but emptied earlier in the war, hundreds of thousands of people are in northern Gaza following their return during a ceasefire earlier this year.An Israeli military offensive currently underway aims to move Palestinians to southern Gaza so forces can more freely operate to combat militants. Rights groups say their movement would amount to forcible transfer.

A sticking point over how the war endsThe war in Gaza began with Oct 7, 2023, attacks by Hamas in which militants killed 1,200 people and took roughly 250 hostage, about 50 of whom remain captive with less than half believed to be alive.Israel's retaliatory response has killed more than 56,000 people, according to local health authorities, who do not distinguish between militants and civilians in their count but say more than half of the dead are women and children. The war has set off a humanitarian catastrophe, displaced most of Gaza's population, often multiple times, and obliterated much of the territory's urban landscape. Talks between Israel and Hamas have repeatedly faltered over one major sticking point, whether the war should end as part of any ceasefire agreement. Hamas says it is willing to free all the hostages in exchange for a full withdrawal of Israeli troops and an end to the war. Israel rejects that offer, saying it will agree to end the war if Hamas disarms and goes into exile, something the group refuses.

After decades in the U.S., Iranians arrested in Trump's deportation drive

Mandonna "Donna" Kashanian lived in the United States for 47 years, married a U.S. citizen and raised their daughter. She was gardening in the yard of her New Orleans home when U.S. Immigration and Customs Enforcement officers handcuffed and took her away, her family said.Ms. Kashanian arrived in 1978 on a student visa and applied for asylum, fearing retaliation for her father's support of the U.S.-backed shah. She lost her bid, but she was allowed to remain with her husband and child if she checked in regularly with immigration officials, her husband and daughter said. She complied, once checking in from South Carolina during Hurricane Katrina. She is now being held at an immigration detention centre in Basile, Louisiana, while her family tries to get information.

Other Iranians are also getting arrested by immigration authorities after decades in the United States. The U.S. Department of Homeland Security won't say how many people they've arrested, but U.S. military strikes on Iran have fueled fears that there is more to come."Some level of vigilance, of course, makes sense, but what it seems like ICE has done is basically give out an order to round up as many Iranians as you can, whether or not they're linked to any threat and then arrest them and deport them, which is very concerning," said Ryan Costello, policy director of the National Iranian American Council, an advocacy group.Homeland Security did not immediately reply to an email seeking comment on Ms. Kashanian's case but have been touting arrests of Iranians. The department announced the arrests of at least 11 Iranians on immigration violations during the weekend of the U.S. missile strikes. U.S. Customs and Border Protection said, without elaborating, that it arrested seven Iranians at a Los Angeles-area address that "has been repeatedly used to harbour illegal entrants linked to terrorism."The Department "has been full throttle on identifying and arresting known or suspected terrorists and violent extremists that illegally entered this country, came in through Biden's fraudulent parole programs or otherwise." spokeswoman Tricia McLaughlin said of the 11 arrests. She didn't offer any evidence of terrorist or extremist ties. Her comment on parole programs referred to President Joe Biden's expanded legal pathways to entry, which his successor, Donald Trump, shut down.Russell Milne, Kashanian's husband, said his wife is not a threat. Her appeal for asylum was complicated because of "events in her early life," he explained. A court found an earlier marriage of hers to be fraudulent But over four decades, Ms. Kashanian, 64, built a life in Louisiana. The couple met when she was bartending as a student in the late 1980s. They married and had a daughter. She volunteered with Habitat for Humanity, filmed Persian cooking tutorials on YouTube and was a grandmother figure to the children next door. The fear of deportation always hung over the family, Mr. Milne said, but he said his wife did everything that was being asked of her."She's meeting her obligations," Mr. Milne said. "She's retirement age. She's not a threat. Who picks up a grandmother?"While Iranians have been crossing the border illegally for years, especially since 2021, they have faced little risk of being deported to their home countries due to severed diplomatic relations with the U.S. That seems to no longer be the case. The Trump administration has deported hundreds of people, including Iranians, to countries other than their own in an attempt to circumvent diplomatic hurdles with governments that won't take their people back. During Trump's second term, countries including El Salvador, Costa Rica and Panama have taken back noncitizens from the U.S.The administration has asked the Supreme Court to clear the way for several deportations to South Sudan, a war-ravaged country with which it has no ties, after the justices allowed deportations to countries other than those noncitizens came from. The U.S. Border Patrol arrested Iranians 1,700 times at the Mexican border from October 2021 through November 2024, according to the most recent public data available. The Homeland Security Department reported that about 600 Iranians overstayed visas as business or exchange visitors, tourists and students in the 12-month period through September 2023, the most recent data reports. Iran was one of 12 countries subject to a U.S. travel ban that took effect this month. Some fear ICE's growing



deportation arrests will be another blow. In Oregon, an Iranian man was detained by immigration agents this past week while driving to the gym. He was picked up roughly two weeks before he was scheduled for a check-in at ICE offices in Portland, according to court documents filed by his attorney, Michael Purcell. The man, identified in court filings as S.F., has lived in the U.S. for over 20 years, and his wife and two children are U.S. citizens.S.F. applied for asylum in the U.S. in the early 2000s, but his application was denied in 2002. His appeal failed but the government did not deport him and he continued to live in the country for decades, according to court documents. Due to "changed conditions" in Iran, S.F. would face "a vastly increased danger of persecution" if he were to be deported, Purcell wrote in his petition. "These circumstances relate to the recent bombing by the United States of Iranian nuclear facilities, thus creating a de facto state of war between the United States and Iran."S.F.'s long residency in the U.S., his conversion to Christianity and the fact that his wife and children are U.S. citizens "sharply increase the possibility of his imprisonment in Iran, or torture or execution," he said.

Russia's Rosneft in early talks with Reliance to sell stake in India unit

Russian oil giant PJSC Rosneft Oil Company is in early talks with Reliance Industries for sale of its 49.13% stake in Nayara Energy, which operates a 20-million tonnesa-year oil refinery and 6,750 petrol pumps in India, sources said. Reliance has held preliminary talks for acquisition of Nayara, which will help it overtake state-owned Indian Oil Corporation (IOC). But the talks are at preliminary stage and there is no guarantee that they may lead to a definite deal as valuation remains a sticky ground, three sources with direct knowledge of the matter said.

Top Rosneft officials have visited India at least thrice in the last one year, including visits to Ahmedabad and Mumbai, for talks with potential investors.For Rosneft, which is looking to exit from Nayara due to western sanctions limiting its ability to repatriate full earnings from India operations, a potential buyer could be one who has substantial earnings overseas or is an international company both of which could make quick overseas payouts for the stake.Being a large exporter of fuel, Reliance has substantial overseas income, the sources said.

While emails sent to Rosneft for comments remained unanswered, a Reliance spokesperson said, "As a policy, we do not comment on media speculation and rumours. "Our company evaluates various opportunities on an ongoing basis," the spokesperson said. "We have made and will continue to make necessary disclosures in compliance with our obligations under Securities Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations 2015 and our agreements with the stock exchanges."Rosneft, which had in 2017 acquired Essar Oil in a \$12.9-billion deal, is unable to get full financial benefits from its Indian operations, including repatriating earnings, due to international sanctions. Essar Oil was subsequently named Nayara Energy. The Russian giant sometime in 2024 decided to exit Nayara and began scouting for potential buyers. Alongside Rosneft, UCP Investment Group, a major Russian financial firm, is also selling its 24.5% stake in Nayara. The rest of Nayara's ownership includes Trafigura Group (24.5%) and a group of retail shareholders. If a deal is struck, Trafigura too may exit the venture within months on same terms, they said. The stake of Rosneft and UCP was offered to Reliance Industries, Adani Group, Saudi Aramco and stateowned ONGC/IOC combine among others.But the \$20-billion valuation that Rosneft had put for Nayara was considered too steep a price by almost every potential investor. Adani Group politely declined the offer to invest in an oil refinery, which is considered a sunset business given the energy transition planned worldwide.



adding Adani had in its deal with TotalEnergies agreed to limit future investments in fossil fuel space to only natural gas.Sources said Saudi Aramco is a serious contender to take over Nayara as it will fulfil its long-desired ambition of having downstream presence in the world's fastest growing oil market. Aramco, the world's largest oil exporter, had previously agreed to invest in a giant oil refinery-cum-petrochemical complex that state-owned firms had planned to build in Maharashtra, but that project hasn't taken off due to land acquisition delays. It had in 2019 signed a non-binding agreement to buy a 20% stake in Reliance's oil-to-chemical (O2C) business for USD 15 billion but the deal was called off two years later over valuation issues.Sources said Aramco too considers the \$20 billion valuation too high.It wasn't known if talks between Rosneft and Aramco have progressed beyond initial contact.

Elon Musk renews his criticism of Trump's big bill as it faces a key Senate vote

Washington: Elon Musk on Saturday renewed his strong criticism of President Donald Trump's sweeping tax and spending cuts bill, warning that the legislation could destroy millions of jobs and damage emerging industries in the US.

"The latest Senate draft bill will destroy millions of jobs in America and cause immense strategic harm to our country," Musk wrote on X, as the Senate prepared to vote on whether to open debate on the nearly 1,000-page bill. He added, "It gives handouts to industries of the past while severely damaging industries of the future." Musk, who turned a year older on Saturday, later posted that the bill would be "political suicide for the Republican Party." His remarks have reopened a recent public conflict with Trump's administration, which he left last month after serving as head of the Department of Government Efficiency. The renewed feud adds another layer of trouble for Republican Senate leaders working overtime this weekend to push the legislation through before Trump's self-imposed July Fourth deadline.Musk has never held back his opinions about Trump's "big, beautiful bill." Soon after leaving his federal post, he described the bill as "pork-filled" and a "disgusting abomination," shaming lawmakers who supported it. "Shame on those who voted for it: you know you did wrong. You know it," he wrote on X earlier this month. Musk, a major GOP donor, even threatened to cut off donations and back primary challengers against lawmakers he said "betrayed the American people."Their back-and-forth has turned personal at times. After Trump responded with disappointment over Musk's attacks, the billionaire escalated tensions by suggesting, without evidence, that Trump was linked to files involving sex offender Jeffrey Epstein. Musk later admitted some of his posts "went too far" and tried to reconcile. Trump, in an interview with The New York Post, downplayed the feud, saying, "Things like that happen. I don't blame him for anything.

Nepal's ex-president Bidya Devi Bhandari returns to active politics, rejoins CPN-UML

Nepal's former President Bidya Devi Bhandari on Saturday (June 28, 2025) announced that she has rejoined active politics by renewing her membership of the ruling CPN-UML, nearly a decade after she left the party to assume the country's top constitutional post.Ms. Bhandari, 62, made the announcement while addressing a programme organised in Kathmandu by the Madan Bhandari Foundation to mark the 74th birth anniversary of her late husband and former Communist Party of Nepal-Unified Marxist Leninist (CPN-UML) General Secretary Madan Bhandari."I have renewed my membership of CPN-UML with an obiective of giving continuity to the party's political journey. Ms. Bhandari said at the function, which was also attended by Prime Minister K. P. Oli. The former President's return to active politics comes amid growing speculation about her future role within the CPN-UML. Over the past few months, she has been holding interactions with party leaders and cadres across the country, fuelling rumours that she may be eyeing a larger role in party leadership. Political experts opine that Ms. Bhandari's decision to rejoin CPN-UML might pose a threat to Mr. Oli, who is enjoying "a kind of monopoly" in the ruling party. Quoting party insiders, The Kathmandu Post newspaper reported that Ms. Bhandari could challenge Mr. Oli in CPN-UML's next general convention. Mr. Oli, who has led the party since 2014, is said to be seeking a third term as chief.Speaking at the same event, Prime Minister

Oli asserted that CPN-UML was united and warned against attempts to divide it.Without naming anyone, he said, "Do not dream of splitting the UML."Mr. Oli also urged party members to focus on the next general elections, scheduled to be held in 2027-28. Adding to the political significance of her move, Ms. Bhandari recently undertook a 10-day visit to China from May 24, during which she held meetings with high-ranking officials. The visit drew attention in Nepal, with observers interpreting it as an effort to boost her political clout.Ms. Bhandari's re-entry into party politics has sparked debate in Nepal's political circles. It is not common for a former President to return to party politics, although there may be no legal restriction, senior journalist and political analyst Dhurva Hari Adhikary said. It may raise moral questions, even if it remains a personal decision, he added.Ms. Bhandari served as Nepal's President for two consecutive terms between 2015 and 2023. She had relinquished her party membership after being elected to the largely ceremonial post in October 2015, becoming the country's first woman Head of State.Before her elevation to the presidency, Ms. Bhandari was a senior CPN-UML leader and had served as the party's vice-chairperson. She was also the Defence Minister in the Madhav Kumar Nepal-led government in 2009.Ms. Bhandari is the widow of Madan Bhandari, a popular Marxist leader who died in a controversial jeep accident in 1993. The incident was widely seen as suspicious, and investigations at the time failed to conclusively establish the cause of the crash.





Decolonising the Indian mind: Beyond political freedom



I do not agree with many things that RSS chief Mohan Bhagwat says, but I have no hesitation in endorsing what in my view is right. Recently, in a speech in Indore, he said that political freedom may have come to us on August 15, 1947, but even after that we remained prisoners of the legacy left by colonialism and were not truly free in the cultural sense.

In this column, I keep away from political matters, but consider the cultural dimension even of politics my legitimate arena. I have consistently argued that it is the inevitable fate of all successfully colonised countries to remain culturally enslaved to their colonial rulers, long after political freedom has been attained. This is because colonial rule is not only about the physical subjugation of a people. It is as much-if not more-about the colonisation of the mind. Thus, political freedom is only one part of the project of decolonisation. Undoubtedly, it is a very significant part. Decades of political struggle and the most remarkable acts of courage and sacrifice of countless Indians preceded the proud unfurling of the Tiranga and the descent of the Union Jack on August 15, 1947. It was not easy or guick to defeat the mightiest military power of the time, and that too principally through non-violence and satyagraha under the leadership of Mahatma Gandhi. It is, therefore, not my intent, even remotely, to downgrade the political importance of our Independence Day.But the colonisers-at least the more farsighted among them-knew that the real purpose behind their political conquest was to achieve far more long-lasting goals. Nobody could have stated it with greater honesty than Thomas Babington Macaulay in his Minute on Education of 1835. Derisively, even damningly, dismissive of the civilisational refinements and achievements of anything Indian, he stated the coloniser's purpose with clinical clarity: 'We must at present do our best to form a class of persons, Indian in blood and colour, but English in taste, in opinions, in morals, and intellect'. This class, he added, would in time become "by degrees fit vehicles for conveying (our) knowledge to the great mass of the population". In saying this he was only echoing what he had said earlier—and again without the slightest ideological prevarication—in a speech in the House of Commons: 'There are triumphs which are followed by no reverse. There is an empire exempt from the natural cause of decay. These triumphs are the pacific triumphs of reason over barbarism; that empire is the imperishable empire of our arts and our morals, our literature and our laws.

It is this 'imperishable empire' in the cultural field that, I think, Bhagwat was talking about. And that empire does not cease to exist with political freedom alone. How true this is can be gauged by even a cursory evaluation of the continuing cultural consequences of colonialism. Decades after colonialism has ended politically, English is still the language of the elite; we judge a person's ability by his or her ability to speak English with the right degree of accent and fluency; most of the Anglicised elite cannot count on a hundred in their own language; our education curriculum ensures-especially that of elite schools-that we have read Shakespeare but not Kalidasa; very few of us have actually read-leave alone studied-our own linguistic classics; we don't know-and this surprised me-even such basics as who was Adi Shankaracharya, what did he write, and when did he live; we effortlessly mimic western cultural choices; in short, so many of us have shallow roots in the immensely fertile landscape of our own culture

The process of reclaiming our cultural roots with authenticity is time-consuming. It can take decades, and sometimes even much more. For instance, in Africa, people in the countries that were under French colonial rule, now speak predominantly French. In spite of so many years of political independence, they have not resurrected their own languages, and in many cases, these are lost forever, and along with them, an entire corpus of cultural memory, symbolism, folklore, proverbs and way of life. Therefore, I do not agree with Mohan Bhagwat that one event, the Pran Pratishtha of the Ram Mandir in Ayodhya, is sufficient to dismantle colonial cooption and ensure true freedom. Culture has a correlation to religion, but it is not only about religion, and thus much more still needs to be done by us to become a culturally rooted, independent and autonomous civilisation. We have been tardy even in doing what wasand is-possible to expedite this process. A good example of this neglect is our education system. Too little has changed in its content and syllabus in an imaginative and enduring manner for our new generations to be sufficiently familiar with their own remarkable cultural heritage. It is true that things are changing, and slowly but surely, we are inching towards reappropriating our own cultural space. But this is still a work in progress.

Jharkhand Forest dept plans to revive dwindling Bison population at PTR

Ranchi: The Jharkhand Forest Department has initiated a study to revive the dwindling population of Bison, popularly known as Gaur, at Palamu Tiger Reserve (PTR), an official said. The bovine, a food source for big cats, has already gone extinct from across Jharkhand, excluding the PTR where merely 50-70 bison are surviving, he claimed.According to wildlife experts, poaching, infection and habitat disturbance by local cattle have been the major reasons for the vanishing of bison from Jharkhand. "Once Bisons were abundant in Jharkhand's Saranda, Dalma, Hazaribagh, Gumla and some other forests. But, they went extinct from across the State. PTR, mainly Betla range, is the last destination where it is surviving but numbers are on the decline," said former State wildlife board member DS Srivastava.

He alleged domestic cattle was posing a major threat to the animal in PTR."Over 1.5 lakh domestic cattle from around the villages in PTR have occupied most of the space of Bison. They are eating food of the Bison and are also spreading several infections such as mouth and foot diseases. The Forest Department needs to check the cattle grazing," he said.PTR Director Kumar Ashutosh said they are carrying out a study to ascertain the parameters that impact the animal. "Various aspects are being studied right from their behaviour to survival requirements so that their population could be increased," Ashutosh said. Giving more details, PTR Deputy Field Director Prajesh Jena said, "We are also studying species of grass they prefer, how to improve their habitats and grow their population. After the study, we will prepare a comprehensive plan for their revival." He said that the bison population in PTR was around 150 in the 1970s."The population is currently between 50 and 70. Its revival is also important from a tiger point of view. They are a good source of food for tigers, other than the Sambar and Cheetal," he said. The tiger count in Jharkhand's Palamau Tiger Reserve (PTR) rose to one in the latest tiger estimation report, released in 2023, from nil recorded in 2018. The reserve official, however, claimed that currently, the population of tigers in the reserve is around five.

"I regret I am not able to make you work on Sundays. What do you do sitting at home? How long can you stare at your wife?" These appalling words from L&T chairman SN Subrahmanyan sparked outrage across the country after he called for the enforcement of a 90-hour workweek. Social media erupted in fury, intensifying the ongoing discussion about the glorification of exploitative work hours in the country. Subrahmanyan's comments came shortly after Infosys co-founder Narayana Murthy publicly endorsed a 70-hour workweek, and shunned the entire concept of work-life balance. These remarks reveal a deep-seated cultural acceptance of overwork and a complete disregard for employee well-being, an ongoing issue in India that progressively seems to be getting worse, one comment at a time.

The tragic consequences of India's toxic work culture became evident through the heartbreaking story of 26-yearold Anna Perayil, a chartered accountant who died just four months into her job. In a now-viral letter, her mother blamed the high-pressure work environment for Anna's death, exposing the devastating consequences of toxic workplace cultures. (Ellis-Petersen, 2024). Anna's story resonated deeply with many, symbolising the emotional and physical toll of India's brutal hustle culture.Together, these incidents have reignited a crucial conversation: is work-life balance in India achievable, or is it destined to remain an unattainable ideal?Workplace Culture

The corporate environment in India is defined by its long working hours, rigid hierarchies and hazy boundaries between work and personal life. According to recent labour data, India has one of the world's most overworked labour groups, with employees putting in far more hours than those in China, Singapore, and even Japan — a country known for its gruesome work culture (Ellis-Petersen, 2024). On average. Indian workers put in 13 extra hours a week than German workers. A McKinsey Health Institute survey also found India to be the global leader in workplace burnout, with 59% of respondents reporting burnout symptoms (Tewari, 2024). These numbers don't just point to superficial issues but indicate a larger problem: India's relentless pursuit of economic growth comes at the expense of individual well-being. This toxic work culture does not just affect employees, it also takes a toll on organisations. According to BRSR (Business Responsibility and Sustainability Report) data, the average employee turnover rate (the number of employees leaving an organisation during a specified period, typically in one year) increased from 24% to 31% in the fiscal year 2024, signaling a growing dissatisfaction with toxic work conditions. Yet, the fact remains that despite the painfully evident drawbacks of overwork, change feels so elusive."This Saturday-Sunday off is not an Indian thing. This is a Western thing," declared Ola CEO Bhavish Aggarwal, backing the viewpoints of the other aforementioned influential figures. When leaders openly support extreme workweeks, it sends an alarming message to both employees and organisations. This creates an environment where excess hours are glorified as a symbol of commitment and productivity. As a result, employees often feel pressured to keep up with these unrealistic expectations, worried that they'll be seen as uncommitted or lacking ambition if they don't. If we choose to accept this reality and simply conform to it, the very idea of a 'day off' is sure to appear mythical in the future, a tale of what once was. In India, the push for rapid economic growth has created a culture that values productivity and competiall else. Organisations its and achieve targets, often exploit the labour force. Employees, trapped in this cycle of proving themselves by working extra hours, often feel threatened with the prospect of losing something crucial in case they leave: promotion, job security or financial stability. A McKinsey Health Institute survey also found India to be the global leader in workplace burnout, with 59% of respondents reporting burnout symptomsMoreover, large corporations have no real incentive to change their practices because executives are aware that if one person quits or fails to do the job according to their standards, thousands of others will step in to take their place (Ellis-Petersen, 2024). This relentless focus on efficiency may drive results, but is it worth the price we pay for it?Cost of OverworkThe toll that toxic work environments can take on health is undeniable. It is wellknown that prolonged stress can lead to serious issues like heart disease, depression and anxiety. A 2022 Deloitte survey revealed that a shocking 80% of the Indian workforce experience mental health issues. In a country where conversations around mental health still face a lot of backlash, the constant pressure to perform often pushes people to the point of burnout, taking a toll not just on individuals but on their families as well. Ironically, the obsession with working long hours may even be counterproductive. Research shows that overworked employees are less efficient, more prone to mistakes, and ultimately less productive. Countries like Germany and Sweden, which value work-life balance, consistently outperform nations that demand longer workweeks, proving that prioritising balance isn't just kinder, it's smarter for the economy too (Rituparna, 2024).Gen Z: Self-Awareness or Self-Sabotage?

The entry of Gen Z into the workforce has brought a drastic shift in workplace dynamics, with an increase in conversations about work culture and challenging traditional norms. This younger generation, which has grown up in the age of rapid technological advancements and a growing awareness of mental health, is unafraid to call out toxic workplace practices. In the aftermath of Anna Perayil's tragic story, a wave of younger employees took to social media to air their grievances through reels, tweets and viral posts that shed light on their struggles. Their openness about challenges has forced employers to focus on issues previously brushed under the carpet.Gen Z's rejection of rigid work structures has given rise to phenomena like "quiet quitting," where employees disengage and do only the bare minimum required due to dissatisfaction with workplace conditions. Hyderabad-based Woxsen University researchers develop AI-based obesity risk detector

Hyderabad: An Artificial Intelligence (AI)-based prediction model to detect obesity risk has been developed by Hyderabad-based Woxsen University researchers alongside a US Scientist.The researchers – Bobba Bharath Reddy, Dr. Hemachandran Kannan and Dr. Shahid Mohammad Ganie, along with US Scientist Prof. Manjeet Rege – explored how combining multiple machine learning methods can predict the risk of obesity based on lifestyle data.

According to the researchers, the healthcare sector, online medical repositories and hospitals were generating vast amounts of data, providing valuable resources for researchers to explore and leverage AI techniques to address real-life health issues. The researchers explained they selected three algorithms from each ensemble method, each possessing distinct characteristics and strengths, to demonstrate the effectiveness of the proposed model from multiple perspectives.

While BMI (body mass index) is commonly used as



the primary indicator of obesity risk, the researchers observed that the BMI has limitations in capturing the full complexity of obesity, which is influenced by behavioural, environmental, and genetic factors. They noted that BMI does not account for critical health indicators such as muscle mass, fat distribution, or other variables, potentially reducing the precision of obesity classification.







Finance Ministry asks public sector banks to monetise investments in subsidiaries via listing on bourses



The Finance Ministry has asked public sector banks (PSBs) to look at monetising their investment in subsidiaries by listing them at bourses after further scaling up operations so that they realise good return. There are about 15 subsidiaries or joint ventures of PSBs lined up for initial public offering or divestment in medium to long term, sources said.

Wherever required banks should invest funds to scale up operations of their subsidiaries or joint ventures, sources said, adding, banks can look at unlocking value at an opportune time.As a precursor to monetisation, sources said, banks should improve governance, professional decisionmaking and bring in greater operational efficiency in their

subsidiaries.

For example, the country's biggest lender State Bank of India may look at listing SBI General Insurance and SBI Payment Services in the future after they scale up their operations.SBI General Insurance Company Ltd, incorporated on February 24, 2009, earned a profit of Rs 509 crore for the financial year ended March 2025.

The general insurance arm of SBI has allotted 3,71,693 equity shares of Rs 10 each during the year ended March 2025. Consequently, the stake of SBI in SBI General Insurance Company Ltd has reduced from 69.11 per cent to 68.99 per cent.SBI Payment Services Pvt Ltd, which is in the merchant acquiring business, is 74 per cent owned by SBI, and the rest with Hitachi Payment Services.SBI Payments is one of the largest acquirers in the country, with more than 33.10 lakh merchant payment acceptance touch points as of March 31, 2024, including 13.67 lakh POS (point of sales) machines, deployed across geographies.Meanwhile, Canara Bank has already initiated the process for listing of asset management joint venture Canara Robeco AMC. Besides, it is also planning listing of its life insurance joint venture Canara HSBC Life Insurance Company Canara Bank has already approved the process of diluting a 14.5 per cent stake in its life insurance venture Canara HSBC Life Insurance Company.

India posts \$13.5 bn current account surplus in March 2025 quarter

The country's current account balance recorded a surplus of \$13.5 billion, or 1.3 per cent of gross domestic product (GDP) in January-March 2025 quarter as against \$4.6 billion, or 0.5 per cent of GDP, in the same quarter of the previous fiscal.During the third quarter of FY2025, there was a current account deficit (CAD) of 11.3 billion, or 1.1 per cent of GDP.For the fiscal 2024-2025, the country's current account deficit was \$23.3 billion, or 0.6 per cent of GDP, compared to \$26 billion, 0.7 per cent of GDP during 2023-24, primarily due to higher net invisibles receipts.

The current account deficit is the difference between exports and imports of goods and services. It is a key indicator of the country's external sector."While the current account balance expectedly reported a seasonal surplus in Q4 FY2025, the size of the same overshot our expectations, amid a surprise dip in primary income outflows in the quarter. This led to the unexpected narrowing in the CAD to 0.6 per cent of GDP in FY2025 from 0.7 per cent in FY2024,' said Aditi Nayar, chief economist, head - Research & Outreach, ICRA Ltd.During Q4 FY2025, merchandise trade deficit was at \$59.5 billion, higher than \$52 billion in Q4 FY2024. However, it moderated from \$79.3 billion in Q3 FY2025, the RBI data showed. Net services receipts increased to \$53.3 billion in Q4 FY2025 from \$42.7 billion a vear ago. Services exports have risen on a year-on-year basis in major categories such as business services and computer services. In the financial account, foreign direct investment (FDI) recorded a net inflow of \$0.4 billion in Janu-



ary-March 2024-25 as compared to an inflow of \$2.3 billion in the corresponding period of FY2024. Net inflow under FDI at \$1 billion during 2024-25 was lower than \$10.2 billion during 2023-24.

Foreign portfolio investment (FPI) recorded a net outflow of \$5.9 billion in Q4 FY2025 as against a net inflow of \$11.4 billion in the same quarter of FY2024. During FY2025, FPI recorded a net inflow of \$3.6 billion, lower than \$44.1 billion a year ago.Net inflows under external commercial borrowings (ECBs) to India amounted to \$7.4 billion in Q4 FY2025, as compared to \$2.6 billion in the corresponding period a year ago.Non-resident deposits (NRI deposits) recorded a net inflow of \$2.8 billion in fourth quarter of FY2025, lower than \$5.4 billion a year ago. There was an accretion of \$8.8 billion to the foreign exchange reserves (on a Balance of Payment basis) in Q4 FY2025 as compared to an accretion of \$30.8 billion in Q4 FY2024."We foresee India's current account deficit to average 1 per cent of GDP in FY2026, assuming an average crude oil price of around \$70/barrel for the fiscal, which is eminently manageable in spite of the prevailing global uncertainties," Nayar said

Pulmonologists and ENT specialists call for greater awareness around chronic cough -- not merely as a post-infection remnant, but as a potential marker of deeper respiratory or systemic concerns. The prevalence of chronic cough in India varies across studies, but generally falls within the range of 5-10% of the adult population. This makes it a common symptom, particularly among those seeking primary care. While some studies suggest a prevalence of less than 5%, others show a higher range of 2% to 18%

Doctors classify cough based on its duration into three main types. Acute cough lasts less than three weeks, subacute falls between three to eight weeks, and chronic cough refers to any that continues beyond eight weeks. But beyond time, the cause -- whether infectious or non-infectious -- shapes clinical understanding. Acute cough is usually the result of viral upper respiratory tract infections or bacterial pneumonia. In the elderly or those with heart conditions, even bronchitis can be complicated by heart failure. Subacute cough often follows a resolved infection and may point to post-viral bronchitis. Chronic cough, however, opens up a broader diagnostic window, requiring evaluation for conditions like asthma, GERD (gastroesophageal reflux disease), chronic bronchitis, postnasal drip, COPD, or in more serious cases, pulmonary tuberculosis.

According to Shachi Dave, consultant pulmonologist at Narayana Hospital, Ahmedabad, "If a cough lasts less than three weeks, it is usually benign. But if it continues beyond that -- especially with warning signs like fever, weight loss, coloured sputum, or blood -- it's vital to get it assessed by a physician."Symptoms like sore throat and fever typi cally point toward an upper respiratory tract infection in the early stages. If these fade but the cough persists, post-viral inflammation may be the cause. A night-time cough with nasal symptoms may indicate postnasal drip. Persistent reflux symptoms such as burning in the chest could signal GERD as the underlying issue. The nature of the cough -dry, mucous-filled, or purulent -- also helps guide diagnosis. The often-missed diagnosis of chronic cough Misdiagnosis is common, with some studies showing that up to 60 percent of chronic cough cases are either mislabelled or inadequately treated. Frequently missed conditions include silent reflux, cough-variant asthma, eosinophilic bronchitis, and even obstructive sleep apnea."We often see patients labelled as allergic or asthmatic without adequate workup. Any cough that isn't resolving with primary care after a month should be evaluated by a pulmonologist," says Ammaiyappan Palaniswamy, senior consultant at MGM Malar Hospital in Chennai. Karthik Madesh Ratnavelu, ENT specialist at SIMS Hospital, adds that habit coughs, especially in children, and psychogenic coughs related to stress are often overlooked. In his view, early referrals and multidisciplinary approaches help avoid delayed diagnosis. When the nerves are too sensitiveA significant body of research now recognises that many chronic coughs are driven not just by physical irritants, but by nerve hypersensitivity. This mechanism, much like that seen in chronic pain, involves both peripheral and central sensitisation of the nervous system. Peripheral sensitisation occurs when airway receptors -- triggered by infections, allergens, or acid reflux -- become overly reactive. "These receptors, once sensitised, begin responding strongly to even minor irritants," explains Dr. Dave. Central



sensitisation follows repeated stimulation, where the brainstem and higher centres of the brain become hyperexcitable, lowering the threshold for triggering a cough. As a result, stimuli like speaking, cold air, or even laughing can provoke coughing.ATP, a chemical released during inflammation, plays a critical role by activating purinergic receptors like P2X3 on the vagus nerve, further enhancing this sensitivity. This understanding marks a shift in viewing chronic cough not just as a symptom, but sometimes as a disorder in itself.

Invisible triggers in everyday environmentsBeyond infections and reflux, environmental triggers can also sustain or aggravate chronic cough. Common caused include hidden mold on walls, poorly ventilated homes or office spaces and exposure to scented products like air fresheners, incense and perfumes. Even the use of mosquito coils or chemical-based hair dyes has been implicated."Dust mites in bedsheets, furry blankets, or upholstery can set off coughing in allergic or asthmatic patients," says Dr. Dave. "Overcrowded living conditions and lack of sunlight or airflow also create ideal settings for infection spread, includ ing tuberculosis."Lifestyle patterns also play a role. Skipping meals or relying heavily on outside food can increase gastric reflux. Stress, irregular sleep, dehydration, and overuse of the voice are other under-recognised contributors. Dr. Karthik warns that those in vocally demanding jobs -teachers, speakers, and singers -- often present with coughs rooted in vocal strain rather than infection. Making living and working spaces more cough-friendly The idea of a "cough-friendly" environment may seem abstract, but experts say small interventions can make a big difference. These include improving air circulation, maintaining moderate humidity, using air purifiers and reducing the use of strong-smelling products. According to Pankaj Chhabra, clinical director at Marengo Asia Hospitals in Faridabad, "Creating awareness is key. Homes, schools, and offices can all benefit from scent-free policies, periodic ventilation, and attention to allergens. It's more feasible than people think."He also emphasises hydration and vocal rest particularly for those with existing airway sensitivity. Public understanding can reduce the stigma associated with chronic coughing -- especially post the worst phases of Covid-19 pandemic -- where a persistent cough carry social discomfort as well as physical toll. Therefore, experts emphasis that a cough that persists for more than three weeks -- especially if accompanied by other symptoms like fever, night sweats, hoarseness, or weight loss -- should not be ignored. Early evaluation can help identify treatable conditions and prevent unnecessary suffering.Chronic cough is not just an irritant. It's a clinical clue that deserves careful attention. Recognising its nuances, triggers, and neural underpinnings can pave the way for better outcomes and healthier indoor environments.

India seizes 39 containers with Pakistani-origin goods routed via UAE

The anti-smuggling arm of the Finance Ministry, the Directorate of Revenue Intelligence (DRI), has seized 39 containers carrying 1,115 metric tonnes of goods worth around Rs 9 crore, of Pakistani origin, that were being routed to India via the UAE in the backdrop of the Pahalgam terror attacks, the government said in a statement on Thursday. This came after the government had terminated direct trade with Pakistan, marked by the closure of the Integrated Check Post (ICP) at Attari on April 24, following the Pahalgam terror attack. Later, the government banned

direct or indirect import or transit of goods originating in or exported from Pakistan on May 2."DRI launched an operation codenamed Operation Deep Manifest, targeting the illegal import of Pakistani-origin goods routed through third countries, primarily via Dubai, UAE. The operation has so far led to the seizure of 39 containers carrying 1,115 metric tonnes of goods valued at approximately Rs 9 crore. One of the partners of an importing firm was arrested on June 26," the Ministry of Finance said in a statement. The Indian Express had reported on May 16 that the DRI had begun seizing in-transit goods originating from Pakistan after Customs authorities increased scrutiny in the wake of the Pahalgam terrorist attack. The Ministry of Commerce had last year raised the issue of Pakistani dates and dry fruits entering India through the UAE after the two countries signed a free trade agreement in 2022. Hyderabad: In a unique attempt to explore the possibilities and promise of Indian traditional systems and practices, a senior psychiatrist from Hyderabad has embraced Yoga as a therapy to address mental health disorders and enhance neurodevelopmental care among patients.Within a few months of adopting Yoga therapy, Dr. Jyothirmayi Kotipalli, Founder and Chief Psychiatrist of Manaha Clinic, said she has witnessed firsthand how the age-old Indian practice can activate specific healing pathways in the human brain that traditional mental healthcare often overlooks.

"We should recognize the limitations of existing medications and psychotherapy for patients with mental health issues when used in isolation. Without diluting modern psychiatry, we aim to deepen it through ancient Indian, yet biologically relevant, tools," she says. For patients with anxiety disorders, where the autonomic nervous system is chronically aroused, employing breathing techniques like Nadi Shodhana and restorative Asanas to increase vagal tone, has significantly helped. In OCD (Obsessive Compulsive

Disorder) patients, where compulsions stem from intrusive neural loops, Kundalini-inspired pranayama and meditative techniques help interrupt these loops by training both breath control and attention redirection, Dr. Jyothirmayi explains."We have seen patients experience improved emotional regulation and even better adherence to their therapy when Yoga techniques are integrated. This is not merely relaxation. It is an evidence-based method of modulating heart rate variability and reducing cortisol," she says.Surya Namaskar is also employed to counter psychomotor retardation in cases of depression. "More than once, I've seen a patient's affect lift subtly after just 20 minutes of mindful movement," she shares.Dr Jyothirmayee highlights that both children and adults with ADHD respond remarkably well to body-based therapies. For children, sessions are adapted using visual cues, storytelling, and sensory tools."Techniques like Bhramari Pranayama, often dismissed as simplistic, can significantly improve sensory processing and attention when repeated consistently.





How Kuldeep Yadav prepped for England tour with Kevin Pietersen's advice and bowling-action tweaks



Wrist spinner Kuldeep Yadav had the England tour on his mind while playing for Delhi Capitals in IPL this season. As luck would have it, around him was the team mentor Kevin Pietersen, the one-time England captain and a batsman with a deep understanding of spin bowling. Kuldeep didn't let this opportunity go to waste. He sought his help and Pietersen obliged. The two would go through the entire England batting line-up, one batsman at a time, and assess their strength and weakness. Kuldeep would throw questions, Pietersen would answer them. At the end of the discussion the English batting great would also pass on a simple mantra to Kuldeep.

"Kevin Peterson was part of our team at DC. He gave me a lot of inputs for the England tour. He told me about fielding positions, pitches and the batsmen. We ran through their batting line up. He told me about the mindset needed in England," Kuldeep told The Indian Express. "Pietersen said that generally spinners come to England with a defensive mindset. They think that in England, fast bowlers will get wickets and they will be in a supporting role. He told me to take the field with an attacking mindset. If I get a game and bowl 15 to 20 overs, I have to always think about how to get the batsmen out."Kuldeep and Pietersen would go through the entire England batting line-up, one batsman at a time, and assess their strength and weakness. It remains to be seen if the left-arm wrist spinner, a rare breed of bowler that batsmen aren't used to playing, gets into the playing XI at Edgbaston. India trail 0-1 in the series, and their most incisive bowler, Jasprit Bumrah, will in all likelihood miss the second Test. India desperately need wicket-takers. Kuldeep's new aggressive bowling approach, and his refined action and stellar performance in white-ball cricket makes him the obvious choice. But will the Indian team management, obsessed with batting deep, compromise on a batsman or all-rounder to include the proven wicket-taker?Locals say the pitch at Edgbaston slows down gradually. At Headingley on an unresponsive pitch; Mohammed Siraj, Prasidh Krishna and Shardul Thakur struggled to make an impact. With pacers ineffective on the tour so far, will India take the spin punt by playing both Ravindra Jadeja and Kuldeep? The two contrastingly different left-armers, bowling in tandem, sounds promising for a team looking for a quick turnaround in the series.Kuldeep knows the importance of taking wickets. "Apan ko kuch aata nahi hai bowling ke aalava (I don't know anything other than bowling). If you don't take wickets, you can't justify yourself for playing in England. If you don't take wickets, I don't think you deserve to play. But I know one thing, wherever one is playing, at home or in England. I have to get the revs on the ball and the drift and that will get me wickets."

Having secured a five-for when he last played against England, the final Test at Dharamshala when India won at home. Kuldeep comes to these shores with a reputation. "The pitches in that series were batting-friendly. The Test matches went for 4-5 days. England conditions are different but as a spinner, I believe that it won't be that different. Besides, the way England bat, I think the spinners will be in

the game," says Kuldeep, subtly suggesting that he didn't take wickets on spin-friendly pitches in the last series and can get England's attacking Bazballers on true tracks this time around.Kuldeep's confidence comes from the adversities he has overcome over the last few years. Around 2021 when he underwent a knee surgery, it was suggested to him by the medical team that he needs to change his action. His slow run-up, his landing on the pitch and gradual pivot was putting a lot of pressure on his front leg.

Kuldeep had been bowling with the same action since the time his coach in Kanpur, Kapil Pandey, convinced him to switch from pace to spin. A pre-teen Kuldeep wanted to be Wasim Akram. The budding left-armer could swing the ball but didn't have pace. His straight-talking coach asked Kuldeep to try spin. To his coach's surprise, he would use his wrist, not fingers, to give revs on the ball. And thus, at age 13, Kuldeep was a Chinaman, a left-arm spinner.Now close to a decade-and-a-half later, Kuldeep was being advised to change the action that got him fame, fortune and the India cap. But as Kuldeep puts it, "When a doctor tells you something, you need to take it seriously.

He recalls the conversation he had with Ashish Kaushik, the head physiotherapist at the National Cricket Academy. "When I had knee surgery Ashish Kaushik told me 'KD you have bowled so much over the years that your front foot has taken too much load. Because of twisting and turning there could be a problem for you going ahead'. I didn't give it too much thought initially but things that doctors say stay in your mind," recalls Kuldeep.Kuldeep's mind started ticking. For starters, he would increase the speed of his run-up as that would help him to glide through his action quickly. Now, the planting and take-off of his front foot was quick, the knee was under less stress. "But I wasn't sure about this new approach. After I returned home to Kanpur I would play a few league games. Instead of ambling I was now running to the crease. But with this fast approach, I was not getting balance. Then slowly, I changed the angle of my run-up. I started coming straighter. Coming in sideways, it was very difficult for me to get balance," he

He would ask his coach about the change and was told that as long as he got revs on the ball it was fine. "Initially there were a number of problems. To flip your old action is very difficult. It took about a month and a half to get the rhythm. It would be there one day and not there the next. It took me 6 months to get the rhythm," he says. Once he got the rhythm back, Kuldeep faced a new problem because of his fast and aggressive run-up. "I need so much energy to bowl with the altered action, I couldn't bowl more than 4 to 5 overs. The run-up was fast and my approach was aggressive. Even 4 overs in T20 was difficult," he says. That was the time he joined the Indian team with Rohit Sharma as captain. Rohit said he wanted him to bowl longer spells but with the same energy. "Soham Desai (Team India's strength and conditioning coach) prepared me so that I started retaining my energy - I could give maximum effort for at least 6 overs," he says. "You must have heard a lot of times in the match, Rohit bhai would keep asking me - Thak raha hai kya (Hope you are not tired)? Now luckily I have started putting in long spells of 8-9 overs. I have also put in 10-12 overs in Tests. It took me 3 years to get that energy to bowl a long spell."In case Kuldeep gets into the team for the Edgbaston game, this will be his first Test without Virat Kohli, Rohit Sharma and R Ashwin on the field.Kohli was the captain when Kuldeep made his Test debut, he was the one who presented him the cap. Rohit was the 'big brother' who understood him and even expressed his exasperation when he faltered. Ashwin, Kuldeep says, was his mentor and sounding board. Over the years, the two would have long conversations on the art of spin bowling, field placements and variations."Once Ashwin bhai had put an arm around my shoulder and told me 'you have to take this spin legacy forward'," says Kuldeep. For that he needs to get a game, starting with the Test in Edgbaston.

We got his wicket in the third over, and Salt in the next. Once that happened, we knew we were halfway there. After that, the game slowed down. We brought on the spinners-Kuldeep, Axar, and Jaddu-and they bowled beautifully. The pitch was helping spin, and the idea was to get the slower bowlers on as early as possible," Rohit explained.

England's Jamie Smith hails Shubman Gill's men's 'fantastic' efforts in 1st Test: 'India kept trying all day'

Jamie Smith, who had hastened England's run to victory on a rather dramatic fifth day of the match, said that he felt India were "fantastic" throughout the match.

"It's hard when you're out there and you're focused on the job at hand," Smith is quoted as saying by ESPNCricinfo. "You know the importance of that moment, when you have the opportunity to start the series with a win, that your focus is all on that." England chased down a target of 371. Efforts of their openers, particularly centurion Ben Duckett, and later of Joe Root after wickets fell, meant that by the time Smith came to bat, the hosts were pretty much in the driver's seat. India have since been criticised for their lack of firepower in the bowling lineup outside of Jasprit Bumrah and Shubman Gill, who made his debut as Test captain in the match, following the ball and struggling to stamp his authority on the proceedings on Day 5. Smith said that while a chase of that magnitude may not be something that happens often, he felt India kept competing throughout the day."When they're trying to get 10 wickets and you're chasing 370, it's not everyday that gets done. There could have been some headdowns at the end but they kept trying all day. I see a lot of chat about maybe some inexperience on their part but I thought they were fantastic throughout the five days."

Possibility of Bumrah taking new ball led to onslaughtSmith finished the match off with a flourish, smashing a four and a six off the second and third balls of Ravindra Jadeja in the second over after India had taken the second new ball. He then hit a six off the last ball of the over to end the chase, himself remaining unbeaten on 44 off 55 balls. Ayush Shetty, Tanvi Sharma enter finals at US Open 2025 in historic feat

HYDERABAD: India enjoyed a historic night at the Yonex US Open 2025, a BWF Super 300 event, in Council Bluffs, Iowa, as young guns Ayush Shetty and Tanvi Sharma reached the Men's and Women's Singles finals, respectively, with statement wins. Ayush, 20, produced a stunning comeback to defeat top seed and world no. 9 Chou Tien-Chen, securing his maiden BWF World Tour final. Tanvi, 16, cruised past seventh seed Polina Buhrova to become the youngest Indian ever to reach a World Tour final.Ayush, who had finished third at the Orleans Masters earlier this year, bounced back from a tight opening game to outplay the top seed 21-23, 21-15, 21-14 in a high-quality semifinal that lasted 67 minutes. Tanvi, ranked world no. 66, stormed into the women's singles final with a dominant 21-14, 21-16 win over seventh seed Buhrova of Ukraine.

A product of the BAI's National Centre of Excellence (NCE) in Guwahati, she has beaten multiple higher-ranked players on her way to the final, including second seed Thuy Linh Nguyen and former Junior World Champion Pitchamon Opatniputh.Tanvi will face top seed Beiwen Zhang of the USA in the final; a win would make her the youngest Indian to win a BWF World Tour title. Ayush, meanwhile, will take on third-seeded Brian Yang of Canada

New Zealand to a certain extent, depending on the rankings at that time," De Villiers said."So, I don't know if it was mismanagement or perhaps because he recently got back from injury, sort of saw the IPL as the warmup phase. Maybe, went to the surgeon, who let him know, 'You can't play the



five Test matches.' So, I mean you got to respect that, and at the end of the day, it's up to Team India to sort of manage him well," he added. You're very powerful so you can bash me up, hit me on the head, tie my hands and legs, and take me forcibly wherever you want, but I wouldn't come on my own.' So they stopped contacting me after that," recalled Aamir.Aamir Khan admitted he was very scared at that time, not only for him, but more so for his family. "I had two small kids then. My parents were very concerned.

They said, 'What are you doing? They're very dangerous.' So I had said only one thing to them then, 'I want to live my life the way I want. I don't want to go there," said Aamir."I was more concerned for the ones close to me," added Aamir. He had two kids then - Ira Khan and Junaid Khan — from his then-wife Reena Dutta. Aamir had tied the knot with Reena in 1986 and they'd become parents to Junaid in 1993 and Ira in 1997. Aamir and Reena got divorced in 2002. A few years ago, Aamir Khan was in talks to do Mogul, the biopic of late producer Gulshan Kumar, who was shot dead by the underworld in 1997. The film was being produced by Gulshan's son Bhushan Kumar, the current head of T-Series, which was founded by his late father. The film was being helmed by Subhash Kapoor. Many years ago, I realized the importance of finding a work-life balance. I don't intend to burnout, I'm not going anywhere." Sharing how in India taking time for oneself is not always viewed as necessary, she said, "Somehow, in our country, including the corporate world, taking leaves or wanting time for yourself carries a connotation of being unprofessional, not hardworking or driven enough. And I disagree. You can be all of those things and still make time for yourself. How are you going to replenish and put energy back into your work if you don't?"



advocated for setting fixed working hour limits for crew members. When asked what changes she wants to make as a producer, she said, "Streamlining the hours that we work, especially for the crew. There is this sense that if you make people work extra and continuously, you get it done faster. My thinking is the exact opposite - people need to be given enough downtime and rest so that they come back with better energy. That'll help you work faster and better the quality of your work too."The actor also spoke about the need to compensate crew members who work overtime. She said. "Step 2 is to be compensated for overtime. Actors, at the end of the day, are going to walk away with the awards and the rewards, and so do the directors and everyone above board. The crew, on the other hand, comes in much earlier and leaves much later. Overtime may happen but we need to find a mechanism where they're at least compensated for that on an hourly basis.'

'BTS' Suga is the Eminem of K-pop': Grammy-winning producer reveals why the West wants to work with the singer



BTS member SUGA kicked off a solo world tour before heading to the military, spanning 102 days across 10 countries, including the United States. The rapper of the seven-member boy band saw his popularity hit a whole new high. But apart from being a performer, SUGA is known for producing his own music—something he's been obsessed with since childhood. He's done it for big names in the industry like Heize, IU, PSY, OMI, Suran, and even Jungkook. But according to Grammy-winning producer Frankie Biggz, SUGA isn't just another idol. His music is now being recognised overseas, and he's changing how people view producers in the K-pop space. Biggz even compared his authenticity to that of U.S. rapper Eminem.

Biggz, who's worked with names like Kanye West, 50 Cent, and Eminem, was recently interviewed by Honorary Reporters, a program backed by South Korea's Ministry of Culture, Sports and Tourism. He praised the "Daechwita" hitmaker for proving that music producers don't always need to stay behind the curtain. They can create beats, master albums, and take full control, on stage, on tour, and on charts worldwide, all at once. What really struck him was how SUGA does it all while being part of one of the most influential groups in the world. A group whose voice reaches even the UN, yet here's a guy still handling every inch of his creative process, start to finish. "So, for SUGA to be doing what he's doing, he had to be obsessed with it. He was obsessed even before he became a member of BTS," Biggz said.

To Biggz, SUGA's already carved a niche that puts him at the top of every Western label's wish-list. "He's an amazing artiste, he looks great, the camera loves him, and he has millions of fans around the world; that's a very attractive quality for any Western label. Secondly, it's not just for show. He attracts Western artistes because he is one of the most talented people on earth." Artistes like him aren't just collaborators, they are someone who bridges the gap, the producer emphasised. "When it comes to breaking through, when it comes to who's going to be the first to introduce a sound, who's going to be the first to carve their way through all of that, he's winning," Biggz said. Since SUGA understands both Korean and Western sounds, he's in a unique spot to connect the two, and the industry trusts him to do just that. "But I think that SUGA is just a chameleon in terms of production," he added. Suga has an authenticity like EminemBiggz also pointed out what separates legends like Kanye and Eminem: "that maniacal obsession with their careers," something he clearly sees in SUGA too. Drawing a direct comparison to Eminem, he said: "He has that presence. He has that authenticity, like Eminem, SUGA carries himself with respect, but if someone offends one of his team members, you're going to have to talk to him first.""In the future, K-pop will likely have an increasing influence on global trends," Biggz said, adding, "Min Yoongi can become a conduit for Western professionals into the Korean industry, demonstrating that professionalism and respect for the process are universal values of the Korean music indus-
