#### Mobile Money users: Beware of New Scam!!

Hyderabad, Aug.19: Here is a caution to the Mobile money users (Phone Pay. Gpay, Paytm or any other third party mobile money Apps). There is a new technique scammer has come up with, to cheat the people. The scammer sends you a real deposit of money into your phone, using his number. He really sends you a small amount, say Rs.5,000 or so and you don't even doubt it. After sending this money, he sends you a message on your mobile saying that you have received some money. The natural thing for you is to get excited and then you want to check your balance. To check your balance, you will enter your PIN, which means you have validated his withdrawal request of your account. Your account will automatically allow his withdrawal request and take out the money. The trick is to just lure you with a small amount initially, to steal from your account. To protect yourself from this scam, whenever you received such an unexpected balance, first enter in, deliberately, a wrong PIN number.

#### BRAOU organised placement drive

Hyderabad, Aug.19 (NSS): Dr. B.R. Ambedkar Open University (BRAOU) in collaboration with Retailers Association Skill Council of India (RASCI) organized Placement Drive for "Stipend Based Apprenticeship Program" at its campus on Tuesday. Westside, a TATA Group, Pai International, an electronics retailer and Apollo Pharmaceuticals participated.

This drive was organised for the first 200 candidates who registered under BRAOU- RASCI Stipend based apprenticeship program launched by the Dr. B, R, Ambedkar Open University. Spot offer letters were issued to the selected candidates who will join these establishments from 1st September 2025. The minimum stipend offered was Rs.13,000 per month. Students were offered these placements with the option of accommodation by some establishments. The next placement drive will be organised in 15 days for the next 325 candidates who registered for the program.

## CM Revanth urges Centre for adequate urea supply to Telangana



Hyderabad, Aug.19: Chief Minister A. Revanth Reddy has urged the Central government to immediately supply urea to the farmers of Telangana in accordance with their sanctioned requirements. He stated that Members of Parliament from Telangana had already raised the issue with Union Ministers, highlighting the problems arising from the inadequate supply of urea to the state despite the approved allocation. Taking to X on Tuesday, the Chief Minister pointed

out that although 8.30 lakh metric tonnes of urea had been allocated to Telangana for the current Kharif season, only 5.32 lakh metric tonnes had been supplied so far - a shortfall of nearly 3 lakh metric tonnes - causing significant hardship for farmers across the state. He also referred to a representation submitted to Union Minister for Fertilizers and Chemicals, JPNadda, by the State 's Members of Parliament. The Chief Minister further stated that he had personally taken up the matter with the Union Minister and that State Agriculture Minister Tummala Nageswara Rao had also written multiple times to the Centre regarding the issue. He alleged that the Union government was discriminating against Telangana by failing to supply urea as per the state's actual needs. Revanth and liganous paties that despite reported of continued negligence, noting that despite repeated efforts by Telangana MPs - including raising the matter in Parliament and staging protests on behalf of farmers the supply still does not match the approved quota. The Chief Minister reiterated his demand for the immediate delivery of urea in line with the sanctioned allocation to protect the interests of Telangana's farmers.

## Complete development works in order of priority: Bhatti

Hyderabad, Aug.19 At the Cabinet Sub-Committee meeting on Infrastructure and Capital Works, the Committee Chairman and Deputy Chief Minister Bhatti Vikramarka emphasised that investments are crucial for the rapid development of the State. He directed officials to carefully utilise resources and complete development works in various departments in order of priority.

On Tuesday at the Secretariat, the Deputy Chief Minister conducted a review meeting along with Ministers and Cabinet Sub-Committee members Uttam Kumar Reddy, Duddilla Sridhar Babu, Komatireddy Venkat Reddy, and Seethakka.On the occasion, Bhatti Vikramarka explained that traditionally, based on revenue and budget allocations, works are approved in the ratio of 1:3 — a method followed in governance for decades. However, in the last ten years, the previous rulers, without regard to income or budget allocations, had approved development works in certain departments at a ratio of 1:25. They initiated works and left them incomplete. As a result, due to a shortage of funds, works were stalled everywhere, leaving new Ministers unable to propose works in their departments, he explained. The Deputy Chief Minister informed officials that, because of the decisions of the previous government, no project is in a position to be completed now, and the government is unable to release funds for any work. Bhatti Vikramarka instructed the Secretaries of various departments to rectify the alarming and unhealthy situation prevailing in their respective departments. The Deputy Chief Minister ordered officials to first identify works that are 95 percent complete



and move forward by prioritising works in a similar manner through well-prepared plans. While undertaking development projects across departments, he stressed that representation should be ensured for all constituencies in the state. Bhatti Vikramarka advised officials to give priority to projects taken up with Central government-sponsored schemes and NABARD assistance, ensuring their completion. The Ministers cautioned officials that during the previous regime, some departments were given 100 percent priority while others were given only 10 percent, and such imbalance should not occur again. The Ministers further instructed that while spending funds on development works, simultaneous efforts must be made to increase revenues. All officers should prepare plans accordingly and move forward.

# PM Modi appeals for unanimous election of Radhakrishnan as Vice-President

Prime Minister Narendra Modi on Tuesday (August 19, 2025) appealed to all parties, including the Opposition, for unanimous election of NDA's Vice-Presidential candidate C.P. Radhakrishnan, as he praised his life of public service at a meeting of the ruling alliance MPs.Mr Radhakrishnan was felicitated at the meeting of MPs here by their top brass, including Prime Minister Modi and several BJP allies.Mr. Radhakrishnan is likely to file his nomination on Wednesday (August 20, 2025).Parliamentary Affairs Minister Kiren Rijiju told reporters that Mr. Modi, in his address, appealed to various parties, especially the Opposition, to back Mr. Radhakrishnan to ensure that he is elected unanimously.Mr. Modi introduced the Maharashtra Gover-

nor, who is a seasoned BJP leader from Tamil Nadu, to the NDA MPs, citing his long public life in which he served ably in different capacities. In his speech, Mr. Modi also raised the issue of Indus Waters Treaty and slammed the then Prime Minister Jawaharlal Nehru for signing the agreement with Pakistan without taking Parliament or his Cabinet into confidence. Nehru did to burnish his own image at the cost of the interest of the country, he said, according to sources.

Over 80% of the waters was allowed to be used by Pakistan, he noted. The Modi government has put the treaty in abeyance following the Pahalgam terror attack. The Prime Minister said his government has been undoing the sins of that era, the sources added. Nehru later told a colleague that he had believed that the agreement will help resolve other issues with Pakistan but it did not happen, he noted, Mr. Modi also spoke of the S&P Global Ratings recent decision to upgrade India's long-term sovereign credit rating, saying it highlights the country's sound economy and will draw more investment.Mr. Rijiju said Mr. Radhakrishnan (67) has led a simple life away from any controversy or taint, stressing that his election as vice president will be a matter of delight for the entire country. With the BJP-led NDA enjoying a comfortable majority in the electoral college comprising MPs from the Lok Sabha and Rajya Sabha, Radhakrishnan's win is a certainty amid indications from the opposition IN-DIA bloc that it will field its own candidate and force a con-

### CM Revanth Reddy urge for supporting justice Sudarshan Reddy in vice-presidential poll

Hyderabad, Aug.19: Welcoming the announcement of Justice Sudarshan Reddy as the Vice-Presidential candidate of INDIA Alliance, Chief Minister A Revanth Reddy called it as a proud moment for Telugu people. Addressing media persons at the Command Control Office in Hyderabad, the Chief Minister said the NDA was "making a mockery of democracy and misusing constitutional institutions," while the INDIA bloc was fighting to safeguard the Constitution. Defeating those "conspiring to abolish the Constitution" was the responsibility of all democratic forces, he noted.

CM appealed to the parties across Telugu states to unite in support of Justice Sudarshan Reddy, and specifically urged Andhra Pradesh Chief Minister N. Chandrababu Naidu, BRS president K. Chandrashekar Rao, Jana Sena chief Pawan Kalyan and YSRCP chief Y.S. Jaganmohan Reddy to back the INDIA Alliance nominee, stressing that the candidature transcends party lines. "Justice Sudarshan Reddy is neither a Congress member nor aligned with any political party. He has always stood as a protector of the Constitution and worked tirelessly for OBC reservations. At this juncture, it is vital that someone with his legal acumen holds such a key position, particularly to ensure the



passage of the BC Bill," he added. The Chief Minister said he was not confident that justice would be done for backward classes if the NDA candidate, Radhakrishnan, were to win. The upcoming Vice-Presidential election was not a Telangana versus Tamil Nadu contest, but rather a battle between "those who protect the Constitution and those who undermine it", he said and appealed to all the MPs to "vote according to their conscience".

### KTR spreading lies on Kaynes semiconductor industry issue - Minister Sridhar Babu



Hyderabad, Aug.19 Terming as a 'lie' the allegation made by BRS leader KT Rama Rao that the Kaynes semiconductor industry shifted from Hyderabad to Gujarat due to state government's 'failure', Minister for IT and industries Duddila Sridhar Babu today remarked that such a statement is a desperate attempt to throw mud on others and to cover his own shortcomings. Spreading falsehoods has always been KTR's habit, the minister said. Sridhar Babu, talking to newsmen, said, "The truth is clear as the Kaynes did not flee Telangana. It was lured to Gujarat only because the Centre and the BJP Government in Gujarat offered massive subsidies. KTR is well aware of this, but still chooses to deliberately mislead the people of Telangana. BRS Leaders have made it their daily routine to launch Goebbelsstyle propaganda, hoping people will blindly believe them. But Telangana citizens are not so gullible." According to the minister, the Central Government approved a 50% subsidy under the India Semiconductor Mission (ISM) for the Kaynes project in Sanand, Gujarat. This scheme, worth Rs 76,000 crore, was launched to promote semiconductors in India. Once it was made clear that units in Gujarat would automatically receive a 50% subsidy, semiconductor firms naturally leaned towards that state. For Kaynes' proposed project of Rs 3,307 crore, the Centre sanctioned Rs 1,654.5 crore as subsidy. On top of that, the Gujarat Government gave an additional 40% subsidy. Together, subsidies covered nearly 70% of the total project cost - about Rs 2,314.9 crore. By comparison, if the same project had been set up in Telangana, the state policy would have allowed conces-

sions worth about Rs 330 crore. Despite the ISM scheme

promising equal support across India, the Centre has extended such extraordinary generosity only towards Gujarat. This biased favoritism - "stepmotherly treatment" is something that the BJP must answer for. Instead of questioning the Centre's discrimination, KTR finds it convenient to hurl baseless charges at Telangana Government. His silence on BJP's favoritism exposes his lack of courage and credibility, the minister quipped. Even Union Minister HD Kumaraswamy admitted that the incentives given in Gujarat amount to Rs 3.2 crore per job created. This itself proves how the Centre and Gujarat lured Kaynes - not any so-called "failure" of Telangana government, he noted.

#### KCR and Harish Rao move High Court against Kaleshwaram commission report

Hyderabad, Aug.19: In a significant development, BRS chief and former Chief Minister K Chandrasekhar Rao (KCR) moved the Telangana High Court challenging the findings of the Kaleshwaram Commission report. He, in his petition, alleged that the commission's report was riddled with factual errors and prepared in line with the ruling Congress government's political agenda.

Along with KCR, former irrigation minister T Harish Rao also filed a separate petition before the court seeking a stay on the implementation of commission's report. Both leaders argued that the inquiry was politically motivated and lacked impartiality It may be recalled that the state cabinet has recently approved the report submitted by Justice P.C. Ghosh, who headed the Kaleshwaram Commission. Chief Minister A Revanth Reddy, defending the report, said it had been prepared after an analytical investigation and that the government would table it in the State Assembly soon. He further assured that views from all political parties would be taken into consideration during the Assembly discussion.

#### Minister Jupally inspects Kadem project

Hyderabad, Aug.19 Adilabad Joint district in-charge Minister Jupally Krishna Rao on Tuesday visited the Kadem project in view of the heavy rains in the district. Details were collected from engineering department officials on the inflow and outflow of the flood water entering the project.

Speaking on the occasion, the minister said that people should be alert in the wake of the heavy rains. He revealed that repair work had already been completed with funds of Rs 9 crore without any danger at the project. He said that roads in low-lying areas and villages had been damaged due to the impact of the rains and added that steps would be taken to improve transport facilities. The minister said that crop fields, residential houses and roads had been damaged due to the heavy floods. Rao said that After the rains subside, the relevant departments would conduct a survey, assess the damage and send a report to the state government. He said that they would later provide financial assistance to the victims. The minister said that search operations were underway for a fisherman, who was swept away in the flood waters and added that the state government would support the family in every way.

The much-hyped Alaska meeting between US Presi dent Donald Trump and Russian President Vladimir Putin oncluded with no ceasefire, no agreement, and no conrete pathway toward ending the Russia-Ukraine war.For all the showmanship — a warm tarmac greeting, twin handhakes, and a joint limo ride — the summit produced little nore than vague assurances, cryptic references to progress," and a reminder that when it comes to this war, there's no deal until there's a deal."

After nearly three hours behind closed doors, Trump onceded, "We didn't get there," before exiting without takng questions. His earlier claim that there was only a "25 ber cent chance" of failure now looks like a self-inflicted low to his credibility as a self-styled peacemaker and lealmaker.Putin described himself as "sincerely interested" in ending what he called a "tragedy," but offered no pecifics. He warned against "sabotage" by Ukraine and Europe and insisted that "primary causes" of the conflict nust be addressed — Kremlin code for its longstanding emands on arresting NATO expansion and ensuring teritorial recognition of the territory gained. Apparently, Putin did not compromise on any of his demands, handled Trump vith his vast diplomatic experience, leaving a window for urther talks.Trump, for his part, said "many points were agreed to" but admitted that "one significant" disagreement emained, without disclosing what it was. His pledge to all Ukrainian President Volodymyr Zelenskyy and Euroean leaders "soon" was small consolation to Kyiv, which ad been excluded from the talks.

#### TGSPDCL's knee-jerk reaction of cable removal leads to massive internet outage in Hyd

Hyderabad: In a knee-jerk reaction to Sunday night's electrocution incident in which six people died during the Sri Krishnashtami chariot procession in Ramanthapur, the Telangana State Southern Power Distribution Company Limited (TGSPDCL) has begun clearing cable and internet wires from electricity poles in the city. The sudden move has left several areas without internet access, prompting citizens to take to X to express their concerns. The action comes at a time when the State government has asked IT companies to switch to 'Work From Home' mode due to the heavy rains lashing Hyderabad and other parts of Telangana.

Several netizens expressed dismay over the haphazard measures, with some even claiming their livelihoods

### Good roads will drive jobs to rural Telangana: Komatireddy

Hyderabad, Aug.19: Minister for Roads & Buildings and Cinematography Komatireddy Venkat Reddy said that quality road connectivity must be the government's top priority, as it holds the key to drawing industries and employment to rural Telangana. Speaking at the Infrastructure & Capital Works Ministers' Committee meeting, chaired by Deputy Chief Minister Bhatti Vikramarka at the State Secretariat on Tuesday, the Minister said that strong road networks from the State capital to district and mandal centres will take industries into villages, creating jobs locally. People should feel confident that employment is possible anywhere in Telangana, not just in the capital," he said.

Calling roads "the first priority for people," the Minister said that they directly impact public transport, emergency services and perceptions of government efficiency. "In

emergencies, the speed of an ambulance is judged by the quality of roads. That is why the government must not hesitate to spend on this sector," the Minister remarked. Pushing for rapid execution of road projects under the Hybrid Annuity Model (HAM), Venkat Reddy promised accident-free roads within three years. He also stressed that timely payments to contractors are essential to remove uncertainty in the system and build confidence among stakeholders, while pointing out that, financial mismanagement by the previous government had created hurdles which the present administration is determined to overcome with a people-first approach. The meeting was attended by Ministers Uttam Kumar Reddy, Sridhar Babu and Seethakka, along with Chief Secretary Ramakrishna Rao, senior officials and secretaries of various departments.

### Cm Revanth not focusing on governance; but blames KCR on every issue –Srinivas Goud

Hyderabad, Aug.19 Criticising the Congress government for failure to announce benefits to the communities on the occasion of Sarvai Papanna Jayanti, former minister and BRS leader V Srinivas Goud today mocked that Chief Minister Revanth Reddy was "taking the name of former CM KCR even in his sleep, instead of focusing on governance." The former minister, at a press meet in Telangana Bhavan, said that the people expected the Chief Minister to announce benefits for professional castes on the occasion of Sarvai Papanna Jayanti on Monday, but he failed to do so. "Apart from blaming KCR everywhere, Revanth has done nothing good. The Congress party promised several benefits to the Gowda community, but instead of implementing them, Revanth is only spreading lies. He was a liar during elections, he remarked.

Refuting Revanth's claim that KCR restricted reservations to under 50 percent, Goud asserted, "KCR fought for 62 percent reservations. It was Congress leaders Swapna Reddy and Gopal Reddy who approached the Su-

preme Court and got the 50 percent cap imposed. Can CM Revanth swear on Sonia Gandhi and Rahul Gandhi that his party leaders were not responsible for this?"Referring to Sarvai Papanna's legacy, he said "It was during KCR's tenure that a GO was issued to hand them over to the Archaeology Department. It is Revanth's government that gave mining contracts in those areas to Congress leaders." He demanded the CM to prove his sincerity by enacting a law to provide 42 percent reservations for BCs, instead of indulging in falsehoods. "There is no point in taking credit for good works and blaming KCR for everything else. The government must immediately complete pending works of Palamuru-Ranga Reddy project," he added. Highlighting the plight of toddy tappers, Goud said that some 700 had died in accidents in the last 20 months without receiving ex-gratia, and that the promised 25 percent reservation in wine shops was not implemented. Former BC Commission member Shubhprad Patel and BRS leader Gautam Prasad were present at the press meet.

### Be cautious with electricity during Ganesh idol processions - CMD Faruqui

The CMD clarified that the said accidents were not due to negligence by the Electricity department but for other causes. The CMD today inspected the Bandlaguda accident site and reviewed the circumstances of the incident. As per the orders of Deputy Chief Minister Bhatti Vikramarka, a special drive is underway to remove dangerous hanging cables from electricity poles, he added and appealed to the public particularly the devotees and pandal organizers to strictly follow the electrical safety measures. Further, he urged the citizens to immediately call '1912' number or the nearest fuse off call center in case of fallen electrical lines or for any emergency situation. Following are the precautions to be taken during Idol processions and at Pandals: Plan the route according to the height of the idol. Inform electricity staff if there are any concerns., Maintain at least a "two-foot distance from electrical lines" to avoid induction effects, Exercise caution while moving cranes, trucks, and tall metal idols, Avoid or minimize decorations with metal frames, Do not climb poles to take electrical connections. Connections must be obtained only through company staff. Use only ISI-marked standard wires. Avoid joined wires. Install an MCB of proper capacity for protection, Inspect surroundings before doing electrical work. Keep children away from wires, poles, and electrical equipment, In case of an electric shock, immediately provide medical help and inform electricity staff and Regularly inspect wiring. Rainwater and moisture may cause leakage and lead to shocks.

Heggade has come under attack from a section of social media users after the Karnataka Government constituted a Special Investigation Team (SIT) to inquire into allegations made by a former sanitation worker that he had been forced to bury several bodies of suspected sexual assault victims around Dharmasthala. Heggade said that various claims made on social media had upset the devotees of the temple. "They (YouTubers) created doubt, confusion and disturbance in the minds of these devotees," he said, hoping that the SIT investigation would dismiss all incorrect claims made against Dharmasthala.

"It was a good decision of the Government to form the SIT. These issues were baseless," he said. Heggade said that he was hurt by the allegations levelled against him during the ongoing probe around the temple town. "My followers have immense faith in me. They have no doubt about



the temple (Dharmasthala) or me," he said, calling the allegations "totally baseless". "It is not a moral way to fight with us." The MP, who is a Padma Vibhushan winner, also urged the Government to initiate action against those involved in the "smear campaign" against the town. "People are hurt by this. The Government should take strict action," he said. Social posts regarding investigation in the case have come under scrutiny after Heggade's family sought an injunction against over 8,000 posts, a majority of which were on YouTube and Instagram. Two groups clashed near Dharmasthala earlier this month over the allegation that YouTubers had defamed the temple townOn Monday, Home Minister G Parameshwara told the Legislative Assembly that the Government would take action against those spreading misinformation about the temple town.

### 'Four booked for 29-year-old tribal man's death in Chhota Udepur': Police

Four men have been booked in connection with the alleged murder of a 29-year-old tribal man in Chhota Udepur district's Bodeli area, said police adding a probe is underway into the matter. According to Bodeli police station officials, the victim, identified as Sahdev Baria, allegedly jumped from a bridge over Meria river on Monday to reportedly "escape" an assault by the accused over a tractor that he had taken from one of the accused for a relative. Baria died during treatment late on Monday night. An FIR into the case was registered at the Bodeli police station based on a complaint from Baria's uncle, Govind Baria. According to the FIR, the four accused, including the owner of a tractor showroom in Bodeli, allegedly waylaid Baria while he was riding his two-wheeler through the Meria river bridge and attacked him.

FIR.As per the FIR, Baria had paid Rs 2 lakh to Ishwarbhai for a tractor before handing it over to his relative. "At that time, Sahdev (Baria) got along well with Jigesh Ishwarbhai... However, soon the owner took back the tractor and fired Sahdev from the job... later he started demanding more money for the tractor and even assaulted Sahdev on the Meria bridge for the same reason," said the FIR.Apart from the show-room owner, other accused have been identified by their first names as Hemant and Jigesh and an unidentified accused. The FIR states that Baria's family, on receiving a call from an acquaintance, had rushed to the crime spot and found the victim lying under the bridge.

#### Cattle markets at a standstill, farmers leaving animals on road: The fallout from Maharashtra butchers' strike over cow vigilantism

Maharashtra Deputy Chief Minister Ajit Pawar earlier this week instructed the police to prevent cow vigilantes from boarding or inspecting vehicles transporting animals. This directive comes in response to the ongoing strike by the Qureshi community, which has been protesting since July 22 against what they describe as an increase in harassment by cow vigilantes. With over 10 lakh butchers from the Qureshi community in Maharashtra going on strike, cattle markets in Akluj and Sangola taluka of Solapur district have virtually stopped operations. It, in turn, has impacted farmers who have now started leaving their unproductive animals loose across the countryside. Afsar Qureshi, member of the All India Jamiatul Quresh and the union of cattle traders, said their decision to stop trade was taken in the face of increased cow vigilantism. "Even with proper documentation, we face violence from self-declared cow vigilantes. There is no protection for us who are carrying out trade in the legal manner," he said. Quershi said the local police, at times, apply stringent sections of the Maharashtra Control of Organised Crime Act, 1999. "Bribes are asked of us for freeing animals despite the court's ruling in our favour," he said.

Afsar said when their members transport animals, the vigilantes stop vehicles on highways. "Even if we have proper papers, they confiscate our animals. Our vehicles are damaged intentionally," he said. The Qureshi community, Afsar said, is spread across the state with a population of over 25 lakh, with a sizable portion of them being involved in the trade of cattle and meat. Since 2015, when the Devendra Fadnavis-led BJP-Shiv Sena government amended the Maharashtra Animal Preservation Act, 1976, to ban the slaughter of cow progeny, the trade in oxen and barren animals has completely collapsed, he said. Afsar noted that this single action has put over 5 lakh traditional butchers out of business. He said cattle traders are easy targets for many. "When we are transporting the animals, many cow vigilantes frame us in false cases. They impound our vehicles and take away our animals. By the time we get court orders, we have lost business," he said. Afsar said that while the Constitution has assured the right to livelihood, in the present environment, they are not allowed to practice the same. Senior cabinet leaders have called for action against cattle traders. Afsar said almost everyone associated with the cattle trade is targeted because of their religion, with little support from anyone. Currently, this strike has severely impacted the operations of cattle markets that handle animals for slaughter. In the cattle market located in Akluj taluka of Solapur, farmers would typically bring their non-productive male buffaloes for sale every Monday.Rajendra Kakade, secretary of the market, said the market saw business of around Rs 50 lakh on Mondays. "Around 400-500 animals are sold with traders coming from every corner of the state," he said. The market has completely shut down since the strike, leaving many farmers with no choice but to leave their animals on the roads. Similarly, the market in Sangola, located in the Solapur district, has also seen all activities come to a standstill. "We hope for a quick resolution to the matter," said Kakade.

#### Thar loses control, mows down 2 people walking on pavement in Delhi's Chanakyapuri, one killed

According to the police, the accident happened when a white Thar was crossing the Gyarah Murti (Eleven Statues) landmark in the Chanakyapuri area of Delhi. The SUV suddenly turned towards the pavement and hit two people walking on it, a police officer said. Both the injured were rushed to the AIIMS Trauma centre, where the doctors declared one of them brought dead, the officer said. The other injured person is under treatment. Crime and forensic teams rushed to the spot to inspect the crime scene, and the police apprehended the driver of the SUV and seized the vehicle. The police are also trying to ascertain whether the driver was drunk, an officer said. A photo of the vehicle shows its left front tyre nearly completely detached due to the impact of the accident. A police officer said the car has an Uttar Pradesh number plate and that the driver works at a private company. In 2025, between January and May, Delhi saw over 2.235 accidents on its roads: 556 of them



were fatal, resulting in the death of 557 people, as per the data shared by the Delhi Police. Although the number of fatal accidents decreased by 13.4 per cent compared to the same period in 2024, which saw 643 fatal accidents, the number of people injured in these accidents increased to 2,187 in 2025 from 2,106 in 2024. According to the data available till now, March has been the deadliest month for accidents in 2025, with 137 fatal incidents resulting in 139

#### Roaring lion, galloping horse and more: 10 new sculptures made from scrap metal to feature in Ahmedabad's beautification drive

A gigantic statue of a roaring Asiatic lion and a galloping horse are among the new sculptures made from scrap to be added to the city's landscape soon, The Indian Express has learnt. Each of these is crafted entirely from discarded metal sourced from the city's urban waste. This initiative blends public art with sustainability, giving scrap a second life while telling stories rooted in culture, identity, and imagination. In the open-air studio of sculptor Sunil Shridhar, one can see an athlete in blue throwing the javelin, presumably to honour Neeraj Chopra, a flag sculpture representing the five Olympic rings and one titled 'Gravity of Love' featuring a couple in a dance pose, suspended midmotion inside a metallic ring. Then there is Weapon of Wisdom, where a pencil spirals around a finger like the Sudarshan Chakra.

Other planned installations include a yoga posture, a figurative abstract sculpture that disrupts urban monotony with mythic proportions, and the 'Wheel of Peace,' representing the five elements-earth, water, fire, air, and space—in a flowing, interconnected form. Across Ahmedabad, 22 sculptures have already found their place in the city's ever-evolving urban landscape, each one forged from discarded scrap metal, and each telling a story of resilience, identity, and transformation. Now, 10 more are set to rise, promising to add new layers of meaning and imagination to the city's streets.ahmedabad beautification drive In the open-air studio of sculptor Sunil Shridhar, one can see an athlete in blue throwing the javelin, presumably to honour Neeraj Chopra.

This initiative is being executed in collaboration with artists contracted by the Ahmedabad Municipal Corporation (AMC). One of them, Sunil Shridhar, told The Indian Express, "I have worked abroad and received several opportunities to continue there. But my heart has always been set on contributing to India; that is the thought that drives me." Ahmedabad is my hometown, and when you are working for your own city, you give it your absolute best. If possible, I would like to extend this kind of artistic contribution

to all of Gujarat, and eventually, to the entire country." The use of scrap metal to create public art has a dual function: it is a cost-effective way to beautify the city, and it sends a strong message about reuse and resourcefulness at a time when cities across India are grappling with the challenges of urban waste.ahmedabad beautification drive Across Ahmedabad, 22 sculptures have already found their place in the city's ever-evolving urban landscape, each one forged from discarded scrap metal, and each telling a story of resilience, identity, and transformation. Municipal Commissioner Banchhanidhi Pani said repurposing scrap metal into public sculptures is part of Ahmedabad's broader 'waste to wealth' initiative. "The metal used in these installations is sourced from urban waste collected in and around the city, he said. He added that Ahmedabad's recent recognition with the Clean City award in the over 10 lakh population category reinforces this vision. "Our focus on recycling, reusing, and reducing aligns seamlessly with the ethos of the Waste to Wealth mission," he said. #### 'He has gone while trying to get a better life for us': Married five months ago, Ludhiana soldier dies in Kashmir Op

Married just five months ago, Lance Naik Pritpal Singh, 27, from Manupur village of Punjab's Ludhiana district, was killed in action during an intense gunfight with terrorists in South Kashmir's Kulgam, Friday. The Army Operation, which started nine days ago at Akhal Forest, is among the longest military operations against terrorists in the Valley in recent years. The Indian Army soldiers are engaged with terrorists in a dense forest. Back home in Punjab, the wails of mourning villagers filled the air at Manupur in Samrala sub-division Saturday as the news of Pritpal's passing reached his family. Wrapped in tricolor, his mortal remains are expected to reach the village Sunday and the cremation will be performed with full military honors. Speaking to The Indian Express, Harpreet Singh, his elder brother said: "Parivaar da karde karde aap turr gaya (He has gone while trying to earn a better life for family). He got married just five months ago in February. "His newly-wedded wife is inconsolable. We have seen too much poverty and our father is a daily-wager. He had joined the Army after passing class 12 so that our family's financial condition could improve." According to the Army statement, Lance Naik

Pripal Singh from 19 Rashtriya Rifles (Sikh Light Infantry), died "on August 8 during intermittent and intense exchange of fire with terrorists" after he "sustained severe splinter injury when hiding terrorists lobbed a grenade." He later succumbed. Harpreet said that his brother's only wish was to see their father Harbans Singh fully cured of the oral cancer he has been suffering from.

"He ensured that my father got the best treatment from the Army hospital. I spoke to him last on August 7, hours before the incident, and even then he told me to take care of my father and others in the family. We had asked him to come home for Raksha Bandhan festivities but he said it won't be possible as he was in the middle of an important operation and he had to catch those terrorists first. He had promised to take leave after the Operation and come home for Diwali. But now he won't," said Harpreet, crying inconsolably. Harpreet said that even as his brother had taken a bank loan and got their house renovated few months ago around his marriage in February, he himself hardly stayed in it. "He hardly stayed in the renovated house. We were waiting for his arrival on Diwali to celebrate together. Mera bhraa turr gaya (My brother is gone forever)," he said. Harbans Singh, father of the deceased soldier said: "Saade baare sochda sochda chala gaya (He has left the world worrying for us). He had promised to come home on Diwali. We were waiting." Pritpal is survived by old parents - father Harbans Singh and sister Kuldeep Kaur, wife Manpreet Kaur, elder brother Harpreet Singh and younger brother Gurdeep Singh. Harpreet, who works at a private factory, says: "What can we demand from the government now. We have lost everything. Everyone knows that terrorists in our country are being sent by Pakistan. Instead of conducting these operations, our government should take full-fledged action against the neighboring country and go all out to teach them a lesson. How long can this go?'

#### AAP slams 'mismanagement by 4-engine BJP govt' over deaths, water crisis in Delhi amid heavy rain

With heavy rain lashing the Capital on Saturday, deaths of eight persons in two separate incidents, flooding of the Giri Nagar pumping station in South Delhi's Kalkaji halting water supply to several areas, and waterlogging in multiple parts of the city brought the BJP government under criticism from the AAP.Leader of Opposition and former CM Atishi said the flooding of the pumping station left thousands of residents in Kalkaji, Giri Nagar, Govindpuri and Govindpuri Extension facing severe water shortage. "Mismanagement by the four-engine BJP govt has not only submerged Delhi roads, but caused a water crisis in Kalkaji. The Giri Nagar pumping station is completely submerged. And the people of Giri Nagar, Kalkaji, Govindpuri and Govindpuri Extn are facing several days of water crisis," she posted on X, along with a copy of her letter to Chief Minister Rekha Gupta.

In her letter, Atishi wrote, "Just a few hours of rain have brought Delhi to a grinding halt. Roads are waterlogged, traffic is at a standstill and even more shocking is that in many parts of Delhi water has entered people's homes. The pumping station of the Giri Nagar UnderGround Reservoir (UGR) is fully submerged in water... So no water is being supplied to the Kalkaji, Giri Nagar, Govindpuri and Govindpuri Extension." She called the situation "the direct result of administrative negligence" and urged the Chief Minister to instruct PWD and Water Minister Parvesh Sahib Singh to restore supply immediately. The heavy rain that caused the flooding began late Friday night, with the India Meteorological Department (IMD) upgrading alerts through the early hours of Saturday from yellow to orange and then to a red alert by 6.20 am. By 8.30 am, Safdarjung recorded 78.7 mm of rainfall in the last 24 hours, while Pragati Maidan logged 100.3 mm. The IMD warned of potential waterlogging, traffic congestion, and reduced visibility across the city. The AAP, in an official statement on Saturday evening, also attacked the BJP-led Delhi government over citywide waterlogging. The party's Delhi president Saurabh Bharadwaj alleged "corruption worth crores in desilting works" and linked it to the Jaitpur incident in which seven people, including two children, died after a wall collapsed amid heavy rain. He further alleged that a 2.5-year-old child drowned in an open manhole, saying, "I had warned CM Rekha Gupta that opening manholes during rain is a dangerous shortcut." Senior leader Manish Sisodia, as per the statement, called the Jaitpur incident "deeply painful" and expressed condolences to the bereaved families. Atishi also posted videos of waterlogged roads in Palam, Dhaula Kuan and Saket, stating, "On Raksha Bandhan, the entire city is submerged... The collapse of governance under Rekha Gupta's government is preventing brothers from meeting their sisters."AAP MLAs Sanjeev Jha and Kuldeep Kumar, also questioned the government's claims of monsoon preparedness and

### Consumer is king? Delhi govt data on redressal of complaints suggests otherwise

A response by BL Verma, Minister of State, Consumer Affairs, Food and Public Distribution in Lok Sabha, dated December 4, 2024, highlights the number of consumer cases filed before commissions between the 2020 and 2024 in the Capital and also the number of pending cases. In Delhi, approximately 4,700 cases on average were filed by the consumers each year between 2020 and 2024, according to Verma's reply to TDP MP Krishna Prasad Tenneti.

As of January 1, 2020, the consumer commissions in the Capital had 23,350 pending cases. Close to five years later, the number stood at 23,635. This means that the total number of cases disposed of in five years was almost equal to the number of new cases filed implying a stagnancy in disposal. "Despite less than 4,700 cases being filed on average, the overall pendency is not reducing. This clearly shows that there is a major issue. Cases that should be disposed of in 90 days are taking two years on average," said Professor Bejon Kumar Mishra, who has close to four decades of experience in consumer advocacy and education. He added, "In a city with a population of close to three crores, less than 5,000 people are approaching consumer commissions. This shows a lack of trust in the system."Data shared by Verma, while responding to questions related to the pendency in consumer commissions on July 29 suggests that the disposal of consumer cases across the country in consumer commissions has slowed down, the government data suggests

Even as an average of 1.74 lakh cases were disposed of every year between 2022 and 2025, there are 5.8 lakh pending cases in all consumer commissions across the country at present with an average disposal rate of 80%. According to the Consumer Protection Act, every complaint needs to be disposed of within three months from the date of receipt of notice if the complaint does not require analysis or testing of commodities, and within five months if analysis is needed. Even as the nationwide disposal of consumer cases was approximately 7,000 and 11,000 more than the number of filed cases in 2022 and 2023, respectively; this trend reversed in 2024. Last year, the cases filed exceeded the disposed cases by over 15,000.

Data shared by the Minister in response to a different



question earlier last month also sheds light on the number of vacancies present in several state consumer disputes redressal commissions. Across the country, 18 out of 36 state consumer disputes redressal commissions don't have presidents, while vacancies exist for 62 members in these commissions. As far as district consumer disputes redressal commissions are concerned, 218 out of 685 commissions don't have sitting presidents, while there are 518 vacancies for members. On how to tackle the increasing pendency of consumer cases, professor Mishra suggested, "I feel eminent persons who have been involved in consumer rights should be made members and presidents of commissions. This way we'll be sure that the posts are being occupied by those who are serious about consumer rights." "Most customers don't know their rights, and even when they do, they usually avoid going to consumer courts. Sometimes the damage caused to them is worth Rs 2,000 to Rs 5.000. Why would anyone want to hire a lawyer and pay a fee of Rs 50,000 for cases like this?," he told The Indian Express. Adding to that, Advocate Paras Jain said, "Seeking affidavit-in-evidence and written submissions by consumer courts in each and every case is frustrating the legislative intent of disposing of consumer complaints in three months...."Jain represented his brother in a 12-vearlong legal battle against Emami's 'Fair and Handsome' skincare product which he eventually won."In a civil case, when a summary judgment can be passed without seeking any affidavit-in-evidence and written submissions, Consumer Courts can also decide on the complaint in a summary manner for the speedy disposal of cases," he added.

#### St. Xavier's College cancels annual Stan Swamy Memorial Lecture after protest by ABVP

Xavier's CollegeFather Stan Swamy was a Jesuit priest and a tribal rights activist based in Jharkhand. He was arrested by the National Investigation Agency (NIA) on October 7, 2019, and stayed in state custody till he died at a Mumbai hospital in 2021 St. Xavier's College on Saturday called off its annual Stan Swamy Memorial Lecture after the Akhil Bharatiya Vidyarthi Parishad (ABVP) protested against the event, alleging it glorified a person who was an accused in the Elgar Parishad—Bhima Koregaon case. The decision came days after the right-wing students' group wrote to the college administration.

The lecture, hosted by the department of inter-religious studies (DIRS), was to have been delivered virtually by Fr Prem Xalxo, associate lecturer, faculty of theology at the Pontifical Gregorian University. He was scheduled to speak on the topic - "Migration for Livelihood: Hope Amidst Miseries."But, earlier this week, the ABVP wrote a letter to the college administration, strongly opposing the event, and demanded action from the state government against the event. "This lecture glorifies a person who was declared as the main accused in the Elgar Parishad-Bhima Koregaon case, and against whom charges have been filed under Unlawful Activities Prevention Act, 1967," said the letter. Father Stan Swamy was a Jesuit priest and a tribal rights activist based in Jharkhand. He was arrested by the National Investigation Agency (NIA) on October 7, 2019, and stayed in state custody till he died at a Mumbai hospital in 2021. Stating that these lectures are usually held on August 9 on the occasion of World Indigenous Day, Rector Fr. Keith DSouza, from St. Xavier's College, said, "Our annual Stan Swamy memorial lecture has been delivered by reputed scholars who have done research in the area of history and development of indigenous peoples across the globe. The topic this year was on the theme of migration.

While the lectures are on several themes related to indig-

As per our Indian criminal jurisprudence, a person is innocent unless proven guilty."Highlighting that the underlying motif of the DIRS is "respecting the other", Fr D Souza further said, "While we respect other perspectives and concerns, we hope to elicit a reciprocal attitude of respect from others as well. A controversy like this does not augur well for international higher educational relations."

#### 'Textbook case of mishandling public money': Delhi govt set to probe irregularities in Chandni Chowk redevelopment project

The BJP government in Delhi is likely to initiate an inquiry into the Chandni Chowk redevelopment project for the alleged irregularities and cost overruns under the previous Aam Aadmi Party (AAP) regime. The project's overall cost allegedly jumped from an estimated cost of Rs 65.6 crore to Rs 145 crore, while its initial cost of work (civil and electrical) increased from Rs 27.79 crore to Rs 105.93 crore – nearly a fourfold increase, said officials. The AAP, however, dismissed the claims and said the latest allegations against the previous government were an attempt to "dissuade (its) leaders from asking questions to the government". "The Chandni Chowk redevelopment project stands as a textbook case of how public money can be mishandled when rules are bent and procedures bypassed. In 2019, under the then Minister-in-Charge (Manish Sisodia), costs spiralled, tenders were ignored, and crores of rupees were diverted — all without mandatory approvals. Delhi deserves better," said Public Works Department (PWD) Minister Parvesh Sahib Singh. "Under my watch, PWD will not be a playground for irregularities but a fortress of transparency and accountability, where every paisa serves the people, not personal interests," Singh added The 1.3-km long redeveloped stretch in Chandni Chowk was inaugurated by former chief minister Arvind Kejriwal in 2021According to the internal findings by the BJP government, sources said, several steps were allegedly bypassed while transferring funds for the project. AAP leader and former Deputy CM Manish Sisodia held the portfolio at the time. It has also been alleged that the previous government violated the standard protocol for administrative approval and expenditure sanctions."As per established norms, a revised sanction must be obtained when project costs exceed approved lim-

its. But PWD continued spending beyond the sanctioned Rs 99.68 crore without obtaining the mandatory revised approval," reads the document. To avoid Cabinet scrutiny, officials said, only an additional preliminary estimate of Rs 40 crore was submitted instead of revised preliminary estimate of Rs 145 crore. "This move appears to have been a deliberate attempt to avoid presenting the full proposal before the Cabinet, which is mandatory for projects exceeding Rs 100 crore... It has also been found that the project was executed through the same contractor without inviting fresh tenders... payments were made in violation of financial transparency and procurement norms," an official said. As per the documents, an amount of over Rs 70 crore was allegedly spent on extra items and deviations. Of the total Rs 145.72 crore spent, more than Rs 70 crore was for extra items and deviations Further, PWD ignored the mandatory requirement of Cabinet approval even as the project cost exceeded Rs 100 crore. The documents also claim that funds were illegally diverted without the Finance department's nod."A total of Rs 30 crore was diverted from the PWD Maintenance Head to Shahjahanabad Redevelopment Corporation (SRDC) without obtaining mandatory concurrence from the Finance Department... The Engineerin-Chief directly submitted the file to the Minister-in-Charge bypassing both the Secretary in charge of the department and the concurrence of the Finance Department - a serious breach of rules and regulations," said the official. Due to these lapses in estimation and execution, the project allegedly suffered severe deficiencies in cost estimation, planning, and financial control. Overall execution lacked due diligence, resulting in large-scale irregularities and fiscal indiscipline, as per the officials. Hitting out at the BJP, the AAP in a statement said, "Rekha Gupta's BJP government knows that it won this Assembly election through cheating and voter list manipulation. They are not popular among the people. They are scared that the people of Delhi now want the AAP government back. They know that the people of Delhi love Arvind Kejriwal and AAP. Therefore, out of desperation, the BJP wants to file hundreds of false cases against AAP leaders."It added: "The people of Delhi know very well that for the last 10 years, vigilance and the Anti-Corruption Branch were under the L-G, and it was the L-G's duty to ensure that corrupt officers were punished. ### Knitwear to apparel, Tamil Nadu's textile belt starts feeling US's 50% tariff heat

IN TIRUPPUR, India's knitwear capital, exporters are already feeling the heat of the 50 per cent tariff US President Donald Trump announced Wednesday. They say orders are being paused, redirected, or lost entirely to competitors like Bangladesh, Pakistan, Vietnam, and Cambodia, all of whom have lower US tariffs ranging between 19% and 36%. One Tiruppur exporter told The Indian Express that his regular US shipment had already been diverted to Pakistan. Another said his American buyer asked him to "hold on" before confirming their summer order. A third revealed that buyers were previously demanding that exporters absorb the 25% tariff hike — a burden that has now doubled overnight.

The revised duties, including baseline and remedylinked tariffs, now push effective rates for some knitted garments to as high as 64%, rendering products up to 35% more expensive than those from regional competitors. What was initially seen as a major setback is now viewed by exporters as "a de facto trade embargo". The blow comes at a particularly cruel time when Tamil Nadu's textile belt was preparing for a rebound in US orders. Tiruppur, Coimbatore, and Karur collectively employ over 1.25 million workers and export Rs 45,000 crore worth of garments annually. Just weeks ago, optimism surged on the back of the India-UK Free Trade Agreement (FTA) and growing US interest in Indian goods due to elevated tariffs on China (125%-145%) and Myanmar (40%). Many exporters in Tamil Nadu had invested in new machinery to meet the expected surge. That hope is now turning into despair under the weight of retaliatory tariffs, especially with respect to China, which is now at 30% and could see a further downward revision once Beijing inks a deal with Washington DC.

"This is a setback," said K M Subramanian, president of the Tiruppur Exporters' Association (TEA). "Standalone exporting companies will be hit first. Buyers are already asking us to absorb part of the tariff. Our margins are just 5% to 7%; how can we share this cost?" Subramanian said while 30% of Tiruppur's exports go to the US, a diverse buyer base in Europe and the Middle East may provide some cushion - but not without pain. "The non-branded buyers will shift immediately. Branded ones may stay because of the social compliance and operating protocols we offer, but we will still bleed for some time." Textiles is a labourintensive sector, and there are worries of job losses if the market shrinks. If exports contract 10-20% due to loss of orders, it can threaten 100,000-200,000 textile and garment jobs collectively in the three hubs — Tiruppur, Karur and Coimbatore — over the next few months. Tiruppur alone contributes Rs 40,000 crore to knitwear exports, supplying global giants like Walmart, GAP, and Costco, and accounting for 55% of the country's knitwear exports. The region had hoped to expand it by 10-15% in FY2025-26. Now, the outlook is grim, with analysts forecasting a 40-50% fall in US-bound orders, especially in cotton and knitted apparel segments. The fallout is not confined to garments alone. In Coimbatore and Karur, known for home textiles, order stagnation has already begun. K Selvaraju, secretary general of the Southern India Mills' Association, said buyers have started deferring or holding off on their summer bookings for bed linens and towels - key products traditionally finalised by October. "We're hearing 'hold on' from clients who had placed advance enquiries," Selvaraju said. "If we miss this window, we miss the season."Karur alone exports nearly Rs 9,000 crore in home textiles each year, with Rs 6,900 crore going as direct exports. Coimbatore mills send large volumes of cotton towels and kitchen linens to the US now burdened with higher duties. This isn't just about one tariff hike - its compounding an already weak environment," Selvaraju said, pointing to India's 11% import duty on cotton and a GST duty inversion that further hurts competitiveness. "Polyester raw material is taxed at 18%, yarn at 12%, but finished garments are taxed at 5%. This adds 6-7% to export costs, while competitors don't have such inverted duties." Meanwhile, the quality of cotton imports from Brazil, which make up 45% of this year's inbound shipments, is under scrutiny for not always meeting US-mandated standards. Selvaraju has urged the Centre to negotiate a cotton-forward deal, offering duty-free access to US cotton in exchange for apparel exports made from it. The global textiles market is highly competitive; India's key rivals face no such punitive hikes. Bangladesh continues with an effective rate of 35–36%, Pakistan has successfully negotiated a 19% tariff, Vietnam is at 20-21%, and Cambodia, though previously at 49%, now enjoys a 19% rate after an August 1 revision. One Tiruppur manufacturer admitted his shipment was lost to Pakistan. "They seem to have offered a better price," he said. "The order slipped."

Subramanian reiterated that Bangladesh remains India's fiercest rival in the US market. "Their 20% rate means they're much cheaper, significant when your margin is about 5%."This margin has now all but vanished. With total duties touching 64%, non-branded US buyers are already shifting to cheaper options. "They shift overnight," Subramanian warned.Industry leaders are urging for immediate policy relief. "The government had then provided an extended credit guarantee-linked scheme," Selvaraju recalled, referring to pandemic-era support. "It's time to bring that back."He also pressed for eliminating the 11% cotton import duty and restructuring the GST regime on manmade fibres. "

### **Europe stresses need to protect Ukrainian** interests ahead of Trump-Putin talks

KYIV/LONDON - European leaders on Saturday welcomed U.S. President Donald Trump's plans to meet Russian President Vladimir Putin on ending the war in Ukraine, while stressing the need to keep pressure on Moscow and protect Ukrainian and European security interests. Trump plans to meet Putin in Alaska on Friday, saying the parties, including Ukrainian President Volodymyr Zelenskiy, were close to a deal that could resolve the three-and-a-half-year-old conflict. The U.S. president is open to a trilateral summit with Putin and Zelenskiy, but for now the White House is planning a bilateral meeting as requested by Putin, a White House official said. Russian and Ukrainian officials could not immediately be reached for comment on the prospects of a trilateral meeting.

Details of a potential deal have not been announced, but Trump said it would involve "some swapping of territories to the betterment of both". It could require Ukraine to surrender significant parts of its territory, an outcome Zelenskiy and his European allies say would only encourage Russian aggression.U.S. Vice President JD Vance met British Foreign Secretary David Lammy and representatives of Ukraine and European allies on Saturday at Chevening House, a country mansion southeast of London, to discuss Trump's push for peace. A joint statement from the French, Italian, German, Polish, British and Finnish leaders and the president of the European Commission welcomed Trump's efforts, while stressing the need to maintain support for Ukraine and pressure on Russia. "We share the conviction that a diplomatic solution must protect Ukraine's and Europe's vital security interests," they said.

"We agree that these vital interests include the need for robust and credible security guarantees that enable Ukraine to effectively defend its sovereignty and territorial integrity," the statement said, adding: "The path to peace in Ukraine cannot be decided without Ukraine. "The leaders said "they remain committed to the principle that international borders must not be changed by force", and added: "The current line of contact should be the starting point of negotiations. "They said negotiations could only take place in the context of a ceasefire or reduction of hostilities. 'Zelenskiy's chief of staff, Andriy Yermak, who took part in the talks with European leaders and U.S. officials, said Ukraine was grateful for their constructive approach."A ceasefire is necessary - but the front line is not a border," Yermak said on X, reiterating Kyiv's position that it will reject any territorial concessions to Russia. Yermak also thanked Vance for "respecting all points of view" and his efforts toward a "reliable peace". European representatives put forward a counterproposal, a European official said, declining to provide details.

The Wall Street Journal said the counterproposal included demands that a ceasefire must take place before any other steps are taken and that any territorial exchange must be reciprocal, with firm security guarantees. "You can't start a process by ceding territory in the middle of fighting," the newspaper quoted a European negotiator as saying. A U.S. official said hours-long meetings at Chevening "produced significant progress toward President Trump's goal of bringing an end to the war in Ukraine, ahead of President Trump and President Putin's upcoming meeting in Alaska. "The White House did not immediately respond when asked about the European counterproposals.

British Prime Minister Keir Starmer and French President Emmanuel Macron spoke and pledged to find a "just



and lasting peace" in Ukraine and "unwavering support" for Zelenskiy while welcoming Trump's efforts to end the fighting, a Downing Street spokesperson said. It was not clear what, if anything, had been agreed at Chevening, but Zelenskiy called the meeting constructive. "The path to peace for Ukraine should be determined together and only together with Ukraine, this is the key principle," he said in his evening address to Ukrainians. Macron stressed the need for Ukraine to play a role in any negotiations. "Ukraine's future cannot be decided without the Ukrainians, who have been fighting for their freedom and security for over three years now," he wrote on X after what he said were calls with Zelenskiy, German Chancellor Friedrich Merz and Starmer. "Europeans will also necessarily be part of the solution, as their own security is at stake."

Zelenskiy has made a flurry of calls with Ukraine's allies since Trump envoy Steve Witkoff visited Moscow on Wednesday, where, Trump said, he achieved "great progress". Ukraine and the EU have pushed back on proposals that they view as ceding too much to Putin, whose troops invaded Ukraine in February 2022. Russia justifies the war on the grounds of what it calls threats to its security from a Ukrainian pivot towards the West.Kyiv and its Western allies say the invasion is an imperial-style land grab. Moscow has claimed four Ukrainian regions - Luhansk, Donetsk, Zaporizhzhia and Kherson – as well as the Black Sea peninsula of Crimea, which was annexed in 2014Russian forces do not fully control all the territory in the four regions, and Russia has demanded that Ukraine pull out its troops from the parts that they still control. Ukraine says its troops still have a small foothold in Russia's Kursk region a year after they crossed the border to try to gain leverage in any negotiations. Russia said it had expelled Ukrainian troops from Kursk in April. Tatiana Stanovaya, a senior fellow at the Carnegie Russia Eurasia Center, said the current peace push was the first "more or less realistic" attempt to stop the war but she remained sceptical about the agreements being implemented.

"There is virtually no doubt that the new commitments could be devastating for Ukraine," she said. Fierce fighting is raging along the more than 1,000-km (620-mile) front line in eastern and southern Ukraine, where Russian forces hold around a fifth of the country's territory. Russian troops are slowly advancing in Ukraine's east, but their summer offensive has so far failed to achieve a major breakthrough, Ukrainian military analysts say. "Not a single serviceman will agree to cede territory, to pull out troops from Ukrainian territories," Olesia Petritska, 51, told Reuters as she gestured to hundreds of small Ukrainian flags in the Kyiv central square commemorating fallen soldiers.

Kyiv says its attacks inside Russia are aimed at destroying infrastructure that is key to Moscow's war efforts, including energy and military infrastructure, and are in response to Russia's continued strikes.

### Iran threatens planned Trump corridor envisaged by Azerbaijan-Armenia peace deal



DUBAI/MOSCOW, GNS News Agency, August 19-Iran threatened on Saturday to block a corridor planned in the Caucasus under a regional deal sponsored by U.S. President Donald Trump, Iranian media reported, raising a new question mark over a peace plan hailed as a strategically important shift.

A top Azerbaijani diplomat said earlier that the plan, announced by Trump on Friday, was just one step from a final peace deal between his country and Armenia, which reiterated its support for the plan. The proposed Trump Route for International Peace and Prosperity (TRIPP) would run across southern Armenia, giving Azerbaijan a direct route to its exclave of Nakhchivan and in turn to Turkey. The U.S. would have exclusive development rights to the corridor, which the White House said would facilitate greater exports of energy and other resources.

It was not immediately clear how Iran, which borders the area, would block it but the statement from Ali Akbar Velayati, top adviser to Iran's supreme leader, raised questions over its security. He said military exercises carried out in northwest Iran demonstrated the Islamic Republic's readiness and determination to prevent any geopolitical changes. "This corridor will not become a passage owned by Trump, but rather a graveyard for Trump's mercenaries," Velayati said. Iran's foreign ministry earlier welcomed the agreement "as an important step toward lasting regional peace", but warned against any foreign intervention near its borders that could "undermine the region's security and lasting stability". Analysts and insiders say that Iran, under mounting US pressure over its disputed nuclear programme and the aftermath of a 12-day war with Israel in June, lacks the military power to block the corridor. Trump welcomed Azerbaijani President Ilham Aliyev and Armenian Prime Minister Nikol Pashinyan in the White House on Friday and witnessed their signing of a joint declaration aimed at drawing a line under their decades-long on-off conflict. Russia, a traditional broker and ally of Armenia in the strategically important South Caucasus region which is crisscrossed with

oil and gas pipelines, was not included, despite its border guards being stationed on the border between Armenia and Iran. While Moscow said it supported the summit, it proposed "implementing solutions developed by the countries of the region themselves with the support of their immediate neighbours – Russia, Iran and Turkey" to avoid what it called the "sad experience" of Western efforts to mediate in the Middle East.

Azerbaijan's close ally, NATO member Turkey, welcomed the accord. Baku and Yerevan have been at odds since the late 1980s when Nagorno-Karabakh, a mountainous Azerbaijani region mostly populated by ethnic Armenians, broke away from Azerbaijan with support from Armenia. Azerbaijan took back full control of the region in 2023, prompting almost all of the territory's 100,000 ethnic Armenians to flee to Armenia. "The chapter of enmity is closed and now we're moving towards lasting peace," said Elin Suleymanov, Azerbaijan's ambassador to Britain, predicting that the wider region's prosperity and transport links would be transformed for the better. "This is a paradigm shift," said Suleymanov, who as a former envoy to Washington who used to work in President Aliyev's office, is one of his country's most senior diplomats. Suleymanov declined to speculate on when a final peace deal would be signed however, noting that Aliyev had said he wanted it to happen soon. There remained only one obstacle, said Suleymanov, which was for Armenia to amend its constitution to remove a reference to Nagorno-Karabakh. "Azerbaijan is ready to sign any time once Armenia fulfils the very basic commitment of removing its territorial claim against Azerbaijan in its constitution," he said. Pashinyan this year called for a referendum to change the constitution, but no date for it has been set yet. Armenia is to hold parliamentary elections in June 2026, and the new constitution is expected to be drafted before the vote. The Armenian leader said on X that the Washington summit had paved the way to end the decades of conflict and open transport connections that would unlock strategic economic opportunities. Asked when the transit rail route would start running, Suleymanov said that would depend on cooperation between the U.S. and Armenia whom he said were already in talks. Joshua Kucera, Senior South Caucasus analyst at International Crisis Group, said Trump may not have got the easy win he had hoped for as the agreements left many questions unanswered. The issue of Armenia's constitution continued to threaten to derail the process, and it was not clear how the new transport corri-

"Key details are missing, including about how customs checks and security will work and the nature of Armenia's reciprocal access to Azerbaijani territory. These could be serious stumbling blocks," said Kucera. Suleymanov played down suggestions that Russia, which still has extensive security and economic interests in Armenia, was being disadvantaged. "Anybody and everybody can benefit from this if they choose to," he said.

### Thailand again accuses Cambodia of planting land mines as 3 soldiers are hurt by blast along border

GNS News Agency, August 19Three Thai soldiers on patrol were wounded Saturday (August 9, 2025) when one stepped on a land mine in territory along the border with Cambodia, Thailand's army announced. The incident came just two days after the two countries reaffirmed their adherence to a ceasefire to end a brief armed conflict. The Army's statement said the incident took place in Thailand's Sisaket province and "clearly demonstrates to both domestic and international society that the use of concealed weapons in border areas continues to exist, constituting a clear violation of the Ottawa Convention by the Cambodian side." The Ottawa Convention, also called the Anti-Personnel Mine Ban Treaty, is an international agreement banning the weapons' use, and both Thailand and Cambodia have committed to

A statement from Thailand's Foreign Ministry said the incident confirmed the Thai Army's findings "that new land mines are being laid in blatant violation of international law." It also noted this was the third such incident in less than a month. Five days of armed conflict broke out last month, killing dozens of people on both sides, including civilians, and displacing more than 260,000. The fighting broke out a day after five Thai soldiers were wounded when one tripped an antipersonnel mine in disputed territory. A ceasefire that took effect on July 29 ended major fighting, though tension remained high. The two countries on Thursday at a meeting in Malaysia committed to a 13-point agreement on implementing their truce. The Thai Army statement, citing its spokesperson Maj. Gen. Winthai Suvaree, charged that Saturday's mine explosion constituted "a significant obstacle to the implementation of ceasefire measures and peaceful resolution of problems." A statement issued in response by the Cambodian Mine Action and Victim Assistance Authority denied Thailand's allegation that Cambodia had laid new



mines.

"We have not, and will not, plant new land mines," said the statement, noting that Cambodia is a party to the Anti-Personnel Mine Ban Treaty Convention, "and has an internationally recognised record of removing, not deploying, these indiscriminate weapons."It noted that Cambodia has cleared more than 1 million mines and nearly 3 million other pieces of unexploded ordnance left over from more than three decades of war and civil unrest that began in 1970. Cambodia had suggested that two earlier explosions last month wounding Thai soldiers might be land mines from past conflicts. Tensions had simmered since May this year when a Cambodian soldier was shot dead by Thai troops in a brief fracas in another contested border area. The escalating dispute was marked by border crossing restrictions and cross-border boycotts and bans of goods and services before fighting broke out. In Saturday's incident, a Thai sergeant major suffered severe injuries, including losing his left foot, said the Thai army statement, while two privates suffered lesser injuries.

### Caste Hindus begin razing 'untouchability wall' in Karur after revenue officials, police intervene

Hindus belonging to Thottia Naicker community, an intermediate caste, who had built an "untouchability wall" allegedly to prevent access to people belonging to Arunthathiyar community, a Scheduled Caste, at Muthuladampatti in Karur in Tamil Nadu began removing the structure on Saturday amid tight security. The wall, measuring about 200 feet in length and 10 feet in height, was raised about three weeks ago on a piece of government poramboke land despite strong objections raised immediately by residents from the SC community who alleged that it was a "wall of untouchability".

Since the erection of the wall, it became a bone of contention between the caste Hindus and the SC community members. While the SC population claimed that the wall was meant to deny them access to areas where the caste Hindus lived, the caste Hindus denied the charge and claimed they had built the wall to prevent anti-social activities by 'outsiders' under the influence of alcohol. Members of the same intermediate caste had reportedly blocked attempts by the Arunthathiyars to build a stage for organising programmes during the annual Sri Muthumariamman Temple festival, and a public toilet on poramboke land. The Revenue department had served a notice a few days ago on the "Kothukarar", leader of the intermediate caste group, to remove the wall within 15 days, citing that the land on which the wall had been raised was a government poramboke land. Moreover, no permission had been obtained to construct the wall. However, the community representatives contented that the wall was not meant to deny



access to the SC people but to prevent the anti-social activities of 'outsiders'. They refused to tear down the wall.Potential to stoke caste clash

Since the issue had the potential to cause caste clashes in the area, the Revenue department served one more notice on Friday night directing the caste Hindus to remove the wall by 11 a.m. on Saturday (August 9, 2025). Strongly opposing the action, a large number of them staged a sit-in protest at the Collector Office on Friday night. They returned to their settlement after revenue officials made it clear that the wall would be demolished on Saturday. As the revenue and police personnel, led by Karur Superintendent of Police K. Josh Thangaiah, began to assemble at the controversial site on Saturday morning, the leaders of the intermediate caste group came forward to destroy the wall on

# Broken swings, damaged pathways, overgrown grass: Why Delhi's parks are no longer a walk in the park

It is 7.30 am on Thursday. A woman sits on a rusty double chest press machine at an open-air gym, struggling to pull down the jammed handles. Sweat trickles down her face. "I've come to this park every day since last year. After I turned 50 and was diagnosed with diabetes, my doctor advised me to walk and exercise," she says, her face momentarily obscured by a cloud of dust as a passerby walks by on a path with broken tiles.

Nearby, a few boys play badminton while others perch precariously on broken benches. Walkers tread carefully, sidestepping piles of garbage. The plants are long dead, and the ground is blanketed in dust. "When the park first opened, there were many swings, but no one bothered to repair them once they broke. There used to be a walking track too, now there's not a single tile left," says Shamsher Ali, in his 50s, who has been visiting the park for his morning strolls for 25 years. He claims he has not seen a single gardener in the last year. This is the Municipal Corporation of Delhi's park in Pocket 11, Jasola Vihar, in Abu Fazal Enclave. But it's far from an isolated case. Across Delhi, many public parks maintained by government bodies show similar signs of neglect — broken equipment at open-air gyms, garbage piled along boundary walls, damaged walking tracks, overgrown grass, and unpruned trees. The MCD maintains 15,320 parks across its 12 zones, according to the last Standing Committee meeting, in the Capital. According to the civic body, there are 6,433 sanctioned posts for gardeners in the horticulture department, but 71.5% of them remain vacant. Currently, 1,018 gardeners are employed on a permanent basis, and 812 work under the Welfare Measure scheme, which offers contractual appointments to the sons, daughters, or wives of deceased gardeners. The horticulture department said it follows the CPWD manual, which prescribes 1 mali for 1.35 acres. The manual serves as a guidebook, providing a framework for planning and executing projects. Abu Fazal Enclave ward councillor Ariba Khan says a shortage of gardeners in her area is making it difficult to maintain the parks. "This park was initially under the DDA but was later transferred to the MCD. However, there's a lack of resources. If the corporation doesn't fix the borewell, how are we supposed to plant trees — and who will maintain them? How can just a handful of gardeners set up a ladder, climb to do pruning, and also cut the grass in multiple parks at the same time?" she asks.Delhi The Municipal Corporation of Delhi's park in Pocket 11, Jasola ViharAt Rajesh Pilot Memorial Park, in Gharoli ward, Shahdara, it's not neglect but unchecked overgrowth that plagues the space. Tall grass has taken over nearly the entire park, with benches buried within it — some even obstructed by fallen trees.

Around 10-15 cows have become the park's unofficial 'maalis', grazing on the grass one patch at a time. However, according to the MCD, cattle grazing is prohibited in public parks. In one corner, several play installations stand — all broken. A seesaw is missing its seat, and the stationary cycle has a cracked metal one. Tarun Anand (47), a resident of the area, claims no gardener has come for the last two years. "There have been instances where the elderly have fallen due to the broken pathways," he says. Another resident adds that many people steal equipment at night and sell it. Vinod Chaudhary (50), a supervisor overseeing 90 parks in the ward since January, says he has only seven gardeners to maintain them all. "Out of the

seven, five are on contract, and their tenders keep expiring. How can I manage every park like this?" he says. Chaudhary says there is an additional problem of a lack of equipment, as there is only one grass cutter machine available at present against the required three. Kondli ward councillor Munesh Dedha, under whose ward the park falls, says, "I have 250 parks in my ward, but only 14-18 gardeners. I have spoken to the MCD Commissioner, he said will provide the funds." Around 18 km away, in Mahipalpur — part of the Najafgarh zone — is yet another neglected park. Narrow lanes branching off from the main road lead to a large ground, half of which is overrun with moss and tall grass, while the other half houses a barely functional open gym. A walking track is nowhere to be seen. Square black mats, meant to serve as flooring in the gym area, are covered in dust — some are even submerged in water. At the centre of the park, tadpoles wriggle in a

Rani Gupta, seated on a bench just a few metres from the park's entrance, gestures around and says, "Everything is damaged. Shouldn't there be grass in a park? Every authority is just lazy — nobody wants to work." Delhi A waterlogged park in Mahipalpur. Half the space is overrun with moss and tall grass 5. A barely functional open gym at the Mahipalpur parkHailing from UP's Banaras, she has lived in the locality for the past 15 years and says the park has remained in the same dilapidated state ever since. "Nobody comes here to inspect anything — repairs are out of the question," says Manish Gupta, 45, a resident since 1991. "My mother doesn't even walk here anymore because of the stray dogs inside." Inderjeet Sehrawat, Mahipalpur ward councillor, says the park comes under the Delhi Development Authority (DDA), so he is not aware of the condition.

In Pandav Nagar, the park in J Block has seen a dip in visitors. Archana Sharma says, "I slipped here once because the walking track has come loose at several spots." She now prefers the park in D Block for her morning walks. The entrance is littered with garbage from nearby houses. Residents say the trees need pruning. A heavy branch fell a week ago and still lies in a corner, blocking part of the walking path. For a group of elderly women who spend two hours here every day, the park holds a special nostalgia — it's how they start their mornings. "We used to come here in winter to enjoy the morning sunlight, but now the trees have grown so tall that they block the light," says Usha Devi, 65, a resident. "When I first started coming, the park was beautifully maintained. Now, a sweeper comes only once a month, but even he just piles the garbage in a corner. Where is the money meant for maintaining the park going?"Delhi Inderjeet Sehrawat, Mahipalpur ward councillor, says the park comes under the Delhi Development Authority (DDA), so he is not aware of the conditionYashpal Singh, councillor of the Pandav Nagar ward, says there are seven parks in the ward, maintained by just two gardeners. "We are in the process of securing Rs 25 lakh from the MLA fund for construction and repair of walking tracks in the J Block park, and an additional Rs 25 lakh from the MP fund for overall park maintenance," he says. He adds that while the MCD's work has been lacking, residents also need to refrain from dumping garbage in the parks. In E Block of Preet Vihar, locals say they have been taking care of the colony park for 13 years. Pratibha Sharma, a resident, claims that no official from the MCD's horticulture department has visited the park in the last 10 years. "We've hired private gardeners to trim the grass and handle basic tasks, but only MCD staff can do pruning," she adds. When contacted, an official from the MCD's horticulture department says many gardeners have retired, leaving very few permanent staff. He adds that while the horticulture department allocates budgets for walking tracks, their construction is overseen by the engineering department. The civic body also stated "Light pruning is done regularly, but for heavy pruning, permission must be obtained from the forest department." Back at the Jasola park, the woman struggling with the chest press machine has given up. Wiping the sweat from her brow, she joins other walkers on the broken-tiled path. "Maybe they'll clean it before August 15," she says with a faint smile, "but after that, it will be the same again."

#### Daniella Weiss: Settler godmother

In July, British journalist Piers Morgan asked Daniella Weiss, an Israeli settler leader appearing on his show, how she felt about the killing of 20,000 Palestinian children in Gaza since October 7, 2023. Ms. Weiss, dressed in a crisp white button-down shirt and a blue-and-white patterned headscarf, responded with a grin, "Arabs around should stop attacking Israel." Mr. Morgan repeated the question six more times, before pressing her: "I will give you one last chance to offer some sympathy, or empathy or sorrow about the deaths of 20,000 children in Gaza. Are you capable of doing that?" Ms. Weiss's initial response was a laugh, followed by repeated claims that Arab children are taught "to hate Jews". "You know what, you couldn't give a damn, could you? You don't care and all you want is all the Palestinians gone," said a visibly irritated Mr. Morgan before wrapping up the session, with a smiling Ms. Weiss remarking, "The audience will judge". Ms. Weiss, a prominent figure in the settler movement since the 1970s, which has promoted illegal Jewish settlements in the occupied West Bank and East Jerusalem, returned to the spotlight in recent years after Hamas's October 7 attack. After the war began, Ms. Weiss stepped up her campaign to resume Jewish settlements in Gaza, while settlers went on rampages in the West Bank against the local Palestinian communities.

Born in 1945 in Bnei Brak, an Orthodox Jewish suburb of Tel Aviv, then part of the British-ruled Palestine, Daniella Weiss grew up attending a religious school in Ramat Gan before studying English literature and philosophy at Bar-llan University. Her father, born in the U.S., and mother, born in Poland, were members of Lehi(the Fighters of the Freedom of Israel), a Zionist paramilitary group founded in 1940, in Palestine.

After the 1967 war, in which Israel captured the West Bank and East Jerusalem from Jordan, Gaza and Sinai from Egypt, and the Golan Heights from Syria, a new wave of Zionist activism pushed for settlements in the occupied territories. Ms. Weiss, who described the outcome of the war as "a miracle... in the dimensions of a Biblical scene", joined Gush Emunim, a right-wing extremist settler movement. "I felt that I wanted to be an active part in this miraculous happening," she later said about her association with the settler movement.

Ms. Weiss and her family settled in the West Bank settlement of Kedumim, where she served as the Mayor from 1996 to 2007. Since the 1970s, settlements have flourished in both the West Bank and East Jerusalem. Today, roughly 4,50,000 Jewish settlers live in the West Bank and 2,50,000 in East Jerusalem. In 2005, more than 10,000



settlers in Gaza were pulled back by the government of Prime Minister Ariel Sharon, following five years of violent Hamas resistance during the Second Intifada — a decision Ms. Weiss calls "a mistake". She claims hundreds of Jews are today ready to move into Gaza immediately if they get government permission. A close ally of Bezalel Smotrich, Israel's far-right Finance Minister who advocates the expulsion of Palestinians from Gaza and its resettlement with Jews, Ms. Weiss is currently affiliated with the Nachala Settlement Movement, which works to expand Jewish settlements in disputed areas. Nachala, which calls for "conquest, immigration and settlement in Gaza", says it has already registered 500 families for future settlement in the enclave. The group wants the war to continue "until the enemy is destroyed". Its main slogan: "Twenty years later, we are returning to the Gaza Strip." In November 2024, Ms. Weiss went to northern Gaza in an IDF-sanctioned trip to survey locations for Jewish resettlements.

Since the October 7 attacks, violence by Jewish settlers against the local Palestinian population has surged. Sixteen Palestinian communities have been driven from their land and 175 Palestinians killed. The escalating attacks prompted the Canadian and British governments to impose sanctions on Jewish settler leaders, including Ms. Weiss.But Ms. Weiss does not seem to care. For her, the borders of the Jewish nation stretch from "the Euphrates in the east to the Nile in the southwest" (this would include a host of modern states in West Asia and Africa such as Palestine, Jordan, Syria, Lebanon, Iraq and part of Egypt). As for Gaza, she is unequivocal. "Gaza Arabs will not stay in the Gaza Strip. Who will stay? Jews," she said recently. "The world is wide. Africa is big. Canada is big. The world will absorb the people of Gaza. How do we do it? We encourage it."

### A month on, how Vadodara bridge collapse has hit families, students, vendors & industries

Nearly a month since a segment of the Mujpur-Gambhira bridge collapsed in the morning of July 9, taking along with it 22 persons into a watery grave in the Mahisagar river in Padra taluka of Vadodara district, a fresh wave of grief gripped the mourning families of Bamangam and villages in Padra taluka. News has arrived of the funeral of the 22nd victim of the tragedy being held in Nani Sherdi village in Borsad, nine kilometres away. Dilipsinh Padhiyar, 24, from Nani Sherdi village in Borsad taluka, succumbed to his injuries, 27 days after the incident. In Nani Sherdi on Wednesday (August 6), Dilipsinh Padhiyar was cremated as per family rituals — his inconsolable young wife stumbling as she walked around his mortal remains to pay her last respects, with support of other women. On July 9, Dilipsinh was on a two-wheeler, returning from his night shift at a pharma company in Bharuch, when the bridge collapsed around 7.30 am. Dilipsinh was among the four injured to be initially rescued. Another injured person, Narendra Parmar, had also succumbed to his injuries during treatment. Along with grief, anger has also swept over the overwhelmed families as well as local residents, who have not only felt the pain of their neighbours in the villages but also suffered loss of livelihood or education in some ways.

Ashok Padhiyar from Bamangam says, "The families who have lost their loved ones are yet to come to terms. At the same time, the sudden loss of the population at large cannot be quantified. Many of us have lost our sources of livelihood and we are staring at a bleak future. Several students have dropped out of college as of now as the travel time is too much and similar courses are not available nearby... We do not know when the new bridge will be constructed to restore normalcy in our lives..."Local sweet shops on the route are ready for the upcoming Raksha Bandhan, but the mood is sombre.

Gambhira (From left) Mohan Chavda's wife, Dilipsinh's brother Ghanshyam, Hitesh Chavda and Atul Rathod's brother Ketan A store owner, who has stacked sweets, says, "Usually, rakhi celebrations would have meant visitors arriving days in advance. But the collapsed bridge has disrupted travel to this side... The number of motorists who would stop by and make purchases has drastically reduced. It is a loss we never imagined. The last month has seen the lowest business since the Covid19 pandemic... I do not know how I will make up for this in the near future?"

Another villager, who earned a living by selling vegetables in the bustling vegetable market in Padra — which is also known as the vegetable bowl of the region — says that travel to Padra via the bridge that was just about 10 minutes drive has now turned into an hour-long detour through the district, incurring additional transportation costs. "For many farmers, selling fresh produce of vegetables, fruits and flowers from the district to the market in Padra and Vadodara now means additional expenditure on transport... This is a long-term problem with no solution in sight. The government has only just announced a new bridge. We do not know when it will be ready." says the vendor. Many residents of the 40 affected villages in Anand district, who used to commute to work in pharma and food manufacturing companies in Vadodara and Bharuch via the bridge, say they have been forced to quit jobs due to the 35-40 kilometer detour to get to work.

Hitesh Chavda, son of one of the victims Mohan Chavda (52), says he has quit his job as a helper at a pharma company in Luna in Padra since the incident. My brother was just 22. The bridge collapsed due to negligence on part of govt officials. People kept demanding repairs... They waited for people to die...

Chavda says, "My father travelled to work everyday. He earned a meagre salary which only helped us scrape through each month. We knew that we could not dream big due to our constraints but we never imagined that going to work itself would lead to his death... Being the only son of my parents, I now have the responsibility to look after my mother. At the moment, the detour that one needs to take to get to work will mean that my mother will continue to grieve alone. So I have guit my job for now."Another victim from Bamangam, Dilipsinh Padhiyar, who was travelling to work with Mohan Chavda on the fateful day, has left behind his young family. His younger brother, Ghanshyam (23), said that the families are undergoing extreme "anxiety and traumatic stress" since the incident a month ago. Ashok Padhiyar, a villager who has been extending support to the families since the day of the incident, says that while the grieving families have received the government compensation, the amount is nothing close to what one would need to live a life of dignity. Ashok says, "What does the government compensation of `4 to `6 lakhs in total mean in today's times? Will Dilipsinh's widow be able to ensure a good life for her daughter? Now-a-days, even a simple wedding in a village costs more than `4 lakhs. The families have lost their breadwinners and the compensation does not match the time we are living in."

Ketan Rathod, brother of Atul Rathod (22) who was among the victims, says that the families are contemplating moving the court petition seeking a "more dignified" compensation. Ketan says, "My brother was just 22. He had his whole life in front of him, which was snatched away when he was going to work as usual because someone did not do their job. The bridge collapsed due to negligence on part of the government officials. What is the purpose of initiating action after a tragedy? The local people have kept demanding repairs but nothing was done... They waited for people to die."Kiran Mori, General Manager, District Industries Centre (DIC), Vadodara, told this newspaper that the industries have been considerate and extended different concessions to their workers as it is a genuine problem and the need for workforce is high. Mori said, "Padra has several chemical and food industries, where thousands of workers arrive every day... After speaking to the companies, as per their mutual convenience, they have decided to give some exceptions to emplyees from the affected areas. Some have given concessions in timing, allowing employees to report to work up to 30 minutes late. Some companies have asked the labour contractors to make travel arrangements. Companies who have their own buses have also changed routes for the employees or even started mini bus services. Some have also approved fuel allowance." Mori adds that the Gujarat State Road Transport Corporation (GSRTC) has started eight new bus routes from Padra to Bhadran, Jambusar and other areas.eThe direct effect of the disruption of connectivity of two districts has been seen on the industries located in Padra and Bharuch.Despite initial efforts that meant brainstorming for several days to find a solution — relaxation in reporting time, to fuel allowances and also deploying private transport to bring workers to the industries in the region — most factory owners are "at a loss" as almost 80% of the workforce has given up their jobs, President of Padra Industries Association (PIA) Pravin Rabadia said

Rabadia says that during the initial discussions with the district administrations of both Anand and Vadodara, including officials of the District Industries Centre, Labour department and the Gujarat State Road Transport Corporation (GSRTC), several suggestions were discussed. However, a month later, the industries are grappling to meet their production deadlines with lost manpower. Padra, which has two clusters of industries — Zone 1 and Zone 2 — has more than 10,000 workers employed in 160 factories. These include 69 chemical industries (comprising pharma manufacturers) as well as food industry, ceramics and other manufacturing units. Further ahead from Padra, pharma companies located towards Bharuch have also been a source of employment to about 41 villages of Anand district. Apart from these, casual workers arriving to facilitate odd jobs remain an unaccounted number.

Rabadia says, "The industries are suffering due to disruption of the route between Vadodara and Anand, which has directly resulted in loss of manpower. In our letter to the District Collector as well as the DIC on July 13, we had recommended some temporary solutions that need to be implemented at the earliest... The tragedy is painful and one cannot forget the loss of human lives. But, we need to see what we can do for the return of normalcy. We have recommended a temporary steel fabricated walk-way with a passage for at least two-wheelers at the point where the bridge has been ruptured in order to allow daily commuters to live their lives until a new bridge is constructed..."Rabadia says that despite attempts made by industries to provide transportation facilities to its workers, the response from the employees has been poor. For many farmers, selling fresh produce in the market in Padra and Vadodara now means additional expenditure on transport... This is a longterm problem with no solution in sight

"Most of these workers belong to the farmer class and allied jobs. For them, travelling eight-hour work in a company can work only if the travel time is short. Earlier, they reached the companies in about 15 minutes and now it has become close to two hours. Workers with farm responsibilities will prefer to work for lower wages closer to their villages. When I arranged a private transport for 22 workers of my factory, only two turned up... I had to discontinue it and I am exploring ways to ensure that my work is not hampered," Rabadia says.

Rabadia adds that the PIA handed over industry-wise, village-wise and person-wise list to the district administration following the bridge collapse and also helped in chalking out two routes from Anand to Padra and Bharuch to decide the number of special GSRTC buses that would be needed for transporting the workers to and from the factories. The special buses have not yet been pressed into service. Even when it starts, the increased travel time will continue to be a deterrent for the workers. The companies too need a solution. We will have to explore the option of hiring workers through private contractors, if a solution is not found... The Gambhira bridge collapse also posed a big challenge for the district administration to retrieve a chemical tanker that was stuck on the Anand end of the

It was after a meticulous planning for three days that

60 experts from the Marine Emergency Response Centre

(MERC) of Vishwakarma, a marine salvage company from Porbandar, that the tanker was successfully retrieved remotely, using specialised pneumatic marine airbags, horizontal cantilevers and strand jacks on standby and mul tiple drone cameras to monitor the operations. With the structure of the bridge compromised and the movement of heavy machinery restricted, MERC experts deployed marine technology to retrieve the vehicle. Speaking to The Indian Express, Ketan Gajjar of the MERC said: "The execution was done with a combination of lifting with the marine bags as well as pulling with the strand jacks." The process of deployment of the marine pneumatic roller bags requires proper methodology and equipment to make the system work effectively and safely. Once the pneumatic bags were successfully deployed and we are convinced that the vehicle is in an upright position to be safely pulled out, the next step was carried out... The execution was done with a combination of lifting with the marine bags as well as pulling with the strand jacks." Anand District Collector Praveen Chaudhary, who oversaw the retrieval of the tanker, said, "The tanker was successfully retrieved and handed over to the owner using the expertise of the marine salvage company that offered services free of cost."

'New bridge will come near the existing one, no plan to repair it'The collapse of the Mujpur-Gambhira bridge has meant that the daily commute of thousands of people across Vadodara and Anand districts has been disrupted, leading to loss of livelihood and even student dropouts. What are the immediate solutions? As far as students are concerned, there is a flow of students from Vadodara to Anand as well as from Borsad and other parts to Vadodara. We gave them two options — we can shift them to nearby schools, even if the capacity is full; we requested additional teachers. The second option is additional bus services to meet their demand

Most of the students have opted for being shifted to schools in Vadodara. They have been granted admission without any leaving certificates so they can study here until the connectivity is restored. It is difficult to provide alternative courses to students pursuing higher education. But eight bus routes have been added based on the requirements of the students to Padra, Vidyanagar and Anand. They have to travel about 35 kilometers more everyday. The real problem is the increased travel time of about 80 to 90 kilometers per day... It will be resolved once the new bridge is ready...We also met industry unions and associations. During the course, we gave them multiple options that they can start their own travel and bus services. Many major companies have started their own services or they can aggregate services by hiring travel operators. Some of the companies have given relaxation of time. We listed more than 100 companies and more than 5,000 employees, who were accommodated in one way or the other. But, the travel time has certainly increased and there is no quick fix for this problem. We will have to wait for the completion of the monsoon.Local villagers from both the districts are demanding that local boats be pressed into service to allow the villagers to cross the breadth of the Mahisagar and get to work on either side. Has the administration considered the request? This is the time for monsoon and Mahisagar witnesses regular monsoon floods. There is Kadana dam on the upstream and they also release a huge cache of water during the season.

## A triangular dynamic in South Asia's power politics



In the complex interplay of great power politics in South Asia, the triangular relationship between the United States, India and Pakistan reveals a story. It is one about enduring strategic necessity as much as it is about the contest of political ideologies, national interests and historical legacies. United States President Donald Trump's recent lunch with Pakistan's Army Chief, Field Marshal Asim Munir - a deliberate overture laden with both symbolism and nostalgia — resurrects the ghosts of Cold War realpolitik. Mr. Trump's repeated claims, despite India's persistent denials, of having brokered a ceasefire between India and Pakistan, using trade as a lever, alongwith his high-profile interaction with the Pakistan Army chief at the White House signals an American eagerness to revert to a diplomacy of shortcuts. The Trump administration's transactional view of diplomacy, privileging deals over doctrines, has led to a turnaround in U.S.-Pakistan relations, casting a dark shadow over the delicate trust meticulously built through decades of U.S.-India counterterrorism cooperation as well as strategic convergence on China — a feat often regarded as one of the most creditable episodes of American diplomacy after the end of the Cold War. America's pronounced shift

Mr. Trump's previous tenure as President was marked by an unusually blunt censure of Pakistan's notorious double-game of a Machiavellian policy of cooperating with western countries in counterterrorism, while simultaneously supporting terror outfits that serve its regional interests. This stance had struck a chord with New Delhi's unyielding approach toward terrorism, buttressing an already blooming 'natural partnership' with Washington. Yet, in the Trump administration's second tenure, a perceptible pivot has taken shape. Very early on, the Trump White House reopened channels of security assistance to Pakistan, notably authorising \$397 million to sustain Islamabad's F-16 fleet ostensibly for counter-terrorism purposes. Public acknowledgments from top American military officials, terming Pakistan as a "phenomenal partner" together with Mr. Trump's own gestures of gratitude toward Pakistan's cooperation in counter-terror operations, reveal an unmistakable recalibration that privileges immediate strategic utility and transactional gains over previously cultivated long-term vision of bilateral relationship. By lauding Pakistan's knowledge of Iran as "better than most", Mr. Trump has hinted at something far more combustible — that Pakistan's military could become a potential asset in navigating the volatile theatre of Iran-Israel conflict.

This American shift has naturally caused concern in New Delhi as it could prove a serious impediment to India's aspirations for a principled partnership with the Trump-led White House. The U.S., the self-styled custodian of a liberal international order that India has also sought to embrace, now appears to treat Pakistan not as a terror-permissive and nuclear-armed outcaste state, but as a strategic interlocutor deserving engagement. The recalibration is supported by multiple factors: economic incentives, personal rapport with Pakistan's military leadership, and America's continuing desire to retain leverage in Afghanistan, and the broader region surrounding China. For Pakistan, it represents a critical opportunity to retrieve lost diplomatic space and rehabilitate its tainted global image. domestic political currents inject Islamabad's willingness to fully embrace cooperation with Washington.India's doctrinal departure

Against this backdrop, the events of late April and early May have concretised the volatility inherent in South Asia's security architecture. The devastating terror attack in Pahalgam unleashed a decisive Indian military response.

India's 'Operation Sindoor' marked a doctrinal departure from the long-standing policy of strategic restraint. Prime Minister Narendra Modi's declaration of a "new normal" has signalled a readiness to transcend previous thresholds, blending kinetic military retaliation with diplomatic campaign with the intent of isolating Pakistan globally and imposing accountability on the state apparatus that enables terrorist groups aligned against India. Mr. Modi's depiction of the ceasefire as a mere pause highlights India's broader aim to alter the calculus of Pakistan's hostility, even as Beijing's close ties with Islamabad and adversarial posture toward New Delhi amplify apprehensions of a two-front confrontation. On the other hand, Pakistan has intensified its dual-track strategy that seeks to combine military posturing with diplomatic engagement with the U.S. with the aim of reviving international attention on the Kashmir issue. The unprecedented promotion of Asim Munir to the rank of field marshal also marks a consolidation of military primacy in Pakistan's national security framework. This entrenchment of a "hard state" doctrine, characterised by centralised military authority which remains fanatically resistant to civilian oversight, underscores Rawalpindi's determination to project unbending strength amid multiple internal and external pressures

Simultaneously, Pakistan is attempting to capitalise on its geopolitical location and diplomatic slyness to maintain its indispensability in America's current strategic calculations. Islamabad's outreach to Washington, which is reflected in trade negotiations, concessions over rare earth minerals, and innovative economic partnerships entwined with American business interests, suggests a cunning charm offensive to sustain international attention and economic lifelines. It is a strategy that perhaps recognises its own limitations in raw military power and economic scale but leverages the geographic centrality and personal diplomacy to maintain geopolitical relevance. The U.S.'s role in this volatile equation is characterised by a deliberate ambivalence that reflects the complexity of its competing priorities. Washington today seems to have become preoccupied to the point of obsession with tariff and trade, implying that India's role in the Indo-Pacific attracts proportionately less attention than in the past, even though the Quad Foreign Ministers held their meeting in Washington on July 1. New Delhi's persistent rejection of any third-party mediation in Kashmir underscores its determination to keep its core security issues tightly within its own sovereign domain. On the contrary, a Beijing-aligned Pakistan is desperate to embrace American engagement, perceiving it as a means to keep Kashmir from fading into diplomatic obscurity and to counterbalance India's manoeuvring space. However, any American effort to "hyphenate" New Delhi and Islamabad would run counter to ndia's vision of itself as a rising global power, while undermining bipartisan consensus to deepen ties with the U.S.

What drives Pakistan's relevance Pakistan's continued relevance in American foreign policy seems to be driven by immutable facts of geography as well as carefully honed craft of personal diplomacy, giving its military leadership an inflated sense of purpose and power. Situated at the crossroads of South Asia, Central and West Asia, and bordering Iran, Afghanistan and China, there are certain quarters in Washington prone to the view that Pakistan is an indispensable linchpin to America's regional strategy, particularly in Afghanistan and Iran where its logistical and intelligence roles are still critical. This geographic leverage likely magnifies Pakistan's diplomatic voice in Washington, reinforcing a perception in Rawalpindi that it could help Pakistan counter India's superior economic and demographic credentials. Personal rapport in diplomatic corridors often translates into material and political support, ensuring Pakistan's endurance as a contradictory, yet "phenomenal" partner. As enduring strategic sympathy for India becomes hostage to the shifting sands of personality-driven politics in the U.S., and the 'friend' in the U.S.-Pakistan frenemy dynamic gaining the upper hand, a geopolitically conscious Washington must walk a delicate tightrope. ### Hamas says it's ready for a ceasefire but wants a complete end to the war in Gaza

Hamas suggested Wednesday (July 2, 2025) that it was open to a ceasefire agreement with Israel but stopped short of accepting a U.S.-backed proposal announced by U.S. President Donald Trump hours earlier, insisting on its longstanding position that any deal bring an end to the war in Gaza.Mr. Trump said Tuesday (July 1, 2025) that Israel had agreed on terms for a 60-day ceasefire in Gaza and urged Hamas to accept the deal before conditions worsen. The U.S. leader has been increasing pressure on the Israeli government and Hamas to broker a ceasefire, and hostage agreement and bring about an end to the war.Mr. Trump said the 60-day period would be used to work toward ending the war - something Israel says it won't accept until Hamas is defeated. He said that a deal might come together as soon as next week. But Hamas' response, which emphasised its demand that the war end, raised questions about whether the latest offer could materialise into an actual pause in fighting. Hamas official Taher al-Nunu said that the militant group was "ready and serious regarding reaching an agreement."He said Hamas was "ready to accept any initiative that clearly leads to the complete end to the war."A Hamas delegation is expected to meet with Egyptian and Qatari mediators in Cairo on Wednesday (July 2, 2025) to discuss the proposal, according to an Egyptian official. The official spoke on condition of anonymity, because he wasn't authorised to discuss the talks with the media. Throughout the nearly 21-month-long war, ceasefire talks between Israel and Hamas have repeatedly faltered over whether the war should end as part of any deal. Hamas has said that it's willing to free the remaining 50 hostages, less then half of whom are said to be alive, in exchange for a complete Israeli withdrawal from Gaza and an end to the war.lsrael says it will only agree to end the war if Hamas surrenders, disarms and exiles itself, something the group refuses to do. An Israeli official said that the latest proposal calls for a 60-day deal that would include a partial Israeli withdrawal from Gaza and a surge in humanitarian aid to the territory. The mediators and the U.S. would provide assurances about talks on an end to the war, but Israel isn't committing to that as part of the latest proposal, the official said. The official wasn't authorised to discuss the details of the proposed deal with the media, so spoke on condition of anonymity. It wasn't clear how many hostages would be freed as part of the agreement, but previous proposals have

called for the release of about 10. Israel has yet to publicly comment on Mr. Trump's announcement. On Monday



(June 30, 2025), Mr. Trump is set to host Israeli Prime Minister Benjamin Netanyahu for talks at the White House, days after Ron Dermer, a senior Netanyahu adviser, held discussions with top U.S. officials about Gaza, Iran and other matters. On Tuesday (July 1, 2025), Mr. Trump wrote on social media that Israel had "agreed to the necessary conditions to finalise the 60 Day CEASEFIRE, during which time we will work with all parties to end the War." Hope, for the good of the Middle East, that Hamas takes this Deal, because it will not get better — IT WILL ONLY GET WORSE," he said.

Mr. Trump's warning may find a sceptical audience with Hamas. Even before the expiration of the war's longest ceasefire in March, Mr. Trump has repeatedly issued dramatic ultimatums to pressure Hamas to agree to longer pauses in the fighting that would see the release of more hostages and a return of more aid to Gaza's civilian populace.Still, Mr. Trump views the current moment as a potential turning point in the brutal conflict that has left more than 56,000 dead in the Palestinian territory. The Gaza Health Ministry doesn't differentiate between civilians and combatants in its death count but says that more than half of the dead are women and children. The war began on October 7, 2023, when Hamas-led militants attacked southern Israel. killing 1,200 people and taking roughly 250 hostages. The war has left the coastal Palestinian territory in ruins, with much of the urban landscape flattened in the fighting. More than 90% of Gaza's 2.3 million population has been displaced, often multiple times. And the war has sparked a humanitarian crisis in Gaza, pushing hundreds of thousands of people

### Judiciary should not override executive's decision to deport a foreign national: Home Ministry



The Union Home Ministry's (MHA) appeal against a Jammu and Kashmir High Court order to repatriate a 62year-old housewife who was deported to Pakistan post Pahalgam terror attack said the "judiciary should not override" the executive's decision to deport a foreign national.It said the High Court order was constitutionally impermissible and unsustainable, as it directed the enforcement of a judicial writ beyond the sovereign territory of India to Pakistan, where she was deported and was thus ultra vires. The Ministry also said that the court's direction was "legally unenforceable and diplomatically untenable". "There exists no extradition treaty, legal instrument, or international obligation binding Pakistan to return her to India. The Indian government cannot, under existing international law, compel a sovereign nation to surrender a non-citizen," the MHA said. The Home Ministry said "courts must preserve the institutional boundaries necessary for effective governance" and the order, if allowed to stand, would establish a dangerous precedent.

The MHA filed a Letters Patent Appeal (LPA) before a Division Bench of the High Court against a June 6 order by Judge Rahul Bharti who directed the Union Home Secretary to bring back the petitioner Rakshanda Rashid in 10 days. Married to an Indian, Ms. Rashid had been staying in Jammu for 38 years on a Long-Term Visa (LTV), which was extended annually even as her citizenship application

is pending with the MHA since 1996. On April 29, at the time of deportation, the LTV did not exist, the MHA said. Ms. Rashid had said in her petition that she applied for LTV renewal in January and the application was never rejected. After the April 22 Pahalgam terror attack, where 26 people were killed, the MHA cancelled the visas of all Pakistani citizens and asked them to leave the country by April 29 The order exempted those with LTVs or Pakistani women married to Indian citizens. The Ministry said that while passing the order, the single judge "failed to appreciate the circumstances and the national security considerations and the reasonable apprehension posed by the Pakistani nationals staying in India on account of war-like situation between India and Pakistan." It added that the order is "contrary to the principles of judicial restraint in the matters concerning national security and international relations, particularly in dealing with the national of a hostile country." It said the order was "based on assumption that marriage to an Indian citizen entitles her to claim a right to reside in India or to have her deportation reopen." Subject to control" It is well settled law that a foreign national does not acquire Indian nationality or legal residency rights solely by virtue of marriage. A foreigner does not possess a fundamental right to reside in India and their entry and stay are subject to regulatory control of the state under Foreigners Act, 1946. Because it is a trite law that a foreign national do not enjoy rights guaranteed under Article 19. The only fundamental right available to a foreigner is under Article 21 of the Constitution of India which does not confer any right to remain in India once a visa expires or is revoked," the MHA said. The Ministry said the order would set a dangerous precedent and "may be cited by foreign nationals to invoke Article 226 for personal repatriation" and the outcome "threatens the integrity of constitutional separation and immigration enforcement alike."The judiciary, by ordering the repatriation of a foreign national from another sovereign country, had encroached on into the domain of the Union Executive, whose functions under Article 73 include decisions regarding foreign relations, immigration policy, and national security, the Home Ministry said.

### Blood and data leaks | The dark side of period tracking apps

If you are a young gadget user with a uterus, chances are that alerts about your upcoming period now come from your smartphone or your smartwatch. Period tracking apps have made it easier not just to stock sanitary pads and painkillers (and perhaps some chocolate), but they also prompt menstruating users to log their physical symptoms, track their mental health, detect potential reproductive conditions, and plan sexual intercourse based on their fertility levels. Period tracking tools are incredibly diverse, with the Apple and Google app storefronts offering many such apps that have seen millions of user downloads. Basic apps are free and merely remember the user's menstrual cycle dates to estimate their future dates. Others offer premium features and advanced data processing so that users can share detailed health and fertility reports with their partner or a healthcare provider. Period apps can now send reminders and health alerts from a variety of devicesPeriod apps can now send reminders and health alerts from a variety of devices | Photo Credit: Simple Design Ltd. via Google Play

The more information users provide about their periods and health, the better the app gets. For this reason, period tracking app users are often encouraged to key in highly personal health information such as food cravings, bowel motions, vaginal discharge or cervical mucus, weight fluctuations, changes in breast texture, sexual activity, period flow, mental health issues, pregnancy status, and even daily facial pimples. Needless to say, this information is a treasure trove for brands and unscrupulous third-parties who want to harvest such data in order to push ads at an opportune moment. For example, a company selling "wellness" supplements that claim to reduce menstrual discomfort would want to market their ads in the Instagram feed of a young user with a history of painful period cramps, rather than to someone with a uterus. Having the data makes all the difference. More worryingly, a period tracking app could be used as evidence by law enforcement authorities in regions where abortions have been criminalised. Period app data could also be misused by abusers to harass the user, discriminate against them, carry out acts of violence, or stop them from accessing abortions. So, are period tracking apps meeting the mark when it comes to protecting their users' data? On the flip side, is it possible that people are relying on their period tracking apps a little too much? The Google Play Store requires app developers to provide up-to-date information about their services, and explain to users how their personal data will be collected or shared. The Clue Cycle & Period Tracker by BioWink with over 50 million downloads on the Google Play Store noted that it may share health and fitness info for app functionality and personalisation purposes. The app profile clarified that health/ fitness information may be collected on an optional basis.

Period tracking apps compile and process vast amounts of highly personal health data shared by their usersThe Flo Period & Pregnancy Tracker by Flow Health Inc. with over 100 million downloads, meanwhile, noted that no data was shared with third parties. However, information such as the user's approximate location and their health/ fitness information could be collected on a largely optional basis for app functionality purposes, developer communications, and personalisation. The user's approximate location could be collected for 'advertising or marketing.'The Period Calendar Period Tracker by Simple Design Ltd. with over 100 million downloads noted that while it might collect health/fitness information for app functionality (on an optional basis), this would not be shared with other companies or organisations. However, there are multiple apps that did not offer robust data protection measures. For example, Wachanga's Clover—Period & Cycle Tracker app with over five million downloads on the Google Play Store noted that it may share data including users' approximate location and their email address for purposes that included 'advertising or marketing.' The app developer also did not provide information about how users could request data deletion. Other period tracking apps seen by The Hindu perpetuated pseudo-scientific ideas such as syncing one's menstrual cycle with the moon' phases, or even comparing cycles with friends. A number of period tracking tools on app storefronts promote highly unscientific ideas

A number of critical 1-star and 2-star app reviews for Clue, Flo, Period Calendar Period Tracker, and Clover all claimed that the apps themselves overused ads to push users into paying for premium features, or repeatedly nagged users to become paying subscribers, or made them view third-party ads in order to use the app. Many of these reviews outlined users' irritation with the intrusive ads, while others expressed frustration because months or years of



health data had been logged into the app and transferring it to another service was a challenge. More worryingly, those using period tracking apps should be aware that a Google Play developer notice is not a data privacy guarantee. In January 2021, the U.S. Federal Trade Commission (FTC) regulator reported that Flo Health Inc. had settled over allegations that it "shared the health information of users with outside data analytics providers after promising that such information would be kept private."

The company shared "health data from millions of users" from the Flo Period & Ovulation Tracker app to firms including Facebook's analytics division, Google's analytics division, Google's Fabric service, AppsFlyer, and Flurry, ΓC's complaint.The Hindu Flo, Wachanga, and Simple Design for comment on the user privacy policies of each app. Only Clue and Simple Design responded. Clue CEO Rhiannon White said that app users' health data was shared under very specific circumstances and under strict limitations and protocols, for user personalisation or research purposes."To be very clear, when it comes to third parties - we have never and will never sell or share sensitive health data with advertisers, insurers or data brokers. That is not our business model our business model is direct to consumer subscriptions, ensuring that our users are our customers, and we serve only them," White said. She noted that some vetted thirdparty tools would process certain usage and tracked health data, with user consent, and that such tools complied with Europe's GDPR standard. Coming to research, White explained that health data was shared in a de-identified format to help correct a "historical lack of data for research into female health.""It is up to each user whether they want to help to close that data gap by consenting to their de-identified data being used for this purpose, which is again why we offer granular consent options within the app," White told The Hindu. "By design, no tool we use processes sensitive user data in a way that could put our members' health information at risk. Ever.

"Meanwhile, Simple Design clarified that users' data was stored on their local device while opting for backup meant the encrypted file was stored only on the users' personal cloud. "No one, including us, has the right to monitor, access, or share their data," said Simple Design, adding that its app has been in operation for over 10 years and serves over 300 million users. From medical apps to appointments When used correctly, period tracking apps can help patients understand their bodies and receive better care from their doctors. However, there are risks when users overly rely on their period trackers, or do not download apps from trusted developers with strong privacy policies. There is very little verified research to support the idea that aligning one's period with the lunar cycle is helpful in any way

Dr. Batchu Sowdamini, Chief Consultant, Obstetrics & Gynaecologist, Apollo Hospitals, Health City in Arilova, Visakhapatnam, explained that a key advantage of period tracking apps was the precise identification of the fertility period, which is useful for people trying to conceive or avoid pregnancy naturally. At the same time, she noted that such apps were not a replacement for contraceptives. Tracking key elements like the length and duration of bleeding, as well as any intermenstrual spotting, helps collect useful data over time. This information, when reviewed over several months, can assist an OB-GYN in identifying patterns that may suggest underlying issues such as endometriosis, PCOS, fibroids, infertility, or even signs of cancer," she said. However, Dr. Batchu outlined some risks that period tracking apps may pose. These included clinical limitations. emotional or psychological impacts, and privacy concerns. She warned that these apps' predictive algorithms come with limitations and that they should not replace a medical diagnosis. # Around \$30-35 billion of India's merchandise exports to America at risk from Trump's tariffs, says UBS Chief India Economist



US President Donald Trump's decision to impose a total tariff of 50 per cent on India has put at risk \$30 billion-\$35 billion worth of New Delhi's exports to the world's largest economy, according to Tanvee Gupta Jain, UBS' Chief India Economist. Consequently, India — whose merchandise exports to the US in 2024 totalled \$87.3 billion, resulting in a surplus of \$45.8 billion — faces the risk of losing almost a full percentage point from its GDP growth over two years, she said. In an interview with The Indian Express Siddharth, Jain also shed light on the possibility of India reducing its purchase of Russian oil and the Indian economy's growth and inflation prospects in light of the RBI's latest monetary policy decision. Edited excerpts:

US tariff on India is now 50 per cent, with a three-week waiting period. Purely in terms of the trade relations, what is your assessment of the impact?

US President Donald Trump has now announced an additional 25 per cent tariff on India for buying oil from Russia, taking the total tariffs to 50 per cent. This additional tariff is effective from August 27, that is 21 days after the executive order. There are a few sectors including pharma, smartphones, (that) are currently under section 232 investigations and are exempted from tariffs. The exempted sectors account for \$24 billion or around 30 per cent of India's total goods exports to the US of \$87 billion. The way we look at the impact of the tariffs is as follows: we note the US accounts for \$87 billion or 20 per cent of India's goods export, or about 2.2 per cent of India's GDP. We multiply the new tariff rate with trade exposure to the US to get a 'GDP at risk' measure. Further assuming a -1 price elasticity, we estimate drag from the proposed tariffs that is 25 per cent effective from today and an additional 25 per cent effective from August 27 versus our current baseline to be 35 basis points (bps) in 2025-26 and 60 bps in 2026-27. We would stress that our estimates are subject to substantial uncertainty as the trade negotiations with the US are ongoing. In addition, other considerations for our growth forecast include how global growth pans out and if counter-cyclical policy support could help support domestic demand momentum in the face of tariff-related uncertainties. These are just scenarios that we have. We are not yet changing our estimates as a lot will depend on how the negotiations happen over the coming weeks and months.

So, the exports at risk from the tariffs are roughly \$56 billion or so. Do you have an estimate of how much that could fall by if the 50 per cent tariff stays in place?

I would say the exports at risk out of India's \$87 billion of goods exports to the US, taking into account the exemptions, are roughly around \$30 billion-\$35 billion. The 21-day pause gives some time for the negotiations to continue later this month.

Do you see any sign of a deal with the US resulting in a meaningfully lower tariff rate without India conceding ground on its two non-negotiables: agriculture and dairy?

Taking lessons from India's Asian peers that have negotiated a trade deal with the US — including Vietnam, Indonesia, the Philippines and Japan — we expect India to open its market to the US, implying zero tariffs on American goods. Like its peers, we expect India to commit to increasing purchases of energy and defence equipment from the US to bring down its goods trade surplus of \$46 billion as of 2024. However, opening up agriculture and dairy sectors to the US remains a key hurdle. These low valueadded sectors could impact Indian farmers' livelihoods especially small ones engaged in dairy production. India's dairy sector accounts for 3 per cent of nominal gross value added and provides a living for over 80 million dairy farmers. In our base case, we would expect a trade deal to happen sooner than later as any lingering uncertainty is a drag to overall growth. As per media reports, the US trade delegation is likely to visit India sometime in the last week of August as part of this discussion. So, we are hoping that something comes out of it. It is interesting that the start date of these additional tariffs, August 27, is a couple of days after the next round of talks between the US and India. India's trade with Russia is clearly an issue for the US. Can India source oil from other countries without a meaningful impact on domestic fuel prices, overall inflation, and the government's finances?

India is a net oil importer and we import almost 88 per cent of our oil requirement. So clearly, movements in oil prices will have a very important bearing on our macro stability risks, including current account, inflation, and the government's finances. Hence, it will impact the overall

economic growth prospects. Before the Russia-Ukraine conflict began in 2022, Russia's share in India's oil imports was 2 per cent. This rose to 36 per cent in 2024-25. As per UBS' oil analysts, Indian refineries are typically complex because the units are optimised to process the heavier Russian Ural. Further, the price advantage of the Ural crude to Brent, which was very favourable for India when the conflict began in 2022, has now reduced to \$2-3 per barrel on a landed cost basis. So, India may not lose much if it shifts away from Russian oil because the savings right now are only \$2 billion.But the UBS global energy team has also pointed out that the crude market is only partially pricing supply disruption due to tariff pressures on India. So, it could temporarily drive crude prices above \$70 a barrel. But if there is sufficient surplus and OPEC spare capacity, it can definitely cap the upside in prices.

There is now a pressure to finish trade deals quickly. Is there anything to be worried about in terms of these deals resulting in India giving up too much during negotiations or not extracting as favourable terms as it could have otherwise?

To be fair, India was the first country to come to the table to negotiate with the US and we are still there right now. So, it seems that India is trying to prioritise national interest and it is not in any rush to finish a trade deal quickly. The hope is that we are able to find a balanced deal between India and the US which works to both the countries' benefit.

RBI's Monetary Policy Committee stayed put on the repo rate, but you now expect an additional 25 bps rate cut in October given the uncertainty caused by the tariffs. How does one understand this additional easing given that the central bank's latest forecast puts headline retail inflation at 4.9 per cent in April-June 2026?

Our inflation forecast for 2025-26 — even before the Reserve Bank of India lowered their estimate by 60 bps to 3.1 per cent — was tracking close to 3 per cent with more downside risk. This is supported by good agricultural output, favourable monsoon, and the lower global crude oil prices. The offloading of excess China capacity in India at cheaper prices could result in a disinflationary impulse. Overlaying this disinflationary impulse with RBI's neutral policy rate assumption of 1.4-1.9 per cent, we see space for the terminal reporate to fall towards 5-5.25 per cent range. For now, we add one 25 bps rate cut in the October meeting to our baseline, with risk of another (rate cut) if growth surprises lower, driven by US trade tariffs and/or a step shift lower in global growth.

Yes, the one-year forward inflation of 4.9 per cent looks very high because of the base effect. But I would expect the new CPI inflation series, which will likely be launched early next year, to streamline that one-year forward inflation forecast. At this point, we think the RBI has kept some ammunition in the form of monetary easing support in case growth risks are skewed towards the downside. The RBI has maintained its 2025-26 GDP growth forecast at 6.5 per cent despite the global uncertainty, although it did trim it back in April by 20 bps from 6.7 per cent. Is the RBI possibly underestimating the hit to growth — not just from the tariffs themselves but also the adverse impact on corporate sentiment from the uncertainty?

I would give the RBI some benefit of doubt because the MPC meeting took place before the additional 25 per cent tariff was announced. If we only incorporate the 25 per cent tariff that was in place before the additional tariff got announced after the RBI policy, the downside risk to GDP growth in real terms for 2025-26 was only coming to around 10-15 bps, as per our estimates.

You recently launched your rural and urban economic activity indicators, where you said household consumption recovery is expected to become broad-based over the next 2-3 quarters backed by RBI's rate cuts, softer inflation, good monsoon, and income tax relief, among other factors. Will this recovery sustain without an appreciable rise in actual income levels?

The UBS India Composite Economic Indicator, our leading indicator with 15 high-frequency data points, suggests economic momentum softened in May. This is in line with our global growth nowcast which suggests that tariffs and global uncertainty dragged growth sharply in May after a resilient April, helped by US tariff front-loading including improved demand, production, and trade. Our activity indicators suggest rural activity improved, while urban activity remained subdued in the June quarter. We note that rural accounts for 46 per cent share of total consumption. Even as rural activity is gaining traction, we believe it is still too early to expect a broad-based recovery in household consumption as urban activity continues to soften. One of the factors supporting our view that household consumption could be the bright spot in 2025-26/2026-27 was urban demand will stabilise on monetary transmission, lower inflation, and policy stimulus from income tax relief and likely fuel price cuts. We were also expecting a pay boost under the pay commission. However, implementation of the Eighth Central Pay Commission seems likely to be delayed to early 2027. While consumption will be growth-supportive, we are not expecting a broad-based household consumption re-

## Income Tax Dept launches ITR-5 Excel utility for AY 2024-25 filing

New Delhi: The Income Tax Department on Saturday released the ITR-5 Excel Utility for Assessment Year 2024–25. This utility can be used by partnership firms, Limited Liability Partnerships (LLPs), and cooperative societies to file their annual returns. Associations of Persons, Bodies of Individuals, artificial juridical persons, cooperative societies, societies registered under the Societies Registration Act, local authorities, and certain business trusts and investment funds are other eligible entities.

Entities other than individuals, Hindu Undivided Families (HUFs), companies, and those required to use ITR-7 can use the ITR-5 form. The IT department on the social media platform X said, "Kind Attention Taxpayers! Excel Utility of ITR-5 is live now and is available for filing."The ITR-5 structure includes detailed financial disclosures, including general information, balance sheet, manufacturing and trading accounts, profit and loss statement etc. Income schedules from various sources, loss set-off, depreciation, deductions, exempt income, foreign assets, GST reconciliation, and tax relief are part of the ITR-5 filing structure.

Key updates for AY 2024–25 include new sections for MSME registration and Section 80-IAC startup deductions, along with expanded reporting for emerging income categories like virtual digital assets (crypto/NFTs). The updated



ITR-5 now permits reporting of buyback losses only if the related dividend has been taxed.

The deadline for filing returns for non-audit cases is September 15. Taxpayers can do e-verification or physically verify their returns by sending the signed form to the Centralised Processing Centre (CPC) in Bengaluru within 30 days. Supporting documents are not needed, but tax credits must match Form 26AS. Before filing, taxpayers must ensure portal registration, bank account validation for refunds, updated digital signatures, and submission of applicable statutory forms.

Arthroscopic & sports medicine at Wockhardt Hospitals, Mumbai Central, however, advises patients to proceed with caution before trying alternative therapies to ensure safety and effectiveness. "Tamarind seeds may interact with certain medications and also may worsen certain health conditions," he iterates. He also shares insight on the possible risks and side effects of using the same. "Interactions with blood thinners like warfarin can increase the risk of bleeding", he warns. Additionally, some people may be allergic to tamarind seeds or other components of the fruit, which can cause an "allergic reaction or anaphylaxis". Moreover, tamarind seeds can be a cause for "gastrointestinal upset" such as nausea, vomiting, or diarrhoea especially if taken in large doses. A lack of regulation, also, can prove to be harmful in

What's the verdict, then?

There might not be sufficient research to predict that there exists a direct relation between tamarind seeds and a cure to arthritis, but it can be used for its other nutrient benefits.Dr Vishal explains that while fresh tamarind is generally "safe", "processed tamarind products with high sodium levels can be harmful". Using fresh tamarind in your regular diet, it can be beneficial and unlikely to cause any adverse effects. Therefore, it's safe to try tamarind for arthritis while keeping in mind other effective treatments are available. To ensure a gradual consumption, Kanika suggests starting with small amounts to assess tolerance.Archana S, Dietician at Aster Women and Children Hospital, Whitefield, Bengaluru, also warns against the serotonin toxicity of tamarind seeds, which can be harmful for people currently taking prescribed antidepressants.

### Are you in a mid-career to senior job? Don't fear AI – you could have this important advantage



Have you ever sat in a meeting where someone half your age casually mentions "prompting ChatGPT" or "running this through AI", and felt a familiar knot in your stomach? You're not alone. There's a growing narrative that artificial intelligence (AI) is inherently ageist, that older workers will be disproportionately hit by job displacement and are more reluctant to adopt AI tools. But such assumptions — especially that youth is a built-in advantage when it comes to AI — might not actually hold. While ageism in hiring is a real concern, if you have decades of work experience, your skills, knowledge and judgement could be exactly what's needed to harness AI's power — without falling into its traps.

What does the research say?

The research on who benefits most from AI at work is surprisingly murky, partly because it's still early days for systematic studies on AI and work. Some research suggests lower-skilled workers might have more to gain than high-skilled workers on certain straightforward tasks. The picture becomes much less clear under real-world conditions, especially for complex work that relies heavily on judgement and experience. Through our Skills Horizon research project, where we've been talking to Australian and global senior leaders across different industries, we're hearing a more nuanced story.

Many older workers do experience AI as deeply unsettling. As one US-based CEO of a large multinational corporation told us: "AI can be a form of existential challenge, not only to what you're doing, but how you view yourself." But leaders are also observing an important and unexpected distinction: experienced workers are often much better at judging the quality of AI outputs. This might become one of the most important skills, given that AI occasionally hallucinates or gets things wrong. The CEO of a South American creative agency put it bluntly: "Senior colleagues are using multiple AIs. If they don't have the right solution, they reprompt, iterate, but the juniors are satisfied with the first answer, they copy, paste and think they're finished. They don't yet know what they are looking for, and the danger is

that they will not learn what to look for if they keep working that way."

Experience as an Al advantageExperienced workers

have a crucial advantage when it comes to prompting AI: they understand context and usually know how to express it clearly. While a junior advertising creative might ask an AI to "Write copy for a sustainability campaign", a seasoned account director knows to specify "Write conversational social media copy for a sustainable fashion brand targeting eco-conscious millennials, emphasising our client's zerowaste manufacturing process and keeping the tone authentic but not preachy". This skill mirrors what experienced professionals do when briefing junior colleagues or freelancers: providing detailed instructions, accounting for audience, objectives, and constraints. It's a competency developed through years of managing teams and projects. Younger workers, despite their comfort with technology, may actually be at a disadvantage here. There's a crucial difference between using technology frequently and using it well. Many young people may become too accustomed to Al assistance. A survey of US teens this year found 72 per cent had used an AI companion app. Some children and teens are turning to chatbots for everyday decisions. Without the professional experience to recognise when something doesn't quite fit, younger workers risk accepting Al responses that feel right - effectively "vibing" their work rather than developing the analytical skills to evaluate Al usefulness

So what can you do?

First, everyone benefits from learning more about AI. In our time educating everyone from students to senior leaders and CEOs, we find that misunderstandings about how AI works have little to do with age. A good place to start is reading up on what AI is and what it can do for you: What is AI? Where does AI come from? How does AI learn?


What can AI do? What makes a good AI prompt? If you're not even sure which Al platform to try, we would recommend testing the most prominent ones, OpenAl's ChatGPT, Anthropic's Claude, and Google's Gemini. If you're an experienced worker feeling threatened by AI, lean into your strengths. Your decades of experience with delegation, context-setting, and critical evaluation are exactly what Al tools need. Start small. Pick one regular work task and experiment with AI assistance, using your judgement to evaluate and refine outputs. Practice prompting like you're briefing a junior colleague: be specific about context, constraints, and desired outcomes, and repeat the process as needed. Most importantly, don't feel threatened. In a workplace increasingly filled with Al-generated content, your ability to spot what doesn't quite fit, and to know what questions to ask, has never been more valuable.

# It's time India scales up production to tide over shuttlecock scarcity arising from change in Chinese food preferences



Trust the French to notice that char siu (barbecued pork) has taken over the land of the Peking duck, on the Chinese dinner table. It's not that their own confit base protein was suddenly affected, to kick off se plaindre (the complaining). The unrelated news arrived through badminton. The last three months have witnessed a steep rise in prices of shuttlecocks, and academies all over India are having to factor in this escalation in their running costs, grin and bear even though shelling out the extra cash can't ensure that stocks will arrive. The reason cited is shortage of raw materials, arising from fewer ducks being harvested.

The shortage – either naturally resulting from a diet switch or artificially contrived, as several coaches guess – means that though India's top players will continue to be catered to by the big corporations, Yonex and Li Ling, the vast majority of upcoming shuttlers are expected to feel the pinch in the coming months. They face anxiety not just over playing the game, but also over when the next stocks will arrive, and uncertainty if training sessions can go on without a supply glitch. While national coach Pullela Gopichand spoke of the dependency on goose feathers needing a long-term solution, coach Vimal Kumar recalled an intrepid project from 40 years ago when India had attempted to get a headstart in shuttle manufacturing, but got priced out by imports that were more cost-effective and also better in quality as the years went on.

In 1994, Kannur's plywood businessman Mayen Mohamed, an engineer by vocation, had set out to expand into manufacturing shuttles. Kerala had a bit of a history of rearing ducks for meat, and he set up a plant to make high-quality shuttles. In this endeavor, he was joined by the legendary Prakash Padukone and Vikram Singh, another well-known shuttler. Gopichand's All England title was still seven years away, and Indian bureaucracy dawdled as the sport developed at a glacial pace. But the entrepreneurial spirit was buzzing.

The shuttles produced under the brand name 'PraVik' on a small scale were high in quality, but it was never going to match Chinese large-scale manufacturing units. A box of 10 shuttles was prized, but the feather market globally would get flooded by cheaper, inferior quality shuttles, though the technology from giants Yonex and subsequently Li Ning and Victor kept improving, driving Indian brands to the periphery. The plant did not lack innovation, but when mar-

kets opened in India, survival was near impossible. The scaling up didn't quite happen, though it remained an experiment that had briefly worked. The kuttanad tharavu mappas (duck curry) remains popular, but this side chickgoose business hasn't quite taken off. Even today, shuttles which get labels stuck on by domestic brands like Skylark and Albatross get made – not in Kerala, but in Bengal. In the Uluberia belt of the state where hasher mangsho (duck meat) remains a delicacy, and hence ducks are raised, smallish industrial units spit out shuttles of varying quality. There's no consistency in these handmade shuttles, and one can't ensure that they will travel around at a uniform speed. They are either too fast, wobble or wither quickly.

"India should seriously look at setting up shuttle-making factories around Kerala and Bengal. The quality of feathers is key, but with what's coming in terms of shortages and price rise, I'm not sure why we cannot," says Vimal Kumar, who says most national federations camp in Hong Kong and Canton and buy the best ones that Yonex or Li Ning offer. The feather shortages however, have hit all makers big and small with even Lingmei, a smaller brand, facing supply delays. Shuttles are broadly either ACPTR (used by academies) or higher end AS-2, used by players on the competitive circuit. The absolute elite play with AS-30, 40, 50. Duck feathers are cheaper than geese but are more prominent because the stem is stronger. The cork of the shuttles, which weighs 4.5 to 5 grams, comes from Portugal and the glue from Burma. One Bengaluru coach mentions that shuttles in recent months have "felt artificial", though he's unable to put a finger on what could have changed. Dealerships are also grappling with a supply lag, originating from Bangladesh to China. Apparently, for a certain cost segment of feather shuttles, ducks from Bangladesh are sourced, though the import of birds is largely for meat. The Badminton World Federation has been experimenting with clones and alternative materials for a long time, but the sport, though not as expensive as tennis, remains mighty picky about feathers. Plastic shuttles are good enough to smash and drive, but shuttlers can pen ballads and reams of poetry for the delicate feel of the 'tumble at the net'. It's how the feather shuttle slows in flight that makes it special, while a plastic one will travel like an ugly bullet.

Though it seems absolutely ridiculous that an entire sport could be at the mercy of whether the Chinese fancy pork or duck for dinner, that is where the sport is at the moment. While plenty of feeder academies survive on nylon shuttles and hybrids, the feather shuttle is a thing of beauty. The air drag, flight and tumble is just not the same. "Synthetics – they are crap," says a Chennai coach, struggling big time with the price rise. Maybe, the Kerala and Bengal units need to get more ambitious, and look at this crisis as an opportunity. Indians are not likely to give up on badminton just because the bird costs got prohibitive. The country is too deep now to take a step back.

## 'I think it's doubtful': Jonny Bairstow gives honest thoughts on England future

A few years ago, England wicketkeeper-batter Jonny Bairstow was one of the staples in the national side. Fast forward to 2025, the player looks to be a long way away from making a comeback in the team with Bairstow himself not looking confident of returning in England colours. "Oh look, if that comes, that comes but I think it's doubtful judging by the fact that I've not heard too much," Bairstow said after scoring an unbeaten 86 off just 50 balls for Welsh Fire in the Hundred.Bairstow last played a T20I match for England in June 27 vs India at the semifinal of the 2024 T20 World Cup. His last ODI match was back in 2023 vs Pakistan at the Eden Gardens in an ODI World Cup group Stage match and his last Test was at Dharamsala against India in March 2024. It was also his 100th Test for the country, making him the 17th player in cricketing history to reach that milestone.

Despite having such a long career, Bairstow has never had a settled role in England's Test side. His batting position has changed over the years and whether he would keep wicket has also never been certain. Bairstow took to the Bazball approach like a fish to water. He was the posterboy for the philosophy in its early days and gave the initial ignition to the method in the summer of 2022, helping England

#### Praggnanandhaa explains what makes Magnus Carlsen great and answers what he has that world no 1 doesn't

R Praggnanandhaa, considered one of the brightest prospects in Indian chess's golden generation, came into the limelight after he defeated World No 1 Magnus Carlsen 2022 in an online chess game when he was just 16 years of age. Since then, the Indian has faced the the Norwegian master quite a few times and has maintained a good record against him. At the 2024 Norway Chess, the now 19-year-old also notched up his first classical win over Carlsen. In July 2025, Praggnanandhaa pulled off a stunning double over Carlsen within three days at the Las Vegas Freestyle Chess event. On Raj Shamani's Figuring Out podcast, Praggnanandhaa explained what makes Magnus Carlsen great and answered what he has that world no 1 doesn't.

"He has this intuition in every position which is just amazing. Like when you actually see his game — even in shorter formats — he usually plays the top three choices of the computer every single time. That intuition is something that he developed over a period of time. He's one of the players who knows a lot of classics from the past. He has read a lot and I think that's one thing he has that helps him. Also mentally he's really strong. You can never see him collapse in a tournament completely. Even when you actually make a mistake when he's lost he's there fighting every chance he's getting and he pushes till the end like he tries every resource that's possible. He exhausts them and I think that's uh one of the reasons he's um he's at the top and when he was coming up. He was playing these end games which people in earlier days thought it was completely fine. They will just make draws because of mutual respect for the players. They'll think it's okay no one is going to win this. Let's make an early draw. But Magnus started playing all those positions. He started grinding and then

His intuition is so good. Even though my intuition suggests a move, I usually try to go in details. It's possible that I can catch him there because he hasn't gone into the details. Sometimes intuition can also be wrong and I can catch him. Our games are always exciting." Carlsen is a five-time world champion, who was never defeated in a world championship until he walked away, thus abdicating his throne. Carlsen is still world no 1 in all three formats. He has been world no 1 in every monthly rating list published by FIDE since July 2011. He first became world no 1 in 2010, but Anand dethroned him soon.

India wicketkeeper batter Sanju Samson opened up about his struggles in international cricket, a phase marked by self-doubt and challenges in making a comeback. Having made his international debut in 2015 at the age of 20 against Zimbabwe in Harare as an injury replacement for Ambati Rayudu, Samson's career since then has been stop-start, taking five years for him to earn his next national call-up.

"Talking about the environment in Kerala, breaking into the Indian team was itself a very big thing to me. And I had played for 2-3 years, and I was like, 'You played for the country, boss well done,' but then I realised that I couldn't be satisfied with just this. It wasn't enough at all so I started thinking, 'What else, what else, what else,'" Samson told Ravichandran Ashwin on his YouTube channel."I had already made my debut when I was 20. It took around 5 years to make my next comeback. So, that was the next big dream... I wanted to make a big comeback into the side. That took a lot of work, physically and mentally," he added.Samson then revealed how he failed to deliver after his comeback, producing a string of low scores against Sri Lanka and New Zealand.

"I scored a 200 in the Vijay Hazare Trophy that's when I made this comeback. I had that confidence, and after that, I got two games in New Zealand and one game in Pune. I didn't perform there, and I went back with a lot of self-doubt. My confidence was shattered, and I was thinking on the lines of, 'Everyone trusted you, and you didn't score.' You feel angry about yourself," Samson admitted. When Ashwin asked how he handles blows to his confidence, Samson replied: "That's something that has constantly been happening to me. And you rightly observed, right from 2014, you think you have come to the Indian team and now everything will start happening. You get the feel that you waited for this, and you are ready for this. Suddenly, unexpected things happen. But you believe that next time you will do better, and what if you flop the next time, too? You definitely go through a very big self-doubt phase." The 66-year-old, who received the Leopard Club Award on August 8, recalled filming the 1998 political satire Primary Colors when, sitting in her van, the phone rang. "Hello, this is Donald Trump," the voice said. Thinking it was a prank, Thompson replied, "How can I help you?' Maybe he needed directions from someone." Then the voice said, "I'd love you to come and stay at one of my beautiful places. Maybe

we could have dinner." Without jumping on the offer, Thompson politely replied, "That's very sweet. Thank you so much. I'll get back to you."Later, Emma Thompson realised it was actually Donald Trump, who had just split from his first wife, Marla Maples, and his team might have been on the hunt to find a suitable partner for him to take out.
