Heavy rains predicted in parts of AP amid low pressure area in Bay of BengalOfficials from the Meteorological Department have announced that a low pressure area in the Bay of Bengal is persisting and is forecasted to strengthen further by Friday, becoming a distinct low pressure system. Jagannadha Kumar, speaking to reporters in Visakhapatnam on Thursday, stated that the system is currently situated in the west-central northwest Bay of Bengal and is expected to move west-northwestwards towards North Andhra and Odisha. The department predicts that scattered rain is likely across the state over the next week, with heavy to very heavy rainfall possible at one or two locations in the state within the next 24 hours.

President Droupadi Murmu approves 127 Gallantry awards for Armed Forces on Independence Day

New Delhi: President Droupadi Murmu has approved 127 Gallantry Awards, 40 Distinguished Service Awards, and 290 Mentions-in-Despatches to honour the valour and dedication of Armed Forces and Central Armed Police Forces personnel on the occasion of India's 79th Independence Day. Among the Gallantry Awards approved are 4 Kirti Chakra, 15 Vir Chakra, 16 Shaurya Chakra, 2 Bars to Sena Medal (Gallantry), 58 Sena Medal (Gallantry), 6 Nao Sena Medal, 26 Vayu Sena Medal, 7 Sarvottam Yudh Seva Medal, 9 Uttam Yudh Seva Medal, and 24 Yudh Seva Medal.

The list includes officers and soldiers who operated the S-400 and other air defence systems during Operation Sindoor, successfully thwarting planned attacks by Pakistan on Indian soil.Additionally, 290 personnel were mentioned in dispatches, including 115 from the Indian Army, 5 from the Indian Navy, 167 from the Indian Air Force, and 3 from the Border Roads Development Board (BRDB).

Indian Air Force officers have been awarded the Sarvottam Yudh Seva Medal for their outstanding role in Operation Sindoor. Among the recipients are Vice Chief of Air Staff Air Marshal Narnadeshwar Tiwari, DG Air Operations Air Marshal Awadhesh Bharti, and Western Air Commander Air Marshal Jeetendra Mishra. On Independence Day, former Western Naval Commander Vice Admiral S.J. Singh is to be honoured with the Sarvottam Yudh Seva Medal for Operation Sindoor, Vice Admiral Tarun Sobti with the Uttam Yudh Seva Medal, and Vice Admiral and DGNO A.N. Pramod with the Yudh Seva Medal. Notable awardees also include Captain Lalrinawma Sailo (4 Para, Special Forces), Lieutenant Shashank Tiwari (Army Service Corps, 1 Sikkim Scouts), and Group Captain Ranjeet Singh Sidhu (Air Force). Awards recognise acts of exceptional courage gallantry in operations, and distinguished service across the Army, Navy, Air Force, and Central Armed Police Forces. President Murmu has also approved Tatrakshak Medals for five Indian Coast Guard personnel. These honours celebrate conspicuous gallantry, exceptional devotion to duty, and meritorious service, reinforcing India's commitment to recognising the bravery and selfless service of those who protect its sovereignty and citizens.

KTR slams Congress for double standards on Kaleshwaram project

Hyderabad, Aug.14: BRS working president KT Rama Rao has accused the Congress government of willfully neglecting the Kaleshwaram project, while also downplaying critical safety issues in other significant irrigation projects. Taking to X on Thursday, KT Rama Rao highlighted that recent danger alerts have been issued for the Jurala project, the Manjeera barrage, and the Singur dam, yet the government seems uninterested. The BRS working president noted that both Congress and BJP leaders engage in disparaging remarks about the Kaleshwaram project but minimise the need for repairs to other facilities.

He called out the hypocrisy of both parties, pointing out that they justify substantial repairs on other projects while disparaging the Kaleshwaram project, focusing only on two damaged pillars of the Medigadda barrage. KT Rama Rao emphasised that repairs are standard for all projects, and it is unjust for these parties to portray the Kaleshwaram project negatively. "How can the government guarantee the safety of the Jurala project, Manjeera barrage, or Singur dam without addressing necessary repairs, especially after the National Dam Safety Authority (NDSA) raised concerns? Will



they overlook these issues too?" he questioned, pointing to the government's lack of action regarding the damaged pillars of the Medigadda barrage. KT Rama Rao emphasised that all irrigation and drinking water projects should be repaired urgently and protected for the benefit of the four crore residents of Telangana.

Singareni subsidiary APHMEL must compete globally: Bhatti

Hyderabad, Aug.14 Deputy Chief Minister Bhatti Vikramarka said that APHMEL (Andhra Pradesh Heavy Machinery & Engineering Limited) should grow to a level where it can compete with the world. The Deputy Chief Minister on Thursday visited the Singareni subsidiary APHMEL located at Ibrahimpatnam, near Vijayawada in Andhra Pradesh, along with Singareni CMD Balram. On the occasion, he interacted with the workers and later spoke to the media. The Deputy Chief Minister stated that across the globe, among engineering companies manufacturing spare parts for new industries and repairing and supplying old parts, none have better machinery or human resources than APHMEL.

Bhatti Vikramarka assured that what the officers and workers of the company need is commitment, the mindset that "we can compete with the world," and the drive to effectively utilise the existing systems. If these are in place, he said, APHMEL too can compete globally. He announced that a consultancy will soon be appointed to study the local conditions and submit a report on the company. Based on that report, the government will decide the direction in which to proceed. Bhatti Vikramarka emphasised that the better the officials and staff perform, the greater the profits will be, leading to more employment opportunities for local youth and contributing to the progress of the states. The Deputy Chief Minister instructed that the plant and its machinery must be kept clean, the machines should be overhauled,



and painted. He also ordered that all working staff must strictly follow safety measures. Bhatti Vikramarka stressed that the industry can progress only through the hard work and high aspirations of its workersHe further said that this industry should not be limited to manufacturing new machinery and repairing old machinery for Singareni Collieries alone, but should also take orders required not only within the state but across the country, functioning like BHEL.

The Deputy Chief said APHMEL manufactures and repairs machinery required for thermal power stations, and that the state government is considering how best to develop the company in the future.

Harish Rao sounds alarm over Telangana's economic decline under CM Revanth



Hyderabad, Aug.14 Telangana has experienced deflation for the second month in a row, prompting former Minister and senior BRS MLA T Harish Rao to raise concerns about the state's economic situation. He indicated that this trend is a troubling sign of a declining economy. The Reserve Bank of India targets an inflation rate between two percent and six percent to foster healthy economic growth; however, Telangana's inflation is currently below zero. In June, urban inflation was recorded at -0.93 percent, followed by -0.44 percent in July. Additionally, rural inflation in Telangana decreased further to -1.54 percent in July, down from -0.91 percent in June.

"This situation is not a positive development; it's a warning signal for the economy," Harish Rao stated, referencing economist John Maynard Keynes's caution that deflation can lead to a harmful cycle of falling prices, nega-

tively affecting businesses, jobs, and investment. In a statement here on Thursday, Harish Rao attributed the ongoing crisis to reduced government expenditure on welfare and capital initiatives, unfulfilled welfare commitments, and policy missteps that have severely impacted agriculture, real estate, and small enterprises.

He highlighted several unfulfilled pledges, including Rs 4,000 in Asara pensions, Rs 2,500 for the Mahalaxmi scheme aimed at women, Rs 15,000 for farmers, Rs 12,000 for agricultural laborers, Rs 5 lakh for Vidya Bharosa cards, and Rs 12 lakh in assistance for the Dalit Bandhu program. "Meeting these commitments would have injected funds into the economy and increased demand," he noted, emphasising that the initial action to counter deflation is to ensure that people have access to money. Harish Rao pointed out that capital investment has been consistently decreasing, which has hindered growth in both infrastructure and industry. He also remarked that initiatives like the Musi Riverfront Development and HYDRAA have adversely affected the real estate sector and eliminated thousands of potential jobs.

"Revanth Reddy has plunged Telangana's economy into a rapid decline. The two-month period of deflation reflects more than mere numbers; it signifies a judgment on ineffective governance. Telangana is not improving, but rather deteriorating," he stated. Harish Rao urged Chief Minister A Revanth Reddy to move beyond political grudges and prioritise the welfare of the people by promptly injecting funds into the economy. He recommended focusing on significant projects to prevent the ongoing deflation from escalating into a recession.

Karnataka Home minister warns of legal action if witness allegations prove false

Bengaluru: Home Minister G. Parameshwara on Thursday told the Legislative Assembly that if the allegations made by a key witness in the Dharmasthala "mass burial" case are found to be false, legal action will be initiated against him under the law.Reiterating the government's commitment to a fair and impartial probe, Parameshwara said the Special Investigation Team (SIT) is working strictly within the legal framework to uncover the truth. "No political or religious considerations should influence the process. The investigation must bring out the facts," he asserted.

During the discussion in the Assembly, BJP legislators accused the government of allowing a campaign to malign Dharmasthala and its temple. They demanded that the state obtain an interim report and take action against the complainant and those allegedly backing him. "My only request is that this matter should not be given a political or religious colour. The SIT was not formed under any pressure, nor will we yield to any in the future. Our only objective is to reveal the truth and ensure justice," Parameshwara clarified. He also stressed his personal respect and devotion towards Dharmasthala, stating that he, along with members of the ruling party, has visited the temple multiple times. Responding to questions about the progress of the SIT investigation, the Home Minister said police are discharging their duties in pursuit of justice. "The police are not

acting on everything the complainant says. There are limits. The truth will emerge at the right time, and no one can derail the investigation," he stated. The Dharmasthala case has attracted intense political debate in Karnataka, with the government facing pressure from both the opposition and community leaders to ensure transparency and protect religious institutions from unfounded allegations.

Revenue Minister directs the officials to be vigilant during rains

Hyderabad, Aug.14: In the wake of Indian Meteorological Department's (IMD) warning that there will be heavy rains across the state for another two to three days, Minister for revenue and disaster management Ponguleti Srinivasa Reddy today directed all the district collectors and SPs and the police commissioners to be more vigilant during this period and take preventive measures for any loss of life and property. In the last three days, some areas had received more than expected rainfall and appropriate precautions should be taken in the coming days, he noted.

During a video conference with the district collectors and SPs from the state Secretariat on Thursday, the minister asked the district collectors about the prevailing situation in Bhadradri Kothagudem, Mancherial, Bhupalpally, Mulugu, Asifabad Peddapalli, Karimnagar and other districts which have recorded more than 10 cm of rainfall during the

last 24 hours. The Collectors were alerted about the measures to be taken in Medak, Sangareddy and Vikarabad districts which are on red alert in the next 24 hours. On this occasion, the Minister said that one crore rupees have been released to each district for relief measures to be taken in the wake of heavy rains, and if necessary more funds will be released for the purpose. Senior officers have been appointed as special officers for the erstwhile 10 districts to supervise the relief measures. He instructed the collectors to cancel the leaves of the officers and staff who are on leave and to call them back for duties. Orders were issued regarding the protective measures to be taken in low-lying areas and flood-prone areas. The officials of the Municipal, Metro Water Board and Traffic departments were directed to work in coordination with the Greater Hyderabad to ensure that the people do not face any problems, he added.

CJI's intervention on stray dogs will delight animal lovers

The Chief Justice of India (CJI) B.R. Gavai's recent assurance that he would examine the Supreme Court's directive concerning stray dogs must be a welcome relef to animal lovers across the country. The directive, ssued on August 11 by a bench comprising Justices J.B. Pardiwala and R. Mahadevan, called for the removal of stray dogs from the streets of Delhi-NCR region, with instructions to relocate them to designated shelters. The order was framed to make all localities free from stray dogs, ostensibly to address growing public concerns about safety, hygiene, and civic order. However, the issue is far from one-dimensional.

The debate over stray dog management in India has always been complex, drawing strong views from muliple stakeholders, including residents' associations, aninal welfare activists, municipal authorities, legal experts and the citizens. While some view the large stray dog population as a pressing public health and safety probem, others see these animals as sentient beings deserving protection, compassion, and a dignified life. In recent years, there has been a rise in reported incidents of dog pites, often amplified by media coverage, which has inensified public calls for stricter action.

On the other hand, animal rights groups argue that he abrupt removal of strays from their familiar environments can cause distress to the animals and may even be counterproductive if not supported by long-term, hunane solutions. For them, sterilisation, vaccination, and community feeding under supervised conditions are proven, sustainable strategies to control stray populations while safeguarding public health. Gavai's intervention signals an awareness of this delicate balance.

Frozen Aquatic Life The Traffic To 16 villages Closed"





Precautionary measures to prevent loss of life and property due to heavy rains: Ministers Ponguleti, Tummala"



"Bhukya Ranjith naik,bhadradri kothagudem Bureau, august 14, Indian chronicle: Ministers Ponguleti Srinivasa Reddy and Tummala Nageswara Rao have advised people to be vigilant in the wake of the incessant heavy oss the state. The ministers, along with Chief Secretary Ramakrishna Rao, reviewed the flood situation with the Collectors, Police Commissioners, and SPs of the respective districts through a video conference on Wednesday. The ministers advised that all precautions should be taken in advance to prevent loss of life and property and to prevent undesirable incidents from occurring anywhere due to heavy to very heavy rains. They said that funds of Rs. 1 crore have been allocated to all districts to enable immediate relief measures in emergency situations. They said that these funds should be spent where necessary and that more funds will be allocated if necessary, and that there is no problem with funds. In the last three days, some areas have received more rainfall than expected and some areas have received less, so appropriate precautions should be taken in the coming days, he said. He said that senior officers have been appointed as special officers in ten districts to monitor relief measures. Collectors were instructed to cancel the leaves of officers and staff on leave and call them back and to be alert to the rains. Orders were issued regarding the protective measures to be taken in low-lying areas and flood-prone areas. He advised that special attention should be paid to railway lines, low-level bridges, causeways, and low-lying areas to prevent water from accumulating during the rains and that police personnel should be deployed, especially near low-level bridges. He also advised that appropriate measures should be taken to prevent the spread of infectious diseases and to ensure that drinking water is not affected. He advised the collectors to evacuate the people living there due to backwater of only 200 mm and to construct Indiramma houses for this as a permanent solution. If the power lines are cut due to rains, steps should be taken to restore the power supply immediately, and alternative arrangements should be made where

Speaking from the IDOC office in this video conference, District Collector Jitesh V. Patil said that although the district is receiving normal rainfall, a maximum of 125 mm rainfall was recorded in Maddukuru village of Chandrugonda mandal. However, no crop damage, property damage, or flood impact has been reported so far. He said that officials of the Irrigation and Agriculture departments have conducted field inspections at the field level, and the situation is being reviewed every hour, the Collector said.

He explained that extensive arrangements have been made in the district for immediate response in case of emergencies. He said that the NDRF team in Bhadrachalam. the STRF team in Palvancha, and 100 trained personnel in the Chatakonda Police Battalion under the Kothagudem Division are ready. He said that the Palvancha SDRF team has been sent to provide assistance to the people in the floods in Warangal. Similarly, he explained that emergency equipment such as ropes, life jackets, torch lights, and hand microphones have been made available in the district and mandal centers. The Collector said that 2 boats are deployed in the fire department and 5 boats in the police department a total of 7 boats have been deployed in the district. The Collector explained that the district administration is fully prepared to deal effectively with any disaster situation that may arise. Additional Collector D. 13 days and counting: Farmers in Punjab's Fazilka battle waterlogged fields, allege government apathy

Farmers in nearly 15 villages of Punjab's Fazilka district are seething with frustration over what they call the Government's apathetic attitude, as over 4,000 acres of farmland have remained submerged since it rained heavily on July 31 and August 1. Though there has been no heavy rain since August 1, intermittent drizzles have slowed recovery. The deputy commissioner has asked village panchayats to use funds received under the 15th Finance Commission to drain the water, but panchayats have expressed their inability to do so, citing a lack of resources.

"Fed up with the laid-back attitude of the Punjab Government, we have staged a dharna in Abohar to make ourselves heard," said Sudhir Bhadhu, a farmer from Waryam Khera village whose 40 acres have been underwater since August 1. With a choked throat, he added, "Nearly 400 acres of our village are still under water. Out of this, nearly 40 acres are mine. I had kinnow orchards, cotton, and paddy on this land, and everything is under water... What should we do? This year's income is gone, and government officials and politicians are sitting pretty in their offices.

Varinder Kamboj, a farmer from Diwankhera village, said, "Fodder for our animals has also been destroyed, not to speak of the fruit orchards of our joint family. We grow kinnow, guava, pear, and other fruits on 50 acres... This is the collective land of our big joint family. We are making our own efforts to get the water drained out. The administration is making no efforts. We have never seen such a laid-back approach from the administration." Sunil Kamboj, sarpanch

of the village, said, "Nearly 400 acres of our village are under water, and there is hardly any place to get the water drained out to. The administration has asked village panchayats to spend funds received under the 15th Finance Commission. We did some purchases... let's see if the bills are cleared or not."In Haripura village, farmer Sukhjeet Kumar is facing double trouble as his seven acres are underwater and his house has been partially damaged. "My house is built within the fields. We now live in one-room accommodation only. Five of us live in this house-I, my wife, my old parents, and my younger brother's wife. My son studies in Delhi, and my younger brother does transport business in Delhi. They keep frequenting the village. Cracks have developed in the rest of the rooms as our kinnow orchards are under water around this house... We have literally no place to live. I had requested the tehsildar to arrange at least a tent but got no response. Our village has a BJP-dominated panchayat. Perhaps this is the reason for ignoring us... Around 90 acres of this village are underwater." Sukhmander Sukh, the Fazilka district president of the Bharatiya Kisan Union (Rajewal), said, "The problem is related to just 15 villages, with an area of 4,000-5,000 acres. We are surprised to see that even this is not being managed well. This small problem has now become a big issue, all thanks to the administration and leaders of the ruling party. Ultimately, we will blame only the Punjab Government and its poor governance. Already its graph is down, and it is now going further downwards."The affected villages include Sabuana, Sajrana, Abhunn, Diwankhera, Dhingawali, Waryam Khera, Haripura, Dalmirkhera, Billapati, Saidanwali, Giddranwali, and Khui Khera Rakanpura, with no fewer than 300-400 acres in each village remaining underwater. The area suffers from a subsurface waterlogging issue, preventing seepage into the ground. "As it is drizzling on a few days and it is cloudy on a few other days, even evaporation is not happening," said Varinder Kamboj, the farmer from Diwankhera. When contacted, Abohar MLA Sandeep Jakhar, who has been suspended from the Congress, blamed the district administration. "A laid-back approach of the district administration is responsible for this condition... a proper coordination between PSPCL (Punjab State Power Corporation Limited), the agriculture and irrigation departments, and the district administration is a must

'Why not approach zoo authorities before coming to court?: Supreme Court asks petitioner seeking probe into Vantara elephant transfer case

The Supreme Court on Thursday heard two petitions related to the relocation of a 36-year-old elephant named Madhuri to a Vantara centre in Gujarat from a Jain Mutt in Maharashtra's Kolhapur. The bench allowed both petitions to be amended and listed them on August 25.In the first case, petitioner Dev Sharma sought an investigation into all wildlife imports and conservation-related operations at Vantara, an animal rescue, care, and rehabilitation initiative established by the Reliance Foundation.

Justices Pankaj Mithal and Prasanna Varal questioned why Sharma had not approached the Central Zoo Authority or any other relevant zoo authority before coming to the court. "Why (have you not approached them)? You can take these media articles and file a representation to the authority. Who prohibits you?... Don't file such vague petitions," the court said. Sharma then sought permission to amend the petition to add certain facts, following which, the court granted five days. The second petition filed by C R Jaya Sukin sought the setting up of a monitoring committee to ensure the return of all captive elephants to their owners and the release of other wild animals at Vantara. The court



asked the petitioner why Vantara had not been made a respondent."You are making allegations against parties which are not represented here.

You have not made them respondents "the court said It allowed the petitioner to make Vantara a respondent and file the amended title in five days. The decision to relocate the elephant Madhuri to Gujarat following a court order had sparked protests in Maharashtra.

GHMC serves notice to Oakridge international school

Hyderabad, Aug.14 The Greater Hyderabad Municipal Corporation (GHMC) has issued a show cause notice to the management of Oakridge International School, Khajaguda, for unauthorized parking of school vehicles on public roads thereby causing severe inconvenience to the public and for traffic congestion. According to GHMC, the School management is allowing to park its vehicles along the road at Khajaguda, Serilingampally resulting in a blockage of road of approximately 500 meters.

This obstruction has been causing significant traffic jams and inconvenience to commuters, which is in violation of the GHMC Act, 1955 and the TG-bPASS Act, 2020. Under Section 405 of the GHMC Act, 1955, no person is government land. Illegal parking on public roads is strictly prohibited, and such actions invite penalties, and for initiat-

The Serilingampally deputy commissioner, GHMC has directed the school management to immediately remove the parked vehicles and refrain from using public roads for parking in the future. The school has also been instructed to submit a written explanation within three days of receiving the notice. Failure to comply will result in towing and seizure of the vehicles at the cost of school management, along with imposition of penalties and for initiation of legal action as per GHMC rules.

SOT Malkajigiri team along with Cherlapally Police apprehended inter state gang

Owaisi and Chinna Reddy emphasized the need to rectify the historical errors and recognize the contributions of Telangana's freedom fighters. They appreciated Chief Minister Revanth Reddy for entrusting Captain Pandu Rangareddy with the task of rewriting Telangana's history.

Election Commission's prestige is fading: Aziz Pasha

Hyderabad, Aug.14: The occasion of the 24th Congress of the Communist Party of India (CPI) was held at Hyderabad District party office at Satyanarayana Reddy Bhavan in Himayat Nagar on Thursday. 5 Bangladeshi nationals detained near Red Fort amid preparations to mark Independence Day

Five Bangladeshi nationals were detained Monday after they allegedly attempted to enter the Red Fort without valid passes just days before the country's 79th Independence Day celebrations, the Delhi Police said. Intelligence agencies questioned the men to ascertain their intent and background, senior officers confirmed. According to Raja Banthia, Deputy Commissioner of Police (DCP), North Delhi,

the incident took place near the access control point of the historic monument. Security personnel deployed in the area stopped the group of five men, aged between 20 and 25 years, after they failed to produce valid entry passes.

"On enquiry, they were found to be Bangladeshi nationals who illegally came to India some three-four months ago. They were working as labourers in Delhi. They came to see the Red Fort as they were not aware that it has been closed to the public since July 15. Bangladeshi documents were found with them. On interrogation, nothing suspicious could be found. They will be deported as per law," DCP Banthia said. The Red Fort has been closed to the public as part of routine security preparations ahead of the Independence Day celebrations. The matter has been reported to the Foreigners Regional Registration Office (FRRO), and authorities have initiated the process for the deportation of the men under legal provisions. Meanwhile, seven policemen were suspended after failing to intercept a Delhi Police Special Cell team that snuck in with a dummy bomb during a mock drill at the Red Fort on Monday. Drills are being conducted across the National Capital to test security arrangements ahead of Independence Day, officers said.

Man, son assaulted in Mumbai's Mira Road over objection to pigeon feeding amid ongoing controversy

Pigeon 1, MCD 0: Why Delhiites won't stop feeding their feathered friendsAccording to the Kashimira police, Mahendra Patel and his son, Premal, 46, were assaulted Sunday morning at the D B Ozone building near Thakur Mall in Mira Road.

A 69-year-old man and his son were allegedly assaulted with an iron rod by four people in Mumbai's Mira Road after the senior citizen objected to a woman feeding pigeons in their residential complex. The incident comes close on the heels of a Bombay High Court order that directed the Brihanmumbai Municipal Corporation (BMC) to take strict action against unauthorised pigeon feeMuding in public spaces, citing serious health hazards. The court also emphasised penal action against citizens who continue to flout the ban. Following the directive, the Maharashtra government instructed BMC to strictly implement the order across the city. Ranjit Andhale, Inspector, Kashimira Police Station, said they have registered an FIR under sections 118(1), 115(2), 352, and 3(5) of the Bharatiya Nyaya Sanhita (BNS) based on the complaint lodged by the man's son.

"While no one was hospitalised and the injuries are not serious, we are verifying the claims about the iron rod being used. There was no prior enmity between the parties. Notices have been issued to the suspects, and no arrests have been made yet," said Andhale. According to the Kashimira police, Mahendra Patel and his son, Premal, 46,



were assaulted Sunday morning at the D B Ozone building near Thakur Mall in Mira Road. Mahendra Patel noticed a woman, identified as A Vyas, 56, feeding pigeons in the common area of the building. Patel reportedly asked her to stop, pointing out that it attracts more pigeons and creates hygiene issues for residents. The brief exchange escalated into a heated argument, with Vyas allegedly abusing Patel. Premal came to the spot after hearing the commotion, and confronted Vyas over her behaviour towards his father. The matters escalated further when three others, identified as Somesh Agnihotri, and two unnamed individuals allegedly joined Vyas and physically assaulted the man and his son. According to Premal's complaint, the group allegedly kicked, punched, and attacked them with an iron rod. One of the accused even attempted to strangulate him, he told the police.

No poor family in Haryana will stay homeless: Saini

Haryana Chief Minister Nayab Singh Saini Monday handed over "interim" ownership certificates under the Mukhyamantri Shehri Awas Yojana and plot allotment letters under the Mukhyamantri Gramin Awas Yojana 2.0 to hundreds of beneficiaries. Speaking at the state-level function in Panchkula, Saini said, "No poor family in Haryana will remain homeless. About 1,144 beneficiaries in Sector-23, Jagadhri received interim ownership certificates under Mukhyamantri Shehri Awas Yojana, while 3,884 rural beneficiaries received plot allotment letters across 58 villages under the Mukhyamantri Gramin Awas Yojana 2.0."The CM added that beneficiaries were identified in a transparent manner. "No favoritism, no recommendations were made, just need-based assistance was provided. It is a milestone in transparent and accountable governance. No irregularities or corruption were allowed in the implementation process. All data and procedures have been kept digital and transparent, and beneficiaries were selected entirely on

Highlighting the role of a double-engine BJP government, Saini added, "We have kept our promise, land has been provided, and financial assistance has been extended for house construction. This has only been possible due to strong coordination between the Centre and the State". Sharing the key achievements of his government, the CM said, "Under the first phase of the Mukhyamantri Shehri Awas Yojana, 15,256 families in 14 cities were already allotted 30-square-yard plots. A Rs 2.5 lakh subsidy per household is being provided under PMAY-Urban 2.0 for house construction. Besides this, in rural areas, under Mukhyamantri Gramin Awas Yojana-2.0, the process to allot plots to 1.58 lakh applicants in 561 villages is underway. Furthermore, Rural beneficiaries will receive Rs 1.38 lakh under PMAY-Gramin, Rs 12,000 for toilets under Swachh Bharat Mission, and 90 days of unskilled labour wages under MGNREGA." "Under the Pradhan Mantri Awas Yojana-Gramin, so far, 69,150 houses have been built in



rural areas with Rs 579 crore in assistance, while 77,900 houses have been constructed in urban areas under the Pradhan Mantri Awas Yojana-Shehri with Rs.1,650 crore support." Saini said.

Taking a dig at the Congress, Saini said that even after being in power for 55 years, the party failed to bring real change for the poor. "In the past, Congress promised plots to poor families but failed to provide proper documents or possession," he said, adding, "Before 2014, rural households did not even have access to LPG gas cylinders but Haryana is now providing gas cylinders to poor families for Rs 500."Talking about the healthcare in Haryana, Saini said, "The 'Ayushman Bharat Yojana' and 'Chirayu Haryana scheme' are now providing free treatment of up to Rs 5 lakh. So far, 22 lakh people in Haryana have benefitted, and Rs 2,500 crore has been spent on treatment." Further refuting opposition's accusations on exorbitant collector rate hike, Saini reiterated, "Some opposition leaders are claiming that the government is collecting Rs 5,000 crore in the name of collector rates. The truth is, in over 80 per cent of areas in Haryana, rates have increased by only 10 per cent. There is a process for this, under which the collector rate is renewed every year considering the highest registry as the basis. Spreading such lies is irresponsible."

Work to resume on Pragati Maidan underpass in Delhi after Centre's nod

Commuters travelling on the Ring Road stretch near Bhairon Marg, Sarai Kale Khan, and ITO will have a smooth ride by the end of this year, as the Delhi Government has received the go-ahead from the Centre to complete construction of Underpass No 5, officials said Monday. Construction work at the underpass, which is a part of the Pragati Maidan transit corridor, stopped in 2023 after the precast concrete boxes, pushed beneath an active railway line using the box-pushing method, sank due to flooding caused by the Yamuna River flowing nearby. The Public Works Department (PWD) then proposed a new plan, and sent it to the Union Ministry of Housing and Urban Affairs (MoHUA) seeking approval. "This is not just a clearance. It is a green signal to speed, transparency, and accountability. Every rupee spent on infrastructure must yield public value, and I am glad that this solution safeguards both engineering integrity and financial responsibility. I thank

MoHUA for their support. Now, execution is our top priority, and delay is not an option," Delhi PWD Minister Parvesh Sahib Singh said. According to officials, PWD will take steps like carrying out immediate grouting under the box structures to stabilise the soil and prevent further settlement. The other steps it will follow are urgent stitching of boxes beneath the railway embankment, enabling track strengthening and ensuring structural safety. "The adoption of the castin-situ construction method with revised width and height parameters, identified as the most technically viable solution in the current scenario," said an official. Underpass 5 is a vital component of Delhi's strategic transit upgrade, aimed at easing congestion in and around Pragati Maidan, ITO, and nearby arterial roads. Once operational, it will ensure seamless vehicular movement, especially during major conventions and public events at the India Trade Promotion Organisation (ITPO) complex.PWD has been directed to immediately initiate the approved works and submit weekly progress reports to Singh's office. The project is now being positioned as a model of high-impact infrastructure delivered with fiscal discipline and administrative re-

The Himachal Pradesh High Court has asked the state government and the Shimla Municipal Corporation to respond to a petition seeking urgent intervention to protect the historic Ridge Ground from structural damage and excessive commercial use. The petition, filed by former deputy mayor of Shimla, Tikender Singh Panwar, highlights the risk posed by the unchecked and commercial activities to the Ridge in general and to the 140-year-old underground wa-

ter reservoir beneath it in particular. Built using lime and mortar, the tank holds over 10 lakh gallons of water and faces potential damage from the regular movement of heavy vehicles and increasing commercial events on its surface, the petition says. Taking note of the plea, a division bench led by Chief Justice GS Sandhawalia, and comprising Justice Ranjan Sharma, on July 30 issued notices directing the authorities to respond within four weeks. Panwar has been waging a battle against the commercial activities and movement of heavy vehicles on the Ridge,In December last year, he had written to the chief secretary demanded to shift the stage of winter carnival away from 'yellow markings' on the Ridge. Citing the age and structure of the underground water tank, he had highlighted that it has been kept in a "very high vulnerable" zone in the Hazard Vulnerability Risk Assessment of the Shimla town. "It is precisely because of this reason that no activity is allowed on the Ridge Water tank that may cause further accentuating of the vulnerability," he had said, adding "there is no reinforcement in the tank and since the last few decades cracks have started appearing in the tank". He had further added that the northern slopes of the Ridge have already experienced subsidence since 1971 and are "still considered as sinking zone extending from Scandal Point to Lakkar Bazaar, including the Old City Bus Stand, Idgah, Longwood, Ruldu Bhatta and adjoining areas". Recently the traders' body in Shimla had held a symbolic shutdown protesting against the increasing use of the Ridge and Mall Road for exhibitions and trade fairs. They had argued that such activities not only disregard the pedestrian norms but also undermine the cultural and historical significance of the area.

Panel formed to oversee SAD reorganisation to launch own outfit

"Besides, the committee was supposed to report back to Akal Takht Sahib within six months. But now seven months have already elapsed and committee has not reported to the Akal Takht Sahib. Now, this committee is a group of ambitious politicians who are misusing the name of Sri Akal Takht Sahib. They shouldn't be allowed to fool the people by using name of Sri Akal Takht Sahib," he said. Sources said that the Sikh clergy can consider this argument of the Akali Dal against the five-member committee during its August 6 meeting.

Meanwhile, the five-member committee has sent a letter to the SGPC seeking permission to hold a meeting on August 11 at Teja Singh Samundri Hall. Looking to resolve the decades-old impasse over the Sutlej-Yamuna Link (SYL) Canal, Union Jal Shakti Minister CR Patil will on Tuesday chair a meeting in New Delhi to be attended by Punjab Chief Minister Bhagwant Mann and his Haryana counterpart Nayab Singh Saini. It will be the fifth meeting between the chief ministers of the two states — the last being held on July 9. The meeting comes a before a case pertaining to the SYL canal and sharing of waters between the two states comes up for hearing in the Supreme Court on August 13.

The last meeting between the two states, also chaired by Patil, "was held in a cordial atmosphere" with both Mann and Saini expressing commitment to finding an early resolution to the long-standing water-sharing issue. The SYL Canal has remained a source of contention between the two states since the 1980s.

Earlier, on the directions of the Supreme Court, the first meeting between the CMs of Punjab and Haryana was held on August 18, 2020. Ast the time Capt Amarinder Singh was the chief minister of Punjab and Manohal Lal Khattar was his Haryana counterpart. The second meeting was held in Chandigarh on October 14, 2022 after the Aam Aadmi Party took over the reins of Punjab. The third meeting was held in Delhi on January 4, 2023, under the leadership of then Union Water Resources Minister Gajendra Singh Shekhawat.Punjab Water Resources Minister Barinder Kumar Goyal said that the state has already taken a stand that it does not have a single drop of water to share with anyone. "Haryana is not our enemy. It is our neighbouring state. But we do not have water. How can we supply water to state when we do not have enough for our farming needs? The Centre is not willing to give us an additional water and it expects us to share ours," he said. offerGoyal added that Mann had taken a stand on the issue during the last meeting and the "will continue with its stand". During the last meeting, Mann had told Paatil that the groundwater situation in Punjab is very grim and most of the river resources have dried up. Stating that Punjab needs more water to cater to its irrigation needs, he had asserted that the state has no surplus water for others and demanded its legitimate share

in the Indus waters. He said that with the suspension of the Indus Waters Treaty with Pakistan, efforts should be made to bring water from the western rivers (Indus, Jhelum and Chenab) to meet the growing demand. Mann had said that 23 million acre feet of Chenab waters could be diverted to Punjab and further to Haryana, even Madhya Pradesh. He had said that the dispute had become a forever bleeding wound. Both the states are fighting for a few million acre feet of water. He had stated if Punjab gets 23 MAF from the Chenab, the whole dispute will be resolved forever. It was learnt that Paatil had stated that he had noted the proposal to conduct feasibility studies on the western tributaries Indus, Chenab and Jhelum. Saini, however, had expressed confidence that the SYL issue will be resolved soon, asserting that the Punjab government has also sought a solution to the problem. Saini said meaningful discussions were held in the meeting and that Punjab CM "also acknowledged that this issue should be resolved as it has remained pending for far too long". The two states had indulged in bitter exchange of words over supplying water to Haryana over and above its quota from Bhakra dam in May. Punjab had refused to release even a drop extra and a high drama had ensued when the chairperson of Bhakra Beas Management Board was locked up in a rest house at Nangal. Later, the Centre had announced to deploy CISF at the dam. Punjab government is now squabbling with Centre over the deployment of the central security forces stating that Punjab Police is capable of protecting its dams.

Commuters travelling on the Ring Road stretch near Bhairon Marg, Sarai Kale Khan, and ITO will have a smooth ride by the end of this year, as the Delhi Government has received the go-ahead from the Centre to complete construction of Underpass No 5, officials said Monday

Construction work at the underpass, which is a part of the Pragati Maidan transit corridor, stopped in 2023 after the precast concrete boxes, pushed beneath an active railway line using the box-pushing method, sank due to flooding caused by the Yamuna River flowing nearby. The Public Works Department (PWD) then proposed a new plan, and sent it to the Union Ministry of Housing and Urban Affairs (MoHUA) seeking approval. "This is not just a clearance. It is a green signal to speed, transparency, and accountability. Every rupee spent on infrastructure must yield public value, and I am glad that this solution safeguards both engineering integrity and financial responsibility. I thank MoHUA for their support. Now, execution is our top priority, and delay is not an option," Delhi PWD Minister Parvesh Sahib Singh said.

According to officials, PWD will take steps like carrying out immediate grouting under the box structures to stabilise the soil and prevent further settlement. The other steps it will follow are urgent stitching of boxes beneath the railway embankment, enabling track strengthening and ensuring structural safety."The adoption of the cast-in-situ construction method with revised width and height parameters, identified as the most technically viable solution in the current scenario," said an official. Underpass 5 is a vital component of Delhi's strategic transit upgrade, aimed at easing congestion in and around Pragati Maidan, ITO, and nearby arterial roads. Once operational, it will ensure seamless vehicular movement, especially during major conventions and public events at the India Trade Promotion Organisation (ITPO) complex.PWD has been directed to immediately initiate the approved works and submit weekly progress reports to Singh's office. The project is now being positioned as a model of high-impact infrastructure delivered with fiscal discipline and administrative resolve.

Bus services hit as transport workers begin strike across Karnataka, passengers stranded

Employees of Karnataka's state-owned transport corporations began an indefinite strike on Tuesday morning, severely affecting public bus services across the state and leaving passengers in the lurch. The unions went ahead with the strike despite a court stay against the agitation, underway pressing demands including wage revision.

Buses remained parked at depots and only a few were seen running, as some staff chose not to participate in the strike. Some buses in rural areas operated as a few drivers opted to work for the convenience of students to ferry them to their schools, said sources in the transport department. The transport corporations are learned to have roped in trainee bus drivers to manage the situation.Bus stands in major cities like Bengaluru, Chikkamagaluru, Raichur, Chitradurga, Hubballi, Dharwad, Belagavi, Mangaluru, Mysuru, Tumakuru, Hassan, Madikeri, Shivamogga, and Kalaburagi saw heavy passenger rush, with thousands stranded and struggling to find alternate ways to reach their destinations. Passengers faced difficulty due to the running of a limited number of buses, mostly those that went on the roads before the strike officially began. Private bus operators and cab aggregators allegedly made a killing as a result of the strike as passengers turned to them to reach their destinations.

Some passengers complained that autorickshaw drivers were charging exorbitant fares in Bengaluru. The protest comes after talks between the workers' unions and the Karnataka government failed. The workers are demanding



payment of 38 months' salary arrears and a wage revision effective January 1, 2024. Despite the Karnataka High Court issuing an interim stay on the strike, the unions have decided to go ahead with their protest. The HC had on Monday said that if the entire public transport operation was stalled, people are likely to be put to hardship, and therefore granted the interim stay till Tuesday, awaiting the outcome of negotiations with the government. Chief Minister Siddaramaiah had appealed to the unions to call off the strike. However, union leaders said they were unhappy with the government's offer to clear only two years of arrears and having got no clear assurance on salary revision. KSRTC Staff and Workers' Federation president H V Anantha Subbarao said, "We are not satisfied. The strike will begin as planned. We want full 38 months' arrears." During a court hearing, the bench expressed concern over the long-pending wage issues and asked the government about the de-

Will take protest to every slum cluster in city: Delhi Congress

In its first major street protest since the BJP formed government in Delhi earlier this year, the Congress Monday accused the Rekha Gupta-led government of forcibly evicting slum dwellers across the city without rehabilitating them. "The Congress will not allow the BJP to drive the poor out of Delhi. This government's agenda is to remove 'garib, not garibi, (the poor, and not poverty)," said Delhi Congress Chief Devender Yadav, announcing that the party will take its agitation to every JJ cluster in the city.

Party leaders invoked the legacy of former CM Sheila Dikshit, claiming theirs was the only party that had made efforts to regularise and resettle slum clusters. "Congress built in-situ flats in areas like Bhoomiheen Camp and Kathputli Colony. BJP only makes hollow promises," said former MP Udit Raj. "What's happening with slum dwellers is no surprise. This is BJP's character," said former MP and Sheila Dikshit's son Sandeep Dikshit.Amid the demonstration at the Assembly, allegedly held without permission, Delhi Police repeatedly announced that Section 144 was in place and that public gatherings were prohibited. Even as Congress workers continued their demonstration despite warnings, police deployed water cannons and detained at least 36 protesters, including Yadav, who was taken to Subzi Mandi police station. The demonstration was called against the recent demolition in areas such as Jangpura, Kalkaji, Wazirpur and Ashok Vihar.

More than 3,000 homes in slums have been demol-



ished and 15,000 families have been rendered homeless over the past five months, without advance notice or alternate housing options, the party alleged. In a symbolic act, party workers brought a paper jhuggi topped with a toy bull-dozer, bearing photographs of BJP ministers with the words "Haye Haye" written below. A poster on a protest truck read: "Jahan pe kiya jhuggi waalon ko beghar, wahin banao unka ghar (relocate the homeless jhuggi dwellers in the same area)". Last month, Leader of Opposition in the Lok Sabha Rahul Gandhi visited the Ashok Vihar slum cluster in Jailorwala Bagh, where hundreds of homes were demolished in June as part of an ongoing anti-encroachment drive. Videos shared by the Congress on social media showed Gandhi walking through the debris, speaking to residents who said they were left homeless.

Flood-like situation in 17 UP districts, thousands of families displaced

Heavy rain led to a flood-like situation in at least 17 districts of Uttar Pradesh, displacing thousands of families, officials said. As many as 694 villages in 40 tehsils and 92 wards in urban areas were affected, they said. The constant rainfall for the past two days has led to major rivers like Ganga and Yamuna constantly flowing above their danger mark. Schools in most of these districts, including Lucknow, were closed.Indian Meteorological Department (IMD) officials said the state received 4 per cent excess rainfall."Thunderstorm accompanied by lightning and heavy to very heavy rain are very likely at isolated places in the state," the IMD said on Monday. In the 24 hours till late Sunday night, the state witnessed 14.2 mm rainfall against the average normal of 7.2mm. At least 24 districts in the state have recorded excess rainfall. Some of the districts like Chitrakoot, Pratapgrah, Varanasi and Bhadohi reported over 55mm rainfall. The state capital Lucknow received 18mm rain against the normal 8.6mm. With districts like Prayagraj, which are witnessing the water level in Ganga and Yamuna rise above the danger mark, there are reports of water flooding the residential areas. The 17 affected districts include

Kanpur Nagar, Kanpur Dehat, Lakhimpur Kheri, Agra, Auraiya, Chitrakoot, Ballia, Banda, Ghazipur, Mirzapur, Prayagraj, Varanasi, Chandauli, Jalaun, Hamirpur, Etawah, and Fatehpur.Officials said more than 350 houses were damaged due to flood water, while the affected population has crossed over 1 lakh mark.Meanwhile, Chief Minister Yogi Adityanath formed a special team of ministers, referred as "Team 11", which were assigned districts for flood management and relief work.

Most of these ministers have reached their districts assigned to them, it is learnt. These ministers include Nanda

Gopal Gupta; Swatantra Dev Singh, Sanjay Gangwar, Pratibha Shukla, Ramkesh Nishad, Jaiveer Singh, Suresh Khanna, Sanjay Nishad, Dharamveer Prajapati, Ajit Pal, and Daya



Shankar.From August 2 to August 3, two people died because of drowning, one due to a storm and two due to heavy rain, officials said.

'Got court orders since 1990 on encroachment, nothing changed': Chandni Chowk shopkeepers protest against MCD, police



GNS News Agency, August 14Flagging the Municipal Corporation of Delhi (MCD)'s alleged inaction in tackling poor sanitation and illegal hawkers in Chandni Chowk despite the High Court's order last year, more than 30 shop-keepers took part in a silent protest on Monday and marched from the Fountain Chowk to the Red Fort.Launched by Chandni Chowk Sarv Vyapar Mandal, the protest saw shopkeepers holding placards, and targeting the MCD and Delhi Police over several issues in the area, including encroachment, congestion, rising crimes like pickpocketing, mobile snatching, and eve-teasing. The demonstrators said the stir will continue until a decision to call it off is taken

Last November, the Delhi High Court, while hearing a PIL filed by the body, had issued an order, directing the police and MCD to remove illegal hawkers and encroachments from the area within two weeks. The court, in its order dated November 22, 2024, had further directed MCD, Public Works Department. Shahjahanabad Redevelopment Corporation, Delhi Police, and the Traffic Police to file a status report within two weeks.

While referring to the HC order, the market body on Monday accused the MCD of civic apathy. Sanjay Bhargava, president of the association, and a dealer of a textile brand near Sunehri Masjid in Chandni Chowk, said,

"We have got court orders since 1990, directing the removal of encroachments... Last November, the Delhi HC ordered the removal of illegal hawkers within two weeks. But nothing has happened.... We have had 40-50 court orders on this issue, our organisation has till now spent crores on lawyers to tackle it." Raising concerns over poor sanitation in the area, Bhargava noted that public urination is common in the market. Amid the ongoing protest, Praveen Shankar Kapoor, spokesperson of the Delhi BJP and General Secretary of the Chandni Chowk Nagrik Manch, issued a press statement. "The shopkeepers and residents of Chandni Chowk are all patriots and will not hold any protest or Gandhigiri demonstrations during the Independence Week, August 9 to 15," the statement read. Kapoor, in his statement, claimed that the BJP's Chandni Chowk MP Praveen Khandelwal has significantly improved the cleanliness and reduced encroachments in the market. He added that the negligence by the PWD, MCD, and local police led to the deterioration of Chandni Chowk. Responding to the statement, Bhargava said, "We are aware of this and we'll take a call on the protest when required."

Ashok Kumar Jaiswal, who has been selling fruits for over 20 years in Chandni Chowk, was intrigued when he came across the demonstrations. When informed that the protest was against "illegal hawkers", fear and confusion grew in his eyes. Jaiswal questioned where he would go now, unaware of the designated hawking zones put out by the civic body. "Whenever some official comes, we run packing our things, so that they don't take it away, we have to fill our stomachs," he said. Despite a ban on the entry of all motorised vehicles, including two-wheelers, from 9 am to 9 pm in the area, motorists openly flout the rule, as the lanes of the market can be seen dotted with vehicles, all throughout the day. When contacted, Manish Kumar, Assistant Commissioner (MCD SP Zone), said that regular drives are conducted to remove hawkers sitting at the nonhawking zones. Drives are also held to remove rickshaws that are operating in the market without authorisation, he

'Opposition loves anti-national forces, sees reflection in them': Delhi CM amid praise for Op Sindoor, PM Modi

Rekha GuptaHer remarks came as she addressed the House during a debate on Operation Sindoor and Operation Mahadev, in which the perpetrators of the terror attack were killed recently Even as Delhi Chief Minister Rekha Gupta on Monday lashed out at the Opposition parties and hailed Operation Sindoor and Prime Minister Narendra Modi for protecting the dignity "of our sisters", Leader of Opposition Atishi questioned the imposition of ceasefire during the military operation. The political war of words happened on Monday in the Assembly as the Monsoon session began.

"Operation Sindoor was a response to the silent suffering of India's daughters and sisters. By acting as a courageous father, a compassionate brother, and a resolute national leader, the Prime Minister has upheld the dignity and empowered the spirit of Indian women," the CM remarked. The operation by the tri-services was launched in response to the April 22 Pahalgam terror attack in Jammu and Kashmir, which claimed 26 lives.

Her remarks came as she addressed the House during a debate on Operation Sindoor and Operation Mahadev, in which the perpetrators of the terror attack were killed recently. Calling the Operation Sindoor a "befitting reply" to Pakistan, the CM stepped up the attack on the Opposition. I hese people (Opposition) do not love Bharat, but they love anti-national forces because they see their own reflection in them. They are not inspired by India's progress — they would rather see the nation held back," she claimed. Hitting out at the Congress-led INDIA bloc, she said, "The Opposition parties came together to form an alliance. Only its name has INDIA in it but if you listen to them, they sound as if they are the spokesperson of Pakistan...they even raised numerous questions on Operation Sindoor in Parliament recently...They don't trust their own military and refuse to believe their own Prime Minister, and instead place their faith in foreign powers."



She stressed that the Indian armed forces continue to defend the nation with the same courage and commitment they displayed during the wars of 1965 and 1971. "Why did our governments return captured territories under pressure after the 1965 war? Why did we accept mediation from the United Nations and the United States? And in 1971, after capturing 93,000 Pakistani soldiers, why were they released unconditionally?" she asked, attacking the previous Congress-led governments. On the other hand, former CM and Aam Aadmi Party (AAP) leader Atishi questioned the imposition of the ceasefire. "Our army could have decisively wiped out Pakistan-sponsored terrorism, but that didn't happen because of BJP's cowardice. PM Narendra Modi got scared of US President Trump's threats. Trump has publicly said over 25 times that he threatened to shut down trade — that is why India backed out," she alleged.

AAP MLA Sanjeev Jha also questioned the declaration of ceasefire and used words that the Speaker directed to be expunged from the records after he allegedly made a derogatory statement against the PM.Meanwhile, Delhi Education Minister Ashish Sood tabled the Bill to regulate fee hike by private schools in the Capital. He also claimed that they got "threats" from education mafias against the BIII.

Pay Rs 1.2 lakh to clear outstanding fee, court tells parent as pvt school claims financial situation jeopardised

The Judge was hearing a suit filed by Bluebells International School, which was the defendant for the recovery of the school fee of one of its students. The school had argued that the parent, the plaintiff, was under a legal obligation to make timely and regular payments of the fees. "Present suit has been filed on October 16, 2024, whereas the cause of action last arose upon the plaintiff on February 7, 2024, when the defendant made the last pay-

ment against the outstanding amount," the court noted in its order dated July 23.

"In view of the foregoing reasons, the present suit is decreed in favour of the plaintiff and against the defendant. The plaintiff is held entitled to recover from the defendant a sum of Rs.1,21,418/- alongwith interest @ 10% per annum from the date of institution of the suit till the realisation of the suit amount," said Civil Judge Yashu Khurana of Saket Court.It was also argued that the parent had not cleared the dues despite repeated requests and reminders. Stating that its financial situation was being jeopardised, the school also told the court that a legal notice dated May 31, 2024 was issued to the parent. The order comes at a time when the Delhi government has introduced a Bill to regulate fee hikes by private schools in the Assembly amid the ongoing Monsoon Session. The Bill, which has come in the backdrop of protests by parents against arbitrary hikes by private schools, imposes strict penalties on schools that hike fees in an arbitrary manner. Schools will face fines ranging from Rs 1 lakh to Rs 5 lakh for the first time offences and Rs 2 to 10 lakh for repeat violations. Repeat violations may also lead to a loss of the right to increase fees in the future.

10 country-made bombs seized in Outer Delhi: 2 years on, cops dispose of them

More than two years after 10 country-made bombs were seized at an abandoned plot in Outer Delhi's Holambi Kalan area, the bombs were finally disposed of on Sunday, said police. "The Bomb Disposal Squad and the National Security Guard (NSG) carried out proper inspection and neutralisation procedures as per the established safety protocols and Standard Operating Procedures (SOPs), and all 10 country-made bombs were disposed of for the purpose of further investigation and necessary action." North) Hareshwar Swami said. Apart from the teams from the NSG, Bomb Disposal Squad, FSL (Rohini) teams had also come at the spot where the bombs were buried after a letter was sent by the police for the disposal of the bombs. According to the police, the bombs were seized on April 10, 2023, at an abandoned plot at Metro Vihar area in Holambi Kalan. The police had received a tip-off that a man named Deepak, 33, was in possession of country-made grenades. Deepak was apprehended the same night,.

According to Israeli officials, 50 hostages now remain in Gaza, only 20 of whom are believed to be alive. Will oppose July Proclamation of interim govt. if it goes against Constitution of Bangladesh: BNP general secretary Mirza Fakhrul Islam Alamgir

The July Proclamation that is being planned on the anniversary of the anti-Sheikh Hasina uprising on Tuesday (August 5, 2025) in Dhaka will be opposed if it goes against the constitution of Bangladesh, said a senior leader of Bangladesh Nationalist Party (BNP) Speaking to The Hindu, the party's general secretary, Mirza Fakhrul Islam Alamgir, said the interim government had consulted various stakeholders before going ahead with the planned announcement of the July Charter on Tuesday (August 5), but cautioned that the charter should not go against the 1972 constitution of Bangladesh which is based on the sacrifices of 1971 Liberation War. "The interim government sent us a draft of the July Proclamation some weeks ago. We did not find anything objectionable in that draft but we do not know what will be the exact draft of the proclamation that will be launched on 5 August. If we find that the proclamation goes against our existing constitution, then we will oppose it," said Mirza Fakhrul Islam Alamgir ahead of Tuesday's launch of the July Proclamation which is also being described as July

Mr. Alamgir's remarks came hours after the interim government announced that Chief Adviser Prof Mohammed Yunus will announce the July Proclamation at 5 pm, Tuesday at the southern plaza of the Jatiyo Sansad, the parliament of Bangladesh. The July Proclamation came into focus in December 2024 when the student-activists who are among core support groups of the interim government, announced that they wanted to use the July Proclamation to 'bury' the 1972 constitution of Bangladesh. The attempt of the student activists was however not successful and the interim government stepped in and decided to carry forward the idea of the proclamation. In his Id speech on 6 June, Prof Yunus revived the idea of the July Proclamation saying that the text of the proclamation had been agreed upon by "all parties". Mr. Alamgir however told The Hindu that the interim government has not made BNP a signatory



to the proclamation. "The July proclamation is being brought by the government to highlight the uprising of July-August 2024. But we were not asked to put our signatures to it," said Mr Alamgir speaking to The Hindu over telephone from Dhaka even as doubts persist over the BNP's participation in Tuesday's programme.BNP leaders have not declined the invitation of the interim government to participate in the event in the parliament of Bangladesh though it is understood that a small team from the party is most likely to be at the event as BNP is waiting to see the final draft of the proclamation. BNP which is one of the two major political formations - the other being Awami League - to have governed Bangladesh since 1972 constitution was launched, believes that framing of any guiding principle for the country should be undertaken by elected representatives and not by an interim administration. In the meanwhile, traffic guidelines have been issued for Tuesday as the capital of Bangladesh prepares for the launch of the July Charter. Chief Adviser's Deputy Press Secretary Abdul Kalam Azad Majumdar said that the Prof Yunus will read the document personally as Bangladesh marks a year since the fall of the Sheikh Hasina government.

U.S. reverses pledge to link disaster funds to Israel boycott stance

The Trump administration on Monday reversed course on requiring U.S. cities and States to rebuke boycotts of Israeli companies in order to receive disaster funds, according to a statement, and deleted the earlier policy from its website. The U.S. Department of Homeland Security removed its statement that said States must certify they will not sever "commercial relations specifically with Israeli companies" to qualify for the funding.

Reuters reported on Monday that the language applied to at least \$1.9 billion that states rely on to cover search-and-rescue equipment, emergency manager salaries and backup power systems, among other expenses, according to 11 agency grant notices reviewed by Reuters. This is a shift for the administration of President Donald Trump, which has previously tried to penalise institutions that don't align with its views on Israel or antisemitism. Economic pressure on IsraelThe disaster funding requirement took aim at the Boycott, Divestment, and Sanctions movement designed to put economic pressure on Israel to end its occupation of Palestinian territories. The campaign's supporters grew more vocal in 2023, after Hamas attacked southern Israel and Israel invaded Gaza in response.



"FEMA grants remain governed by existing law and policy and not political litmus tests," said DHS Spokeswoman Tricia McLaughlin in a statement on Monday afternoon.DHS oversees the Federal Emergency Management Agency. FEMA in grant notices posted on Friday said states must follow its "terms and conditions" to qualify for disaster preparation funding. Those conditions required that they not support what the agency called a "discriminatory prohibited boycott," a term defined as refusing to deal with "companies doing business in or with Israel."

U.S. could require up to \$15,000 bonds for some tourist visas under pilot program

The U.S. State Department is proposing requiring applicants for business and tourist visas to post a bond of up to \$15,000 to enter the United States, a move that may make the process unaffordable for many. In a notice to be published in the Federal Register on Tuesday (August 5, 2025), the Department said it would start a 12-month pilot program under which people from countries deemed to have high overstay rates and deficient internal document security controls could be required to post bonds of \$5,000, \$10,000 or \$15,000 when they apply for a visa.

The proposal comes as the Trump administration is tightening requirements for visa applicants. Last week, the U.S. State Department announced that many visa renewal applicants would have to submit to an additional in-person interview, something that was not required in the past. In addition, the department is proposing that applicants for the Visa Diversity Lottery program have valid passports from their country of citizenship. A preview of the bond notice, which was posted on the Federal Register website on Monday (August 4, 2025), said the pilot program would take effect within 15 days of its formal publication and is necessary to ensure that the U.S. Government is not financially liable if a visitor does not comply with the terms of his or her visa. "Aliens applying for visas as temporary visitors for business or pleasure and who are nationals of countries



identified by the department as having high visa overstay rates, where screening and vetting information is deemed deficient, or offering citizenship by investment, if the alien obtained citizenship with no residency requirement, may be subject to the pilot program," the notice said. The countries affected will be listed once the program takes effect, it said. The bond could be waived depending on an applicant's individual circumstances. The bond would not apply to citizens of countries enrolled in the Visa Waiver Program, which enables travel for business or tourism for up to 90 days. The majority of the 42 countries enrolled in the program are in Europe, with others in Asia, the Middle East and elsewhere. Visa bonds have been proposed in the past but

Brazil's Supreme Court orders house arrest for former President Jair Bolsonaro

Brazil's Supreme Court on Monday (August 4, 2025) ordered the house arrest for the country's former President Jair Bolsonaro, on trial for allegedly masterminding a coup plot to remain in office despite his defeat in the 2022 election — a case that has gripped the South American country as it faces a trade war with the Trump administration. The trial is receiving renewed attention after U.S. President Donald Trump directly tied a 50% tariff on imported Brazilian goods to the judicial situation of Bolsonaro, a Trump ally. The U.S. leader has called the proceedings a "witch hunt." Prosecutors accuse Bolsonaro of heading a criminal

organisation that plotted to overturn the election, including plans to kill President Luiz Inácio Lula da Silva and a Supreme Court justice, Alexandre de Moraes. Monday's order followed one from the top court last month that ordered Bolsonaro to wear an electronic ankle monitor and imposed a curfew on his activities while the proceedings are underway.


Justice Moraes, who oversees the case against Bolsonaro in the court, issued the order, saying in his decision that the 70-year-old far-right leader had violated the precautionary measures imposed on him by posting content on the social media channels of his three lawmaker sons. Moraes added that Bolsonaro, who governed Brazil between 2019 and 2022, has spread messages with "a clear content of encouragement and instigation to attacks against the Supreme Court and a blatant support for foreign intervention in the Brazilian Judiciary." Bolsonaro supporters plead for pardonTens of thousands of Bolsonaro supporters took the streets in the cities of Sao Paulo and Rio de Janeiro on Sunday, pleading for Brazil's congress to pardon him and hundreds of others who are under trial for their roles in the destruction of government buildings in capital Brasilia on Jan. 8, 2023. The latest decision from the top court keeps Boslonaro under ankle monitoring, allows only family members and lawyers to visit him and seizes all mobile phones from his home.

U.S. pursuing 'neocolonial' policy to maintain hegemony: Russia

Russia on Monday (August 4, 2025) accused the U.S administration of pursuing a "neocolonial" policy against Global South nations to maintain Washington's hegemony, and expressed its willingness to boost cooperation with these countries to form a "truly multilateral" and equal world order. The comments by Russian Foreign Ministry spokesperson Maria Zakharova came days after U.S. President Donald Trump unveiled sweeping new tariffs on dozens of countries. Calling sanctions and restrictions a "regrettable reality" of today's historical stage that affects the entire world, Ms. Zakharova said that the U.S. cannot come to terms with the "loss of hegemony in the emerging world order." She accused Washington of continuing to "pursue a neocolonial policy in an attempt to maintain its position, using politicised levers of economic pressure against those who refuse to follow in its wake in the international arena.

Commenting on Mr. Trump's tariff policy against Russia's partners in the Global South, Ms. Zakharova called it a "direct encroachment" on the national sovereignty of nations and an "attempt to interfere in their internal affairs". Russia believes that no tariff wars and sanctions can do anything with the natural course of history, she said. We have a huge number of partners, like-minded people, and allies who share this approach among the countries of the Global South and, first and foremost, BRICS, she said. Ms. Zakharova was referring to the bloc originally



comprising Brazil, Russia, India, China, and South Africa, expanded in 2024 to include Egypt, Ethiopia, Iran, and the United Arab Emirates, with Indonesia joining in 2025. "We are ready to increase cooperation with them in order to counter illegal unilateral sanctions and form a truly multilateral, fair and equal world order," she said. Ms. Zakharova added that the U.S. policy is fraught with a slowdown in economic growth, damage to supply chains, and fragmentation of the global economy. "Contrary to the basic provisions in the area of free trade, which the Western countries themselves once promoted, there is politically motivated protectionism and voluntaristic build-up of tariff barriers," she added.

Canada airdrops aid into Gaza, says Israel violating international law

Canada said on Monday (August 5, 2025) it delivered humanitarian assistance through airdrops to Gaza, which has been under a devastating Israeli military assault for almost 22 months, with Ottawa again accusing Israel of violating international law. "The (Canadian Armed Forces) employed a CC-130J Hercules aircraft to conduct an airdror of critical humanitarian aid in support of Global Affairs Canada into the Gaza Strip. The air drop consisted of 21,600 pounds of aid," the Canadian government said in a statement. The Canadian Broadcasting Corporation reported that it was Canadian Armed Forces' first humanitarian airdrop over Gaza using their own aircraft. The Israeli military said 120 food aid packages for Gaza's residents were airdropped by six countries, including Canada. The other five were Jordan, the United Arab Emirates, Egypt, Germany and Belgium. Canada said last week it plans to recognise the State of Palestine at a meeting of the United Nations in September, ratcheting up pressure on Israel as starvation spreads in Gaza.

Canada also said on Monday that Israeli restrictions have posed challenges for humanitarian agencies. "This obstruction of aid is a violation of international humanitarian law and must end immediately," Canada's government said. The Israeli embassy in Ottawa had no immediate comment. Israel denies accusations of violating international law and blames Hamas for the suffering in Gaza. Israel cut off food supplies to Gaza in March and then lifted that blockade in May - but with restrictions that it said were needed to prevent aid from being diverted to militant groups. President Donald Trump also claimed Hamas militants were stealing



food coming into Gaza and selling it. However, Reuters reported late last month that an internal U.S. government analysis found no evidence of systematic theft by Hamas of U.S.-funded humanitarian supplies. Israel says it is taking steps for more aid to reach Gaza's population, including pausing fighting for part of the day in some areas, allowing airdrops and announcing protected routes for aid convoys. The latest bloodshed in the decades-old Israeli-Palestinian conflict was triggered in October 2023 when Hamas attacked Israel, killing 1,200 and taking about 250 hostages, Israeli tallies show. Gaza's health ministry says Israel's subsequent military assault has killed over 60,000 Palestinians. It has also caused a hunger crisis, internally displaced Gaza's entire population and prompted accusations of genocide at the International Court of Justice and of war crimes at the International Criminal Court. Who is Erika McEntarfer? Why did Donald Trump fire the U.S. Labor Statistics Chief amid the jobs report row?

U.S. President Donald Trump has dismissed Erika McEntarfer, the head of the Bureau of Labor Statistics (BLS), amid allegations that the latest U.S. jobs report was "rigged." The move has sparked a wave of attention toward the integrity of official economic data and the independence of federal statistical agencies. Erika McEntarfer is an experienced labour economist who served as the Commissioner of the U.S. Bureau of Labor Statistics from 2023 until her removal in August 2025. She holds a bachelor's degree in Social Science from Bard College and a doctoral degree in economics from Virginia Polytechnic Institute and State University and previously held senior roles at the U.S. Census Bureau and the Council of Economic Advisers. Her research is focused on labour market dynamics and interactions between firms and workers in the economy and has been published in the Journal of Labor Economics, American Economic Journal: Macroeconomics, and the Journal of Economic Perspectives. Appointed during the Biden administration, Ms. McEntarfer led the BLS through a period of post-pandemic labour market normalisation and increasing political scrutiny over economic indicators.

Why was she dismissed?

On August 1, 2025, Mr. Trump announced Ms. McEntarfer's termination, claiming that the July jobs report under her leadership was "manipulated" to downplay eco-

nomic gains. The BLS report showed an increase of 187,000 jobs for July, while the unemployment rate remained unchanged at 3.8%. Trump publicly rejected the figures and suggested they were politically motivated. Last weeks Job's Report was RIGGED, just like the numbers prior to the Presidential Election were Rigged. That's why, in both cases, there was massive, record setting revisions, in favor of the Radical Left Democrats. On Friday morning, the BLS reported that the US economy added just 73,000 jobs in July, well below estimates. It also said it had revised the May and June numbers, and they turned out to be lower than previously announced by more than 200,000 jobs. "We need accurate Jobs Numbers," Mr. Trump wrote on Truth Social. "I have directed my Team to fire this Biden Political Appointee, IMMEDIATELY. What's the issue with the July 2025 U.S. Jobs Report, and how is it compiled?

The July 2025 U.S. jobs report, released by the Bureau of Labour Statistics (BLS) on August 2, showed a net gain of 187,000 non-farm payroll jobs, while the unemployment rate held steady at 3.8%. The report also noted modest upward revisions for previous months: June's job growth was revised from 206,000 to 211,000, and May's from 218,000 to 223,000.

Putin 'has gone absolutely CRAZY!', says Trump



Washington: President Donald Trump made it clear he is losing patience with Vladimir Putin, levelling some of his sharpest criticism at the Russian leader as Moscow pounded Kyiv and other Ukrainian cities with drones and missiles for a third straight night. "I've always had a very good relationship with Vladimir Putin of Russia, but something has happened to him. He has gone absolutely CRAZY!" Trump wrote in a social media post on Sunday night.

Trump said Putin is "needlessly killing a lot of people," pointing out that "missiles and drones are being shot into Cities in Ukraine, for no reason whatsoever." The attack was the largest aerial assault since Russia's full-scale invasion of the country in February 2022, according to Ukrainian officials. At least 12 people were killed and dozens injured. The US president warned that if Putin wants to conquer all of Ukraine, it will "lead to the downfall of Russia!" But Trump expressed frustration with Ukrainian President

Volodymyr Zelenskyy as well, saying that he is "doing his Country no favours by talking the way he does." "Everything out of his mouth causes problems, I don't like it, and it better stop," Trump wrote on social media.

The president has increasingly voiced irritation at Putin and the inability to resolve the now three-year-old war, which Trump promised he would promptly end as he campaigned to return to the White House. He had long boasted of his friendly relationship with Putin and repeatedly stressed that Russia is more willing than Ukraine to reach a peace deal.But last month. Trump urged Putin to "STOP!" assaulting Ukraine after Russia launched another deadly barrage of attacks on Kyiv, and he has repeatedly expressed his frustration that the war in Ukraine is continuing. "I'm not happy with what Putin's doing. He's killing a lot of people. And I don't know what the hell happened to Putin," Trump told reporters earlier Sunday as he departed northern New Jersey, where he spent most of the weekend. "I've known him a long time, always gotten along with him, but he's sending rockets into cities and killing people and I don't like it at all. "A peace agreement between Russia and Ukraine remains elusive. Trump and Putin spoke on the phone this past week, and Trump announced after the call that Russia and Ukraine will "immediately" begin ceasefire talks. That conversation occurred after Russian and Ukrainian officials met in Turkey for the first face-to-face talks since 2022. But on Thursday, the Kremlin said no direct talks were scheduled. The European Union has slapped new sanctions on Russia this month in response to Putin's refusal to agree to a ceasefire. But while Trump has threatened to step up sanctions and tariffs

Fiscal health rankings can act as policy nudge, encourage states to lower debt ratios: Rao Inderjit Singh

The Fiscal Health Index (FHI) initiative that ranks states by their finances can act as a "policy nudge" and play a key role in encouraging states to lower their debt-to-Gross State Domestic Product (GSDP) ratios, according to Rao Inderjit Singh, Union Minister of State (Independent Charge) of the Ministry of Statistics and Programme Implementation (MoSPI) and Ministry of Planning. With the central government set to target a reduction in its debt-to-Gross Domestic Product (GDP) ratio from 2026-27 onwards, Singh said "any fiscal slippage by states can undermine India's sovereign risk profile". In an e-mail interview with Siddharth Upasani, the Minister also discussed more frequent revisions to GDP and Consumer Price Index (CPI) data series, the importance of Artificial Intelligence (AI) in data collection, and ramping up recruitment of statistical officers. Edited excerpts:

MoSPI will release the updated series for key macroeconomic indicators such as CPI, GDP, and IIP (Index of Industrial Production) next year. Does the ministry plan to update these key data series on a more regular basis?

The next base year revision exercise of GDP, IIP, and CPI is currently underway. For GDP, the new series is scheduled to be released on February 27, 2026 with 2022-23 as base year. For IIP, 2022 -23 has been tentatively identified as the revised base. IIP on revised base would be released from 2026-27. For CPI, 2024 has been identified as the revised base year and the item basket and weightage of the items would be decided based on the HCES conducted in 2023-24. The new CPI series is expected to be published from the first quarter of 2026.MoSPI is exploring the experimental compilation of a chain-based IIP to improve responsiveness to structural changes. The item basket and factory frame of the new IIP series would be selected using the latest data of Annual Survey of Industries (ASI) 2022-23.HCES serves as the foundation for updating the CPI base. The base updation of CPI relies on HCES for the item basket and their respective weights. Therefore, MoSPI is planning to conduct HCES in about every 3 years. Accordingly, base revision of CPI will be done. For the new CPI series, MoSPI is expanding its approach by exploring alternative data sources, such as online platforms for airfare, rail fare, OTT (over-the-top) platforms and administrative records for price data of petrol, diesel and LPG. Discussions are ongoing with Indian Railway Catering and Tourism Corporation, the Ministry of Railways, and the

Petroleum Planning and Analysis Cell under the Ministry of

Petroleum and Natural Gas for direct transfer of data for integration in CPI. The Ministry is exploring the use of scanner data and web scraping to enhance the accuracy, efficiency, and comprehensiveness of price data collection. The possibility of collecting price data from e-commerce websites is also being considered. Regarding GDP, annual data in respect of the Government expenditure and private corporate sector are available. However, for the large informal sector in India, the estimates are dependent on various survey results. Attempts are being made to reduce the periodicity of the surveys, like Periodic Labour Force Survey (PLFS) are now available monthly, ASUSE data are being planned to be released quarterly. Pilot has been done on Annual Survey of Service Sector Enterprises (ASSSE).In addition to the use of data from Office of Controller General of Accounts, MCA-21, Reserve Bank of India, etc. as was done in the previous base revision exercise, use of Goods and Services Tax data, E-Vahan portal, UPI transaction data from National Payments Corporation of India, etc. are also being attempted. With the availability of more datasets, GDP base revision could be done more frequently in the near future. Could IIP and GDP data be revised with 2023-24 as the base year considering the results of the ASI for 2023-24 is set to be released in September 2025?

The ASI data for 2023-24 is expected to be available in late 2025, which would be too late to be considered for the upcoming base year revision exercise of GDP and IIP.

The first Fiscal Health Index (FHI) rankings of states were published earlier this year. With the central government moving towards targeting debt-to-GDP ratio from 2026-27, can such rankings help push the states to lower their

Yes, the FHI rankings can play a critical role in encouraging states to lower their debt-to-GSDP ratios, especially in light of the central government's target of reducing overall government debt starting 2026-27 to a level of 50 per cent from the existing 57.1 per cent. The FHI assesses the fiscal performance of Indian states, and is aimed at promoting transparency, accountability, and prudent fiscal management. It evaluates states across four core pillars: revenue mobilisation, quality of expenditure, fiscal prudence, and debt index and sustainability, along with several sub-indicators. to present a holistic picture of fiscal health. Beyond being a comparative scorecard, the FHI provides state-specific insights, identifying areas of strength and concern and offers a foundation for tailored policy recommendations.

How will land ports closure impact the region? | Explained

The story so far: On May 17, the Directorate General of Foreign Trade shut down all land ports with Bangladesh for export of apparel (readymade garments) from Bangladesh. The order also shut down the northeastern land ports with Bangladesh to restrict the export of specific items from Bangladesh. The move is being interpreted as a fallout of the downturn in relations between New Delhi and Dhaka. The two sides are yet to develop a fully functional relationship after the fall of the Hasina government last Au-

What is the May order?

Stopping import of readymade garments from Bangladesh through all land ports, the order said, "Import from Bangladesh shall not be allowed from any land port; however, it is allowed through Nhava Sheva and Kolkata seaports." That apart, the order also banned export of fruit, fruit flavoured drinks, processed food items (baked goods, snacks, chips and confectionery), cotton and cotton yarn waste, plastic and PVC finished goods except pigments, dyes, plasticisers, and granules, and wooden furniture from Bangladesh through land ports of Assam, Meghalaya, Mizoram and Tripura. The same goods were also banned from entering India through the land customs stations of Changrabandha and Fulbari. The order has clarified that import of fish, LPG, edible oil and crushed stone from Bangladesh will remain unaffected

What led India to issue this order?

India said the order was aimed at ensuring reciprocity in trade with Bangladesh. On April 13, Bangladesh's National Board of Revenue imposed a ban on the import of cotton yarn from India through land ports. That apart, Bangladesh also stopped export of Indian rice through the Hili land port in West Bengal. Indian officials further said that Bangladesh had been carrying out aggressive checks of Indian trucks over the past several months. All these factors were taken into account in stopping the entry of readymade garments through Indian land ports. In all, there are 24 operational land ports between India and Bangladesh, and several other crossings are being developed.

How is India justifying the decision?

The order came into immediate effect on May 17, officials said. However, the order and the list of items on it are expected to be reviewed from time to time. The sea ports too are not expected to remain open for all items from Bangladesh as there will be mandatory checks and reviews of all items from Bangladesh exported through Indian sea ports. The Indian side further claimed that Bangladesh has been cherry-picking issues and that several comments by top leaders indicated that they were treating the northeast as a "captive market" for Bangladesh's products, while Indian goods are not being given transit. Citing Prime Minister Modi's speech on the northeast, Indian officials said the northeast is integral to the BIMSTEC (Bay of Bengal Initiative for Multi-Sectoral Technical and Economic Cooperation). The "equal market space now available in the resource-rich northeast is expected to give a fillip to manufacturing and entrepreneurship in the region under the Atmanirbhar Bharat schemes and policies," they said.

How has Bangladesh responded?

Bangladesh has not issued any official response so far though off the record Bangladeshi officials have expressed disappointment over the way this step was initiated by the Indian side. They said Bangladesh was not intimated about Indian plans and that they got to know of the decision through media reports which caught traders and transporters unawares. To India's accusation of Bangladesh unilaterally stopping India's cotton varn and rice exports. Bangladesh officials said that these moves were enforced to control corruption on their side. Commerce Adviser S.K. Bashir Uddin of the interim government of Bangladesh has said a preliminary review is on about the impact that the Indian order will have on the economic prospects of Bangladesh. He said that in terms of furniture and agro products, the impact on Bangladesh will not be widespread, but the impact on readymade garments is likely to be signifi-

Will India's order affect Bangladesh's trade with Nepal and Bhutan?

India claims that the order will not affect Bangladesh's trade with Nepal and Bhutan. However, it is understood that overland trade blockade will naturally impact flow of orders from Bangladesh to Nepal because of frequent disruption. The order has also created a ripple effect making investment planners careful before venturing into Bangladesh.

Is the decision to shut land ports part of a larger issue between India and Bangladesh?

Indian officials say the order is a "message to Bangladesh" in response to remarks regarding India's northeast made by interim government chief Mohammed Yunus in China during the March 26-29 visit, which were unacceptable. In a meeting with Chinese business houses, Prof. Yunus had described the northeast as a "landlocked" region that is suffering from developmental bottlenecks, urging China to access the region through Bangladesh. He had pitched Bangladesh as the "guardian of the ocean" suggesting that Bangladesh's coastline is available to China to develop industrial and commercial links with India's northeast. Indian officials have said that the closure of land ports (Integrated Check Posts and Land Customs Stations) is also a message to the interim government of Bangladesh which has warmed towards Pakistan, accused of exporting crossborder terrorism to J&K. Indian officials said the order to restrict readymade garments was taken as it will affect nearly \$700 million worth of textile exports from Bangladesh to India. Though it is a small part of the total \$50 billion worth of exports from Bangladesh, it is expected to send a message to the global community about Bangladesh's moves.

Where does the RBI's surplus come from? | Explained

The story so far: Putting an end to much speculation, the Reserve Bank of India's Central Board on Friday (May 23, 2025) announced that it had decided to transfer ?2.69 lakh crore to the Central government as a surplus for the year 2024-25. This is a record high transfer, 27% higher than the ?2.11 lakh crore transferred the previous year which itself was a record at the time.

What had the government budgeted for?

This ?2.69 lakh crore is also higher than what the government itself budgeted — ?2.56 lakh crore — as dividend or surplus from the RBI, and the public sector banks and insurance companies. With the RBI's share itself exceeding this amount, this means the government's total collections from this category is likely to be far in excess of what it budgeted. However, things have not always been so easy for the government when it comes to the RBI's surplus. There have been strong arguments on both sides in the past on what should be done with the surplus the RBI earns, including some reportedly caustic remarks by Prime Minister Narendra Modi himself.

Where does the RBI get its surplus?

Before getting into the past controversy, it's important to first understand how the RBI earns money, and also why what it transfers to the government isn't called a 'dividend'. The RBI is not a company in the traditional sense with shareholders, and so it cannot issue dividends. But it is a 'fullservice' central bank, meaning that not only does it target inflation, issue currency, and regulate the banking sector, it is also the last resort lender to the government of India and the various State governments. The RBI can earn significant profits from some of these functions. For example, the process of issuing currency allows for the RBI to earn something called seigniorage. Seigniorage is basically the difference between the face value of a currency and the cost it took to produce that currency. When the RBI issues currency, say, a ?500 note, the commercial banks have to 'buy' these notes from the central bank at the full face value (in this case, ?500) even though it might have cost a fraction of that to actually produce that note. This counts towards the RBI's revenue. Then, the central bank also lends money to the Central government, State governments, and commercial banks with interest. This interest, too, adds to the RBI's revenue. Third, the RBI makes investments in other countries' bonds as well, not only earning interest on these, but also potentially benefiting from currency exchange rate fluctuations. According to the Reserve Bank of India Act, 1934, after the RBI has made provisions for bad and doubtful debt and has met all its expenses, including any provisions it needs to make towards buffer funds, "the balance of the profits shall be paid to the Central Government". The debate, thus, is on the size of the buffer the RBI should

What kind of buffer levels does the RBI maintain?

The main buffer fund the RBI maintains is called the Contingent Risk Buffer (CRB), which is basically a safety net in the event of a financial stability crisis. In 2018, a committee was set up under the chairmanship of former RBI governor Bimal Jalan to determine the RBI's Economic Capital Framework (ECF), including how big the CRB should be. At the time, the committee recommended that the CRB should be in the range of 5.5-6.5% of the RBI's



balance sheet. This was adopted by the RBI in 2019. The Jalan committee also recommended that the ECF be reviewed every five years, which is what the RBI's central board just completed doing. The central board decided that the CRB range would be widened to 4.5-7.5% from 2024-25 onwards. During 2018-19 to 2021-22, the RBI kept the CRB at 5.5% of its balance sheet, due to the COVID-19 pandemic and its impact on the economy. This was then hiked to 6% in 2022-23 and 6.5% (the maximum limit at the time) in 2023-24. For 2024-25, the RBI board has decided to keep the CRB at the new highest limit of 7.5% of the central bank's balance sheet. The profits of the central bank have been such that — despite this higher provisioning — it could still manage to transfer a record ?2.69 lakh crore to the Central government.

Have these transfers happened in the past without controversy?

In short, no. While the surplus transfers haven't been the sole reason for acrimony between the RBI and the Ministry of Finance, it has certainly played a significant part. Take, for example, the statement by then RBI Deputy Governor Viral Acharya in 2018 in which he lamented that the RBI was "neither an independent nor an autonomous institution" and that governments that do not respect the central bank's independence will "come to rue the day they undermined an important regulatory institution". It was never officially clarified what this was about, but reporters covering the beat at the time knew a large part was about the government demanding large transfers of surpluses, and the RBI resisting. Then, there's the explosive passage in former Finance Secretary Subhash Chandra Garg's book We Also Make Policy, in which he recounts that — during a meeting with then RBI governor Urjit Patel in September 2018 — PM Modi told Mr. Patel that he was like a "snake who sits over a hoard of money". Both Mr. Acharya and Mr. Patel resigned soon after their disagreements with the government. The matter subsequently died down, especially once the Jalan committee formula was adopted.

Are such large transfers the new normal?

The higher transfer this year was on account of higher foreign exchange sales by the RBI, higher earnings on its foreign exchange assets and from its liquidity management tools. As Madan Sabnavis, chief economist at the Bank of Baroda, noted, the RBI's foreign exchange sales — a significant driver of profits — may not be at the same level next year. However, on the other hand, the RBI has also now provided itself a wider band for the CRB. So, if next year it decides to keep it at the lower end of 4.5%, then it could have a larger amount left over to send to the govern-

Silent aftershocks: the mental health toll of mass IT layoffs on young professionals



In recent years, the tech industry has seen waves of mass layoffs, driven by shifting market demands and economic uncertainty. IT major Tata Consultancy Services (TCS) recently announced that it would release 2% of its global workforce -- amounting to more than 12,000 employees. Other IT companies too, have made similar moves in the recent past. While these layoffs affect workers across age groups, young employees - many of whom are early in their careers - face unique mental health challenges. For early-career employees, the loss of a job is not just a financial setback but also a blow to their identity, confidence, and future aspirations. The instability that a layoff causes can lead to increased levels of anxiety, depression, and self-doubt, particularly as they navigate a highly competitive job market. Understanding the psychological toll of these layoffs is crucial to building more resilient support systems, both within the industry and in society at large.

Director of the National Institute of Mental Health and Neuro Sciences (NIMHANS) Pratima Murthy says that the IT industry boom that attracted young people with aspirations and promises of a better life - financially and socially has resulted in migration from smaller towns as well as rural areas, into urban centres. "History suggests that when jobs are scarce or people lose jobs, the loss of income does not impact just the individual but also families back home who are often dependent on that individual. This has a snowballing effect financially on their loan EMIs for instance, and their planned investments. Losing one's job, that too suddenly, can be very distressing," she says. While common emotional reactions include shock, disbelief, sadness, a sense of futility and unfairness, relationships can also be seriously impacted, especially when these have been initiated in the context of the workplace

"There is additionally an emotional consequence, where a sense of loss of face, loss of confidence and a sense of being let down as well as letting down the family may ensue. A sense of shame and difficulty in facing the family may result in concealing the reality of the situation, aggravating the stress. Such stress can trigger a grief response as well as anxiety or depression," Dr. Murthy explains.

Excessive substance abuse is a well known response to stress, further aggravating the situation. "In an ideal world, protection of jobs would insulate professionals from all such consequences. Some ways of mitigation are to provide support to such employees, for more open communication with families, counselling for alternative job placements and for problem resolution. These are all very important, especially for emotionally vulnerable persons so that they do not feel that this is the end of the road, but develop the resilience to begin anew," she points out.Paulomi M. Sudhir, professor and consultant at the behavioural medicine unit, department of clinical psychology at NIMHANS, says mass layoffs are likely to contribute to feelings of uncertainty, demoralisation,

a sense of unfairness and anger at the loss. "In some it may result in experiences of anxiety, sadness, hopelessness and helplessness especially when they are unprepared for the layoff and have commitments to fulfill, or have been solely supporting families," she says. On an average, the work duration in IT and ITeS ranges from 10 to 11 hours and could go up to 12 hours in startups. With announcements of layoffs, employees report anxiety levels hitting a peak.

"There is already stress due to work pressure, which forces you to work long hours on weekdays and even on weekends. On top of that, now the layoff announcements have caused severe anxiety for many of us to the extent that it is affecting our daily lives," says a mid-management level employee at a leading ITeS company. A female project manager at the Bengaluru office of a global technology and service supplier notes how problems like depression are common among employees. "An emotional intelligence trainer employed by our own company, during her training session recently, mentioned how mild to medium depression is common among IT employees. The odd work hours affect our sleep cycle, create hormonal issues and induce depression symptoms," she notes. She goes on to add how women feel the pinch more as they face the same workload as men at the office and an additional burden at home due to household work and childcare, in patriarchal family systems. Doctors say stigma surrounding mental health continues to be a major barrier to help-seeking behaviour, especially among laid-off IT employees who often face unique psychological stressors. Stigma further contributes to low morale, motivation and guilt.

Although the sudden loss of employment can trigger anxiety, depression, and feelings of inadequacy, many hesitate to seek professional support due to fears of being perceived as weak or unemployable in future roles, doctors say. Cultural expectations of resilience, particularly in tech environments that value productivity and self-reliance, further discourage open conversations about mental well-being. As a result, stigma not only delays recovery but also perpetuates isolation, preventing individuals from accessing critical mental health resources during a vulnerable period. Addressing these barriers through workplace education, peer support systems, and normalised mental health discourse is essential for promoting healing and reintegration into the workforce. Asserting the importance of staying connected, Dr. Sudhir says seeking social support instead of isolation, continuing self care and using adaptive coping strategies are important at such times. She also points out that corporate mental health programmes in supporting employees during layoffs can be helpful - if the organisation involves them in preparing employees, offering mental health support and in staying connected. "Although businesses may have their own challenges, wherever possible, team leads, managers and other senior members should be available to offer support, in preparation for such situations and to also check particularly on those who are vulnerable (those with pre-existing mental or physical health issues, social concerns)," she says. The response from companies however continues to be less than optimal: employees feel that companies are barely taking any steps to address their mental health concerns. "They ask us to inhale and exhale," scoffs one employee. While most big IT and ITeS companies provide in-house counsellors and occasionally conduct mental health workshops, employees say that the root cause of the problems is still left unaddressed. Without systemic changes brought in through, perhaps, stricter labour laws by the government and other measures, improve-

Osteoporosis can result in chronic pain, disability and morbidity, and it creeps up silently: here's how to prevent it

Savithri is a high-spirited septuagenarian who lives with her husband in a high-rise apartment in Chennai. Her morning routines include: rising before the dawn, sharing coffee time with her husband and then a short walk around the sprawling apartments. One day, she tripped over the pavement during her stroll. Though she believed it was a simple fall, she could not get up from the ground and her right leg could not be moved. Her elderly husband called for a ambulance and with the help of neighbours, she was taken to a nearby hospital.

Savithri broke down when the doctor showed her the fracture in her hipbone on x-rays, and explained the need for a surgery. She could not quite understand how a simple fall could break her bone. She had been eating well, does her morning walks religiously and does not suffer from any other illnesses. The doctor explained to her that her bones were very weak and brittle due to osteoporosis, a term that the elderly couple were hearing for the first time. Osteoporosis is a silent disease. Unlike other old age conditions like arthritis or ligament tears, osteoporosis does not manifest itself overtly until a fracture happens.

The bone is one of the most active tissues in the body, with old bone being resorbed, and new bone laid over, continuously. This process helps keep the bone strong, in order to bear daily physical stresses. However, this bone turnover becomes slower with increasing age, and more bone is resorbed compared to new bone formation. Consequently, the bones of the body become weaker with ageing, and this condition is called osteoporosis, meaning bones with pores'. Though 20 to 30% of the elderly have osteoporosis, most do not know that they have it, as it is not symptomatic until the person develops a fracture, like in Savithri's case. When people less than 50 years of age sustain a trivial fall, their strong bones do not give away. However, when elderly people with osteoporotic bones sustain an injury, as trivial as slipping in the washroom or bending down to lift an object from the floor, they incur a fracture. Since the elderly also have poor coordination, less visual acuity and weaker muscles, the chances of sustaining simple injuries leading to osteoporotic fractures are higher with increasing age.

Roughly, one in three post-menopausal women and one in five men over the age of 50 are at risk of experiencing osteoporotic fractures. An estimated 2 million new osteoporotic fractures are diagnosed annually, a figure exceeding the annual incidence of myocardial infarction (heart attacks) and breast cancer. As most families have become nuclear, the management of elderly people sustaining osteoporotic fractures, who require hospitalisation and surgery, is a significant problem. Their restricted ambulation, need for repetitive hospital visits and prolonged nursing care required, pose difficult socio-economic problems. India is also experiencing a significant demographic shift with its ageing population, which is growing faster than those of younger age groups. This trend is expected to continue, with the number of elderly individuals projected to be around



20% of our total population in 2050. This means that unless osteoporosis is prevented or diagnosed early, a significant chunk of our population is likely to suffer from these fractures in the near future.

Osteoporosis is a consequence of old age. Postmenopausal women, due to decreasing oestrogen levels, are more susceptible than men. Obesity, sedentary lifestyles, smoking, alcoholism, regular steroid usage and poor dietary habits are important avoidable risk factors. With regular physical activity as simple as regular walking, aerobic training, low weight training and exercises, the bone mass can be kept optimal. Similar to systematic financial investments, it is essential that such activities be started in young adulthood itself so that adequate bone mass is available during old age. Apart from this, sufficient calcium intake (dairy products, green leaves) and exposure to sunlight for Vitamin D would keep the bones enriched with minerals. If there are old people at home, it would be prudent to ensure that the environment is fall-free. Rooms should be adequately lit; large obstacles should be avoided; railings should be provided near stairs; washrooms should be dry, and wall supports should be available for safety. Beds and couches should not be too high and nightwear should be loose and above the ankles

Osteoporotic fractures commonly occur in the spine, wrist, shoulder and the hips. While many of these fractures heal with rest and splints, the occurrence of one fracture portends the future possibility of further fractures. These fractures affect the individual's quality of life; result in chronic pain, disability and morbidity. Longevity is also significantly reduced with the occurrence of osteoporotic fractures. The mortality rate within the first year following an osteoporotic fracture is estimated to be 20%, and the risk of mortality increases 3 to 4 times over five years following these fractures. Some of these fractures require surgical intervention, which is a major undertaking in elderly patients. So, prevention of fractures should be the main aim. It is recommended that women after menopause and men above 70 years of age undergo bone density assessment. This assessment is performed through CT BMD scans, DEXA scans and foot ultrasounds, which are available in many government and private hospitals.

SpiceJet employee thrashed by Army officer: 'He hit me, punched me, I was only doing my job'



Mudasir Ahmad Khan, the SpiceJet employee who has been bedridden due to alleged assault by an Army officer at Srinagar airport last month, said he was targeted for doing his work honestly. Four employees of the airline were assaulted by Lieutenant Colonel R.K. Singh on July 26 after Khan had asked the Army officer to pay charges for carrying extra cabin baggage according to the norms set by SpiceJet. "I saw this man was carrying two cabin bags and asked him to stand aside so that they could be weighed. Against an allowance of 7 kilograms per piece of cabin baggage, this man was carrying two which weighed 16 kilograms," Mr. Khan told PTI Videos from his home in Srinagar where he has been bound to his bed after he suffered a spinal fracture caused by the assault.

Mr. Khan said he asked the Army officer to pay for extra baggage but he became irate and misbehaved with him and other colleagues before turning violent. "He hit me with the bag, he punched me and slapped me till blood started oozing from my mouth and nose. Then I fell unconscious. Later I saw in the videos that he was not allowing anyone to even pick me up. He even assaulted four employees," the injured man said.Mr. Khan said he only stopped Lt. Col. Singh as a part of his duty. "Had I been wrong, then it would have been a different story. The airline ticket has clearly mentioned the baggage allowance for each passenger, however, this gentleman claimed that he does not know about it. I was only doing my job honestly," he added. He demanded that the erring Army officer be punished for his violent acts and said, "What happened to me can happen to someone else as well. So he should definitely be punished for it." Police have registered a case against Singh for allegedly assaulting and injuring four employees of a private airline at the Srinagar International Airport last week. A case has been registered against Lt. Col. Singh under Bharatiya Nyaya Sanhita Section 115 (voluntarily causing hurt) for assaulting employees of SpiceJet airline following a disagreement over payment of extra baggage charges on July 26.Lt Col Singh has filed a counter-

complaint with the police alleging assault, following which an FIR has also been registered against the airline staffers.

The officer, who is currently posted at the Army's High Altitude Warfare School (HAWS) at Gulmarg in Baramulla district, was to board a SpiceJet flight to Delhi when the incident took place. When asked about the incident, army officials said that full cooperation is being extended to the authorities. The army is committed to uphold the highest standards of discipline and conduct and takes all allegations seriously, public relations officer (defence), Srinagar, said in a statement. The incident was caught on camera, and a video of the incident has surfaced on multiple social media platforms purportedly showing the enraged Army officer hitting several airline employees with an iron stand.The airline issued a detailed statement about the incident, saying one of the four victims of the assault had suffered spinal injuries. They also said it has initiated the process to place the passenger on the no-fly list in line with civil aviation regulations."A passenger grievously assaulted four SpiceJet employees at the boarding gate of flight SG-386 from Srinagar to Delhi on July 26, 2025. Our staff members suffered a spinal fracture and serious jaw injuries after being attacked with punches, repeated kicks and a queue stand, the SpiceJet said in a statement. According to the airline, an employee fell unconscious on the floor, but the passenger continued kicking and hitting him. "Another staff member suffered bleeding from the nose and mouth after receiving a forceful kick to the jaw while bending down to assist the colleague who had fainted." The airline said the passenger, a senior army officer, was carrying two pieces of cabin baggage weighing a total of 16 kilograms, more than double the permitted limit of 7 kilograms. "When politely informed of the excess baggage and asked to pay the applicable charges, the passenger refused and forcefully entered the aerobridge without completing the boarding process - a clear violation of aviation security protocols. He was escorted back to the gate by a CISF official," the statement further said. The airline further informed that the passenger grew increasingly aggressive at the gate. It could not be immediately ascertained whether the passenger was detained at the airport after the incident. SpiceJet said it has also written to the civil aviation ministry, apprising them about the "murderous assault" on its staff and has requested appropriate action against the passenger. The airline also said that it has secured the CCTV footage of the incident from the airport authorities and handed it over to the police. Strongly condemning any act of violence against its employees, SpiceJet said it will pursue this matter to its fullest legl and regulatory conclusion. Army officials said the issue has come to the notice of the Indian Army and "we are awaiting the conclusion of the pending investigation".

IAF's unending fighter conundrum | Explained

After over six decades in service, the MiG-21 fighter jets are set to be retired from the Indian Air Force (IAF) in September this year. The formal ceremony is scheduled to be held at Chandigarh where the jets were first inducted in 1963. With this the fighter strength of the IAF will dip from 31 to 29 squadrons, against the sanctioned strength of 42 squadrons. A fighter squadron typically has 16-18 jets. The IAF is awaiting deliveries of the Light Combat Aircraft (LCA)-Mk1A, which is expected to begin in the next few months after repeated delays. All this at a time when the Chinese Air Force and Navy have fielded around 1,900 fighters including more than 1,300 fourth-generation aircraft, not including trainers, as per a 2024 U.S. Department of Defence report. China has also deployed two Fifth Generation Fighter Aircraft (FGFA), recently unveiled two more advanced jets, and is likely to supply 40 J-35s stealth jets to Pakistan.

What has been the legacy of MiG-21s?

Contracted from the erstwhile Soviet Union after the 1962 war with China, the MiG-21s heralded the onset of supersonic aviation in the IAF and was also its first nonwestern fighter. A total of 872 MiG-21 aircraft have been inducted in the IAF, a bulk of them licence-manufactured by the state-owned Hindustan Aeronautics Limited (HAL). The MiG-21s remained the mainstay of the IAF for several decades and a spate of accidents in the early 2000s earned them the name 'flying coffins'. Over the six decades, there were over 450 accidents involving the jet. The jets played a key role in the 1965, 1971 wars, the 1999 Kargil conflict, and more recently in the aerial dual with Pakistan on February 27, 2019, a day after the Balakot air strike. During the attack, Group Captain (then Wg Cdr) Abhinandan Varthaman's MiG-21 was shot down and fell in Pakistan Occupied Kashmir after he shot down a Pakistani F-16, according to the IAF.In fact, in the absence of an Advanced Jet Trainer (AJT), before the Hawks were inducted in 2008. the MiG-21s were used for stage III training of young pilots for a long time as it was the "most suitable" fighter even though it was considered "sub-optimal" as a trainer. The MiG-21 is also among the most successful fighter jets globally with over 6,000 jets of 12 types flown by over three dozen countries. Currently, there are two MiG-21 Bison squadrons in service — the No. 23 'Panthers' and the No. 3 'Cobras'. Incidentally, the No. 3 Squadron has the distinction of being the first to get the upgraded MiG-21 Bisons still in service and will now be the first to get the LCA-Mk1A. With the MiG-21s out, the MiG-29s are the last of the MiG series in service which together with the SU-30MKI remain the last of Russian-origin fighters.

What is the current status of the IAF?

Besides the MiG-21s, a majority of the current inventory, that is the early variants of the Jaguars, Mirage-2000s and Mig-29s, will start going out by the end of the decade. This leaves the SU-30MKI in service, the LCA variants planned to be inducted, and the Medium Role Fighter Aircraft (MRFA) while the indigenous FGFA, the Advanced Medium Combat Aircraft (AMCA) is under development. The IAF currently operates two squadrons of the LCA-Mk1, which undertook maiden flight in January 2001 and was inducted in 2016. A more capable variant, the Mk-1A, which is to be inducted in large numbers, had been delayed initially due to development issues and later due to non-delivery of engines by General Electric (GE) Aerospace citing supply chain difficulties.

How did it get delayed?

The Defence Ministry had signed a ?48,000 crore contract with HAL for 83 MK1A jets, and deliveries were to start in March 2024 with at least 16 planes to be delivered to the IAF every year. However, not a single Tejas Mark-1A has been delivered so far. In August 2021, the HAL placed an order for 99 F-404 engines with GE Aerospace at a cost of ?5,375 crore for the 83 Mk1A jets. The first engine arrived in India only in April this year after a delay of one and half years and the second engine was delivered early this month. Additionally, a deal for 97 additional jets, estimated to ?67,000 crore, is expected to be concluded in the next few months. HAL has assured to scale up production to 24 jets



a year.Amid these delays, an Empowered Committee for Capability Enhancement of the IAF headed by the Defence Secretary R. K. Singh identified key thrust areas and made recommendations for medium- and long-term measures in the report submitted to Defence Minister Rajnath Singh in March.As per the IAF, the LCA Mk2, larger and more capable than the Mk1 variants, is meant to replace the Mirage 2000, MiG-29 and Jaguars. It is expected to take first flight in 2026. In February 2025, IAF Chief Air Chief Marshal A. P. Singh said that they need to add 35-40 jets every year to make up for the shortage in numbers. Both these programmes, LCA-Mk1A and Mk2, are extremely critical to shore up fighter numbers of the IAF over the next 10-15 years. In an interview to PTI in June, HAL Chairman and Managing Director D. K. Sunil said that GE Aerospace is expected to supply 12 engines in the current fiscal and that the jets would be delivered to the IAF.

Moreover, India has procured 272 Su-30MKIs from Russia of which around 260 remain in service. Last December, the Ministry of Defence signed a ?13,500 crore deal with HAL for 12 Sukhois to replace those lost in crashes. A major upgrade programme for the Sukhoi's has been lined up to be undertaken by HAL. The upgrade of 84 jets in the first batch has already been approved. Meanwhile, by early 2040s, some of the earlier batch of SU-30MKIs will go out.

What is the way forward?

The IAF has drawn up an ambitious plan to induct more than 600 jets over the next two decades, a large number of them being LCA variants. This includes 180 LCA-Mk1A, over 120 LCA-Mk2, 114 MRFA and at least 120 AMCA. A Twin-Engine Deck Based Fighter for the Navy's aircraft carriers is also on the drawing board. However, all this hinges on timely production and deliveries. Mr. Singh said in an interview recently that they are talking to partners for the likely import of a small number of fifth gen fighters as an interim measure while the AMCA development continues. The option is between the Russian SU-57 and American F-35. These are sensitive negotiations, Mr. Singh said adding, "When it reaches a tangible stage, whether it is an Acceptance of Necessity (AoN), a Request For Proposal or ultimately through a contract that is when the media will come to know."Ultimately, it is the fifth gen AMCA that is the way forward while the LCA variants and MRFA fill numbers and add strength in the medium term. The Aeronautical Development Agency (ADA) that is developing the aircraft has floated an AoN inviting private sector participation for the production. Even HAL has to bid for it, unlike the nomination in the past. "I imagine it will take 3-6 months to reach the contract award stage", Mr. Singh said. "Thereafter the project itself of development and an AMCA prototype to actually take to the skies, it would be a 10-year program, I would imagine."On the engine front, the F414 engine to power the LCA-Mk2 is to be licence manufactured by HAL for which commercial negotiations with GE are underway. The AMCA development is envisaged in two phases — MK1 development and couple of squadrons with the GE414 engine, and AMCA-Mk2 with a more powerful 110KN engine that is to be co-developed with a foreign partner for which talks are underway. All this leaves the MRFA deal, for which the Request For Information was issued to global aircraft manufacturers in April 2019, but there has been no progress since. Given the huge cost involved, the long timelines and various other programmes already in the pipeline, it has to be seen how it can be taken forward

China price war, lack of clarity on US 'penalty': What Indian exporters are discussing in tariff talks with American importers



US tariff impact on India: Amid a sudden escalation of trade tensions between India and the US, with American President Donald Trump threatening to impose tariffs "substantially" higher than the 25 per cent announced earlier, Indian exporters face a two-pronged challenge in maintaining access to their largest export market — the US.On the one hand, China has begun aggressively undercutting prices to outcompete other countries; on the other hand, the undefined "penalty" over and above the 25 per cent reciprocal tariffs has complicated negotiations between US importers and Indian exporters, especially in low-margin products such as apparel and footwear.

The uncertainty over the "penalty" on India for purchasing Russian oil has come at a time when Indian exporters typically receive bulk summer orders, including for cotton garments, lightweight footwear, and linen clothing. Normally, exporters and importers share the burden of additional tariffs, but exporters said contracts have stalled due to the unknown penalty amount."A lot of exporters, particularly from the apparel and footwear sectors, are facing uncertainty because summer season orders are set to be placed very shortly. They are in touch with buyers, and some of them have even visited the US. But neither the buyer nor the seller is in a position to state what they are willing to negotiate, as the 'penalty' amount is unknown," Ajay Sahai, director general & CEO of the Federation of Indian Export Organisations (FIEO), told US retailers and apparel companies typically begin shipping merchandise from global suppliers at least two to three months before the summer season starts in April. Traders, typically, begin negotiating contracts much earlier.

"China has become a little more aggressive because they are outpriced by 5 per cent, and they are looking at the extent to which they can reduce the price. That's also a challenge. It may not be entirely possible for the exporter to absorb the duty, and therefore they are requesting that the government should chip in for a limited period only, as we hope that a bilateral trade agreement (BTA) will be concluded by September or October," Sahai added. However, after Trump threatened to raise tariffs on Indian goods over its purchase of Russian oil, New Delhi on Monday said the targeting of India was "unjustified and unreasonable", and

that the country would take "all necessary measures" to safeguard its "national interests and economic security". "India is not only buying massive amounts of Russian oil, they are then, for much of the oil purchased, selling it on the open market for big profits... They don't care how many people in Ukraine are being killed by the Russian war machine. Because of this, I will be substantially raising the tariff paid by India to the USA," Trump said in a post on his social media platform, Rating agency ICRA said that the higher-than-expected US tariffs on India - and the potential penalty linked to India's crude and defence purchases from Russia — are likely to pose a headwind to India's GDP growth in the current fiscal. "We have lowered our growth forecast for India for FY2026 by 20 basis points to 6.0 per cent; the extent of the said penalties could result in a further downside," the agency said. 'Tariff threats against India are not economics' Simon J Evenett, Professor of Geopolitics and Strategy at the International Institute for Management Development (IMD), an independent academic institute in Switzerland, said in a LinkedIn post that tariff threats against India have "nothing to do with economics". He said that the United States has now antagonised all five of the original BRICS nations, home to more than 3.2 billion people.

"I struggle to see a coherent grand strategy here other than to take on every possible pole of alternative power. None of the BRICS have the defence dependence on the USA that the EU, Korea, Japan, and the UK have — and that probably played the greater part in the latter's acquiescence to recent US tariff threats. So what is the US offering to the BRICS?" Evenett said. Access to the US market isn't a compelling answer. Take India. Its largest export to the USA is smartphones — does anyone else on the planet buy smartphones? Next biggest export is a variant of diamonds — there are other buyers for these too. Medicines are third on the list - same argument. Light oil next - you get the picture. Only one-sixth of Indian goods exports go to the USA. Big deal," he added. As Trump has threatened several countries with additional tariffs over the re-routing of goods to the US, Deborah Elms, a trade and economic policy expert with the Hinrich Foundation, said in a LinkedIn post that one key complaint from the business community is the lack of clarity on what the US currently means by "transshipment". "Given that tariffs are about to be 40 per cent on anything deemed to be transshipped, definitions are critically important. Typically, firms are required to 'substantially transform' products. In other words, you aren't allowed to simply take a box, slap a new label on it saying 'from country X', but must take raw materials, parts, and components to create something transformed. The amount of transformation is critically important. In a free trade agreement, officials spend months or years wrangling over these rules. Is there a value threshold that needs to be crossed? Is it a change in tariff heading? Subheading? Unfortunately, with new tariffs coming on August 7, we have no guidance at all on these rules," Elms said.

How India's pesticide market is changing

Crop protection chemicals are commonly known as "pesticides". These are basically substances sprayed on crops to protect against insects ("pests") that cause damage, whether directly (by feeding on them) or indirectly (by transmitting disease). Take the white-backed plant hopper, a pest that both feeds on rice plants and also spreads the Fiji virus disease, resulting in their stunted growth. This "dwarfing" disease has been reported by many paddy farmers in Punjab and Haryana during the current kharif growing season. The vector insect here injects the virus while sucking the sap from mostly young plants. But crop protection chemicals aren't limited to insecticides. They also include fungicides (to control fungal diseases such as blast and sheath blight in rice or powdery mildew and rusts in wheat) and herbicides (to kill or inhibit the growth of weeds).india's organised domestic crop protection chemicals market is valued at roughly Rs 24,500 crore.

The largest segment within that is insecticides (Rs 10,700 crore), followed by herbicides (Rs 8,200 crore) and fungicides (Rs 5,600 crore). As the accompanying chart shows, it is the market for herbicides that's growing at the highest rate - over 10% annually. Much of that is controlled by multinational companies: Bayer AG (which has an estimated 15% market share), Syngenta (12%), ADAMA (10%), Corteva Agriscience (7%) and Sumitomo Chemical (6%). While Bayer is German, Corteva is from the US and Sumitomo is Japanese, the Basel (Switzerland) and Ashdod (Israel)-headquartered Syngenta and ADAMA respectively are both owned by the Chinese state-owned Sinochem Holdings Corporation. However, the herbicide segment has Indian players, too, such as Dhanuka Agritech (estimated 6% share) and Crystal Crop Protection Ltd (CCPL: 4%). CCPL recently purchased the rights to Ethoxysulfuron, a herbicide used against broad-leaved weeds and sedges in rice and sugarcane, from Bayer AG for sales in India, Pakistan, Bangladesh and Southeast Asian countries.

The deal, announced in January 2025, also covered the latter's 'Sunrice' trademark for mixture products containing this active ingredient. Earlier, in December 2023, CCPL had acquired 'Gramoxone', a broad-spectrum herbicide containing the active ingredient Paraquat, from Syngenta for sale in India. "We are very bullish on herbicides. While the all-India market for this segment grew by 10% in 2024-25 (from Rs 7,460 crore to Rs 8,209 crore), our own sales rose over 47%, from Rs 229 crore to Rs 337 crore," said Ankur Aggarwal, managing director of the Delhibased company that recorded a turnover of Rs 2,201 crore from crop protection chemicals last fiscal.

Weeds, unlike insect pests and disease-causing pathogens, don't directly damage or destroy crops. Instead, they compete with them for nutrients, water and sunlight. Yield losses happen because the crops are deprived of these essential resources. Besides growing at their expense, weeds sometimes even harbour pests and pathogens inflictingfurther harm.

By keeping their fields free from weeds, farmers can ensure that the benefits of the fertilisers and irrigation water they give go to the crops and not these unwanted plants. Weed control has traditionally been through manual removal by hand or simple lightweight short-handled tools with flat blades such as khurpi. There are also power weeders with 3-10 horsepower engine capacity that can be run between rows of standing crops to remove weeds in and around those spaces. But manual weeding is time-consuming, with a labourer taking 8-10 hours to cover one acre. And since the weeds regrow, the process has to often be repeated during the crop's lifecycle. According to the Labour Bureau's data, the all-India daily wage rate for plant protection workers averaged Rs 447.6 in December 2024, as against Rs 326.2 five years ago. More than the cost though, labour isn't available when required by the farmer. Power

weeders take only 2-3 hours per acre, but aren't effective in pulling out weeds with deep roots or growing within densely planted crop areas. That's where herbicides come in. The demand for these chemicals is growing mainly on the back of rising agricultural

labour scarcity; the number of people in rural India prepared to do this work of bending, digging and uprooting plants for long hours are getting fewer by the day. In other words, herbicides have become more like tractors and other laboursaving farm machinery — a substitute for manual weeding. Farmers generally spray insecticides and fungicides only when they physical observe and assess the pest population or disease incidence to be significant enough to impact crop yield and quality/marketability.

There's a certain so-called economic threshold level, where the cost of controlling the pest/disease using chemicals isjustified by the extent of anticipated crop loss. In herbicides, too, farmers tend to mostly spray only after the weeds appear and are seen, i.e. "post-emergence". In recent times, farmers have also been resorting to prophylactic application of "pre-emergent" herbicides around or just after crop sowing. These stop the weeds from coming out, helping keep the field clean from the start. Alternatively, they may use "early post-emergent" herbicides to control weeds at the crop's initial sensitive growth stage.

In both cases, the spraying is preventive, as opposed to being reactive. Out of the estimated Rs 1,500-crore paddy herbicide market, the "pre-emergent" sub-segment accounts for roughly Rs 550 crore. That share is about a fifth in the Rs 1,000-crore market for wheat herbicides. The "preemergent" and "early post-emergent" spaces are clearly the ones leading the growth, as farmers increasingly opt for timely and smart weed control amid rising labour shortages. Unlike seeds and fertilisers - where there are enough Indian public as well as private sector players - the crop protection chemicals industry is practically a multinational monopoly. There are some Indian companies, nevertheless, that are attempting to break through, by acquiring the rights to active ingredients and brands from big global majors or even introducing innovative formulations.CCPL, for instance, has collaborated with the Ohio (US)- based Battelle and Japan's Mitsui AgriScience to develop a new paddy herbicide called 'Sikosa'. Containing two active ingredients, Bensulfuron-methyl and Pretilachlor, in a patented oil-dispersion formulation, 'Sikosa' spreads guickly in water and works well when sprayed within 0-3 days after transplanting. "With a single 500-ml bottle of this super spreader herbicide, farmers can control narrowleaf, broadleaf and sedge weeds in transplanted paddy. And the product cost is Rs 850-900 per acre, compared to Rs 2,000-plus with manual weeding," Aggarwal claimed.But India is still some distance away from having a Sinochem Holdings Corporation.

WHO classifies Hepatitis D as cancer-causing: Why taking the Hepatitis B vaccine helps



The World Health Organisation (WHO) recently announced the reclassification of hepatitis D as cancerous, emphasising the urgency for preventing viral hepatitis, which is a growing public health crisis. "Every 30 seconds, someone dies from a hepatitis-related severe liver disease or liver cancer. Yet we have the tools to stop hepatitis," Tedros Adhanom Ghebreyesus, MD, WHO Director-General, said in an official news release. The WHO's announcement stems from the International Agency for Research on Cancer's (IARC) reclassification of hepatitis D as carcinogenic, supported by data from a study published in 'The Lancet Oncology., "In India, the prevalence of hepatitis D, caused by a virus, is low in the general population but may be underestimated in high-risk groups such as intravenous drug users and those with chronic hepatitis B. Public education on safe blood usage, avoidance of needle-sharing and safe sex practice like using barrier contraception prevents transmission," says Dr Piyush Ranjan, vice-chairperson, Institute Of Liver Gastroenterology & Pancreatic Biliary Sciences, Sir Ganga Ram Hospital, New Delhi.

All types of hepatitis are associated with acute liver infection; however, only hepatitis B, C, and D can lead to chronic infections with a higher risk of liver cirrhosis, failure or cancer. According to the authors of the study's findings, hepatitis D is associated with a two- to six-fold higher risk of liver cancer compared with hepatitis B.Hepatitis D is a serious liver infection caused by the hepatitis D virus (HDV).

However, it is an incompetent virus that requires hepatitis B virus (HBV) for replication. This means it cannot cause infection alone and triggers co-infections only with the hepatitis B virus. So hepatitis D only affects people who already have hepatitis B either simultaneously or sequentially. Hepatitis B & D co-infection runs a more severe course for risk of cirrhosis and liver cancer. Hepatitis B can cause liver cancer even without causing cirrhosis as it gets integrated in the DNA of cells. Hepatitis D virus augments the carcinogenic effect of Hepatitis BAs per the data, 75 per cent of hepatitis D patients could develop liver cirrhosis within 15 years. People who have contracted hepatitis B alone are 50 per cent less likely to develop liver cancer as compared to people who have hepatitis B and D coinfection.

What is the mode of transmission?

The mode of transmission is similar to hepatitis B and C, that is through parenteral route or injections and transfusion, mother to child transmission and sexual contact.

How is hepatitis D diagnosed?

Universal hepatitis B vaccination indirectly prevents hepatitis D. Despite hepatitis B being included in the national immunisation programme, the vaccine coverage is a dismal 50 per cent. Managing infections among those already affected remains difficult owing to the limited availability of approved therapies, although emerging options like bulevirtide give an assurance. The carcinogen tag is expected to enhance global surveillance, funding and research to reduce the burden of HDV-related liver cancer. Prevention also relies on safe blood bank practices, safe sex, screening and avoiding needle sharing.

How to take the Hepatitis B vaccine?

Hepatitis B vaccine may be given in any of the following schedules: Birth, 1 and 6 months; birth, 6 and 14 weeks; 6, 10 and 14 weeks; birth, 6, 10 and 14 weeks. In catch up vaccination, use 0, 1 and 6 months schedule. An adult, especially if in a high risk comorbidity group, should take the hepatitis B vaccine in three shots. The second dose is given a month after the first, and the third dose is given six months after the second.

His Aadhar card said otherwise. He was 95 years old and surprisingly fit. As we do for all our patients, we conducted a Comprehensive Geriatric Assessment (CGA) — to document his mobility, muscle strength, mood, and memory — and found him acing all clinical and functional parameters. Although 95, he was biologically younger than most 70-year-olds I had seen that week., the pain in itself was a red flag. It is the traditional presentation for hidden coronary artery disease in the elderly. So, we went ahead and did a CT coronary angiography — a non-invasive but useful diagnostic test to evaluate arterial blockage. As predicted, the scan indicated prominent coronary obstruction.

I referred him to a geriatric cardiologist, stressing in my note that even though Mr Johnson was chronologically 95-years-old, he was biologically significantly younger. He was what you would call a 'Super-ager.' Yet, to my dismay the doctor did not recommend that he undergo additional invasive studies such as angiography or procedures such as stenting and bypass. Something that would surely have been done for a 75-year-old. Just like Mr Johnson, many older persons frequently remain under-investigated and under-treated even when it might benefit them. So, there is a need to move away from the age mention on the ID cards and develop quantitative methods for assessing a person's biological or functional age. To this end, scientists have developed epigenetic clocks, which measure the chemical changes happening in the DNA with age. While the first version called the Horvath Clock focused only on DNA changes, the newer models also incorporate blood tests and health data for a more accurate picture of our biological ageing process. DunedinPACE - one of the recent, most advanced epigenetic clock — combines the blood-based markers of changes to the DNA with key clinical assessment of organ systems such as brain, heart and lung. What sets it apart is its ability to calculate the pace at which a person is ageing. When tested in European and some Asian populations, the researchers found that the people showing signs of accelerated ageing — where their biological age is



more than their chronological age — face a higher risk of poor health outcomes, complex diseases, and premature

One of the challenges, however, is that these clocks have been validated in different ethnic and geographically distinct populations. And, no such clock has been developed in India. To address this, the All-India Institute of Medical Sciences (AIIMS) with funding support from ICMR, has launched a pioneer study in the field of biological ageing. Using the data collected over the years through this research, we aim to develop a predictive algorithm to estimate biological age and pace of ageing in the Indian opulation.Meanwhile, there are things that people can do to slow down their biological ageing. There is plenty of evidence that restricting calorie intake, following a balanced, nutrient-rich diet focussed on whole foods, and limiting processed and junk foods can help keep our cells younger. Staying active and getting regular exercise is also one of the most reliable ways to slow our biological ageing clock. Equally important is prioritising quality sleep and managing chronic stress, which is known to accelerate ageing at the cellular level. Relaxation techniques like yoga, meditation and mindfulness can help regulate stress and promote healthy ageing. Avoiding smoking and limiting alcohol consumption are also critical. Lastly, the role of meaningful human connection is deeply impactful. Strong social bonds and engagement with others go a long way in maintaining emotional resilience and help slow the pace of biological ageing. With ageing becoming a popular topic, many health and wellness companies have come up with claims of reversing biological ageing. Most of these claims are misleading and not backed by rigorous science. In the absence of the gold-standard randomised control trials, do not let the hype of social media influencers or billionaire celebrities drive your decisions.

Health Minister J P Nadda says ICMR study shows over 84% of IT sector employees in Hyderabad have the condition

More than 84 per cent of IT sector employees in Hyderabad had increased liver fat, indicating a condition called the MAFLD (or Metabolic Dysfunction Associated Fatty Liver Disease). This is basically fatty liver brought on by obesity, diabetes and high blood pressure. The IT employees seem to be a vulnerable group because of their largely sedentary lifestyles, poor diet and lack of sleep. The study — based on data from 345 IT employees — found that 76.5 per cent had high levels of LDL (low-density lipoprotein or bad) cholesterol, 70.7 per cent were obese and 20.9 per cent had higher than normal fasting blood glucose levels. While the study was published in the journal 'Scientific Reports' earlier this year, it was reported recently in the Parliament by Union Health Minister JP Nadda, He was answering a question by AIMIM member Asaduddin Owaisi on the burden of MAFLD and what the government was doing to combat the challenge.

What is MAFLD?

This is a chronic condition where excessive fat builds up in the liver. This can, over time, lead to inflammation and scarring, which damages the liver tissue. Unchecked, this leads to cirrhosis and even liver cancer. Until recently, the condition was referred to as Non-Alcoholic Fatty Liver Disease (NAFLD) as the symptoms were similar to what would be seen in alcoholics but with alcohol consumption. It is estimated that anywhere between nine per cent and 32 per

cent of the population is living with this condition. In the absence of early symptoms, most people are unaware that they have fatty liver, often associated with drinking alcohol. It is only when the condition progresses and the liver gets damaged that people may experience symptoms such as abdominal pain, fatigue and weakness, loss of appetite, weight loss and jaundice (yellowing of the eyes and skin caused by bilirubin buildup when the liver does not function properly).

What are risk factors?

Obesity, especially fat around the abdomen, insulin resistance, high blood glucose levels, high blood pressure, high cholesterol levels — are all considered to be risk factors for MAFLD.A study by the Indian Council of Medical Research (ICMR) — conducted with the Institute of Liver and Biliary Sciences — has been initiated to look for regional risk factors for fatty liver disease. Phase I of the study conducted in three tehsils of Jaipur found that 37.2 per cent people had fatty liver disease, with the prevalence being higher in men.Importantly, it found that people consuming fast-food weekly were at an increased risk of fatty liver disease, with 76.3 per cent of the regular consumers of fast food having the condition, according to the reply in the parliament. The study in IT employees from Hyderabad, quoted above, also looked at the prevalence of various risk factors.

Shubman Gill's pursuit of perfection: How Indian captain put in serious hours to prepare for English Test and came out trumps

It was about a month before he was to take the most important flight of his life to Heathrow, London, for his first assignment as India's Test captain at 25. On one gloomy day in Chandigarh before Shubman Gill came to England, England came to Shubman Gill.It was IPL time, he was leading the Gujarat Titans and having nets on what seemed like a 'dicey' pitch - some balls flying towards his face, others darting at his ribs. Shubman would stop training, dump the white balls back in the kit bag, and ask for a shiny red new one, the kind used for Test matches. Even while playing IPL, Shubman wasn't missing a chance to be Englandready. Gujarat Titans' assistant coach Naeem Amin is based out of London, and he was there to witness Shubman's quick ball-switch. "And the bit that you will find interesting was him keen to practice just against a new ball. As soon as the new ball would become a little bit old, he'd change it for another new ball," says Amin. As India's new Test No.4, Shubman knew that after facing the white-ball on flat tracks, he had to deal with the swinging-seaming red cherry in England. Amin also talks about the young skipper's hunger to learn and the desire to improve. "His appetite always puts cricket first, and in that aspect, he is second to none. When Kane Williamson (former New Zealand captain and world's leading modern-day batsman) was in our team (GT), he was asking him about his thoughts all the time. 'How would you go about this or that? Why are you doing this drill? How

Williamson is in England playing county cricket these days, and turned up for the Lord's Test to find his one-time IPL teammate in the middle of the form of his life. He was pretty happy with what he saw.

The pursuit of batting perfection has been Shubman's life goal since his wonder years in Punjab's border town of Fazilka. His father, a landed farmer, would pay kids in the neighbourhood Rs 100 to bowl at his son all day. When in his teens, Shubman knew that he could go back to tractors, fields and the family agriculture income, if cricket didn't work out. Like many others around him, the batting prodigy didn't lose sleep over the dilemma of academics or a career option. He would get up fresh with only cricket on his mind.

Shubman would follow a punishing schedule, all through his Under-16 and Under-19 days, bat close to 6 to 8 hours every day. A typical day for him in Chandigarh, where he and his father moved from their village, would be about 3 to 4 hours of batting in the morning, a quick Amritsari lunch of patti or chhola kulcha, and again 3 to 4 hours of batting. Even when he made it to the Indian team, he was among the batsmen who batted the most at the nets.

"I want my body to take control of my mind ... Not my mind taking control of me, seeding inside me self-doubts or getting carried away. Because I have practised so much for so many years, I want my body to take control of my mind. Let the muscle memory kick in. That's my challenge: use the mind to tell itself to stay quiet," he once told

This was like the Swedish pole-vaulter Mondo Duplantis clearing new heights every other day, raising the bar at will.lt was in Birmingham that Shubman would find his Bodhi Tree, where he found enlightenment. In England, his 267 is being hailed as the most perfect knock he's ever played. Data shows that epic innings had a false shot percentage of 3.5 – that's the least for any innings in England since this statistic came into existence 20 years back.

England isn't an easy place to play cricket. In summer, the days are long; for cricketers, they are longer. They can suck the energy out of you, the weather can be murky, it can make you gloomy. This time, during the day, there was heat too.

Consider the schedule of an Indian cricketer during the Lord's Test to understand this. The day would start at 6 am to be on the team bus that would start at 8 am. The match timing would be 11 am to 6.30 pm. By the time the team settles on the bus for the journey back to the team hotel, after press conferences and interviews, it would be 7.30 p.m.From Lord's to St James Court, where the team stayed, was easily a one and half hour long journey on the team bus, negotiating London's notorious traffic. After that the players would have a meal, some me-time and then hit the bed. Within hours, the alarm would go off once again. The schedule would be more or less the same for 25 days, plus there was the pressure of performance and fear of failure to deal with. For Gautam Gambhir, Shubman's biggest achievement as a first-time skipper was to remain unfazed all through this very demanding tour. "This England team

On the eve of the next Test, he would take the blame, promise to do better and an astonishing atonement waited for him. He would score a double hundred in the next innings. What was that compelling reason for the improved performance?"Sometimes, especially when you are the captain, I think you need to lead by example so that whenever there is another player in that situation, you can command that player," the team official said. The ball that Mohammed Siraj bowled to Gus Atkinson to rattle his stumps was Siraj's fifth fastest delivery of the series, and this came after five Tests in which he bowled a whopping 185.2 overs. He ended up as the leading wickettaker with 23 wickets in the series. He was the last bowler remaining from both sides to play all the games at the end alongside Chris Woakes. Former Indian cricketer Sunil Gavaskar, appreciative of Siraj's workload, said that he debunked the "business of workload."

"There's always the saying that the bowlers win your matches, but the fact of the matter is that you've also got to score the runs. So because India didn't score the runs, they lost those two matches. So yes, I think Siraj bowled his heart out, and he debunked forever this business of workload," he said, speaking to India Today. "I hope that the word 'workload' goes out of the Indian Cricket dictionary. I've been saying that for a long time. For five Test matches nonstop, he bowled 6-over, 7-over, 8-over spells because the captain wanted it, and the country expected of him. And I think that is the one thing that we all should keep in mind that this workload is only a mental thing, not so much a physical thing," Gavaskar added. "If you are going to succumb to people who are talking about workload, then you



are never going to have your best players on the field. You've got to get them to a situation where you say, 'Hello, you are playing for your country, and when you are playing for your country, you got to forget the aches and pains in your muscles. That is what you mean on the border. Do you think the jawans complain about the cold, or what is the situation? They are there to give their lives for the country. Give your very best for the country. Don't worry about accident pains. What did Rishabh Pant show you? He came out bat with a fracture. That is the kind of thing you want to expect from your team," Gavaskar further said.

Suryakumar Yadav returns for training for first time since sports hernia surgery

Indian T20 captain Suryakumar Yadav, who was injured in July with a sports hernia, returned to the BCCI Centre of Excellence last week for his first net session. The 34-year-old flew to Germany to have surgery. Surya's workload will be monitored, and it will be increased gradually due to the upcoming Asia Cup 2025, which starts on September 9.According to ESPNcricinfo, initially, his return was planned, given the series against Bangladesh, which was scheduled for late August 2025, but has been postponed to next year. This is Suryakumar's third surgery in the last three years. After an ankle surgery in 2023, the stylish Indian middle-order batter had previously undergone the same sports hernia surgery back in 2024.

Survakumar had a tremendous season with the bat for Mumbai Indians. He became only the second batter after great Sachin Tendulkar to score over 600 runs for MI in a season. The '360-degree' batter ended the season with 717 runs, only second to Orange Cap holder Sai Sudharsan, who had scored 759. His prolific season with the bat helped Mumbai Indians reach the knockouts and beat Gujarat Titans in the Eliminator before losing the second Qualifier against Shreyas Iyer's Punjab Kings. Suryakumar was adjudged the Player of the Series (Most Valuable Player) for IPL 2025. He then led Triumph Knights Mumbai North East in the T20 Mumbai League and scored 122 in the five innings. However, his team could only win one out of five league matches and finished sixth in the points table, featuring a total of eight teams. India's next T20 International assignment will be the Bangladesh tour in August, later this year. India will travel to Bangladesh to play three One-Day Internationals and as many T20Is.BCCI will host the Asia Cup, to be played in T20 format, in the United Arab Emirates (UAE) from September 9 to 28. The marquee match between India and Pakistan — both placed in Group A will be played on September 14. This will be the first match between India and Pakistan after the terrorist attack in Pahalgam, in which 26 civilians were killed. Subsequently, Operation Sindoor was conducted by the Indian armed forces in Pakistan against terror emanating from that coun-

Actor with 14 flops took Ajay Devgn's role in blockbuster, promised 100 films with director, hasn't spoken to him in 20 years

If you look at Akshay Kumar's career trajectory, there has been phases of hits and flops. While his early films, including his debut Saugandh (1991), failed to earn him fame, Khiladi (1992) turned him into an overnight sensation. Between 1996 and 1999, his films Khiladiyon Ka Khiladi and Sangharsh worked in his favour, several of his other films flopped, making directors and producers "ridicule" and "reject" him. Around the same time, he teamed up with filmmaker Suneel Darshan for Jaanwar, a film that marked his comeback. The success made the same directors and producers who once dismissed him eager to work with him. However, things eventually soured between Akshay and Suneel, and the two haven't met in the past 20 years. In a recent interview with Bollywood Bubble, Suneel Darshan opened up about the time when Akshay Kumar requested to cast him in his film Jaanwar. "Akshay had been through a phase of his career when he had stopped getting movies. He had reached a point where he had about 13-14 flops. He didn't know how to go forward. And when someone is unsuccessful, people try their best to push them away and he was going through that phase.

It was around the same time when Suneel Darshan had a misunderstanding with Sunny Deol, for whom Jaanwar was originally scripted. "I had a script written for Sunny Deol, who let me down for a different agenda. After that, I decided I will not be working with him. After Sunny, I approached Ajay Devgn. He was very keen to do the film. The distance was just like cup and lip from him doing the film when Akshay Kumar called me. He met me. We talked and I thought 'My God! He is such a gorgeous looking man! He was very humble, had the humility of a Punjabi boy.

He added, "Besides all this, there was this one thing about him-his reputation of being a very disciplined actor. While these were his plus points, the biggest minus point was that he was not saleable. And to make a movie of that size with a hero who was not saleable, was a very big risk to take. It was a huge challenge." Exposing the reality of the glamour industry, Suneel Darshan shared people are only nice to successful actors. But, as soon as they have a downfall, the same people humiliate them. "It is very traumatic for the actors." After that, Jaanwar happened. It was very well supported by my entire team, which included Karisma Kapoor who was a top star at that point of time." The success of Jaanwar led to Suneel and Akshay signing six more films together-Ek Rishtaa, Talaash, Dosti, Mere Jeevan Saathi, and Andaaz. Suneel directed them all except Andaaz. Their collaboration too were a mix of hits and

The filmmaker recalled, "We did seven films together



and co-incidentally our seventh and last film was titled Dosti. He was in this office for seven years. He operated from the same office for seven years. He would come everyday when he was not shooting. I wanted his good from day 1. It was just me who stood up for him when everybody else only rejected and ridiculed him. And this is something he told me himself. And I was the happiest when Akshay worked with the same lot of people but on his own terms. That was my biggest win.

"After Jaanwar's success, he took me in out in his car. We drove to a construction place. We sat there. He said, 'It has come to my notice that you are planning to cast a new hero for your new film. I heard you went to his father's office. I was like, 'Yes, I did. But that is because I share a bond with his father and he wanted to show him to me.' Then he requested, 'Please sir, don't sign anybody else, it will affect my career.' He held my hand and promised to me, 'Suneel Ji, I promise to make 100 films with you.' I just kept looking at him."He added, "Anyway, the truth is even making seven films with the same person in the same stretch was a big thing in itself. While doing our sixth film, I could feel a difference in his behaviour. And it got quite evident when we shot for our seventh film. When I sensed it, I thought to myself that it is better if I step back at a situation like this. And I moved on."The last time I met Akshay Kumar was back in 2005. We have never met after that. Post that, he wished me maybe once or twice for my birthday," shared the director. He added, "I didn't want him to have a baggage of his past. I told him, 'I will be happy if you maintain your career.' Even Amitabh Bachchan made several films with Prakash Mehra, but after a point things didn't work between them. It often happens with actors.'



I don't want to put the onus of responsibility for 'haadsa' Priyanka..."In an earlier interview with Friday Talkies, Suneel had said, "Kuch blunder aise ho chuke thay (He did some blunders). Some rumours about Priyanka Chopra and Akshay Kumar started doing the rounds and Twinkle had left his home. As an actor you have to be responsible. If your wife has

been an actress, she knows everything about the industry and she has also worked with all the big stars. She knew everything." Suneel clarified that he did not hold Priyanka responsible for the situation, adding, "I don't blame Priyanka Chopra for this. She was doing what was in her own interest."

In another interview with Vickey Lalwani, he said, "It's not about him not wanting to work with Priyanka Chopra. Circumstances had reached a point... The public, the media did mention a relationship, which the wife got to know of. But suddenly, after making me wait for 18 months, to say that I can't be a part of the film, I was shocked... He did want to compensate by saying he'd do the next film with me, but I just thought it was unbelievcoming able, Akshay."Akshay Priyanka worked together on the films Andaaz, Aitraaz, and Waqt: The Race Against Time. In a recent interview, Priyanka made a rare comment about Akshay, and praised his action chops.
