It's the first National Award for friends and frequent collaborators Shah Rukh and Rani as well as for Vikrant. While Shah Rukh got it for his role in "Jawan", sharing his win with "12th Fail" star Vikrant, Rani bagged it for "Mrs Chatterjee vs Norway". There were whistles and loud cheers as Rani and Shah Rukh went up to receive their awards at the traditionally sober ceremony. Mohanlal, recognised for a remarkable career spanning five decades and more than 360 films, got a standing ovation from the crowd gathered at the city's Vigyan Bhawan. "I got to know that when Mohanlal's name was announced for Dadasaheb Phalke, there was wave of happiness among people. It shows that he has made a space for himself in countless people's heart," the president said in her address after the award ceremony. "He has presented the softest of the soft and toughest of the tough



emotions quite naturally," Murmu added in a speech in which she congratulated all the winners and touched on various issues, including the plurarity of Indian cinema, Indian sensibility and women-centric films. "Now we see women in many places in cinema like actors and producers. I have seen films about mothers, women uniting against societal wrongs, and strong women who raise their voices. I salute these filmmakers on behalf of sisters and daughters. Please thank your crews for your success, they are behind it,' she said. Just like Indian literature is created in various Indian languages, the president said, Indian cinema is advancing in so many languages, dialects, regions and local environments. Ponnam demands Centre to address Telangana's 7,000 crore GST loss

Hyderabad, Sept.23: Minister for Transport Ponnam Prabhakar stated that the new revised GST framework is causing Telangana to incur annual losses of Rs. 7,000 crore, and he urged the central government to take responsibility for these losses. Addressing the media conference at Gandhi Bhavan on Tuesday, Ponnam Prabhakar criticised the central government for its GST reduction strategy, suggesting that it conveys a message akin to "let yourself perish."

He further remarked that the central administration is placing the entire burden of welfare onto the states while simultaneously exploiting them through various cesses. He recalled that when GST was implemented, it was promised that the central government would compensate states for pensation has yet to be fulfilled. "The Telangana state is currently facing a revenue loss of Rs. 7,000 crore due to the newly revised GST framework. The central government needs to provide clarity on how much it will actually compensate for these losses. Union Ministers from Telangana, including Kishan Reddy and Bandi Sanjay, should engage in discussions with the central authorities and seek clarification on this matter," he stated. The Minister accused BJP



leaders of exaggerating claims that GST is benefiting the poor. In reality, he argued that GST implementation has disadvantaged the poor. He described the reductions in GST as electoral theatrics and asserted that the impoverished have yet to experience any benefits from it. He criticised the additional taxes associated with different GST slabs as a burden too heavy for the poor to manage, Ponnam

Kavitha demands bonus for Singareni workers based on gross profits

Almatti height increase would be detrimental to Southern Telangana - TBJP Chief

Hyderabad, Sept.23 : Telangana BJP President N Ramchander Rao on Tuesday accused the Revanth Reddy-led Congress government for 'compromising' the interests of Telangana over the proposed increase in the height of Almatti dam. Addressing a press conference at the state party office here, Rao said that the Karnataka government is contemplating raising the dam's height from 519 to 524 meters, which would be highly detrimental to farmers in Telangana. He criticized Revanth Reddy for frequently visiting Delhi to meet Sonia Gandhi, Priyanka Vadra, and Rahul Gandhi, but failed to raise the crucial dam height issue despite both states being ruled by the Congress party.

The BJP leader further alleged that, despite a Supreme Court stay prohibiting any construction or height increase of the dam, the Karnataka government is proceeding with land acquisition around the site with the clear intention of expanding storage capacity. He warned that any increase in height would severely affect farmers across southern Telangana, particularly in the districts of Mahabubnagar, Nalgonda and Ranga Reddy, potentially turning these ar-

"The BJP will strongly oppose any attempt to raise the Almatti Dam height," Rao declared, questioning why the Telangana Chief Minister, despite his party being in power in Karnataka, has failed to take proactive measures to safeguard Telangana's rightful share of Krishna

river waters. Even Mahabubnagar district, the Chief Minister's native place, would face water scarcity if the project proceeds, yet the CM has chosen silence on this critical matter. He accused the Congress government of prioritizing 'contracts and commissions' over protecting the state's interests. It is for this reason that scriptures exalt the mother to the status of Parabrahman — the Supreme Consciousness itself. To bow at her feet is to bow to the highest spiritual reality. To walk around her in reverence (pradakshina) is equivalent to circumambulating the very cosmos.""A mother, even if aged, frail, forgetful, or unable to care for herself — still holds the divine power to uplift her children. Though she may no longer remember whether she has eaten, though she may struggle to utter a prayer or light a lamp — her mere presence is redemptive. She may speak to herself or live in silence, but her being is a sacred tirtha (pilgrimage). "Media Bias Undermining Democracy: Putta Madhukar Slams Favoritism Toward Duddilla Sridhar"



"P.S.ASHOKAN"Indian Chronicle"Hyderabad, Telangana: ""Former Manthani MLA Putta Madhukar launched a scathing attack on certain media outlets, accusing them of deliberately creating a biased political atmosphere in favor of sitting MLA Duddilla Sridhar. Addressing the media at a press conference held at Telangana Bhavan on Tuesday, Madhukar questioned whether democracy is being replaced by selective narrative-building and mediafueled political monopolies. He alleged that some media organizations, possibly under Sridhar's influence, are engaging in false reportage, portraying him as absent from public life - a claim he dismissed as baseless and defamatory. ""> "What wrongdoing have I committed to warrant such slanderous propaganda from channels like NTV?" Madhukar demanded.""The media should be a watchdog of democracy — holding the powerful accountable — not acting as a shield for entrenched political elites."""Madhukar, who has been in public life for over 37 years, said he has always remained accessible to the people of his constituency, even after electoral defeats. He challenged the media to focus on more pertinent issues, such as the current MLA's underperformance, rather than vilifying him without cause.""> "If you're intent on running stories, focus on Sridhar — a three-time minister and five-time MLA — who, despite decades in power, has failed to bring a single factory, industry, or meaningful employment to Manthani." Madhukar asserted. """He lambasted the Duddilla family for failing to contribute to their own native village of Dharmaram, even after four decades of political and economic prominence.""> "Despite living in the U.S. for 40 years with the people's blessings, Sridhar's family couldn't even donate a bench to a local school," he said. ""Even after being selected for a pilot project under the Indiramma housing scheme, they couldn't complete two houses."""Madhukar further criticized the media silence surrounding incidents like the removal of an Ambedkar statue, which he and his supporters had installed using personal funds. He accused certain groups of operating "like thieves in the night", removing the statue's cover before its planned inauguration."

"He also drew historical parallels, accusing Sridhar's father of colluding with authorities under the guise of anti-Naxal operations in the past, and alleging that Sridhar continues similar practices today through police suppression. ""Addressing rumors about an ongoing CBI inquiry, Madhukar denied any wrongdoing and said he has nothing to fear. ""> "Whether I win or lose, I remain with the people. I've contested four times and lost three, yet my bond with Manthani is unwavering."""He criticized past efforts to prevent him from receiving party tickets, claiming that Sridhar and his father systematically blocked rivals from contesting. Cotton Procurement Must Be Transparent: District Collector Jitesh V. Patil

Patil has directed officials of the concerned departments to ensure that cotton procurement across the district is carried out in a fully transparent manner. ""On Tuesday, the Collector held a review meeting at the camp office with officials from Agriculture, Marketing, Planning, Transport, and Police departments to discuss cotton procurement arrangements.""Speaking on the occasion, the Collector stressed that all officials must ensure farmers do not face any difficulties and that they receive the government-fixed Minimum Support Price (MSP) in a fair and transparent manner. He noted that cotton is being cultivated in 1,72,937 acres across the district, and the Agriculture Department has estimated a yield of 26.56 lakh quintals. For 2025-26, the government has fixed the MSP for cotton at ?8,110 per quintal, he added.""Officials informed the Collector that six procurement centers have been set up under the Cotton Corporation of India (CCI) to facilitate purchases. The Collector instructed the Legal Metrology Department to thoroughly inspect weighing bridges to avoid discrepancies in weighing, and directed that farmers' produce be recorded accurately. He also emphasized that payments to farmers should not be delayed and must be processed on time through a transparent system. "The Collector further instructed that procurement centers be equipped with basic amenities such as drinking water, accommodation facili-



ties, storage warehouses, and moisture testing machines. He cautioned that no middlemen or unauthorized buyers should interfere with the procurement process, and urged farmers to sell their produce only at government procurement centers. ""He also directed millers to take adequate fire safety precautions at cotton mills and advised that awareness be created among farmers on using cotton stalks for biochar production after harvest. ""The meeting was attended by CPO Sanjeeva Rao, Agriculture Officer Baburao, Marketing Officer Narender, Legal Metrology Officer Manohar, Transport Officer Venkataramana, along with officials of other concerned departments and cotton millers.

Why is India's trade deficit with China a concern? What is the risk of increasing dependence? | Explained

The bilateral trade between India and China has been growing at a healthy rate, but the trade gap remains sharply tilted in Beijing's favour. India has time and again flagged its concern over the ballooning trade deficit and the non-trade barriers faced by Indian goods in the Chinese market., Prime Minister Narendra Modi said it is important for India and China to work together to bring stability to the world economic order as he asserted that New Delhi is ready to advance bilateral ties from a strategic and long-term perspective based on mutual respect, mutual interest and mutual sensitivity. A list of questions and answers to understand the trade-related issues between the two countries:

How much is the bilateral trade between India and

During April-July 2025-26, India's exports rose by 19.97% to \$5.75 billion, while imports increased by 13.06% to \$40.65 billion. In 2024-25, India's exports stood at \$14.25 billion, while imports were \$113.5 billion.Trade deficit (difference between imports and exports) rose from \$1.1 billion in 2003-04 to \$99.2 billion in 2024-25. China's trade deficit accounted for about 35% of India's total trade imbalance (\$283 billion) in the last fiscal. The gap was \$85.1 billion in 2023-24.

Why is the deficit with China a concern?

Because it is not only large, but also structural. What makes it more serious is that China now dominates India's import baskets across virtually every industrial category — from pharmaceuticals and electronics to construction materials, renewable energy, and consumer goods, according to think tank GTRI.

For which key products China's share is over 75%? GTRI analysis states that in antibiotics like erythromycin, China supplies 97.7% of India's needs; in electronics, it controls 96.8 per cent of silicon wafers and 86 per cent of flat panel displays; in renewable energy, 82.7% of solar cells and 75.2% of lithium-ion batteries come from China. Even everyday products such as laptops (80.5% share), embroidery machinery (91.4%), and viscose yarn (98.9%) are overwhelmingly Chinese-sourced.

What is the risk of increasing dependence on China?

GTRI Founder Ajay Srivastava says overwhelming dominance gives Beijing potential leverage against India, turning supply chains into a tool of pressure in times of political tension. The imbalance is deepening as India's exports to China continue to decline, reducing India's share in bilateral trade to just 11.2% today from 42.3% two decades ago. However, according to the Commerce Ministry, most of the goods imported from China are raw materials, intermediate products and capital goods like auto components, electronic parts, mobile phone parts, machinery and active pharma ingredients. Thes are used for making finished products, which are also exported. India's dependence on imports in these categories is largely due to the gap in domestic supply and demand, the Ministry said.

What steps India has taken to cut its import dependence?

Introduction of production linked incentive schemes for over 14 sectors to boost domestic manufacturing; stricter quality standards and measures for quality controls, testing protocols, and mandatory certification to check substandard and poor-quality products in the market and protect consumers' interest. The government encourages Indian business establishments to explore alternative suppliers to diversify their supply chains and reduce dependency on single sources of supply. It also monitors the surge in imports on a regular basis and takes appropriate action. Further, the Directorate General of Trade Remedies (DGTR) is empowered to recommend trade remedial actions against unfair trade practices. India has imposed anti-dumping duties on a number of Chinese goods and sectors such as chemicals to engineering items to protect domestic firms from cheap imports

What is the impact of rising trade deficit?

Pressure on foreign exchange reserves, dependence on external suppliers, cheaper imports can hurt local manufacturers; can lead to currency depreciation pushing cost of imported goods, fuelling inflation; and over-reliance on imports reduces incentives for building domestic capacity in key sectors, slowing long-term industrial growth.


Carpet industry demands special bailout package

The carpet industry has urged the central government for a special bailout package for the exporters in this sector, especially in Bhadohi, as a cushion against the impact of 50% tariff imposed by the U.S.All India Carpet Manufacturers Association (AICMA) and the Carpet Export Promotion Council (CEPC), which operates under Ministry of Textiles, had met with Union Textiles Minister Giriraj Singh in this regard.Bhadohi MLA Zahid Baig (Samajwadi Party) has also requested a special 10% bailout package from the Uttar Pradesh government to provide relief to the exporters.

According to Akhilesh Singh, Chief Administrative Officer of CEPC's Bhadohi office, India's carpet exports in the last financial year were valued at ?16,800 crore. Of this, 60% was exported to the U.S. and 40% to European countries. He noted that Bhadohi alone accounts for 60% of the country's total carpet exports, making it clear that the U.S. tariff will hit the district's exporters the hardest. Both organisations stressed that their priority is to keep their American importers engaged. They explained that if these importers begin sourcing from countries where the U.S. has imposed lower tariffs, such as China, Turkey, and Pakistan, it would be extremely difficult to win them back.

Meanwhile, in a letter to Uttar Pradesh Chief Minister Yogi Adityanath, Baig emphasized that the tariff will most significantly impact the carpet industry because 99% of carpets made in India are exported, with 60% of that going to the U.S.The MLA highlighted that the carpet industry is a



cottage industry that employs 30 lakh people, with women making up a valuable 25% of that workforce. He stated that these women are self-reliant, earning through various types of carpet weaving from their homes. Baig warned that if exports are affected, the biggest blow will be to the weavers, labourers, and women who create these carpets using only their hands and skills, without the use of machinery. This could impact a large portion of the population and lead to millions losing their livelihoods. Mr. Baig urged the government to protect the 800 export units in U.P. from this direct blow. As a representative of Bhadohi, he appealed to the chief minister to immediately announce a 10% special bailout package for Uttar Pradesh's exporters to save the carpet industry.

EC mulls setting up polling booths in Bengal's housing societies; won't allow on private premises, says TMC

The Election Commission (EC) has proposed to set up polling booths in housing societies and high-rises in the state which have over 400 voters, a move opposed by West Bengal's ruling Trinamool Congress stating that they will not allow booths on private premises.

The poll panel first started this experiment in Delhi to increase voter turnout in urban areas. Many in Bengal's political and administrative circles believe the decision could impact next year's Assembly polls, especially in constituencies like Kolkata, Howrah and the Salt Lake-New Town area that house large numbers of multi-storeyed residential complexes. However, the BJP, which believes that high-rise residents tend to be its supporters and are often prevented from stepping out to vote by alleged Trinamool-backed goons, welcomed the decision. "Polling booths were set up in high-rises for the first time during the Delhi Assembly polls, and it raised the turnout by 15 per cent compared to the previous election," a poll panel official said. "So, it was decided to extend the measure across the country." For now, housing complexes with at least 400 voters will be considered for the privilege, sources in the Election Commission said. "For this, the secretary of the housing society would have to give a No-Objection, and there should be a proper space, like a community hall, to set up the polling booth," said a senior EC official. He added, "The Election Commission will arrange the polling and security personnel. It will also ensure CCTV coverage."

But sources in the EC said the TMC opposed the proposal. State Sports Minister and TMC leader Aroop Biswas, who was part of the party's delegation to the EC, said, "It is not acceptable to set up booths in private areas. Our party will not allow booths on private premises. We had already opposed such proposals."Responding to this, BJP leader Rahul Sinha said, "It is obvious that the TMC would oppose such proposals. They know that educated people don't support them. That is why they always try to stop them from reaching the booth. Previously too, in many cases, they just kept many societies under lock and key so that the people residing there couldn't exercise their franchise and the TMC cast their votes. If the EC sets up such booths, the TMC won't survive."

Expressing concern, a senior BJP leader said, "If the EC tries to implement this decision, TMC leaders would threaten the secretaries of housing societies so that they would not give permission to the poll body to set up booths in their societies."On Friday, the EC had a meeting with an all-party delegation on booth rationalisation, during which the state Chief Election Officer (CEO) decided to increase polling booths in the state by almost 14,000. A draft list of the new booths has already been prepared. According to the draft list, West Bengal will now have 80,681 polling booths. As per the proposal, the total number of booths will increase by 13,816, as many as 37 booths will be abolished, and 1,253 booths will be reorganised. Another 703 booths will be shifted to a new location. Couple's deaths after liver transplant surgery: Pune police record statements of family members

Pune liver transplant deaths, Sahyadri Hospitals liver transplant case, Kamini Koamkar death after liver donation, The relatives of the deceased had approached the Deccan Gymkhana Police station alleging medical negligence for the deaths. The Pune city police on Friday recorded the statements of relatives of Kamini Koamkar, 42, and her husband Bapu Balkrishna Koamkar, 49, who had died after a liver transplant surgery at Sahyadri Hospitals in the city. Kamini, a resident of Hadapsar, had donated part of her liver to her husband Bapu on August 15. Post-transplant, Bapu passed away on August 19, while Kamini, who had initially recovered, developed hypotensive shock and multi-organ dysfunction and died three days later. According to Sahyadri Hospitals authorities, she could not be saved despite advanced treatment.

The relatives of the deceased had approached the Deccan Gymkhana Police station alleging medical negligence for the deaths. The police had recorded an accidental death report and launched an inquiry. "We have recorded the statements of the family members of the deceased as a part of an inquiry into the accidental death report," said senior police inspector Girisha Nimbalkar, Deccan Gymkhana police station. The state health directorate has set up a high-profile committee headed by Professor Mohamed Rela, a leading figure in liver transplantation and president of the International Liver Transplant Society, Chennai, to review the case of the deaths. Police said when-



ever medical negligence is alleged, a medical board comprising competent authorities from the state-run Sassoon General Hospital is formed and conducts an inquiry. "After this board submits a report, a First Information Report may be registered in cases where the committee finds medical negligence," Nimbalkar said.Balraj Wadekar, brother of Kamini Koamkar, said,

"The police have sought our stance in the case. We have provided all the details on the timeline, medical history, and other relevant information," Wadekar said. According to Wadekar, the complaint, post-mortem report, and other details will be submitted to the 8-member committee. "They will decide on our complaint of medical negligence," he added.

Elgaar Parishad accused Ramesh Gaichor released on temporary bail to meet ailing father, jail authority apologises to Bombay HC for delay

The Taloja Prison authorities on Thursday tendered an unconditional apology before the Bombay High Court for not complying with its August 26 order and submitted that the Elgaar Parishad case accused Ramesh Gaichor was released on a three-day temporary bail on the night of The High Court had granted temporary bail to Gaichor to visit his ailing father and directed the Taloja prison to release him on September 9, so that he would be back in jail on September 11. However, Senior Advocate Mihir Desai and Advocate Sanskruti Yagnik for Gaichor filed an application on Wednesday claiming that he was not released from prison despite the HC order, as the jail authorities insisted on a release warrant from the trial court. On Thursday, Pramod Wagh, Superintendent of Taloja Central Prison, filed an affidavit tendering unconditional apology for not complying with the August 26 order. The affidavit informed the HC

that Gaichor was released from jail after 10 pm on Wednesday. The court accepted the apology and modified the duration of the temporary bail period from 11 pm on September 10 till 5 pm on September 13.

Ramesh Gaichor, who was part of the cultural group Kabir Kala Manch, was arrested along with others by the National Investigation Agency (NIA) in 2020 for his alleged role in the controversial Elgaar Parishad event held in Pune on December 31, 2017.A Division Bench led by Justice Ajey S Gadkari on Wednesday pulled up the jail authorities for not complying with its August 26 order and questioned as to what was the need for the release bond or warrant procedure to be followed when the HC had ordered his release. The government lawyer had claimed that a warrant or bond was a general procedure followed while seeking a release, and that the delay took place due to a certain misunderstanding on the part of jail authorities, and such issues had also arisen in earlier cases. The court orally remarked that it was "sheer high-handedness" by the jail superintendent and warned of action against him. The High Court, on August 26, passed an order on Gaichor's criminal appeal challenging the July 1 order of the special court designated under the National Investigation Agency (NIA) Act, which rejected his plea for temporary bail. Gaichor had claimed that he had not met his over 75-year-old father, who is suffering from age-related ailments since his arrest in September 2020, and he was desirous to see him. The appellant had said that the trial court did not consider the said aspects and rejected his temporary bail plea.

Bikram Singh Majithia seeks anticipatory bail in DA case, Punjab & Haryana HC seeks govt response

The Punjab and Haryana High Court on Thursday gave the Punjab Government two weeks to respond to former minister Bikram Singh Majithia's petition for anticipatory bail in a disproportionate assets case registered in July.

Majithia, a senior Shiromani Akali Dal (SAD) leader and brother-in-law of party chief Sukhbir Singh Badal, moved the high court after an Amritsar court dismissed his anticipatory bail application. The former minister was arrested from his home on June 30. His judicial custody, first extended till August 28, was further prolonged to September 6. He remains lodged in New Nabha Jail near Patiala.

A Mohali court rejected Majithia's regular bail plea on August 19, citing the seriousness of the charges and the ongoing investigation. On August 22, the Punjab Vigilance Bureau filed a 40,000-page chargesheet against him in the case. Also on Thursday, a Mohali court dismissed his plea for a separate cell in jail, directing that he continue to share a barrack with other inmates. The Vigilance Bureau has al-



leged that Majithia amassed Rs 540 crore, routed through shell companies. On September 8, the Bhagwant Mannled Cabinet granted prosecution sanction against him under section 19 of the Prevention of Corruption Act.Majithia first approached the high court on July 3, seeking relief against what he called his "illegal arrest and remand".

Bengaluru woman defrauded out of Rs 3.75 crore with Sadhguru's deepfake video: police

sadhguruIn June this year, Sadhguru Vasudev Jaggi and his Isha Foundation approached Delhi High Court against the misuse of his identity through Al-generated deepfakes. (Photo: Sadhguru Jaggi Vasudev/Instagram)A 57-year-old retired woman in Bengaluru has lost Rs 3.75 crore to scammers who used an Al-generated deepfake video of spiritual leader Sadhguru Jaggi Vasudev to promote fake investment opportunities, the police said on Thursday.

The woman, a resident of CV Raman Nagar, was completely unaware of deepfake technology when she encountered what appeared like a genuine Sadhguru video on social media between February 25 and April 23. The woman said in her complaint filed at the East CEN police station, "I watched a video of Sadhguru stating that he had been trading with the firm, for which a link is provided below and If you click it and input your name, email, phone number for an amount of \$250, your finances will improve greatly." After she followed the instructions, the woman was contacted by a person calling himself Waleed B, who claimed to represent a company called Mirrox. The fraudster operated through multiple UK-based phone numbers and added the woman to a WhatsApp group with approximately 100 members. She was then directed to various websites and instructed to download the Mirrox stock trading app. Waleed conducted trading tutorials via Zoom, later introducing another accomplice, Michael C, as a substitute instructor. The scammers employed psychological tactics, with group members regularly sharing fabricated profits and screenshots of supposed account credits to build trust and legitimacy, according to the FIR.

Convinced by these manipulative strategies, the woman began transferring money to bank accounts provided by the fraudsters. By April 23, she had transferred the entire Rs 3.75 crore across multiple transactions, with the fake platform displaying impressive returns on her investments. The woman realised that she had been cheated only when she attempted to withdraw her profits. The



scammers demanded additional payments for processing fees and taxes, raising her suspicions. When she refused to pay these extra charges, the fraudsters ceased all communication. Since the woman filed her complaint on Tuesday, nearly five months after the fraud concluded, a police officer said that the recovery of the lost money would be challenging. The officer added that the authorities were coordinating with banks to freeze the fraudsters' accounts. In June this year, Sadhguru Vasudev Jaggi and his Isha Foundation approached Delhi High Court against the misuse of his identity through AI-generated deepfakes.

What is deepfake? Deepfake is a combination of the terms 'deep learning' and 'fake'. It refers to artificial intelligence software that overlays a digital composite onto an existing video or audio file. Deepfakes are generated using machine learning models that employ neural networks to manipulate images and videos.

In January 2024, actor Rashmika Mandanna's deepfake video went viral and the police arrested Eemani Naveen, an engineer from Andhra Pradesh, who created the video to increase his Instagram followers. Journalist Rajdeep Sardesai and Infosys Foundation chairperson Sudha Murty, wife of Narayana Murthy, are some of the other prominent personalities whose deepfake videos have been used by cybercriminals.

Telangana student among five arrested by Delhi Police over alleged ISIS links

Hyderabad: A youth from Telangana is among five persons arrested by Delhi Police from different parts of the country over alleged terror links. A team from Delhi Police's Special Cell police on Wednesday took a youth into custody in Bodhan town of Telangana and shifted him to the national capital for investigation.

Huzaifa Yemen, 20, is a B. Pharma student at a local college. Literature related to arms, including PDF files, was seized from him, a police source said. 'Behind shutters, we heard gunshots': Bengal and Tripura PhD scholars stranded amid Nepal unrest

Four agricultural scholars, including two from West Bengal's Bidhan Chandra Krishi Viswavidyalaya (BCKV), have been stranded in Kathmandu, Nepal, following violent protests. The group had travelled to Kathmandu on September 5 to participate in the World Congress on Climate Change and Its Effect, held from September 6 to 8 at Central College. The PhD scholars — Swapnajit Chowdhury (from Agarpara, Tripura), Souvik Chakraborty, Mayukh Bhattacharyya and Manihar Talukdar (all from West Bengal) — were scheduled to depart on September 9 by bus from Gangabu (Naya) Bus Park for Kakarvitta on the Indo-Nepal border, and onward to Siliguri. Their plans were disrupted after widespread unrest.

Speaking to The Indian Express, Mayukh Bhattacharyya said, "When we came out of the conference,

we saw that the entire place was burning. Suddenly, we noticed a group from the mob running towards us. The four of us ran towards a momo shop which was open and hid there. From behind the closed shutters, we could hear the crowds and gunshots. Late in the evening, we went to our hotel."He added that while the situation remained grim, they were being provided food and water at the hotel. "We cannot venture out as per Army instructions but then we have to see the monetary aspect also. The food prices will rise. Also, due to disturbed network, online transactions are becoming difficult. We do not know for how long we have to stay. After a few days, it will become difficult for us," Bhattacharyya said. Another scholar, Talukdar, said, "We cannot believe what is happening. We got to know that the bus terminus was burnt, roads were blocked, there are also terrible mobile network issues in our area of Kathmandu. The curfew is on and the Army can be seen everywhere Our families are very worried now."Since September 7, the scholars have been confined to the hotel. "The next day from the terrace of the hotel we could see the Parliament burning and mobs running in the streets and looting shops,' Bhattacharyya recounted. He added that the Indian Embassy in Kathmandu had advised them to remain indoors until the situation normalised. "We have been told to postpone our journey and stay inside the hotel for safety. If the situation worsens, we would seek evacuation support from the Indian Ministry of External Affairs to return to India."According to the scholars, the road journey from Kathmandu to the Indo-Nepal border takes 17-18 hours, and "nobody is ready to risk such a long ride". Airline tickets, they said, had become prohibitively expensive after limited flights resumed. Talukdar, meanwhile, noted: "I do not have a passport, so I can only enter Bengal by road. 'Gentle, brilliant, disarming': How Sri Lankan PM Harini Amarasuriya is remembered by mentor, Hindu College peers

In the early 2000s, Delhi was on edge. A spate of lowintensity bomb blasts-many targeting fruit carts and crowded markets-had unsettled the city. Children were warned against lingering outside schools, and residents grew wary of ordinary street corners. It was during this tense period that Harini Amarasuriya, a former Sociology student at Hindu College, visited her professor, sociologist Susan Visvanathan, at Jawaharlal Nehru University. "Harini admitted to nervousness, and I said, 'Why? Colombo has the same problem.' So she laughed and said, 'If I died there, in Colombo, people would know I had died, but if I died on a street here in a bomb blast, no one would know,' Visvanathan recalled. She never forgot the candid remark, edged with humour and vulnerability. As Amarasuriya is set to return to Delhi as the Prime Minister of Sri Lanka, her alma mater is preparing to honour her with an honorary doctorate at a special convocation. The ceremony, planned in mid-October at Hindu College, marks a homecoming for the former undergraduate who once sat by the window in Room 27, debating Karl Marx and Max Weber with her

Born in March 1970 in Galle on Sri Lanka's southwestern coast, Amarasuriya was the youngest of three children in a family whose fortunes shifted when her father's tea estate was nationalised. She moved with her family to Colombo, studied at Bishop's College, and spent a year in the United States as an exchange student. But as political violence escalated in Sri Lanka in 1988-89, she was forced to discontinue her studies there.Later, on an MEA-sponsored scholarship, she enrolled in Delhi University's Hindu College, where she completed her BA (Honours) in Sociology in 1994. She went on to earn a Master's in Applied Anthropology and Development from Macquarie University in Australia and a doctorate in Social Anthropology from the University of Edinburgh. Amarasuriya's early career unfolded not in Parliament but in community health. Her first job was as a social health officer in a community mental health centre, working with institutionalised women. Later, as head of the Humanities and Social Sciences Department at the Open University of Sri Lanka, she built a reputation as an academic and activist. She entered politics only in 2021, joining the Marxist Janatha Vimukthi Peramuna. Last year, she was appointed Prime Minister—only the third woman to hold the office in the island nation's history.

Room 27 and a student who stood outVisvanathan still remembers the first time she encountered Amarasuriya as a student in the early 1990s. "I came back from a Teen Murti Fellowship in 1992, to Hindu College, and was delighted to find a quartet of students, Ruchi, Ranu, Harini and Amrita, who stood out in a small class of 15 students. They came for all the lectures I took on Sociology of Religion, Urbanisation and Stratification, and in 1993, they sat in on a hundred lectures on Marx, Weber, and Émile Durkheim. Harini sat in the front row, first seat near the window in Room 27, and they answered and questioned one another as their curiosity and imaginative interventions were unique. I had the freedom to integrate questions around everyday contexts of reading and interpreting Sociology with them." "They had such a wonderful gang life, each maintaining their unique identity, not quarrelsome or competitive, that I did keep in touch with them in the following 30 and more years as a friend, who occasionally got to hear from them about what they were currently busy with. In my mind, I could not quite separate them, as their gang life was so erudite," she said. When Visvanathan met Amarasuriya again in 2024 while following up field work in Sri Lanka's tea plantations, she was struck by the continuity. "She had not changed at all...as we were both 32 years older, it was interesting for me that she had continued her rehabilitation work with Tamil and Sinhala workers through the organisation called NEST, had a PhD from Edinburgh University and was currently editing a book describing the status of refugees from the War Years in Sri Lanka, who were now diaspora from UK. Her simplicity and charm and her sense of humour were the same as in 1992," Visvanathan said.

Together, they travelled to villages and small towns around Colombo and Galle. "Crowds of people would turn up to hear her, and so also in hotels and on street corners. The fact that they trusted her and communicated an ardour of hope and optimism was the most striking thing about her. When I returned to India, it was with the knowledge that



she had made an impact on her people, resulting in the success of the party in the elections last year," Visvanathan said. "I am so delighted that Dr Harini Amarasuriya is being honoured by the Indian government, as she integrates theory and praxis, and democracy and dialogue are regenerative forces implicit in her vocabulary," she added.


Among her peers in Hindu College, those memories take a softer and more personal hue. Her classmate Ranu Jain, now a photographer, recalls her fondly. "It gives me much joy to share a little about my association with Harini, whom I first met in Hindu College, University of Delhi, and got to know over the course of three lovely years studying Sociology. In a class polarised by intellectual differences, it was easy to see one person always standing out as the sane voice of friendship. That was Harini, with the most disarming smile. She could mediate between groups with kindness and laughter. And her quiet intelligence, gentleness, and warmth were and continue to be her most striking qualities," Jain said. Jain met Amarasuiya again in Colombo in 2013. "It was then that I learnt of her interest in the grassroots movements in Sri Lanka. I enjoyed reconnecting with her and seeing how she was still the same person that I knew way back in college, her simplicity and brilliance unchanged. She told me about her cat and her rabbits and how they lived happily together, and I could imagine how her parenting would have played a definitive role in their amicable co-existence," Jain added. Watching her rise to leadership, Jain said, "I am happy that she is visiting India and New Delhi as Prime Minister of Sri Lanka and a guest of the state and am certain that her leadership will inspire generations of Sri Lankans and people all over the world. I think of her fondly and wish her well."When Delhi University gathers in mid-October to confer an honorary doctorate, Hindu College will be hosting not just a head of government, but a former student remembered as "gentle," "brilliant," and "the most disarming smile" in a class of 15.

Russian drones in Poland's airspace stir worries for Europe's civil aviation



SEOUL/FRANKFURT, GNS News Agency, Sept 23 The incursion of Russian drones in Poland has reignited safety concerns over the vulnerability of civil air transport in Europe, aviation and insurance experts said, the latest upheaval facing airlines from escalating global conflict. Early on Wednesday, Poland shot down drones in its airspace with the backing of military aircraft from its NATO allies, the first time a member of the Western military alliance is known to have fired shots during Russia's war in Ukraine. Warsaw Chopin and Modlin airports, as well as Rzeszow and Lublin airports in the country's east, temporarily closed before resuming operations.

Countries bordering on Ukraine have reported occasional Russian missiles or drones entering their airspace since Russia's 2022 invasion, but not on such a large scale, and they are not known to have shot them down. Proliferating conflict zones around the world have increased the burden on airline operations and profitability, adding to safety concerns and disrupting travel. With airspace closures around Russia and Ukraine, throughout the Middle East, between India and Pakistan, and in parts of Africa, airlines are left with fewer route options. Detours add to airlines' fuel costs and lengthen journey times. Eurocontrol, a 41-nation coordination agency, has said Ukraine's closed airspace has added to congestion in the region's skies. Since October 2023, many international carriers have suspended flights to the region due to fears of missile and drone interference.

Wednesday's drone incident followed Israel's attempt on Tuesday to kill the political leaders of Hamas in the Qatari capital Doha. Worries about further disruption for the travel industry pressured airline stocks. Shares in British Airways owner IAGFlight disruptions were relatively limited because the drone incursion happened early in the morning, before many airlines had started flying. Polish airline LOT redirected some flights to western Poland and said it expected cancellations and delays. which operates in central and eastern Europe, said its security teams "closely monitored" the situation and adjusted flight schedules after airports closed. The European Union Aviation Safety Agency said no advisory was needed for the drone incursion due to its temporary nature, adding that Poland's aviation authorities were able to sufficiently handle the incident.

Aviation analysts say airlines are increasingly wary of the risks posed by incursions into civilian flight zones. "This is a wake-up call, I think, for everyone in Europe that can expect this more often," said Eric Schouten, head of security consultancy Dyami. Two senior aviation insurance market sources said the market was watching events in Poland and Qatar closely. If the market got a sense either that Russian drone incursions into Polish airspace were becoming consistent and deliberate, or that Israeli airstrikes in the Middle East were likely to continue, it would pose serious questions for insurers, one source added.LOT, Lufthansa, Ryanair, and airBaltic did not immediately respond to requests for comment. Poland's civil aviation authority and air navigation service did not respond to a request for comment on additional measures taken to ensure airspace safety. Following the drone incident, airlines may review their risk assessments in Poland, said Matthew Borie, chief intelligence officer at aviation risk consultancy Osprey Flight

They may consider flying further west in Poland away from the Russian, Ukrainian, and Belarusian borders, operating during daylight hours and carrying extra fuel to cope with potential diversions, he said, similar to steps taken in the Middle East. The worst-case scenario for airlines flying near a conflict zone is a plane being struck — either accidentally or deliberately — by weaponry. Since 2001, six commercial planes have been unintentionally shot down, with three additional close calls, according to Osprey. In one such incident, in December, an Azerbaijan Airlines flight crashed in Kazakhstan, killing 38 people. The plane was accidentally shot down by Russian air defences, according to Azerbaijan's president and Reuters sources. In 2020, a Ukrainian passenger plane was mistakenly targeted and destroyed by Iranian air defence operators." If this happens more often, you really have to understand what's happening ... What might go wrong? I'm always saying, misidentification is your biggest risk," Schouten added.

WASHINGTON, GNS News Agency, Sept 23 President Donald Trump's expansion of executive power, including his unprecedented push to send troops into U.S. cities to combat crime and his attempt to seize control of aspects of the economy, has left Americans uneasy, a new Reuters/Ipsos poll found. The findings suggest that a substantial majority of the public favors limits on presidential power and does not approve of Trump's efforts to shatter longstanding norms. "President Trump has not convinced most Americans that there is an emergency in this country that requires greatly expanded presidential power to address," said David Hopkins, a political scientist at Boston College. Over the last few weeks, Trump's administration has taken control of the Washington, D.C., police department and deployed National Guard troops to the city, claiming that crime there is out of control. He has discussed sending troops to Chicago and New Orleans as well. On crime, only 32% of Americans said they would feel safer with armed soldiers deployed to large cities in their state, the poll found. Some 62% of Trump's fellow Republicans were warm to military patrols in big cities, but only one in four independents felt the same way, as did just one in 10 Democrats. Only one in five respondents said they often feel unsafe because of high crime in their area, and just a third of people overall said they avoid big cities because of crime, suggesting that a majority of voters view crime as a remote phenomenon that does not affect them personally. About half of Republicans said they steer clear of large cities for fear of becoming victims."People agree that crime and safety are an issue, but they think Trump's abuse of power doesn't fix the prob-

lem, he makes it worse," said Jesse Ferguson, a veteran Democratic strategist. Trump has also taken a strong hand in attempting to regulate the U.S. economy by pushing for the government to take a 10% stake in chipmaker IntelHe has tried to pressure the Federal Reserve to lower interest rates and tried to fire a member of its board of governors following allegations the central banker committed mortgage fraud, a charge the official has denied. The president has faced legal challenges to his tariffs across a range of nations, claiming trade imbalances constitute a national emergency. He has also threatened to retaliate against U.S. companies such as AppleThe Reuters/Ipsos poll found just 16% of Americans overall - including 2% of Democrats and 34% of Republicans - thought it would be good for the president to have power to set interest rates and tell companies where to manufacture products. Trump's overall approval rating remains stable at 42%, according to the poll, with nine in 10 Republicans supporting him. "Even if citizens have concerns about urban crime or economic performance, they don't view either issue as currently in a state of unprecedented crisis requiring unprecedented measures to resolve," Boston College's Hopkins said."And while Trump certainly has a set of personal admirers who would happily grant him whatever powers he might seek, there are also many Republican voters who supported Trump in the last three elections but who don't agree that he should be allowed to operate without limits."U.S. voters overwhelmingly want their president to respect the authority of federal courts, with nine in 10 Democrats and seven in 10 Republicans saying the president should abide by judicial rulings even if he disagrees with them. Still, Republicans are more inclined to give Trump a free hand. Asked if they were willing to give up some checks and balances in the U.S. democratic system to have a government that can take action faster, 39% of Republicans said they would take that offer, compared to 45% who rejected it. Only 17% of independents - and the same share of Democrats - liked the idea. At the same time, voters of both parties are increasingly less likely to view the U.S. as exceptional. Some 29% of people in the latest Reuters/Ipsos poll agreed with a statement that "America is the greatest country in the world," down from 38% in a Reuters/Ipsos poll conducted in November 2017, during Trump's first term in office. The share of Democrats who agreed fell to 12% from 26% and among Republicans the share dropped to 55% from 59%. The poll, which was conducted online and nationwide, gathered responses from 1,084 U.S. adults. It had a margin of error of 3 percentage points for all respondents, and between 5 and 6 points for Republicans, Democrats and independents.

Police search for sniper who killed conservative activist Charlie Kirk in Utah

SALT LAKE CITY, GNS News Agency, Sept 23- Police and federal agents mounted an intense manhunt on Thursday for the sniper believed to have fired the single gunshot that killed conservative activist Charlie Kirk as he was fielding questions about gun violence during a university appearance. Kirk, 31, a podcast-radio commentator and an influential ally of Donald Trump, is credited with helping build the Republican president's base among younger voters. He was gunned down on Wednesday in what Utah Governor Spencer Cox called a political assassination. The Reuters Tariff Watch newsletter is your daily guide to the latest global trade and tariff news. The slaying, captured in graphic detail in video clips that rapidly spread around the internet, occurred during a midday event attended by 3,000 people at Utah Valley University in Orem, Utah, about 40 miles (65 km) south of Salt Lake City. In one clip, blood could be seen gushing from Kirk's neck immediately after a shot rang out, and he slumped in his chair.

Kirk, co-founder and president of the conservative student group Turning Point USA, was pronounced dead at a local hospital hours later. His murder stirred immediate expressions of outrage and denunciations of political violence from Democrats and Republicans alike.Cox said Kirk's events on college campuses were part of a tradition of open political debate that was "foundational to the formation of our country, to our most basic constitutional rights". "When someone takes the life of a person because of their ideas or their ideals, then that very constitutional foundation is threatened," Cox said. The shooting punctuated the most sustained period of U.S. political violence since the 1970s. Reuters has documented more than 300 cases of politically motivated violent acts across the ideological spectrum since supporters of Trump attacked the U.S. Capitol on January 6, 2021. Trump himself has survived two attempts on his life, one that left him with a grazed ear during a campaign event in July 2024 and another two months later foiled by federal agents. The lone perpetrator suspected of firing the single gunshot that struck Kirk in the neck, apparently from a rooftop sniper's nest on campus, remained "at large," said Beau Mason, commissioner of the Utah Department of Public Safety, at a news conference four

Security camera footage showed a person believed to be the assailant dressed in all-dark clothing, Mason told reporters. But some eight hours after the killing, authorities said they still had no suspect in custody. State police issued a statement on Wednesday night saying that two men had been detained, and one was interrogated by law enforcement, but both were released. "There are no current ties to the shooting with either of these individuals," the statement said. "There is an ongoing investigation and manhunt for the shooter." One of the two detainees, an older man



seen in photos that circulated online shortly after the killing, Salt Lake Tribune. Officials said he had been charged with obstruction by university police. The other man had been initially described by the governor as a "person of interest" in the investigation. Police said late on Wednesday that investigators were seeking clues at "multiple active crime scenes," pinpointed on the basis of where Kirk was shot and "locations where the suspect and the victim traveled. "Kirk, who was married and the father of two young children, had just returned to the United States from an overseas speaking tour in South Korea and Japan. His appearance on Wednesday was the first in a planned 15-event 'American Comeback Tour" of U.S. college campuses. Known for his often-provocative discourse on topics ranging from race and gender to immigration and firearms regulation, Kirk often used such events to invite members of the crowd to debate him live. At the moment he was shot. Kirk, a staunch advocate of the Constitution's Second Amendment right to bear arms, was being questioned by an audience member about gun violence, according to multiple videos of the event posted online. In a video message taped in the Oval Office and posted to Trump's Truth Social online platform, the president vowed that his administration would track down those responsible for Kirk's killing. Trump, who routinely describes political rivals, judges and others who stand in his way as "radical left lunatics" and warns that they pose an existential threat to the nation, also decried violent political rhetoric, while casting it as a phenomenon of the political left."For years, those on the radical left have compared wonderful Americans like Charlie to Nazis and the world's worst mass murderers and criminals," Trump said the video, recorded in the Oval Office. 'This kind of rhetoric is directly responsible for the terrorism that we're seeing in our country today, and it must stop

'Not a friendly place': Inside the Bangkok prison where ex-PM Thaksin is jailed

Three blankets to sleep with, an open bathing area, bland food and the constant risk of violence. These are the conditions inside the maximum security prison in Thailand's capital where 76-year-old former premier Thaksin Shinawatra is jailed, according to two people with knowledge of the facility. Once one of Thailand's richest and most powerful men, Thaksin was ordered on Tuesday to serve a year in jail by the Supreme Court, which determined that the billionaire had wrongfully spent time in a hospital in lieu of prison. Thaksin's initial eight-year sentence for conflicts of interest and abuse of power while Prime Minister from 2001-2006 was commuted to one year, following his homecoming from self-exile in August 2023. He was released on parole in February 2024, after just six months of detention, the entirety of which he had spent in the VIP wing of a hospital.

Since then, he has lived in a high-fenced, suburban mansion in Bangkok, often ferried around the city in a black and silver Mercedes-Maybach sedan and flown out of the country in a private jet. An hour after the court delivered its verdict, Thaksin was placed in a van, escorted by Corrections Department officials, and, following medical checks, transferred to Klong Prem prison. The facility, which houses some 6,500 prisoners, has held high-profile Thai political figures and a media mogul. Viktor Bout, an international arms dealer dubbed "the merchant of death", is also a previous inmate."It is a very depressing life. When I first got inside, all I did was cry," said Somyot Pruksakasemsuk, an activist and magazine editor, who served more than seven years in prison on lese majeste charges, including time at Klong Prem. Qatar bombing tests the limits of the Trump-Netanyahu alliance

Americans uneasy at Trump's moves to expand

WASHINGTON, GNS News Agency, Sept 23 Less than four months ago, President Donald Trump met with the leader of Qatar, praising his opulent palace and signing a sweeping defense agreement with the Gulf monarchy, a key ally that hosts the biggest U.S. base in the Middle East.Israel's surprise attack on Tuesday against Hamas leaders in Doha has jolted that relationship, angering Trump and drawing fierce condemnation from Doha and Western allies. Ordered by Israeli Prime Minister Benjamin Netanyahu and targeting the political offices of the Palestinian militant group, the strikes killed a Qatari security agent and five others, but failed to kill the Hamas leaders. Trump said he was "very unhappy about every aspect" of the Israeli operation.But for all the indignation, the strikes are unlikely to change the president's fundamental approach toward Israel, analysts and U.S. officials say. If anything, the bombings underlined the cold calculus beneath the Trump-Netanyahu relationship.Israel has shown it is not afraid to act against U.S. interests. The administration of Prime Minister Benjamin Netanyahu did not formally warn Washington of its impending bombing campaign on Tuesday, U.S. officials said.

That lack of warning recalled Israel's September 2024 attack on Hezbollah, when Israel wounded thousands of the militant group's members with booby-trapped pagers, without informing then-President Joe Biden. Trump, for his part, has occasionally expressed displeasure with Netanyahu. But his administration has strongly supported Israel's campaign to weaken Hamas and allowed it to largely take the lead on key issues such as Iran's nuclear program. "On this one, I think Trump is annoyed by Netanyahu's tactics," said Aaron David Miller, a senior fellow at the Carnegie Endowment for International Peace and veteran U.S. peace negotiator.But, Miller added, "(Trump's) instinct is that he agrees with Netanyahu's notion that Hamas cannot just be hollowed out as a military organization. It needs to be fundamentally weakened." Asked for comment, the White House referred Reuters to remarks by Trump on Truth Social on Tuesday night, during which he said the bombings did not advance U.S. or Israeli interests. "However," Trump wrote, "eliminating Hamas, who have profited off the misery of those living in Gaza, is a worthy goal."Some analysts declined to rule out the possibility that Netanyahu may yet exhaust Trump's patience if he springs more surprises on Washington. In practice, that could mean a withdrawal of political cover for Israel's ongoing invasion of Gaza, which has provoked outrage among European and Arab nations as famine conditions spread.

"As his Arab friends complain to him about what Israel is doing - and they are doing so now - he may say to them give me a credible plan for the day after in Gaza and with an alternative to Hamas running it and I will tell Bibi you have done enough," said Dennis Ross, a former Middle East negotiator for Democratic and Republican administrations.Israel's strike in Doha will likely dampen Trump's hopes for more Gulf states joining the Abraham Accords, a landmark agreement brokered by his first administration in which several Arab countries forged diplomatic ties with Israel.Still, a rupture between the two men seems unlikely, argued Michael Oren, Israel's former ambassador to the United States, saying that Trump appreciates strength and transactions that end wars." If Netanyahu can continue to appeal to those two sides of this president then he will be okay. I'm not concerned about the relationship," said Oren.In May, Trump traveled to Saudi Arabia, Qatar and the United Arab Emirates during his first major foreign trip, skipping Israel, which many analysts viewed as a snub. The Republican president returned to office in January promising to reinvigorate relations with Netanyahu that had deteriorated under his Democratic predecessor. During that trip, Trump agreed to lift sanctions on the new Syrian government at the behest of Saudi Crown Prince Mohammed bin Salman. That move alarmed Israeli

Ahmed al-Sharaa, a former al-Qaeda commander. But just



a month later, the Trump-Netanyahu alliance seemed back Trump - who campaigned on ending foreign conflicts - surprised even some of his own political allies by sending B-2 bombers to partially destroy Iran's key nuclear facilities.If that created goodwill within the Netanyahu administration, it did not benefit Trump's foreign policy interests, at least in the short-term. Iran and Israel for breaking a U.S.-brokered ceasefire. In July, the U.S. appeared to criticize an Israeli strike in Damascus, which destroyed part of Syria's defense ministry. And on Tuesday, Israel notified the U.S. shortly before the Qatar strike, but there was no coordination with or approval from Washington, two U.S. officials said. 19 terrorists gunned down in NW Pakistan

Peshawar: Security forces have gunned down 19 terrorists from the banned Tehreek-e-Taliban Pakistan in three separate engagements in restive Khyber Pakhtunkhwa province in northwestern Pakistan, the army said on Thursday.Intelligence-based operations were conducted by the security forces in Mohmand, North Waziristan and Bannu district during the September 9-10 night, the Inter-Services Public Relations, the military media wing of Pakistan, said on Thursday.During the operation in Mohmand district, security forces engaged with the terrorists at the specified location,

and after an intense exchange of fire, 14 of them were killed.In another intelligence-based operation conducted in the general area of Datta Khel in North



Waziristan district, four terrorists were killed by the security forces while one terrorist was gunned down by the security forces in an encounter that took place in Bannu district. Weapons and ammunition were also recovered from the terrorists. Meanwhile, unidentified militants demolished the house of an intelligence agency official in Nasar Khel area of Lakki Marwat district and fled with his weapons on Wednesday night. The militants forced their way into the house, held his family members hostage in one room and then demolished part of the official's house, police said. The terrorists have accelerated their activities against people associated with law enforcement agencies and security personnel, especially police and the Frontier Constabulary in the southern districts of the province.

Speeding shaped by social pressure, poor road design, weak enforcement systems: research



Speeding is not just about ignoring rules but is also shaped by social pressure, poor road design and weak enforcement systems, a research study based on evidence from nine countries by the George Institute of Global Health has found. Global evidence shows that every 10 km/h reduction in average vehicle speed reduces the risk of a fatal crash by up to 40 per cent, making speed management one of the most powerful tools for saving lives.

The research, published in BMJ Injury Prevention, a peer-reviewed journal, is the first global qualitative evidence synthesis on why people speed. With rapid growth in car and motorcycle ownership, combined with limited public transportation, speeding and its deadly consequences are worsening. These insights are highly relevant for India, which continues to record the highest number of road crash deaths worldwide. In 2023 alone, there were over 480,000 crashes and 172,000 deaths -- roughly 55 crashes and 20 deaths every hour.

Aligning with the UN's Second Decade of Action for Road Safety (2021–2030), the study notes the urgent need for smarter, stronger speed management strategies to halve

deaths and injuries by 2030. "Speeding is not just an individual choice — it is shaped by culture, road design and the credibility of enforcement. If we want to save lives, we need to create systems where safe driving is the easier choice, not the harder one," said Pratishtha Singh from The George Institute for Global Health, India. Researchers found that simply informing people that speeding is dangerous is not sufficient. Effective interventions must address peer pressure, challenge dangerous cultural norms linking speeding to masculinity and design roads that naturally slow down traffic. The study also noted that these findings reflect perceptions from diverse global contexts and may not apply equally everywhere. Importantly, there are still major gaps in high-quality research and evidence from low and middle-income countries, including India. Addressing Indian drivers, Jagnoor Jagnoor, Co-director of the WHO Injury Collaborating Centre, The George Institute for Global Health, said, "Reducing average speeds by just 10 km/h can cut the risk of a fatal crash by up to 40 pc. Speeding is not a marker of a nation's development - the true measure is how much we value human life. Staying within limits isn't about being slow; it is about making sure everyone gets home safely."The researchers have recommended stronger, more transparent enforcement, including automated systems like cameras and speed radars; road design that naturally slows traffic, including narrower lanes, speed bumps and roundabouts; policies to reduce average speeds by at least 10 km/h, which can cut fatal crash risk by up to 40 per cent. Stricter licensing systems for young drivers and targeted policies like invehicle speed limiters; reduction and public health campaigns to challenge myths such as "speeding saves time" and address gender norms around risky driving; and greater investments in reliable and affordable public transport to reduce dependence on private vehicles are among other rec-

Tamil Nadu's tryst with horizontal reservation for college students

Way back in August 1996, the then DMK government in Tamil Nadu headed by M. Karunanidhi issued a Government Order (G.O.) setting up a high-level committee to review the standard of education. The committee recommended 15 per cent reservation for students studying in panchayat schools in rural areas for admission to professional courses. Subsequently, in December 1997, another G.O. extended the 15 per cent reservation to medical courses from the following academic year. It was later extended to law courses as well. The policy was in force for a couple of years. In 2001, the AIADMK led by J. Jayalalithaa came to power and soon after, the government increased the quota from 15 to 25 per cent.

Several writ petitions were filed before the Madras High Court by aggrieved parties challenging the G.O. In February 2002, the Madras High Court ruled the G.O. was unsustainable. The Bench comprising the then Chief Justice of Madras High Court, B. Subhashan Reddy and Justices K.P. Sivasubramaniam and K. Ravirajapandian stated that besides the fact that rural reservation could not sustain, the increase in reservation would not stand Constitutional scrutiny. "For the foregoing discussion, we hold that the rural reservation provided at first with 15% and then extending to 25% for admission in professional colleges in the State of Tamil Nadu, by issuance of the impugned Governmental orders by the Government, has got absolutely no nexus to the object to be achieved and there is no intelligible differentia either and that the Government has failed to justify the discrimination and as such they are invalid being infractive of Article 14 of Indian Constitution and are hereby set aside," the Bench held. The court also directed the government to approach the Medical Council of India and the Bar Council of India for additional seats to offset the differential arising out of those given admission under the policy. Tamil Nadu government was quick to file a Special Leave Petition in the Supreme Court against the High Court's pronouncement. It held that horizontal reservation was intended to protect the underprivileged who could not be treated on a par with the privileged, urban students. The SLP maintained that the classification was made based on social and educational backwardness of the students who studied in schools run by village panchayats. Tamil Nadu's submission also stated that the direction of the High Court to create additional seats was inconsistent with Supreme Court judgment in the Rajiv Kapoor case. The Supreme Court, however, declined to stay the Madras High Court's judgment. Consequently, the 25% quota for rural students was not implemented thereafter. After nearly two decades, the Tamil Nadu government, this time headed by the AIADMK's Edappadi K. Palaniswami, unanimously passed a Bill in September 2020 in the Legislative Assembly seeking to provide 7.5 per cent horizontal reser-



vation for government school students on a preferential basis for National Eligibility-cum-Entrance Test (NEET) qualified candidates. This was based on recommendations of a Commission headed by retired High Court judge P. Kalaiyarasan.

The Commission had observed that students from government schools are disadvantaged compared to those in private schools "due to a cognitive gap created by socioeconomic factors such as caste, wealth, parental occupation, parental education, gender etc., and these psychological and socio-economic barriers cannot be bridged by a few months of intensive coaching for NEET, even if provided for free". It recommended 10 per cent reservation for government school children but the government preferred to offer 7.5 per cent quota. Justice P. Kalaiyarasan (left), then Madras High Court judge with C.Ve. Shanmugam (right), then Tamil Nadu Law Minister at Salem on December 12, 2017 in August 2021, after the DMK came to power under M.K. Stalin, the government extended the reservation policy to engineering, agriculture, veterinary and fisheries courses based on recommendations by a Commission headed by retired High Court judge D. Murugesan. In doing so, the government introduced a different criterion in reservation – the socially and educationally deprived – while not disturbing the integrity of the 69 per cent caste-based reservation. It meant that public school students would have minimum representation within the vertical quotas meant for BC, MBC, SC and ST students, besides the OC as well. This also formed the basis of Tamil Nadu's argument before the Madras High Court when a batch of petitions challenged the constitutional validity of the law. The State held that the law only provided a preferential source of admission and that the categorisation was based on intelligible differentia that had close nexus to the object sought to be achieved by ensuring that government school students did not lag behind. In April 2022, the Madras High Court upheld the constitutional validity of the law.

WHO adds GLP-1 drugs for diabetes, others to essential medicines list

The World Health Organization has added GLP-1 drugs to treat diabetes to its essential medicines list alongside treatments for cystic fibrosis and cancer, and said it hopes this will help improve global access to the costly drugs. Essential drug list The list, consisting of 523 medicines for adults and 374 for children, is a catalogue of the drugs the WHO believes should be available in all functioning health systems. In the past including a drug has helped boost access for people in poorer countries, such as for HIV treatments in the early 2000s. "Rather than letting price be a disqualifying factor, the committee views inclusion in the essential medicines list as a potential catalyst for access," Lorenzo Moja, head of the WHO secretariat overseeing the list, told Reuters. The expert committee added the active ingredients in Novo Nordisk's Ozempic and Eli Lilly's Mounjaro to the list, to treat type 2 diabetes in conjunction with established cardiovascular disease, chronic kidney disease or obesity. The drugs were initially developed for diabetes but have become wildly popular weightloss drugs too, under different brand names, but the WHO stopped short of adding them to treat obesity alone, as it also did in 2023.

The committee said this decision provided clear guidance on which patients would most benefit from the therapies. "High prices of medicines like semaglutide and tirzepatide are limiting access to these medicines," the WHO statement added, saying that encouraging generic drugmakers to produce the product would also help when patents begin to expire on the drugs next year. A spokesperson for Novo Nordisk said the company was committed to supporting broader access to its treatments. Several



companies are already working on generic copies. Globally, there were more than 800 million people worldwide living with diabetes in 2022, the WHO said. There are also more than 1 billion people with obesity. Earlier this year, a WHO memo said it would recommend the use of the drugs for obesity, a separate step to adding them to the essential list.

The list also includes Vertex Pharmaceuticals' combination therapy for cystic fibrosis, Trikafta or Kaftrio. Activists have criticised its high price and lack of accessibility for years. It also includes Merck's top-selling cancer immunotherapy drug, Keytruda, for the treatment of cervical cancers, colorectal cancers, and non-small cell lung cancers that have spread, or metastasized and recommended strategies to increase access. The WHO also added rapid-acting insulin analogues, also made by Novo Nordisk and Eli Lilly, among others, to the list for treating type 1, type 2 and destational diabetes.

How loud is too loud? What you need to know about the risks of hearing loss



Last month, a social media user Prachi Patel, shared a story about how she lost 20% hearing in one ear and 35% in the other, due to prolonged use of wireless earphones (buds/pods) with noise cancellation features. She claimed that the suction created by the ANC (active noise cancelling) technology weakened her hearing, and also caused tinnitus, a condition where constant ringing is experienced in the ears. According to the World Health Organisation (WHO), over one billion young adults are at risk of permanent, avoidable hearing loss due to unsafe listening practices. The WHO also states that by 2050, nearly 2.5 billion people are projected to have some degree of hearing loss, while more than 700 million will require hearing rehabilitation. The ears are sensitive sensory organs, and while hearing loss is usually thought of as occurring due to old age, the fact is, one's hearing can get damaged at any age if there is an exposure to harmful levels of noise or constant noise. At present, experts say, young adults are at a high risk of hearing damage. "Millions of teenagers and young people are at risk of hearing loss due to the unsafe use of personal audio devices and exposure to damaging sound levels at venues such as nightclubs, bars, concerts and sporting events," the WHO said in a statement in 2022.

The louder a sound, the more the damage it can potentially cause to one's ears. According to the United Statesbased National Institute of Deafness and other Communication disorders (NIDCD): "Sounds at or below 70 Aweighted decibels (dBA), even after long exposure, are unlikely to cause hearing loss. However, long or repeated exposure to sounds at or above 85 dBA can cause hearing loss. The louder the sound, the shorter the amount of time it takes for NIHL [noise-induced hearing loss] to happen."But how do we know that a particular sound is loud and possibly damaging our hearing? The NIDCD lists noise levels as follows to give you an indication: Whispering is 30 dB; the sound of your fridge humming is 40 dB; your normal talking voice at arm's length is 65 to 80 dB. But anything above that: such as a lawn mower or sounds in a movie theatre are between 80 to 104 dB and are loud enough to make you lose some of your hearing. The NIDCD advises: "To protect your ears, try to sit farther away from the speakers, and put in a pair of earplugs." It further explains that listening to music with your headphones at the highest volume: 96 to 110 dB can make you lose some of your hearing in just a few minutes. "To protect your hearing, turn it down to a lower volume. The music will still sound great!" it states. The message is clear: regularly being around noise that is more than 85 decibels can cause hearing loss. Sounds between 60-70 dB are safe.

Hearing loss is not always sudden. It can happen over time, and it can be moderate or severe. It can happen in one ear or both. Exposure to loud sounds can also lead to temporary hearing loss, the WHO states. The WHO also warns that "prolonged or repeated exposure can lead to permanent hearing damage, resulting in irreversible hearing loss."Suresh Naruka, senior consultant, ENT, at Apollo Hospitals, New Delhi has been seeing a number of youngsters who are experiencing hearing loss. "Youngsters who are exposed to continuous, loud music often have the hearing graph of an 80-year-old," he says. He further explains, "People who are constantly exposed to loud noises or even some amount of noise (even if its moderate) on a day-today basis, such as people working on ships, may hear a continuous buzzing sound in their ears and thus show early signs of hearing difficulties." Experts say that it is not the device but the volume of noise and duration of exposure that is to blame for hearing loss. Dr. Naruka explains that the "real risk to your ears comes from listening to content at high volumes for prolonged periods, not the earbuds, earpods or headphones. Even listening to a television set at a high volume may pose a risk." He adds that hearing loss impacts not just one's hearing ability, but also leads to psycho-social dissociation. Multiple myths also abound about the use of ear pods/buds and headphones/earphones. One common myth is that as ear pods go inside the ear canal, they cause more damage while headphones used from outside are safer. This is not true. Either device, when used at high volume levels can be harmful. Another belief is to do with cancer: according to the American Cancer Society however, bluetooth ear devices send out radiofrequency waves at significantly lower levels than even mobile phones. At present, there is no conclusive research to prove exact harms or cancer risk association. The key message here is to keep the volume down, or at a comfortable limit on personal audio devices. Wearing a protective hearing aid such as a clean pair of earplugs at noisy places can help.Dr. Naruka suggests "moving away from loud and noisy places, wearing clean ear plugs or headphones, getting ear checkups and activating volume control on devices." He adds that one needs to be careful if one's occupation involves exposure to noises such as working at an airport, or if one is living near an industrial area. "If hearing loss is sudden and if you report it within 24 hours, chances of getting your hearing ability back are quite high, but the possibility reduces with delays in getting treatment."

The largely unregulated space of home health care in India

When Ani Grace Kalaimathi was looking for a home health assistant for her aged mother, little did she anticipate the challenges. The young women who presented their qualifications to her claimed to be trained nurses but could not perform even simple tasks, she says. Ms. Kalaimathi, who is the registrar of the Tamil Nadu Nurses and Midwives Council, is not the only one who has experienced difficulties finding professional care for an elderly relative. Home health care for the elderly and the immobile, she says, is an unregulated sector: there is a huge demand, and limited supply, creating a system where agencies have mushroomed, but adequate training is often missing.

The elder health care space has grown substantially but haphazardly, picking up momentum in the past decade. Small players and large hospital groups have both entered the field, with the latter offering services including physiotherapy, diet counsellors and doctors-on-call, along with home care

Meanwhile, standalone organisations train people from the community and place them in homes. There is, however, a dearth of training or refresher courses for updating knowledge amongst staff, say experts. Geriatrician K.R. Gangadharan, whose Heritage Foundation of India has been in the field of elder care since 1995, began his journey when he trained persons as bedside assistants. But he too has faced issues: from not being able to maintain contact with trained personnel who either change their phone numbers or drop out of service, to demands from the family of the elderly that assistants must also do domestic work.

Also, advances in the medical field as well as familial expectations have now changed. Costs have gone up, making access to trained medical assistants difficult for a majority of families. "Many families do not understand that the roles of a health assistant, a full-fledged nurse and a domestic help are different. This leads to unpleasant interactions between the assistants and the family that hurt the elderly in need of care," he says. This was the case with Trina's 78-year-old father, who is severely diabetic with foot ulcers. The health assistant employed by the family agreed to also assist Trina's mother, a cancer survivor. But Trina says, "He would insist that we not even enter the room of our parents. I was afraid he might hurt my parents. Things were always difficult." An altercation between her son and the caregiver turned physical, leaving her son with serious injuries. The Chennai-based hospital from which they had accessed the service, withdrew the caregiver after a complaint from the family. There is no regulatory mechanism to oversee agencies, say experts, nor is there clarity on services to be provided or the requirement for minimum wage. Service providers in the elder healthcare space unanimously declare that it is fragmented, available in silos and only accessible to those with financial wherewithal. It is primarily young women who enter this field, says Ms. Kalaimathi. Unfortunately, she says, the lack of standardised courses leads to aspirants spending money beyond their means but learning very little, she says, adding that the carer she had employed for her mother said she had spent ?45,000 but had learnt everything on her own through YouTube videos. Since there is a demand for certified home healthcare assistants, candidates could be offered a six-month course and one-year internship, she says. Interested candidates who have completed Class 12 could later pursue the auxiliary nursing course, she suggests. "When such a course is started, the scope of the programme must be defined. Systematic training must be given, and shorter, associate courses are also needed. The National Skill Development Corporation offers such courses," she adds. She says that trained candidates who wish to pursue higher



studies could be offered concessions and be allowed to join nursing programmes. "We need qualified nurses in the tertiary care sector and in district healthcare facilities and the government must focus on this," she says. The distribution of health assistants in the country is unequal, with a concentration of cadre in urban areasDr. Gangadharan, who is currently involved in a training programme in Kurnool in Andhra Pradesh at the request of the State, says 50 people will be trained annually under the programme. There is a need for such trained personnel, he points out, as at least 5%, amounting to seven million elderly in the country, are disabled. If trained hands are deputed to villages with the promise of a livelihood, it would both offer jobs and help provide care where needed. Home care should be correlated with day care centers and later, to institutional care when the elderly cannot take care of themselves, he adds.

Rajit Mehta, managing director, Antara Senior Care highlights a critical aspect: most elderly citizens are inadequately prepared, financially, to deal with health issues. Apart from investing in pension schemes and setting up a corpus, there is also a need for insurance products to cover recurring healthcare expenses, assisted living facilities and at-home care services, he says. A dedicated body to oversee the sector is necessary, he adds. "The fragmentation that currently exists hampers the development of a cohesive ecosystem," he says. Sai Kumar, head, medical services, Apollo Home Healthcare, Apollo Hospitals, Chennai, says the Apollo Group ventured into home healthcare to address short term and long-term care. He adds that health insurance would reduce the burden that hospitalisation epicadae place an patients.

sodes place on patients. The distribution of health assistants in the country is unequal, with a concentration of cadre in urban areas, whereas 70% of the elderly live in villages, says Dr. Gangadharan. Adding to this problem, candidates who come from rural parts of the country do not want to go back there. The solution, he says, lies in streamlining services. He cites Kerala's Kudumbasri scheme, where the government pays for the healthcare of the elderly and says it is worthy of emulation. "The government should make it part of its political manifesto, as in 25 years we will have 300 million senior citizens," he points out. On regulating homes for the elderly, he says the government should hand-hold organisations, instead of being an inspecting authority. His organisation, for instance, is a regional resource training centre for the government. "We are supposed to monitor old age homes funded by the government. I encourage the staff to do their work correctly so that the government does not shut them down. This way, I can ensure at least 60% of them run effectively," he says. Such organisations that work with the government could pull institutions up for mistakes but not function as punishing agencies. This would benefit the community, he points out. The future of home care for the elderly may see the use of more technology — from monitoring vitals and using wearables to alert elders to changes in their health status.

Military biographies: a matter of heroes and overlapping history



.K. Krishna Menon, India's defence minister before and during the 1962 Sino-Indian war, was not a popular figure with the service chiefs, who nicknamed him 'God Almighty' for his overbearing ways. Not particularly fond of Gen. Thimayya (Timmy), Menon sought the opinion of Major General Sam Manekshaw on Thimayya. Sam, outspoken and articulate, replied, "Sir, as a junior officer, we are not permitted to express an opinion on a superior officer. We respect our seniors and we have no two opinions on it." In his book on Thimayya, An Amazing Life (KW Publishers), Brigadier C.B. Khanduri writes about this innocuous but pivotal conversation that kickstarted a political storm leading to Thimayya's resignation, which he later retracted. Biographies on Indian military leaders from different eras reveal overlapping spaces in history. For instance, Khanduri's book mentions how Timmy's recommendations on China were ignored by Menon, leading to India's debacle in 1962. On the other hand, Arjun Subramanian's book Shooting Straight (HarperCollins) begins the career story of Lt. Gen. Rostum (Rusty) Nanavatty after the 1962 conflict. Nanavatty was commissioned at the end of the war, a few years after Timmy's career ended and at a time when a demoralised national leadership was undergoing a catharsis. Subramaniam highlights a letter written by the young Lieutenant Nanavatty who is remarkably unsparing in his criticism of the leadership for its foibles in the war.

The author deftly uses the letter to bring out the fearlessness in the young officer's thinking. In a way, Subramaniam's narrative in Shooting Straight is a consequential document about the war's impact on young Indians. The stories of Timmy and Rusty are from different Indias — separated by the war of 1962 as the inflection point. Wedged between the two eras is the post-war decade after 1971. On one hand, the wars of the 1960s were over and on the other, the insurgencies of Punjab and Kashmir of the 1980s hadn't yet arrived. Air Chief Marshal Idris Latif was an Air Force Chief during this period in the late 1970s. His wife, Bilkees Latif, in her book on her husband The Ladder of His Life (KW Publishers), reminisces about an important dimension of the question of choice during Partition in 1947. Soon after the Partition was announced, Latif, then a young air force officer, was goaded by another Muslim officer leaving for Pakistan to join him. To the officer's opinion that Pakistan was a land for Muslims, Latif replied, "You must be joking; what has religion got to do with nationality? I'm an Indian, born in Hyderabad, you know — and not the Hyderabad in Pakistan!" He even advised the departing officer to stay, insisting that the Indian Air Force would be a better choice. Latif followed in the footsteps of Brigadier Mohd Usman who chose India over Pakistan. The story of Latif, who rose to become India's first Muslim Air Chief. is emblematic of the secular culture of India's

military. Typically, biographies provide a framework to situate events in the context of a nation's journey. Military biographies assign signposts on the time-trajectory in a country's history, especially in India, where the journey post-independence has been a progression from early existential struggles to assertions of identity. By exploring the paths of these protagonists, the biographies seek to capture the cultural impressions, personalities, choices, and help contextualise judgements on these characters. In the case of Nanavatty, peeling away his personality helps reveal his versatility. Like the tenure in Sri Lanka in the 1980s, when para commando units were sceptical of Nanavatty's role as a commander but grew to respect his initiative, wholeheartedness and an ability to lead from the front.

Subramaniam's writing, lucid and accessible, aided by the protagonist's painstaking notes, brings out the clarity in Nanavatty's thinking, which underpinned his career philosophy. Khanduri writes about Timmy as a committed and vocal personality who commanded a larger than life presence. He carried the legacy and impressions of a colonial army, and oversaw the transition during post-independence nation-building, before the era of wars in the 1960s. Nanavatty, on the other hand, was the archetypal infantryman who believed that victory is measured by the proverbial 'foot', and whose spartan measures set a high bar in tackling 'dirty' insurgencies of the 1990s.

Complex journeysThe biographies of Timmy, Latif and Nanavatty help us understand the personalities and the road taken by each. While Timmy's life is set in a time of tussles within the government, Latif played a key role in the modernisation following the 1971 war, including the replacement of old Canberra aircraft and the induction of Jaguars, all the while working with two different Prime Ministers of different political parties. Subramaniam's work on Nanavatty reveals the general's approach in more complex security challenges than the other two - which involved the Indian Peace Keeping Force in Sri Lanka and the insurgency in Kashmir. The three narratives collectively depict how the Indian armed forces have evolved since independence to the nineties. The three books delve into the nuances of military leadership, particularly with the stakeholders — political or military. All three were straight shooters in their approach, but differed on their styles. While Timmy could be vocal and confrontational, Latif managed the political leadership adroitly, while Nanavatty, by the 1990s, had adopted a pragmatic approach. Despite these three eminently readable books and a recently republished biography of Gen. Srinagesh (Commanded by Destiny/Penguin Books), military biographies are rare in India. Many belong to an era of World Wars, when accounts were documented and information was archived better. Sadly, within this thin historiography, several books suffer from abysmal writing or hagiographical accounts. One wishes to see more critique of the protagonist in accounts. In his book, Subramaniam reminds us that objective biographies of military leaders, especially those whose careers reached a pinnacle in the 1980s and 1990s, are rare, which makes Lt. Gen. Nanavatty's book both relevant and unusual. At the level of perceptions, military biographies in India run the risk of being mistakenly assumed to be technical accounts of a closed community. In a country where the military has had a major role to play in its history, a diminished understanding robs readers of an essential part of history defined by its characters. India needs more biographies that provide a lens to understand people and past events, and their influ-

Ration at your doorstep

On August 12, 2025, Tamil Nadu Chief Minister M.K. Stalin launched Thayumanavar Thittam, a scheme to provide ration products at the doorsteps of senior citizens and lated means 'one who shows motherly affection', is not new for Tamil Nadu, conceptually or in practice. But what makes it different from similar schemes implemented in the past is its reach. Thayumanavar Thittam, at a cost of cost of ?30.16 crore, is set to benefit about 20.4 lakh senior citizens and 1.3 lakh persons with disabilities across the State. In early July, the authorities conducted a trial run of the scheme in 10 districts, including Chennai. Tamil Nadu is perhaps the only State to follow a universal public distribution system (PDS) instead of a targeted PDS. Unlike in many other States, where licences are issued to private dealers to run fair price shops, cooperative societies in Tamil Nadu manage the affairs of nearly 95% of the shops (as against the national average of over 20%). Of about 37,330 shops in the southern State, more than 35,000 shops are handled by cooperative societies.

Tamil Nadu has also established 2,495 mobile fair price shops to ensure access to essential commodities for people in remote, hilly, and geographically challenging areas. Five years ago, during the COVID-19 pandemic, the then AIADMK regime also opened seven such shops and named them after former Chief Minister Jayalalithaa. Other States have been implementing schemes similar to Thayumanavar Thittam for some time. Under the Oppom scheme in Kerala. auto rickshaw drivers deliver essential commodities at the doorsteps of people who cannot visit PDS shops to collect their supplies due to old age, illnesses, or other issues. In Karnataka, the Anna Suvidha scheme benefits those aged over 75. Punjab is also implementing its own variant of the concept.In Delhi and Andhra Pradesh, the execution of similar schemes ran into problems. The scheme in Delhi never took off when the Aam Aadmi Party was in power. In Andhra Pradesh, regime change proved to be the obstacle: the Telugu Desam Party-led government reversed the previous YSR Congress Party government's practice of supplying essential commodities through mobile dispensing units for all beneficiaries. In the revised scheme, door delivery of commodities has been restricted to about 16 lakh PDS beneficiaries who are aged above 65 years or are physically challenged. Nevertheless, the idea has clearly been gaining currency. This is why it is strange that the Union government told the Lok Sabha early this month that "there is no provision under the [National Food Security] Act for delivery of foodgrains at the doorstep of beneficiaries." What should have been stated is that Section 32 (1) of the Act says that the law does "not preclude the Central government or the State government from continuing or formulating other food-based welfare schemes.

The DMK regime's initiative was appreciated by Desiya Murpokku Dravida Kazhagam (DMDK) general secretary Premalatha Vijayakant, who is not an ally of the ruling party. Describing the launch of the scheme as a "victory" for DMDK founder Vijayakant and the party, she recalled how Vijayakant had promised electors during the 2006 Assembly polls that his party would deliver commodities to beneficiaries if brought to power. His idea had been ridiculed then, she said. The DMDK general secretary was, however, guarded about her party's position on forming an alliance with the DMK for the 2026 Assembly elections and clarified



that the decision would be taken at the party's meet in Cuddalore in January. Amma Makkal Munnetra Kazhagam (AMMK) general secretary T.T.V. Dhinakaran criticised the scheme, contending that it had been implemented keeping the Assembly elections in mind. He also reminded the government that it had not implemented the DMK's electoral promise of increasing the quantity of sugar and including urad dal once again under the PDS. Notwithstanding the criticism, Mr. Stalin seems to be conscious of the fact that it is officials in charge who determine the success of any scheme. This was evident when he pointedly sought their cooperation. Without the right approach from them, schemes such as this may fail to ensure food security to lakhs of beneficiaries.

'Global gold prices may double on weaker dollar'

International spot gold prices may touch \$7,000 an ounce by 2030 in the event of a dollar devaluation, according to Anindya Banerjee, head of currency and commodities, Kotak Securities. This is twice the current price of about \$3,400 an ounce."The United States is trying to morph from the world's consumer of last resort into a net producer. That pivot requires a cheaper currency and smaller capital inflows—outcomes that are bullish for real assets and especially for gold," said Mr. Banerjee. A cheaper dollar may be achieved even as an outcome of policies such as immigration control and tariffs, among others, to achieve a zerotrade deficit, he pointed out.U.S. President Donald Trump, during a recent interaction with the American media, said "you make a hell of a lot more money with a weaker dollar. When you have a strong dollar, you can't sell anything. It's only good for inflation, and it's good psychologically. It makes you feel good." The American government is reportedly mooting the idea of devaluing the dollar to shore up exports and reduce the trade deficit. The immediate consequence of such a move would be a spike in international gold prices according to analysts. An active devaluation might be unlikely because that might reduce dollar's status as a reserve currency, said Maneesh Sharma, AVP of commodities and currencies, Anand Rathi Shares and Stock Brokers. He, however, said even without a planned devaluation, a cheaper dollar, which is the outcome of tariffs and trade controls, would invariably lead to a surge in gold prices.

The science of sleep and the role of sleep aids



Some people seem to fall asleep the moment their head touches the pillow, while others toss and turn, counting imaginary sheep or scrolling endlessly on their phone. For the latter group, a growing market of sleep aids exists from white noise machines and rain sound playlists to herbal teas, melatonin pills and age-old practices like drinking warm turmeric milk before bed. Do these sleep aids help? And what makes falling asleep so effortless for some, yet such a challenge for others? Experts point to a complex mix of biology, lifestyle and environment.

What is sleep

According to Sridhar R., senior consultant, Interventional Pulmonology, MGM Hospital, Chennai, sleep is broadly divided into two categories: Rapid Eye Movement (REM) sleep and Non-REM (NREM) sleep. NREM has three stages, from light sleep (N1) to deep, restorative slow-wave sleep (N3). REM, where vivid dreaming occurs, is vital for memory and emotional processing. A typical night involves four to six sleep cycles, each lasting 70-120 minutes, moving fluidly between NREM and REM stages. While adults require 7 to 8 hours of sleep, Indu Khosla, senior consultant, Paediatric Pulmonology, Narayana Health SRCC, Mumbai, notes that newborns may sleep up to 22 hours a day, children need 9 to 12 hours, teenagers 8 to 10 hours and older adults 6 to 8 hours. Interestingly, she adds, "Indians and Asians generally take less sleep than their Western counterparts." Experts explain that those who nod off quickly may simply have a robust circadian rhythm the body's internal clock and lower pre-sleep arousal. Others may benefit from optimal "sleep hygiene": regular sleep times, low stress before bed and minimal light exposure. On the other hand, for people who lie awake, causes can range from excessive evening caffeine and screen use to underlying sleep disorders like insomnia or obstructive sleep apnea (OSA). Sounds and habits Auditory aids -- white noise, pink noise, rain sounds, whale calls, Indian classical ragas, even traditional conch blowing can help by masking sudden, disruptive sounds. M.S. Panduranga, senior consultant , Neurology, Dharamshila Narayana Superspeciality Hospital, explains, "The brain processes sounds even during sleep. A continuous, uniform sound acts like an acoustic blanket, reducing the chance of arousals from irregular noises."Pink noise, such as steady rainfall, can even synchronise brain waves and consolidate sleep. Indian classical music, says Dr. Sridhar, offers a "structured broadband quality" that relaxes without the jarring impact of random noise. For babies, rhythmic sounds may mimic the mother's heartbeat in the womb, aiding sleep but Dr. Khosla cautions against creating long-term dependence on such aids. Sindhu V., consultant, pulmonology, SRM Global Hospitals, Chennai explains, "India's mix of traditional and modern habits has a clear impact on sleep". Late-night chairich in caffeine -- and prolonged screen exposure suppress melatonin, delaying sleep onset. Blue light from devices signals the brain to "stay awake," a problem most pronounced in urban areas.

In rural regions, sleep tends to follow the natural light cycle -- early to bed, early to rise, whereas city dwellers often push bedtimes later due to artificial lighting, socialising or work. "Practices such as yoga, meditation and warm milk before bed, rooted in Indian tradition, can help counteract these modern disruptions,"Dr. Sindhu said. Sleep asso ciated health risksInsomnia -- sleep disorder where people struggle to fall asleep, stay asleep, or both, even when they have the opportunity for a full night's rest, Obstructive sleep apnea(OSA)-- another sleep disorder where your upper airway repeatedly becomes blocked during sleep, causing pauses in breathing (apnea) or shallow breathing (hypopnea) , restless leg syndrome -- a neurological disorder that causes an irresistible urge to move the legs, often accompanied by uncomfortable sensations and narcolepsy -- a chronic neurological disorder that disrupts the brain's ability to regulate sleep-wake cycles, leading to excessive daytime sleepiness and other sleep disturbances are among India's most prevalent sleep disorders.

OSA, often linked to obesity, enlarged tonsils, craniofacial structure-- the intricate framework of the head and face, encompassing the skull, facial bones, muscles, nerves, and teeth, which develops from complex embryonic processes like neural crest cell migration disrupts deep sleep and can cause hypertension, heart disease, and memory impairment. Dr. Khosla stresses that even children especially those living with obesity, Down syndrome, or neuromuscular disorders can suffer from OSA, making timely diagnosis through sleep studies crucial. While there is some evidence that herbal remedies including chamomile tea, ashwagandha, brahmi, and turmeric milk promote relaxation, self medicating with over-the-counter sleep medications can be risky. Dr. Sridhar advises professional consultation, particularly for chronic insomnia (trouble sleeping three or more nights a week for over three months) or when sleep issues are linked to other health conditions.

Quality matters as much as quantity. "A regular sleep schedule, reduced evening caffeine, limited screen time, a calm sleep environment and moderate daytime activity can make falling asleep and staying asleep much easier", says Dr. Panduranga. For those still struggling despite good habits, doctors recommend seeking evaluation rather than relying indefinitely on home remedies or sound machines. While International health bodies such as World Health Organization supports research and guidelines on sleep disorders and includes certain prescription medicines for short-term use in specific cases, their primary advice too is to build lasting, good sleep hygiene. As experts puts it, "Good sleep is not a luxury, it's a biological necessity. Every stage of sleep has a role in keeping your body and mind healthy. If you're not getting it, your health will eventually show it."

To survive AI and global geopolitics, India should become a hub of knowledge creation, not just knowledge processing

Earlier this month, Tata Consultancy Services (TCS), India's largest IT services firm, confirmed it will lay off 12,000 employees. For decades, companies such as TCS symbolised India's prowess in IT-enabled services — a low-cost, high-scale model that rode the wave of globalisation. But that model is now under existential strain. The era of labour arbitrage is drawing to a close, and the age of artificial intelligence (AI) is rewriting the rules of economic competitiveness.

Generative AI, machine learning, and automation are fast replacing the very tasks that once gave India its edge: coding, data entry, support services, and even parts of analytics. The decline in headcount is not a blip; India's core export, white-collar digital labour, is being disrupted. And the country does not seem prepared as we see problems in absorbing science and engineering talent newly entering the job market. Simultaneously, the manufacturing-led catchup route is narrowing. For years, economists argued India could do what China did in the 1990s — turn industrial policy and export-led manufacturing into mass employment and structural transformation. But that ship has largely sailed. Countries such as Vietnam and Bangladesh have already captured the low-cost manufacturing space. Add to that rising automation and India's own infrastructure bottlenecks, the feasibility of China-style manufacturing resurgence diminishes rapidly.

What, then, is India's pathway to sustained economic relevance?

The answer lies upstream — in innovation, discovery science, and a smart, coordinated science, technology, and innovation (STI) policy. If India wants to be a rule-maker rather than a rule-taker in the Al-driven global economy, it must invest urgently in becoming a hub of knowledge creation, not just knowledge processing. This will only be achievable with a new national compact that starts from STEM but goes above and beyond embracing STEPS - an integration of STEM with policy and society. This means building a generation of technologists who understand not just how to build systems, but how those systems affect entrepreneurship, business model and scaling, ethics, governance, and inclusion. It also means reforming curricula to include data governance, AI ethics, climate-tech, innovation economics, and intellectual property policy. Finally, it also means urgent, mission mode requirement of an integrated, State-agnostic approach where we will see not just southern India having a head start in STEM and STEPS. The New Education Policy (NEP), 2020 provides some groundwork, but implementation must go further and deeper. From IITs to State universities, India will need a deliberate shift toward interdisciplinary innovation and doctoral-level research capacity. India's innovation-to-education pipeline is currently too weak to sustain a 21st century knowledge

And sadly in this, as noted above, manufacturing likely will not save India any more. The dream of becoming the "next China" in manufacturing is now largely unrealistic. India's manufacturing sector contributes just 14-16% of the GDP — a figure that has barely budged in a decade. More worryingly, global manufacturing is undergoing its own Al-



led transformation: smart factories, predictive maintenance and robotic assembly lines are shrinking the need for cheap labour. Competing on cost is now a losing battle. Moreover, global supply chains are also realigning around strategic resilience and digital integration, not just wage arbitrage. India's challenge is not to attract the next garment factory but to build the next quantum computing lab or climate-resilient agri-tech platform. Which brings us to the question of how a Triple Helix approach might be India's best shot at future-readiness. To get there, India will need a clear National Science and Innovation Strategy underpinned by deep collaboration between government, industry, and academia. No single actor can deliver the transformation needed and increasingly the need of the hour will be science-based entrepreneurship and scientist entrepreneurs. It has been done before like by Vijay Chandru, inventor of Simputer and founder of Strand Genomics, also a former IISc Professor, but one Vijay Chandru is hardly enough for a country of 1.3 billion.Government also must invest in blue-sky science, reform its R&D funding structures, and design enabling regulatory frameworks for frontier tech (AI, biotech, semiconductors, and so on). Universities must evolve into innovation hubs, not just exam factories. They must work closely with industry, build tech transfer offices, and reward risktaking. Industry also must move beyond short-term returns and co-invest in long-horizon research, from chip design to synthetic biology refusing to accept modest productivity gains with a middling equilibrium mindset. Global lessons abound. The U.S.'s DARPA ecosystem, Germany's Fraunhofer Institutes, and Israel's Start-Up Nation playbook all demonstrate how strategic state support and institutional coordination can turn ideas into global advantage. India can build from their lessons, leverage on the current global geopolitical headwinds and create a national consciousness around science and innovation. It is not just investment in science that will matter, but investment in the science of innovation itself brings in a critical evaluation mindset for upgrading based on evidence. India lacks a coherent framework to measure what works: which R&D models yield translational success? How do tech incubators perform over time? Where does research funding leak or stagnate?A National Science of Science and Innovation Policy (NSIP) platform — a cross-ministerial, data-driven approach to governing the innovation ecosystem - could be a way forward. NITI Aayog's AI strategy and the recent National Research Foundation are steps in the right direction, but coordination and scale remain insufficient.

Nepal, Indonesia, Bangladesh, Sri Lanka: When demographic dividend isn't delivered



Sri Lanka in 2022. Bangladesh in 2024. Indonesia in August 2025...and now Nepal, a month later. The past few years have been littered with youth-led uprisings in Asian countries, coming at a time when the headline growth numbers have not resulted in better lives for those entering the labour force. At the same time, the ruling elite and business class seem to have prospered. Over the last week, the children of Nepal's political class have come under heavy fire for displaying their luxurious lifestyles on social media, with the phrase 'nepo kids' trending as the Gen Z's ire over corruption took centre-stage. In 2024, Nepal was ranked 107 out of 180 countries in Transparency International's corruption rankings. Bangladesh was ranked 151, Sri Lanka 121, and Indonesia 99.

If politics is about optics, the leaders of these countries have not quite helped themselves. Earlier this week, Indonesia's President, Prabowo Subianto, fired the globally respected Sri Mulyani Indrawati as the finance minister amid some of the worst public unrest in years following the revelation that Parliamentarians were set to receive a monthly housing allowance equivalent to \$3,000. The allowance, scrapped on September 4 after days of violent protests, was almost 10 times the country's highest monthly minimum wage of \$337 in the capital city of Jakarta. Indrawati, a former Managing Director at the World Bank and Executive Director at the International Monetary Fund, had burnished Indonesia's image with her fiscal restraint during her 13 years as the finance minister under three Presidents. However, she was at odds with Subjanto and his populist policies. The high levels of corruption and lack of political continuity have meant economic growth has not been inclusive, with the youth suffering in particular. And these countries are all rather young. According to the United Nations' World Population Prospects 2024 report, the median age of Nepal last year was 25 years, only slightly lower than Bangladesh's 25.7. For Indonesia it was 30.1, while Sri Lanka's was 33.1 years.

Whither demographic dividend?

Countries with a young population bank on the youth

to propel economic growth higher. According to the Bank, from 2000 to 2023, South Asia created 10 million jobs a year on average - just over half of what was required. High youth unemployment In Indonesia, the national average unemployment rate in 2024 was 4.91 per cent. But for those in the 20-24 age bracket, the unemployment rate was more than three times as high: 15.34 per cent. In Bangladesh, the national unemployment rate in 2023 was 3.35 per cent. However, at 8.24 per cent, the highest unemployment rate was for those in the 15-24 years age bracket. In Nepal, the country's statistics office said in

The high dependence on foreign employment and remittances, coupled with limited industrial development and job creation in the formal sector, presents ongoing challenges for policymakers," the National Statistics Office said in a report titled Demographic Dividend in Nepal, adding that the labour market sector had not shown any improvement, with unemployment increasing to 12.6 per cent in 2022-23 from 11.4 percent in 2017-18. With underemployment even more prevalent, especially among those aged 15-24, young Nepalis were looking abroad for jobs, resulting in remittances accounting for nearly a quarter of the country's GDP. Inflows into equity mutual funds declined by around 22 per cent to Rs 33,403.37 crore in August, compared to Rs 42,702.35 crore in July, as investors turned cautious amid tariff-related uncertainties, the latest data from the Association of Mutual Funds in India (AMFI) showed.On August 27, US President Donald Trump slapped a 50 per cent tariff — split evenly between general and additional duties — on Indian exports, which dampened investor sentiment. Domestic equity market indices, Sensex and Nifty, fell 1.69 per cent and 1.38 per cent, respectively in August.


Total assets under management of the mutual fund industry dipped to 0.22 per cent to Rs 75.19 lakh crore in the reporting month, compared to Rs 75.36 lakh crore.Inflows through systematic investment plan (SIP) marginally declined to Rs 28,265 crore in August, compared to a record high inflows of Rs 28,464.03 crore in July. "Although positive equity flows continued for 54th straight month, month on month there was a dip of 22 per cent. This is more of a reflection of global macros than domestic factors, tariff news heightened volatility in the markets leading to cautious approach by investors," said Ankur Punj MD and business head, Equirus Wealth.Among equity mutual fund schemes, small cap funds witnessed a month-on-month fall of 23 per cent in net inflows at Rs 4,992.91 crore, compared to Rs 6,484.43 crore. Mid-cap funds saw a 3 per cent rise in inflows at Rs 5,330.62 crore in August, compared to Rs 5,182.49 crore in the previous month. Liquid funds saw the highest amount of outflows at Rs 13,350.06 crore. Inflows into the overnight fund stood at Rs 4,950.84 crore.Inflows into hybrid mutual fund schemes slowed to Rs 15,293.7 crore compared to Rs 20,879.47 crore in July. During the reporting month, gold exchange traded funds (ETF) garnered Rs 2,189.51 crore of inflows, compared to Rs 1,256.09 crore in July. Danish drug major Novo Nordisk slashes 11 per cent of workforce to save \$1.3 billion



New Delhi: In a major restructuring drive, Danish drug major Novo Nordisk on Wednesday announced plans to slash 9,000 jobs or 11 per cent of its global workforce and save (\$1.3 billion) by the end of 2026. The company, in a statement, said that with the restructuring, it expects to simplify, improve decision-making speed, and reallocate resources toward growth opportunities in diabetes and obesity. Battling rising pressure from US rival Eli Lilly, the maker of blockbuster weight-loss drug Wegovy, announced its third cut of the year to its profit forecast.

The company's Wegovy and its diabetes treatment Ozempic are reportedly losing market share and slow sales growth, especially in the US market. "Our markets are evolving, particularly in obesity, as it has become more competitive and consumer-driven. Our company must evolve as

well," CEO Mike Doustdar, who only took the helm last month, said in the statement. Tanishaa Mukerji recalls life-altering head injury during 'Sssshhh...' shoot: 'My brain shifted inside my skull'; Neurologist explains what happens during a concussion



Speaking to Vickey Lalwani, she recalled travelling with co-stars Dino Morea, Gaurav Kapur, and director Pavan S Kaul when their car skidded off black ice and fell into a gorge. "My director was driving the car. It was a good film. We were enjoying a lot. Dino Morea, me and Gaurav Kapur, were all inside the car. We all thought we would go to work together that day. The director was driving the car, and he slid on black ice, and our car stumbled into a gorge. Gaurav had fractures in three places in his arm. Dino also had a fracture (sic)."

Tanishaa herself sustained the most alarming injury. "I suffered from a head injury, which was very dangerous; I had a concussion. So the doctor told me, my brain had shifted to the side of my scalp and then came back to its place, and that's why the left or maybe the right hemisphere of my brain was swollen. It took more than one year for it to get better, but I had to finish this film and other films (sic)."The experience also came with memory loss, something she described as almost cinematic. "After this accident, I lost my memory. We see in films that characters get up after an injury and ask, "Who are you?" I was that person. My mom was with me in Manali, where the shooting was going on, and we had to come to Delhi for treatment."

So, what actually happens inside the brain during such concussions, and how dangerous can this type of injury

be?Dr Shiva Kumar R, senior neurologist, Poorna Neuro Holistic Care & Manipal Hospital, Sarjapur Road, Bengaluru, tells indianexpress.com, "When someone sustains a concussion or a head injury, the brain can move suddenly inside the skull due to impact. This rapid movement causes stretching of brain tissue and temporary disruption of nerve cell communication. In severe cases, the brain can strike against the inner walls of the skull, leading to swelling or small bleeds."

He adds, "The phrase 'brain shifted to the side' is a layman's description of this internal movement. While most concussions are mild and reversible, any swelling in one hemisphere can become dangerous because it increases pressure inside the skull. If not managed properly, it may lead to complications such as prolonged symptoms, neurological deficits, or, in rare cases, life-threatening situations."

How common is memory loss after a concussion, and what determines whether it is temporary or long-lasting?

Memory loss is one of the hallmark symptoms of a concussion and is fairly common. Dr Shiva Kumar states that it usually occurs because the brain's ability to process and store new information is temporarily disrupted by the injury. In most cases, this memory loss is short-term, lasting from minutes to weeks. "Whether it becomes long-lasting depends on several factors: the severity of the injury, whether there were repeated head injuries, the age and overall health of the patient, and how quickly treatment and rest were initiated." "Initially, doctors advise complete rest to allow the brain to recover from the trauma. This includes physical rest and also limiting mental strain, such as long screen time or multitasking. Rehabilitation may involve physiotherapy for balance, occupational therapy for daily skills, or cognitive therapy to strengthen memory and concentration. Adequate sleep, hydration, balanced nutrition, and stress management also play a critical role in healing. Most importantly, avoiding another head injury during the recovery phase is essential, since repeated concussions can cause long-term cognitive issues," notes the expert.

It is believed to have soothing properties that can calm mild skin irritation and make the skin feel nourished," said Dr Chause.Dr Shweta Nakhawa, consultant dermatologist, KIMS Hospitals, Thane, said almond oil is full of vitamin E, fatty acids, and antioxidants. "It softens skin, seals in moisture, and enhances overall texture. Skin can feel smoother and look healthier with repeated use. Others apply it to eyelashes and eyebrows as it conditions the hair, lessening dryness and breakage, making them look healthier and glossier," said Dr Nakhawa.

Does almond oil enhance circulation?

The oil itself does not actually enhance circulation. "Gently massaging it onto the skin does, however, have the effect of stimulating circulation, which causes the face to temporarily have a natural sheen and look refreshed," said Dr Nakhawa.

Can it actually make eyebrows and eyelashes grow?



According to Dr Nakhawa, almond oil conditions and healthily strengthens hair shafts so that they don't become brittle. That creates the illusion of fuller brows and longer lashes. But it won't necessarily make it grow faster—it's more about healthy hair.

What to consider?

There are a few cautions to keep in mind. "Almond oil may not suit everyone, especially those with oily or acneprone skin, as it can clog pores and lead to breakouts People who have sensitive skin should avoid them completely to prevent allergic reactions. Always do a patch test before applying it to your face. Use it in small amounts, preferably at night," said Dr Chause, For people who have allergies to nuts, almond oil must be avoided entirely, stressed Dr Nakhawa. Avoid using almond oil on broken skin, acne, or on extremely humid days since it tends to make skin greasy. "Use sparingly, a little goes a long way. Use just a few drops on clean skin. If you notice redness, itching, or acne, discontinue," said Dr Nakhawa, Almond oil is a natural, gentle solution that has proven advantages. "It is best used with care and in relation to skin type, not as something to be applied across the board for everyone," said Dr Nakhawa.

From birds that trick others into raising their young to spiders that perfume the air with false promises, nature is full of expert con artists. These strategies may seem cruel, but they're products of evolution. Trickery saves energy, increases survival, and ensures the next generation thrives. Whether it's a cuckoo chick outcompeting its nestmates or a drongo stealing a hard-won meal, deception in the wild is often the difference between life and death. Here are some of nature's most notorious tricksters and how they pull off their scams.

The cuckoo

Imagine raising a child that isn't yours, without ever knowing it. That's the life of many songbirds tricked by the common cuckoo. This bird lays its egg in another species' nest, and the unsuspecting parents raise the chick as their own. Some cuckoos even lay eggs so similar in colour and pattern to their host's that it's almost impossible to tell the difference. By the time the foster parents realise something is wrong, their own chicks are often gone.

In the summer nights of North America, male fireflies flash signals to attract mates. But not all of them end in romance. Females of the Photuris genus copy these flashes to lure unsuspecting males closer. When the hopeful males arrive, expecting courtship, they are swiftly eaten. To make matters worse, the females steal the males' defensive chemicals and use them to protect themselves from predators. Love, in this case, is literally deadly.

Bolas spider

Unlike most spiders, which build intricate webs, the bolas spider employs a different strategy. It releases chemicals that mimic the scent of female moths. Male moths, drawn by the "perfume," come flying in, only to be caught by the spider's swinging sticky line, much like a fisherman



casting a lure. It's a deadly combination of disguise and patience. The alligator snapping turtle

Lurking in the muddy rivers of the American South is a turtle with a sinister trick. The alligator snapping turtle opens its mouth wide, showing a pink, worm-like tongue. Fish, fooled into thinking they've found a snack, swim right in. One snap of the turtle's massive jaws, and the hunter becomes the hunted. Deep in Iran lives a snake whose tail ends in a bulb and wiry scales that move like the legs of a spider. 

Faf du Plessis reacts to political activist Charlie Kirk's assassination: 'I'll never understand America and why everyone can just have a gun'

Charlie Kirk, who was a political activist and co-founder of Turning Point USA, was shot dead in the Utah Valley. The incident took place when Kirk was speaking at Utah Valley University (UVU) in Orem. Kirk was speaking under a tent on the university campus during his American comeback tour when the incident occurred. The shooter has still not been caught by the authorities, and they are investigating. President Donald Trump called the killing of Kirk 'a dark moment for America.' Former South African skipper Faf du Plessis has also chimed in with his opinion and questioned the law of Americans to have guns. "RIP Charlie Kirk. I'll never understand America and why everyone can just have a gun," Du Plessis wrote on X (Formerly known as Twitter). Du Plessis, from 69 Test matches, has scored 4163 runs at an average of 40.03 with 21 half-centuries and 10 centuries. In ODIs, he amassed 5507 runs from 143 games at an average of 46.67, including 12 centuries and 35 halfcenturies, and in T20Is, he scored 1528 runs from 50 games at 35.53, bagging one ton and 10 half-centuries to his name

The United States Senate has passed a gun safety bill in 2022, the most significant action against rising gun violence in the country. The bill was passed on Thursday (June 23), hours after the US Supreme Court ruled that Americans have a constitutional right to carry firearms in public for their safety and self-defence. The bipartisan bill was passed with a majority of 65-33 votes in the Senate. At least 15 Republicans voted for the measure, a surprisingly high number for a party that has largely voted against gun control over the years, and Joe Biden who was president at the time has approved the bill. Current Federal law allows licensed dealers to sell handguns only to people aged 21 and above, but they can sell long guns (like rifles) to those 18 and older, according to Everytown for Gun Safety. Pri-

vate sellers can sell handguns to 18-year-olds, and there is no minimum age for long guns. However, Trump said he would handle such laws if re-elected, but during his campaign before getting elected as president for the second time, he told an NRA event: "No one will lay a finger on your firearms," as reported by AP. Speaking earlier today on the killing of Kirk Trump recalled the assassination attempt against him in July last year and the killing of UnitedHealthcare CEO Brian Thompson in 2024. Trump said, "Radical left political violence has hurt too many innocent people."

He returns to the venue — the National stadium — where he became the Olympic champion four years ago. However, Nadeem dethroned him in Paris last year. It was Pakistan's first Olympic gold in 40 years with a record throw of 92.97m.

However, Nadeem — who has been recovering from injury - has competed just once since the Paris Olympics, winning the Asian Championships in May. Chopra did not compete at the continental meet but he has had another remarkable season, finishing in the top two in every competition he's taken part in and also crossing the 90m-mark, throwing 90.23m at the Doha Diamond League.Nadeem spoke to reporters at the Punjab Stadium in Lahore after his final training session before leaving for the Japanese capital. "I always target to do my best in every event and I am going to Tokyo with the same mission with high hopes. And rest is on God," Arshad was quoted as saying by Pakistani daily, Dawn. When asked about his rivalry with Chopra, Nadeem replied: "My competition is always against Arshad Nadeem, I have my competitions against myself. I am in good shape and well prepared for the contest in Tokyo. Most of the other main rivals in Tokyo [javelin throw event] are same who were at the Paris Olympics, so it will be good contest." Nadeem, who had undergone a calf surgery in July, added he 'regretted' missing the Diamond League. "But the decision was taken just not to take any risk before the World Championships," he added. Asad Abbas Shah, one of Nadeem's doctors, was quoted as saying by the newspaper that the thrower was in 'best physical shape'. "Yesterday (Tuesday), Arshad passed all the fitness tests; that is a good news that he has recovered from his calf injury,"

'Arshdeep Singh has better numbers than Jasprit Bumrah': Former opener says India have 'Champions Trophy hangover' in Asia Cup

Arshdeep Singh being left out of India's Asia Cup 2025 opener against the United Arab Emirates (UAE) was among the more surprising elements of their squad for the match. In the end, it mattered little as India steamrolled UAE in Dubai, racing to the paltry target of 58 in just 4.3 overs with nine wickets to spare. India went with just one full-time pacer in Jasprit Bumrah and former opener Aakash Chopra feels that they seem to be going with the formula that worked for them earlier this year in the Champions Trophy that was also played in the UAE. "I think it has a Champions Trophy hangover in this playing XI, that was March, that was dusty, I have never seen that square as dry as I saw in March in Dubai," Chopra said on ESPNCricinfo. "But, this is September, but they have gone with the same tactic, albeit in a different format. Is that actually the way India are going to plan? You have to pick your best team.

Arshdeep has been pivotal to India's success in T20Is for the past couple of years and is also the record wicket-taker for the country in the format. He is also one strike away from becoming the first Indian to take 100 T20I wickets. "Arshdeep Singh. 99 wickets, Arshdeep Singh has got more wickets, better numbers than Jasprit Bumrah in T20s for India," said Chopra.UAE coach Lalchand Rajput had said after the match on Wednesday that the fact that Arshdeep was left out shows the quality and depth that India have at



their dispossal. Kuldeep Yadav foxed the inexperienced UAE batters to end with a match-winning four-wicket haul. UAE had a fairly good start but Jasprit Bumrah (1/19) and Varun Chakaravrthy's (1/4) powerplay strikes started their collapse. Shivam Dube (3/4) also played his part in the demolition job that the Indian bowlers did in the middle overs, as did Axar Patel (1/13). "World champions will crush teams. It was good till powerplay but once spinners started operating, it changed. There was not much turn but if it's Kuldeep and Varun, even top batters struggle against them. Also, if Arshdeep can't make it to playing eleven, it tells you about the (Indian) team's depth," said Rajput.

known as the Rawalpindi Express, was asked if he would take the responsibility of fixing the Pakistan cricket team if the Pakistan Cricket Board (PCB) asked him. Akhtar, while expressing his reservations about being asked in the first place by the Pakistan board, said he would have to consider how much time he could dedicate to the job considering he has young kids.

"First of all, PCB will never ask me to do this job. The reason is that I'm going to do the right thing, whatever is necessary. I'm not saying give me the power. I believe in teamwork. I believe in logic. I believe in working together. It's not about 'give me the power and I'll fix it.' No, no, no, it's not like that. I would rather have a 20-member selection committee. I will take their advice: 'What do you guys say? Tell me." Akhtar said. Akhtar drew up a comparison between India's Abhishek Sharma, who smashed a 39-ball 74 against Pakistan in the Super 4 game, with Saim Ayub, who scored 21 runs off 17 balls against India in the same game. The former Pakistan pacer said that Ayub had looked "scared" of failing on the big stage, even though he plays really well in the local Pakistan Super League (PSL). "To fix Pakistan cricket, if I am given three years and handed the command, the children (players) must be given confidence. '

Over the decades, both actors have carved their own unmatched legacies, but their bond has remained intact. Actor Suhasini Maniratnam, who is also the wife of filmmaker Mani Ratnam and cousin of Kamal Haasan, spoke about this relationship at SIIMA, describing them as "like brothers." She recalled: "If Kamal gets injured while shooting, Rajini sir will immediately call me and ask, 'Is Kamal in a lot of pain?' If I say yes, he will reply, 'If Kamal says pain, it must be true because he never complains.' That shows their closeness."Speculation around their reunion first began when Rajinikanth, at the trailer launch of Coolie, playfully asked, "Did Kamal Haasan make a cameo?"

When Kamal Haasan confirmed film with RajinikanthAt SIIMA, Kamal addressed the rumours with his trademark humour. When the host, actor-comedian Sathish, asked the veteran star if the news doing the rounds holds any truth, Haasan replied in the affirmative. "We were united long ago, but chose to remain apart because they kept splitting a biscuit and giving us only half each. We wanted a full biscuit each, and we got it and relished it well. Now we are content with just half a biscuit again, so we have come together."

Stephen Colbert, Chris Pratt and Jimmy Kimmel react to activist Charlie Kirk's death: 'Hope these are the actions of a mad man'



Conservative activist Charlie Kirk was shot dead on Wednesday at the age of 31 while hosting a college event in Utah. Following the tragic incident, numerous creators, celebrities, and influencers took to social media to express their condolences and extend their prayers to Kirk's family. The Late Show host Stephen Colbert and Guardians of the Galaxy actor Chris Pratt also acknowledged the gruesome nature of Kirk's death. Just before getting into his opening monlogue, where Colbert usually tears into president Donald Trump, he prepared a separate video addressing the Trump ally's death. He said, "After the scripts of our tonight's show were finalised, we learned that Charlie Kirk, a prominent

right wing activist, was killed at a speaking engagement in Utah. Our condolocenses go to this family and loved ones. I am old enough to personally remember the poitical violence of the 1960s, and I hope it is obvious to everyone in America that this brand of violence doesn't solve anything. I pray with all my heart, that this is the abberant actions of a mad-man and not a sign of things to come."Actor Chris Pratt took to social media and wrote on X (formerly twitter), "Praying for Charlie Kirk right now, for his wife and young children, for our country. We need God's grace. God help us."

Jimmy Kimmel, who along with Stephen Colbert has been extremely vocal against the Trump administration, wrote a long message on Instagram urging his followers to stop pointing fingers. He wrote, "Instead of angry finger-pointing, can we just for one day agree that it is horrible and monstrous to shoot another human? On behalf of my family, we send love to the Kirks and to all the children, parents and innocents who fall victim to senseless gun violence. On this day I remember Mellisa and Mark Hortman. On this day I remember the kids that were murdered in school shootings. On this day I remember the domestic abuse busting killed by their partner. May they rest in peace. Their deaths are endlessly ignored. Gun violence is awful."Even though Jimmy Kimmel and Stephen Colbert did not see eye to eye with Charlie Kirk in terms of their political ideology, they appealed to their viewers to raise their voice against political violence of any kind. Even talk show host Rosie O' Donnell, who is one of the people who left America after Donald Trump became president condemned Kirk's shooting and said, "No just no. Do not become the murderer. This is wrong on every level."

Pahlaj Nihalani accuses Anurag Kashyap of leaking his own films for money; takes dig at Prasoon Joshi: 'He doesn't even come to office'



Producer Pahlaj Nihalani, who served as the chairperson of the Central Board of Film Certification (CBFC) between 2015 and 2017, had a controversial tenure marked by multiple clashes with filmmakers. One of the most publicised battles during his term was with Anurag Kashyap over the cuts suggested for his hard-hitting film Udta Punjab. In a recent interaction, Nihalani revisited the issue. Speaking to Pinkvilla, Nihalani alleged that the film's co-producers Ektaa Kapoor and her mother Shobha Kapoor were ready to accept the cuts, but Anurag, who was also a co-producer, opposed it. He remarked, "There are a lot of problems in censor board now as Prasoon Joshi doesn't go to office, so it's a free for all. He has been the longest serving chairman of the board as he has been the chairman for 7 years but he doesn't come to office.
