BM Birla Science Centre unveils magnificent 7-foot Stegodon tusks, other ancient wonders

Hyderabad: Step into the BM Birla Science Centre and get transported to millions of years back when giants roamed the land. And the best relic here at the newly opened pavilion is the spectacular seven-foot-long tusks of an extinct Stegodon Elephant. These are the tusks that most have seen as illustrations accompanying information on species that walked the earth very long ago and went extinct. Here at the science centre, one can now view the meticulously calibrated and assembled Stegodon tusks, which belonged to a genus believed to have existed from 11 million years ago to as recently as 6,000 years ago.

CM Revanth Reddy emphasises on development of V-Hub and Al Hub in Hyd

Chief Minister Revanth Reddy has emphasised the need for the V-Hub to become an iconic building as he reviewed the progress of the AI Hub and T-Square on Saturday afternoon. The meeting took place at the Integrated Command Control Center (ICCC) and was attended by Minister Sridhar Babu, Special Chief Secretaries Jayesh Ranjan and Sanjay Kumar, along with other senior officials.

During the meeting, Reddy instructed concerned officials to commence construction of the V-Hub by the end of November. He highlighted the importance of securing funding from the Japan International Cooperation Agency (JICA) for the project. The Chief Minister stressed that all necessary precautions must be taken during the construction process to address any potential challenges, particularly regarding parking facilities. He also urged officials to facilitate the establishment of international brands, such as Apple, within the V-Hub. Additionally, it was proposed that the facility should operate around the clock and incorporate a utility zone. In relation to the Al Hub, Reddy



ordered inspections of engineering staff college buildings for temporary accommodation and advocated for the creation of a corpus fund dedicated to the Al Hub.

He recommended forming a board comprised of representatives from world-renowned AI institutions to aid in its establishment and development.

PM Modi to unveil projects worth Rs 42,000 crore in agriculture, allied sectors today

Prime Minister Narendra Modi is set to launch and lay the foundation of projects and schemes worth over Rs 42,000 crore in the agriculture and allied sectors here on Saturday.PM Modi will launch two major schemes in the agriculture sector, with an outlay of Rs 35,440 crore. This includes the PM Dhan Dhaanya Krishi Yojana, which has an outlay of Rs. 24,000 crore, according to a statement from the Prime Minister's Office (PMO). "It has the objective of enhancing agricultural productivity, increasing adoption of crop diversification and sustainable agriculture practices, augmenting post-harvest storage at the panchayat and block level, improving irrigation facilities and facilitating availability of long-term and short-term credit in the selected 100 districts," the statement highlighted. The Prime Minister will also launch the 'Mission for Aatmanirbharta in Pulses' with an outlay of Rs. 11,440 crore.It is aimed at improving productivity levels of pulses, expanding the area under pulse cultivation, strengthening the value chain - procurement, storage, processing - and ensuring reduction of losses.PM Modi will also inaugurate and dedicate to the nation projects valued at over Rs 5,450 crore in the agriculture, animal husbandry, fisheries, and food processing sectors, while laying the foundation stone for additional projects worth around Rs 815 crore.PM Modi is set to participate in a special Krishi programme at the Indian Agricultural Research Institute in New Delhi, and interact with farmers and thereafter, participate in a public programme, where he will address the gathering on the occasion. "The programme underscores the Prime Minister's continued commitment to farmer welfare, agricultural self-reliance, and strengthening rural infrastructure. It will focus on promoting modern agricultural practices, supporting farmers, and celebrating significant milestones in farmer-cen-



tric initiatives," according to the PMO. The projects being inaugurated by the Prime Minister include Artificial Insemination Training Center at Bengaluru and in J&K; Centre of Excellence at Amreli and Banas; Establishment of IVF Lab at Assam under Rashtriya Gokul Mission; Milk Powder Plants at Mehsana, Indore, and Bhilwara; Fish Feed Plant under Pradhan Mantri Matsya Sampada Yojana at Tezpur, Assam; Infrastructure for Agro-processing Clusters, Integrated Cold Chain, and Value Addition Infrastructure, among others. The projects whose foundation stone will be laid by the Prime Minister include Integrated Cold Chain and Value Addition Infrastructure (Irradiation) in Krishna, Andhra Pradesh; Trout Fisheries in Uttarakhand; Integrated Aqua Park in Nagaland; Smart and Integrated Fishing Harbour in Karaikal, Puducherry; and state-of-the-art Integrated Aquapark in Hirakud Odisha, among others. During the programme, the Prime Minister will interact with farmers engaged in pulses cultivation, who have benefited from various government schemes aimed at establishing a value chain-based approach in Agriculture, Animal Husbandry, and Fisheries.

Telangana govt likely to move **Supreme Court on BC reservations**

The Telangana state government has announced its intention to challenge the recent decision by the High Court which stayed Government Order (GO) 9 concerning Backward Class (BC) reservations. The government plans to approach the Supreme Court on Monday to seek redress. Following a thorough review of the High Court's ruling, officials have opted to engage senior counsel to present their arguments. Notably, legal experts in the field of reservations, such as Abhishek Manu Singhvi and Siddhartha Dave, are expected to represent the government in this matter.

The High Court's decision has placed a stay on GO 9, as well as on GO 41 and GO 42, citing non-compliance with the so-called "triple test" required for reservations. The court noted precedents from previous Supreme Court rulings which established that exceeding a 50 per cent cap on reservations is unconstitutional. In light of this, the petition-



ers have been given two weeks to file a counter, while the government has four weeks to respond. The next hearing is scheduled for December 3.The High Court's order has been formally published, detailing its objections to the implementation of the challenged reserva-

Hyderabad's Formula E race placed Telangana on global map, says KTR

Hyderabad: Bharat Rashtra Samithi (BRS) working president and former Minister KT Rama Rao said the successful hosting of India's first Formula E race in Hyderabad marked Telangana's emergence on the global stage as a hub for innovation, clean mobility and advanced technology. Speaking as the chief guest at the 10th FMAE National Student Motorsports Competition 2025 in Coimbatore on Friday, Rama Rao said the Formula E event was not merely a spectacle but a statement of intent. "When the world's fastest electric cars raced on Hyderabad's streets, it proved that Telangana is ready for the future. The event generated nearly Rs 700 crore in economic activity and drew international attention to the city's technological capabilities," he said. Rama Rao said the race was only the beginning of a larger journey. "The foundation has been laid, and Hyderabad will soon emerge as the hub of India's Mobility Valley," he said, underscoring the State's long-term vision for sustainable, technology-driven industrial growth.

Highlighting Telangana's innovation ecosystem, Rama Rao recalled how the State built globally recognised institutions like T-Hub, the world's largest startup incubator, and T-Works, India's largest prototyping centre."In the time it takes to sip your chai, an idea can walk from T-Hub to T-Works," he quipped, emphasising the seamless link between idea incubation and execution. Addressing hundreds of young engineers, innovators and motorsport enthusiasts from across India, Rama Rao urged students to create opportunities instead of waiting for them. "Why stand in line when you can start one of your own?" he asked. "Do not just be job seekers, be job creators. Once you start dreaming big, you will be surprised by your own potential."Drawing a parallel with Telangana's journey, Rama Rao reminded that many had once doubted the possibility of statehood.

"Yet here we are, 11 years later, standing tall as a role model for the nation across multiple sectors. That is the power of belief, resilience and vision," he said, Rama Rao urged the youth to seek impact over income and authenticity over authority while maintaining their hunger for speed and scale. "You are sharper, more responsible and more conscious than people give you credit for. It is you who will drive India forward," he told the students. Concluding his address, Rama Rao quoted from the recent Formula 1 film: "Hope is not a strategy. Create your own breaks.""Whether in motorsport, governance or life, success does not come by chance. We must design our opportunities, execute with courage, and create our own breaks. That is how the future is built," he said.

Rift between Bandi Sanjay and Eatala Rajender resurfaces ahead of local body polls

Karimnagar: The long-standing rift between Union Minister of State for Home Bandi Sanjay Kumar and Malkajgiri MP Eatala Rajender has once again surfaced ahead of the upcoming local body elections. Rajender's recent remarks on issuing B-forms to party candidates have sparked a fresh dispute between the two factions in the Huzurabad Assembly constituency. Addressing a press conference in Huzurabad on Friday, Rajender asserted that he had been representing the constituency for 25 years and, as a local leader, would issue party Bforms to candidates contesting the local body elections.In a swift response, BJP district president Gangadi Krishna Reddy, without naming the MP, said that the decision on candidates would be taken by the party high command. He clarified that B-forms would be issued to district leaders as per the instructions of the State leadership, adding that the BJP had no tradition of distributing B-forms based on individual recommendations

He further stated that the party would recognise the services of long-time leaders and activists, indirectly hinting that Rajender's followers, who joined the BJP in 2021, would not be given tickets for the local polls. Meanwhile, Rajender's alleged anti-party remarks have been circulating within BJP circles. According to party sources, during his recent visit to his native Kamalapur on the occasion of Dasara, the MP reportedly told his followers that he would help them secure tickets from the All India Forward Bloc (AIFB) if they failed to get BJP tickets. Following this, district leaders are said to have lodged a complaint with State BJP president N Ramchander Rao, accusing Rajender of acting against the party line. Though neither the MP's comments nor the complaint copy has surfaced publicly, followers of the Union Minister allegedly leaked the information to the media. It may be recalled that Sanjay Kumar's comments in July on groupism within the Huzurabad BJP unit had sparked a major controversy. During a local event, he had stated that tickets would only be given to those working for the party and not for individuals, questioning why factionalism had developed in Huzurabad when it was absent elsewhere in the State. Rajender had reacted sharply to those remarks, criticising Sanjay Kumar. Party insiders said the rivalry between the two widened further after Rajender was denied the State BJP president post — a decision his group believes was strongly opposed by Sanjay

TGSRTC to build 12 new bus terminals across Hyd

Hyderabad: To cater to the growing passenger footfall, the Telangana State Road Transport Corporation (TGSRTC) is planning to develop its infrastructure in the capital region. As part of it, the authorities have proposed to construct about 12 new bus terminals across Hyderabad to improve urban connectivity.

It is learnt that proposals in this regard have been sent to the state government and construction will begin once approval and budget allocations are received.

The proposed new bus terminals are planned at locations including at Kukatpally, Balanagar, Kalimandir, Hitec City, Lingampalli, Jeedimetla, KPHB Colony, IS Sadan, Gandimaisamma, Uppal and Ghatkesar.

The shocking incident of shoe hurling at Chief Jusice Bhushan Ramkrishna Gavai in the Supreme Court remises reflects the normalisation of hate in a deeply fracured society. It shows that even the highest constitutional spaces are not free from social prejudices. The attack has eft the legal fraternity and the public deeply disturbed. The act, committed by 71-year-old advocate Rakesh Kishore n the name of honouring 'Santan Dharma', occurred while he Chief Justice was presiding over a hearing. Justice Bavai, who belongs to the Dalit community, upholds, at east symbolically, the promises of the Constitution vherein equality and dignity transcend multiple socio-culural barriers. The attack on him is a shameful reflection of the growing intolerance corroding our national fabric When even the educated sections of society resort to such ıncivil behaviour, it signals a dangerous moral decay. This nindset stems from blind religious fanaticism, political nanipulation, and a deliberate assault on reason and contitutional values. India's strength lies in its tolerance, diversity, and respect for differing opinions — not in mobike reactions. Such disgraceful conduct against the head of the judiciary undermines the dignity of the law. The naion must wake up to this rising tide of bigotry before it frowns our collective sanity. The CJI was apparently tareted for remarks he made while refusing to entertain a public interest litigation seeking judicial intervention for the econstruction of an idol of Lord Vishnu in the Khajuraho emple. His comments were interpreted as being hurtful o Hindu sentiments. Over the past decade, an ideological cosystem promoting radical right-wing thinking has been reated. This has emboldened certain groups that have epeatedly taken the law into their own hands, from cow


Transforming Digital Learning: Peddapalli Collector Leads Initiative to Restore ICT Equipment in Government Schools.

Telangana State records rare record in paddy yield:- State Irrigation and Civil Supplies Minister Captain N Uttam Kumar Reddy

October 11):- Telangana State has achieved a rare record in paddy yield, said State Civil Supplies and Irrigation Minister Uttam Kumar Reddy. "State Irrigation and Civil Supplies Minister Captain N Uttam Kumar Reddy said that Telangana State has recorded a rare record in paddy yield. He spoke at a special review meeting on the paddy procurement process at the Yadadri Bhuvanagiri District Collector's Office on Saturday evening. He clarified that this was possible only with the farmer-friendly policies adopted by the state government under the leadership of Chief Minister Revanth Reddy and Deputy Chief Minister Mallu Bhatti Vikramarka. Telangana has emerged as the state with the highest grain production of 148.3 lakh metric tons in the history of independent India, he said. "He said that after coming to power, one of the three crops cultivated has competed with the other and has created a record in grain production in all three crops. The yield of 148.3 lakh this monsoon is a testament to that. He said that the state government has prepared the ground for the purchase of grain. He said that the grain will be purchased at a cost of 22 thousand to 23 thousand crores. He said that the government has decided to purchase 80 lakh metric tons of the total harvest, of which 40 lakh metric tons are of the Sanna and 40 lakh metric tons of the Doddu varieties. He said that 8342 purchase centers are being opened across the state for the purchase of grain. He revealed that 1205 purchase centers have already been opened in the district centers of Kamareddy, Nizamabad, Medak, Siddipet and Nalgonda. "He said that the officials are paying special attention to creating infrastructure at the grain procurement centers. He said that a special review meeting will be held in Hyderabad on the 16th of this month on the grain procurement process. He said that the procedures prepared by the government on grain procurement have already been sent to the officials at the field level. He said that the grain procurement process, which started on October 1, will be completed in the second week of January. Referring to the procurement issue in Yadadri Bhonagiri district, he said that

7.79 lakh metric tons of grain were harvested in the cultiva-

tion of two lakh 83 thousand 18 acres. Trump tariff impact becomes clearer: Andhra pegs shrimp export losses at Rs 25,000 crore, 50% export orders cancelled

Andhra Pradesh has estimated that due to Trump US tariffs, shrimp export losses are approximately Rs 25,000 crore, with about 50 percent of export orders cancelled. Nearly Rs 600 crore in tariff burden has fallen on about 2,000 containers being exported, government officials said Monday. Chief Minister N Chandrababu Naidu has once again appealed to the Centre to support aqua farmers in Andhra Pradesh who are facing severe distress due to US-imposed tariffs.

US tariffs touched 59.72 percent after Trump announced 25 percent additional tariffs over and above the 25 percent announced earlier, as well as the 5.76 percent countervailing duty and 3.96 percent anti-dumping duty. Naidu suggested relief in GST and extending financial packages to the state's aqua farmers. He urged the Union Government to take decisions at the national level to protect aqua farmers from losses. The CM also requested measures to increase domestic consumption of aqua

products. Naidu has written separate letters to Union Finance Minister Nirmala Sitharaman, Commerce and Industry Minister Piyush Goyal, and Fisheries Minister Rajeev Ranjan Singh. He requested the finance minister to look into issues such as GST and financial relief, the commerce and industry minister to pursue agreements with other countries in the agua sector, and the fisheries minister to focus on expanding the domestic market. The CM pointed out that aqua farmers and families dependent on the sector in Andhra Pradesh are facing hardships. He also explained the measures currently being taken by the state government. Andhra Pradesh accounts for 80 percent of the country's shrimp exports and 34 percent of marine exports, with exports valued at around Rs 21,246 crore annually. About 2.5 lakh aqua farmer families and 30 lakh people dependent on allied sectors are in difficulty. Chandrababu stated that US tariffs have had the greatest impact on shrimp exports. The CM stated that the state government has already initiated relief measures — for example, after discussions with feed producers, aqua feed MRPs have been reduced by Rs 9 per kg, and subsidised supply of transformers is also being considered. He requested bank support for exporters and aqua companies, including a 240day moratorium on loan and interest repayments, interest subsidies, and a temporary waiver of the 5 percent GST on frozen shrimp. In addition, he urged the Centre to focus on diversifying export markets beyond the US. He suggested entering into Free Trade Agreements (FTAs) with the European Union, South Korea, Saudi Arabia, and Russia to boost exports. The CM also sought interim financial support for exporters, clarity on tariff/tax relief schemes, and noted that exporters were ready to supply seafood to the EU.

'No parchi-kharchi:' Haryana CM says 1.8L govt jobs given on merit

Haryana Chief Minister Nayab Singh Saini on Sunday said the incumbent BJP government provided government jobs to 1.80 lakh youths "purely on merit and without 'parchikharchi' (nepotism and sifarish)". Speaking at the 75th foundation day celebration of Saini Shikshan Sansthan, the chief minister said, "Government schools have been offering free coaching to meritorious students, alongside a range of scholarship schemes. Under the Super-100 programme, 534 students have successfully cleared competitive exams such as IIT and NEET."

Saini said, "Education is a powerful tool to uplift the backwards sections of society. And, in line with that vision, the government has implemented 27 per cent reservation in educational institutions and public sector jobs."The CM said, "For children from backwards class families with an annual income up to Rs 3 lakh, the government is offering education loans of up to Rs 15 lakh for studies in India and Rs 20 lakh for studies abroad at an annual interest rate of 4 per cent. Students from families earning less than Rs 1.80 lakh annually have been exempted from school fees up to Class XII, and college and university fees for daughters from such families have also been waived."The chief minister noted, "The government facilitated the enrolment of 2,650 underprivileged children into recognised private schools. Under the Vidyarthi Parivahan Suraksha Yojna, 35,000 students from Classes I to XII are receiving free transport, while 6,506 girl students from classes IX to XII are benefiting from the Chhatraa Parivahan Suraksha Yojana."The CM also felicitated meritorious students and acknowledged the contributions of generous donors. Saini further stated, "Atal Tink-



ering Labs have been established in all 22 districts of Haryana, and over 5,000 schools now have Wi-Fi connectivity. To advance digital education, the government has distributed 5 lakh tablets to students in Classes X to XII, installed digital boards in approximately 40,000 classrooms, and set up 1,201 Information and Communication Technology laboratories.

A Functional Literacy and Numeracy programme has been launched for students in classes one to three to strengthen foundational learning."The CM said, "Through the National Skills Qualification Framework, schools are now equipping students with practical skills, with the system already implemented in 1,001 institutions. 'Will protest before CM': Stuck in jam, MLA Nand Kishor Gurjar manages traffic; slams Ghaziabad cops for negligence

The scene at Loni Tiraha in Ghaziabad morning was unusual. Stuck in a massive traffic jam on the Delhi-Saharanpur Road, the BJP's Loni MLA Nand Kishor Gurjar stepped out of his car and took matters into his own hands - managing the traffic himself, pulling up police officers present at the spot, and warning that he will protest outside Chief Minister Yogi Adityanath's residence if the administrative negligence is not dealt with."I have been standing in the sun since morning and an officer passed in front of me, but did not even stop. This negligence will not be tolerated," Gurjar was heard saying, as he supervised the flow of vehicles. The MLA, who said he was on his way back after inspecting the condition of roads, also spoke to several drivers on the spot and assured them that roads in Loni would soon be made pothole-free. Speaking to The Indian Express, Gurjar alleged that corruption and dereliction of duty had become rampant in local policing. "There was a jam, and people were standing there for hours. We called the police, but they came late. There is information that posts are being given for Rs 2.5-3 lakh. Seniors with experience are sitting idle while 21-22-year-olds, who just completed training, are made chowki in-charges. They spend their days on cell phones, disrespect even MPs, and claim to be busy with 'video conferences' instead of being on the field," he said. The MLA claimed that he had recorded WhatsApp calls with three sub-inspectors admitting to having paid bribes for postings. "Yogi-ji has given clear instructions that officials should be on the field. If this matter is ignored, I will sit at the CM's office in protest," he said. Responding to the allegations, Keshav Kumar Chaudhary, Additional Commissioner of Police, Ghaziabad, said the videos have reached senior police officers and the allegations will be looked into. "We saw his video. The allegation will be probed properly after which adequate actions will be taken," he stated. Gurjar also alleged that money was being taken to "settle Rohingya Muslims" in Ghaziabad. "They are destroying Ghaziabad by doing so... Earlier, I had filed a complaint against a person who had misbehaved with a woman. The police claimed that he had been locked behind bars, but I later got to know that he was able to go scot-free," Gurjar said. "Our complaints are not being taken seriously. Let alone MLAs, they don't even pay attention to MPs. One can only imagine how they must be behaving with the common people who leave all their work and come to the police station for help," he told reporters on Saturday after reaching the office of Siddhartha Gautam, Assistant Commissioner of Police

SC clears Chandigarh doctor of negligence in 20-year-old maternal death case

The Supreme Court has exonerated a Chandigarh doctor and her nursing home from charges of medical negligence in the death of a young mother and her newborn nearly 20 years ago, bringing closure to a protracted legal battle that had shadowed her career. A bench of Justices Sanjay Kumar and Satish Chandra Sharma allowed the appeal of obstetrician-gynaecologist Dr. Kanwarjit Kochhar and Deep Nursing Home on September 9, overturning rulings of the State Consumer Commission and the National Consumer Disputes Redressal Commission (NCDRC). The court also directed complainant Manmeet Singh Mattewal to refund the ?10 lakh compensation already received, in monthly instalments.

The tragedy dates back to December 2005, when 32-year-old Charanpreet Kaur, a Chandigarh lecturer and bank manager on deputation, was admitted to Deep Nursing Home in the eighth month of her pregnancy. After being induced, she delivered a baby boy at 2:40 am on December 22. The newborn did not survive despite immediate re-

suscitation attempts. Soon after, Kaur suffered an uncontrolled postpartum haemorrhage, a life-threatening complication where the uterus fails to contract after delivery. Records show that blood was urgently requisitioned, additional specialists were consulted, and she was shifted to PGI Chandigarh — the only regional centre equipped for advanced intervention — but she was declared dead at 5:30 am. Mattewal alleged gross negligence in the management of bleeding, transfer arrangements, and record-keeping, filing a claim of nearly ?1 crore before the Chandigarh State Consumer Commission in 2006. In 2007 the State Commission held the doctor negligent for not verifying Kaur's blood group and for delays in transfusion, awarding compensation of ?20.26 lakh. The NCDRC in 2012 upheld the order in part but shifted liability solely onto Dr. Kochhar, citing antenatal lapses such as failure to insist on haematological and cardiological tests. The Supreme Court has now struck down those findings. Writing for the bench, Justice Sanjay Kumar observed: "Our sympathies aside, we are called upon to examine the validity of the finding that Dr. (Mrs.) Kanwarjit Kochhar, the obstetrician-gynaecologist who conducted the delivery, is guilty of medical negligence. All the experts who constituted the five Medical Boards found that there was no negligence on her part or on the part of the nursing home."The court was particularly scathing about the NCDRC's approach, noting that Mattewal's complaint had focused only on post-delivery management and transfer, yet the Commission fastened liability for antenatal care. "The NCDRC clearly transgressed its jurisdiction in building a new case for the complainants, contrary to their pleadings. It was not for it to travel beyond the pleadings in the complaint case and build up a new case on its own," the bench held.Reiterating established precedent, Justice Kumar cited Jacob Mathew vs. State of Punjab (2005): "Simply because a patient did not favourably respond to the treatment given by a physician or if a surgery failed, the doctor cannot be held liable per se." The judgment also underscored that courts and consumer fora "are not experts in medical science and must not substitute their own views over that of specialists." Allowing the appeal, the bench dismissed Mattewal's complaint and ordered that the ?10 lakh already paid be refunded in instalments, split between the insurer and the Kochhars. "In the circumstances, parties shall bear their own costs," the ruling concluded.

Delhi woman driving BMW that killed senior Finance ministry official booked for destroying evidence

Delhi BMW accident news: A day after a senior Finance Ministry official was killed when a BMW hit his motorcycle in the Delhi Cantonment area, Delhi Police Monday said the woman driving the car has been booked under sections of culpable homicide not amounting to murder and for attempting to destroy evidence after the accident. Navjot Singh, 57, who was posted as Deputy Secretary in the Department of Economic Affairs under the Finance Ministry, was killed and his wife injured when the BMW rammed into them on Sunday afternoon. The BMW was being driven by a woman, Gaganpreet, who was accompanied by her husband, Parikshit Makkar, and two young children, police said.

According to police, the car was registered in the name of Gaganpreet's husband. They live in West Delhi's Rajouri Garden. "After the accident, the duo — Gaganpreet and Parikshit — took Navjot and his injured wife to Nulife Hospital in GTB Nagar, nearly 17 km from the accident site. It has been revealed that the hospital owner is known to them, as Gaganpreet's parental home is in the same locality where the hospital is located," a police officer said. Gaganpreet and her husband were also admitted in the same private hospi-



tal, where they are under observation of the doctors, the officer said. The statements of Gagandeep and her husband are yet to be recorded but a case under sections 281 (negligent and rash driving), 125B (act endangering life or personal safety of others), 105 (culpable homicide not amounting to murder) and 238 (causing disappearance of evidence of offence, or giving false information to screen offender) has been lodged at Delhi Cantonment police station.

'50 lakh footfall in first week of September, snags' as its twin challenges – Is Kolkata Metro Durga Puja ready?

As Kolkata prepares for the annual Durga Puja surge, the city's Metro network, which is operated by Indian Railways, is witnessing record crowds and mounting operational headaches. Metro said a "record" 6.96 lakh people used its services across its network on Friday - 5.25 lakh on Blue Line, the north-south corridor connecting Dakshineswar and Sahid Khudiram stations; and 1.66 lakh on Green Line, the east-west corridor linking Howrah Maidan to Salt Lake Sector V. While the full commissioning of the Green Line has created a seamless corridor linking Howrah and Salt Lake, the dramatic rise in passengers has exposed capacity limits and bottlenecks just weeks before the festival. With millions of people expected to flock to the streets during the week-long Durga puja, many will use the Metro's newly expanded network to travel from the suburbs to the city's pandals.

The central question looming over the city is: Is the Metro ready for the Puja rush?

Last month, Prime Minister Narendra Modi inaugurated sections in the two corridors. Among them was the completion of the Green Line's last leg - the 2.6 km Esplanade-Sealdah section. This vital link now connects the city's two major railway stations, Howrah and Sealdah, and has created a seamless 16.6 km corridor from Howrah Maidan to Sector V. This integration has had an immediate and dramatic effect on ridership. Data from the first week of September shows passenger footfall on the Metro regularly exceeding 6.5 lakh per day, with a record-breaking 8,07,030 passengers on September 1. The surge, however, has exposed the Metro's vulnerabilities. The Blue Line, the city's oldest and most heavily used corridor, is bearing the brunt of the new traffic. Its interchange at Esplanade, already the heart of Kolkata's shopping district, has become a major congestion point, struggling to cope with the influx of shoppers and office-goers. Older, smaller stations like Chandni Chowk and Central are also facing similar challenges with limited space and infrastructure. "During the pre-Puja season, Metro trains are usually crowded, but this year it is impossible to board during office hours. From 6.15 pm to 7.00 pm, I often let two or three trains pass because the gates won't close due to the massive crowds. I can only get on about one out of every three trains," said Arbindo Das, a regular Blue Line passenger. Operational setbacks

have compounded the pressure. The Kavi Subhash terminal on the Blue Line has been closed for maintenance since July 28, forcing short terminations at Shahid Khudiram and Mahanayak Uttam Kumar and disrupting schedules. A technical snag on September 8 at Kavi Nazrul station, also on the Blue Line, added to commuter misery: a journey from Baranagar to Chandni Chowk that normally takes 24 minutes stretched to 40, leaving thousands stranded during peak hours. Overcrowding has also made it difficult to close train doors, further delaying services. Furthermore, the introduction of the Noapara-Airport Yellow Line on August 25, which also interchanges with the Blue Line, added another layer of complexity. Metro officials are now working on a trial basis to separate the Yellow Line services from the Blue Line to insulate the old system, a move similar to how the Green Line and Blue Line services are physically separated. Amid rising complaints from commuters over irregular frequency and short-termination of trains on the Blue Line, Metro is urging passengers to "cooperate", especially during peak hours. In a statement, Metro said not all trains could be run across the full stretch of the corridor owing to operational constraints following the closure of Kavi Subhash station (New Garia), the original terminal, over a month ago. "Passengers are requested to cooperate so that Metro can run smoothly. At present, commuters are resisting vacating the coaches at Mahanayak Uttam Kumar station during peak hours, which causes a cumulative effect and adversely affects the services," the Metro said on Thursday.Of the 272 services, the Metro said, 32 will be run between Dakshineswar and Tollygunge instead of the entire stretch connecting the northern and southern parts of the city. Metro authorities have also begun a series of operational measures. Officials said they are regulating the number of services and have begun efforts to reopen the Tollygunge car shed to improve train operations. This will allow for additional rakes to be placed at Mahanayak Uttam Kumar and Noapara stations before the start of daily services. They are also exploring the possibility of extending Green Line services beyond midnight. "We are encouraging passengers to use digital ticketing by offering a 5% discount, hoping to reduce queues and manage crowds more efficiently," said an official. "Night-long services on the Blue Line are being planned for key Puja days," said a Metro official, while the CPRO added, "We are monitoring the situation closely. For now, services will remain the same, but depending on future requirements, some decisions might be taken."The network's operational systems and station infrastructure must catch up quickly if it is to handle the spectacular footfall Durga Puja brings. "While the new lines are transformative, the recent footfall data and service hiccups show the system is under strain. With Puja approaching, how authorities manage the peak days will be crucial," said civil engineer Ratul Bose, who regularly takes the Metro ride from Dumdum to Esplanade (Blue Line). The Metro officials, however, are assertive that "improvement will be visible". "Metro Railway is analysing each incident thoroughly and working towards improvement," it said in a statement

NCW seeks report from Jadavpur University over death of undergrad; police summon 4 students

The National Commission for Women (NCW) on Saturday took suo motu cognizance of the death of a thirdyear English honours student of Jadavpur University and has sought a report from the university authorities and the Kolkata Police Commissioner within three days. NCW chairperson Vijaya Rahatkar has written to the Commissioner, seeking a thorough investigation, forensic examination, and post-mortem report. According to the NCW statement, "Chairperson Vijaya Rahatkar, has written to the Commissioner of Police, Kolkata, seeking a thorough and impartial investigation, forensic examination, and post-mortem report, along with an inquiry into the role of university authorities in ensuring campus safety. The Commission has also sought timely updates to the victim's family and strict action if any foul play is found. A detailed Action Taken Report has been sought within 3 days.'

Archana Majumdar, one of the member's of the NCW, while speaking to The Indian Express said, "Overall the Commission is anxious about what is happening in West Bengal starting from the RG Kar rape and murder to the rape in law college in the city and now JU." "No child is safe there. Parents send their children for studies, and they come back home dead. We will visit the university for inspection, we will also visit the deceased girl's family and the JU authorities," she said. Meanwhile, Kolkata Police, which is investigating the case, has seized the victim's mobile phone and summoned four students from the University's drama club for interrogation. Deputy Commissioner of South Suburban Division Bidisha Kalita stated that the police are probing all angles and have obtained CCTV footage. "We are probing all angles. We are visiting the spot with the autopsy surgeon. We have got the CCTV footage."DC Kalita and the autopsy surgeon visited the incident site, where police



measured the distance between the pond and the festival venue, as well as the pond's depth. The police are reviewing the university's CCTV footage to track the student's movements from her entry into the university and identify the people she was with that day. Police sources have said that five persons have been questioned. The father of the deceased student, Arnab Mondol, expressed concerns about the investigation, saying, "We demand a thorough probe. My daughter couldn't swim, was scared of darkness, and it's unlikely she'd go to that spot alone. Her bag was dry when handed over to us, which is suspicious. We believe her university friends should be thoroughly questioned." Overcome with emotion, he added, "My 22year-old daughter was a bright student. I'm still in shock that I had to perform her last rites instead of her doing mine one day."The primary post-mortem report reveals that death occurred due to drowning, with no external or internal injuries found. Traces of alcohol were found in the student's stomach, but the quantity will be determined through the viscera report. The university has tightened entry and security regulations across its premises following the incident.

Following the incident, Ghazipur District Magistrate Avinash Kumar ordered a magisterial inquiry and a three-member Special Investigation Team (SIT) was constituted to probe the incident. The SIT is headed by Varanasi DCP Gaurav Banswal and includes Additional DCP Anshuman Mishra and ACP Nitin Taneja. Superintendent of Police (SP) Iraj Raja said action will follow the inquiry's findings. He noted that no FIR has been registered so far because the victim's family has not filed a complaint. "We have removed the personnel from active duty to ensure the inquiry proceeds without influence," an official added



A senior official said the postmortem report revealed congestive heart disease as the cause of death but also recorded four injuries on the body, raising questions that investigators aim to resolve. Authorities say the protest began as a dispute between two groups over the installation of electricity poles, with one group accusing another of erecting poles on private land without consent. On September 9, villagers staged a sit-in outside the Nonhara police station seeking action; police told protesters the matter fell under another department

'Twenty days after wedding,' man throws father-in-law down the stairs in Kolkata, kills him

A 30-year-old man has been arrested for allegedly murdering his 75-year-old father-in-law in a fit of rage following a heated argument at the victim's Golf Green residence in Kolkata. The arrested accused, identified as Sanjit Das, who married the victim's daughter Soumashree just 21 days prior, was taken into custody after police launched an investigation. According to police, an argument began between the victim, Samik Kishore Gupta, and his daughter on Thursday evening around 6:30 pm. The situation es-

calated when Das allegedly pushed Gupta down the staircase, causing severe head injuries. The couple then reportedly fled the scene. The couple then reportedly fled the scene, leaving the victim's wife to find her husband's body the next morning. Gupta's body was discovered on the staircase landing the next morning by a neighbour on Friday. The victim's son, Sujay Gupta, was also found unconscious under a cot in the house and was hospitalized. A police investigation was launched immediately and Das was arrested, who reportedly confessed to the crime during interrogation. According to police reports, a heated argument erupted between the victim and his daughter on September 12 evening, around 6:30 pm, with Sanjit and Soumashree present. In a fit of rage, Das allegedly pulled the victim out of bed and pushed him down the stairs, causing severe head injuries. After the initial fall, Sanjit reportedly brought the victim back to his bed, only to lift him again and push him down the stairs towards the landing. A murder case has been registered based on the statement of Gupta's wife, Jayashree. While the motive behind the murder is still under investigation. "The victim's son, Sujay Gupta, was found unconscious under a cot in a first-floor room. He was admitted to MR Bangur Hospital for treatment. The reason behind his unconsciousness is also being probed.," the

FIR in Bulandshahr against UK-based influencer over post on Nepal protests

A case was registered against Arpit Sharma, a UKbased social media influencer and a chartered accountant, in Uttar Pradesh's Bulandshahr district over his comments on the Nepal protests, officials said According to police, the FIR was registered against Sharma, who hails from Bulandshahr, over his now-deleted post in which he spoke about Nepal's Gen-Z protests in India's context. Sharma has more than 4 lakh followers on Instagram and over 1 lakh followers on X, formerly Twitter. He also has a YouTube channel with 11,000 subscribers. Bulandshahr Superintendent of Police (City) Shanker Prasad said, "His statements were deemed a threat to the unity, integrity, and sovereignty of the country."The FIR was registered under section 152 (act endangering sovereignty, unity, and integrity of India) of the Bharatiya Nyaya Sanhita at the Kotwali Nagar police station in Bulandshahr on a complaint by a police constable Aslam Malik.Sharma "deliberately tried to provoke unrest through his video and comments, and sparked public outrage", the complainant alleged. Sharma responded to the FIR via a post on X. "I have done nothing wrong... Hate cannot shake me. They are viciously defaming me, but I



will try to stand tall.""With Gandhiji's values as my strength, Bhagat Singh's courage & Baba Saheb's constitution, I stand for peace, truth and unity," wrote Sharma who is son of Aam Aadmi Party (AAP) leader Vikas Sharma who unsuccessfully contested the Uttar Pradesh Assembly elections on party ticket from the Bulandshahr seat. The protest in Nepal was sparked by a short-lived social media ban which led to thousands of people taking to the streets to show their anger over widespread graft and poverty.

DUSU elections: Manifestos focus on women empowerment, student welfare

Free Wi-Fi, sanitary pad vending machines, rollback of the National Education Policy (NEP), and a menstrual leave policy—these are among the promises featured in the electoral manifestos of the top contenders in the Delhi University Students' Union (DUSU) elections. With polling just days away, the three main players for DUSU polls— Akhil Bharatiya Vidyarthi Parishad (ABVP), Congress's National Students' Union of India (NSUI), and the Left alliance of the Students' Federation of India (SFI) and All India Students Association (AISA)—unveiled their manifestos . While NSUI released their manifestos on Friday, SFI-AISA and ABVP released it on Saturday. The heart of these manifestos centres on student issues: affordable education, safer campuses, access to hostels, among otherABVP, which has long commanded DU's electoral space, rolled out a manifesto leaning on welfare promises: subsidized metro passes, free Wi-Fi, subsidized health insurance, accessibility audits, and expanded hostel facilities. "The ABVP manifesto highlights the real issues faced by students of Delhi University, It reflects our belief that students are not merely citizens of tomorrow but also active citizens of today," said ABVP National General Secretary Virendra Singh Solanki.

"By prioritizing subsidized metro passes, provisions for specially-abled students, and women-centric measures, this manifesto demonstrates that ABVP-led DUSU is committed to working 365 days a year," he added. On the party's objectives for the academic year, ABVP's presidential candidate Aryan Maan said, "This year, we are determined to ensure adequate sports facilities and nutrition, campus accessibility audits for specially abled students, and free Wi-Fi access across DU. With these initiatives, we aim to establish Delhi University as a premier global institution."Deepika Jha, ABVP's Joint secretary candidate stressed on women's empowerment and safety. "Our priorities include establishing women's hostels in every college, installing pink booths, providing sanitary pad vending machines, appointing permanent gynaecologists, and introducing scholarships for transgender students," noted Jha. For the Congress-backed NSUI, the manifesto launch echoed Leader of the Opposition of Lok Sabha Rahul Gandhi's rhetoric of opening a "Mohabbat Ki Dukan." "We are confident of winning 4-0," said NSUI National President Varun Choudhary. "We are following the path of Bahujan-Nayak Shri Rahul Gandhi and are determined to safeguard the Constitution of India. Once again, we will open the 'Mohabbat Ki Dukan' in Delhi University, where diversity, love, and dignity for all will remain our top priority."NSUI's manifesto includes promises such as the scrapping of Higher Education Financing Agency (HEFA)-linked fee hikes, granting up to 12 days of menstrual leave per semester, rolling back NEP (National Education Policy) 2020, and upgrading hostels as well as classrooms. Its "Her Manifesto" focuses on women's empowerment, pledging zero tolerance for harassment, legal aid cells, increased female security personnel, sanitary napkin vending machines, and medical-counseling centers in every college. In its manifesto, the SFI and AISA alliance presented itself as the conscience of student politics. The party's candidates Anjali, Sohan, Abhinandana, and Abhishek argued that their manifesto, centered on affordable education and hostels for all-is more student-centric than their rivals'. The alliance promised to resist fee hikes, push for elected Internal Complaints Committees and establish gender sensitisation cells in all colleges. SFI-AISA alliance also vowed to implement a menstrual leave policy for women students and further demanded the inclusion of women's colleges like Lady Shri Ram College, Gargi College, and Daulat Ram College in the student union. Their consistent efforts-from the Concessional Metro Pass campaign to Common Univer-

sity Entrance Test (CUET) admission assistance-were high-





lighted as evidence of the Left alliance's grassroots connection. In their joint appeal, the alliance's student leaders trained their guns at the NSUI and ABVP. "The still rampant use of money-muscle power by organisations like the NSUI and ABVP makes it urgent for students to vote for those who have been sincere to the cause of student welfare," they stated. While the three major parties are ready to battle it out for the DUSU polls, the Aam Aadmi Party's (AAPs) relaunched student wing- the All Students Action Party, (ASAP)-which was set to debut in the student election, has decided to not contest this year."We won't be contesting this year," said ASAP member Ishwar Chand. "We are focusing on building the party together, bringing up units in every college, and making our presence stronger by voicing student concerns. We will fight next year if our base is stronger." ASAP was launched earlier this year as a revamped version of the Chhatra Yuva Sangharsh Samiti (CYSS). Chand pointed to their ongoing protests, including calls to boycott the India-Pakistan cricket match after the Pahalgam killings, as reflection of the party's grassroots level presence. "We are active on the ground and want to keep this momentum going," he said.

Irrigation experts dismiss Revanth Reddy's 904 TMC of Krishna water pitch as ignorant posturing

Hyderabad: With the all important phase of hearing by the Krishna Water Disputes Tribunal-II (KWDT-II) set to commence on September 23, Chief Minister A. Revanth Reddy has surprisingly asked the State irrigation team to demand a staggering 904 TMC of Krishna water.

But the KWDT-II's terms, set in 2023, focus mainly on redistributing the 811 TMC fairly, prioritizing local needs over diversions outside the basin. Irrigation experts are of the impression that the 904 TMC demand might be a bold starting point for negotiations, but calling it Telangana's "legal right" may amount to overstepping. They are apprehensive that such a demand may appear a flip-flop claim and may weaken Telangana's case if it alienates the tribunal. The focus should stay on the solid 575 TMC claim, backed by data on catchment, drought and violations by Andhra Pradesh

The claim for 904 TMC speaks more about ignorance of the political leadership and its urge to convert water needs into political rhetoric. As hearings begin, Telangana's farmers hope for a fair flow, not political overreach, say irrigation experts. The Krishna River has a reliable yield of 2,130 TMC, though its average flow is 2,578 TMC. Overusing it risks ecological damage, like zero water downstream during droughts.

Hezbollah marks one year since Israel killed then-chief Nasrallah

BEIRUT, Lebanese armed group Hezbollah on Saturday will commemorate one year since its then-chief Hassan Nasrallah was killed by Israel, the opening salvo of a war that ultimately battered his once-powerful group and left swathes of Lebanon in ruins. On the evening of September 27, 2024, a string of Israeli bunker-busting bombs on a Hezbollah complex in Beirut's southern suburbs killed Nasrallah, who had led the powerful Shi'ite religious, political and military group for more than 30 years.

Nasrallah's death and the war that followed dealt huge blows to the Iran-backed group. His heir apparent Hashem Safieddine was killed weeks later. By December, Hezbollah's Syrian ally Bashar al-Assad was toppled. Now pressure is swelling on the group to disarm - a demand Hezbollah has rejected. Nasrallah became secretary general of Hezbollah in 1992 aged just 35 after his predecessor, Sayyed Abbas al-Musawi, was killed in an Israeli helicopter attack. With his fiery speeches, he swiftly became

the public face of a once-shadowy group founded by Iran's Revolutionary Guards in 1982 to fight Israeli occupation forces. He was at the helm when Hezbollah guerrillas drove Israeli forces from southern Lebanon in 2000, ending an 18-year occupation, and declared a "Divine Victory" after the group waged 34 days of war with Israel in 2006, winning Israel defeat their armies. As his group grew to become Lebanon's most influential political and military force, it also developed a regional role as the spearhead of Iran's "Axis of Resistance" - fighting in Syria on behalf of Assad and training Houthis in Yemen. The day after Hamas's crossborder attack into Israel on October 7, 2023, Hezbollah entered the fray in solidarity with its Palestinian ally by firing on Israel from southern Lebanon.

That prompted exchanges of fire for nearly a year before Israel sharply escalated by detonating explosivesrigged communication devices used by Hezbollah, pummelling the country with air strikes and sending troops into Lebanon's south. More than 4,000 people were ultimately killed in Israel's military assault, including more than 300 children. Despite a truce, Israel continues to carry out deadly strikes in Lebanon. Israel's air and ground campaign prevented a formal burial for Nasrallah for months. Followers, including his son, have since flocked to his grave to pray. Crowds are expected to gather in Hezbollah strongholds in the southern suburbs of Beirut, Lebanon's south and east. The group's secretary-general, Naim Qassem, who took over a month after Nasrallah's killing, will make an address. Tensions over the commemoration have been mounting this week, particularly after Hezbollah projected the portraits of Nasrallah and Safieddine on the famed towering rocks off the coast of Beirut. The display went ahead, despite orders by Lebanese Prime Minister Nawaf Salam and the Beirut governor not to do so, angering Lebanese opponents of Hezbollah who said the cliffs should not be

UN sanctions on Iran loom after vote to delay fails

UNITED NATIONS,- GNS News Agency, Oct 11United Nations sanctions on Iran are set to be reimposed on Saturday, Britain's U.N. envoy said on Friday after a Russian and Chinese Security Council resolution to delay them failed, prompting Tehran to warn that the West bore responsibility for any consequences.

The decision to restore sanctions by Western powers is likely to exacerbate tensions with Tehran, which has already warned that the action would be met with a harsh response and open the door to escalation. The Russian and Chinese push to delay the return of sanctions on Iran failed at the 15-member U.N. Security Council after only four countries supported their draft resolution. "This council does not have the necessary assurance that there is a clear path to a swift diplomatic solution," Britain's envoy to the United Nations, Barbara Wood, said after the vote. "This council fulfilled the necessary steps of the snapback process set out in resolution 2231, therefore U.N. sanctions targeting Iranian proliferation will be reimposed this weekend," she said. Iranian President Masoud Pezeshkian told a group of journalists and analysts that Iran had no intention to leave the Non-Proliferation Treaty as a reaction to the revival of the U.N. sanc-

"Iran will never seek nuclear weapons ... We are fully nium," Pezeshkian said. All U.N. sanctions on Iran are due to return at 8 p.m. EDT on Saturday (0000 GMT) after European powers, known as the E3, triggered a 30-day process accusing Tehran of violating a 2015 deal meant to prevent it from developing a nuclear weapon. Iran denies seeking nuclear weapons. Diplomats had said the resolution to delay sanctions for six months had been unlikely to pass, after last-ditch talks between Iran and Britain, France and Germany failed to break a deadlock. Nine countries voted no, while two abstained. Following what it said was European states' "irresponsible" reinstatement of the snapback mechanism, Iran recalled on Saturday its ambassadors to Germany, France and the United Kingdom for consultation, state media reported. Russia's deputy envoy to the United Nations accused the Western powers of burying the diplomatic path. "The U.S. has betrayed diplomacy, but it is the E3 which have buried it," Araqchi told the council, saying the snapback was "legally void, politically reckless and procedurally flawed.""Diplomacy will never die, but it will be more difficult and more complicated than before," he told



reporters after the Security Council meeting. The European powers had offered to delay reinstating sanctions for up to six months to allow space for talks on a long-term deal if Iran restored access for U.N. nuclear inspectors, addressed concerns about its stock of enriched uranium, and engaged in talks with the United States. The U.S. representative at the council said Iran had failed to address E3 concerns meaning a return of sanctions was inevitable, although she left the door open for diplomacy. France said the return of sanctions was not the end of diplomacy.U.N. sanctions would come into force immediately on Saturday, while European Union sanctions would return next week.Iran's economy is already struggling with crippling sanctions reimposed since 2018 after U.S. President Donald Trump ditched the pact during his first term. The sanctions would restore an arms embargo, a ban on uranium enrichment and reprocessing, a ban on activities with ballistic missiles capable of delivering nuclear weapons, a global asset freeze and travel bans on Iranian individuals and entities and would also hit its energy sector. Addressing the U.N. General Assembly earlier on Friday, Israeli Prime Minister Benjamin Netanyahu, whose country bombed Iran's nuclear installations with the United States in June, said the world should not allow Iran to rebuild its nuclear and military programs."We lifted a dark cloud that could have claimed millions and millions of lives, but ladies and gentlemen, we must remain vigilant," Netanyahu told the General Assembly on Friday. "We must not allow Iran to rebuild its military nuclear capacities, Iran's stockpile of enriched uranium. These stockpiles must be eliminated, and tomorrow U.N. Security Council sanctions on Iran must be snapped back,"

Israeli strikes kill 32 in Gaza as Netanyahu rejects ceasefire calls

Deir Al-Balah: Israeli strikes killed at least 32 people across Gaza overnight, health officials said, as international pressure grows for a ceasefire but Israel's leader remains defiant about continuing the war. Strikes in central and northern Gaza killed people in their homes in the early hours of Saturday morning, including nine from the same family in a house in the Nuseirat refugee camp, according to health staff at the Al-Awda hospital where the bodies were brought. The attacks came hours after a defiant Israeli Prime Minister Benjamin Netanyahu told fellow world leaders at the UN General Assembly on Friday that his nation "must finish the job" against Hamas in Gaza.

Netanyahu's words, aimed as much at his increasingly divided domestic audience as the global one, began after dozens of delegates from multiple nations walked out of the UN General Assembly hall en masse Friday morning as he began speaking. International pressure on Israel to end the war is increasing, as is Israel's isolation, with a growing list of countries deciding recently to recognise Palestinian statehood — something Israel rejects.Countries have been lobbying US President Donald Trump to press Israel for a ceasefire. On Friday, Trump told reporters on the White House lawn that he believes the US is close to achieving a deal on easing fighting in Gaza that "will get the hostages back" and "end the war." Trump and Netanyahu are scheduled to meet on Monday, and Trump said on social media Friday that "very inspiring and productive discussions" and "intense negotiations" about Gaza are ongoing with countries in the region.

operation in Gaza City, which experts say is experiencing famine. More than 300,000 people have fled, but up to 700,000 are still there, many because they can't afford to relocate. The strikes Saturday morning demolished a house in Gaza City's Tufah neighbourhood, killing at least 11 people, more than half of them women and children, according to the Al-Ahly Hospital where the bodies were brought. Four other people were killed when an airstrike hit their homes in the Shati refugee camp, according to Shifa hospital. Hospitals and health clinics in Gaza City are on the brink of collapse. Nearly two weeks into the offensive, two clinics have been destroyed by airstrikes, two hospitals shut down after being damaged, and others are barely functioning, with medicine, equipment, food and fuel in short supply. Many patients and staff have been forced to flee hospitals, leaving behind only a few doctors and nurses to tend to children in incubators or other patients too ill to move.

On Friday, aid group Doctors Without Borders said it was forced to suspend activities in Gaza City amid an intensified Israeli offensive. The group said Israeli tanks were less than half a mile from its health care facilities, and the escalating attacks have created an "unacceptable level of risk" for its staff. Meanwhile, the food situation in the north has also worsened, as Israel has halted aid deliveries through its crossing into northern Gaza since September 12 and has increasingly rejected UN requests to bring supplies from southern Gaza into the north, the UN Office for the Coordination of Humanitarian Affairs said. Israel's campaign in Gaza has killed more than 65,000 people and wounded more than 167,000 others, according to the Gaza Health Minis-

Sarkozy jailing reignites debate over French political justice ahead of Le Pen appeal



PARIS,GNS News Agency, Oct 11 - Former President Nicolas Sarkozy's prison sentence has deepened divisions in France over judges' handling of political wrongdoing, months before far-right chief Marine Le Pen attempts to overturn an embezzlement conviction and run for top office. A Paris court jolted the political sphere on Thursday when it handed Sarkozy a five-year sentence for criminal conspiracy over attempts to raise campaign funds from Libya. He will soon become the country's first post-war president to be imprisoned.

Sign up here.Ludovic Friat, the president of the USM, the largest union representing French prosecutors and judges, said the ruling demonstrated that no one was above the law - even if some might choose to guestion the court's motivation. "There will clearly be a before and after this decision," he said. "In high-profile political-financial trials, some inevitably see judges stepping onto the political stage. What I regret is that ... too often, this becomes a smokescreen that diverts attention from the offences actually committed."As Sarkozy left court, he reiterated his innocence, and said the ruling would undermine faith in France's judiciary."What happened today ... is of extreme gravity in regard to the rule of law, and for the trust one can have in the justice system," he said. Sarkozy's prison sentence is enforceable immediately, with the former president given a short time to put his affairs in order, but not allowed to avoid prison pending an appeal as some French politicians have done in the past. Appeals can take years, fuelling a sense of impunity for those in power, so judges are increasingly handing out "provisional execution" sentences that start immediately, lawyers and politicians have told Reuters."For several decades, there has been a growing democratic demand for integrity among elected officials," Judith Allenbach, the president of another judicial union, told Reuters.

She said 89% of jail terms over two years were enforced ahead of any appeals process and that judges were enacting laws passed by parliament mandating tougher sanctions for this type of crime.Le Pen, the far-right leader of the National Rally (RN) party, was also given a "provisional execution" in March, when she was convicted of embezzling EU funds. She got a five-year political ban that bars her from running in the 2027 election.Le Pen, whose January appeal will determine whether she can run in 2027, said Sarkozy's conviction showed that "the generalisation of provisional executions by certain jurisdictions represents a great danger." Judicial sources said Le Pen and Sarkozy's cases are distinct, and it is impossible to say how one might influence the other. Friat said the Sarkozy ruling showed judges are not wavering in their fight against political crime."I can understand her concern," he said of Le Pen, while emphasising that he did not know what the appeals court would decide.Le Pen's allies say right-wing politicians receive harsher treatment from judges, highlighting the case of former centrist Prime Minister Francois Bayrou, who was acquitted of fraud last year over the alleged misuse of EU funds.Le Pen's plight also caught the attention of U.S. President Donald Trump, who said she was a victim of "lawfare" and sent a diplomatic delegation to offer support. Brigitte Bareges, a right-wing former mayor, was convicted of embezzlement in 2021, and given a five-year political ban with "provisional execution." She was acquitted on appeal."What we see today is that the justice system - or at least a part of it - has become the weapon of those in power," she said. Trump slaps steep US tariffs on drugs, heavy trucks and furniture

WASHINGTON, GNS News Agency, Oct 11 U.S. President Donald Trump on Thursday unveiled sweeping new import tariffs, including 100% duties on patented drugs and 25% levies on heavy-duty trucks starting next week, triggering fresh trade uncertainty after a period of comparative calm. The latest salvo, which Trump said was to protect the U.S. manufacturing industry and national security, follows wide-ranging duties on trading partners of up to 50% and other targeted levies on imported products such as steel and autos. Trump's announcement on Truth Social of the steep duties that go into effect on Wednesday shattered a relative lull in his tariff assault on global trading partners, throwing new obstacles at businesses already struggling with disrupted supply chains, soaring costs and consumer uncertainty. His new duties included a 50% tariff on imported kitchen cabinets and bathroom vanities, as well as a 30% levy on upholstered furniture, raising costs for a core consumer sector. Trump's administration pressed forward over the summer with trade deals to ease tariffs for some key partners, including Japan, the European Union and South Korea. Questions swirled on Friday whether these would protect countries from the higher sectoral tariffs. A White House official said the administration would honor 15% caps on tariffs for imported pharmaceuticals under patent for countries with trade deals that specified such reductions.for drugs, semiconductors and autos, but no documents have been issued for a South Korean trade deal, leaving its cars still subject to a 27.5% total U.S. tariff. There were no explicit trade deal provisions to cap tariffs for heavy trucks or furniture for any trading partners. Trump targets Microsoft Global Affairs head Lisa Monaco, calls for firing

New Delhi: US President Donald Trump urged Microsoft Corp. to dismiss its Head of Global Affairs Lisa Monaco, labelling her as "corrupt," "deranged," and "a menace to US national security". On President Trump's social media account, Truth Social, he claimed that Monaco's senior position at Microsoft, a company with significant government contracts, provides her access to sensitive information that he believes she cannot be trusted to handle.

Trump wrote that he's already stripped Monaco of security clearances and prohibited her from accessing federal properties. "After successfully manipulating Intel CEO Lip-Bu Tan and eventually failing to cancel Jimmy Kimmel, President Donald Trump has named his next target for retribution: Microsoft head of global affairs Lisa Monaco," said a report from Verge. Monaco took the job in May at Microsoft and is since leading the company's global government engagements following a long career in public service. She served as the 39th deputy attorney general under former US President Joe Biden and AG Merrick Garland, which "seems her biggest crime in Trump's eyes," the report



said. It's not clear why Trump took this moment to go after Monaco, but he may be just now becoming aware of her role at Microsoft, the report added. The report also hinted that Microsoft has not exactly been in Trump's crosshairs, but the company recently reduced the scope of its cooperation with the Israeli military as it performs mass surveillance of Palestinian civilians.

Rachael Haynes backs India to do well at the ICC Women's ODI World Cup, predicts Australian, England and South Africa to make the semifinals



Rachael Haynes belongs to an extraordinary league of women that made the Australian cricket team the greatest in history. She was the first player to retire from that golden generation. The 38-year-old is a winner of two ODI and four T20I World Cups. After making 98 on her Test debut at No. 7 against England at Worcester in 2009, the left-hander moved up the order. She served the Australian toporder with distinction for the best part of a decade. She was also a brilliant fielder who came up with some stunning catches. She captained Australia during the team's successful defence of the Ashes in 2017. Excerpts from an exclusive interview Haynes gave The Hindu at New Delhi:

You have been to India on several occasions, as player, coach and television commentator. Women's cricket has changed a lot in India, hasn't it?

Yeah. I was here for the WPL. I got to be part of that first season [2023] and that was a really exciting tournament to be part of. It has been a couple of years, and it is nice to be back, though in the commentary box, in a bit of a different role. I think the India-Australia series has been a really interesting one to follow because both of these sides are obviously tuning up for the World Cup. It has been interesting to see them find the right combinations and also, I suppose, build that rivalry that we know India and Australia have. And India is probably the second best team in the world.I think they are a team with momentum at the moment and that's really important heading into a big tournament. How do you look back at the experience in the WPL? You were part of the inaugural WBBL back in Australia as well. I suppose it was really different to Season One of WBBL that I was part of. The game has come such a long way over that time. And yeah, I suppose there was a lot of noise about India having a version for the women. When they eventually introduced the tournament, I mean, hats off to them. They did a wonderful job in creating a real spectacle, obviously drawing some of the best players in the world to the tournament. And it was done in a little bit of a different style, you know, with the auction format for players. And for a change, there was really good money in

That is right. And I am sure the players, you know, before the current players have laid a really nice foundation, I suppose, for this generation to be able to step into and enjoy a bit of financial reward. You joined Gujarat Giants as the head coach in the first WPL. But you had a big setback when your captain and best player Beth Mooney got injured in the very first match and had to pull out from the tournament.

Beth picked up that calf injury and it is not easy to replace a player like that. To lose both her keeping and her batting, it is effectively two skills in a team, which threw our balance out a little bit. But that is part of elite sport; that happens. And yeah, we just weren't able to quite get going

after that first match. But all in all, it was really great to work with the local players. And in the WPL's inaugural match at Navi Mumbai, Harmanpreet Kaur played that blinder to lead Mumbai Indians to a huge victory. She also played one of the finest ODI innings, against Australia in the 2017 World Cup semifinal at Derby.I wasn't playing in the match, but I was on the bench that day. And it was just some of the most phenomenal hitting I have ever seen. The ball-striking was amazing. It didn't matter what Australia tried to do to counteract it, she had an answer. And that innings was no exception. She is a fantastic player. And I have had the opportunity to play alongside her as well at the Sydney Thunder in the WBBL.But in the next edition in 2022, Australia regained the World Cup, and you made 68 in the final against England at Christchurch and had a big partnership with Alyssa Healy for the first wicket.

It was great. Alyssa was absolutely smoking the ball and playing wonderfully. So I basically just put myself down at the other end. But yes, it is nice to contribute in big tournaments and I suppose to go on and experience that team success together. How do you look forward to the World Cup starting here in India on September 30? You wouldn't mind an India-Australia final perhaps?

I would absolutely love to see that. This is a real opportunity for the Indian side. You know, it's a huge privilege to play in a home World Cup and to have that support around. And we certainly experienced that in the T20 World Cup in Australia back in 2020. That was easily the most rewarding and fun tournament I have ever been part of as a player: we played that final at Melbourne in front of 86,000 people that supported us.

Apart from Australia and India, who do you think could make the semifinals?

I think England will be there. You know, Charlotte Edwards is such a fantastic coach and they will have Heather Knight coming back into their team. And I think South Africa will get through, just.

What makes this Australian side, of which you were a part until three years ago, so good?

I think one thing the squad and the selection and coaching group have done well is make sure they are always giving younger players an opportunity around the environment. They have brought Nicole Faltum and Charli Knott, who are sort of performing well in domestic cricket.

How do you view the changes the women's game has seen since the time you started out?

I think the game has just continued to evolve, and that has coincided with an increased investment from a lot of different boards around the world. So Australia, England and India are probably really leading the way in that respect. The success of the national side is really underpinned by the strength of your domestic programme, and there is no coincidence from my point of view that the top three teams in the world at the moment are well-funded and have good, strong domestic structures. I suppose in fairness to New Zealand, they are the current T20 World Cup holders. But a lot of their players end up on that sort of domestic circuit around the world.

National Centre for Divyang Empowerment gives jawans injured in line of duty a fighting chance

Until a year ago, Amit Kirtaniya, 33, would tremble with fear every time he heard the sound of a utensil dropping on the floor. The clatter would disrupt his sleep and bring back traumatic memories. On June 5, 2023, Kirtaniya, a constable with the Central Reserve Police Force (CRPF), and two of his colleagues were patrolling the hills of Bijapur district in Chhattisgarh after receiving information that Maoists were on the move. Suddenly, there was an explosion. "We were thrown in the air in different directions," Kirtaniya recalls.

The three men lay bleeding on the hill. A few hours later, a rescue team arrived and flew them by chopper to a government hospital nearby. The area had been filled with Improvised Explosive Devices (IED), Kirtaniya says. Having stepped on one, he lost both legs, sustained 95% physical disability in his right arm, and lost vision in his right eye. "A day later, I was airlifted by an air ambulance to Delhi's All India Institute of Medical Sciences (AIIMS) where I was admitted for 15 days," he says. "I was awake and conscious. The doctors sought my permission to amputate my legs above the knee. I had watched a viral video which gave me hope that I would be able to walk again with artificial limbs. So, I agreed."

The CRPF, one of the seven Central Armed Police Forces (CAPF) in India, helped him get artificial limbs last April at the National Centre for Divyang Empowerment (NCDE) in Hyderabad. Divyang, which means divine body part, was a term introduced by Prime Minister Narendra Modi in 2015 to refer to persons with disabilities. Located at the CRPF Group Centre in Hakimpet, on the outskirts of Hyderabad in Telangana's Rangareddy district, the NCDE is the only facility of its kind in the country. Conceived by former CRPF chief, Dr. A.P. Maheshwari, and inaugurated in December 2020, the NCDE is an exclusive facility for training CAPF personnel who suffer injuries and become physically challenged in the line of duty. In just five years. the NCDE has trained over 219 'Divyang warriors', as they are called on campus, producing medal-winning para athletes and skilled IT professionals. Infrastructural support The NCDE has a sprawling campus. It has about 180 barracks, each divided into 10x10 feet cubicles fitted with a table, chair, wardrobe with adjustable handles, a motorised bed, a shoe rack, and a window. Of the barracks, more than 100 are wheelchair-friendly, complete with attendant support. It is common to see Divyang warriors rise from their wheelchairs to salute superiors. The campus is equipped with wide ramps and elevators, and motorised buggies and vans to ferry trainees across its grounds. A hospital behind its main complex was built to handle emergencies. The Renault Group, a French multinational automobile manufacturer, has pledged motorised wheelchairs, sports chairs, and a bus by November 2025, signalling further expansion of mobility support to the personnel on campus. Kirtaniya says the artificial limbs were uncomfortable at first, but have now become a part of him. "I remove them while resting or sleeping. It takes 5-7 minutes to wear the entire gear, which re-

quires servicing too. In the monsoon season, the equip-

ment retains moisture and needs further maintenance," he says. The constable, who used to trek for miles in jungles wearing a bulletproof jacket and carrying a gun, has been training to be an archer at the NCDE for the last one and a half years. His batch consists of 20 trainees. Seven of them have already been selected for national games ranging from archery to discus throw. The trainees are also provided skill development classes in IT, which are run in collaboration with BITS Pilani.Kirtaniya's efforts have resulted in some success. The father of two children won two medals — a bronze and a silver — at the Khelo India Para Games this year. He is happy, but says he misses the jungles. "I trained to be a fighter, but now I am a sportsperson," he says. The physical training infrastructure at the campus is comprehensive. A ramp leads to a fully equipped gym, tailored for the needs of persons with disabilities, with specially designed machines calibrated to their strengths and requirements. Physiotherapists guide them through sessions that focus on improving gait, strengthening arms, and shedding excess weight gained during recovery. Separate physiotherapy rooms offer focused exercises to restore mobility. At a meditation hall, two daily sessions of deep relaxation, mindfulness, and progressive muscle relaxation are conducted to reduce stress, anxiety, and minimise trauma. The counselling wing, led by specialists, focuses on post-traumatic stress disorder and trauma care. The wing also often handles cases of candidates who feel suicidal. "Our goal is to instil confidence in the people here so that they can lead a dignified life even with a physical disability," says Dr. K. Nagarjuna, a clinical psychologist at the wing. The risk of dangerous operations The CRPF is the main force deployed for anti-Maoist operations. In the 38 districts in India affected by Left Wing Extremism (LWE), 15 were located in Chhattisgarh in 2024. Following a directive by the Union Ministry of Home Affairs, security forces have intensified operations in LWE-affected States, particularly Chhattisgarh, since 2023. Continuous operations have led to a sharp decline in LWE-affected districts from 126 in 2013 to 18 districts in April 2025. Four of the six most affected districts are in Chhattisgarh, according to data from the Ministry. However, these operations have also led to many grievous injuries. Since 2016, at least 46 CRPF personnel have lost limbs in IED explosions in LWE-affected areas. In 2023, 10 personnel had to undergo amputations as their limbs were damaged in explosions. On July 27, Union Home Secretary Govind Mohan said that CAPF personnel who get severely injured during operations and have to undergo amputation will be allowed to continue in service until retirement with all the benefits. Mohan said the government will ensure that the best medical facilities and technology are available for limb replacement surgery for CAPF personnel. Until July 30 this year, the NCDE had facilitated the fitment of 106 artificial limbs while 135 fitments are under process. Rehabilitation includes personnel who suffer bullet wounds and injuries from road accidents while on their way to duty or on leave.

Beyond maternity leave: Reintegration is the real test of inclusion for mothers



the workforce come up, maternity leave and related challenges is always a point of contention. However, the real challenge is not the leave itself, but the noise and clutter around it. Streamlining the entire journey and experience, from pregnancy to reintegration into the workplace, determines whether women remain, prosper, or quietly depart. According to the Marching Sheep Inclusion Index 2025, 63% of listed Indian companies do not have women in Key Managerial Positions (KMP). Representation thins out as roles become senior. Another stark reality: multiple studies show that nearly 46% of women in India drop out of the workforce within two years of maternity. Motherhood is still among the largest reasons why women drop off the corporate ladder. These statistics are important because they identify where the talent pipeline starts thinning. The pressures new mothers face

To really understand why so many women step away from work after motherhood, we have to peel back the layers of pressure they carry every single day. Family expectations: In most households, it's still presumed that caregiving is a woman's natural responsibility. Even if both parents are employed, majority of the household chores and caregiving usually fall on the mother. Extended families, though supportive in many ways, can sometimes perpetuate the gender norms: "The child needs the mother more."Societal norms: The stereotype of a good mother is too often defined as one who is always available for the child and takes care of nutrition, academics, hobbies, and everything. Anything less leads to guilt, feeling inadequate. Pursuing professional goals with full focus after childbirth seems like an uphill task. Whether or not openly criticised, new mothers find themselves constantly defending their choices, to neighbours, relatives, even friends. Struggles within: In addition to what others may want, there is also the inner struggle. Long sleepless nights, physical fatigue, and the bouts of emotions that accompany motherhood make new mothers question themselves. Most question: "Am I selfish in prioritising my career? Will my child suffer?" Guilt and self-doubt becomes a constant companions. Organisational systems: Then there's the workplace. Coming back to work after maternity leave is supposed to be like homecoming, but it feels more like entering a war zone. Inflexible policies, no work flexibility, no access to childcare and sometimes even apathy from managers and team seems like being alone. True, the mother has been away for six months or more, and the team would have shared the extra workload and they would have waited for her to return, but now that she is back, what next? The truth is, women don't drop out because they can't cope. They drop out because the world around them makes it far harder than it should be. The ripple effect of dropouts The impact of working women exiting workplaces is not invis-

• For organisations: Trained talent is lost, business continuity suffers, and replacement costs add up. A Deloitte report estimated that replacing a mid-level employee costs anywhere between 150–200% of their annual salary. Culture also takes a hit when women disappear from leadership pipelines.• For the economy: India's female labour force

participation rate is about 37% in 2024 (PLFS data), one of the lowest among emerging economies. If women participated at the same rate as men, India's GDP could rise by nearly 27% (McKinsey Global Institute). Dropouts stall this growth.. For society: Every time a mother leaves the workforce, stereotypes about women not lasting long in careers get reinforced. This slows down progress on gender parity. Even international research points to the same trends. It is estimated that by 2023, 40% women will either be single or choose not to have children. In India, with increasing number of women delaying to get married or even putting off marriage or having children at an older age, the demand for greater workplace support becomes even more pressing. What organisations can controllt is true that companies cannot rewrite family dynamics or erase social expectations overnight. But they do have a circle of control and that is where the biggest difference can be made.

 Train and sensitise managers to respond with empathy when a woman announces her pregnancy and returns from maternity leave. • Create systems that enable women to transition back without penalty on role, increments or bonuses. When companies proactively manage this integration, the impact does not remain confined to the office. It sends a signal to families, to society, and to young women entering the workforce that careers and motherhood can co-exist. Handling the journey not just the leave The return to work is not a single event. It is a journey that begins the day a woman shares her pregnancy news and continues until she feels fully integrated again. The moment of disclosure matters: If the manager reacts with worry or disappointment, women tend to hide or delay the news. This creates fear and uncertainty about the future role and career. A response rooted in curiosity, empathy and reassurance sets a different tone. Policy support is critical: Flexible hours, phased return options, childcare facilities, and support for remote work help women transition at their own pace without impacting role, deliverables and accountability. • Addressing the emotional layer: Many women experience imposter syndrome "Am I good enough anymore?" Coaching, counselling, and peer support groups can help deal with this emotional turmoil. • Active listening: HR and managers must tune in to subtle signals of distress. Withdrawal, hesitation, or declining participation in meetings are clear signals of waning engagement and need to be addressed. • Role models matter: Women who see seniors balancing motherhood and leadership are more likely to believe that their own careers are sustainable. When organisations view maternity as a complete journey from pregnancy to reintegration they retain not just employees, but also their trust. Retention: When women feel seen and supported, and set up for success after maternity, they stay. They grow professionally and climb ladders instead of stepping away from them.Productivity: A mother who returns to a workplace that offers flexibility and trust brings with her an incredible sense of focus and resilience. With the appropriate systems in place, a mother doesn't merely come back, she flourishes. Profitability: According to Marching Sheep Inclusion Index 2025 firms with higher women representation in senior positions don't merely look good on paper, but they actually perform better. Reputation: How an organisation treats a returning mother during this critical stage becomes part of its brand's identity. Therefore, the message is clear: A company shouldn't just hire talent, but must stand by it. That reputation draws in not only women but talent of every gender who value fairness and humanity at work. Ultimately, the question is simple: Do we want maternity to be the point where careers stagger, or do we want it to be just another phase in a thriving professional journey? India's workforce cannot afford the loss of talent that happens when mothers leave. Reintegration is not charity, nor is it policy on paper. It is about building a workplace where women do not feel like they are returning after a break because they never

Why degrees alone won't build India's workforce



India's education system has expanded dramatically in recent years, democratising access across geographies and social groups. But while degrees have become more accessible, employability has not. Each year, over 10 million students graduate, yet, fewer than half meet industry-defined benchmarks for job-readiness. This gap is not a reflection of low aspiration or poor intent. It is a systemic issue rooted in how we define, deliver, and measure education.

DisconnectThere is a dangerous illusion that completing a degree is the same as building a career. For many young people in India, especially in smaller towns, higher education is treated as an automatic gateway to employment. However, only 8.25% of graduates find jobs related to their field of study. Most are either left underemployed or pushed into unrelated roles, not due to lack of intelligence, but due to lack of direction.

Our education system remains syllabus-driven and exam-oriented, rarely aligned with actual market needs. The result is a generation of graduates, confident in theory but underprepared in application. In sectors like engineering, the disconnect is even sharper, with over 80% of graduates deemed unfit for core roles. A critical gap in India's education-to-employment journey is the absence of hands-on exposure. With limited industry touchpoints, especially in non-metros, students graduate without workplace awareness, communication skills, or portfolios that recruiters expect as a baseline. This is further widened by an ecosystem that rewards course completion and enrollment numbers, not placement outcomes. Institutions have little incentive to build employer networks, integrate applied learning, or support structured mentorship. Students are left navigating the most critical phase of their lives — career launch — largely on their own.Looking ahead

The way forward lies in rethinking education not as a product but as a full-stack system that drives employment. This means introducing students early to the landscape of career possibilities through localised, relatable role models

and vernacular resources. Skilling must follow, but in industry-aligned formats that are accessible and affordable. Mentorship should no longer be optional. It must be embedded through digital coaches, alumni engagement, and structured guidance that helps students match their strengths to the right opportunities. Finally, placement support must go beyond urban job portals. We need regional placement ecosystems that reflect local economic realities, connecting graduates to jobs in BFSI, digital services, logistics, healthcare, and beyond. Job creation isn't a peripheral goal; it is the test of whether our education system works. If education is reimagined as a system, it must be wired into demand, employer partnerships, local enterprise incubation, and clear employment pathways. This means creating jobs and not just churning out graduates. India's edtech sector has a critical role to play in enabling this transformation. But the entire focus needs to shift from enrollments to measurable, long-term outcomes. We can no longer measure progress by scores or degrees alone. The real metric is 'how many young Indians find jobs that align with their skills'? It is time we stopped asking, "How many graduated?" and start asking, "How many progressed?" It is not the certificate that secures the future; it is the path-

ESIC payroll data: over 20 lakh new employees enrolled in July

New Delhi: At least 20.36 lakh new employees were added in the payroll data of Employees' State Insurance Corporation (ESIC) in July, an increase of 4.86 per cent from 19.37 lakh new workers enrolled in June, an official statement said on Friday.

Over 48 per cent of new registrations comprise young people under 25 years of age, according to a Ministry of Labour and Employment statement. About 31,146 new establishments have been brought under the social security ambit of the ESI Scheme in the month of July, thus ensuring social security to more workers. "It is noticeable that out of the total 20.36 lakh employees added during the month, 9.85 lakh employees amounting to around 48.37 per cent of the total registrations belong to the age group of up to 25 years," the statement said. The gender-wise analysis of the payroll data indicates that net enrollment of female members has been 4.33 lakh out of the total 20,36,008 employees added in July. Moreover, a total of 88 transgender employees have also been registered under the ESI Scheme in July, which attests to the commitment of ESIC to deliver its benefits to every section of society.

Building health for 1.4 billion Indians



India's health-care system stands at a defining juncture. The task is dual: expand access for the millions who are underserved, while ensuring affordability amid rising costs. This needs an integrated framework, strengthening insurance, leveraging scale, embedding prevention in primary care, accelerating digital adoption, enabling regulatory clarity, and unlocking sustained investment. Through a systemic, interconnected approach, India can build a health-care model that is inclusive, financially viable, and globally aspirational.

Insurance as the foundation of affordabilityPooling risk remains the most effective way to make costly care accessible. Even modest premiums — ?5,000 to ?20,000 for individuals or ?10,000 to ?50,000 for families — can unlock coverage worth several lakhs, shielding households from catastrophic financial shocks. Yet, penetration remains low: only 15%-18% of Indians are insured, with the premium-to-GDP ratio at 3.7% compared to the global average of 7%. The gap is significant, but so is the opportunity, as gross written premiums already stand at \$15 billion in 2024 and are projected to grow at over 20% CAGR till 2030. Affordability cannot rest on insurance alone. True impact comes when payers, providers and patients partner, expanding coverage, embracing prevention and making insurance a tool for everyday health security, not just a crisis shield.India's health-care system has mastered something that the world is only now beginning to appreciate — delivering quality care at extraordinary scale. Where an MRI in the West may handle seven to eight scans a day, in India the same machine manages many times that volume. This ability to stretch resources without diluting quality is not coincidence. It is the product of decades of ingenuity in doctor-patient ratios, workflow design, and infrastructure use.

The next leap is clear: extend this efficiency to India's vast heartland. Tier-2 and tier-3 cities remain underserved, yet they represent the true frontier. If India can replicate its urban efficiency in these geographies, it will not just close the access gap. It could set a global benchmark for how scale, innovation and inclusion can reshape health care. Schemes such as Ayushman Bharat (Pradhan Mantri Jan Arogya Yojana, or PM-JAY) have redefined access. Covering nearly 500 million people, with ?5 lakh a family for advanced care, PM-JAY has enabled millions of cashless

treatments in both public and private hospitals. Its impact is visible: timely cancer treatments for beneficiaries have increased by nearly 90%. Expanding private hospital participation in government-backed schemes is essential to reach the next 500 million. But this must be anchored in fair reimbursements and transparent processes, ensuring viability for providers and real value for patients. A study in Punjab revealed a stark reality — even insured families faced catastrophic expenses on diabetes, hypertension, and other noncommunicable disease (NCD) outpatient care. The solution is two-fold: redesign insurance to include outpatient and diagnostics, and launch a nationwide push for prevention. But this is incomplete without public participation. Alongside payers and providers, people must embrace a preventive mindset — controlling risks, staying alert and raising awareness. Every rupee in healthier lifestyles saves multiples in treatment. If schools, employers, communities and citizens rally behind prevention, India can blunt the looming tsunami of NCDs and secure a healthier future. India was early to adopt telemedicine and is now pushing boundaries with Artificial Intelligence. Tools that detect early signs of sepsis, triage diagnostic reports, or enable remote consultations are already in practice. These innovations not only improve patient outcomes but also optimise the productivity of doctors and nurses. Digital health is also democratising access. Remote consultations mean that a cardiologist in a metropolitan city can guide treatment for a patient in a village that is hundreds of kilometres away. Combined with the government's Ayushman Bharat Digital Mission, such innovations could enable universal health records and continuity of care across the country. Regulation and trust as the missing linkHealth-care innovations are promising, but challenges persist. Insurers in New Delhi are considering a 10%-15% premium hike due to pollution-driven respiratory illnesses which shows how environmental factors raise healthcare costs. Without safeguards, such pressures could hit affordability for millions. This is where regulation is crucial. The Finance Ministry has urged the Insurance Regulatory and Development Authority of India (IRDAI) to strengthen claims of settlement and grievance redress, recognising that trust drives insurance penetration. Without confidence in fair and transparent claims, households will not prioritise health insurance. Robust regulation, paired with fair pricing, is essential to deepen coverage and build confidence

In 2023, India's health sector drew \$5.5 billion in private equity and venture capital, fuelling digital health, pharmacy networks, and hospitals. But capital remains skewed toward metros. The true test is directing this to tier-2 and tier-3 cities, building primary networks, and training specialists so that growth translates into inclusion. India's health care is at an inflection point. Insurance must cover everyday care, providers must scale efficiently, prevention must cut long-term costs, and technology must drive access. With aligned investment and bold public-private partnerships, we can design a system that is not episodic or exclusionary, but universal, resilient, and sustainable. Health care must move from being a privilege to becoming every Indian's right.

Which sectors are worst hit by U.S. tariffs?

The 50% tariffs imposed by the U.S. on imports from India came into effect on August 27, sending ripples through the Indian economy and the government. Several sectors, many of them labour-intensive, have the U.S. as a major export destination, and many are already seeing a significant dip in demand. The government is cognisant of this and is devising a plan to support these sectors, at least in the short term.

How do we know which sectors will be worst affected?

The intensity of the impact of tariffs can be arrived at by looking at three metrics in combination: the amount exported to the U.S. in absolute terms, the share of the U.S. in that sector's total exports to the world, and the final tariff that sector is facing. If a sector exports a large amount to the U.S., the U.S. forms a major part of its total exports, and the tariffs are high, then the pain felt by that sector will likely be high. However, if the U.S. forms a small share in a sector's total exports, then the impact is likely to be limited.

Which sectors are likely to see a severe impact?

According to data from the Ministry of Commerce and Industry, India exported about \$2.4 billion worth of shrimp to the U.S. in 2024-25, making up 32.4% of its total shrimp exports. Earlier, the U.S. only imposed a 10% countervailing tariff on shrimp from India. However, the addition of the 50% tariff now takes this total to 60%. Reports indicate that exporter purchase prices of shrimp in Andhra Pradesh — the source of the majority of India's shrimp — fell by about 20% following the 25% tariff imposed on August 7. Prices are likely to fall further due to the current 60% tariff.India exported \$10 billion worth of diamonds, gold, and jewellery to the U.S. in 2024-25, accounting for 40% of total exports in this sector. Tariffs have now risen from 2.1% to 52.1%. Reports from hubs like Surat already show that production cuts are underway. Surat's diamond polishing industry itself employs about 12 lakh people. One of the worst-hit sectors is likely to be India's textiles and apparel exports sector. These exports to the U.S. stood at \$10.8 billion in 2024-25, with apparel alone accounting for \$5.4 billion. Further, the U.S. accounts for 35% of India's apparel exports. The sector now faces a 63.9% tariff, up from the previous 13.9%. "Tiruppur exporters are rushing shipments while cancelling new styles," said the Global Trade Research Initiative (GTRI) in its report. "Noida-Gurugram has frozen planned capacity expansions and is considering downsizing, Ludhiana reports a slump in yarn and fabric demand, with working capital under stress, and Bengaluru units are preparing for shift cuts as buyers push for offshore production."India exported \$1.2 billion worth of carpets to the U.S. in 2024-25, which makes up 58.6% of total carpet exports. Tariffs have increased from 2.9% to 52.9%. Other significantly affected sectors include handicrafts, leather and shoes, furniture and bedding, and agricultural products such as basmati rice, spices, tea, pulses, and sesame.

Which sectors will see a more modest impact?

India's export of organic chemicals to the U.S. stood at \$2.7 billion. This made up 13.2% of India's total exports. The sector now faces 54% import tariffs, up from the previous 4%. The exporters' body, CHEMEXCIL, and industry bodies have already approached the government for some intervention. India exported \$4.7 billion worth of steel, aluminium, and copper to the U.S. in 2024-25, about 17% of India's total exports of these metals. "While the U.S. is not the largest market for Indian metals, it is critical for hundreds of SMEs in the Delhi-NCR engineering belt and eastern foundry hubs," GTRI said. "The tariff threatens to disrupt jobs in stainless steel, aluminium casting, and copper semi-finished goods, putting severe pressure on small and



medium exporters reliant on U.S. orders."India exported \$6.7 billion worth of machinery and mechanical appliances to the U.S. in 2024-25, making up 20% of its total exports. This sector is also expected to face a drop in demand.

Is the government planning to help these sectors?

Prime Minister Narendra Modi and Commerce and Industries Minister Piyush Goyal have been repeating the 'swadeshi' mantra and asking Indians to 'go vocal for local', so that the economy can reduce its dependence on exports. Apart from this, The Hindu reported on August 13 that the government is working on a multi-ministry plan to ease the short-term pain of exporters. In the medium to long term, the government is working with exporter bodies to diversify their export destinations and make better use of existing free trade agreements. The Reserve Bank of India Governor Sanjay Malhotra has also said that the central bank stands ready to provide whatever help it can.

India win SAFF U17 Women's Championship with 5-0 triumph over Nepal

Hyderabad: India stamped their authority with a commanding 5-0 victory over Nepal at the Changlimithang Stadium in Thimphu on Friday to clinch the 2025 SAFF U17 Women's Championship title in style. The victory lifted India to 15 points from five matches, an unassailable lead at the top of the table. Bangladesh's slip-up earlier in the day (a 1-1 draw against hosts Bhutan) ensured the title for India.Pearl Fernandes (15', 43') and Divyani Linda (79', 90+2') both scored a brace, while Nira Chanu Longjam (5') netted the opener. From the opening whistle, India dominated completely. The ball rarely entered their half as wave after wave of blue shirts pressed forward, pinning Nepal back and keeping the action away from goalkeeper Munni. The floodgates opened early when, in the fifth minute, Nira Chanu struck from a set-piece, guiding the ball cleanly into the net. Ten minutes later, she turned provider, curling a cross into the box for Pearl Fernandes to finish with composure. India continued to pile on the pressure with sharp movements and fluid attacking play. Just before half-time, in the 43rd minute, a Divyani cross found Pearl, who swept home her second goal. The second half began scrappily, with chances, offsides and near misses, before India struck again. In the 79th minute, Shveta Rani delivered a deep cross that Bonifilia Shullai flicked goalwards, allowing Divyani Linda to finish at the line.India closed the game smartly thereafter, and in added time, Divyani once again rose to the occasion, sliding in an

Property registration fee doubled in Karnataka from 1% to 2%



Property registrations in Karnataka are all set to get dearer from this weekend. The State government on Friday doubled the registration fee for all properties from 1% to 2%. This move comes in the context of the Department of Stamps and Registrations falling severely short of revenue targets both in 2024-25 and the first quarter of 2025-26. The State used to levy a stamp duty of 5% of the guidance value of a property, 1% registration fee, 0.5% cess and 0.1% surcharge, adding up to 6.6%. With the registration fee now doubling to 2%, the total fee payable for any property transaction is 7.6% from August 31, Sunday. Among the lowestMullai Muhilan M.P., Inspector-General of Registration and Commissioner of Stamps (IGR&CS), Karnataka, told The Hindu that despite this hike, the total fee payable

for any property transaction in Karnataka is among the lowest among all neighbouring States in South India. For instance, in Tamil Nadu it is 11%, he said. The government order issued on Friday also doubled the registration fee for Joint Development Agreements (JDA) and General Power of Attorney (GPA) for JDAs from 1% to 2%. The impact of this is expected to be big, as these are usually large parcels of land and will impact the real estate sector dear. The realty sector has been slow for multiple quarters now. As against an initial revenue target of ?26.000 crore, the department collected only ?22,500 crore in 2024-25 and in the first quarter that ended on June 30 the Department has fallen back by 35% against the proportional target for the year, set at an ambitious ?28,000 crore. Criticism from builders Builders blame this on the e-Khata mandate for property transactions which they term a "bottleneck", among other factors. They argue that doubling registration fee is not the answer to missing revenue targets. While there was a proposal to increase the stamp duty by 1%, following a performance review meeting of the Department of Stamps and Registrations chaired by Chief Minister Siddaramaiah in June earlier this year, the decision was taken to hike registration fee by 1%. Karnataka continues to be one of the few States to impose a lower stamp duty of less than 6%. Asked what is the additional revenue expected through this hike, Mr. Muhilan said they were working towards achieving the revenue target set, but did not put a number

Can an AI image-to-video feature put children at risk?

On June 22, Reddit co-founder Alexis Ohanian posted a childhood photo of his mother and himself. In the picture, both are wearing red sweaters while hugging each other against a mountain backdrop. Alongside the image, Mr. Ohanian posted an Al-generated video that brought the picture to life: the mother and child cuddle each other as the wind ruffles their hair. "Damn, I wasn't ready for how this would feel. We didn't have a camcorder, so there's no video of me with my mom," posted Ohanian on X (formerly Twitter). "I dropped one of my favorite photos of us in midjourney as 'starting frame for an Al video' and wow... This is how she hugged me. I've rewatched it 50 times."

The post quickly went viral, and garnered well over 20 million views. While many empathised with Mr. Ohanian's act of turning a cherished family photo into a video, he was also severely criticised. Many X users accused him of creating "false" memories, damaging his ability to grieve his mother in a healthy way, or seeking comfort in an interaction that he manufactured. The capacity to turn images into videos is not limited to tools like Midjourney. In recent weeks, multi-billionaire Elon Musk announced 'Grok Imagine' for users to generate short videos from text/image prompts. Google, in July, rolled out 'Create' mode in its Photos app to transform photos into short videos for U.S.-based users. There are also other, smaller platforms that offer to turn users' photos into Al videos. Al tools have been used for years to enhance old media through a process called Al upscaling: removing blurred parts, pixelation, and grain to deliver better output. While GenAl has made this process faster and easier, it also allows users to morph and manipulate images with advanced tools that can remove objects and fill in

The jump in technology comes with legal questions to consider, as permission is usually required before making any significant edits to a copyrighted creation. Furthermore, ethical conundrums also arise when a person manipulates a photo featuring someone who is no longer alive. Significantly, more users need to consider the impact on the photo's most vulnerable subjects — children.Children's rights and safety at riskFor instance, cybercriminals can now rapidly create realistic Al videos of minors by using their publicly available photos with ease. In the past, criminals have targeted minors by generating synthetic nude photos of them to extort money. One such case in the U.S. led to a teenager dying by suicide. His family was not aware that the child was being harassed. Data protection lawyer and Al specialist Kleanthi Sardeli, who works with the Vienna-based NGO noyb and advocates for consumers' digital rights, said that turning still images into video clips could be done for innocent reasons but that there are "serious implications" to consider as well. "The lower the barriers to creating realistic content, the more we also need to think about ethics, consent and context. A photo can be turned into a convincing video without the knowledge or consent of the person depicted, increasing the risk of deepfakes, defamation and abuse," said Ms. Sardeli, adding that the risks multiplied when photos of children were involved. She explained that under the EU's GDPR regulations, children cannot legally consent to such use of their personal data, including their image, until they turn 16 years old. Though experts and lawmakers have called on AI companies to enforce strong guardrails to prevent Al chatbots from generating highly pornographic media, the reality is that many chatbots easily churn out sexual content. What's more, Al firms and their bosses are aggressively promoting their service. For instance, one specific video Mr. Musk shared that promoted Grok Imagine's capability depicted a fantasy-style clip of a winged woman wearing very little clothing. Across the internet, meanwhile, websites lure users with morphed porn videos, featuring celebrities, and invite users to digitally undress victims of their choice. "Beyond obvious dangers such as CSAM (Child Sexual Abuse Material), less malicious uses, such as animating a child's photo for advertising or entertainment purposes, can also jeopardise children's privacy, dignity and autonomy," said Ms. Sardeli.

The Hindu reached out to both Google and xAI about the safeguards in place on these platforms to restrict users from turning photos of children into videos, and whether there are content filters to stop photos from being turned into pornographic content or child abuse material. A Google spokesperson said that the company took child safety online seriously and that the photo-to-video capability in Google Photos could be used with only two prompts: "Subtle movements" and "I'm feeling lucky". Furthermore, these videos would include an invisible SynthID digital watermark, as well as a visual watermark, the company said. "Our safety measures include extensive 'red teaming' to proactively identify and address potential issues, as well as thorough evaluations to understand how features can be used and prevent misuse. We also welcome user feedback on issues, which we use to make ongoing improvements to our safety measures and overall experience. We have clear policies and Terms of Service on what kinds of content we allow and don't allow, and build guardrails to prevent abuse," said the Google spokesperson. "Google Photos is a place to store vour memories and we want our users to be able to use its fun creative tools on photos of their friends and family, in-



cluding their kids, while also prioritising safety," the company said.xAl did not respond to a request for a statement.In the U.S., the National Center for Missing and Exploited Children (NCMEC) has highlighted that it is "deeply concerned" about how Generative AI was being used to sexually exploit children. "Over the past two years, NCMEC's CyberTipline has received more than 7,000 child sexual exploitation reports involving GAI [Gen AI], and the numbers are expected to grow as we continue to track these trends," stated the organisation on its website. Meanwhile, Ms. Sardeli noted that existing laws in the EU provided some safeguards but were not specifically designed with AI content in mind. This means EU child protection laws clearly prohibit explicit material, but they are less clear when it comes to synthetic media that is not overtly illegal but is still exploitative or harmful, according to her.In India, the Ministry of Electronics and Information Technology (MEITY) has issued advisories that require platforms to remove morphed content (including AI deepfakes), and especially if the content is graphic or sexually abusive. Furthermore, platforms such as Meta, Google, and X have appointed grievance officers in India to handle complaints raised by affected users."Al providers are beginning to build in safeguards, like detection systems and content filters, but these are uneven across platforms and not always effective. The law is lagging behind the technology. In particular, there is no comprehensive global framework that addresses the misuse of children's likenesses in GenAl," explained Ms. Sardeli. Jio forays into smartglasses with JioFrames

New Delhi: Digital firm Jio on Friday announced entry into the smartglass segment by unveiling JioFrames that will allow hands-free access to calls, music, recording of videos, etc, backed by AI voice assistant in multiple Indian languages.

"JioFrames is an Al-powered wearable platform and ecosystem, made for India. With support for multiple Indian languages at launch, you can simply speak to Jio's multilingual Al voice-assistant," Reliance Jio Chairman Akash Ambani said while sharing the "first look" of the device at the company's annual general meeting (AGM) on Friday. It is a hands-free, Al-powered companion designed for the way India lives, works, and plays, he said. The segment is dominated by Ray-Ban Meta Al Glasses with 73 per cent market share globally in the first half of 2025, as per Counterpoint Research.

Jio introduced a slew of new features and tools like reels and photo gallery customisation to step up competition with global platforms. Jio has been coming up with all elements of digital ecosystem to enable users generate data and store them securely with privacy within the company's ecosystem that can be leveraged by artificial intelligence for offering personalised services.

India-US deal could involve a grand bargain on oil: New Jersey Governor



Disagreeing with US President Donald Trump's move to impose high tariffs on allies, New Jersey Governor Phil Murphy — a top leader of the rival Democratic Party — said here Wednesday that when it comes to the India-US bilateral trade deal, there will be a "landing place" on the 50% tariffs but there could be a "grand bargain" including on oil. The 25% penalty tariff was slapped on India last month for importing Russian oil.

Incidentally, Union Commerce Minister Piyush Goyal, who was in the US recently for trade talks, said Wednesday that India's energy security goals will have a "very high element" of US involvement in the years to come. For the past few years, the US has been the fifth largest supplier of crude oil to India and the second-largest supplier of LNG. Asked about the ongoing trade talks, Murphy told The Indian Express in an exclusive interview: "The vibrations around suggest there's a landing place sooner rather than later...the vibrations are that there's going to be a deal here, which means that it would be less punitive than the current. But it's probably a grand bargain...that has oil as part of it.

Murphy was in Mumbai with his wife Tammy Murphy as part of their six-day four-city "economic mission" to India that included visits to New Delhi, Kochi, Bangalore and Mumbai. A former US Ambassador to Germany (2009-13), Murphy has worked in Goldman Sachs where he headed the firm's Asia unit. Supporting US President Donald Trump's measures with respect to Russia, he cautioned that imposing heavy tariffs on America's allies "is not the right way to get there." Asked if India was being singled out given that China also imports Russian oil, he said: "China needs to be taken to task...China cannot come out of this and cannot get away with what they're doing."On Russia, he echoed Trump's objective of ensuring accountability. "Russia deserves to be taken to task, and they need to continue to be taken to task. But I'm not of the opinion that putting big tariffs on your allies is the way to do that," Murphy said.

Murphy also made it clear that he does not "agree with the policy" on H-1B visas, signalling concern over its impact on students and immigrant communities. He will complete eight years as Governor in January of New Jersey, a state where the Indian diaspora is a force to reckon with. Touching upon immigration concerns, particularly the H-1B visa issue that directly affects New Jersey's large Indian community, Murphy struck a more optimistic note. "It (H-1B Visa issue) started out like, holy cow, Friday, \$100,000 a year. It's now down to \$16,667 a year. The people we have spoken to say it won't get worse than that. It could get better," the Governor said. "I agree with the principle to give every American kid the shot at everything that could be fulfilled, but this is not the way to do it," he said. When asked whether the current India-US chill, on trade and visas, is a hiccup in a longer bilateral arc of engagement or a long-term structural change in the relationship, Murphy said: "I hope it's a short-term reality. It won't be easy to regain the trust on both sides.... I agree with President Trump's objective to take Russia to task. That's not the issue. The issue is how you do...This is the case with a lot of the Trump administration policies. It's less arguing about the principle, it's more arguing about the execution. But I hope it's more

Stating that he is an optimist by nature, he said, "I think there's so much at stake. We're so intertwined. I mean, we've met company after company, university after university with deep ties at the moment and I'm hoping it can be contained." On the issues of H-1B visas and how it may impact Indian workers and students, he said, "You want to keep bad people out of your country? I'm all for that, but I've always thought the student visa process was a good one..... In the H-1 visas as well, if anything, I would expand that program. Secure borders and then expand that program to get the talent we need," he said. Asked if there will be a decline in the number of students going to the US because of the H-1B visa issues, he said, "I bet it will, unfortunately...they will end up going somewhere else or they'll stay here. I would not be surprised if more American universities could have a presence in India. You could see one plus three programs, two plus two, three plus one." "Over 2,000 Indian students are waiting for their visas for the semester that began a month ago. I think we will get where we've been working with the State Department. But that's a challenge that we're going to have to cut through and it won't be overnight." Asked if some of the decisions taken were reversible, the Governor said: "I can't speak for the Trump administration or for the administration. You've already seen the H-1B visa get announced on Friday and get changed within 24 hours. Yes, it doesn't get worse than it is today. Could it get better? Yes. My guess is there will be legal action, lots of people are looking at that, including us. So I'm not sure about reversing... does it go back to where it was Thursday? I don't know, but they clearly dropped the economic price and they delayed it till April."He said that student visas will have to get better. Stating that it used to be a race for three months to get visas processed, he said, "Now this is going to end up being a longer tail, probably a year-round process. These all depend on who the presi-

As Trump expands tariff net, why questions loom over the effectiveness of a trade deal with the US

The effectiveness of trade deals with the US has come under fresh scrutiny as US President Donald Trump on Friday expanded the tariff net to multiple products, including patented drugs and heavy trucks that were previously exempted from reciprocal tariffs. Trump's move assumes significance as India is in the middle of negotiations with the US, and the elimination of reciprocal tariffs is a key ask from the Indian side, though sectoral tariffs are not part of the talks. While the tariffs on pharma drugs may not affect India in the short term, experts said that the use of Section 232 is already impacting India's steel and aluminium manufacturers, and expansion of tariffs could further hurt exports even after the trade deal. Government officials said that a new investigation could lead to more products with steel and aluminium facing higher tariffs in the US.

Deborah Elms, Head of Trade Policy at the Singaporebased Hinrich Foundation, said that fresh sectoral tariffs under Section 232 raise several questions about whether or not they are covered under any existing bilateral trade deals. The US has already pushed for steep asks from India to sign a trade deal. Differences over India's purchase of Russian oil have already been a flashpoint between India and the US.On expanding use of Section 232, Simon Evenett, Professor at Switzerland-based IMD Business School, said that the US is fast expanding national security investigations on a range of products that raised several concerns. "The choice of Section 232 over other trade tools isn't accidental. According to legal experts, Section 232 tariffs are difficult to challenge in courts-unlike the IEEPA tariffs currently facing Supreme Court review. It's a calculated move to create more legally bulletproof trade barriers," Evenett said. Evenett emphasised that there are 12 concurrent Section 232 investigations across sectors from semiconductors to wind turbines, and this represents a "fundamental shift toward prioritising security concerns over openness, customer choice, and competitive pricing". "Rather than the broad-based tariff announcements we saw in April 2025, this Administration is now deploying a sliceby-slice approach. This likely reflects lessons learned from adverse financial market reactions to blockbuster tariff packages," he said.

Experts also said that several Section 232 investigations could have a hidden agenda, such as in the case of robots. While national security concerns around robotics are legitimate, there's potentially another motive at play. "Im-



posing high robot tariffs (historically in the range of 25-100 per cent under Section 232) would artificially inflate domestic robot prices, pushing companies toward hiring local workers over automation—a backdoor employment creation strategy," Evenett said. In signs that India may not receive relief for Section 232 tariffs under the trade deal, New Delhi has begun approaching the WTO against sectoral tariffs and has also indicated retaliation. Minister of State for Commerce and Industry Jitin Prasada, in a written reply to a parliamentary question earlier this year, said that the US has refused discussions in the WTO over steel and aluminium tariffs, citing national security. "India has accordingly reserved its right to suspend substantially equivalent concessions (right to impose equal trade measures in response) due to the US's non-compliance with its obligations under the Agreement on Safeguards (AoS)," Prasada said. Starbucks to close stores, lay off 900 workers

New York: Starbucks is laying off around 900 nonretail employees and closing some US and Canadian stores as it focuses more of its resources on a turnaround. The Seattle coffee giant will notify employees whose positions are being eliminated early Friday and said that it plans to close an undetermined number of stores in North America in the coming days. A review of Starbucks locations revealed that many are falling short of financial performance targets or are failing to create the environment customers expect, according to a letter sent by Starbucks CEO Brian Niccol on Thursday. "Each year, we open and close coffee houses for a variety of reasons, from financial performance to lease expirations," Niccol wrote. "This is a more significant action that we understand will impact partners and customers. Our coffee houses are centres of the community, and closing any location is difficult." Starbucks said Thursday that it expects to end its fiscal year with 18,300 stores in North America, down 124 from last year. It's rare for Starbucks to



shrink its store count during a fiscal year. Niccol is a turnaround specialist who was brought into Starbucks a year ago this month to give the brand a jolt.

In 2024, India reported 504,728 cases of animal bites other than dogs. Of these, around 11 people succumbed to their injuries, and many were left in critical condition. A significant share of these cases came from monkeys, whose population is currently estimated at over 50 million. With ever-dwindling green spaces, monkey-related nuisances within communities have been on the rise, and so have the number of monkey bite cases. "Any person bitten by a monkey needs immediate first aid," confirms Dr Rahul Agrawal, Head of the Department & Clinical Director - Internal Medicine, CARE Hospitals, Hitech City, Hyderabad.Ideally, a person should visit a doctor within a few hours of the bite. "The sooner the better. Rabies is a deadly disease, and thus immediate medical attention and vaccination are critical," Dr Agrawal cautions. It can also transmit tetanus, bacterial infections, and the herpes B virus in some cases. Taking quick and correct action immediately after a monkey bite can significantly reduce the risk of serious infection or complications. So, before you rush to the hospital, here's what you should immediately do to treat a monkey bite: First aid and next steps after a monkey biteImmediate care helps prevent infections and ensures faster healing. Here's what you should immediately do in case of a monkey bite.

Wash the wound thoroughly with soap and running water for 15–20 minutes.



Apply an antiseptic solution, such as povidone-iodine. Avoid using home remedies (such as turmeric, lime, or chili) as they can worsen the wound. If bleeding is heavy, press gently with a clean cloth to control it.

Visit a doctor immediately — ideally within a few hours — for rabies vaccination, tetanus protection, and further wound care. Warning signs to look out for after a monkey biteDr Agrawal advises monitoring the wound for redness, swelling, or pus discharge. Severe pain, fever, or red streaks moving up the arm or leg also require urgent medical help. "Later symptoms like confusion or weakness are also serious. Don't ignore them," he further warns.

It's OK to use paracetamol in pregnancy. Here's what the science says about the link with autism

United States President Donald Trump has urged pregnant women to avoid paracetamol except in cases of extremely high fever, because of a possible link to autism.Paracetamol – known as acetaminophen or by the brand name Tylenol in the US – is commonly used to relieve pain, such as back pain and headaches, and to reduce fever during pregnancy.Australia's Therapeutic Goods Administration on Tuesday re-affirmed existing medical guidelines that it's safe for pregnant women to take paracetamol at any stage of pregnancy.

Paracetamol is classified as a Category A drug. This means many pregnant women and women of childbearing age have long used it without increases in birth defects or harmful effects on the foetus.lt's important to treat fevers in pregnancy. Untreated high fever in early pregnancy is linked to miscarriage, neural tube defects, cleft lip and palate, and heart defects. Infections in pregnancy have also been linked to greater risks of autism.

How has the research evolved in recent years?

In 2021 an international panel of experts looked at evidence from human and animal studies of paracetamol use in pregnancy. Their consensus statement warned that paracetamol use during pregnancy may alter foetal development, with negative effects on child health.paracetamol A mother's underlying illness or reason paracetamol is being taken that influences child development are important factors (image source: pexels)Last month a group of researchers from Harvard University examined the association between paracetamol and neuro-developmental disorders including autism and attention-deficit hyperactivity disorder (ADHD) in existing research. They identified 46 studies and found 27 studies reported links between taking paracetamol in pregnancy and neuro-developmental disorders in the offspring, nine showed no significant link, and four indicated it was associated with a lower risk.

The most notable study in their review, due to its sophisticated statistical analysis, covered almost 2.5 million children born in Sweden between 1995 and 2019, and was published in 2024. The authors found there was a marginally increased risk of autism and ADHD associated with paracetamol use during pregnancy. However, when the researchers analysed matched-full sibling pairs, to account for genetic and environmental influences the siblings shared, the researchers found no evidence of an increased risk of autism, ADHD, or intellectual disability associated with paracetamol use. Siblings of autistic children have a 20 per cent chance of also being autistic. Environmental factors within a home can also affect the risk of autism. To account for these influences, the researchers compared the outcomes of siblings where one child was exposed to paracetamol in utero and the other wasn't, or when the sib-



lings had different levels of exposure. The authors of the 2024 study concluded that associations found in other studies may be attributable to "confounding" factors: influences that can distort research findings.paracetamol There is no clear evidence that paracetamol has any harmful effects on an unborn baby A further review published in February examined the strengths and limitations of the published literature on the effect of paracetamol use in pregnancy on the child's risk of developing ADHD and autism. The authors noted most studies were difficult to interpret because they had biases, including in selecting participants. When confounding factors among siblings were accounted for, they found any associations weakened substantially. This suggests shared genetic and environmental factors may have caused bias in the original observations. Working out what causes or increases the risk of autism. A key piece to consider when assessing the risk of paracetamol and any link to neurodevelopmental disorders is how best to account for many other potentially relevant factors that may be important. We still don't know all the causes of autism, but several genetic and non-genetic factors have been implicated: the mother's medication use, illnesses, body mass index, alcohol consumption, smoking status, pregnancy complications including pre-eclampsia and foetal growth restriction, the mother and father's ages, whether the child is an older or younger sibling, the newborn's Apgar scores to determine their state of health, breastfeeding, genetics, socioeconomic status, and societal characteristics. It's particularly hard to measure the last three characteristics, so they are often not appropriately taken into account in studies. Why a one-time Punjab cricketer in Australia is quoting singer Karan Aujla to say "mahaul poora wavy hai"

Five years ago, Punjab cricketer Nikhil Chaudhary, after a long domestic season, took a flight to Australia to celebrate his birthday. It was early 2020, easily the worst time to travel. Within days of his landing, Covid-19 deaths would see a global spike and Australia would shut its entry and exit points. The only son of a Ludhiana builder was stuck thousands of miles away from home.

After a couple of months, restrictions would lift, internal travel would resume and Nikhil would join a local Brisbane club. He would go on to play in the local league, inform his parents that he was staying back, change his visa type from 'tourist' to 'study' to eventually 'sports.' His decision not to call home for money would take him to a place he had never been - a Mexican restaurant where he chopped onions when not waiting tables, on an Australia Post van delivering close to 250 packets a day and drive an Uber taxi. This wasn't a life the boy in his early 20s, growing up in a comfortable home with two sisters and doting parents, was used to

This weekend, Nikhil, 29, is expected to become a first-class cricketer in his adopted country, only the second Indian after Rusi Surti, the Test player who turned up for Queensland in 1972, towards the end of his career. Picked for Tasmania's state squad for the Sheffield Shield this season, Nikhil, after an impressive performance in the Big Bash League and other domestic white-ball tournaments, is likely to make it to the playing XI soon. Speaking to The Indian Express after a training session, he talks about the life-size frame of Aussie legend David Boon in the Tasmania dressing room, the awe of walking on the turf that has been Ricky Ponting's backyard and his inability to express his true feelings. "Please understand, words will fail to describe what I am going through. You wouldn't be able to understand either, only I know what all I had to go through. I think it's just the fruit of all the struggles that I have been through for the last 5 years ...," says the all-rounder who while playing for Punjab, shared the dressing room with Harbhajan Singh, Yuvraj Singh, Shubman Gill and Arshdeep Singh.

He also mentions the sweaty time in the kitchen, tears rolling down his cheeks chopping onions, rude customers encountered on delivery, and that one day in August 2023 when he was on the verge of throwing it all away. That was when he poured his heart out to his local guardian, Billa Chacha – not his real uncle but his friend's uncle at whose home he was locked up during the pandemic. "I share everything with him, he is closer to me than to his own nephew," he says. That was the time Nikhil played Brisbane's very competitive T20 league that had games over the weekend. He remembers, it was a Friday and he had returned from

his 6 am shift feeling terribly low. After a few hours, he had to leave for the game but was in no mood. After three years on the circuit, with his cricket career not going anywhere, he had a heart-to-heart chat with his Chacha."I told my chacha, meri toh bas ho gayi hai (I've had enough) ... I am quitting cricket. I will focus on my life, do some business here and try to get citizenship," he said. Chacha was noncommittal, he didn't drag the conversation. Nikhil's troubles that day didn't seem to be ending. His team had an early collapse and the late-order batsman, dealing with the crisis in his life, had another fire to douse. "That day I scored 79 from 29 balls," he said. This wasn't merely a match-winning and game-changing knock, it was a life-altering innings. The next day, a Saturday, was a break and the final was on Sunday. So Nikhil got behind the wheel and switched on the Uber app. "While driving, I got a call from my manager. I thought I knew what he would say - 'Well played, Nikki, well done. You got the team into the finals' and everything ... But he said 'Nikki, we did it. Check your phone

Nikhil would stop his car and to his utter disbelief, saw a contract to play Australia's premier T20 league, the Big Bash, for Hobart Hurricanes. I stepped out of the car and took a very deep breath," he says. Did he take the next Uber trip? Nikhil laughs and says, "Bro, I switched off Uber, actually deleted the app and said, 'I will not run this again." He would call home, inform them about the big 'Big Bash' development and the family would heave a sigh of relief. Before that T20 windfall, Nikhil would often get a call from his mother, Manju, who would endlessly ask permission to send him money. Those conversations would be cut short. Living with other struggling migrants in Australia, the cricketer with dreams didn't want to be different from those seeking a degree, permanent residency or one day owning a curry shop."I have never liked to be privileged. Everyone around me in Australia was struggling, they would do odd jobs while chasing their dreams. I too wanted to do the same. My father has done enough for us that I don't need to work for the next 50 years, but I am doing what he did so he wasn't against me doing things on my own," says Nikhil.

His father Saneh, an engineer, moved from Muzaffarnagar in Uttar Pradesh to Delhi for a better life. It was in the nation's capital that Nikhil and his sisters were born. The family would shift base again, this time to Ludhiana, their present and permanent address. Nikhil was two then."I did internationally what he did domestically. I think he knew how it feels when you go from one place to another and make it big there," he says. The Big Bash League would give Nikhil instant fame - overnight popularity in Australia, India and the wide world of short-video watchers. Last year, after a game in which he scooped Pakistan and Perth Scorchers pacer Haris Rauf for a six over point, his phone was flooded with messages. "I still haven't answered many of the messages I got that day.

Having followed the Asia Cup intently, Nikhil has set his goals for this year's Big Bash. "I want to hit Haris for a six and get Babar Azam out. That's what I am manifesting," he says, carrying cricket's recent India vs Pakistan theme.A die-hard fan of cult Punjabi singer Karan Aujla, Nikhil says life on the Australian cricket circuit is great - "yahan ke players, coaches, team bahut chill hai". "As Karan Aujla says 'mahaul poora wavy hai (the atmosphere is all wavy)," says the man making waves in Australia.

Brazil, Turkey topple Poland's Kucharczyk-Urbanska at New Delhi 2025

Hyderabad: Zileide Cassiano Da Silva (Brazil) and Fatma Damla Altin (Turkiye) became only the second and third athletes in history to beat Karolina Kucharczyk-Urbanska (Poland) in a global women's Long Jump T20 competition when they relegated her to bronze medal in the IndianOil New Delhi 2025 World Para Athletics Championships here on Sunday. Zileide Cassiano Da Silva and Fatma Damla Altin, who had finished behind the Polish athlete in the Paris 2024 Paralympic Games, found the pace, rhythm and the flight to leap to 5.88m and 5.72m to take gold and silver. The legend Karolina Kucharczyk-Urbanska, who was returning to World Para Athletics Championships after missing 2024, had a best of 5.55m.

It was only the third defeat in a global competition for Karolina Kucharczyk-Urbanska in 10 global competitions since making her debut in 2011. She has won gold in four World Championships and three Paralympic Games. Though she has breached the 6m often, an ankle injury has meant that she had to satisfy herself with a season's best jump for bronze. Karolina Kucharczyk-Urbanska said the bronze felt like gold because she is dealing with an injured ankle. She also said she liked how she fought till the end to be on the podium despite competing in unfamiliar heat and humidity. "I had a lot of fun today," she said. I fought hard to get on the podium," she said. Interestingly, Mikela Ristoski (Croatia), the athlete who had beaten the Polish jumper both in World Para Athletics Championships in Christchurch in



2011 and the Paralympic Games in Rio de Janeiro in 2016 was engaged with Karolia Kucharczyk-Urbanska in the fight for bronze but was unable to edge her famed rival out of the podium. From the Shot Put circle, the Netherlands' Lara Baars sent the iron ball over 9.77m for a new World Record in the women's F40 class. The only competitor who went over the 9m mark, the 28-year-old rewrite her own World Record twice, thus accounting for the 30th World Record in New Delhi 2025. Meanwhile, on Sunday morning, the Jury of Appeal reversed an earlier decision and reinstated four marks of Brazilian Paulino dos Santos Thiago in the men's Shot Put F57 final, including a best of 14.82m that gave him the silver medal and relegated India's Soman Rana to bronze and Finland's Teijo Koppikka out of the po-

For Maximilian, this gesture was more than just a lucky charm. It was his way of saying thank you to India. Wearing words in Hindi on my forehead was a way to show respect and gratitude. Steffi had a tradition of wearing words in the host country's language as a mark of courtesy. Maximilian embraced that tradition in Delhi—and made

it his own. The lotus symbol added another meaningful layer to the headband. For the 29-year-old athlete, it represented resilience and grace—qualities that mirrored his own journey of recovery from injury.

"I know that in Buddhism, grace and resilience are important. It's about moving forward unscathed through adversity. For me, it was the perfect symbol," he said.

This wasn't just for show—the message and symbols on the headband influenced his mindset. That mindset came alive in the final moments of the race. With Fukunaga ahead. Maximilian seemed to be missing out on gold, but the words on his forehead reminded him not to give up. In the last meter, he gave it his all and won by just three hundredths of a second. After the race, he admitted, "I had knee pain and couldn't train properly for weeks. So this medal was completely unexpected. But the headband reminded me-never give up." Maximilian's headband became a talking point after the race. He appeared joyful and emotional, because for him, the moment was more than just about the medal-it was about the connection an athlete feels when embracing the culture of a country that has cared for and hosted them so graciously.

From that Rohit Sharma to now, oh god. I'm amazed by his vision and thought process, not only for the team but also the individuals. 

Gukesh Dommaraju was checkmated on the board in a bullet game by world no 2 Hikaru Nakamura, who then threw the world champion's king into the crowd in celebration, at the exhibition chess event called Checkmate: USA vs India where the Indian team were swept by the Americans by a 5-0 margin. Gukesh had managed to play out draws in the 10minute and the five-minute games before the match descended into a oneminute bullet game with a one second increment per

In the bullet game, Gukesh was checkmated







on the back rank by Nakamura's queen with another bishop cutting off the escape square. In the oneminute clash, Gukesh had an healthy advantage on the clock at one time with the evaluation bar also showing that Gukesh had the upperhand. But against a player of Nakamura's calibre in the faster time controls, that initial edge proved to be inconsequential as the American soon surged ahead on the clock and put Gukesh under significant pressure on the clock before delivering a checkmate.

revealed by the global governing body of chess. Aamir nodded in agreement, adding, "Yes, I do remember my parents couldn't pay fees on time either, and then they would announce our names in the assembly." Playback singer was born to samosa seller, sang at jagratas since age 4, now earns in crores

Bollywood has long celebrated stories of grit and transformation, often through rags-to-riches tales. One such iconic example is Amitabh Bachchan's Sooryavansham, where an illiterate man rises to become a powerful industrialist through sheer hard work. While such stories often seem like cinematic fantasies, playback singer Neha Kakkar's real-life journey proves that such miracles can happen off-screen too.Neha was born to a humble family in Rishikesh. At the age of four, her family moved to Delhi, where they began performing at religious gatherings to make ends meet. Her early introduction to music came not from formal training, but from these devotional events.

Speaking about her childhood on Indian Idol, Neha recalled, "I have been singing since I was four years old. Back then, there were no time limits. The performances often continued until morning, and sometimes, people didn't even acknowledge our efforts. Singing for long hours often meant I couldn't go to school the next day."Despite their hard work, the family continued to struggle financially. In a particularly emotional revelation, Neha shared: "We still can't forget those days when my father used to sell samosas outside Sonu didi's college (referring to her sister, singer Sonu Kakkar). The college students would tease her, and it was heartbreaking." At 16, Neha moved to Mumbai to audition for Indian Idol, a decision that would change her life. Though she didn't win the competition, her journey came full circle when she returned to the same stage—this time as a judge.Reflecting on her path, Neha told Radio City: "I have never learned music formally-I don't know what Sargam is. Rohan (her husband, singer Rohanpreet Singh) teaches me now, as he's trained. I just used to listen to people and sing—that's how my journey began."

She credits much of her success to the countless devotional performances she gave as a child: "I think doing Mata ka Jagrata really paid off. After Indian Idol, I didn't have to run after music directors for work. It's like divine energy stayed with me. My songs just kept becoming superhits." On returning to Indian Idol as a judge, Neha said: "It felt surreal. When I first came as a contestant, I felt so small. My self-esteem was low. I was just hoping to maybe win the show. Never in my wildest dreams did I imagine judging it someday." She added: "Back then, my attitude was: 'I am nothing.' So going from 'nothing' to everything was huge for me. Sitting in that judge's chair, I could see teenage Neha standing beside me, reminding me, 'Kahaan se kahaan



aagayi."'Her big break came when she lent her voice to Pritam's hit song "Second Hand Jawani" from the 2012 film Cocktail, which quickly went viral. This opened the floodgates of opportunity."I was approached by Yo Yo Honey Singh for Aaj Blue Hai Paani, and everything just skyrocketed from there," she recalled. What followed was a string of chartbusters-London Thumakda, Tukur Tukur, and many more. Neha became not just a household name but also one of India's most-followed female artists, ranking as the 22nd most-followed artist globally on Spotify. The fame came at a cost. "I suddenly became extremely busy-performing back-to-back shows in India and abroad. I didn't even have time to breathe. I ended up compromising my health. But now, I've finally taken a break-because I can afford to. It's a luxury," she admitted. She also went through depression after her breakup with actor Himansh Kohli, which she publicly expressed on her Instagram account. Later, on a reality show, she shared battling several health issues like Thyroid and Anxiety. While Neha attributes much of her success to divine blessings and her early struggles, she is quick to credit her family—especially the men in her life—for their unwavering support. "Today, the men in my family-whether it's Rohan, Tony Kakkar (her brother), or my father—they all want me to be bigger than them. They call me their flagbearer. It feels incredible," she shared with pride.
