HC grants two weeks to Cong govt on local body poll

Hyderabad, Oct.17 : The Telangana High Court has given the state government and the State Election Commission (SEC) two weeks time to file their counter affidavits in connection with a petition seeking for conduct of local body elections. During the hearing before a division bench headed by Chief Justice Aparesh Kumar Singh, the SEC's counsel Vidyasagar informed the court that the commission had written to the state government regarding the provision of BC (Backward Classes) reservations in the upcoming lo-



cal body elections. Further action would be taken after receiving a response from the government, he added. The case pertains to a petition filed by one Surender, who sought directions to the SEC to conduct the local body elections in directed by the court during an earlier hearing. The SEC's counsel told the court that the earlier election notification had been stayed following the High Court orders, and that the government must now finalize the reservations afresh. Meanwhile, the government's counsel requested three weeks' time to take a decision on the issue. However, the court granted two weeks and directed both the government and the SEC to file their counters within that period, and adjourned the case hearing.

MP Krishnaiah walks



Hyderabad, Oct.17: Bharatiya Janata Party (BJP) Rajya Sabha Member of Parliament R. Krishnaiah advocated for the allocation of 42 percent reservations for Backward Classes (BCs) in local body elections, as was promised by the Congress government to the people. In support of this demand, he organised a walkathon on Friday, which commenced from Dilsukhnagar and concluded at Moosarambagh. Participants in the event included individuals from diverse backgrounds—youth, intellectuals, women, and members of various BC organisations —who joined together regardless of their political affiliations.

During the walkathon, the MP, along with fellow participants, chanted slogans emphasizing that "BCs must be afforded political significance and 42 percent reservations."R. Krishnaiah asserted, "The ongoing negligence towards BCs and the exploitation of the community as a vote bank must cease immediately. BCs are entitled to equal rights, and we shall persist in our struggle until our rights are secured."

The BC organisations have requested a State-wide bandh on Saturday, advocating for 42 percent reservations. All political parties, including the Congress, have already expressed their support for this initiative. The Rajya Sabha Member of Parliament has urged all parties to provide unconditional backing for the bandh. He emphasised that the call for 42 percent reservations is aimed at promoting the welfare and better future of the upcoming generation of BCs

Infrastructure must expand in line with rising power demand: Bhatti



Khammam, Oct.17: Deputy Chief Minister and Minister for Finance, Energy, and Planning, Bhatti Vikramarka stated that the Power department plays a crucial role in achieving the goals of Telangana Rising Vision 2047. The Deputy Chief Minister on Friday conducted a review meeting with the officials of the Power department from the undivided Khammam and Warangal districts at the Khammam

Speaking on the occasion, Bhatti Vikramarka said that all suggestions received for improving power services to consumers have been noted. He instructed officials to study and prepare proposals for new substations keeping in view the future requirements. He announced that two 400 kV substations would be sanctioned for Khammam district to meet its growing industrial power needs. Bhatti Vikramarka said five Young India Integrated Gurukul Schools have been sanctioned in Khammam district, each serving as a model

institution akin to a village, and that new industrial parks are being established there. He emphasised the need to strengthen power distribution and transmission systems in view of these developments.

The Deputy Chief Minister instructed officials to ensure there are no loose wires or unsafe electric poles that could cause fatalities, and to inspect the field regularly under the Polam Bata (field inspection) programme every week to address such issues. He commended the power department staff for their dedication, noting that they work in floodwaters and heavy rains to restore power supply in record time. "It is our responsibility to ensure that the good work of our staff is not undermined by a few individuals acting out of selfish interests," Bhatti Vikramarka said. The Deputy Chief Minister emphasised that the power department is vital to realising the Telangana Rising Vision 2047, and that quality power supply is the foundation for development in every sector. He reiterated that the government is working seriously toward making Telangana a 3-trillion-dollar economy by framing appropriate policies. "If everyone from linemen to CMDs performs their duties with commitment our Power Department can achieve great results," he said. He announced plans to introduce uniforms for NPDCL employees. He stated that Electricity Ambulances, equipped with transformers, technical staff, and all necessary tools, have been deployed, and that at least one such ambulance should be available in every Assembly constituency. The Deputy Chief Minister directed that the 1912 helpline number be widely publicised, and that all complaints received through it must be resolved promptly. "I will personally call 1912 to test the response," he said.

CM to present licensed surveyor certificates on Oct 19: Ponguleti



Hyderabad, Oct.17: Minister for Revenue Ponguleti Srinivas Reddy announced that Chief Minister A. Revanth Reddy will officially distribute licensed certificates to surveyors who have undergone government training. This ceremony is scheduled to take place at the Shilpa Kalavedika in Hyderabad on October 19. The Minister convened a review meeting at his office in the Secretariat on Friday, attended by Revenue Secretary DS Lokesh Kumar and Survey Commissioner Rajiv Gandhi Hanumanth.

During the meeting, he reported that in the initial phase, a total of 7,000 individuals received training, with 3,465 successfully qualifying. He noted that each mandal will have 4 to 6 licensed surveyors appointed, based on the land area. Furthermore, the Minister indicated that the second phase of training for an additional 3,000 individuals commenced on August 18, 2025, and an eligibility examination will be held under the supervision of JNTU on October 26.He stated that candidates who pass this examination will participate in a 40-day apprenticeship programme, with their services expected to commence by the second week of December. Srinivas Reddy noted the essential connection between the Revenue department and the Survey department, emphasising that conflicts will diminish only when land measurements and records are accurate and transparent. He asserted that the surveying system can ensure security and justice for the people only if it is fortified. The Minister highlighted that the survey department has

suffered neglect for the past decade, resulting in insufficient staffing at the field level and consequently inadequate services for the public. The Minister made it clear that with these two measures - GPOs in every revenue village and now licensed surveyors in every mandal - the aim is to strengthen the system so that the people get the necessary land-related services."The government's resolve is to ensure that land records are clear and that services are provided to the people without any hassle and without corruption," Ponguleti Srinivas Reddy said.

400 crore Diwali bonus for Singareni workers: Bhatti

Hyderabad, Oct.17: Deputy Chief Minister Bhatti Vikramarka announced that Singareni workers will receive a Diwali bonus of ?400 crore.

isakhapatnam, Andhra Pradesh, for a large-scale artifiial intelligence (AI) hub is huge by any reckoning. To begin with, it is the IT major's biggest investment outside he US so far. Unsurprisingly, its employment generation otential is humungous - more than 1 lakh jobs. The fiverear project (2026-30) will scale the data centre to muliple gigawatt (GW). Harassment of Sakshi Journalists Condemned "Bhadrachalam Reporters Protest for Press Freedom



"Bhukya RanjithNaik,Bhadradri kothagudem Bureau, October 17, Indian Chronicle: Journalists in Bhadrachalam staged a strong protest on Friday condemning the Andhra Pradesh Government's alleged harassment of Sakshi newspaper and its Editor, R. Dhanunjaya Reddy, in what they described as a serious attack on press freedom. "According to the protesting media personnel, the Andhra Pradesh Government, displeased with Sakshi's recent exposé on spurious liquor trade in the state, has been repeatedly targeting the newspaper's editorial team. Over the past five days, the police reportedly served three separate notices to Editor Dhanunjaya Reddy — even visiting Sakshi's head office in Hyderabad to deliver them personally.""The journalists expressed outrage over what they called a vindictive approach by the government towards Sakshi management, editors, and reporters, terming it an attempt to "silence a voice that speaks for the people." "As part of the protest, local journalists from various associations gathered at Ambedkar Centre in Bhadrachalam, wearing black badges and holding placards demanding the withdrawal of the "false and politically motivated" cases filed against the Sakshi team. They later submitted a petition at



the Ambedkar statue, urging protection of media rights, confidentiality, and freedom expression. "Addressing the gathering, B.V. Ramana Reddy, President of the Bhadrachalam Press Club and Member of the Telangana IJU Committee, along with District Secretary Anand, said:""The Andhra Pradesh Government is deliberately targeting Sakshi's Editor. Raiding media offices, intimidating journalists, and denying adequate time for response are blatant violations of press freedom. Such actions threaten democracy itself. Every journalist in the country should unite and oppose this injustice." "The journalists also submitted a memorandum at the Bhadrachalam Sub-Collector's office, demanding immediate withdrawal of cases against Sakshi Editor Dhanunjaya Reddy. Ashanna was brought separately in a car under tight security.""Police welcomed the surrendered Maoists with a copy of the Indian Constitution and a pink rose, symbolizing their return to the mainstream. Among the surrenderees were four Dandakaranya Special Zonal Committee members — Bhaskar alias Rajman Mandavi, Ranita, Rajusalam, and Dhannu Vetti alias Santulu — and Regional Committee member Ratan Alam. ""Of the total, 110 were women and 98 were men, including one Central Committee member, four Zonal Committee members, one Regional Committee member, 61 Area Committee members, 21 Divisional Committee members, 98 party members, and 22 PLGA cadres. They collectively surrendered 153 weapons, including 19 AK-47 rifles, 17 SLRs, 23 INSAS rifles, one LMG, 36 .303 rifles, four carbines, and one UBGL. """CM Announces Comprehensive Rehabilitation Package "Chief Minister Vishnudev Sai announced a generous rehabilitation and welfare package for the surrendered Maoists. Each will be provided with a house, agricultural land, and financial assistance for three years. MEIL secures USD 225.5 million project from Kuwait oil company

Hyderabad/Kuwait, Oct.17: Megha Engineering and Infrastructures Limited (MEIL) has achieved another global milestone by securing a USD 225.5 million (KWD 69.23 million) project from the Kuwait Oil Company (KOC). The project involves the design, construction, operation, and maintenance of a New Gas Sweetening and Sulphur Recovery Facility (NGSF) at West Kuwait's oilfields.

This project will be developed on a Build-Own-Operate (BOO) basis, with an option for KOC to buy back the facility. It will be executed in two stages - Execution Phase and Operation & Maintenance (O&M) Phase. The project, located near Booster Station BS-171, will be completed in the period of 790 days, followed by five years of operation and maintenance. The associated Sulphur Recovery Unit (SRU) will comprise two trains, each with a 100 TPD (Tons Per Day) capacity, achieving an overall 299.9% sulphur

recovery efficiency. The advanced facility is designed to treat sour gas containing up to 4% hydrogen sulfide (H2S) and 10% carbon dioxide (CO2), processing 120 million standard cubic feet per day (MMSCFD). Green India Challenge launches pilot bamboo plantation to empower tribes

Adilabad, Oct.17: In a pioneering effort to restore livelihoods and combat environmental degradation, the Green India Challenge (GIC) a nationwide environmental movement founded by former Rajya Sabha MP Joginpally Santosh Kumar has launched a pilot bamboo plantation project spanning 5 acres in Mullalagutta 2 village, Adilabad rural mandal in the district. This first-of-its-kind initiative seeks to address the acute bamboo shortage faced by the Kolam (Kollam) tribes, a Particularly Vulnerable Tribal Group (PVTG)in Telangana, whose traditional livelihoods and craftsmanship depend on bamboo.

For generations, the Kolam community has skillfully used bamboo to craft mats, baskets, fences, and ritual items—products that are integral to their economy and cultural heritage. However, stringent forest conservation rules have restricted access to natural bamboo resources, forcing tribal families to trek 7–10 kilometers daily to gather limited bamboo culms. This has pushed over 6,000 Kolam families in Adilabad into economic distress and dependence on exploitative middlemen. Stepping in with empathy and determination, Joginpally Santosh Kumar (fondly known as Santosh Anna) has spearheaded the pilot plantation. The site—5 acres of land generously donated by local philanthropist Tekam Rao Ji Patel -will serve as a bamboo nursery and cultivation hub for the Kolam community.

A hallmark of GIC's legacy of record-breaking afforestation drives—including its entries in the Limca Book of Records and Guinness World Records—this initiative marks a strategic shift toward community-centered ecological restoration. Currently, 50% of the plantation work has been completed, featuring bamboo species carefully selected to suit the region's soil and climate conditions, under the guidance of forest department experts and GIC volunteers. "This is not just about planting bamboo—it's about planting hope and restoring dignity," said Joginpally Santosh Kumar. "The artistry of the Kolam tribes deserves revival. By ensuring a sustainable bamboo supply, we can create jobs, enhance incomes, and promote self-reliance. A com-

munity event will soon be organised to complete the plantation and introduce training programs in advanced bamboo craftsmanship," he said. Aligned with the objectives of the National Bamboo Mission, the project promotes bamboo as a sustainable, fast-growing resource that supports carbon sequestration, soil restoration, and rural livelihood generation. Once mature, the plantation is expected to yield thousands of bamboo culms annually, providing a reliable and renewable resource base for tribal artisans. Future project phases will focus on value addition and market linkage, empowering artisans to sell bamboo products directly through fair trade markets and eliminating exploitative intermediaries. Now in its eighth edition, the Green India Challenge has successfully planted over 20 crore saplings across India since its inception in 2018, inspiring millions to take part in the nation's green movement.

Israel strikes Gaza as Palestinians pin hopes on Trump's Gaza plan

Israeli planes and tanks pounded areas across the Gaza Strip overnight and on Sunday (October 5, 2025), destroving several residential buildings, witnesses said, as Palestinians desperately awaited implementation of a U.S. plan to end the war.U.S. President Donald Trump, who had called for an end to the bombing, said on Saturday (October 4, 2025) on his Truth Social platform that Israel had agreed to an "initial withdrawal line" inside Gaza and that "when Hamas confirms, the Ceasefire will be IMMEDI-ATELY effective. "The Israeli escalation comes as Egypt prepares to host delegates from Hamas, Israel and the U.S., and Qatar, to kick off talks over the implementation of the most advanced effort yet to halt the conflict. Hamas had drawn a welcoming response from Mr. Trump on Friday (October 3, 2025) by saying it accepted certain key parts of his 20-point peace proposal, including ending the war, Israel's withdrawal, and the release of Israeli hostages and Palestinian captives. But the group has left some issues subject to further negotiation, as well as questions unanswered, such as whether it would be willing to disarm, a key demand from Israel to end the war.

"Progress would depend on whether Hamas would agree to the map, which shows the Israeli army would remain in control of most of the Gaza Strip," said a Palestinian official, close to the talks. "Hamas may also ask for a strict timetable for the Israeli withdrawal from Gaza. The first phase of talks will determine how things are going to proceed," he told Reuters, asking not to be named. In Gaza City, which Israel describes as one of Hamas's last bastions, Israeli forces pressed ahead with attacks and warned residents who left against returning, saying it was a "dangerous combat zone". On Sunday (October 5, 2025), witnesses said Israeli planes escalated attacks against targets across the city, Gaza's biggest urban centre. This followed a tense night in which drones dropped grenades on the rooftops of residential buildings and troops blew up explosive-laden vehicles, demolishing dozens of houses in two Gaza City neighbourhoods, Sabra and Sheikh Radwan.

Where is Trump?

"Where is Trump in all of this?" said Rami Mohammad-Ali, 37, from Gaza City, now displaced in the city's western side, near the beach. "The explosions don't stop, the drones drop bombs everywhere, as if nothing has happened. Where is the truce Trump told us about?" he asked.Local health authorities said at least one Palestinian was killed, and several others were wounded in those attacks. Three other people were killed in separate Israeli strikes across the enclave, medics said.Amjad Al-Shawa, head of the Palestinian NGOs Network, which liaises with the United Nations and international humanitarian organisations, said Gaza City has begun experiencing acute shortages of food and fuel, days after Israel blocked the route from the south to the north.

"We are speaking about tens of thousands of children who suffer malnutrition, elderly who need extra care, those are in danger now because of the Israeli occupation blockade of Gaza City and the escalation of the attacks," Mr. Shawa told Reuters. Under Mr. Trump's plan, all Israeli hostages, alive and deceased, were due to be released within 72 hours of Israel publicly accepting the agreement. But it was not clear at what precise point the clock on that 72hour deadline would start ticking, given Israeli Prime Minister Benjamin Netanyahu agreed to the timeline several days before Hamas responded. Israel says 48 hostages remain, 20 of whom are alive. There may be logistical challenges too. Sources close to Hamas told Reuters that handing over living hostages could prove relatively straightforward, but retrieving bodies of dead ones amid the huge devastation and rubble of Gaza may take longer than a few days to

Mr. Trump said on Friday (October 3, 2025) he believed Hamas had shown it was "ready for a lasting PEACE" and he called on Mr. Netanyahu's Government to halt airstrikes in Gaza. Domestically, Mr. Netanyahu is caught between growing pressure to end the war — from hostage families and a war-weary public - and demands from hardline members of his coalition who insist there must be no let-up in Israel's campaign in Gaza. Far-right Finance Minister Bezalel Smotrich said on X that halting attacks on Gaza was a "grave mistake".Mr. Smotrich and Security Minister Itamar Ben-Gvir, also a hardliner, have significant influence in Netanyahu's Government and have threatened to bring it down if the Gaza war ends. Israel began attacking Gaza after the October 7, 2023, Hamas-led attack on Israel in which some 1,200 people, mostly civilians, were killed and 251 taken hostage, according to Israeli tallies. Israel's campaign has killed more than 67,000 people in Gaza, most of them civilians, according to Gaza health authorities, and

'We were treated like animals', deported Gaza flotilla activists say

International activists who arrived in Istanbul after being deported from Israel following the military's interception of their Gaza-bound flotilla said on Saturday (October 5, 2025) they had been subjected to violence and "treated like animals". The Global Sumud Flotilla set sail last month seeking to ferry aid to war-battered Gaza but Israel blocked the boats, detaining more than 400 people whom it began deporting on Friday.Of that number, 137 activists from 13 countries flew into Istanbul on Saturday (October 5, 2025), among them 36 Turkish nationals."We were intercepted by a huge number of military vessels," Paolo Romano, a regional councillor from Lombardy in Italy, told AFP at Istanbul airport. "Some boats were also hit by water cannon. All of the boats were taken by very heavily armed people and brought to shore," the 29-year-old said. "They put us on our knees, facing down. And if we moved, they hit us. They were laughing at us, insulting us and hitting us," he said. "They were using both psychological and physical violence."Among those on board the flotilla, which counted some 45 vessels, were politicians and activists, including Swedish climate campaigner Greta Thunberg.Mr. Romano said they tried to force them to admit they had entered Israel illegally. "But we never entered Israel illegally. We were in international waters and it was our right to be there."On landing, they were taken to a prison and held there without being allowed out and were not given bottled water, he said. "They were opening the door during the night and shouting at us with guns to scare us," he said. "We were treated like animals." Worst experience Iylia Balqis, a 28-year-old activist from Malaysia, said Israel's interception of the boats was "the worst experience"

"We were handcuffed (with hands behind our backs), we couldn't walk, some of us were made to lie face down on the ground, and then we were denied water, and some of us were denied medicine," she said. The activists were flown to Istanbul on a specially-chartered Turkish Airlines



plane. In a post on X, the Israeli Foreign Ministry confirmed 13/ more provocateurs of the Hamas-Sumud flotilla were deported today to Turkey". Relatives of the Turkish activists could be seen awaiting their arrival at the VIP lounge inside Istanbul airport, waving Turkish and Palestinian flags and chanting "Israel murderer". The Turkish activists were to undergo medical checks on arrival and would appear in court on Sunday to give testimony, their lawyers said. Turkiye has denounced Israel's interception of the flotilla as "an act of terrorism", saying on Thursday it had opened an investigation. Foreign Minister Hakan Fidan praised the activists as "brave individuals who gave voice to humanity's conscience" in a post on X and said Ankara would ensure all of its nationals were brought back, without giving an overall number. Italian journalist Lorenzo D'Agostino, who was on board the flotilla to cover its mission, said they "were kidnapped in international waters when we were 55 miles (88 kilometres) from Gaza". "It was two hellish days that we spent in prison. We are out now thanks to the pressure of the international public that supports Palestine," he said."I really hope this situation ends soon because it has been barbaric the way we have been treated." Libyan activist Malik Qutait said he was not afraid and vowed to keep trying to reach Gaza."I will collect my group, arrange medicine, aid and a ship and I will try again," he said.

Russian strikes kill five in Ukraine, cause power outages

Intense Russian strikes on Sunday (October 5, 2025) in Ukraine killed five people in the southern Zaporizhzhia region and Lviv in the west and badly damaged energy infrastructure, severing power supplies to tens of thousands. Russia has stepped up attacks on Ukraine's energy infrastructure as the weather chills. "This Sunday night, Russia launched yet another barrage of missiles and drones against the people of Ukraine, targeting the Lviv, Zaporizhzhia, Chernigiv, Vinnytsia, Ivano-Frankivsk, Kherson, Kharkiv, and Odesa regions," Prime Minister Yulia Svyrydenko said.Lviv has been the area that the Russian military has targeted the most since Moscow launched its full-scale offensive on Ukraine in February 2022."In Lviv, four people were killed and four others injured. In Zaporizhzhia, one person was killed and 10 injured after Russia targeted residential areas with drones and aerial bombs. Across all affected areas, residential buildings and critical infrastructure were damaged."Ivan Fedorov, the head of the Zaporizhzhia region, earlier said a 16-year-old girl was among those receiving "necessary assistance" from medical personnel after the attack. There were widespread power outages in the city as energy equipment was damaged, the service provider said. President Volodymyr Zelenskyy said the overnight attack saw over 50 missiles and about 500 attack drones fired at his country. "The Russians once again targeted our infrastructure — everything that ensures normal life for our people. We need more pro-



tection and faster implementation of all defence agreements, especially on air defence, to deprive this aerial terror of any meaning," he said Sunday (October 5). A nationwide air alert was in place across Ukraine as of 4:09 a.m. (0109 GMT). Poland's armed forces meanwhile said on X that they had mobilised planes and put ground defences on high alert to secure the country's airspace, especially in areas close to Ukraine. The Mayor of Lviv, a western Ukrainian city near the border with Poland, said public transport routes were not operating due to a "massive enemy attack". Public transport in Ivano-Frankivsk, another western city, would "start running later than usual" on Sunday, its mayor said.Mr. Fedorov said on Sunday that Russia's overnight attack left "more than 73,000 consumers... without electricity" in Zaporizhzhia, and the Lviv mayor said part of the city had no power.

RAT gets deployed on Air India's Birminghambound plane; aircraft lands safely

Mumbai: The operating crew of Air India's Amritsar-Birmingham flight reported that the Boeing 787's Ram Air Turbine (RAT) unexpectedly deployed during the final approach on October 4, but the aircraft landed safely, the airline said on Saturday.RAT deploys automatically in the eventuality of a dual engine failure or total electronic or hydraulic failure. It uses wind speed to generate emergency power.Air India said it has cancelled its Birmingham-Delhi flight as the aircraft has been grounded for inspection.

"The operating crew of flight Al117 from Amritsar to Birmingham on 4 October 2025 detected deployment of the Ram Air Turbine (RAT) of the aircraft during its final approach. All electrical and hydraulic parameters were found normal, and the aircraft performed a safe landing at Birmingham," the Tata Group-owned Air India said in a statement. The airline, however, did not share specific details, including the number of people on board. Alternative arrangements are being made to accommodate the passengers, Air India said in the statement.

It may be mentioned here that both engine or hydraulic/ electrical failure or software malfunction are also being cited as among the several probable causes of the Air India Boeing 787 plane crash in June this year. On June 12, Air India's Boeing 787-8 aircraft operating flight AI 171 en route to London Gatwick crashed into a medical hostel complex soon after take-off from Ahmedabad, killing 260 people, including 241 persons who were onboard the plane.India's aircraft accident bureau, Aircraft Accident Investigation Bureau (AAIB), is probing the crash. The AAIB in its preliminary report in July this year said that the engine fuel control switches of the ill-fated Boeing 787-8 plane were cut off seconds after lift off, with one of the pilots asking the other why did he cut off, and the latter responding saying he did not do so, according to AAIB. In its 15-page preliminary report on the crash, which happened within around 30 seconds of the plane lifting off, the Aircraft Accident Investigation Bureau (AAIB) said the fuel control switches were switched on later, but the deceleration in one of the engines could not be stopped.US aircraft maker Boeing has maintained silence on one of the deadliest air crashes in India in the last three decades.

Judge temporarily blocks Trump administration from deploying troops in Portland, Oregon

Portland: A federal judge in Oregon temporarily blocked President Donald Trump's administration from deploying the National Guard in Portland, ruling in a lawsuit brought by the state and city. US District Judge Karin Immergut issued the order pending further arguments in the suit. The plaintiffs say a deployment would violate the US Constitution as well as a federal law that generally prohibits the military from being used to enforce domestic laws.

Immergut wrote that the case involves the intersection of three fundamental democratic principles: "the relationship between the federal government and the states, between the military and domestic law enforcement, and the balance of powers between the executive, legislative and judicial branches of government. "Whether we choose to follow what the Constitution mandates with respect to these three relationships goes to the heart of what it means to live under the rule of law in the United States," she wrote. Generally speaking the president is allowed "a great level of deference" to federalise National Guard troops in situations where regular law enforcement forces are not able to execute the laws of the United States, the judge said, but that has not been the case in Portland.

Plaintiffs were able to show that the demonstrations at the Portland immigration facility were not significantly violent or disruptive in the days or weeks leading up to the president's order, the judge wrote, and "overall, the protests were small and uneventful." "The President's determination was simply untethered to the facts."The Defence Department had said it was placing 200 members of Oregon's National Guard under federal control for 60 days to protect federal property at locations where protests are occurring or likely to occur after Trump called the city "warravaged."Oregon officials said that description was ludicrous. The US Immigration and Customs Enforcement building in the city has recently been the site of nightly protests, which typically drew a couple dozen people in recent

weeks before the deployment was announced. Trump The Republican president has deployed or threatened to deploy troops in several US cities, particularly ones led by Democrats, including Los Angeles, Washington, Chicago and Memphis. Speaking Tuesday to US military leaders in Virginia, the president proposed using cities as training grounds for the armed forces. Last month a federal judge ruled that Trump's deployment of some 4,700 National Guard soldiers and Marines in Los Angeles earlier this year was illegal, but he allowed the 300 who remain in the city to stay as long as they do not enforce civilian laws.

As for Portland, the Defence Department announced that it was placing 200 members of Oregon's National Guard under federal control for 60 days to protect federal property at locations where protests are occurring or likely to occur. That announcement came after Trump called "warravaged" in late September, a characterisation that Oregon officials called ludicrous while saying they do not need or want federal troops there. The US Immigration and Customs Enforcement building in Portland has been the site of nightly protests, and the demonstrations and occasional clashes with law enforcement have been limited to a one-block area in a city that covers about 145 square miles (375 square km) and has about 636,000 residents. A handful of immigration and legal advocates often gather at the building during the day. At night, recent protests have typically drawn a couple dozen people. A larger crowd demonstrated September 28 following the announcement of the guard deployment. The Portland Police Bureau, which has said it does not participate in immigration enforcement and only intervenes in the protests if there is vandalism or criminal activity, arrested two people on assault charges. A peaceful march earlier that day drew thousands to downtown and saw no arrests, police said. Trump sent federal officers to Portland over the objections of local and state leaders in 2020 during long-running racial justice protests following George Floyd's killing by Minneapolis police. The administration sent hundreds of agents for the stated purpose of protecting the federal courthouse and other federal property from vandalism. That deployment antagonised demonstrators and prompted nightly clashes. Federal officers fired rubber bulled and used tear gas. Viral videos captured federal officers arresting people and hustling them into unmarked vehicles. A report by the Department of Homeland Security's inspector general found that while the federal government had legal authority to deploy the officers, many of them lacked the training and equipment necessary for the mission. The government agreed this year to settle an excessive force lawsuit brought by the American Civil Liberties Union by paying compensating several plaintiffs for their

Gazans long for end to war, Rubio says not yet

WASHINGTON/CAIRO/JERUSALEM, U.S. Secretary of State Marco Rubio said on Sunday that war in Gaza has not yet ended despite Israel and Hamas both agreeing to parts of President Donald Trump's plan for the strip, as Gazans called for its quick implementation to end their suffering."We will know very quickly whether Hamas is serious or not by how these technical talks go in terms of the logistics," Rubio told NBC News' "Meet the Press" about the release of hostages from Gaza. Hamas had drawn a welcoming response from Trump on Friday by saying it accepted certain key parts of his 20-point proposal, including ending the war, Israel's withdrawal, and the release of Israeli hostages and Palestinian captives. But the group left some issues up for further negotiation at talks in Egypt, as well as questions unanswered, such as whether it would be willing to disarm, a key demand from Israel to end the war.Israeli negotiators will leave for Egypt tonight and negotiations on the release of the hostages are expected to begin on Monday, the day before the war's second anniversary, said an Israeli government spokesperson. A Hamas delegation, led by the group's exiled Gaza chief, Khalil Al-Hayya, was also expected to land in Cairo later on Sunday, to join representatives of the United States and Qatar for talks over the implementation of the most advanced effort yet to halt the conflict.

The plan has stirred hopes for peace among Palestinians but there was no let up of Israeli attacks on Gaza on Sunday as planes and tanks pounded areas across the enclave, killing at least 16 people, local health authorities said. Four of those killed were seeking aid in the south of the strip and five were killed in an airstrike in Gaza City in the early afternoon, they said. Shadi Mansour stood in the destruction left by an Israeli airstrike in the Gaza City suburb of Tuffah on Saturday, which killed his son Ameer, 6, and 16 other people.

Why is a spectre of empty classrooms looming? | Explained



The story so far: The State of Tamil Nadu has sought a review of a Supreme Court judgment requiring in-service teachers from Classes 1-8 in non-minority schools across the country to clear the Teachers' Eligibility Test (TET) in two years or be "compulsorily retired". Other States have equally voiced concern about the September 1 judgment and its harsh lesson to lakhs of teachers validly employed in government, aided, unaided and private schools mentioned under Section 2(n) of the Right of Children to Free and Compulsory Education (RTE) Act, 2009. They are likely to follow Tamil Nadu to the top court.

What is the situation in Tamil Nadu?

Tamil Nadu alone employs 4.49.850 teachers in government and aided schools, of whom 3,90,458 are not TETqualified. The States have argued that if the judgment is implemented, the entire school system faces the imminent prospect of collapse, with mass disqualification of teachers and denial of classroom instruction to millions of children. Tamil Nadu argues that the judgment provokes a direct conflict with Article 21A (fundamental right to free and compulsory education for children aged six to 14) of the Constitution. The State has sought a balance between ensuring quality of education and safeguarding the right to educa-

What did the judgment mandate?


The two-judge Bench of Justices Dipankar Datta and Manmohan is not unaware of the ground realities. Justice Datta, who authored the September 1 judgment, acknowledged the contributions of non-TET qualified teachers appointed prior to the RTE Act. The court agreed that dislodging elementary school teachers was a "bit harsh" as they have taught students for decades without any serious complaints. Hence, the court, invoking Article 142 of the Constitution, has exempted teachers with less than five years left to retire from taking the TET. However, they would have to clear the TET if they seek promotion. But teachers who have more than five years of service must mandatorily qualify for the TET within two years from the date of the judgment. If they fail, they would have to quit service or be retired with terminal benefits. Future appointments or promotions for teachers in non-minority schools would necessarily require TET qualification. Further, the two-judge Bench

judgment referred to a larger Bench the question whether minority educational institutions ought to be also included under the purview of the RTE Act. The court noted that the minority status was being misused by school managements to circumvent the mandate of the RTE Act to have TETqualified teachers conduct elementary education. The judgment was based on a batch of appeals questioning school education departments' insistence on faculty clearing the TET in minority institutions. The two-judge Bench criticised a 2014 Constitution Bench judgment in the Pramati Educational and Cultural Trust case, which took minority institutions entirely outside the ambit of the RTE Act. The September 1 judgment made a strong pitch to bring schools run by minorities — whether religious or linguistic — into the RTE fold as the 2014 judgment had "unknowingly jeopardised the very foundation of universal elementary education". It said the exemption of minority institutions from the RTE Act has led to "fragmentation of the common schooling vision and weakening of the idea of inclusivity and universality envisioned by Article 21A".

What do the review petitions argue?

Review petitions filed by Tamil Nadu and a Keralabased teacher's union, Deseeya Adhyapakha Parishad (NTU) Kerala, argues that "even if the objective of enhancing teaching quality is accepted as legitimate, compelling pre-RTE Act appointees to pass TET on pain of disqualification is manifestly disproportionate". Tamil Nadu recommended "less intrusive alternatives" like in-service training, capacity building, refresher courses, or bridging programmes to achieve the same goal without destabilising the education system. At the centre of the controversy is the interpretation of Section 23 of the RTE Act. As per 23 (1), the National Council for Teacher Education (NCTE) has laid down minimum qualifications for a person to be eligible for appointment as a teacher in Classes one to eight, through its notification on August 23, 2010. An essential qualification is passing the TET conducted by the appropriate government. The rationale for including the TET is to bring national standards and the benchmark of teacher quality in the recruitment process. In its review petition, Tamil Nadu contended that Section 23(1) would apply only to future recruitment of teachers. The State refers to Section 23(2) which empowers the Centre, through notification, to relax the minimum educational qualifications for appointment of teachers for a limited period not exceeding five years in case States have to deal with contingencies of dearth of teachers or institutional shortages. A proviso appended to Section 23 also makes it clear that any teacher who, at the commencement of the RTE Act, did not possess the minimum qualifications (TET) must acquire such qualifications within a period of five years. Section 23 does not call for a "blanket mandate" for TET nor could the interpretation of the provision be stretched to retrospectively disqualify teachers who were validly appointed before the notification of minimum qualifications (TET), Tamil Nadu submitted in its review plea. The State said the September 1 judgment raises the spectre of "empty classrooms" and distracted teachers scrambling to save their livelihood for the next two years.

What is Nagaland's job quota issue? | Explained



The story so far: On April 26, an organisation of five "advanced" tribes in Nagaland set the Neiphiu Rio-led government a 30-day deadline to revise the job reservation policy for the State's Backward Tribes (BTs). The government formed a panel on September 22 to examine the job quota policy, but the five-tribe body found fault with its nomenclature.

What is the job reservation policy?

Almost four years after it attained statehood in December 1963, Nagaland introduced a policy to reserve 80% of State government jobs for all indigenous Scheduled Tribes. The government identified 11 BTs in 1977 and apportioned for them what came to be known as "reservation within a reservation". In August 2024, Chief Minister Neiphiu Rio told the 60-member Nagaland Assembly that 37% of non-technical and non-gazetted jobs are currently reserved for BTs. He said this quota is divided into 25% for seven BTs in eastern Nagaland comprising six districts — Kiphire, Longleng, Mon, Noklak, Shamator, and Tuensang — and 12% for the remaining four BTs. An April 2011 notification from the State's Personnel and Administrative Reforms Department said the Chakhesang and Pochury tribes inhabiting Phek district will be clubbed together for half the 12%, while the Zeliang tribe will have 4% of government jobs reserved for them, and the remaining 2% will be reserved for the Sumi tribe in Kiphire district. Beyond Kiphire, the Sumis are among the five non-BT communities along with the Angamis, Aos, Lothas, and Rengmas.

Why do the tribes want this policy revised?

In September 2024, the Five Tribes Committee on Review of Reservation Policy (CoRRP) submitted a memorandum to the State government, requesting an assessment of the job quota system. The members of this committee are representatives of the apex social bodies of each of these five tribes. The committee argued that the policy was relevant in 1977, but it no longer reflects the prevailing socio-economic and educational landscape of the State. Its secretary, G.K. Zhimomi, said that the CoRRP's core demand was to "either scrap the reservation policy altogether or allocate the remaining unreserved (20%) guota to the five tribes." He also said the government went back on a move to review the policy in 1987 and issued an order two years later, stating that the quota slabs would continue until further notice. The CoRRP set its first 30-day deadline on April 26 for the government to act on its demand for a review. "We are not against any tribe benefiting from the reservation policy. A review of this 48-year-old policy is long overdue because of the vastly different scenario now," they

How did the government respond?

Reacting to the CoRRP's demand, student and social organisations of the BTs listed as beneficiaries of the job quota opposed any potential revision, arguing that the dilution of the current policy would disproportionately harm the State's marginalised communities. Wary of a backlash from these tribes, the government chose to tread carefully. The CoRRP launched its initial phase of agitation after the expiry of its 30-day ultimatum. It was suspended after Deputy Chief Minister Yanthungo Patton assured them that a commission to review the policy would be constituted by June 17. However, Mr. Rio remarked that any significant administrative reforms, including those related to reservations or delimitation, should be undertaken only after the national Census exercise scheduled for 2027. On August 6, the State Cabinet approved the constitution of a seven-member Job Reservation Commission to be headed by a retired IAS officer of the Nagaland cadre. The following day, government spokesperson and Minister K.G. Kenye cited official data to claim that the five non-BT tribes hold 64% of the government jobs while the BT tribes hold 34%. He indicated that the status quo needed to be maintained.

Why does the stalemate continue?

The CoRRP criticised the first commission announced in August as it accommodated a member each from the Eastern Nagaland People's Organisation, the Central Nagaland Tribes Council, and the Tenyimi Union Nagaland. They insisted that this commission lacked neutrality as these three organisations represented the BTs wholly or partially. The CoRRP also found fault with the second commission the government announced on September 22. They said that the government deviated from an agreement to name this panel 'Job Reservation Commission' instead of 'Reservation Review Commission', thus implying it was not serious about reviewing the existing quota system. The difference over the panel's nomenclature is yet to be resolved.

How is India responding to crowding disasters? | Explained

The story so far: On September 27, a political rally by actor and Tamilaga Vettri Kazhagam (TVK) founder Vijay in Tamil Nadu's Karur district ended in a fatal crowd crush in which 41 people were killed. Chief Minister M.K. Stalin appointed a one-person commission headed by retired judge Aruna Jagadeesan to examine the tragedy's causes. He said rules for public events would be framed once the commission submitted its report.

What happened in Karur?

The event was part of Mr. Vijay's first State-wide political tour. TVK organisers initially presented a list of four central business locations in Karur for the rally, but the police rejected them as they were too congested and instead granted permission for Velusamypuram on the Karur-Erode road, where other political parties had previously held events. The organisers said Mr. Vijay would speak at 12 p.m., and supporters began assembling from 9 a.m. He was delayed however, and as the day wore on, the crowd grew steadily, with several thousands gathering in the evening. By the time Mr. Vijay reached Karur from Namakkal around 6 p.m., his convoy could not access the meeting spot because of the crowd. The congestion worsened when the gathering was forced to make way for his vehicles. Witnesses described having no space to move. Residents also recalled younger people climbing poles and transformers to get a glimpse of the actor while others said the event's timing coincided with evening wage disbursals for textile workers, adding to congestion in the area. As the programme began around 7.20 p.m., people started fainting in the crowd. When the situation deteriorated further, Mr. Vijay departed from the spot and ambulances began to arrive soon after, taking injured people to government hospitals in Karur, Namakkal, and Tiruchi. By nightfall, dozens were reported dead and scores injured. Many of the 41 people who died were young adults aged 18-30.

What has India done to manage crowds?

At the national level, the Bureau of Police Research and Development (BPR&D) published its most recent Comprehensive Guidelines on Crowd Control and Mass Gathering Management in June 2025. These guidelines, intended for police and other law enforcement agencies, emphasise scientific crowd management practices. The National Disaster Management Authority has maintained its "Managing crowd at events and venues of mass gathering" guide since 2020 alongside "suggestive frameworks" for crowd management plans. These documents recommend advance risk assessment, detailed site layout plans, predetermined ingress and egress routes, real-time monitoring, and communication protocols. The National Institute of Disaster Management (NIDM) has run training modules to handle large congregations as part of its capacity-building programmes. After the crowd crush at a New Delhi railway station in February, the Indian Railways updated its manuals for around 60 stations with high footfall by introducing holding areas, better dispersal zones and crowd monitoring, among others. These measures are mostly advisory, however, and not statutory

What measures have States introduced?

Following a deadly stampede outside M. Chinnaswamy Stadium in Bengaluru in June 2025, the Karnataka government tabled the Crowd Control (Managing Crowd at Events and Venues of Mass Gathering) Bill, 2025. This instrument covers political rallies, conferences, cultural programmes, and other events, and fixes responsibility on organisers. It also empowers district magistrates to cancel or redirect events, regulate the use of loudspeakers, and impose fines



and imprisonment for violations. The Uttar Pradesh State Disaster Management Authority issued the Guidelines for Managing Crowd at Events of Mass Gathering, 2023 — a document that formalises measures for religious and cultural events. The Gujarat Institute of Disaster Management prepared training materials that include technical instructions on calculating site capacity, planning exits, training volunteers, and ensuring first aid and fire safety. After a stampede at the Mansa Devi temple in Haridwar in July, the Uttarakhand government ordered safety arrangements at major temples to be updated and directed authorities to remove encroachments around shrines. The Maharashtra government introduced a Bill in 2025 empowering the Nasikrimbakeshwar Kumbh Mela Authority to authorise temporary townships and bypass certain urban planning norms so that facilities can be created for large gatherings.Local enforcement agencies have supplemented these steps with operating protocols. After the Bengaluru incident, for instance, the Karnataka police circulated a new Standard Operating Procedure to control crowds at public functions and detailed responsibilities for coordination between departments, medical preparedness, and fire safety. In many districts across States, the police have also directed organisers of large religious or political gatherings to prepare crowd management plans, limit crowd size, deploy medical teams, set up temporary barricades, and divert routes. These orders are still only administrative and aren't backed by a law. Most State-level initiatives have also been introduced after specific accidents: the Uttarakhand directives followed the Haridwar stampede; Tamil Nadu's announcement after the Karur rally deaths: Karnataka's Bill after the stadium incident; and Maharashtra's Bill after incidents related to the Prayagraj Kumbh Mela.

What is scientific crowd control?

According to prevailing scientific wisdom, safely navigating a crowd depends on controlling its density and sidestepping hazardous flow patterns. Modelling studies have shown that the risk of a deadly crush escalates when crowd density approaches 5 persons per sq. m. Since cameras on drones linked to computers on the ground can continuously monitor crowd density, not using such technologies to manage crowds is seen as a shortcoming. Second, crowds should never be channelled into bottlenecks, slopes or counter-flows because they magnify pressure and destabilise movement. In a moving crowd, individuals are advised to move diagonally, towards the less dense edges, and to avoid resisting the flow. Because compressive asphyxia rather than trampling is the main cause of fatalities, individuals should keep their forearms across the chest to protect their breathing space and maintain balance with staggered footing. If one is knocked down, rolling to the side and shielding the head and neck while attempting to rise quickly is recommended.

When a Chennai-based influencer and her partner drugged and killed her children in 2018

When Vijay, a bank loan mediator, and Abirami got married in September 2011 and moved into their modest home near Kundrathur, everything seemed calm, with no hint of the storm that would one day tear their lives apart.In the years that followed, the couple had two children and settled into what appeared to be an ordinary family life. Meanwhile, Abirami began gaining popularity online as a local social media 'reels star', nicknamed 'Biryani Abirami' for her food-related content. But things began to change when she met Meenakshi Sundaram, a biryani delivery agent at a shop frequently visited by her and her family.On August 30, 2018, Abirami's neighbour saw her leave home on her two-wheeler, with Meenakshi Sundaram on the pillion. The neighbour recalled overhearing him tell Abirami: Give them the tablets and inform me when it is done

When guestioned later, Abirami, then 25, told the neighbour that her children were unwell and that Meenakshi Sundaram had been referring to their medicine. However, the neighbour remembered seeing him at Abirami's house on at least two occasions previously. At the time, Abirami had introduced him as a family friend. Still, something about the exchange that day did not sit right, the neighbour later recalled. What no one around them yet knew was that Abirami and Meenakshi Sundaram were entangled in a relationship, one that would soon culminate in the tragic deaths of her two children, at the hands of their own mother. A pre-

That same night, after Vijay, then 30, returned home from work, Abirami brought him a glass of milk, the same milk she had already given to their two children, Ajay, 6, and Karnika, 3. When Vijay took a sip, he found it bitter. Abirami said it was because she had forgotten to add sugar, but Vijay, already tired, said he did not want it anymore and went to bed. He woke up later than usual the next day. As he hurried to get ready for work, he asked why Abirami had not cooked anything yet. She told him that she and the children were going to her mother's house in Periyapanicheri, and they would eat there. Before leaving, Vijay asked what their youngest was doing; Abirami said she was asleep. Normally, Vijay would kiss his daughter goodbye before heading to work, but that morning, when he approached her, Abirami pulled him back, saying the child had been coughing all night and had not slept well, and that he should not disturb her. At that moment, their son was sitting in front of the television. Vijay looked at him and said, "I will go and come back, son," before heading out for the day.

Around 3.30 p.m., Abirami called Vijay and told him they were heading to her mother's house. She also reminded him that it was his birthday, and asked him to come over.In the meantime, according to police records, Abirami went to a pawn broker's shop, hoping to pledge a gold chain. The broker told her he could offer only ?12,000, but she insisted she was unwell and urgently needed money. She then asked him to buy the chain outright, and he paid her ?17,000 in

Vijay, meanwhile, had to work through the day and night. On the morning of September 1, 2018, he tried calling Abirami several times, but there was no response. Concerned, he contacted her younger brother, who told him that neither Abirami nor the children were at their mother's house. Worried, Vijay left for Periyapanicheri. About 20 days earlier too, Abirami had gone missing from home. At the time, Vijay had no idea where she was, but their son Ajay had told him that she often visited a house nearby, belonging to "an uncle" named Meenakshi Sundaram. Ajay also said he could identify the house. With the boy's help, Vijay had tracked Abirami down and brought her back home. This time, suspecting a similar situation, Vijay went to Meenakshi Sundaram's house in Kundrathur, accompanied by his brother-in-law. However, Abirami was not there. When they returned to Vijay and Abirami's house near Kundrathur, they found the door merely latched, not locked. Inside, both children were lying on the bed, tucked under the bedsheets up



to their necks. At first, they appeared to be asleep. But when Vijay tried to wake them, it slowly dawned on him that they were no longer alive. How the case unfolded Vijay rushed to Kundrathur police station and lodged a complaint that his children were dead and their mother was missing. Then Inspector of Police, Kundrathur, Charles, began the investigation after sending the bodies of children for post-mortem. The police noted that Abirami's two-wheeler was missing from the house. On the same day, the police scrutinised call records and went to the two-wheeler parking lot located behind the Koyambedu bus stand. They checked the CCTV footage recorded between 4.42 p.m. and 5 p.m. on August 31, 2018, the previous day. The footage showed Abirami bringing the vehicle inside, and later boarding a bus. The police investigation revealed that Abirami had travelled to Nagercoil and attempted to take a room in a hostel there.

Based on information of her return, on the morning of September 2, as a police team lay in wait at the parking lot — her scooter in view — Abirami and Meenakshi Sundaram turned up, and she tried to ride away with him on the pillion. When the police chased them, they fell off th vehicle and were caught. According to the police, Abirami confessed to murdering her children. Her mobile phone and two-wheeler were seized as part of the investigation. During interrogation, Abirami told officers that she had met Meenakshi Sundaram, who worked at a biryani shop, about two months earlier. Wanting to live with him, she said she decided to kill her husband and children. Both Abirami and Meenakshi Sundaram were arrested.

The police charged the two accused with premeditated criminal conspiracy, alleging that the plan was carried out under the instigation of the second accused, Meenakshi Sundaram. According to the charges, the first accused, Abirami, mixed sedatives into the milk given to her children. Both were later remanded to judicial custody. The postmortem report said the children appeared to have died of systemic absorption of the drugs consumed. Charges under Sections 302 (murder) of the Indian Penal Code (IPC) were filed against the first accused Abirami, and under Sections 302, read with 109 (abetment), against the second accused Meenakshi Sundaram. The case was taken up by the District Mahila Court, Chengalpattu, on November 29, 2018, and during the trial, 25 witnesses were examined and 23 exhibits were marked. The case was later transferred to the Principal District Sessions Court, Kancheepuram. At the conclusion of trial, Principal District Sessions Judge P.U. Chemmal pronounced the judgment in July this year

The Right to Education Act and minority educational institutions



The Supreme Court on Monday cast doubt on a Constitution Bench judgment from a decade ago that exempted minority educational institutions from the provisions of the Right of Children to Free and Compulsory Education Act, 2009 (RTE Act). A two-judge Bench of Justices Dipankar Datta and Manmohan, while deciding on whether the Teacher Eligibility Test (TET) was mandatory for minority schools, held that the ruling in Pramati Educational and Cultural Trust v Union of India (2014) requires reconsideration by a larger Bench of the SC.

The court observed that by taking minority schools out of the ambit of the RTE Act, the Pramati judgment may have jeopardised the fundamental right to quality education for children studying in them. The two-judge Bench ruled on a batch of appeals on whether (i) TET could be made mandatory for teachers in minority schools, and (ii) in-service teachers in non-minority schools who were appointed before the RTE Act came into force, must pass TET to be eligible for promotion or continue in service. TET is the minimum qualification for appointment as teacher for Classes 1

The court referred the issue of the applicability of the RTE Act to minority schools to a larger Bench, and passed a nuanced order for in-service teachers of non-minority schools. It directed that teachers with less than five years of service remaining may continue in their jobs without clearing TET, although they would have to pass the test in order to be promoted. Teachers with more than five years left for retirement must clear TET within two years. (Anjuman Ishaat e Taleem Trust v. The State of Maharashtra)The Bench said that the verdict in Pramati appeared "legally suspect", "questionable", and "disproportionate" because the five-judge Bench had struck down the applicability of the entire RTE Act to minority institutions based almost entirely on its analysis of a single provision of the Act — Section 12(1)(c). This section requires all schools to reserve at least 25% of seats in Class 1 for "children belonging to weaker sections and disadvantaged groups in the neighbourhood". The court pointed to a critical conflict created by the sweeping exemption: While Article 30(1) of the Constitution protects the right of minority groups to establish and administer their institutions, Article 21A guarantees every child a fundamental right to education. Therefore, the Bench reasoned, exempting minority schools from the Act denies children studying in them the statutory benefits and protections that flow from the fundamental right under Article 21A. The Bench called for a harmonious interpretation where the rights under Article 21A and Article 30(1) "can and must co-exist mutually" rather than one being treated

as an "unqualified trump card" over the other. What Pramati ruling heldThe five-judge Constitution Bench was deciding the validity of The Constitution (86th Amendment) Act, 2002, which introduced Article 21A, and The Constitution (93rd Amendment) Act, 2005, which introduced Article 15(5) in

Article 21A established education as a fundamental right; Article 15(5) allowed the state to make special provisions for backward classes, SCs, and STs in educational institutions, including private educational institutions, 'whether aided or unaided by the State, other than the minority educational institutions". Pramati upheld the validity of both amendments, but ruled that the RTE Act was unconstitutional "insofar as it applies to minority schools, aided or unaided, covered under clause (1) of Article 30...". The court reasoned that the unique character of minority institutions must be protected. It feared that forcing these institutions to comply with the RTE Act would lead to an "abrogation" of their fundamental right under Article 30(1) to "establish and administer educational institutions of their choice". The judgment said that a "legal obligation [under Section 12(1)(c)] to admit children belonging to weaker sections and disadvantaged groups in the neighbourhood who need not be children of the members of the minority community...cannot be forced upon a minority institution because that may destroy the minority character of the school". The Act guarantees free elementary education for children of ages 6-14. Government schools are required to provide free education to all enrolled children; aided schools must provide free seats proportionate to the aid they receive. Private unaided schools are required to reserve 25% of entry-level seats for children from disadvantaged groups, reimbursed by the state (Section 12(1)(c)). The Act sets minimum standards of pupil-teacher ratios, trained teachers, infrastructure, and libraries, bans corporal punishment and capitation fees, and places an obligation on all schools to contribute to universal education.R Govinda, who was instrumental in drafting the RTE, wrote in the Routledge Companion to Primary Education in India (2023), that "the BTE Act is child-centric and not institution-centric". Govinda told The Indian Express: "We believed [the Act] was about the fundamental right of the child, not the administrative rights of schools. There was no need to exempt minority institutions. The right of an individual child should be held higher than the collective right of groups to run institutions as they wish."The two-judge Bench cited a study by the National Commission for Protection of Child Rights, which found that only 8.76% students in minority schools were from disadvantaged backgrounds, and that 62.5% of students belonged to non-minority communities.

'This is indicative of many institutions labelled as 'minority' not serving their communities exclusively, but continuing to enjoy exemption from inclusionary mandates," the Bench said. After the RTE Act came into effect in 2010, private schools and minority groups complained that the 25% quota infringed on their autonomy, and the law was challenged in court. In April 2012, a three-judge Bench upheld the Act, but it exempted unaided minority institutions, ruling that quotas would "change their character" and breach Article 30(1). The 2014 ruling extended the exemption to all minority schools, regardless of whether they received government aid or not. Following the judgment, many private schools were alleged to have sought minority status sometimes with only a token minority management — to escape RTE compliance. Dr Latika Gupta of the Department of Education at Delhi University said: "Many so-called minority schools that were essentially private institutions with a minority label could escape norms. They did not admit poor children from their own community and continued as

Why Gurgaon comes to halt after heavy rain but Noida does not



On Monday, the Millennium City of Gurgaon witnessed kilometres-long traffic jams on key stretches in the peak hours in the evening after just 100 mm of rain. Commuters said they were stuck for hours in the traffic caused due to waterlogging — their woes yet again raised guestions over Gurgaon's urban planning and development. Year after year, residents complain of the traffic coming to a standstill even after moderate rainfall. Noida, the other suburban city in the NCR, however, sees fewer instances of waterlogging and traffic snarls in such situations. The city was established in 1975 during the Emergency when Sanjay Gandhi, son of then Prime Minister Indira Gandhi, wanted to move industries out of the national capital. Governed by the New Okhla Industrial Development Authority (NOIDA), Noida, which has eventually been pitched as the state's economic powerhouse, was developed under the Uttar Pradesh Industrial Area Development Act, 1976, as an industrial township. Experts say that Noida was a planned "greenfield" city, developed on entirely new, undeveloped land. Infrastructure, like roads, sewers, drain pipes, footpaths and streetlights, was laid out after the land was acquired all at once by the development authority, according to PSN Rao, Professor of Housing, School of Planning and Architecture, Delhi.Commuters make their way through a waterlogged road amid rainfall, in Gurugram, Monday Commuters make their way through a waterlogged road amid rainfall, in Gurugram, Monday. (PTI)It was then that the private developers came into the picture and plugged into the common infrastructure. Nearly half a century back, the acquired land comprised 50 villages and having a total area of 14,915 hectare (36,841 acres). Currently, it covers 81 villages and a total of about 20.316 hectares of land. "Proper planning was done for Noida and thus, a drainage and road network proportionate to the built infrastructure was built," says Mukta Naik, an urban researcher formerly with the National Institute of Urban Affairs and the Centre for Policy Research.Gurgaon, on the other hand, was developed in a public private partnership (PPP) mode," Rao points out as he explains how land parcels of different sizes and shapes at various locations were acquired and developed by private developers, most prominent among them being

DLF. "While the external infrastructure was developed by

the state government, internal infrastructure was not linked

to it properly," he adds. The Indian Express previously reported that the Haryana government — from the 1970s onwards — introduced a series of laws, which enabled private firms to acquire land on a large scale to develop townships. Land acquisition was not carried out in a uniform manner. This led to irregular plots, and roads that led to nowhere. The Aravalli ridge, on the southern edge of Gurgaon, is the natural high ground for the city, the report pointed out. From there, the land slopes down towards the north, which is at a lower altitude. Rainwater in Gurgaon thus flows mainly from the south to the north, towards the Najafgarh Jheel in West Delhi. The natural drainage channels have disappeared now, and haphazard urban expansion has not kept the city's topographic reality in mind, ac-

Don't judge food by its packaging, learn to read the food labels

Hyderabad: Most of the food that we consume today is pre-packaged and processed. A major reason why, as customers, people should think twice before they blindly reach out to pick their favorite food product from the shelves of the supermarket. For the past year or so, a concerted effort on the part of doctors, nutritionists and food scientists, is underway to make people aware about the importance of properly reading and understanding food labels, so that they can make an informed choice. It is a fact that most of the customers are unaware of how to read a food label. So, what are the most important pieces of information on the back of the colourful food packet that can help them make a safe purchase? In its guidelines on how to properly read food labels, especially nutrient information on the label, the NIN researches advise "If the label states, two servings for the entire packet and the calorie content is 100 calories per serving, then use of the entire packet would imply consumption of 200 calories. Always remember, 'fat-free' does not always mean 'calorie-free'. The food scientists also urge the public to look closely and check for 'energy' coming from carbohydrates and sugars. "Pay attention to sugars, especially added sugars, to reduce risk of obesity and NCDs. select food that are low in refined carbohydrates and total fat content, especially saturated fats and those that contain no trans-fat

China's parade, Asia's divide



The brief video of Prime Minister Narendra Modi holding hands with Chinese leader Xi Jinping and Russian President Vladimir Putin at the Shanghai Cooperation Organisation (SCO) summit in Tianjin has gone viral. The three-way handshake, occurring against the backdrop of US President Donald Trump's relentless effort to bully friend and foe alike, symbolises a moment when major powers are jockeying for geopolitical advantage. Yet a photo-op does not a grand alliance make. If anything, the impracticality of a Eurasian coalition against America is highlighted by Modi's absence from China's spectacular military parade in Beijing on Wednesday to mark its victory in World War II. Xi will preside over the display of the People's Liberation Army's (PLA) formidable military prowess in Tiananmen Square. Modi's decision to skip the parade underlines India's continuing distance from Beijing's efforts to reinterpret the past for present purposes. Those who claimed that the SCO handshake buried the Quad will note that Modi's absence puts him in the same company as the leaders of Australia, Japan, and the United States, who will also stay away.

In September 1945, Imperial Japan surrendered, ending the war in Asia. In Europe, the victors and a defeated Germany collectively mark the end of hostilities. Asia, however, remains divided in its memory. Reconciliation is elusive even eight decades later. China calls its commemoration, "The Chinese People's War of Resistance Against Japanese Aggression and the World Anti-Fascist War". Yet the military parade, arguably, is less about the past and more about enduring rivalries. Beijing seeks to mobilise nationalist sentiment against Japan and position itself as Asia's pre-eminent power. Tokyo, unsurprisingly, urged countries not to attend. Australia, India, and the US — all critical to the Allied victory in Asia — declined invitations, as did Britain, France, and the Netherlands (the European powers with a major presence in Asia in World War II). For the Quad powers, participation would have been less about celebrating the shared struggle of 1945 than legitimising China's aspirations for the domination of Asia. By contrast, many Southeast and Central Asian leaders have shown up in Beijing. Their attendance is less about the War's memory than about signalling positive sentiments towards China. One notable absence is the Philippines, a major theatre of World War II. It is now at the receiving end of Chinese military power in the South China Sea.

Why does the memory of the same war divide Asia so sharply? Because national experiences differed profoundly. China endured 14 years of brutal Japanese occupation, but the war was also about the communists' triumph over the nationalists. Korea suffered colonisation and then division. Southeast Asia welcomed as well as fought a rising Japan in Asia. India's experience was equally complex. Its emerging nationalist elite was divided in its response to the War, and it also suffered the division of the nation on religious lines. The Indian Army fought the Japanese in Burma and took the surrender of Japanese forces in Rangoon, Singapore, Jakarta, and Hanoi. Yet there was also the Indian National Army (INA), led by Subhas Chandra Bose and backed by Tokyo. For Bose, an alliance with Japan was a path to independence from Britain.

Bose's INA also underlines the complexity of the regional memory of Japanese imperialism. Japan styled itself as Asia's liberator from European colonialism. Its slogan, "Asia for Asians", had much resonance in the region. Nationalists in Burma, Indonesia, and Indochina initially welcomed Tokyo's promise of solidarity and support. Japan trained militias, weakened European colonial rulers, and briefly inspired hopes of independence. But the occupation soon revealed its brutal face — resource plunder, forced labour, and repression. For much of Asia, Japan became both the oppressor and midwife of decolonisation. If Indian and Chinese nationalists shared an anti-imperial sentiment, why did they not collaborate? The answer lies in the adversaries they faced. India's battle was against Britain, China's against Japan. Indian nationalism was deeply divided. Gandhi refused to back Britain's war effort, launching Quit India in 1942. Bose allied with Japan and raised the INA. The Indian communists, a powerful force then, initially dismissed the War as an "inter-imperialist" conflict. After Nazi Germany attacked the Soviet Union, they became staunch supporters of the anti-fascist war.

The Chinese nationalist leader Chiang Kai-shek's 1942 visit to India and his meeting with Gandhi did little to bridge the gap. China, which found itself on the side of the victorious Allies, gained much in the post-War settlements and the permanent membership of the UN Security Council. Despite its massive contributions to the Allied victory, India got little to show for it after the War thanks to its internal divisions. Indian and Chinese nationalist movements failed to find solidarity at a critical juncture in the 20th century despite their shared sense of anti-imperialism. Since then, their repeated efforts to find common ground have been unsuccessful. That situation has not changed with an hour-long meeting between Modi and Xi in Tianjin on Monday. Modi's refusal to attend the Beijing parade underscores the deep divergence in how Delhi and Beijing interpret the past and envision Asia's future. South Asia is well represented at the parade, with Afghanistan, Bangladesh, the Maldives, Myanmar, Nepal, and Pakistan sending delegations. Pakistan's army chief, Asim Munir, who will be at the parade today, might well claim credit for the undivided Indian Army's contributions to victory in Asia — a historical irony that should not be lost on Delhi. When the PLA goose-steps across Tiananmen Square, Asia will be reminded of a war that deeply divided the region. The military spectacle in Beijing today may project unity, but the guest list reveals division. The real challenge for Asia is not simply to remember the past but to escape being trapped by it. For India, the challenge is more complex. World War II left Delhi struggling with the consequences of the geopolitical fragmentation of the Subcontinent and Partition. The Indian elite's misreading of the politics of that era proved costly. Today, the stakes are equally high. India risks repeating the error if it fails to grasp the dynamic interplay between Washington, Moscow, and Beijing and define a clear sense of its own interests. Studying in the US: How the rules could change, and what students already in America should do now

On August 28, the Department of Homeland Security (DHS) published a draft regulation that would abolish the "duration of status" (D/S) system, which has for nearly half a century allowed F-1 academic students and J-1 exchange visitors to remain in the US for as long as they were enrolled full-time, and were compliant with visa rules. The government has now proposed to impose a stay ceiling of four years, beyond which the student visa holder will have to apply to the DHS for an 'extension of stay' (EOS). There are more than a million international students in the US, a third of whom — more than 330,000 — are from India.

What is duration of status, and why does the DHS want

Currently, no expiry date is put on the I-94 records of students who are admitted to the US on F-1 visas. (Form I-94 is used by Customs and Border Protection (CBP) to record the arrival and departure dates of people visiting the US.)Instead, their stay is marked as "D/S", which means they can remain for as long as they are enrolled full-time. Compliance is overseen primarily by universities through Designated School Officials (DSOs), and reported to the Student and Exchange Visitor Information System (SEVIS), the student tracking system of the DHS.It has pointed to cases of students staying on for decades in the US, moving from one program to another, and sometimes enrolling in language schools after obtaining advanced degrees.In 2023, the suspected overstay rate among F-1 visa holders was estimated at 2.69%, a significant number given the very large number of F-1 and J-1 admissions to the US.F-1 admissions had risen from about 260,000 in 1980-81 to more than 1.6 million in 2023; J-1 exchange visitor admissions had grown 250% since the mid-1980s to cross half a million in 2023. These numbers "pose a challenge to the Department's ability to monitor and oversee" such visa holders, according to officials. It is argued that assigning fixed end dates will allow the government to reassess compliance more regularly and reduce opportunities for abuse.

What specific changes have been proposed to the existing system?

Students can stay for up to four years or until the end date of their program, whichever is sooner.* To stay longer - to complete a degree, pursue Optional Practical Training (OPT), or enrol for a PhD — they would have to apply for an EOS with US Citizenship and Immigration Services (USCIS) under the DHS. This would involve filing Form I-539 (application to extend non-immigrant status), paying fees, providing financial evidence, and submitting their biometrics. DHS may also call applicants for an interview.* The grace period after completing studies would be reduced from 60 days to 30 days.* Transfers between schools would be restricted: undergraduate students will have to complete an academic year before moving to another school; graduate students will not be able to change programs midcourse.* Students will not be allowed to start a new degree at the same or lower level while staying in F-1 status, which will effectively end the practice of doing a "second Master's".* The duration of language study will be capped at 24 months. "Everybody's going to start having an end date..., initially four years; if you need more time, you have to apply for an extension," Houston-based immigration at-



torney Chand Parvatheneni told The Indian Express. The change in the system will create a new layer of unpredictability, Parvatheneni said: "Until now, as long as the school was confirming someone was enrolled, USCIS did not get involved. Now USCIS could approve or deny. So for somebody spending a lot of money to study, there could be some uncertainty if it takes more than four years."

Who will be impacted the most if the rules change in

Students in short Master's programs may not be directly affected, but anyone in a longer program or seeking work experience through OPT, will be impacted. A two-year Master's followed by three years of STEM OPT already exceeds the four-year cap. PhD programs, which often take 5-6 years, would almost certainly require one or more extensions. "What this means is at some point, many might have to apply for extension. Anybody who has a possibility of crossing four years has to understand that they do have to go back to USCIS and apply," Parvatheneni said. The elimination of the second Master's route closes a popular fallback option for Indians who miss out on an H-1B visa (meant for specialty occupations). "Previously, many people used to do a second Master's because they weren't getting through with the H-1B lottery. Now that option might be closed. One of the alternatives is probably looking at a PhD," Parvatheneni said.

What happens to students who are already in the US?

The State Department and CBP will continue to admit students under the D/S system until a final rule is put in place. The Student and Exchange Visitor Program (SEVP) of the US Immigration and Customs Enforcement (ICE) has informed universities that this is currently only a proposal, and students need not take any action at this time. "On the day this news came out..., people assumed the rules were final. I got a lot of messages... We had to tell people this is just a draft, not a final rule," Parvatheneni said. If and when the rule is finalised, there will be transition provisions, DHS has indicated. Current students will be given fixed end dates based on their existing I-20s (certificate of eligibility for F-1 status issued by SEVP-certified schools), plus a one-time grace period. They would have to comply with the new

When could this proposed rule come into effect?

Stakeholders have until September 29 to submit comments on the proposal. Comments on paperwork and SEVIS changes are due by October 27.DHS must then review and respond to submissions before issuing a final rule. If the process moves forward, the changed rule could take effect in early or mid-2026.

In an effort to prevent a spike in airfares during the festival season, aviation regulator Directorate General of Civil Aviation (DGCA) has asked airlines to deploy additional capacity to meet the demand surge, the Ministry of Civil Aviation (MoCA) said Sunday. Consequently, IndiGo, Air India, Air India Express, and SpiceJet would cumulatively add over 1,700 flights, the

carriers have informed the regulator.

According to the ministry, the DGCA will "maintain rigorous oversight of airline fares and flight capacities to protect passengers' interests during the festive season". Amid high festival travel demand in autumn, particularly around Diwali, domestic airfares tend to see major spikes. India's export of computer services has increased by 30 per cent since artificial intelligence firm OpenAl launched ChatGPT in November 2022, according to Franziska Ohnsorge, World Bank's Chief Economist for the South Asia Region. Speaking on the sidelines of the Fourth Kautilya Economic Conclave, organised by the Ministry of Finance and Institute of Economic Growth, Ohnsorge said India's computer services sector was booming and its exports have particularly benefited from the release of ChatGPT.

As per latest data from the Reserve Bank of India (RBI), India's export of software services in the April-June quarter stood at \$47.32 billion, up 13 per cent year-on-year. In July-September 2022, the quarter before ChatGPT was made available to the public by OpenAI, India's software services exports amounted to \$36.23 billion. On the whole, Ohnsorge thinks India is "well placed" to benefit from the advent of AI, with the services sector – especially the Business Process Outsourcing (BPO) industry – adopting it rapidly. "We look at millions of job postings and you can see that 12 per cent of job postings in the BPO sector since the release of ChatGPT require AI skills and that's double of what it was before the release of ChatGPT. And this is triple what other sectors want. So, the BPO sector is really adopting AI and enthusiastically embracing it," Ohnsorge said, pointing out that India ranked 46th in Oxford Insights' Government Al Readiness Index, which was a much better position than other emerging markets and developing economies and almost at the level of advanced nations

Export of services is crucial for India as the country enjoys a sizable surplus with the rest of the world as opposed to a deficit on the merchandise trade front. According to preliminary data from the Ministry of Commerce and Industry, India had a goods trade deficit of \$122 billion in the first five months of 2025-26, or April-August. However, much of this was cancelled out by a services trade surplus of \$81 billion over the same period. In April-August 2024, India's goods trade deficit stood at \$121 billion, while the services trade surplus was lower at \$68 billion. Ohnsorge said that while opportunities in AI will attract the private sector investments, that may not necessarily be enough to



move the headline numbers, with growth in overall private capital expenditure having slowed down since the coronavirus pandemic. "This is the opposite of what's happening everywhere else in other emerging markets. And it is also the opposite of what has happened in public investment, where you see a real acceleration," the World Bank's economist said, although she added that even India's weaker private investment growth rates were higher than those in other emerging markets and developing companies. "So, it is slow by Indian standards, but it is not slow by international standards." However, what is slow by international standards is net Foreign Direct Investment (FDI), which Ohnsorge said is "weak". While gross FDI into India in July rose to a 50-month high of \$11.11 billion, net FDI was a lower \$5.05 billion, as per RBI data. Net FDI is calculated after adjusting for investments that are repatriated by foreign companies and overseas investments made by Indian companies. FDI is a key indicator of the health of the economy and the confidence foreign investors have in the country. Foreign inflows into India have picked up steam in recent months after a disappointing 2024-25 which saw net FDI inflow total just \$959 million even though gross inflows rose to \$80.62 billion. The precipitous fall in net FDI in 2024-25 from \$10.15 billion in 2023-24 came on the back of a Indian companies and foreign companies cashing in on their past investments in India. In 2024-25, foreign firms took back \$51.49 billion to their home countries from India, up 16 per cent from 2023-24. Meanwhile, overseas FDI by Indian companies rose 69 per cent to \$28.17 billion. Both these factors contributed to the net FDI in the last fiscal being

'India-EFTA deal strengthens rule of law amid growing global trade uncertainty': Switzerland's State Secretary for Economic Affairs

The trade deal between India and the European Free Trade Association (EFTA) countries will strengthen the rule of law and help bring certainty for businesses amid increasing complicaBudliger added that US tariffs on India will not impact private companies' investment commitment, since Swiss companies realise the importance of local presence in a large market such as India. India and EFTA — comprising Switzerland, Norway, Iceland, and Liechtenstein came into effect on October 1. Under the deal, EFTA nations committed to investments worth \$100 billion over a period of 15 years. Edited excerpts:

Both India and Switzerland are facing steep US tariffs. How can India and EFTA benefit from the deal amid an increasingly uncertain global trade environment?

The implementation of the (India-EFTA) deal on October 1 could not have come at a better time. It's excellent news for our entrepreneurs, who are navigating an increasingly complex global environment. This complexity stems not only from bilateral tariff discussions with the United States, but also from the fact that Swiss companies operate manufacturing facilities around the world. As tariffs continue to shift, they face growing uncertainty and volatility. Moreover, the anticipated outcomes of the Section 232 investigations by the US Department of Commerce add yet another layer of complexity. So, having a Trade and Economic Partnership Agreement (TEPA), which strengthens the rule of law, is very important.

These steep 50 per cent tariffs on India are not just making access to American markets difficult, but also leading to investment uncertainty. How do you think these tariffs will impact planned investments by EFTA countries?

I'm not concerned about that. I believe we will see a wide range of relationships developing with India. First, we will have Swiss companies that will simply want to export their products to India. Others may aim to serve the Indian market more directly, perhaps not necessarily by manufacturing entire machines locally, but by providing services such as repair and maintenance. In fact, these services often generate significant added value, as they require training local people, ensuring long-term support. Finally, you'll have those companies that will set up shop to serve the

region, to serve the continent, (and) to serve the world.My sense is that Swiss companies have understood the importance of being present in large markets. So we are the sixth largest FDI (source) in the US as well, and I believe that the investment now flowing into India is not primarily intended for re-export to the US. This is evident even in countries such as China, without implying any notion of decoupling. The same applies to the European Union: many of our members you know have at least one foot in the EU, they're often present in the US, they're present in China. I think what's happening now — and we've had a bit of a late start with India because India is only now opening up really and encouraging FDI... before it was a rather closed market. I think there is great catch-up potential

We are seeing a number of other deals that have an investment portion, like between the US and the EU. For EFTA's investment pledge to take shape, how are the bilateral investment treaty talks progressing?

I believe the increasing willingness of countries to consider investment pledges is a constructive way to help balance the dynamics between larger markets and smaller markets. Switzerland would therefore welcome the opportunity to re-establish a bilateral investment protection treaty. I would consider this a key element in ensuring the best possible framework for actionIf you read the TEPA, the Swiss private sector committed \$100 billion investment and 1 million jobs. In turn, India committed to establishing optimal framework conditions for this investment to smoothly and quickly happen. I'm happy to hear that the signals coming from the Ministry of Finance are quite positive. We've been informed that they are working on a model text, which is very encouraging. It's definitely something that we consider would be a key step now. Chinese curbs on critical minerals are a concern for India's industry as it is for the West. Your thoughts on India-EFTA collaborations on the same?We conducted an independent assessment to assess Switzerland's dependence on critical minerals, and the findings were mixed. The good news is that Switzerland often imports components, and that's why we also abolished the industrial tariffs in 2024, because we noticed that actually, by not manufacturing 100 per cent in Switzer-

Hugging pandas for a living? Yes, it's a real job in China



Pandas are undoubtedly adorable. Whether eating grass or rolling on the ground, they will help us break the monotony in the most fascinating way possible. Strangely, unlike in the wild, they are not very friendly among their peers when living in captivity, where there is minimal scope for stimulation. And often they are found in a solitary retreat. That is precisely why they need to be shown some love and care. Take, for instance, the case of China, where a research centre exclusively hires humans to cuddle pandas. The Chengdu Research Base of Giant Panda Breeding in Sichuan, China, delves deeper into pandas' behavioural patterns and has human cuddlers to keep them cheerful. There is a formal process for hiring these panda cuddlers. For example, the applicants can't be more than 22 years old. They should have good writing and photography skills and, most importantly, be familiar with the panda Why human caretakers?

Because they sense a feeling of belongingness with them. Human cuddles remind them of their mothers' warmth, who are famously affectionate with baby pandas. Most importantly, the relationship is based on food and sustenance. Pandas rely on humans not just for cuddles, warmth and love, but also for food. On the other hand, human caregivers happily apply for this job because of pandas' neotenic traits, like big eyes or a childlike appearance.

And what are you supposed to do as a human cuddler?

Start by giving the pandas a fuzzy hug. Make them feel at home. Let them acknowledge your presence. And once they do, cuddle with them, hold their hands, take them for a walk, click a photo or two, and make sure they are active and alert.

How much do you earn as a human cuddler?

This year-round job helps human cuddlers earn up to USD 32,000 (INR 28,19,856 approximately) and has perks like accommodation, food, and even transportation. So, if you have a thing for pandas, stay prepared for this fun and slightly hectic job requiring you to spend hours caring for pandas. The unique service is a part of conservation efforts in China aiming to protect this vulnerable species and contribute to its regrowth. The panda population is declining, amid growing cases of forest fragmentation, poaching, and habitat destruction. According to the World Wildlife Fund (WWF), "There are some 1,600 giant pandas in the wild, but the population is being threatened by habitat loss and deforestation."

Are you planning on trying a monotrophic diet? Learn what it can do to your blood sugar levels

Several celebrities, including athletes and actors like Anushka Sharma, Virat Kohli, and Sunil Chhetri, are known to eat one type of food for months without getting bored. Known as the monotrophic diet, this eating pattern focuses on the idea that simplifying food combinations can ease the digestive process, allowing the body to break down and absorb nutrients efficiently. By eating just one food type, the digestive system isn't overburdened with complex combinations, which can sometimes lead to bloating, indigestion, or other digestive discomfort. With the spotlight on blood sugar levels lately, we decided to find out what happens to the body if we go on a monotropic diet, and the kind of impact it can have on our insulin levels.

Edwina Raj, Head of Services – Clinical Nutrition & Dietetics, Aster CMI Hospital, Bangalore, explained that a monotrophic diet means eating only one food at a time or repeating the same food for all meals in a day. Its impact on blood sugar depends on the type of food chosen. "If the food is high in carbohydrates or sugar, like rice, potatoes, or sweet fruits, it can cause quick spikes in blood sugar levels. On the other hand, if the food is low in sugar and rich in fiber, like leafy greens or non-starchy vegetables, blood sugar rises more slowly," she said.

Dr. Yashawant Kumar – Founder and CEO, Benefic Nutrition added that eating the same kind of food in a mono diet can lead to ketosis, aka a metabolic state that occurs when your body burns fat for energy instead of glucose. "A mono diet creates a dysfunctional and quite a scary relationship with blood sugar. Either it increases sugar spikes dangerously or risking it also you can drop the blood sugar very low," he said. Instead of following a mono diet, he recommended making sure your diet is balanced diet combine micronutrients. Choose complex carbs for example offer whole grains, legumes, vegetables and simple sugars.

Can you follow this diet and curb insulin spikes?

If you want to follow a mono diet and reduce insulin spikes, opt for foods with a low glycemic index (GI). These are foods that release sugar into the blood more gradually.



Whole fruits with fiber, vegetables, and legumes are better choices than refined or starchy foods. Drinking water, eating in smaller portions, and avoiding overeating also help control sugar swings. Pairing mono meals with some physical activity, like walking, can further balance blood sugar.

Is it safe for diabetics?

For people with diabetes, Raj said that following a strict monotrophic diet is generally not safe. It may cause sharp fluctuations in blood sugar, nutrient imbalances, and energy crashes. "Since diabetics need a mix of protein, healthy fats, fiber, and complex carbs to keep sugar steady, depending on one food can make management harder," she said, adding that if a diabetic still wants to try a mono-style approach, it should only be under medical guidance, with close monitoring of sugar levels. A balanced diet is usually safer and more effective for long-term health. "It is completely unsafe if you, a type 2 diabetic, are not taking a doctor's advice switching to a monotropic diet by yourself," said Kumar. For diabetics looking to enjoy sweet flavors without impacting blood sugar, look for a product which is a combination of monk fruit and erythritol. "Monk fruit is derived from a fruit it contains the compounds called mogrosides that provide sweetness but have no calories or no impact on blood sugar," he recommended.

While the lead actors were kept away from the limelight during promotions, the director had been sharing bits and pieces of information about them all along to keep us hooked. Talking to Instant Bollywood, Suri recalled Padda's first audition for the film and how Panday helped turn things around.

"The first thing I said was, 'What are you wearing?' Aneet also came to meet me in my office, dressed up in something which was completely off my character, a yellow dress. That went disastrously bad when she met me. But it was Ahaan actually who was saving the scenario that day, and he was there with me when we met her and he tried to distract me. He was the one who told me, 'Give her another chance, I'm telling you, she's good,' said the director. What changed? Suri shared that following Panday's advice, he called Aneet up, and said, "'You guys have a problem, thinking I like something — please come in what you think you are.' She came in wearing a white shirt and jeans the next day, and I said, this is it, if you see the trailer, this is a jeans and kurta kind of a look, which is her lost and clumsy, and that's what she is," he revealed.



Dr Shree shared some key strategies to help you cope

1. Acknowledge Your Feelings: It's okay to feel hurt, angry, or disappointed. Bottling up emotions can hinder



healing. Allow yourself to process your feelings in a healthy way, like journaling, talking to a trusted friend, or engaging in a creative outlet

- 2. Reframe the Narrative: Don't view rejection as a personal failure. Instead, see it as an opportunity to learn and grow. Maybe your skills need some honing, or perhaps the timing wasn't right.
- 3. Analyse the Situation: If the opportunity allows, try to understand the reasons for rejection. Did they provide any feedback? This can be valuable information to help you improve for next time. However, avoid excessive self-criticism
- 4. Focus on the Positive: Rejection doesn't erase your strengths and accomplishments. Take a moment to appreciate your past successes, and remind yourself of your skills and value.
- 5. Learn and Adapt: Use the experience as a learning opportunity. Did you discover a new skill gap you need to address? Perhaps your approach needs some tweaking. Growth comes from adapting to challenges.
- 6. Build Resilience: Rejection can be tough, but it also helps build resilience. Each time you overcome a setback, you become better equipped to handle future challenges.
- 7. Celebrate Small Wins: Don't get discouraged by aiming for giant leaps. Celebrate small victories along the way. This keeps you motivated and reminds you of your progress.
- 8. Keep Moving Forward: Don't dwell on the rejection. Use it as motivation to keep striving towards your goals. There are many paths to success, so explore new opportunities and keep putting yourself out there.

'Root to average 150 Down Under': Steve Harmison backs Joe Root, says England will beat Australia 3-1

It is no surprise that when a touring England side will play Australia away from home, the spotlight will be on World No. 1 Test batter Joe Root, who has to carry the baggage of underperforming Down Under. Root, who is the second-highest run getter in Tests after the great Indian batter Sachin Tendulkar, is yet to score a century on Australian soil.Root, who boasts a stellar record against Australia at home and has four tons to his name against Australia in England, would be the linchpin in England's batting order, which plays an attacking brand of cricket. However, for Root, the second-

highest run-getter in Tests, Australia remains an unconquered territory. In 14 Tests, he has yet to win a game; he has yet to register a three-figure score. But former England fast-bowler Steve Harmison has picked his side and shown a lot of faith in Root's ability. "People have been telling me for two years that Joe Root is coming over to Australia to average 50. He's not. I think he's coming over to average 150. I really do," Harmison was quoted as saying by Fox Sports. Root is well on track to break Tendulkar's record for the highest runs in Test cricket and Harmison believes the 34-year-old's exploits in the upcoming Ashes would take him a lot closer to the legendary Indian batter's tally of 15,921 runs. "The way he is playing. The mindset he is in. You can have your mortgage on Joe Root scoring at least one hundred. It would not surprise me if he went past what Cook did in 2010-11." England to beat Australia 3-1'Harmison also picked his winner, claiming England could beat this Australian side. "I am backing England, maybe like 3-1 to come to Australia and sledge Australia and Joe Root to have the best series he has had for a long time. I am that confident England will win," Harmison said. "Where Joe is at with his mentality and the fact that Cummins is out, I mean Joe is vulnerable the first 15 to 20 balls in Australian conditions, but after that he just keeps accumulating. England doesn't fear Australia. I don't think there's a fear in the world anymore, the way the young players go," he added.

'Just having fun': Carlos Alcaraz defends playing multimillion dollar exhibition event in Saudi Arabia after pulling out of tour event citing injury

(Photo: Reuters)The top tennis players in the world often complain about the hectic year-round calendar that takes a heavy physical and mental toll on them. But when some of them turn up for a lucrative exhibition event, promising more than the prize money for winning a Grand Slam for a little fraction of the exertion, after pulling out of a big regular Tour event citing injury, criticism is inevitable.

World No.1 Carlos Alcaraz finds himself at the receiving end for headlining the Six Kings Slam, where the Spaniard will headline a field of half a dozen marquee names, which also include Jannik Sinner, Novak Djokovic, Alexander Zverev, Taylor Fritz and Stefanos Tsitsipas. There is a reported \$4.5m on offer, with some players also likely to have been paid seven-figure sums as appearance fees. The winner could take home up to \$6m, according to BBC Sport. In comparison, the US Open champion gets \$5m, the highest purse among the four Grand Slams. Alcaraz has teed up for the ongoing event in Riyadh after pulling out of last week's Shanghai Masters 1000 citing an ankle injury. But he said the four-day event doesn't put as much strain on the mind and body as regular events that sometimes go on for two weeks or longer. "It's a different format, different situation playing exhibitions than the official tournaments, 15, 16 days in a row, having such a high focus and demanding physically," the six-time Grand Slam champion, who won the French Open and US Open



this year, said. "I don't feel 100 percent – the doubts are there when I'm moving on court, but it has improved a lot and I'm going to compete and perform well."

Alcaraz would play no more than two matches in the tournament, having received a bye into the semifinals. For the 22-year-old from EI Palmar, the exhibition event was just an opportunity to have a good time on the court while also having a big payday. "We're just having fun for one or two days and playing some tennis, and that's great, and why we choose the exhibitions," he said. "I understand [the criticism], but sometimes people don't understand us, our opinions. It's not really demanding mentally [compared with] when we're having such long events like two weeks or two and a half weeks," Alcaraz was quoted as saying by BBC Sport. It is the second time the Six Kings Slam is taking place, with Sinner beating Alcaraz in last year's final, but it's unlikely that if they meet in Riyadh, the clash would occupy too high a place in their catalogue of epic rivalry.

Noman's 10-for, Afridi's reverse swing give Pakistan famous win over South Africa

Lahore: Pakistan's spin duo Noman Ali and Sajid Khan did the heavy lifting before Shaheen Shah Afridi applied the finishing touches, as the hosts wrapped up a 93-run victory over World Test Championship (WTC) winner South Africa on Day 4 of the first Test at the Gaddafi Stadium on Wednesday. The win gave Pakistan a 1-0 lead in the two-Test series, while ending South Africa's record 10-match winning streak, their longest in Test cricket history.

Defending a target of 276, Pakistan tightened the screws on a pitch that had become increasingly treacherous for batting. No team had ever chased such a total at the Gaddafi Stadium, and Pakistan's spinners ensured it remained that way. Noman Ali, with subtle variations and unrelenting accuracy, picked up his third 10-wicket haul in Tests, while Afridi's reverse-swing burst finished off the resistance. South Africa's hopes had briefly flickered through Dewald Brevis and Ryan Rickelton, who battled in contrasting styles. Brevis counterattacked with a brisk 54 off 54

balls, striking six fours and two sixes — one a no-look hit over long-on to bring up his fifty. Rickelton, in contrast, dug in for a gritty 45 off 145 balls, anchoring the innings.But both fell before lunch — Brevis bowled by Noman with a sharpturning delivery, and Rickelton edging Sajid Khan to slip. South Africa, needing another 139 at the break with four wickets left, had already lost momentum.Soon after lunch, Senuran Muthusamy was trapped lbw by Noman, and Pakistan's spinners continued to frustrate the visitors. Though Kyle Verreynne and Simon Harmer managed to take South Africa past Pakistan's second-innings score — the first such instance on these increasingly dry, spin-friendly surfaces — a comeback never looked likely.

The turning point came when Afridi, relatively quiet for much of the Test, was brought back with the old ball from around the wicket. He immediately found reverse swing, pinning Verreynne Ibw with a searing inswinger. With rhythm and control back, Afridi rattled the tail - clean bowling Prenelan Subrayen and Kagiso Rabada with fast, full deliveries. Earlier in the day, South Africa had resumed at 51/2 but quickly slumped to 55/4. Tony de Zorzi was bowled by Afridi's third ball of the morning, while Tristan Stubbs fell attempting a reverse sweep off Noman — well caught at slip by Salman Agha, who claimed his fifth catch of the match. Ultimately, Pakistan had laid the foundation with a strong first innings on Day 1. South Africa spent the rest of the match chasing the game. "Chris Gayle, Virat, and, of late, Abhishek Sharma. You should tell Abhishek next time to try to be soft on the bowlers. Let him bat like this for India, not for SRH, Chakaravarthy said on "Breakfast with Champions". Chakaravarthy also revealed how he was a follower of chess and admitted that while things were going well for him, at present, he still had some work to do to be as good as the likes of Sunil Narine and Rashid Khan."I follow chess now. When Gukesh won the championship, he told I might be the World Champion right now, but everyone knows Magnus Carlsen is the number one player. So I might be ranked number one, but the number one is always Jasprit Bumrah. There are Sunil Narine, Rashid Khan. I am doing well, but still some time to go before I can reach



that stage," he said

The spinner said that, as compared to some of his other team-mates, he was more of an introvert and took time to write and visualize at the end of practice sessions. "I've always been an introvert. I'm not like Arshdeep or Nayar who are outspoken and can crack jokes. I have a slightly dark humor. After practice I go to my room, to stay away from cricket I keep writing. I love writing. It brings out what's within me outside and helps me visualize. By the end I totally forget that I was a cricketer and I have a match to play the next day

The spinner also revealed how he had planned to sleep with the trophy and take a photo with the cup next to him. However, since the team did not get the trophy after the final, he eventually slept with a coffee mug next to him. "So I had planned everything. I had planned that I will sleep and take a photo with the cup next to me. But after the match, there was nothing next to me. There was just a coffee cup, so I went ahead with it," he said. The 2025 Asia Cup ended in controversial circumstances after the Men in Blue did



not take the trophy from the Asian Cricket Council (ACC) President Mohsin Naqvi and celebrated on the podium without the cup in hand. Chakaravarthy added that it did not matter that India did not get the trophy, for it did not take away the fact that they had won the tournament. "I knew that we would win all games. We are the number one team in the World. The Cup can be taken away but we are champions," he said.

If a wicket went, he would jump out of his seat. I would say, 'Calm down man, let him (dismissed batter) cross halfway, don't meet him when he's just 10 yards away from the stumps. Let him come near the boundary line, then cross him'. He was like a cat on a hot tin roof ready to punch out there. That's Virat for you," remarked Shastri on the LiSTNR podcast.

'Get to the bloody gym...'Kohli and Shastri, as captain and coach, formed a crucial partnership in Indian cricket in the previous decade, where the emphasis on fitness was elevated to new standards. Shastri recounted how running with Kohli in the middle meant bad news for his sluggish teammates. 'It did because he would show them up otherwise. When you are running between the wickets, if you



are a lazy bugger, you'll soon find out. He'll be completing two runs and you'll be trying to finish the second and he'll be looking for the third while you've not even finished your second run. Immediately, the message then is, 'Get to that bloody gym and start training and get fitter'."

Despite making appearances in notable roles in a slew of films in the 2000s, Rajat Bedi never managed to rise to prominence, secure bigger parts, or become a star who cannot be ignored. By the middle of that decade, opportunities dried up for him, and he went without work for years. Eventually, he bid adieu to cinema and moved to Canada to find a new livelihood. However, Rajat returned to India recently and appeared in a few regional films before catching the eyes of audiences yet again with his performance in Aryan Khan's

The Ba***ds of Bollywood.

Rajat Bedi's career is, in a way, a testament that nepotism doesn't work the same way for all the star kids. Despite being the son of director-producer Narendra Bedi and the grandson of legendary writer-director Rajinder Singh Bedi, Rajat found little success in cinema for most parts of his career. During a recent interview, he revealed that no industry insiders even looked back at him and his family following the untimely demise of his father."I was nine years old when I lost my father. He was 45. I remember vividly that no one from the industry looked back at us, except for director Prakash Mehra and his family. For about six months to a year after Papa's death, Prakash-ji sent money to our house, telling my mother, 'Bhabhi, don't worry.' My mother has been a housewife her entire life. Mumbai: Bollywood actress Triptii Dimri, who enchanted audiences with her hauntingly beautiful performance in the 2020 period horror-mystery Bulbbul, took a stroll down memory lane as she rewatched the film. Taking to her Instagram stories, Triptii shared a picture of her television screen with Bulbbul playing on it. "It's that kind of night... Me, Bulbbul, and a little nostalgia," Triptii wrote as the caption. She then posted a picture of the moon and wrote: "The after effects of watching Bulbbul." Bulbbul also stars Avinash Tiwary, Paoli Dam, Rahul Bose, and Parambrata Chattopadhyay. Set against the backdrop of the 1880s Bengal Presidency, the film revolves around a child bride and her journey from innocence to strength. It follows a young woman who grows into an enigmatic figure ruling her household, hiding her painful past as supernatural murders of men plague her village. Triptii had her first lead role in the romantic drama Laila Majnu (2018) but gained critical recognition for her performances in Anvita Dutt's Bulbbul and Qala. She later rose to mainstream fame with supporting roles in top-grossing action films such as Animal, Bad Newz.



(Credit: Ravi; Express Archives) Although it's been over seven years since Sridevi passed away, the indelible mark she left on Indian cinema remains as bright as ever. Widely regarded as the country's "first female superstar," Sridevi worked in several languages throughout a career spanning nearly five decades that began as a child artiste. Known for her versatility and the effortless manner in which she could handle both intense emotions and humour on screen, she remains beloved to audiences and some of the film industry's biggest names to date.

Legendary cinematographer-turned-director Ravi K Chandran, too, is an ardent fan of Sridevi. He adored her so much that he used to cut out pictures of her from newspapers, film magazines, and movie posters to paste on the walls of his college hostel room. In an exclusive interview with SCREEN, Ravi opened up about his lifelong admiration for the veteran actor. He also revealed Sridevi's reac-

tion when he told her about having a "Sridevi room" during

his college years. "When we were in college, I stole one cut-out of Sridevi, wherein she was featured standing, from a theatre and brought it to my room, which became the 'Sridevi room'. The walls were filled with her pictures. Any time her image appeared in the newspapers, I would snip it out and paste it on the wall. Whenever someone wanted to see her or offer prayers, they came to my room. During exam seasons, we advised each other, 'Macha, come and take ashirwad from Sridevi," he recalled. Despite rising to prominence in Bollywood, Ravi K Chandran mentioned that he never got the chance to meet his matinee idol for the longest time. He finally chanced upon her quite coincidentally, thanks to her brother-in-law and frequent collaborator Anil Kapoor. He reminisced, "One day, I went to meet director Rajkumar Santoshi for a story narration. Afterwards, he suggested catching a night show of The Hangover, and I agreed. He also invited Anil, who lived nearby Since his driver was unavailable, Anil came with us, and we all sat in my car. Meanwhile, he said, 'Let me call Sri also.' But I didn't realise who he was referring to at the time. He gave directions to my driver, and I thought we were picking somebody else. Upon reaching there, Sridevi walked in! They asked me to sit in the centre of the back seat, with Anil on one side and Sridevi on the other. Suddenly, I felt like my heart stopped: my screen idol was sitting next to me!"Ravi continued gushing, "I was speechless. She sat next to me in the theatre as well, and I couldn't help but keep looking at her. Then I told her, 'Do you know ma'am, I once stole your cut-out and kept it in my hostel room? I can't believe this moment now.' She replied, 'What are you saying, sir? I have seen all your films.' I immediately said, 'Please don't call me sir. I can't handle it. I'm a big fan of yours, and I can't believe this moment is real. That was one of the highest moments of my life."Unfortunately, Ravi K Chandran never got to collaborate with his idol. Sridevi passed away in an accidental drowning incident in Dubai on February 24, 2018, at the age of 54. The Bollywood legend is survived by her husband, Boney Kapoor, and daughters Janhvi and Khushi Kapoor.Renowned for his work in movies like Virasat, Kannezhuthi Pottum Thottu, Kandukondain Kandukondain, Dil Chahta Hai, Kannathil Muthamittal, Aayutha Ezhuthu, Black, Paheli, Saawariya, Ghajini, My Name Is Khan,
