#### Mancherial court jails two brothers for five years in 2022 murder attempt case

Mancherial: A local court on Tuesday sentenced two brothers to five years of rigorous imprisonment and imposed a fine of Rs.1,000 each for attempting to murder a woman three years ago. Additional Assistant Sessions Judge D Ram Mohan Reddy pronounced the verdict against Durgam Sammaiah and his brother Durgam Lingaiah of Bheemaram, who were found guilty of attempting to murder Kota Shankaramma of Ankushapur by attacking her with an iron rod in 2022.

The court examined the evidence and cross-examined the witnesses produced by Additional Public Prosecutor Nandi Ravinder before delivering the judgment.

#### CM Revanth's film workers' meeting sees poor attendance, yet promises land, ticket hike

Hyderabad: With an evident eye on the Jubilee Hills bypoll, Chief Minister A Revanth Reddy on Tuesday announced a slew of measures for film workers, even as the meeting he addressed at Yousufguda saw a poor turnout. Despite taking a U-turn from his earlier stand that the Congress government would not permit hikes in ticket fares, the meeting saw very few attendees, with most chairs

left empty and several participants leaving midway. Only a few known faces, including producers Dil Raju and director Harish Shankar, were present.

Unfazed by the sparse attendance, the Chief Minister went ahead with his announcements, stating that the government would soon issue orders allowing cinema ticket price hikes, provided that 20 percent of the additional benefits were shared with film workers. Revanth Reddy announced that land would be allotted for film workers in the proposed Bharat Future City and directed officials to identify three to four acres in Krishnanagar toDil Raju establish a school for the children of film workers. He also urged the 24 Crafts union leaders to set up a Film Workers Welfare Fund, with the State government contributing Rs.10 crore upfront. The fund, he said, should be used to support families of workers who suffer injuries or lose their lives. "Extend your support to me and it will be my responsibility to get Hollywood to Hyderabad and compete with New York, Tokyo and Dubai," Revanth Reddy said, adding that he would stand by them as a friend, likening himself to Karna's character from the

#### Turnout trends show urban voter apathy in Jubilee Hills despite growth in electorate

Hyderabad: Despite a steady rise in the number of registered voters over the past 16 years, the Jubilee Hills Assembly constituency has continued to show a pattern of low voter turnout, remaining a challenge for both political parties and election authorities. One of Hyderabad's most high-profile and urban segments, the constituency has a diverse mix of both poor and affluent voters. An analysis of polling data shows that the voter base in Jubilee Hills grew from 2.59 lakh in 2009 to 3.85 lakh in 2023 and nearly 4 lakh in the latest revision of electoral rolls in September 2025. However, the voting percentage has remained stagnant and even dipped sharply at times, indicating a widening gap between voter enrolment and participation. Following delimitation in 2009, the Jubilee Hills con-

stituency was carved out of the then Khairatabad constituency. In the 2009 Andhra Pradesh Assembly elections, the constituency recorded a 52.76 per cent voter turnout. After the formation of Telangana, turnout dropped to 50.18 per cent in 2014 and further declined to 45.59 per cent in 2018, the lowest among the State's urban segments Assembly elections saw a marginal rise to 47.58 per cent, still well below the State average.Parliamentary election trends showed a similar pattern. In the 2019 Lok Sabha polls, the segment registered just 39.4 per cent voting, which rose modestly to 45.38 per cent in 2024, again reflecting limited voter enthusiasm despite high-profile campaigns. As for parties that managed to win despite the low turnout, the first election in 2009 saw P Vishnuvardhan Reddy, now with the BRS and then with the Congress, emerge victorious. Thereafter, it was Maganti Gopinath for the next three terms,



with the first time in 2014 being with the Telugu Desam Party, and the last two, with the Bharat Rashtra Samithi.

Political observers said Jubilee Hills reflected the broader urban apathy seen in upscale and cosmopolitan constituencies, where issues such as civic amenities, traffic, and governance often dominate discussions but rarely translate into active voter participation. They also pointed to the large floating population, high-income demographics, and weekend travel as factors behind low turnouts. With the upcoming Jubilee Hills bypoll on November 11, political parties are facing the challenge of mobilising passive urban voters. The bypoll result could depend not only on party strength but also on how effectively candidates can motivate residents to step out and vote in larger numbers. Accordingly, all political parties have been repeatedly appealing to voters to exercise their franchise.

## **Congress to make Pranahita-Chevella**

Hyderabad: The flagship irrigation initiative of former Chief Minister K Chandrashekhar Rao, the Kaleshwaram Lift Irrigation Project, is once again proving to be an indispensable lifeline for Telangana, with the Congress government set to integrate the long-stalled Pranahita-Chevella project into the Kaleshwaram project. All that remains is final approval from the Cabinet, according to sources in the Irrigation Department. The move comes after a long brainstorming over redesigning the original Pranahita-Chevella plan, first envisioned under the previous Congress regime to deliver 160 tmcft of Godavari water to north Telangana. Now, it is being recast as an extension of the Kaleshwaram project, with the original Pranahita-Chevella layout serving as another arm of the larger network.

Under the new design, water will be piped from Thummidi Hatti to the Yellampalli reservoir via Kaleshwaram's Sundilla barrage. Technical experts have cleared it in principle.

Two crucial factors have driven this realignment. First, it would help avoid fragile coal-rich zones along the Pranahita river's path, particularly in Adilabad district's upper stretches and areas near Maharashtra-Telangana border. Geological investigations and basin mapping have flagged key coalfields in proximity to the originally planned route for the Pranahita-Chevella project. Rerouting through safer corri-

dors would not only prevent construction headaches but also mitigate environmental issues. A cluster of coal hotspots in Adilabad's northern reaches are part of the fragile zone to be taken care of while implementing such a massive irrigation project. This is an active mining hub under Singareni Collieries and it holds vast reserves and lies directly along Pranahita's upper flow. By avoiding these coal belts, planners can sidestep the need to blast through them, preserving both the mines' future and the project's timeline.

#### Road Transport and Highways Ministry's annual revenue projected to reach Rs 1.4 lakh crore in 2 years:...

New Delhi: The annual revenue of the Ministry of Road Transport and Highways, currently at Rs 55,000 crore, is projected to rise to Rs 1.4 lakh crore within two years, reflecting the immense growth potential of the sec-Union Minister Nitin Gadkari said on Tuesday."Infrastructure must be people-centric, ensuring comfort and convenience for citizens. To support this, 670 roadside amenities have been developed across the country," said Gadkari, addressing the CII National Conference on "Future of Smart Roads - Safety, Sustainability and Resilience" here. Gadkari further stated that under the vision of Prime Minister Narendra Modi, to make India a five-trillion-dollar economy by 2027, the development of world-class infrastructure will play a pivotal role. He noted that the road and transport sector offers mmense opportunities for economic growth, investment, and employment generation across the country.

#### Cyclone Montha batters Telangana, disrupts harvest and procurement activities

Hyderabad: Cyclone Montha, unleashing heavy rains across the eastern districts of the State, has severely impacted harvest activities apart from hitting paddy and cotton procurement operations. The India Meteorological Department (IMD) has issued red alerts for extremely heavy rainfall in the four districts of Jayashankar Bhupalpally, Mulugu, Bhadradri Kothagudem and Mahabubabad. Orange alerts have been sounded for five additional districts including Khammam, Warangal, Hanamkonda, Peddapalli, Mancherial and Kumram Bheem Asifabad. Administration in other neighbouring districts is also on high alert. Besides widespread disruptions to daily life and trade, districts that have already experienced excess rainfall and untimely downpours are bracing for nature's fury. The administration, particularly the Irrigation Department and revenue personnel, has been placed on high alert, while National Disaster Response Force (NDRF) teams remain on standby.

Farmers preparing to harvest paddy and cotton are receiving essential precautionary guidance from agriculture officials to protect their crops. In certain areas, particularly Makthal and Moosapet mandals of erstwhile Mahabubnagar district, untimely rains have already wreaked havoc on cotton and maize crops three days ago. In Addakula mandal, paddy stocks were drenched due to heavy rains at harvest centres and market yards. The cyclone's effects are feared to cause further damage, with cotton crops likely to bear the brunt. Although arrivals of produce have continued to gain momentum, purchases remain subdued due to moisture-related issues. In Suryapet district, Collector Tejas Nandlal Pawar and his team reached out to farmers in Arvapalli, Timmapur and Velpucherla areas, advising paddy and cotton growers to stay vigilant and take immediate precautions to safeguard their produce from the cyclone's impact over the next 48 hours. He also enquired about the availability of tarpaulins and officials' preparedness for paddy procurement. In Medak district, arrivals of stocks at the purchase centre of the local Primary Agricultural Cooperative Society in Kazipet village, Narsapur mandal, are increasing. However, procurement has yet to pick up. Farmers have expressed concerns over the delayed paddy purchases amid the impending cyclone threat. Yadadri Bhongir suffered major damage to paddy stocks in Choutuppal market yard due to heavy rains. Officials in other districts, including those in Godavari and Krishna basins, are monitoring conditions closely as the cyclone's influence spreads. Evacuation drills and relief preparations are underway to mitigate potential flooding risks.

#### Anganwadi workers in Telangana demand Congress government to clear pending bills

Khammam: Anganwadi workers across Telangana are reeling under a severe financial crisis with the Congress government failing to clear the rental and other dues pending for the past several months. It is said that the rental dues for Angwandi centres being run in private properties have been pending for the past eight months. The workers are forced to spend from their pockets to clear rents ranging from Rs 2000 to Rs 3000 every month to keep the centres

Speaking to Telangana Today, AITUC affiliated Anganwadi Workers and Helpers Association state vice president Gone Rani said the government had recently conducted Poshan Vatika (Nutri-garden) training for the workers for three days but the travel and dearness allowances for the period was yet to be cleared. Similarly, money spent by the workers on activities like Seemantham (Baby shower), Annaprasana (Giving babies their first solid food), Aksharabhyasam (A child's initiation into formal learning) held at Anganwadi centres was also pending for two years.

Likewise, bills related to Arogya Lakshmi programme wherein one nutritious meal provided every day to pregnant and lactating women and children below the age of six through Anganwadi centres as well as money spent on procuring LPG cylinders were also pending for the past five months. Anganwadi workers, who are paid Rs. 13,500 monthly, were forced to spend nearly Rs 6000 every month on expenses incurred in running the centres. They have to meet their ends with the remaining money and it gets difficult to run families with that money, Mani complained. "When the officials are asked to clear the pending dues, they say funds are not available and that the dues will be cleared only after funds are released. The government should look into the issue and take immediate steps to address it," she

That was not all. The workers were not paid the money for the services they rendered as booth level officers during the last Assembly elections as well as Rs.10,000 for carrying out the recent socio-economic survey. The government had promised to pay for the 24-day strike staged by the workers two years ago but failed to deliver the prom-

#### President Murmu to take sortie in Rafale fighter jet at Ambala Air Force Station on October 29

New Delhi: President Droupadi Murmu will visit Ambala, Haryana on October 29 where she will take a sortie in a Rafale fighter jet at the Ambala Air Force Station.

Notably, the President who is the Supreme Commander of the Indian Armed Forces also took a sortie in a Sukhoi 30 MKI fighter aircraft at the Tezpur Air Force Station, Assam on April 8, 2023. It is worthy to note here that Rafale was also deployed during 'Operation Sindoor'.

Earlier this month IANS reported that Dassault Aviation of France is planning a Rafale Assembly Line in India with an eye on the Indian Navy and Air Force orders. According to sources close to the development, India can soon become the first country to produce a 4.5 generation fighter aircraft without being an Original Equipment Manufacturer or the OEM.

Dassault has a current backlog of close to 200 Rafales which includes outstanding deliveries for existing orders of 80 aircraft for UAE, 42 for Indonesia, 12 for Croatia, Egypt 54, Greece 24, Qatar 36 and potential 26 for the Indian Navy.

### Road safety should be a priority, not an afterthought

Full details of the horrific Kurnool bus mishap in Andhra Pradesh, in which 20 people died, are yet to come but, but the accident proves for the nth time that the auhorities in our country are not proactive but reactive—and that too in a slow and slipshod manner. For a few lays before this, a fire in a moving AC sleeper bus burned at least 20 passengers alive and wounded 15 on the laisalmer-Jodhpur Highway. Even the Rajasthan tragedy lid not wake up the officials concerned in other states.

To be sure, intercity private buses are generally dong a good job by providing comfortable travel to passeners at reasonable prices; the entrepreneurs running these ervices are doing what the Railways has failed to do depite its massive resources and government support. It is measure of government incompetence and apathy at all evels, Central as well as state, that the authorities havenot even been able to come up with realistic rules and regulaions to ensure smooth and safe operations by private bus companies. Despite the vital role these buses play, the egulatory framework governing them remains chaotic and outdated. Operators are required to obtain multiple clearances—from transport authorities, road safety departnents, and local administrations—but these are often reluced to paperwork rather than meaningful checks. Veicle fitness certifications, driver training standards, and ire safety inspections are either perfunctory or routinely ypassed through bribes and middlemen. The Kurnool tragedy underlines the tragic consequences of this regulatory acuum. Most intercity buses, particularly AC sleeper coaches, are not equipped with basic fire-suppression ystems or emergency exits that meet modern safety

Patil has appealed to the public to remain alert as the Meteorological Department has forecast widespread heavy rainfall across the district over the next two days due to cyclone impact. The Collector issued a press statement on Tuesday and urged precautionary measures. "He advised people residing in low-lying areas, river catchment regions, villages and towns to remain cautious and take preventive steps as rainwater may inundate such areas. Citizens were instructed to be



careful while crossing roads, bridges, streams and culverts, and to avoid stepping out unless necessary. Children and elderly persons should stay indoors. The Collector also warned the public to keep away from fallen trees and snapped power

lines.""Focusing on the ag-

riculture sector, the Collector said that the upcoming cyclone may severely impact crops. As a large extent of paddy is in harvest-ready condition, farmers are advised to postpone paddy harvesting for the next two to three days. Farmers who have already harvested should shift the produce to safer, elevated locations and protect it from rainwater by covering it with tarpaulin sheets or other materials. ""He added that farmers can avoid major financial losses by taking timely preventive steps. The Collector further directed officials to ensure proper protective arrangements at market yards and procurement centres so that rainwater does not enter crop storage points.

#### Neglecting to Include Water Board Outsourcing Employees in the IMSIS Portal Is Unjust: Telangana Outsourcing JAC President Puli Lakshmaiah



"VADDEPALLI KISHORE, Uppal, October 28 (Indian Chronicle): ""Telangana Outsourcing JAC President Puli Lakshmaiah and representative Siddi Ramulu strongly criticized the Water Board officials for their negligence in updating the data of outsourcing employees in the IMSIS (Integrated Management System for Information Services) Portal. "They stated that while the government had instructed all departments to register the data of every employee, the officials in the Water Board claimed they received no such order — yet, they ensured that all permanent employees' details were entered into the portal. However, the data of outsourcing workers employed in the same department were not uploaded. "Lakshmaiah pointed out that categories such as linemen, meter readers, bill collectors, WTP and STP workers, QAT staff, garden workers, DPOs, sewerage workers, pump operators, and several others - to-



taling over 5,000 outsourcing employees — were left out of the IMSIS registration process. He expressed deep concern that, despite the government's clear instruction to complete this process by the 25th of this month, the officials ignored it and only updated data for permanent staff. He remarked that if the government were to withhold the salaries of permanent employees, only then would officials take their duties seriously."

According to him, only 55% of employee details have been uploaded online so far. He questioned what had happened to the remaining 45%, and what was being done with the salaries allocated for those employees. The Telangana Outsourcing JAC leaders demanded that the government take immediate action against the negligent officials and ensure that all outsourcing employees' data are properly recorded in the IMSIS portal without further delay.

#### School Attender Arrested for Sexually Harassing Minor Girl Students – Rural ACP Vijay Kumar

28, INDIAN CHRONICLE: "A shocking case of sexual harassment against minor girl students by a school attender came to light in Karimnagar district. According to police reports, Mohammad Yakub Pasha (30), working as an Office Subordinate (Attender) at a government school in Gangadhara, allegedly harassed several minor girl students. Yakub Pasha, belonging to the Dudekula community, is a native of Shayampet village in Geesukonda mandal and currently resides in Kurikyala village under Gangadhara mandal. He reportedly behaved indecently with girl students, touched them inappropriately, and threatened to post morphed photos taken with them during school events if they resisted his advances. Following complaints, officials including the District Child and Women Welfare Officer, Child Welfare Committee members, Mandal Education Officer and MPDO visited the school and interacted with the students. Their inquiry confirmed that the allegations were true. Subsequently, on Monday evening, the Headmistress of the school lodged a formal complaint at the Gangadhara Police Station. Based on the complaint, a case was registered under stringent sections of the Bharatiya Nyaya Sanhita (BNS), Protection of Children from Sexual Offences (POCSO) Act, and the Information Technology (IT) Act. The investigation was launched under the supervision of Karimnagar Rural Assistant Commissioner of Police, G. Vijay Kumar. During the probe, it was confirmed that the accused had indeed sexually harassed the students. Acting on this, the Gangadhara Sub-Inspector's team arrested Yakub Pasha at Rekurthi Crossroads on Tuesday morning. After conducting medical examinations, the accused was produced before the court and remanded to judicial custody. Speaking to the media, ACP Vijay Kumar stated that no leniency would be shown towards anyone involved in sexual offences against minor girls or women. He warned that strict legal action would be taken in all such cases. ## Basic facilities should be provided to farmers in the market yard so that they do not face any difficulties in buying paddy

October 28):- Yadadri Bhuvanagiri District Collector Hanumantha Rao has instructed the concerned officials to provide basic facilities to farmers in the market yard so that they do not face any difficulties in buying paddy."On Tuesday, the District Collector conducted a surprise inspection of the paddy purchase center in the market yard at Ramannapet mandal center and the Nagaram paddy purchase center in

Valigonda mandal. Speaking on the occasion, the District Collector said...that farmers should not be discouraged by the recent rains and should set up tarpaulins and matiges around the paddy until the weather improves. The district collector has issued orders to the market yard officials to immediately construct doors after farmers complained that the grain was being washed away due to rain water dripping from the shed. The entire market yard was inspected again. Since the concrete for drying the grain piles was not laid properly and there were holes, the holes in the concrete should be filled with mortar and leveled. The level line in the electricity in the market yard is dangerous. The SC has issued orders to the electricity department to immediately change the line and install a new, larger pole so that there is no problem for lorries to come and go. Since the old moisture machine that checks the moisture percentage showed high moisture percentage, it should be seized and another moisture machine should be brought and checked and used. The officials were instructed to immediately check the moisture percentage of the grain in the market and purchase it immediately. The District Collector also asked the millers to cooperate with the farmers due to the untimely rains. He called the contractor to transport the grain to the mills and ordered him to send a lorry to the Ramannapet market yard within 2 hours. The concerned officials participated in this program.



#### How a modest school started by 2 friends in Surat grew into a university in 100 years



GNS News Agency, Oct 28

Long before independence, two friends in Surat, Chunilal Ghelabhai Shah, a clerk in the postal department, and Jaikishandas Athawala, a journalist and social reformer, decided to set up a school. They aimed to provide quality education to all at an affordable rate, compared to the schools operating at the time. Thus, in 1905, the Sarvajanik Education Society (SES) was formed on the lines of the Deccan Education Society, Pune. It established the first school, named The English School, popularly known as 'Dhingli school' (also referred to as 'Doll School'), which operated from a private lawn in the Gopipura area of Surat.

On October 1, 1912, Sarvajanik Education Society was registered in the government records as a philanthropic organisation run by a trust. According to the centenary volume of the SES, Chunilal Shah, an alumnus of the erstwhile Baroda College, now MS University of Baroda in Vadodara, whose father was a teacher in a government school, realised that missionary schools charged high fees for an English-medium education.

Their fee was Rs 8 per month for Classes 1 and 2, Rs 12 for Class 3, so the Doll school decided to charge eight paisa for Classes 1 and 2, while the highest fee was Rs 1.80 per month. The first batch saw 11 students being enrolled. While the medium was English, the Sanskrit language was introduced in Class 3 and Gujarati after Class 5. Among the teachers were Ganesh Sahasrabuddhe, who came from Pune's Deccan College; Narbheram Joshi, headmaster of Elphinstone College, Jamnagar; and Murshanker Vyas, headmaster of Vansda English School, who gave honorary services. Its list of alumni has illustrious names like writers

Kanhaiyalal Munshi, Jyotindra Dave, Chandravadan Mehta, former chief minister Hitendra Desai, former Governor of Delhi and chief vigilance commissioner of India M G Pimputkar (ICS), Ramon Megsaysay award winner and Gandhian Manibhai Desai), former Chief Justice of India A M Ahmadi, former Chief of Indian Army staff (Arun Shridhar Vaidya), and so on. Its current list of alumni includes International table tennis player Harmit Desai; International triathlon player and South Asian champion Pooja Chaurashi; seven-time Guinness World Record holder in martial arts Vispi Jimmy Kharadi; international swimmer Ansul Kothari; Mehul Chitroda, gold medal winner in yoga at an international competition in Taiwan; and Anjali Sangle, gold medal winner in the Asian powerlifting event in Hong Kong.At present, over 28,000 students are studying in schools, colleges, and other courses at 32 education institutions run by the SES.Among these seven are self-financed primary schools, seven secondary grant-in-aid schools, and a secondary self-financed school, followed by six grant-in-aid colleges affiliated to Veer Narmad South Gujarat University, eight self-financed colleges affiliated to Sarvajanik University (The Gujarat government granted it a private university status in 2021), and three research centres.SES chairman Bharat Shah said, "Our society runs on donations, and we charge minimum fees, but we impart quality education to the students and provide other facilities.""The goal is to ensure that no student in the city is left behind in education. For students who are unable to pay the fees, we have scholarships. We also have two hostels for girls and one for boys, catering to students from neighbouring tribal villages in South Gujarat. The charges of these hostels are

Shah said the SES has plans to set up a multispeciality hospital. "We will also start a medical college in the future."The university also runs a research centre, where students pursuing PhD and MPhil get the advantage of an age-old library containing a rare collection of manuscripts. Apart from this, the society also operates the Dr Nimesh Vashi Centre for Environmental Engineering and Research. Apart from academic education, the society also operates a music school for women, which offers evening classes. Shah said, "The society runs education institutions that have classes with cutting-edge technologies - smart board, smart classrooms, e-learning, audiovisual system, online education, computer laboratory, etc."

#### Furnish information under RTI Act to BPL people free of cost, Telangana High Court affirms

The Telangana High Court has affirmed the right of Below Poverty Line (BPL) individuals to receive information under the Right to Information (RTI) Act, 2005, without charge. This ruling by the bench of Justice T Madhavi Devi on September 3 stemmed from a petition filed by Gadipally Ganesh, a law student from the Mahabubabad district.

Ganesh had sought information regarding the beneficiaries of the Indiramma Indlu housing scheme in his village, suspecting that eligible applicants were being excluded. His request, submitted to the Public Information Officer (PIO) of Narsimhulapet Village, was met with a demand for a fee of Rs 6,171 to cover printing costs. Despite appeals to both the First Appellate Authority and the Telangana Information Commission, Ganesh was denied relief, prompting him to file a writ petition with the high court.Justice Madhavi Devi's judgment underscored a critical point: Section 7(5) of the RTI Act explicitly mandates that information be provided free of charge to persons belonging to the BPL category. The court determined that no state-level directive, including the government order (GO) 454 of 2005 cited by the authorities, could supersede this central statute. The



court noted that GO 454, while setting fees for RTI requests, failed to address the statutory exemption for BPL applicants and therefore could not be applied to justify the denial of free information. The ruling emphasises that charging a fee to a BPL applicant is a violation of the fundamental principles of the RTI Act. The court has since directed the PIO to furnish the requested information to the petitioner at no cost, reinforcing the Act's core objective of ensuring transparent and accessible governance for all citizens, particularly the economically disadvantaged. #### Backbone of Punjab defense against flood, MGNREGA workers complain pending wages





As Punjab reels under heavy rainfall and flooding, Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) workers have emerged as the backbone of the state's flood defense. While embankments (Dhussi bundh) on the Beas, Ravi and Ghaggar rivers have breached at several points, the Sutluj's bandh has held firm so far thanks largely to the relentless efforts of farmers, villagers and particularly MGNREGA workers. In Ludhiana's Sasrali, where erosion threatens the Sutluj's bandh, strengthening work is underway. However, the irony — while MGNREGA workers stand as shield against the floods, payments worth nearly Rs 7 crore are pending in Jalandhar district alone — Rs 1.25 crore in Mehatpur, Rs 94 lakh in Phillaur, Rs 42 lakh in Nurmahal, Rs 33 lakh in Shahkot, Rs 50 lakh in Lohian and Rs 69 lakh in Rurka Kalan among others. Thousands of MGNREGA workers across the state are filling lakhs of sandbags daily, either to reinforce exist-

ing embankments or to keep them ready for emergencies. According to the Rural Development and Panchayat Department, 7.18 lakh households were engaged in MGNREGA work between April and early September this year. In comparison, 8.34 lakh households worked in 2024 and 8.49 lakh households in 2023. While hundreds of workers are working in every district, officials said, Jalandhar alone has employed around 700 for filling the sandbags. "More than 35,000 sandbags have been filled in the past couple of days," said ADC (Development) Jalandhar, Vivek Modi. Last year, MGNREGA workers were deployed continuously from April to August to strengthen the Dhussi bundh under a special flood-protection drive. "Because of that work, despite unprecedented rainfall this year, the embankment from Phillaur to Gidderpindi has survived without any breach so far," said Tarsem Peter, president of the Pendu Mazdoor Union. Criticising the government for "11th-hour preparations" this season, Peter said, "Had the workers been engaged from April again this year, much of today's emergency could have been avoided."Though the Centre credits the wages directly, Pendu Mazdoor Union leaders argued that the state must coordinate better to ensure timely disbursal. On the ground, the workers are complaining that their hardships remain unaddressed. "We are working tirelessly to save the bandh, even though our wages remain unpaid for weeks," said Kulwinder Kaur, who is part of a group working near Sangowal village. "We are daily wagers, our kutcha houses are damaged by incessant rain and the government should at least provide ration relief." Another MGNREGA worker at Sangowal, Sunita, said: "Several MGNREGA workers' mud houses have become unlivable due to incessant rain. Safe housing must be provided to us." Meanwhile, religious and social organisations have stepped in with langars and other essentials. Alongside MGNREGA workers, farmers and farm union members are also standing guard at embankments. However, they allege that ruling party leaders have mocked their voluntary efforts to cover up official lapses. "We are working day and night at the bandhs to prevent breaches, but instead of acknowledging our role, leaders are passing derogatory remarks." But the question looming large is whether those shoring up Punjab's fragile flood defenses will themselves be left unprotected from poverty and neglect

#### 6-month extension to Himachal chief secy; no further extension allowed, says ASG in HC

There is a six-month cap on the period of extension granted to government official, and there can be no further extension beyond the said period, Additional Solicitor General (ACG) of India S D Sanjay has submitted in the Himachal Pradesh High Court. The ASG made the submission before a division bench headed by Chief Justice GS Sandhawalia, which is examining whether a March 28 order granting an extension to Chief Secretary Prabodh Saxena was in violation of Central Service Rules and Department of Personnel & Training (DoPT) guidelines. The bench, also comprising Justice Ranjan Sharma, later listed the matter for September 22. The bench was hearing the arguments on a public interest litigation (PIL) filed by one Atul Sharma who has sought the quashing of the extension, arguing that vigilance clearance cannot be granted to an officer facing a corruption case under the Prevention of Corruption Act.

A 1990-batch IAS officer, Saxena has been chargesheeted in the INX Media scam and had earlier been granted exemption from personal appearance in the case. He was given an extension of six-month on March 28, barely three days before his retirement. The extension ends on September 30. Appearing for Union of India, ASG Sanjay submitted that Chief Minister Sukhvinder Singh Sukhu had sought a one-year extension, citing Saxena's role in key public-interest projects."Full justification had been given for his services for executing various projects in the State in public interest. Resultantly, the Competent Authority had granted the extension to the serving Chief Secretary for a period of six months under Rule 16(1) of the All India Services (Death-cum-Retirement Benefit) Rules, 1958," the ASG submitted. The ASG further submitted that there is a cap on the period of extension, which is only six months and there can be no further extension beyond the said period in view of the mandatory provisions of the Rules.

During an earlier hearing on August 13, the court had summoned the entire record from the Centre and the State regarding the extension, which was produced on September 4 in a sealed cover. "We have gone through the same and it is re-sealed and retained by this Court, which will remain in the custody of Registrar General," the court said, ad deferred thb ematter to September 22. Meanwhile, in a related matter, the court modified a June 20 order imposing a Rs 5 lakh cost on the state government for the delay in appointing the Himachal Pradesh Real Estate Regulatory Authority (HP RERA) chairman and member. The court directed that the amount be deposited with the Registrar (Accounts) within a week to be used as part of a relief fund aimed at helping those affected by the state's recent severe weather conditions. The court also outlined a structured plan for relief distribution, similar to efforts made in 2023. Donations in cash, clothes, medicines, utensils, and other essentials will be collected from judges, staff, advocates, and district judiciary members. The District Legal Services Authorities will be tasked with identifying affected areas and ensuring distribution. A nodal officer—the Registrar (Accounts)—will oversee collection and distribution in coordination with the State Legal Services Authority.

#### From barren fields to berry dreams: Strawberry boom transforms Haryana's arid belt

On a crisp September morning, 32-year-old Sandeep Nagil walks through rows of freshly tilled earth in Harita village, his feet brushing the soil that will soon cradle strawberry saplings. The once-parched land, notorious for its aridity near the Rajasthan border, now promises a winter carpet of crimson berries, a sight few could have imagined three decades ago. Nagil, who runs a 1.5-acre strawberry nursery, beams as he shows off imported saplings. "This time, I've brought plants from Egypt," he says with pride. "Earlier, we sourced them from Florida to prepare nurseries locally, ensuring quality for fellow farmers. Now, Egyptian nurseries are better." He plans to cultivate strawberries on 6.5 acres this season. Harita is among three villages, along with Saharwa (Hisar) and Chanana (Bhiwani), that have turned sandy tracts into a thriving strawberry hub, expanding from a single acre of experimental cultivation in the 1990s to over 500 acres today. The transformation began in 1996 when Dr Anil Godara, then a scientist at Chaudhary Charan Singh Haryana Agricultural University (CCSHAU), planted strawberries on one acre using Israeli techniques. Encouraged by success, he expanded to 10 acres and inspired farmers from neighbouring villages to take the plunge

Today, these farmers collectively supply their harvest to Delhi's Azadpur market, sharing transportation costs. "Three years ago, I earned Rs 9.75 lakh from just 2.25 acres," says Nagil. "If the weather holds, one can make Rs 3-5 lakh per acre." Some farmers, he adds, have even bought more land with their profits. Strawberry farming here is no casual affair. Nagil has installed CCTV cameras for security and insists that the crop demands precision and daily care. "It's a micro-managed form of agriculture," he says.Local farmers credit their success to Godara, who continues to guide them even after retiring as head of CCSHAU's horticulture department. "Whenever we face a problem, we call him," says Nagil. Godara explains why the crop thrives here: "Light, well-drained soil and a mix of hot days and cool nights create ideal conditions." The growing season runs from September to March, with one harvest per year. The strawberry saplings are planted between mid



September and early November and the fruit is harvested in March. The fruit, he notes, is highly perishable, lasting just 1-5 days, so farmers rush it to market immediately

When actively farming, Godara imported plants from California because Hisar's climate resembles that of California. "A good crop can yield up to 200 quintals per acre," he says. Noida-based astrologer Ashwini Kumar, who was arrested on Saturday for allegedly sending a WhatsApp message threatening to blow up Mumbai, is no stranger to police cases. In 2023, the 51-year-old had been arrested in Patna after a businessman, Firoz Ahmed, filed a cheating complaint against him. Kumar had, however, claimed Firoz

To exact revenge over his previous arrest, Noida Police said Kumar allegedly sent a fake threat message in Firoz's name to the official WhatsApp number of the Mumbai Traffic Police on Friday. The message claimed that 34 "human bombs" carrying "400 kg of RDX" had been planted in 34 vehicles for a blast that would "shake the entire city". As per the FIR lodged at Bihar's Kotwali police station on June 9, 2023, Firoz — a Patna-based businessman — had claimed that "in May 2022, one person, namely Ashwini Kumar Supra, called him up and introduced himself as an Intelligence Bureau (IB) officer". The complainant said he had told the caller about his financial difficulties. Kumar then told him he'd help him get a loan from a bank using his "IB reference". Over the next one-and-a-half years, Firoz alleged, he transferred more than Rs 15 lakh to two bank accounts provided by Ashwani - one in Delhi and another in Noida — but never received any loan. Firoz then lodged a complaint, and police filed a cheating and impersonation case under IPC sections 406, 418, 419 and 420. Subsequently, Kumar was arrested and sent to judicial custody on June 12, 2023. He moved the District and Sessions Court, Patna Sadar, for bail. The case was transferred on August 7, 2023, to the court of Additional Sessions Judge (10th), Kumar Dhirendra Rajajee.

The petition was heard on multiple dates across August and September.In his written order, the judge noted that bank statements in the case diary showed about Rs 8 lakh had been deposited into the accused's accounts while only about Rs 50,000 had been returned. The order also recorded documents filed by Kumar, which showed that Firoz had described two earlier transfers — Rs 3.6 lakh on May 10, 2022, and Rs 1.37 lakh on May 18, 2022 — as gifts, even referring to him (Kumar) as "his best friend who has helped him many times". The defence had also argued that Kumar and Firoz "have a business relationship". The judge, however, had disposed of the bail request, concluding that the allegations were serious and not fully explained.Kumar then approached the Patna High Court by filing a petition on October 10, 2023. The High Court granted him bail on March 20, 2024, on furnishing bail bonds of Rs 10,000 with two sureties of the like amount each to the satisfaction of CJM, Patna.

### Aid trucks roll into Gaza as dispute over hostage bodies is paused



JERUSALEM/CAIRO, GNS News Agency, Oct 28-Aid trucks rolled into Gaza on Wednesday and Israel resumed preparations to open the main Rafah crossing after a dispute over the return of the bodies of dead hostages that had threatened to derail the fragile ceasefire deal with Hamas. Israel had threatened to keep Rafah shut and reduce aid supplies because Hamas was returning bodies too slowly, showing the risks to a truce that has stopped two years of devastating warfare in Gaza and freed all living hostages held by Hamas.

However, the militant group returned more Israeli bodies overnight, and an Israeli security official said on Wednesday preparations were under way to open Rafah to Gazan citizens, while a second official said that 600 aid trucks would go in. Hamas returned four bodies confirmed as dead hostages on Monday and another four bodies late on Tuesday, though Israeli authorities said one of those bodies was not that of a hostage. The dispute over the return of bodies still has the potential to upset the ceasefire deal along with other major issues that are yet to be re-

Later phases of the truce call for Hamas to disarm and cede power, which it has so far refused to do. It has launched a security crackdown, parading its power in Gaza through public executions and clashes with local clans. Longer-term elements of the ceasefire plan, including how Gaza will be governed, the make-up of an international force to take over there and moves towards the creation of a Palestinian state have yet to emerge. Twenty-one bodies of hostages remain in Gaza, though some may be hard to find or recover because of destruction during the conflict. An international task force is meant to find them. The deal also requires Israel to return the bodies of 360 Palestinians. The first group of 45 was handed over on Tuesday and the bodies were being identified, said Palestinian health authorities

The war has caused a humanitarian catastrophe in Gaza, with nearly all inhabitants driven from their homes, a

global hunger monitor saying famine was present in the enclave and health authorities overwhelmed."Our situation is utterly tragic. We went back to our homes in the al-Tuffah neighbourhood and found there are no homes at all. There is no shelter. Nothing," said Moemen Hassanein in Gaza City, with tents and shanties behind him.

Reuters video showed a first group of trucks moving from the Egyptian side of the border into the Rafah crossing at dawn on Wednesday, some tankers carrying fuel and others loaded with pallets of aid. However, it was not clear if that convoy would complete its crossing into Gaza as part of the 600 trucks that were due to enter the enclave on Wednesday - the full daily complement required under the ceasefire plan. Aid trucks entered Gaza through other crossings."Humanitarian aid continues to enter the Gaza Strip through the Kerem Shalom Crossing and other crossings after Israeli security inspection," the Israeli security official said. Israel's public broadcaster Kan reported that Wednesday's aid deliveries would include food, medical supplies, fuel, cooking gas and equipment to repair vital infrastructure. Underscoring the political challenges facing the truce, Israel's far-right National Security Minister Itamar Ben-Gvir, an opponent of the ceasefire plan, said on X that the aid delivery was a "disgrace". "Nazi terrorism understands only force, and the only way to solve problems with it is to wipe it off the face of the earth," he added, accusing Hamas of lies and abuse over the return of hostages' bodies. Rafah is due to be opened to Palestinian inhabitants of Gaza either entering or exiting the enclave. But those awaiting medical evacuation told Reuters they had not yet received notification to prepare for travel. The Palestinian Authority, which governs in the Israeli-occupied West Bank, is preparing to operate the Rafah crossing into Egypt, which it previously did with EU assistance. Israel closed the crossing in 2007 after Hamas took over the enclave, but later allowed some movement through it under an agreement

Several other Palestinian factions present in Gaza have backed the days-long Hamas security crackdown as it battles local clans that had tried to take over areas of the territory during the conflict. The Popular Front for the Liberation of Palestine, one of the groups backing the Hamas crackdown, described the clans being targeted as "hubs of crime". The ceasefire envisaged Hamas initially restoring order in Gaza and U.S. President Donald Trump, who brokered the deal, endorsed Hamas' crackdown on rival gangs, while warning it would face airstrikes if it did not later disarm.Palestinian Authority chairman Mahmoud Abbas condemned the public executions after a video, authenticated by Reuters, showed masked gunmen shooting dead seven bound, kneeling men in a Gaza street. Israeli forces inside Gaza have pulled back to what the truce deal calls a yellow line just outside the main cities. Israeli Defence Minister Israel Katz said it would immediately enforce any violation of the line.

### Syria's Sharaa tells Putin at Kremlin meeting he will respect all past deals with Moscow



MOSCOW, GNS News Agency, Oct 28- Syrian President Ahmed al-Sharaa told Russian President Vladimir Putin on Wednesday he would honour all past deals struck between his country and Moscow, a pledge suggesting Moscow's two main military bases in Syria are safe. Sharaa, who once headed the Syrian branch of al Qaeda and who toppled predecessor Bashar al-Assad, a close Russian ally, late last year, was speaking at the start of Kremlin talks with Putin, his first visit to Russia since coming to power.

"There are bilateral relations and shared interests that bind us with Russia, and we respect all agreements made with it. We are working on redefining the nature of relations with Russia," Sharaa, who was speaking in Arabic, told Putin.Putin told him that Moscow was ready to do all it could to act on what he called "many interesting and useful beginnings" that had already been discussed between the two sides when it came to renewing relations. The Kremlin chief also congratulated Sharaa on the fact that parliamentary elections were held earlier this month in Syria. "I believe that this is a great success for you, because it leads to the consolidation of society, and despite the fact that Syria is currently going through difficult times, it will nevertheless strengthen ties and cooperation between all political forces in Syria," said Putin.

The Kremlin said before the talks that the fate of Russia's two main bases in Syria - the Hmeimim air base in Syria's Latakia province, and its naval facility at Tartous on the coast - would be discussed. Russia, which has economic and energy-related interests in Syria that it also wants to secure, has a military presence at Qamishli airport - in the northeast near the borders of Turkey and Iraq - as well. Russian Foreign Minister Sergei Lavrov said on Monday that Moscow believed Damascus wanted the military bases to stay and spoke about an idea of also using them as logistics hubs to get aid to Africa by sea and air. Syrian officials are seeking guarantees that Russia will not help rearm remnants of Assad's forces, a Syrian source said before the talks. Sharaa is hoping that Russia might also help rebuild the Syrian army, the same source said.

Sharaa's visit is sensitive. Russia used its military muscle to back Assad for years against Syrian rebels who came to power in December last year led by Sharaa. Moscow then granted asylum to Assad and his family when they fled the country. The Assads now live discreetly in Moscow, according to Russian media. Sharaa will use the talks to formally request that Moscow hand over Assad to face trial over alleged crimes against Syrians, two Syrian sources told Reuters. Russia prides itself on being able to protect its foreign allies and is not likely to agree to hand over Assad to Damascus. Lavrov said on Monday that Russia had given Assad refuge because his life had been under threat. Sharaa, who is hoping to secure economic concessions from Russia, including the resumption of wheat supplies on favourable terms and compensation for war damage, is expected as well to press for Moscow's backing to resist Israeli demands for a wider demilitarised zone in southern Syria. He may also raise the issue of redeploying Russian military police as a guarantor against further Israeli encroachments, one of the two sources said. The Kremlin said it did not expect Putin and Sharaa to hold a news confer-

### India, Indonesia conduct bilateral naval exercise 'Samudra Shakti' in Visakhapatnam from Oct 14-17

New Delhi: The Indian Navy is hosting an Indo-Indonesian bilateral maritime exercise at Visakhapatnam from October 14-17, aimed at enhancing interoperability, strengthening mutual understanding and sharing best practices between the two navies, officials said on Wednesday.

The participating units include INS Kavaratti, an antisubmarine warfare corvette of the Eastern Fleet under the aegis of Eastern Naval Command (ENC), and the Indonesian Navy Ship KRI John Lie, a corvette (with an integral helicopter), which arrived at Visakhapatnam to a warm welcome by the ENC, the defence ministry said. Exercise Samudra Shakti highlights the shared commitment of both nations towards maintaining stability and peace in the Indo-Pacific region, the official said. It is a key bilateral engagement aimed at enhancing interoperability, strengthening mutual understanding, and sharing best practices between the two navies, the defence ministry said in a statement.

The harbour phase features a range of activities aimed at building camaraderie and professional rapport that include cross-deck visits, joint yoga sessions, friendly sports fixtures, and professional subject matter expert exchanges, it said. The sea phase will involve dynamic and complex maritime operations aimed at increasing tactical coordination.

#### What is Britain's China spying case about?



LONDON, GNS News Agency, Oct 28The British government has come under sustained criticism after a prosecution against two men accused of spying for China collapsed last month, with critics saying it was because of fears of upsetting Beijing. WHAT IS THE UK CHINESE SPYING CASE?

Two men, Christopher Cash, 30, a former director of the China Research Group think-tank, and Christopher Berry, 33, who worked as a researcher for a senior law-maker, were arrested by British police in March 2023 on suspicion of spying for China.In April 2024, the men were charged with an offence under the 1911 Official Secrets Act of passing politically sensitive information to a Chinese intelligence agent known as "Alex". They denied any wrong-doing and China says the case is entirely fabricated and a malicious slander.In an unexpected move, Britain's Crown Prosecution Service (CPS) dropped the charges on September 15, a month before the trial was due to start, saying the case no longer met the evidential threshold.

WHY DID THE CHINESE SPYING CASE COL-

Since it was dropped, Prime Minister Keir Starmer's Labour government has been accused by opponents of undermining the prosecution because it did not want to upset China, with which it is seeking better economic ties. Critics have particularly singled out Britain's National Security Adviser Jonathan Powell because of what they say are his ties to China. The UK government has rejected these accu-

sations. Starmer said the decision to drop the case was made independently by the CPS and that ministers were disappointed it had not gone ahead. However, the CPS said, prior to the prosecution being dropped, that it had for many months asked the government for new evidence which it believed was necessary for the case to go ahead.

WHY IS THERE A DISPUTE?

The problem centred around the wording of the charge. Under the Official Secrets Act (OSA), a law brought in to deal with German spying before World War One, it is an offence to communicate documents which might be useful to "an enemy". At the time when the men were charged, Britain's then-Conservative government had classified China as an "epoch-defining challenge" but stopped short of officially labelling it a threat. However, lawmakers and the intelligence agencies had regularly warned about the threat of Chinese espionage and activities designed to influence British politicians, businesses and academia. In July 2024, in a separate case which involved a team of Bulgarians later found guilty of spying for Russia, London's Court of Appeal determined that an enemy under the OSA meant a country which "represents a current threat to the national security of the UK". It was following that ruling that the CPS said it had sought new evidence from the government, but that none of the additional witness statements obtained stated that China was a threat to national security at the time of the offence. The government says the statements, provided by a deputy national security adviser without any involvement from Powell, had to state the official position at the time of the charge under the then Conservative administration. The CPS says it is now up to the government whether to make those statements public. Starmer said on Wednesday that these would be published.

WHO IS RIGHT?

It is possible that even disclosing these statements will fail to provide clarity on who was right, as some legal experts suggest both the government and the CPS got themselves in a muddle over the issue. The experts say that if the CPS had enough evidence to bring a charge in April 2024, then it is not clear what more they needed after the Court of Appeal's ruling which, if anything, made it easier to define an "enemy" under the OSA. However, that is unlikely to deflect criticism that the government appeared to be unwilling to provide evidence which made clear China was a threat, even if it was not officially described as such, because it would have meant stating it publicly in court.

### Trump targets China cooking oil trade - but sales were already tanking



WASHINGTON/BEIJING,GNS News Agency, Oct 28 U.S. President Donald Trump said he was considering terminating some trade ties with China, singling out cooking oil, which traders and analysts said would have little impact as such shipments had already plummeted from China over the past year."I believe that China purposefully not buying our Soybeans, and causing difficulty for our Soybean Farmers, is an Economically Hostile Act. We are considering terminating business with China having to do with Cooking Oil, and other elements of Trade, as retribution," Trump wrote on social media on Tuesday.Read about innovative ideas and the people working on solutions to global crises with the Reuters Beacon newsletter. "As an example, we can easily produce Cooking Oil ourselves, we don't need to purchase it from China."The U.S. was China's top market for used cooking oil (UCO), importing a record 1.27 million metric tons worth \$1.1 billion in 2024. But after China cut tax rebates late last year and the U.S. imposed tariffs on Chinese goods this year, imports plunged 65% in January-August to 290,690 tons, or \$286.7 million.As such, Trump's comments would have "minimal" impact on the commodity, two UCO traders in China said on condition of anonymity as they were not authorized to speak to media. "Domestic producers are now mainly taking orders for Europe and are no longer considering the U.S. market," said one of the traders.

SHORT HISTORY AS EXPORT MARKET FOR CHINESE COOKING OILThe U.S. does not have a long history of being a top export market for Chinese used cooking oil, a product that can be converted into renewable diesel and which has helped the U.S. become one of China's top ten export destinations only as recently as 2022.By contrast, the Netherlands, Singapore, Spain and Malaysia have consistently processed hundreds of millions dollars' worth of Chinese UCO over the past decade, Chinese customs data shows. Year-to-date shipments to this year's top buyer Singapore are up 15% from last year at \$537 million, while exports to the Netherlands - whose figures are distorted by the Rotterdam megaport - have jumped 131.5% over the same period. REUTERS/Florence Lo/Illustration Purchase Licensing Rights, opens new tabChinese used cooking oil exports to the U.S. had surged in 2023, driven by federal and state incentives supporting biofuels and a rush to build new renewable diesel plants. Analysts said Trump's announcement was not escalatory following a week of fresh tariff threats and export controls. Used cooking oil trade is small compared with that of soybeans. Last year, China imported 22.13 million tons of U.S. soybeans worth \$12 billion.But restricting UCO imports allows Trump to show the U.S. agriculture industry he is still being tough on China, some analysts said. "Used cooking oil is a niche trade, but it shows how the Trump Administration is standing up for American farmers, just as China shifts its agricultural purchases towards other suppliers," said senior analyst Chim Lee at the Economist Intelligence Unit. China is the world's largest buyer of soybeans. In recent months it has slashed purchases of U.S. sovbeans in favor of Brazilian and Argentine produce. Trump has called the shift a negotiation tactic. He said this month he hoped to discuss soybeans with Chinese counterpart Xi Jinping while also saying the U.S. may halt a large share of imports from China. "So from 100% tariffs on all Chinese trade (in response to the rare earth/critical mineral export controls) to targeted sanctions on cooking oil?" Brad Setser, a former U.S. trade official now with the Council on Foreign Relations wrote on X.

### Pakistan, IMF reach staff-level agreement for \$1.2 bn loan deal

Islamabad: Pakistan and the IMF on Wednesday reached a staff-level agreement (SLA) on the country's loan programmes, paving the way for Islamabad to access USD 1.2 billion, pending approval from the global lender's board.

The Washington-based International Monetary Fund (IMF) will provide Pakistan with USD 1 billion under its Extended Fund Facility (EFF) and USD 200 million under its Resilience and Sustainability Facility (RSF) after approval from the fund's board. Last week, an IMF mission led by Iva Petrova concluded talks with Pakistani authorities on the second review of the EFF agreed in 2024 and the first review for the RSF climate loan agreed this year, but it left Pakistan without signing a staff-level agreement.

In a statement issued early on Wednesday, Petrova stated that the staff-level agreement remained subject to approval by the IMF Executive Board. "Supported by the EFF, Pakistan's economic programme is entrenching macroeconomic stability and rebuilding market confidence," she said.

"The recovery remains on track, with the FY25 current account recording a surplus — the first in 14 years, the fiscal primary balance surpassing the programme target, inflation remaining contained, external buffers strengthening, and financial conditions improving as sovereign spreads have narrowed significantly," she said. However, she added, the recent floods had weighed on the country's outlook, particularly of the agriculture sector, bringing down the projected FY26 gross domestic product (GDP) to about 3.25-

3.5 per cent.

The IMF official also noted progress on Pakistan's policy priorities, saying: "The authorities reaffirmed their commitment to the EFF and RSF-supported programmes, and to maintaining sound and prudent macroeconomic policies while advancing ongoing structural reforms." She said that authorities remained committed to meeting the FY26 budget primary surplus of 1.6 per cent of GDP, anchored in sustained efforts to mobilise revenue through tax policy and compliance measures, and "stand ready to take necessary actions should revenue shortfalls risk programme targets". "At the same time, the authorities are assessing the flood damage and are providing urgent flood relief support in the affected provinces via reallocations in the provincial and federal budgets," Petrova said.

She also said that efforts were underway to enhance revenue mobilisation, broaden burden-sharing between federal and provincial governments, and strengthen public financial management. The IMF official noted that the State Bank of Pakistan (SBP) was committed to a prudent monetary policy stance to ensure inflation remains durably within its target range of five to seven per cent. On the issue of circular debt to the power sector, she said that Pakistan remained committed to preventing its accumulation through timely tariff adjustments that ensure cost recovery and maintaining a progressive tariff structure. Petrova added that the recent floods and those of 2022 had underscored the need for building Pakistan's climate resilience.

#### The unexplained drop in gender ratio following Bihar's SIR



In the 2024 general elections, Bihar was one of the few States where a higher percentage of women voted compared to men, even though there were fewer women than men registered on the electoral rolls. The plausible explanation for this was that a high number of men had migrated from the State to other parts of the country and were unable to travel back to their respective constituencies. One of the ostensible reasons for the Election Commission of India to conduct its Special Intensive Revision exercise — done within 40 days between June 25 and August 1 — was to exclude voters who were not ordinarily resident in Bihar, including migrants working outside the State. Given that the turnout of men was lower than the turnout of women (by several percentage points in some seats) in the election, it was expected that the share of male electors would be pruned, leading to a higher gender ratio from the 907 female voters for every 1,000 male voters registered in the 2024 general elections

However, the final SIR rolls show the opposite trend. The gender ratio has come down to 892, one point lower than what it was in the draft electoral rolls in August. This suggests that there were barely any re-inclusions of women who had been excluded from the draft rolls. The fall in the gender ratio since the Lok Sabha elections in parliamentary constituencies also shows a moderate correlation (0.45) with the increase in female turnout relative to men. The chart below illustrates this relationship: in constituencies where the female turnout was higher than the male voter turnout, the exclusion of women from the electoral rolls was higher in the final rolls. It shows the ratio of female to male electors against the ratio of female to male voter turnout in the 2024

The chart below shows the gender ratio of voters in the 2024 Lok Sabha elections in the horizontal axis and the decline in gender ratio since the elections to the final SIR roll.In parliamentary constituencies such as Gopalganj, which registered 1,218 women voting for every 1,000 men who voted, the reduction in the gender ratio from the 2024 general elections to the final SIR roll was 8.38% (967 to 886). The corresponding numbers for Kishangani were 1,066 women and 7% respectively. These numbers suggest that a significant number of eligible female electors could have been left out in the final SIR rolls. In previous Data Points, we had found that the exclusions were higher in the 18-29 age category and particularly for the reason, 'permanently shifted'. The ECI said in the Supreme Court that women's names would have been excluded as they had migrated to other States after marriage. Yet, our data stories had shown that more men migrated for work than women who migrated for marriage, according to the Census and later surveys.

Ground reports from Gopalganj and Kishanganj by The Hindu revealed that many women whose names were taken off had not gone far: some had moved to neighbouring villages in the same seat and some were registered in the rolls in booths which represented their residence after marriage. Yet, the large-scale reduction in the gender ratio across the entire State, except for a few seats suggests that not all women who had married and migrated to other parts of the State would have re-registered themselves in the rolls. When this question was put forth to the Chief Election Commissioner on October 5 in Patna, he put the onus on political parties to include names that had been left out and said such revisions could continue till 10 days before the deadline for filing nominations. The map below shows the seat-wise absolute change in gender ratio between the January and September 2025 rolls The SIR exercise whittled down the electoral roll from 7.89 crore in January 2025 to 7.42 crore in September 2025, with the net exclusion of 47 lakh voters across Bihar. The map below shows the seatwise percentage change in electors between the January and September 2025 rolls. The highest deletions have occurred in seats at or near the State's border.

#### What's happening at Visva-Bharati? A dive into the university's NEP crisis

Once envisioned as a living embodiment of Rabindranath Tagore's philosophy of free learning, Visva-Bharati University now stands at a crossroads. When the National Education Policy (NEP) was introduced in 2020, it promised a new era for India's learning institutions, aiming to foster innovation, interdisciplinarity, and global competitiveness. At Visva-Bharati—founded by Rabindranath Tagore with a vision of blending art, science, and humanity—the expectations were particularly high. But five years later, the university finds itself mired in controversy, cutbacks, and campus unrest

In 2025, the university eliminated its modest ?6 lakh internal annual fund used to support experimental science laboratories—a move that faculty say cripples scientific education at the institution. "Reducing the allocation to zero means shutting down scientific exploration," said a senior professor from the Department of Science, "We can't purchase basic materials or run hands-on projects. There's no proper hiring happening either." Faculty report that instead of academic support, they're now being sent to administrative training sessions under the Rashtriya Karma Yogi program, which draws leadership lessons from Indian epics like the Gita and Mahabharata. A shift in campus culture

Much of the current unrest is being traced back to the tenure of Vice-Chancellor Bidyut Chakrabarty (2018–2023), during which the campus witnessed increased disciplinary actions, protests, and administrative crackdowns. According to university sources, over 150 faculty members faced disciplinary action during this period. Professors who opposed administrative decisions were issued show-cause notices. Students protesting fee hikes were expelled. One professor called it a period of "censorship and fear," where academic discussions were replaced by disputes and confrontation. "Teaching became a form of survival," the professor said. The university also cancelled the historic Poush Mela in 2020 after clashes erupted over plans to construct a perimeter wall around the grounds—an act many saw as a rejection of Tagore's open, inclusive ideals.Between legacy and reform

While many criticize the changes, some faculty believe the NEP offers an overdue course correction. "Earlier, even learning English faced bureaucratic blocks. Tagore always supported a forward-looking mindset," said a senior professor, who served as the Chairperson of Visva-Bharati's NEP campaign committee. "Yes, change meets resistance. But I've seen appointments bypassed for decades, under different governments. This is not new."He argued that if even one of Visva-Bharati's five core objectives had been fully realized, India might be further along the path of intellectual decolonization. Political undercurrents and curriculum battles



The university's troubles reflect a broader pattern in Indian higher education—where politics and academia increasingly overlap. Dr. Ujiwal Roy Chowdhury, Vice President of the Global Media Education Council, explained that whichever party controls the Centre, it tends to influence central universities. "Vice-Chancellors and registrars often hold positions aligned with central government agendas, whether Congress or BJP," said Dr. Roy Chowdhury. "Curriculum changes are inevitable. But today, vetting of professors through ideological think tanks like the Vivekananda Foundation is a visible shift."He added that coverage of Islamic history has been reduced in the curriculum, while inclusion of Indian Knowledge Systems (IKS) has become a new metric for securing funding. Campus voices and controversies

In recent years, controversies at Visva-Bharati have multiplied—professor suspensions, student expulsions, the blocking of academic events, and the 2024 suicide of a student, which again put the university under scrutiny. Even the recent declaration of Santiniketan as a UNESCO World Heritage Site sparked criticism, as initial campus plaques reportedly omitted Rabindranath Tagore's name. West Bengal Chief Minister Mamata Banerjee called the omission "an insult" to Bengal's cultural history. "I've seen values erode," said a long-serving professor. "Critical thought and empathy—what Tagore stood for—are fading fast."A student union leader summed up the sentiment on campus: "The attacks aren't always physical. Suspending professors linked to CERN, cancelling our Mela, and ignoring our voices—this is a slow dismantling of Visva-Bharati's soul."Visva-Bharati, once a symbol of India's intellectual independence and cultural unity, is now a mirror reflecting the broader dilemmas of higher education in India—caught between reform and rigidity, legacy and ideology, autonomy and state control. As NEP continues to roll out across the country, the crisis at Visva-Bharati raises a critical question: Can policy ambition succeed if implementation sidelines the very values it seeks to promote?

#### How does Gaganyaan's vital crew escape system work? | Explained

The story so far: The Gaganyaan mission aims to safely transport Indian astronauts to a low-earth orbit of around 400 km altitude using the human-rated LVM3 (HLVM3) rocket as the launch vehicle, and to return them safely. In human space missions, crew safety is more important than mission success. It is imperative that safety is addressed during all phases: launch pad, ascent, orbit, and

What is the CES?

A dedicated Crew Escape System (CES) will be used during the initial part of the atmospheric phase of the Gaganyaan mission to ensure crew safety in the event of a contingency that jeopardises the mission. The CES is designed to rapidly separate the crew module, along with the crew, from a malfunctioning launch vehicle, and move it to a safe distance in the least possible time. The atmospheric phase of flight is one of the most critical stages of the ascent, during which the rocket accelerates to hypersonic speeds — more than five times the speed of sound — and will be experiencing very high structural loads. The HLVM3 rocket is equipped with two powerful S200 solid-fuel boosters to lift off, and unlike liquid or cryogenic engines, solid

motors cannot be shut down once they are ignited. Thus, the CES must extract the crew module with greater acceleration than the launch vehicle itself, and in minimal time. The CES is a quick-acting system positioned at the forward end of the launch vehicle and is equipped with multiple special-purpose solid motors. These motors use high burn-rate propellants that consume fuel faster than conventional solid motors, generating higher acceleration. In the Gaganyaan mission, the CES could impart acceleration up to 10-times that of gravity. For a healthy human body, such high acceleration is tolerable for a few seconds if the crew is positioned correctly, with the acceleration acting perpendicular to the chest and the body pressed against the seat in a "child in cradle" orientation. Rocket systems are more intricate than those of aircraft, with rocket reliability much lower than that of passenger aircraft. Nevertheless, the CES significantly improves crew survival probability through its heritage-based design, redundant systems, and robust mission planning. What are different types?

The CES is classified into two types based on the way it extracts the crew module: (i) puller type - used in Gaganyaan, where the CES pulls the crew module away from the launch vehicle; (ii) pusher type -

#### What India can learn from Maldives' parent-to-child triple elimination of diseases



On October 13, 2025, the World Health Organization announced that the Republic of Maldives had become the first country in the world to eliminate mother-to-child transmission (EMTCT) of HIV, syphilis, and Hepatitis B virus (HBV). This validation, endorsed by the WHO Director-General after rigorous review, means that the Maldives has reduced the transmission of all three infections from mothers to newborns to levels no longer considered a public health problem. Before this milestone, 19 countries (Cuba, Malaysia, Belarus, Sri Lanka, Armenia, Moldova, Namibia, Belize, Jamaica, Saint Vincent and the Grenadines, Dominica, Thailand, Anguilla, Antigua and Barbuda, Bermuda, Cayman Islands, Montserrat, St. Kitts and Nevis and Oman) had achieved single or dual elimination of HIV and/ or syphilis. Yet, none had reached the combined benchmark of eliminating all three infections.

Vertical transmission refers to the transfer of infection from a parent to a child during pregnancy, childbirth, or breastfeeding. From a clinical standpoint, it is a biological event; from an ethical perspective, it is a profound social failure. A child who acquires an infection at birth carries a burden it did not choose, often shaped by gaps in awareness, access, or social protection. Preventing vertical transmission is not merely a medical obligation but an ethical one. Allowing a newborn to inherit a preventable infection is a collective injustice that societies must strive to end. Vertical transmission has long been an indicator of equity and social justice within health systems. Its elimination represents fairness across gender, geography, and class.

Three diseases, one goalThe three infections (HIV, syphilis, and HBV) share a common transmission pathway but have distinct biological consequences. HIV (Human Immunodeficiency Virus) can cross the placenta or spread during delivery and breastfeeding. Without treatment, up to 30% of infants of HIV-positive mothers become infected, but timely antiretroviral therapy can reduce this risk to below 2%. Syphilis, caused by Treponema pallidum, is transmitted when the bacterium crosses the placenta. Untreated maternal syphilis can result in miscarriage, stillbirth, or congenital infection, outcomes that are entirely preventable through early screening and penicillin treatment. HBV is transmitted mainly at birth. An infant exposed to HBV faces a 90% chance of developing chronic infection, which later predisposes the child to cirrhosis and liver cancer. When the HBV Immunoglobulin and HBV vaccine is administered within 12 and 24 hours, it can prevent almost all such transmissions. Together, these infections not only threaten physical health but also carrysignificant social stigma, often discouraging women (and later their infected newborns) from seeking timely testing or care. How validation works

The WHO validation process is a structured, multilevel review designed to ensure accuracy and sustainability. Every country begins with a proposal sent by the Health Ministry to the WHO through a National Validation Committee (NVC), which compiles data, verifies records, and assesses testing, treatment, and vaccination coverage. The national report is then reviewed by a WHO Regional Validation Committee (RVC) that performs site assessments and audits laboratory quality. Finally, the Global Validation Advisory Committee (GVAC) reviews the regional findings and recommends certification to the WHO Director-General, who issues an official validation certificate. Even after recognition, countries must periodically prove that they continue to maintain elimination every three years for HIV and syphilis and every five years for Hepatitis B. This cyclical reassessment ensures that elimination remains a living public health standard rather than a one-time milestone. Elimination targets

A country must meet strict 25 explicit targets for epidemiological impact and health system performance to qualify for validation based on impact, process, and viral load among mothers and infants.Lessons for IndiaAccording to provisional 2024 estimates from the WHO South-East Asia Region, over 23,000 pregnant women were affected by syphilis, leading to the birth of more than 8,000 infants with congenital syphilis. Around 25,000 HIV-positive pregnant women required treatment to prevent transmission to their babies. Meanwhile, Hepatitis B remains a major concern, affecting over 42 million people across the region. TThe Maldives' success offers hope that India and other countries can adapt to their scale. Replicating its approach across a nation of 1.45 billion people may not be pragmatic, but its principles are applicable. India can begin by targeting island regions such as Lakshadweep and the Andaman and Nicobar Islands, followed by other Union Territories and smaller states. Achieving elimination at the sub-district and district levels would allow India to expand towards a national milestone progressively. While the Maldives demonstrates feasibility, its population size and centralised system are unique. The lesson is not to imitate its structure but to emulate its discipline. Language and sensitivity India also offers an important conceptual contribution to global health communication. The WHO framework refers to vertical transmission as "mother-to-child transmission." but India mandates, through both convention and government order, the use of "parent-to-child transmission." This terminology recognises that responsibility for infection does not rest solely with mothers. In many cases, women may themselves be victims of sexual violence or infection acquired from a spouse/offender. The inclusive term reflects gender sensitivity and acknowledges that men, too, share accountability for transmission prevention. This linguistic shift is not semantic; it symbolises empathy. It ensures that publichealth communication does not stigmatise mothers, who are already marginalised. Global and moral imperative The elimination of parent-to-child transmission is both a medical and ethical necessity. The message for India and the rest of the world is that triple elimination is technically feasible when health programmes are integrated, verified, and prioritised based on data. For the WHO, the Indian experience with inclusive terminology and multi-programme integration offers lessons in cultural adaptation and ethical framing. Preventing vertical transmission protects infants and the dignity of mothers and families. Each infection prevented is a life course altered, proving that prevention remains the most humane form of care.

#### Confusion continues in Mahagatbandhan

With just three days remaining to the deadline for filing nominations for the first phase of elections to the Bihar Assembly, the Mahagatbandhan is yet to declare division of seats among its allies. Amidst the confusion, each party is finalising its list of candidates and intense negotiations are on between the allies to swap seats. The deadline for filing nominations for the 121 seats that go to the polls in the first phase is October 17. The second meeting of the Congress Election Committee (CEC) was held on Tuesday (October 14, 2025) evening. After a three-hour meeting, the CEC decided to set up a four-member committee, headed by Ajay Maken, which will decide on the candidates after the seat-sharing negotiations are over. The Congress is expected to contest around 58-60 seats but there are differences over five seats with the RJD.

"We had launched INDIA bloc from Patna in 2023 with the common resolve BJP Hatao, Desh Bachao. But we seem to forget about it during seat sharing negotiations. The INDIA bloc has paid for this mistake in Haryana and Maharashtra. We hope everyone would learn from their mistakes and be more accommodative," D. Raja, CPI general secretary said, commenting on the drawn out negotiations. The CPI(ML), meanwhile, has started preparing to file nominations on at least 18 seats that have been cleared between the allies. On Monday night, Rashtriya Janata Dal president Lalu Prasad Yadav, according to sources, had distributed the party symbol to half a dozen candidates. When the leader of Opposition in the Bihar Assembly and the RJD's chief ministerial face Tejashwi Yadav returned to Patna he overturned his father's decision, asking the leaders to return the symbol for now. Divya Gautam, the late actor Sushant Singh Rajput's cousin, has been named as the Communist Party of India (Marxist-Leninist)



Liberation's candidate. Rajput was found dead in June 2020 at his residence in Mumbai. The Mumbai Police investigation revealed that he had died by suicide and the BJP ran a campaign "Justice for Sushant" before the 2020 Assembly election, claiming foul play. Ms. Gautam, a theatre artist and former All India Students' Association (AISA) leader has been fielded from the Digha Assembly seat. She is scheduled to file her nomination on Wednesday. She had contested the Patna University Students Union election but narrowly lost. She currently teaches at Patna University. The CPI(ML) is yet to formally release its list of candidates. Vikassheel Insaan Party leader Mukesh Sahani, who began negotiations demanding 35 seats, has now agreed to 25 seats. According to sources, the allies want to offer him fewer seats. There was speculation that Mr. Sahani, who switched sides from the NDA to the grand alliance recently, was also negotiating with the BJP. But with the NDA declaring its seat sharing arrangement, options are limited for Mr. Sahani.

#### How cable TV network came under Tamil Nadu government's control


The Tamil Nadu Arasu Cable TV (TACTV) Corporation Limited, a State government-owned cable television distribution network, had faced criticism recently for allegedly "blocking" the telecast of Puthiya Thalaimurai, a Tamil news channel, on its network. Such measures to curb TV news channels had been taken by different regimes in the past

Against this backdrop, it would be worthwhile to examine the long and complex history of the State's foray into cable television broadcasting. When the cable TV boom happened in the 1990s, post-globalisation, the Multi-System Operator (MSO) business was dominated by businessmen with political backing, whose fortunes swung depending on which party was in power. The idea of bringing order to Tamil Nadu's cable television sector first took shape during the 2001-2006 AIADMK regime. In May 2002, the Assembly passed the Tamil Nadu Exhibition Television Screen through Multi-System Operations, Video Cassette Recorder and Cable Television Network (Regulation) Bill. Chief Minister Jayalalithaa had then pointed out there was no effective regulatory mechanism, leading to a virtual monopoly by a particular network.

This policy intervention was widely seen as an attempt to end the domination of a few large MSOs, particularly Sumangali Cable Vision, a Sun Network company. However, when the Bill was sent to the President for approval, it was returned on Constitutional grounds. An archival report in The Hindu quoted the remarks: "The subject 'Broadcasting and other forms of communications' is contained in Entry 31 of List 1 of the Seventh Schedule of the Constitution, on which the Union has exclusive powers to make laws."Towards the end of its tenure, the Jayalalithaa government renewed its effort by proposing the nationalisation of the cable TV business. The move, it said, would set right the deficiencies and faults in the service offered by private operators. In January 2006, it introduced the Tamil Nadu Acquisition, Transfer and Taking Over of the Administration of Cable Television Network (Including Multiple Service Optical Transport System) Bill, citing several complaints about poor services and exorbitant charges. When the Bill was tabled, it triggered heated debates between the treasury and Opposition benches over the State's power to legislate on the subject.

### What your child's platelet count and haemoglobin levels could be telling you



Platelets are blood cells essential for blood clotting, while haemoglobin is the iron-containing molecule that helps carry oxygen. Platelets are small, colourless cells normally found in your child's bloodstream. They spring into action when there is an injury to blood vessels, helping to stop bleeding and forming clots. Haemoglobin, on the other hand, is an iron-containing protein in the red blood cells that gives them their colour. It circulates in the bloodstream, carrying oxygen from the lungs to the rest of the body. The normal range of platelets and haemoglobin in blood varies with age. and can also fluctuate slightly from day to day. A normal platelet count for children is generally between 1,50,000 and 4.50.000 platelets per microliter of blood. Normal haemoglobin (HGB) levels in children vary significantly by age. Newborns have the highest levels, but these gradually decrease in the first months of life before stabilising with minor variations until puberty.Low haemoglobin levels cause a condition known as anaemia and reduce the amount of oxygen delivered to tissues. Common symptoms include unusual tiredness, weakness, and reduced activity levels. Causes of anaemia include nutritional deficiencies (iron,

vitamin B12, folic acid), chronic diseases such as liver or kidney disorders, blood loss, and genetic mutations affecting the haemoglobin.

High haemoglobin levels cause a condition called polycythaemia, which can also be harmful. This condition may be asymptomatic or may cause symptoms such as headaches, fatigue, dizziness, blurred vision, itchy skin (especially after warm baths), facial redness, or an enlarged spleen leading to discomfort in the upper left abdomen. Other signs include numbness or tingling in the extremities, bone pain, nosebleeds, shortness of breath, or even blood clots, such as deep vein thrombosis or stroke. Common causes nclude heart and lung disease or a genetic condition called Polycythaemia Vera.low platelet count, known as thrombocytopenia, can become life-threatening if the platelet level drops below a critical range, as internal bleeding may occur. Symptoms include easy bruising, frequent nosebleeds, or small red/purple dots (petechiae) on the skin. Causes include viral infections (such as dengue), certain medications, autoimmune conditions, and blood cancers such as leukaemia. If you notice reddish spots or excessive bruising in your child, consult a paediatrician immediately. A high platelet count, known as thrombocytosis, usually results from an underlying condition. It often has no symptoms and is detected incidentally during routine health checks. The most common cause in children is recovery from a recent viral infection, which typically resolves within a few weeks. Other causes include infections, inflammation, or iron-deficiency anaemia. If your child has nosebleeds, frequent bruising, persistent headaches, fatigue, lethargy, or blood in the stool or urine, consult your paediatrician. A doctor can interpret a complete blood count (CBC) to identify the cause of abnormalities and decide whether further tests or treatment are necessary

### Can an ivermectin pill keep malaria from being transmitted?

Between 2000 and 2015, the world's fight against malaria made remarkable progress, with millions of lives saved through better prevention, diagnosis, and treatment. Of late, however, that momentum has slowed. In 2023 alone, malaria claimed nearly 6 lakh lives, with 95% of those deaths occurring in the African region. India has made dramatic progress too, with malaria cases dropping by over 80% in the last decade, especially in urban and semi-urban areas. However, some districts in Odisha, Chhattisgarh, Jharkhand, and the Northeastern States continue to struggle with persistent transmission. This lingering threat has drawn renewed attention to the mass drug administration (MDA) of endectocides, systemic insecticides that work from inside the human body, as a promising tool to reduce malaria transmission. Among these, ivermectin reportedly stands out as the most promising candidate.

Ivermectin has been around since the 1970s. Originally developed to treat parasitic worms, it has been safely given to more than four billion people and is a cornerstone of global campaigns against river blindness and lymphatic filariasis. Dubbed a "wonder drug," it earned its discoverers the Nobel Prize. However, a surprising discovery later expanded its potential: mosquitoes that bit people recently treated with ivermectin often died or didn't live long enough to spread malaria. This finding sparked renewed interest in using ivermectin as a vector control tool in malaria-endemic regions. Subsequent modelling and pilot studies suggested that mass drug administration with ivermectin, especially when timed to seasonal transmission peaks, could help bring down infection rates by shrinking the mosquito population.In malaria control, mass drug administration aims to eliminate the parasite from both symptomatic and asymptomatic individuals, reducing the human reservoir and interrupting transmission

To test this idea in the real world, scientists launched the BOHEMIA trial in Kenya and Mozambique and the findings were published on July 23 in The New England Journal of Medicine. In Kenya, the trial was conducted in Kwale County, a coastal region with year-round malaria transmission despite 85% bed net coverage. The villagers were randomly given either ivermectin or albendazole (an anti-parasitic drug that doesn't affect mosquitoes) once a month for more than three months, starting in October 2023. Children aged 5 to 15, who are among the most vulnerable, were then monitored for six months. The result: malaria cases dropped by 26% in the ivermectin group. This figure exceeded the World Health Organisation's threshold of a 20% reduction to be considered a valuable public health tool. Notably, children living farther from untreated areas had even greater protection, suggesting a strong communitylevel impact. More than 56,000 doses were administered during the study and the participants reported no serious side effects. However, the trial excluded pregnant women and children under 15 kg of body weight, which may limit the drug's broader applicability. The Mozambique trial could not yield conclusive results as the research term's operations were severely disrupted by Cyclone Gombe and a subsequent cholera outbreak. In November 2024, a study in Guinea-Bissau called the MATAMAL trial involved more than 25,000 people in 24 villages. It tested whether adding the drug ivermectin to an already strong malaria treatment program — which used the drug dihydroartemisininpiperaquine, or DP — could make the program work better. Contrary to expectations, there was no significant



difference in malaria prevalence between villages that received ivermectin and those that received a placebo. In fact, there were slightly more malaria cases in the ivermectin group, with no clear impact on mosquito survival or infection rates. Researchers concluded that the timing and dosing used in this trial may not have been sufficient to add value to existing interventions.

Ivermectin still mattersDespite mixed results, both trials reaffirmed ivermectin's safety in large-scale campaigns. Side effects were mild and temporary, mostly headaches and dizziness, with no serious adverse events reported. Ivermectin also offered a distinct advantage over traditional malaria control tools. Bed nets, indoor spraying, and larvicides target mosquitoes that bite indoors and at night. But mosquitoes evolve: some now bite earlier, outdoors or even feed on livestock. This makes it harder to keep them at bay with conventional tools. On the other hand. humans, regardless of time or location. It can also be delivered through existing deworming or parasitic disease campaigns, making it a practical dual-use tool, particularly in remote or underserved areas. The BOHEMIA team also found significant collateral benefits. In Mozambique, people who took ivermectin had fewer skin problems like scabies and head lice. In Kenya, many noticed a dramatic drop in bed bugs. As with all widespread interventions, resistance is a looming concern. A 2024 review in Parasitology Research highlighted the growing resistance to ivermectin in ectoparasites like ticks, lice, and scabies mites, mostly due to overuse in veterinary medicine.

While resistance among human parasites is still rare, there's little data on its impact on Anopheles mosquitoes. Only two out of 18 reviewed studies examined ivermectin's impact on mosquito populations, highlighting a critical gap in surveillance. Should resistance emerge, the drug's value as a malaria control tool could diminish rapidly. And the drug's widespread use for scabies, lice, and livestock parasites may make resistance develop faster. Researchers have also warned that as ivermectin's mass drug administration expands, resistance in non-target organisms must be closely monitored as this risk is often overlooked. Ivermectin affects many parasites, so targeting one species may accelerate resistance in others. In regions with multiple parasites, the chosen doses might favour the target but harm broader control efforts. To stay ahead, researchers are exploring longer-lasting formulations, higher doses, and combining ivermectin with malaria vaccines or genetically modified mosquitoes. Upcoming trial data and resistance tracking will shape its future role in malaria con-

#### New species of finless snake eel named after Kanniyakumari

Researchers from National Bureau of Fish Genetic Resources (NBFGR), Kochi functioning under Indian Council of Agricultural Research, have discovered a new species of finless snake eel and named it after Kanniyakumari as Apterichtus kanniyakumari. The discovery has been published in the latest issue of international peer-reviewed journal, Zootaxa. The species belonging to the genus Apterichtus was discovered off the Colachel coast and has been named after Kanniyakumari to honour the district's cultural, linguistic, historical and geographical significance, said T. T. Ajith Kumar, Principal Scientist and Head, Regional Centre of NBFGR, Kochi.

He added that the researchers from NBFGR have used two specimens collected from Colachel, where fishermen have reported catching them at a depth of 100 metres, during deep-sea trawling. Researchers and scientists have conducted extensive morphological analysis, vertebral counts and DNA based molecular analysis, which confirmed that the eel represents a species which is previously unknown to science. According to the discovery published in

Zootaxa, the new species is distinguished from its congeners by the following characteristics such as head length 9.6-9.7% of total length (TL), tail length 1.8-1.9% of TL and body depth at gill openings 42.1-54.8% of TL. Other features include three preopercular and 9 supratemporal pores, conical uniserial teeth on jaws and vomer, distinct goldenyellow body colouration, ventral side of head pale white with yellow lines along the lower jaw, and three black blotches including one behind the eyes followed by one in rictus and other behind the origin of rictus. The species also has a mean vertebral formula of 52-131. In addition, molecular analysis based on mitochondrial CO1 gene exhibits that this new species forms a distinct clade with its sympatric species, Apterichtus nanjilnaduensis. Mr. Ajith Kumar highlighted species Kanniyakumari as the 16th species discovered from the Indian coast by the NBFGR team. "Kanniyakuamri has a rich biodiversity that needs to be explored further to strengthen the India's biodiversity catalogue," he said.

## Why eco-restoration alone won't help residents of the heavily industrialised Manali-Ennore region in North Chennai




For decades, residents of Ennore and Manali in North Chennai have lived under the shadow of fertiliser plants, oil refineries, and coal-powered thermal plants along the coast. The presence of these "red-category" industries makes Tiruvallur district the State's most polluted industrial cluster, which has left locals there to endure recurring gas leaks, oil spills, and layers of toxic dust settling over fishing hamlets and working-class neighbourhoods.

The crisis deepened in December 2023, when two major industrial accidents — an oil spill and a gas leak — once again exposed the vulnerability of residents. In response, the Tamil Nadu government set up the Manali Ennore Rejuvenation and Restoration Council (MERRC), which was recently launched by the Minister for Environment, Climate Change. As per a government order issued in September 2024, the Council has been tasked with greening projects, desilting, waste management, mangrove restoration, and pollution control. But residents and experts say these efforts fall short. Without addressing the severe health problems that already plague communities, they warn, restoration will remain incomplete. Toxic everyday exposure

For P. Vijayashanthi, a mother of two kids, who moved to Sathyavani Muthu Nagar in Ennore just over a year back, the effects have been stark. "It is terrible for newcomers like me. I developed a continuous cough that doctors linked to asthma. When I leave this area, it improves. When I return, the throat and cough problems start again," she says. She avoids letting her children play outside and shuts windows whenever the air turns pungent. "If we leave our footwear outside overnight, by morning, a layer of black dust covers them," she adds. A recent report from the Global Climate and Health Alliance (GCHA) flagged Ennore-Manali as a stark example of how fossil fuel operations devastate public health. The Cradle to Grave report warns that pollution affects human health from foetal development to old

age. "Our waters are the heart of our culture," said fisherman R. L. Srinivasan from Kattukuppam in the report. "But coal and oil refinery pollution has poisoned them. Fishing is no longer viable, and many of us are leaving behind generations of tradition." Residents say water sources are badly contaminated. "When we dug borewells, the water looked pale whitish, so we had to close them," says Ms. Vijayashanthi. In Valluvar Nagar, Vadivukkarasi says, "Children under five have breathing troubles. Doctors say it's because we live in an industrial area. Effluents in the water cause diarrhoea." According to the GCHA report, fossil fuel pollution is linked to asthma, cardiovascular disease, neurological disorders, cancer, and complications in childbirth. Many harms remain understudied, often surfacing decades later. At a public hearing in January 2024, residents raised concerns about fertility and cancer. Lalitha from V.O.C. Nagar said: "I spent ?3.5 lakhs on treatment. You'll find many families here without children or with cancer patients.' No doubt these claims will have to be investigated thoroughly by State agencies. Demands for a health survey intensified after dust samples collected by locals in May 2025 in Sathyavani Muthunagar showed dangerously high levels of lead, uranium, cadmium, and fluoride. However, no plans have been floated by the State government to carry out a health survey. For older residents in the area, decline has been long and visible. "In the 1970s we fetched clean water two kilometres away. Even then my children's teeth turned yellow from fluoride. Now there are respiratory problems too," says 69-year-old K. Devaki.Without immediate systemic interventions, including health surveys, medical access, and environmental clean-up, Ennore risks remaining a "sacrifice zone" where livelihoods and dignity are traded for industrial growth. Shweta Narayan of the GCHA, co-author of the Cradle to Grave report, stresses that health must be addressed alongside the environment. "Environmental restoration prevents future health problems. But what about the people already affected?" she asks. She calls for parallel, robust health infrastructure in heavily industrialised regions, citing how residents in Cuddalore district have had to pay out of pocket for treatment of allergies and respiratory illnesses caused by untreated industrial effluents. Soumya Swaminathan, chairperson of the M. S Swaminathan Research Foundation and former chief scientist of the World Health Organization, says interventions must be multipronged. "A quick assessment of health needs is essential to understand the kinds of diseases and issues people face, and to make access to specific health services easier. Psychological support must also be given, and residents should be consulted on how things can be improved," she adds.

### NISAR satellite sends first radar images of Earth's surface



The NASA-ISRO Synthetic Aperture Radar (NISAR) Earth-observing radar satellite has sent the first images of Earth's surface as the joint mission between NASA and ISRO approaches full science operations later this year.NASA said that the images from the spacecraft, which was launched by ISRO on July 30, display the level of detail with which NISAR scans Earth to provide unique, actionable information to decision-makers in a diverse range of areas, including disaster response, infrastructure monitoring, and agricultural management. "By understanding how our home planet works, we can produce models and analysis of how other planets in our solar system and beyond work as we prepare to send humanity on an epic journey back to the Moon and onward to Mars," said NASA Associate Administrator Amit Kshatriya. images from NISAR is a remarkable example of how partnership and collaboration between two nations, on opposite sides of the world, can achieve great things together for the benefit of allNASA said that on August 21, the satellite's Lband synthetic aperture radar (SAR) system, which was provided by NASA's Jet Propulsion Laboratory in Southern California, captured Mount Desert Island on the Maine coast.

"Dark areas represent water, while green areas are forest, and magenta areas are hard or regular surfaces, such as bare ground and buildings. The L-band radar system can resolve objects as small as 15 feet (five metres), enabling the image to display narrow waterways cutting around it," NASA said. It added that on August 23, the Lband SAR captured data of a portion of northeastern North Dakota straddling Grand Forks and Walsh counties. "The image shows forests and wetlands on the banks of the Forest River passing through the centre of the frame from west to east and farmland to the north and south. The dark agricultural plots show fallow fields, while the lighter colors represent the presence of pasture or crops, such as soybean and corn. Circular patterns indicate the use of centre-pivot irrigation," it added. The U.S. space agency further said that the images demonstrate how the L-band SAR can discern what type of land cover - low-lying vegetation, trees, and human structures — is present in each area. "This capability is vital both for monitoring the gain and loss of forest and wetland ecosystems, as well as for tracking the progress of crops through growing seasons around the world," it said.

#### 'Confined field trials' on GM maize to begin soon at Punjab Agricultural University

The field trials of two kinds of genetically modified (GM) maize are expected to begin in the ongoing kharif (summer) season at the Punjab Agricultural University, days after the Genetic Engineering Appraisal Committee, the country's top regulator for the sector, gave the nod for the trials, after receiving consent from the Punjab government.In its meeting in June, the committee recommended a proposal by Bayer Crop Science Limited for the conduct of confined field trials on herbicide-tolerant transgenic maize, and insect-resistant transgenic maize at the Ludhiana-based university for this year's kharif season.


The trials will study weed-control efficacy in herbicidetolerant maize hybrids with the application of Glyphosate-K salt, and the efficacy of insect-protected maize hybrids against targeted lepidopteran pests. "The field trials will begin soon as this is the right time for sowing maize," Puniab Agricultural University Vice-Chancellor Satbir Singh Gosal told The Hindu. The university had no involvement in decisions related to the commercialisation of the crop; its mandate was limited to conducting research, under which the field trials would be conducted on GM maize, Mr. Gosal said, dismissing concerns over genetic modification. "At the Punjab Agricultural University, we have the necessary infrastructure, facilities and experts, so we are going ahead with the trials. We need to understand that, unless we study the matter, we will not know whether it's good or bad. The trials are for research purposes only, and we are not going to recommend that it (GM maize) should be grown commercially or not. It's for the Central government to take a call. We would be conducting the trials adhering to the guidelines of the Department of Biotechnology, Government of India, and established standards of procedures. It's a research institute, and it's our mandate to conduct research," Mr. Gosal said. The Coalition for a GM-Free India, a plat-



form advocating safe and sustainable agriculture, has urged the Punjab government to withdraw its No Objection Certificate (NOC) for the trials. In a letter to Punjab Agriculture Minister Gurmeet Singh Khudian, Kavitha Kuruganti, coconvenor of the coalition, said that the State government had an issued order prohibiting the usage of glyphosate, a deadly herbicide with a large body of scientific literature pointing to its negative impacts on human health and the environment....How can the university experiment with herbicide-tolerant maize that has been modified to withstand the application of glyphosate, which is in itself against the legally-approved label claim for glyphosate in India's pesticides regulatory regime?" Ms. Kuruganti said.In 2018, the Punjab government banned the sale of glyphosate, a herbicide used extensively in the State to control a wide variety of weeds in almost all crops. Pointing out that the State government's NOC would result in national repercussions, Ms. Kuruganti urged the State to prioritise an inquiry into the scientific basis on which such NOCs were being issued, and to immediately withdraw the NOC that has been issued for confined field trials on GM maize.

### Surging AI investment similar to dot-com boom of late 1990s: IMF

The International Monetary Fund (IMF) warned on Tuesday that the rising investment in Artificial Intelligence (AI) "echoes the dot-com boom of the late 1990s" and that if expectations from this new technology are not met, financial markets could "reprice sharply"....the current AI boom presents some parallels with the dot-com boom of the late 1990s. Market optimism about a new technology - the internet then, AI now - is pushing up stock valuations, fueling a tech-centered investment boom, and sustaining consumption on the back of strong capital gains," the IMF said in an update to its World Economic Outlook (WEO) report.

"But the risk is also that lofty profit expectations will ultimately be unmet – as often happens when new general-purpose technologies are introduced. A significant market repricing...could impact aggregate wealth and consumption and spill over to broader financial markets," it added. The dot-com boom of the late 1990s saw a huge jump in valuations of US technology companies. However, a bust followed in 2000-2002, resulting in many companies being wiped out. In recent years, investment in Al companies has ballooned and been to the tune of tens and hundreds of billions of dollars, sparking concerns that too much money is being funnelled into the sector and that the results may not match the investments. On Tuesday, Google said it will invest \$15 billion over five years to set up an Al data centre in Andhra Pradesh. This is the US tech giant's biggest-ever investment in India. Globally, as per Stanford University's 2025 Al Index Report, private investment in AI in just 2024 rose to \$109.1 billion in the US, \$9.3 billion in China, and \$4.5 billion in the UK. Since 2013, the total private Al investment has been \$470.9 billion in the US, \$119.3 billion in China, and \$28.2 billion in the UK. India ranked seventh with \$11.3 billion of private investment in Al from 2013 to 2024, as per the . Stanford report released earlier this year in April. Economists have also noted that the ongoing Al investment boom has also propped up the US economy, which has defied expectations and grew 3.8 per cent year-on-year in the second quarter of 2025. A similar growth rate is expected in the third quarter that ended in September. In its report, the IMF cautioned on Tuesday that an "abrupt repricing" of technology companies' stocks could be caused by weaker-thanexpected financial results and Al productivity gains. This would mark an end to the Al investment boom and the "associated exuberance of financial markets, with the possibility of broader implications for macro-financial stability" a correction "could erode household wealth and dampen consumption". Earlier this month, employees of OpenAI founded in 2015 and at the forefront of AI developments with its popular ChatGPT - sold shares in the start-up that valued it at \$500 billion, making it the world's most valuable private company. Anthropic, founded in 2021, is valued at \$183 billion. Anthropic co-founder Dario Amodei met Prime Minister Narendra Modi on Saturday. ### RBI supervision for EPFO, Post Office bank on cards after Centre's nudge

Two state-owned institutions critical to India's social security net — Post Office Savings Bank (POSB) and Employees' Provident Fund Organisation (EPFO) — could come under the Reserve Bank of India's oversight, with the Government writing separately to the country's top banking regulator seeking a supervisory intervention in both. In case of the Department of Posts, the missive came in the wake of a scam involving the siphoning off of Rs 96 crore of public money over a 24-month period up to May 2024 due to fraudulent activities in the operation of the Post Office Savings Bank schemes. Following this, it has reached out to the Department of Economic Affairs in the Ministry of Finance seeking a supervisory pact with the RBI for undertaking a review of internal controls, sources told The Indian Express.

The Ministry of Labour and Employment, meanwhile, wrote to the RBI in February this year seeking advice on aspects pertaining to fund management and investment practices of EPFO. The Ministry had requested the RBI to examine systemic, policy and capacity-related issues within EPFO's fund management and investment framework, following which the RBI had submitted a report flagging issues such as accounting practices and the conflict of interest as a regulator. The EPFO's Board has now approved the formation of a committee with officials from the RBI, Finance Ministry, and Labour and Employment Ministry. "The RBI works as a super regulator. The idea behind approaching them was to seek guidance for EPFO's operations," an official said.

The POSB was under the purview of the Ministry of Finance and has been operating as an agency that is covered under the Payment and Settlement Systems Act, 2007. There is already RBI's authority over the payment-related functions of the Bank given that it comes under the 2007 Act. The Department of Posts has maintained that technology management of POSB operations has been handed over to India Post Payment Bank from August 2022, which is regulated by the RBI. The proposed new MOU with RBI for the POSB is aimed at undertaking "a review of the internal processes".

This comes in the wake of the audit scrutiny of the Department of Posts' savings bank operations last year revealing 60-odd cases of misappropriation of public money in post offices spread over 14 postal circles.

Audit reports showed "manual manipulation or alteration" of the Sanchay Post database by officials. The failure of the head post offices in implementing internal checks for prevention of fraudulent activities in operation of Post Office Saving Bank Schemes has been cited as a reason for this new request for RBI intervention. A nudge for the move also came from a Parliamentary panel, which was informed of the "large volume of transactions involved in the POSB" and an oversight by the RBI for undertaking a review of "the internal controls and checks" needed to be instituted at prescribed intervals to prevent fraudulent activities in operation of Post Office Savings Bank.

This recommendation for the Department to enter into an MOU with RBI is learnt to have been sent to the Department of Economic Affairs "for necessary guidance and inputs". When contacted, a senior Finance Ministry official said they were not in receipt of this proposal but did not provide an official comment. The RBI did not respond to queries sent by on the Government move. An internal audit report had flagged the mismanagement across postal circles. Subsequently, on May 2, 2024, details of punitive action taken against officials in the Department, who allegedly failed to ensure implementation of internal checks in these cases, were listed out in the wake of the audit report.In these 60 fraud cases, a total number of alleged offenders, including prime offenders (108), co-offenders (46) and subsidiary offenders (1,018), were identified for disciplinary action. The number of offenders against whom action was completed was pegged at 718. The offenders against whom action had been initiated was said to be 267 while there were 187 offenders against whom action could not be taken due to either death or retirement. These numbers include some overlaps. In all, a total of 985 alleged offenders, "who had committed fraud and sub offenders who had failed to ensure implementation of the internal checks codified for preventing fraudulent activities in operation of POSB schemes", have been punished severely, the Department of Posts said in its submission to the Parliamentary panel.



Both the Post Office Savings Bank and the EPFO have significant assets under management, being the custodian of public money. The EPFO manages Rs 26 lakh crore for over 30 crore account holders, while the Department of Posts had more than 29.29 crore POSB accounts with an outstanding balance of Rs 12.56 lakh crore under Post Office Savings Bank schemes, as per government data updated till December 2021. For the EPFO, the RBI has recommended separation of regulatory and fund management functions citing potential conflict of interest due to the dual role of managing various funds and regulating similar provident fund trusts by other entities.

Also, the RBI has flagged anomalies in the process of returns distribution by the EPFO, stating that it is not based on accrued income, and the accounting policy does not recognise losses and provisioning by charging released income. It has also pointed out that the EPFO assumes a held-to-maturity portfolio where all assets are held at cost until redemption and is not doing marking-to-market. The central bank has also advised the EPFO to conduct a scientific and rigorous actuarial assessment of its liabilities visà-vis assets separately for all its schemes. According to the RBI, EPFO needs to take a "considered and gradual approach" to diversify, including increasing exposure to equities and other asset classes, to enhance returns and mitigate the yield trap, and manage risk through phased investments, strict risk controls and regular portfolio reviews. At present, equity allocation of the EPFO stands at 15 per cent of the fresh accretions. The EPFO invests 45-65 per cent in government bonds and 20-45 per cent in corporate debt. It can invest a minimum of 20 per cent in corporate bonds, which can go up to 45 per cent.

## Google's Raiden Infotech to get Rs 22,000 cr incentives from Andhra for Vizag data centres

Amaravati: Raiden Infotech India Pvt Ltd, a Google company, which is setting up data centers in a phased manner, with a cumulative investment exceeding 87,500 crores in Andhra Pradesh, will receive Rs 22,000 crore as incentive from the state government over a period of time. According to a recent Government Order, Raiden Infotech will set up more than 1000 MW data centers in a phased manner, with a cumulative investment of Rs 87,520 Crores in Visakhapatnam and Anakapalli districts. In its biggest ever investment in India, tech giant Google on Tuesday said it will invest USD 15 billion in building an AI infrastructure hub in AP, which would include a gigawatt-scale data centre in partnership with Adani Group. The AP government has signed a mega deal with Google to set up a USD 15 billion gigawatt-scale Artificial Intelligence data centre in Visakhapatnam. "SIPB (State Investment Promotion Board) has decided to extend the above-listed incentives with an overall cap of Rs 22,002 crore. The above SIPB recommendations were placed before the council of ministers in its meeting dated 10.10.2025 and the same was approved," the GO said. As part of the incentive package, the state government offered a 25 per cent discount on the land-160 acres at Rambilli, 120 acres at Adavivaram and Mudasarlova, 200 Acres at Tarluvada. The land shall be made available to the notified partners of Raiden Infotech India after approval from the competent authority. In addi-

### Tejasswi Prakash says her 'lips are always full' when she wakes up in the morning: 'Yeh roz hota hai'



Why do some people's lips appear fuller when they wake up?

Many people feel slight puffiness in different parts of the body after a night's sleep, and the lips are no exception. "While sleeping, fluid can build up in soft tissues, making the lips temporarily look plumper. This effect usually fades within 1 to 2 hours after waking, as the body begins to move and circulation improves. Things like sleeping position, hydration, and room temperature can affect how noticeable the swelling is," explained Dr Shweta Nakhawa, consultant dermatologist, KIMS Hospitals, Thane.Dr Shareefa Chause, dermatologist, Dr Shareefa Skin Care Clinic, Mumbai said that ot may happen when the body retains a bit of fluid, "especially if we've slept face-down or had a salty meal before bed"

Is this the same as getting a cosmetic lip filler?

No, this natural fullness is short-lived and not the result of any procedure. "Lip fillers involve injecting substances to improve shape and volume for a longer time, while morning puffiness is just a temporary fluid shift that goes away on its own. It doesn't change the structure of the lips in any way," noted Dr Nakhawa.



Can this swelling ever indicate a problem?

In most cases, mild swelling is normal and harmless, Dr Nakhawa asserted.: However, if the puffiness lasts longer than usual or is accompanied by discomfort, itching, or visible irritation, it could be linked to allergies, reactions to products, or environmental triggers. Persistent swelling should not be ignored, as it may need further attention," added Dr Nakhawa.

Are there ways to maintain a naturally fuller look with-

Simple daily habits can help lips look healthy and defined. "Staying well-hydrated, gently exfoliating the lips to remove dry skin, and using nourishing balms can keep them smooth and supple. Temporary plumping products or glosses can also create a slightly fuller effect for a few hours. Regular care helps bring out the lips' natural shape and softness," said Dr Nakhawa. If the puffiness doesn't go away or happens often, it's best to consult a doctor to rule out any underlying cause, said Dr Chause.

## 'Assumed it is age-related fatigue': Patients, doctors reveal how osteoporosis silently steals mobility, and why early awareness matters

Praveen Rajput's wake-up call came in the form of excruciating pain that refused to subside. "I was diagnosed last year after experiencing extreme pain in my foot joints and ankles. Standing for long hours left me unusually tired, and my feet often swelled up," recalls the Gurugram resident. "Initially, I assumed it was just age-related fatigue, but when the pain persisted, I got it checked. That's when I learned I had osteoporosis."Her experience is far from unique. Across India, millions live with the condition without realising it until it's too late. According to a 2021 study published in Henry Ford Health Scholarly Commons, "Prevalence of osteoporosis ranging from 8 to 62 per cent in Indian women of different age groups has been reported in several studies. In males over 50, prevalence varies between 8.5 and 24.6 per cent."The invisible threat

Osteoporosis has earned the label of a "silent epidemic" for good reason. Dr Abhijit Agashe, consultant orthopaedic and joint replacement surgeon at Sahyadri Super Speciality Hospital, Pune, explains: "It's a 'silent' pathology with non-specific symptoms. Patients normalise back pain, height loss, or fatigue. Primary care often prioritises diabetes, blood pressure, and lipids; bone health is usually an afterthought."The consequences of this invisibility can be severe. Dr (Prof.) Raju Vaishya, senior consultant orthopaedic and joint replacement surgeon at Indraprastha Apollo Hospitals, New Delhi, notes, "Most patients are asymptomatic until their first fracture, leading to underrecognition."Limited infrastructure further compounds the problem. "In smaller cities, DXA scans, which measure bone density, are not easily available, and even where they are, cost is prohibitive," says Dr Agashe. "Many people take vitamin D and calcium supplements on their own without first checking their actual levels."Why Indians are more vulnerableIndia's population faces a unique constellation of risk factors that make osteoporosis more prevalent. Dr Agashe points to several dietary and lifestyle patterns: "Our diets are often low in calcium, and cereals like wheat and rice can reduce calcium absorption. Vitamin D deficiency is widespread due to limited sun exposure, pollution, and cultural clothing practices." Dr Vaishya echoes this, adding, "High prevalence of vitamin D deficiency, low dietary calcium intake, and lifestyle habits all contribute.'

Nutritionist Aditi Prabhu, founder of NutroDynamix, notes additional dietary pitfalls: high consumption of polished grains, ultra-processed foods, low protein intake, insufficient



calcium-rich foods, and excessive tea, coffee, and salt—all of which compromise bone health.For women, risks multiply. "Indian women often undergo early menopause and multiple pregnancies, both of which reduce bone strength," says Dr Agashe. Dr Vaishya adds, "Postmenopausal decline in oestrogen accelerates bone loss. Lifetime calcium deficiency, poor nutrition, and early menopause all contribute significantly."

Praveen explains, "It has definitely slowed me down. I can't stand for long periods, and even simple tasks require frequent breaks. Eating very cold foods often triggers bone pain. I carry a crepe bandage to ease discomfort in my foot."Lakshmi, 64, shares a similar story: "My mobility is reduced by 20-30 per cent, so I rely on others for certain tasks. I have to manage pain while taking calcium supplements twice daily." Her son, Sudarshan Venkat, adds that while osteoporosis affects her mobility, other conditions like autoimmune disorders and rheumatoid arthritis also play a role. The psychological toll of osteoporosis is often overlooked. Praveen admits, "I feel anxiety and frustration, especially when pain limits movement. Missing my daily walk or exercise routine makes me feel low or anxious about gaining weight or becoming more prone to other health issues. There's always a subtle fear of fractures in the back of my mind."

### Sidhant Purohit returns to sting Delhi with 70 as Himachal reach 165/3 in Ranji Trophy

When Delhi arrived to bowl after lunch on Day 2 of their Ranji Trophy fixture against Himchal Pradesh, the 430run total and fifties for six of the top seven of their batting order would have instilled plenty of confidence. At close of play with Himachal's top order looking steady and patient, leaving them at 165/3 despite a late dropoff, the home side may be regretting losing their last six wickets for just 124 runs in the opening session here on Sunday. Key to the visitors' minor fightback and show of strength at the Feroz Shah Kotla grounds was a succesful homecoming for their unheralded opener Sidhant Purohit. The Delhi boy, brought up in the age group system in Himachal, scored a measured 165-ball 70 which acted as the fulcrum of his side's effort on Sunday; one that inspired some hope of potentially saving this match."Until my wicket, we were in a very strong position," Purohit told reporters. "There is full confidence that we can continue like this tomorrow.'

At 27, Purohit, in his debut Ranji season, is a late bloomer. He grew up near Gurugram and still trains at the Vinay Marg complex in the capital, but had to grind it out and wait plenty of years for a chance at first-class cricket away from home in the hills. The big score came as a reprieve after a nightmare debut, scoring a duck against Puducherry in the campaign opener last week. Purohit knows the value of proving his worth quickly in hyper-competitive environments. "For the last two years, I have been waiting for a chance, didn't get into the team. I wasn't frustrated but I felt that I should make it, so now I need to make

the most of being here," he said. And the 27-year-old showed an appetite for playing the longest format on Sunday, even if it came with the asterisk of facing a Delhi bowling lineup that lacked sufficient bite to make breakthroughs in these batting friendly conditions. The six wickets that fell in the first session was more of an outcome of Delhi's batters going for their shots with a big total on the board and their tail failing to wag. In an 86-run opening stand alongside his skipper Ankush Bains, which lasted almost the entirety of the second session, Purohit proved that with patience, runs are on offer on this track. "We planned to play like this. We had time, it's only the second day, so we wanted to make sure we don't play false shots and go long," Purohit said. Purohit would finally lose his wicket during an excellent late spurt from Delhi stalwart Navdeep Saini. The fast bowler generated movement to find a thick edge from Ankit Kalsi, caught by a diving catch from Sanat Sangwan at gully, a few overs prior. This time, he nailed his line and length to castle Purohit's off-stump. Some late wickets, a 265-run lead, and expectations of the wicket to break apart and aid the spinners more as the Test wears on, have kept Delhi upbeat after toiling in the field for much of Sunday. But there was plenty of evidence in Purohit's innings to suggest that the home side can take the opposition for granted only at their own peril. His late burst claiming two wickets was impressive, and Delhi pacer Navdeep Saini still harbours belief that he can make an India comeback, after representing the country in 2 Tests and 19 white-ball games. The problem for him, however, is that he no longer plays in the IPL, which is according to him, now the main medium of judgement in Indian cricket across all formats. Performances elsewhere, like the two wickets he found during a brilliant late burst in his spell of nine overs on Day 2 of Delhi's Ranji trophy fixture against Himachal Pradesh on Sunday, matter far less, he stresses

"The reality is that, now, only those players play for India who perform in the IPL. This the truth," the 32-year-old fast bowler told reporters at the Feroz Shah Kotla ground. "So it was a big loss for me to miss out last year." Saini last featured in the IPL for the Rajasthan Royals back in 2023, and he failed to earn a contract in the competition this year. Brief scores: Delhi 430 all out in 116 overs (Sangwan 79, Doseja 75; V Arora 4/78) lead Himachal Pradesh 165/3 in 55 overs (Purohit 70, Bains 43; N Saini 2/20) by 265 runs.

#### 'There was a lot of chatter between the two of us': Rohit Sharma opens up about match-winning partnership with Virat Kohli vs Australia in Sydney

Rohit Sharma and Virat Kohli rolled back the clock on Saturday against Australia as the two Indian behemoths guided the Men in Blue to a 9-wicket win against Australia in the third and final ODI at Sydney. While the series was already lost after Australia won the first two matches, the veteran Rohit scored 121 and Kohli slammed 74 as the two icons gave Indian fans something to smile about."Yeah, fantastic partnership after a long time. I think we hadn't had a 100-run partnership for a long time. It was good to get that partnership for the team's perspective looking at how we were placed at one point. We lost Gill early. Not early, I mean, we still managed to get 40, 45 and then Gill got out. So obviously we knew with Shreyas not being there, it was an added responsibility for the batters and it was a great partnership. We enjoyed every moment we spent out there. There was a lot of chatter between the two of us. We played so much cricket together, we understand each other really well. It was about taking the game, understanding what was required at that point and it definitely comes with the experience as well. With so much experience between the two of us, we used it pretty well," Rohit talked about the partnership with Virat in a video released by BCCI. Coming off the back of a long break to the Indian side, the Mumbai batter talked about India's and his own mindset going into the 237run chase against Australia. "Once we started to bat, obviously up front with two new balls, it was a bit challenging. The pitch was slightly misbehaving at the start and we knew



once the shine of the ball was off, it gets a little easier. So that was the plan. I wanted to bat as deep as possible and see how we can take the game till the end," he said. "Sometimes you can think so many things and it doesn't come off. But today was the day where I thought, okay this is what I have to do and it just perfectly fit into my plans. Obviously when you play in Australia, you got to plan and play. So all the planning and all the understandings I had from the previous experience, I used it today," the former India captain added. This was the first time Rohit and Virat returned to the national side after the final of the Champions Trophy in March where they defeated New Zealand. Since then, they have both retired from Tests. The two had already retired from T20Is after winning the T20 World Cup last year.

### After 159, Ajinkya Rahane vents out his hurt: "I should have played BGT series"

After cracking 159 against Chhattisgarh on a rain-affected day, Ajinkya Rahane revealed his hurt of being overlooked for India's Test tour to Australia in the 2024-25 season. The 37-year-old dismissed the age factor. "It's not about the age. It's about the intent. It's about the passion for the red ball and the hard work you put in the middle. So I don't believe in that completely," he said. He then fished out the example of Australia great Mike Hussey, who made his Test debut at 30. "In Australia, you see, Michael Hussey made his debut 30s. Still he made runs. Experience matters in red ball cricket. I thought, personally, the Indian team needed me in Australia," 37-year-old Rahane said after scoring his 42 first class hundred.

Rahane, the mastermind of India's turnaround in the 2020-21 series, has been overlooked since the trip to West Indies in 2023 after a hundred-less run of 31 innings. In this period, he shone only sporadically, eking out only four halfcenturies. He showed signs of resurgence with scores of 89 and 46 against Australia in the WTC final (2023), but thereafter got a solitary Test. He again dwelled on the age factor: "After 34-35 players are old. Players are always looking to do well. Players are always looking to give their best. And if someone is really passionate about playing red ball cricket. I think selectors should look into it. Because they come and watch the game. Every time it's not about the performance. It's about the intent and the passion and how you play with the red ball."He lamented the lack of communication from the selectors. "I thought an experienced player like me should get more chances. And there was no communication. I can focus on only the controllable things which I am doing right now. But as I said, the Indian team needed me in Australia and I was fully ready for it," he said.

He then pointed out the examples of Rohit Sharma and Virat Kohli in the three-match ODI series Down Under. Rohit top-scored in two of India's games and won the player of the match award. Kohli, after successive ducks, scored an unbeaten 71 in Sydney. "When you have guys like Rohit and Virat, who have won so many matches for India especially in white ball cricket, you need that experience in the team. You cannot go with all newcomers, or the young ones



in the team. Young blood is important, but if you have experience, the team will do well. It is especially the case in red ball cricket. I was really happy to see Rohit getting that 100," he said.

Before the season, rumours swirled that his position in the Mumbai team was shaky. The hundred, thus, brought him joy, which manifested as a gesture towards his family after reaching the landmark on Saturday. He took a dig at some of his critics. "There are many unwanted people. When they don't know about the game, they still talk about a player who has been playing consistently with a good attitude and intensity. I always want to do well for Mumbai. They don't know what it takes. As an international cricketer who has played for so many years, I think something clicked for me. But the support of my family and kids has been massive. They've always been with me. They said, 'Daddy, you can do it'," he said. Before wrapping up the interaction, he passed a message to colleague Sarfaraz Khan, continuously overlooked by the national selectors, not considering him even for the India A game. "The only thing I can tell him is don't get distracted and frustrated. It's very easy to say but it's very hard to do. You can just focus on playing cricket and keep scoring guns. He's been doing that. But as a player, when you go through this phase, it's really challenging and tough. But keep your head down and just focus on the controllable things," he asserted. ### For Rohit Sharma, every game is like playing his first match and last match at the same time

The most fascinating sportsman is the sportsman riding his sunset. He knows his sunniest days are a fragment of memory or recorded archives; that he is perennially living on borrowed time; that there is nothing left to prove, but yet there is something more to prove, that he still has the dexterity in his limbs, the passion in his eyes, the love in his heart and the desire in his mind to turn up on the grandest stage. Whenever he took the field in the three-match ODI series against Australia, these thoughts could have passed through Rohit Sharma's mind. Removed from captaincy, self-restricted to a lone format, the selectors undecided on his future, away from competitive cricket for 150 days, Rohit, at 38 and with 11,168 runs before boarding the flight to Australia was a certified 50-over colossus. Yet, he had to prove the same things he had proven a thought times.

But unlike in his youth, the selectors would bestow little allowance of time, their patience would dry faster than ink on a blotting paper. In a bafflingly interrupted career, Rohit is a well-worn traveller through this lane, far too familiar with its treacherous bends and corners to be overwhelmed. He meets all the challenges with a smile, and sheets of steel beneath. Beneath the silk of the strokes, is a coat of fierce defiance, of a self-made cricketer. Few other modern-day cricketers of his country had to make as many comebacks or prove themselves as many times as Rohit had, in his 18-year-old career. For half a decade since his entry to international cricket, he tussled with the talentedbut-laidback misconception; he passed through an endless lost-and-found cycle; he donned several roles until he found his true calling of opening the innings. He was not a natural and a flawed one, for its deceitful portfolio. But he strove and succeeded, making an impressive career as a Test

Doubts still lingered, can he succeed overseas? Can he flourish on the big stage? Can he tame James Anderson and Stuart Broad in England? Can he juggle the captaincy chores and batting? In a taxing but rewarding decade, he ticked all the boxes. His Test numbers betray a sense of unfulfillment, a late-blooming arc, but against the white ball, he was one of the finest of his era. In ICC tournaments, he was as prolific and influential as his great contemporary, Virat Kohli (fourth highest run-getter in World Cups) and owns more hundreds in those tournaments than Sachin Tendulkar. Yet, the spectre of the past could lose its lustre in the capricious present. Besides, Australia could

be where a batsman from Asia could feel his age or twice the number, when he would feel the revoltingly slow reflexes, the disobedient hands, the lethargic feet and the drained mind in extreme degrees. The conditions daunted him in Perth, but less than a week later, he cracked a half-century and an undefeated hundred to not only pocket the player of the series trophy, but to assert that the rumours of his decline are exaggerated, that he still could reel out runs abroad. Adelaide and Sydney were not as challenging as Perth, but were not absolute shirtfronts either. Midway through the Adelaide knock, he regathered his bearings. Perhaps, the catalyst was the lofted off-drive off Josh Hazlewood, when he shimmied out of the crease and coaxed him over midoff. The feet had begun to dance, the hands shed its rigidness, the balance and poise had been restored, and the runs began to flow. Even though a false shot ended his Adelaide resurgence, he continued in the same vein in Sydney, where he batted somewhere closer to his peak, with a dainty smile on his face. En route the smooth ride, he casually proved that he still has the game, will and temperament to score a hundred. That he has the fight and mentality; that his reverting to the old ideals of systematic than chaotic aggression would usher in an autumnal bloom, and could probably offer one last shot at glory that has eluded him, a 50-over World Cup triumph that could paint his career with perfection, the crowning jewel in his mantlepiece

His match-winning 121 on Saturday was not his greatest white-ball innings, but it was simply a Rohit Sharma innings, a victory of timing over power, manoeuvrability over muscularity, a triumph of pure talent. But the infrequency of ODIs would mean that Rohit, as well as Virat Kohli, would have to prove that they are supreme enough, not merely good enough, to own the spots. The breaks between the series could be vast, the scrutiny could be vaster, the process of ageing will accelerate, reaction times would dwindle and muscle mass would reduce, there could be more aches and sores. One bad injury could end it all. The team management could be tempted to blood youngsters; Yashasvi Jaiswal and Abhishek Sharma are waiting impatiently. One bad series could thrust them to the exit door. The uncertainty could be suffocating. In a sense, it's like making their debut every time they walk out to bat in a new series. It is Rohit's perception when he landed in Perth too. "When we arrived in Perth, I forgot what has happened in the last 15-17 years, wanted to start fresh, and that's how I personally look at all the games that I've played. I'm sure it'll be the same for Virat as well, but I enjoyed playing these three games."At its heart, like in the dark days of 2012, he would have realised that it's a battle he has to fight himself. He had once told this paper: " (In 2012), I figured that it's just my battle and I shouldn't be expecting that anyone would come and help me. That I need to figure it out on my own. That I have to create my own path from my own struggle. That trait was inbuilt: figure out a way out of any problem, don't go looking for people to help you."It's the same mentality that burns in him to sustain his last meaningful link to the game he has given his life to. But for that, he has to prove the things that he has proved a thousand times. And that makes the sportsman riding his sunset the most fascinating of them all.

### Rohit Sharma bids goodbye to Sydney in touching post: 'One last time, signing off...'

Rohit Sharma has pretty much confirmed that his epic knock in the third ODI in Sydney was the last time he played in Australia, in India colours at least. The former India captain on Sunday posted a photo of him standing with his back to the camera in front of the "Departures" sign, presumably at Sydney's Kingford Smith airport. "One last time, signing off from Sydney," said Rohit along with the picture. The 38-year-old's place in the Indian ODI team, along with that of his long time teammate and fellow veteran Virat Kohli, was

questioned by many after he was included in the squad while being stripped of captaincy. The series against Australia was Rohit and Kohli's first in international cricket in over seven months, having retired from ODIs and T20Is. Rohit, however, had visibly lost a considerable amount of weight and even shed the aggressive style of batting he had adopted in recent years. He went on to be highest scorer for India in the second and third ODIs, accumalating 73 in 97 balls in Adelaide and a masterful 121 not out of off 125 balls in Sydney. While India lost the series 2-1, Rohit won the player of the series award. Rohit's century came as part of an unbeaten 168-run stand off 170 balls with Kohli, who followed up his twin ducks in the first and second ODIs with 74 not out off 81 balls. Rohit leaves an incredible ODI record at the SCG. He has played six matches at the iconic ground and scored 454 runs at an average of 90.80 with two centuries and as many half-centuries. "Fond memories of 2008 and a nice way to finish getting that knock and getting that win. I don't know we'll be coming back to Australia but it was fun all these years I have played here. A lot of good memories, bad memories but all in all, I will take the cricket that I played here," Rohit had said after the innings while talking to the broadcasters.

#### When Cricket Australia chief Todd Greenberg was asked if Big Bash will woo Virat Kohli and Rohit Sharma

Indian cricket and Messrs Gautam Gambhir and Ajit Agarkar might be in various stages of 'moving on' and 'letting go' of Rohit Sharma and Virat Kohli, with an eye on the ODI future. But the star batsmen's match-winning partnership and big runs (Rohit 121\* off 125 and Kohli 74\* off 81) and the lingering images of their stardom from emotional fans at Sydney, mean foreign franchise leagues are waiting to pounce on the duo, as soon as they are relieved of India NT contracts. Ravichandran Ashwin might well have been just a canary in the coalmine after he was brought into the Big Bash League, though foreign franchise leagues will need to outbid Sharma and Kohli's IPL value earnings, to persuade them to retire from all formats (including IPL) to land them. Cricket Australia chief Todd Greenberg set the pot stirring when he told the Aussie media that India's biggest stars would continue to get wooed to join and play in the Big Bash. This was even before the Saturday night fever, that highlighted the duo's popularity as they set up a vintage chase in a dead rubber, full-house Third ODI watched by legions of blue shirts. As per cricket.com.au, hours before Sharma and Kohli sealed their last outing in Australia with big runs, and before captain Gill spoke of their future and how their game time will be managed, Greenberg was answering questions about how the BBL planned to net the big silvery shining fish. Greenberg was asked if it was conceivable that Cricket Australia could bring a player of their calibre to the BBL, especially after Sydney Thunder pulled off the recent Ravichandran Ashwin coup."I think in the short to medium term, I think it is realistic," CA's chief executive said. "We're going to keep the dialogue open.""Ravi(chandran) Ashwin coming is a really important moment for the BBL and it will highlight the strength of bring-

ing Indian players into the league," Greenberg was quoted as saying by cricket.com.au. "What that manifests over time, I think, is to be seen," he continued. "Some of that will depend on whether we take private capital into the BBL which is an open conversation for us at the moment. But I think you're going to see an enormous explosion of interest around the Thunder this year on the back of Ravi Ashwin playing. There's one thing the best leagues have all over the world in every sport – they have access to the best players, and the BBL should be no different to that."

Bringing in private capital will be a massively ambitious step for CA, but the website wrote, 'The noise emanating from the heaving SCG reached fever pitch during the evening as Rohit and Kohli, along with their fanatical supporters, turned a supposed dead rubber into a victory parade for two demi-gods playing what was almost certainly their final international games in Australia. It was a reminder of the unmatched fervour the Indian diaspora have for the sport. It was also apparent just how much the game has changed over the course of the pair's careers.'Since Sharma first sparkled in Australia 17-and-a-half years ago, 81 men's internationals have taken place, abd cricket.com.au quoted that only one (the 2020-21 Boxing Day Test) featured neither Sharma or Kohli in a time spanning eight bilateral tours and two World Cups. The two have scored 18 Australian tons between them (Kohli 12, Rohit 6) and close to 6,000 runs, as per the website. Kohli (3,690) outscores Travis Head (3,540) for runs made in Australia. "I've always loved coming here," Rohit told Fox Cricket later. "I enjoy playing cricket here in Australia. Fond memories of 2008 and nice way to finish getting that knock and getting that win as well.

#### Senna Hegde's Avihitam joins long list of Malayalam movies to face off with the CBFC with mandated cut to the reference 'Sitha' from the film

Adding to the long list of confrontations between the Malayalam film industry and the Central Board of Film Certification (CBFC), director Senna Hegde's latest film Avihitam seems to have run into a conflict with the use of a line referencing 'Sita' in the film. The certification body has now requested the filmmakers to remove the dialogue which begins with "Neeyum ninte Sitayum thammilulla," which translates to "Between you and your Sita...

This particular line is used to refer to the heroine of the movie by another character. The film, which satirizes the moral policing and implicit prejudices against married women, is Senna Hegde's follow-up to Thinkalazhcha Nishchayam, 1744 White Alto, and Padmini. The latest recommendations from CBFC have ignited a discourse on social media, with most comments being against the decision to cut lines that are used in a different context in the film. The film stars Unni Raj, Renji Kankol, Vineeth Chakyar, Vrinda Menon, and Ammini Chandralayam in important roles. Avihitam is in good company with regard to the recent tussles with CBFC with films like Shane Nigam's Hal (which got recommended 15 cuts), which included the removal of words like 'beef biriyani'. Anand Tiwari, Meghna Gulzar, Laxman Utekar sir..." Vicky has worked twice with all three of them. With Anand Tiwari, he did Love Per Square Foot and Bad Newz; with Meghna Gulzar, he did Raazi and Sam Bahadur; with Laxman Utekar, he did Zara Hatke Zara Bachke and Chhaava. Vicky also named Neeraj Ghaywan, the director of Masaan. "Also Mozez Singh; he was actually my first director. He made this film called Zubaan, which was the first film we shot, but it came after Masaan. He was the first guy who ever said a yes to my audition. Mozez is very special. All these people, I know I can meet them, talk to them, and not have filmy discussions. These are the people,"

In the past, Vicky has said that the first time he performed for the camera was for an international film that Anurag recommended him for. In an interview with acting coach Atul Mongia on the Artist Collective YouTube channel, Vicky said, "My first on-camera appearance was in a Michael Winterbottom film. Anurag called me one day and asked, 'Listen, you want to do an item number?' I hesitated, but he said it would be with Huma Qureshi, and it would be great."In a 2016 interview with Hindustan Times, Vicky described Anurag as his 'mentor' in the film industry. "Anurag is like family to me, he is my mentor. I started out in this industry with his film. I was an assistant director in his film Gangs of Wasseypur and I know him personally. He is my guardian. #### After starring in Chhaava, Vicky Kaushal defends hyper-masculine action movies: 'I don't see anything wrong'



Actor Vicky Kaushal, who delivered the biggest hit of his career in Chhaava this year, said that he sees 'nothing wrong' with hyper-masculine action movies. Directed by Laxman Utekar, Chhaava was criticised for fueling communal tensions with its incendiary narrative, which pitted the Maratha king Chhatrapati Sambhaji Maharaj against the Mughal emperor Aurangzeb. Violence actually broke out in the city of Nagpur following the film's release, while other acts of vandalism took place in various other parts of the country. In an interview, Vicky said that the industry operates on the basis of supply-anddemand, and that the day audiences stop demanding violent action films, the industry will stop making them.

Appearing on the Yuvaa conclave, Vicky was asked what he feels about the glorification of hyper-masculine heroes, a decade after he starred in the tender film Masaan. He said, "There have always been phases and trends in the industry... The intensity of action, the intensity of drama, the intensity of comedy, the intensity of romance... It goes through phases. The phase is dictated by the society, and not the other way around. It's a demand-and-supply business. It's a business, at the end of the day, and we would like to tell you stories that you would like to hear."

Vicky admitted that every year throws up 'two or three out-of-syllabus' films that emerge as hits, but said that they are anomalies. "But more of than ever, it will be that they will try to gauge what the demand is, and then supply accordingly," he said, adding that it is up to the filmmakers to stay true to their artistic vision within these market confines. "Of course there is a phase going on right now where the audience needs to be given an experience in theatres, and this experience is given with great visuals and sound, and high stimulation. But I don't see anything bad or wrong in that."Vicky said that films like this 'might not be everybody's cup of tea', and added that this phase will pass soon enough, when the audience begins to give signs that it no longer wants to watch blood-soaked action movies. "It's all done keeping the audience in mind. The day they feel they're done with it, you won't see these films," he said. Chhaava is the biggest Indian hit of the year, having made more than Rs 800 crore at the global box office. It made Rs 600 crore through its Hindi-language version alone, catapulting Vicky to the A-list. He will next be seen in Sanjay Leela Bhansali's Love and War, which also features Alia

#### Pankaj Dheer's family lost everything after Geeta Bali exacted a promise from his father, shelved incomplete film despite Dilip Kumar's request

Pankaj Dheer, who passed away in Mumbai on Wednesday, was best known for playing Karna in BR Chopra's Mahabharat and in Chadrakanta. Pankaj was admired by fans throughout his life for his work in the mythological show, and this kind of adulation was quite cherished by Pankaj and his family, as they had battled through some difficult times. Pankaj had previously shared that his father, filmmaker CL Dheer, lost everything when he had to shelve a partially made film after the sudden death of actor Geeta

In an earlier interview with Lehren retro, Pankaj shared that his father, CL Dheer, joined the film industry in 1941. After assisting V Shantaram for a few years, he went on to direct and produce films like Bahu Beti, Rain Basera, Aakhri Raat, Zindagi, among others. He then recalled the tragic chapter of their life, which happened during the making of a film called Raano, starring Dharmendra and Geeta Bali.

Pankaj recalled that his father and Geeta were co-producers on that film, and had invested equal amounts of money in it. His father was also the director of the film. "Almost 6-7 days of work was left so Geeta Bali suggested that he could finish everything else, and finish the rest of her scenes at the end. The entire film was done and ready, just 3 days of Geeta Bali's scenes were left. You can call it bad luck... Geeta Bali got infected with smallpox in Punjab," he recalled. Geeta was in Punjab with the rest of the crew and was brought to Mumbai (then Bombay) after her illness was diagnosed. "She couldn't recover. She asked my father for a promise on her death bed that after I die, you will let go of this film, and my father honoured his promise," he because of this incident, and could never fully recover.



shared.
