He-Man of Bollywood Dharmendra passes away aged 89

Mumbai: Veteran Bollywood star Dharmendra, aged 89, has passed away. The octogenarian on November 12 had got discharged from Breach Candy Hospital in Mumbai and was said to be in a stable condition and recovering well at home. At that time Dr. Rajiv Sharma from the hospital said that the legendary star has gone home 'fully satisfied'• after receiving the required treatment.

Sharing an update on the actor's health, he stated, "Dharmendra ji has gone from the hospital with full satisfaction. His family has taken him home. Everything has been arranged for him." "He is in a stable condition. I request the public not to spread the false news but instead pray for his recovery so that he can celebrate his next birthday with pride." The star was admitted to Breach Candy Hospital in Mumbai and sources on November 10 had said that Dharmendra is critical and on life support. On October 31, the actor, was kept under strict medical observation by top doctors at Breach Candy Hospital in Mumbai. The superstar would have turned 90 on December 8.

On the professional front, Dharmendra was last seen in the movie Teri Baaton Mein Aisa Uljha Jiya in 2024. The movie starred actors Shahid Kapoor and Kriti Sanon. The actor is set to star next in the movie 'Ikkis', directed by ace director Sriram Raghavan. The movie stars Agastya Nanda and Simar Bhatia. The movie is a war drama based on the life of Arun Khetarpal, the youngest Param Vir Chakra recipient. The film also features Jaideep Ahlawat and Sikandar Kher in important roles and is slated to release in December. Dharmendra, who is widely considered one of the greatest, most handsome, and most commercially successful film stars in the history of Indian cinema, had a cinematic career spanning over six decades; he has worked in more than 300 films.



Dharmendra holds the record for starring in the highest number of hit films in Hindi cinema. He was honored with the Padma Bhushan in 2012. Dharmendra made his debut in 1960 with Dil Bhi Tera Hum Bhi Tere. He first gained popularity in the mid-1960s for films such as Ayee Milan Ki Bela, Phool Aur Patthar, and Aaye Din Bahar Ke. He starred in several successful Hindi films from the late-1960s to the 1980s, such as Ankhen, Shikar, Aya Sawan Jhoom Ke, Jeevan Mrityu, Mera Gaon Mera Desh, Seeta Aur Geeta, Raja Jani, Jugnu, Yaadon Ki Baaraat, Dost, Sholay, Pratiggya, Charas, Dharam Veer, Chacha Bhatija, Ghulami, Hukumat, Aag Hi Aag, Elaan-E-Jung, Tahalka, Anpadh, Bandini, Haqeeqat, Anupama, Mamta, Majhli Didi, Satyakam, Naya Zamana, Samadhi, Resham Ki Dori, Chupke Chupke, Dillagi, The Burning Train, Ghazab, Do Dishayen and Hathyar.In the late 1990s, he appeared in character roles in several successful and acclaimed films, such as Pyaar Kiya To Darna Kya, Life in a... Justice Surya Kant sworn in as 53rd Chief Justice of India

President Droupadi Murmu sworn in Justice Kant merely days after Justice Kant, as a member of the 16th Presidential Reference Bench, advised her that neither she nor the State Governors, while dealing with State Bills, are bound by timelines "imposed" by the Supreme Court as in the April 8 judgment in the Tamil Nadu Governor case. Both Chief Justice Kant and his immediate predecessor, Justice B.R. Gavai, was recently lauded by Solicitor General Tushar Mehta for bringing "Indianness" in the courts. Mr. Mehta, in his address, highlighted that their judgment did not refer to foreign precedents of law and banked on the heritage of Indian case laws and legal principles in their verdicts. After the oath ceremony, in an act of camaraderie, Justice Gavai reserved the official vehicle designated for the Chief Justice of India for Chief Justice Kant, ensuring that his successor's maiden journey to the Supreme Court as CJI was in the official car itself. Chief Justice is seen as a judge who leans more towards gently nudging disputes to a resolution over time rather than taking a confrontational approach. Justice (as he was then) Kant had resolved the

farmers' agitation from the Bench by prompting both sides - the protesting farmers and the Union government - to the negotiating table at a critical point when matters were spiralling with farmers' leaders on an indefinite strike on the borders of Delhi.Chief Justice Kant's tenure would be closely watched for his handling of the Special Intensive Revision (SIR) case. So far, his Bench has made interventions to make the SIR procedure transparent and accessible to citizens, but is yet to take up the basic issue of whether the exercise itself is constitutional or not. Meanwhile, the SIR has expanded from Bihar to its second phase covering 12 States and Union Territories and covering 51 crore people. Chief Justice Kant was seen to draw a sharp dividing line between humour and perversity while hearing the case of Youtuber Ranveer Allahbadia, who had approached the apex court for Protection against arrest over his comments about parents and sex in the show 'India

"Humour is an art. Humour is something that the entire family can enjoy and nobody feels embarrassed. That is talent. Using filthy language is not talent. Talent is using ordinary words to produce humour. We have excellent comedians in Bollywood. Writers of humour," Justice Kant had given his take on what humour ought to be really. The judge had also constituted a panel of senior IPS officers to comb through the social media posts of academician Ali Khan Mahmudabad to pick out the nuances in his contentious social media posts on Operation Sindoor. Justice Kant has been a part of several impactful decisions of the apex court. including the abrogation of Article 370 of the Constitution which removed the special status to the erstwhile State of Jammu and Kashmir. Justice Kant was also part of the Bench which held the electoral bonds scheme unconstitu-

HMDA achieves record-breaking bid of Rs 137.25 crore in first set of Neopolis e-auctions

Hyderabad: The Hyderabad Metropolitan Development Authority (HMDA) commenced the first set of e-auctions for Neopolis on Monday, delivering landmark results with two marquee land parcels fetching record prices. Two land parcels, Plot 17 (4.59 acres) and Plot 18 (5.31 acres), closed at record prices of Rs 136.50 crore per acre and Rs 137.25 crore per acre, respectively. Plot 18 was the first to be secured by MSN Urban Ventures LLP, followed shortly thereafter by Vajra Housing Projects LLP, which emerged as the winner of Plot 17. Together, the two auctions generated impressive Rs 1,356 crore in monetised revenue for the government of Telangana, HMDA release stated.

Hyderadbad-based Dr Reddy's gets European approval for osteoporosis biosimilar AVT03

New Delhi: Dr Reddy's Laboratories on Monday said the European Commission has granted marketing authorisation for its biosimilar to treat osteoporosis. The company has received approval for AVT03, a biosimilar of Prolia (denosumab) and Xgeva (denosumab), the Hyderabad-based drug firm said in a statement. Prolia is a prescription medicine used to treat osteoporosis in women who have been through menopause and in men who are at increased risk of fractures, bone loss linked to hormone ablation in men with prostate cancer at increased risk of fractures and bone loss associated with long-term treatment with systemic glucocorticoids.

sible opportunity. Major collision averted at Delhi airport as Afghan flight lands on wrong runway

New Delhi: A major collision was averted at the Indira Gandhi International Airport here on Sunday when an Ariana Afghan Airlines flight from Kabul mistakenly landed on a runway from where another flight was taking off, a senior DGCA official said. The regulator has already launched a probe into the incident, he said. Ariana Afghan Airlines A310 aircraft operating flight FG-311 (Kabul-Delhi) was given clearance to land on runway 29L. However, the aircraft landed on runway 29R, he said.

The pilot-in-command (PIC) of the Ariana flight stated that he lost ILS (Instrument Landing System) at 4NM (nautical miles) and the aircraft turned right, after which the captain landed with visual approach on runway 29R, the official said. The ILS is a precision radio navigation system that provides short-range guidance to an aircraft allowing it to approach a runway at night, during bad weather and poor visibility. As per the PIC, he lost ILS at 4NM and the aircraft turned right, after which the captain landed with visual approach on RWY 29R, the DGCA official said, adding the ATC confirmed FG 311 was given landing clearance for



RWY 29L and the captain also acknowledged he had clearance for RWY 29L only. The PIC, the official said, alleged that after the Final Approach Fix, both ILS systems malfunctioned while the aircraft was established on the ILS for runway 29L. The Final Approach Fix (FAF) marks the beginning of the final approach segment of an instrument approach procedure. "Due to poor visibility and the failure of the ILS guidance, the aircraft unintentionally deviated from the intended approach path. We were not advised by Delhi tower of any deviation during the approach," the PIC told the authorities. After landing, the pilot said he "noticed that he had landed at runway 29R," according to the official."

On Trump administration's draft peace proposal for Ukraine

The Trump administration's draft peace proposal for Jkraine has triggered predictable unease in Kyiv. Presilent Volodymyr Zelenskyy has warned that Ukraine now aces a "very difficult choice", risking the loss of its dignity r a key partner. U.S. President Donald Trump has urged im to accept the proposal by Thanksgiving (November 27). Ukraine's apprehensions are understandable. Accordng to the leaked draft of Mr. Trump's 28-point plan, Kyiv vould be required to cede territory in Donetsk and ecognise Crimea, Donetsk and Luhansk as de facto Russian. In the other two oblasts annexed by Russia (Kherson and Zaporizhzhia), the conflict would be frozen along the ine of contact, effectively allowing Moscow to retain the reas it has seized. Russia would withdraw from the terriories it has captured outside the five oblasts and pledge ot to attack neighbouring countries again. The plan also emands Ukraine cap its armed forces at 6,00,000 personnel and formally renounce its bid to join NATO. The loc's eastward expansion would be halted, sanctions on Russia lifted, while Ukraine would receive "reliable secuity guarantees". The plan does not elaborate on these puarantees, but U.S. media said that the Trump adminisration has circulated a separate three-point plan, promisng NATO-style security assurances to Kyiv. Russian President Vladimir Putin has positively responded to the roposal, but Ukraine and its European partners are crambling to craft an alternative proposal to achieve what hey call "peace with dignity". Several elements of the rump plan mirror Russia's long-standing demands, including the halt of NATO's eastward expansion. On the ther hand, the proposal that Ukraine cede territory is not joing to be easy for any Ukrainian leader to implement.

Car Catches Fire on ORR Near Shamirpet; One Person Burned to Death

ceived information through Dial-100 that a car traveling on the Outer Ring Road (ORR) from Shamirpet towards Keesara had caught fire. Police reached the spot immediately and found the vehicle completely engulfed in flames. A fire engine arrived soon after and extinguished the fire. During inspection, police found a person burned to the bone in the driver's seat. A clues team was called to the location to collect forensic evidence. Preliminary investigation revealed that the vehicle was a Ford EcoSport bearing registration number TS03 FD 7688. The car belonged to Tallapalli Durgaprasad (age 30), a native of Jaigiri village, Hasanparthy mandal, Hanumakonda district, and a partner of E69 Digital News Channel. According to the information gathered, Durgaprasad had come to Hyderabad on business work and stayed at a relative's house in Miyapur last night. This morning, at about 4:30 a.m., he left alone in the car. CCTV footage confirmed that the vehicle crossed Dundigal Toll Gate at 5:22 a.m. Police suspect that the fire accident may have occurred while the vehicle was parked on the roadside along the ORR stretch between Shamirpet and Keesara. However, the exact cause of the incident will be known only after a detailed investigation. Doctors have been requisitioned to conduct an on-spot PME. A case has been registered and the investigation is ongoing.

Protest Against Repeal of Working Journalists Acts "TWJF, HUJ Stage Dharna at Central Labour office"





'Indian chronicle, Secunderabad, November 24 "The Telangana Working Journalists Federation (TWJF) and the Hyderabad Union of Journalists (HUJ) staged a massive protest on Monday in front of the Central Labour Department office at Vidyanagar, Hyderabad, demanding the withdrawal of the four new Labour Codes introduced by the Central Government. Journalists raised slogans calling for the reinstatement of the repealed Working Journalists Acts and condemning the Centre's labour policy decisions. The demonstration continued for nearly two hours. "The dharna was led by P. Ranchander, Convenor of the Federation's Ad-hoc Committee, who said the Union Government was favouring corporate interests at the cost of workers' rights. He termed the repeal of long-established labour laws—secured through decades of struggles—as unjust and undemocratic. He urged the Centre to immediately withdraw the Labour Codes. "TWJF State General Secretary B. Basavapunnayya strongly criticised the scrapping of the two existing Working Journalists Acts. He said journalists are already facing numerous challenges, and the new Labour Codes would further aggravate their difficulties, undermin-

ing job security and employee safeguards. "Labour leader

J. Venkatesh, addressing the journalists, said the new Labour Codes pose a "life-and-death issue" for workers. He pointed out that the Codes empower employers and governments to fix wages, undermine minimum wage norms, extend working hours from the existing 8 hours to 12–16 hours, and fail to guarantee overtime protections. He added that the Centre has effectively distanced itself from ESI and PF responsibilities, leaving workers vulnerable. He demanded that the State Assembly pass a resolution opposing the new Codes. "Following the protest, federation leaders submitted a representation to Central Deputy Chief Labour Commissioner Biswa Bhushan. Senior leaders and members of TWJF and HUJ, along with a large number of journalists, participated in the demonstration.

White collar terror module: Haryana preacher pleads with police to collect rent from doctors



The atmosphere in the police interrogation room at Srinagar is tense, but a Haryana preacher detained in connection with a 'white-collar' terror module remains focused on unpaid rent from arrested doctors. Maulvi Ishtiyaq, the religious preacher from Mewat in Haryana, was picked up by Jammu and Kashmir Police after the recovery of 2,500 kg of explosive material, including ammonium nitrate, potassium chlorate, and sulphur, from his rented residence located outside Faridabad's Al Falah University, which has emerged as the epicentre of the terror module.

His name surfaced during the interrogation of Dr. Muzammil Ganaie, a key member of the 'white-collar' terror module arrested from the University. At his instance, the police team recovered explosives from the residence of the preacher. This white-collar module was busted on November 10 after an intense investigation by Srinagar police and led to the arrest of eight persons, including three doctors. But one, Dr. Umar-un-Nabi, had managed to give a slip and was driving the explosive-laden car that blasted outside Red Fort, killing 15 people on November 10.

Maulvi Ishtiyaq told his interrogators a shockingly different story, claiming that Ganaie and Umar approached

him earlier this year, asking him to store what they called "fertilisers" at his home and allegedly agreed upon a monthly storage fee of ?2,500, according to officials. Maulvi Ishtiyaq was not concerned about the gravity of the situation and his concern was about the outstanding rent owed by Ganaie and Umar which was pending for the last six months, they said.Living below the poverty line and struggling to support his four children and family, the religious preacher told the officials of the National Investigation Agency, Srinagar Police and others from central security agencies to recover the outstanding rent from Ganaie so that he could send the money back home. The officials recalled that the disparity between the heinous crime of storing enough material for a massive terror attack and the detainee's immediate, desperate concern for the rent payment was enough to briefly break the tension in the interrogation room. The incident provides a bizarre and tragicomic look into the lives entangled on the fringes of major terror plots, said a senior police offi-

His story was supported by Ganaie during interrogation, the officials said, adding Maulvi Ishtiyaq has been handed over to the State Investigation Agency for further action. The preacher was detained on November 12 after a series of raids conducted by Jammu and Kashmir police along with their Haryana counterparts. Jammu and Kashmir police on November 10 along with their counterparts in Haryana and Uttar Pradesh carried out the operation to unravel a 'white-collar' terror network of banned Jaish-e-Mohammed (JeM) and Ansar Ghazwat-ul-Hind and arrested eight people. Investigations led to the Al Falah University where 2,900 kg of explosives was recovered. It all started on the intervening night of October 18-19, when posters of the banned JeM surfaced on walls just outside Srinagar city. The posters warned of attacks on police and security forces in the Valley

There should have been more Indian shuttlers at the top now: Saina Nehwal

Saina Nehwal was a trailblazer for Indian badminton on the court and now she is ready to do the same off it. Nehwal has become the first women badminton star, along with Spaniard Carolina Marin, to associate with the Legends' Vision, an ambitious project by four legends of the sport. Envisioned by Lin Dan, Lee Chong Wei, Peter Gade and Taufik Hidayat, the vision aims to go beyond competitions, trophies and prize money and focuses on four core ambitions: enhancing junior development, enriching communities, expanding participation, and driving innovation across the sport. Now in its 10th year and returning with its Legacy Tour to India, the project has launched 'A Racket's Second Life' in the country to spread the game among the less privileged kids.

What exactly is the Legends' Vision and how did your association with this tour come about?

It's a programme that has been around for 10 years but I only joined it last year. Their motto is to promote the game all over the world. And they are launching in India, for the first time ever, 'A Racket's Second Life', which invites donations of used rackets for someone who cannot afford to buy. We believe that even those who don't know much about the game will want to play and learn more about it if they get a racket in hand and start playing. A game grows when everyone is learning and playing it regardless of the level. When I was coming up, Gopi sir gave me a racket and that meant so much for me, I wanted to prove myself worthy of it. But do you think that Indian badminton has hit a speedbreaker?

Yes, there is a little bump, especially among the girls. The boys are still doing well, Lakshya is doing extremely well. But there is a slight slide among the girls. I think everybody is different; some bodies are capable of doing extraordinary early on, others take time. Maybe in 10 years, a new kid will come along with a group who is doing well.I think we were very lucky that way, 10-15 years back, me, (P.V.) Sindhu, (Kidambi) Srikanth, (H.S.) Prannoy, (Parupalli) Kashyap, Sai Praneeth, Guru Sai Dutt, Ajay Jayaram, all of us were doing extremely well. Every time we participated in a Super Series event, we would be confident at least one of us would win a medal.I feel it took them some time to come into the circuit but in the last one to two years, there has been a lot of improvement from some of the girls. Unnati (Hooda) and Anmol (Kharb) are doing well. We should give them some time. Every country goes through this, including China. In Korea, earlier there were no players, now suddenly one player is dominating. We will have to wait and see how it goes. There are two ways of developing talent - cyclical, where one generation is brilliant across the board, like yours. Then there is a gap before the next generation succeeds. The other is continuous, where the next generation is already even as the previous one is still reaching its peak, something like China. What do you think we need to do to move from the former

Honestly, it's a question for me too. Badminton has grown a lot in India, coaches have been coming for many years. Actually, more foreign coaches are entering now. And honestly, some more players at the top should have started by now. I think the coaches can give a better answer to where the mistakes are happening. The players now have everything. We didn't have trainers or physios or even enough quality coaches, there would be one looking after 40 players. Competition exposure was also less, and moreover, we didn't have social media to be aware of what or how others were performing. It can't be that the players don't have the ability either; they are all very good. Maybe it's just taking a little time. There is also impatience. People want immediate results, they are not able to stay in one place for long, they keep changing their training venues and partners seeking instant success. Most of them are not training in a group. If you train in a group, the results will come. Every player has a different game so you get to train against different players. And you keep pushing each other. There is also competition within the group.

Girls like Akarshi (Kashyap) and Malvika (Bansod) have been playing on the circuit for 5-6 years. I don't understand this because if you are not progressing, it's a big question. At the same time, I have seen Unnati who has improved a lot in the last one to two years, she is playing consistently in semis and finals of Grand Prix. Tanvi (Sharma) is also playing really well. But we don't have a 15-16 year



old athlete who can go all the way. I feel we have missed the bus somewhere. We are getting a lot of support. There are so many foundations who are supporting, along with a lot of schemes. As a player, I can only think about where a player went wrong on the court. But the 'missing bus' part and why it is taking so much of time, maybe coaches can answer better.

What about you getting into full-time coaching, especially now that you already have one (Kashyap) in the family?

I can see his condition. He trains from 4 a.m. to 1 p.m. and everyday he is frustrated over someone or the other. Coaching is tougher than playing, you have to put so much effort and time and your entire self into it. But it's also about passion. I will just wait and see. I have been in sports for so many years, played at the highest level, so we have already seen so much stress. I want to be with my family for some time. My parents didn't really do anything except be with me, now I want them to enjoy life. But you never know after three to six years, I might want to go back to the game. Now I do motivational talks and if any of the youngsters want, I try to support them, tell them to come and play.

Badminton is played by everyone but what do you think needs to be done to attract viewers?

I still feel the marketing can be much better. Both the Indian and the international federations need to do much more so that people come and watch tournaments. That is how kids will learn. When you talk about cricket or football World Cups or the tennis Grand Slams, you see the events promoted almost a year in advance and there is constant talk about it, information and promotions. We have the World championships next year and it is the biggest event in the sport. We are also hosting it after 16 years. Given all that, I just feel that maybe we are lacking a little in pushing the tournament across the country. Those who follow closely will know but does the common public know about the event or its importance?

Three Security Personnel Killed in Suicide Attack at Peshawar Paramilitary HQ

Peshawar: At least three security personnel were killed and two others injured in a suicide attack at a paramilitary force headquarters on Monday in Pakistan's Peshawar, according to a senior police official. Three suicide bombers, who attempted to storm the Federal Constabulary (FC) headquarters, were also killed in counterfiring, City Police Chief Mian Saeed said. "One attacker detonated himself at the main gate, while the other two entered the premises. FC personnel engaged them and both were killed on the spot." Saeed added.

"Two suicide explosions took place inside the FC headquarters, one at the main gate and the other near the motorcycle stand located within the premises," Inspector General of Police Khyber Pakhtunkhwa Zulfiqar Hameed said. The powerful blast at the main gate triggered panic in the surrounding residential and commercial areas, with the explosion heard from a considerable distance.

Additional contingents and rescue teams rushed to the site, and security across the area was placed on high alert, officials said. According to hospital officials, five people, including three civilians, were injured in the attack. Khyber Pakhtunkhwa Chief Minister Sohail Afridi has strongly condemned the terrorist attack while reiterating that the provincial government "stands firmly" with the police and all law enforcement agencies. The civilian paramilitary force, originally called the Fron-tier Constabulary, was renamed by the government as Federal Constabulary in July. The head-quarters of the force is located in a crowded area, close to a military cantonment, Dawn reported.

U.S. set to label Maduro-tied Cartel de los Soles as terror organization



President Donald Trump's administration is set to ramp up pressure on Venezuelan President Nicolás Maduro on Monday (November 24, 2025) by designating the Cartel de los Soles as a foreign terrorist organization. But the entity that the U.S. government alleges is led by Mr. Maduro is not a cartel per se. The designation is the latest measure in the Trump administration's escalating campaign to combat drug trafficking into the U.S. In previewing the step about a week ago, U.S. Secretary of State Marco Rubio accused Cartel de los Soles, or Cartel of the Suns, of being "responsible for terrorist violence" in the Western Hemisphere.

The move planned on Monday comes as Mr. Trump evaluates whether to take military action against Venezuela, which Mr. Trump has not ruled out despite bringing up the possibility of talks with Mr. Maduro. Land strikes or other actions would be a major expansion of the monthslong operation that has included a massive military buildup in the Caribbean Sea and striking boats accused of trafficking drugs, killing more than 80 people. Venezuelans began using the term Cartel de los Soles in the 1990s to refer to high-ranking military officers who had grown rich from drugrunning. As corruption later expanded nationwide, first under the late President Hugo Chávez and then under Maduro, its use loosely expanded to police and government officials as well as activities like illegal mining and fuel trafficking. The "suns" in the name refer to the epaulettes affixed to the uniforms of high-ranking military officers.

The umbrella term was elevated to a Maduro-led drugtrafficking organization in 2020, when the U.S. Justice Department in Trump's first term announced the indictment of Venezuela's leader and his inner circle on narcoterrorism and other charges. "It is not a group," said Adam Isaacson, director for defense oversight at the Washington Office on Latin America organization. "It's not like a group that people would ever identify themselves as members. They don't have regular meetings. They don't have a hierarchy."Up until this year, the label of foreign terrorist organization had been reserved for groups like the Islamic State or al-Qaida that use violence for political ends. The Trump administration applied it in February to eight Latin American criminal organizations involved in drug trafficking, migrant smuggling and other activities. The administration blames such designated groups for operating the boats it is striking but rarely identifies the organizations and has not provided any evidence. It says the attacks, which began off the coast of Venezuela and later expanded to the eastern Pacific Ocean, are meant to stop narcotics from flowing to American cities.But many — including Mr. Maduro himself — see the military moves as an effort to end the ruling party's 26-year hold on power. Since the arrival of U.S. military vessels and troops to the Caribbean months ago, Venezuela's U.S.backed political opposition also has reignited its perennial promise of removing Mr. Maduro from office, fueling speculation over the purpose of what the Trump administration has called a counterdrug operation. Mr. Trump, like his predecessor, does not recognize Mr. Maduro as Venezuela's

President.

Mr. Maduro is on his third term in office after ruling-party loyalists declared him the winner of last year's presidential election despite credible evidence that the opposition's candidate defeated him by a more than 2-to-1 margin. He and senior officials have been repeatedly accused of human rights violations of real and perceived government opponents, including in the aftermath of the July 2024 election.U.S. Defense Secretary Pete Hegseth said last week that the upcoming designation of Cartel de los Soles will provide a "whole bunch of new options to the United States" for dealing with Mr. Maduro. But Mr. Hegseth, speaking in an interview with conservative news outlet OAN, did not provide details on what those options are and declined to say whether the U.S. military planned to strike land targets inside Venezuela.

'So nothing is off the table, but nothing's automatically on the table," he said. Trump administration officials have signaled that they find it difficult to see a situation in which Mr. Maduro remaining in power could be an acceptable end game. But as Mr. Trump considers an array of military and non-military options, including covert action by the CIA, for next steps, there is strong belief inside the administration that Mr. Maduro's rule "is not sustainable," according to a senior administration official who was not authorized to comment publicly on the sensitive matter. The official added that Mr. Trump has been keenly listening to his intelligence team, which has reported to him that chatter picked up inside Venezuela indicates growing anxiety from Mr. Maduro and other high-level Venezuelan officials as the U.S. strikes continue. Mr. Trump, the official said, is "very content and satisfied" for the moment with the strikes' impact. All the while, pleas from Mr. Maduro and others close to the Venezuelan leader to speak directly to the administration, relayed through various intermediaries and channels, seem to be more frantic, the official said. But Mr. Trump has not sanctioned any intermediaries to speak to Maduro on behalf of the U.S. administration. The 2020 indictment accused Mr. Maduro, Interior Minister Diosdado Cabello and Defense Minister Vladimir Padrino López, among others, of conspiring with Colombian rebels and members of the Venezuelan military for several years "to flood the United States with cocaine" and use the drug trade as a "weapon against America." Colombia is the world's top cocaine producer. Before laying down weapons as part of a 2016 peace deal, members of the Revolutionary Armed Forces of Colombia, or FARC regularly used the porous border region with Venezuela as a safe haven and hub for U.S.-bound cocaine shipments often with the support or at least consent of Venezuelan security forces. Dissidents continued the work. Colombia's National Liberation Army guerrilla is also involved in the ille-

Mr. Maduro has denied the charges. The U.S. Justice Department this year doubled to \$50 million the reward for information that leads to Mr. Maduro's arrest.Mr. Maduro has insisted that the U.S. is building a false drug-trafficking narrative to try to force him from office. He and other government officials have repeatedly cited a United Nations report that they say shows traffickers attempt to move only 5% of the cocaine produced in Colombia through Venezuela. The U.S. Treasury Department imposed sanctions on the Cartel de los Soles in July, saying Mr. Maduro and his top allies had bent the power of the Venezuelan government, military and intelligence services to assist the cartel in trafficking narcotics to the U.S.U.S. authorities also alleged Mr. Maduro's cartel gave material support to the Venezuelan gang Tren de Aragua and the Sinaloa cartel, both of which were among the organizations that the U.S designated as foreign terror organizations in February.

Philippine President says 7 suspects in corruption scandal have been detained, others being sought

Philippine authorities detained seven suspects and several more were being sought in a major corruption scandal involving flood control projects, President Ferdinand Marcos Jr. said on Monday (November 24, 2025) as he tried to quell public outrage over the brazen anomalies that have implicated powerful members of Congress. Massive corruption has been blamed for substandard or non-existent flood control projects in the poverty-stricken Southeast Asian country long prone to deadly floods and extreme weather. Two Philippine Presidents, including Mr. Marcos' late father, were overthrown in peaceful public revolts due to alleged plunder and misrule.

The initial batch of more than a dozen suspects, including Zaldy Co, a former member of the House of Representatives, and government public works engineers, were indicted by the Sandiganbayan, a special anti-corruption court, in the first of what is expected to be dozens of criminal graft and corruption lawsuits that Mr. Marcos promised would lock up implicated senators, House members and wealthy construction company owners by Christmas.

The first corruption case involved irregularities in flood control projects in Oriental Mindoro province, including a river dike worth 289 million pesos (\$4.8 million), that were undertaken by Sunwest Corp., a construction firm that officials say is owned by Mr. Co's family.Mr. Marcos said one suspect was arrested and six others surrendered over the weekend to police. The arrested suspect was found in a house in suburban Quezon city in the capital region where an unspecified number of people who were trying to help hide the suspect were also arrested, he said.

"My advice to the remaining suspects is for all of you to surrender, don't wait to be pursued," Mr. Marcos said in an early Monday post on his Facebook account. "This will continue, we will not stop." Interior Secretary Jonvic Remulla said the location of Mr. Co, who is believed to be outside the Philippines, was unknown, but three other suspects may soon surrender to the Philippine embassies in the United States, New Zealand and Jordan and be flown back home. "No matter where you are in the world, we will find you," Mr. Remulla said at a news conference, where mug

Witnesses have testified in Senate hearings and in an independent fact-finding commission established by Mr. Marcos that several former and incumbent senators and House members have pocketed huge kickbacks from favored construction companies, which cornered lucrative flood control contracts for years. A number of Department of Public Works and Highways officials and engineers have testified under oath in the Senate hearings that they helped arrange the corrupt deals and received large sums for doing so. The lavish lifestyles, mansions, suitcases of cash and fleets of luxury cars and private jets of the leading corruption suspects have sparked huge protests. An upcoming demonstration scheduled for Nov. 30 is backed by the dominant Roman Catholic church. Those implicated include Rep. Martin Romualdez, the President's cousin and key ally, who has denied any involvement but has stepped down as House of Representatives speaker. Former Senate President Chiz Escudero has also been accused of pocketing kickbacks and has stepped down from his post but strongly denied any wrongdoing. Aides have defended Mr. Marcos from allegations linking him to the irregularities, saying that he first raised alarm over them in July in his annual state of the nation address before Congress. Canada to amend citizenship law; likely to benefit Indian-origin families

Ottawa: Canada has moved closer toward modernising citizenship-by-descent law, after a bill to amend the act received royal assent, in a move that is likely to affect thousands of Indian-origin families.

Bill C-3, an Act to amend the Citizenship Act (2025), has received royal assent. This represents an important milestone in making the Citizenship Act more inclusive, while maintaining the value of Canadian citizenship, said a news release issued by the Canadian government on Friday. "Once the new law comes into force, Canadian citizenship will be provided to people born before the bill comes into force, who would have been citizens if not for the first-generation limit or other outdated rules of past legislation", the news release said.

The first-generation limit to Canadian citizenship by descent was introduced in 2009. It means that a child born or adopted outside Canada is not a Canadian citizen by descent if their Canadian parent was also born or adopted outside Canada.

Quarrying crisis in Tamil Nadu's Uthiramerur leaves residents in distress



If one were to have a bird's eye view of Uthiramerur taluk in Kancheepuram district, it would possibly be a canvas of grey with small patches of green. However, it was not like this in the not-so-distant past. A vast portion of the land known for its kuda olai system of election and bewitching temple architecture is "greying", thanks to a large number of granite quarries and crushing units. Almost every tree and plant, roads, mud on the roadsides, and crops in the fields have turned grey in and around villages including Siruthamur, Pazhaveri, Arungundram, Pazhaya Seevaram, Alanjeri, and Thirumukkudal, thanks to quarrying and stone crushing units that make M-sand. On a cloudy, still afternoon in November, the roads around these units feel eerie, and the trees seem frozen as if petrified.

Estimates show that close to 60 villages in this region are affected by quarrying, and there are around 80 quarries. According to a mapper, data from the National Remote Sensing Centre show that in 2005-06, a total of 4.21sq. km. was under mining in the erstwhile Kancheepuram district. The area increased to 33.13 sq. km. in 2015-16, but this figure includes some sand mining areas too. The district also saw a reduction in land under paddy, with quarrying being a major cause.

Farmers at Alanjeri said a proposed quarry (Kori as they call it) that they were protesting against had fenced off land where a channel bringing water from a hillock runs through. "The channel, constructed by the Rural Development Department, used to carry water to our irrigation tank wherein two wells that meet our drinking water needs are situated. The water gets contaminated by guarry dust and if the water does not fill up the Alanjeri tank, a chain of 10 other tanks won't get water. We used to grow three crops of paddy a year. Now, we struggle to grow one crop," said V. Balakrishnan, a farmer. The village only has Dalit farmers and they claim the first quarry in their village is located on Panchami land unknowingly sold in bits and pieces to others. "We have been petitioning the Collector for several years to stop the operation of the quarry and not allow a second one to come up. The new one lies on the route of the annual procession of our village deities Theni Amman and Palani Amman. They won't allow us to take a detour even," said Vijayakumar, another farmer. Farmers lead the

C. Devaraj of Arungundram said his father Chinnapaiyan was the first to die in an accident caused by the heavy vehicles carrying stones from a quarry. "He was one of the first to protest against the quarry operations in the area. It was in November 2003." In one village, the panchayat president refused to pass a resolution against the quarries since he himself owned one. "The quarries are so close to each other in some cases that we have no space for our animals to graze," he added. Last year, farmer leaders from several villages joined to stage a hunger strike seeking relief to Rajendran, a farmer whose land could not be cultivated, with the well drying up because of quarry operations. "We were denied police permission even to use chairs for the protest," said Harikrishnan of Pazhaveri. Mr. Rajendran said it was 12 years since his well dried up. "I have been holding up against the quarry operators and managing with the income from milch animals. If I approach enresentatives, they tell me to sell off handed down by my forefathers. I don't want a car or airconditioner; I want to grow crops on my land and pass it onto my son to grow food for the people," he said. Farmer leader Manavalan said public hearings for new quarries are not held in the village or nearby, but in places where quarry owners muster enough supporters to out-number those opposing them. "Last year, a public hearing for a quarry witnessed very angry exchanges between farmers and an IAS officer. We told him to travel with us by bike without a helmet to feel the kind of dust we inhale from the trucks carrying the stone without cover. People are getting asthma and wheezing. The quarries do not follow basic rules like sprinkling water regularly to prevent the dust from flying," Mr. Harikrishnan added. The village roads running around the taluk are like a dirt patch for the mighty trucks that carry blue metal and stones. "Since the vehicles are always overloaded, they cannot stop as soon as they should. We shudder to send children to school as accidents keep happening. We are waging a continuous battle with the trucks. Two bridges across Palar River, connecting Pazhaya Seevaram and Thirumukkoodal and and Avalur and Walajahbad, have a continuous flow of vehicles on all days, except on Sundays," said Premkumar of the BJP, which has been holding protests in the area, calling for restriction in the timing for the trucks to ply. Farmers have been demanding that the timing of the trucks be regulated so that students can travel

Quarries and stone-crushing units are a major source of fugitive dust, a significant environmental concern that arises at nearly every stage of the operation. Dust is emitted during unloading of raw materials, crushing, screening, conveying, and storing of finished products. As stones are broken, shaken on vibrating screens, transported along conveyor belts, and stored in open stockpiles, fine particles particularly stone dust — become airborne. A 2023 study in the International Journal of Health Sciences and Research found that prolonged exposure to silica dust significantly impairs lung function among stone guarry workers in South India. The researchers observed that lung impairment was the highest among loaders, followed by stone grinders, drillers, blasters, and stone cutters. The problem is particularly acute with fine materials, like stone dust, which are easily carried by the wind and can linger in the air for long. Dust from stone quarries not only affects the workers on site but also people living nearby. Poornima Prabhakaran, Director, Centre for Health Analytics Research and Trends at Ashoka University, said that though the dust particles released from quarries are relatively large, they are hazardous to human health. Prolonged exposure to high dust levels can lead to respiratory problems, silicosis, and skin or eve irritation, she added

The Central Pollution Control Board (CPCB) has outlined stringent guidelines for stone-crushing units. They include the requirement for full enclosure around crushers and screens to contain dust at the source. Additionally, units must install fine-mist water sprinklers to dampen dust particles, along with bag filters and dry dust-extraction systems to capture airborne dust. Conveyor belts are to be fully covered to prevent dust from escaping, and discharge points must be fitted with telescopic chutes to control dust release when materials are transferred. Stockpiles of crushed material should either be kept wet or covered to reduce dust dispersion, ensuring that emissions are minimised and air quality is preserved within and around the crusher zones.S.M. Shiv Nagendra, a professor in the Department of Civil Engineering at the Indian Institute of Technology Madras, and an expert in air quality monitoring, said the carrying capacity of areas near quarries should be assessed. He noted that quarrying close to residential areas contributes significantly to pollution. The CPCB guidelines also mandate that internal roads be paved to prevent dust resuspension; wind-breaking walls and foggers be installed; and accumulated dust cleaned regularly. Units must also recycle water used for suppression and conduct ambient air monitoring to ensure the control of particulate emissions. While industries are required to implement continuous real-time air quality monitoring, quarries are not bound by the same regulation. However, even with these monitoring systems in place, they may not fully capture the extent of the pollution. Mr. Nagendra pointed out that current air quality monitoring stations measure pollution only in a onekilometre radius, leaving out the full extent of pollution affecting surrounding areas.

In July 2025, the National Green Tribunal (NGT) directed the Tamil Nadu Pollution Control Board (TNPCB) to enforce stricter standards for granting or renewing Consent to Operate (CTO) for quarrying and mining units in the State, after several units came under the scanner for violations. It ruled that quarrying activities should not continue unless penalties for past environmental violations were fully paid. These violations included failure to maintain safety distances, inadequate fencing and greenbelt development, insufficient dust control measures, and exceeding the approved extraction limits. The NGT instructed the TNPCB to require water sprinkling, greenbelt development, blacktopped roads, and equipment enclosures before granting CTO. It also recommended that greenbelt development begin at the application stage to ensure saplings are ready when operations start.

G. Sundarrajan of Poovulagin Nanbargal, an environmental organisation, called for the identification of guarry clusters and a third-party audit of the Cumulative Impact Assessment to evaluate the effect on groundwater and air quality. He also pointed to other States, like Telangana, which use satellite imagery to monitor sand mining and storage in near real-time and suggested that Tamil Nadu adopt a similar approach. A senior hydrogeologist, who preferred to remain anonymous, said the lack of a proper law to govern mining and groundwater extraction is the main reason for the current situation. The management of groundwater is governed by a mere government order: MS 142. A draft Tamil Nadu Groundwater (Development and Management) Act has been drawn up, but is yet to be enacted. Mining is a major subject in this Act because mining for coal or sand or rock will affect groundwater extraction. In Neyveli, the groundwater level, which used to be at 6 feet, is now at 35 feet-40 feet with continuous mining, he said. He said there is regulation only at the individual mine level now. Nobody is seeing the larger picture, and this is leading to environmental damage. An ecologist said that when people keep scooping stuff out of the quarries, the surrounding groundwater level will go down. In the long run, the nature of the soil will change owing to water loss. This will lead to gradual desertification, the kinds of plants able to grow on such a soil will change, and farmers will have to change their crops. Food crops will vanish. One day, the soil, instead of becoming grey, will go "bald" and will not be able to grow anything.

No alternative to M-sandA former government official who had worked in Kancheepuram said the district administration was seized of the matter and there were times when up to 30 quarries had been shut down. "The quarry owners have been warned to keep the truck tops closed with tarpaulin and instructed to carry only the permitted load. The TNPCB is the one that has the larger role in controlling the quarries," he said. However, without the quarries, construction activities and road laving in and around the city would come to a standstill. "Give us an alternative material to Msand, gravel, and blue metal. As river sand cannot be mined, the administration has no other option but to allow rock mining," he pointed out. The District Environmental Engineer of Kancheepuram acknowledged the complaints and representations about the pollution from stone quarries. "We have received representations forwarded from the Collectorate. They have sought a report, and we are starting work on it,"

Uranium found in breastmilk of lactating mothers, more studies expected in other states



: A recent study has revealed alarming levels of uranium (U238) in the breastmilk of lactating mothers across sevarl districts in Bihar, raising serious health concerns for their infants. Researchers from multiple institutions have found that uranium exposure through breastmilk could pose significant non-carcinogenic health risks to infants.

Speaking with ANI, Dr Ashok Sharma of AIIMS Delhi who is a co-author of the study, said, "The study analysed breast milk from 40 lactating mothers and found uranium (U-238) in all samples. Although 70% of infants showed potential non-carcinogenic health risk, the overall uranium levels were below permissible limits and are expected to have minimal actual health impact on both mothers and infants. The highest average contamination occurred in Khagaria district and the highest individual value in Katihar district. While uranium exposure may pose risks such as impaired neurological development and reduced IQ, breastfeeding should not be discontinued and remains the most beneficial source of infant nutrition unless clinically indicated. "The study showed that: 70% of the infants had HQ > 1, indicating possible non-carcinogenic health risks from uranium exposure through breast milk. Uranium exposure in infants may affect: Kidney development, Neurological development, Cognitive and mental health outcomes (including low IQ and neurodevelopmental delay) if longterm exposure continues."

"However, based on the observed uranium concentrations in breast milk samples (0-5.25 ug/L), the study still concludes that the actual impact on infant health is likely low, and most uranium absorbed by mothers is excreted primarily through urine, not concentrated in breast milk. Therefore, breastfeeding remains recommended, unless a clinical indication suggests otherwise," he said Dr Ashok also said that such studies will be conducted in other states to know about the presence of heavy metals."We are under the process of examining the heavy metals in other states and their impact on human health which is a need of the hour."The study, conducted on 40 randomly selected lactating women from various districts of Bihar, involved quantification of U238 in breastmilk. All samples tested contained uranium, with the highest levels observed in the Katihar district. Health risk assessments showed that infants are particularly vulnerable due to their limited ability to eliminate uranium from their bodies. The study estimates that 70 per cent of the infant population analysed could experience non-carcinogenic health effects from exposure. Uranium, a naturally occurring radioactive element, is commonly found in granite and other rocks. It can contaminate groundwater through natural processes and human activities such as mining, burning coal, nuclear industry emissions, and the use of phosphate fertilisers. On futher studies to identify the presence of pesticides, environmental pollutants in breastmilk Dr Ashok said, "the article does address future directions, and pesticides are included in their plans. From the study's discussion and conclusion sections, this investigation focused on uranium (U-238) in breast milk; our previous work had already identified arsenic, lead, and mercury in breast milk. We further highlight the need for continued biomonitoring of toxic contaminants, including environmental pollutants such as pesticides in breast milk, to better understand infant exposure risk.

The World Health Organisation (WHO) sets a provisional limit of 30 micrograms per litre (ug/L) for uranium in drinking water, while some countries, such as Germany, have adopted stricter limits of 10 ug/L.In India, uranium contamination has been reported in an estimated 151 districts across 18 states, with 1.7 per cent of groundwater sources affected in Bihar. Globally, elevated uranium levels have been observed in countries including Canada, the United States, Finland, Sweden, Switzerland, the United Kingdom, Bangladesh, China, Korea, Mongolia, Pakistan, and the lower Mekong Delta region. Though prior global studies have shown high uranium concentrations in groundwater, clear clinical symptoms among exposed populations have not been consistently observed. However, the current research underscores the urgent need to monitor U238 in Bihar to assess and mitigate potential health risks to mothers and

Auramine in Indian food: why a banned dye keeps returning | Explained



India continues to face recurring episodes of chemical adulteration in food, particularly through the use of nonpermitted synthetic dyes. One of the most persistent among them is auramine O, a bright yellow industrial dye banned under Indian food-safety regulations. Recent inspections by state food-safety departments, academic studies and even everyday observations such as unnaturally bright yellow chickpeas sold in public have again uncovered its pres ence in sweets and savoury items. This concern is not new, India has dealt with multiple waves of dye-related adulteration for nearly four decades, from metanil vellow in turmeric. rhodamine B in cotton candy and curry masala, Sudan dyes added to spices. Argemone oil mixed with mustard oil, calcium carbide used to ripen fruits, urea added to milk to thicken, mineral oil mixed with edible oils to chalk powder added to flour revealing systemic vulnerabilities in both regulation and awareness. Auramine's re-emergence is part of this larger pattern.

Auramine O is a synthetic yellow dye extensively used in industry, including textile and leather processing, printing inks, paper manufacturing, and certain microbiological staining procedures. It has a vivid colour and is inexpensive, but Auramine O is not approved for use as a food colour in India, the European Union, the United States, or most other regulatory jurisdictions. Toxicological research has linked its ingestion to a range of health risks, including liver and kidney damage, enlargement of the spleen, mutagenic effects that can alter genetic material, and potential carcinogenic outcomes. Animal studies have consistently demonstrated organ lesions and disruptions in metabolic processes even at relatively low doses of exposure. Reflecting the seriousness of these findings, the International Agency for Research on Cancer (IARC) classifies auramine as a substance that is possibly carcinogenic to humans.

How does auramine enter food?

Despite longstanding prohibitions, auramine continues to enter the food chain largely due to its easy availability and low cost. Industrial-grade colours are sold informally in local markets, and small-scale sweet makers or street vendors often rely on these unlabelled powders because they provide a bright, appealing yellow that mimics saffron, turmeric, or permitted synthetic colours. In many cases, producers remain unaware of regulatory restrictions or view enforcement as sporadic and avoidable. During festive seasons when large quantities of brightly coloured sweets, snacks, and fried items are produced the use of inexpensive colourants tends to spike, raising the likelihood of auramine contamination.

What have earlier investigations in India shown?

Findings from different regions consistently show that dyes such as auramine, metanil yellow, rhodamine B, and malachite green appear in certain samples of sweets, savoury snacks, condiments, and pickles. These violations are particularly common in unorganised food sectors, where oversight is limited and ingredients are often procured through informal supply chains. Regulatory challenges compound the problem. India's food production landscape is dominated by micro and small enterprises, many of which operate with limited technical knowledge of safe manufacturing practices. While the Food Safety and Standards Act, 2006, provides stringent provisions against adulteration, enforcement remains uneven due to variations in laboratory capacity, staffing, and surveillance systems across states. In several toxicology reports, long-term ingestion of non-permitted dyes including auramine -- has been linked to physiological degeneration, organ pathology, and genetic damage in animal studies. Yet, despite repeated crackdowns, the recurrence of auramine in food samples indicates that economic incentives and supply-chain fragility continue to override compliance.

What is the global context?

The concerns surrounding auramine are not unique to India. Historically, several countries encountered similar issues in the mid-20th century, when industrial dyes including auramine were occasionally used in foods before emerging toxicological evidence prompted universal bans. Today, regulators in the U.S., EU, and East Asian nations classify auramine strictly as an industrial dye, and its presence in consumables triggers product recalls and import alerts.In recent years, isolated reports of auramine contamination have surfaced in turmeric consignments, pickles, and brightly coloured sweets across parts of South Asia and Africa, underscoring its global status as a prohibited and hazardous additive.

Why are these violations significant for India today?

Despite improvements in food safety systems, the wide variety of street foods, festival sweets, and locally prepared snacks in India can sometimes increase exposure to products that may contain industrial dyes, largely because these items often move through complex and informal supply chains. Children who tend to consume a disproportionate share of brightly coloured foods are at increased risk of longterm harm. Recurrent contamination erodes consumer trust and creates pressure on regulatory authorities to strengthen surveillance. The continued detection of auramine also highlights structural challenges related to informal manufacturing, limited awareness of safety standards, and the affordability gap between permitted and non-permitted

colourants. What steps are being taken?

The Food Safety and Standards Authority of India (FSSAI) periodically intensifies sampling, surveillance, and enforcement efforts, particularly during festive seasons when colour adulteration peaks. Several states have launched targeted drives against illegal colourants, leading to seizures of unlabelled dye packets and prosecution of violating units. Alongside enforcement, awareness programmes for small food manufacturers and street vendors are being expanded to encourage safer manufacturing practices. There is also a push to strengthen laboratory infrastructure and develop rapid testing kits that can detect industrial dyes at the point of sale.

What lies ahead?

Eliminating auramine from the food chain will require a multilayered approach. This includes tighter regulation of chemical markets selling industrial dyes, sustained community-level education for small manufacturers, broader deployment of easy-to-use testing tools, and stronger penalties for chronic violators. Consumer education especially regarding the risks associated with unnaturally bright foods will also be crucial.

'Helpless' Mohanlal: How the Dadasaheb Phalke awardee's portrayals of despair always hit the audience square in the chest



A few weeks ago, as I was mindfully writing a piece for the Cinema Anatomy column here, analysing Mammootty's exceptional ability to ace emotional scenes and convey vulnerability with remarkable finesse, I couldn't help but wonder if there was any strong emotion that Mohanlal portrays in an equally astounding manner. Yes, he is an exceptional actor who has proven his marvellous range over the past 4+ decades, highlighting that he can handle comedy, tragedy and rage with equal magnificence, thus always striking a chord with audiences almost effortlessly. But if we look at it on a microscopic level, are there any specific human emotions or responses that he handles with exquisite precision, such that his depiction of them seldom misses the target of the audience's hearts?

Later, as I was mindlessly scrolling through social media, I stumbled upon a video featuring a scene from director Sibi Malayil's Chenkol (1993), penned by AK Lohithadas. The clip highlighted how effortlessly Mohanlal conveyed complex layers of his character through his eyes, while also demonstrating outstanding subtlety. It's true. The character of Sethumadhavan in Chenkol and its prequel, Kireedam (1989), which earned Mohanlal his first National Film Award (Special Mention), was not only nuanced and hard-hitting, but also devoid of the typical embellishments Indian film heroes usually receive. And it was masterfully executed by the actor, positioning it as a reference for arcdriven acting.

Nonetheless, in that very scene — where Sethumadhavan talks to his henchman, Haidrose (Cochin Haneefa), with an eerie ecstasy about their new life as goons, mentioning how the more they kill, the more money they make — the brilliance of his acting went far beyond his eyes. While we see his eyes — which frequently welled up in Kireedam as he was simply a youngster caught in a web of misfortunes — initially dry as the desert, devoid of any sympathy for others owing to his life experiences over the years, as the conversation with Haidrose progresses in the single shot, his tone also shifts and it becomes clear that its also his expressions that added gravity to his performance. The state of equanimity that Sethumadhavan has reached - where quietude arises from the pain he has endured and the realisation that nothing can hurt him anymore stemmed from a deep sense of despair: the complete loss of hope, and a frame of mind that no longer sought it. That intense portrayal of helplessness communicated far more about Sethumadhavan than Lohithadas had penned or Sibi envisioned. As I was appreciating Mohanlal's performance in that scene, a couple more moments from various other movies came flooding back, wherein he handled similar emotions with notable sophistication. One by one, I began revisiting such scenes and couldn't help but appreciate the evocative yet subtle manner in which he depicted despair and helplessness in several movies over the years. One of his earliest films, where Mohanlal showcased an extraordinary command in depicting helplessness, was Fazil's Nokkethadhoorathu Kannum Nattu (1984). Despite not having many dialogues in the final act of the movie and remaining a mere but constant presence on screen — mirroring the powerlessness of his character in those circumstances — he managed to convey distress perfectly there, adding an additional layer of innocence. It was because of the impact he made with his performance in the end that the transition from his face to Vallyammachi (Padmini) fixing the doorbell of her house, in the hope that her granddaughter would one day return and ring it, resonated deeply and brought us to tears.

By the time he appeared in Alleppey Ashraf's tragedy Ninnistham Ennishtam (1986), Mohanlal had become a spectacular actor, showing significant improvement from his initial amateur performances. Here, he masterfully blended both despair and helplessness with remarkable precision, bringing out the emotional core of his submissive-natured character beautifully.

Despite his role being just a cameo in Reghunath Paleri's Onnu Muthal Poojyam Vare (1986), it was Mohanlal's incredible ability to convey and bend these emotions even through his voice that made it unforgettable. The film revolves around a single mother and her four-year-old daughter who become a ray of hope in the life of a man overshadowed by dark clouds of hopelessness and helplessness. While he showcased intense portrayals of these emotions at various junctures in movies like Deshadanakkili Karavarilla, Namukku Parkkan Munthirithoppukal, Amrutham Gamaya, Sarvakalashala, Unnikale Oru Kadha Parayam, Vandanam, Dasharatham and Thazhvaram, he presented them with hard-hitting innocence in films like TP Balagopalan MA, Gandhinagar 2nd Street, January Oru Orma, Nadodikkattu, Ulsavapittennu, Chithram and Aye Auto, in tune with the tone of these titles. Take Venu Nagavally's Sarvakalashala (1987), for instance. Here, despite having no one in life and nothing to look forward to, Lal (Mohanlal) is a character who wishes to find people and spaces wherein he can emotionally anchor himself. While we see a ray of light coming from within Lal in the initial parts of the movie, trying to pierce through the darkness in life, once he realises that all the relationships he had made over the years have shattered due to a misunderstanding, the actor reaches his absolute best and slowly allows despair to eclipse that streak of light in the character.At a crucial moment in Sibi Malayil's Dasharatham (1989), we see Rajiv Menon (Mohanlal) hoping against hope and approaching the surrogate Annie (Rekha) one last time, asking if he could have his son back. His realisation that, despite being filthy rich, there are moments when he is utterly helpless hits him hard, and his opulent robes seem to fall away as he begs in desperation. Here, the actor brilliantly showcased his ability to portray a character's gradual emotional downfall and eventual rock bottom with sturdiness, as well as the person tricking himself into believing that there could be light at the end of the tunnel.In one of the most heart-wrenching moments from Venu Nagavally's Aye Auto (1990), we see autorickshaw driver Sudhi (Mohanlal) being asked to get up from the table where he had sat down to eat at the home of one of his affluent customers, who had invited him for her birthday

lunch. As her grandmother (Sukumari) scolds him for sit-

ting in the first turn while their rich relatives are yet to be fed,

Sudhi gets up, not just because he's insulted but with a sheer realisation of his supposed position in such social circles, highlighting the helplessness of a person who is stripped of even the mind frame to raise voice for oneself.In Sibi's Bharatham (1991), we see Kalloor Gopinathan (Mohanlal) at his helpless worst upon realising that his elder brother Ramanathan (Nedumudi Venu) passed away in an accident at a faraway place and was cremated like a waif by the authorities, who were unable to track down his relatives. On the other hand, in Priyadarshan's Kilukkam (1991), we see many shades of Joji's despair that fall at various points on the spectrum, ranging from comedy to tragedy. While the sheer hopelessness in him, a tourist guide, comes across as humorous in the iconic "Vattaanalle?" scene when he realises that his customer Nandini (Revathi) is not only penniless but also struggling with her mental health, the same emotion wells up in our eyes when he portrays Joji realising that they can never be together. "Do you love her?" Nandini's foster father, Justice Pillai (Thilakan), asks him. He hums in agreement. "What about her?" With a blank face, he replies, "I have never asked her," and walks away, underscoring his circumstances — financial and otherwise which have even deprived him of the courage to confess

One of the reasons why several Mohanlal-led movies from that era, such as Kilukkam, became classics was that he could effortlessly depict such stirring emotions. If his helplessness pushed Sathyanadhan (Sadayam) to paranoia, prompting him to take the lives of both the victims and perpetrators in a scenario, it made Sidharthan (Aham) embrace sainthood. Ashokan (Yoddha) channelled it into mastering martial arts so that he could rescue the kid who had placed his faith in him. In Pavithram (1994), he portrayed the same emotion through Unnikrishnan's gradual realisation that he had slowly become irrelevant in the life of his little sister, whom he raised in the absence of their par-

From the courtroom scene in Nirnayam (1995); Aadu Thoma's reaction to his father blatantly insulting him under the pretence of inviting him to his sister's wedding in Spadikam (1995); the bootlicking scene in Kaalapani (1996); Anandan crying into a prop beard upon realising he has once again been relegated to the background in a film where he was initially offered a prominent role, and later losing balance and melting into the sofa upon hearing of Kalpana's (Aishwarya Rai) death in Iruvar (1997); Raghuraman running around a fantasy land, screaming and warning its inhabitants against eating the Ilama fruit — the cause of their collective blindness — in Guru (1997); the condemned prisoner Niranjan begging Dennis (Suresh Gopi) to marry his girlfriend Abhirami (Manju Warrier) in Summer in Bethlehem 1998); and the entire life of Kunjikuttan in Vanaprastham (1999); To Mullankolli Velayudhan explaining why he never dreams or desires anything in Naran (2005); almost every scene following Ramesan Nair's descent into Alzheimer's in Thanmathra (2005); Premachandran learning of his father's death in Rasathanthram (2006); the cynical and narcissistic Sidharthan tearing up in front of Raji (Kalpana) in Pakal Nakshatrangal (2008); Sivankutty letting go of his childhood friends — whom he had planned to kill — in Bhramaram (2009); the entirety of Mathews' character in Pranayam (2011); Raghunandan witnessing the death of Sameer (Sidharth Bharathan) in Spirit (2012); Georgekutty communicating through a blink to his family not to worry, even as he is brutally beaten by the police, in Drishyam (2013); Mathew Manjooran's tearful goodbye to his wife Neelima (Manju Warrier) in Villain (2017); and finally, Shanmugham realising that the body he helped cops George Mathan (Prakash Varma) and Benny (Binu Pappu) dispose of in Thudarum (2025) was his own son's -Mohanlal has portraved countless shades of helplessness and despair with absolute flair and dexterity. Yet not once did he fail to hit the audience square in the chest. Thanks to his uncanny ability to make viewers feel as if they are watching someone they already know well, the emotions of his characters become their own, and his intense performances consistently leave a lump in their throats. As Kerala Chief Minister Pinarayi Vijayan perfectly encapsulated during a recent event organised by the state government to felicitate the Malayalam superstar for winning the Dadasaheb Phalke Award, "The emotional experiences provided by the characters played by Mohanlal are most intricately etched into the cinematic experience of Malayalees over the last half-century. As a result, transforming into Mohanlal occasionally in daily life became even a habit for some. Few other stars have influenced Malayalees as much in their walk, sitting, gaze, and body language. This might be why British anthropologists Filippo Osella and Caroline Osella wrote that 'Mohanlal is the alter ego of Malayalees."

Scientists reverse Alzheimer's in mice using nanoparticles

Hyderabad: In a stunning scientific breakthrough, an international research team has demonstrated a novel nanotechnology strategy that effectively reverses Alzheimer's disease pathology in mice. Instead of targeting neurons directly, the therapy focuses on repairing the brain's critical defense system i.e. blood-brain barrier (BBB). The BBB is the vascular gatekeeper responsible for clearing toxic waste, like the protein amyloid-beta (AB), from the brain. In individuals with Alzheimer's, this clearance system clogs up. Researchers from IBEC (Institute of Bioengineering of Catalonia) and WCHSU, China, developed a unique 'supramolecular drugs', nanoparticles that are bioactive in their own right, not just drug carriers. The researchers in their study said that these nanoparticles act as a switch, mimicking a key clearance protein (LRP1) to reset the barrier's function. The results were immediate and dramatic. Just one hour after injection, the mice showed a 50 to 60 percent reduction in Aß in the brain. More strikingly, a mouse equivalent to a 90-year-old human, treated at an older age, showed a full recovery of healthy behavior after six months. "The long-term effect comes from restoring the brain's vasculature," explained Giuseppe Battaglia, a leader of the study. "Once the vasculature is able to function again, it starts clearing AB... allowing the whole sys-

tem to recover its balance.

Dr Reddy's, Zydus Lifesciences recall medicines from US market over quality issues



New Delhi: Two major Indian pharmaceutical companies, Dr Reddy's Laboratories and Zydus Lifesciences, are recalling certain medicines from the US market due to manufacturing issues, the US health regulator has said.

According to the latest enforcement report by the US Food and Drug Administration (USFDA), an American subsidiary of Hyderabad-based Dr Reddy's is recalling 571 vials of Succinylcholine Chloride Injection, a medicine used to relax muscles. The recall was initiated on September 26 after the USFDA reported an "out-of-specification result

during six-month stability testing."The affected batch is being withdrawn nationwide in the United States as a Class II recall, which indicates that exposure to the product may cause temporary or reversible health problems, but serious health issues are unlikely. Similarly, the US arm of Zydus Lifesciences, Zydus Pharmaceuticals (USA) Inc, is recalling over 1,500 boxes of Entecavir tablets, an antiviral medicine used mainly to treat chronic hepatitis B.

The recall, which began on September 24, involves 912 bottles of 0.5 mg tablets and 600 bottles of 1 mg tablets. The USFDA cited "failed impurity/degradation specifications" as the reason for the recall. India is home to the largest number of USFDA-compliant pharmaceutical plants outside the United States, and such recalls highlight the strict regulatory oversight maintained by the US authorities. This is not the first instance of Indian drug makers recalling medicines from the US market. Earlier, companies like Sun Pharma, Lupin, and Dr Reddy's had initiated similar recalls over product mix-ups and quality issues, ensuring patient safety remains a priority. In July this year, Sun Pharmaceutical Industries, headquartered in Mumbai, recalled 5,448 bottles of a generic drug used to treat Attention Deficit Hyperactivity Disorder (ADHD). The medicine in question was Lisdexamfetamine Dimesylate capsules, which failed to meet the required dissolution standards during testing.

They bust drug rings. They tackle cyber fraud: Meet Delhi's six women sleuths leading from the front


They were once on the margins of police investigations, confined to handling cases of crimes against women. Today, Delhi Police's women sleuths are leading from the front: busting drug syndicates, cracking down on human trafficking, and tackling financial fraud and cybercrime. Though the Delhi Police does not tick all boxes of gender equality, the growing presence of women in investigative roles reflects institutional progress and personal resilience. In their years in the force, these women have proved their mettle — whether it is questioning suspects, analysing evidence, or leading field operations — and are looking to inspire a new generation to pursue careers in law enforcement. The Indian Express speaks to six women investigators across different departments on why they joined the force and what keeps them going. Head Constable, Crime Branch, Anti-Narcotics Task Force (ANTF)It was September 2024. A Crime Branch team, including Anita, were heading to a familiar drug den - Outer Delhi's Sultanpuri.She had been with the premier anti-narcotics unit for two years

"A particular community controls the drug business in Sultanpuri... A woman, Alka, was one of the most prominent names. We had been trying to get something on her for months. And now we had," says Anita, as she recalls what in policing terms is called a 'sensational' case. The team reached Sultanpuri, and Anita and her team entered a three-floor house where Alka lived. And then, all hell broke loose. Delhi women police force Anita Wadhwa, Head Constable, Crime Branch, Anti-Narcotics Task Force (ANTF)"I was sent by the team to handcuff Alka. I hadn't even touched her when a stream of people — residents — poured out from the rooms. Some more came in from the main gate. There were about 60-80 people," Anita says. The team had anticipated this. Her instructions were clear — hold Alka and run towards the PCR van, without looking back. And that's what she did. Bricks were thrown at me. One hit my head. My whole team was surrounded... one of the head constables was being beaten up. I managed to get into the PCR van. Local police had come in, and they rescued my team members. And then, someone hit the back window of our vehicle with a brick." Anita savs

Shards from the window fell on the seat, with many tiny pieces penetrating her back and waist. "For the next 10 days, I couldn't sleep on my back or my left side. But it was nothing compared to what happened to my team members. One of them almost died," she adds. Anita describes herself as someone who has been well-trained for these situations, with her extensive experience in police stations located in the criminal underbelly of Delhi. Bespectacled in thin, pink-rimmed glasses, Anita is 5 feet 5 inches. Dressed in a blue floral salwar kameez, she could easily be mistaken for an ordinary citizen — until she slips on a red halfjacket emblazoned with Crime Branch, Delhi Police.Born in Rajasthan's Sri Ganganagar in 1980, she was the middle child among three children. The family moved to Delhi when she was two years old. "My father, Om Prakash Wadhwa, initially started a tours and travels business, which suffered losses. Then he started a small tailoring business from our home in Moti Nagar. It was a two-room accommodation. My elder brother, younger sister and I shared a room," she recalls. Anita had a strict upbringing. Her father made no distinction between boys and girls when it came to discipline. "If we were to be home at 7 pm, and it was 7.01 pm, we would wish we'd never gone out...," she recalls.Her mother, Krishna, was silent, she says. "She didn't speak much in front of my father. But she would pacify him when he grew angry." A young Anita craved independence. In the second year of her graduation at Delhi University's Janki Devi College in 1999, she did a stenography course and joined a private firm. "But I wanted more. So in 2001, I sat for the Delhi Police constable exam," she says. In 2002, the results came out. Anita, 22, was selected. Her family was happy. "They were apprehensive, but who doesn't want a government job for their child?" she quips.

Her first posting was at North Delhi's Maurice Nagar police station. In 2003, Anita married Navneet Tyagi; he now runs a battery rickshaw rental business. "We lived in the same area, and our families were well acquainted. We used to talk often. One day, he asked my father for my hand in marriage. Never asked me, though," she chuckles. The couple has two sons, aged 21 and 18 years. In 2009, Anita says, there were vacancies for the post of head constable. "But I couldn't apply. I was pregnant with my second child. But I was patient, and vacancies opened up again in 2013," she recalls. Anita cleared the test and became a head constable. In 2022, she got her dream transfer to the Crime Branch. She now awaits another promotion — to Assistant Sub-Inspector. "It's finally on the horizon," she says.

Head Constable, Crime Branch, Anti-Human Trafficking Unit (AHTU)It was January 2025. Sukanya was at her Rohini office, tracking a case — much like she had been doing for the past 12 years with the AHTU — of two missing girls. The girls, 12 and 14, both sisters, were untraceable since October 2024. "After months of surveillance, we got a lead that the girls were taken to Jalgaon. Inspector Virender, who has been my boss since I joined, asked me and Head Constable Anuj to head to Maharashtra...," says Sukanya, who goes by her first name. On January 6, she and Anuj reached Jalgaon, and arrested the accused — a



man in his late 20s, who had lured the sisters through Instagram. "It's hard when you go to another state. The locals are hostile... You don't know the language. You try to act tough where you can. But sometimes it's pure luck," says Sukanya.

Anuj and Virender Kumar have been by Sukanya's side since her early days as a constable at the AHTU. Initially confined to paperwork, she was nudged onto the field by Virender. "He always encouraged me... Eventually, I started getting more opportunities to lead investigations, she says. She recounts one of her assignments in Bihar, where she was surrounded by a couple of residents in an open field. "My team was far off. The accused's family was not letting me touch him. They would take him and start heading towards their village. I had to follow him in the wet mud, trying not to fall, and drag him back. For almost 30 minutes, I... was fending off the crowd," she says. This kind of grit, says Sukanya, was instilled in her early in life. Hailing from Ladpur village in Haryana's Jhajjhar, she was the third among four children. Her father, Phool Kanwar, was a farmer. "My father used to go to the akhada (wrestling pit) every day, and would take me with him. He trained me in wrestling for years; I represented my school and college in multiple state-level competitions," says Sukanya.

Her 5-foot-7-inch frame still carries the presence of an athlete. Dressed in an off-white salwar kameez with pink floral patterns, paired with black sneakers, she ties her black nair neatly in a bun.Growing up, sne says, the most prominent figure of authority in her village was the police. "When they arrived in their jeeps, I used to marvel at the attention they got from all the villagers. Everyone wanted to be seen with the kotwal, and let people know that they knew them. I wanted that," she says. So, when Sukanya completed her BA from Maharshi Dayanand University in Rohtak, she told her father she wanted to join the police. "He didn't ask me a single question. He just listened. And from the next day, he trained me at the akhada for my physical test. He taught me how to ride an Enfield. He prepared me in the best way he could."In 2010, Sukanya cleared the Delhi Police constable exam and was posted at the Crime Branch. The next year, she married Harish Chakara, a constable in the force. "My husband and I shifted to Kanjhawala. I became a mother in 2012," she says.

December 2015 brought Sukanya one of her first big assignments. "We were assigned a case from the DCP office — it was about a racket based in Uttar Pradesh, where girls from economically poor backgrounds were being 'sold' to older men," says Sukanya. She and her team started tracking phone numbers that were active around the areas from where some of these girls were picked up. And soon, they got a lead."I went with the raiding party to Muzaffarnagar When we entered the isolated building, we found a row of underage girls... about 15 of them. They looked pale. I was asked to take them out one by one. The way they held my hand... that's the feeling I work for," says Sukanya, her eyes gleaming. Sitting on an old couch inside the Delhi Police Headquarters on Ashoka Road, Sukanya says her colleagues have moved elsewhere. "Anuj is now in Outer North Delhi. Inspector Virendra is now the SHO at IGI Airport. My new team members are warm, but it will take time to get to know them."She says she has taken on more desk work now. "My son is 13... I have to be there for him. But I still get calls in the middle of the night from families who thank me for returning their daughter or son." Anju sits behind a hulking wooden desk, with neatly stacked files and an old HP computer, in a rectangular cabin. She is dressed in a crisp white shirt and black pleated pants. Her first-floor office, in the EOW police station in Central Delhi's Mandir Marg, resembles a lawyer's chamber.

With the setup and her attire, one could easily mistake Anju for a lawyer. She could have been one, too. "As far as I can remember, my only dream was to become a lawyer," says the Inspector. After she finished her BSc Honours from DU's Kirori Mal College, she sat for the judicial services examination. "I failed by 2 marks... I had to get a job now," says Anju. She found one at a call centre. But her mother wanted her to get a government job. In 2009, she sat for the Delhi Police constable exam and cleared it in one go. She joined the force in 2010. Her first posting was at the Shahbad Dairy police station, where she handled the rape of a young child in 2014. But she could see a change taking place when it came to women in the force. "Women head constables were either assigned rape or molestation cases or roped in as helping hands in cases where the wife or sister of an accused needed to be contained," says Anju. "But from my batch, about 85 women head constables were recruited. That was a huge number back then."

Electronics industry sees labour codes as big The future of health lies in harmony push for women's workforce participation



India's electronics manufacturing sector believes that the notification of the four long-pending labour codes — covering wages, industrial relations, social security and working conditions - will raise employee trust, reduced attrition, strengthen health and social protection, and widen women's participation. The codes will envisage better safety culture in manufacturing operations, and greater investor confidence in India's electronics system design and manufacturing (ESDM) ecosystem. The India Electronics & Semiconductor Association (IESA) said that the ESDM sector will benefit in four key ways due to the codes, centred around encouraging more women to join the sector, enhanced skill retention, improved health and safety standards and better social protections."Allowing women to work in all rolesincluding night shifts and specialised operations—with mandatory safety measures will help expand the talent pipeline in semiconductor assembly, verification labs, and 24×7 manufacturing operations. Recognition of gig and platform workers and portability of benefits is a forward-looking addition suited to India's digital and innovation-driven economy," the industry body said

"Provisions for fixed-term employment, faster dispute resolution, single licensing, and simplified compliance directly support the scaling of high-tech manufacturing clus-

ters. At the same time, parity of benefits for FTEs and expanded social security protections ensure a balanced, worker-centric ecosystem," it added. Women are a crucial demographic for electronics manufacturers. A 2024 report by Quess Corp shows women accounted for 78 per cent of the industry's workforce. They are usually hired on assembly lines for smartphone production, as operators, quality assurance professionals, and in testing roles. The India Cellular and Electronics Association (ICEA) said that the codes will also boost business productivity while ensuring better working conditions for workers. "The Codes cap maximum working hours at 8 hours per day and 48 hours per week, with overtime payable at twice the normal rate for hours beyond regular working time. This will ensure better work-life balance for employees, increase household cash flow of hard- working team members and simultaneously ensure greater business productivity," ICEA said.

Pankaj Mohindroo, Chairman, ICEA, said, "For the IT and electronics sectors, these reforms bring about stronger social security, operational clarity, and a more stable workforce environment—factors that will enhance productivity and enable long-term competitiveness. ICEA believes these changes will facilitate sustainable job creation and support India's aspiration of becoming a self-reliant manufacturing powerhouse". However, IESA flagged some potential near-term challenges, which includes companies seeing higher wage and compliance costs as benefits expand, adjustment period for MSMEs to adopt new norms, and a need for stronger HR processes and documentation practices. "The Labour Codes will significantly strengthen blue-collar jobs in electronics manufacturing by ensuring better wages, safer workplaces and expanded social security. A more formal and future-ready workforce will reduce attrition and boost productivity across India's factories. These reforms mark an important step toward building globally competitive ESDM and semiconductor ecosys-

Labour codes and MSMEs: Gains from cut in compliance obligations likely to offset any cost increase

The implementation of the four new Labour Codes, seen as the biggest revamp of India's labour laws in decades, is expected to ease the compliance burden for the country's Micro, Small, and Medium Enterprises (MSMEs), something that these smaller businesses had been calling for years. And while expanded social security net, safety mandates, and greater digitisation of human resource management dictated by the Codes could push up employee costs, industry representatives are of the view that not only would these costs pale in comparison to the reduced compliance burden, but that they would benefit the sector in the long

"For MSMEs, the new Labour Codes answer our longstanding demands to ease compliance issues," said India SME Forum President Vinod Kumar. According to Kumar, with compliance becoming structurally simpler and more uniform and wage, social security, and safety obligations becoming stronger and more enforceable, well-run MSMEs that already follow most core laws will get a level playing field and less regulatory ambiguity. Further, while highly informal units will face a sharp adjustment with higher unit labour costs, they will also benefit from potentially lower legal and reputational risk over time. The Parliament had cleared the Code on Wages in 2019 and the other three codes on industrial relations, social security, and occupational safety, health, and working conditions in 2020. The four codes will replace 29 Central labour laws and are aimed at widening the social security net for all workers, including those who work for companies such as Zomato, Swiggy, and Amazon, among others, as the codes define gig and platform work and aggregators for the first time.

In addition to Aadhaar-linked Universal Account Numbers making welfare benefits easily accessible and available across states, regardless of migration, the codes will also define a National Floor Wage and mandate timely wage payments. The government is likely to pre-publish draft rules for the labour codes within a week, after which it will provide 45 days for public comments. Some of the provisions of the codes that relate to the industry may come into effect from April 1, 2026. Some MSME sector insiders and representatives feel that payroll costs are set to rise on account of the broader and better-defined social security net, guaranteed minimum wages, specified working hours, double overtime pay, and paid leave. According to Association of Indian Entrepreneurs (AIE) - which acknowledged the Codes are a major reform - the likely increase in operational costs for MSMEs is a concern and more clarity, transitional support, and flexible implementation mechanisms from the government is needed. These costs come at a time when MSMEs are already battling high inflation, rising capital costs, and market uncertainties," the AIE said in a statement on Saturday. "The complexities of these rules may not be manageable for micro and small units who lack dedicated HR or legal teams," said AIE National Chairman KE Raghunathan. The AIE emphasised that MSMEs "must not be overwhelmed by sudden regulatory shock" and the Codes' implementation must be MSME-sensitive as otherwise, "the reforms could unintentionally slow down job creation and discourage new entrepreneurs". However, others feel the rise in costs may not be that high. According to Suchita Dutta, Executive Director of Indian Staffing Federation, while there might be a 5-7 per cent increase in costs in the short-term, the long-term benefits from reduced compliance will be far more

"Today, the underhand deals on the compliance front - you won't even be able to estimate how many millions (of rupees) are flowing out of such companies just to show themselves as compliant," Dutta said. "Compliance is a big headache. It may be an indirect cost for many; only for a handful it shows as a direct cost. But the court cases, legal notices, delays, penalties that have to be paid – these run into multiples of crores." The good part is that licenses have been reduced. The amount of ease that will come because of that and the compliance burdens that will reduce, that will offset the increase in the visible cost. The costs of noncompliance are at least 5x more than what you're going to be paying right now (under new labour codes). If you are non-compliant on ESIC or you are not giving minimum wages and have more than 20 people, or you are doing casual employment, it won't go unchecked for a long time," Dutta added. According to the government, provisions relating to contract labour will now apply to contractors employing more than 50 workers, up from 20 before. As such, a contractor employing less than 50 contract staff will not require a license. This, the government said in a statement on Saturday, will free small contractors "from excessive regulation" and encourage small business growth.

The long-term benefits also include greater formalisation for a sector that employs the highest number



of Indians after agriculture, with improved social security and paid leave, among other changes, having the potential to mitigate the high-attrition rate MSMEs usually grapple with. According to India SME Forum's Kumar, mandatory appointment letters and clear rules on timely payment of wages are expected to push MSMEs to move workers onto proper rolls, maintain clean muster and payroll records, and upgrade payroll software. "Thresholds and rules around contract labour, retrenchment, and fixed-term renewal are now more clearly defined, which can reduce future disputes and enables MSMEs to formalise arrangements that were earlier informal or semi-compliant," Kumar added. Dutta of Indian Staffing Federation also noted that the implementation of the labour codes should be seen in conjunction with the Pradhan Mantri Viksit Bharat Rozgar Yojana (PMVBRY), launched by Prime Minister Narendra Modi in his Independence Day speech."PMVBRY is saying EPFO will offer support if social security is a burden. If that support comes every six months, companies now have the motivation to do formal employment. That, in conjunction with the labour codes, is a positive move and it cannot be done in a highly staggered way; both of them coming together makes sense. This is where we need to educate people that the CTC (cost to company of employees) rising will not have an impact,"

The consolidation of 29 central laws into the four Labour Codes, common definitions such as for 'wages', and digital filings, as per India SME Forum, will reduce fragmentation, duplication, and interpretational disputes for small businesses operating in several states. Further, the provision for single or fewer registrations and returns, standardised formats, and an 'inspector-cum-facilitator' approach should lower transaction costs while making it easier for MSMEs to understand requirements.

Britain's Daily Mail publisher in talks to buy Telegraph

London: The publisher of Britain's Daily Mail has entered exclusive talks to buy Telegraph Media Group in a deal that would link two news groups that have traditionally supported the right-leaning Conservative Party Daily Mail and General Trust plc (DMGT) said on Saturday that the talks were designed to finalise the terms of a 500 millionpound (USD 654-million) deal to buy the Telegraph from an Abu Dhabi-backed venture known as Redbird IMI.

The proposed transaction comes after concerns about foreign ownership of British news organisations stalled Redbird IMI's efforts to take control of the Daily Telegraph and its sister Sunday publication two years ago. Culture Secretary Lisa Nandy said she would review any new acquisition to ensure it protects the public interest and complies with legislation governing "foreign state influence" in media mergers. "Under ownership, the Daily Telegraph will become a global brand, just as the Daily Mail has," Chairman Jonathan Harmsworth, also known as Lord Rothermere, said in a statement.

The battle over ownership of the Telegraph, a fixture on Britain's media landscape since 1855, began in 2023, when the Barclay family lost control of the company in a dispute with its lenders. In November of that year, a venture between New York-based RedBird Capital and Abu Dhabi's International Media Investments said it had agreed to acquire the Telegraph in exchange for loans that would allow Barclays to repay their debts to Lloyds Banking Group.But that deal triggered a debate in the House of Commons about the dangers of foreign influence over Britain's news media and by extension the national political debate. The previous government, led by Conservative Prime Minister Rishi Sunak, quickly announced plans to review the proposed

It demands an ecosystem of balance — between mind and body, human and environment, science and spirit. It is a fact that India has emerged as a hub of innovative research and development initiatives, transforming the global traditional medicine sector. To support this transformation, WHO's Global Traditional Medicine Centre (GTMC) serves as a knowledge hub for evidence-based collaboration and innovation. With its strategic focus on evidence and learning, data and analytics, sustainability and equity, the GTMC aims to optimise the contribution of traditional medicine to global health and sustainable development. It also upholds a guiding principle often overlooked in the age of globalisation — a respect for local heritages, resources, and rights.

Established in Jamnagar, Gujarat, with the foundational support of the Government of India, the GTMC is an expression of shared global leadership. It reflects WHO's vision that harnessing the potential of traditional medicine, when grounded in evidence, innovation, and sustainability can be a game-changer for health. India's commitment to this vision stems from the belief that knowledge must serve humanity collectively. The establishment of the Centre in India is a testament to this spirit. Under the Prime Minister's emphasis on evidence-based research in the field, there have been initiatives such as a dedicated AYUSH department at the Bureau of Indian Standards (BIS), development of global standards in AYUSH Systems through ISO/TC 249/SC 2 subcommittee, paving the way for wider global acceptance of India's traditional medicine. The growing recognition of traditional medicine as a scientific and social asset took a decisive step in August 2023, when the first WHO Global Summit on Traditional Medicine was held in Gandhinagar, Gujarat, alongside the G-20 Health Ministerial Meeting. Thus, WHO and the Government of India have signed a Memorandum of Understanding to co-host the Second WHO Global Summit on Traditional Medicine (New Delhi, December 17-19, 2025), marking a new chapter in global collaboration for health and sustainability. With its theme, "Restoring balance: The science and practice of health and well-being", it will mobilise multi-stakeholder action in support of WHO's new 10-year Global Traditional Medicine Strategy (2025-34), adopted at the 78th World Health Assembly earlier this year. These initiatives are designed not only to celebrate traditional medicine's heritage but also to propel it into the future — where it stands validated by science, empowered by technology, and guided by ethics. As the birthplace of Ayurveda, Yoga, Unani, Siddha and Sowa-Rigpa, India's contribution lies in demonstrating how traditional knowledge can coexist with modern science. Its approach is rooted in integration — uniting tradition with technology, research with community participation, and well-being with sustainability. As the world gathers once again under a shared commitment to restore balance, India's message is simple yet profound: health must heal, not harm; progress must sustain, not consume; and science must serve, not separate. The summit is more than an event — it is a global convergence to reaffirm that the future of health lies in harmony. Six of a family critical after consuming food cooked with acid in Bengal

Kolkata: Six members of a family, including two children, are in critical condition after accidentally consuming food cooked with acid in Ghatal, West Midnapore district, police said on Monday. They are undergoing treatment at SSKM Hospital in Kolkata. Two of them are children. The incident took place in Ghatal of the West Midnapore district on Sunday. The police said that Panchanan Mandal, the health officer of Ghatal Panchayat Samiti, rushed to the spot on receiving the information.Local police and administration officials also went to the area to investigate how this incident took place.

Preliminary investigation suggests that the incident happened after a meal was prepared using acid mistakenly assumed to be water. However, the police are also investigating whether it was a deliberate attempt to spike the food with acid in a bid to wipe out the entire family. "Six members of a family fell seriously ill after consuming food. It is believed that acid was used instead of water to make the food. All of them, including two children, have been transferred to SSKM Hospital in Kolkata for treatment. Their condition is



critical. An investigation has started," said a senior officer of West Midnapore district police. According to local

Stuart Broad on his viral moment in the commentary box in the 1st Ashes Test: 'Close my eyes and just pray that it wasn't actually happening'

Coming out of the 1st Test at Perth, the Ashes found its first noteworthy viral moment from the commentary box where former England pacer Stuart Broad had closed his eyes as the Three Lions kept losing wickets against Australia. Broad had an expression of disbelief and closed his eyes and prayed that the England collapse turned out to be a bad dream. "It's what Test cricket does. It sort of brings all your emotions out and it was that period of commentary where we lost 4 in the blink of an eye. And when Rooty chopped on, it was just a natural reaction for me was to close my eyes and just pray that it wasn't actually happen-

ing. If I close them, maybe it wasn't actually happening. Can we just soak up a little bit of pressure somehow," Broad opened up on Sky Cricket about the moment after England were thrashed by the hosts by 8 wickets.

"I have been there loads of time before in Australia, we all would have been where they just opened that door slightly and then when you talk about you are not just playing against the Australian cricket team, you are playing against Australia, it's that moment where that comes in because suddenly the crowd was erupting, everyone celebrating with their mates in the crowd and you just see Jamie Smith walking out to bat and you think, you have never been in this situation like this before. You have never felt what's going on. And credit to Australia, they were absolutely superb. But England just opened that door," he added. England were absolutely savaged by critics when they failed to take advantage of a 40-run lead after Australia had been skittled out for 132, chasing the 172-run 1st innings target set by Ben Stokes and Co. Hoping to build on that lead, the England batting combusted in the second innings and they were wiped out by Mitchell Starc, Brendan Doggett and Scott Boland, managing to score just 164, giving their bowlers 205 runs to defend. Travis Head slammed a brutal 123 while Marnus Labuschagne chipped in with a half century as Australia easily chased down the target in just the second day, taking a 1-0 lead in the series.

Why Mark Wood wanted to drive from Perth to Brisbane after 1st Test loss

England pacer Mark Wood considered driving all the way from Perth to Brisbane, a distance that could easily have been 4000km, after England lost the first Ashes Test at the Optus Stadium within two days. Wood, who is a nervous flyer, suddenly found himself with three extra days after the early end of the 1st Test. The Englishman explored the option of making the drive but was talked out of it as quickly as the thought appeared.

"If I could drive across the country, I would," said the 35-year-old, speaking to former teammate Stuart Broad on the For The Love Of Cricket podcast. "I did speak to a local who said if you go across the country, that's a big danger. So you'd have to drive around the coast. But I did look at it," said Wood. Wood spoke about the loss suffered by England in the first Test and said that while the result didn't go his country's way, they did a few things right and the result shouldn't take away from their overall performance. England were quick to dismiss Australia in the first innings but fell to a rapid Travis Head century in the second innings.

"I feel we know this is one of five [Tests]. There has to be a reflection of what has gone on but also to know that we did some good things and we take those into the next game. We have been hit hard in round one but we have more



rounds to throw some back."Wood also made it clear that he believed in the England bowling unit's ability to make this a competitive Ashes tour. The English picked up Australia's batting in the first innings but Travis Head's quickfire century in the second innings turned the game around for the hosts. "I definitely feel this team has 20 wickets in it — the makeup of the team has been designed to take 20 wickets in these conditions," Wood said. "As a bowling group, we can take a lot of confidence from that game and it being a day-night Test in Brisbane, we know around night time we can zip it around. And if we zip around at pace, that can make it difficult.

'Panic is not the answer': Greg Chappell offers advice to England after 8-wicket loss to Australia in 2025-26 Ashes Test at Perth

Former Australian captain Greg Chappell has urged England not to panic and remain calm, following a thumping eight-wicket loss in the 2025-26 Ashes series opener at Perth on Saturday. The 77-year-old said that the visitors needed to sit down and discuss what had gone wrong, with Ben Stokes and Brendon McCullum taking charge of plotting a comeback in the series. Chappell reiterated that Stokes and his men needed to shut out the outside noise and prevent themselves from making wrong calls before the next match.

"Panic is not the answer. Cold, calm discussion must take place, grounded in the unvarnished truth of the situation. McCullum and Stokes hold the leadership keys because they alone know the full extent of the structural damage, the vulnerabilities, and crucially, which areas of the edifice remain sound. The structure is sound enough to escape. But England must not listen to the shouts; they must learn the lessons. Only then can they hope to get back on the course, lest the race be over before the end of the first straight.""They know that listening to the shouting outside will only lead them down a blind alley, or worse, cause them to add insult to injury by making the wrong decision," he wrote in his column The former right-handed batter felt that England had got their bowling lengths wrong at Perth and perhaps got a bit carried away by assuming there would be trampoline-like bounce at the venue. "The most critical tactical error was the length they bowled in both innings. It is a mistake many touring teams have fallen for at the WACA and now at the new Optus Stadium. England's bowlers, perhaps seduced by the bounce, bowled too short



too often". "England must prepare for the home attack Starc, Scott Boland and Brendan Doggett - to pitch it up relentlessly. The English bowlers must reciprocate. This is no time for tentative half-measures: the mantra for the bowling unit must be: if in doubt, pitch it up," he added. Chappell felt that, despite the loss in Perth, the visitors had positives to take out of the match, adding that they were blown away by excellent individual performances from Mitchell Starc and Travis Head and a better tactically aware skipper in Steve Smith. "For all the talk of a humbling loss, the truth is that England had many positives from the match and were, arguably, in a winning position more than once. Australia won because they were superior in three critical areas and had a more robust plan for the specific conditions in Perth: they had the best bowler in Mitchell Starc, the best batter in Travis Head, and the more tactically acute captain in Steven

'Ones that drink too much & carry on like pork chops': Darren Lehmann slams England for constant 'sandpapergate' jibe at Steve Smith

Former Australian batter and coach Darren Lehmann has slammed England for constantly reminding them of the "sandpapergate" incident involving batting talisman Steve Smith, saying that their behaviour felt like they had never done anything wrong in life. Lehmann was the coach of the Australian side when the incident took place in 2018 during a Test match against South Africa in Cape Town. Smith was banned for 12 months for his involvement in the

"The abuse you get is daily. It is unbelievable. He [Smith] is playing every day. It would be worse for him. In England, they just don't forget. It is like they have never done anything wrong in their life. It is only the ones that drink too much and carry on like pork chops," Lehmann told ABC after the first Ashes Test. "It just borders on abuse,

but we did the wrong thing, you've got to accept it. It's not great for your mental health, to be completely honest," he added. Ahead of the first Test match at Perth, former England spinner Monty Panesar had a war of words with Smith over the "sandpapergate" incident. The 43-year-old had said that the visitors should make Smith feel "guilty" about the incident and question whether it was ethical that he got to lead Australia after his involvement in the incident.

"Say something like: 'I don't think it's ethical that he's the captain. I don't think he played the game fairly.' Really get into him and make him feel guilty about it. Make him feel like: 'They're probably right, I shouldn't be here, I shouldn't be doing this.' This is where the UK media must also focus and put pressure. Use it as a way to help England," he had told an online betting website. Smith had responded to the comments by bringing up Panesar's erroneous answers in his appearance on the "Mastermind" show."I'm going to go off topic here ... Who of you in the room has seen Mastermind, and Monty Panesar on that? Any of you?" Those of you that have will understand where I'm coming from. And those of you who haven't, do yourself a favour because it is pretty comical. Anyone that believes that Athens is in Germany ... that's a start. [That] Oliver Twist is a season of the year, and America is a city, it doesn't really bother me those comments. That's as far as I'll go with that one," Smith had said in a pre-match press conference. Panesar had responded to Smith's jibe, saying that he had made mistakes on a TV show while the Australian had erred on the cricket field. "I've had some great moments for England and I've had shockers, and he's had some great moments for Australia and he's obviously had a very big shocker in South Africa. We've both made mis-

Why Brendon McCullum is confident going into Brisbane Test after Perth loss

Stay calm, stay together... keep the faith. England head coach Brendon McCullum has asked for his players to keep their heads up and trust in the plans they have in store for the Brisbane Test, after the opening Ashes Test match in Perth ended in a loss for the English. If we're able to seize the key moments that separate the wins and the losses, then I have complete confidence that we'll be a live chance in this series," said McCullum in Perth, according to the

When you're under the bat and things haven't quite worked out, that's when your methods are tested, and that's when you've got to stay calm as a leader, you've got to keep plotting the path and the way forward, and keep the boys' eyes on the prize," he added. "We know how big this series is. We know how many eyeballs are on it, we know how disappointed all the fans will be, and we're incredibly disappointed ourselves. We're better than what we showed in the last four hours of Saturday, and we look forward to the next opportunity," said McCullum.

For some reason, he even took a DRS that didn't reprieve him.Nitish Reddy stabbed a Jansen bouncer and it went off the splice towards gully and Markram ran across from the slips to take a good catch. Ravindra Jadeja tried to pull out off another bouncer from Jansen but the ball bounded off the shoulder on to the bat, and to the slips. "Definite question marks about Indian batsmen. India don't play a Test series next year at home. They have a long time to reassess what to do at Test match level. Smriti Mandhana postpones wedding after father hospitalised in Sangli

Tuhin Mishra, the manager of Mandhana, said the World Cupwinning cricketer's father suffered the health complication early on Sunday morning. "Smriti's father, Mr. Shrinivas Mandhana was having breakfast this morning, and his health started deteriorating. We waited thinking he would recover soon, but it didn't improve. "So we thought not to take any risk and called an ambulance, and he has been taken to the hospital. He is under observation" said Mishra.

Considering her father's health condition, Mishra said, Mandhana decided to postpone her wedding till he recovers. "Smriti is very close to her father. So, she has decided to postpone the marriage, which was going to happen today, till her father is fine. "The doctor has said he (Mandhana's father) will have to be in the hospital for the time being. We are also in shock and hope that he recovers quickly because it's a big occasion for everyone" he added. "So, Smriti is very clear, she wants her father to be okay first, and later she will get married. I would request you to respect the family's privacy at this time," said Mishra. Mandhana's family doctor Dr Naman Shah said a medical team is monitoring the health condition of her father. "At around 1.30 pm, Mr Srinivas Mandhana got leftsided chest pain, we call it 'angina' in medical term. As the symptoms surfaced, his son called me, we sent ambulance, he was shifted to hospital. We found out in ECG, other reports, that cardiac enzymes are elevated, hence we need to keep him in observation," he told PTI. "Blood Pressure is also elevated, efforts are on to lower it. Dharmendra dies at 89: The 'macho' hero who broke boundaries, gave India both Sholay and Satyakam



Veteran Bollywood actor Dharmendra passed away on Monday morning in Mumbai at the age of 89, police sources at the cremation ground confirmed to The Indian Express. The veteran actor, who had worked in over 300 films over his storied career, had been ailing for a month. His last rites were conducted at the Pawan Hans crematorium. Dharmendra would have turned 90 on December 8 this year. Dharmendra was hospitalised in October for a health check-up after complaining of breathlessness. His team had shared that he was doing well and had chosen to extend his stay at the hospital so that he could undergo proper medical screening. Earlier this year, he underwent an eye graft surgery (corneal transplantation). An outsider who came from a village in Punjab and made Hindi cinema his own, acting in over 300 films which included both mainstream blockbusters and underrated gems, Dharmendra was among those few actors whose stardom was not impacted by the rise of Rajesh Khanna and Amitabh Bachchan. As he often said, he received few awards in his career but the massive love of his fans more than made up for it. He balanced Sholay — arguably the most iconic Hindi film over decades - with a Satyakam; audience will always remember his comic turn in Chupke Chupke. His career spanned decades and generations.

Dharmendra's story is the stuff dreams, and films, are made of. Born Dharmendra Deol, he was born to a school teacher in the Sahnewal village of Ludhiana district, Punjab in 1935. His film ambitions took off after he won a national talent contest organised by a film magazine. He made his debut in Hindi films in 1960 with Dil Bhi Tera Hum Bhi Tere. The film went unnoticed and it was only next year that he delivered his first success, Shola Aur Shabnam. He followed it up with Mohan Kumar's Anpadh (1962), and Bimal Roy's Bandini (1963), which won the National Award for Best Feature Film in Hindi. Dharmendra came to be known as the charming, handsome man who could deliver captivating performances on screen. Phool Aur Patthar marked his first action role, and it was his action-hero image that eventually gave him the title of the 'He-Man of

Bollywood'. Tum Haseen Mai Jawan was Hema Malini's debut film, and her pairing with Dharmendra proved to be a hit. They went on to work together in a number of films. It was during the 1970s that Dharmendra fell in love with film actor Hema Malini, even though he was already married to Prakash Kaur at the time, and was a father to four children – sons Sunny and Bobby, and daughters Ajeeta and Vijayta. His and Hema's love story was nothing less than a movie as the two were ready to go against the world to be with each other. Despite opposition from Hema's family, and amid conversations of her alliance with Jeetendra, Hema and Dharmendra got married. They later welcomed two daughters – Esha and Ahana. While Dharmendra was also married to Hema, he continued to live with his first wife Prakash and his extended family, while Hema lived close by. Towards the later part of his career, he was seen in supporting roles in films like Life in a... Metro, Johnny Gaddar, Apne, Yamla Pagla Deewana, Rocky Aur Rani Kii Prem Kahaani and Teri Baaton Mein Aisa Uljha Jiya. His film Ikkis, where he will be seen with Agastya Nanda, will release in December. Dharmendra set up his production house Vijayta Films in 1983 and launched his son Sunny Deol with the 1983 film Betaab. They also produced films like Ghayal, Barsaat, Socha Na Tha among others. The film film produced under the banner, Pal Pal Dil Ke Paas, launched his grandson Karan Deol. He won a National Award for the film Ghayal under the category, Best Popular Film Providing Wholesome Entertainment. In 2012, the veteran actor was honoured with the Padma Bhushan in 2012.

The actor contested from Bikaner in Rajasthan during the 2004 Lok Sabha elections and served the constituency till 2009. He did not return to politics after this even though his wife Hema continues to be a serving Member of Parliament and his son Sunny has also been an active politician in the past. Dharmendra is survived by sons Sunny, Bobby, daughters Ajeeta, Vijayta, Esha and Ahana, along with his first wife Prakash Kaur and second wife Hema Malini.

Dharmendra started his career in the movies in the 1960s and soon became known as the He-man of Bollywood. He also came to be known for his lively lifestyle, which also included a lot of alcoholic drinks. The actor never shied away from admitting that he loved his drinks, but he also knew that his son Sunny Deol was never comfortable with them. In fact, he also suggested that it was probably his lifestyle that made Sunny a teetotaler. In a 1983 interview, which was conducted before the release of Betaab, which marked Sunny's debut and was produced by Dharmendra, the veteran actor said that his son had learnt from his mistakes.

In a chat with Cineblitz, Dharmendra was asked about Sunny's upcoming career in the movies as the 25-year-old was about to make his debut. Dharmendra, who was also a leading man at this time, said, "He has learnt from my mistakes." And he immediately added, "Look, he doesn't smoke and he doesn't drink" as if he believed that these were his biggest mistakes. He then recalled the times when he had taken a drink in front of his sons, and how he saw a wave of hurt on Sunny's face whenever he poured himself a drink, and this made him feel guilty. "He has seen me getting drunk, and I remember how hurt he used to look. Unlike Bobby, who comes and tells me, 'Papa, don't do this, don't do that'. Sunny could never say such things to me. But the hurt look on his face when I'd pour a drink would make me feel very guilty. He has seen that drinking does a person no good," he said.



In the same chat, Dharmendra also said that Sunny would never have an affair. "Likewise, he knows that affairs never do anyone any good. They only come in the way of your work. So Sunny is going to stay away from them," he said. Three years before this interview, Dharmendra had married his long-time girlfriend Hema Malini, without divorcing his first wife Prakash Kaur. By this time, he already had a daughter named Esha with Hema. In the years prior, it was well known that Hema and Dharmendra were deeply in love with each other. Dharmendra passed away at 89 in Mumbai on Monday, November 24. He is survived by his six children – Sunny, Bobby, Ajeeta, Vijayta, Esha and Ahana; and his two wives – Prakash Kaur and Hema Malini.

When Hema Malini gave birth to daughters Esha Deol and Ahana, Dharmendra booked entire hospital to 'protect his wife'

Veteran actor Dharmendra, who passed away on November 24, was known not only for his screen presence but also for the deeply protective and affectionate bond he shared with his family, especially with his second wife, Hema Malini. A remarkable story of Dharmendra's affection towards Hema has resurfaced — the times when Bollywood's He-Man booked an entire hospital to ensure Hema's privacy when she gave birth to their daughters Esha Deol and Ahana Deol.

Dharmendra booked an entire hospital during Esha Deol's birthDuring her old appearance on The Kapil Sharma Show, Hema was asked whether the veteran actor had indeed booked the entire hospital during the delivery of Esha and Ahana. Confirming the same, she had said, "Yes, it's true, during the delivery of Esha and Ahana, he had booked the whole hospital on my name so that I don't get disturbed by fans," the actress reminisced.

Hema Malini's close friend, Neetu Kohli, had also spoken about the same during her appearance on the show Jeena Isi Ka Naam Hai. Neetu had shared that Dharmendra quietly booked all 100 rooms of the nursing home ahead of Esha Deol's birth. She had said, "No one even knew that Hema was expecting. Dharam ji quietly booked all the rooms

at the hospital just to make sure she had complete peace and privacy. It was his way of protecting his wife and their unborn child." Dharmendra and Hema kept their marriage under wraps for years as their relationship was under scrutiny, given that Dharmendra was already married to Prakash Kaur at that time and was also a father to four kids — Sunny Deol, Bobby Deol, Vijeta Deol and Ajeita Deol.

While speaking on Kapil, Hema had also shared a glimpse of her romance with Dharmendra. Hema and Dharmendra's first official collaboration was on the 1970 film Tum Haseen Main Jawaan, and that's where their romance began. Speaking about their dating days, when they would speak on the telephone for hours, she recalled how, because of their busy schedules, she would often fall asleep during the call.

She said, "During that time, I was constantly shooting throughout the night and because of which I was too tired and slept while talking to Dharamji." She added, "Pyaar Bhari Baatein, Ek Certain Time Tak Thik Lagti Hai and then you start to feel bored...Agar Dharamji Yeh Sunengey to Unhe Bahot Buraa Lagegaa."

thank you for being the strength we all need, thank you for teaching us the values of family, and thank you for always being our safe place. You are our Galaxy. Love you forever and ever."



Priyanka Chopra says ambition and achievement can coexist with a balanced life


Mumbai: Global star Priyanka Chopra feels that stories like "Born Hungry" serve as a reminder that ambition and compassion don't have to be at odds with each other in a world obsessed with speed and success. Asked whether stories like "Born Hungry" remind audiences of the human cause behind ambition and achievement? Priyanka told IANS: "I don't think they're mutually exclusive. Ambition and achievement can happen along with a balanced life and without human sacrifice. There is a balance to be found, and that's what we all need to strive for."

Priyanka reflected on the emotional weight behind Sash Simpson's journey from abandonment to accomplishment. "His life changed, and like I said, so many children's lives don't. His story deserves to be told because of what he made out of it, what he built himself, and how he



pulled himself out of, I don't know, maybe the abandonment issues that he must have had or the fear that he must have lived with. As a mother of a young child, I can't imagine... if she was out there in the world all by herself... what kind of fear she must have felt."She said she often finds herself thinking about Sash's early years.Priyanka added: "So, I always think about Sash's younger self and how dark and bleak that time in his life must have been, and how he's been able to come out of that and become the incredible success that he is."

Every time I came back to the hotel, I had to shower because I absolutely reeked I was cleaning fish every single day!"

Speaking at the Torino Film Festival, Banderas shed new light on the Matt Johnson-directed, 'Tony,' which reimagines the chef-turned-globetrotter as an aimless young man, reports variety.com."After finishing university, (Bourdain) originally wanted to become a writer,"• Banderas said. But almost immediately, he began struggling with depression and drug addiction, so the film explores the very difficult early years of his life.Banderas plays a Brazilianborn restaurateur who takes the young Tony, played by 'The Holdovers'• breakout Dominic Sessa, under his wing. "Through this relationship, Tony begins to truly learn how to cook,"• he said.

"So the film is not just about cuisine or culinary techniques; it's about his life, his identity, and his way of being" shaped by this unique mentor. "While the real Bourdain began as a dishwasher at a restaurant run by Provincetown mainstay Ciro Cozzi, Banderas" mentor is more of a composite character. He described the part as "a man from Brazil who works in the United States and has travelled the world." "My character studied at the finest institutions, graduating from the best gastronomy schools, yet he always remained an outsider," Banderas added. He created his own restaurant outside the traditional world of elite chefs, developing his own dishes with ingredients accessible to ordinary communities simple food for everyday people. placed great emphasis on mentors while in Turin to accept a lifetime achievement award. "I am a theater actor." • he said.
