### Retired banker duped of Rs 51 lakh in fake Pre-IPO scam

Hyderabad: A 60-year-old retired bank employee from Malakpet was duped of Rs 51.20 lakh after falling prey to a fake Pre-IPO investment scheme operated through social media and WhatsApp groups.According to the Cyberabad Cybercrime Police, the victim came across a Facebook post in the name of IIFL Capital in November 2025. After clicking the link, he began receiving WhatsApp messages from a man identifying himself as Goshan Yadav from IIFL Capital, who promised high returns and assured assistance in IPO allotments.He was added to a WhatsApp group titled "IIFL CS Pre-IPO 067", where members posted fabricated screenshots of profits and IPO allotments to lure investors

## Telangana High Court refuses to stay panchayat elections

Hyderabad: The Telangana High Court on Friday refused to issue stay orders over the conduct of panchayat elections in the State. Challenging the State government's GOMs 46, which provides reservations to BCs, SCs and STs within the 50 percent ceiling, a few BC organisations, including Madiwala Machadeva Rajakula Sangham and Telangana Pradesh Gangaputra Sangham filed separate petitions in the court appealing that the elections should be kept on hold.

Hearing the petitions, the High Court Bench comprising Chief Justice Aparesh Kumar Singh and Justice GM Mohiuddin refused to issue stay orders at this stage stating that the election notification was already issued. The Bench also informed the petitioners that court cannot interfere after the election notification has been issued, according to reports. The Court also asked the petitioners whether they were seeking the cancellation of elections as the sub-cat-



egories reservations were not declared by the government. However, the Court has directed the State government to file a counter on the sub category reservations within six weeks. The next hearing has been scheduled after eight weeks, reports said

## BRS demands judicial enquiry into check dam blast incident

Karimnagar: BRS has demanded that the government order a judicial enquiry into the check dam blast incident which occurred in the Manair river between Gumpula-Thanugula villages.In this regard, BRS MLAs Gangula Kamalakar and P Koushik Reddy along with other party workers submitted a representation to the district Collector Pamela Satpathy in Karimnagar on Friday.

Speaking on the occasion, Kamalakar said that the check dam was not damaged accidentally due to heavy water flow and was blasted with bombs. Local farmers also told a BRS delegation led by T Harish Rao which inspected the spot recently. Local people heard a loud blast in the night and suspected that the sand smugglers had demolished the check dam to clear the way for illegal transportation of sand. Based on a complaint lodged by irrigation Divisional Engineer (DE) and Executive Engineer (EE), police registered an FIR but no action has been taken so far. There was a possibility of sidetracking the issue. So, they gave representation to the Collector for judicial enquiry besides making public the forensic lab report.

The BRS leaders along with party working president KT Rama Rao and Harish Rao will soon meet the DGP on the issue, he informed. Besides the Kaleshwaram project, about 20 check dams were constructed by the former Chief Minister K Chandrashekhar Rao. As a result, the water table



rose significantly and subsequently the cultivation area has also been expanded. Reacting to comments that poor quality works done by the previous BRS government were the main reason for damage of the check dam, Kamalakar said that there was no truth in the allegation. "If it was true, why was it not damaged when about 1.5 lakh cusecs of water flowed through the check dam?" he questioned. The BRS government constructed 27 check dams in total. Stating that they would continue their protest till the accused were arrested, he said that if necessary, they would approach the union Home Minister to get the information about bombs used to blast the check dam.

### BRS leader Harish Rao slams CM Revanth Reddy over worm-infested rice served to schoolchildren

Hyderabad: Decrying the failure of the Congress government to provide proper food to the school children in the welfare hostels, BRS senior leader and former Minister T Harish Rao on Friday lambasted Chief Minister Revanth Reddy over worsening conditions of school kitchens in the State.Reacting to the reports that children at a government school in Kumram Bheem Asifabad district were served rice infested with worms, he accused the Congress government of failing to ensure even basic hygienic food for students despite tall claims of international standards.

He said the government which was boasting of setting up Young India International Schools with international standards must ensure that the children in government schools get rice without worms. He reminded that the Chief Minister had declared that he would personally conduct reviews and those serving substandard food to students would be sent to jail. Taking to social media platform 'X', he wanted to know how many review meetings were held so far in the last 23 months and how many people had been jailed for serving substandard food. "Your words have no value, your actions have no direction," the BRS leader charged. "What is the government doing when children are forced to take to the streets? What exactly are you doing as the Minister for



Education and as the Chief Minister?" he asked. The Siddipet MLA accused the Congress government of indulging in "cheap politics" and "scams in every sector," alleging that the administration was more focused on commissions and kickbacks than delivering governance. "What is the use of a Chief Minister who cannot even provide proper food to schoolchildren?" Harish Rao asked. Demanding immediate action from the State government, the BRS leader sought immediate response from the government on the incident of worm-infested rice being served in Kumram Bheem Asifabad district.

## R Krishnaiah demands withdrawal of GOMs 46, suspension of Panchayat polls

Hyderabad: Accusing the Congress government of deceiving the BCs, National Backward Classes JAC Chair-

man and Rajya Sabha member R Krishnaiah demanded withdrawal of GOMs 46 and suspension of Gram Panchayat elections. Under the aegis of BC organisations, a protest was staged at Gun Park in the city on Friday. Speaking on the occasion, R Krishnaiah said there were apprehensions among BC organisations over GOMs 46 as it was against the interests of BCs. The Congress government should reinstate GOMs 9 and extend reservations to the community accordingly, he demanded. "Chief Minister A Revanth Reddy should lead an all-party delegation to Prime Minister Narendra Modi to exert pressure for extending 42 percent reservations to BCs," Krishnaiah insisted.Coming down heavily on the Congress government for deceiving the BCs, the Rajya Sabha MP questioned as to why the Congress MP Rahul Gandhi or INDIA parties were not raising the issue in the Parliament."

## Jubilee Hills residents struggle as GHMC road and drainage works progress slowly

Hyderabad: These days, residents in the Jubilee Hills areas are experiencing severe disruptions in their normal life with road excavations and underground drainage works, launched days before the by-poll, advancing at a snail's pace and leaving trenches open. The civic projects have affected SBH Colony, Kamalapuri Colony, Shalivahana Nagar Colony, LIC Colony, the main stretch near Satya Sai Nigamagamam, and colonies in Yellareddyguda. The Greater Hyderabad Municipal Corporation (GHMC) began the excavation of key roads and installation of new underground drains ahead of the Jubilee Hills by-poll to improve infrastructure. The works commenced days before the by-poll and continued through the colonies of SBH, Kamalapuri, Shalivahana Nagar, LIC and on the main thoroughfare near Satya Sai Nigamagamam.

## Ponnala slams Congress' new irrigation alignment, calls land transfer policy 'biggest land loot'

Hyderabad: BRS leader and former Minister, Ponnala Lakshmaiah on Friday questioned the need for pumping of water from Tummidi Hatti to Sundilla and then to Yellampally project under the new plans of the Congress government. Addressing a news conference along with G. Deviprasad, he said the new alignment of the Pranahita-Chevalla project lacked thorough investigation. Drawing water from Tummidi Hatti to Sundilla and pumping it back to the Yellampalli project using the infrastructure of the KLIP would involve a wasteful expenditure of Rs 9,000-Rs 12,000 crore. There was no need for this new alignment as water from Yellampally is already flowing wastefully into the sea. Ponnala said that the Hyderabad Industrial lands Transfer policy" is actually not confined to Hyerabad city. It would be implemented as Telangana Industrial Land Transfer policy all over the state. It is going to emerge as the biggest land loot policy. Future City and Kodangal Lift Irrigation Scheme are unnecessary when Palamuru-Rangareddy Lift Irrigation project comes to fruition. Over 90 percent of the works on the project were already completed. He said that the plans to use satellite imagery for the implementation of Raitu Bandhu to cut direct transfers would once again give scope for corruption.G. Deviprasad stated that as the Congress government is completing two years in power and no section of society is satisfied with its performance. He claimed that all poll guarantees have been "thrown to the



wind" and credited BRS, under KCR's leadership, for effectively playing the role of principal opposition in the last two years. Deviprasad recalled that on November 29, 2009, K. Chandrashekar Rao began his historic fast-unto-death for Telangana statehood, forcing the Centre to announce the formation of the state. ### Hyderabad residents demand stricter fire safety after Shahalibanda electronics store blaze

Hyderabad: The electronic consumer goods stores in the city are tickling bombs with the management failing to take proper fire safety measures. Early this week, two people died and six others suffered injuries when fire broke out at Gomathi Electronics in Shahalibanda old city. Due to the intensity of fire, the compressors of refrigerators and air conditioners started exploding. Due to the blast, the shutter of the store ripped apart and the flying metal pieces hit the road users.

One person Sajjad Ali, a resident of Khilwat who was going on the road on his scooter died after he was hit by the metal pieces. The shop owner, Shiva Kumar Bansal, too suffered injuries and died. The air conditioners and refrigerators have compressors that are filled with gas. When the temperature increases due to the fire, the compressors explode and not only amplify the fire but the flying metal objects hit and injure or even kill any person," said a fire official. During the fire incident at Gomathi Electronics on Monday the eyewitnesses said they had heard several blasts in the shop and due to its impact the shutter of the store got ripped and its pieces fell over 20 meters away. "We are investigating the details of the fire with the assistance of the forensic experts. So far, we



suspect the compressors exploded due the fire that resulted following a short circuit," said a police official. The fire department officials maintain that they respond to a fire call and the men go and douse the fire. This apart, the fire fighters conduct awareness programs to educate people on fire safety protocols. "We don't go and inspect shops to check if they are adhering to fire safety rules. It is the GHMC or HYDRAA who have to check and issue notices to buildings," said District Fire Officer Hyderabad, T Venkanna. Local residents point out that in the past two years, fires broke out at two different electronic consumer goods stores at Shahalibanda.

### India's labour reforms with caveats

The objective behind the long-awaited labour codes no doubt laudable, as they promise minimum wages, enhanced social security and safety net for employees and easing regulations and compliance norms for employers, but several areas of concern need to be addressed vith fairness and sensitivity. Among the issues flagged by the labour unions is the freedom given to the employrs to fire employees at will and convert permanent jobs nto fixed-term contract work. The working hours in facto ies have been increased from 9 to 12 hours, and in shops and establishments from 9 to 10 hours. Trade unions will ose their relevance, as their membership base will be depleted due to workers being employed on contract. There s a strong justification for labour reforms in the country to eflect the new realities of the industry. As India aspires to become a global economic powerhouse, it needs to shed he baggage of archaic laws originally meant to protect he interests of the colonial masters. A new beginning has een made with the replacement of 29 central laws with our labour codes, covering wages, industrial relations social security and occupational safety and working conlitions. The move is being projected by the government as a historic reform that will simplify compliance, extend social security and strengthen worker protections. The ollout promises timely wages, formal appointment letters, ninimum-wage guarantees and annual health check-ups or employees. Recognition of gig and platform workers vithin the social-security architecture is perhaps the single iggest structural change, acknowledging a segment long eft outside the statutory net. While the reforms would help n improving competitiveness and productivity, the govrnment must make efforts to bring labour unions on board

Her passing has left the community in a state of disquietude. Inquiries are being posited about how an elderly, bedridden woman, beleaguered by chronic illness, could have procured petrol. Who facilitated this acquisition? Or, more disturbingly, were familial members

## Sourav Ganguly's wife Dona lodges complaint with Kolkata Police: 'Obscene, body-shaming remarks on social media'

Former India cricket captain Sourav Ganguly's wife and noted Odissi dancer Dona Ganguly has lodged a complaint with Kolkata Police, alleging that she has been subjected to obscene and body-shaming comments on social media. Dona approached the Thakurpukur police station on Wednesday night to file the complaint. The police have registered a formal case against unknown persons. She has alleged that a Facebook account has been repeatedly posting objectionable comments targeting her.

According to the complaint, a Facebook page has been continuously uploading obscene remarks about her following her performance at the Kolkata International Film Festival. Dona and her troupe had performed at the KIFF inauguration on a song composed and written by Chief Minister Mamata Banerjee. Kolkata Police said they have received the complaint and that the Cyber Cell is investigating the matter. Earlier in 2021, Dona had also alleged that a fake



Facebook profile was being operated in her name, where several photographs of Sourav Ganguly, her daughter Sana, and herself had been posted without her knowledge. She was informed about the profile by one of her students, after which she decided to take the matter seriously.

## Why has the BMC tightened the rules for erection of hoardings in city after a gap of 17 years?

The Brihanmumbai Municipal Corporation (BMC) on Thursday, November 27, announced a new set of rules pertaining to the erection and installation of advertising billboards and hoardings following the hoarding collapse incident in Ghatkopar last year. This is the first time since 2008 that the civic authorities have come up with fresh regulations in this regard. The BMC's move was prompted by an incident in May last year when 17 people were killed and 75 others sustained injuries after a hoarding collapsed in Ghatkopar. According to the findings of a structural investigation in the wake of the incident, the billboard collapsed due to heavy winds. After the incident, the BMC mooted the formation of a new hoarding policy. A draft was prepared last year and the civic authorities invited suggestions and objections from citizens and stakeholders. Following this, hearings were held and the final draft of the rules was published on Thursday.

What do the new rules state?

The new rules propose stricter measures for the setting up as well as long-term maintenance of new hoardings and billboards - a provision that has been introduced for the first time. Besides this, the new rules also encourage private parties to set up more digital signage boards instead of the existing conventional billboards. The new hoarding rules proposed by the BMC prohibit the setting of billboards on footpaths as well as on rooftops. These spaces are now very commonly used for setting up hoardings. The new rules have also made it mandatory that the size of hoardings should not exceed 40 feet by 40 feet. The policy mandates regular structural audits of all hoardings in Mumbai. Besides, the BMC has also reduced the grace period of six months to three months now. Earlier, after a license expired, a private stakeholder would get a grace period of up to six months to bring down the billboard.

Furthermore, the BMC has also drafted stricter norms for digital billboards. According to the new rules, LED signages should have a maximum luminance ratio of 3:1, which means that the billboards can only be three times brighter than their existing environment. Authorities said this limitation will ensure that the reflecting light from the hoardings does not distract motorists. The officials said earlier

there was no cap on the luminance ratio, while the average ratio maintained was between 4:1-6:1. For the first time, the civic body has also permitted a wider range of hoarding shapes, including V- and L-shaped structures and triangular, square, pentagonal and hexagonal billboards. However, these formats will require a no-objection certificate (NOC) from the Mumbai traffic police. Advertisements may also be displayed on barricades and outer surfaces of buildings that are under construction or undergoing repair work.

How will stakeholders be required to obtain permissions for setting up billboards under the new rule?

According to the policy, stakeholders will have to oblige and adhere to all the guidelines mentioned in the policy document. Following this, they will have to apply to BMC as well as the Mumbai police's traffic department for permission. Meanwhile, the latter will inspect the shape and dimensions of the hoarding or billboard following which it will issue an NOC to the stakeholder. In the meantime, the stakeholder is also supposed to submit a structural audit of the billboard structure to the BMC. After getting the permission, the stakeholders are also supposed to carry out routine audits of the structure as a precautionary measure and submit it to the authorities. For digital billboards, the stakeholders will also have to acquire a separate NOC from the traffic police so that safe luminance levels are maintained. Alongside this, for billboards erected near places with hightension wires, a specific NOC from the electrical board will be required. The authorities have also maintained that to ensure transparency, the BMC will lease out its spaces for advertisement through a tendering process.

How will violators be held accountable?

Under its new policy, the BMC has also introduced a new blacklisting policy, which would temporarily or permanently revoke the licence of stakeholders for violating or flouting the norms. The BMC has also stated that under the new policy, the stakeholders will have to pull down advertisements within three months after the license expires. The civic body has also stated that the stakeholders will have to ensure an accidental insurance cover amount ranging between Rs 5 lakh and Rs 1 crore, depending on the damage.

What is the current status of hoardings in the city today? What did the old rules state?

Presently, the city boasts 1,025 licensed hoardings, contributing a revenue of Rs 100 crore to the BMC. These hoardings operate under guidelines outlined in the BMC's 2008 document titled 'Guidelines for permitting display of advertisements and similar signs'. The guidelines, initially intended for periodic reassessment due to the city's dynamic demographic changes, were neglected by the authorities, failing to undergo any evaluation over the past decade. The BMC's earlier hoarding guidelines mandated a review every 10 years. According to this rule, the 2008 guidelines were due for revision in 2018. However, while a revised draft was prepared, its implementation was delayed due to the COVID-19 pandemic in 2020.

#### 'Does not deserve any sympathy': Chandigarh court sentences taxi driver to life for 2010 MBA student rape-murder

A Chandigarh court on Friday sentenced a taxi driver, who was found guilty of the sexual assault and murder of a 21-year-old MBA student in 2010, to life imprisonment, saying that he "does not deserve any sympathy of the court". The Special Women and Child Court had held Monu Kumar, 38, guilty under sections 302 (murder) and 376 (rape) of the Indian Penal Code on Thursday. The court of Dr Yashika, Additional District and Sessions Judge, had also imposed a fine of Rs 1 lakh on Kumar.

On Friday, Kumar was produced before the court, where his counsel, advocate Sunil Pandey, sought leniency in punishment. "He is the only support of his mother. He has been serving her, and there is no one to look after her. Also, he stated that he remained in custody since his date of arrest and facing trial of the present case without any fault, and been falsely implicated in other matters," the counsel submitted. Special Public Prosecutor (SPP) Maninder Kaur argued that the victim was brutally raped and murdered by the convict, and her parents had waited for justice for almost 15 years as the deceased was their only child. Submitting that the convict was involved in other crimes, the SPP sought that the death penalty be awarded.

The defence counsel contended that the present case does not fall in the category of the rarest of the rare, saying that it was based on circumstantial evidence and there was no direct evidence against the convict, and that he must be given a chance to reform. The court noted that there were multiple cases pending for trial against Kumar at different courts and held that a requisite sentence has to be imposed upon the convict to protect society as a legitimate response to the collective conscience. "It is an obligation on the court to the society which has reposed faith in the court of law to curtail evil," the court said. Stating that it was not the rarest of rare cases that called for capital punishment, the court added, "It is a case of its own kind where a convict was

arrested after 14 years of the incident with the efforts of police party and scientist who had examined the samples of deceased and samples of the convict."The court held that the present case is not only based on circumstantial evidence, but scientific evidence too. The blood and bodily fluid samples taken from the clothes and body of the deceased were linked to the accused through a DNA profile match, it added. Praising the police and Central Forensic Science Laboratory officials for their efforts, the court said that it "really appreciates the efforts of police party, specially Investigating Officer DSP Harditt Singh and SI Mohan Kashyap and Dr. Sunita, Assistant Director/Scientist, who have sincerely performed their duties and contributed to the society at large by collecting evidence against a person, who had remained absconded almost for 14 years after the incident". "Judge does not preside over a criminal trial merely to see that no innocent man is punished. A judge also presides to see that a guilty man does not escape. Both are public duties," the court said. "The law does not enjoin a duty on the prosecution to lead evidence of such character which is almost impossible to be led or at any rate extremely difficult to be led. The duty of the prosecution is to lead such evidence which it is capable of leading," the court added. The 21-year-old MBA student was found murdered in Chandigarh in 2010. On July 30, 2010, she had left her house to attend English-speaking classes but never returned. Her body was found later, following which she was rushed to PGI, where doctors declared her 'brought dead'. Kumar, a drug addict, was arrested in 2024 in connection with the rape and murder of another woman in Maloya in 2022. During interrogation, the police claimed, he confessed that he had committed the rape and murder of a woman in 2010 in Chandigarh. After he was sentenced to life imprisonment, Monu Kumar alleged outside the courtroom that he was falsely implicated in the case because he had an argument with the local police.

## 'Aadhaar can't be accepted as proof of date of birth': UP issues directions to all departments

Aadhaar DOB proof: The Uttar Pradesh Planning Department on November 24 directed heads of all the departments against the use of Aadhaar cards as birth proof. It has asked the departments to refer to the letter by Unique Identification Authority of India (UIDAI) dated October 31, 2025, which had clarified that "Aadhaar card is not the proof of birth". Sources said the development comes amid reports of some departments still considering "Aadhaar cards" as the proof of birth. The Planning Department is the nodal department for implementing directions related to Aadhaar.

"Deputy Director, UIDAI, Lucknow regional office, in the letter dated October 31, 2025, had informed that Aadhaar Card is not the proof of Birth. Irrespective of this, some of the departments are still using Aadhaar as proof of birth. Thus, you are requested to direct all concerned that they should not accept Aadhaar Card as the proof of Birth," read the order issued by Amit Singh Singhal, special Secretary Planning, to all the additional chief secretaries, principal secretaries and secretaries across the state. "This direction had come from UIDAI in the past as well. But now this request has been made again after it came to our notice that some of the departments were still accepting Aadhaar card as birth proof," a senior officer of the Planning Departmen told The Indian Express. Officials said that birth certificate, high-school marksheets and other prescribed documents can be used as proof for date of birth for official purposes, instead. The letter from UIDAI was issued from its Lucknow regional Office by Deputy Director Aditya Prakash Bajpai on October 31.



in which sources informed that he had pointed out that despite earlier information given in this regard on June 5 this year, it had come to their knowledge that various Departments of Uttar Pradesh Government were still accepting Aadhaar card as proof for Date of Birth. "This becomes strictly necessary to implement in the places like recruitments, admissions in educational institutions, where age is a very important cut-off criteria. Thus, Departments should take proper supportive documents for Proof of date of birth," informed an official. Uttar Pradesh Deputy Chief Minister Keshav Prasad Maurya has hailed the direction as it would help prevent the cases of fraud. "There have been instances, when people like Azam Khan got the PAN cards of his son changed to make him an MLA. So this direction gives a good message to all and should be welcomed by all," said Maurya.

### TMC workers hacked to death during kangaroo court meeting in West Bengal's Malda English Bazar

A TMC worker was hacked to death and five others were injured after a meeting of a 'salishi sabha', a kangaroo court, turned violent in West Bengal's Malda district on Thursday, police said. The incident took place at Rajnagar in the Kaliachak police station area when the meeting was underway to settle a dispute over driving a tractor across farmland, they said. The deceased was identified as Ekramul Sheikh, 45, they added. A dispute had been brewing between Ekramul and TMC booth president Samsul Sheikh for days. The two had earlier approached the police, but their families claimed no formal complaint was registered. On Tues-

day, standing maize crops were destroyed after a tractor ran across a farmland, police said. To resolve the dispute, a meeting was convened at Rajnagar Model Madrasa by a local TMC leader. During the hearing, Samsul was allegedly asked to hold his ears and perform sit-ups. Enraged by this, Samsul allegedly drew a sharp weapon and lunged at Ekramul, police said. Ekramul sustained multiple injuries, and several others standing nearby were also wounded in the attack. He was rushed to the Malda Medical College and Hospital, where doctors declared him dead, they said. Superintendent of Police Pradeep Kumar Yadav said a large police contingent was deployed at the spot immediately. Police said a total of seven people have been detained in connection with the incident.BJP's district general secretary Biswajit Roy said the violence reflected the "collapse of policing" in the state. "After the TMC came to power, there is no police administration left. Police are busy protecting TMC offices, which is why people are forced to go to meetings of such kangaroo courts. We condemn this incident," he said. TMC's district general secretary Biswajit Ghosh claimed the incident was a result of "family dispute". "Wherever something happens, the BJP tries to drag the TMC into it. This is unacceptable. Police will take necessary action," he said.

## Kejriwal demands Centre to remove 18% GST on air purifiers

Former chief minister Arvind Kejriwal on Friday demanded that the central government immediately remove 18 per cent GST imposed on air and water purifiers, in view of the worsening air quality in Delhi-NCR. In a post on X in Hindi, he stressed that clean air and clean water are the basic rights of every citizen. "In Delhi and across North India, the air has become deadly. Instead of providing solutions, the government is collecting more taxes from the public," he said in the post. He further pointed that when people go to buy air purifiers to protect their families from pollution, they find that the government is charging 18 per cent GST on them, which is outright injustice.

The AAP supremo demanded that the Centre immediately remove the GST imposed on air and water purifiers. "If you cannot provide solutions, at least stop burdening the pockets of the people," he added. The air quality is likely to remain 'very poor' over the coming week, according to the forecast by the Air Quality Early Warning System for



Delhi. With Delhi's air quality slipping into the 'very poor' and 'severe' categories this winter, doctors have stressed the need for regular diagnostic screening to detect early signs of pollution-linked health deterioration, especially among smokers, asthma patients, children and people with preexisting cardiac or respiratory conditions.

### With 12-day Durga Puja break, Bengal govt employees will have more than 150 days off in 2026

State government employees in West Bengal will have more than 150 non-working days in 2026, with an extended 12-day holiday during Durga Puja and several long festival breaks throughout the year.

According to the holiday list published by the state Finance Department, Durga Puja and Kojagari Lakshmi Puja together account for a 12-day stretch of holidays next year. Government employees have been granted leave on October 15, 16 and 17 for Chaturthi, Panchami and Sasthi. October 18, a Sunday, coincides with Maha Saptami. October 19, 20 and 21 will be holidays for Ashtami, Nabami and Dashami. October 22, 23 and 24 have been declared as additional Puja holidays. Lakshmi Puja falls on October 25, also a Sunday, while October 26 has been marked as an additional holiday for Lakshmi Puja. In effect, government employees will have nearly half of October off. In November too, employees will get more than 10 days of leave due to Kali Puja and Chhath. However, in 2026, government staff will lose six festival holidays that fall on a Sunday. These include Shivaratri (February 15), Durga Puja Saptami (October 18), Lakshmi Puja (October 25), Kali Puja (November 8), Chhath Puja and Birsa Munda's birth anniversary (November 15).

In 2026, employees will receive 27 holidays under the Negotiable Instruments Act and 26 holidays under state government orders — a total of 53 days. With 52 Saturdays and 52 Sundays in the year, the total number of nonworking days crosses 150.

## Internal bickering to the fore in Bhadrachalam Congress in the wake of GP polls

Kothagudem: Internal bickering has come to the fore in Bhadrachalam Congress once again in the wake of gram panchayat polls. #### Uddhav Thackeray slams BJP over advisory curbing use of 'Vande Mataram' in Rajya Sabha: 'Must oppose hyprocrisy'

Shiv Sena (UBT) chief Uddhav Thackeray on Friday launched a sharp attack on the BJP-led Union government after the Rajya Sabha's new bulletin advised MPs not to end their speeches with words like "thanks", "Jai Hind", or "Vande Mataram". Calling the move "hypocritical" and "a betrayal of the BJP's own sloganeering politics," Thackeray said the same party that once demanded citizens chant Vande Mataram was now objecting to it inside Parliament. "What happened to their old slogan, 'Desh me rehna hoga to Vande Mataram kehna hoga'? Now they themselves are restricting it. Their Hindutva and patriotism stand exposed as fake," he said. "My MPs Priyanka Chaturvedi and Sanjay Raut will raise the Vande Mataram slogan in the Rajya Sabha. Let me see what they do after that," Thackeray said. Moving beyond the Parliament row, he targeted the Maharashtra government over the civic polls and the alleged rampant misuse of money. He said the ongoing municipal and nagar parishad elections in the state had seen "money flowing like never before," echoing concerns carried in the party mouthpiece Saamana. "The arrogance of power is visible everywhere in their speeches and in their behaviour. Ministers are not meeting farmers, they only open bags of money where votes are needed," he alleged. 'Chaotic development' worsening pollution

On Mumbai's worsening air quality, Thackeray, in the press conference at Matoshree, accused the state government of "chaotic development" and linked the spike in pollution to decisions such as reviving the Aarey car shed project which he had scrapped during his tenure. "When I was the chief minister, I stayed the car shed at Aarey immediately. My opposition was never to the Metro but to the destruction of green cover. The trees cut in Aarey, and the zero-planning development since, have pushed pollution to dangerous levels," he said. Drawing a sharp metaphor, he added, "This is not the cloud from an Ethiopian volcano. It is the smoke of corruption erupting here," referring to the volcano that recently erupted in the East African nation,

sending plumes of volcanic ash and dust that travelled across the Red Sea and disrupted flights in India. Thackeray also raised concerns about the 2027 Nashik Kumbh Mela, alleging administrative neglect and hinting at political motives behind the delay in appointing a Guardian Minister for the district. "Next year, lakhs of devotees and sadhus will come to Nashik. Their convenience and safety is the government's responsibility. Yet, even today, Nashik has no Guardian Minister. Why?" he asked. Citing the deadly stampede during the Prayagraj Mela, he warned that any lapse could prove disastrous. "Is the reason for this delay hidden somewhere in the Kumbh Mela budget? That is the real riddle," he said. Thackeray further launched a sharp attack on the Maharashtra government over the felling of trees in Nashik's Tapovan area for the proposed Sadhugram ahead of the 2027 Kumbh Mela, calling the move "a massacre of nature wrapped in the rhetoric of Hindutva" and warning of agitation. He said that the citizens of Nashik are opposing the tree-felling and the Sena (UBT) supports their demand and would agitate if needed. He accused the state of destroying a site deeply woven into the mythological memory of Lord Ram's sojourn.

"Tapovan has been sanctified by the touch of Lord Ram and it holds dozens of tree species, medicinal plants and cultural traditions. Yet, in the name of preparing for Kumbh, they plan to axe all of it," he said, adding that the land has "witnessed more Kumbhs than all of us combined."He questioned the government's logic behind the large-scale tree felling. "Girish Mahajan says if one tree is cut, 10 will be planted. If they already have a vacant place where 10 new trees can fit, then why not build the Sadhugram there? Why destroy what already exists?" Thackeray asked. He termed the exercise "corruption carried out under the banner of Hindutva." Targeting the BJP directly, he said the party's version of Hindutva was a "sham." "They chant 'Ram Ram' in Ayodhya and do 'Muh mein Ram, bagal mein Adani' in Nashik. We cannot accept such hypocrisy and it must be opposed," Thackeray said. "Who are you destroying

Thackeray reiterated that he was not opposed to the Sadhugram itself but to the environmental destruction it could lead to. "This is not about faith, this is about contracts. First, you kill nature, then you promise to plant new trees. That's not devotion, it is actually deception," he alleged, asking why the space used for the last Kumbh Mela was not being retained this time. Claiming access to tender documents, he said the plans included a future conference hall and convention centre in the Tapovan area, suggesting that the Kumbh Mela was only a pretext. "This is a contractor-driven development agenda. The land is being cleared today to be handed over to someone tomorrow," Thackeray said, adding that the party will not let it happen.

#### Small battery retrieved from five-month-old infant's food pipe at Ahmedabad Civil Hospital

Doctors at Ahmedabad Civil Hospital retrieved a battery from the oesophagus of a five-month-old baby. They found that chemical leaching from the battery had also caused ulcers in the upper part of the child's food pipe. The child had swallowed a button cell while playing a few days ago. His parents took him to a private hospital after he continued coughing for several days. An X-ray showed that a round foreign body was stuck in his esophagus. That is when the parents recalled that the child was playing with a small button cell, and ne was taken to Anmedabad Civi Hospital.Dr Rakesh Joshi, Medical Superintendent and HOD of Pediatric Surgery, said, "If the cell had not been removed on time, there was a possibility of perforation in the esophagus due to the battery chemical, and the child's condition would have become extremely critical. The child was immediately brought to Civil from a private hospital and the team of doctors succeeded in averting this risk through



complex management and surgical procedures.'

After a successful operation, the child was discharged with necessary medicines to heal the ulcers. After 15 days, the follow-up endoscopy showed that the esophageal wall had healed completely.

#### Air pollution: Bombay HC appoints team for inspection of construction sites in Mumbai

The Bombay High Court has ordered the formation of a five-member team to inspect construction sites in one or two areas of Mumbai to check if compliance with earlier guidelines issued to curb air pollution is being followed. The team is expected to submit a report in a week, following which the court will hear the case on December 15.The court's directions came while hearing petitions on deteriorating air quality levels in the city. The court was told that despite past orders on effective steps recommended to improve air quality, there were violations. The division bench of Chief Justice Shree Chandrashekar and Justice Gautam Ankhad said that instead of giving many directions that may create confusion, small steps can be taken to suggest how air pollution can be brought within permissible limits. The court agreed that there is a need for a long-term plan which will take time, noting that Delhi has been struggling for 15 to 20 years."...a team of five members, constituting one official of the Brihanmumbai Municipal Corporation (BMC), Maharashtra Pollution Control Board (MPCB), two members of civil society and one public health official. The team shall be provided with all logistics, transport and security personnel for entry into construction sites," the bench said. The members of the team and the areas to visit will be decided and submitted later in the day to the court. Earlier during the hearing, amicus curiae Senior Advocate Darius Khambata told the court that one of the major reasons for pollution was identified to be dust from construction sites, and the court had passed detailed orders in 2023-24 on 27 guidelines that the BMC had to ensure compliance with. These included sensors at construction sites and monitoring whether steps are being taken to reduce the dust, including sprinkling water, and covering the vehicles during transportation of material. He said that, as per a newspaper report, of the 1,000 construction sites in the city, only 400 have sensor monitors, and 117 of those are not working. The court was also told by the BMC counsel that the sensors are yet to be connected to a central monitoring system. "There has to be a concerted plan and not a kneejerk reaction whenever the air quality is bad. The long-term plan will take time, but if even putting monitors mandated by the court order in 2023 is taking this long to implement, it is concerning," Khambata submitted to the court. It was dis-

cussed that while vehicular traffic is also a cause for pollu-

tion, which can be dealt with easily, the court said that it



would want to avoid causing harassment to citizens. The court was informed that committees were already in place, appointed during previous hearings, to which the bench said that it would want an independent survey on the steps being taken. It said that it would first deal with the specific area of pollution caused at construction sites. Senior Counsel Milind Sathe, who is representing the Brihanmumbai Municipal Corporation (BMC), informed the court that there are special squads in place in each ward that visit construction sites and stop-work notices have also been given in cases of violations. Senior Counsel Janak Dwarkadas, representing NGO Vanashakti, said that many of these steps are only on paper, seeking stricter compliance. He also informed the court that a committee appointed by the high court was to submit weekly reports on compliance with the guidelines, but they had not received the reports since March.

"We are thinking how to verify the facts... they are saying that they are monitoring... let us get some records, maybe ward-wise... instead of asking the BMC to file another report... we want a report from some independent source," the court said, appointing the team. The court also directed that the BMC and the public health department, in the meantime, issue a public health advisory as 'awareness for citizens to protect themselves from air pollution' and suggested distribution of masks in major public spots like railway stations and bus stops. An intervener on behalf of a consortium of developers also told the court that while the BMC has mandated installing the sensors, they are provided only 13 approved vendors, who are unable to provide

the sensors for 15,000 sites across the city.

#### HC rejects Haryana BJP MLA Gaurav Gautam's plea to dismiss poll challenge

The Punjab and Haryana High Court on Friday dismissed a plea by BJP MLA Gaurav Gautam to reject an election petition challenging his victory in the Haryana Assembly polls, ruling that the allegations of corrupt practices using religion were detailed enough to proceed to trial. In a 21-page order, Justice Archana Puri said the petition by runner-up Karan Singh Dalal, who secured 75,513 votes against Gautam's 1,09,118 in the Palwal constituency, disclosed a "substantial cause of action". The court noted that while simply mentioning words like "Sanatan" or "Hindutva" may not amount to wrongdoing, the full context, including speeches at religious events just before the October 5, 2024, polling, needed evidence to be tested. Dalal, an Independent candidate who came second with a margin of 33,605 votes, filed the petition under the Representation of the People Act, 1951, accusing Gautam of indulging in corrupt practices by appealing to voters on religious grounds during events like a Bhagwat Geeta Katha on September 12 and a Khatu Shyam Baba gathering on September 19. He sought to set aside Gautam's win and disqualify him for six years under Section 8A of the Act. The petition, supported by videos downloaded from Gautam's official Facebook, Instagram and YouTube pages, described how he attended these gatherings and "appealed for votes from the devotees present there, who were the voters of the Palwal Assembly constituency." In one instance at the Geeta Katha

in Dev Nagar, Palwal, Gautam allegedly "sought votes by referring to Sanatan dharma and Hindutva and that he was willing to do anything for his religion," promising bigger religious events in return.

Gautam's counsel, senior advocate Vijay Kumar Jindal, argued the claims were "vague and without any material facts and particulars, necessary to constitute cause of action". He said the petition failed to show how the election result was materially affected and that details like the congregation's composition or the speeches' impact were missing. Jindal also questioned the petition's verification and affidavit, urging the court to strike out the pleadings. Dalal's lawyer, senior advocate Mohan Jain, countered that the core allegations in paragraphs 6 to 11 were "clearly set up" and backed by a pen drive of videos played in court. He argued for "substantial compliance" with legal requirements, citing Supreme Court precedents like G M Siddeshwar vs Prasanna Kumar (2013), which held that election petitions should not be thrown out at the threshold if the basics are met.Justice Puri, after reviewing the law and precedents, observed: "Close perusal of the election petition reveals about the mention made about the place, where the religious gathering, as asserted, had taken place and the participation of the applicant-returned candidate. Reliance is also placed upon the videos recorded in the pen-drive, about the manner, in which the applicant had pleaded to the voters to vote for him."The judge added that the use of terms like "Sanatan" and "Hindutva" in speeches "soon before the elections" had to be appraised in context, whether the gatherings included a "cross-section of people" and if the appeals espoused "the cause of Hindu religion." She ruled: "Use of the same, can only be established in this context, in which it has been used, while leading evidence and only thereafter, it can be adjudicated, whether it amounts to corrupt practice under Section 123(3) of the RP Act."The court clarified that its observations were limited to dismissing the rejection plea and would not influence the main trial. The October 2024 Haryana Assembly elections saw Gautam declared the winner on October 8, with polling on October 5 following a schedule that included nomination scrutiny on

#### Mamkoottathil sexual assault case: BJP's Sreelekha questions complaint delay

BJP leader R Sreelekha on Friday questioned the delay in filing the sexual harrassment complaint against Palakkad MLA Rahul Mamkoottathil, while expressing her support for the survivor. Sreelekha, who is contesting the local body elections in Thiruvananthapuram on a BJP ticket, made the remarks in a Facebook post. The former Director General of Police said she has always stood with survivors and will continue to do so. "The only regret is why she could not file a complaint until now. Why was a case not registered all this time?" she wrote. She also sought to know why the complainant had to approach the Chief Minister directly."Was it to give the accused time to switch off his phone and go into hiding or secure anticipatory bail? Or to prevent more influential people involved in the Sabarimala gold theft from being arrested?" she asked. Sreelekha said there should be no delay or lapse in protecting victims."I hope other young women he allegedly harassed will also file complaints soon," she said. Later, she clarified to reporters that she raised concerns about the delay in registering the case. "The allegations were raised several months back. Police should have taken action then," she said. Meanwhile, the LDF and BJP continued to allege that the Congress and UDF had protected Mamkoottathil.

"Shafi Parambil and former KPCC president K Sudhakaran publicly supported him without he like challenging the people of Kerala and women here," Education Minister V Sivankutty said. He added that the government would proceed legally and no compromise would be made. "Apart from political issues, the morality of Congress will also be discussed in the upcoming local body election," he said. Sivankutty said Mamkoottathil should re-



sign from the Assembly for moral reasons. Asked about actor and MLA Mukesh, who also faced a sexual harassment case, he said he was unaware of the details.CPI(M) state secretary M V Govindan also said Mamkoottathil no longer deserved to continue as MLA and must resign. "The Congress must demand his resignation. There will be a thorough probe," he said. Former BJP state president K Surendran said people would not believe that Mamkoottathil is absconding"He might have received help to go into hiding. It cannot be considered a normal case," he said.Surendran alleged that the Kerala Police have details of other women who were targeted by Mamkoottathil. "But the police are not taking any action. There is a deliberate attempt to delay his arrest," he said.BJP leader C Krishnakumar said the party would launch strong protests until Mamkoottathil resigns and is arrested. "After the complaint was filed, the MLA fled. Earlier, when allegations were raised, he stayed away instead of answering them,' Krishnakumar said.

#### TMC panchayat chief shot on open road in Howrah, hospitalised along with associate

The head of Howrah's Sampuipara Basukathi gram panchayat and Trinamool Congress leader Debobrata Mondal, alias Babu Mondal, was shot on Thursday night. His associate, Anupam Rana, was also hit by a bullet. Both were rushed to a private hospital in North Howrah in critical condition, and Mondal has since been shifted to SSKM Hospital. The incident took place around 11 pm in the Sampuipara area under Liluah police station while the two were returning home on a motorbike, police said. "Babu Mondal was returning home after a small party when he was hit from very close range. They both were on a bike,"

Mondal was shot in the waist and shoulder. When Anupam tried to intervene, he was also hit before the suspect fled. Residents rushed the two to the hospital after they collapsed on the road. "They have been hospitalised. A case has been registered and all efforts are being made to arrest the accused," said Howrah Police Commissioner Praveen Tripathy. Several party leaders and workers, including Howrah District (Sadar) Trinamool President and MLA Goutam Chowdhury, MLA Kalyan Ghosh, and Domjur Youth Trinamool President Noorj Molla, visited the



hospital.MLA Kalyan Ghosh said, "It is unclear why such an incident occurred. We have asked the police to arrest the culprits immediately." Police have launched an investigation and are searching for the assailant. The shooting has triggered panic in the area, further heightening tensions in Howrah ahead of the 2026 Assembly elections. A name that has surfaced during the probe is that of Suman Choudhury, a history-sheeter previously jailed in extortion and attempted murder cases. Police sources said CCTV footage is being examined to identify and arrest the accused.

#### Delhi Police arrest conspirator behind shooting at Kapil Sharma's café in Canada

The Delhi Police Crime Branch on Friday claimed to have arrested one of the conspirators behind the firing incident at Kapil Sharma's KAP's Cafe in Canada. The accused has been identified as Bandhu Man Singh Shekhon, a close confidant of Goldy Dhillon, who had taken the responsibility for the shootings at Sharma's cafe. He was reportedly arrested from Ludhiana, and the police also recovered a Chinamade PX-3 high-end pistol and eight live cartridges from him. Dhillon alias Gurpreet Singh hails from Rajpura in Punjab and is a close member of the Lawrence Bishnoi gang in India. According to the police, Shekhon, a native of Ludhiana, had provided logistical support, including vehicle and weapons, to Dhillon's shooters who fired at the cafe. They said Shekhon was in Canada at the time of the shoot-

ing but later came back to India. "After returning to India, he was trying to rebuild the network of Goldy Dhillon's gang in Punjab to extort businessmen and carry out shootings against other rival gangs," a police officer said. Sanjeev Yadav, Deputy Commissioner of Police (Crime), told The Indian Express that the accused had bought the recovered China-made pistol for Rs 8 lakh from a Punjab-based gangster Sonu Khatri, who is currently in the United States. Yadav said Sonu is part of an international weapons trafficking module allegedly linked to ISI-backed handlers in Pakistan. Last week, 10 foreign-made semi-automatic pistols, including high-end Turkiye-manufactured PX-5.7 models used exclusively by special forces, and 92 live cartridges were seized by the Crime Branch and four key operatives of this syndicate were arrested."

#### Israeli forces kill Palestinian men in West Bank after they appear to surrender

Israeli forces on Thursday (November 27, 2025) killed a pair of Palestinian men in the occupied West Bank after they appeared to surrender to troops, drawing Palestinian accusations that the men were executed "in cold blood." The Israeli military said it was investigating. The killings, captured in videos shown on two Arab TV stations, came as Israel pressed ahead with its latest offensive in the West Bank, where the army has stepped up its activities over the past two years. Israel says it is cracking down on militants, but Palestinians and rights groups accuse Israel of using excessive force and say dozens of unarmed civilians have been killed. Israel has been fighting on a number of fronts as a shaky ceasefire in Gaza moves forward. On Thursday, Israel carried out another round of airstrikes on suspected Hezbollah sites in southern Lebanon. Ongoing conflicts in the region have fueled concerns that unrest could spill over and undermine the fragile truce in Gaza.

A Palestinian-American teenager held in Israeli detention for nine months was also released on Thursday night. The 16-year-old emerged visibly thin and was embraced by his crying family. The Israeli military and national police announced they were opening an investigation into the deaths on Thursday of the two men, who were shot by members of the border police, a special unit that often operates alongside the Israeli military. In a video shown on Palestine TV, which has no sound, the two men come out of a garage holding their hands up and lifting their shirts to show they are not carrying explosives. They are ordered to the ground and kicked by one of the policemen. They are then ordered back to the garage. In a video shown by Egyptian TV station Al-Ghad, the men are ordered back to the entrance of the garage. As they are on the ground and surrounded by troops, gunshots are heard and the men slump down, apparently lifeless. At least one soldier is seen firing his weapon. In a statement, the Israeli military said the two men were wanted militants in the northern town of Jenin who had thrown explosives and opened fire at troops. It said that after the men surrendered and exited a building, "fire was directed toward the suspects." It said was the incident was "under review" and would be referred "to the relevant professional bodies." Palestinians and human rights groups say such investigations yield few results, and Israeli troops

Israel's far-right National Security Minister Itamar Ben-Gvir, who oversees the national police, praised the Israeli forces, saying they had acted "exactly as they are expected to — terrorists must die!"In Ramallah, the Palestinian Prime Minister's office accused Israel of executing the men "in

cold blood." It called the shooting "an outright extrajudicial killing in blatant violation of international humanitarian law." Palestinian authorities identified the men as Al-Muntasir Abdullah, 26, and Yousef Asasa, 37, and said Israel had taken away their bodies. The incident was reminiscent of the case of Elor Azaria — a soldier convicted of manslaughter in 2017 for fatally shooting an already wounded Palestinian attacker. That case deeply divided the nation, with nationalistic politicians defending the soldier. Azaria was released early from prison after serving a nine-month sentence.

The shooting is part of a larger operation in a northeastern region of the West Bank. Israel's military has detained more than 100 people since Tuesday (November 25, 2025) in the town of Tubas, according to Abdullah al-Zaghari, spokesman for the advocacy group Palestinian Prisoners' Club. The military has said the operation was a response to "attempts to establish terrorist strongholds and construction of terror infrastructures in the area." On Nov. 19. Palestinian attackers stabbed an Israeli to death and wounded three more at a West Bank intersection before being shot down by troops. Israel's military has scaled up military operations in the West Bank since the Oct. 7, 2023 Hamas attack, which triggered the war in Gaza. The latest operation comes amid a rising tide of Israeli settler violence in the West Bank, Israeli leaders have played down the settler attacks as the work of a small minority. But Palestinians say the attacks are frequent, often in close proximity to Israeli troops, and the settlers are rarely punished.

Israel's air force carried out another series of strikes in parts of southern Lebanon on Thursday. Israel says its ongoing strikes are aimed at preventing Hezbollah from rebuilding after a devastating war last year. But the United Nations on Tuesday said Israel had killed at least 127 civilians, including children, in its strikes on Lebanon since the ceasefire came into effect one year ago. Things escalated earlier this week with a rare strike in Lebanon's capital of Beirut, killing Hezbollah's chief of staff. On Thursday, Lebanese Prime Minister Nawaf Salam criticized Hezbollah for not disarming in a rare rebuke of the group, saying the Iranbacked militants have failed to deter Israeli airstrikes, protect the Lebanese people or even safeguard the lives of its own leaders. Pope Leo XIV is scheduled to visit the country on Sunday (November 30, 2025), when he will meet the crisis-hit nation's political and religious leaders. Mohammed Ibrahim, an American teenager held in Israeli custody for nine months, was released on Thursday evening and immediately checked into a hospital, his uncle told the AP. Visibly thin, head shaven and still in a grey jumpsuit, Ibrahim wiped tears away as he was embraced by family members shortly after his release in videos taken by the

His father, Zaher Ibrahim, kissed his son and began to cry. "He's skinny and pale, his eyes are sunken in and he still has signs of scabies," said Zeyad Kadur, the uncle. The teen was visiting family in the West Bank with his parents when he was arrested at his family's home at night for allegedly throwing rocks at Israeli settlers in the West Bank, according to the Council on American-Islamic Relations and several members of Congress. In an affidavit, Mohammed said he only confessed to stone-throwing after he was threatened by interrogators with a beating.

## Sons of Virginia Giuffre, who accused Andrew and Epstein of abuse, seek control of her estate

Melbourne: Lawyers for two sons of Virginia Giuffre, her housekeeper and her former attorney appeared in an Australian court Friday in a case deciding who controls her estate. Giuffre was the highest-profile accuser of sex offender Jeffrey Epstein and she settled a lawsuit for an undisclosed sum in 2022 against then- Prince Andrew, now known as Andrew Mountbatten-Windsor after he was stripped of his royal titles over his association with Epstein She died by suicide in April at the age of 41 at her farm in Western Australia state without leaving a will.

The only adults of her three children — Christian Giuffre, 19, and Noah Giuffre, 18, — filed a case in the state Supreme Court in June to gain control of their mother's estate including property in Western Australia, where she had lived for years, and potential revenue from her memoir "Nobody's Girl." The memoir, released last month, expands on her claims that she was sexually trafficked as a teen by the late financier to billionaires, politicians and King Charles Ill's brother. Mountbatten-Windsor categorically rejected the allegations and said he didn't recall having met her. The brothers want the court to appoint them administrators of their mother's estate. The brother's application is opposed by Virginia Giuffre's former housekeeper and caregiver Cheryl Myers and her former Perth-based attorney, Karrie Louden. The women want to be made administrators.

A temporary administrator was appointed this week



to manage the estate. The first court hearing in the case was held Friday and another will be scheduled next year. Lawyers on Friday discussed a range of issues, including whether Virginia Giuffre's daughter, who cannot be named for legal reasons, and her estranged husband Robert Giuffre should become parties in the case. Virginia Giuffre separated from her husband and children this year. She had been charged with breaching a family violence restraining order over an incident in February, and died before she was to appear in court over the matter.

## WHO issues unprecedented global guidelines to combat infertility

The World Health Organisation (WHO) on Friday published for the first time directives to improve the prevention, detection and treatment of infertility, which affects millions across the globe. "One in six people worldwide experience infertility during their lifetime," said Pascale Allotey, the global health body's head of sexual and reproductive health.

"The condition affects individuals and couples across all regions yet access to safe and affordable care remains highly inequitable", said Ms. Allotey. The new guide would provide a "unified, evidence-based foundation" to ensure care is safe, effective and accessible for all, she added.

According to the WHO, infertility is a condition of the male and female reproductive system, defined as the inability to achieve pregnancy after 12 months or more of regular unprotected sexual relations. The situation can lead to major distress, stigmatisation and financial difficulties. In several countries, most of the cost of infertility tests and treatment is borne by patients, which often leads to "catastrophic financial expenditures". "In some settings, even a single round of In Vitro Fertilisation (IVF) can cost double the average annual household income," the WHO noted.

The guide sets out 40 recommendations and calls for the integration of fertility in national health funding, services and strategies. It also wants to see steps for effective clini-

cal management, in both diagnosis and treatment. For example, the WHO calls for male diagnoses, which are often under-investigated, suggesting a range of approaches, starting with advice before moving to active treatment. It also advises increased investment in prevention. Health professionals need to address the main risk factors for infertility, which include untreated sexually transmitted infections and smoking, the global health body noted.

#### Hong Kong apartment tower blaze kills 128

Hong Kong: Hong Kong firefighters searched through a high-rise tower complex apartment-by-apartment Friday for more victims after a massive fire engulfed seven of its eight buildings, killing at least 128 people in one of the city's deadliest blazes. Crews were prioritising apartments from which they received more than two dozen calls for assistance during the blaze, but were unable to reach, Derek Armstrong Chan, a deputy director of Hong Kong Fire Services, told reporters. The toll rose Friday afternoon to 128 after more bodies were found in the blackened towers, and Secretary for Security Chris Tang told reporters at the scene that the search for victims was continuing and the numbers could still rise.

The fire started midafternoon Wednesday in one of the Wang Fuk Court complex's eight towers, jumping rapidly from one to the next as bamboo scaffolding covered in netting in place for renovations caught ablaze until seven buildings were engulfed. It took more than 1,000 firefighters, some 24 hours to bring the blaze under control, and even nearly two days later, smoke continued to drift out of the charred skeletons of the buildings from the occasional flare-up. The final search of the buildings was expected to be completed later Friday, at which point officials have said they will officially end the rescue phase of their operation at the complex in Tai Po district, a northern suburb near Hong Kong's border with mainland China. It was unclear how many people

could possibly be inside the buildings, which had almost 2,000 apartments and some 4,800 residents. "We will endeavour to force entry into all the units of the seven blocks concerned so as to ensure that there are no other possible casualties," Chan said. He said an updated figure on the number of missing people cannot be calculated until the search and rescue operation is complete.

The apartments from which a total of 25 unanswered rescue calls were received, which are being prioritised, were primarily on higher floors, where the fire was last to be extinguished, he said. More than 70 people were injured in the blaze, including 11 firefighters, and about 900 people were housed in temporary shelters. Most of the casualties were in the first two buildings to catch fire, Chan said. The apartment complex housed many older people. It was built in the 1980s and had been undergoing a major renovation. Hong Kong's anti-corruption agency said on Thursday it was investigating possible corruption relating to the renovation project. Three men, the directors and an engineering consultant of a construction company, have been arrested on suspicion of manslaughter, and police said company leaders were suspected of gross negligence. Police have not identified the company where the suspects worked, but The Associated Press confirmed Prestige Construction & Engineering Company was in charge of renovations in the tower complex. Police have seized boxes of documents from the company, where phones rang unanswered Thursday. Authorities suspected that some materials on the exterior walls of the high-rise buildings did not meet fire resistance standards, allowing the unusually fast spread of the fire. Police also said they found plastic foam panels which are highly flammable — attached to the windows on each floor near the elevator lobby of the one unaffected tower. The panels were believed to have been installed by the construction company, but the purpose was not clear. Authorities planned immediate inspections of housing estates undergoing major renovations to ensure scaffolding and construction materials meet safety standards. The fire was the deadliest in Hong Kong in decades. A 1996 fire in a commercial building in Kowloon killed 41 people. A warehouse fire in 1948 killed 176 people, according to the South China Morning Post.

#### India on high alert as Imran Khan rumours push Pakistan towards chaos

New Delhi: Indian Intelligence agencies have alerted the security forces to remain in a state of very high alert in the wake of the developments unfolding in Pakistan. Trouble is brewing in Pakistan in the wake of rumours relating to the death of former Prime Minister, Imran Khan. Huge crowds are mobilising outside the Adiala Jail in Rawalpindi, where Khan is lodged. Thousands of PTI supporters have gathered outside the jail demanding that they meet with their leader. The Pakistan Army, however has refused permission for a meeting with Khan, while also dismissing rumours about his death.

Intelligence Bureau officials say that rumours relating to the death of Khan began to circulate three days back. Since then there has been a massive build up of his supporters. If the Army does not provide proof that Khan's supporters have been seeking, then violence is bound to engulf Pakistan. An official said that violence is imminent in Pakistan given the current situation. For India, the spillover is the concern and trouble in the neighbourhood is never a good sign for national security. An Intelligence Bureau official said that the ISI is already planning a series of major attacks in India, so that attention is diverted.

Khan remains a very popular figure in Pakistan and if news about his death is true, then the country would witness violence of a very unprecedented nature. It would be beyond the control of the security forces in Pakistan to control the people and eventually the country could face a civil war like situation. The Army wants to keep Imran Khan down and all issues relating to him under wraps. However, it may

not be able to sustain this for long as the people are getting anxious and are seeking answers. The ratings of the establishment in Pakistan, especially with Field Marshal Asim Munir at the helm has hit an all time low.

An official said that the people are being stopped by force and the Army does realise that a majority of the population wants the current dispensation out. Pakistan watchers say that the people are particularly upset that the Army engineered a coup to take Khan out of power and install a dummy government under Shehbaz Sharif. There is no respect for a democratically-elected process and the people have being voicing their disgruntlement against this, experts add.Indian officials say that the rumours relating to Khan's death was something that the establishment did not expect. This has put the Army on the back foot. If one looks at the build up of supporters, it is massive and the Army would not be able to contain them by using force. Officials say that the Pakistan Army would look to buy time so that it would be able to handle the situation. In order to buy time, the Army and ISI would plot attacks in India so that this would act as a diversion for sometime. The chatter that has been picked up suggests a sense of urgency to carry out a spectacular strike in India.

The ISI is not planning some small attack. It wants one on the scale of a Mumbai 26/11 or Pulwama so that the attention and focus of the Pakistan people is completely diverted, another official said. Intelligence agencies have alerted security officials to keep a watch particularly on the eastern border. There is a lot of ISI related activity that is on in Bangladesh. Several modules have come up in collaboration between the Lashkar-e-Tayiba and Harkat-ul-Jihadi-Islami (HuJI) with the sole intention of carrying out attacks in India. Pakistan is also planning to fly in Hafiz Saeed to Bangladesh so that he could give the members of this module a pep talks. Officials say that Saeed is always roped in to give the terrorists of his modules a pep talk just before a major attack is launched. This was found to be the case prior to the Mumbai 26/11 attacks. Officials say that given the current situation in Pakistan, the ISI is desperate to create a diversion. With the borders with Jammu and Kashmir and Puniab becoming harder to operate, the focus is on the modules of Bangladesh to carry out a major attack in India, officials add. Officials also add that such a diversion would give the Pakistan Army time to handle the situation relating to Imran Khan, which in turn would calm the people.

## Cyclone Ditwah: Tamil Nadu government seeks additional NDRF teams, support from armed forces

Tamil Nadu Chief Minister M.K. Stalin, on Friday (November 28, 2025), said that the State is prepared to face cyclonic storm Ditwah, as south Tamil Nadu and the Cauvery delta region brace for heavy rains. The State government has sought additional NDRF teams and contingency support from the armed forces. ## Automation in Ahmedabad construction sector has reduced women's participation by nearly 80%: Study



"As a woman, you should not touch machines," Deeptiben (name changed), a 30-year-old worker from Dahod, described how she was denied opportunities to learn at a large construction site. Sugunaben (name changed), another 35-year-old migrant worker with over 15 years of experience in masonry assistance, said she has been told repeatedly how they (women) are only meant to be a helper. Other women workers shared: "While we work, we have to take a ghunghat (veil), otherwise people will say we do not have sharam (shame) ... our husbands say that we won't be able to learn so it is better to work together".

Such rebukes echoed across construction sites reflecting the gender bias that bars women from skill development and upward mobility, according to the Aajeevika Bureau-Work Fair and Free (WFF) research report titled 'Building Futures: Women Workers at the Margins of Construction Automation, The Case of Ahmedabad, Gujarat' released on Tuesday. Aajeevika Bureau is a public service organisation working on the rights and well being of migrant workers and Work Fair and Free (WFF) is the knowledge institution conceived and incubated by the bureau. Authored by Geeta Thatra and Saloni Mundra, the report said that automation has reduced women's participation by nearly 80 per cent in tasks such as material handling and concrete production. Highlighting how automation and industrialisation of construction are reshaping the labour processes and deepening the exclusion of women workers in the city's booming industry, the report states that in high-rise buildings and precast projects, contractors increasingly recruit migrant men workers, marginalising Bhil Adivasis and women workers who have historically sustained Ahmedabad's construction industry. "Automation and industrialisation are leading to greater outsourcing of construction activities, with contractors bringing their trained men workers. Bhil Adivasis and women workers are the worst affected with the shift to long-distance male migrants,' said Saloni Mundra, executive at Aajeevika Bureau.

The study, conducted between December 2023 and February 2025 in Ahmedabad and Gandhinagar, adopted a Feminist Participatory Action Research (FPAR) methodology to foreground the experiences of migrant women workers. Four projects – two residential, one commercial, and one government-funded infrastructure project ranging from Rs 100–500 crore – were studied to analyse automa-

tion across project types and stages alongside off-site construction - two autoclaved aerated concrete (AAC) block factories, a precast concrete factory, and a precast yard. The sites were selected based on accessibility and to capture variations in project type and scale. Research participants, including workers, contractors and professionals were approached through existing networks and snowball referrals, ensuring voluntary participation. "There is a general perception that women cannot work and only raise kids, but it is not true. We can operate machines and work more than men, but we need opportunities. Since big machines have come, Adivasi women like us don't get much work. But if we are given the chance to learn new skills, we too can advance in construction," said Savitaben Bilvad, a 48year-old construction worker, a native of Dahod, who has been working in Ahmedabad for the last 30 years. The report pointed out that despite years of experience, women earn 10-20 per cent less than male "helpers" and 40-50 per cent less than "skilled" male workers from the same regions. Wages are often paid to male family members, rendering women's contribution invisible."We don't want to spend energy on matters like harassment and women's safety," a supervisor at a precast yard told researchers, underscoring persistent gender bias in hiring and workplace practices. "I work as a mazdoor (helper) because the contractor does not see me as a karigar (mason). I go to the site as a jodi (pair) with my husband and don't find work alone. Even though I know plastering and can operate a breaker machine, I earn only half of what my husband gets, said Surekhaben Maida, a 38-year-old migrant construction worker from Dahod.Another migrant construction worker Sharmaben Bhuria from Dahod said contractors deny work to women with children. "We are told what these women with kids do. Where should we keep our toddlers then. If we are denied work, how will we support our family? There should be facilities for our children at the work site. We have come for work in Ahmedabad, but due to our children we don't get work," she told The Indian Express. The research urges the state's labour department and construction industry to ensure that technological progress does not deepen gender inequality."Automation need not always mean displacement. Now is the time for the construction industry to reimagine women's inclusion. With access to training, recognition, and support systems, women's participation can be sustained, and they can move to technical and better-paying roles," said Geeta Thatra, associate director at Work Fair and Free. Rise of automation in Ahmedabad since the 2010s when automation and industrialised construction have expanded added with growth of precast and prefabricated construction, especially after COVID-19-Modular construction, BIM, drones, and IoT devices are gaining traction, while emerging technologies such as AI, robotics, 3D printing, and digital twins remain experimental-Technological adoption is uneven across building and infrastructure projects. ## Microplastics threaten Goa's estuarine fisheries, human consumers



Microplastics in water bodies can be ingested by very small organisms, which in turn are consumed by larger ones. As a result, the bodies of animals higher up in the food chain accumulate more microplastics and can suffer from amplified toxicity. This phenomenon is called bioaccumulation. To understand microplastic bioaccumulation along the Goan coast, scientists from the CSIR-National Institute of Oceanography in Goa and the Academy of Scientific and Innovative Research in Ghaziabad recently examined the habitats and feeding behaviour of 251 fishes belonging to nine species of finfish and shellfish. These included mackerel, anchovy, oyster, clam, catfish, sardine, and other commercial varieties, which the team captured from various depths in the ocean's water column. In a study published in Environmental Research in August, the team identified 4,871 polluting particles in these fish, of which 3,369 particles were plastic polymers of 19 types. The scientists also found more contamination on the sea floor and in sediments at the bottom of the water column (in benthic realm) than in the open water column (pelagic realm).

These particles were mainly from degraded fishing material left at sea and wastewater discharged from human settlements. Based on the findings, the scientists have indicated that the fish are suffering from disrupted gene expression, oxidative stress, reproductive damage, and lower growth. When people eat these fish, according to the team, effects on the human body could include immune dysfunction, higher risk of cancer, and toxicity to the brain. Five key questions Fisheries around Goa focus on the estuaries — ecologically critical zones that nourish young fish and which serve as feeding grounds for the older ones. Finfish and shellfish are commonly fished at estuaries. These fish kinds also feature frequently in Indian cuisine because they are accessible, affordable, and are rich in proteins.

Anchovies, sardines, and mackerel are small pelagic fish that play an important role in estuarine ecosystems, feeding on plankton and drawing in larger predatory fish. They are also filter feeders: they trap floating particles in the water and ingest them, and are thus more liable to imbibe microplastics. These small fish are consumed by other larger ones, which in turn are prey for the elasmobranchs, or cartilaginous fish, including the sharks that dwell in shallow shelf waters. Microplastics thus move all the way up the food chain in a process called trophic transfer, eventually affecting the apex predators and human consumers. The scientists analysed fish samples only from the Mandovi estua-

rine system, part of the Mandovi-Zuari system that contributes to 97% of Goa's fish output. They treated the bamboo shark, an apex predator, as the focal species to identify the effects of microplastic accumulation. The study fills a knowledge gap for five key questions for the region: microplastic contamination quantities in commercial fish, factors that increase the uptake of microplastics in fish, parts of the body that are the primary ingestion pathways, evidence of microplastics through ingestion in the bamboo shark, and risks of microplastic ingestion for fish and human health along the Goan coast.

The scientists analysed 30 members each of mackerels, sardines, anchovies, bamboo sharks, sole fish, catfish, clams, and oysters, plus 11 of the rarer green mussels. These fish were grouped by their feeding levels: filter feeders and planktivores, secondary consumers, and carnivorous consumers. The scientists determined the microplastic concentration in their bodies by assessing the soft tissue. Their analysis revealed that anchovies had the highest concentration among the pelagic species, at 8.8 microplastic particles per individual (MP/in). The catfish led the benthic realm at over 10 MP/in. The bamboo shark had the least: 3.5 MP/in. The water column itself contained 120 MP/litre. The team found that the longer bodies the fish had, the fewer microplastic particles they accumulated. They also concluded that fish with habitats closer to contaminated sediments on the sea bed ingested more microplastics when they fed. Among the finfish, the scientists found more microplastics in the digestive tract than in the gills, indicating accumulation through the consumption of contaminated water or prey. (As water moves through the fish, the particles are trapped in the gills and could lead to respiratory issues.)They also identified four major shape-types of microplastics: fibres (53%), fragments (29.9%), films (13.1%), and beads (4%). Marine animals use colours to detect prey, and the particles came in nine hues: blue (37.6%), black (24.3%), red (12%), discoloured (8.7%), transparent (6.8%), green (4.4%), pink/purple (2.5%), yellow (1.9%), and orange (1.7%). The types and colours of microplastics revealed their sources to be fishing gear, tire residue from roads, e-waste, packaging, and textiles. In all, the study categorised the region and ecosystem as lowrisk but placed benthic life at more risk than pelagic. The paper also said 11 of the 19 types of polymers identified were highly toxic. The study showed 66 of the 71 shellfish to have poor nutritional statuses. Previous studies have found the direct effects of microplastics on fish include lower fitness, protein, and fatty acids and lower nutritional quality. Indirectly, as the demand for such fish drops in the market, coastal populations could be at risk of losing their livelihoods. "This is a good study that further supports several other independent findings," Ravidas K. Naik, who also studies microplastics in marine environments at the National Centre for Polar and Ocean Research in Vasco da Gama and wasn't affiliated with the study, said. "There are microplastics in every place on earth, and such findings only underscore the urgent need for us to take action as a society to remove plastic from various environments, with better waste disposal and new research for biodegradable

## Leaked PAT papers on 5 YouTube channels have lakhs of views, Pune police launch probe

Pune City police have launched an investigation into the alleged leak of the Periodic Assessment Test (PAT) question papers after at least three papers of the exam — held between October 10 and 13 — were found uploaded on five different YouTube channels along with their answers.

According to police, the probe will not only focus on the YouTube channels where the papers were leaked but will also examine leaks, if any, within the state government entity responsible for the exam, as well as private contractors engaged in the exam's administration. A Pune-based company was responsible for the printing of the papers while a Mumbai-based cargo company was responsible for the transport of the papers.PAT is an exam conducted by the State Council of Educational Research and Training (SCERT), Maharashtra. It is a standardised assessment in government-run and aided schools with the objective of testing and improving learning outcomes. The test is conducted for three subjects: primary language (Marathi), Mathematics and third language (English). Many videos mentioned in the FIR are still available online on YouTube. Two videos uploaded on October 10 on different channels mentioned in the FIR have amassed over 1.2 lakh views and 90,000 views respectively in the last four days.

A senior officer from the Pune City police said, "The SCERT officials had given us a complaint application two days ago. On Monday, we called the officer concerned of assistant director rank and based on the statement given by the officer, an FIR was registered late on Monday. The FIR primarily names five YouTube channels on which the three question papers were uploaded along with the answers. The officer has stated that these question papers on the Youtube channels matched the actual papers, prima facie confirming the leak."Tanaji Mane, head of the Maharashtra Principals' Association and principal at Sharadchandra Pawar Prashala and Junior College in Solapur, said, "The PAT papers first arrive in the district, then at the taluka, then at the central school. It is in this distribution chain the papers are getting leaked." In addition to this, the schools are not being given enough papers and are being asked to xerox as required. The rules are that one should not xerox, but on the ground we have to xerox as it is not possible to conduct the exams for some kids and not for the others. This gives another opportunity for the paper to leak at the xerox centre," he added.A L

Deshmukh, retired principal of Apte Prashala, said he was against the idea of conducting PAT exams as it is not possible to prevent leaks in an exam of this scale. "It is difficult to control such a huge system. We have the experience with our HSC and SSC board exams and we all know what happens there. But because those exams are conducted on a war-footing with all district collectors and police commissioners involved, we are able to somehow manage those exams. So it is natural that the PAT papers get leaked." He also said the government should not show a lack of trust in teachers and let them conduct learning outcome assessment exams at their levels.

#### How we sharpened James Webb telescope's vision from million kilometres away

Sydney: After Christmas dinner in 2021, our family was glued to the television, watching the nail-biting launch of NASA's US\$ 10 billion James Webb Space Telescope. There had not been such a leap forward in telescope technology since Hubble was launched in 1990.

En route to its deployment, Webb had to successfully navigate 344 potential points of failure. Thankfully, the launch went better than expected, and we could finally breathe again. Six months later, Webb's first images were revealed, of the most distant galaxies yet seen. However, for our team in Australia, the work was only beginning. We would be using Webb's highest-resolution mode, called the aperture masking interferometer or AMI for short. It's a tiny piece of precisely machined metal that slots into one of the telescope's cameras, enhancing its resolution. Our results on painstakingly testing and enhancing AMI are now released on the open-access archive arXiv in a pair of papers. We can finally present its first successful observations of stars, planets, moons and even black hole jets. Working with an instrument a million kilometres away Hubble started its life seeing out of focus – its mirror had been ground precisely. but incorrectly. By looking at known stars and comparing the ideal and measured images (exactly like what optom-

### Tamil Nadu's last Congress Chief Minister Bhaktavatsalam's virus remark that went viral



One remark that Bhaktavatsalam, the last Congress Chief Minister of Tamil Nadu, made after the declaration of results of the 1967 Assembly election was, "I see a virus has spread all over Tamil Nad[u]. I pray God may save the people."

However, Bhaktavatsalam continues to be viewed adversely by sections of historians and political leaders for the way he handled the acute shortage of rice and anti-Hindi imposition agitation in the State. He is still blamed for the debacle of the Congress in the 1967 Assembly election. Yet, one remark that he made after the declaration of results of the 1967 Assembly election, remains a subject of intense debate among the political class and students of contemporary history. The observation was this, "I see a virus has spread all over Tamil Nad[u]. I pray God may save the people." Actually, this formed a part of his statement made exclusively to The Hindu, according to a report published on February 24, 1967. Needless to say, the outgoing CM, who graciously congratulated the DMK, stated he accepted the defeat as "the verdict of the people against the Congress."That the poll results stunned the Congress party was an understatement as not only the incumbent Chief Minister and most of his Cabinet colleagues were defeated but also the then all-India president of the organisation and former Chief Minister K. Kamaraj had to bite the dust. In Virudhunagar, a young student-leader P. Srinivasan of the Dravida Munnetra Kazhagam (DMK) had outsmarted Kamaraj by a margin of a little less than 1,300 votes while another DMK nominee, D. Rajarathnam, beat Bhaktavatsalam nearly by 9,000 votes in Sriperumpudur.

In an hour-long interaction with reporters at his Nungambakkam residence, the DMK chief C. N. Annadurai, who became Chief Minister on March 6, 1967, described his predecessor's statement as "unfortunate" and sounded somewhat bitter by saying that "it is thoroughly unbecoming of him," reported this newspaper on February 25. M. Karunanidhi, who succeeded Annadurai two years later following the latter's death, in his memoir, Nenjukku Neethi (Volume 1) [which he originally wrote in 1975], likened Bhaktavatsalam's observation to "one of spewing venom."

Two days later, the outgoing CM clarified his controversial remark, which, he said, had been "misunderstood." There was no "insinuation" in his remark against any indi-

vidual or party. "What was uppermost in his mind was that there should be some introspection and that the Congress should look into its shortcomings and rectify them. All that he was concerned about was the obsession with which the body politic was seized. He did not mean any reference to the D.M.K. and that was why he used the expression 'a virus' and not 'the virus' or 'cancer'. He said that 'God may save the people,' because he found that his partymen had not been able to deal with that obsession. He had in mind the shortcomings in 'our own organisation and organisational approach.' In fact, he had been mentioning it to his friends even before the elections," The Hindu reported on February 28. Three years later, in an interview to popular Tamil periodical. Kumudam, the former Chief Minister gave another clarification about what he meant by the term "virus." This interview was published in December 1970, the contents of which were carried in Bhaktavatsalam's memoir, Enadhu Ninaivugal, which was published in 1971. When the memoir was launched, he was on the side of the then Prime Minister Indira Gandhi, who had fallen out with senior leaders including Kamaraj. Spearheaded by Indira

Gandhi, the Congress had become an ally of the DMK. In the interview, he explained that the fact that the people had rejected the Congress, which had got freedom [from the British] for the people and strove for the welfare of the public by formulating several developmental schemes, had made him to ponder over confusion, which had engulfed the people. "I used the term - virus - only to refer to this state of confusion," he explained. He did not describe the DMK MLAs or the DMK as "virus." Had it been otherwise, this would have been "contrary to my nature," Bhaktavatsalam pointed out, recalling he had made clear his position to Annadurai, V.R. Nedunchezhian and Karunanidhi who called on him at his residence before assuming charge. Karunanidhi, who was Public Works Minister in the Annadurai's Cabinet, told him that he and his colleagues too were initially under the wrong impression. Now, they had got clarity after the explanation. In February 1987, Bhaktavatsalam died at the age of 89. At that time, the AIADMK's founder M.G. Ramachandran, as Chief Minister, ensured that the former CM was given a state funeral at an exclusive spot on the premises of the Gandhi Mandapam, Guindy. Eleven years later, the DMK government had constructed a proper memorial for him at a cost of ?25 lakh and in 1998, declaring open the memorial, the then Chief Minister Karunanidhi lauded Bhakthavatsalam for his administrative abilities. He told the audience that he learnt the basics of government administration from his predecessor, this newspaper mentioned in a report published on March 14, 1998. He also recalled how Bhakthavatsalam, [as Finance Minister] inaugurated a mother-child care centre set up by him (Karunanidhi, who was in the Opposition then) in his native Thirukuvalai near Thiruvarur in 1962 despite stiff opposition from the local Congressmen, [an incident of which was recounted in Enadhu Ninaivugal too]. Similarly, on his release from prison in Palayamkottai, Bhakthavatsalam had called him to his residence and explained to him why he was incarcerated. When he (Karunanidhi) gave him a list of persons who were still in prison, the latter, as the Chief Minister, immediately ordered their release. These instances revealed Bhakthavatsalam's "humane side," the daily mentioned as Karunanidhi having said.Bhakthavatsalam's daughter and social activist, Sarojini Varadappan, and granddaughter Jayanthi Natarajan, who was the then Union Minister of State for Civil Aviation, attended the inauguration of the memorial.

## How does Gaganyaan's vital crew escape system work? | Explained



The story so far: The Gaganyaan mission aims to safely transport Indian astronauts to a low-earth orbit of around 400 km altitude using the human-rated LVM3 (HLVM3) rocket as the launch vehicle, and to return them safely. In human space missions, crew safety is more important than mission success. It is imperative that safety is addressed during all phases: launch pad, ascent, orbit, and descent.

What is the CES?A dedicated Crew Escape System (CES) will be used during the initial part of the atmospheric phase of the Gaganyaan mission to ensure crew safety in the event of a contingency that jeopardises the mission. The CES is designed to rapidly separate the crew module, along with the crew, from a malfunctioning launch vehicle, and move it to a safe distance in the least possible time. The atmospheric phase of flight is one of the most critical stages of the ascent, during which the rocket accelerates to hypersonic speeds — more than five times the speed of sound and will be experiencing very high structural loads. The HLVM3 rocket is equipped with two powerful S200 solidfuel boosters to lift off, and unlike liquid or cryogenic engines, solid motors cannot be shut down once they are ignited. Thus, the CES must extract the crew module with greater acceleration than the launch vehicle itself, and in minimal time. The CES is a quick-acting system positioned at the forward end of the launch vehicle and is equipped with multiple special-purpose solid motors. These motors use high burn-rate propellants that consume fuel faster than conventional solid motors, generating higher acceleration.

In the Gaganyaan mission, the CES could impart acceleration up to 10-times that of gravity. For a healthy human body, such high acceleration is tolerable for a few seconds if the crew is positioned correctly, with the acceleration acting perpendicular to the chest and the body pressed against the seat in a "child in cradle" orientation. Rocket systems are more intricate than those of aircraft, with rocket reliability much lower than that of passenger aircraft. Nevertheless, the CES significantly improves crew survival

probability through its heritage-based design, redundant systems, and robust mission planning.

What are different types?

The CES is classified into two types based on the way it extracts the crew module: (i) puller type — used in Gaganyaan, where the CES pulls the crew module away from the launch vehicle; (ii) pusher type — used in vehicles like SpaceX's Falcon 9, where the crew module is pushed away using compact, high-thrust liquid-fuel engines. Both systems have advantages and disadvantages, with the choice depending on propulsion technology and system integration aspects. The U.S.'s Saturn V, Russia's Soyuz, and China's Long March vehicles also use puller-type CES designs. In September, 1983, two Soviet cosmonauts escaped a massive explosion on the launchpad when their Soyuz rocket caught fire just before lift-off. Their lives were saved by the launch vehicle's automatic crew escape system. This remains the first and only time a crewed launch escape system was activated before lift-off. Once the CES has moved the crew module a safe distance away from the failing vehicle, the module will be released and decelerated by a multistage parachute system. This will reduce the module's velocity in steps, ensuring it splashes down safely in the sea without exceeding the crew's physiological limits upon impact. Typically, the crew will remain inside the module until splashdown. But during the Soviet Union's first human spaceflight, Yuri Gagarin ejected from the Vostok module at approximately 7 km altitude and parachuted safely to the ground. The Integrated Vehicle Health Management system (IVHM), which is a network of sensors, electronics, and software, will aid in taking a decision to activate the CES when a contingency arises. It will monitor all vital parameters of vehicle systems and crew health in real time. Based on the synthesised information and the flight regime, it will ensure prompt anomaly detection, minimise false alarms, and activate the CES early enough to protect the crew.

Has it been tested?

The ISRO has developed a cost-effective, single-stage Test vehicle powered by the Vikas engine to validate the CES. The first successful test occurred in October 2023, during which the CES was activated when the Test vehicle reached transonic conditions — a critical phase in atmospheric flight when the velocity transitions from subsonic to supersonic. ISRO plans additional Test vehicle flights to simulate other critical ascent trajectory conditions. The CES is a cornerstone of the Gaganyaan programme and reflects ISRO's commitment to astronaut safety. By integrating advanced engineering, rigorous testing, and reliable systems like the IVHM, the CES ensures India's first human spaceflight mission will prioritise the safe return of its crew, even in the face of unforeseen challenges.

## The evolving political dynamics in volatile Bangladesh



Bangladesh's political landscape is undergoing a rapid transformation ahead of the general election which is to take place in February 2026. Student advisers and the Bangladesh Jamaat-e-Islami (JEI), Bangladesh's largest Islamist party, which extended support to the interim government from the beginning, are positioning themselves to make the most out of the current set-up and are effectively challenging the older two-party system featuring the Awami League and the Bangladesh Nationalist Party (BNP). Signs of this new political configuration were evident when Mohammed Yunus, Chief Adviser to the interim government, was seen at the 80th session of the United Nations General Assembly (UNGA) in New York in the company of Naib Ameer of the JEI, politician Syed Abdullah Mohammed Taher and Tasneem Zara, a young leader from the studentbacked and newly formed National Citizen Party (NCP). The delegation also included Mirza Fakhrul Islam Alamgir of the BNP. But the presence of at least two Jamaat leaders and the elderly Alamgir showed that the NCP and the Jamaat have covered a great political distance within the last year. There is considerable frustration among the supporters of the Awami League and the BNP as the leadership in both parties is not responding to the changes that are sweeping across Bangladesh's politics. With the flight of Awami League leaders from the country, Khaleda Zia's BNP was the immediate beneficiary as it was expected to take charge in case an election was held by December 2024 or January 2025. As the interim government delayed the election, the BNP chose to wait and became restive only when it became clear that the students would form their own party. In the process it lost valuable time and suffered reputational damage as Bangladesh was rocked by a series of violent incidents which included the brutal killing of Lal Chand Sohag, a trader in Dhaka on July 9, 2025. The BNP's cadre had to bear the blame. The former Prime Minister of Bangladesh, Sheikh Hasina, who is based in New Delhi, has been in touch with her party cadre (the Awami League) on the ground but has not held a single press interaction, virtual or in person. She has not designated anyone on the ground in Dhaka as the party has been banned since May 2025 (In October 2024 Awami League's student wing was banned). Neither has she or her colleagues expressed remorse over the loss of lives in the protests of July-August 2024. At the same time, the BNP's pitch for political power is weak as its top leadership is still in exile. When senior BNP leaders organised a rally as a show of the BNP's strength in May 2025 and accused Mr. Yunus of delaying elections — the party had demanded elections by December 2025 — the BNP's Acting Chairman, Tarique Rahman, addressed the gathering from his London home (he has been based here for nearly two decades because of his disputes with Ms. Hasina and the military). Sources in the BNP have indicated that he may return in November but there has been no announcement of a definite date for his return. That the BNP has still not been able to bring back Mr. Rahman from London in what is

now a Hasina-free Bangladesh is a sign that its relations

with the interim government are not as normal as they may

appear. The BNP has not given a clear explanation for Mr.

Rahman's absence in Dhaka, with the elections just months away. The Awami League's inability to delegate responsibility to some of its over ground leaders such as Saber Hossain Chowdhury has also not gone down well with the party's traditional supporters. The party's leaders who are in exile have countered this with the line that delegating responsibilities would make local leaders vulnerable to severe actions by the interim government. But the common man in Dhaka is of the opinion that a lack of delegation by Ms. Hasina only reveals the political insecurity of the Sheikh Hasina family. The new players

The NCP and the Jamaat are increasing pressure on Mr. Yunus to ban more political parties and introduce a proportional representation (PR) system for the election. Their argument is that the PR system would ensure a "level playing field for all political parties". In fact, the PR system would increase pressure on the BNP which remains the sole inheritor of the older political system on the ground. The BNP has also been humiliated in campuses after facing defeat in the student union elections at Jahangirnagar University and Dhaka University where Jamaat-backed student panels won. Jamaat-student coordination on campuses is supported by the fact that some of the student activists were trained under the Jamaat's student wing, Shibir. There are several takeaways from the emerging plot. First, the BNP's long-held argument that an interim government would be apolitical has been proved wrong. During the rule of the heikh Hasina-led Awami League, the BNP was the strongest proponent of an interim government to conduct credible elections. Yet, the 2024 interim government, which the BNP had welcomed initially, has in turn thrown up new challengers for the BNP. If the BNP wins the election in 2026 or manages to emerge as the single largest party, it would be because the history of the two-party-led system still has significant appeal in Bangladesh. The Army's muted stand

Second, the pause in two-party politics under the interim government has been a reality check for the Bangladesh military. Unlike his predecessors such as General Ershad, the current Bangladesh Army chief, Gen. Waker-Uz-Zaman, has refrained from direct interference in the political domain even though the army took over magisterial powers following the serious deterioration in the law and order situation. On occasions, Gen. Zaman has said that the military could step in if the interim government makes compromises in areas that the army considers vital for Bangladesh's security. The Bangladesh army's real test is expected in winter 2025 when politics will heat up in Dhaka as the International Crimes Tribunal is to deliberate on the future of Ms. Hasina and her colleagues. At the moment, the army appears to be under pressure. In December 2024. Gen. Zaman was successful in scuttling the launch of the so-called July Proclamation that aimed to replace the 1972 constitution. But he could not do this on August 5, 2025 when Mr. Yunus announced it as a guiding document for

Third, within the nationalism-centric party system of Bangladesh, the Jamaat-e-Islami, with its pro-Pakistan history of 1971, is yet to make a convincing nationalist pitch for the elections as it continues to be an organisation with a transnational ideological network across multiple countries including the United States, the United Kingdom and Pakistan. If the student leaders of the NCP and the Jamaat leadership can continue to keep the BNP under pressure during the interim administration (it has already banned the Awami League), a new political bloc featuring the Jamaat and popular student activists could well emerge as a determining force in the election. The Jamaat has a history of aligning with the BNP as a junior partner during 2001-06 (during 1991-96, it gave outside support to the BNP), but with the students, it could emerge as a senior partner.

## Powering up the Australia-India clean energy partnership



At a time when both India and Australia are pushing ambitious clean energy targets, it is timely that Australia's Minister for Climate Change and Energy, Chris Bowen is arriving in Delhi today (October 15) to meet his Indian counterpart, New and Renewable Energy Minister Pralhad Joshi. His visit comes amidst confronting vulnerabilities in the global supply chains of businesses and the government grappling with how to meet ambitious targets in the clean energy transition. The central challenge is clear: how to scale up renewable energy while avoiding an ongoing overdependence on China, which dominates the processing and manufacturing of critical materials. This is where the India-Australia Renewable Energy Partnership (REP), launched last year by Prime Ministers Narendra Modi and Anthony Albanese, must move from vision to implementation. If it is to succeed, both countries need to focus on joint projects, critical mineral cooperation and capacity building, turning climate ambition into practical, resilient outcomes. Mr. Bowen will have the chance to highlight the significance of this partnership when he delivers the Australia India Institute's Annual Oration in New Delhi this week. A climate change vulnerable region

The Indo-Pacific is already experiencing the harshest effects of climate change. Between 1970 and 2022, the region averaged nearly 10 climate-related disasters a month, causing thousands of fatalities and billions in losses. By 2050, projections suggest as many as 89 million people could be displaced, with 80% of the region's population directly impacted. To mitigate the challenges, India has pledged to reach 500 GW of non-fossil electricity capacity by 2030, with about 280 GW to come from solar. And it is already five years ahead of schedule to reach it. In July 2025, half of India's installed electricity capacity is now from non-fossil sources. Meanwhile, Australia has recently set a 62%-70% reduction in emissions below 2005 levels, by 2035, raising its climate ambition in line with net-zero goals.Mr. Bowen said recently on the sidelines of the United Nations General Assembly that the emission reduction target is 'ambitious and achievable, but also investable'. Yet, targets alone do not insulate against structural risks. The global clean energy transition depends on critical minerals, solar components, batteries and hydrogen technologies. The risks of single country dependenceToday, much of this value chain is concentrated in one country. China refines over 90% of rare earth elements and produces nearly 80% of global solar modules, giving it a pivotal role in the world's renewable energy supply. For India, this dependence is acutely felt in sectors such as electric mobility and wind power, where the import of rare earth magnets and battery materials is unavoidable. For Australia, the story is different but connected: while it is one of the world's largest producers of lithium and has rich reserves of cobalt and rare earths, it lacks large-scale refining and downstream manufacturing.

This vulnerability has already been tested. The COVID-

19 pandemic exposed supply chain fragilities when component shortages disrupted production across sectors. More recently. China restricted rare earth exports, which sent a warning signal to industries worldwide. For India, such disruptions slowed the electric vehicle production. A leading Electric Vehicle (EV) scooter company, for instance, produced just 10,824 units of its EV scooters in July, nearly halving output from a year earlier. For Australia, they underlined the risks of being a raw-material supplier alone. These examples make clear why downstream processing, diversification and supply chain resilience are not optional but strategic imperatives. The REP presents a framework to respond to this challenge. It lays out cooperation across eight areas: solar photovoltaic technology, green hydrogen, energy storage, solar supply chains, circular economy in renewables, two-way investment, capacity building, and other shared priorities. Importantly, it also proposes a Track 1.5 Dialogue, bringing together policymakers, industry and research institutions to build practical collabo-

A strong basis for collaborationSo, what does each side bring to the table? Australia's strengths lie in its resource base and regulatory stability. It can supply India with critical minerals such as lithium and rare earths, but the real value lies in co-investing in refining and processing infrastructure that strengthens the control both countries can have over the clean energy value chain. Australia's recent Net Zero Jobs Plan also reflects its focus on creating the skilled workforce needed for this transition, an area where collaboration with India makes sense.

India's own advantage lies in its scale and youth. With nearly two-thirds of its population under the age of 35, India's demographic dividend can be directed towards clean energy manufacturing, installation and maintenance through programmes such as Skill India. Its growing market demand for solar, storage and hydrogen, combined with production-linked incentive (PLI) schemes, offers Australian firms an avenue to expand investment while helping diversify supply chains. Together, Australia's resources and India's workforce can form the backbone of a more resilient and regionally anchored clean energy ecosystem.Mr. Bowen's Delhi visit could not have come at a more crucial moment. #### **Balancing empowerment with economics**



The Stree Shakti scheme, which offers free bus travel to girls, women, and transgender people across Andhra Pradesh, has been in effect for two months. So far, it has increased ridership, enhanced mobility for women, and generated positive public sentiment. However, beneath this encouraging start lie operational and financial concerns. Questions about sustainability, the strain on transport infrastructure, and equitable access challenge the long-term viability of Stree Shakti. The scheme was launched on August 15, Independence Day, to highlight the government's resolve to advance women's independence and empowerment. Within the first 30 hours of its introduction, more than 12 lakh women passengers travelled for free by bus. The number has been steadily growing since then. According to data by the Andhra Pradesh State Road Transport Corporation (APSRTC), around 19.6 lakh women used the free bus service on August 31. By October 6, this number had increased to 28.3 lakh. The daily government subsidy also grew from ?7.76 crore to ?10.86 crore during this period and the number of Stree Shakti buses increased from 85 to

This data reflects early success but also points to cost implications and the logistical adjustments needed to sustain such high usage over time. With an estimated annual cost of ?1,942 crore and a monthly expense of ?162 crore, the APSRTC will be reimbursed by the State government for the scheme's costs through the submission of zero-fare tickets. However, the continuous allocation of such substantial funds could strain the State's finances, especially if economic conditions fluctuate. Another challenge is overcrowding due to the shortage of vehicles in the APSRTC fleet. The waiting period has become long, particularly during peak hours. With the sudden surge in the number of women travelling by RTC buses, men are on the verge of becoming a minority onboard. Officials have also reported a slight decline in the number of fare-paying passengers.

While trying to manage the existing fleet, they are awaiting the arrival of more than 700 electric buses, which may help ease the situation. Chief Minister N. Chandrababu Naidu, who is keen on steering the State towards greener public transportation, has announced that all diesel vehicles in the RTC fleet will be replaced with electric buses. The State Transport Corporation will need to build and maintain a comprehensive electrical ecosystem comprising high tension supply lines with dedicated feeders and substations, scalable charging stations, backup systems, and renewable energy integration. This is imperative not only to support electric mobility, but also to ensure safety, efficiency and resilience, say officials. While the scheme has given women reason to celebrate, it has not been received well by auto-rickshaw and maxi cab drivers, who have been

protesting across the State, citing revenue losses. They

have demanded compensation for the income shortfall

caused by the scheme. In response, the government announced the Auto Mitra programme, offering financial assistance of ?15,000 annually to drivers. The drivers want this amount to be increased to ?30,000 and also want some of their other demands to be fulfilled. Meanwhile, the APSRTC employees' union has been urging the RTC management to procure more buses in view of the rising occupancy rate. Warning against the continued use of outdated buses, union leaders are demanding that the authorities buy at least 2,500 new buses — both electric and diesel — and also recruit 9,000 employees to reduce dependence on outsourcing. The workers are also worried about the government's plan to operate electric vehicles under the Gross Cost Contract Model. Under this system, State Transport Units hire private bus operators to run electric buses. The government owns the buses, and private operators manage operations and maintenance under a contract, earning a fixed amount per kilometre. The proposed model has sparked fears of privatisation among workers of the State-run transport corporation. The Stree Shakti is a significant step towards empowering women and has already delivered promising results. However, it also faces challenges related to implementation and financial sustainability. Addressing these concerns is essential to ensuring the scheme's long-term

### Scientists edge closer to cutting HIV out of human DNA

Hyderabad: The day is not far away when scientists can literally cut the HIV/AIDS virus out of a patient's cell genome. Geneticists are now very close to developing a CRISPR-based therapy that can be safely delivered throughout the body of a patient to target and edit the latent HIV reservoir, setting the stage to cure HIV.A few months ago, a US-based company Excision BioTherapeutics presented proof-of-concept data from their CRISPR therapy EBIT-101, and its promise to target and destroy the HIV reservoir in the human body. CRISPR (Clustered Regularly Interspaced Short Palindromic Repeats), which is a geneediting tool that acts like molecular scissors, allows scientists to precisely cut and modify DNA. In this study, phase I and II clinical trials (EBT-101) tested a novel CRISPR-Cas9 gene therapy as a potential functional cure for HIV infection.At present, there are Antiretroviral Therapies (ART), a combination of proven drugs that keep the HIV virus dormant in the human body. The primary challenge to curing HIV is the existence of the latent reservoir of infected human cells (T-Cells) where the virus' genetic material is kept dormant by administering patients with ART therapy. Once the patient stops the ART therapy, the dormant virus reactivates and causes rebound. The core gene editing technology, which became the basis of the EBT 101 therapy, was developed by two US-based researchers Dr Kamel Khalili (Temple University) and Nobel laureate Dr Jennifer Doudna (UC Berkeley). The CRISPR-Cas9 system was designed to be directly delivered to the T-Cells and other tissue reservoirs that harbour dormant HIV DNA.Once inside the infected cell, CRISPR makes multiple cuts across the integrated HIV genome, thus permanently removing large segments of the virus DNA from the body. The phase I and Il trials, which involved a small group of participants, demonstrated that one-time IV infusion of CRISPR therapy was safe and well tolerated, with no serious side effects.

#### India Q2 GDP Growth Data 2025: India's Q2 GDP growth beats expectations again, rises 8.2% on manufacturing, financial services uptick



The Indian economy continued to expand at a faster-than-anticipated rate in the July-September quarter, with GDP growth rising to a one-and-a-half-year high of 8.2 per cent on the back of double-digit growth in financial services and the real estate sectors. The manufacturing sector too expanded at the fastest pace in six quarters.

Economists had broadly expected the GDP growth to moderate to 7.3 per cent from 7.8 per cent in April-June, with the Reserve Bank of India (RBI) having forecast a growth rate of 7 per cent. However, the growth rate unexpectedly rose for the fourth quarter in a row in July-September. "The Secondary (8.1 per cent) and Tertiary Sector (9.2 per cent) has boosted the Real GDP growth rate in Q2 of FY 2025-26 to rise above 8.0 per cent," the Ministry of Statistics and Programme Implementation (MoSPI) said

Within the secondary sector, the Gross Value Added (GVA) of manufacturing rose by 9.1 per cent, up from 7.7 per cent in April-June, while construction sector growth edged down to 7.2 per cent from 7.6 per cent in the previous quarter. The big jump in manufacturing sector growth was also aided by a favourable base. In the second quarter of 2024-25, manufacturing growth was a mere 2.2 per cent. However, the construction sector had grown by 8.4 per cent in that quarter. Meanwhile, in the tertiary - or services sector, GVA of 'Financial, Real Estate & Professional Services' rose by 10.2 per cent, up from 9.5 per cent in April-June and 7.2 per cent in the second quarter of last year. The GVA of 'Public Administration, Defence & Other Services' continued to grow at a high pace of 9.7 per cent, broadly similar to the 9.8 per cent growth recorded in April-June. Agriculture, meanwhile, saw a GVA growth of 3.5 per cent. The overall GVA growth rate rose to 8.1 per cent from 7.6 per cent the previous quarter and 5.8 per cent in July-September 2024. The GDP is calculated by adding net indirect taxes — indirect taxes such as Goods and Services Tax (GST) minus subsidies — to GVA.In addition to the GDP growth rate rising to 8.2 per cent, the GVA growth rate of 8.1 per cent being below the GDP growth rate was another surprise. Economists had widely expected the GDP growth rate to be lower than the GVA growth rate in the second quarter.GDP growth without adjusting for inflation, or nominal GDP growth, declined to a four-quarter low of 8.7 per cent in July-September from 8.8 per cent in April-June. Growth surprises again

The high GDP growth number comes days before the RBI's Monetary Policy Committee (MPC) begins its three-

day meeting on December 3, with Governor Sanjay Malhotra scheduled to announce the interest rate decision at 10am on December 5. With headline retail inflation at a record low of 0.25 per cent in October, the MPC was widely expected to cut interest rates for the first time since June. However, the robust growth figure may have thrown a spanner in the works. "The MPC faces a challenging act at the December rate review, with the mix of a strong growth print and record low inflation. We expect an emphasis on forward looking growth guidance and high real rate buffer due to weak inflation, to justify a move to lower rates further," Radhika Rao, Senior Economist at DBS Bank, said. So far in 2025, the MPC has lowered the repo rate by 100 basis points (bps) to 5.5 per cent. As per the GDP data released on Friday, GDP growth in April-September - the first half of 2025-26 stood at 8 per cent, up from 6.1 per cent in the first half of 2024-25. Similarly, GVA growth in April-September this year was 7.9 per cent, compared to 6.2 per cent last year. The statistics ministry was also scheduled to release industrial growth data as per the Index of Industrial Production (IIP) for October on Friday. However, the ministry said in a statement that the IIP data will now be released on Monday.

Private consumption on the rise

As expected, private consumption growth rose for the second quarter in a row in July-September due to the combination of low inflation and the Goods and Services Tax (GST) cuts that came into effect from September 22. Private Final Consumption Expenditure rose 7.9 per cent in July-September after having expanded by 7 per cent in April-June and 6 per cent in January-March. Gross Fixed Capital Formation, a proxy for investments, rose by 7.3 per cent, down from a growth of 7.8 per cent in April-June but higher than the increase of 6.7 per cent in the second guarter of 2024-25. However, Government Final Consumption Expenditure was down 2.7 per cent after a 7.4 per cent rise in April-June and 4.3 per cent in July-September 2025. "On the whole the economy has done well with exports growing by 11 per cent in Q2. Going forward the headwind will be the tariff impact which will get starker in October-November. The tailwind is the GST push which can negate and go beyond. This needs to be monitored going ahead," Madan Sabnavis, Chief Economist at Bank of Baroda, said. Real GDP has been estimated to grow by 8.2% in Q2 of FY 2025-26 against the growth rate of 5.6% during Q2 of FY 2024-25. Nominal GDP has witnessed a growth rate of 8.7% in Q2 of FY 2025-26. The Secondary (8.1%) and Tertiary Sector (9.2%) has boosted the Real GDP growth rate in Q2 of FY 2025-26 to rise above 8.0%. Manufacturing (9.1%) and Construction (7.2%) in the Secondary Sector, has registered above 7.0% growth rate at Constant Prices in this quarter. Financial, Real Estate & Professional Services (10.2%) in the Tertiary Sector has sustained a substantial growth rate at Constant Prices in Q2 of FY 2025-26.

Agriculture and Allied (3.5%) and Electricity, Gas, Water Supply and Other Utility Services Sector (4.4%) has seen moderate Real growth rate during Q2 of FY 2025-26. Real Private Final Consumption Expenditure (PFCE) has reported 7.9% growth rate during Q2 of FY 2025-26 as compared to the 6.4% growth rate in the corresponding period of previous financial year. Real GDP has registered 8.0% growth rate in H1 (April-September) of FY 2025-26, as compared to the growth rate of 6.1% in H1 of FY 2024-25.

## Economists see India's Q2 GDP growth at 7.3%, RBI could cut interest rates on Dec 5

The Indian economy is likely to have performed better than the Reserve Bank of India's (RBI) expectations in the second quarter of FY26, according to the median of estimates of 10 economists, with data scheduled to be released on Friday by the Statistics Ministry likely to show that GDP growth in the three months ended September stood at 7.3 per cent. The Indian central bank's latest forecast pegged growth in July-September at 7 per cent.

While possibly lower than the five-quarter high growth

rate of 7.8 per cent in the April-June quarter, another 7 per cent-plus expansion in the July-September quarter — despite the 50 per cent US tariffs that came into effect in late August — would burnish India's growth story."Growth is tracking better than expected with Q2FY26 GDP growth at 7.3 per cent and Q3FY26 GDP getting support from GST cuts. Even before the GST cuts, rural recovery has become more broad-based in Q2, supported by stronger labour market conditions and good crop output. Urban demand has clearly responded to the GST cut with rise in consumer durable consumption expenditure," Gaura Sen Gupta, IDFC First Bank's Chief Economist, said in a note on Monday.

Rate cut to follow?

Days after the Ministry of Statistics and Programme Implementation (MoSPI) releases the GDP data on Friday at 4pm, the RBI's Monetary Policy Committee will begin its three-day meeting on December 3 and announce its interest rate decision on December 5. And despite the economy chugging along at a good pace, economists think the central bank may cut the policy reporate for the first time in six months.

"While such strong growth outcome would otherwise be seen as a deterrent to a rate cut, it is important to note that growth has peaked and H2FY26 (October 2025-March 2026) growth is estimated to be lower than H1 (April-September 2025)," Barclays' economists Aastha Gudwani and Amruta Ghare said in a note earlier this month. "For a forward-looking, inflation-targeting central bank, we believe the stage is set for the RBI MPC to deliver a 25 basis points (bps) repo rate cut in the upcoming December meeting."So far in 2025, the MPC has lowered the repo rate by 100 bps to 5.5 per cent. But with headline retail inflation at record lows – it stood at just 0.25 per cent in October and is seen averaging below 2 per cent in FY26 by a few economists, well below the RBI's target of 4 per cent – space may have emerged for the committee to cut interest rates further. Nominal growth slowdown The fall in inflation could also make it difficult to read the GDP data for the second quarter in a row. In April-June, low inflation meant nominal GDP growth — or growth without adjusting for price changes — was at a three-quarter low of 8.8 per cent even though the real growth number of 7.8 per cent painted a positive picture of the economy. The nominal GDP growth rate needs to be monitored for two reasons. Firstly, it is not only tracking below the Finance Ministry's Budget assumption of 10.1 per cent, but economists are predicting it could be lower than 8 per cent growth — in both the July-September quarter and FY26 — that is required to meet the Budget esti-

mate as per the latest GDP estimate for FY25. A lower than



anticipated nominal GDP affects the Budget math, with tax collections not growing as hoped and fiscal deficit and debt-to-GDP ratios being higher than estimated.

GDP growth below GVASecondly, a slowdown in tax collections will also likely result in GDP growth being lower than the growth in overall Gross Value Added, or GVA. In April-June, GVA growth was 7.6 per cent, 20 basis points lower than the GDP growth rate. The GDP is calculated by adding net indirect taxes — indirect taxes such as Goods and Services Tax (GST) minus subsidies — to GVA. So, if net indirect taxes fall or their growth slows down, GDP growth would be lower than the rise in GVA. Back-of-theenvelope calculations show the government's net indirect taxes fell on a year-on-year basis in Q2 compared to a 10 per cent rise in Q1. According to State Bank of India Research, GDP growth in the second quarter may be 7.5-8 per cent, while GVA growth is seen at 8 per cent. The consumption quarter? The reduced GST rates may have only come into effect towards the end of Q2 on September 22, but the surge in demand in the final few days of that month in conjunction with other factors such as low inflation may have lifted private consumption by 8 per cent, according to Paras Jasrai, Economist and India Ratings & Research. This would be the highest since the 8.1 per cent increase in Q3FY25.In addition to retail inflation averaging a mere 1.7 per cent in Q2FY26 and rural agricultural wages growing by almost 6 per cent, Jasrai sees a potential boost in demand from the impact of the personal income tax cuts announced in the Union Budget for FY26 and a healthy 7.8 per cent rise in employee costs of over 500 listed companies. Private demand would have risen more than 8 per cent if not for households delaying purchases ahead of the GST cuts' rollout.In Q1FY26, private consumption growth had risen to 7 per cent from 6 per cent in Q4FY25, although it was lower than 8.3 per cent in Q1 that fiscal. Corporate over-performancelf households had a good three months in terms of their budgeting, so did companies, with Q2FY26 proving to be the best quarter in two years: HSBC analysts found that although sales of listed Indian companies were only 6 per cent higher year-on-year, their profits were up 13 per cent. Here, inflation again played a big role. Even though retail prices rose 1.7 per cent year-on-year in Q2, wholesale inflation — which is indicative of the increase in inputs costs for producers -- averaged zero over the same pe-

# 'Sab soch rahe the I am carrying a coffin': Sushma Seth recalls taking tanpura to America; psychologist on awkwardness people feel while carrying noticeable luggage



Legendary actor Sushma Seth once shared a funny and heartfelt memory from her early days when she travelled to the United States carrying a tanpura, a traditional Indian musical instrument. "Everyone thought I was carrying a coffin," she said with a smile on Soul Safar aur Ehsas, remembering the curious and puzzled looks from fellow travellers as she carried the big, oddly shaped case. Tanpura is an essential instrument for classical Indian music, and for Sushma, it was not just an instrument but a part of her identity and art. However, travelling with such a large and unusual item brought its own share of awkward moments. The awkwardness of carrying noticeable luggage

Carrying large or distinctive luggage can make people feel uneasy or self-conscious, said Dr Anjali Mehta, a clinical psychologist who studies social anxiety, as she explains why this happens. "When you have something that draws attention, like a musical instrument, it naturally makes you stand out. This unwanted attention can make people feel awkward or worried about being judged," she says.Dr Mehta added that the physical effort involved in carrying or managing such items also plays a role in the discomfort. "It's

not just about others watching you. Carrying something big or heavy is tiring and sometimes embarrassing because you worry about bumping into others or inconveniencing people," she notes. This heightened self-awareness can make the situation even more uncomfortable.

Mr. S Giriprasad, Psychologist, Aster Whitefield, further adds that this embarrassment is a result of our social wiring which makes us concerned about our status within a group. " If you happen to have more physical space than others it may lead to the idea that you are thinking of marring the appearance of being clumsy, selfish, careless, or socially awkward. This apprehension uses the same mechanism as that behind impression management and the spotlight effect, which is the case when people always overestimate the extent to which others notice or judge their appearance and actions." For Sushma Seth, despite her fame and confidence, the experience was relatable for anyone who has ever felt the eyes of strangers on them because of what they are carrying. "Even though I was proud of my tanpura, I couldn't help but notice how weird I must have looked to others," she shared. When passion meets

Sushma's story highlights the small but real social challenges faced by people carrying items connected to their passion or profession. It also shows how personal belongings can sometimes create invisible barriers and feelings of awkwardness in public places. Dr Giriprasad explains that people may adopt avoidance or low-profile strategies such as tucking a bag close, shuffling along to reduce feared scrutiny. As Dr Mehta sums it up, "Feeling awkward when carrying noticeable luggage is completely normal. But embracing what makes you different—whether it's a musical instrument or something else—can also be empowering and confidence-building."

## Dr Madhu Chopra is not a fan of applying sunscreen indoors, encourages all to embrace 'gentle rays of the early morning and late evening'

A solid expert-approved skincare routine, stripped down to the basics, includes cleansing, moisturising, and SPF. Together, these three work to maintain the skin barrier's health. Dermatologists worldwide encourage people to apply sunscreen every day, even when not stepping outside the confines of their homes. However, Dr Madhu Chopra disagrees. In a recent Instagram post, she said that the "gentle rays of the early morning and late evening can actually nourish your skin, boost your mood, and support overall wellness".

But what's the truth – is it ever ok to skip sunscreen?

Dr Aparna Santhanam, Dermatologist and Head Medical Operations at Kaya Limited, emphasised the importance of sunscreen in daily skincare routines, including when indoors. While she acknowledged the skin's need for natural vitamin D from sunlight, she also mentioned that unprotected exposure to UV rays and blue light can harm delicate skin, especially on the face, hands, neck, and other exposed ar-

"The sun's UVA and UVB rays trigger a cascade of free radical damage and inflammation that is the major cause of wrinkles, sagging skin, discolourations, as well as many other issues that rob skin of its youthful qualities. By protecting skin from this damage, daily use of sunscreen delivers anti-ageing and skin health benefits above and beyond any other product," she said. Dr Santhanam pointed out that if an individual's exposure to sunlight and screens is truly minimal, such as in low-light indoor environments, a break from sunscreen might be acceptable. "Limited, gentle sun exposure in the early morning or late evening is indeed beneficial for vitamin D synthesis," she said, agreeing with Dr Chopra's claims. But there's a catch. Madhu Chopra on applying sunscreen indoors Apply sunscreen after every 2-3 hours after the first application (Source: Freepik)She pointed out that relying solely on incidental indoor sunlight through windows or on blue light from screens will not provide the same benefits as the required amount of Vitamin D and, more importantly, will still leave skin vulnerable to



damage. According to her, the sun does not degrade the effectiveness of the sunscreen, but it is our own sweat and oil that break down its components. "Oil secretion is a continuous process, and your sweat glands are functional even when you are not sweating profusely," she added. Thus, when the oil glands disrupt your sunscreen, you do not want to leave it unprotected from the light that is seeping in.

How often should you apply sunscreen indoors?

For sunscreen to be effective, it needs to form a layer on the skin. "So even if you don't venture outside, most of us are still exposed to the sun's rays through windows, light reflected on roofs, floors, walls and even furniture — even on overcast days," said the expert. That is why the right thing to do is to apply sunscreen every 2-3 hours after the first application. To maintain the sunscreen's protective effect, reapplication is necessary. For most modern lifestyles with increased screen time and indoor ambient light, daily application of a broad-spectrum sunscreen that protects against UVA, UVB, and blue light is recommended.Dr Santhanam encouraged maintaining a healthy balance by enjoying safe sun exposure for overall wellness while consistently protecting visible skin to avoid long-term damage. Consistency and diligence are key when it comes to sunscreen. Applying SPF 30 or higher every day, even on cloudy days or when you're just sitting inside by a window, helps the skin benefit from natural vitamins without compromising its health from harmful rays and environmental

The skipper was subsequently ruled out of 2nd Test in Guwahati as well as the ODI series with KL Rahul set to lead the Men in Blue. Regular vicecaptain Shreyas Iyer also misses the series after he was injured taking a catch in the Australia series last month. He was admitted to a hospital in Sydney to due a laceration of the spleen with internal bleeding and was discharged after a few days."I think the best is for the medical to give that. I spoke to Shubman two days ago just to check in with him and he's recovering well. So that's pleasing to hear. Shreyas has also started his rehab, which is great. So yeah, we're looking forward to welcoming them back into the squad. And the good thing is that they're healthy and they're starting their preparation on their way back into the team," Morkel

He's getting hit in the elbow, he's getting hit," he added.Khawaja also said that while sideways movement was something easier, it was



the unpredictability of a ball moving up or down that causes batsman real problems, and according to him, Perth has had that problem not just this year, but previously as well. "You can't really predict up and down. Up and down is the hardest – sideways is a little bit easier, but up and down, your hands can't catch up. So day one wicket at (Perth) is a piece of s\*\*\*, I'm happy to say that. It has been last year, it was this year," Khawaja said.

The third match in Ranchi as well as the 4th match in Mohali was won by India before England notched up a win in the last and final ODI in Dharamsala. India ultimately won the series 3-2. What next for Dhoni and KohliWith the 2027 World Cup firmly in his focus, Kohli will look to make an impact in the upcoming South Africa ODI series. The Indian icon has already hung up his boots from T20Is after helping India win the T20 World



Cup in 2024 before retiring from Tests earlier this year.

He won the Champions Trophy in the ODI format earlier this year and then played for the country after almost 7 and a half months when he returned for the Australia series Down Under in October. He didn't have an ideal start to the series, getting out for back to back ducks in the first 2 ODI matches before roaring back to form with 74 runs in the 3rd ODI.Dhoni, meanwhile, will be lining up for the Chennai Super Kings for the next IPL set to take place in 2026. In the last couple of editions, Dhoni's future has been the talk of the town whenever the new IPL seasons begin. Local media reported that Cummins was bowling at what appeared to be full speed to stand-in captain Steve Smith for more than an hour with a pink ball at the Sydney Cricket Ground on Friday. Cummins has not played in a match since Australia completed a clean sweep of the West Indies in the Caribbean in July, where he first experienced soreness in his back. Meanwhile, veteran opener Usman Khawaja has been included in the Australia squad after back spasms prevented him from batting



in the second innings of Perth's series opener.

Cummins's absence in the squad means native Queenslander Brendan Doggett looks set to retain his place in the XI for Brisbane after collecting five wickets in the first Test. England arrived in Brisbane on Thursday, with its entire first test XI opting against pink-ball match practice with only unused squad members Jacob Bethell, Matthew Potts and Josh Tongue to feature against a Prime Minister's XI team this weekend. Ben Stokes' side will hold its first training session at the Gabba on Sunday followed by a session under lights on Monday. Steve Smith (captain), Scott Boland, Alex Carey, Brendan Doggett, Cameron Green, Travis Head, Josh Inglis, Usman Khawaja, Marnus Labuschagne, Nathan Lyon, Michael Neser, Mitchell Starc, Jake Weatherald, Beau Webster.

The 2026 season is a packed season with Asian Games in Aichi-Nagoya, Japan and Commonwealth Games in Glasgow, Scotland. ## Ab de Villiers on Gautam Gambhir: 'I've known him as an emotional player...generally an emotional coach is not a good thing to have'

On Wednesday, India was whitewashed by South Africa 2-0 at Guwahati. It has happened for the second time under Gautam Gambhir's tenure as Head Coach after the New Zealand debacle last year. The result on Wednesday has raised a few questions about Gambhir's role as head coach. Plenty of former players and pundits have been quite critical of Gambhir's coaching style and tactics. Former South African cricketer Ab de Villiers gave his view on the same as well

"Speaking on behalf of the Indian side, it's really difficult. I don't know what GG is like when it comes to leadership. I've known him as an emotional player and if that is the case in the change room, generally an emotional coach is not a good thing to have. But it's not to say he's that kind of a coach and the kind of leader behind the scenes. There's no right and wrong. Some players will feel comfortable with a former player. Some players will be comfortable with a coach that's never played the game before but he's got a lot of years of experience of coaching the game," De Villiers said on R Ashwin's YouTube channel.

Tere Ishk Mein movie review: In the 2013 film Raanjhana, Dhanush played a Hindu lad from Varanasi who falls in love with a Muslim girl. That was a time when filmmakers could still — just about — carry off an inter-religious love story without the moral police threatening to burn theatres down. In 2025, Aanand L Rai and writers Himanshu Yadav and Neeraj Yadav return with Raanjhana's spiritual sequel, and this time around it isn't religion but class-rich girl, poor boy-which becomes the point of conflict. And just in case that isn't enough, the writers throw the entire kitchen sink at us - college love story, parental opposition, patriotic flag waving, even a war - in a film which ends up being a totally outdated, confused, heavy-on-melodrama-and-glycerine mishmash of genres.But the one thing Tere Ishk Mein never loses sight of is its leading man, played by Dhanush, as the epitome of a lover who has no business being the centre of any narrative in this day and age: an ultra-violent college student whose only job is to break bones while chasing political rivals down the corridors of Delhi University, forcing his attentions on a girl whose interest in him is strictly academic, at least to begin with, while shouting: agar main pyaar mein pad gaya, toh poori Dilli jala doonga.

Even in 2013, Dhanush's character's slitting-his-wrists in his pyaar-ka-paagalpan being papered over by belated

calming was a problem. In 2025, so many elements in the film are problematic at so many levels, starting with a 'hero' whose uncontrollable temper can't be in all honesty explained away by his mother-less childhood, with a perfectly supportive father (Prakash Raj) at his back. Dhanush is a terrific actor, and the way he goes all in with the bashing and slapping and thrashing — throwing in a ghastly crass comment at Mukti's professors about sexual availability for good measure — does take you in when he is at it. But his character is nothing but the reddest of all red flags I've seen in a while: it's unbelievable that a contemporary film will try and shove down our throats that most toxic of male tropes — what the male lover wants, the male lover will get - whether he is the nikamma, roaming around with best friend Ved (Priyanshu Painyuli) in the first half, or the bravest pilot that the Indian air force has, ignoring his commanding officer's (Vineet Kumar Singh) orders to show his bravery. Wait. Shankar is not just merely brave: he is 'outrageous, outstanding, out-of-hand' in the words of an admiring flight-mate; he is 'aggressive, angry, alpha' in the words of a woman who once had a problem with him being all these things, and tried to turn him into a 'kanya rashi ka ladka', in Shankar's laced-with-contempt description. So being soft and gentle is not manly? Tell me again, why are we glorifying this 'aggressive, angry, alpha' man? Can this be our hero in 2025? ## An Oscar campaign can cost Rs 100 cr and above. Can Homebound, with Martin Scorsese in its corner, bring it home?



If Martin Scorsese handpicks an Indian film and hails it as 'cinema,' would The Academy not stand up and take notice? But even the Hollywood legend has won the Oscar only once, for The Departed in 2007 (He's been nominated 16 times though). Neeraj Ghaywan's Homebound has not only gotten Scorsese's blessing with his attachment as an Executive Producer on the film, but has also been selected as India's official Oscars entry. The consensus across the board is that for once, the Film Federation of India jury has put their money on the correct pick, which strikes the balance between craft and logistics, storytelling and marketing muscle, and substance and optics. Throughout the past 23 years, ever since Ashutosh Gowariker's Lagaan made it to the Best International Feature nominations at the Academy Awards in 2003, the house has often been divided on India's chosen contender.

Whether it's Jallikattu vs Gully Boy in 2020 or All We Imagine As Light vs Laapataa Ladies just last year, the FFI has often gotten flak for choosing the film which has the logistical wherewithal to pull off the gargantuan task that is an Oscar campaign over picking a smaller critically acclaimed indie with a rewarding global film festival run. But that strategy hasn't yielded the desired results as neither of those picks even made it to the shortlist.

But Homebound seems different — it's had a six month-long monumental run at major film festivals like Cannes, Toronto, Melbourne, and Marrakech, winning several awards in the process. In fact, it's backed by Marrakech Film Festival Director Melita Toscan, who was instrumental in getting Scorsese on board. At the same time, it's bankrolled by Karan Johar's Dharma Productions, which has recently gained more commercial heft by selling majority stakes to Serum Institute of India CEO Adar

"Oscars is like a full-blown political campaign. It doesn't matter much how much goodwill your film enjoys already. You've to start from the scratch again in order to get the attention of The Academy voters," says Shaunak Sen, whose documentary All That Breathes secured a nomination in the Best Documentary Feature Film category at the Oscars a couple of years ago. He describes the incessant cycle of hosting screenings like running on a hamster wheel. "You've to hit an airport, organize a screening, then hit another airport, do another screening. It's exhausting, and not to mention, very expensive. Because along with organizing a screening, you're also organizing dinner for the voters,' adds Shaunak. A screening in Los Angeles hence can cost upto \$50,000."In our experience with Writing with Fire, we realized it's exciting when you do a curveball from outside the system, be ingenious with limited resources, and use this juggernaut to build some solid visibility around the film. Using every dime and dollar to ensure the film is watched," says Rintu Thomas, whose 2021 film was the first-ever Indian documentary feature to be nominated in the Oscars category. "When Rintu and Sushmit's (Ghosh) Writing with Fire was in contention, I remember sending the film to Ava Duvernay and requesting for her support. She was so kind. She really talked up the film. Endorsement from prominent

creators with credibility, heft, and clout in the international ecosystem helps shift the narrative for your film," says Smriti Kiran, producer and creative impact strategist.

But the International Feature category is an altogether different beast. While it's mostly the documentary filmmakers who are eligible to vote in the documentary categories (just like it's only the actors for the acting categories), that's not the case with the international feature category. Academy voters have to now opt in and watch all other contenders to vote for their pick, making this category one of the toughest to crack at the ceremony. How does one then locate the vector?

Archana Misra, CEO of Product of Culture, which does marketing and strategy for global breakout films with focus on Oscar campaigning, believes Homebound has already secured sustained interest through its festival run. An average white voter would be aware of the film, given they're the audience that's present at prestigious global film festivals like Cannes. "The Academy has diversified and increased its voter bank over the past few years. But majority of the voters are still white," says Archana, adding, "From the feedback we've received from Academy voters about Homebound, they feel it's a universally resonant tale yet very locally rooted. The filmmaker, Neeraj Ghaywan, is also a distinct voice and very well-respected in the international film circles.Martin Scorsese in conversation with Neeraj Ghaywan in New York. Martin Scorsese in conversation with Neeraj Ghaywan in New York.Shruti Ganguly, New York City-based filmmaker, also hails Neeraj as one of the primary draws for Homebound. "I was present at the recent New York screening of the film, which was followed by a Q&A session that Martin Scorsese did with Neeraj. I was surprised to find out how invested Scorsese was in the film. Usually, we see these EPs get attached to a film after it breaks out. That feels a bit of a slap-on. But in Scorsese's case, he's been involved in the making since its scripting stage and even gave feedback for the drafts, and the cuts during the edit stage. He also said he's been a fan of Neeraj since his first film Masaan (2014). That speaks a lot about Neeraj and his appeal," says Shruti.

Homebound's Oscar competition

Homebound is pitted against the best of the best from across the world, including the likes of Sentimental Value (Norway), The Secret Agent (Brazil), and No Other Choice (South Korea). "We're doing as many screenings as we can. Right now, the situation is that all screening rooms of Los Angeles are completely booked out. Because every film is at the peak of its campaigning right now," says a source close to Dharma Productions who's in the US leading Homebound's Academy campaign. "So far, the response we've got is fairly positive. So, we're feeling very optimistic," he adds. Aranya Sahay's indie Humans in the Loop, streaming on Netflix, has also entered the Oscars race. It's contending for the Best Adapted Screenplay category, and is funding its Oscar campaign through a grant by Film Independent (they refused to disclose the amount). The film got a very limited, strategic release in Indian cinemas last month, and could barely earn Rs 3 crore throughout its brief lifetime. But the chances of that coming in the way of its consideration by Academy voters are quite distant.

#### Abused by mother, Kyunki Saas Bhi Kabhi Bahu Thi actress was forced to dance for money, was beaten with hunters, shoes



Coming from a humble background, she was fondly called Bulbul by those who knew her. While she acted on screen from a very young age, not many knew that her performance began when she was a child. Actress Jaya Bhattacharya, popularly known for her role as Payal in Kyunki Saas Bhi Bahu Thi, might have been a celebrated vamp on Indian television. But in real life, she was a victim of a bad marriage, which only affected her as she grew up.Born in 1978 in Lucknow, into a Bengali family, Jaya Bhattacharya doesn't have many happy memories. In fact, she carries trauma due to all that her mother went through. Life wasn't typically easy for Jaya, as being a girl child turned out to be her biggest mistake. Talking about her traumatic childhood, the actress once said in an interview with Siddharth Kannan that, "Both my parents never wanted to marry each other, they didn't get along, and that trickled down to the child. My mother wasn't happy; her dreams never got fulfilled, so whatever she could give me was incomplete... I have been beaten with a hunter, rolling pin, tong, shoes, and what not. I have been beaten a lot, and that made me stubborn. In the bargain, I have damaged

Recalling her humble background, the actress shared, "I was an only child, we didn't come from a wealthy background. We lived in a small room right from the time I was in the third standard till the time I came to Mumbai." While Jaya loved her father, she held a grudge against her mother until a few years ago. Even though she has healed from the scars of her childhood, she says, "I was not upset with my father, but with my mother. I learned everything that I shouldn't do in life from my mother, like making relationships for her benefit and then discarding them, not to value people, not to judge people, and not to support your child in front of others. My mother never stood by me." She further added, "When they started to make me act, one of them would accompany me. I hardly had any friends because I wasn't allowed to go to anyone's house. So I didn't speak much. Out of jealousy, people started saying wrong things about me, and my mother supported them, saying her daughter was bad. This hurt me the most; she doubted her own upbringing. Your child can go wrong, but you should trust your upbringing. If you degrade them in front of outsiders, what will the child do?"Jaya recalled an incident where, due to her mother's stress about having a girl child, she ran away from home to Haridwar. She recalled, "When I was in class 9, my father retired, my mother had made a big issue about how she would accumulated my dowry. How will I get married? So the day my father retired, I ran away from home with my classmate. We ran away to Haridwar, but we were so scared that we didn't leave the aashram for a week." Sharing how things never got better with her mom, Jaya added, "Even when my mother was hospitalized, she went through a very bad phase. Our last conversation was when she blamed me for spoiling her body by hospitalizing her. I used all my savings for her treatment, even though I actually hated her, and I told her this on her face. My mother would not eat food from my hands; she wanted a son."

Talking about her father, Jaya said, "My father was stubborn, but he was a very correct and proud human being. He had a lot of self-respect. He faced a lot of abuse from people, even though he did the right things. That really hurt me, but I was proud of him." Facing a great deal of abuse not only made Jaya stubborn but also angry. "I was an angry person from within due to various reasons. I had lost my femininity and would abuse normally. Once a costar told me that directors were scared to work with me because of my abusive nature."

Parents pushed Jaya into actingEven though she never wanted to act, Jaya Bhattacharya was pushed in front of the camera by her parents. Recalling this, the actress said in an interview, "I was pushed towards acting. I used to dance, and was training in music. Once I got a chance to do a telefilm, the director spoke to my father and first made me dance as a woman, and then also asked me to enact the male part. The shoot was supposed to happen after three days, but my father woke me up the next day at 5 am and took me. I didn't want to do it, but he took me there. That's how it started..."Jaya said that she also faced exploitation and casting couch. She shared, "After the telefilm, the director came with one of his friends, saying he wanted to take me out, but my mother kept dodging him. But he was adamant, so they gave in. He took me to a restaurant, and I was 17-18 at that time. Later, we came home, and the director disappeared after that, but his friend started coming home every day. He taught me how to drive. Later, we got to know he was involved with the mafia. One day, that guy offered to take me to Mumbai, but I said no."Navigating through her life, Jaya Bhattacharya came to Mumbai after she was offered a show. That time, she only had Rs 2000 on her, and she got on a train without any reservation. "I had gotten my father discharged from the hospital, and dropped him at a cousin's house, then I came to Mumbai," Jaya said. She recalled how people in the industry trusted her.In 2000, life changed for Jaya when she bagged the role of Payal in Ekta Kapoor's Kyunki Saas Bhi Kabhi Bahu Thi. What was supposed to be a month-long cameo went on to become a 7-year association. Sadly, Jaya never felt respected on the show; in fact, she only faced abuse from fans. Recalling her time on Kyunki, the actress said, "I faced a lot of abuse for Kyunki; that was my success. I never got an award for that iconic character; no acceptance or acknowledgement was given, even though I deserved it. I enjoyed the abuses. It was supposed to be a month-long cameo, and I worked on the show for 7 and a half years without signing a contract. I was the most underpaid actor, never got a raise until I asked for it. I was given a 50 percent lesser raise than others, and that hurt my ego. I was not respected." Jaya even recalled an incident where she was eating on the streets with a pregnant Smriti Irani when a fan came and pushed her away, calling her a 'gandi aurat'. "She told Smriti to stay away from me, else it would harm her unborn child." After Kyunki, Jaya went on to star in some great shows like Banoo Mein Teri Dulhan, Kasam Se, Karam Apnaa Apnaa, and more. To date, Jaya has managed to stay relevant on the acting front, her very recent performance was in Delhi Crime Season 3.

Otherwise, it was a joy working with him. He is a really great director."

Anupam further added that he might have fallen sick because he used to shoot for several films simultaneously. "I was doing 5-7 films at the same time, even more than that. There was a time when I was doing 23 films at the same time. I don't want to sound politically correct, because when you say you are politically correct, you aren't correct. I love my work and I love working. I wanted to become an actor all my life and God has put me in a position when I am one," he reflected. When asked to elaborate on Deepika Padukone's ongoing 8-hour work shift debate, the actor replied, "Even if a director says there's a 12-hour shift, even if I have 2 scenes in the film, I will be committed for those twelve hours to that person.
