Hyderabad police to deploy Al for smarter investigations and policing

Hyderabad: City Police Commissioner VC Sajjanar on Wednesday announced that the department is considering the use of advanced technology and Artificial Intelligence to expedite investigations and enhance policing efficiency. Stressing that basic and core policing remain the foundation of effective law enforcement he warned that strict action would be taken against any negligence that tarnishes the image of the police force. Addressing senior officers and Station House Officers at a review meeting held at the TGICCC in Banjara Hills, Sajjanar outlined priority areas including law and order maintenance, crime control, community engagement, technology adoption, and human resource management.

Pakistani officials allegedly stop Hindu pilgrim from joining Sikh jatha for Guru Nanak birth anniversary

"Pakistani officials told us you are Hindu, you cannot go with a Sikh jatha," said Amar Chand, who was sent back along with six family members after crossing over to Pakistan to participate in the birth anniversary celebrations of Guru Nanak Dev.A jatha (group) of nearly 1,900 Sikh pilgrims had crossed the Attari-Wagah border on Tuesday to take part in the Parkash Purb of Guru Nanak Dev. Chand said he was among those pilgrims.

He claimed that his family wanted to offer prayers at

gurdwaras in Pakistan on the occasion of Parkash Purb of the Sikhism founder. "They sent us back because I was a Hindu," he said. According to Chand, he and his family completed all formalities after crossing the Attari-Wagah land route. "We were asked to board a special bus for pilgrims. We spent ?95,000 (Pakistani currency) on bus tickets for all seven members," he told PTI.He alleged that five Pakistani officials then arrived and asked them to disembark. "The Pakistani officials told us you are Hindu, you cannot go with a Sikh jatha," said Chand. "Then they sent us back," he added, saying Indian officials questioned their Pakistani counterparts about the reason for the decision. Chand, who was earlier a Pakistani national and came to India in 1999 before obtaining Indian citizenship in 2010, said the amount spent on bus tickets was not refunded. A resident of Delhi, Chand also claimed that seven other Indians from Lucknow were similarly turned back. Meanwhile, the jatha, which is visiting Pakistan from November 4 to November 13, will visit Gurdwara Nankana Sahib, Gurdwara Pania Sahib, Gurdwara Sacha Sauda, and Gurdwara Darbar Sahib Kartarpur. Earlier, the Centre had refused permission for Sikh pilgrims to travel to Pakistan for the Parkash Purb citing the security situation. Later, the Union government allowed a Sikh jatha to visit the gurdwaras in Pakistan.

KTR condemns Revanth Reddy's anti-Muslim remark, demands apology

Hyderabad: BRS working president KT Rama Rao found fault with Chief Minister A Revanth Reddy for his controversial remark that there are no Muslims without the Congress. Condemning the statement as insulting, he demanded an unconditional apology from the Chief Minister to the Muslim community. "Muslims existed long before the Congress was formed. Revanth Reddy should come out of his ignorance. Just like there will always be Hindus even if there is no BJP, Muslims will remain even if there is no

Congress," he asserted. Stating that the Chief Minister's comment was a desperate attempt to communalise politics ahead of the Jubilee Hills bypoll, he said Revanth Reddy and Prime Minister Narendra Modi shared a "Fevicol bond," as a Congress-BJP joint government was effectively running Telangana.

"While Rahul Gandhi accuses the CBI and ED of be ing political tools of the BJP, Revanth Reddy happily handed over the Kaleshwaram project case to the same agencies. What more proof is needed to show his double standards? he asked. Referring to the ACB case against him in the Formula-E race controversy, the former Minister said the Governor had already permitted prosecution but the Congress government stalled it since the charges were baseless. He countered the allegations by daring the Chief Minister to undergo a lie detector test together on a public platform."I am ready for a lie detector test on the Formula-E race case. Let Revanth Reddy also take one in the ACB case on the Cash for Vote scam. People will know who is the real culprit," he said. BRS govt spent Rs 5,328 crore on Jubilee Hills development, says KTR

Hyderabad: BRS working president KT Rama Rao on Wednesday released the Jubilee Hills Progress Report, detailing the development and welfare works undertaken in the constituency during the BRS regime from 2014 to 2023. He said the previous government had spent Rs 5,328 crore for infrastructure, housing, welfare and social development, directly benefiting over 2.12 lakh people. According to the report, the highest expenditure of Rs 2,463 crore went toward public transport and roads, including the Rs 333-crore Shaikpet flyover, Rs 408 crore for road maintenance under the CRMP scheme and Rs 1,722 crore for an 8.4-km Metro Rail stretch. The BRS government spent Rs 919 crore on public health, which included Rs 900 crore for the Telangana Institute of Medical Sciences (TIMS) at Erragadda, and funds for KCR Kits, Kanti Velugu, nutrition kits and Arogya Lakshmi schemes

For housing, Rs 324 crore was used for constructing double-bedroom houses. In the social welfare sector, Rs 705 crore was spent on schemes such as Aasara pensions (Rs 564 crore for 25,905 beneficiaries), Shaadi Mubarak and Kalyana Lakshmi (Rs 63 crore for 6,320 families), Dalit Bandhu (Rs 10.6 crore), BC Bandhu (Rs 3.8 crore), and Ramzan and Christmas festive support for over



1.11 lakh beneficiaries. The report said Rs 87 crore was spent on education, Rs 44 crore on infrastructure and safety including CCTV and street lights, Rs 505 crore on electricity maintenance, Rs 180 crore on drinking water projects such as the Boradanda reservoir and HS 75 crore on sew age system upgrades under Strategic Nala Development Programme (SNDP). For environmental greening, Rs 26 crore was spent on parks, lakes and disaster management. "Every rupee spent reflects our commitment to making Jubilee Hills a model constituency," Rama Rao

KTR dares Revanth Reddy for open debate on Hyderabad's development record

Hyderabad: BRS working president KT Rama Rao on Wednesday dared Chief Minister A Revanth Reddy for an open debate on Hyderabad's development during the 10 years of BRS rule versus the two years of Congress governance. He asked the Chief Minister to fix the date, time and place for the debate. "Let's settle who developed Hyderabad and who ruined it. I am ready to come anywhere, whether it is his Jubilee Hills palace, the Integrated Command Control Centre, Gandhi Bhavan or the Assembly. If Revanth Reddy is honest and courageous, let him come for a debate. The people will see who has delivered and who has destroyed," he said. Unveiling the Jubilee Hills Constituency Progress Report at Telangana Bhavan, Rama Rao said the Chief Minister was speaking out of frustration after sensing defeat in the Jubilee Hills by-election. "We can speak to him in a language he understands, but we choose restraint out of respect for his office, even if he does not respect it himself," he asserted. Explaining Hyderabad's transformation under the BRS regime, he said the K Chandrashekhar Rao government had built 42 flyovers and underpasses, while the Congress had neither laid a single new road nor filled even a single pothole. He ridiculed the Chief Minister for merely inaugurating projects completed under the BRS rule without executing any new works. The Swachh Hyderabad initiative had turned the city into a model for urban governance, introducing thousands of Swachh autos and collecting 7.5 metric tonnes of garbage daily. "Hyderabad won 30 national and several international awards as India's most liveable city. Now, Congress has turned it into a cesspool," he said, pointing out that the



Congress government was billing citizens for water that was supplied for free during the BRS regime and forcing beopie to depend again on water tankers. Chandrashekhar Rao government had built one lakh double-bedroom houses in Hyderabad, while the Congress regime demolished thousands without building new ones.Rama Rao reminded that the BRS had completed the Hyderabad Metro Rail, ensured 24-hour power supand illuminated Telangana with LED installations. "Now, power cuts are back. Show us one LED installed by your government," he said, also slamming Revanth Reddy for intimidating L&T officials connected to the Metro project and forcing them to exit the project. The BRS government had developed over 16,000 nurseries across Telangana, while Congress had cut trees and damaged biodiversity in its alleged plan to sell Hyderabad Central University land worth Rs 10,000 crore

TVK declares independent contest, Vijay named Chief Ministerial candidate

Chennai: Bringing to a close weeks of political speculation, the Tamilaga Vettri Kazhagam (TVK) on Wednesday announced that it would contest the 2026 Tamil Nadu Assembly elections independently, with its founder and actor Vijay named as the party's Chief Ministerial candidate. The decision was formally announced at the party's special general council meeting held at a private hotel in Mamallapuram. The meeting, presided over by Vijay, was attended by more than 2,000 general council members, party district secretaries, and office-bearers from across the State. The session began on a sombre note with a two-minute silence in memory of the 41 people who died in the Karur stampede during Vijay's rally on September 27. The tragedy, which had cast a shadow over the party's activities, was acknowledged as a "painful lesson" that strengthened TVK's resolve to ensure better safety measures at future public events.

During the meeting, the general council adopted 12 resolutions setting the political and policy tone for the upcoming polls. One of the key resolutions urged the Election Commission of India to halt the ongoing Special Intensive Revision (SIR) of electoral rolls, alleging that the exercise could disenfranchise eligible voters. The TVK accused both the DMK government in the State and the BJP-led Union government of "failing to protect Tamil interests", particularly in connection with the repeated arrests of fishermen by the Sri Lankan Navy. Another resolution condemned what it described as the "shocking deterioration" of law and order in Tamil Nadu, pointing to the Coimbatore college student sexual assault case as evidence of the State's "failure" to ensure women's safety. The council also raised concerns

about the hardships faced by delta farmers following delays in paddy procurement and the sprouting of harvested crops in fields, and criticised the government's alleged inaction against encroachments on wetlands. It further demanded the publication of a White Paper on industrial investments to bring transparency in job creation and infrastructure development. The resolutions reaffirmed that decisions regarding electoral alliances would be taken only by Vijay and that the party would spearhead its own front in the 2026 elections. Meanwhile, police removed party banners and restricted flag displays around the venue, citing

Revanth Reddy threatening Jubilee Hills voters, says BRS

Hyderabad: Former MLA Balka Suman charged Chief Minister A Revanth Reddy with intimidating voters ahead of the Jubilee Hills by-election, calling his remarks a new low in the State politics. He said no Chief Minister in the country's history had ever resorted to threats dur-

Addressing a press meet at Telangana Bhavan, Suman stated that the fear of defeat was visible in Revanth Reddy's statements and his impatience could be sensed from his personal attacks on BRS working president KT Rama Rao. He accused the Congress government with unleashing a State-sponsored intimidation, citing attacks on the BRS activists in Jubilee Hills constituency.

He said Congress candidate Naveen Yadav and his associates were threatening BRS supporters and questioned how a person with a criminal background was allowed to serve as Naveen Yadav's chief election agent. Meanwhile, BRS minority leaders accused the Congress of betraying Muslim voters. BRS leader Mukheeb Chanda said Muslims had lost faith in Revanth Reddy's leadership, considering his proximity to the BJP and failure to deliver on promises such as the construction of a graveyard in Borabanda. "Revanth Reddy repeatedly backtracked from promises made to the minorities especially burial grounds for Muslims. Mohammed Azharuddin was given a Cabinet berth, only as a poll tactic," he added.

NASA-ISRO's NISAR satellite to be declared operational on Nov 7, says ISRO chief

New Delhi: NASA and ISRO are all set to declare their first-ever jointly developed NISAR satellite operational on Friday, ISRO chairman V Narayanan said here on Wednesday. The NASA-ISRO Synthetic Aperture Radar (NISAR), said to be the most expensive Earth observation satellite ever built, has the ability to monitor most of the planet's land and ice surfaces twice every 12 days. The 2,400 kg NISAR satellite was launched on July 30 from ISRO's Satish Dhawan Space Centre using the GSLV rocket. "Entire data calibration has been completed, and we will have a conclave on November 7 to declare the satellite operational," Narayanan said at the Emerging Science, Technology and Innovation Conclave (ESTIC) here. The NISAR mission is the first to carry two SAR systems - the L-Band and S-Band sensors. The Lband radar can penetrate forest canopies and measure soil moisture, forest biomass, and the motion of land and ice surfaces. The S-band radar is more sensitive to small vegetation, and can observe certain types of agriculture, grassland ecosystems and moisture in snow. Both sys-

tems can collect data through clouds and precipitation, day and night. "All the data is very outstanding. Every 12 days, the Earth can be scanned, and it is going to be a highly useful satellite," Narayanan said. The ISRO chief also said the first uncrewed mission of the Gaganyaan project - India's human spaceflight programme - is expected to take place in January, with plans to send its astronauts into space on a home-built rocket by 2027. Narayanan said over 8,000 tests have been carried out for the mission so far, and ISRO plans to conduct three uncrewed missions before sending astronauts to orbit the Earth. He said India also plans to launch the first module of the Bhartiya Antariksh Station by 2028 and make the complete five-module orbital lab operational

Intense battle on in Bengaluru for a 'new' Congress CM

The penultimate month of 2025 has begun in an un expectedly turbulent manner in Karnataka. After all, the struggle for the pinnacle of power in the south-wester state of India -the CM post - had been set in motion righ from the day Congress assumed power in May 2023. While it is still unclear whether it had the backing of the high com mand or not, it seemed like there was an undeclare agreement between the top two leaders - Chief Ministe Siddaramaiah and his deputy D K Shivakumar - that the two would trade places at the midpoint of the five-year government, which happens to be this month.

As the deadline drew near, the pulls and pressures from both lobbies started impacting the political atmo sphere in the state for some weeks now. While the CM who has survived similar power struggles throughout hi long career, emphatically denied existence of any such power-sharing arrangement and asserted that he woul last the full term, the Deputy CM, also the state unit chie was not openly contradicting it yet had enough backer within the state Congress unit and government to raise call in his favour. After having joined the Congress nearl 20 years back, Siddaramaiah has proved to be more use ful and effective to the New Delhi power lobby. His smar usage of the potent minority and backward caste cards have kept his detractors a little wary of what his next move could be and presumably, a better candidate for remain ing at the top of the helm. In contrast, a life-long Congress man, Shivakumar, has been feted for his crisis manage ment dexterity and ability to raise funds for various politi cal wheeling-dealing in States where Congress is in power Yet, he has been deprived of the CM chair as he doesn have the aggregating influence of his arch-rival,



MMRDA's 70 KM Underground Tunnel Project -A Game-Changer For Mumbai's Traffic Problems

This underground tunnel project constitutes the construction of network tunnels across Mumbai connecting key locations and roads. An official from MMRDA had elucidating the 3 phases told "To avoid congestion and bottlenecks in city the project is aimed to divert through traffic via underground tunnels". ""- Phase 1: A 16-km tunnel linking Worli (coastal road) to BKC and Mumbai Airport Terminal 2."-Phase 2: A 10-km stretch connecting both express highways with direct airport access."- Phase 3: A 44-km northsouth corridor to streamline freight and commuter traffic. ""MMRDA plans to take up the implementation of first phase immediately in which a feasibility report is being prepared that helps in finalising cost estimates, construction methodology and essential approvals and permissions.""The first phase of the project is a tunnel which is nearly 16 km long tunnel linking Worli (coastal road) to BKC and Mumbai Airport Terminal 2, also provides connectivity to the proposed Mumbai-Ahmedabad bullet train



station at BKC. "The second phase of the project connects two major thoroughfares - the Eastern Express Highway that links commuter belt on the eastern part of the city and Western Express Highway that links commuter belt on the western part of the city. "The third phase is a longest tunnel which is roughly 44 km long north-south corridor that serves freight and commuter traffic.

Road Closure at Dammaiguda Anushakthi **Nagar Causes Major Inconvenience to Siddhartha Colony Residents**

CHRONICLE): "Residents of Siddhartha Colony are facing severe inconvenience after a few individuals allegedly blocked the main road connecting Anushakthi Nagar Water Tank to the colony. The closure of this key route has forced residents to take a long detour through the main road,

adding several hundred meters to their daily travel. Locals said the issue is affecting everyone schoolchildren, elderly people, and daily commuters as they struggle to reach schools, hospitals, and workplaces. They questioned the authority behind closing the road and demanded that immediate action be taken to reopen it. Residents stated that they have been submitting petitions to officials and local representatives for years, but their requests have been ignored. They expressed frustration that no one has paid attention to their repeated appeals.

The situation has worsened further after underground drainage works, which began recently, were left incomplete midway. Residents

accused those responsible for the road closure of acting for their own personal benefit while violating the public's right to free movement. They urged authorities to intervene and restore access to the blocked road immediately.

In a meeting organized at the Integrated District Collectorate Building Conference Hall in the district center on Tuesday, District Additional Collector (Revenue) David along with officials of the district agriculture, marketing, transport, fire and police departments, CCI officials and ginning mill owners held a review on cotton purchase, arrangements in ginning mills, management of the Cotton Kisan mobile app- awareness to farmers, and safety measures in ginning mills. Speaking on the occasion, the District Collector said that the ginning mill owners, CCI and marketing officials should complete the necessary arrangements for the purchase of cotton for the 2025-26 season. He said that

cotton was cultivated in 3 lakh 30 thousand acres in the district this season and that there is a possibility of a cotton yield of 38 lakh quintals and arrangements should be made in that direction. He said that the support price for cotton has been fixed at Rs 8,110 and steps should be taken to purchase cotton under the auspices of CCI through 24 ginning mills in the district. Auto Driver Dies After Attempted Self-Immolation Near Traffic Police Station

Police said the man took the extreme step after being caught in a drunk-and-drive check. According to police, the deceased, identified as Singireddy Meen Reddy (32), a resident of Bhagat Nagar, Jawahar Nagar, Jammigadda, was earning his livelihood by driving a rented auto (registration number AP 28 Y 1789). On November 4, 2025, at around 8:30 PM, Kushaiguda Traffic Police were conducting drunk-and-drive checks at Radhika Crossroads. Meen Reddy was found driving the auto under the influence of alcohol. Police seized the vehicle and informed him that it would be released only if a sober person came on his behalf to collect it. Disturbed by the incident, Meen Reddy reportedly poured petrol on himself near the traffic police station around 10:20 PM and set

Locals and police personnel immediately alerted emergency services, and a 108 ambulance shifted him to Gandhi Hospital for treatment. However, due to severe burn injuries, he died at around 5:10 AM on Wednesday (November 5) while undergoing treatment. Preliminary investigations suggest that Meen Reddy had been struggling with alcohol addiction and financial difficulties for a long time. Police believe he was mentally distressed and feared that the auto owner would confront him after the vehicle was seized, which led to his drastic decision. Malkajgiri Police have registered a case and initiated an investigation.

Journalists Demand House Sites – Govt Should Not Cite Court Verdicts as Excuse: Greater Journalists Housing Society Appeals to CM"

Pune Metro to develop 508 metre footoverbridge, to benefit those using Bengaluru-Mumbai national highway

With the construction for extension of Metro Line 2 from Vanaz to Ramwadi set to begin soon, the Pune Metro is gearing up to provide access to those travelling by the Bengaluru-Mumbai national highway bypass at Chandni Chowk through a 580-metre-long foot-overbridge. The Chandni Chowk on the Bengaluru-Mumbai bypass has always been a busy location with those travelling via state or private buses between Bengaluru-Kolhapur-Sangli-Satara-Konkan region and Mumbai either alight at the location to enter Pune city or board vehicle to travel to other locations, including various cities on the highway. Similarly, those travelling to Rajiv Gandhi Infotech Park at Hinjewadi or industrial area at Chakan, Shirwal, Khandala, Pirangut use the Chandni Chowk junction on the national highway as bus stand. The national highway is also used as an easy access to hilltown of Lonavala and Mahabaleshwar on either

The two mega sports facilities – Chhatrapati Shivaji Sports Complex at Balewadi and Cricket stadium at

Gahunje which holds various international, national and premiere league sports events are alongside the highway. There are many prominent educational complexes alongside the national highway making the road the busiest one for commuting. While extending the route from Vanaz to Chandni Chowk to 1,123 metres there will be two stations Kothrud Depot and Chandni Chowk. "The Pune Metro has decided to make access easy for public travelling via national highway at Chandni Chowk and has planned construction of a 580 mete-long foot over bridge," said a Pune Metro officer. This Metro footover bridge will be connected to the National Highway Authority of India (NHAI) footover bridge across the national highway at Chandni Chowk for the public to cross the busy national highway, he said, adding this would enable citizens to go to either side of the national highway. From the opposite side of Metro service, commuters can now cross the road and then take the proposed footover bridge to reach Chandni Chowk Metro station. Also, the Pune Metro has planned an integrated double decker flyover above the existing road level at Kothrud depot like the one on Karve Road to address the traffic issue. The two stations to be developed at Kothrud depot and near Chandni Chowk will be 140 metres long and 21 metres wide. In June, the Central Government had given its nod for extending the Metro route from Vanaz to Chandni Chowk so that a continuous link to Wagholi Metro corridor will strengthen East-West mass transit in Pune.

The Maha-Metro is operating Pune Metro Line 1 from Pimpri Chinchwad Municipal Corporation (PCMC) to Swargate and Line 2 from Vanaz to Ramwadi, while Pune Metro Line 3 from Shivajinagar to Hinjewadi is being executed by Pune Metropolitan Road Development Authority (PMRDA). The operation of the Pune Metro Phase 1 lines, including Line 1 – PCMC to Swargate and Line 2 – Vanaz to Ramwadi, of the Pune Metro Rail Project has begun.

Can't deny career benefits due to FIR: HC directs Punsup to promote employee

Justice Harpreet Singh Brar held that Singh, who joined Punsup as a clerk in 2001 on compassionate grounds after his father's death, should be treated as a confirmed employee from In a significant relief to a long-serving employee, the Punjab and Haryana High Court has ordered the Punjab State Civil Supplies Corporation Limited (Punsup) to grant annual pay increments to Pritpal Singh, confirm his permanent status, and consider him for promotion and other career benefits. The court set aside a June 2024 order by the corporation that had denied these benefits, citing a pending police case against him.

Justice Harpreet Singh Brar held that Singh, who joined Punsup as a clerk in 2001 on compassionate grounds after his father's death, should be treated as a confirmed employee from October 15, 2004. This is because he continued working beyond the maximum three-year trial period without any formal extension or dismissal, making his confirmation automatic under service rules. The case stemmed from Singh's appointment letter, which required him to pass a typing test as a condition of service. He cleared it in March 2020, but Punsup withheld his increments and other perks, linking the delay to a 2017 police case filed by the vigilance bureau. No formal charges have been framed in that case to date, and Singh argued that the corporation could not penalise him solely on the basis of the ongoing investigation. Justice Brar rejected Punsup's stance, emphasising that a minor penalty from separate proceedings does not bar financial benefits like increments or pro-



motions. He observed that denying earned increments amounts to punishing someone without fault. "It would be punishing a person for no fault of his," the court quoted the apex court, adding that increments can only be withheld as a formal punishment after proven inefficiency or misconduct. The high court further reasoned that an annual increment recognises services already rendered in the previous year and is a vested right, separate from future assessments. "The mere registration of a police case does not equate to misconduct or guilt but serves only as a marker of a future investigation whose outcome remains uncertain, the judgment stated. Consequently, the court quashed Punsup's June 13, 2024, order and directed the corporation to grant Singh notional increments from October 15, 2002, with actual payments starting from the date he passed the typing test. It also ordered confirmation of his trial period completion from October 15, 2003, and consideration for promotion and the career progression scheme as per rules. The corporation has three months from receiving the

'SDM hoon main': Police probe video of scuffle between RAS officer, petrol pump staff in Bhilwara

Police are investigating claims and counter-claims after a video emerged purportedly showing a Rajasthan Administrative Service (RAS) officer slapping a petrol pump worker for not prioritising the refuelling of his car in Bhilwara. The Sub-Divisional Magistrate (SDM), Chhotu Lal Sharma, however, claimed the staff had misbehaved with his wife and made inappropriate remarks.

The video, captured at the petrol station on Tuesday, purportedly shows Sharma getting out of his car and shouting at the petrol pump staffer, who was refuelling another vehicle. He allegedly shouts, "Main SDM hoon, SDM hoon main yahan ka ... pehle tereko pata nahi gaadi lagi hui hai (I am the SDM here, don't you know my vehicle is here)" and gets into a scuffle with the worker. As another staff member tries to intervene, the SDM allegedly slaps him, who then slaps the SDM back. The SDM's wife then steps out, with Sharma allegedly going after the staff member and

shouting at him for daring to slap the SDM. The incident took place at 3:44 pm on Tuesday in Rayla, Bhilwara, while the SDM is currently posted in Pratapgarh district. Later, the SDM's wife submitted a complaint claiming that the petrol pump staff winked at her and misbehaved with her. In her complaint, she claimed that they were headed home to celebrate Diwali and stopped to get fuel. "The person who was refuelling winked at me, which angered my husband. He then scolded the staff member, who then started refuelling another vehicle behind us, instead of ours," she alleged in her complaint, claiming that the staff also used objectionable language with her. "My husband then stepped out, and three people started assaulting him. The petrol pump owner came and he also started abusing," she claimed.

As per Bhilwara police, three staff members of the petrol pump were arrested and subsequently let go. Bachhraj Choudhary, SHO of Rayla police station, told The Indian Express, "We are investigating her complaint, but prima facie, there was no eve-teasing. There are CCTV cameras, and the entire incident was captured." He said that no FIR has been lodged in the case so far, and the petrol pump owner and staff have not filed a complaint. "The three persons were arrested and taken in preventive custody, presented before the tehsildar, and then released," the SHO said. In response to the alleged incident, Leader of Opposition Tika Ram Jully said, "After reviewing the CCTV footage and media reports that have surfaced in the dispute between the SDM and petrol pump employees in Bhilwara, this case also appears to involve misconduct by the SDM towards the petrol pump workers. However, in this matter, an FIR has also been filed by the SDM against the petrol pump employees, and the police have arrested them as well.""The Bhilwara Superintendent of Police should personally monitor this case to ensure justice is served. It should not be the case that injustice is done to the poor due to the arrogance of power," he

'Scheme to buy votes': Opposition targets Maharashtra govt after report highlights irregularities in Ladki Bahin Yojana

Opposition leaders in Maharashtra have raised concerns over the implementation of the Mukhyamantri Majhi Ladki Bahin Yojana, following an Indian Express report on October 22 that highlighted irregularities in the scheme aimed at supporting women. Congress MLA Vijay Wadettiwar criticised the government, stating that the scheme was introduced with the Assembly polls in mind, and once the civic body polls are over, the scheme will be scrapped

"The state government introduced the Ladki Bahin scheme ahead of the Assembly elections to influence voters. Funds were distributed indiscriminately, but now irregularities have come to light. Men were among the beneficiaries," said Wadettiwar. "Earlier, there was no transparency in the scheme. The government is now imposing arbitrary conditions. The scheme will likely be discontinued after municipal and district council elections. No matter what ministers say, the scheme will be stopped."The Maharashtra Pradesh Congress Committee (MPCC) posted on X, "Schemes launched just to lure votes and their implementation are two different things. This shabby, mismanaged government is good only at announcements and publicity. What else can one expect from leaders who introduce such schemes before elections to cover up vote manipulation?"Nationalist Congress Party (SP) spokesperson Clyde Crasto demanded a Special Investigation Team (SIT) probe into the matter. How 2 Mumbai cops stuck in a traffic jam ran into a murderer

A traffic jam, two Mumbai policemen returning home from work, and a call for help. More than a decade ago, this sequence of events unexpectedly set into motion the unravelling of a murder case. It was October 10, 2014. Two policemen returning home after a long day's work were stuck in traffic in the western suburbs of Goregaon. While they were near Oberoi Mall, they saw a man gesturing with his hands, screaming "Mujhe bachaao (save me)". The policemen approached the man and asked him why he was shouting. The man seemed to be intoxicated, and the policemen allegedly heard him say that he had assaulted someone using a screwdriver. The person may have died, he allegedly added. The policemen took the man to the Goregaon police station and handed him over to the on-duty station officer. When the police began questioning him, the man allegedly revealed that he had assaulted a man named Sandeep Dhamnaskar, his employer's neighbour. He also revealed that the incident had taken place at a local park.A police team was immediately dispatched to the scene. Soon, the police said, it was confirmed—the intoxicated man, later identified as Ranjeet Chauhan, had, in fact, committed a crime. According to the police, Chauhan and Dhamnaskar got into an argument over the latter's refusal to bring liquor. Dhamnaskar's wife, Bhakti, who was informed about the spat, rushed to the spot and saw people running helterskelter. According to eyewitnesses, Chauhan began attacking Dhamnaskar multiple times with a screwdriver. Bhakti also allegedly witnessed the assault. She intervened and, with the help of others, rushed Dhamnaskar to the hospital, where he succumbed to his injuries. Chauhan fled—only to run into the police at the traffic jam. During the trial before the sessions court, the police relied on the statement of Bhakti, who had witnessed the assault, and the testimony of the two policemen who had seen Chauhan. The sessions court on October 17 found Chauhan guilty of murder and sentenced him to life imprisonment. The court said that while Chauhan admitting that he had killed a person after being apprehended by the two policemen in the traffic jam cannot be considered as a confession as it was made before the police, the circumstances of how he was caught and handed over to the police can be considered as evi-

How plastic whistles are becoming an anti-ICE resistance tool in Chicago



CHICAGO,GNS News Agency, Nov 5 As the shrill sound of whistles echoed through a parking garage in Chicago's North Side on Tuesday, two people flung their car doors open, ducked inside and shrank down into their seats. Outside, a convoy of federal immigration enforcement vehicles that had arrived in the area just minutes prior sped off. "We just saw a bunch of guys with whistles that chased them out," said Luke, a landscaper who was working nearby and declined to share his full name.

The Trump administration in early September launched a targeting what it said were hardened criminals among immigrants in the U.S. without legal status, though many noncriminals have been swept up in raids.

Agents have teargassed crowds, rappeled from a Black Hawk helicopter to raid an apartment building, dragged immigrants from cars, held people at gunpoint and shot two people, including one fatally. Against this heavily militarized force, whistles have

become a modest but effective tool to fight back."It grew like wildfire," said Baltazar Enriquez, president of Little Village Community Council, a community group in one of Chicago's largest Latino enclaves. "If we have to patrol our neighborhood for the next three years, we're willing to do that just to keep our community safe. "The group began handing out the whistles to neighborhood residents over the summer. and local activist groups have passed out the whistles at local festivals and parades and dropped them off at Little Free Libraries. Some residents have picked up whistles from community groups that advertised them on social media - others have simply bought them from dollar stores and Amazon."Our officers are highly trained," said Tricia McLaughlin, assistant secretary for public affairs at the Department of Homeland Security, and "they are not afraid of loud noises and whistles."Their ease of use and low cost have contributed to their soaring popularity on the streets and on social media. But the impact of a whistle against squads of armed, fast-moving immigration officers is limited.On a quiet residential street in another North Side neighborhood, residents ran out of their apartments to confront ICE officers as they detained a group of landscapers. Vance says Trump's policy rejects Israeli annexation of West Bank

TEL AVIV, GNS News Agency, Nov 5- U.S. Vice President JD Vance said on Thursday President Donald Trump would oppose Israeli annexation of the occupied West Bank and it would not happen, suggesting a move by Israeli lawmakers to that end looked like a stupid "political stunt". A bill applying Israeli law to the West Bank, a move tantamount to annexation of the territory Israel captured in the 1967 Middle East war, won preliminary approval from Israeli lawmakers on Wednesday. Asked by reporters about the move, Vance said: "If it was a political stunt, it is a very stupid one, and I personally take some insult to it."Vance spoke after U.S. Secretary of State Marco Rubio warned that moves toward annexing the territory that endanger Trump's plan to end the Gaza war, which has yielded a shaky ceasefire so far. "The West Bank is not going to be annexed by Israel. The policy of President Trump is that the West Bank will not be annexed. This will always be our policy," Vance said during a trip to Israel to help shore

Israeli Foreign Minister Gideon Saar said after Vance's remarks that the government had not decided to bring the vote on annexation forward at this stage in order to ensure the success of Trump's multi-stage Gaza plan. The U.S. has long been Israel's most powerful and staunch major power ally and the Trump administration is particularly close to Israel with considerable sway over its leadership. Senior U.S. officials including Rubio have been visiting Israel seeking to keep alive the brittle ceasefire between Israel and Palestinian militant group Hamas after two years of devastating war that has upended the Middle East. Vance told reporters in Tel Aviv that he "feels pretty good" about the Gaza ceasefire after having talks with Israeli Prime Minister Benjamin Netanyahu. Repeated bouts of gunfire and explosions have shaken the deal and the two sides have traded blame for violations of its first phase, which has seen the return of Israeli hostages in exchange for Palestinian prisoners, a handover of bodies of some deceased hostages, and a partial pullout of Israeli troops.

The U.S. State Department said Rubio was visiting Israel to support the implementation of Trump's 20-point Gaza plan and pave the way towards reconstruction, stable governance and possible steps towards Palestinian statehood. He was preceded by Vance, who was also due to meet Israeli Defence Minister Israel Katz and Strategic Affairs Minister Ron Dermer on Thursday before

There are hundreds of thousands of people living in Jewish settlements across the West Bank. The United Nations and much of the international community consider the settlements illegal under international law. Israel's government cites biblical and historical connections to the West Bank, territory that it regards as disputed, and opposes the establishment of a Palestinian state. The settlements are a highly volatile issue that have for decades loomed as a major obstacle to Middle East peace, as they fragment territory Palestinians want for a viable state. Wednesday's vote was the first of four needed to pass the law and coincided with Vance's visit to Israel - a month after Trump said he would not allow Israel to annex the territory. Netanyahu's right-wing Likud party did not support the legislation, which was sponsored by lawmakers outside his ruling coalition and passed by a vote of 25-24 out of 120 lawmakers. Netanyahu's government had been pondering annexation as a response to a string of major Western allies recognising a Palestinian state to put pressure on Israel to stop its war in Gaza, but appeared to shelve the idea after Trump objected. Settlement building has been expanding rapidly since 2022 when Netanyahu's government - the most right-wing in Israeli history with ultra-nationalist coalition partners who seek annexation of both the West Bank and Gaza - came to power.

Zelenskiy appeals to EU leaders over long-range weapons

BRUSSELS -GNS News Agency, Nov 5 President Volodymyr Zelenskiy urged European allies on Thursday to supply Ukraine with long-range weapons after failing to secure a promise from U.S. President Donald Trump to provide Kyiv with powerful Tomahawk missiles. Zelenskiy, who addressed European Union leaders in Brussels, also called on them to agree as soon as possible on a plan to use frozen Russian assets and said Kyiv would use a "significant part" of any funds made available to buy Europeanmade weapons. "When we talk about long-range weapons for Ukraine, we mean that the Putin regime should feel real consequences from this war. I urge you to support everything that helps Ukraine get such capabilities — because it really makes a difference for Russia," he said. "Just look at how nervous (Russian President Vladimir) Putin became when this topic came up. He understands that long-range weapons can truly change the course of the war. "Zelenskiy has been seeking Tomahawk missiles from the United



States. Trump did not rule out providing Kyiv with such missiles during talks in Washington with Zelenskiy last week but appeared cool to the prospect."These long-range weapons are not only in the U.S. - some European countries also have them, including Tomahawks. We are already talking to the countries that can help,"

Northern Ireland court finds soldier not guilty of murder over 'Bloody Sunday' killings



BELFAST, GNS News Agency, Nov 5A Belfast court on Thursday found a British soldier not guilty of murder in the only trial of a member of the British armed forces over the 1972 "Bloody Sunday" killings of 13 unarmed Catholic civil rights marchers in Northern Ireland. The British government in 2010 apologised for the "unjustified and unjustifiable" killings, when members of the British army's elite Parachute Regiment opened fire in the mainly Irish nationalist city of Londonderry in one of the defining moments of Northern Ireland's recent history.

Sign up here.But all efforts to prosecute soldiers have failed and many relatives of victims and their supporters now believe the chance of a successful prosecution of British armed forces is remote.Belfast Crown Court was silent when the verdict was read. The soldier, who cannot be identified legally and is known as Soldier F, was in court but hidden behind a blue curtain to protect his identity.He was found not guilty of killing two men and trying to kill five others.Judge Patrick ?Lynch said in his verdict that he was satisfied that soldiers had lost all sense of military discipline and opened fire with intent to kill and that "those responsible should hang their heads in shame".But he said the case fell short of the burder of treef

"Delay has, in my view, seriously hampered the capacity of the defence to test the veracity and accuracy of the hearsay statements," he said. "The evidence presented by the Crown ... signally fails to reach the high standard of proof required in a criminal case; that of proof beyond a reasonable doubt. "Mickey McKinney, brother of William McKinney, one of the two victims named in the case, said he put the blame for the failure to successfully prosecute any soldiers squarely with the British state. "Soldier F has been discharged from the defendant's criminal dock, but it is one million miles away from being an honourable discharge," McKinney told journalists outside the court.A DE-FINING MOMENT OF NORTHERN IRELAND'S 'TROUBLES'Bloody Sunday became one of the defining events of the Troubles, three decades of sectarian violence involving nationalists seeking a united Ireland, unionists wanting Northern Ireland to remain a province of the United Kingdom, and British forces. The shootings fuelled suspicion of the authorities among the Catholic minority and prompted dozens to join the Irish Republican Army's violent campaign against British rule. Thirteen people, all unarmed Catholics, were killed when the soldiers opened fire in the staunchly nationalist Bogside area of Londonderry on January 30, 1972. A 14th victim later died from wounds sustained on the day. The troops said they shot at people armed with guns or nail bombs.

Defence lawyers did not call any witnesses and said that the core of the case, military statements taken over 50 years ago, were manifestly unreliable, with no independent supporting evidence offered to back the prosecution case. Earlier in the trial the court heard a short statement Soldier F gave to police in 2016, in which he said that while he was sure he properly discharged his duties as a soldier that day, he no longer had any reliable recollection of the events and therefore was unable to answer the officers' questions. The British government in 2010 apologised for the killings after a judicial inquiry found that the victims were innocent and had posed no threat to the military. That inquiry had been set up by British Labour Prime Minister Tony Blair in 1998, after an original 1972 investigation absolved the paratroopers of blame. In a statement on the verdict the British government said it was "committed to finding a way forward that acknowledges the past, whilst supporting those who served their country during an incredibly difficult period in Northern Ireland's history.'

What will happen to Louvre jewellery after heist? There are two likely scenarios

The spectacular heist of jewellery from the Louvre museum in Paris has many people wondering how a theft like this could occur in broad daylight and what might happen to the items that were stolen from the museum.In a first-floor window, break into secure glass displays, and take nine items of jewellery of immeasurable value. Although an alarm was set off and museum guards were nearby, the thieves were able to escape quickly, using motor bikes to get away. They dropped one stolen item, a diamond and emerald-encrusted royal crown that had belonged to Empress Eugenie. Napoleon III's wife. Their loot include iewellerv from French imperial times - brooches, necklaces, earrings and a tiara. The French prosecutor's office said the jewels were worth some 88 million euros (A\$157 million), not including their historical value. The speed and professionalism of the heist shows this was a well-planned crime, carried out by highly skilled perpetrators. That suggests they are linked to organised criminal groups. Several media outlets reported a number of smaller thefts from French museums in recent weeks, including gold nuggets from the Paris Natural History Museum. There is no suggestion these

What might happen to the loot?

The stolen jewellery includes well-known pieces that are easily recognisable. This will make it difficult, if not impossible, to sell them on the black market, even to well-heeled collectors and buyers. This problem is well-known from other museum heists – such as the theft of the Canadian "Big Maple Leaf" giant gold coin from Berlin's Bode Museum in 2017 or the famous heist of 13 masterpieces by Degas, Manet and Rembrandt from the Isabella Stewart Gardner Museum in Boston in 1990. Those paintings have never been recovered. Instead, most experts believe one of two scenarios are more likely. In the first, the jewellery would be broken down into smaller pieces. Diamonds and other gemstones may be taken out, altered and then offered for sale. Silver and gold may be used to manufacture

other pieces or may be sold separately.

This scenario would make it easy to conceal the origin of the pieces and sell them openly or online. The combined value, however, would be significantly lower compared to leaving the pieces intact. It is thus doubtful the thieves targeted the specific jewellery for this purpose. Scenario two would involve the thieves, or more likely the masterminds behind them, trying to sell the pieces back to the Louvre or trying to extort money from the French government for their return. This may be done through brokers or other middlemen and may not happen for a while, until there is less public and media attention and the perpetrators feel sufficiently safe to contact - directly or indirectly museum or state authorities. Given the historical significance of the pieces coupled with the embarrassment caused by the heist, the Louvre and the French government would be keen to have the pieces returned as swiftly as possible and might be willing to negotiate, albeit secretively. Much of this remains, however, speculation. Only a few days have passed since the heist occurred and many questions about the events, perpetrators and their motives remain unanswered. And just who may be behind this spectacular heist from France's largest museum has everyone guessing. The Louvre theft brings to mind the jewellery heist at the Green Vault at the Zwinger Palace in Dresden, Germany, in 2019. In this case, the perpetrators had closely examined the museum's security system for many days and were able to enter the building without being caught on camera. They entered through a window on the first floor and within minutes stole 21 pieces of jewellery from several displays. Unlike the Paris heist, the Dresden thieves entered at night and used brute force to damage the displays to take their loot. Some years after the robbery. German authorities were able to identify and arrest the thieves involved in the heist - all five were members of a notorious Berlin-based crime family. The perpetrators have since been tried and convicted and are serving long jail times. Most of the jewellery was retrieved and returned - unaltered - to its famous home.

Saudi Arabia appoints Sheikh Saleh bin Fawzan al-Fawzan as kingdom's new grand mufti

Dubai: Saudi Arabia appointed a prominent ultraconservative scholar late on Wednesday as the country's new grand mufti, the kingdom's top religious scholar. Sheikh Saleh bin Fawzan al-Fawzan, 90, took over the position, the state-run Saudi Press Agency reported. The decision came from King Salman, based on the recommendation of his son, Crown Prince Mohammed bin Salman, the report added

Sheikh Saleh, reportedly born Sept 28, 1935, in Saudi Arabia's al-Qassim province, studied the Quran with a local imam after his father's death. He became a prominent scholar, speaking to the faithful via the "Noor ala al-Darb," or "Light the Way," radio show and via multiple books he's authored and his television appearances. His fatwas, or religious orders, have been shared via social media as well.

Sheikh Saleh has faced criticism in Western media in the past for some of his pronouncements. Human Rights Watch in 2017 reported Sheikh Saleh, when asked if Sunni Muslims should view Shiite as their "brothers," responded: "They are brothers of Satan." The Shiite "lie about God, his prophet, and the consensus of Muslims... There is no doubt about the unbelief of these" people, Human Rights Watch separately quoted Sheikh Saleh saying at another moment.Such comments about the Shiite from religious leaders in Saudi Arabia are common, particularly amid political tensions between the kingdom and Iran. Sheikh Saleh also criticised Yemen's Houthi rebels for firing missiles toward holy sites in the kingdom. In 2003, Sheikh Saleh was quoted as saying: "Slavery is a part of Islam. Slavery is part of jihad, and jihad will remain as long as there is Islam." The sheikh also had a fatwa attributed to him in 2016 banning the mobile game "Pokemon Go" as a form of gambling. Saudi Arabia under Crown Prince Mohammed now owns a sizable stake in Nintendo and the gaming division



of Niantic, the maker of "Pokemon Go".

Sheikh Saleh takes the post after the September death of Sheikh Abdulaziz bin Abdullah al-Sheikh, who held the position of grand mufti for a quarter century. The al-Sheikh family, descendants of Sheikh Mohammed Ibn Abdul-Wahhab, long had seen its members serve as the grand

Sheikh Mohammed's ultraconservative teachings of Islam in the 18th century, widely referred to as "Wahhabism" in his name, had guided the kingdom for decades, particularly after the 1979 Islamic Revolution in Iran saw the kingdom grow even more conservative. The grand mufti is one of the top Islamic clerics in the world of Sunni Muslims. Saudi Arabia, home to the holy cities of Mecca and Medina, hosts the annual Hajj pilgrimage required of all able-bodied Muslims once in their lives, making the pronouncements of the grand mufti that much more closely followed. Saudi Arabia has socially liberalized under King Salman, allowing women to drive and opening movie theatres as the country tries to move its economy away from being dominated by its oil industry.

'Trust' issue among Tata trustees



Following his reappointment to the board of the Tata Trusts, Venu Srinivasan emailed his fellow trustees on October 21. The mail read: "My dear fellow trustees, thank you very much for the confidence reposed in me, and for the kind words that have been expressed. I sincerely, hope we will now work harmoniously." Fellow trustee Mehli Mistry, immediately responded: Dear Venu, it has always been our intention to work harmoniously together! The only problem earlier, was the lack of required information requested by us, which you all nominated directors have agreed to provide. We must bury the past, respect each other and move forward as a team unanimously! That's what Ratan would have expected to do."Even as it indicates the trustees search for harmonious functioning, this correspondence sums up the drama at Tata Trusts that began on September 11 when the reappointment of Vijay Singh to the Tata Sons Pvt. Ltd. (TSPL) board was opposed by four trustees - Mehli Mistry, Darius Khambatta, Jehangir H.C. Jehangir and Pramit Jhaveri. The core issue appears to be flow of information from the trustees nominated to the Tata Sons board back to the other trustees. The underlying trust (no pun intended) seems to have given way as the camp comprising the four trustees named above alleges that information has not been shared by the trustees nominated to the TSPL board, namely Noel Tata, Venu Srinivasan and Vijay Singh (he was a nominee until September 11).

They narrate instances of resolutions passed in the TSPL board that were not brought back to the Trust board as provided in Article 121 A of TSPL's Articles of Association. The said Article was introduced in 2014 and stipulates a range of actions of TSPL board that require affirmative vote by a majority of the Trust nominees (Article 121). The examples quoted range from the 3.8 billion euro acquisition of Italian commercial vehicle manufacturer IVECO by Tata Motors, where the trustees were informed towards the end of the deal, to the more contentious one where the TSPL board approved funding of ?1,000 crore to Tata International Ltd., a company of where Noel Tata is chairman, in April.

The group ranged against Mr. Tata hints at a conflict of interest here as Tata wears three hats — chairman of the trusts, its nominee on the board of TSPL and chairman of four group companies, namely Tata International, Trent, Tata Investment Corporation and Voltas. In addition, he's vice-chairman of Tata Steel and Titan. "How can you as the owner (representative of Tata Trusts) sitting on the board (TSPL) vote as director along with the board on a ?1,000 crore funding resolution related to a company (Tata International) where you're chairman and also approve it as a trust nominee?," asks a person speaking for a trustee. Sources close to Noel Tata however dismiss this. "They want every proposal over ?100 crore to be taken back to them for approval, which is not necessary," they aver. And according to them, if at all there is a conflict of interest. it is in Mehli Mistry's business dealings with Tata Power (he manages their logistics), while also being listed as a promoter of the company by virtue of his position as trustee on the Tata Trusts. This is violative of related party provisions in law, they allege. Ironically, Mehli Mistry was the one who had proposed and pushed for the appointment of Noel Tata as chairman of the trusts to replace Ratan Tata upon the latter's demise a year ago, according to a source. This was against opposition from a fellow trustee who wanted the position to be kept vacant. Story goes that this trustee hosted a dinner for three other trustees the day before the crucial trust board meeting where he persuaded them not to appoint Noel Tata. This move failed after Mehli Mistry, who was part of the dinner, proposed Noel Tata's name for

chairmanship in the board meeting the next day. Ask Mistry's camp why he did that and the answer is: "The Tata Trusts have to remain with a Tata!" There was also the worry that an empty chair could attract unwanted characters from outside. Sources close to Mr. Mistry underline that the trustees are even now not against Mr. Tata but they're sore about "lack of transparency" from him. "There is no issue between individuals on the trust board. It is an issue of issues," said a person who did not want to be identified.

This person also complains that when the crucial issue of IPO was discussed in the TSPL board, the information was not shared with the trustees. "We asked but were told that that 'we're not at liberty' to share with you," says the source. This response did not help because Tata is related by marriage to the Shapoorji Pallonji (SP) group which has been pushing for a TSPL IPO. The trustees then sought a meeting with N. Chandrasekaran through the three Trust nominees on the TSPL board but that did not happen until one of the other four, understood to be Jehangir H.C. Jehangir, approached Mr. Chandrasekaran with a request for an update. The latter immediately made a two hour presentation over dinner to all the trustees with full transparency including his vision for the group. Impressed by the presentation, Mehli Mistry is supposed to have mailed the other trustees the very next morning with a proposal to nominate Mr. Chandrasekaran for a third term as Chairman of TSPL. This was followed up with a unanimous resolution in the next trust board meeting. The Trusts also resolved that an IPO of TSPL was not in the best interests of the group and Mr. Chandrasekaran was asked to engage with the SP group on the subject. If there is one issue which both camps agree upon, it is on whether or not Tata Sons Pvt. Ltd (TSPL) should go public. The two sides are unanimous that an IPO of TSPL is not in the interests of both the group and the

"Why should we bail out the SP group now? Did they ask us before running up a debt of ?50,000 crore? And where has the money gone?," asked a person aligned with Noel Tata. When businessline queried about his personal relations, the person shot back saying that it had no impact on his decision. The feeling is that the philanthropic activities of the trusts and the group will suffer if public shareholders enter the equation. "When the telecom business folded up, the entire ?40,000-50,000 crore debt was discharged by TSPL though the business was housed in a separate company. We could've asked the banks to take a haircut but we repaid every rupee. That's the Tata ethos. Would this have been possible had TSPL been listed? Would the public shareholders allow this?," asks this person.

The response from the other four trustees is the same. The best interests of the group and the trusts will be served only by keeping TSPL private, they say, adding that neither TSPL nor the trusts should be pressured by the financial problems of a particular shareholder. They also point to how the group is now into sensitive and nationally important businesses such as semiconductors and manufacture of defence equipment which need to be kept out of the public eye. These are also long gestation projects that need continuous financial support with returns in the distant future. The implication is that this will not be possible if TSPL is listed as public shareholders would demand quick returns.

Chandra emerges strongerEven as the trustees quarrel among themselves, if there is one winner it is N. Chandrasekaran, Sources from both camps have nothing but praise for him with one pointing out that he's taken the group profits from ?850 crore (when he took over) to about ?27,000 crore now. They also point to his forays into new generation businesses such as electronics and semiconductors to support their decision to give him a third term. These businesses need to be nurtured and he's the best placed to do it, according to them. Ask them whose side is Mr. Chandrasekaran on now and they're both circumspect

"We don't know," is the reply that comes with some wariness built in. Indeed, given his perceived closeness to the powers-that-be in New Delhi, the two sides would rather was among the four who met Union Home Minister Amit Shah and Finance Minister Nirmala Sitharaman a few days ago. The others were Noel Tata, Venu Srinivasan and Darius Khambatta.Interestingly, though it was put out that the government had summoned them, sources close to the four trustees ranged against Noel Tata say that the meeting was arranged by Mr. Chandrasekaran at the former's request.

Study projects deaths due to pancreatic, colorectal and breast cancers to rise by 2030 in India



A recent disease-forecasting study — which analysed data from the Global Cancer Observatory (GCO) - has indicated a rise in cancers linked to lifestyle and metabolic factors and a decline in infection-related and tobacco-related cancers in India. The study, projecting the future burden of 23 major cancer types up to the year 2030, has been published in the BMJ Open this week. Calculated by forecasting age-standardised mortality rates (ASMR), the study found an ongoing epidemiological transition that is a clear shift towards cancers associated with lifestyle and economic development. The ASMR is a way to fairly compare death rates between populations that have different age structures. The authors used an autoregressive integrated moving average (ARIMA) model to forecast ASMR for 23 major cancer types until 2030, using aggregated, nationallevel cancer mortality data for the Indian population from 2000 to 2019.

Led by researchers and oncologists from MS Ramaiah University of Applied Sciences, Bengaluru; Amrita Institute of Medical Sciences and Research Centre, Kochi; Great Lakes Institute of Management, Chennai, and Department of Statistics, Assam University, Silchar - the study revealed that among males, mortality rates due to colorectal cancer and pancreatic cancer are expected to increase by 6.55% and 9.59%, respectively, from 2025 to 2030. Among females, breast cancer is expected to have the highest increase from 2025 to 2030, followed by lung, colorectal can-

cer, pancreas, ovary, kidney, and lymphomas.

However, among both genders, mouth and oropharynx cancers and urinary bladder cancer mortality are projected to decrease between 2000 and 2030, attributed to the reduction in tobacco use and household air pollution, said Denny John from MS Ramaiah University of Applied Sciences, who is the lead author of the study. "The study provides the first comprehensive, long-range forecast of agestandardised mortality rates for 23 cancer types in India using a robust time-series approach. We used an autoregressive integrated moving average (ARIMA) model that has a greater ability for prediction and applicability for cancer forecasting in the country," Dr. John told The Hindu. "The ASMR of 23 major cancer types was selected for forecasting cancer mortality as this metric takes into account changes in the population's age structure over time, enabling a more accurate comparison of mortality risk across different periods, regardless of the impact of population ageing. Projections of cancer mortality would be helpful for clinicians, researchers, healthcare administrators, and policymakers in planning facilities, equipment, and staffing allocation in the country," he said. Highlighting the public health implications of the study, K. Pavithran, professor and head, department of medical oncology at Amrita Institute of Medical Sciences and Research Centre, Kochi, said it underscores the importance of strengthening primary prevention and early detection strategies, especially for cancers that show steeply increasing projections, such as breast and colorectal cancer. "Improving early detection through expanded screening programmes, such as mammography and colonoscopy, and improving diagnostic infrastructure in rural and underserved regions are essential," the professor saidNarassima M.S., assistant professor at Great Lakes Institute of Management, Chennai, said that since the analysis is based on national-level estimates from the Global Cancer Observatory, this may mask significant subnational and regional heterogeneity in cancer patterns across States, an area that also needs to be focused on for better allocation of resources depending on region-specific pat-

Drug-resistant bacteria proliferate in Gaza



Ever since Israel intensified its attacks on Palestine in October 2023, sparing not even hospitals, more than 66,000 Palestinians have been killed, according to the latest bulletin from the Gaza's Health Ministry. But nearly three times that number of people, some 1.6 lakh, have been left grievously wounded. In this crisis comes a worrying report on Gaza's health crisis in the latest edition of The Lancet Infectious Diseases: according to the paper, disease outbreaks have proliferated in the area, and now the infections are becoming multidrug resistant as well, imposing a new challenge on an already beleaguered population.

Multi-drug resistance is defined "as non-susceptibility to at least one drug in three or more classes". In the study, the researchers calculated the multiple antibiotic resistance (MAR) index for each isolate. The index is equal to the number of antibiotics to which an organism is resistant divided by the number of antibiotics to which it was exposed. Ballistic, crush traumaTests on 1,317 samples collected from al-Ahli hospital in Gaza revealed that MAR was reported in over two-thirds of the samples (in the form of pus, wound swabs, and urine) collected last year, "reflecting the overwhelming burden of ballistic and crush trauma," the paper, authored by scientists including faculty at the Islamic University of Gaza, read. Pseudomonas aeruginosa, a bacteria already known to be associated with serious illnesses, including hospital-acquired infections such as ventilator-associated pneumonia, dominated, followed by Staphylococcus aureus, common cause of skin abscesses and respiratory infections; Klebsiella, known to cause pneumonia, urinary tract infections, and meningitis; and Escherichia coli, which can cause serious food poisoning.

The study also found that two-thirds of all isolates were multidrug resistant. "We found high resistance among Enterobacterales spp. isolates, with more than 90% of wound isolates resistant to amoxicillin-clavulanate, cefuroxime, and cefotaxime. Resistance to ceftriaxone and ceftazidime was also alarmingly high in wound isolates," the paper noted.

Children targetedGaza's healthcare system has been progressively devastated by Israel's onslaught. Since October 2023, one of Gaza's only functioning microbiology service centres is a small laboratory at Al-Ahli Arab Hospital in Gaza City, which retained power largely via diesel generators and battery inverters. "The hospital, which is one of the only hospitals in Gaza that has remained partly operational, has treated large volumes of traumatic injuries despite frequent airstrikes (beginning as early as October, 2023, and continuing at the time of writing) in the northern two governorates of the Gaza Strip," the paper read. According to the World Health Organisation (WHO), between October 7, 2023, and July 30, 2024, Israel carried out 498 attacks on healthcare facilities in the Gaza Strip. "A total of 747 persons were killed directly in those attacks and 969 were injured, and 110 facilities were affected," the Independent International Commission of Inquiry for the U.N. reported. As many as 500 medical staff were killed while Israeli security forces also blocked access by humanitar-

"Direct attacks on healthcare facilities, including those offering sexual and reproductive health care and services, have affected about 540,000 women and girls who are of reproductive age in Gaza," it added. The U.N. report also said the high number of child deaths is likely attributable to the fact that "children represent a majority of the patients treated in hospitals for blunt and penetrating trauma".

Medical professionals told the Commission they had treated children with direct gunshot wounds, meaning the kids had been targeted. "Children were operated on without preoperative and post-operative care, increasing the risk of wounds becoming infected, including by insects and parasites, resulting in complications and, in some cases, death, the report said. Vulnerable to disease "A major finding is that about 76% of that sample did come from blast- or traumarelated injuries, which speaks to the volume of blast-related injuries that are coming in as a result of the Israeli military assault on Gaza," Bilal Irfan, a coauthor of the study and a global health scholar with an interest in bioethics, conflict medicine, and trauma systems, with the Centre for Bioethics at Harvard Medical School, said in an interview with a US daily. We don't even know the true scale "because of the destruction of almost all the laboratories and the killing of a lot of the medical staff, so to even get a small insight into what is happening in Gaza is extremely important," Dr. Irfan, who also conducts research at Harvard's Brigham and Women's hospital and the University of Michigan, told The Guardian. "Long-term sheltering of displaced families outside the hospital might also have contributed to transmission of infectious diseases." it added. Beyond Gaza's borders The international medical community "has a duty" to act and respond to this crisis, the paper's authors wrote. "First and foremost, health-care workers and governments worldwide must advocate for the cessation of the Israeli military invasion that has resulted in a surge of trauma injuries and the widespread deliberate targeting of hospitals, laboratories, and water desalination plants; without this ceasefire, the infection burden will escalate further." It added that drug supply should be coordinated across humanitarian agencies and donors, perhaps through the WHO, so that the antimicrobial response can be tailored to the documented need of hospitals. If protection of Palestinian health facilities, antibiotic supply pipelines, and functional laboratories are not secured soon, the resistant organisms documented here will probably disseminate far beyond Gaza's borders," the

As air turns toxic, hospitals see rise in respiratory cases

Hospitals in Delhi have registered a sharp increase in the number of people complaining of breathing difficulties and respiratory ailments amid a spike in the city's air pollution levels, with doctors increasingly advising them to wear face masks and avoid visiting polluted areas. Delhi's air quality remained in the 'very poor' category for a third straight day on Wednesday, with the 24-hour average air quality index (AQI) standing at 353 at 4 p.m., according to the Central Pollution Control Board.

The worst affected by air pollution are children and older adults due to their weaker immune systems and reduced lung capacity besides persons living with asthma, chronic obstructive pulmonary disease, and heart conditions. "Apart from the vulnerable population, which is highly sensitive to

Is age catching up with India's dams?



"At Independence, the new Government of India ... made the building of big dams a central part of its strategy for transforming India, a commitment to which it adhered for decades," historian Daniel Klingensmith wrote in his 2007 book 'One Valley and a Thousand'.

The Damodar Valley Corporation, the Bhakra Nangal, and the Hirakud in the 1940s were followed by dams on the Rihand, Koyna, Tungabhadra, Chambal, and Krishna rivers in the decade after. In fact, in the two decades from 1951, India had started work on 418 large dams and by 2000 had completed around 4,000. In Klingensmith's telling, building dams had become "a way by which the modernity and worth of the nation could be enhanced, tested, and displayed."Today, however, India faces the challenge of large parts of its hydrological infrastructure ageing en masse. According to the National Register of Large (Specified) Dams, some 1,065 were 50-100 years old and 224 were more than a century old in 2023. Many major dams of the post-1950 period are now in the last stages of their originally intended lifespan, raising safety and performance concerns that transcend problems of engineering alone.

In practice, India's dam projects have typically assumed a useful life on the order of a few decades. The Bhakra Dam completed in 1963 was expected to serve for at least 100 years as a reservoir but its builders underestimated sedimentation rates, so much so that the reservoir's capacity had dropped by nearly 25% in the first 35 years of its use. Likewise, the Lower Bhavani Dam in Tamil Nadu had lost 28% of its capacity between 1956 and 2005 and the Nizam Sagar Dam had lost roughly half its capacity just in the first three decades of use since 1931. These examples illustrate one fact clearly: the initial design life of many dams isn't equal to the actual life. The cost of running a dam at its original performance levels can shoot up as it ages — and this is before the additional 'climate load' is factored in. Dams more than 50 years old today have outdated spillway capacities and structural safety factors and require urgent attention to ensure they can continue to function safely.

This photograph shows buildings near the Arbaat Dam, 40 km north of Port Sudan, after it collapsed following heavy rains and torrential floods on August 25, 2024. Dams' multiple failure modes can be split into three types: structural, hydraulic, and geotechnical. These modes are hard to pry apart in practice but it's useful to treat them separately if only to identify specific ways to surmount them.A structural failure is when a dam ruptures or collapses due to weaknesses implicit to its structure. Common causes include poor design and/or construction, material degradation, and structural components being forced to withstand forces they weren't equipped to. For example, progressive concrete deterioration can weaken a concrete dam over time. One way this happens is when silica in rocky aggregates in the structure reacts with alkali compounds in the cement to form a water-absorbing substance. As the substance expands, the concrete starts to crack from within. This category also includes structural cracks, slope instability in earth embankments, and gate and sluice failures. Worldwide, about 42% of concrete dam failures have been attributed to foundational and structural issues. Structural failures in Indian dams have been traced to seepage, corroded piping, and/or weak foundations. A hydraulic failure occurs when the dam can no longer safely store water. The best known cause of this mode, especially in the era of climate change, is overtopping; when flood waters pass over the dam's pinnacle, potentially breaching the structure en route. When inflow exceeds the dam's capacity, insufficient spillway capacity or blocked spillways can also lead to overtopping. Similarly, when a dam's outflow is very fast, it can erode the structure's downstream face, also resulting in hydraulic failure. In earth and rock-filled dam failures worldwide, overtopping has been the single most common cause (about a third of the time). India's first recorded dam failure, of the Tigra Dam in 1917, was also due to overtopping, and overall this cause has been the main one in most of the 36 recorded dam failures in the country.

Finally, a geotechnical failure occurs when the dam's foundations, abutments or the materials within the dam are unstable. Internal erosion in the foundation has accounted for about 29% of masonry dam failures worldwide. Earth-fill dams are particularly susceptible to flawed piping in the dam's body, where water can seep through the dam or its foundation and eventually cause a breach. Earthquakes and landslides can also trigger structural as well as geotechnical failures. Dams in seismically active zones are particularly vulnerable to quake-induced cracking or slope failures. When the magnitude-6.6 Koynanagar earthquake in Maharashtra shook the Koyna Dam in 1967, the structure developed cracks and began to accumulate hydrostatic pressure, raising fears of a breach. Real-world failures are a combination of these modes. An initial structural deficiency could lead to excessive leaks (geotechnical failure) that weaken the dam. Thus when the part of the river upstream of the dam receives heavy rainfall or when there's a glacial lake outburst flood (like the one that roiled Sikkim in 2023), the waters overtop the dam and results in a catastrophic breach. The world's history of dams indicates more than 70% of failures occur in the first decade of operations as this is when flaws in the design or construction are most likely to become evident. But as dams age, delayed maintenance, material ageing, and unanticipated flooding or seismic events can dramatically increase failure risk. After all, as climate change intensifies, it increases the risk of natural disasters of unprecedented magnitude — and to not have precedent means to lose history as a guide. Caring for older damsIndia's Central and State governments have developed an evolving framework of policies, laws, and projects to ensure dam safety, led by the safety regime established by the Dam Safety Act 2021. The instrument provides a framework to surveil, inspect, operate, and maintain all specified large dams, and requires institutional mechanisms at both the Central and the State levels to uphold it. At the Act's heart is the National Committee on Dam Safety, the apex body with the responsibility of evolving dam safety policies and reviewing the work of State-level agencies. The Committee is joined by the National Dam Safety Authority (NDSA), a regulatory body under the Union Jal Shakti Ministry tasked with enforcing policy and resolving interstate disputes. In this scenario, every State with large dams is required to establish a State Dam Safety Organisation (SDSO) headed by qualified engineers to oversee dams in its jurisdiction. (If a dam is located in one State but operated by another, the NDSA supplants the relevant SDSO.) The 2021 Act also

specifies regular inspection schedules. Dam owners - of-

ten a State's irrigation department or power utility — are required to conduct pre-monsoon and post-monsoon checks every year, among others. The law also requires each dam to have an emergency action plan and an alarm system, and provides for remedial actions that SDSOs can order if a dam is found to be falling short. Before the Act, the Central Water Commission (CWC) had set guidelines for dam owners on regular maintenance and safety reviews. To this end, many States have had Dam Safety Review Panels: expert groups typically populated by experienced dam engineers, hydrologists, and geologists and which audit ageing dams and recommend rehabilitation measures. The Dam Safety Organisation within the CWC also maintains a database of dam incidents and assists States in investigative studies. After any major natural disaster, a dam is also subjected to special inspections. In 2012, the Indian government mooted the flagship Dam Rehabilitation and Improvement Project (DRIP) to upgrade ageing dams. DRIP places particular emphasis on capacity building, including training State dam engineers in contemporary safety practices and developing au courant emergency action plans. Upgraded dams as a result have piezometers, inclinometers, and seismic monitors on site watching for signs of distress. These in turn also require dam health monitoring software to be integrated with dams' operations and for each dam to maintain a log, like its report card.

From 2012 to 2021, DRIP I rehabilitated 198 dams in Jharkhand, Karnataka, Kerala, Madhya Pradesh, Odisha, Tamil Nadu, and Uttarakhand. Work included grouting cracks, strengthening spillway piers, improving drainage and filtration systems in earth dams, replacing gates and valves, installing modern sensors and instruments, and improving operational processes. The government approved DRIP phases II and III in 2020 to cover 736 dams in 19 States, with financial assistance from the World Bank and the Asian Infrastructure Investment Bank for physical rehabilitation and to undertake comprehensive safety evaluations. As of early 2024, reviews for more than 400 dams had reportedly been completed. Dovetailing on DRIP are guidelines to deal with the consequences of natural events rendered more intense and/or frequent by climate change. This includes rechecking the probable maximum flood for spillway designs, improving spillway capacity, and adding auxiliary channels. Older masonry and concrete dams are also evaluated against current earthquake codes and strengthened if required by anchoring, buttressing or adding reinforced concrete overlays. The National Hydrology Project and flood forecasting initiatives have also been working to improve flood management upstream. On the flip side, DRIP doesn't make room for dams to be decommissioned; instead it focuses on extending the lifespan of dams at all costs. India in fact lacks an official dam decommissioning policy. The Dam Safety Act empowers authorities to declare a dam unsafe and potentially stop its operation, but there's no procedure to decommission it altogether. Experts have recommended India develop a risk-based framework, i.e. when a dam's failure risk exceeds acceptable limits and it's no longer feasible to strengthen it. Calls by experts to decommission specific dams, such as the Mullaperiyar, have thus far only been dealt with in courts.

Economics of ageingAs a dam ages, the cost of its upkeep rises. Older dams often require structural strengthening, e.g. by retrofitting their spillways or reinforcing concrete; upgrading gates and mechanical equipment; and continuously dredging and managing sediment. Second, the loss of reservoir capacity thanks to siltation diminishes water supply, irrigation potential, and hydroelectric power generation capacity. Addressing sedimentation by dredging and restoring catchment areas, among other measures, is also expensive. At one point, the Government of India had deemed the Bhakra reservoir's large-scale dredging to be "cost-prohibitive".

To evaluate the potential cost of a complete failure, analysts use risk assessment models that consider the probability of failure together with its consequences. In practice, a dam's hazard classification (low, significant or high) is based on the worst consequences should it fail. Conseuence analysis frameworks, such as the one the US's Department of Homeland Security uses to assess dam safety, enumerate the consequences in three categories: human (populations at risk, potential loss of life), economic (property damage, infrastructure loss, cost of replacement and remediation), and critical services (loss of water supply, power, irrigation). Thus, a comprehensive failure scenario analysis might estimate the asset replacement cost of the dam and its associated structures, the remediation cost for downstream cleanup, and the lost power generation or water supply as part of business losses. Depending on the relevant rules, the analysis may also include intangible costs like environmental damage and long-term economic setback to the region. India currently makes limited formal demands of economic analyses of dam failures. Before the government approves a dam, the project proponent is required to submit an environmental impact assessment (EIA) that includes a dam failure analysis. Since 2021, the Dam Safety Act has required certain dams to have emergency action plans and inundation maps on file. But the government has also been progressively weakening EIA governance, including approving projects sans EIAs and allowing defaulters to pay a fine and continue offending ones.Perhaps the worst failure in India's history was the collapse of the Machchu-II Dam in Morbi in Gujarat in 1979. This earthen dam was built in the 1970s and was breached after extreme rainfall. Water spilled from the dam in a flash flood that killed more than 2,000 people (although some estimates go up to 20,000).

The failure also demolished most of Morbi town. More recently, the Tiware Dam in Ratnagiri district of Maharashtra failed in 2019, wiping out entire villages and killing 19 people. Following tropical cyclone Daniel, the Derna and the Abu Mansour Dams in Libya collapsed in September 2023 and killed more than 3,800. The incident prompted countries worldwide to double-check their own dams — and thus the Himachal Pradesh government found 21 dams in the State had violated their safety norms, including possessing inadequate spillways. The discovery drew calls for older dams to have their safety margins reviewed by independent experts. Dam failures also impose long-term costs as local governments have to restore damaged transport links, compensate and rehabilitate the affected families, and reverse losses in agricultural productivity. Even near-miss events can exact high costs. While the 2018 floods strained but didn't breach several dams in Kerala, the State's economy was hit by the emergency reservoir drawdowns and controlled downstream spilling it had to effect. This said, economic evaluations of dam safety are now moving towards risk-based decision-making, which means vouchsafing investments for dams that pose the highest risk, which in turn is a function of the likelihood of failure and the magnitude of downstream consequences. Such an approach helps ensure limited funds are directed to averting the most severe potential disasters, even if the limitedness is arguably artificial and not inevitable. Perhaps the best way to contextualise these measures and policies is to read them in the context of three of India's great old dams (subjectively speaking): the Mullaperiyar, the Hirakud, and the

Small farms are more productive than large farms, finds study



Researchers at the Indian Institute of Technology, Bombay (IIT Bombay) and the University of Hyderabad conducted a study and found that productivity in India's semiarid tropics depends less on farm size and more on access to inputs, credit, and markets. The study involved analysing data from 1975 to 2014 and examining changes through three waves over 40 years. The researchers found that small farms were indeed more productive, especially in the early years (1975–84), citing more intensive family labour, higher attention, and adding more fertilisers per unit compared to larger landholders. The 1960s have shown that smaller farms are generally more productive than large farms in terms of yield per acre. However, the new study proves that even during those early years, the productivity scale was not as tilted towards small farms as previously thought

The findings suggest that the inverse farm size-productivity relationship, where the productivity decreases as the farm size increases, was never as pronounced in the semi-arid regions of India. As agrarian distress dragged on in these regions, the productivity advantage of small farms faded in the later years (2009-2014). "The smallholders still matter greatly for food security and rural stability, but they are increasingly vulnerable due to monocropping and high input costs. To strengthen the capacity of smallholders, the need is to improve their access to appropriate technologies, affordable credit, and reliable extension services," says Prof. Sarthak Gaurav from Shailesh J. Mehta School of Management, IIT Bombay and a co-author of the study. The findings prove that the farm size-productivity relationship is complex, context-dependent, and much weaker than previously thought. The researchers relied on village-level studies from the International Crops Research Institute for the Semi-Arid Tropics (ICRISAT) datasets spanning over four decades from 1975 to 2014. According to the researchers, this database is considered one of the world's longest-running agricultural panel studies from semi-arid tropics, a region that missed out on the early benefits of the Green Revolution, as it tracks farming households across multiple decades

The ICRISAT data is mainly from three representative zones: Akola, Solapur, and Mahabubnagar. The researchers explain that the unique agroecological and institutional conditions here make it an ideal setting to understand how productivity patterns changed in response to delayed but significant transitions in agriculture. According to researchers, they merged household and cultivation data across survey waves and also used external sources, including the India Meteorology Department's (IMD) gridded data, to fill the gaps. The researchers recommend prioritising the improvements in smallholders' collective capacity to access markets and inputs. The other recommendation is to help smallholders organise into collectives or producer groups to enable them to pool resources, adopt agroecological practices, and negotiate better prices.

With some knowledge of the principles of AI, individuals can utilise tools that identify deepfakes and verify facts, which ultimately lead to a healthier information ecosystem. Breaking down complicated AI terminology, such as Human In The Loop (HITL), to students requires relating it to their daily lives. HITL simply denotes that while AI will handle many of the processes, human intervention is still necessary in decision-making and correcting errors. BC reservations, both Congress and BJP caught on a slippery ground

HYDERABAD: The national parties - Congress and Bharatiya Janata Party (BJP) are caught on a slippery ground over 42 percent reservations to BCs in the local body elections and employment and education sectors in the State.Ahead of the local body elections, both the parties had drawn up grand plans to win the confidence of BCs. Much to their dismay, all the plans went awry, triggering unrest among the BCs and exposing their "commitment".

The Congress on its front has been reiterating its commitment towards the community by stressing that two bills were passed in the Assembly and council on March 17 and 18 this year. The same were sent to the President of India's assent. However, as there was no approval from the President's Office, the Congress government issued an ordinance but even that was not approved. Finally, the Panchayat Raj Act 2018 and





Municipalities Act, 2019 were also amended.

But all these efforts did not fructify. Though the Congress government was well aware of all these challenges, it has been stressing that 42 reservations would be extended to the BCs. It had even planned to hold a public meeting in Kamareddy on September 15 but postponed it citing rains. Eventually Chief Minister A Revanth Reddy on Friday said the State government would wait till the

Supreme Court's orders over the issue. The entire episode reflected the Congress government's "commitment". Amidst all these developments, it is unclear if the State government would conduct the local body elections before September 30 – the deadline set by the High Court.On the other hand, the State BJP has been facing challenging times and is defenseless over the BC reservations issue. The party has been trying to blame the Congress government, charging that in the guise of extending 42 percent to BC reservations, it was actually facilitating more reservations to the backward Muslims. But this campaign did not strike a chord with the people as expected by the party.It is learnt that the Telangana BJP leaders had raised the issue with the central leadership in New Delhi during the Vice Presidential elections. However, as there was no clear indication from the party central leadership, the State leaders were left disappointed.

India's reliance on imported crude oil creeps up further on demand growth amid stagnant domestic production



Indian refiners' heavy imports of Russian crude are seen as a lever that the Trump administration believes it can use to force the Kremlin's hand into ending the Ukraine war.India's oil import dependency was 87.8 per cent in FY24. 87.4 per cent in FY23, 85.5 per cent in FY22, 84.4 per cent in FY21, 85 per cent in FY20, and 83.8 per cent in FY19. Growing demand for fuel and other petroleum products amid stagnant domestic crude oil output led to India's reliance on imported oil inching up further during April-September (first six months) of the current financial year 2025-26 (FY26). Latest data released by the oil ministry's Petroleum Planning & Analysis Cell (PPAC) shows that India's oil import dependency was 88.4 per cent in April-September, up from 87.9 per cent in the corresponding period of the last financial year. For the full FY25, reliance on imported oil was at 88.2 per cent, a full-year record.

Industry watchers believe that the import dependency level for the entire FY26 could be a tad higher than the April-September level, as was the case in the previous financial year. India's energy needs are consistently growing, leading to higher oil imports. This is fuelled by factors like growing energy-intensive industries, increased vehicle sales, a rapidly expanding aviation sector, growing consumption of petrochemicals, and a rising population. India's reliance on imported oil has generally increased over the years, with the exception of FY21 when demand was suppressed due to the COVID-19 pandemic.India's oil import dependency was 87.8 per cent in FY24, 87.4 per cent in FY23, 85.5 per cent in FY22, 84.4 per cent in FY21, 85 per cent in FY20, and 83.8 per cent in FY19.

India's heavy reliance on imported crude oil makes its

economy vulnerable to global oil price fluctuations. This also impacts the country's trade deficit, foreign exchange reserves, the rupee's exchange rate, and inflation rate, among others. The Indian government aims to reduce the country's reliance on imported crude oil but faces challenges due to sluggish domestic oil output amid rising demand. In 2015, the government had set a target to cut the dependence on imported oil from 77 per cent to 67 per cent by 2022. However, import dependency has only increased. The government has implemented several policy reforms to encourage investments in India's oil and gas exploration and production sector. The government is also promoting electric mobility, biofuels, and other alternative fuels to reduce oil imports. While there has been an increase in electric mobility adoption and the blending of biofuels with conventional fuels, it is not sufficient to offset petroleum demand growth.India's crude oil imports rose to 121.2 million tonnes in the six months to September from 120.7 million tonnes in the year-ago period. Meanwhile, domestic oil production declined slightly to 14.2 million tonnes from 14.4 million tonnes. Total domestic consumption of petroleum products in April-September rose 1 per cent year-on-year to 118.3 million tonnes, of which only 13.7 million tonnes of products estimated to have been produced from domestic crude oil, resulting in a self-sufficiency level of just 11.6 per cent, per

The computation of the extent of import reliance is based on the domestic consumption of petroleum products and excludes petroleum product exports as those volumes do not represent India's demand. India-the world's thirdlargest consumer of crude oil and also one of its top importers—is a net exporter of petroleum products. Despite higher oil imports and import dependency, the country's gross oil import bill for April-September declined 14.7 per cent to \$60.7 billion year-on-year. The relief was primarily on account of lower oil prices in the international market vis-à-vis last year. Crude oil imports top the list of India's merchandise imports. Unlike most large economies, India is seen as a major growth centre for oil demand given the future consumption potential and relatively low per-capita energy demand currently. In fact, India is among the few markets where refinery capacity is expected to expand substantially over the coming years. India currently has a refining capacity of nearly 258.1 million tonnes per annum.

Today let me talk about a 50-year-old patient of mine, who has a healthy constitution but gets himself tested every one to three months without fail. Neither does he have any family history of a chronic disease, nor do his routine tests show wild variations to merit concern or medication. Lest laboratories refuse to repeat tests, he goes to different labs for sample collection. If any reading is slightly out of range or is marked bold, he compares with the last report and seeks an emergency appointment. Worse, he self-monitors his health with specialised tests like CRP and cortisol without the advice of the doctor. What is driving his anxiety about health?

It would be easy to dismiss over-testing as an anxiety issue. But what he and many like him are exposed to are misinformation and Instagram reels on tests one should take to prevent a major health crisis. For example, he has come to me seeking answers on why his CRP levels are marginally up and why the slight elevation in his liver enzymes indicates a chronic liver condition. Now CRP levels could be slightly higher for a number of reasons. Similarly, slightly elevated liver enzymes can be a short-term aberration related to obesity, alcohol and medication, which is often settled by lifestyle adjustments. My patient has even ignored my assurance, uploaded his test results on Chat GPT and ended up being worried that he was developing a major illness that floated up on his screen. Currently, we are counselling him for mental stress but many of you should know about the tests you should do, what you don't need and how not to waste money.

How frequently should one do a full-body check-up?

Ideally, every adult should do a full body checkup once a year. People with chronic conditions or a family history of certain illnesses may need more frequent checkups, possibly every six to 12 months. Unless there is a worrisome condition that develops in between and which requires specific tests, these are enough.

What is the downside of frequent testing?

Repeating tests at small intervals can yield false positives and build unnecessary tension. This leads to ten more tests that the patient wants, leading to medical mismanagement. Your doctor is the best person to interpret your basic package of tests and suggest specific tests should they suspect a condition.CRP: Most patients ask me if they should get a CRP test, a blood test that measures the amount of C-reactive protein (CRP), a protein produced by the liver in response to inflammation. CRP is not an everyday test because it indicates overall inflammation, which is not a diagnostic tool for a specific condition. Doctors order it to help diagnose and monitor acute illnesses like Covid, autoimmune disorders, arthritis, pneumonia and infections, not to track daily health fluctuations. Besides, CRP is affected by age, obesity, smoking, diabetes, and even intense exercise. HsCRP: This is the high sensitivity CRP test that many people go for, having gotten tested for it during Covid. This is specific for cardio-vascular risk management and is not for everybody. It is recommended for those above 45 with high cardiovascular risks like obesity, diabetes, blood pressure, cholesterol, family history, smoking. In fact, frequent repetitions will show different readings as they fluctuate with exercise, stress or even mild infection. Homocysteine: This is an amino acid linked to blood vessel damage, high levels of which indicate Vitamin B12, B6 or B9 deficiency. Although this test is being mentioned in terms of preventive heart health, it is recommended only when you develop an unexplained heart disease or stroke without a history of risk factors, when you have a strong family history of premature heart attacks, or when you have clotting disorders and unexplained B12 deficiency. Also lowering homocysteine has not reduced heart disease risk in patients, a risk which needs to be mitigated by other lifestyle parameters. Repetition is not required unless the vitamin B 12 levels need to be corrected Serum cortisol: Being a stress hormone, cortisol levels fluctuate wildly through the day. So a reading cannot give you the exact health status of your body. It is very specific to assess adrenal gland dys-

Centre to allow only senior officials to flag 'unlawful' content for blocking



Information TechnologyCurrently, the rules say that such directions can be issued by an "appropriate Government or its agency," without specifying any particular designation of the official. The Ministry of Electronics and IT is bringing out amendments to one of its content blocking laws, under which it will specify that content notices sent under Section 79 (3)(b) of the Information Technology Act, 2000, can only be issued by senior officials at the Centre and state levels, officials said Wednesday.

As per amendments to the Information Technology Rules, 2021, the ministry will specify that content blocking intimations to social media platforms like YouTube, Instagram and X can be sent by a senior officer not below the rank of Joint Secretary (JS), or equivalent, and a Director or an officer equivalent in rank where a JS has not been appointed. In case of police authorities, only an officer not below the rank of Deputy Inspector General of Police (DIG), specially authorised, can issue such intimation. A senior government official said that there had been instances in some states, where police officers at the rank of sub inspectors and assistant sub inspectors were sending content notices to social media companies. "We felt there was a need to create a mechanism where not any officer can issue such notices, and that power is only available to the very senior ones," this official said. Currently, the rules say that such directions can be issued by an "appropriate Government or its agency," without specifying any particular designation of

"Accountability of the government increases with this change. And we will be giving a reasoned intimation whenever any such order is passed. And the orders will be passed at a fairly senior level, JS and above, and DIG and above,"

IT Minister Ashwini Vaishnaw told reporters. To be sure, Elon Musk-owned social media platform X had challenged this specific provision of the IT Act, saying that the government was trying to establish a "parallel" content blocking regime, under which it had empowered any official at the Centre and state levels to issue content notifications. The Karnataka High Court had ruled in favour of the Central Government last month

Senior officials briefing the media said the changes the government was now bringing about were not related to X's arguments and have no relation to them. The amendments, which are expected to kick in from November 15, are expected to specify that the content intimation to platforms must clearly specify the legal basis and statutory provision, the nature of the unlawful act, and the specific URL/identifier or other electronic location of the information, data or communication link to be removed. All intimations view by an officer not below the rank of Secretary of the appropriate Government - the IT Secretary in case of the Centre, and either the Home or IT Secretaries at the state level. On the face of it, the changes the IT Ministry is now making to the law, seem to address some of the concerns X had raised in its plea. As per Section 79(3)(b) of the IT Act, online intermediaries like X can lose their safe harbour protections if they fail to block access to content which has been flagged by an "appropriate" government agency. Safe harbour protections are key to the functioning of social media platforms, as they afford them legal immunity from hosting user generated content.

This process is separate from Section 69(A) of the IT Act, which also allows for content blocking in cases affecting the "sovereignty and integrity of India, defence of India, security of the State," whereas under Section 79 (3)(b), any "unlawful" content can be directed to be removed. In fact, one of X's contentions in its case was that the IT Ministry had "directed" all central ministries, State governments, States' deputy generals of police, and effectively tens of thousands of local police officers, that they are authorised to issue information blocking orders under Section 79(3)(b), outside the Section 69A process. MeitY has also provided all Central and state government agencies a "Template Blocking Order" to use to issue these "unlawful" information blocking orders, the plea had said.

UPI hits record Rs 1.02 lakh crore in single-day payments as GST cuts fuel Diwali demand

New Delhi: Finance Minister Nirmala Sitharaman highlighted on Thursday that the Unified Payments Interface (UPI) platform processed 754 million payments worth Rs 1.02 lakh crore on October 18, marking the highest singleday tally, as consumer demand surged due to the GST rate cuts. During the three days between Dhanteras and Diwali, the average UPI volumes stood at 736.9 million — higher than 647.46 million in the corresponding period a month ago, the Finance Minister said.

"It has been a cracker of a Diwali for retailers this year as GST rate cuts have boosted consumption, enabling the middle class to add more items to their shopping bags this festive season," she observed. From lab-grown diamonds to casual wear and products to adorn homes, both mass and premium segments of the market picked up, Sitharaman remarked. She pointed out that the roll-out of Goods and Services Tax (GST) 2.0 has injected fresh momentum into India's growth story by enhancing household purchasing power, easing business operations, and simplifying tax ad-

"By rationalising slabs and lowering rates across a range of consumer goods, the reform has delivered tangible savings for households, freeing up disposable income

and helping stimulate demand," the Finance Minister added. According to the Confederation of All India Traders (CAIT), Diwali sales soared to an all-time high of Rs 6.05 lakh this year. This marks a 25 per cent jump over the 2024 festive sales of Rs 4.25 lakh crore from the Navratri to Diwali period and is the highest-ever sales in India's trading history, according to Research and Trade Development Society, the research wing of CAIT.

Mainline retail accounted for nearly 85 per cent of total sales, indicating a strong revival of the brick-and-mortar market, the survey showed. The reduction in GST rates across key consumer and retail categories, such as confectionery, home decor, footwear, ready-made garments, consumer durables, and daily-use items, significantly improved price competitiveness and increased purchase momentum. About 72 per cent of surveyed traders reported higher sales volumes directly attributable to reduced GST, according to the survey. Consumers expressed greater satisfaction with stable prices amid festive demand, aiding consumption continuity post-Diwali. The non-corporate and non-agricultural sector has emerged as a central pillar of India's growth, driven by 9 crore small businesses, crores of small manufacturing units, and the largest base of consumers.

If that's not possible, use a sanitiser with at least 60 per cent alcohol before touching your face or food. MoneyCash notes and coins pass through hundreds of hands and environments — from sweaty palms to dusty counters. Bacteria and microbes linked to skin and respiratory infections are usually detected on currencies, which are circulated widely. Even though

India is moving toward digital payments, physical currency still dominates in many areas. After handling cash, especially coins, make it a point to wash or sanitise your hands thoroughly. Handrails From staircases to escalators and public transport, handrails are designed for safety — but they often collect layers of dirt, sweat, and microorganisms from hundreds of hands daily. Because they're rarely cleaned, these surfaces can become a hotspot for bacteria and even viruses, such as the common cold and flu. So the next time you grip a handrail for balance, remember to sanitise afterwards. Light switches are one of the most frequently touched but least-cleaned surfaces in any home From kitchen switches coated with oil splatters to bedroom panels touched after returning from outside, these spots can accumulate germs guickly. In fact, studies show that switchboards can carry more bacteria than toilet seats if not cleaned regularly. Use disinfectant wipes to clean them once a week — and if you have just switched on a light in a public restroom or shared area, make sure to wash your hands soon after. Soap DispensersIt might sound ironic, but soap dispensers themselves can be a source of germs especially in public restrooms. People often touch the handles or pumps before they've washed their hands, leaving behind a mix of bacteria and viruses.

Ahead of this match vs Real, Arne Slot's side lost 6 of their last 8 matches which put a dent on their hopes of retaining the title they had won last season. The Dutchman brought in Andy Robertson in place of a struggling Milos Kerkez in the Villa match which acted like a tonic with the Scottish left-back using all his experience to his advantage, giving the Reds a much-needed stability on that side. Robertson's performance against Villa was awarded with a start against Real on Tuesday as he kept the 15-times UCL winners at bay. Another bright spot in the team was right back Conor Bradley, an understudy of now Madrid player Trent Alexander Arnold when he was in Liverpool. With his ex-Liverpool mentor watching from the stands, Bradley burst out from under Trent's shadow, delivering a defensive masterclass as he kept Vinicius Jr quiet. The Brazilian tried a few of his flicks and tricks but Bradley's physicality ensured that the Madrid ace was kept marginalized for the lion's share of the match. With the two wing backs on top of their game, the shaky centre-back partnership of Virgil van Djik and Ibrahima Konate also looked way more assured, successfully shutting down Real's attacking threat with Kylian Mbappe looking out of sorts. Madrid managed just 8 shots in the whole match with just 2 of them on target which says a lot about how solid the Reds were in the back, a trait that was almost a forgotten art at Anfield if you look at the last few matches. Liverpool looks to have found a bit of rhythm back and the smart thing would be to continue with this formation and a set team. But with Isak, Kerkez, Cody Gakpo and Jeremie Frimpong all destined to come back to the first-team, Slot has a conundrum in his hands on how to keep things in balance.

Vidit was among a few Indians held to a draw in their first-round matches, alongside top seed and reigning World Champion D. Gukesh and third seed R. Praggnanandhaa. Vidit now enters tricky territory, where he will face Oro in a series of short time-control matches. These begin with two rapid games of 15 minutes plus a 10-second increment per move, with reversed colors. If a winner is not determined, the players will play two more rapid games, this time with 10 minutes plus a 10-second increment. If the tie persists, the tiebreaks will move to a blitz segment, starting with two games of five minutes plus a three-second increment, then two games of three minutes plus a two-second increment, before potentially reaching a sudden-death match.Gukesh is in action against Kazakhstan's Kazybek Nogerbek while Praggnanandhaa is taking on Australian Temur Kuybokarov as both need to win their games to qualify directly to third round. A draw in either of their games will result in tiebreaks as well. India No. 1 Arjun Erigaisi had beaten his opponent Martin Petrov of Bulgaria in their first match and now needs only a draw to proceed



Rishi Kapoor's rejection from FTII led to a rift between Raj Kapoor and Asrani, claims veteran journalist: 'He didn't have the educational qualification'



Raj Kapoor was going through his toughest phase after the release of Mera Naam Joker as he was on the brink of losing everything, even his studio, and at this time, the filmmaker-actor decided to launch his son Rishi Kapoor in the teenage romance film Bobby. Raj decided to cast newcomers Rishi and Dimple Kapadia in the film, and wanted Rishi to get some basic training in acting before starting the film. At the time, the Film and Television Institute of India (FTII) in Pune was one of the few acting schools in the country and Raj wanted his son to enroll there but he couldn't make it happen.

In a recent interview with Vickey Lalwani on his YouTube channel, veteran journalist Hanif Zaveri shared, "When Raj Kapoor wanted to launch Rishi Kapoor in Bobby, he wanted Rishi to get some training at FTII. But there was some minimum educational qualification that was required to get admission but Rishi didn't have that, and he was rejected." Raj was still keen for Rishi to go to the institute so he started finding out other ways that could help his son get admission.

During this time, late actor Asrani, who had been an acting student at FTII, along with Jaya Bachchan, was also an acting teacher at the institute. Raj hoped that Asrani could be of some help in this department and got in touch with him. "Raj Kapoor went to Asrani and hoped that Asrani would help Rishi in getting admission. But that couldn't happen and it led to a rift between Raj Kapoor and Asrani," Hanif said. The veteran journalist said that after this, Raj Kapoor never cast Asrani in any of his films, but it did not affect Asrani and Rishi Kapoor's relationship. The two worked together in the 1975 film Rafoo Chakkar and later, when Asrani directed the film Chala Murari Hero Banne, Rishi appeared

for a cameo. Hanif claimed that Rishi did not take a penny for his work in the film. Chala Murari Hero Banne starred Asrani in the lead role and the actor had previously shared that he had a tough time casting for the film, which led to his "lowest phase."

Moscow to host DiamondButterfly Film Award on Nov 24

Hyderabad: Entries from over 20 countries will be vying for the coveted Diamond Butterfly Film Award being hosted by Moscow on November 24, 2025.

This event, being organised by Eurasia Academy of Cinematographic Arts, is already equated by many with the Oscars in terms of its scale and importance and is one of the most anticipated initiatives of the Russian Ministry of Culture and the Russian Culture Foundation aimed at promotion of national cinema as an instrument of traditional values, history and cultural sovereignty, says KhodzhaevThe changing dynamics in the international cinema market with a freshly generated vibrancy in Eurasia creates further opportunities for investment in new joint incentives that can provide a momentum to the Russia-India filmmaking collaboration and co-production. On India-Russia film industry, Khodzhaev says: "The positive effect of this intercultural infusion is visible in the stronger Russian-Indian bonds which beyond the political matrix transcend people-to-people affinity. The gravitational appeal towards India formed over the years in my country via cinema is inseparably linked to the names of Raj Kapoor, Amitabh Bachchan, Dharmendra, Mithun Chakraborty, Hema Malini. She was interested in knowing about me as they were looking for an actress for their film. She asked my aunt if she could meet me and get my phone number, which she did. So basically, I didn't go out looking for work, it came to me."

Pooja added, "It's like what Imtiaz Ali says in one of his films: what you are seeking is seeking you. Eventually, Yash Raj Films took my number from Rakesh ji, and it wasn't like many people were auditioning for my part or there was tension about whether I'd get it or not. It was very simple, they called me and soon I was on set. So, if things are meant to happen, they do. But if they aren't, no matter how many auditions you give, it won't fall in place." During the conversation, while showing stills from the film's making, Pooja Ruparel shared a special memory about her costume: "This dress actually belonged to Poonam Sinha. I think my mother had carried a few options, and what they had initially planned for me didn't work out. Then my mother offered if I could wear this, and they instantly said yes, it worked. So I wore it for the scenes. Thank you, my aunt."In an earlier interview with SCREEN, Pooja had revealed more about her career beginnings: "Three years after King Uncle, they got my number from Filmkraft's office and gave me a call. By then, we had refused 100 offers. After King Uncle, every child actor role was offered to me first. Luckily, my parents had the foresight to say that I was not a moneymaking machine and that I would go back to school, even though we were very middle-class. So, I never felt like I was a star. Prabhas is 'a battalion that fights alone' in Hanu Raghavapudi's period action epic Fauzi, see poster


