Andhra Pradesh cancels tender process for Polavaram-Banakacherla project DPR

Hyderabad: Amid fierce backlash from Telangana, spearheaded by the Bharat Rashtra Samithi (BRS), Andhra Pradesh has abruptly cancelled the tender process for the Detailed Project Report (DPR) of the contentious Polavaram-Banakacherla link project (PBLP), which was aimed at diverting Godavari waters to Krishna basin and beyond.Irrigation officials confirmed on Friday that AP had withdrawn the tender notice issued on October 11 after reviewing technical and financial parameters.

PM Modi credits Bihar's record turnout to NDA's track record of governance

Aurangabad/Bhabhua (Bihar): Prime Minister Narendra Modi on Friday asserted that the record turnout in the first phase of the Bihar Assembly polls was proof that people have reposed their trust in the "track record of Narendra and Nitish". While the NDA will register its largest victory in this election, the Congress is now busy finding excuses for the impending defeat, the PM claimed. Addressing back-to-back rallies in Aurangabad and Bhabhua, the headquarters of Kaimur district, in the poll-bound State, Modi predicted victory of the NDA, led in Bihar by Chief Minister Nitish Kumar, the JD(U) president, and also lauded the Election Commission for successfully conducting elections across 121 constituencies where voting was held. He cited the examples of the Ram temple in Ayodhya, the abrogation of Article 370, and Operation Sindoor to assert "I do what I promise". "Yesterday, the voters of Bihar broke all records. Never before in the history of the state has there been such a high poll percentage. Much of the credit goes to mothers and sisters, the Maatri Shakti (mother power), who turned up in large numbers to raise the turnout to nearly 65 per cent. It is evident that they all have trust in the track record of Narendra-Nitish," said Modi.

The people have voted to ensure that an NDA government, which would guarantee good governance, remains in place in Bihar, the PM said. "They have not been taken in by the false promises of RJD-helmed opposition. Even the Congress, despite being an ally, is not trusting the RJD's promises made in their manifesto," claimed Modi.Without mentioning the INDIA bloc Chief Ministerial candidate Tejashwi Yadav by name, the PM said, "The crown prince of jungle raj gets tongue tied whenever he is asked what his plans are for fulfilling the bogus promises he has been making".

People do not want a return of the 'jungle raj' during which Naxals ruled the roost and several lives were claimed in violence that used to take place during elections, he asserted. Hinting at a poll campaign of the RJD, which has been a matter of controversy, Modi said, "The jungle raj wallahs have taught even children to speak of things like katta (unlicensed country-made handgun) and dunaali (double-barreled gun)". "Investors would run away at the sight of the lantern (RJD) panja (palm of hand symbol of Congress) and laal jhanda (red flags of the Left). They must have tried to create mischief this time as well. But I commend the Election Commission for conducting orderly polls," said Modi. The Prime Minister alleged that Nitish Kumar, the state's longest serving Chief Minister, whom he cred-



ited with having "brought jungle raj to an end", faced non-cooperation from the Centre "in the first nine years of his tenure", when Congress-led UPA was in power. They tried to take revenge on the people of Bihar, alleged Modi. "People have faith in the track record of Modi and Nitish because I do what I promise. Today, a Ram temple is in place at Ayodhya, which has undone 500 years of injustice. Article 370 has been scrapped. And, I had promised on Bihar's soil that perpetrators of the Pahalgam terror attack will be punished. You all know what happened in Operation Sindoor," said Modi. In an apparent jibe at Congress leader Rahul Gandhi's "Vote theft" charge, Modi claimed the opposition party was "already busy finding excuses for impending defeat.

They are carrying out a net practice of how to explain why they lost Bihar". "It is now confirmed that the NDA will register its largest victory in this election. I urge you to be ready for a victory celebration after November 14," he told the gathering. Speaking in an area of Bihar from where a large number of people are known to be in the armed forces, the Prime Minister also spoke of the one rank one pension scheme, which has led to Rs one lakh crore being transferred into accounts of ex-servicemen. "The RJD people might not even know how many zeros are in one lakh crore," chuckled Modi, adding: "

They cannot think of providing jobs to the people. They made people do away with their land while promising jobs. Now they are out on bail," said the PM. The allusion was to the land for jobs scam, pertaining to the tenure of RJD supremo Lalu Prasad as Railway Minister in the UPA 1 government. Prasad and a number of his family members, including son and heir apparent Tejashwi Yadav, are named in the case. "The Congress and RJD know nothing except a politics of insults.

Bus plunges into Rajarhat canal; over 40 injured, 9 serious

A private bus lost control and fell into the Mazar canal in Rajarhat near Kolkata on Friday morning. The accident happened at Kharibari under the Rajarhat police station, when the bus was heading from Berachapa to Chakla Karunamayi in the North 24 Parganas district. The reason for the accident is not clear. However, some eyewitnesses said the vehicle was being driven recklessly, due to which it hit the side railings and then fell into the canal.

The locals also blamed the condition of the road and claimed that minor accidents happen on the stretch regularly owing to its pitiable state.Initially, locals tried to rescue passengers by jumping into the water. Upon receiving the information of the accident, personnel from the Rajarhat police station also reached the spot and shifted the injured to the Deganga Hospital. "At first, 46 people were admitted to the hospital, and a few of them



were discharged after primary treatment. The condition of nine people is serious, and they have been shifted to the RG Kar Hospital," said a policeman.

Tight security with 1,600 cops for Jubilee Hills bypoll

Hyderabad: With polling for the Jubilee Hills Assembly by-election scheduled for November 11, Hyderabad Police and election authorities have put in place a tight, multilayered security grid involving over 1,600 personnel to deter violence, prevent booth capturing and ensure smooth and fair polling. According to Hyderabad City Police, the plan combines enhanced local deployment, special police units, vehicle check-posts and support from central forces and Election Commission flying squads, along with administrative measures such as arms deposit orders for licence hold-

ers within the constituency. Authorities said as many as 1,600 local police personnel would be deployed across the constituency and at polling stations, with additional patrolling and pickets in sensitive areas.

The security plan includes support from central armed force units and eight companies of CAPF, along with eight striking force teams and Quick Response Teams (QRTs), which will be deployed at sensitive polling stations, counting centres and other key locations to assist the State police wherever required. According to West Zone DCP Ch Srinivas, there are about 65 critical or sensitive polling points across the constituency and adequate police forces have been deployed. Unaccounted cash worth Rs 3.4 crore has been seized so far.

"There are route mobiles also in place, headed by senior police officers. A three-tier security system is being followed. CCTV surveillance and close monitoring of strongrooms and EVM storage have been given top priority," the DCP said.Hyderabad Police Commissioner V C Sajjanar had earlier issued orders under the Arms Act requiring licenced firearms within the Jubilee Hills limits to be deposited or produced for verification, a standard precaution during elections to curb the use of weapons.

Hyderabad declares three-day holiday for Jubilee Hills bypoll

Hyderabad: The Hyderabad district administration on Friday declared a three-day paid holiday for offices and institutions where polling stations and counting centres have been set up for the Jubilee Hills Assembly constituency bypoll scheduled for November 11. As per an order issued by Hyderabad Collector Harichandana Dasari, a holiday has been declared on the day of polling on November 11. In addition, a day before polling i.e., November 10 and counting day i.e. November 14 have also been declared a holiday for offices and institutions where polling stations and counting centres have been established. All the Head of the Officers of respective departments and offices/Institutions in which polling stations and counting centres are established are to implement the orders scrupulously, the Collector said.

Civil society groups seek Revanth Reddy's ouster over anti-Muslim remarks

Hyderabad: Civil society organisations have demanded that the Congress high command immediately sack Chief Minister A Revanth Reddy for his anti-Muslim rhetoric. They urged the Muslim community not to vote for the Congress party in the upcoming Jubilee Hills by-election. At a press conference held here on Friday, several noted Muslim personalities condemned Revanth Reddy's recent statement at an election campaign rally. Revanth Reddy had said, "Congress hai toh Musalman hai, Congress hai toh aapki izzat hai, Congress nahi hai toh, aap kuch bhi nahi hai (If Congress is in power, Muslims have respect; if it is not, then Muslims have nothing)".

Advocate Syed Taraq Quadri, former member of AP State Minorities Commission, said Muslims fear only the Allah and not any political party. "The Chief Minister's statement demeans the Muslim community in the State, he should tender unconditional apology. The Congress will face defeat in the Jubilee Hills election, Muslims should not vote for the Congress," said Taraq Quadri. Major SGM Quadri (Retd) of Help Hyderabad, a civil society group and NGO, said the Chief Minister should not underestimate the power of Muslims in Telangana as they can form or topple any government. "The Chief Minister released a Muslim Declaration ahead of the Assembly elections in 2023 but so far nothing has been implemented. The promised Rs 4,000 crore budget for the community is an eye wash. The Chief Minister thinks Muslims can be taken for a ride, it will not be so," Major Quadri said, adding that the Chief Minister was



systematically finishing Muslim leadership in the State. The civil society groups reiterated that they had supported the Congress party in 2023 elections hoping that it will help in the upliftment of the Muslim community. "The present Chief Minister is raising communal boundaries and indirectly threatening the Muslim community. The previous BRS government established residential schools for minorities, helped with scholarships and other welfare schemes," said SS Tanvir, SC/ST Muslim Front convenor. Saba Quadri, a social activist, said they had campaigned for the Congress party keeping in view the stand of Rahul Gandhi and Priyanka Gandhi towards the community. We used our own funds for campaigning for the Congress in 2023 believing the 'Mohabbat Ki Dukan' initiative. But the current Congress Chief Minister is not doing anything for the welfare of minorities in the State.

Harish Rao predicts silent revolution in Jubilee Hills

Hyderabad: Former Minister and senior BRS MLA T Harish Rao on Friday predicted a silent revolution in the Jubilee Hills bypoll, asserting that people would decisively vote for the Car symbol to safeguard Telangana's future expose the Congress government's failures. Emphasising the need for a strong voice to question the Revanth Reddy government, which he described as marked by misrule, intimidation, and administrative collapse, he said there were only two teams — one that promised six guarantees and another that fought for their implementation. "People should decide between development and destruction," he said, urging voters to support BRS candidate Maganti Sunitha. Fielding a volley of questions during a Meet the Press programme at the Press Club of Hyderabad in Somajiguda, Harish Rao said whether in power or opposition, BRS had always stood with the people. "When houses were demolished in the name of HYDRAA, we fought for justice. Mohammed Azharuddin became a Minister because BRS questioned injustice to minorities," he charged. He lambasted the Congress government for complete regression in all sectors except crime, citing official police reports to show how law and order had deteriorated since December 2023. "From January to September 2025 alone, there were 189 murders, 1,700 kidnappings, 123 rape cases, 1,051 robberies, and over 6,400 house thefts. Crimes against women rose by 12.3 per cent, rapes by 28 per cent, and kidnappings by 26 per cent. Hyderabad, once an investment hub under KCR, has now turned into an insecurity hub," he said.

The former Minister compared this to the previous BRS regime, which established the Integrated Command Control Centre and installed around 10 lakh CCTV cameras, including six lakh in Hyderabad. "Revanth Reddy reduced the Command Control Centre to a venue for review meet-



ings, while most CCTV cameras remain defunct due to lack of maintenance. Murders are happening in broad daylight, while police act like political agents. Drugs worth thousands of crores were seized in Cherlapalli by Mumbai police, which is a shameful blot on the government," he remarked.On the Congress government's borrowings, Harish Rao said the State's debt had increased by Rs 2.08 lakh crore in just two years. "The State's own tax revenue, which was 12 per cent under BRS, has fallen drastically. Revanth Reddy has stopped welfare schemes citing lack of funds, yet he is ready to spend Rs 1.5 lakh crore each on the non-existent Future City and Musi Riverfront projects designed for commissions," he alleged. Responding to questions about Kavitha's allegations, he said the Congress was indulging in political diversion to cover up its failures. "If anyone must answer, it is Revanth Reddy, as his own colleague Konda Surekha's daughter accused him of extortion and gun threats," he countered. On the Kaleshwaram project issue, he rubbished allegations of BRS-BJP collusion. "If Revanth truly had no ties with the BJP, why hasn't the ED questioned him in the Vote-for-Note case? He would have been behind bars long ago," he quipped.

Dragging armed forces into politics not good for the country

Horticulture crop... Oil palm cultivation... Expansion targets should be achieved in the district and steps should be taken to increase farmers' income

November 7):- Yadadri Bhuvanagiri District Additional Collector Bhaskar Rao has instructed the officers of the local bodies of Yadadri Bhuvanagiri District to take steps to achieve the expansion targets of oil palm cultivation, which is a horticulture crop, in the district and to increase the income of farmers. "On Thursday, an awareness seminar was organized at the Collectorate Conference Hall on the expansion of oil farm cultivation under the auspices of Horticulture, Agriculture, Cooperatives, and Oil Fed for AOs, PACS Secretaries, and Horticulture Officers. Speaking on the occasion, the Additional Collector instructed the officials to implement every scheme effectively so that the income of farmers increases. He said that the officials should work in coordination to increase the area under oil palm plantations. The target is to

cultivate the crop in 3500 acres in the district, and the officials should be advised to identify and educate the farmers for cultivation, and to inform the farmers about subsidies, intercropping income, drip subsidies, etc. He instructed them to show successful farmers as role models and increase the area under cultivation. He said that the scheme should be implemented so that farmers benefit from the cultivation of oil farm crops in the district. He said that facilities like orchards, vegetables, modern cultivation methods, cold storage, processing units, etc. should be provided effectively. He said that farmers should be made aware so that they can grow oil farm crops instead of paddy. He said that the government is providing subsidies on drip and sprinkler methods to farmers for high yields with less water through the Telangana Micro Irrigation Project. With the availability of subsidies by category, farmers have the opportunity to reduce cultivation costs and increase their income. Sandeep, who runs Vasavi Madron Rice Mill, refused when the officials asked him to give him a truck sheet so that he would not be able to harvest rice during the Rabi season. The officials, who were angry with him, registered a 6A case against him on September 9. He approached the High Court after he gave a request to the Collector that it was not ration rice but the higher officials ignored him. He expressed his grief over the authorities not releasing the seized rice despite the High Court's orders to release it after examining the seized rice. Union Minister Nitin Gadkari Responds on Uppal–Narapally Elevated Corridor Works

"KISHORE VADDEPALLI, Uppal, November 7 (Indian Chronicle): "On behalf of the All-Party JAC, Mekala Madhusudhan Reddy brought to the attention of Union Ministers Nitin Gadkari and Kishan Reddy that the Uppal-Narapally Elevated Corridor (Flyover), which was launched in 2018 with a promise to be completed within 18 months, has remained incomplete even after seven years, with less than 50% of the work finished. He assured that, considering the difficulties faced by the public, steps would be taken to resume the flyover works immediately and bring the elevated corridor into public use at the earliest, as mentioned in his reply

Mumbai Airport sees surge in self-service travel adoption, over 6.3 million passengers used DigiYatra in 16 months

Chhatrapati Shivaji Maharaj International Airport (CSMIA) in Mumbai has witnessed a sharp rise in the use of technology-enabled travel solutions, with more passengers opting for self-check-in kiosks, self-baggage drop units, and biometric-enabled DigiYatra services over the past 16 months. According to data shared by the airport, between April 2024 and August 2025, more than 3.86 million passengers printed boarding passes through self-check-in kiosks. Domestic carriers dominated usage, with IndiGo (2.58 million boarding passes), Air India (1.09 million), and Air India Express (53,301) accounting for the largest share. Among international airlines, Air France (90,902), Emirates (18,356), and Lufthansa (18,017) recorded significant

engagement. The adoption of self-baggage drop (SBD) machines has also grown steadily. Over 7.15 lakh bags were processed through 32 SBD units during the same period, with an average processing time of 17 to 20 seconds. Domestic carriers handled nearly 6 lakh of these bags, while international airlines such as KLM, Air France, Emirates, Lufthansa, and Swiss Airways contributed more than 70,000. Monthly adoption rates of SBD rose from 4.15 per cent to 13.9 per cent for international flyers and from 5.26 per cent to 6.28 per cent for domestic travellers between April 2024 and August 2025, the airport said. Biometric-enabled DigiYatra services have seen the sharpest growth. CSMIA's 46 DigiYatra e-gates and 40 face pods processed 6.3 million passengers in the 16 months, with monthly adoption climbing from 12 per cent in April 2024 to 32 per cent by August 2025. The facility allows passengers to clear checkpoints within two to three seconds on average

The airport said these shifts are supported by its modernised Airport Operation Command Centre (AOCC) and aviio, an Al-powered mobile-first platform developed by Adani Airports that enables predictive analytics and real-time operational efficiency. Other tech initiatives include the deployment of autonomous cleaning robots, with plans to introduce smart washrooms and more artificial intelligence-driven solutions across the terminals. "CSMIA continues to lead India's aviation sector in digital transformation, witnessing a sharp rise in passenger adoption of self-service and tech-enabled travel solutions," said a CSMIA officer.

Chandigarh Super Bazar staff get justice after 25-year legal battle

In a landmark ruling that brings closure to a 25-year legal battle, the Punjab and Haryana High Court has ruled in favour of over 100 laid-off employees of the now-defunct Super Bazar Chandigarh, a former cooperative consumer store society. The division bench, comprising Justices Harsimran Singh Sethi and Vikas Sur, ordered the immediate release of long-pending payments, including service benefits, notice pay, and compensation, to be funded from the society's liquidated assets. The judgment, delivered on September 16, stems from the society's closure in 2000. The court upheld the employees' claims against the Registrar Cooperative Societies, Union Territory of Chandigarh, and the society's management, dismissing administrative appeals and addressing the workers' decades-long struggle for fair treatment. The ruling includes substantial financial relief for the employees, whose services were terminated on October 10, 2000. Key payouts include: Service benefits with interest: The workers will receive full gratuity, leave encashment, and other benefits, with 6 per cent simple interest per annum added from the date these were due (October 10, 2000) until payment.

• Three months' notice pay: The court ordered payment of three months' salary in lieu of notice, as required by law, but never provided in 2000. This amount also carries 6 per cent interest from the termination date. Compensation for lost opportunities: The court noted that the Chandigarh Administration had promised to absorb work-



ers into other departments but failed to do so. As many are now too old to find new jobs, the judges mandated "suitable compensation" from the society's assets, considering their years of service and current hardships.

• Provident Fund release: The Employees' Provident Fund Organisation is to receive Rs 32.05 lakh (including interest up to 2012) for unpaid contributions, with this amount to be paid to the workers within eight weeks of the order, ensuring no deductions from their shares. The funds for these payments will come from the society's liquidated assets, estimated at over Rs 11.50 crore, including fixed deposits earning interest. The court directed that any remaining amount after three years be deposited with the Registrar of Cooperative Societies for future claims, ensuring no further delays.

"Students staying in hostels, especially those who have come to West Bengal to study from outside the state. are expected to follow the rules of the hostels. They should avoid venturing out late at night, although they have the fundamental right to go wherever they want. "But the police have certain logistical limitations in monitoring the movement of every individual. Officers would not know who is leaving home at night and cannot stand guard outside every home. she said, reports PTI. She was speaking to reporters at Netaji Subhas Chandra Bose International Airport here before leaving for natural disaster-hit north Bengal to review relief and rehabilitation work.Banerjee termed the incident "shocking", and said that no accused would be spared. "This is a shocking incident... We have zero tolerance for such crimes. Three accused have been arrested and police are conducting searches for others. Nobody will be spared," she said in her first reaction to the incident. Banerjee said that the institution of which the woman is a student of also bears responsibility for the incident.



A startup revolution, the goal of 'innovation capital'



At the TN Rising Investment Conclave in Hosur recently, a young founder from Torus Robotics walked up to the stage, papers in hand, ready to exchange an investment memorandum of understanding with the Government of Tamil Nadu. What set this apart from most of the other corporate majors exchanging MoUs that day was their journey so far — starting with government-backed incubation and refining a difficult problem with patient mentorship and modest seed support. That morning, they were no longer petitioners for opportunity. They became partners of the government in a significant sector with ?100-crore investment. Welcoming startups such as Torus Robotics and many more as investors in the State is a symbol of what we set out to build: a system where a startup nurtured by the government can mature into a collaborator of the State. This is a deliberate outcome of a strategy that marries innovation with inclusion and policy with purpose. Exponential growth in startups

For decades, Tamil Nadu's industrial identity has been anchored in manufacturing excellence. Over the last four years, we have extended that strength into deep-tech and innovation, quietly, steadily and inclusively. When our government assumed office, the State had 2,032 Department for Promotion of Industry and Internal Trade (DPIIT)-registered startups. Today, the number has crossed 12,100, which is roughly a six-fold rise in just four years. It is a matter of pride that 50% of them are women-led. Tamil Nadu has been recognised as 'Best Performer' in the States' Startup Ranking 2022 by the Union Government's DPIIT, which is a move up from 'Emerging State' category in 2018. Chennai was ranked 18th in Asia in the Global Startup Ecosystem Report 2024, and among Asia's top 10 for Affordable Talent. Tamil Nadu also leads the nation in the number of incubators and has been named a model State for the innovation ecosystem by the Atal Innovation Mission.

This is an outcome of a three-pillar strategy that the State has followed to facilitate startups and spark innovation. The first pillar is using State capital as a strategic catalyst. Through the Tamil Nadu Startup Seed Grant Fund (TANSEED), seed grants of ?10 lakh are provided to startups, and ?15 lakh to women-led, green-tech and rurallivelihood ventures. So far, 169 startups such as Ippopay, Gallabox and Dream Aerospace have received ?18.79 crore, which have gone on to attract more than ?537 crore in investments - a 28X multiplier on the State's seed rupee. We are extending this capital logic to frontier sectors. For instance, the Tamil Nadu Space Tech Fund of ?10 crore offers milestone-based assistance up to ?50 lakh on a 1:1 match with external investors, backing both core and downstream space applications, from satellites to Artificial Intelligence (AI)-driven geospatial solutions. Focus on inclusion, gender parityOur second pillar is employing principles of inclusion, and not as charity but strategy. The Scheduled Castes and Scheduled Tribes (SC/ST) Startup Fund, launched in 2022-23 with an initial ?30 crore and enhanced to ?50 crore in 2023-24, delivers equity investments to level the playing field. Forty-three startups such as OrbitAid, Unibose and TAMS Tribal Green Fuel have received 260 80 crore so far. We followed it up with the Periyar Social Justice Venture Lab — an acceleration programme designed to support social enterprises and empower entrepreneurs from SCs and STs. More than 30 such startups are already engaged, and the model is already yielding appreciable results with eight companies having successfully raised the next round of funding totalling ?16.9 crore. We have focused

on gender parity through Thozhili bootcamps that have equipped over 200 women in Coimbatore, Kanniyakumari, Erode and Chennai — 15 women entrepreneurs received ?14.70 lakh for incubation expenses. For physically challenged founders and transgender founders, Special Seed Grant Funds of up to ?5 lakh with structured mentorship and incubation access have been established. For rural innovators, the Gramam Thorum Puthozhil scheme (Establishing Start-ups in Villages) has been implemented. The aim is to have 100 startups in 100 villages, using equity-free TANSEED grants of ?1 lakh and incubation via regional hubs.

Our third pillar was building a decentralised and connected ecosystem. Ten regional hubs — Chennai, Madurai, Tirunelveli, Erode, Salem, Cuddalore, Hosur, Thanjavur, Coimbatore and Tiruchi — bring infrastructure, mentors and markets closer to entrepreneurs. A Metro Hub functions in Chennai, and Thoothukudi has been announced as the next addition. We are also creating the pipeline earlier with 100 Pre-Incubation Centres being rolled out in Tier-II/III/IV institutions. The first 25 have been sanctioned at ?7.5 lakh each (total cost of ?1.87 crore).

Digital rails tie these hubs together. MentorTN has onboarded 320 mentors and 1,171 startups and facilitated 1,120 hours of mentoring. TANFUND connects startups to capital with 300-plus investors and 2,500-plus entrepreneurs registered, 221 Investor Connect programmes conducted, 1,417 startup-investor connections and ?127.09 crore raised so far. StartupTN is also a key partner in Naan Mudhalvan's hackathon programme 'Niral Thiruvizha', through which we guide student projects toward becoming successful commercial startups. The collaboration connects academic and entrepreneurial ecosystems to help students develop technology-driven solutions for real-world problems.

We have complemented capital and infrastructure with tools that reduce friction and raise quality. The story so far: The Mohan Majhi-led Bharatiya Janata Party (BJP) government in Odisha announced the new Odisha Panchayat Samiti Accounting Procedure (Amendment) Rules, 2025, after state cabinet approval last month. However, the Biju Janata Dal (BJD) and the Congress have strongly criticised the amended rules, stating that it undermines people's representatives of the Panchayati Raj Institutions (PRIs).

What are the amended rules?

As per the amended rules, officials at the ground level will now enjoy greater financial authority to pass bills without requiring the counter-signature of elected representatives. Previously, Block Development Officers (BDOs) could clear bills only up to ?2 lakh, with any amount above that needing the approval of the Panchayat Samiti chairman, an elected representative. Under the new provision, BDOs can independently sanction bills up to ?10 lakh. Similarly, the power to grant administrative approval for Panchayat Samiti plans and estimates has been delegated to the Chief Development Officer-cum-Executive Officer of the Zilla Parishad, a senior district-level bureaucrat, even though Zilla Parishads are headed by elected chairpersons. The amendment also expands the authority of engineers to accord technical sanction for larger development projects. Depending on their ranks, engineers can now clear projects ranging from ?5 lakh to ?4 crore — a sharp rise from their earlier financial limits. Similarly, financial authority has been transferred to engineers in implementation of the Mahatma Gandhi Natural Rural Employment Act (MGNREGA), a central government scheme. Administrative approval powers have also been revised for general developmental schemes. BDOs can now approve projects up to ?20 lakh, and Panchayat Samiti Chairpersons (elected representatives) up to ?50 lakh.

What has the opposition said?

According to the government, these amendments will expedite bill processing, ensure timely approvals, and facilitate smooth implementation of developmental programmes across all Panchayat Samitis while retaining the supervisory role of the chairpersons. However, the BJD has alleged that the recent amendment was a conspiracy to downgrade the authority of elected representatives in PRIs on purely political grounds. In the 2022 rural polls, the Naveen Patnaik-led BJD had secured an emphatic victory, winning 766 of 853 Zilla Parishad seats with 52.73% of the

vote — nearly 90% of the total. Although panchayat elections are not contested on party symbols, BJD-backed candidates had virtually swept the polls across the State. The next panchayat elections are due in 2027. The BJP, buoyed by its unexpected triumph in both the Assembly and Lok Sabha elections of 2024, is under tremendous pressure to replicate that success at the grassroots level to consolidate its influence. Observers note that the BJP, through its control of the bureaucracy, can now implement development programmes without depending on PRI members — most of whom are aligned with the BJD.

Why is the BJD angry?

For the BJD, the issue goes beyond financial control or political leverage. The party contends that the BJP has sought to tamper with a legacy: the strengthening of the threetier PRIs, a system nurtured by both the late Biju Patnaik and his son, Naveen Patnaik.Biju Patnaik was credited as the first Chief Minister in India to introduce 33% reservation for women in PRIs, later extending it to chairperson posts. Naveen Patnaik further raised this quota to 50% in 2012. The BJD has also objected to the rebranding of its flagship scheme Ama Odisha Nabin Odisha as Bikashita Gaon Bikashita Odisha, with provisions substantially altered. Under the original scheme, each panchayat received ?50 lakh, but allocations have now been reduced to just ?7-8 lakh, the

religion, caste and the neverceasing struggle for livelihoods



The political dynamics in Seemanchal — encompassing the districts of Kishanganj, Purnia, and Katihar in Bihar - reveal a paradox. Its citizens, in one of India's most backward regions, yearn for governance that will liberate them from cycles of dependence on weather and migration for a better living. But the demography of the place, the overarching influence of the Bharatiya Janata Party from the Centre, and the fragmented polity ensure that simple equations of communal and caste support continue to overdetermine electoral variables in the region. While livelihood issues remain the primary concern for working and underprivileged classes, the electoral landscape here is heavily influenced by a mix of identity politics, caste, and religion. The issue of the Special Intensive Revision (SIR) of electoral rolls has loomed large over the region, though it has been handled to some extent. Anomalies caused by its hasty implementation were acknowledged by some Booth Level Officers (BLOs) but have since been corrected. For example, at Booth no 167 at the Upgraded Middle School in Dhobiniya West, Kishanganj Assembly constituency, close to 93% of those who were excluded were marked as dead. The BLO in charge of the booth said this anomaly had crept in because the reasons for omission were marked in a hurry, as there was little time left to verify the names of residents in the area, which included an itinerant tribal population. The BLO said the error was corrected subsequently, with many marked as "dead" changed to "permanently shifted". The final roll published by the Election Commission of India does not contain the reasons, but mentions that five voters were added afresh to the roll. BLOs across booths, especially in those areas where women voters were disproportionately high among the exclusions, argued that this was done with the families' consent as many young women had already registered in their spouses' places and there were no undue or faulty deletions.

Still, the threat of disenfranchisement remains high for some residents who have been denied official documents since 2005. For instance, residents of an Iranian colony in Kishangani, who asserted that they have lived in the area for generations since British rule, complained that many of them had received notices from the election officers citing inadequate documentation, even after enrolment in the SIR. Haider Ali, a resident, showed that his father held a passport and was enrolled in the 2003 voter list. He himself had other identity documents but received a notice from the Electoral Registration Officer (ERO). Other residents, including some with valid passports, had also received notices. Mr. Ali and a dozen others whose names were in the draft roll managed to be included in the final rolls, but he said there were over 200 people in the area who lack identification documents because of a dispute over their identity since

The travails faced by the Iran-origin residents of Kishanganj, who follow the Shia branch of Islam, were however an anomaly, said Tanzil Asif, the editor of Main Media news portal. He said that Muslim residents in the region had largely secured identification documents fearing harassment ever since the BJP had raked up the "outsiders-infiltrators" campaign. Senior Congress leader and Kadwa MLA Shakeel Ahmad Khan also noted that Muslims in Seemanchal, contrary to their diversity, have long been stereotyped, and with the BJP's rule at the Centre, have become more proactive in equipping themselves with sufficient identification documents. The final voter list was uploaded on the website of the Bihar Chief Electoral Officer on September 30, but in largely illiterate areas, such as the flood-prone Sikorna village in Kadwa, there was little awareness of this, as residents awaited physical verification. Mr. Khan echoed his party leadership's strong denunciation of the EC and the SIR process.

AIMIM entryKishanganj, where nearly 70% of the population is Muslim, had offered a new dynamic in the 2020 Assembly election with the entry of the All India Majlis-e-

Ittehadul Muslimeen (AIMIM) into the fray in Seemanchal. While some AIMIM legislators had defected to the parties in the INDIA bloc after the polls, the "spoiler" factor of the party is still fresh in memory, especially among the Muslim community. Mr. Asif asserted that the AIMIM was not a significant force now and that its most well-known face, State secretary and Amour MLA Aktharul Iman, has largely held his own only due to his personal appeal.Mr. Iman refuted the allegation that his party was communal, saying that it functioned within constitutional boundaries and he himself, as a senior legislator, had always articulated the interests of not just Muslims, but of marginalised sections such as Dalits. He quoted numbers to suggest that parties such as the Rashtriya Janata Dal - to which he belonged before joining the AIMIM - paid little more than lip service to issues related to Muslims and had not provided commensurate representation to the community in contrast to the dominant Yadavs. Yet, he said, the AIMIM had sought to join the INDIA bloc to counter the majoritarianism of the BJP but it was the RJD and other parties that had shown little inclination to let them to do so.A former close associate of Chief Minister Nitish Kumar, Master Mujahid Alam, who defected from the Janata Dal (United) to the RJD earlier this year, now seeks to contest on an RJD ticket from Kochadaman. He dismissed the AIMIM threat and suggested that the party's language, especially that of its leader Asaduddin Owaisi, was sharply communal and could polarise elections. This, he says, is why the INDIA bloc avoids them. Mr. Khan echoed this view, believing that the BJP's fearmongering about "infiltration" will ultimately drive long-term residents, including Bengali-speaking Muslims, from places like Kadwa, to continue to support his inclusive and secular views. The communalisation of politics is a clear undercurrent in Seemanchal. At the bustling Gulab Bagh market, farmers and traders expressed satisfaction with the Nitish Kumar government and the BJP, citing good roads, hospitals, and an airport in Purnia. A farmer, Krishnakant Yadav, confidently stated that aside from the "50% of Yadavs and Muslims", everyone else would vote for the incumbent government, a sentiment echoed by trader Umesh Sahni, who asked rhetorically, "How much more development would

However, a worker in the same market, Faraz Ahmad, discreetly disagreed, suggesting that voter support was not so straightforward, especially in constituencies like Amour, where voters were wary of the BJP and would likely back the Mahagathbandhan (grand alliance). Gauri Shankar Sah, a trader from Samastipur who had come to Purnia to sell his wares, added that while Seemanchal might see support split along communal lines, other parts of Bihar were more contested, with caste variables playing a more prominent role. His co-worker, Raj Kumar Sahni, emphasised that in places like Rupauli, held by Independent MLA Shankar Singh, local issues often trump broader narratives. The verdant villages of Katihar district promise an abundance of crops and food production to new eyes. But as we delve deeper into these villages, the extent of problems faced by residents in one of India's most population-dense but backward regions is starkly visible. Villagers in Sikorna, Kadwa, where the Mahananda river flows, identify themselves as Shershahbadi, a Bengali-speaking Muslim community. The frequent flooding of the region has devastated village roads and wreaked havoc in the lives of the residents there, who angrily demanded that Mr. Khan respond to their requests for more development work. In nearby Bharri village, paediatrician Manvendra Nath Thakur pointed to severe issues in the region related to lack of diversity in the economy. corruption, and the regressive outcomes of prohibition, which had led to several youth and teenagers suffering from drug abuse, among others. All of these would be addressed only if the polity moved beyond issues related to identity

Erukala Woman's House Demolished Despite High Court Stay: Tribal Leaders Seek Justice."



"P.S.ASHOKAN"KARIMNGAR BUREAU"""A major controversy has erupted in Manthani town of Peddapalli district after officials allegedly demolished the house of an Erukala tribal woman in defiance of the Telangana High Court's interim stay order. Leaders of the Erukala community have appealed to the National Commission for Scheduled Tribes (NCST), urging immediate action against the officials responsible." According to the complainant, Kurra Sarakka, wife of Kurra Lingayya, both belonging to the Scheduled Tribe (Erukala) community, the family had obtained all necessary building permissions and NOC from the Manthani Municipal and Revenue authorities. In February 2024, they also secured full approval through TS-bPASS

(Letter No. 367075/MANT/0011/2024) for the construction of a G + 1 residence on Survey No. 314 near Bokkala Vaagu within municipal limits. ""Sarakka stated that despite a High Court interim order dated 30 October 2025 restraining authorities from taking any action, a team of officials led by Municipal Commissioner Manohar, Town-Planning Officer Ashok, Tahsildar Kumaraswamy, Revenue Inspector Anil Reddy, and police personnel headed by CI Raju and SI Sagar, allegedly acting on the instructions of District Collector Koya Sriharsha, arrived at her house around 5 a.m. on 31 October with nearly 30 police constables.""

"They took away our mobile phones, ignored my pleas, and forcibly shifted our family to the police station before razing the building to the ground," Sarakka alleged, adding that the demolition caused an estimated loss of ?1.35 crore and rendered her family homeless. "Community representatives condemned the incident as a "blatant violation of the court's authority and an act of discrimination against a Scheduled Tribe family." They demanded that the NCST order a full-fledged inquiry, initiate disciplinary and legal proceedings against the officials involved, and provide adequate compensation to the affected family. "Erukala Association leaders have also appealed to the State Government to uphold the dignity and rights of tribal citizens, calling the incident a "serious affront to constitutional justice."

US, China seek to avoid trade war escalation, salvage Trump-Xi meeting in Malaysia talks



KUALA LUMPUR, -GNS News Agency, Nov 7 Top economic officials from the U.S. and China ended their first day of talks in Kuala Lumpur on Saturday, with a Treasury spokesperson describing them as "very constructive". The world's two largest economies are looking to avert an escalation of their trade war and ensure that a meeting happens next week between U.S. President Donald Trump and Chinese President Xi Jinping. The talks on the sidelines of the Association of Southeast Asian Nations summit will chart a path forward after Trump threatened new 100% tariffs on Chinese goods and other trade curbs starting on November 1, in retaliation for China's vastly expanded export controls on rare earth magnets and minerals. The recent actions, which also include an expanded U.S. export blacklist that covers thousands more Chinese firms, have disrupted a delicate trade truce crafted by U.S. Treasury Secretary Scott Bessent, U.S. Trade Representative Jamieson Greer and Chinese Vice Premier He Lifeng over four previous meet-

He smiled and waved to reporters but did not comment as the Chinese delegation left the venue for the talks, Kuala Lumpur's Merdeka 118 tower, the second-tallest building in the world. China's top trade negotiator Li Chenggang is also participating in the talks. A Reuters witness saw Li arriving alongside He earlier in the day. About the talks, a Treasury spokesperson said: "They have been very constructive, and we expect them to resume in the morning". The Malaysian government and the U.S. and Chinese sides have provided few details about the meeting or any plans to brief the media about outcomes. TALKING POINTS

The three officials will try to pave the way for Trump and Xi to meet next Thursday at an Asia-Pacific Economic Cooperation summit in South Korea, a high-stakes conversation that could revolve around some interim relief on tariffs, technology controls and Chinese purchases of U.S. soybeans. Minutes before the talks started, Trump left Washington for his tour of Asia and laid out several talking points for the meeting with Xi. It was extended in subsequent talks in London and Stockholm and was due to expire on November 10.But the delicate truce frayed at the end of September, when the U.S. Commerce Department vastly expanded an export blacklist to automatically include firms more than 50% owned by companies already on the list, banning U.S. exports to thousands more Chinese firms.

China struck back with the new global rare earth export controls on October 10, aiming to prevent their use in military systems. Bessent and Greer blasted China's move as a "global supply chain power grab" and vowed the U.S. and its allies would not accept the restrictions. Reuters reported that the Trump administration is considering a plan to up the ante with curbs on a dizzying array of softwarepowered exports to China, from laptops to jet engines. The Trump administration added to the tension on Friday by announcing a new tariff probe into China's "apparent failure" to meet the terms of the 2020 U.S.-China "Phase One" trade agreement that halted their trade war during Trump's first term. Ontario premier provokes Trump's ire once again with Reagan ad

OTTAWA,GNS News Agency,Nov 7 - The premier of Canada's most populous province has again complicated the country's delicate trade negotiations with the U.S., this time with a political ad targeting Americans that has drawn the ire of U.S. President Donald Trump.The ad, commissioned by Doug Ford, Ontario's outspoken Conservative premier who is sometimes compared to Trump, uses a snippet of Republican icon and former President Ronald Reagan saying that tariffs cause trade wars and economic disaster.Read about innovative ideas and the people working on solutions to global crises with the Reuters Beacon newsletter. Sign up here.In a series of posts on Truth Social late on Thursday, Trump called the ad fraudulent, declaring that "ALL TRADE NEGOTIATIONS WITH CANADA ARE HEREBY TERMINATED."

Prime Minister Mark Carney, unlike Ford, has sought to lower the temperature with Trump since taking office in March and had hoped for a deal to eliminate U.S. tariffs on Canadian steel and aluminum imports. In March, Ford, who often sports a "Canada is not for sale" hat, threatened to implement a surcharge on energy going to several American states if the U.S. moved ahead with tariffs on steel and aluminum. Ford later relented, and the White House claimed victory, saying he had "Backed down." Ford said in a Friday statement that after discussions with Carney, Ontario would pause the U.S. advertising campaign on Monday so that trade talks could resume. But the disputed commercial will continue to air this weekend as the Toronto Blue Jays play in the first two games of the World Series, he added, Ford said the message has reached U.S. audiences "at the highest levels. "Some analysts suggested that Ford's ad was only a pretext for Trump's outburst. "Mr. Trump doesn't like to be confronted with the truth," said Asa McKercher, an expert in U.S.-Canada politics at St. Francis Xavier University. He said that the ad is an accurate representation of Reagan's views. Trump first saw the ad earlier in the week and said on Tuesday, "If I was Canada, I'd take that same ad also. "McKercher said that Ford has often used his aggressive and populist style to appeal to American audiences in appearances on conservative-leaning outlets like Fox News, but that his latest ad may have misfired. The Canadian dollar weakened after Trump broke off trade talks, and Ontario is the province most impacted by auto and steel tariffs. "When you use Ford's attack-dog approach, there's always a risk that you're going to get smacked," McKercher said, adding it would be Carney who might need to make concessions to get Trump back to trade negotiations.

Still, Ford's approach attracted some unusual support from politicians on the other side of the political spectrum. Manitoba Premier Wab Kinew, who heads the leftleaning New Democratic Party in the province, posted a message for his "good friend Doug Ford," calling on him to keep running the ads. Green Party leader Elizabeth May cheered "Go Doug Ford!" as she arrived at Parliament in Ottawa on Friday. Pollster Shachi Kurl, president of the Angus Reid Institute, said Ford has acted "as the more pugilistic foil" when the prime minister has adopted a more conciliatory approach to Trump, noting that "it's not a stance that generally hurts him (Ford). "In February, Ford handily won a rare third term as Ontario premier. Earlier this month, Ford said he confronted and threatened to beat up a suspected shoplifter at a Home Depot store, telling an audience at a Toronto club, "Screw this, I'm going after this guy."Trump previously called off trade talks with Canada in June, citing his objection to Canada's digital services tax. Carney rescinded the tax later that month. Under previous



Prime Minister Justin Trudeau, Trump threatened numerous times to walk away from trade talks between Canada, Mexico and the U.S.Laura Stephenson, chair of political science at Ontario's Western University, said Carney does not have many good options, but that the situation is fixable. "Ford can play the bad guy and Carney will have to be the level-headed guy trying to keep discussions on track," she said.

Russian missile, drone strikes on Ukraine kill 4, 16 injured

Kyiv: Russian missile and drone attacks on Ukraine overnight into Saturday killed at least four people and wounded 16 others, local officials said.

In the capital, Kyiv, two people were killed and nine were wounded in a ballistic missile attack in the early hours of Saturday, Timur Tkachenko, head of Kyiv's city military administration, said. A fire broke out in a non-residential building in one location, while debris from intercepted missiles fell in an open area at another site, damaging windows in nearby buildings, Ukraine's State Emergency Service wrote on the message app Telegram. "Explosions in the capital. The city is under ballistic attack," Mayor Vitali Klitschko wrote on Telegram during the onslaught.

In the Dnipropetrovsk region, two people were killed and seven wounded, acting regional Gov Vladyslav Haivanenko said, adding that apartment buildings, private homes, an outbuilding, a shop and at least one vehicle were damaged in the strikes. Ukraine's Air Force said Russia launched nine missiles and 62 drones, of which air defences intercepted four missiles and 50 drones.

In Russia, the country's defence ministry said its air defences shot down 121 Ukrainian drones over Russia overnight. The attacks came after Ukrainian President Volodymyr Zelenskyy urged the United States on Friday to expand sanctions on Russian oil from two companies to the whole sector, and appealed for long-range missiles to hit back at Russia. Zelenskyy was in London for talks with two dozen European leaders who have pledged military help to shield his country from future Russian aggression if a ceasefire stops the more than three-year war. The meeting hosted by British Prime Minister Keir Starmer aimed to step up pressure on Russian President Vladimir Putin, adding momentum to recent measures that have included a new round of sanctions from the United States and European countries on Russia's vital oil and gas export earnings.

Thailand's Queen Mother Sirikit, influential style icon, dies at 93?



BANGKOK, GNS News Agency,Nov 7,Thailand's Queen Mother Sirikit, who brought glamour and elegance to a postwar revival in the country's monarchy and who, in later years, would occasionally wade into politics, has died aged 93, the Thai Royal Household Bureau said on Saturday. The palace said she had been hospitalised since 2019 due to several illnesses and developed a bloodstream infection on October 17 before passing away late on Friday. A mourning period of one year has been declared for members of the royal family and household.

The government said public offices would fly flags at half-mast for a month and asked government officials to observe mourning for one year. Thai Prime Minister Anutin Charnvirakul cancelled his trip to the ASEAN summit in Kuala Lumpur due to the Queen Mother's death. He told reporters he would travel to Malaysia to sign a ceasefire agreement with Cambodia on Sunday but return to Thailand afterwards. STYLE ICON WHO CHARMED THE WORLDSirikit's husband, King Bhumibol Adulyadej, was Thailand's longest-reigning monarch, with 70 years on the throne since 1946. She was at his side for much of that, winning over hearts at home with their charity work. When they travelled abroad, she also charmed the world's media with her beauty and fashion sense.

During a 1960 visit to the United States that included a state dinner at the White House, Time magazine called her "svelte" and "archfeminist." The French daily L'Aurore described her as "ravishing". Born in 1932, the year Thailand transitioned to a constitutional monarchy from an absolute monarchy, Sirikit Kitiyakara was the daughter of Thailand's ambassador to France and led a life of wealth and privilege. While studying music and language in Paris she met Bhumibol, who had spent parts of his childhood in Switzerland. "It was hate at first sight," she said in a BBC documentary, noting that he had arrived late to their first

meeting. "Then it was love."The couple spent time together in Paris and were engaged in 1949. They married in Thailand a year later when she was 17.Always stylish, Sirikit collaborated with French couturier Pierre Balmain on eyecatching outfits made from Thai silk. By supporting the preservation of traditional weaving practices, she is credited with helping revitalise Thailand's silk industry.CHAMPIONED RURAL DEVELOPMENT

For more than four decades, she frequently travelled with the king to remote Thai villages, promoting development projects for the rural poor - their activities televised nightly on the country's Royal Bulletin. She was briefly regent in 1956, when her husband spent two weeks in a temple, studying to become a Buddhist monk in a rite of passage common in Thailand. In 1976, her birthday, August 12, became Mother's Day and a national holiday in Thailand. Her only son, now King Maha Vajiralongkorn, also known as Rama X, succeeded Bhumibol after his death in 2016 and upon his coronation in 2019, Sirikit's formal title became the Queen Mother. Officially, the monarchy is above politics in Thailand, whose modern history has been dominated by coups and unstable governments. On occasion though, the royals including Sirikit have either intervened or taken actions seen as political. In 1998, she used her birthday address to urge Thais to unite behind the then-prime minister, Chuan Leekpai, dealing a crippling blow to an opposition plan to hold a no-confidence debate in the hope of forcing a new election.Later, she became associated with a political movement, the royalist People's Alliance for Democracy (PAD), whose protests brought down governments led by or allied to Thaksin Shinawatra, a populist former telecoms tycoon. In 2008, Sirikit attended a funeral of a PAD protester killed in clashes with police, implying royal backing for a campaign that had helped oust a pro-Thaksin government a year earlier. For many Thais, she will be remembered for her charitable work and a symbol of maternal virtue. Her death will be treated with reverence in a country where any criticism is held at bay by strictly enforced lese-majeste laws, which prescribe potential prison sentences for insulting royals, even those who are dead. The government has requested the private sector to modify festive events to align with the national mourning period. Kpop group Blackpink, which includes one Thai member, will go ahead with scheduled concerts this weekend, with organisers asking concertgoers to dress in black and white as a mark of respect. On Saturday, mourners dressed in black gathered in front of Chulalongkorn Hospital where Sirikit had died. Thai PM to sign Cambodia ceasefire deal, cuts short ASEAN trip after royal death

KUALA LUMPUR, GNS News Agency, Nov 7 -Thailand's prime minister will travel to Malaysia on Saturday to sign a ceasefire deal with Cambodia and meet with U.S. President Donald Trump, but will cut short his attendance at the ASEAN Summit there due to the death of the Thai Queen Mother Sirikit. Foreign ministers of the Association of Southeast Asian Nations were meeting on Saturday at the start of a weekend of global diplomacy in Kuala Lumpur, with teams from the United States and China holding trade talks alongside the summit. Trump is due to arrive on Sunday morning for the first stop of his trip through Asia, and was set to watch Cambodia and Thailand sign a broader ceasefire deal after he helped broker an end to a deadly five-day border conflict in July. Dozens of people were killed and around 300,000 were temporarily displaced in the most intense fighting between the Southeast Asian neighbours in recent

Thai Prime Minister Anutin Charnvirakul will arrive in Malaysia on Saturday night and attend the opening ceremony of the ASEAN summit on Sunday, the Thai government said in a statement, after earlier signalling he might have to miss the whole event. He will then have a meeting with Trump where they will discuss economic issues, security and regional development, ahead of the signing ceremony of the ceasefire deal, which is being brought forward so that Anutin can return to Bangkok on Sunday. "Thailand has recently received several requests for bilateral meetings at the leadership level, which will lead to the development of cooperation in various areas, including the economy, security, and trade," Anutin said. Earlier he said he would miss next week's APEC Summit in South Korea due to the death in the royal family. ASEAN, at its annual meeting, plans to press for trade multilateralism and deeper ties with new partners, while managing the fallout from Trump's global tariff offensive. It will also welcome East Timor, Asia's youngest nation, as its 11th member. Alongside the regional talks, U.S. Treasury Secretary Scott Bessent and U.S. Trade Representative Jamieson Greer will hold a round of trade talks with a Chinese delegation led by Vice Premier He Lifeng.



The world's two biggest economies are looking to find a way forward after Trump threatened new 100% tariffs on Chinese goods and other trade curbs starting November 1 in retaliation for China's vastly expanded export controls on rare earth magnets and minerals. World leaders, including Chinese Premier Li Qiang, Brazilian President Luiz Inácio Lula da Silva, Canadian Prime Minister Mark Carney, South Africa's Cyril Ramaphosa and Japan's newly elected Prime Minister Sanae Takaichi, will join Trump at the summit on Sunday. The U.S. president is expected to hold a highly anticipated meeting with Lula on the sidelines of the summit, although the talks are still unconfirmed. Lula said he plans to argue that the 50% tariffs imposed by Washington on Brazilian goods were a "mistake", citing a \$410 billion U.S. trade surplus with Brazil over 15 years. Trump told reporters aboard Air Force One on his way to Asia that he would consider reducing tariffs on Brazil under the right circumstances. Trump stated that he does not intend to hold a similar meeting with Carney and that he is "satisfied with the deal we have" with Canada. Trade talks with Canada, the United States' second-largest trading partner, were abruptly cut off over an advertisement issued by Ontario's provincial government that featured former U.S. President Ronald Reagan saying tariffs cause trade wars and economic disaster.

Trump returns to Asia for ASEAN summit amid trade, security talks

Kuala Lumpur: Southeast Asian foreign Ministers held talks Saturday ahead of a landmark ASEAN summit that will formally welcome East Timor as the bloc's 11th member and mark US President Donald Trump's first trip to Asia since returning to the White House. The meeting serves as a curtain-raiser for the annual Association of Southeast Asian Nations summit, which starts on Sunday in Kuala Lumpur, followed by two days of high-level engagements with key partners, including China, Japan, India, Australia, Russia, South Korea and the US.Leaders are expected to focus on regional security, economic resilience, and maritime disputes, with US tariffs and shifting global trade patterns looming large over discussions.

Malaysian Foreign Minister Mohamad Hasan cautioned his counterparts that "the turbulence of global politics will surely continue to cast a long shadow over our region in the years ahead." "As the international landscape becomes increasingly dominated by contestation rather than consensus, division rather than dialogue, ASEAN finds itself at a crossroads," he said. "Our space for neutrality and centrality is narrowing, particularly in areas such as trade, technology and regional security arrangement," he said. "We must continue to act as the speakers and not the spoken for." A separate leaders summit of the Regional Comprehensive Economic Partnership — the world's largest trade

bloc encompassing ASEAN and five partners: China, Japan, South Korea, Australia, and New Zealand - will convene for the first time since 2020. Its revival comes as regional economies seek to stabilise trade flows at a time when Washington's tariff measures have rattled markets and tested decades of globalisation. Apart from Trump, Chinese Premier Li Qiang and Japan's newly inaugurated Prime Minister Sanae Takaichi are among more than a dozen leaders attending the ASEAN summit and related meetings.Brazilian President Luiz Inácio Lula da Silva and South African President Cyril Ramaphosa will also participate as new sectoral dialogue partners — part of Malaysian Prime Minister Anwar Ibrahim's effort to deepen ASEAN's economic ties with Africa and Latin America. Trump's trip marks his first ASEAN meeting since 2017 and his first journey to Asia in his second term. The last US president to attend an ASEAN meeting was Joe Biden in 2022.Officials say Trump is expected to witness new US trade deals, including with Malaysia. Trump is also expected to preside over the signing of an expanded ceasefire between Thailand and Cambodia, following border clashes between the countries earlier this year. The ceasefire deal was brokered in Kuala Lumpur in July with ASEAN's support and under Trump's threat to suspend

Nitish-niti: What this moment means for the Bihar CM, his party



It was an uncharacteristic sop, considering Nitish Kumar, while a proponent of state-led welfare schemes, has in the past publicly opposed the language of freebies and direct doles, making it clear that he preferred the subsidy model instead. Critics of the government saw in the announcement a sign of desperation — that the Chief Minister, after almost two decades in power, was no longer his own man. His health, after all, has been the topic of conversation, anti-incumbency was a real fear, and his alliance partner, the BJP, after years of snapping at his heels, seemed to be catching up. Yet, those close to him cite the free electricity announcement to say that Nitish is very much in control. A source close to the CM House explains, "The scheme was, in fact, the BJP's idea, which his bureaucrats too backed. The CM agreed, but gave his own value-addition to the scheme — that consumers can also opt to install solar panels on their rooftops. For extremely poor families, the government will bear the entire cost, and for the rest, the government will provide appropriate support. He insisted on the solar panel idea so that the burden of the free scheme on the state exchequer would be eased over time.'

Over the past two decades. Nitish has led the JD(U) in four Lok Sabha elections and as many in the state. Irrespective of which way the results went, there has been one constant: Nitish as Chief Minister. He has walked between alliances with the ease of a man crossing a familiar path, each time underlining his worth to his allies and rivals.But this time could be different. At 74. Nitish is visibly slowing down. The man, known to be alert and cautious and with an enviable grasp on facts and figures, often trails off mid-sentence. His interactions with journalists at his Vidhan Sabha office, a regular feature during Assembly sessions, have been curtailed since 2019, and he has shunned media interviews. Two decades is a long time by any measure, but most certainly for politics. As Nitish Kumar prepares to take the field for another campaign, around him, much has changed. A generational shiftWhen Nitish began his first big term in 2005, he was up against Lalu Prasad and his quintessential family politics that had come to define Bihar. Lawand-order and patronage in governance were the biggest talking points. So Nitish, who had positioned himself as an antidote, put his head down and worked on getting the basics right: roads, schools and hospitals, law and order. The state budget rose from Rs 25,000 crore under the RJD rule to over Rs 1 lakh crore in a matter of few years and now stands at Rs 3.17 lakh crore. The road network in the state went up from 14,468 km in 2005 to 26,000 km in 2025.

But now, as Bihar votes on November 6 and 11, he will have to convince an entire generation of young voters, who have never seen or would have no memory of the Lalu-Rabri regime, that he continues to be their best bet. He will have to work hard to dial down the hope that his opponent Tejashwi Yadav's employment promises may have stirred in this segment, explain to them how he once redefined the state's politics, how he moved away from the RJD's politics that revolved around identity and the lalten (lantern, the RJD's symbol) to a strong welfare model that focused on

education for girls, women's empowerment and grassroots governance. This generation of young voters, those in the 20-29 age group, has gone up from 15.5% of the population in 2006 to 18.9% in 2026 (based on Census projection data). Meanwhile, there has been a generational shift in Nitish's rival camp too, with his old foe's son Tejashwi Yadav projecting himself and the RJD-led Opposition bloc as a youth-led alternative. The Leader of the Opposition has promised that if the Mahagathbandhan came to power, it would ensure a government job for a member of every family in the state. As Nitish Kumar prepares to take the field for another campaign, around him, much has changed. As Nitish Kumar prepares to take the field for another campaign, around him, much has changed.JD (U) chief spokesperson Neeraj Kumar says the party, too, has been reaching out to the youth. "We opened an engineering college in each of the 38 districts. We set up a Youth Commission to identify the problems of the youth and suggest measures to resolve those. We are also giving a monthly allowance of Rs 1,000 to those between 18 and 25 years for two years, besides running a credit card scheme for students of professional courses by giving them loans of up to Rs 4 lakh on a 4% interest rate," he says.

Ashwani Kumar, leading social scientist and professor at Tata Institute of Social Sciences, Mumbai, says whether this generational shift works for or against Nitish remains to be seen. "Indeed, Bihar has changed beyond recognition. Yet, Nitish Kumar's political dilemma in 2025 remains as much generational as ideological. The development-centric Vikas model that transformed Bihar in 2005 now demands an upgrade — a shift from vernacular modernity to an aspirational, cosmopolitan Vikas Plus. He will have to meet the aspirations of a state with one of India's largest millennial and Gen Z populations. Nitish, the most unusual socialist and Mandal-era wizard, is making a careful effort to emotionally reconnect with this restless generation."RJD national spokesperson Subodh Kumar Mehta says it was Lalu's "social investments, which led to a greater participation of the weaker sections in the decision-making processes, that paved the way for Nitish Kumar". "People expected Nitish to carry forward the idea of social empowerment and economic development. Nitish peaked in 2010 but post 2010, his image as a pan-India leader got dented on various fronts," he says. When Nitish came in, he was a leader without a caste bloc while Lalu's politics coalesced around his unbeatable Muslim-Yadav social base. Nitish sensed an opportunity. With some deft calculations, he rearranged the existing pieces of the caste puzzle to carve out a new base for himself — the Extremely Backward Classes as a subset of non-Yadav OBCs, Mahadalits and women.

Through a mix of political messaging and targeted welfare schemes such as 50% reservation in panchayats, the free bicycle scheme and prohibition, Nitish assiduously cultivated the women vote - an effort that paid off as women came out in huge numbers to vote. From 2010 onwards, in a reversal of voting trends until then, female voter turnout in Bihar has consistently outstripped the male turnout. According to Election Commission data, in 2015, for example, 60.5% of women voted compared to 53.6% of men. "Nitish Kumar's strength is his caste-neutral constituency of women, consolidated through 50% quota in panchayats, the formation of 11 lakh self-help groups with 1.4 crore Jeevika workers, and the Rs-10,000 assistance to 1.21 crore women entrepreneurs. Plus, girls from Class 1 to postgraduate levels get free education in the state; we give Class 9 girls — now also to boys — free bicycles. Teiashwi envies this constituency, cultivated very meticulously by Nitish," says another JD (U) leader. While the JD(U) may be confident about the women vote, it's the EBC plank that has chipped away since the 2010 Assembly elections, when the NDA ended up with 206 of 243 seats - the first vindication of Nitish's social engineering project.

Since then, several top EBC and Mahadalit leaders have left his ranks - from top EBC leader and former MP Mangani Lal Mandal, who is now RJD state president, to prominent Dalit leaders Uday Narayan Choudhary and former minister Shyam Rajak (now in the RJD). While the JD(U) has worked to retain the EBCs and Mahadalits, who together form around 20% of the population, with land and vocational training schemes, the Opposition camp, too, has been wooing them. In the 2020 polls, when the JD(U) won only 43 out of the 115 seats it contested, it lost from over three dozen seats that had a substantial EBC and SC population. A JD(U) leader explains: "Till the 2010 Assembly elections, JD(U) was the main stakeholder of EBC votes. But with the rise of Narendra Modi since the 2014 Lok Sabha elections, the BJP has also been getting a substantial chunk of EBC votes. Nitish's core constituency of OBC Luv-Kush (Kurmi-Koeri) also saw cracks in the 2024 Lok Sabha polls when the Mahagathbandhan cut away Koeri votes by fielding seven candidates from the social group." Besides, his old team of political advisors - former bureaucrat N K Singh, former MP Shivanand Tiwari (now in the RJD), and veteran socialists such as K C Tyagi and the late Sharad Yadav - has made way for a different set of people. Many oldtimers in the party point to the appointment of Sanjay Kumar Jha, a former BJP man who is now the JD(U)'s national working president, as evidence of how far the party has left its socialist background behind. Kartikeya Batra, Assistant Professor (Economics) at Azim Premji University who is currently researching Bihar election trends, says, "It is a fair point that EBCs and Mahadalits may not have received fair representation in jobs, politics and other positions of power (during Nitish's terms). For instance, as per one analysis, in Bihar's current Assembly, a little over 10% MLAs belong to the (non-Muslim) EBC category, which is much lower than their population share. However, does that mean that JD(U)'s pro-EBC and pro-Mahadalit politics has failed? I would say that ensuring empowerment among marginalised communities is an incremental process. The first step was to ensure basic public goods such as law and order, education and healthcare. Maybe not fully, but that has happened over the last two decades."On whether the current set of policy priorities have reached a point of saturation, Batra says: "The next obvious aspiration among these social groups will be to occupy positions of power. This does give other parties an opening, but cannot negate what CM Nitish Kumar has done for them in the past."The indispensable Mr KumarNitish Kumar's JD(U) was the number one party in 2010 (115 seats), number two in 2015 (71 seats, when he was part of the Mahagathbandhan) and number three party in 2020. Despite this apparent slide, Nitish went on to become CM each time. His numbers did not matter, what mattered was which side he chose. The BJP tried its best to decode this "Nitish factor", but failed. In 2015, with Nitish out of the NDA, the BJP in Bihar had hoped to ride on the Modi wave that brought it to power in the 2014 general elections. But despite a high-pitched campaign by PM Modi, the Mahagathbandhan, of which Nitish was a part then, won 178 of 243 seats and rode to power. Nitish had proved that he held the key to the power cabinet. Nitish walked in and out of the NDA some more, before finally coming back in January 2024. "After Nitish made sure that the BJP had learnt its lesson — that they had no life without him — we returned to the NDA fold on our terms, getting the best ministries," says a JD (U) source. But with the BJP on a much surer footing since then, Nitish has been looking increasingly vulnerable within the alliance. In the 2020 elections, the JD(U) contested on 115 seats, but won only 43, while the BJP had a much better strike rate (it won 91 of the 102 seats it contested).

Jobs, palayan, and the weight of being a Bihari: Aboard a train full of migrants going home for Chhath Puja

The Amrit Bharat Express that leaves Delhi's Anand Vihar station in the afternoon and arrives in Motihari in Bihar the next morning is packed to the brim. Every year, as Chhath Puja nears, trains headed east overflow with migrants returning home. This one is no exception. In the sleeper coach, it takes nearly 15 minutes to push through the narrow aisle to the berth. Sacks, suitcases, plastic buckets, cardboard boxes filled with pressure cookers, and utensils lie strewn around. The only way to move luggage is to balance it on the head and squeeze sideways. In the compartment where this reporter has a reservation, 15 adults and seven children share eight seats. The floor and berths are cluttered with bags and new purchases — mixies, dinner sets, blankets — all gifts to take home. Some passengers have no option but to stand through the night. Yet, there isn't a word of complaint. "Arey kono baat naikhe, sab kehu adjust ho jai. Chhath ba (This is no problem, we can adjust to anything, this is Chhath after all)," a man says cheerfully, giving up his berth for the children.

That soon turns into grumbling about the filthy condition of trains. However, the blame falls not on the Railways, but passengers themselves. "Stuff a train with Biharis and they'll make it dirty," a man jokes. "The dirtiest trains are the ones going to Bihar." His friend nods. "And Chirag Paswan keeps saying 'Bihar First, Bihari First'. First teach Biharis some civic sense."The jokes have an edge. They come from a place of shame. not arrogance. Beneath the laughter runs the shared knowledge of palayan, migration, the word that defines modern Bihar and now shapes its politics.

Sitting on the floor near a toilet between a coach and the pantry car are Ramesh Sah, a Bania (OBC) by caste, and Ravikant Pandit, a Kumhar Prajapati (EBC), both in their fifties and both from Chiraiya in Motihari. They work in Haryana and are on their way home for the festival. "What has any government done for people like us?" asks Sah. "If they had, I wouldn't be sitting between two coaches like this. Only migration is the big problem. No party has solved it, no party will. You need a leader like Yogi Adityanath who does what he says."In another coach, 25year-old Vijay Thakur, who works as a barber in Gurgaon, sits on the floor near a toilet. For him, migration is not a political failure but a social one. "My brothers migrated in the 2000s, then I joined them. The problem isn't politicians, it's us. We can't rise above caste, so no leader feels the need to change anything."

Between coaches S2 and S3, two young men stand clutching their bags. Mohammed Jehangir and Saheb Alam, marble polishers in Delhi, are from Awasani in West Champaran. They have been working outside Bihar since 2014. "There are no jobs at home. I have six brothers, all in different cities," says Jehangir. More than the physical hardship, what weighs heavily are the slights they face for being a Bihari in another state. Mukesh Sah, a 30-year-old auto driver from Piprakothi in Motihari, sits in the aisle and is forced to get up every time someone heads to the bathroom. "I live with four others in one small room near Kailash Colony (in Delhi). In my village, I wouldn't tie my buffalo in that space. But the landlord earns lakhs just because he was born in the right place."

"Ask anyone in this train how we're treated in Delhi. 'Bihari' is used as an abuse. But we bear it for our families."When someone jokes that he can soon go home faster on a bullet train. Mukesh laughs. "Bullet train? We'll still be sitting in the aisle! No one, (PM) Modi or Nitish (CM Nitish Kumar), has done anything for migrants. That's why people want change now. Yogi ji should contest from Bihar."In the adjacent coach, Anil Kumar Yadav, a 26-yearold factory worker in Haryana, has similar complaints. "My supervisor calls me 'Ae Bihari!' I told him, I don't call you 'Ae Haryanvi'. Don't I have dignity? They employ us because we work hard, but still treat us as somehow less."The conversation soon turns towards the elections, as naturally as the train rattling over the tracks. "Only in Bihar do people worship the setting sun," Yadav says, drawing political symbolism from the Chhath Puja rituals. "That's why Nitish keeps winning.

Yadav calls himself a Lalu Prasad loyalist — credits the RJD leader with giving dignity to the lower castes — but adds, "He never developed Chhapra. Modi at least takes all investments to Gujarat."He talks of Bihar's glorious past - Nalanda, Aryabhatta — and wonders why no one builds on it. "Look at Haryana. Gurgaon is like Dubai! Cyber Hub shines like pearls. If they can do it there, why can't Bihar? Bihar isn't poor, its governments are.'

However, not everyone agrees. Ramesh Mahato and Vijay Sah, both auto drivers in Delhi, argue over Nitish Kumar's record. "He's done good work — roads, electricity, peace," says Mahato, a steady NDA voter. Sah shakes his head. "Not voting for him this time." Why? "Because of



darubandi (liquor ban)."But isn't Prohibition a good thing? "Good? Liquor is available everywhere. Only costlier now. Jan Suraaj is saying they'll lift it, and all those who drink will vote for them - 75% of men in Bihar drink," Sah says. Jehangir, the marble polisher, is impressed with Jan Suraaj because of its founder Prashant Kishor, the strategist-turned-politician. "He talks sense. Very sharp, no journalist can stand before him. He's quick with replies, like Owaisi (AIMIM chief)." Still, he says he'll vote for RJD leader Tejashwi Yadav, not Kishor.Yet, Kishor's shadow looms large on the train. Byas Sah and Luv Kumar, painters from Bettiah who are returning from Panipat, say people in their village discuss Kishor often. "We watch his speeches on YouTube. People like the issues he raises," says Byas. The two debate his promise to end Prohibition and generate jobs. "Maybe that'll help," hopes Luv, who says he will vote for the BJP. But their fellow traveller Jeetendra Kumar, 21, interrupts: "That will destroy Bihar!" Byas shrugs. "At least he's talking about migration. He says every youth will earn Rs 10-12,000 in Bihar itself. Maybe then this tyranny travelling like packed sardines — and the humiliation we face in cities will end."In the next coach, Ravi Jha, a young man from Sitamarhi, says his family has always voted for the BJP, but adds he will vote for the RJD. Not because he sees great promise in Tejashwi, but because he does not like the BJP candidate who is a Teli (OBC), while the RJD candidate is a Rajput. Further down, carpenters Ram Avtar Paswan from Ramnagar and Imamul Hussain from Bagaha share a single berth. Paswan, a Dalit, supports the BJP. "It's a dabang (fearless) party," he says with pride. Hussain, who backs the RJD, bursts out laughing. "Dabang? What will they do, beat up those who don't vote for them? Power doesn't win votes; money does. The Rs 10,000 given to women will decide the election." Paswan grins. "Why? Won't Hindu-Muslim politics help the BJP win? Soon, the polls will be polarised and all Hindus will vote in favour of the BJP."At that moment, the train jerks violently and halts. "Puncture to nahi ho gayi? Ja ke check karna. Tumko to aata hai (Has there been a puncture? Go check, you know

how to do it)," Paswan jokes, nudging Hussain.

Mohammed Shami, 35, will not join those two illustrious men, with more than 1,000 wickets between them, in that roll of honour, but ever since he made his much-awaited comeback last November after a year-long absence because of an ankle injury, his main focus has been to successfully age. There appears to be a consistent desire to create meaning from whatever is left of his cricketing life even as he comes to terms with the inevitable bodily vul-

There has, however, been one major obstacle -India's selectors are unmoved. While the T20I boat has admittedly sailed past Shami after a below-par IPL (six wickets from nine matches at an economy-rate of 11.23 for Sunrisers Hyderabad), the Bengal quick's non-inclusion in the touring party to Australia for the ongoing three-match ODI series, despite his prominent role in India's 2025 Champions Trophy-winning side, would have hurt. His fortunes in Test whites were dealt body blows when he was selected neither for the two multi-day matches India-A played against Australia-A in September nor for the upcoming twin fixtures against South Africa-A. The opening Test of India's twomatch series against South Africa at his beloved Eden Gardens on November 14 thus looks like an unattainable dream.All of which has now given rise to the question of whether Shami still has something to offer the Indian team and if the think-tank still sees value in the speed merchant who, not so long ago, bamboozled batters with his skiddy pace, impeccable skill and inch-perfect control. For one, Shami seems to be suffering from a lack of game-time in red-ball cricket, something chief selector Ajit Agarkar pointed out when the squad for the two-Test series against the West Indies was announced. Since the World Test Championship final against Australia in June 2023, Shami has played one Ranji Trophy match versus Madhya Pradesh in November 2024, one Duleep Trophy encounter for East Zone versus North in August and last week's Ranji game versus Uttarakhand. "He has not played a lot of cricket," Agarkar said. "In the last two-three years, I think he has played one match for Bengal and one match in the Duleep Trophy. So, as a performer, we know what he can do. But, he will need to play something."But it is equally true that he has been a victim of circumstances. After the successful Champions Trophy sojourn, Shami played a full IPL. The Duleep Trophy was his next stop but the tournament's knockout format meant that the pacer could play just one tie as East Zone crashed out in the quarterfinal. In fact, in that one outing, Shami, watched by selectors Shiv Sunder Das, and Subroto Banerjee and S. Sharath (both of whom have since vacated their positions), gave a decent account of himself despite not bowling at full throttle. He sent down 34 overs in all, troubled batters with his seam movement and lift, and, in a throwback to his menacing past, struck Kanhaiya Wadhawan once on the glove and then on the helmet, off back-to-back deliveries. In the recent eightwicket win over Uttarakhand, he was the Player of the Match (3/37 in 14.5 overs & 4/38 in 24.4 overs). Handbrake off

needs to do more than this. It may help — and even liberate — him that he would not be required to hold himself back in the fear of getting injured again, for this may well be his last roll of the dice. "He is a guy who has performed when he has been provoked, and shown intensity and focused harder if he has been challenged and kind of chided... that's the kind of personality Shami is," former India batter W.V. Raman, who has seen Shami at close guarters during his coaching stints with Bengal, told The Hindu. "So, I think this is perhaps something that he will take as extreme provocation and maybe force his way back into the side and perform extraordinarily."This, in turn, will depend on two things. In the event Shami regains his old magic, would the Indian management like to ration his time as a lead pacer the way it does with Jasprit Bumrah? Does it view Shami's inclusion as a hindrance to the development of a young pace bowler? The decision-makers' thinking, at least in the second matter, is evidently clear. Khaleel Ahmed (27 years), Punjab's Gurnoor Brar (25), who was in the Rest of India team for the Irani Cup, and Vidarbha's Yash Thakur (26), who won the Ranji Trophy last season, all found a place in the India-A squad that played Australia-A, and are also part of the roster that will take on South Africa-A. With Bumrah, Mohammed Siraj, Prasidh Krishna and Akash Deep part of the first-choice attack, and the likes of Harshit Rana and Arshdeep Singh already among the back-ups, it does leave Shami with very little room. Moreover, India is pencilled in to play just three Tests in the first nine months of 2026 one versus Afghanistan at home and two away in Sri Lanka - before it travels to New Zealand for two more. As a result, ODIs might be where Shami finds his opportunities, with the 2027 World Cup in South Africa, Zimbabwe and Namibia a good target to aim at. The 50-over format is where he has left his deepest imprint in recent times, setting the 2023 World Cup on fire with a tournament-high 24 wickets from seven matches at an average of 10.70 and then winning the 2025 Champions Trophy.In the UAE, Shami became the fastest Indian bowler to get to 200 ODI wickets (104 matches) and was the second-quickest internationally, behind Australian left-arm pacer Mitchell Starc (102). It is perhaps instructive that, in August, Shami said that winning the 2027 edition was the "only dream left", and as recently as last week, with reference to his non-selection for the Australia tour, caustically remarked: "If I can play fourdayers [Ranji Trophy], I can also play 50-overs cricket."

For Shami to attract the selectors' gaze, he perhaps

"It's all a question of timing," said Raman when asked if 2027 was a realistic target. "A lot of factors will be at play, but it's definitely something that cannot be ruled out. Especially [with respect to] fast-bowling, because, of late, there has been a great need for fast-bowlers. "I'm sure that he will fancy his chances, given that he's done it over a period of time and he knows, perhaps, that he can maintain the fitness that is required. It will be challenging no doubt because beyond a certain stage, every year that passes in your life is going to be challenging.'

Trans people deserve better



As both a trans woman and a woman, I have come to understand that policy is not an abstract document drafted in bureaucratic chambers; it is the scaffolding of our lives. For gender minorities, whose existence is often questioned or ridiculed, the absence of inclusive, enforceable, and humane policy is not just a governance gap; it is a denial of dignity. Families may abandon us, schools may shut their doors, and workplaces may feign diversity while keeping us at the margins. Gender transition is expensive and requires resources most cannot access. The cost of abandonment, coupled with hunger, often leaves little choice but to walk into situations that endanger dignity and safety. A hungry body rarely waits for laws to catch up; it succumbs to survival. Hollow quotas Governments announce quotas for employment, education, housing, and welfare initiatives. But the reality is one of selective dispersal, corruption, and bureaucratic gatekeeping. One only needs to ask how many trans persons have genuinely benefited from these quotas to see the distance between promise and practice. I recall standing in a queue outside a government office, forms filled in triplicate, my gender identity scrutinised with voyeuristic curiosity rather than bureaucratic neutrality. A guota that exists on paper but requires humiliation to access is not empowerment, it is entrapment.

Beyond the corridors of policy lies the texture of daily life. Try finding a home for rent as a transwoman and you will encounter the labyrinth of prejudice. Landlords hesitate, neighbours whisper, and societies form silent barricades. Housing, a basic marker of stability, becomes a privilege denied. Even public spaces are fraught with ridicule. On buses, people stare and snigger; in markets, whispers follow every step. For many trans persons, the act of boarding a train or buying vegetables is an exercise in courage. To present one's strongest self while enduring relentless humiliation is nothing short of heroic. Yet, policy has not caught up with the reality that safety in public spaces is as much a right as food or shelter. History shows us the cost of systemic exclusion. When African-Americans were denied civil rights, democracy in the U.S. was hollow. When

women were denied the vote, half the world was relegated to second-class. The denial of rights to gender minorities is a repetition of history's cruellest errors. Every time a trans person is denied education, a scientist is lost. Every time a trans person is denied housing, an artist is displaced. Every time a trans person is ridiculed in public, a leader is silenced. Policy cannot remain something done for us; it must be done with us. For too long, gender minorities have been treated as passive recipients of government benevolence than active participants in shaping priorities.Representation in politics is not symbolic — it is structural. Without trans voices in Parliament, State Assemblies, and municipal councils, our realities remain footnotes in files rather than the focus of legislation. When decisions about housing, healthcare, or education are made without us, they reproduce the blind spots of privilege. Urgent prioritiesThe first is education, including scholarships, inclusive curricula, and anti-discrimination protocols. A child bullied out of school is not just a statistic; she is a future cut short. The second is to provide affordable, state-supported gender transition and mental health care. Transitioning is not cosmetic; it is survival. The third is employment and housing. Anti-discrimination laws, rental protections, and workplace inclusivity must be enforced with penalties. Representation must translate into payrolls and property deeds. All these are non-negotiable foundations of equality. A nation that sidelines its gender minorities sidelines its own potential. The measure of society is not how it treats its powerful but how it safeguards its vulnerable. Denial of human rights is not merely a trans issue; it is a national issue. By excluding us, India loses talent, creativity, and the unique perspectives diversity brings. Consider the flourishing of arts, sciences, and reform whenever societies widened their embrace. When women entered universities, medicine advanced. When Dalits entered legislatures, democracy deepened. When LGBTQ+ persons are allowed to live openly, culture and business innovated with vitality. India cannot aspire to global leadership while silencing voices at home that seek nothing more radical than the right to live with dignity. As a trans woman, I am reminded daily that resilience is our inheritance, but resilience cannot substitute for rights. Policy must bridge the chasm between personal courage and systemic support. Without it, we remain trapped in cycles of abandonment and ridicule. And most importantly, without seats for us in political chambers and decision-making forums, every law will remain about us but never truly with us. Inclusion in politics is not tokenism; it is the very architecture of justice. The censor board passes derogatory content about us, but a trans person has never been appointed to a mass-media board. Policy is not paperwork. Policy is life. Until gender minorities are woven into its fabric and its political debates with sincerity, our nation will remain

a patchwork of promises rather than a tapestry of justice.

Inside Bengaluru's private schools: How workplace hierarchies are impacting teacher well-being



Largely characterised by the model of missionary founded schools which existed as the first private schools in the city, Bengaluru's mid-range to high-income private schools continue to be the benchmark of 'quality education' for most urban middle-class parents. This image, now more than a few decades in the making, finds its place amongst a larger nation-wide phenomenon of commercialised private schooling that is characterised by similar features across infrastructural and intellectual factors. The private schooling phenomenon, as it were, has been highlighted by scholars who suggest that the growing perception of good education continues to attract the middle-class to elite sections of parents for whom private schooling whether midrange or high-income is the norm. India's private school sector is the 3rd largest school system in the world just behind China's school system and India's Public Education System. Some 73% of students in urban areas attend a private

The National Education Policy 2020 (NEP) posits private schools as one of the key examples of educational development that should be emulated in public schools. It proposes a twin-development model by which simultaneous advancement of both private and public school can take place with the public school emulating the management style and "efficiency" of a private school. However, beneath the seemingly "efficient" functioning with lakhs of students passing out of the ICSE, CBSE and International curricula every year is an unanswered question of hidden workload and labour code violations that have lost their cases multiple times in the Indian court.

Legally, teachers in India do not fall under the category of "workmen" or "workers". This exclusion is rooted in a consistent line of Supreme Court judgments that have sought to define the nature of teaching as distinct from the categories of labour covered by India's industrial and labour laws. The prevailing judicial interpretation hinges on the view that teaching is an intellectual and moral activity, not aligned with the manual, clerical, or operational functions typically associated with industrial employment. This position was firmly established in Sundarambal v. Government of Goa, Daman and Diu (1988), where the Supreme Court held that teachers are not "workmen" under Section 2(s) of the Industrial Disputes Act, 1947. The court reasoned that including teachers within this category would undermine the "nobility" of their profession and fail to capture the essence of their intellectual labour. The demographic profile of private school teachers in India reveals distinct patterns compared to their public school counterparts. According to existing data, private schools, particularly in urban areas, tend to attract younger, highly educated female teachers. The average age of a private school teacher is 34 years, notably younger than the average of 40 years for government school teachers. This younger age profile also corresponds with differences in household status—private school teachers are significantly less likely to be heads of households, especially in urban contexts (29% in urban areas versus 42% in rural areas). In terms of educational qualifications, private school teachers are reported to possess tertiary education, with 88% in urban areas and 75% in rural areas holding degrees at the undergraduate level or higher. How work culture affects teacher well-beingOutside the research and

legal precedents into teacher labour is the work culture that

these teachers with a clear distinction of who reports to whom. Occupational well-being is affected by a number of factors ranging from physical exertion to emotional labour performed at the place of work. In this instance, teachers were asked to respond specifically to structural and operational systems in workplaces and its effects. Teachers often reported either rigid hierarchies or flexible hierarchies- both of which had a clear impact on their work lives. Ms. Hemathy, a biology teacher in one of Bengaluru's mid-range private schools reported, "In my school, if a teacher approaches a principal directly, they'll be asked, 'Why didn't you approach your HOD first?"One teacher also spoke to how person-dependent the hierarchical structure makes other systems of functioning, "My coordinator puts the relevant systems in place, but if she leaves, the structure will fall apart. There's no official channel between teachers and management."Rigid hierarchies are usually maintained in institutions to reduce the time spent completing an administrative task so as to ensure labour hired is efficiently used. Counterintuitively, and as reported by teachers, the presence of a rigid hierarchy did not result in better efficiency towards reducing teacher workload. Several teachers in midrange to high-income schools reported being subject to multiple administrative layers in their reporting structure, "We submit lesson plans to at least three people before approval", a middle-school Geography teacher, Ms. Edvina says. "It becomes more about how much can be presented on paper more than what I can actually execute in a classroom". Teachers interviewed noted that these processes created feelings of being over-monitored and undervalued mainly because of the administrative workload that is redundant to the classroom but serves to maintain power structures outside of it. Good workplace is rare luckA mirror image of this evidence also strengthens the causal connections. In schools where teachers said the hierarchy was the most flexible part of the school's operations, they pointed to the better working standards and were more satisfied in the way that they taught. However, teachers in this environment were extremely aware and are quick to point out they are the anomaly. A teacher of Mallya Aditi International, a well-known high-income school in Bengaluru, says: "I say this to everyone I meet, I know I struck the lottery when I joined Aditi. I wouldn't get this treatment anywhere else."The corporatisation of schools is part of this phenomenon, says retiree and formal head of department, Ms Shobita. The movement creates more and more power vacuums and ambiguous structures where there is no platform to address issues related to workload. In certain environments, particularly older schools where seniority is perpetuated across the years, that is, seniormost teachers taking position as head of subject departments, the culture toxifies over time. "There was a culture where seniors would dictate even how you wore your sari and what materials such as chiffon or georgette could be disallowed," says Ms. SuchetaTeachers consider having good superiors as "lucking out". To them, it dictates the tone for the academic year altogether. Ms. Sucheta, an ex-commercial studies teacher, taught at the same school for 13 years. While praising her department, she says, "But I saw across departments with friends, there was 50% to full control over teachers' lives whether it was the number of classes they took, how they taught, what they did, how they corrected or evaluated the papers. Sometimes it would drain them out". A culture of protection and community is built when there is a lack of an institutionalised guarantee of workplace ethics or workload compensation. A lot of work occurs under the guise of teachers as vessels of the school's legacy. They are expected to perform teaching tasks and carve out time within the spaces to facilitate events. Culture was also perceived to "trickle down" from leadership. As one teacher explained, "The principal being fair sets the tone for the rest of the employees." The emotional labour of teaching continues to remain an ambiguity when formal well-being systems were absent, teachers relied on peer bonding to fill emotional gaps. As one teacher

How Trump's H-1B fee threatens India's IT firms and Big Tech business models



The Trump administration has deployed a \$100,000 annual fee on H-1B visas, a move designed to obliterate the business models of India's IT giants and Big Tech's wage arbitrage schemes while leaving America's universities and startups standing. Whether this crude instrument will achieve its intended effect without inflicting collateral damage on America's innovation ecosystem remains an open question. The policy addresses a genuine issue as H-1B workers now account for 65% of America's IT workforce, up from 32% in 2003. This surge did not just occur because of a shortage of American talent. The administration notes that computer science graduates face unemployment rates of 6.1%, while their peers in computer engineering struggle with 7.5% joblessness. Meanwhile, some technology firms filed over 10,000 H-1B applications in fiscal 2024 alone, often in the same years they conducted mass layoffs of Ameri-

After a back and forth over the weekend, the Trump administration has confirmed that the fee will apply only to new visa applications. Still, this will devastate India's IT services industry. Companies like Tata Consultancy Services, Infosys and Wipro have built empires on a simple arbitrage: import Indian engineers willing to work for substantially less than their American counterparts. Their business model depended on H-1B visas costing a few thousand dollars in filing fees, making it economical to flood the system with applications and cherry-pick the most cost-effective workers.At \$100,000 per visa, this lottery system becomes prohibitively expensive. Indian IT firms face a stark choice: raise prices dramatically or retreat to offshore delivery models. Either option undermines their competitive position against American rivals, though the latter may paradoxically accelerate job losses as entire functions migrate overseas rather than remaining onshore with H-1B workers. American technology companies will face their own reckoning. The minimal cost of H-1B applications previously allowed HR departments to treat visa petitions like lottery tickets. Now each hire becomes a significant capital allocation requiring executive approval. This should naturally filter applications toward genuinely exceptional candidates with irreplaceable skills, which was the programme's original purpose. Yet the policy's collateral damage may prove severe. International students contribute over \$40 billion annually to America's economy, with more than half pursuing STEM fields. These represent the world's intellectual elite, individuals who have already demonstrated commitment to American institutions through years of study and substantial financial investment. The \$100,000 fee signals that their post-graduation prospects in America have dimmed considerably. Countries like Canada, Australia and the United Kingdom have crafted sophisticated strategies to attract precisely these individuals. As America raises barriers, competitors lower them, potentially capturing the talent that will drive the next decade's technological breakthroughs. The timing seems particularly unfortunate. China's growing technological prowess and geopolitical tensions have intensified competition for global talent. Pushing the world's brightest minds toward rival nations does not eliminate security risks, but merely transfers competitive advantages to America's competitors. A blunt instrument The policy's design reflects a preference for simplicity over sophistication. Rather than treating all H-1B applications equally, a more nuanced approach might have created graduated fees based on salary levels, exempted graduates from elite American universities, or established lower rates for workers in cutting-edge research fields. Such refinements could have maintained the policy's effectiveness against labour arbitrage while preserving America's ability to attract exceptional talent. The current approach resembles using a sledgehammer where a scalpel might suffice. The broader implications extend beyond immigration policy. America's post-war dominance in science and technology rested partly on its ability to attract and retain global talent. The H-1B programme, whatever its flaws, served as one mechanism for this attraction. By making the programme prohibitively expensive for most employers, the administration risks severing connections between American institutions and international talent pools. The policy may also accelerate trends it ostensibly seeks to reverse. If American companies cannot economically hire foreign workers for onshore roles, they may shift entire operations overseas. This could reduce employment opportunities for American workers rather than increasing them. Similarly, the fee structure may inadvertently benefit the largest technology companies at smaller firms' expense. Google or Microsoft can absorb \$100,000 fees more easily than startups or mid-sized companies, potentially concentrating talent among established players rather than distributing it throughout the innovation ecosystem. The administration's approach reflects a broader philosophical shift from balancing corporate needs with talent attraction toward prioritising domestic workers. This addresses legitimate concerns about wage suppression and worker displacement. However, immigration policy operates in a global context where other nations compete aggressively for the same talent America now seems increasingly reluctant to welcome. The irony is stark: having spent decades building the world's most attractive higher education system and innovation ecosystem, America now risks gifting its carefully cultivated advantages to competitors through self-imposed barriers. Whether the benefits of reduced labour arbitrage will outweigh the costs of diminished talent attraction remains unclear. What seems certain is that other nations stand ready to welcome the exceptional individuals America may no longer want. For global Big Tech and Indian IT firms, the \$100K will clearly make them put their house in order and re-evaluate how they plan to hire and deploy human resources in the coming months.

All-access pass: Chennai rides to the future

Seamless travel between different modes of public transport in Chennai is round the corner. The 'Chennai One' mobile application, developed by the Chennai Unified Metropolitan Transport Authority (CUMTA), will allow commuters to use a single pass across transport systems. It will be launched by Chief Minister M.K. Stalin on Monday. In the works for long, the application has been developed by integrating the digital ticketing platforms of the Chennai Metro Rail and suburban trains — including the Mass Rapid Transit System — along with the electronic ticketing system of the Metropolitan Transport Corporation (MTC). Commuters will be able to travel in all the three modes of public transport using the application. They will no longer have to download different mobile applications or carry different

'Chennai One' is based on insights gathered from a study, titled 'Journey Planner-cum-Integrated Ticketing in Chennai Metropolitan Area'. Officials say this application will be the first of its kind in the country, integrating three different modes of public transport, while giving the option of finding the cheapest and fastest mode of transport available, drawing from even private travel aggregators, if necessary.CUMTA Member-Secretary I. Jeyakumar says that while digital ticketing systems are available for Metro Rail and suburban trains of Southern Railway, a new digital ticketing system has been developed for the MTC as part of this mobile application. The ticketing system involves integration of the application with the Unreserved Ticketing System (UTS) of the Indian Railways. It will be maintained by the Centre for Railway Information System (CRIS). "Once the MoU is signed, the digital application will be tested for errors so that commuters can have seamless and hassle-free travel." Mr. Jeyakumar says several inputs have gone into fine-tuning the application, which will cover more than 6,000 bus stops (latitudes and longitudes), 650 bus routes, and the nearly 3,500 buses of the MTC fleet.In a study done before commissioning the integrated ticketing system, the CUMTA found nearly 47 lakh commuters using the different modes of public transport in the city every day, with the three major modes of travel — the MTC, Southern Railway, and Metro Rail — having a common distancebased fare system. While the MTC and Metro Rail, which are State-owned transport bodies, have found convergence in recent months through a common mobility card called 'Singara Chennai', suburban trains use an independent digital ticketing system of the UTS. The MTC, having recently launched digital ticketing through the Unified Payment Interface (UPI), has been clocking nearly one lakh digital transactions daily through electronic ticketing machines. Fare integration is the future forwardWhile the CUMTA is coming out with the common digital ticketing mechanism, transport activists insist that a common fare denomination mechanism will be more attractive for commuters to use public transport. Sivasubramaniam Jayaraman of the Institute for Transportation and Development Policy (ITDP) says digital transactions are the future and with the CUMTA having developed a common ticketing mechanism, fare integration is the way forward. Transport activists point out that the fare structure for all modes of public transport is based on distance, with minor changes reflecting passenger amenities. Hence, a common fare mechanism should be put in place for the commuters to use public transport for longerdistance travel in different modes.CUMTA Member-Secretary I. Jeyakumar says the first phase of the common ticketing project is the medium integration of Metro Rail, suburban trains, and MTC buses, and fare integration will be done in the final phase. He adds the future is not far ahead for commuters to travel hassle free by using the

CUMTA's integrated ticketing application. Transport activ-

ists insist that a common fare denomination mechanism will be more attractive for commuters to use public transportAccording to the data, nearly 35 lakh passengers use MTC buses, nine lakh use suburban trains and three lakh ride Metro Rail services daily. Comparing the unified ticketing mechanism available in Mumbai and Bengaluru, where commuters could travel only on bus and Metro Rail using a mobile application, the CUMTA would roll out a wholesome integrated system, for the first time in the counaimed at providing last-mile connectivity, he says. The MaaS tool developed by the Ministry of Housing and Urban Affairs, in collaboration with German agency GIZ, evaluated five major indicators: travel behaviour, system integration, policy readiness, market potential, and data availability for ticketing system integration of independent public transport operators (PTOs). To assess the use of automatic fare collection (AFC), cashless ticket systems, and inter-modal options, the CUMTA did a readiness survey among the PTOs. It found that the Chennai Metro Rail was the only operator that had implemented all the three systems. Southern Railway did not implement two systems (AFC and inter-modal options) and the MTC was not familiar with any of these systems. The CUMTA also carried out a multi-PTO workflow study, involving a passenger travelling from Ennore to Guduvancheri using the three modes of public transport taking a suburban train from Ennore to Central (?5), the Metro Rail from Central to Airport (?40), and an MTC bus from Airport to Guduvancheri (?31) using the QR code mechanism. The study also generated management information system (MIS) reports of the various steps for smooth and seamless travel on all the three routes. Railway Board's green signalFor the ticketing system, the CUMTA conducted a market study by roping in private and government players, including the CRIS, Chartr, and IIT-Madras, to understand the capital and operational expenditures required for deploying the integrated ticketing system. After this, the only hurdle for the CUMTA to implement the common ticketing mechanism was bringing on board the Railways' UTS, for which the Railway Board gave the green signal through a letter in September 2023. "Ticketing is no longer a simple part of the public transport experience. It is what enables freedom of movement across modes and borders," the UITP, or International Association of Public Transport, highlighted in one of its reports some years back. From London to Singapore, cities across the world had adopted unified ticketing decades ago, resulting in significant ease of commuting. For instance, the UITP report indicated that when the number of travellers rose sharply in the 1990s, Transport for London (TfL) introduced the Oyster card; by 2013, payment for more than 85% of all rail and bus rides were made through it. This is the kind of paradigm shift that Chennai is poised to witness once the CUMTA launches the single ticketing mobile application, wherein a single QRcode ticket would be sufficient to travel on Chennai Metro Rail, MTC buses, and suburban trains. With the National Common Mobility Card (NCMC) or the Singara Chennai Card already in place and commuters using MTC buses and Metro Rail with the help of these cards, the CUMTA's mobile application will only enhance commuting. India and US begin work on trade draft; Goyal underlines: No deal with a 'gun to the head'



The India-US trade talks, marked by twists and turns, seems to be moving closer towards a conclusion as negotiators from both sides are said to have begun working on the language of the text but a final announcement will require "political convergence," a senior government official said here Friday. Indicating as much while strongly reiterating the red lines, Commerce Minister Piyush Goyal, at a conference in Berlin Friday, said that India doesn't do deals with a deadline or with a "gun to the head." He framed the negotiations as a process in which India will look at its long-term implications and how it secures the national interest for a country with a young, aspirational population.

In New Delhi, explaining the course of the talks, the senior official said: "There are some non-tariff barriers that are being discussed. Teams had virtual sessions yesterday, and some more virtual talks will happen on Monday. In principle, we have agreed and are finalising the language (of the deal text). As far as the deal is concerned, there is more or less convergence from both sides."

The official added that "this time" US negotiators could arrive in India for talks. On a question regarding past differences over oil and agriculture, the official said, "We are finding some common ground (on agriculture). As negotiators, we know there aren't many differences. We are negotiating positively. Engagement is going well. Having said that, the deal has not been announced. It could happen in the future. Deals are announced at a political level. As negotiators, we know we are close," the official said. The official further said that the India-US trade deal, like other deals announced between the US and other countries, won't be a conventional free trade agreement (FTA). "It won't be a conventional FTA because there are reciprocal tariffs which are not WTO most-favoured-nation (MFN) tariffs. Normally, deals are negotiated MFN vs MFN. In that context, this will be a different kind of deal," the official said. As the US has begun adding more and more items under the Section 232 tariffs net, the official said, "In some of the areas, our efforts

will be to address them." Underlining the red lines, Goyal said Friday during the Berlin Global Dialogue in Germany that India does not do trade agreements in a hurry or with a "gun to our head".The minister was in Berlin to participate in the dialogue, a meeting of leaders and German businesses to discuss ways to boost bilateral trade and investments."We are in active dialogue with the EU. We are talking to the US, but we do not do deals in a hurry and we do not do deals with deadlines or with a gun to our head," he said. He added that trade deals should be viewed with a long-term perspective. "India looks long-term, India never takes decision in a rush or on the pressure of the moment. And we have accepted if there is a tariff on us, there is a tariff on us. We are looking how to overcome that, we are looking at newer markets, we are looking at a stronger demand impetus within the Indian economy, so we have a very resilient structure. (We are) 1.4 billion people, we are young. So they are not in a situation where they want to do sub-optimal deals, we would like to really look at long term. We recognise that 20-25 years from now, we will be a \$30trillion economy and, accordingly, we will negotiate based on the future. Trade deal is for the long run, to recognise the future and to get the best deal for the country," Goyal saidWhen a panelist remarked that India was being asked to rethink its friendship with Russia, Goyal said: "I do not think India has ever decided who its friends will be based on any other considerations other than national interest... and if somebody tells me you can't be friends with the EU, I won't accept that, or if somebody tells me tomorrow I can't work with Kenya, it's not acceptable." The decision to buy a particular product from a country is something that the entire world will have to take a call on, he said."I was reading in today's paper that Germany is asking for an exemption from US sanctions on oil... The UK has already sorted or probably got an exemption for procuring oil from the US... so then why single out India?" he said. Goyal's remarks come as the US has imposed additional tariffs on India over its imports of Russian oil. On October 22, the US also imposed sanctions on Russia's two largest crude oil producers, Rosneft and Lukoil, barring all American entities and individuals from conducting business with them. "Trade deals are for a longer duration. It is not only about tariffs or access to goods and services; it is also about trust and relationships... Trade deals, in a longer context, are far more than just tariffs, and we are too focused on current issues and tariffs," he added. India and the US have been negotiating a bilateral trade agreement since March this year. So far, five rounds of talks have been completed. Goyal on Thursday stated that these negotiations are progressing and expressed hope that both sides would work towards a fair and equitable agreement in the near future

RBI to cap bank lending for corporate takeovers at 70% of deal value

The Reserve Bank of India (RBI) on Friday laid down draft guidelines for bank financing of corporate acquisitions, marking a significant policy shift that opens the door for lenders to fund takeovers, a practice long prohibited in India. Under the proposed rules, banks can finance up to 70 per cent of the acquisition value, with the balance 30 per cent to be funded by the acquiring company through its own equity.

This means if the acquisition cost is Rs 10,000 crore, banks can lend up to Rs 7,000 crore to fund the acquirer which should be a listed company with a profit track record for three years. "The acquisition value of the target company should be determined by two independent valuations, as prescribed under SEBI regulations," the RBI said in its draft framework. The move follows RBI Governor Sanjay Malhotra's announcement during the October 1 monetary policy, in which he said banks would now be permitted to finance corporate takeovers, an area previously off-limits due to regulatory concerns.

For decades, Indian banks were barred from directly funding takeovers amid fears that promoters could misuse borrowed funds to gain control of companies rather than invest in genuine business expansion. Limited exceptions were made in recent years, mainly for acquisitions carried out under the Insolvency and Bankruptcy Code (IBC)

process. The RBI has now asked banks to formulate a comprehensive policy on acquisition financing. This must include clear norms on borrower eligibility, security and margin requirements, risk management, monitoring mechanisms, and overall exposure limits. The move is expected to deepen India's credit market, improve liquidity for mergers and acquisitions, and give banks a greater role in shaping corporate restructuring while maintaining regulatory safeguards against misuse.

The RBI said banks should comply with the rule that the acquiring company and the SPV set up by it, wherever applicable, should be a corporate body and should exclude financial intermediaries such as NBFCs and Alternate Investment Funds (AIF)."(The) Acquiring company should be a listed entity, having a satisfactory net worth and profit making for the last three years. The annual returns target company should be available for at least the previous three financial years," the central bank said in its Draft Reserve Bank of India (Capital Market Exposure) Directions, 2025. The aggregate exposure of a bank towards acquisition finance should not exceed 10 per cent of its Tier 1 capital, the central bank said. Further, the acquiring company and the target company should not be related parties, where a 'related party' is as defined in Section 2 (76) of the Companies Act 2013. The credit assessment should be based on the combined balance sheet of the acquirer company and the target company, it said. Post-acquisition debtto-equity ratio at the acquiring company level or the SPV/ target company level, as applicable, should be within prudential limits set by financing banks, subject to a maximum of 3:1, the RBI said. The acquisition finance should be fully secured by shares of the target company as primary security, the RBI said. Assets of the acquirer and/or target company, or other securities held by the acquiring company, may be taken as collateral security as per the bank's policy. "Banks should put in place rigorous and continuous monitoring of acquisition finance exposures to manage the risks, with early warning systems and regular stress testing to detect and address any signs of stress in the portfolio," it said. Meanwhile, the RBI said the aggregate capital market exposure (CME) of a bank, on a solo basis, should not exceed 40 per cent of its Tier 1 Capital as on March 31 of the previous financial year. "The aggregate CME exposure of a bank, on a consolidated basis, should not exceed 40 per cent of its consolidated Tier 1 Capital as on March 31 of the previous financial year," the RBI said.

Reliance, Meta launch Rs 855 crore joint venture for enterprise AI in India

Mumbai: Reliance Industries on Saturday announced that its subsidiary, Reliance Intelligence Ltd, has established a joint venture with US tech giant Meta's subsidiary to market and distribute enterprise AI in India. A new company, namely Reliance Enterprise Intelligence Limited (REIL), has been formed as a joint venture with Facebook Overseas, Inc., according to an exchange filing. The Mukesh Ambani and Mark Zuckerberg-led companies have committed an initial combined investment of around Rs 855 crore in the unit, aimed at "developing, marketing, and distributing enterprise AI services."Reliance Intelligence will own 70 per cent of REIL, while Facebook Overseas, Inc., a unit of Meta Platforms, will hold 30 per cent, the filing said. The partnership will provide an enterprise Al platform-as-a-service, enabling organisations to customise and deploy generative models, along with a suite of pre-configured solutions for industries including sales, marketing, IT operations, customer service, and finance.RIL's AI arm will invest Rs 2 crore towards the initial subscription of 20 million equity shares of Rs 10 each. The transaction does not fall within a related party transaction, and none of the company's pro-



moters or promoter group, or group companies have any interest in the above transaction, the filing said. No governmental or regulatory approvals were required for the incorporation of REIL, it added. Reliance announced a joint venture in August that will use Meta's open-source Llama models combined with Reliance's enterprise reach to offer Al tools across sectors. Meta will provide technical expertise for Llama-based models, while Reliance will leverage its digital infrastructure and access to thousands of Indian enterprises and small businesses.

Know your ORS: Why sugary drinks may be worsening your diarrhoea and WHO formula holds the key



Watching children come to her clinic severely dehydrated despite taking ORS (oral rehydration solution) prompted Hyderabad-based paediatrician Dr Sivaraniini Santhosh to look into what they were having. She found that these tetrapacks often did not have the right sugar-salt ratio. In fact, they had added sugar that made them no different from other flavoured drinks."A true ORS formulation uses a specific, low amount of glucose to help the body absorb sodium and water. Excessive sugar in drinks disrupts this process, creating a high concentration in the gut that pulls water from the body. The excess sugar can draw more water into the bowels, leading to a severe kind of diarrhoea and fluid loss," she says. The problem? It leads to more dehydration and diarrhoea in already sick children something that can turn fatal in the absence of timely medical care. That's why she decided to begin her campaign against flavoured drinks posing as ORS. What genuine packet of ORS looks like What genuine packet of ORS looks

It took eight years for the country's apex food regulator (Food Safety and Standards Authority of India [FSSAI]) to stop all fruit-based, non-carbonated, ready-to-drink beverages from using the term ORS in their trademarked name. But her battle continues as the Delhi High Court has stayed the operation of the order after the Johnson & Johnson subsidiary, JNTL Consumer Health, submitted that products worth Rs 155-180 crore have already been manufactured or are in the supply chain.Dr Santhosh says over the last decade or so, many fake products had entered the Indian market. "Even if a product carries the warning 'not ORS', people still think that it is an ORS solution because that's what the brand name suggests," she says. So, what exactly is ORS and why is it so important to maintain the sugar and salt proportion in the formulation?

The oral rehydration solution — a simple glucose-electrolyte mixture — can reduce deaths and hospitalisation due to acute diarrhoeal diseases, especially in children under the age of five. The glucose in ORS helps the small intestine absorb sodium and water more effectively and offset fluid loss. This is possible because a specific transport mechanism for sodium and glucose remains intact even during diarrhoea. By facilitating rehydration, ORS can prevent serious complications such as dizziness, low blood pressure and organ damage. Its timely use is especially critical for children and the elderly who are more vulnerable to rapid fluid loss.ORS is the result of ground-breaking work by Indian paediatrician Dr Dilip Mahalanabis during the Bangladesh liberation war of 1971. It helped save millions of lives in the following decades. With a deficiency of saline to treat cholera patients in the refugee camps during the war, Dr Mahalanabis started administering patients with the simple salt, water and sugar solution, asking them to consume it till their condition improved. This reduced the case fatality in the refugee camps from 30 per cent to just one per cent. That's why it was hailed as "the most important medical advancement of the 20th century." The composition of the ORS is based on the daily sodium and notassium requirement and what is lost in the stool — earlier for cholera and now for the more common diarrhoeal diseases. The glucose in the solution facilitates the absorption of salts in the ORS, which in turn pull in the water, helping in quick rehydration," says Dr Harish Chellani, former head of the department of paediatrics at Safdarjung hospital. "However, any additional glucose and the change in concentration shifts the osmotic pressure. So, the water gets drawn out of the cells and into the gastrointestinal tract. This actually worsens the diarrhoea. This is the reason the ORS has to stick to the WHO formulation."

Nearly eight per cent of children under the age of five globally die due to diarrhoea. In India, the prevalence of diarrhoea in this age group is at 9.2 per cent, according to data from the National Family Health Survey. Dr Sisir Paul, clinical director at Madhukar Rainbow Hospital, says, "For most cases of diarrhoea, you do not need antibiotic therapy. It is the resulting dehydration that has to be managed as it can lead to hypertension, kidney failure and death. Providing ORS solution is an effective way to prevent complications, especially in remote areas where access to health facilities can be limited." All the more reason why these lifesaving packets cannot have too much sugar. "The absorption of the water will not happen properly if the WHO formula is not followed," says Dr Ramesh Aggarwal, professor of neonatology at the All India Institute of Medical Sciences (AIIMS), Delhi. Dr Chellani argues that high sugar drinks may prompt children to drink more. "People say that the WHO formulation is not tasty and children might not drink it even when they have diarrhoea but that is not true. The use of ORS is actually self-limiting — children will continue to drink it as long as they are dehydrated. The problem with a sweetened, flavoured drink is that children may continue to drink it beyond their requirement. This can not only be dehydrating, it also exposes the children unnecessarily to more salts and sugars." He says people should avoid giving children aerated beverages during such an episode. "Many believe that lemon-aerated beverages can help when the stomach is tender but in reality, they can distend the stomach and increase the risk of vomitting, leading to

further fluid loss." The WHO had an older high osmolarity formulation meant for those with cholera that causes higher sodium loss — and a new low osmolarity formula. Studies have shown that the low osmolarity formula can reduce unscheduled requirement for IV by 33 per cent, stool output by 20 per cent and vomitting by 30 per cent in children. WHO has recommended the use of this formula since 2003. For this solution, you need 2.6 grams of sodium chloride, 13.5 grams of glucose, 1.5 grams of potassium chloride and 2.9 grams of trisodium citrate. This is usually available as a packet of powder that has to be mixed in a litre of water. Such packets are available across all government healthcare centres and with ASHA workers for free. Similar products can be purchased at any neighbourhood medical store. Smaller packets meant for a glass of solution and reconstituted solution in tetra packs are also available but one has to ensure that it is the WHO recommended formulation. Once made, the solution can be used for up to 24 hours, after which a new solution should be prepared. Dr Aggarwal warns that "the sachets should be mixed with the amount of water specified on the pack - mixing it with too little or too much water can change the concentrations. It is easy to mix the one-litre packs as people usually have one litre bottles available at home." He cautions people against trying to divide the powder in a sachet on their own to mix two or three batches of solution. "If you divide the powder on your own, then there is no way to tell how much salt and sugar is going in. It is best to mix the entire pack," says Dr Aggarwal. Dr Paul advises against gulping down the powder with water as it changes the composition. All three experts warn against preparing the solution at home. "These packets are easily available everywhere now. Parents should use these salts to ensure that the concentrations are maintained," says Dr Chellani. Experts say it is best to use ORS salt sachets readily available at government health facilities or neighbourhood stores instead of buying tetra packs. Most of these sachets will mention "as per WHO recommended formulation." While not all tetra packs are sweetened drinks, the salt sachets are likely to reduce the risk of ending up with products that do not adhere to the concentrations. Sachets usually cost less than Rs 22 as the price of the ORS in India is capped at Rs 1.11 per gram of salt and a packet usually contains over 20 grams of pow-

Swimming and water workouts: Swimming in an indoor pool has an impact on lung volume measurements because swimmers' diaphragm and other respiratory muscles must expand to a greater pressure during the respiratory cycle. This can improve the function of these muscles and change the elasticity of the lung, chest wall or ventilatory muscles. Compared to runners, swimmers have better lung capacity. Easy hacks: Climbing up the stairs helps you process oxygen better. Twisting and bending forward, backward and sideways — and doing soft lunges with low intensity, all done with gradual breathing, make for a good lung workout. Pilates: Pilates strengthens the diaphragm and other muscles involved in breathing, which improve both inhaling and exhaling. Routines build core strength and spinal alignment, which in turn reduce slouching and allow the lungs to expand more fully. By coordinating movement with deep breathing, Pilates exercises have been shown to improve key pulmonary parameters such as forced vital capacity (FVC), peak expiratory flow rate (PEFR) and maximum voluntary ventilation (MVV). Breathing routines: Inhale and exhale through the nose and when extremely exhausted, inhale through the nose and exhale through the mouth with proper recoveries in between if you are panting.

Pranayama routines like Kapalbhati and Anulom Vilom can increase lung capacity and oxygen intake. Practising these for only 5-10 minutes a day will give a burst of energy and freshness. I would also recommend double breathing, which oxygenates the blood and energizes the body. Stand comfortably with feet apart. Begin with inhaling through the nose with a short sharp inhalation followed by a long breath. Exhale twice through the mouth with a short, then long exhalation. While breathing in, stand tall with your spine erect and while exhaling, squat a little. Yoga is best for strengthening and flexing heart and lung muscles. Practise chest opening asanas like Setu Bandhasana, Bhujangasana, Ustrasana and upward stretching Tadasana. Make sure to combine exercise with the right diet and sleep to make sure that you get full benefits.

The idea from the franchise was to start afresh, have more money available in the purse, and build a team that can go all the way," head coach Abhishek Nayar told JioStar.A notable omission from the retention list was that of 2025 Women's World Cup Player of the tournament Deepti Sharma, who played 25 matches for the franchise over three seasons and scored 507 runs and took 27 wickets. Nayar said omitting big names from retentions was not an easy decision, but they have a process in place that they believe in fully. "These calls are never easy, but we believe in our process. The goal now is to go into the auction with intent, make smart decisions, and put together a side capable of winning the title," he said. Some of the big international names released by Warriorz include Alyssa Healy, Tahlia McGrath and Sophie Ecclestone. Healy did not play for the franchise in the WPL 2025 due to a stress injury on her right foot. Deepti captained the franchise in her place during that season, in which they finished in fifth place with six points in eight matches.

Richa Ghosh's batting mantra: 'Amol Sir assured me it was okay to take a little time to settle in before pulling off the big hits under pressure'

Stressing on how clarity of her role helped unlock her big hitting game, World Cup winning sensation Richa Ghosh, said she was told her job was to finish well. "Amol sir (Head Coach Amol Muzumdar) made everyone's role in the team very clear. For me, it was simple, play fearless cricket, look for the big shots, and finish the innings strongly. He also assured me that it was okay to take a little time to settle in. That trust he showed, believing I could pull off the big hits under pressure, helped me immensely," Ghosh told JioStar show 'Follow The Blues', while speaking of her batting.

Ghosh's cameos were bigly responsible for India getting to some big totals after the late innings impetus she provided. However preparation went back far into last two years. "Before the World Cup, I really focused on spending more time at the crease and building my innings. Whenever I got the chance to play, I concentrated on playing ground shots and making sure I didn't throw my wicket away. For me, it was all about keeping the scoreboard ticking with singles and holding up one end. That's what I worked on the most," she said. Ghosh planned to use her higher strike rate to pile pressure on opposition. "My main job was to finish innings strongly by scoring quickly in the final overs. Whenever I got the chance to bat, my focus was on applying the finishing touches. I aimed to maintain a high strikerate and put pressure on the opposition bowlers. Scoring those extra runs reduces the pressure on our team and gives us a better chance to win," she explained.

It will be a trait that comes in handy next year in the

T20 World Cup. She views deliveries as binaries – if hittable hit. If the ball is good, then scoot to take single. Keep scoreboard ticking. Not complicating is her quality. "My mindset is simple. Whenever I come to bat, if the ball is in my zone. I go for my shots. Hitting a boundary or a six in a pressure situation really helps release the tension. If it's a good delivery, I'm happy to take a single and target the next ball. That's the method I stick to," she said. Even during tough phases, no one was afraid because we always had each other's backs. That support system was our biggest strength. And when we finally won the final, the feeling was just incredible, completely different and absolutely unforgettable," she told JioHotstar. Ghosh recalled how the team song came about and how it had been bubbling away within their hearts for years. "We actually created our team song a few series ago. It was something we really wanted. But we made a pact to only sing it, and reveal it to the world after we lifted the World Cup trophy. Every player contributed to it in some way. So, the moment we won at the DY Patil Stadium, we just knew we had to sing it right there on the ground. It was a magical feeling," she said. "When those final South African wickets started falling, and Harman didi (Captain Harmanpreet Kaur) took that last catch, we all just scattered in different directions. But an entire generation of Indian cricket fans dreaded their might, and were left heartbroken almost 30 years ago, when India lost in the World Cup semifinals. 13 March 1996 was the OG 19th November.

So when Sanath Jayasuriya posted a picture of the giants the Sri Lankan 1996 World Cup winning team that had defeated Tubby Taylor's Australia, it sent several Indians down the balances of nostalgia. A defeat that had back then felt like doom, also gave rise to lifetime of respect and adoration for the defiant, gutsy Lankans. The picture had swashbuckler Jayasuriya, middle order lynchpin Aravind D'Silva and ace spinner Muttiah Muralitharan all kitted out in suits. But one man in a long red, close collar shirt was unrecognisable, to the most fervent cricket fans. Arjuna Ranatunga, looking taller than ever, and considerably leaner, was smiling. And though he held the glass of pineapple punch like he would fling the ball to Chaminda Vaas or Murali any moment, it was a distinctly different looking skipper who earned everyone's love and respect by winning that final. Social media was abuzz with comments about how different he seemed, and gushing of Indians who had been awed like rest of the world. Romesh Kaluwitharana, the tiny keeper would open the innings with Jayasuriya, and go bonkers with his pinch-hitting. The heavyweights wouldn't stop - D'Silva, Ranatunga themselves and then Roshan Mahanama and Hashan Tilekaratne in subsequent years as the aggressive batters revolutionized one day cricket. The



team had often been cornered by aspersions cast on Muttiah Muralitharan's bowling action, but Ranatunga with his chewing gum ruminating face, blinkless stare and steely resolve, would lead from the front and stand sturdy rallying around the embattled spinner often called by umpires.

Australia's power batting is a risk at T20 World Cup 2026, reasons R Ashwin: 'If the pitches are sticky, India will be in driver's seat'

Australia's unrelenting T20 aggression was blown to pieces on a tacky pitch by India's slower bowlers during the fourth T20I in Queensland on Thursday, earning them a crucial 2-1 lead ahead of the final match of the series. After making a just-above-par 167-run total, India bundled out Australia for only 119 to register a comfortable victory. The hosts' chase petered out when all-rounder Shivam Dube removed the dangerous Tim David with a slower bouncer and proceeded to remove skipper Mitchell Marsh on 38. Spinners Varun Chakaravarthy, Washington Sundar and Axar Patel then broke the back of Australia's order, sharing six wickets between them for only 49 runs.

Ashwin cautioned that Australia's all-out aggressive approach could backfire at the World Cup if the wickets proceed to remain slightly two-paced as it was at the Carrara Oval, playing more to India's strengths. It is understood that the T20 World Cup will be slotted between the first week of February and March in India with Pakistan to play their matches in Sri Lanka. "We had said that the fixture that Australia has set for the T20 series has suited India more than anybody else because in all these places, the ball comes a little slower, and even when you go to Brisbane, you will see that the ball comes a little slower. Obviously, the Ashes are coming, so I don't think they will give you a Test match pitch. So the pitch will come a little slower, and Australia is going to find it hard. "Many people, after previewing and looking at the team a bit, are saying that Australia's team is very strong, very powerful for the upcoming World Cup, but if the wicket comes a little slower, sticks a little, or turns a



little, the performance we saw today is the kind of performance you might end up seeing from Australia even at the World Cu," said Ashwin on his YouTube channel. With their vaunted spin attack complementing the pacers led by Jasprit Bumrah, India's bowling ammunition could prove deadly if the wickets are on the slower side at the back end of the domestic season in early 2026, felt Ashwin.

"But how will the wickets be in February-March? Will they stay a bit fresh, will there be dew? Dew maybe will not be late. So keeping all these factors in mind, Australia's power batting is definitely a risk, but if the wicket comes a little sticky, India is going to be in the driver's seat," he added. "Even today, Australia were in a good position, but when Dube got that double break, especially off Tim David. The last match, I had prepared a bit, and his improvement in batting, especially against spin, has been remarkable. His wicket was then taken by Dube."

His co-star, former child actor Satyajeet Puri, recently talked about the euphoria around Rajesh Khanna at the peak of his fame. While appearing on the Friday Talkies podcast, Puri recalled shooting with Khanna on a Shakti Samanta directorial. Shakti Samanta directed films like Kati Patang, Amar Prem and Aradhana and was guite instrumental in Rajesh's success. Satyajeet shared that even though Rajesh was the biggest star of the country, he couldn't avoid Samanta's anger. From Thamma to Lokah: Indian cinema's Vampire Boom rakes in the big bucks




After doctors give up and pronounce him dead, the man vanishes from his bed only to be discovered ravenous inside the hospital's blood bank. He rips open packets containing blood with his "punching-machine-like teeth" and guzzles it down. He effortlessly scales highrises and beats up any baddie he encounters. Yet, sunlight makes him recoil. His newly-developed pallor and appetite suggest a supernatural transformation: He may have exhaled his final human breath but he has respawned as a vampire. The story of this newly-fanged protagonist, who romances an alluring female vampire, is at the heart of the just-released film Thamma. With it, Maddock Films' Maddock Horror Comedy Universe (MHCU) ventures into vampire territory for the first time, after previously populating its world with witches, a headless demon, a ghostly creature and bhediya (Hindi cinema's spin on the werewolf). Released on October 21 as a Diwali-week family entertainer, Thamma arrives at a time when vampire-led narratives, both international and homegrown, are enjoying a resurgence. Led by Ayushmann Khurrana and Rashmika Mandanna, the vampire romance has earned over Rs 55 crore in India during the first three days of its release, notwithstanding mixed reviews. The makers are already teasing a larger crossover ahead — one that could stage an on-screen face-off between bhediya and vampire in future instalments of

Unlike the West, where the filmmakers have periodically used horror as a tool to shock, subvert and provoke reflection, the horror genre in India has taken a long time to shed its 'B-grade movie' tag and move beyond jump-scare, sleaze and gore. Today, mainstream cinema has not only embraced it as a potential blockbuster material but also drawn A-listers to come onboard. Little wonder that Indian filmmakers, who swear by "entertainment", are serving horror movies, for the second consecutive year, as crowdpullers amidst Diwali celebrations after last year's horrorcomedy Bhool Bhulaiyaa 3. From the beginning, reveals Thamma's director Aditya Sarpotdar, it was decided that the movie would be a Diwali release. "On the eve of Diwali, when a family gets together and decides what movie to watch, they should want to watch Thamma. So, when that is a clear agenda, I feel you have to entertain the audience while you bring in all these other elements of mystery and intrigue without making it too dark," says Sarpotdar, who also directed last year's surprise hit Munjya (2024).

Indian filmmakers, encouraged by the audience's appreciation for movies like Tumbbad (2018), Stree (2018), Bramayugam (2024) are undoing decades of dismissive

attitude towards the horror genre with a new-found interest in vampire-led narratives. Released on August 25, the Malayalam-language Lokah Chapter 1: Chandra, produced by Dulquer Salmaan and directed by Dominic Arun, apart from generating incredible buzz and acclaim, grossed Rs 300 crore globally. This makes it the highestgrossing Malayalam film ever as well as one of the biggest Indian films to feature a female lead, Kalyani Priyadarshan, who plays the titular lead and a centuries old yakshi with vampire-like features. During the end credit roll, Lokah teases the audience with a glimpse of two of Malayalam cinema's biggest stars — Tovino Thomas and Dulquer — appearing as supernatural beings in the second instalment of this five-part ambitious franchise. Vampires have seized the spotlight as evident from some of the biggest film releases of 2025. After a Christmas Day opening in America last year, Robert Eggers's gothic vampire horror Nosferatu kicked things off in India with a January release. This remake of Nosferatu: A Symphony of Horror (1922), the iconic German Expressionist vampire tale by FW Murnau, earned four Oscar nominations for Best Cinematography, Best Costume Design, Best Production Design and Best Makeup and Hairstyling this year. Considered to be a visionary director, Eggers calls Nosferatu — a tale of obsession between a haunted young woman (Lily-Rose Depp) and the vampire Count Orlok (Bill Skarsgård) infatuated with her — his "most personal" project.Released in April, Ryan Coogler's Sinners drew instant acclaim for its original vision. This southern-gothic vampire musical, set in the 1930s, is steeped in Black history, magic of blues and vampire folklore. The Smokestack twins, Smoke and Stack (both the characters are essayed by Michael B Jordan) return to their hometown to make a fresh start, only to discover that an even greater evil is lurking to ruin their plan. Sinners, apart from amassing about \$362 million worldwide, has emerged as an Oscar frontrunner in multiple categories, including Best Picture and Best Director, alongside Paul Thomas Anderson's One Battle After Another. On October 30, the movie is returning to select Imax theatres for a week-long Halloween run. One of the timeless literary works, Bram Stoker's 1897 classic novel Dracula, has inspired many retellings and spin-offs as well as laid out the template for portrayal of vampires onscreen. The central character of Count Dracula, an aristocrat, who is sustained by the blood of others, also became a metaphor for political and social critique. It gained currency especially after Karl Marx, while criticising unpaid work wrote in his book Das Kapital 'Capital is dead labour, which is vampire-like, lives only by sucking living labour, and lives the more, the more labour it sucks.'Many vampire stories and horror movies have sunk their teeth into the ills of capitalism the way Sinners does. Others like Ana Lily Amirpour's debut feature A Girl Walks Home Alone At Night is about a female vampire, who stalks potential victims, mainly immoral men, in a fictional Iranian town called Bad City. Oscarwinner Kathryn Bigelow, too, made her debut with Near Dark (1987), which is described as an artsy vampire Western and is about living on the edge. Author Anne Rice humanised vampires in her popular novels and the film Interview with the Vampire (1994), based on her book, deals with existential themes. Experiments with the vampire sub-genre continue as romantic fantasy Dracula: A Love Tale was released in France while action-horror Dracula: Rise of the Vampire was released in the United

Amitabh was seen fondly recalling his iconic dialogue from the film: "Sar zameen-e-Hindustan, salaam alaikum." As the promo transitioned to Diljit singing, Amitabh smiled appreciatively, responding with warm gestures of praise. After finishing the song, Diljit said, "Sir, aap bahut pyaare ho!" To which Amitabh folded his hands, bowed slightly, and embraced him once again.

Beyond his artistic endeavours, Diljit has also been making headlines for his humanitarian efforts. Deeply affected by the Punjab floods of 2025, the singer announced that he would donate all his prize money from the show to support flood victims. Earlier, he had also pledged to adopt ten of the most severely affected villages in Gurdaspur and Amritsar, in collaboration with local NGOs and the administration. His team revealed that the initial focus is on providing essentials like food, clean water, and medical aid, with long-term plans for rehabilitation and sustainable reconstruction of homes

On the professional front, Diljit is part of the muchanticipated film Border 2, and he has also lent his voice to songs in Kalki 2898 AD and Kantara: Chapter 1. He recently released his latest album Aura.
