No shortage of urea in Yadadri Bhuvanagiri district: Yadadri Bhuvanagiri District Collector Hanumantha Rao

“(Mandava Srisailam... Yadadri Bhuvanagiri District Bureau... Indian Chronicle... December 29):- District Collector Hanumantha Rao clarified that there is no shortage of urea in the district. He stated that there are sufficient stocks of urea fertilizers required for the district and that farmers need not worry. Speaking on this occasion, the District Collector said that 6191 metric tons of urea are available in the district as of today. He informed that 15611 metric tons of urea have been supplied to the district so far. He directed that canopies and drinking water facilities should be provided at every sales counter to avoid inconvenience to the farmers. He instructed that urea sales should start at the counters from 6:00 AM. The Collector assured the farmers that the current urea stocks in the district are sufficient for cultivation, and that more supplies are also being received regularly as needed. He said that the concerned officials and agriculture department staff are continuously monitoring the urea distribution. He warned that strict action would be taken against those who resort to illegal practices such as creating artificial shortages and selling at exorbitant prices. He advised farmers to contact the nearest agriculture officials if they face any problems in the supply of urea. The Collector requested the farmers not to purchase urea in excess of their needs and to use it in a scientific manner.

Youth Drowns While Swimming in Pedda Vagu in Kaghaznagar Mandal; Body Recovered

No Signal, No Purchase: Kapas Kisan App Woes Hit Cotton Farmers


“Taj Khan, Kaghaznagar, December 29 (Indian Chronicle)“Cotton farmers across Komaram Bheem-Asifabad district are facing severe difficulties due to technical issues with the Kapas Kisan mobile application, which is mandatory for online registration for cotton procurement by the Cotton Corporation of India (CCI).“Farmers alleged that they have been visiting agriculture offices for several days without any resolution to their problems. They stated that frequent network and signal failures are preventing them from completing online registration on the

Kapas Kisan app, leaving them unable to sell their produce through CCI.“Adding to their woes, farmers complained that agriculture officials often fail to report to their offices on time, even by noon, causing further inconvenience to those who travel long distances in the hope of assistance. They alleged that the district agriculture administration has been turning a blind eye

to the issue.“Farmers said that even after completing online registration, CCI has not lifted cotton for more than ten days in several cases. Due to delays and failed registrations, harvested cotton is being stored in farmers' houses, leading to deterioration in quality and financial losses.“Demanding immediate intervention, the Democratic Youth Federation of India (DYFI) submitted a representation to District Agriculture Officer A.O. Kiran at the District Collectorate, urging the authorities to resolve the technical glitches and ensure timely procurement of cotton.“DYFI district team participated in the programme.



Water Supply Likely to Be Disrupted in Kaghaznagar as Outsourced Workers Join Strike

From today, outsourced workers responsible for drinking water supply have also joined the strike, leading

Elderly, Differently-Abled Face Hardship at Asifabad Post Office; No Facilities at Pension Disbursal Centre Leave Asifabad Pensioners Struggling


PG Freshers' Day at JSPS Government Homoeopathic Medical College, Ramanthapur

Complaint Filed Seeking Cancellation of Alleged Illegal Layout in Mallapur

“NARRA SRINIVAS REDDY (NSR), Medchal - Malkajgiri Staff Reporter, December 29, (INDIAN CHRONICLE): Botla Sailu, National Secretary and State President of the All India Hindustan Congress Party, has submitted a formal complaint to the Greater Hyderabad Municipal Corporation (GHMC) seeking the immediate cancellation of a draft layout approved in Survey No. 111 (Part) of Mallapur Village, presently known as Shakti Sai Nagar. In a representation addressed to the GHMC Commissioner, Sailu alleged large-scale land encroachment and serious procedural irregularities in the approval of the said layout. According to the complaint, the property was originally purchased in 1996 through a registered sale deed. However, in 2019, a so-called “rectification” process was initiated, allegedly altering the original land boundaries to unlawfully include adjacent government land into private ownership. The complaint states that based on these altered boundaries, a draft layout was sanctioned by GHMC through Letter No. 1/C1/07859/2019 dated September 19, 2019. Sailu contended that the layout approval was obtained using falsified records and misrepresentation of facts. He further alleged collusion between the applicant, certain officials in the office of the Chief City Planner, GHMC, and local political representatives, resulting in the manipulation of official records and misuse of administrative authority. The complaint claims that public land has been illegally encroached upon under the guise of layout regularisation. Demanding immediate action, Sailu called for the revocation of the draft layout and requested a comprehensive site inspection and land survey to identify and protect encroached government land. He also issued a legal notice warning that failure to act within 15 days would compel him to approach the Telangana High Court by filing a writ petition in the interest of protecting public property. Copies of the complaint were marked to the Medchal–Malkajgiri District Collector, the Hyderabad Disaster Response and Asset Protection Agency (HYDRAA) Commissioner, and the Uppal Tahsildar. Meanwhile, GHMC has acknowledged the complaint through its Prajavani grievance redressal system. The grievance has been registered under the Town Planning Department (Others category) and assigned a complaint number for further examination.

CIBIL Score Rules Change from Jan 1, Faster Updates to Benefit Borrowers

““Taj Khan, Kaghaznagar, December 29 (Indian Chronicle)““In a major relief to borrowers, the Reserve Bank of India (RBI) has introduced new norms to speed up CIBIL score updates, which will come into effect from January 1. The changes are aimed at improving transparency, reducing delays in credit reporting and strengthening consumer protection.“Under the existing system, banks and non-banking financial companies (NBFCs) take 30 to 45 days to report loan-related information to credit bureaus. As a result, borrowers who repaid old loans often had to wait for several months for their credit scores to improve.“With the new rules, banks and NBFCs have been directed to report credit information at

least twice a month, ensuring that loan closures or new borrowings are reflected in credit reports within 15 days. This faster update mechanism is expected to help borrowers access loans—such as home or car loans—at lower interest rates, provided their credit scores improve.“The RBI has also strengthened safeguards against fraud. If any fraudulent loan attempt is made in a person’s name, credit bureaus must immediately alert the customer via SMS or email. Further, banks are required to inform customers before marking an account as a defaulter, allowing errors to be corrected in advance.“In another key consumer-friendly move, banks must now clearly state the specific reason if a loan application is rejected. If a borrower raises a complaint regarding an error in the credit report, it must be resolved within 30 days. Failure to do so will attract a penalty of ₹100 per day, payable to the affected customer, making grievance redressal time-bound and accountable.“Going a step further, the RBI has proposed weekly credit data updates from July 1, with reports expected to refresh on the 7th, 14th, 21st and 28th of every month. This measure is aimed at further enhancing transparency and curbing rising cyber fraud and reporting inaccuracies.“The RBI’s decision is being seen as a significant relief for ordinary borrowers, making credit histories more dynamic, accurate and firmly within the control of consumers.

Tightened Security Measures in Godavarikhani Ahead of New Year Celebrations.

Ram Reddy““As part of strengthened law and order measures, a strict police naka-band (check-post operation) was conducted across the Godavarikhani area to ensure public safety and prevent unlawful activities during the New Year period.““Acting on the directives of **Ramagundam Police Commissionerate Commissioner Amber Kishore Jha, and as per the instructions of Peddapalli Deputy Commissioner of Police B. Ram Reddy, the operation was carried out under the supervision of Godavarikhani ACP M. Ramesh.““The naka-band was led by Godavarikhani One Town CI Indrasena Reddy, along with CI Ravinder, deploying 2 Circle Inspectors, 12 Sub-Inspectors, and nearly 100 police personnel. Simultaneous vehicle checks were conducted in multiple localities including



5 Incline, Vithal Nagar, Tilak Nagar Down, Tilak Nagar, Ramesh Nagar, Chandrashekhar Nagar, Santosh Nagar, and Dwaraka Nagar.““During the operation, DCP B. Ram Reddy and ACP M. Ramesh personally participated in vehicle inspections. The checks were aimed at preventing illegal transportation, movement of prohibited substances, suspicious activities, and criminal offences, including thefts and chain snatching. Special emphasis was laid on curbing the illegal transport of ganja and other narcotic substances.““Suspected individuals and vehicles were stopped and subjected to thorough verification. Police examined essential documents such as Registration Certificates, Driving Licences, Insurance, Fitness Certificates, and Pollution Under Control (PUC) certificates. Cases were registered against offenders involved in drunk and driving, rash driving, triple riding, minor driving, riding without helmets, and driving without valid documents.““As part of enforcement action, 80 two-wheelers, 6 auto-rickshaws, and 3 cars were penalised. In addition to imposing fines, the police also educated motorists on road safety norms and traffic regulations. Details of vehicle owners, passengers, and travel destinations were carefully verified to ensure comprehensive monitoring.““The DCP stated that such naka-band operations are being conducted solely to maintain peace, safeguard public security, and prevent anti-social and unlawful activities. He further announced that similar intensified checks will be carried out on December 31, including special drunk-and-drive checks after 10:00 PM.““The public, especially the youth, were strongly advised to celebrate the New Year responsibly with their families at home, and not to indulge in reckless behaviour on roads that could inconvenience others. The police warned that strict legal action will be taken against anyone violating the law and appealed to youngsters not to sacrifice their bright future for momentary pleasure.““The DCP also emphasized that such inspections will continue with greater strictness and urged citizens to extend full cooperation to the police in maintaining peace and order.

5th grade to 9th grade. SET Convener and SC Gurukula Secretary Krishna Aditya stated that applications can be submitted online from the 12th of this month to the 21st of next month by paying a fee of Rs. 100. He said that the entrance exam will be conducted in selected district centers until February 22nd of next year. He mentioned that only one application will be accepted per phone number. The convener warned that a criminal case will be registered if someone uploads another person's photo in-

stead of the candidate's photo during the application process. Krishna Aditya revealed that the combined district will be considered for the selection of admissions. Seat Details: ST Gurukul schools: 83 schools, 6,640 seats; BC Gurukul schools: 294 schools, 28,680 seats; SC Gurukul schools: 235 schools, 18,700 seats. There are a total of approximately 55,000 seats available for admission into the 5th grade in BC, SC, ST, and General Gurukul schools. Last year, 1.60 lakh applica-

tions were received. There is huge demand for seats in Gurukul schools. The number of students applying is increasing every year. The free education, accommodation, books, along with the provision of diet and cosmetic allowances, and the fact that the results are consistently above 90 percent, are contributing to their growing popularity. Furthermore, the training provided in Gurukul schools for competitive exams like EAMCET, CAT, ICET, and IIT JEE, which is on par with private colleges, is further increasing their appeal.
