No Difference Between Accreditation and Media Cards: Minister Ponguleti Assures Journalists



“Taj Khan, Kaghaznagar, December 30 (Indian Chronicle)““State Minister for Revenue, Housing, and Information & Public Relations, Ponguleti Srinivasa Reddy, has categorically clarified

that there is no distinction between Accreditation Cards and Media Cards. He assured that all government benefits applicable to accreditation cardholders will equally apply to me-

dia cardholders as well, urging desk journalists not to harbor any misconceptions. “The Minister stated that necessary amendments to Government Order (GO) No. 252 will be made and issued in writing to remove any ambiguity. He emphasized that desk journalists need not worry, as the government stands firmly with them. “On Tuesday, the Minister held discussions at the Secretariat with representatives of the TWJF and the Desk Journalists Federation of Telangana, addressing their concerns and clarifying various issues raised by them. “Some people are deliberately trying to create confusion. Do not believe such misinformation. There is no discrimination or bias. None of you should be anxious—I stand with you,” the Minister asserted. He made it clear that the government has no intention of viewing journalists in separate categories and reiterated that all welfare schemes will be uniformly extended. “The decision, he explained, was taken with good intentions and a

firm commitment to support genuine and eligible journalists. He also pointed out that apart from Telangana, no other state in the country issues accreditation cards on such a large scale. “The Minister further announced that after the conclusion of the Assembly sessions, a comprehensive meeting will be convened with all journalist associations in the state, including desk journalists. He assured that opinions, suggestions, and recommendations from all stakeholders would be considered, and appropriate amendments and additions to GO 252 would be made to ensure greater benefits for journalists. “Those who met the Minister included TWJF state leaders B. Rajashekhar and Gandra Naveen, Federation President and General Secretaries Upender and Mastan, along with leaders Nissar, Vijaya, Rajaram, and representatives of the Sports Journalists Association, including Krishna and Srinivas, among others.

Senior journalist Lakshmana Rao passes away due to heart attack: TWJF Union journalist members express condolences

(Mandava Srisailam...Hyderabad, Indian Chronicle, December 30): Senior journalist TK Lakshmana Rao (70), renowned as a 'Mofussil Specialist', is no more. Lakshmana Rao, who wrote a unique chapter for himself in the Telugu journalism field, had been undergoing treatment at NIMS hospital in Hyderabad for some time due to illness and breathed his last on Tuesday morning due to a heart attack. Journalists and journalist associations expressed deep shock over his death. “Lakshmana Rao was born in 1954 in Prathipadu, East Godavari district. His father was Tempalli Anjaneyulu, a Grade One Telugu scholar. He completed his Intermediate in Pithapuram, East Godavari district, and his BA in Kakinada. He also earned a PhD. Due to his immense interest in politics, he had the habit of reading newspapers daily. In that process, an unexpected dream came true when he got an opportunity at the 'Udayam' newspaper. In 1984, he started his journey as a trainee sub-editor at the 'Udayam' newspaper under the leadership of renowned editor ABK Prasad. In his long career of approximately 38 years, he held various key positions in major daily newspapers such as Udayam, Andhra Bhoomi, Vaartha, and Sakshi. Senior journalist Pasham Yadagiri was his inspiration. He faced many setbacks in his professional life. He eventually established himself and rose to high positions, having a 38-year career in mainstream newspapers. He retired as an Assistant Editor at 'Sakshi' and has been leading a retired life for the past ten

years. He is known for his support of rural journalists. Firmly believing that rural journalists are the foundation of the press system, he shared in their joys and sorrows and earned great recognition as a 'Mofussil Editor'. He sincerely followed the principle that "news should not be filled with false praise... it should be close to the truth... and should not hurt anyone." He always expressed concern about the current trends in journalism where harsh language is becoming increasingly prevalent. He moved many people with the excellent headlines he crafted for the news stories brought in by rural journalists. Lakshmana Rao is survived by his wife, a daughter, and a son. Lakshmana Rao's last rites will be performed on Wednesday (December 31) at the Journalists Colony in Gopannapalli. “TWJF Condolences” The Telangana Working Journalists Federation (TWJF) has expressed its condolences on the death of senior journalist TK Lakshmana Rao. Federation State Convener Mamidi Somayya stated that the services rendered by Lakshmana Rao to the field of journalism and to journalists, having worked in various prominent newspapers for over three and a half decades, are unforgettable. He lauded Lakshmana Rao, saying that the Telugu media industry has lost a great pioneer, and expressed his deepest condolences to Lakshmana Rao's family.



Uppal Excise Police Arrest Man for Selling Dry Ganja; 5.200 Kg Seized



“KISHORE VADDEPALLI, Uppal, December 30 (Indian Chronicle): “Acting on the instructions of the Malkajgiri DPEO and under the supervision of the AES, Malkajgiri, the Uppal Excise Police on Tuesday arrested a person involved in the illegal sale of dry ganja in the Uppal area. “Based on specific information, Uppal Excise Station House Officer B. Omkar, along with his staff, conducted a raid in the Hanuman Sai Nagar area of Uppal and apprehended the accused. The arrested person was identified as Sudhanshu Kumar, a native of Bihar, currently residing at Hanuman Sai Nagar, Uppal. “During the operation, the excise officials seized 5.200 kilograms of dry ganja and one mobile phone from his possession. A case has been registered against the accused. During interrogation, the accused revealed that he had procured the dry ganja from Bihar at a rate of ₹25,000 per kilogram, transported it to Uppal, and sold it in small packets at higher prices to con-



sumers, thereby earning illegal profits. “Those who played a key role in cracking the case include Uppal Excise Inspector B. Omkar, Excise Sub-Inspector Srinivasulu, Excise Sub-Inspector P. Naresh Reddy, and other staff of the Uppal Excise Station.

RBI AGM Visits CFL at Mavala, Reviews Financial Literacy Initiatives



“Taj Khan, Kaghaznagar, December 30 (Indian Chronicle) “Reserve Bank of India Assistant General Manager (AGM) Gomathi, along with Lead District Officer (LDO) Gomathi and District Lead Bank Manager (LDM) Uthpal Kumar Dham, visited the Centre for Financial Literacy (CFL) at Mavala in Adilabad district on Tuesday (December 30, 2025). “During the visit, the officials reviewed records and reports maintained at the CFL and sought details about the financial literacy awareness camps being conducted at the village level. The RBI AGM expressed satisfaction with the performance of the CFL counsellors. “Addressing the gathering, AGM Gomathi emphasized the need to further strengthen financial awareness among rural populations and motivate

people at the grassroots level to become financially literate. She stressed the importance of educating the public about banking facilities and consumer rights provided by the Reserve Bank of India and banks. “She also called for extensive awareness campaigns on digital payments and cyber frauds, highlighting the growing need for vigilance in the digital era. Additionally, she instructed that villagers should be informed in detail about unclaimed deposit amounts and made aware of the facility to recover such funds through the UDGM portal. “AGM Gomathi underlined that Financial Literacy Centres play a crucial role in spreading awareness about banking services among the public. “CFL counsellors Kamalakar, Satyanarayana, and Bhoomanna were present during the programme.

Government Issues Stern Warning to Sarpanch, Deputy Sarpanch Over Misuse of Joint Cheque Power Misuse Will Lead to Removal from Office and Imprisonment, Government Cautions

“Taj Khan, Kaghaznagar, December 30 (Indian Chronicle) “The State Government has issued a strong warning to Sarpanch and Deputy Sarpanch, making it clear that any misuse or obstruction of Joint Cheque Power will invite severe consequences, including removal from office and imprisonment. “Importance of Joint Cheque Power “The government reiterated that the joint signature system of the Sarpanch and Deputy Sarpanch in the management of Gram Panchayat

could invite legal action. “Strict Punishment for Abuse of Authority “The government categorically stated that acts such as misappropriation of public funds



funds is a crucial financial safeguard. Every rupee spent on development works must carry the approval of both elected representatives. However, officials have expressed concern that personal and political differences are being used to deliberately block cheque approvals, thereby seriously hampering village development. “Transparency Ensures Legal Protection “The government has directed that all decisions related to the utilisation of Gram Panchayat funds must strictly be based on Gram Sabha resolutions. Emphasis has been laid on online payments instead of cash transactions, and authorities have instructed that all expenditure details must be promptly recorded in official registers. Officials clarified that adherence to transparency will ensure smooth audits and provide legal protection to public representatives, warning that deviations

for personal use, drawing bills without completion of works, submission of false accounts, and forgery of signatures will be treated as serious criminal offences. In such cases, the District Collector is empowered to register criminal cases, remove the guilty from office, and initiate imprisonment proceedings. “Power Struggles

Stalling Development? “Officials have observed that in several villages, power struggles between Sarpanch and Deputy Sarpanch are becoming a major obstacle to development. The government warned that deliberately withholding signatures on bills for political reasons will be dealt with strictly. If an inquiry establishes that development works were intentionally obstructed, the District Collector has the authority to cancel the cheque-signing powers of the Deputy Sarpanch, the government clarified.

Telangana Extends Journalists' Accreditation Cards Validity Till February 28, 2026

“Taj Khan, Kaghaznagar, December 30 (Indian Chronicle) “The Government of Telangana has extended the validity of existing State and District Journalists' Accreditation Cards by two months, from January 1, 2026 to February 28, 2026, to avoid inconvenience to working journalists. “According to a communication issued by Special Commissioner Ch. Priyanka of the Information and Public Relations (I&PR) Department, the current accreditation cards are set to expire on December 31, 2025. The extension has been granted as the department is in the process of issuing a fresh notification inviting applications for new accreditation cards through an online system. “The government stated

(DMAC) Chairpersons have been requested to extend the validity of existing district-level accreditation cards accordingly. “The order follows instructions issued by the Special Secretary to the Government and has been com-

municated to the Chairman of the Telangana State Media Academy, Regional Joint Directors of Multi Zones I and II, and all District Public Relations Officers (DPROs) for necessary action.

After the problem was brought to his notice recently, Marri Shashidhar Reddy immediately responded and, along with local BJP leaders, inspected the overflowing sewage water from in front of the KFC Mall on Padmarao Nagar main road up to the rear side of Gandhi Hospital. "He spoke to officials of the Water Board over the phone and questioned them about the continuous sewage overflow. Water Board officials



informed him that plans were being prepared for a permanent solution to the problem. 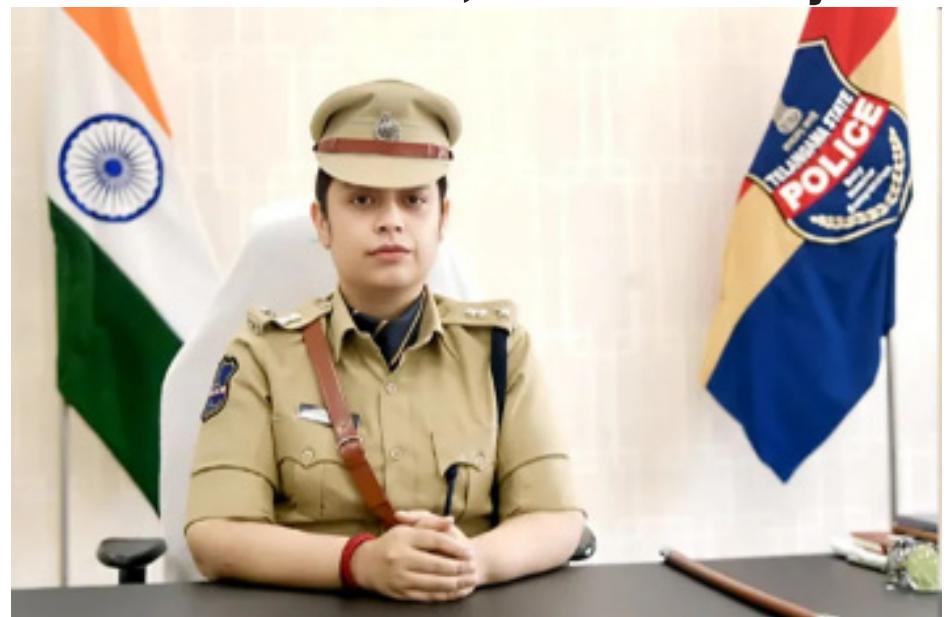
“Celebrate New Year Peacefully, Police Appeal to Public

Drunk-and-Drive Checks from December 31 Evening: SP Nitika Pant

“No Permission for DJs During New Year Celebrations, Police Clarify

Taj Khan, Kaghaznagar, December 30 (Indian Chronicle) "District Superintendent of Police Nitika Pant has appealed to the public to celebrate the New Year peacefully across the district. She announced that special drunk-and-drive checks will be conducted district-wide from the evening of December 31 as part of heightened security arrangements. "The SP warned that vehicles driven under the influence of alcohol will be seized, and strict legal action will be taken against offenders. She further stated that triple riding, wrong-side driving, rash driving, speed racing, and other traffic violations are illegal and will attract stringent penalties. "She made it clear that if minors are found driving vehicles, cases will be registered not only against them but also against their parents. Acts such as cake cutting on roads, bursting fire-crackers in public places, and organizing bike races have been declared of

fences under the law, and violators will face strict action. "No DJ Permission, Public Events Need Prior Approval "SP Nitika Pant categorically stated that DJ systems will not be permitted under any circumstances during New Year celebrations. She warned against organizing public programmes, rallies, meetings, gatherings, or events without prior police permission. For conducting programmes using sound boxes or microphone systems, mandatory police approval is required. "She also informed that Section 30 of the Police Act is currently in force across the district. "Action Against Public Nuisance and Cyber Frauds "The SP said that legal action will also be taken against those consuming alcohol in public places and causing inconvenience to others. She emphasized that the district police have put in place robust measures to maintain law and order. "Cautioning the public about cyber threats, she warned that cybercriminals



may circulate fake links in the name of New Year greetings, and urged citizens to remain vigilant. "Appealing particularly to youth and the general public, SP

Nitika Pant called upon everyone to follow police guidelines and celebrate the New Year responsibly, without causing inconvenience to others.

Ramagundam Police Commissionerate Extends New Year Greetings Announces Stringent Safety Measures.



“P.S.ASHOKAN”KARIMNGAR BUREAU.“Ramagundam, December 30, 2025:“The Ramagundam Police Commissionerate has extended warm New Year greetings to all citizens within its jurisdiction. Issuing a press statement, Police Commissioner Amber Kishore Jha appealed to the public to celebrate the New Year with joy, responsibility, and strict adherence to the law. “Emphasising the message “Do not destroy your future for momentary pleasure,” the Commissioner urged citizens to celebrate happily but within the legal framework. “Special Drunken Drive Enforcement”“As part of New Year safety measures, a special drunken driving drive will be conducted from 10.00 pm on December 31 across the Ramagundam Police Commissionerate limits. Persons found driving under the influence of alcohol will be booked, vehicles will be seized, and bind-over proceedings will be initiated. Strict legal action, including fines, cancellation of driving licences, and prosecution, will be taken against offenders. “Appeal to the Public”“Residents of Peddapalli district and Mancherla district were advised to celebrate New Year festivities peacefully and responsibly, without causing inconvenience or harm to others. The Commissioner stressed the importance of avoiding risky behaviour and ensuring the safety of oneself and others. “Extensive Security and Monitoring”“To prevent untoward incidents, intensive patrolling will be carried out with the support of local police, traffic police, She Teams, plain-clothes squads, and Special Branch personnel. Special focus will be laid on preventing illegal gatherings, public consumption of alcohol, harassment of women, and other unlawful activities. “Restrictions and Guidelines”“New Year celebrations must conclude before 12.30 am. “Organisers of cultural programmes must obtain prior police

permission. “Obscene dances are strictly prohibited. “Installation of CCTV cameras and deployment of security personnel at event venues are mandatory. “Public inconvenience caused by unauthorised celebrations will invite stringent action. “Use of DJ systems, orchestras, loudspeakers, and fireworks is strictly banned. “Liquor shops, wine shops, bars, and restaurants must strictly adhere to government-approved timings. “Traffic and Youth Advisory”“Triple riding, rash driving, wrong-route driving, and riding without helmets will attract strict legal action. The Commissioner warned that criminal cases registered against youth could adversely affect future prospects, including government employment and foreign visas. Parents were urged to closely monitor their children, and youngsters were advised to stay away from alcohol and reckless behaviour. “Zero Tolerance Towards Drugs”“The police will adopt a zero-tolerance policy towards the sale or consumption of banned drugs, ganja, and other narcotic substances during the New Year period. “The Police Commissioner appealed to citizens to respect the law, cooperate with the police, and celebrate the New Year peacefully, safely, and lawfully, preferably with family at home. “Your Safety – Passengers’ Safety: A Collective Responsibility”“Awareness Programme for Auto Drivers”“In a separate initiative aimed at preventing road accidents and promoting traffic discipline, Indrasena Reddy, Inspector of Godavarikhani I Town Police Station, conducted an awareness programme for auto drivers. “During the programme, auto drivers were educated on: “Strict adherence to traffic rules”“Safe and responsible driving practices”“The dangers of drunken driving”“Importance of valid documents such as driving licence, insurance, fitness certificate, and pollu-

tion certificate”“Addressing the gathering, the Inspector stated that auto drivers play a crucial role in ensuring passenger safety and that responsible driving can prevent numerous road accidents. He advised drivers to place photographs of their family members inside their vehicles, noting that such reminders help drivers act responsibly and avoid mistakes that could jeopardise their families’ future. “He cautioned that even a minor lapse could result in devastating consequences for families and

urged drivers to refrain from violations. Drivers were also requested to promptly inform the police about any suspicious activities. The Inspector observed that the misconduct of a few drivers tarnishes the reputation of the entire community and warned that strict legal action would be taken against violators. “He further clarified that insurance benefits are applicable only when the driver holds a valid licence and stressed the need to keep all mandatory documents updated at all times.

108,102 Ambulance Services For Devotees During Jangu Bhai Jatara



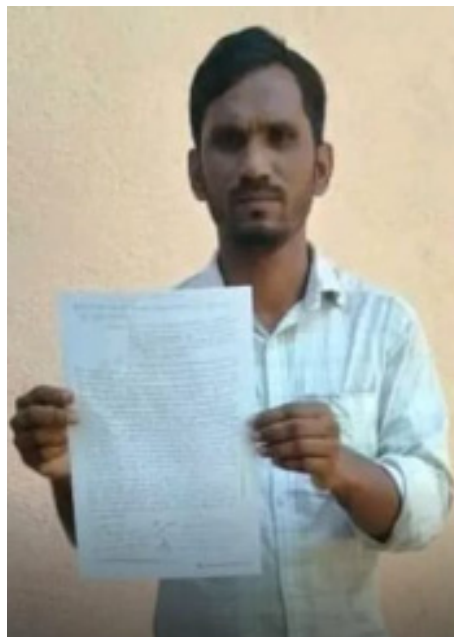

He said that there is a surplus of urea in dealers, co-operative societies and Markfed godowns in the district, and that urea is being provided to farmers every day through urea distribution centers in the district according to the cultivation, and the urea distribution process will continue from 6 am every day. He said that for the convenience of farmers, shamianas and drinking water facilities should be provided at the sales centers, and that steps are being taken in coordination with the authorities to set up at least 3 counters in each sales center so that the farmers do not face any difficulties. He said that the authorities should take steps to provide urea to the farmers through this pass mission based on the passbooks of the landowners.
