Hyderabad Police implement ‘Zero Delay’ policy across commissionerates

Hyderabad: City Police Commissioner V C Sajjanar on Wednesday said police should not be restricted by jurisdictional boundaries in crime control and stressed strict implementation of the ‘Zero Delay’ policy for immediate response to crimes. Speaking at a coordination meeting of the Hyderabad, Cyberabad and Rachakonda police commissionerates at the TGICCC, he said the nearest police unit must act promptly, regardless of limits, to prevent criminals from exploiting delays. The three commissioners discussed joint surveillance on habitual offenders, intelligence sharing and coordinated traffic enforcement.

Vande Mataram, Ethiopian anthem both see land as Mother: PM Modi

Addis Ababa: Prime Minister Narendra Modi on Wednesday drew parallels with ‘Vande Mataram’ and Ethiopia’s national anthem (March Forward, Dear Mother Ethiopia) and said that both countries refer to their land as “Mother”, which reflects their shared perspective. Addressing the Joint Session of Ethiopia’s Parliament, PM Modi said, “With the call of ‘Sabka Saath, Sabka Vikas, Sabka Vishwas, Sabka Prayaas’, which means together with everyone’s growth, trust and effort, our emotions with our motherland, also reflect our shared perspective,” he said.

Drawing parallels to India’s national song ‘Vande Mataram’ and Ethiopia’s national anthem, PM Modi said that both refer to “our land as the Mother”. “They inspire us to take pride in the heritage, culture, beauty and protect the motherland,” he added. The Prime Minister further said that science has traced some of the earliest footprints of our species in Ethiopia.

“When the world speaks of ‘Lucy of Dinkinesh’, they are not speaking only of fossils but of a beginning — that

belongs to all of us, whether we live in Addis Ababa or Ayodhya. In India, we say ‘Vasudhaiva Kutumbakam’, which means ‘The world is one family’. It reminds us that beyond politics, borders and differences, we share a common origin. If our beginning was shared, then our destiny must also be shared,” he added. PM Modi received a warm welcome as he arrived to address the Joint Session of the Ethiopian Parliament. This is also the 18th Parliament in the world where the Prime Minister delivered his address. The Prime Minister said he feels “very much at home” during his visit to Ethiopia and called it a “moment of great privilege” to address the Parliament of the African nation.

“It is a moment of great privilege to stand before you today. It is wonderful to be here in Ethiopia, the land of lions. I feel very much at home because my home state, Gujarat in India, is also home to lions,” he said. “I am honoured to be here in this temple of democracy, in the heart of the nation, with ancient wisdom and modern aspirations. I come to you with deep respect for your Parliament, your people and your democratic journey. On behalf of the 1.4 billion people of India, I bring greetings of friendship, goodwill and brotherhood,” he added. The Prime Minister again expressed gratitude for conferring him with Ethiopia’s highest civilian honour, the ‘Great Honour Nishan of Ethiopia’. “I accept this award with folded hands, humility on behalf of the people of India,” he said. He said that Ethiopia is one of the oldest civilisations in human history. “Here, history is alive in the mountains, valleys and in the hearts of the Ethiopian people,” he added. “Today, Ethiopia stands tall because its roots are deep. To stand in Ethiopia is to stand where the past is honoured, the present is full of purpose, and the future is welcomed with an open heart. The blend of old and new — the balance between ancient wisdom and modern civilisation — this is the true strength of Ethiopia,” he further said, amid the loud cheers in the Parliament.

Hyderabad students shine in CLAT 2026 UG, PG top 100

Hyderabad: Six Hyderabad students, including an all-India rank of 61, figured in the top 100 ranks of the Common Law Admission Test (CLAT) 2026 UG results that were announced on Tuesday. Four boys and two girls were among the top 100 ranks in the CLAT UG this year. The highest mark secured in CLAT 2026 UG is 112.75.

Similarly, three students — two women and one man — from Hyderabad bagged ranks in the top 100 in the CLAT 2026 PG. The highest mark secured in CLAT 2026 PG is 104.25. While Parthiva Sushanth Obulasetti from Guntur secured an all-India 17th rank, Mihika Aggarwal from Hyderabad got an all-India rank of 61 in the CLAT UG. Both students are from Abhyaas Law Prep here.

Constitutional morality goes for a toss in Telangana as Speaker dismisses disqualification pleas

Hyderabad: In a move that has sharpened accusations of constitutional hypocrisy against the Congress, Telangana Assembly Speaker Gaddam Prasad Kumar on Wednesday dismissed disqualification petitions filed by the BRS against MLAs who defected to the ruling party, citing technical grounds and lack of ‘sufficient evidence’. The decision comes despite the Congress led by Rahul Gandhi repeatedly projecting itself as a defender of the sanctity of the Constitution, even as its handling of the defection issue had, from the outset, signalled a strategy of delay and reliance on procedural technicalities to wriggle out of an uncomfortable situation. The prolonged inaction by the Speaker had indicated that the ruling party would seek refuge in narrow interpretations rather than address the substance of the allegations. In a press release issued by State Legislature Secretary V Narasimha Charyulu, it was stated that the Speaker, acting as chairman of the tribunal on disqualification petitions, dismissed the pleas. The uploading of the detailed orders on the Assembly website, he said, was under process.

BRS leaders, including party whip KP Vivekananda and general secretary Soma Bharat Kumar, appeared before the Speaker along with advocates representing both the BRS and the defected MLAs. Following the verdict, the BRS announced that it would challenge the Speaker’s order in court. Speaking to the media, Vivekananda termed the decision a ‘brutal attack on democracy’ and said the BRS would pursue all legal remedies to ensure that the turncoat MLAs were held accountable. After 10 MLAs defected to the Congress after being elected on the BRS symbol, the BRS had filed disqualification petitions before the Speaker. With no decision forthcoming for months, the party approached the High Court and subsequently the Supreme Court, seeking directions to compel the Speaker to act. Notices were issued to all 10 MLAs, but only eight responded, denying that they had joined the Congress. Kadiam Srihari sought more time to file his response, while Danam Nagender, who even contested on a Congress ticket in

between, is yet to submit his reply, with both these seen as Congress tactics to delay the entire process. In the first phase, the Speaker’s ruling covered petitions against five MLAs, Tellam Venkat Rao, Bandla Krishnamohan Reddy, Prakash Goud, Gudem Mahipal Reddy and Arekapudi Gandhi. Significantly, the order was pronounced just a day before the expiry of the four-week deadline set by the Supreme Court, which had repeatedly pulled up the Speaker for delays and warned of possible contempt proceedings. The apex court had earlier fixed a three-month deadline ending October 21, which was ignored, prompting sharp observations. The BRS had argued before the court that no meaningful inquiry had been conducted into the defection of the 10 MLAs. While the Speaker is yet to decide on the remaining five cases, the Supreme Court hearing scheduled for Thursday is expected to have a bearing on the course ahead.

The Speaker’s reasoning has drawn criticism as five MLAs were spared disqualification on the ground of “insufficient evidence” despite the BRS placing extensive material on record. This included affidavits, photographs, public statements, social media posts and documented participation of the MLAs in Congress programmes over several months. Some of them have openly campaigned for Congress-backed candidates in the recently concluded gram panchayat elections. Yet, the Speaker held that they were still technically with the BRS, effectively brushing aside the material presented during the hearings. The rejection of the disqualification petitions has reignited debate over the erosion of parliamentary norms in the State. The timing of the verdict, delivered on the eve of the Supreme Court deadline, has been widely viewed as procedural compliance without substantive scrutiny, serving to shield the defectors.

Despite repeated admonitions from the Supreme Court and explicit warnings of contempt, the Speaker’s inaction stretched for nearly a year before culminating in a last-minute order that protected the turncoat MLAs. The Congress’ attempts to justify the defections by citing the BRS’s past record have also come under scrutiny. Legal experts have pointed out that equating individual defections with legislative party mergers permitted under the Tenth Schedule reflects a selective and untenable reading of constitutional provisions. The contrast becomes sharper in the national context. In Haryana, the Congress demanded the immediate disqualification of its MLA who joined the BJP, calling it a moral imperative. In Telangana, the same party appears willing to bend institutional processes to suit political convenience. Beyond the legal battle, the political fallout is already visible. Defections have fuelled factionalism within the Congress, disrupted constituencies and affected governance. As the BRS prepares to return to the Supreme Court, a larger question looms over the State: if the Speaker functions as a shield for the executive, who safeguards the sanctity of the Assembly.

Mystery surrounds whereabouts of former CPI Maoist chief Ganapathy

Hyderabad: The whereabouts of legendary Maoist ideologue Ganapathy remain a closely guarded secret, even years after he stepped down from the leadership of the CPI (Maoist). Despite sustained intelligence efforts, security agencies have not been able to trace his location. Ganapathy, whose original name is Muppala Laxmana Rao, led the Indian revolutionary movement for over 25 years. He handed over the reins of the CPI (Maoist) to Baswaraj, also known as Namballa Kesava Rao, in February 2017. Baswaraj was later killed in an encounter with security forces in the Abujh Mad forests of south Chhattisgarh on May 21, 2025.

Ganapathy had become general secretary of the then CPI ML People’s War in June 1992. Following its merger with the Maoist Communist Centre of India in 2004, the CPI (Maoist) was formed. Under his leadership, the movement expanded to nearly 157 districts (out of 600) across the country, with the unification of revolutionary groups considered his major contribution. After stepping down, Ganapathy’s status and location were kept strictly confidential. Even the leadership transition was not disclosed for more than a year and was officially acknowledged only after media reports revealed the change.

A party document prepared after the CPI (Maoist) Central Committee meeting in February 2017 suggests that Ganapathy may have been moved out of active conflict zones due to health concerns. The document indicates that only a small inner circle of the party may remain in contact with him, possibly once or twice a year. The resolution on



party veterans stated that senior leaders should gradually be relieved of responsibilities based on physical and health conditions. It also said that if adequate security could not be ensured amid intensified counter insurgency operations, veterans should be shifted to non-struggle areas, either rural or urban. According to the document, regional or state committees were tasked with coordinating their security and maintaining contact at least once every six months. It also noted that if political conditions improved, such veterans could be allowed to enter public life and contribute openly to the movement. The security of such ‘veterans’ should be taken care of by the Regional Bureaus or the State committees. In a situation where the party could not establish a contact with them in six months, the veterans should continue on their own till the party established the contact again. Based on this resolution, it is believed that Ganapathy may no longer be in traditional Maoist strongholds such as Bastar or Saranda forests and could be residing discreetly in an urban location.

Swearing-in of newly elected Sarpanches postponed to Dec 22

Hyderabad: The swearing-in ceremony of newly elected Sarpanches across Telangana has been postponed from December 20 to December 22 following representations from public representatives citing the absence of an auspicious muhurat.

According to officials, December 20 coincides with the new moon day, prompting elected representatives to request a change in the schedule for swearing-in. The

Panchayat Raj department accepted the request and re-scheduled the appointment date accordingly. With the revised schedule, the first meeting of the respective gram panchayats where elections were recently held will now take place on December 22. Deputy Sarpanches will be elected on the same day. Panchayat Raj and Rural Development Director G Srijana issued formal orders in this regard and instructed district and local authorities to make necessary arrangements to ensure smooth conduct of the swearing-in and inaugural meetings.

Speaker rejects BRS petitions against defected MLAs; party to move Supreme Court

Hyderabad: Telangana Assembly Speaker Gaddam Prasad Kumar on Wednesday rejected the disqualification petitions filed by the BRS against MLAs who defected to the Congress after being elected on the BRS symbol. The Speaker pronounced the verdict around 3.30 pm, citing lack of sufficient evidence to declare the MLAs as defectors, sources said. BRS leaders including petitioners and their lawyers are still awaiting to meet the Speaker at the State Legislative Assembly on his decision. Following Wednesday’s decision, the BRS confirmed plans to challenge the Speaker’s order in the Supreme Court.

In the first phase, the decision covered petitions against five MLAs — Tellam Venkat Rao, Bandla Krishnamohan Reddy, Prakash Goud, Gudem Mahipal Reddy and Arekapudi Gandhi. The ruling came a day before the expiry of the four-week deadline set by the Supreme Court, which had repeatedly censured the Speaker for delays and warned of contempt proceedings. The apex court had earlier fixed a three-month deadline ending October 21, which was not adhered to, leading to sharp observations against the



Speaker. The BRS had approached the Supreme Court alleging that no inquiry was conducted into the defection of 10 MLAs. Notices were issued to 10 MLAs, but only eight responded and denied to have joined the ruling Congress. Kadiam Srihari sought more time to respond, while Danam Nagender is yet to reply. The Supreme Court hearing on Thursday is expected to play key role in deciding their fate.

Speaker’s ruling on defected MLAs a grave constitutional violation, says Harish Rao

Hyderabad: Stating that degradation of the constitutional institutions for political gains was something only the Congress government under Chief Minister A Revanth Reddy seems capable of doing, senior BRS leader and former Minister T Harish Rao said Rahul Gandhi’s ‘Save the Constitution’ slogan has been thoroughly exposed with the Speaker’s ruling regarding the defected MLAs. “Speaker Gaddam Prasad Kumar, on Wednesday, dismissed the petitions filed by BRS against five MLAs, Tellam Venkat Rao, Bandla Krishnamohan Reddy, T Prakash Goud, Gudem Mahipal Reddy and Arekapudi Gandhi, citing insufficient evidence to prove they had formally defected to the Congress. The MLAs argued that they continued to affiliate with BRS technically, despite allegations of switching loyalties after the 2023 elections. Launching a scathing attack on the Congress government, Harish Rao called the decision a “grave constitutional violation”. The provisions of the anti-defection laws clearly outlined in the Constitution were ignored. “By completely setting aside the anti-defection rules specified in the Constitution regarding MLAs who switched parties and ruling in favour of the ruling party, this is nothing but trampling the Constitution,” he stated. “Rahul Gandhi’s

KTR calls Speaker’s ruling on turncoat MLAs ‘murder of democracy’

Hyderabad: Terming Assembly Speaker Gaddam Prasad Kumar’s decision to dismiss disqualification petitions against five BRS MLAs a murder of democracy in broad daylight, Bharat Rashtra Samithi (BRS) working president KT Rama Rao said the protection of the defectors despite their public admissions of switching for ‘development’ exemplified the Congress’s attitude. He accused the Congress of delaying action on disqualification due to fear of by-elections, amid growing public backlash against Revanth Reddy’s government, particularly evident during recent panchayat polls. Telangana Assembly Speaker Gaddam Prasad Kumar rejected the petitions filed by BRS, citing insufficient evidence to prove that the MLAs — Tellam Venkat Rao (Bhadrachalam), Bandla Krishna Mohan Reddy (Gadwal), T. Prakash Goud (Rajendranagar), Gudem Mahipal Reddy (Patancheru), and Arekapudi Gandhi (Serilingampally) — had formally joined the Congress.

On Venezuela and U.S. aggression

In line with a series of hostile moves, the U.S. seized a Venezuelan oil tanker, Skipper, on December 10. Venezuela called it the latest example of Washington's "pi-racy, kidnapping, theft of private property, extrajudicial executions in international waters". The tanker was part of Venezuela's ongoing efforts to support Cuba through subsidised oil shipments, with proceeds from resale to China providing Havana crucial revenue. For decades, Venezuela has sent oil to Cuba at highly subsidised prices, with Cuba sending doctors and security professionals to Venezuela. The seizure represents a troubling escalation in U.S. policy toward Venezuela under President Nicolás Maduro. It is also clear that the U.S. Secretary of State, Marco Rubio, a major hawk on U.S. foreign policy towards Cuba, has sought to disrupt one of the island nation's economic lifelines. The overt moves to engineer regime change in Venezuela and other brazen acts mark a new low in U.S. foreign policy, recalling the interventionist era of its Monroe Doctrine in Latin America. Before the seizure of Skipper, the U.S. had also conducted strikes in Caribbean waters on boats that Washington alleged were used by drug traffickers. These attacks appear to constitute acts of war carried out without clear legislative authorisation. The Trump administration insists that the operations are part of its "war on drugs", but has not presented credible evidence to link Mr. Maduro to cartels or to drug trafficking networks. To be clear, Mr. Maduro is credibly accused of manipulating the results in the 2024 presidential elections and his government also bears substantial responsibility for Venezuela's crippling economic collapse. But, acknowledging its failures does nothing to justify the Trump administration's hostile approach.

Indian Equities Hit Record Highs as Inflation Tumbles and Valuations Reset: PL Asset Management



Hyderabad: PL Asset Management, the asset management division of PL Capital Group (Prabhudas Lilladher), in their recent report 'PMS Strategy Updates and Insights', cited that Indian equity markets scaled fresh all-time highs in November, decisively outperforming global peers as a powerful combination of record-low inflation, resilient domestic growth and normalized valuations improved the risk-reward profile for investors. While global markets remained uneven — pressured by weakness in technology stocks, a cooling AI-led rally and soft macro data from China — India stood out as a relative bright spot, supported by strong domestic fundamentals and steady liquidity conditions.

Headline inflation emerged as a key driver of sentiment during the month. Consumer Price Index (CPI) inflation fell sharply to 0.25%, the lowest level on record and

well below the Reserve Bank of India's medium-term target of 4%. The sharp disinflation reinforced expectations of additional policy easing, providing meaningful support to equity valuations. Reflecting confidence in the domestic growth outlook, the RBI revised its FY26 GDP growth forecast upwards to 7.3%, while India posted 8.2% GDP growth in Q2FY26, reaffirming its status as the fastest-growing major economy globally. Domestic activity indicators remained supportive despite global headwinds. Manufacturing PMI moderated to 56.6 amid tariff-related export softness but continued to signal healthy expansion. GST collections remained robust at ₹1.70 lakh crore, underlining the strength of domestic demand, while strong festive consumption further cushioned growth. Importantly, India's current account deficit improved to 1.3% of GDP, helping maintain macro stability despite currency pressures and volatile global capital flows.

In contrast, global markets displayed growing signs of fatigue. The Nasdaq 100 declined during the month amid profit-taking in AI-linked stocks, while China and Hong Kong equities weakened on sluggish macro data and muted policy traction. Precious metals outperformed as investors sought safety, and crude oil prices softened ahead of expected rate cuts by the US Federal Reserve. Against this backdrop, India's relative stability, predictable policy environment and domestic flow resilience helped it extend its outperformance.

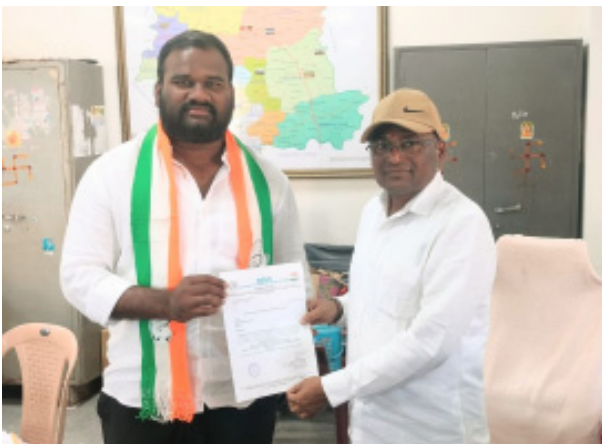
Chukkalabodu Sarpanch Polls Turn into Political War Between Koram Kanakaiah and Bhukya Dal Singh Naik

Deposit Not Received By 27 Candidates

Chunarkar Satish, supported by BRS, got 1,897 votes, while independent candidates Durgam Prashanth got 945 votes and Durgam Durgaji got 708 votes. The fact that the candidate supported by the ruling party got the least votes at the mandal center has become a matter of discussion.”

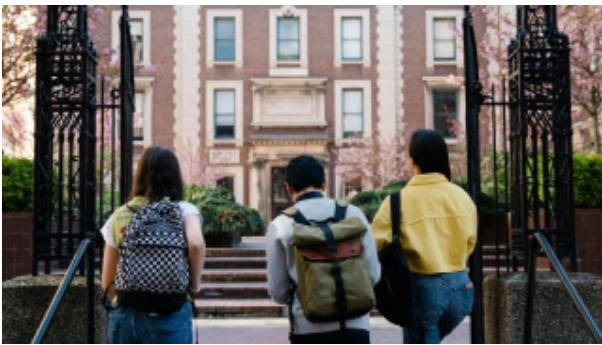

How an early outreach project that began in Pune is helping less-advantaged students get into top tech schools

For many students from economically disadvantaged backgrounds, the path to engineering is often cut short not by a lack of ability but by a lack of access to quality teaching, mentoring, and resources. Over the last nine years, Cognizant Outreach's Project Dhyeya has been working to change that reality, creating a structured pathway that supports students from Class 8 through engineering education and into the workforce. The volunteer-led effort that began in Pune has since expanded to Hyderabad, Kolkata and Hubaneswar, supporting more than 650 students across four cities. Speaking to The Indian Express, Abhijit Datar, Global Delivery Head, IoT and Engineering, Cognizant, who has been closely associated with the initiative, said, "Our programme focuses on early intervention, recognising that the most critical gaps in India's education system emerge well before college. There is a massive drop between Class 10 and Classes 11–12.

"A student scoring 90 per cent in Class 10 often falls to 70 per cent in Class 11, for example. That drop has nothing to do with intelligence. It's about preparedness," he added. Project Dhyeya identifies students as early as Class 8 through a raw aptitude-based entrance test that evaluates reasoning and problem-solving skills rather than academic exposure. In Pune alone, 700-1,000 students appear

for the test each year, of which 30 to 60 are selected. "We are not testing what students already know," Datar said. "We are testing how they think. Talent is evenly distributed. Opportunity is not." Once selected, students receive 10 to 15 hours of instruction every week, delivered through a combination of online learning and weekend sessions held at Cognizant offices.

The curriculum is aligned with national-level competitive examinations such as the National Means-Cum-Merit Scholarship (NMMS) scheme and the National Talent Search Examination (NTSE), and students are provided with laptops, books, digital access, and study material. The project also partners with reputed coaching institutions and covers the entire cost of preparation in classes 11 and 12. "From the time a student joins us in Class 8 until they complete engineering, money is never the reason they drop out," Datar said. "We take what I call academic guardianship. Students from Project Dhyeya have secured admissions into IIT Delhi, IIT Bombay, IIIT Allahabad, College of Engineering, Pune (COEP), Vellore Institute of Technology (VIT), and the Pune Institute of Computer Technology (PICT), among others. More than 50 per cent of our current beneficiaries are girls," he added. Several students have gone on to secure internships and pre-placement offers at leading global organisations, including at Cognizant. "One student recently received an internship offer from Goldman Sachs, while another converted an internship at Barclays into an offer. These are not outliers anymore. When you invest early and consistently, outcomes start becoming predictable," Datar said. The initiative has a strong volunteer network involving over 250 Cognizant associates. In the long term, the project hopes to ensure that at least 10 per cent of hiring in technology and manufacturing companies comes from economically weaker sections and from among girls, according to Datar, who underlined that the programme is not about philanthropy. "It is capability-building. If you give students the right foundation, mentoring, and resources, they don't need sympathy. They just need opportunity," he said.

Four days after 'assault' on govt officials in Banaskantha village, no arrests yet

Four days after police and revenue officials of the Gujarat government were attacked allegedly by armed villagers, an uneasy calm had descended on Padaliya village. Around 1,000 tribals had gathered on an open ground when The Indian Express visited this village of Danta taluka in Banaskantha district, occupied largely by tribals. Many of the residents were not willing to talk about the incident in which over 40 officials were injured. Eyeing political, religious and tribal connect, Congress to launch 2nd phase of 'Jan Akrosh Yatra' in Central Gujarat

After the first phase in North Gujarat, the Congress Tuesday announced the second phase of its 'Jan Akrosh Yatra' in Central Gujarat. The yatra will be flagged off on December 20 from Bhathiji Maharaj Temple in Fagvel Kheda district, where the then Chief Minister Narendra Modi launched his state-wide Gujarat Gaurav Yatra in 2002. The yatra will conclude on January 6 at Kamboi Dham in Dahod-Samadhi of Shri Govind Guru, a revered figure of tribals and freedom fighter, who passed away in October 1931.

In Jhalod taluka, Shri Govind Guru Dham memorial is a place of importance for the tribals. Born as Govind Giri Banjara, Shri Govind Guru was a social and religious leader as well as a freedom fighter. In March 2024, Congress leader Rahul Gandhi began the 55th day of the Bharat Jodo Nyay Yatra with a visit to the Kamboi Dham in Dahod.

Bhathiji Maharaj Temple that attracts a large number of devotees including Hindus and Muslims is dedicated to Bhathiji Maharaj, who according to folklore sacrificed his life to protect village's cows from attackers during his wedding. The Kshatriya Thakor community worships him as kuldevata (family deity). Addressing a press conference at the Gujarat Pradesh Congress Committee headquarters Rajiv Gandhi Bhavan here, GPCC president Amit Chavda said the yatra will cover seven districts of Central Gujarat – Kheda, Anand, Vadodara, Chhota Udepur, Panchmahal, Mahisagar and Dahod (three municipalities, 55 talukas and 37 municipal areas). The problems of Central Gujarat will be raised and "corruption in the area" will be exposed dur-

ing the 1400-km yatra, Chavda said.

The first leg of Jan Aakrosh Yatra held in North Gujarat between November 21 and December 3, covering a distance of 1300 km, has received widespread public support, the GPCC president said. "During the first leg of the yatra, the public has openly expressed their anger against corruption, mismanagement, discrimination and injustice that have become widespread during the three decades of BJP rule in Gujarat. The Pradesh Congress Committee had started the Jan Aakrosh Yatra to give voice to the questions, pain and voices of the public," Chavda said.

Stating that the Aakrosh Yatra is not an election march, but a fight for the rights of the people, Chavda said: "The government collects taxes, but does not listen to the voice of the people. Therefore, people from all sections of society should join this march to give a voice to the people. The Jan Aakrosh Yatra is the voice of the people and in the coming days this voice will be reverberated in the entire Gujarat." Speaking on the occasion, Leader of the Opposition in the Legislative Assembly Tushar Chaudhary said that the government is not carrying out recruitment despite lakhs of vacant posts in the government. "During the first phase of the yatra, the Congress demanded complete waiver of farmers' debt and raised shortage of fertilizers and seeds, illegal liquor and drug business and the need to give employment to the youth through regular recruitment. There is great public outrage against non-recruitment and exploitation of youth through fixed salaries, contracts and outsourcing, despite lakhs of vacant posts in the government," Chaudhary alleged. To cover: 7 districts (Kheda, Anand, Vadodara, Chhota Udepur, Panchmahal, Mahisagar, Dahod), 3 municipal areas, 55 talukas and 37 municipal areas. Key programmes: Interaction with all sections of people including farmers, women, unemployed youth, small traders, farm laborers, and workers. 12 years on, CBI court acquits Haryana judge, parents in wife's death case

An FIR was initially registered at the Civil Lines police station in Gurugram on the complaint of her brother, Pradeep Aggarwal. More than 12 years after a 28-year-old woman, the wife of a Haryana judicial officer, was found dead with bullet injuries in Gurugram, a special CBI court in Panchkula on Tuesday acquitted her husband and his parents of charges of dowry death, criminal conspiracy and cruelty. The acquitted include the woman's husband Ravneet Garg, who was then posted as chief judicial magistrate, his father K K Garg, a retired sessions judge, and his mother Rachna Garg.

Additional district and sessions judge Rajeev Goyal, special judge for CBI cases, acquitted the three of offences under Sections 304B (dowry death), 120B (criminal conspiracy) and 498A (cruelty by husband or his relatives) of the Indian Penal Code. A detailed judgment is yet to be released. According to the prosecution, Geetanjali, a resident of Sector 8, Panchkula, was found dead on July 17, 2013, at the Gurugram police lines with multiple bullet injuries. A post-mortem examination reported three bullet injuries and a head injury. Her family alleged she had been harassed for dowry and murdered. An FIR was initially registered at the Civil Lines police station in Gurugram on the complaint of her brother, Pradeep Aggarwal. The investigation was later transferred to the Central Bureau of Investigation on the family's request. In September 2016, the CBI arrested Ravneet Garg, then posted as civil judge (senior division) in Kaithal, in connection with the case. He was subsequently granted bail. In December the same year, the agency filed its chargesheet, alleging that Garg and his parents had caused Geetanjali's death for dowry. During the



trial, public prosecutor Amit Jindal argued that a licensed revolver belonging to Garg was found near the body and that a ballistic report indicated the bullets recovered from the victim had been fired from the same weapon. The prosecution also pointed to live cartridges recovered from Garg's residence and alleged dowry demands to support its case.

The defence, represented by Teriminder Singh, Manbir Rathee and Parmod Bali, countered that the accused had been falsely implicated and had no role in Geetanjali's death. They argued that while the CBI continued to investigate the case as one of murder and medical opinion also pointed in that direction, the agency changed the charge to dowry death under Section 304B at the time of filing the chargesheet. Senior counsel Teriminder Singh further submitted that evidence during trial showed Geetanjali had spoken to her parents on the day of the incident and had made no complaint against her husband, undermining allegations of dowry harassment and cruelty. After hearing the arguments and examining the evidence, the court acquitted all three accused. Ravneet Garg had been placed under suspension following his arrest in the case.

Mahatma Gandhiji was not a leader of a political party

December 17): - A round table meeting was held at SV Hotel in the Yadadri Bhuvanagiri district center with social organizations, Arya Vysya business community members, senior citizens, and representatives of all political parties, to protest against the central government's move to change the name of the Mahatma Gandhi National Rural Employment Guarantee Scheme to Prime Minister Modi's Viksit Bharat Daily Yojana and introducing a bill to this effect in Parliament. At a meeting organized by Arya Vysya leaders Manchikanthi Krishnamurthy and Rachamalla Ramesh, PCC General Secretary Pottnak Pramod Kumar, former Municipal Chairman Barre Jahangir, Dalit Aikya Vedita District President Battu Ramachandrarai, and CPM Town Secretary Maya Krishna participated and spoke. They stated that the previous UPA government had introduced the Mahatma Gandhi National Rural Employ-

ment Guarantee Scheme to ensure that people in rural areas had work every day, allowing them to work in their own villages. This scheme enabled people in villages, hamlets, and tribal settlements to work locally and earn a livelihood. However, the current Narendra Modi-led central government has introduced a resolution in Parliament to change the name of this scheme. Protesting this move, the round table meeting held in Yadadri Bhuvanagiri district headquarters resolved that the central government should refrain from removing the name of the Father of the Nation, Mahatma Gandhi, from the scheme. Similarly, they stated that if Mahatma Gandhi's name is removed, they will launch a phased movement from the village level to the national level, involving the Arya Vysya community, business leaders, senior citizens, and all-party political parties. Resolutions passed at the meeting included: Mahatma Gandhi is not a political party leader, but the Father of the Nation and a messenger of world peace; Mahatma Gandhi embodies the principles of peace and non-violence; submitting petitions to district collectors; organizing a movement at Gandhi statues with members of the Arya Vysya community, business leaders, senior citizens, and political party leaders at the state and national levels; a postcard campaign; and collecting signatures to be sent to the State Governor and the President. Prominent businessmen Diddikadi Narsing Rao, Kurella Janardhan, retired principal Somachandragupta, Vasavi Club president Bajjala Mahesh, prominent journalist Cholleti Govardhana Chari, Sevala state secretary Pittala Balaraj, town president Dakuri Prakash, SFI district president Vanam Raju, Belde Anand, Market Committee director Ranga Krishna, MD Athar Hanumantharao, Bachu Nagender Gupta, BC Association district president Kotha Narasimhaswamy, retired employees Krishnareddy, Satyanarayana, and others participated in the program.

Rs 50,000 for Indian documents, three-month age gap between brothers: ED files supplementary chargesheet in migration racket case

The Enforcement Directorate (ED) has filed the first supplementary chargesheet against Pakistan national Azad Hussain alias Azad Malik alias Ahammed Hossain Azad, and his Indian accomplice Indubhushan Halder alias Dullai in connection with a case pertaining to an alleged racket of illegally obtaining Indian documents for Bangladeshi nationals in West Bengal, officials said on Tuesday. The ED said in a statement that it filed a supplementary chargesheet in the case on December 11 before a special PMLA court in Kolkata and named Halder and four others as accused. The special court located at Bichar Bhavan in Kolkata has issued notice upon the accused persons, the statement said.

The ED probe, launched on an FIR registered against Hussain, revealed the accused was living in India under the assumed identity of Azad Malik and in connivance with Halder, was fraudulently obtaining Indian identity documents for illegal Bangladeshi immigrants in lieu of money. Subsequently, Hussain was arrested on April 15 while Halder was arrested on October 13. Both are currently in judicial custody. According to officials, ED conducted searches at premises linked with Hussain and seized incriminating documents and records, showing he procured multiple Indian identity documents such as Aadhaar card, PAN card, and

passport using forged information with the help of his accomplices. He is also accused of operating a hawala network to facilitate illegal cross-border remittances between India and Bangladesh, collecting payments in cash and UPI, before transferring equivalent amounts to Bangladesh using platforms like bKash.

Hussain referred Bangladeshi clients to Halder and the duo would charge Rs 50,000 each for making Indian documents, including passports, and processed 300-400 such applications of illegal Bangladeshis in India, ED officials said. The ED said there were 29 passport applications in which Halder had submitted copies of ITR and some applications contained "several discrepancies beyond imagination", underlining the fact that Indian IDs were issued for the Bangladeshis using "fabricated" documents. In one instance, according to the agency, two brothers had furnished their dates of birth in the passport application form as 1st January 1988 and 1st April 1988, respectively – a gap of only three months, which is biologically impossible. "In another instance, two brothers have dates of birth as 24.10.1975 and 24.05.1976 respectively, a gap of only seven months, which is again dubious," the ED said in a statement.

The agency also found that a local Full Fledged Money Changer (FFMC) permitted Hussain to operate the forex counter despite being aware of his non-Indian identity. Hussain used to sell forex in public without any supporting documents for a commission, the ED said. For maintaining the documentation as per the RBI guidelines, they used to show fake, bogus sales in the name of several individual entities by using their documents without their knowledge and consent, ED said. Large sums of money, exceeding Rs 80 crore, were deposited into the company's bank accounts under the guise of foreign currency sales to multiple customers, ED said, adding the probe has revealed that these transactions involved forged documents, fake cash memos, and unauthorised use of individual identities of numerous customers.

CM Sukhu leads Anti-Chitta walkathon, says will wipe out network

Himachal Pradesh Chief Minister Sukhvinder Singh Sukhu on Tuesday led an Anti-Chitta Awareness Walkathon in Hamirpur, which witnessed the participation of thousands of school and college students among citizens of the state. Commencing from Government Senior Secondary School (Boys) Hamirpur, the walkathon concluded at the Police Lines Dosarka Ground. Before the walkathon, the Chief Minister administered a solemn oath at the school ground, where the crowd pledged to eliminate chitta and other narcotics from the state. "Strict and decisive action is under way to uproot the 'chitta termite' from its very roots through the unyielding force of the law."

Addressing the gathering, the CM said Himachal Pradesh was engaged in a decisive battle against chitta. He emphasised that the state has launched a comprehensive and uncompromising offensive against this lethal drug. He also said drug traffickers, suppliers and those providing protection to these illicit networks were being systematically targeted. The state is using advanced technology besides a strengthened intelligence framework and stringent legal provisions to dismantle narcotics cartels. Reiterating his government's resolve, the CM said the administration was committed to wipe out the chitta traf-

fickers' networks. He underscored that this campaign was not merely a law enforcement initiative but a people's mass movement to protect the core identity and social fabric of Himachal Pradesh. Sukhu outlined a holistic strategy to combat the chitta mafia with a special focus on rehabilitation and support for victims of drug abuse. The administration is establishing new de-addiction centres across the state. The state is also forming a dedicated 'Drug De-addiction, Prevention and Rehabilitation Board' to coordinate efforts in treatment, prevention and community outreach. The CM emphasised that youths trapped in drug addiction are being rehabilitated and brought back into the mainstream of society.

Sukhu also announced rewards ranging from Rs 10,000 to Rs 10 lakh to those providing information about chitta suppliers. He also assured that the identities of informers would be kept confidential with complete protection guaranteed by the government. Sukhu also said the administration held meetings of Drug De-addiction Committees in 234 panchayats and urban local bodies, most affected by drugs. These meetings focused on strengthening public participation and marking detailed discussions. During the walkathon, the CM interacted with children and explained how chitta poses a serious threat to the health and the society. He encouraged students to spread awareness about the fatal effects of drugs and narcotics. Students and citizens carried placards and raised slogans against chitta. Technical Education Minister Rajesh Dharmani, Political Advisor to the Chief Minister Sunil Sharma Bittu, MLAs Suresh Kumar and Captain Ranjit Singh, Chairman APMC Ajay Sharma, Chief Secretary Sanjay Gupta, Director General of Police Ashok Tiwari, Convener and Advisor of the De-addiction, Prevention and Rehabilitation Board Naresh Thakur, Co-Convener Sanjay Bhardwaj, Congress leaders Pushpender Verma and Subhash Datwalia, representatives of various organisations and other dignitaries were present on the occasion.

‘Nobody will be spared’: BMC issues notice to metro contractor J Kumar Infraprojects for flouting pollution norms; MMRDA defends

AMID THE city grappling with air pollution woes, the Brihanmumbai Municipal Corporation has issued a fresh show cause to J Kumar Infraprojects—the third in three years—for violating the air pollution mitigation guidelines on multiple accounts at the Metro Line 2B worksite spanning over 2.5 km in Bandra Kurla Complex. The project managed by Mumbai Metropolitan Region Development Authority (MMRDA) is being executed by J Kumar Infraprojects—the contractor appointed by MMRDA. Records accessed by The Indian Express show that this is the third time that the M/S J Kumar has been served a show cause notice including a stop work notice in 2023 over non-compliance. According to the BMC notice, a copy of which is with The Indian Express, the contractor failed to adhere to norms on 18 of the 20 accounts that were applicable to the project. BMC has a 28-point guideline that was issued in October 2023 to regulate pollution at construction sites. The latest notice was served to J Kumar RMC plant operated by J Kumar Infraprojects on December 11, 2025 for failing to adhere to mitigation measures at the Metro worksite's RMC plant.

The show cause notice was served after site inspection by the BMC's H(East) ward's air pollution mitigation squad on December 4, wherein the squad observed an array of violations—from lack of metal/tin sheets to absence of air pollution monitoring records and lack of valid PUC certificates for their transport vehicles among others. Noting the violations, BMC first issued an 'Inspection Report' to the contractor on the same day and asked them to comply with the stipulated norms. However, as BMC in its sub-

sequent visits noted that most of the applicable guidelines were not being adhered to, it then issued a "show cause" notice to J Kumar's RMC plant site on December 11. "Such non-compliance amounts to a violation of the prescribed Air Pollution Mitigation Guidelines and poses a serious threat to environmental safety and public health," said the BMC in its show cause notice, stating that a stop work notice will be issued against the project works in the absence of a satisfactory explanation. BMC additional municipal commissioner, Avinash Dhakne said, "Nobody will be spared, whether it is a government or private agency. We have issued strict instructions that whoever is polluting should be booked. Today as well, I convened a meeting with some ward officials where I directed them to strictly issue notices wherever there is a discrepancy." Emails sent to J Kumar Infraprojects did not elicit any response.

A senior officer with MMRDA, requesting anonymity said, "Our records show that PM 2.5 and PM 10 limits at the project site are satisfactory and within the stipulated norms. We are not contributing to air pollution as 90 percent of the work on the Metro project sites have already been completed. Currently, most of the pollution is being contributed to by private development projects. Therefore, instead of blaming the Metro work site, the BMC should focus on such sites which are actually contributing to air pollution as well as implement the mitigation measures." With this third notice to M/S J Kumar for this project site in three years, BMC had served a stop work notice to J Kumar Infraprojects in November 2023 for failing to adhere to the mitigation measures at the BKC work site and then again issued a show cause notice to M/S J Kumar's casting yard site on December 23, 2024 wherein the civic body had flagged the absence of adherence to the civic norms for mitigation of air pollution. The show cause notice at the BKC worksite has come at a time when the BKC commercial hub has been grappling with deteriorating air quality. Records from the MPCB showed that the monitoring station at Bandra Kurla Complex has recorded consistently poor AQI since early November this year, when unseasonal rainfall activity receded. Between November 6 and Tuesday (December 16), the BKC station logged 'moderate' AQI over 100 on all days with the worst air quality was observed on December 4 when the AQI level plummeted to the poor category at 232.

UP acts tough against fake fertiliser sale, CM calls for invoking NSA

In a meeting with the Agriculture Minister and department officials, the CM said that accountability should be fixed, and the guilty will face action irrespective of their position if the government receives any information about irregularities. He further said the activities of field-level officers will be monitored, and an open vigilance inquiry will be conducted if collusion or negligence is found at any level. In another meeting, he directed the ministers of key departments to conduct monthly reviews of works in order to achieve the goal of making Uttar Pradesh a \$1 trillion economy. During a meeting with Cabinet ministers and top officers of key departments, the CM also instructed that the Chief Secretary conduct fortnightly reviews, additional chief secretaries, principal secretaries and heads of departments weekly reviews for the same. Taking stock of the status of budget allocations and expenditure of various departments for the financial year 2025–26, he emphasised quality review of "identified points" and timely completion of all works, along with time-bound disposal of files by officials concerned. The Chief Minister was informed that UP's gross state domestic product (GSDP) stood at Rs 29.78 lakh crore and that the state's contribution to the national economy in 2024–25 increased to 9 percent, up from 8.6 percent in 2022–23. It was also stated that 93 percent of the GSDP target has already been achieved and efforts are underway to reach the target of Rs 42 lakh crore. Adityanath instructed that real-time data of departmental works be uploaded promptly and the data collection process be expedited further. The ministers and officers were asked to maintain continuous coordination with Central government officials to ensure the timely receipt of the central share and the budget allocations be spent on time.

The Planning Department should establish a robust mechanism to collect data from all departments on a weekly basis, he said.

"UP contributes 21 percent of the country's total foodgrain production. Ensuring foodgrain and nutritional security while increasing farmers' income through an effective agricultural strategy is the government's objective. The state's agricultural growth rate remains above 13 percent and work on seed parks and the UP Agri-Edge project should be expedited," he said. The CM added that road safety is the government's top priority and concrete efforts should be made to reduce road accidents in view of fog.

The Transport Department should hold a comprehensive review meeting, rationalise registration fees for commercial vehicles and enhance quality bus services for convenient public travel, he said. He further said that Uttar Pradesh has witnessed a record influx of tourists in recent years. By June this year, around 125 crore tourists visited the state, it was informed. Claiming that Garhmukteshwar was a major pilgrimage centre in western Uttar Pradesh, he ordered upgrade of facilities for devotees and tourists there. He also called for effective implementation of the homestay policy, promotion of the hotel industry and developing tourist destination plans. District-wise targets will be set under the Chief Minister's Mass Marriage Scheme, he said, adding that the setting up of digital libraries at the gram panchayat level be expedited and high-quality computers be provided. The CM was informed that in the power sector, reduction in electricity theft and technical losses has improved the performance of state power corporations. In the industrial sector, the addition of 7,000 new factories under the ASI framework has accelerated economic activity in private and semi-private companies, it was said. Increased registration of companies and factories under MCA has further strengthened industrial development, it was claimed. In the education sector, it was reported that salary adjustments for teachers and staff of government-aided schools have resulted in an additional increase of approximately Rs 0.60 lakh crore in the sector's GSVA. Adityanath said that the agriculture and cooperation ministers will review fertiliser availability and distribution on a daily basis while the Chief Minister's Office will directly monitor the situation in all districts. He directed the district magistrates, additional district magistrates and sub-divisional magistrates to conduct surprise inspections of fertiliser shops and cooperative societies.

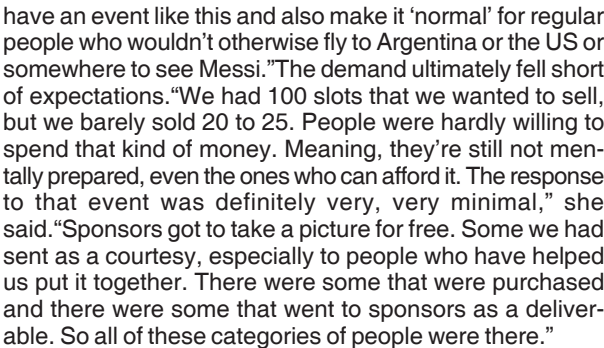

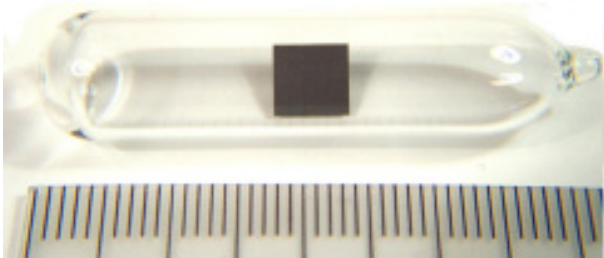

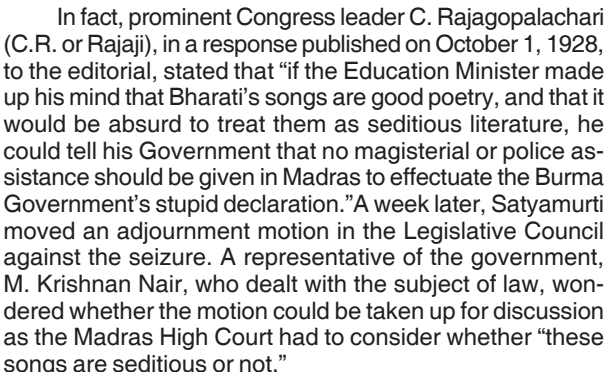

Ra.," were involved in an intense debate whether Bharati could be called a "Mahakavi" or not.

What should not be glossed over is that “Kalki” was a known associate of C.R., who came in for criticism in February 1919 that he did not properly introduce Bharati to Mahatma Gandhi during their meeting in Chennai. Prominent Tamil writer-critic, Ashokamitrin, in his essay on “Kalki,” writes that in the outlook of Rajaji, artists like Bharati were neither essential nor required preservation. In 1934–35, “Kalki” questioned Va. Ra.’s assessment of Bharati as Mahakavi. Amshan Kumar, who did a documentary on many

In about two-and-a-half years, the memorial was ready and the inauguration drew a larger crowd than what the foundation stone-laying event did. In the words of this newspaper, "the Bharathi Festival here commenced this evening [of October 12, 1947], literally, with a burst of song. From three this afternoon, it was almost non-stop music, closing with the climax of Srimalathi M.S. Subbulakshmi's melodious singing [which went on till 8 p.m.]." The music concerts did not end with M.S. but went on till late in the night. Dandapani Desikar was another leading musician who participated in the festival. "A vast pandal specially put up to seat 30,000 was packed to capacity, while nearly double that number stood outside listening," wrote The Hindu on October 13, 1947. Among those present were the then Chief Minister Omandur P. Ramaswami Reddiar, Tamil Nadu Congress Committee (TNCC) chief K. Kamaraj, industrialist M.A. Muthiah Chettiar, and connoisseur of the arts T.K. Chidambaramanatha Mudaliar. On the second day (October 13), Rajaji, who was the then Governor of West Bengal, declared open the memorial, built at a cost of ₹50,000. Ramaswami Reddiar unveiled Bharati's bust. Lavishing praise on the literary figure, C.R. said: "...he was the common and cherished possession of all Tamilians and not the exclusive possession of any one of them," this paper reported on October 15, 1947.

According to one school of scholars of the contemporary history of Tamil Nadu, Communist leader P. Jivanandam had, on the occasion, mooted the idea of the government purchasing the copyrights of Bharati's works and making the works available in public domain. However, what The Hindu stated in its report was that "like Gandhi's literature, Bharathi literature too should be [regarded as] a national possession and not [that of] any individuals." Kumar Nevertheless, the demand grew louder subsequently and on March 12 1949, the then Education Minister T.S. Avinashilingam Chettiar informed the Assembly about the government having secured all the rights for reproduction of Bharathi's works, apart from the government obtaining the manuscripts of the poet to be preserved in "a befitting manner" at the Government Museum. A day earlier, Ramaswami Reddier announced after talks with A.V. Meyappa Chettiar, one of the pioneers of Tamil cinema, that the latter had agreed to transfer to the government the rights vested in him of reproducing Bharati's songs, poems, other compositions and works, in Tamil and English, by sound reproducing or broadcasting devices. The government provided ₹15,000 to the poet's brother C. Viswanatha Aiyar for having agreed to give away the rights in regard to printing and publication. In April 1955 came the announcement of the government for having released the copyright to the public. Two years later, the then Chief Minister Kamaraj launched an edition of Bharati's works, running into 600 pages, at a price of ₹1.5 per copy. Vai Govindan, the publisher ("Sakthi Karyalayam"), informed the gathering on the occasion that "out of 15,000 copies printed, advance orders had already been received for 10,000," this newspaper reported on April 15, 1957. Puducherry and Chennai saw the establishment of memorials in the 1970s and 1990s for Bharati at the sites where he resided for a considerable period. As observed by C.R., in 1945 when he laid the foundation stone for the Ettayapuram memorial, Bharati had "a wide vision and generous outlook of things," qualities of which every individual should attempt to possess.

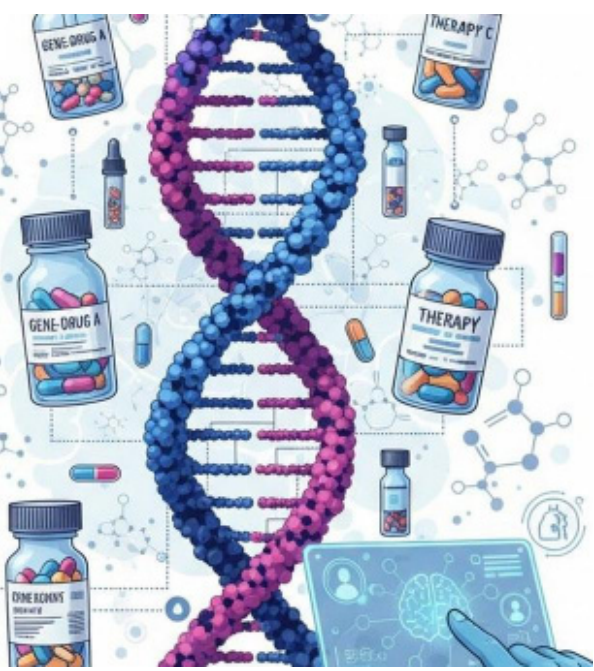

Pharmacogenomics: reading genes to tailor prescriptions for individuals



The old medical advice to “start low and go slow” reflects a fundamental challenge in healthcare: the same drug at the same dose can heal one patient while harming another. For decades, physicians have prescribed medications based on population averages, essentially conducting a trial-and-error experiment with each patient. Today, pharmacogenomics is rewriting this script by revealing how our genes influence drug response, transforming medication prescribing from guesswork to precision.

The drug-gene connectionPharmacogenomics examines how genetic variations affect an individual’s response to medications, determining whether a drug will be effective, ineffective, or even dangerous for a particular person. Unlike traditional medicine’s one-size-fits-all approach, this field recognises that genetic differences can dramatically alter how our bodies metabolise and respond to drugs. Mostly, this variability arises from differences in drug-metabolising enzymes, particularly the cytochrome P450 (CYP) family, which processes approximately 75% of commonly-prescribed medications. Genetic variations in these enzymes create different metaboliser phenotypes. A “poor metaboliser” with low functional enzyme activity may accumulate toxic drug levels from standard doses, while an “ultrarapid metaboliser” with enhanced enzyme activity may receive no therapeutic benefit. These aren’t rare genetic quirks. Studies show that approximately 90% of people carry at least one actionable pharmacogenetic variant. The clinical implications are profound: genetic factors contribute significantly to adverse drug reactions (ADRs), which rank among the leading causes of hospitalisation and death in developed nations.Real-world impact

The translation of pharmacogenomics from the laboratory to the clinic, has begun to deliver measurable gains across diverse areas of medicine. A clear example is Warfarin, a widely prescribed blood thinner with a notoriously narrow therapeutic window. Genetic variants in the CYP2C9 and VKORC1 genes account for approximately 50% of the variation in Warfarin dose requirements. Patients carrying certain variants may need only one-third of the standard dose to achieve therapeutic effect. Pharmacogenomic-guided dosing algorithms that incorporate these genetic markers have demonstrated improving outcomes, reducing adverse bleeding risks and helping patients reach therapeutic levels faster than traditional trial and error dosing methods.In cardiovascular medicine, Clopidogrel, a cornerstone antiplatelet drug used after heart attacks and stenting, provides another compelling example. The drug requires activation by the CYP2C19 enzyme. Patients with loss-of-function CYP2C19 variants, particularly CYP2C19*2 (found in 25-30% of the population), exhibit reduced drug activation and significantly higher risks of cardiovascular events including stent thrombosis. Reflecting this evidence, the 2022 Clinical Pharmacogenetics Implementation Consortium (CPIC) guidelines now recommend alternative antiplatelet agents for CYP2C19 poor metabolizers undergoing percutaneous coronary intervention.Beyond cardiology, psychiatry has also emerged as a fertile ground for pharmacogenomic implementation. Many antidepressants and antipsychotics are extensively metabolised by CYP2D6 and CYP2C19. The genetic variants in these enzymes can profoundly influence drug levels and side effects. Pre-emptive pharmacogenomic testing in psychiatric patients has demonstrated reduced adverse drug reactions, improved symptom control, and decreased healthcare costs. Oncology, too is advancing rapidly under the pharmacogenomics lens. Testing for variants in the DPYD

gene before administering chemotherapy drugs like 5-fluorouracil can prevent severe, life-threatening toxicity.

Over the past decade, genetic testing costs have fallen dramatically i.e. from thousands of dollars to roughly \$200-500 for comprehensive panels today. Yet the true value of pharmacogenomics extends far beyond the price. Economic analyses consistently show that genetic-guided prescription is cost effective for several drug-gene pairs, particularly in chronic disease where patients require long-term medication management.To assess this value, experts use a framework that considers several factors, such as severity and cost of side-effects, the frequency of genetic variants in the population, the availability of alternative drugs, and range of medications influenced by variations. For example, screening for HLA-B*57:01 before prescribing Abacavir, or for HLA-B*15:02 before Carbamazepine, helps in the prevention of potentially adverse reactions such as fatal Stevens-Johnson syndrome, making these test unequivocally cost-effective. The economic benefits compound when considering pre-emptive or panel-based testing strategies, where a single genetic test can provide guidance for dozens of medications throughout a patient’s lifetime. Such approaches transform pharmacogenomics from a one-time diagnostic expense into a long-term investment in safer and more efficient healthcare.However, the cost-effectiveness of pharmacogenomic testing varies significantly across different clinical settings. In acute, short-term conditions with limited treatment duration, routine testing may not be justified. But in chronic diseases that involve multiple medication trials such as depression, cardiovascular disorders, or chronic pain; the economic case is much stronger. Increasingly, healthcare systems recognise that preventing even one serious adverse drug reaction often offsets the cost of testing multiple patients.

Implementation challengesDespite compelling scientific evidence, pharmacogenomics still faces substantial barriers towards widespread clinical adoption. A 2023 scoping review identified knowledge gaps among healthcare providers as the primary obstacle. Most physicians and pharmacists receive minimal pharmacogenomic education in training, leaving them ill-equipped to order, interpret, and apply genetic test results. Beyond education, infrastructure limitations compound this challenge; many electronic health record systems lack adequate decision-support tools to integrate pharmacogenomic data into prescribing workflows. Without such digital assistance, clinicians often struggle to act on genetic information in real time.Reimbursement uncertainty creates additional hesitation. While some health systems and insurers cover pharmacogenomic testing for specific indications, coverage remains inconsistent across payers and jurisdictions. Meanwhile, regulatory pathways continue to evolve: over 100 Food and Drug Administration (FDA) drug labels now contain pharmacogenomic information, yet the clinical implications of these labels vary as some offer actionable recommendations while others are merely informative statements.Finally, cultural and institutional resistance should not be underestimated. Changing prescribing practices requires not just evidence but also trusted implementation frameworks, local champions, and administrative support. Encouragingly, where implemented, these programmes demonstrate that systematic approaches addressing education, infrastructure, and workflow integration can successfully overcome these barriers.The path forwardThe future of pharmacogenomics lies in pre-emptive testing strategies, where genetic information is obtained before a medication is needed and remains available throughout a patient’s healthcare journey. Several health systems now offer pre-emptive pharmacogenomic panels to high-risk populations, integrating results into electronic health records to trigger alerts when relevant medications are prescribed. As whole-genome sequencing becomes increasingly affordable, pharmacogenomic information may become a routine component of preventive medicine.Ultimately, pharmacogenomics represents a fundamental shift in how we think about drug therapy from treating populations to treating individuals, from reactive care to proactive prevention, from trial-and-error to precision medication. The prescription, quite literally, is written in our genes: we are now learning how to read it.

Integrated Child Development Services programme: A 50-year lifeline

At an anganwadi near Baiyappanahalli in Bengaluru, around 20 children, most of whom are between three and six years old, are busy playing, making merry, and having fun.He doesn’t seem to care much about the lunch at his anganwadi. But his friend, Niithu (who likes to be referred to as Dhanamma because “that’s what her dad calls her”) interjects.“You will fall sick if you eat ice cream. I like anna sambar (rice and sambar),” she says.“So, do you come to anganwadi for anna sambar?” I ask her.“I come here to study,” she surprises me, and goes on to recite the English alphabet.At another nearby anganwadi, 5-year-old Oviya approaches sheepishly with her notebook. True to her name, she seems to have an inclination for art. The book is filled with pencil drawings, most of them outlines of her own palm filled in with drawings of flowers and other filigree.A million kids, a million hues. Anganwadis, the first step for many Indian children to nutritious meal, education and socialisation, have been operating for 50 years now, catering to all such hues.A child is like a seedWhen the Integrated Child Development Services (ICDS) programme was inaugurated 50 years ago by the then Prime Minister Indira Gandhi, T. Narasipur in Mysuru was one of the first places in India where the pilot programme was launched. The programme has come a long way since and seen remarkable progress in the southern State where anganwadi workers have played key role in shaping generations.“Think of a seed that would one day grow into a healthy tree, a beautiful ecosystem in itself, nourishing everything around it. But if the seed itself goes bad, then what a huge loss that is. Every child is like a seed, and ICDS is the nourishment that would protect it from decaying,” says S. Varalakshmi, general secretary of the All India Federation of Anganwadi Workers and Helpers (AIFAWH) and general secretary, CITU.

A national programmeICDS is the world’s largest community-based programme for early childhood development.

As of June 30, 2021, there were 9,06,16,953 beneficiaries under anganwadi services in India. In FY 2021-22, the BJP-led Union government restructured the programme into Mission Saksham Anganwadi & Poshan 2.0.A first-of-its-kind programme combining health, education, and nutrition, the scope of ICDS has expanded over the years to offer a range of services, including a supplementary nutrition programme, pre-school education, immunisation of mothers and children, health check-ups, referral services, and health and nutrition education.Scaling up through decadesNot vastly different from many other parts of the country then, in Karnataka, the programme was launched against the grim backdrop of prevalent infant mortality, malnutrition, and low literacy rates. The State, however, has been credited for taking proactive steps to scale up the programme rapidly.From one project in T. Narasipur in 1975, the number increased to 24 across 20 districts by 1980, and more than quadrupled in the next decade.While the primary focus of the programme is children below six years of age and pregnant and lactating mothers, in 1994-95, a special intervention was devised for adolescent girls using the ICDS infrastructure for the first time in Karnataka. The intervention focused on nutrition, health, educational, recreational and skill development of school-dropout girls aged between 14 to 18 years. The initiative, though, was later transformed and became targeted in nature, where the focus was only on adolescent girls in aspirational districts.Today, Karnataka has 69,922 anganwadi centres across 204 projects catering to 40,54,456 beneficiaries. This includes 33,25,035 children between the age of 6 months and 6 years, and 7,29,421 pregnant and lactating mothers.Anganwadis with functional toilets - 65,642Anganwadis with drinking water source - 64,426Karnataka has some of the best anganwadi infrastructure in the country. A significant proportion of our total number of anganwadis are in their own building with their own kitchen,

The Gambhir coaching era—caught in a spin web



For every visiting side bar none, India has loomed as the Final Frontier — as the eloquent Stave Waugh put it — for a long time. Even when they ruled the world with an iron fist, most teams with the exception of West Indies, irrepressible and unmatched, found India impossible to conquer. Nations went years, sometimes even decades, without so much as sniffing a victory on Indian soil, beaten as much in the mind before they even set foot on these shores as on the park, where India’s cricketers made the most of gremilins in the opposition camp, their own familiarity with demanding conditions and their unquestioned skills to cut a swathe through all comers.A dominance that started in the early 1990s when, under Mohammad Azharuddin and spearheaded by Anil Kumble, India brooked no stopping spilled over to the next two decades. There were occasional blips, as there are bound to be – series losses to South Africa in 2000, Australia in 2004 and England in 2012 – but they were so few and far between that when they did transpire, they registered remarkably highly on the shock scale.

England’s come-from-behind 2-1 triumph in 2012 was a wake-up call of sorts, though it must be remembered that under Alastair Cook, the visitors had a formidable all-round unit. The captain himself, Jonathan Trott, the prickly but imitable Kevin Pietersen, the classy Ian Bell and Joe Root, on his first tour with the senior side, constituted a terrific batting line-up, while James Anderson produced telling bursts of reverse swing to admirably support spin twins Graeme Swann and Monty Panesar.India themselves were in the early stages of transition, having lost Rahul Dravid and V.V.S. Laxman to Test cricket just a few months previously. Sachin Tendulkar was still around, as were Virender Sehwag and Gautam Gambhir and Mahendra Singh Dhoni, tasked with overseeing the process of taking India into the future, but Cheteshwar Pujara and Virat Kohli were still relatively new and Ravindra Jadeja made his debut only in the final Test of that series, in Rajkot.India were ripe for the taking then, and England didn’t disappoint, riding on the magnificence of Pietersen and the quality of Swann and Panesar to overturn a 0-1 deficit with style and panache. That was in December 2012; no one knew that it would take 143 months for someone else to reprise the heroics of England and humble India in their backyard.

Kiwis take wingsThat privilege went to New Zealand, unassuming and unfancied, last November. Tom Latham’s men arrived low on confidence after being beaten 2-0 in successive Tests in Galle just weeks previously. Between the Sri Lanka defeat and the first of three Tests against India in Bengaluru, there was a captaincy switch with Tom Latham replacing Tim Southee. Worse, their best batter of all time, Kane Williamson, would not be starting the series – as it panned out, he didn’t play any of the three Tests – and they had the weight of history pressing down on them.New Zealand’s last victory on India soil had come in November 1988, under John Wright, who later was to become India’s first overseas coach. Inspired by off-spinner John Bracewell’s eight-wicket match haul, they surged to a 136-run win at the Wankhede Stadium in Bombay (as it was then called). When they landed in India in October last year, ambitious as they are, they would have hoped for one victory, at the most. In the end, they landed three successive sucker punches on the trot, the last two on turners in Pune and Mumbai, even though the hosts had the services of Rohit Sharma, Virat Kohli and R. Ashwin, all now retired from the five-day game.

That was in Gambhir’s second Test series in charge – the first was a 2-0 drubbing of Bangladesh at home; now into his fourth such assignment at home alone, he has overseen a 4-4 win-loss record in our land. India have gone from invincible to vulnerable, forcing the smart alecks to tom-tom that they are a better travelling side than in their own patch, a wisecrack hard to dismiss given that they have lost as many matches in India in the last 13 months as they did in the preceding 11 and a half years.

Contrasting fortunesGambhir’s got a stellar record as white-ball coach; under his tutelage, India clinched the 50-over Champions Trophy and the T20 Asia Cup, both in Dubai, in March and September respectively, apart from giving an excellent account of themselves in bilateral skirmishes too. Despite the radical shake-ups, including an insistence on a

left-right combination at the middle at most stages of a white-ball innings, he has managed to build exponentially on the gains accrued under the Rohit-Dravid management as preparations for the defence of the T20 World Cup take firm root.But when it comes to Test cricket, India in the Gambhir era have been terribly undercooked. Their win-loss record in 18 Tests from September 2024, when the former India opener kicked off his stint in the red-ball format against Bangladesh in Chennai and Kanpur, is a modest 7-9, with two losses. Like Pujara mentioned the other day, transition can no longer be used as an excuse, not after having secured a 2-2 draw in England in the summer when India amassed 12 centuries in five Tests. As callous and dismissive as it might sound, Rohit and Kohli were hardly missed in England with Shubman Gill relishing his elevation to the captaincy with four centuries, K.L. Rahul and Yashasvi Jaiswal hitting twin hundreds at the top of the tree, Rishabh Pant weighing in with centuries in both innings in Leeds, and Ravindra Jadeja and Washington Sundar filling their boots while securing a stirring draw in Manchester.Honours secured in England, India got down to business in earnest against West Indies last month, with comprehensive victories in Ahmedabad and Delhi. The first, within three days, was on a good cricket track that helped the seamers on day one and then played like a true Indian surface, with consistent turn and bounce, aided by a red-soil base. The second had to be earned the hard way, on a placid, unresponsive deck at the Arun Jaitley Stadium that went to sleep at some stage on day three and never woke up.

India had to stretch every sinew to make inroads into the West Indian batting, the all-round quality of their bowling carrying the day. As laboured as that victory was, it suggested that India had decided to make a clean break and veer away from the Bunsen burners that singed them badly against New Zealand. After all, the temptation to torture the Caribbeans on raging turners would have been massive; by shunning that urge and sticking to the old-school mode of approach, the message was they had learnt from the Kiwi misadventure and wouldn’t go down that path again.But within four weeks of the Delhi Test came the Eden debacle against South Africa, the defending World Test Champions all right, but whose last Test win in India had come in 2010. Kolkata threw up a shocker, a pitch of such unpredictable bounce that at various stages, it bordered on the dangerous. The highest team tally in the match was 189, no one apart from Temba Bavuma made a half-century and India were shot out for 93 whilst chasing 124 in the fourth innings, none of which did any of the characters involved in this drama proud.After the 30-run debacle, Gambhir fronted up and told the media that it was ‘exactly’ the kind of track the team management had requested. Maybe he didn’t want to throw the curator under the bus because no one would have asked for a surface where the top would come off on day two, nor would any curator wilfully lay out a brown carpet fading and fraying at the edges this early in the piece. But while Gambhir might have sprung to Sujan Mukherjee’s defence — much like batting coach Sitanshu Kotak made a spirited defence of his under-fire head coach on Thursday afternoon — the underlying message was the insistence on playing on a turner in the conviction that its spin bowling, and batting against spin, continue to be India’s greatest strengths.The former proclamation might still be true but the latter most certainly not, so maybe it’s time for Gambhir to put the ‘we want turners’ line to bed and concentrate on making the most of the massive resources under his command through other means. Maybe he should take a leaf out of the book of his three immediate predecessors, Dravid, Ravi Shastri and Anil Kumble, during whose coaching tenure India hardly played on a square turner. Pune in 2017 and Indore in 2023, both against Australia, were aberrations, while the pitch didn’t have more than a fringe part to play in the losses to England in Chennai in 2021 and Hyderabad last year. India backed themselves to make big runs on true surfaces, and even if the opposition did likewise in their first innings, knew they had the depth and class in both pace and spin to craft victories.Batters’ travailsTheir record in that period is evidence enough that their belief wasn’t based on a wing and a prayer. Many of India’s batters of this vintage don’t — maybe they can’t — trust their defence enough and therefore are unwilling/unable to bat out time. A half-dozen scoreless deliveries are enough to send them into a tizzy, which means a false stroke is never far away. Use of the feet to come down the track or go deep in the crease to manoeuvre the ball have gone out of circulation, and several of the batters might be privately cursing their fate at being ‘exposed’ on tracks ranging from the tricky to the diabolical.After the second Test against South Africa from Saturday, India don’t play a WTC Test till August next year, and their next home assignment is only in January 2027. If they aspire to be in the WTC final that summer, Gambhir needs to see the writing on the wall and dispense with his fatal attraction towards spin. After all, you

US sanctions Indian entities, individuals involved in Iranian petroleum & petroleum products sales

New York/Washington: The Trump administration has sanctioned entities and individuals from India involved in sales of Iran’s petroleum and petroleum products, saying the funds from this trade support Tehran’s regional terrorist proxies and procure weapons systems that are “a direct threat” to the US.The Departments of State and Treasury sanctioned shipping networks responsible for funding the Iranian regime’s “malign activities” through illicit oil sales, as well as an airline and its affiliates that arm and supply Iran-backed terrorist groups.

Among those added to the Treasury Department’s Office of Foreign Assets Control Specially Designated Nationals List are Indian nationals Zair Husain Iqbal Husain Sayed, Zulfikar Hussain Rizvi Sayed, Maharashtra-based RN Ship Management Private Limited and Pune-based TR6 Petro India LLP. The State Department is designating 17 entities, individuals, and vessels in several countries, including, but not limited to India, Panama, and the Seychelles, involved in Iran’s petroleum and petroleum products sales, the administration said.Concurrently, the Department of the Treasury is designating 41 entities, individuals, vessels, and aircraft, intensifying its efforts against Iran’s petroleum and petrochemical exports and disrupting financial streams and commercial operatives that support Iran’s malign activities.

The funds generated by this oil trade are used to support Iran’s regional terrorist proxies and procure weapons systems that pose a direct threat to US forces and American allies, the State Department said Thursday.The administration said TR6 Petro is an India-based petroleum products trader, which between October 2024 and June 2025, imported over USD 8 million worth of Iranian-origin bitumen from multiple companies.It is being designated for know-



ingly engaging in a significant transaction for the purchase, acquisition, sale, transport, or marketing of petroleum or petroleum products from Iran, the State Department said.The Iranian regime continues to fuel conflict in the Middle East to fund its destabilising activities, the State Department said. This behaviour enables Iran to fund its nuclear escalations, support terrorist groups, and disrupt the flow of trade and freedom of navigation in waterways that are crucial to global prosperity and economic growth.The United States will continue to act against the network of maritime service providers, dark fleet operators, and petroleum products traders involved in the transport of Iranian crude oil and petroleum products, it said.The State Department said the US will continue to act in support of National Security Presidential Memorandum 2 (NSPM-2), which directs the imposition of maximum pressure on the Iranian regime to deny it access to resources needed to sustain its destabilising activities.“

Govt introduces N-power bill in Parliament, permits private participation, limits supplier liability



The government on Monday introduced a new Bill in the Lok Sabha called the Sustainable Harnessing and Advancement of Nuclear Energy for Transforming India (SHANTI) Bill, 2025, which will allow private participation in India's highly restricted nuclear power sector. The new Bill will replace the existing Atomic Energy Act, 1962 and the Civil Liability for Nuclear Damage Act, 2010.

The government said the new Bill is a key step towards achieving India's target of 100 gigawatts of nuclear power capacity by 2047, as it seeks to "harness the full potential of India's nuclear energy and indigenous resources through active involvement of both the public and private sectors." accelerated growth of Artificial Intelligence, high-performance computing, quantum technologies, indigenous semiconductor fabrication and large-scale data-driven research requires stable, reliable, abundant, clean and round-the-clock power supply, which can be ensured through expanded deployment of nuclear energy and necessitating a new legal framework promoting research and innovation in private-sector," the short title of the Bill read. A key change in the new Bill is removal of an earlier provision under 'right of recourse' which had allowed nuclear plant operators to seek compensation from suppliers in the event of a nuclear accident caused by defective equipment, sub-standard services or acts of suppliers or their employees. This provision was repeatedly flagged by foreign nuclear equipment vendors as a deterrent to investing in India's nuclear sector as it exposes them to long-term and uncertain liability risks in the event of a nuclear accident. Under the new Bill, both public and private companies, as well as their joint ventures, will be allowed to set up nuclear power plants, trans-

portation or storage of nuclear fuel, and import or export nuclear fuel, technology, equipment and minerals required for nuclear power generation. However, all entities involved in nuclear energy production will be required to obtain safety authorisation from the Atomic Energy Regulatory Board. The Bill makes "safety authorisation" mandatory for the manufacture, possession, use, transport, import, export or disposal of radioactive substances and radiation-generating equipment, as well as for establishing, operating or decommissioning radiation facilities.

Meanwhile, the Bill retains certain exclusive Central government control over critical and sensitive activities. These include enrichment and isotopic separation of radioactive substances, management and reprocessing of spent fuel and high-level radioactive waste, production and upgradation of heavy water, among others. The Bill also provides for the creation of new institutional arrangements, including an Atomic Energy Redressal Advisory Council, designation of Claims Commissioners, and a Nuclear Damage Claims Commission for cases involving severe nuclear damage, with the Appellate Tribunal for Electricity acting as the appellate authority. Further, it empowers the Central government to establish a Nuclear Liability Fund for the purpose of meeting its liability in case of a nuclear incident. On the liability front, the Bill specifies graded liability caps for nuclear power operators based on their size of installation. Operators of reactors with thermal power above 3,600 MWe will have a liability limit of Rs 3,000 crore. Reactors with thermal power above 1,500 MWe and up to 3,600 MWe will carry a cap of Rs 1,500 crore, while those above 750 MWe and up to 1,500 MWe will be liable up to Rs 750 crore. For reactors above 150 MWe and up to 750 MWe range, the liability limit is set at Rs 300 crore. Smaller reactors with thermal power up to 150 MWe, fuel cycle facilities other than spent fuel reprocessing plants, and transportation of nuclear materials will have a liability cap of Rs 100 crore. India enacted The Atomic Energy Act, 1962 after repealing the Atomic Energy Act, 1948. Since then, the Act has been amended four times, with the latest amendment being in 2015. However, the sector was confined to the Central government. In 2010, the Civil Liability for Nuclear Damage Act, 2010 was enacted to provide for civil liability for nuclear damage and prompt compensation to the victims of a nuclear incident through a no-fault liability regime.

New GDP series to eliminate 'discrepancies' component; full back series by Feb 2027

India's statistics ministry, as part of the ongoing revision of the GDP data series, plans to do away with the contentious 'discrepancies' component that has, over the years, puzzled economists. In the second discussion paper on the methodological improvements in the compilation of GDP, released on Tuesday, the Ministry of Statistics and Programme Implementation (MoSPI) also said it plans to publish the GDP 'back series' with the new base year by February 2027.

"On launch of the new series of GDP estimates with the Base Year: 2022-23 on 27.02.2026 (February 27, 2026), it is planned to publish the back series of GDP estimates on the revised base year within one year," the MoSPI discussion paper said. The ministry has invited comments on the paper by January 7, 2026.

The statistics ministry calculates GDP using two methods – production or income approach and the expenditure approach. But due to different sources of data used for the two approaches and variations in coverage, valuation, and lags in recording of data, the final GDP numbers arrived at through the two approaches may not match. As such, the difference is shown as 'discrepancies' under the expenditure approach along with Government Final Consumption Expenditure, Private Final Consumption Expenditure, Gross Fixed Capital Formation, change in stock, valuables, and net exports. This is because the expenditure-side GDP is seen as being less accurate than its production -side counterpart. "The alternative is to remove the discrepancy by examining the data in the light of the many accounting constraints in the SNA (System of National Accounts), making the best judgement possible about where the errors are likely to have arisen and modifying the data accordingly," MoSPI's discussion paper said. When 'discrepancies' are positive, it means that the GDP calculated through the production approach – by adding the value added of the various sectors, such as manufacturing, services, and agriculture – is greater than the GDP arrived at by adding together the different types of expenditures. Similarly, when 'discrepancies' are negative, the expenditure-side GDP is more than that computed from the production side.

GDP. However, in nominal terms – or without adjusting for inflation – the 'discrepancies' figure was a negative Rs 2.46 lakh crore, or -2.9 per cent of GDP. "It's very good if discrepancies are done away with," said Kunal Kundu, India Economist at French investment bank Societe Generale. "Ideally, discrepancies should come down over time, from one revised estimate to the next. However, we have seen in the past that sometimes this figure has increased in magnitude. This makes it very difficult to understand what has been driving GDP growth." As part of the new GDP series – the first number under which will be released on February 27, 2026 for the October-December quarter – MoSPI plans to integrate the so-called supply and use tables with the compilation of annual accounts "to ensure that discrepancies are limited in the early estimates and finally eliminated when full set of data becomes available at the time of final estimates". Supply and use tables show how different goods and services are supplied by domestic industries and imports and how they are distributed between different intermediate or final uses, including exports. In this accounting framework, the total supply and use of each type of good and service must be balanced. Large 'discrepancies' – the July-September figure of 3.3 per cent of GDP in constant prices was the largest on an absolute basis since April-June 2022 – can also lead to significant revisions in GDP growth rates in the future. There have also been sizable swings in 'discrepancies' in recent years, especially after the coronavirus pandemic. For instance, in January-March 2023, 'discrepancies' stood at (-)3 per cent of GDP. However, this changed to a positive 3.3 per cent of GDP in the subsequent quarter, April-June 2023. "While the elimination of discrepancies would be a good move, it is just one aspect; we need to be mindful of how difficult it is to calculate GDP. The current series has been hampered by several issues, including the use of survey data from more than a decade ago," Kundu of Societe Generale added.

Global trade getting weaponised through tariffs: Sitharaman

New Delhi: Finance Minister Nirmala Sitharaman on Wednesday said global trade is increasingly "getting weaponised" through tariffs and other measures, and India will have to negotiate its way carefully. She said that the overall strength of the economy will give the country an added advantage. "Trade is getting weaponised through tariff, through many other measures and India will have to negotiate its way carefully in this, and not just take care of tariff but I think overall our economy strength is what is going to give us that additional advantage," Sitharaman said at Times Network's India Economic Conclave 2025. She said that globally it is now "very clear" that trade is not free and fair.

"India can be lectured saying you (India) are very inward-looking, you are a tariff king and so on. But tariff has been weaponized," she said adding India's intention was never to weaponise tariffs. India, she said, only safeguarded its domestic industries against flooding which happens from a "predator".

But the weaponisation of trade today is without criticism, the minister said, adding that some nations state that tariffs are not good and no one should take these measures



but "suddenly we have newer people coming up saying we'll come up with tariff barriers and there's no questioning. So that seems to be the new normal". These remarks are important as global trade has been disruptive due to the high tariffs imposed by the US. Mexico too has recently announced to impose high tariffs in countries with which they do not have free trade agreements.

'24 ghante kaam karke faayedda kya hai': Anil Kapoor on importance of taking breaks from work



All work and no play makes Jack a dull boy, and Anil Kapoor agrees. The Mr. India actor once said that a large number of people are obsessed with always working and hardly ever take a break. "24 ghante kaam karke fayda kya hai. Hum log bhool gaye chill karna," (what's the point of working 24x7? We have forgotten how to chill), said Kapoor, adding that non-stop grind is consuming us. Citing an example of established personalities, the actor added: "Bade bade log bahut successful hue hain. Humse zyada achieve kiya. Hazar guna zyada achieve kiya. Jo kam bhi karte hain successful bhi hote hain, wo chill bhi karte hain relax bhi karte hain, holiday pe bhi jate hain." (Many people are successful who have achieved thousands of times more than we have. Such people also relax and go on holidays.)

Anil Kapoor believes that this inability to take a break from the grind is because we have made financial issues our entire personality: "Gareebi humari fitrat me hai... Humari rag-rag mein hai insecurity aur gareebi". (Poverty runs in our veins and has become a part of our nature) Taking a cue from Anil Kapoor's confession in an interview with Republic World, we reached out to Mehezabin Dordi, a Clinical Psychologist at Sir HN Reliance Foundation Hospital, Mumbai, to understand how this 24/7 hustle culture affects people's mental, psychological, and emotional health. anil kapoor Adding on to Kapoor's opinion, psychologists say that the human mind and body aren't built to be 'on' all the time (Photo: Instagram/Anil Kapoor) How dangerous is the 24/7 hustle culture

"In today's hustle culture, we've started wearing exhaustion like a badge of honour," says Dordi, who further points out that being "busy" has become a measure of worth. However, the human mind and body, as the psychologist rightly points out, aren't built to be on all the time. When we forget how to pause, it starts taking a quiet toll. "Mentally, our attention span shrinks, our creativity dulls, and everything starts to feel like a chore. Psychologically, we move into survival mode; we are always alert, always chasing, rarely resting. The brain begins to interpret even small tasks as threats, which leads to irritability, anxiety, and emotional fatigue. Emotionally, the joy starts fading from things we used to love."

The psychologist tells indianexpress.com that people often describe it as "feeling flat" not sad necessarily, just disconnected. "That's the early sign of burnout. Over time, this chronic overdrive affects sleep, mood, even physical health, headaches, blood pressure, digestive issues, you

Doctor reveals essential item you must wear when travelling on flights

If you've ever felt your legs getting heavy or noticed swelling in your feet after a long flight, you're not alone. Sitting still for hours on a plane can mess with your circulation. That's where compression socks come in—they're not just for medical use anymore. More and more travellers are slipping them on to stay comfortable and avoid health issues. Dr Narander Singla, Lead Consultant – Internal Medicine at CK Birla Hospital, Delhi, explains it clearly: "Wearing compression socks during flights, especially long-haul journeys, can be highly beneficial for certain travellers." These special socks are made to gently squeeze your legs, helping your blood flow better and keeping your legs from feeling tired or swollen.

Why are compression socks good during flights?

One big reason to wear compression socks on flights is to lower the risk of Deep Vein Thrombosis (DVT)—a condition where blood clots form in deep veins, usually in the legs, because of sitting too long. As Dr Singla puts it, "Compression socks help maintain proper blood flow, significantly lowering this risk." But that's not all. They also reduce swelling and keep your legs feeling lighter. "They also help prevent leg and foot swelling by limiting fluid accumulation," Dr Singla explains. "Additionally, compression socks can alleviate discomfort, reduce leg fatigue, and contribute to a more pleasant travel experience." Who should use them?

While many people can benefit from compression socks, some might need them more than others.

"This includes people at higher risk of DVT, such as those with a history of blood clots, recent surgery, cancer treatments, or who are taking estrogen," says Dr Singla. "Older adults and pregnant women may also benefit, as they often experience circulatory issues or discomfort during flights." If you have poor blood flow or certain medical conditions, it's best to talk to a doctor first. "Individuals with severe arterial disease or poor circulation should

name it." Sadly, the effect spills onto the person's relationships as well. "When we're constantly preoccupied, we stop being emotionally available to the people we care about. Breaks and holidays aren't indulgences; they're essential resets that protect our mental health, creativity, and ability to connect with others."

How does the 'gareebi ki fitrat' settle in?

Just like Kapoor said, a person's financial background, and how they grew up around money, plays a very crucial role in determining their ability to take a break. "If you've grown up in a home where every rupee had to be stretched, the idea of 'taking time off' can feel unsafe or even irresponsible. There's often a subconscious voice saying, 'If I stop working, something bad will happen.' That fear doesn't magically disappear even when you're financially stable later in life," notes Dordi. This is described as "scarcity mindset, a deep-seated habit of focusing on what could go wrong, rather than what could go right. "Many people who've faced early financial struggles also tie their self-worth to productivity as if constant working equals safety or value. So even planning a small vacation can bring guilt, anxiety, or shame." The psychologist asserts that sometimes it's not just about money but also about emotions. "People may feel guilty for spending on themselves when family members are still struggling, or they might downplay self-care as 'luxury.' The truth is, rest doesn't make you ungrateful or lazy. It's a way of protecting the life you've worked so hard to build."

Any advice for people who find it challenging to take a break from work?

"For many of us, slowing down feels uncomfortable, even scary, because our minds are wired to equate movement with progress. But rest is not the opposite of productivity; it's part of it," explains Dordi, recommending following gentle, practical ways to begin: 1. Start small You don't have to disappear for a week. Begin with short "micro-breaks" during your day, 10 minutes to stretch, walk, or step away from screens. Research shows even tiny breaks improve focus and prevent emotional exhaustion. 2. Create a shutdown ritual At the end of your workday, do something symbolic: close your laptop, put your phone away, or take a short walk. Your brain needs cues that say, "The workday is done." 3. Experiment with rest If guilt or anxiety creeps in, think of rest as an experiment, not a luxury. Try a half-day off and observe how you feel emotionally, physically, and mentally. Most people come back clearer and calmer.

4. Reframe your beliefs When that inner critic says, "I don't deserve to rest," challenge it. Ask yourself: Would I say this to someone I care about? Rest doesn't make you less committed; it makes you more sustainable. 5. Plan recovery, not escape A break doesn't always have to mean travel or spending big. It can be a staycation, a digital detox weekend, or a slow morning at home. The goal is to detach from the grind mentally. 6. Address deeper roots If the idea of taking time off feels unsafe or triggers anxiety, it may help to explore it with a therapist. Sometimes, the issue isn't about time; it's about old fears around safety, identity, or control.



consult a healthcare provider before using them, as they could potentially worsen these conditions," warns Dr Singla. Also, people with sensitive skin or existing skin problems should be careful—they might find the socks irritating.

Picking the right pair Not all compression socks are the same. The level of pressure matters, and so does how well they fit. "Moderate compression (15–20 mmHg) is sufficient," Dr Singla recommends for most flyers. You want them to be snug, not tight or uncomfortable. Make sure to follow sizing instructions carefully. "Knee-high socks are generally recommended, as thigh-high socks can roll down and create a harmful tourniquet effect," he adds. If you fly often or lead an active lifestyle, using compression socks regularly might help your legs feel less tired and reduce swelling. "Athletes may also find relief from muscle soreness and experience faster recovery when using them consistently," says Dr Singla. To get the most out of compression socks on a flight, it's also a good idea to stay hydrated and get up every couple of hours to stretch or walk. Small leg movements, like ankle rolls or calf raises, can help too. "Proper hydration helps prevent blood from thickening," says Dr Singla. "And movement is key to encouraging blood flow." So next time you pack your travel essentials, consider adding a pair of compression socks. They might make your journey a lot more comfortable and safer, too.

'People are most unsettled and unhinged in marriages...': Nimrat Kaur on choosing to remain single at 40+, psychologist weighs in

Being single in their 40s is a choice that many people still struggle to understand, especially women. Why being at home feels like a vacation to D Gukesh, R Praggnanandhaa and Arjun Erigaisi

In a recent clip uploaded on its social media handles, FIDE asked some of the top chess players in the world a simple question: if they could pick one vacation spot for the rest of their lives, what would it be? Amidst the understandable replies like Greece, Bali, Havana, Switzerland, San Sebastian, Maldives and the Caribbean islands, the response from a trio of top Indian stars – D Gukesh, R Praggnanandhaa and Vaishali Rameshbabu – stands out. It's not a lack of imagination on the part of the Indians, nor are they reluctant travellers. On the contrary, so cramped are the jet-setting lives of India's top chess players that being at home for them has begun to feel like a luxury. "Nowadays going home feels like a vacation," world champion Gukesh told FIDE in the interview with a smile.

In just a three-month phase between August to October this year, Gukesh has flown from Spain (Granada Chess Open) to Poland (for an exhibition event against Jan Krystof Duda in Katowice) to the USA (for St Louis Rapid and Blitz in Missouri and then the Sinquefeld Cup) to Uzbekistan (for FIDE Grand Swiss), to USA again (for Checkmate: USA vs India exhibition event in Arlington, Texas) to Greece (for the European Club Cup in Rhodes) to the US (for Clutch Chess: Champions Showdown event in St Louis) before playing in the FIDE World Cup in Goa. After a short break, he's in Mumbai playing at the Global Chess League (GCL) before he flies off to Qatar for the World Rapid and Blitz Championship, then returning to India to play at Kolkata's Tata Steel Chess India Rapid and Blitz, where each day players play multiple games just like in every other rapid and blitz tournament. (The Global Chess League, in contrast, is just one game a day, occasionally two, which gives players plenty of breathing space.) The year has also seen Gukesh make trips to the Netherlands for the Tata Steel Masters, Germany and France for Freestyle events, Romania for the Superbet Chess Classic, Norway for Norway Chess, and Croatia for the SuperUnited Rapid and Blitz.

India's other top players like Praggnanandhaa and Arjun Erigaisi are also racking up air miles as rapidly as Gukesh due to packed tournament calendars. Pragg, for example, played in events at a breakneck pace through the year as he was chasing a Candidates spot through the FIDE Circuit route. That took him to Wijk aan Zee, Prague, Paris,

Warsaw, Bucharest, Jermuk (Armenia), Tashkent, Zagreb, Las Vegas, Saint Louis, Samarkand (Uzbekistan), Sao Paulo and London. And then there were the World Cup and GCL for which he came to India. This calendar means that between late August and early October, the youngster played on three separate continents. Right after his exit from the World Cup last month, he was on a flight to play in the London Classic before coming to Mumbai and will play in the World Rapid and Blitz, Tata Steel Kolkata and Tata Steel Wijk aan Zee before competing at the Candidates tournament in Cyprus in March-April. "I've hardly been home this year. At the most, I get two weeks at home. To me, that's not really a break, because by the time you feel relaxed, another tournament is there and you have to start playing. I would like a much longer break," Pragg says.

"Even after winning the UzChess Cup in Tashkent (on June 28), I had to leave immediately. I'd played for seven hours on the final day, because it was a morning round. I played a classical game, then had to fight it out in the tie-breaks, then there was a closing ceremony. By the time I got to the room, I was dead. But I still had to pack immediately to fly out. But all this is part of what we do," he shrugs. His good friend Erigaisi would agree. After his defeat to Wei Yi in the quarters of the FIDE World Cup, he gave himself a break of 10 days at home before flying off to Jerusalem for a tournament and then to South Africa for the Freestyle Chess season finale. That done, he's flown to Mumbai to play in the GCL. Afterwards, just like Gukesh, Arjun and Pragg, he will be on a flight to Qatar for the World Rapid and Blitz, then off to Kolkata for the Tata Steel Chess tournament. "After the Jerusalem tournament ended, I had to fly the same night because there were some Freestyle Chess activities from the next day itself in South Africa," Erigaisi says, describing a 13-hour journey, involving a flight from Tel Aviv to Addis Ababa and from there to South Africa. After the Freestyle event, Erigaisi was on a flight to Mumbai the next day itself to play in the GCL. "But that flight had many chess players," he smiles.

Ask him how many days on average he plays in tournaments, and Erigaisi estimates just over half of the year. And that, he points out, is a lower workload from the phase between June 2021 and June 2022 when he was playing in tournaments for about 200 days. Ask him if there are ideas like 'workload management' in chess, just like in other sports, and he shrugs: "At least now that I'm still young, fatigue hasn't happened. It's also why we all realise that fitness is one of the important goals for us. It's one of the reasons why Magnus Carlsen is still so good at 35 and Vishy sir is doing so well at 56." Gukesh too shrugs off any talk of mental fatigue. When asked by FIDE at the World Cup why he had chosen to play in an exhibition event in the USA, that too in rapid and blitz, just before he had to play in a classical World Cup on the other side of the world, with issues like jet lag to contend with, he replied: "I was telling myself, if I don't push myself at this age, when am I going to push myself?"

Tilak Varma jumps to fourth in ICC T20I rankings as Varun Chakravarthy stays on top

Hyderabad: India's hard-hitting batter Tilak Varma has surged up two places to fourth in the ICC Men's T-20I Player Rankings even as spinner Varun Chakravarthy has consolidated his position at the top of the bowling rankings. Varma followed up his score of 26 in the opening match against South Africa in Cuttack with 62 in New Chandigarh and 26 not out in Dharamsala this past week to overtake Pakistan's Sahibzada Farhan and England's Jos Buttler in the list led by India's Abhishek Sharma. Varma's

best ranking is the second position that he reached in January this year. South Africa captain Aiden Markram's knock of 61 in a score of only 117 in the third match has taken him eight places up to 29th while Quinton de Kock's match-winning 90 in the second T20I has lifted him 14 places to 53rd position. The T20I bowling rankings see Chakravarthy, who bagged two wickets each in the two T20Is played this past week, adding 36 rating points to his tally, which has gone up to a career-best 818 points.

Seamers from both sides have moved up the charts. India's left-arm Arshdeep Singh, who was named Player of the Match for his haul of two for 13 in Dharamsala, is up four places to 16th while South Africa pacers Marco Jansen (up 14 places to 25th) and Lungi Ngidi (up 11 places to 44th) have also progressed. In the ICC Men's Test Player Rankings, Devon Conway's scores of 60 and 28 in Wellington helped his team to a nine-wicket win in the second match of their ICC World Test Championship series against the West Indies and lifted him seven places to 34th position among batters. Mitchell Hay made a fine debut, top-scoring with 61 as he started his Test career in joint-78th position while Jacob Duffy took five second-innings wickets for just 38 runs to move up 15 places to a career-best 48th position among bowlers.

'Dizzy, nausea': Why Steve Smith made a shock withdrawal on morning of Adelaide Test against England

Steve Smith withdrew from the third Test of the Ashes series against England on the morning of the opening day's play. Cricket Australia has confirmed Smith had been suffering from "nausea and dizziness" in the lead-up to his shock withdrawal from the Adelaide Test. The late withdrawal allowed Usman Khawaja a rare opportunity to play in the series, which he has grabbed with both hands, leading Australia on a tricky day's play thus far. Khawaja had started slowly and had reached 5 from 27 balls when Harry Brook dropped a regulation catch at second slip. From that moment on, Khawaja changed his intent, and started to hit more shots. Smith had even done his warm-ups at the Adelaide Oval, but had to leave the stadium after a chat with the coach Andrew McDonald. Smith had led Australia in the first two Tests, but luckily, for them, Pat Cummins had come back for this game to take over the leadership role.

Smith has been feeling unwell in the last few days. "Over the past few days he has been feeling unwell, with symptoms including nausea and dizziness," a Cricket Australia statement said. "He was assessed and monitored closely and was close to being available to play. However, given the persistence of symptoms, a decision was made not to proceed." He is being treated for a potential vestibular issue. This is something Steve has experienced intermittently in the past and is being managed accordingly. He is expected to be available for the Boxing Day Test in Melbourne.

Cummins shared his relief that Usman Khawaja was ready to take over at such a short notice. "Steve is feeling a little bit unwell the last couple of days," captain Pat Cummins said. He came and gave it a crack this morning but didn't think he was going to get up for this one so he's headed off home. But we're pretty lucky we have got someone like

Usman who can step right in. "Smith's loss is a huge blow as Stuart Broad had spoken him as the thorn in England's flesh. "To win the series, we have to keep him (Smith's average) to under 50, don't we?" Broad said on the 'For the Love of Cricket' podcast, which he co-hosts alongside Jos Buttler. "He's gonna score a hundred, it's what he does. (If) he averages 40, that's at least 15 under his career average, so you're doing brilliantly. I think you have to get him early," he added. "If England aren't celebrating in his first 40 runs, it's going to be a long series." Obviously his technique has changed throughout, but I still can't sit here and go 'well this is how you get him out'. That's an unbelievable strength of his. He's incredibly difficult to bowl at. How much will cheapest Football World Cup tickets cost? After global fan backlash, FIFA reduces costs of some tickets

FIFA, the global governing body for football, was forced to reduce the price of a handful of tickets for each game at next year's FIFA World Cup after global backlash from fans. The good news for fans is that the cheapest tickets for the FIFA World Cup will now be \$60. However, the bad news is that the number of \$60 tickets for each game at the World Cup in North America is likely to be from 400 to 750 per team, that too given to national federations whose teams are playing that game.

Fans from nations whose teams are not playing at the World Cup cannot get their hands on the cheap tickets since the handful of tickets will be distributed by the football associations of the 48 countries taking part in the tournament. FIFA said it was bringing in the new tickets under a "Supporter Entry Tier" price category. This means that some fans will be able to see FIFA World Cup final at a price of just \$60 (approximately Rs 5400) rather than the earlier anticipated

\$4,185. The World Cup in North America will be the first edition that features 48 teams — up from 32 — and is expected to earn FIFA at least \$10 billion in revenue while being the most expensive ever for fans. FIFA claims it has already received more than 20 million ticket requests in its latest sales phase.

FIFA's initial ticketing plans gave participating teams no tickets in the lowest-priced category. The standard allocation is 8 per cent of stadium capacity per team. This led to furore among fan groups. The cheapest prices ranged from \$140 to \$265 for group-stage games that did not involve co-hosts the United States, Canada and Mexico. The \$265 games involve Lionel Messi's Argentina, Portugal with Cristiano Ronaldo and well-supported teams like Brazil and England. This move is a rare climbdown by FIFA and its president Gianni Infantino. There has been a global outcry by fans from the time the ticket prices were announced. Infantino has also been criticized for his political alignment with Donald Trump after he gave the U.S. President a peace prize. The World Cup will have 16 host cities, and will be held in 11 NFL stadiums in the United States, plus two in Canada and three in Mexico. While FIFA has not outlined why it was changing its policy and introducing the cheap tickets, it did state that the lower prices are "designed to further support traveling fans following their national teams across the tournament." According to a report in the Associated Press, Football Supporters Europe group, which represents grassroots fan groups, said the limited price cut was "an appeasement tactic due to the global negative backlash." "This shows that FIFA's ticketing policy is not set in stone, was decided in a rush, and without proper consultation," the group said in a statement.

Why CSK spent heavily on youth and KKR on overseas performers

To put the IPL mini-auction in a nutshell, it was an afternoon where Kolkata Knight Riders and Chennai Super Kings, entering the table with a purse of Rs 64.30 crore and Rs 43.40 crore respectively, shook the room in Abu Dhabi. Among the top six buys on Tuesday evening, five came from their table. The prices told a story in itself. Top eight buys were Cameron Green (KKR, Rs 25.30 crore), Matheesha Pathirana (KKR, Rs 18 Cr), Kartik Sharma (CSK Rs 14.20 Cr), Prashant Veer (CSK Rs 14.20), Liam Livingstone (SRH, Rs 13 Cr), Mustafizur Rahman (KKR, Rs 9.20 Cr), Josh Inglis (LSG, 8.60 Cr), and Auqib Nabi (DC, Rs 8.40 Cr). A mix of overseas players, who are far from proven consistent performers and uncapped Indians who are unknown commodity but franchises willing to take a gigantic leap of faith.

With the demand and supply mismatch being evident, Australia's Green broke the record for costliest overseas player, with KKR buying him for Rs 25.30 crore. Chennai, which has been a franchise that always banked on experience and proven names, chose a paradigm shift, investing in uncapped Indian players, headlined by 19-year-old Kartik and 20-year-old Prashant. At Rs 14.20 crore each, they are the most expensive uncapped players in IPL history. While all eyes were on KKR and CSK, the rest of the franchises, which came with the purpose of filling the holes, would now head back a happy bunch. The next IPL can't come any sooner.

The 64.50 crore in Kolkata made a huge difference for them. For a franchise that splurged Rs 24.75 crore for Mitchell Starc and Rs 23.75 crore on Venkatesh Iyer in the last two auctions, they once again went all out in pursuit of Green, who was lined up as a replacement for Andre Russell. It is a franchise that doesn't hesitate to spend a majority of its purse on starters and the trend continued. They didn't stop there, with their death bowling resources being weak, and an area to address, they set their eyes on Pathirana. Despite being injury-prone and struggling for form, KKR believe reuniting him with their mentor Dwayne Bravo could give him a fresh start. That Delhi, Lucknow Super Giants were also in the race for a bowler still finding his feat said how franchises were desperate to have a pacer with X-factor even keeping the cons in mind. At Rs 15.20 crore, the price did come as a surprise, but KKR did seem to have a back-up plan in place. For Plan B, they have the Bangladeshi seamer Mustafizur Rahman, who generated interest from CSK before they landed him for Rs 9.20 crore. Once the trio were in, they managed to fill their holes with Finn Allen, Rachin Ravindra, Tim Seifert and Rahul Tripathi at their base price.

Father earned Rs 12,000 as teacher; son Prashant Veer hopes to be perfect MS Dhoni student, picked for Rs 14.2 crore by CSK

A son of 'Shiksha Mitir' (Primary Teacher) who earned around Rs 12,000 per month, 20-year-old Prashant Veer was picked for Rs 14.20 crore by Chennai Super Kings (CSK) in Indian Premier League's mini-auction on Tuesday. Veer wasn't expecting too much, and like any uncapped player, he hoped someone in the auction room would merely raise the paddle for him. "I was just hoping that someone would raise their paddle, it took me some time to process that I have gone to CSK for 14 crores. Sapna lag raha tha sab, I told Rinku (Singh) bhai ke pinch karo ek baar. My family has not seen so much money in their life, this will change things for good. What I will do with the money, yeh sochney ka kaam gharwalon ka hai, mera nahi," he told The Indian Express. (It felt like a dream to be picked by CSK. I told Rinku to pinch me. My family will decide what to do with the money. God heard my prayers.)

Divine intervention or not, CSK needed to fill the gap left by Ravindra Jadeja, and Veer, a left handed batsman and left arm spinner, was almost a like for like replacement, as the franchise looks to rejuvenate its squad. "I always wanted to play for CSK especially under MS Dhoni. He too bats lower down the order like me, I had wished that whenever auction happens, I should go to CSK. Bhagwan ne lagta hai sun liya," Prashant added.

He didn't take the traditional route of travelling to Lucknow or Kanpur. Instead, seven years ago, he decided to travel to Saharanpur to play his cricket. His childhood coach Rajiv Goyal recalls



ing assembled a trial session way earlier than the rest of the franchises, in September, they chose to press the reset button in their approach with their eyes firmly on uncapped domestic talent. The signs had come midway through last season when they invested in youth. This auction, they went further. After going for Green, they stopped pursuing Ravi Bishnoi when the bid touched Rs 6 crore. Once the uncapped players came up, they didn't keep the paddle down until they landed both their top targets, Veer and Kartik. An Indian spinner missing, Rahul Chahar was bought for Rs 5.20 crore before the likes of Akeal Hoseni, Matthew Short, Matt Henry, Sarfaraz Khan, Zakary Foulkes and Aman Khan were grabbed at base price. "As the game has evolved, we might have been a little bit slow to evolve with it," CSK head coach Stephen Fleming admitted. "Sometimes you can hang on to theories and philosophies because of past success but we identified that we needed to shift and partly the work that we did last season halfway through has enabled us to continue that work done," he explained their new strategy. KKR and CSK going hard on their targets meant that the rest were able to land their targets with minimum fuss. Delhi Capitals, for instance, got Ben Duckett and David Miller, both at base price. Lucknow got lucky with Anrich Nortje and Wanindu Hasaranga, but their winning bid for Inglis, who could miss majority of the season, for Rs 8.60 Cr raised eyebrows. Defending champions Royal Challengers Bengaluru, having missed Venkatesh Iyer, bought him for Rs 7 Cr alongside left-arm uncapped pacer Mangesh Yadav from Madhya Pradesh. Rajasthan Royals added Ravi Bishnoi for Rs 7.20 crore, while Sunrisers Hyderabad threw a surprise by landing Livingstone for Rs 13 crore. Punjab Kings needed back-ups and got it in the form of Ben Dwarshuis and Cooper Connolly. Even Mumbai Indians, which entered the auction with just Rs 2.75 crore, got Quinton de Kock and four uncapped players. It was a rare evening in Abu Dhabi, where all 10 franchises arrived with plans, executed them and returned all smiles.

how his student Rakshit Garg called him to inform that one boy was willing to come here and play cricket in Saharanpur.

"He must have been 15 years old, Prashant and Garg were in the same hostel in Mainpuri but cricket wasn't as competitive as he expected there," Goyal recalls. Garg asked Prashant to compare their hostel coaching. "Both landed in my academy. The way he was timing the ball, you can see there was something different in him. I took him to my old house where other players used to stay. Since then he's trained there," Goyal recalled. Cricket threw another challenge at him financially. Prashant's late grandfather Suryakumar Tripathi was taking care of Prashant's cricketing dream with his pension. His father was earning a mere 8,000 rupees from teaching then. "When his grandfather died, he said, sir ab mera cricket khatam. I told him you play here, I will manage whatever I can. And then we took help of Akram Saifi, who is chairman of Saharanpur District Cricket Association, he took care of him later on," Goyal said.

Despite clearing all selection trials, Prashant didn't see his name in Uttar Pradesh's Under 16 squad. He was desperate but his coach was clear that he needs to work harder. Prashant urged Goyal to try get him to play in Chandigarh. He got admission in a college in Jalandhar and continued to play junior cricket. Akshaye Khanna made his debut with the 1997 film Himalay Putra, produced by his father Vinod Khanna. While the film did not perform well at the box office, it brought him recognition. Since then, the actor has remained highly selective, sometimes staying away from films for years. Including Dhurandhar, Akshaye has appeared in just 48 films over nearly three decades. Speaking about his selective career choices, he once told Mid-Day, "For me, not working is the hardest part of being an actor. It is depression time. I'm the opposite of someone who looks forward to six months off. But destiny played its cards—I ended up taking forced breaks, not by choice. It's very hard when you aren't getting material you connect with." While it remains unclear whether Akshaye Khanna's character Rehman Dakait will return in Dhurandhar Part 2—scheduled for release on March 19—given that the character was killed in the first film, the actor is next set to appear in the Telugu film Mahakali, followed by Drishyam 3.

‘Akshaye Khanna is baap’: Mukesh Chhabra reveals actor said yes to Dhurandhar immediately, calls him a man of his word



The release of Aditya Dhar's actioner Dhurandhar has set the internet abuzz, drawing widespread attention to the sheer brilliance of Akshaye Khanna, who plays the crime kingpin Rehman Dakait in the film. Across social media platforms, one can find reels praising his electrifying dance to the song FA9LA, while timelines are flooded with tweets applauding the intensity he brings to the role. Renowned casting director Mukesh Chhabra, in an exclusive conversation with SCREEN, opened up about how Akshaye Khanna was cast in the film. Praising the actor, Chhabra said,

"He is baap! Now he has literally taken over the internet. The social media belongs to Akshaye Khanna since the time the film has released. Wherever you go, be it Facebook, Instagram, X, all you see is him on your

timeline. People are only talking about his entry and the way he has performed overall. And he had no idea it would become so big, because he is just too focused as a guy on his work." Talking further about the casting process, Chhabra revealed how it all came together. "We jotted down lots of names for his role and then we went about shortlisting, where we zeroed in on his name. Then he came for the narration, and he came alone, that was the beautiful part. And after it ended, he looked at me and I looked at him and he said, 'Loved it, maza aa gaya yaar' (I loved it, I really enjoyed it, man)." He added, "Aaj main padh leta hoon raat mein jaakar phi" (I'll read it tonight and get back to you). And he is not one of those guys who says 'aaj padh leta hoon' (I'll read it today) and then ghosts you. He is a man of his word. That's the best part about him, that he takes every single decision on his own." Another casting choice that has been drawing significant attention is Rakesh Bedi, who plays the politician Jameel Jamali in the film. Speaking about Rakesh Bedi's casting, Chhabra said, "Almost every producer, director, or actor I know is taking his number from me and congratulating him. Some are even planning to cast him, and I'm so happy for him. I think he completely reinvented himself in this film, especially in the way he performed. He actually added his own humor to the character; it was never in the script." He further explained, "I think he spoke to Aditya and said, 'I want to add another layer to this.' He's a great actor, when actors improvise, they always come up with new ideas. And Aditya is extremely collaborative. There's no barrier with him; you can communicate freely and really speak your heart out." Recalling his first conversation with Rakesh Bedi, Chhabra shared, "When I called Rakesh ji, I just told him, 'It's a very interesting character, you haven't done anything like this, please do it.' And he immediately responded, 'Beta, main trust karta hoon tujhe, let's do it' (Son, I trust you, let's do it)."

Agastya Nanda's Ikkis pushed to Jan 1 to dodge Dhurandhar wave, avoid clash with Avatar Fire and Ash

The makers of Ikkis have postponed the release of the Agastya Nanda-starrer. The film was earlier slated to hit theatres on December 25. However, amid the unstoppable box office wave of Dhurandhar, which shows no signs of slowing down, the makers have shifted Ikkis' release date to January 1, 2026.

Trade analyst Taran Adarsh shared the update on social media and pointed out how producer Dinesh Vijan and his banner Maddock Films have previously benefited from strategic release-date shifts. He noted that Maddock had moved earlier films like Hindi Medium and Chhaava to avoid clashes with big-ticket releases such as Baahubali 2 and Pushpa 2, decisions that ultimately proved profitable. He wrote, "DINESH VIJAN'S WISE MOVE – 'IKKIS' SHIFTS TO 1 JAN 2026... ?? 2017: #HindiMedium smartly shifted to a later date once #Baahubali2 locked its release. ?? 2024: #Chhaava avoided a direct clash with #Pushpa2 and moved to 2025. The postponement of #HindiMedium and #Chhaava worked to their advantage, with both eventually enjoying a clear run."

Taran further added that apart from the fear of being overshadowed by the Dhurandhar wave, Ikkis was also facing stiff competition from the Hollywood giant Avatar, which is scheduled to release in India on December 19. He



wrote, "#Dhurandhar is creating havoc at the boxoffice and shows no signs of slowing down... Plus, #Avatar – the #Hollywood giant – will have an extensive release in #India this Friday [19 Dec 2025]. Neither film is likely to surrender screens or prime shows during the #Christmas week." As per the update, Ikkis will now enjoy a solo theatrical release on January 1, 2026. Taran also announced that the film's final trailer will be released on December 19. Ikkis is directed by Sriram Raghavan and is based on the life of Param Vir Chakra awardee Arun Khetarpal, a hero of the Indo-Pakistani War of 1971.

‘It's good Hema Malini didn't attend Dharmendra's prayer meet': Manoj Desai recalls massive turnout, hundreds queuing up to meet Deols



Veteran actor Dharamendra's death left the entire country in mourning, creating a huge void in Hindi cinema. Recently, theatre owner Manoj Desai spoke about the veteran actor's prayer meet and described the massive turnout and long queues outside the ceremony organised by his first wife, Prakash Kaur, and their sons, Sunny Deol and Bobby Deol. On the same day, Dharmendra's second wife Hema Malini hosted a prayer meet in Mumbai at her home. Speaking to Vicky Lalwani, Manoj shared that he was in the queue of hundreds at Dharmendra's prayer meet and had to wait a long time before meeting Sunny Deol. He said, "There was a huge line of cars. My car was standing at the 86th spot. Before me and behind me, there were big cars. They performed bhajans at the prayer meet and the whole world was there. Everybody turned up at the prayer meet. I met Sunny Deol and I told him that many people are coming, so I will leave from the front gate and he told me 'thanks

for coming'. I stood for 45 minutes outside, waiting for my car because there was such a huge queue outside."

"Never saw a prayer meet like that of Dharmendra" Manoj shared that he hadn't seen a footfall so big at any other prayer meet of any artiste than what he witnessed at Dharmendra's. He said, "I have gone to so many prayer meets of so many artistes including Rajesh Khanna's, in which I was sitting next to Amitabh Bachchan. I had also gone to the prayer meet of Yash Chopra, but I had never seen a prayer meet like that of Dharamji's. It felt like the whole nation was there. There was no one who didn't want to come."

Manoj also commented on why Dharmendra's second wife and veteran actor Hema Malini organized a separate prayer meet for the actor in Mumbai and didn't attend the prayer meet that Sunny Deol and family arranged. "I was not surprised that Hemaji didn't turn up. Before any controversy or any such talk would have happened, she organised a separate prayer meet for him. It was good that she didn't come. Hema and Dharmendra ji were very close, but if somebody would have said something to her, the whole prayer meet would have been messed up. So, it was good that she organised a prayer meet separately." Hema Malini and Dharmendra's prayer meet Hema Malini with her daughter Esha and Ahana during the Dharmendra prayer meeting in New Delhi. Talking about Dharmendra and Hema's chemistry, he said, "I think he had maximum chemistry with Hemaji. However, he had chemistry with all his heroines, including Mumtaz and Meena Kumari." Dharmendra had four children with his first wife, Prakash Kaur – sons Sunny and Bobby Deol, and daughters Ajeeta and Vijeta Deol. He married Hema Malini in 1980 and they have two daughters together, Esha Deol and Ahana Deol. Dharmendra died in Mumbai on November 24 at the age of 89.

Radhika Apte says she wants to forget first film Vaah! Life Ho Toh Aisi!: 'Producers treated me horribly, didn't pay'



Radhika Apte has completed 20 years in the film industry. However, she confesses she'd like to forget her first film, Mahesh Manjrekar's 2005 fantasy comedy Vaah! Life Ho Toh Aisi!, which also starred Shahid Kapoor, Sanjay Dutt, Amrita Rao, and Arshad Warsi among others. She blames the producer, Sangeetha Ahir, for the disappointing start to her career. "The awful producers

didn't put me up, didn't pay me. When my mother and I asked them to sign a contract, they said, 'Arey, even Urmila Matondkar didn't sign a contract. I don't know if she signed or not, but they treated us horribly. Mahesh Manjrekar was a great guy. That's why I like to forget my film because the production was awful! And I say it out loud," said Radhika in an edition of Creator X Creator on SCREEN, confessing that she doesn't like to admit to her first film. Radhika also recalled how she landed that supporting role in Vaah! Life Ho Toh Aisi!. "I was doing a play called Brain Surgeon. It was a good play. We won an award in a state competition. Mahesh Manjrekar was one of the judges. He called me after the play and said, 'I want to cast you.'" Radhika recounted. But of the three films Manjrekar was working on then as a director, he thought Radhika was too young to fit into the other two — the 2004 supernatural drama Rakht, starring Bipasha Basu, and the 2007 film Deha.

"Then I didn't do a film for a long time. I finished college, and then I went back to films after a long time. So, I don't really count that as one of the films I did. But yeah, it's been two decades," added Radhika. She went on to star in a Bengali movie and a couple of Marathi films before making her Hindi film debut with Ram Gopal Varma's 2010 political action thriller Rakta Charitra, which was also made in Telugu the same year. Radhika was most recently seen in Tisca Chopra's directorial debut Saali Mohabbat, which also stars Divyendru, Anurag Kashyap, and Sharat Saxena. She plays Smita, a homemaker who finds out her husband is having an affair with her sister. Backed by Manish Malhotra's Stage 5 Productions, the film is streaming on ZEE5.

Saroj Khan refused to choreograph Madhuri Dixit's 'Dhak Dhak', accepted on one condition: 'No one will question me'

The film industry often witnesses a duo of artists come together and make magic every single time they meet. That relationship can be between a director and actor, a composer and a singer, or even a choreographer and actor. One of the best examples of the latter is the relationship between actor Madhuri Dixit and late choreographer Saroj Khan. In a recent interview, Madhuri recalled working with the stalwart and shared some stories from their time together. The actor appeared on Radio Nasha's YouTube channel and was asked about some of the iconic songs from her career. Naturally the mention of Saroj ji kept coming, as Madhuri first told a story from the sets of Subhash Ghai's Ram Lakhan. She revealed that the famous song 'O Ram Ji' was completely different when picturised for the first time. Dixit said that there was a communication gap between Ghar and Saroj, but nothing too difficult for the latter to fix.

Recalling the story, Madhuri said, "I will in fact tell you a very funny story from the shooting of 'O Ram Ji'. So obviously Javed Akhtar had written the words for it, and Bappi Lahiri had composed it, but no one briefed Saroj ji about the song. She was made to listen to the song and was asked for the steps. Now my character was very innocent, and I was supposed to be complaining to the elder brother (Jackie Shroff) about his younger one (Anil Kapoor), but she made it into a total Bollywood number." She added, "Subash ji stopped her mid-performance and said, 'Esa character nahi hai ladki ka' (This is not how the girl is like). But the genius of Saroj ji is that within minutes she had come up with a new choreography, and then you saw what she did." The actor talked about the shooting of one of her most iconic songs, 'Ek Do Teen', from the N Chandra film Tezaab. Madhuri revealed that she initially didn't understand the meaning or reasoning behind the song and said, "The first time I heard 'Ek Do Teen', I didn't understand it. I thought they didn't have enough words, and that is why they have put numbers. But then I realised the meaning behind the song." She continued and said that Saroj ji wanted her to work extra hard in order to prepare for a proper Bollywood number. "Right as the shooting was about to start, Saroj ji told me, 'You have only done classical or semi-classical numbers. You haven't done something like this, so you



need to rehearse.' I agreed, and for 13 days straight I rehearsed with her. At one point she got annoyed with me and said, 'Tum ghar jaao abhi' (You go home). But I stood there and said that I wasn't going before finishing my rehearsal." Madhuri added, "Because I was used to dancing on stage, performing for a camera was difficult. But that song helped me learn so much about this art and how to dance for the camera." Madhuri then talked about the Bappi Lahiri song Tamma Tamma from the film Thanedar, directed by Raj N Sippy. She recalled the difficult steps for the song and said, "Shooting Tamma Tamma was incredibly tough. We had 4 people doing the same steps: me, Sanju, and two backup dancers. Now if anything went wrong, they had to reshoot it from the beginning. We had to do 40 retakes because Saroj ji refused to cut. She wanted it all in one shot. We finally got the shot, and we were relieved, but we were so tired. Our knees were busted up by the end." The Indra Kumar directorial, Beta, had the song 'Dhak Dhak' in it, performed by Udit Narayan and Anuradha Paudwal. The song is one of the most beloved from Madhuri's discography, and yet it almost didn't happen. Madhuri revealed that the song was a last-minute addition to the film and that Saroj ji worked everyone to the bone in order to shoot the song in the limited time. "Now, like many other songs in the past, 'Dhak Dhak' also came to us in the last moment. Indu Ji (Indra Kumar) was adamant that he had to have this song for the film. I told him that I had to go for an outdoor shoot in three days, and it wasn't possible. But he wouldn't budge, and I finally decided to pull double shifts in order to shoot the sequence," said Madhuri.
