CM Revanth Reddy assures of funding for villages development

Hyderabad, Dec 24: In a recent event held in the Kodangal constituency, Chief Minister Revanth Reddy announced a significant initiative aimed at empowering local governance. A felicitation ceremony for newly elected Sarpanches saw Reddy reveal that funds will be provided directly to Sarpanches for the development of villages, marking a shift towards decentralised financial support.

The Chief Minister declared that large villages would receive ₹10 lakhs and smaller villages ₹5 lakhs under the newly introduced Special Development Fund for Sarpanches. Importantly, Reddy emphasised that these funds would be disbursed without the involvement of ministers, MLAs, or MPs, ensuring a more straightforward approach to village development.

"Your support has brought me to this position. Since 2009, you have carried me on your shoulders. I will transform Kodangal into a model for the entire country," Reddy stated. He also highlighted the importance of village prosperity for national growth, asserting, "The country will prosper only if the villages prosper."

During his address, the Chief Minister called for a united effort among Sarpanches, urging them to work collaboratively for the development of their communities, free from party politics and rivalries. He encouraged Sarpanches to strive for the highest quality of services for their constituents, reinforcing that village development should transcend political affiliations.

In addition to the funding initiative, Reddy announced that all eligible residents in the villages would also receive ration cards, further underscoring the government's commitment to the welfare of rural communities.

Haryana writing farmers' prosperity through collaboration, says Amit Shah

New Delhi, Dec 24

Union Home and Cooperation Minister Amit Shah, on Wednesday, addressed a Cooperative Conference organised by Krishak Bharati Cooperative Limited (KRIBHCO) on the theme 'Role of Cooperation in Sustainable Agriculture' here, with the Haryana Chief Minister Nayab Singh Saini and several other dignitaries were also present.

Home Minister Shah said, "Haryana, connected with history, religion, spirituality, and traditions, is today gradually writing new dimensions of farmers' prosperity through the collaboration between agriculture and cooperatives."

He noted that on the occasion of the International Year of Cooperatives, Milk chilling centre, Haryana State Cooperative Supply and Marketing Federation Limited (HAFED) flour mill, distribution of RuPay Platinum Card and registration certificates of model Primary Agricultural Credit Societies (PACS), and the portal on the International Year of Cooperatives were also inaugurated at this conference organised by KRIBHCO.

Home Minister Shah said that nearly 70 per cent of the country's population resides in rural areas, and a large section of "our population is directly or indirectly dependent on agriculture, farming, and animal husbandry for livelihood".

He added that "if agriculture and animal husbandry are viewed as independent businesses, these sectors provide employment to a large number of people".

He said the two sectors generating the maximum employment in the country are agriculture and animal husbandry.

"However, when agriculture and animal husbandry are linked with cooperation, it not only provides employment to 125 crore people but also plays an important role in making them prosperous."

The Union Minister said that in Gujarat "Amul at present distributes nearly Rs 90,000 crore every year to 36 lakh women milk producers. If the same quantity of milk were sold at market prices, it would fetch only Rs 12,000 crore".

He added that the "difference between Rs 12,000 crore and Rs 90,000 crore reflects the strength of cooperation. That is why it is said that by linking animal husbandry, agriculture, and cooperation, prosperity through cooperation can be achieved".

Home Minister Shah said that "agriculture and animal husbandry were always viewed only from the employment perspective, but Prime Minister Narendra Modi by establishing the Ministry of Cooperation at the Centre gave a new mantra of prosperity through Cooperation".He added that "now cooperation is being linked not only with employment but also with prosperity".

Home Minister Shah said after becoming the country's Prime Minister, Narendra Modi strengthened the foundation of agriculture and utilised agriculture strengthened through cooperation to make farmers prosperous.

He added that "low water usage, fewer chemicals, and lower risk form the foundation of the new agriculture policy. This includes achieving higher yields with less water through scientific irrigation methods, reducing fertiliser use through natural farming, and selecting crops with minimal risk through soil testing".

He said that steps must be taken to increase farmers' income through soil health, water security, institutional credit, market access, and processing, packaging, and marketing of produce.

"Along with this, agriculture dependent on subsidies must gradually move towards sustainable farming, which ensures sustainable profits."He added that for this purpose, the state government has worked to promote different verticals like water and soil conservation, their testing, organic farming, climate-resilient agriculture, the Digital Agriculture Mission and cooperation.



Cyberabad police arrest 11 in child trafficking racket, rescue two infants

Hyderabad, Dec 24:

The Cyberabad police on Wednesday arrested an 11-member gang involved in child trafficking in the State and rescued two infants from them.

The arrested are Vemula Babu Reddy, Venkipally Gangadhar Reddy, Daram Laxmi, Ram Hari Roy, Kummari Harsha Roy, Sangeeta Debi, Gudepu Sujatha, Suraboina Anuradha, Esarapu Jyothi, V Madhavi and Pothula Sobha.

According to the DCP (Madhapur), Ritiraj said the prime suspects Babu Reddy and Gangadhar Reddy had maintained two different gangs comprising men and women and took their help to search for poor people who would sell their infants for a price.

"After identifying the women who were willing to sell the babies, the gang members would pay the parents some amount and take away the babies. Later, they would sell the babies to childless couples for a price between Rs 6 lakh and Rs 7 lakh," said DCP Ritiraj.

Babu Reddy and Harsha Roy were previously arrested by the Gopalapuram police in connection with the IVF centre racket in multiple cases and remanded. However, they managed to obtain bail from the court and resumed their activities.



Chilly weather to persist in Hyderabad on Christmas Eve and the next day

Hyderabad: Hyderabad and districts continue to experience cold wave conditions with minimum temperatures below normal by 3 degree Celsius and 4 degree Celsius at many locations.

While daytime temperatures on Wednesday are expected to climb up to 28 degree Celsius, temperatures during Christmas Eve on Wednesday night and early hours of Christmas on Thursday morning are expected to be chilly.



ISRO's 'Bahubali' rocket places 6,100 kg US satellite into orbit

The Indian Space Research Organisation's (ISRO) 'Bahubali' rocket on Wednesday successfully launched a 6,100-kg US communications satellite, the heaviest payload carried by an Indian launcher, into the desired orbit.

As part of the mission, LVM3-M6, nicknamed 'Bahubali' for its heavy-lift capability, placed the BlueBird Block-2 satellite into low earth orbit (LEO). It is the largest commercial communications satellite to be deployed in LEO. The satellite belongs to a next-generation BlueBird Block-2 constellation designed to provide space-based cellular broadband connectivity directly to standard mobile smartphones.

The BlueBird Block-2 mission is part of a global low earth orbit constellation aimed at enabling 4G and 5G voice and video calls, text messaging, streaming and data services worldwide, at all times.The mission was a dedicated commercial launch aboard ISRO's LVM3 launch vehicle, which placed the satellite of US-based AST SpaceMobile into orbit. It marked the sixth operational mission of the LVM3.

Developed by ISRO, LVM3 is a three-stage heavy-lift launch vehicle comprising two solid strap-on motors (S200), a liquid core stage (L110) and a cryogenic upper stage (C25). In earlier missions, the vehicle successfully launched Chandrayaan-2 and Chandrayaan-3. The previous LVM3 mission — LVM3-M5 carrying the CMS-03 satellite — was successfully conducted on November 2.ISRO Chairman V Narayanan said the mission was the first dedicated commercial launch undertaken by India for a US customer. "This is our 104th launch from Sriharikota and the ninth successful mission of the LVM3 launch vehicle, demonstrating its 100 per cent reliability," he said.Prime Minister Narendra Modi described the launch as a significant stride in India's space sector. "The successful LVM3-M6 launch marks a proud milestone in India's space journey. It strengthens India's heavy-lift launch capability and reinforces our growing role in the global commercial launch market. This is also reflective of our efforts towards an 'Aatmanirbhar Bharat'. Congratulations to our hardworking space scientists and engineers. India continues to soar higher in the world of space," he said.The PM added that powered by India's youth, the country's space programme was becoming increasingly advanced and impactful. "With LVM3 demonstrating reliable heavy-lift performance, we are strengthening the foundation for future missions such as Gaganyaan, expanding commercial launch services and deepening global partnerships."



Incident-Free New Year Rachakonda CP Sudheer Babu Strict Action on Drugs, Liquor Sales to Minors, No DJ Permission for Outdoor Events



....“NARRA SRINIVAS REDDY (NSR), Medchal - Malkajigiri Staff Reporter, December 24, (INDIAN CHRONICLE):“Rachakonda Police Commissioner Sudheer Babu, IPS, on Tuesday held a coordination meeting with owners and representatives of pubs, bars, restaurants, farmhouses, wine shops, and event organisers within the Rachakonda limits, in connection with New Year celebrations. The meeting focused on security arrangements and preventive measures to ensure that no untoward incidents occur during the festivities. Addressing the gathering, the Commissioner said the objective is to celebrate an Incident-Free New Year. He stressed that there should not be a single accident, no loss of life, and no disturbance to public peace during New Year celebrations. He appealed to the public, youth, and organisers to act responsibly and cooperate with the police. Anticipating large gatherings and heightened enthusiasm among youngsters, the Commissioner stated that comprehensive security measures are being implemented to prevent any law and order issues. Special teams from Traffic Police, SOT, She Teams, and patrol units will be deployed round the clock to prevent crimes and untoward incidents. The Commissioner made it clear that DJ systems will not be permitted at outdoor events, and fireworks are strictly prohibited. Event organisers were instructed not to allow crowds beyond the permitted capacity. To ensure women's safety, She Teams will be actively deployed at celebration venues. To curb drug abuse, special checks and inspections will be carried out during New Year celebrations. The Commissioner warned that strict action will be taken against drug peddlers and organised gangs involved in the supply of prohibited substances. Pubs, bars, and wine shops were directed to close strictly within the prescribed timings. The Commissioner warned of severe action against establishments selling liquor to minors. Organisers were advised to make proper parking arrangements and ensure the installation of CCTV cameras in and around pubs, bars, restaurants, and commercial establishments. He further stated that New Year events organised at farmhouses located on the city outskirts must strictly adhere to all rules and regulations. Drug consumption, obscene dance programmes, and any indecent activities involving women will not be tolerated under any circumstances. Traffic police were instructed to take necessary measures to avoid congestion on roads. Drunken driving checks will be enforced strictly, and vehicle owners who allow minors to drive will face legal action. To prevent speeding, reckless driving, and illegal bike racing during late-night hours, certain flyovers will be temporarily closed for a specified period, he said. Death blow to Aravalli

The environmental degradation of Aravallis, India's oldest mountain range, has been a saga of bureaucratic apathy and human greed coming together to plunder the country's unique treasure. Over the decades, several hillocks of the range have vanished due to illegal mining and deforestation, leading to a loss of an ecosystem that is most crucial for the survival of not just mankind but also for wildlife. Once a thriving ecosystem of hills, forests, fauna, aquifers and natural drainage, the Aravallis, which straddles the States of Rajasthan, Haryana, Delhi and Gujarat, now carries the dubious distinction of being the country's most degraded forest range. Dealing a further blow to the mountain range is the new definition proposed by the Ministry of Environment and Forests for it. As per the new definition, proposed by a committee under the Environment Secretary, any landform that is at an elevation of 100 metres or more above the local profile will be considered as part of the Aravalli Hills, along with its slopes and adjacent land. This elevation-based definition could potentially leave more than 90% of the forest range vulnerable to mining and construction. What is more shocking is the Supreme Court's approval of the proposal. The 100-metre benchmark and the use of local profile — the immediate surroundings of a hill — as the measuring base, rather than a standardised baseline such as the State's lowest elevation, would result in a very significant part of the Aravalli range not being counted as Aravalli anymore.

With 550 km of the range lying in Rajasthan, the Supreme Court's approval of the new definition, recommended by a Centre-led panel, has triggered widespread protests across the State, joined by the opposition parties, environmental activists and social media influencers. Union Environment Minister Bhopender Yadav has promised that no new mining leases would be granted until a detailed study is undertaken. But questions remain over the extent of illegal mining, the future scope of mining in the areas excluded under the 100-metre definition, and the impact of every mining block on the surrounding landscape. And there are activities besides mining that can lead to environmental harm.

candidate shouting slogans calling her the deputy sarpanch while she was the deputy sarpanch. With caste differences evident from the very beginning, questions are being raised among the locals about how the development of the panchayat will continue for the next five years.

The four labor codes that harm workers must be repealed: - CITU State Vice President S. Mallikarjun



""(Mandava Srisailam... Yadadri Bhuvanagiri District Bureau... Indian Chronicle... December 24): CITU State Vice President S. Mallikarjun demanded the repeal of the four labor codes introduced by the BJP government, which are detrimental to workers."On Wednesday, a meeting of the CITU District Committee was held at the local CITU district office under the chairmanship of District President Komatireddy Chandrareddy."Speaking as the chief guest at this meeting, CITU State Vice President S. Mallikarjun criticized the central government for issuing a notification on November 21 for the implementation of the four labor codes as part of a conspiracy to turn the working class, the creators of wealth, into modern slaves for the benefit of corporate managements. He criticized that the codes include provisions that allow employers to increase the eight-hour workday, which workers fought for and achieved, to twelve hours. He strongly condemned the labor codes for questioning the workers' right to strike and their right to form unions. They criticized the government for eliminating the concept of permanent employment and introducing a fixed-term employment system, thereby removing job security. They also criticized the Modi government for introducing a new definition that excludes workers earning more than 18,000 rupees from the purview of labor laws, thus exploiting the working class. On the other hand, they stated that a bill has been introduced under the name of Electricity Amendment 2025, which would eliminate the possibility of farmers receiving subsidies and endanger the rights of the states. They criticized the BJP, alleging that it is weakening the Mahatma Gandhi National Rural Employment Guarantee Act (MNREGA) and changing its name to V.V. Ramji, and that while the central government previously allocated 90% of the funds, it has now limited it to 60%, shift-



ing the remaining 40% onto the states. They alleged that this is part of a conspiracy to gradually abolish the employment guarantee scheme. They also stated that the government has introduced a bill on insurance laws under the name "Sabka Bima Sabki Raksha" (Insurance for All, Protection for All), allowing 100% FDI in the insurance sector. They warned that this is extremely dangerous for employees and beneficiaries, and that it only benefits insurance companies, investors, and corporate entities, causing severe harm to the people of the country. They criticized that the bill introduced under the guise of nuclear safety, accountability, and sovereignty is part of a conspiracy to privatize nuclear power produced in the public sector. They alleged that the policies of the Narendra Modi-led BJP government are simultaneously attacking workers, farmers, employees, and the poor. They called upon people's organizations to prepare for a resistance movement against these policies, and as part of this, urged workers and the public to participate in large numbers in the nationwide protest program at district centers on December 26th and the worker-farmer unity rally on January 19th to teach Modi's policies a fitting lesson. Those who participated in the meeting included CITU District Secretary Kalluri Malleshham, District Treasurer MD Pasha, District Vice Presidents Dasari Pandu, Maya Krishna, Donuri Narsireddy, District Assistant Secretaries Gorige Somulu, Turkapalli Surender, Chekka Ramesh, Potta Yaddamma, Silveru Ramakumari, Pailla Ganapathi Reddy, and District Committee members Adimoolam Nandeeshwar, Gandhamalla Mathaiah, Morigadi Ramesh, Burugu Swapna, Cheemakandla Sriramulu, Radharapu Malleshham, Potharaju Jahangir, Bathula Dasu, Thooti Venkatesh, SD Umar, CH Srinu, Jonnakanti Devaiah, Konde Narasimha Jangayya, and others.

Journalist associations are pressing for amendments to GO 252; preparations underway for joint action:

- Indian Federation of Working Journalists (IFWJ), Telangana Journalists Welfare Association (TJSS) representatives Mamidi Somaiah, “-Round Table meeting on the 27th“-Key decisions taken at the emergency meeting of journalist associations

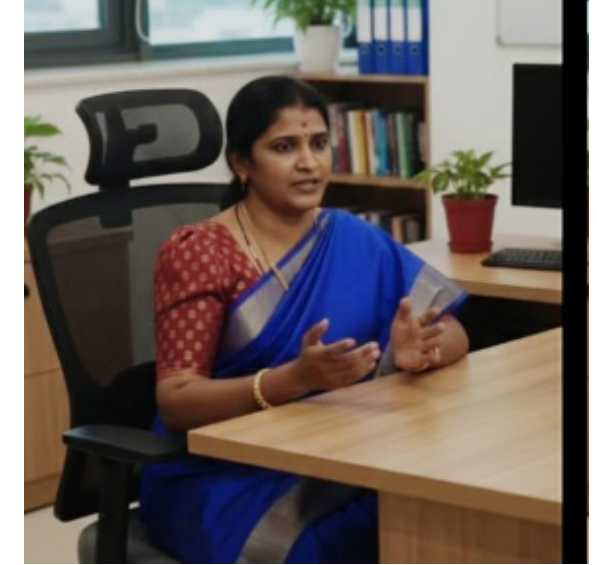


“(Mandava Srisailam... Hyderabad Indian Chronicle... December 24):- Several journalist associations held an emergency meeting in Hyderabad on Wednesday regarding GO 252 issued by the state government finalizing the media accreditation rules. The associations decided to act as a bridge between the journalists and the government and to exert pressure on the government to amend the flawed GO 252. Representatives from the Telangana Working Journalists Federation (TWJF), All India Working Journalists Association (AWJA), Indian Federation of Working Journalists (IFWJ), and Telangana Journalists Welfare Association (TJSS), including Mamidi Somaiah, K. Koteswara Rao, Pulipalupula Anandam, Ananchinni Venkateswara Rao, and senior journalist Venkataratnam, participated in this meeting. They revealed the key decisions taken at the meeting to the media. They stated that it was decided to organize a round table meeting in Hyderabad on the 27th of this month, and to move forward by including representatives from all journalist associations. The journalists stated that the government is confusing them by deciding to issue two types of cards, and that the benefits of these accreditation and media cards have not been clearly specified. They questioned why the orders state that the accreditation card will only serve as identification for reporters to gather government information, while desk journalists can only use the media card for welfare schemes, calling this rule unfair. For the first time, accreditation cards will be issued to digital news media, but it has been clarified that this will only be for websites. They strongly objected to the significant reduction in the number of accreditation cards under these new rules. They expressed concern that while the previous government issued 23,000 accreditation cards, the new government order could lead to a reduction of over 10,000 cards. A fee of Rs. 250 has been imposed for obtaining a duplicate card if the original is lost. They also stated that making a police FIR mandatory in case of a lost card is unac-

ceptable. Previously, reporters had a card at the constituency level, but this has now been abolished. Cards will only be issued at the state, district, and mandal levels, and they said they would discuss this matter with the government. They requested the government to reconsider its decision, stating that previously there were special quotas for General, Sports, Cultural, Film, and Cartoonists, but now this quota has been abolished and limited only to cartoonists under the freelance quota. They said that a degree qualification or five years of experience is mandatory for state-level accreditation, and an Intermediate qualification is mandatory for district and mandal-level reporters, but their experience is not being considered. They urged the government to put an end to the previous practices of giving accreditation to auto drivers, sarpanches, and party workers. They stated that previously, one accreditation card was given for every 50,000 people in urban areas and mandals, but now the GO (Government Order) states that only one card will be given per mandal, which is unfair.“The cards given to cable channels at the district level have been cancelled. They said that previously, cards were given at the district level, and it is unfair to state that these cards do not confer any special status, that they should be used only for journalism purposes, and that the words 'Accredited to the Government of Telangana' should not be used or printed on visiting cards or letterheads. They expressed concern that this GO will crush small newspapers and that it is a vindictive approach against small newspapers, adding insult to injury. They said that accreditation rules have been framed with stringent regulations in our state, unlike in any other state, and requested the state government to reconsider and amend this GO. He said that several journalists' associations would participate in the round table conference scheduled for the 27th of this month, where they would discuss Government Order 252 and formulate a plan of action, and that a joint action committee would be formed if necessary.

FSSAI License & Registration Mela on December 26th in Yadadri Bhuvanagiri District: - V. Jyothirmayi Assistant Food Controller, erstwhile Nalgonda district

“(Mandava Srisailam... Yadadri Bhuvanagiri District Bureau... Indian Chronicle... December 24):- As per the orders of the State Food Safety Commissioner, an FSSAI License & Registration Mela will be conducted on December 26th in Yadadri Bhuvanagiri district under the supervision of V. Jyothirmayi, Assistant Food Controller of the erstwhile Nalgonda district, according to district Food Safety department officials. They stated that the main objective of this mela is to create awareness among all types of food business operators in the district about the mandatory FSSAI license or registration, and to provide services easily in one place. They revealed that the mela will offer:“New FSSAI registrations“License renewals“License modifications“Necessary guidelines and advice“They advised all types of food business operators, including hotels, tiffin centers, restaurants, bakeries, grocery stores, meat and fish vendors, milk and dairy product vendors, food stalls, street food vendors, catering units, etc., to compulsorily attend this mela. On this occasion, Assistant Food Controller V. Jyothirmayi... Jyothirmayi stated that conducting a food business without an FSSAI license is illegal and warned that strict action would be taken against those who violate the regulations. She advised every food business operator to take advantage of this opportunity, attend the fair with the necessary documents, and obtain their license or registration.““Important Note for Business Owners“She stated that it has come to their attention that some brokers, consultancies, or Food Safety Mitra are issuing FSSAI registrations incorrectly, without considering the actual turnover of the businesses. She clarified that licenses or registrations obtained through such unauthorized means will be cancelled and will not be valid. There-



fore, she urged every food business operator to contact the local Food Safety Officer, and after proper verification, obtain the license or registration only through the official government online process, and not to trust fraudulent brokers.“The officials of the Yadadri Bhuvanagiri district Food Safety Department appealed to make this program a success. As part of this, Assistant Food Controller V. Jyothirmayi of the erstwhile Nalgonda district will be available from 9:00 AM at Ganj, next to the Kanyaka Parameshwari Temple in Bhongir town, to provide necessary guidance. She requested business owners to utilize this opportunity.

Complete the works under the Amrut 2.0 scheme in all municipalities of the district expeditiously: Yadadri Bhuvanagiri District Additional Collector for Local Bodies, Bhaskara Rao

Every consumer has the right to know about the quality, quantity, and price of goods: Yadadri Bhuvanagiri District Collector Hanumantha Rao

December 24): Yadadri Bhuvanagiri District Collector Hanumantha Rao said that every consumer has the right to know about the quality, quantity, and price of goods. On Wednesday, the District Collector attended and addressed a meeting held at the Collectorate meeting hall under the auspices of the Civil Supplies Department to observe National Consumer Day. On this occasion, the District Collector said that everyone should cooperate in protecting consumer rights and that awareness should be created among the public about the laws to overcome adulteration and protect consumers. He stated that the Consumer Day would be truly meaningful only when proper justice is served not only to the educated but also to the common people. He said that obtaining quality goods and services is a fundamental right of every individual. He specifically requested consumer rights associations to stand by and provide services to farmers in remote villages to ensure they receive quality seeds. He said that since food and medicine are a part of daily life, justice will be served only if there are stringent punishments. He added that the district's Food Safety Officer is continuously conducting inspections to ensure a society free from adulteration. The Collector stated that the concerned officials should conduct extensive inspections of hospitals, medical shops, fertilizer shops, hotels, hostels, and other establishments in the district. Vigilance Inquiry Against Medchal District Registrar Allegedly Delayed

“NARRA SRINIVAS REDDY (NSR), Medchal - Malkajgiri Staff Reporter, December 24, (INDIAN CHRONICLE):“All India Hindustan Congress Party State President Botla Sailu has alleged undue delay and negligence in the vigilance inquiry initiated against Medchal District Registrar Ashok Kumar, questioning the role of senior officials in the Stamps and Registration Department. Addressing the media, Botla Sailu demanded an explanation from the Telangana Stamps and Duties Commissioner as to why the vigilance inquiry against the district registrar is allegedly being prolonged without conclusion. He alleged that irregularities are taking place in land registrations across the Medchal district, particularly involving government lands. According to him, several sub-registrar offices in the district are functioning under the indirect influence of the district registrar. He claimed that in nearly 12 sub-registrar offices, close associates of the district registrar are allegedly facilitating irregular registrations. He further stated that several sub-registrars have gone on leave and senior assistants are managing the offices, allegedly leading to procedural lapses. Botla Sailu questioned why the vigilance inquiry has not progressed de-



spite serious complaints and said the delay raises suspicions about administrative inaction. He demanded the immediate transfer of the Medchal District Registrar and called for a full-fledged vigilance probe followed by strict action if wrongdoing is established. He also alleged that basic facilities are lacking at the district registrar's office, stating that even visitors are not provided proper seating arrangements. He further accused the official of failing to furnish information sought under the Right to Information Act, allegedly causing delays and violating transparency norms. Expressing concern over what he described as systemic issues in the Registration Department, Botla Sailu alleged that public revenue is being adversely affected due to irregular practices. He urged senior government authorities to intervene and ensure accountability, stating that repeated instructions issued by the government to officials are allegedly not being implemented effectively. He concluded by demanding immediate administrative action and strict monitoring to safeguard public interest and government revenue.

Ahead of its December 25 inauguration, here’s how you can reach Navi Mumbai International Airport

As Navi Mumbai International Airport (NMIA) prepares to begin commercial operations from December 25, access to it remains a central concern. Located at Ulwe in Panvel taluka, the airport sits outside Mumbai’s main suburban rail line, and will open without direct metro or express rail connectivity.Until several planned infrastructure projects are completed, passengers will depend on a mix of suburban trains, buses, and road-based transport to reach the airport. Each mode offers distinct advantages and constraints that are likely to shape travel choices in the airport’s early months.Suburban rail will remain the most economical way to reach Navi Mumbai airport, but it is also the most indirect. There is no direct train service to the airport terminal, and all rail passengers must change trains at least once and complete the final stretch by road.

Passengers travelling from South Mumbai and parts of Central Mumbai typically board Harbour Line services from Chhatrapati Shivaji Maharaj Terminus (CSMT) towards Vashi, Nerul or Belapur CBD. At Belapur CBD, they must switch to the Belapur–Uran suburban line to reach Targhar station. Commuters from Thane and the central suburbs can use Trans-Harbour Line services to Nerul before making the same change towards Targhar.Targhar station, which became operational recently, lies approximately 1.8 to 5 km from the airport terminals, depending on the route taken. From here, passengers must rely on auto-rickshaws, taxis or shuttle services to complete the last-mile journey.In non-peak hours, the journey from CSMT to Targhar usually takes between 75 to 90 minutes, but during peak periods it can exceed

two hours due to crowding and interchange delays. Travel from Navi Mumbai nodes is significantly shorter, typically under 30 to 35 minutes. Suburban rail fares remain low, with second-class tickets costing under Rs 40 and first-class fares ranging between Rs 95 and Rs 175.Despite its affordability, rail travel poses practical challenges for airport users. Peak-hour crowding on the Harbour and Central lines makes boarding with luggage difficult, while interchanges at Kurla, Dadar, and Belapur CBD involve foot over bridges and waiting time. Dedicated airport express trains have not yet been introduced.Public bus services will offer the cheapest surface connectivity to the Navi Mumbai International Airport, but they remain the least predictable option, particularly for time-sensitive travel.

Brihanmumbai Electric Supply and Transport (BEST) and Maharashtra State Road Transport Corporation (MSRTC) buses operate between Mumbai, Thane, and various Navi Mumbai nodes, but none provide direct access to the airport terminal.Most bus journeys require passengers to alight at locations such as Panvel, Belapur, Nerul, or Ulwe, and then take an autorickshaw or taxi for the final leg. Travel times vary widely depending on traffic conditions, route congestion, and the number of intermediate stops. Fares are typically modest, ranging from Rs 50 to Rs 200, but multiple transfers are often unavoidable.Bus services are especially vulnerable to congestion along the Sion–Panvel Highway, near Panvel junctions and within Ulwe. Combined with limited luggage space and frequent stops, these factors make buses less suitable for passengers travelling on tight departure schedules. Interestingly, no city bus carrier, including BEST or NMMT, has announced a dedicated bus service to the airport so far.Road travel is expected to be the most common mode of reaching NMIA in its initial phase, particularly for passengers with luggage. Key access corridors include the Mumbai Trans Harbour Link (Atal Setu) from Sewri, the Sion–Panvel Highway, the Vashi Bridge, Palm Beach Road, and the Eastern Freeway for travellers from South and Central Mumbai.

Atal Setu has reduced the time for harbour crossings to about 20 minutes, significantly improving access from South Mumbai. However, congestion on feeder roads within Navi Mumbai often determines the overall journey time. Under moderate traffic conditions, travel from South Mumbai to NMIA typically takes 60–80 minutes, while journeys from the western suburbs can stretch to 90–120 minutes. From Thane and central suburbs, road travel usually takes 60–90 minutes, while residents of Navi Mumbai nodes can reach the airport in as little as 20–30 minutes during non-peak hours.Taxi fares generally range from Rs 1,000 to Rs 1,500 from South Mumbai and Rs 1,500 to Rs 2,500 from the western suburbs, with toll charges applying on Atal Setu.Several key connectivity projects linked to NMIA will not be operational before its launch. Metro Line 8, also known as the Gold Line, which will connect Chhatrapati Shivaji Maharaj International Airport and NMIA, has been approved but is still under construction, with operations expected around 2029.The Ulwe Coastal Road, designed to provide direct access from Atal Setu to the airport, is under construction and expected to open in early 2026. Dedicated airport rail or metro express services have yet to be announced.

How will new codes change labour laws? | Explained



The story so far: On November 21, Union Labour Minister Mansukh Mandaviya announced the implementation of four Labour Codes — the Code on Wages, 2019, Industrial Relations Code, 2020, Code on Social Security, 2020 and the Occupational Safety, Health and Working Conditions (OSHCW) Code, 2020. Parliament had passed these codes between 2019 and 2020.

Why is the process taking time?

As labour is in the concurrent list, both the States and Centre have the power to makes Rules. The Centre published draft Rules for each code between July 7, 2020 and November 19, 2020; and as on July 2025, 32 States and Union Territories have also pre-published draft Rules under the four Labour Codes. According to a statement in Parliament during the last Monsoon session, West Bengal and Lakshadweep have not pre-published draft Rules under any Labour Codes. Delhi has pre-published draft Rules only under the Code on Wages. Tamil Nadu is yet to pre-publish draft Rules under the Code on Social Security. The Centre stated that the delay in implementing the Rules was mostly because of the lag in States.

What are the key features?

The Code on Wages repeals the Payment of Wages Act, 1936, the Minimum Wages Act, 1948, the Payment of Bonus Act, 1965 and the Equal Remuneration Act, 1976. The Industrial Relations Code amalgamates the Trade Unions Act, 1926, the Industrial Employment (Standing Orders) Act, 1946 and the Industrial Disputes Act, 1947. The Code on Social Security nullifies nine Acts including the Employees' Compensation Act, 1923, the Maternity Benefit Act, 1961 and the Unorganised Workers' Social Security Act, 2008. The OSHWC Code repeals Acts such as the Factories Act, 1948, the Mines Act, 1952, and the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979. The Government repealed and codified 29 Acts that decided the structure of labour rights from the colonial period to the first United Progressive Alliance government.

What are the major changes?

According to the Government, the Labour Codes promote formalisation of employment, expand social security coverage, ensure minimum and timely wages for more workers, provide for engaging more women in the workforce and reduce compliance burden for employers. Some of the other features include mandatory appointment letters to all workers, social security such as provident fund and State insurance for all workers including gig and platform workers, and a statutory right for minimum wage payment. Women can now work at night and in all types of work across establishments, and they will have equal opportunities in high-paying roles. A national floor wage will be set to ensure no worker receives a wage below the minimum living standard. Gender-neutral pay and job opportunities, prohibiting discrimination against transgender persons, and "shifting enforcement towards guidance, awareness and com-

pliance support rather than punitive action," are some of the other features.

How have employers responded?

Almost all employers' organisations have welcomed the Codes. The president-designate of the Confederation of Indian Industries R. Mukundan told The Hindu that the labyrinthine labour law framework needed to be simplified, harmonised and modernised. "The Labour Codes do exactly that. They will create jobs, ensure social protection and maintain industrial harmony in a fast advancing economy," he said. He argues that the uniformity across States, digital filings, reduced disputes and the emphasis on flexibility will make India a more attractive destination for doing business. However, representatives of micro, small and medium enterprises (MSMEs) are sceptical. The Association of Indian Entrepreneurs (AIE) fear that the new Labour Codes may significantly increase operating costs for MSMEs and disrupt business continuity across key sectors. "While AIE fully supports progressive labour reforms and the need for a modern workforce framework, the organisation has cautioned that the immediate impact on MSMEs could be severe unless governments provide clarity, transitional support, and flexible implementation mechanisms," it said in a statement. It is seeking a transitional grace period with reduced penalties for MSMEs.

What are the concerns of trade unions?

Barring the Bharatiya Mazdoor Sangh (BMS), all Central Trade Unions (CTUs) are opposed to the Labour Codes. Ten CTUs and associated federations organised strikes against the proposed Labour Codes in 2019, 2020, 2022, 2023 and on July 9, 2025. The BMS has welcomed the implementation of two Labour Codes, the Code on Wages and Code on Social Security, and has questioned provisions in the Industrial Relations Code and the OSHWC Code. The CTUs worry that the codes will take away several federal rights, including the right to decide minimum wages in the States. The floor wage, according to them, is a joke played on workers as in the past too, the Centre had failed to address the demands and realities of workers. On social security, the CTUs argue that 93% of the workers are not covered under any social security and the codes have no provision to improve the scenario. Also, the threshold of workers for factory licence has been increased and this will exclude a lot more workers from the social security and minimum wages provisions, allege trade unions. On the Industrial Code too, they have issues as there will be "unwarranted restrictions" on the functioning of trade unions, including "limitations on membership, restrictions on outsiders serving as office-bearers, and the introduction of concepts such as the sole negotiating union and the negotiating council." The right to strike also sees curtailments in the code. Trade unions have questioned the reduction of retrenchment notice pay, limiting the period for workers' money claims, exclusion of house rent allowance from the definition of "wages", the overall emphasis on contractualisation and allowing women workers in night shifts in sectors such as mines.

What lies ahead?

The Government has announced that all stakeholders will get 45 days to respond to the draft Rules of the Codes which it will again pre-publish with some modifications. Opposition-ruled States have reservations: Kerala said it will not implement the codes, while Karnataka, West Bengal and Tamil Nadu have also questioned the Centre's "unilateral" approach. The trade unions have urged the Government to convene the Indian Labour Conference, the tripartite forum that has not met for over a decade, at the earliest. Employers also want to the government to facilitate more discussions at the factory level so that relations are not

India's population to stabilise by 2080 due to dip in fertility rate: IASP



India's population is expected to stabilise by 2080 at 1.8 or 1.9 billion due to dipping total fertility rate, which is currently below the replacement level at 1.9, an official said. India is undergoing a rapid demographic transition, with the birth rate dropping sharply over the past two decades, he said. "In 2000, our TFR was 3.5 and today it stands at 1.9. This is a drastic decline," Indian Association for the Study of Population (IASP) general secretary Anil Chandran told PTI.

He said India's population is expected to peak at 1.8 or 1.9 billion by 2080, when growth is expected to stabilise. "All estimates show that India's maximum population will remain below two billion," Mr. Chandran added. He attributed the fall in fertility primarily to increasing development and education levels. Increased female literacy, he said, has directly shaped decisions around marriage and childbearing, leading to smaller families. Greater use of con-

traceptives and wider access to birth control have further accelerated the decline, he said. "Couples today are better informed and exercise greater control over when and how many children to have," Mr. Chandran said. He said that late marriages and growing economic opportunities — especially for women pursuing careers — have also significantly influenced reproductive choices. "Development is inversely proportional to birth rates. Illiterate groups still have fertility levels above three, but among the educated, TFR ranges between 1.5 and 1.8," he said. Citing Kerala's example, Mr. Chandran said the State achieved replacement-level fertility (2.1) between 1987 and 1989 and now has a TFR of around 1.5. West Bengal's fertility rate has also seen a sharp fall. According to the Sample Registration System (SRS) Statistical Report 2023, the state's TFR has dropped to 1.3, down from 1.7 in 2013 — a decline of nearly 18% and well below the replacement level of 2.1. West Bengal now ranks among the lowest in the country, on par with Tamil Nadu and just above Delhi, while recording the lowest urban TFR and the second-lowest rural TFR nationally, he said. The demographer noted that while birth rates are falling, life expectancy continues to rise due to improvements in healthcare. "More people are living beyond 60, and this brings new challenges of elderly care, especially as younger people migrate for work," he said, adding that solutions such as elderly day-care facilities are increasingly being discussed. IASP, founded in 1971 and comprising around 1,100 demographers and population scientists, regularly deliberates on such issues with support from bodies including UNFPA, the Population Council and the Population Foundation of India.

Chandigarh battle: Why did Centre backtrack from bringing Punjab & Haryana's capital under its control



Story so far: Beating a hasty retreat, the Ministry of Home Affairs (MHA), on Sunday (November 23, 2025), clarified that it has 'no intention of introducing a Constitutional Amendment Bill to bring Chandigarh under Article 240 of the Constitution'. On November 21, the Centre had listed ten bills including a Bill to put Chandigarh under the Centre's ambit and 'ensure uniform treatment as other union territories without legislature'. The Bill would allow Centre to appoint an independent administrator in Chandigarh, bringing the Union Territory directly under Central control — like other UTs. Currently, Punjab Governor Gulab Chand Kataria acts as Chandigarh's administrator.

The listing of the Bill had created uproar from not only Opposition parties in Punjab like Congress, Shiromani Akali Dal (SAD) and Aam Aadmi Party (AAP), but from Bharatiya Janata Party's (BJP) Punjab unit itself. Punjab Congress leaders Pratap Singh Bajwa and Manish Tewari asserted that Chandigarh was meant to be Punjab's capital and any attempts to snatch it away would be an open attack on Punjab's rights. SAD chief Sukhbir Singh Badal called the Bill a 'betrayal on all commitments made to Punjab to hand over Chandigarh to it', while AAP MP Malvinder Kang called upon all Punjab MPs to 'unite and defeat this Bill in Parliament'. Caught unaware by Delhi, BJP Punjab chief Sunil Jakhar assured that 'Chandigarh is an integral part of Punjab' and rushed to meet Amit Shah to 'resolve the confusion'. Within two days, the Centre rescinded the Bill and clarified 'The proposal does not in any way involve altering the governance and administrative arrangements of Chandigarh or the traditional relations of Chandigarh with Punjab or Haryana. An appropriate decision will be taken only after adequate consultation with all stakeholders'.

In 1948, the partitioning of Punjab resulted in the state losing its capital — Lahore, to Pakistan. After much debate, the foundation for a new capital located at the foothills of the Shivalik Himalayas, was laid by India's first Prime Minister Pt. Jawaharlal Nehru, on April 2, 1952. Designed by a team of European experts led by French architect M. Le Corbusier, the city was one of India's first to follow modern town planning standards with clear, equal-sized divisions for residential areas with its own market, cinema, library, police and fire service. Linked by main roads, residential areas in Chandigarh fall in different sectors separated from the area housing the Capitol, Town Hall, shopping centre, commercial centre, recreation centre, museums and the University. It was inaugurated by then-President Dr. Rajendra Prasad on October 7, 1953. However, with the formation of Haryana in 1966, where Hindi-speaking areas of Hissar, Rohtak, Gurgaon, Karnal, Mahendragarh, Ambala, Jagadhri and Naraingarh were handed over to the new state and Chandigarh was made a Union territory and a joint capital

of Punjab and Haryana. The Bharatiya Jana Sangh (BJP's predecessor) opposed the reorganisation of Punjab terming it a "betrayal of public confidence".

1970: In face of threats of self-immolation by Akali Dal leader Sant Fateh Singh, then-Prime Minister Indira Gandhi promised to hand over entire Chandigarh to Punjab. In exchange, Haryana will be given the Hindi-speaking area of Fazilka including the famous Abohar market. As this area did not border Haryana, a 6.43 km-long corridor would be constructed to access it, declared Ms. Gandhi. With the help of Centre's aid, Haryana was to build a new capital and leave Chandigarh by 1975. This award was never implemented and even Punjab urged Centre to reconsider handing over Fazilka to Haryana. 1985: Years later, taking another stab at the Chandigarh issue, then-Prime Minister Rajiv Gandhi signed the Rajiv-Longowal accord on July 25. The 11-point resolution awarded Chandigarh to Punjab and Haryana was to be compensated by the transfer of the Hindi-speaking areas of Punjab. A commission was to be set up to demarcate these areas by December 31, 1985 and the two transfers was to be effected on January 26 next year. It also promised to set up a commission to examine the remaining territorial claims and counter-claims of Punjab and Haryana. Though it was not specified, the future of Abohar and Fazilka, which under Mrs. Gandhi's award of 1970 were to be included in Haryana, too, would be settled by this commission. Prime Minister Rajiv Gandhi and President of Akali Dal Sant Harchand Singh Longowal exchanging documents after signing a Memorandum of settlement on Punjab issue, in New Delhi on July 24, 1985. This resolution was also never implemented amid Opposition from Haryana and other political parties. The signatory of the accord - Akali Dal chief Sant Harchand Singh Longowal, who had also allowed sharing of rivers Sutlej and Beas' waters with Haryana, was murdered along with the chief engineer of the Sutlej-Yamuna Link Canal. The river dispute still remains with the project stalled. Recent incidents

2005: Haryana asserted its claim on Chandigarh demanding a separate High Court for Haryana via a resolution. It urged the Centre to suitably amend the Punjab Reorganisation Act. As of date, no such changes have been made. 2022: MHA notified rules aligning the service conditions of all employees of Chandigarh with the Central Civil Services. About 60% of employees are from Punjab and 40% are from Haryana, in Chandigarh's civil services. The move was welcomed by the employees as it meant better benefits and salaries. In response, the Punjab Assembly unanimously passed a resolution to immediately transfer union territory of Chandigarh — the joint capital of Punjab and Haryana, to Punjab. Countering it, Haryana passed a resolution to retain its right to the two States' joint capital territory of Chandigarh. Meanwhile, the Chandigarh Municipal Corporation passed a resolution to remain as a Union Territory. 2024: Haryana government had offered 12 acres of land in Panchkula in exchange for 10 acres of land near IT Park Road in Chandigarh to construct its new Assembly building. Union Ministry of Environment, Forests and Climate Change had reportedly granted environmental clearance for the land offered by Haryana. Outraged, all major parties in Punjab — Congress, BJP and even AAP, opposed the move urging the Punjab Governor to not allow the project, asserting that Chandigarh belonged to Punjab. In February this year, the Chandigarh administration rejected the land swap stating that the property offered by Haryana was not upto the UT's urban building standards. It claimed that the Panchkula land 'lacked proper access, had a natural drain (nullah) running through it and was in a low-lying area' while the IT Road land was a prime property valued at around ₹640 crore. The Centre's backtracking of its recent move to resolve the Chandigarh conundrum shows lack of political will to settle it and that the tussle for the joint capital is likely to feature in the 2027 electoral campaign for Punjab.

Paying attention in a digital world



Even before digital devices fragmented attention spans, teachers exhorted students to "Pay attention". When I was in school, in the 1970s and 1980s, teachers would use this phrase, sometimes banging on a desk with a wooden duster, to get our attention. The use of the verb 'pay' suggests that we have always perceived attention as a scarce resource, not to be frittered away. However, over the last decade, as gadgets made deeper inroads into our everyday lives, there is a growing recognition that our attentions are being parcelled and monetised, often leaving individuals distraught and dismayed. Is it possible to regain control of our attention spans? Attention, like many other psychological phenomena, is hard to define. Even without the tug of social media, we are bombarded by a plethora of sensations, only a fraction of which may be relevant to us in a given moment. Though the term 'attention' is used as if it's a "single entity," in Altered Traits, Daniel Goleman and Richard Davidson posit that it actually consists of a set of abilities that includes selective attention, vigilance, goal focus and meta-awareness.

Paying attention is hard work in the analogue world. However, it becomes exponentially harder when we are fed a continuous diet of digital 'brain rot'. Social media platforms are designed to lure our flickering attention only to fill our heads time and again with largely banal stuff. An article in The

Economist (dated September 13, 2025) likens this to a form of 'theft' because when we direct our attention to our device, it prevents us from engaging in something else, which, in turn, can dampen our productivity. Because attention is controlled by both voluntary and involuntary mechanisms, tech companies take advantage of the latter to keep us scrolling endlessly.

Two types of ADHD?

In an article in Psyche, three psychiatrists, Paul Kudlow, Karline Treunicht and Elia Abi Jaoud observe that the incidence of attention-deficit hyperactivity disorder (ADHD) has mushroomed in both children and adults over the past two decades. Further, they argue that the disorder has morphed and the condition is more akin to a spectrum with two extremities that they refer to as Type I and Type II ADHD. As our ability to pay attention is determined by

both biological and environmental factors, most of us "fall somewhere between these two poles." According to the psychiatrists, Type I ADHD is the "classical form" which typically manifests in early childhood as a "neurodevelopmental condition". Given appropriate support either in the form of a structured learning environment or stimulant medication, most children with this form of ADHD get better with age. However, of late, the psychiatrists have been encountering a subset of patients who show a different profile. They don't necessarily have problems staying focused as children. However, in their teens or 20s, they start exhibiting a lack of focus, impulsivity and disorganisation though they weren't like this earlier. The authors posit that Type II ADHD possibly results from countless hours spent scrolling and swapping screens. Brains then get rewired, predisposing them to

continually crave instant gratification. As a result, people find it difficult to engage in tasks that require a slower but deeper and more deliberate form of engagement like reading a book or listening to a lecture. The psychiatrists add a caveat that most studies regarding digital usage and symptoms of ADHD are correlational. However, the preliminary longitudinal evidence that exists suggests that heavy digital reliance precedes the onset of symptoms of inattention and impulsivity. According to the authors, the most effective treatment might be to curb digital usage to "deliberate windows" of short durations and engage in offline activities that enhance focus. As early as 1890, William James notes in Principles of Psychology that the skill of repeatedly redirecting a meandering mind is "the very root of judgment, character and will". Given how consequential attention is, everyone.

Trump-MbS summit — \$1 trillion among friends



As adrenaline-high at the Saudi-American Summit last week demonstrated, the 80-year-old bilateral alliance remains perhaps the oldest transactional deal still going strong. It predates the establishment of post-Second World War global architectures such as the United Nations, the North Atlantic Treaty Organization (NATO) and the Bretton Woods Institutions. It was conceived as a secret “oil-for-security” strategic partnership signed on Valentine’s Day 1945 between U.S. President Franklin D. Roosevelt and King Abdul Aziz bin Abdul Rehman al-Saud on the USS Quincy in the Suez Canal Area. Originally intended to last 60 years, it was renewed in 2005. Thanks to the exceptional amity between U.S. President Donald Trump and Saudi Crown Prince Mohammed bin Salman (MbS), this arrangement is currently being reset to the new domains of strategic cooperation, with the potential to anchor bilateral, regional and global developments in a more consequential manner. The trajectory of ties

During the past 80 years, U.S.-Saudi ties have not always had smooth sailing. First, thanks to shale technology, the U.S. has become the world’s largest producer of crude and a significant exporter. While this has reduced the commercial content of the relationship, the U.S.’s exports have remained steady, leading to a decline in the bilateral merchandise trade and a balance swinging in America’s favour. As Saudi Arabia’s trading partner, the U.S. now ranks below China and India. Historically, the ties came under strain during the Ramadan War of 1973, when Saudi Arabia joined an Arab oil embargo. In the mid-1980s, the Saudis surprised the Americans by buying intermediate-range ballistic missiles from China, a country they did not even recognise then. There have been tensions as the American military supplies were staunch during the Yemen war, affecting Saudi offensive and defensive capabilities through the Houthis.

The assassination of Jamal Khashoggi, a prominent Saudi commentator working with The Washington Post, in the Saudi consulate in Istanbul in October 2018 jolted ties, and the Biden presidency initially decided to keep MbS at arm’s-length. The friction pushed the Saudis into diversifying their ties with China and Russia. In December 2022, China’s President Xi Jinping visited Riyadh and held three separate summits with the leaders of Saudi Arabia, Arab and Muslim countries, respectively. Later, Beijing also facilitated the resumption of diplomatic ties between Saudi Arabia and Iran. Since late 2023, the U.S. support for Israel’s brutal military campaign in Gaza has also made it difficult for Riyadh to turn a new page in bilateral ties. The Saudis have resisted U.S. pressure to formally recognise Israel, pre-conditioning it on the creation of a pathway to Palestinian statehood, which Israel has ruled out. New contours under the Trump presidency

There has been a positive sea change in bilateral ties since Mr. Trump took over the U.S. presidency this year. His first visit of his second term abroad was to Saudi Arabia in May 2025, where an agreement to supply \$142 billion worth of military equipment was secured. The new contours of this new relationship were in evidence at the no-holds-barred state visit. It included a moving guard of honour, a fly-past, a private lunch and a 300-guest banquet, both hosted by Mr. Trump, who also attended the investment forum at which deals worth \$270 billion were signed. On his part, MbS readily agreed to raise the promised Saudi investments in the U.S. economy from \$600 billion to \$1 trillion without a fixed time frame. The amount is nearly as big as the country’s GDP and the entire corpus of the Kingdom’s

The illusion of flow: U-turns slowing Hyderabad down

A little before 8 a.m. on a weekday, Dinakar Kumar Rao stays perched on his two-wheeler at the edge of Uppal junction, watching traffic crawl in slow motion. The skywalk above him may tower impressively, but the chaos below feels like a road network stuck mid-thought — cars edging forward, stopping, shuffling sideways, building pressure that bursts into honks.

Rao, 47, has lived in Boduppal for over a decade and has learnt to mark time by these rhythms. What he once assumed was temporary inconvenience on his long commute to Gachibowli has now settled into a daily test of patience. “What should have become easier has somehow become more complicated,” he says. “It is not just being stuck in traffic; it is the sense that movement itself has stopped making sense.” Uppal junction embodies that confusion. One approach road is closed, forcing thousands of commuters into a long U-turn loop before they can rejoin the main road. The diversion adds only a few minutes, yet the irritation accumulates far beyond the number. “You take a loop, lose five minutes and end up exactly where you started,” he says. Across the city, the pattern repeats. At Jubilee Hills, a car trying to beat a U-turn curve smashed into a bus in July, flinging its driver onto the bonnet. In Rasoolpura in September, a man was thrown off his scooter when a speeding vehicle cut through a U-turn near the NTR statue. Such incidents, buried in FIRs and routine police reports, say more about the city’s design anxieties than any traffic dashboard ever does. The numbers underline the scale. Nearly 800 U-turns dot the tri-commissionerate — 439 in Cyberabad, about 200 in Hyderabad and nearly 150 in Rachakonda. Between 2021 and 2025, the city recorded 366 accidents at U-turn locations, including 25 fatal crashes. In 2024 alone, nearly 4% of all road accidents occurred at U-turn points. Police booked close to 20,000 violations for prohibited or improper turns over five years, with the numbers rising each year. With roughly 1,500 new vehicles added daily and average speeds hovering at just 22-23 kmph, Hyderabad’s roads are inching close to saturation. Authorities insist that U-turns exist for good reason. Each one, they say, goes through a proposal stage, GHMC approval and a trial run before opening. But over time, a pattern has emerged: U-turns open with fanfare, close under pressure, reopen with tweaks and quietly shut again. Tamaka is the clearest example: reopened experimentally in April 2025 and shut within weeks after massive

Public Investment Fund (PIF), which already has 40% of its foreign investments in the U.S. economy. The groundbreaking Strategic Defence Agreement was signed, formally designating Saudi Arabia as a “major non-NATO ally” and committing the U.S. to actively assist Saudi Arabia if it came under an attack.

Moreover, the bilateral differences on basic issues such as the global oil glut, Riyadh-Tel Aviv reconciliation, Iran, and the Kingdom’s drive towards strategic autonomy were papered over during the Summit, which was conspicuous by the absence of any final communiqué. The visit can, nevertheless, be considered as a qualified bilateral success, particularly as it managed to bury the past ghost issues. The robust revival of the U.S.-Saudi ties in Trump 2.0 is bound to have a regional impact. Under MbS, Saudi Arabia, the Arab world’s largest economy, has abandoned its low-key diplomatic profile, adopting a more assertive and visible pursuit of national interests. This process has accelerated after the two-year-long Israeli military campaign that has subdued Iran, the Kingdom’s long-standing rival in the region and the Islamic world. MbS has already persuaded Mr. Trump to drop sanctions against Syria’s new regime and has asked for stronger American intervention to end the Sudanese civil war. Even the Iranian President has sought the MbS facilitation of the resumption of nuclear talks with Washington. The robust endorsement by the White House during the recent visit would further empower MbS, who at 40 years could be around for decades, making him an indispensable, long-term U.S. interlocutor as the region’s geopolitical architecture gets reconfigured. While the visit was silent on global issues, there are signs of subterranean bilateral coordination. Although oil has largely disappeared as the driver for bilateral economic synergy, the Saudi economy continues to be highly dependent on oil export revenues. Moreover, as recent U.S. sanctions against the two Russian oil majors demonstrated, Washington intends to continue its dominance of the global oil market. Both Saudis and Americans want the oil price to be at a moderate, sustainable level. The concerted American actions on sanctions against Iran, Venezuela and two Russian oil majors can only help stem the emerging supply-side oil glut, shore up the price and create market space for higher exports by both Saudi Arabia and the U.S. For the U.S., reinforced ties with Saudi Arabia would also stave off the recent encroachments by China and Russia on its turf, and complement its regional Pax Americana. Impact on India The Washington Summit does have several implications for India. First, it may provide advanced U.S. military equipment access to Pakistan, with which Riyadh concluded a strategic mutual defence agreement in September 2025, apparently with the U.S. nod-and-wink. Second, although India, as the world’s third-largest oil importer, would prefer oil prices to be low, moderation and stability in the oil market may still be preferable as it navigates for alternative sources to Russian supplies. Third, soaring Saudi ambitions for its post-oil Vision-2030, such as AI data centres, may create economic opportunities for India. Fourth, curbing China’s foray into Saudi Arabia may open the door wider for India. India also needs to prioritise entering into a Comprehensive Economic Partnership Agreement with Saudi Arabia. Lastly, the emerging modus vivendi with Israel may also facilitate the work on the India-Middle East-Europe Economic Corridor, which transits through Saudi Arabia. At a different level, White House’s differential treatment of MbS shows that its single-minded pursuit of economic transactions continues to trump all previous qualms, such as human rights and proliferation concerns, may light India’s pathway to an economic peace with the Americans. The evident MbS-Trump bonhomie during the White House Summit signals the U.S. reclaiming primacy in Riyadh. The locus of the relationship has, nevertheless, shifted from the past “oil-for-security” paradigm. As the new, more nebulous drivers congeal and Saudi Arabia asserts its sovereign autonomy, the alliance enters an uncharted territory. While much may remain unaltered, it would, nevertheless, be fascinating to watch its progression.

jams. Tolichowki has gone through similar flip-flop interventions. Even the TRANSCO U-turn near IKEA in Cyberabad was briefly redesigned as a junction before spiralling queues forced authorities to revert to the earlier layout. Hyderabad Joint Commissioner of Police (Traffic) D. Joel Davis acknowledges the growing concern. “Each U-turn is introduced only after a trial to assess whether it solves congestion or adds to it. Now, teams are being formed to revisit all U-turns across the city to determine which should stay open and which must be closed,” he says. For commuters, however, the city is not a policy blueprint but a daily negotiation, and those negotiations are wearing thin. Karkhana is a good place to see how. Suresh Kumar, 54, has commuted on this stretch for over 30 years and remembers when late-night cricket matches in the bylanes were the biggest disturbances. “In the last two years alone, the U-turns on this two-kilometre stretch have opened and closed so many times that even regular drivers have stopped keeping count,” he says. “First it was near Mahankali temple, then shifted towards Grill 9 restaurant, then pushed further down, and now it sits half a kilometre before Vikramপুরi signal.” For residents, this has created its own arithmetic. A short trip to the corner store now means looping past a busy signal, adding minutes and irritation. “Anyone coming into Karkhana from Trimulgherry or Dairy Farm Road must go all the way to Vikramপুরi just to double back home. From the outside it looks orderly, but the discomfort belongs to us,” says Kumar. Those new to the city find the maze even harder to navigate. When Anita Verghese moved to Hyderabad a few months ago, she expected the city to be simpler than the metros she had lived in. Within days, she found herself circling through one U-turn after another across the western corridor. “It is confusing, exhausting and, frankly, unnecessary,” she says. “As a pedestrian, you feel like a non-entity because there is no signal to help you cross. It feels as though signals were removed, U-turns put in their place to create an illusion of movement and everyone just went along with it.” That illusion matters. While U-turns theoretically reduce delays by eliminating signal stops, the extra distance and merging time often exceed what a red light would have required. In peak hours, reaching a U-turn 300-400 metres ahead can take over a minute, followed by another half-minute to merge. Analysis shows many commuters spend more than 90 seconds on a U-turn manoeuvre, longer than the average 70-second delay at a properly timed signal.

When a convicted Sengottaiyan stood disqualified from contesting elections



A quarter of a century ago, former AIADMK veteran leader K.A. Sengottaiyan, who joined actor-politician Vijay’s Tamilaga Vettri Kazhagam on Thursday (November 27, 2025), stood disqualified from contesting elections. In the year 2000, the former Transport Minister was convicted in two different corruption cases and sentenced to jail attracting disqualification from contesting polls under the Representation of People Act.

Mr. Sengottaiyan had served as Minister for Transport in Jayalalithaa’s first Cabinet (1991-96). Soon after the AIADMK faced a rout in the 1996 Assembly elections, the M. Karunanidhi government had registered multiple corruption cases against the former Chief Minister, some of her erstwhile Cabinet colleagues, their family members and bureaucrats. The CB-CID registered cases against Mr. Sengottaiyan, his personal assistant and officials, under the Prevention of Corruption Act accusing them of causing wrongful loss to the Jeeva Transport Corporation (JTC), Anna Transport Corporation (ATC) and J. Jayalalithaa Transport Corporation (JJTC, later renamed Rajiv Gandhi Transport Corporation). They were accused of conspiring and deriving pecuniary advantage in the procurement of bus spare parts, printing of tickets and bus body building.

On October 3 that year, Mr. Sengottaiyan was arrested by the CB-CID in the ATC corruption case. He was the fourth former Minister to be held on corruption charges after Indira Kumari, T.M. Selvaganapathy and K.P. Krishnan. He was remanded in the Salem Central Prison. Subsequently, he was arrested in the JTC and JJTC cases. He secured bail in January 2007. Later, the government constituted three Special Courts in Chennai to exclusively try the 46 corruption cases related to the 1991-96 Jayalalithaa government. Mr. Sengottaiyan’s cases were transferred here and charges were framed against him. Mr. Sengottaiyan took the defence that the cases were foisted on him due to political vendetta.

Hong Kong blaze: Why buildings have disastrous fires and how they can be prevented



On November 26, a fire started on scaffolding at the Wang Fuk Court housing complex in Tai Po in Hong Kong and spread rapidly across multiple high-rise blocks wrapped in bamboo and other flammable external materials. At least 44 people had died as of 7 am IST (November 27) while hundreds were missing. The local police had reportedly arrested three construction executives even as investigators were looking into how renovation work on the structure had allowed the fire to spread vertically so fast.

Why do buildings burn? Buildings burn when three things come together and keep feeding each other: heat, fuel, and oxygen. Potential ignition sources include short circuits, welding sparks or a kitchen flame but also any fireworks inside or nearby. The heat from these sources heats nearby material until it decomposes and releases flammable gases. Those gases can mix with air and burn, releasing even more heat, which then warms other materials. In a building filled with plastics, fabrics, paper, and synthetic foams, this positive feedback loop can quickly avalanche into a big fire. Once a room’s surfaces all get hot enough, the space can reach a point called flashover, when almost everything ignites within seconds and the fire becomes very hard to control or survive. Many large fires since 2000 have started off as localised blazes that the structures’ geometry and construction materials fanned into building-scale disasters. Architects and engineers have known that external scaffolding, cladding systems, and cavities on the façade can act like open chimneys that allow hot gases to race upwards, pulling in fresh air from below and warming up the higher levels.

How are occupants put at risk? In Hong Kong, based on an early assessment by investigators, bamboo poles and plastic mesh that surrounded the towers gave the first fire a continuous and combustible path up the towers’ exterior. Similarly, in Shanghai in 2010, sparks from welding had ignited nylon netting and bamboo scaffolding, and the resulting fire spread into a 28-storey apartment building under renovation. In London’s Grenfell Tower in 2017, an electrical fault in a fridge started a small flat fire, but flammable cladding and insulation on the façade plus a ventilated gap behind the panels created a powerful artificial chimney that carried flames rapidly up the tower, killing 72 people. A similar sort of external cladding contributed to repeated fires at Dubai’s Torch Tower in 2015 and 2017. Inside buildings, the way a fire grows is shaped by the fire load (i.e. the quantity of materials that can burn), compartmentation, and escape routes. Hospitals, nightclubs, offices, and factories in particular are known to have a dense fire load, including beds, medical plastics, soundproofing foam, paper files, stored chemicals, and textiles. When ignition occurs in a poorly compartmented space, flames and smoke can spread through stairwells and ceiling voids. The 2011 AMRI Hospital fire in Kolkata began with an electrical fault in the basement, where hospital administrators had stored flammable materials. The smoke and heat moved upwards even as alarms and attempts at evacuation failed, and eventually 89 people died.

In the Station nightclub fire in the US in 2003, pyrotechnics ignited polyurethane foam around the stage. Within minutes, the foam and ceiling were burning, and smoke and

“The Chief Minister (Karunanidhi) had been attempting to distance him from the AIADMK as he played a vital role in protecting Ms. Jayalalitha, the then Leader of the Opposition, from being physically attacked in the Assembly and also as he was staunch pillar of support for his party leader in Coimbatore and Erode districts,” The Hindu reported in July 2000 citing his defence in the ATC scam. On August 4, 2000, Mr. Sengottaiyan and the co-accused were convicted in the JTC scam and sentenced to undergo rigorous imprisonment for four years. He was also directed to pay a fine of ₹1.05 lakh. “In the 195-page order, the Special Judge-I, Mr. A.C. Arumugaperumal Adityan, found the three guilty and sentenced them under various provisions of PCA and IPC. The convicted were later lodged in the Central Prison, Vellore. Mr. Sengottaiyan, is the fourth member of the previous AIADMK cabinet, besides the former Chief Minister, Ms. Jayalalitha, to be convicted and sentenced by Special Courts set up to try cases registered under PCA,” The Hindu reported.

Four months later, Mr. Sengottaiyan was convicted in the ATC case and sentenced to five years rigorous imprisonment by Special Judge-II S.S.P. Darwesh. On account of his conviction in these two cases, Mr. Sengottaiyan could not contest in the 2001 Assembly elections, in which the AIADMK was voted back to power. Jayalalithaa herself stood disqualified from contesting in the election on account of her conviction in the TANSI land deal cases. In April 2002, Mr. Sengottaiyan was acquitted in the JJTC case by the Special Court. Subsequently, in February 2005, the Madras High Court set aside his convictions in the ATC and JTC cases. In the 2006 Assembly elections, he won for the fifth time from the Gobichettipalayam constituency, though the AIADMK lost power. The Karunanidhi Government then moved the Supreme Court challenging Mr. Sengottaiyan’s acquittal in the two cases. However, in November 2006, the Supreme Court declined to interfere with the judgement solely on account of delay in filing the appeal. “To a question from the Bench about the reason for the delay in filing the appeal, senior counsel Altaf Ahmad, appearing for the State, said it was filed after the new government assumed office in this May,” a report in The Hindu said. The Bench told the counsel “change of political climate cannot be cited as a reason for the delay. You can’t go by that logic. State is a State. This happens to bureaucrats who can’t act independently [to go on appeal]. The appeal is being dismissed only on the ground of delay.” In 2011, Jayalalithaa returned as Chief Minister and inducted Mr. Sengottaiyan as a Minister in a Cabinet. She later sacked him. Thereafter, he returned as Minister only in the Edappadi K. Palaswami Cabinet in February 2017.

overcrowding together led to the death of 100 people, compounded by a lack of sprinklers. A similar story played out in 2016 at the Ghost Ship warehouse fire in California, where 36 people died during a party in a cluttered and illegally converted warehouse with no sprinklers or alarms. More than 250 workers died in the Ali Enterprises garment factory fire in Karachi in 2012 because the company’s owners and managers had barred the windows and locked the exits, so the workers couldn’t outrun the smoke and heat, even though the structure itself didn’t collapse immediately. In Dhaka’s FR Tower fire in 2019, office workers were trapped in a high-rise building that had few usable exits and no sprinklers, again allowing an ordinary fire to become lethal. Twenty-five people were killed.

How can buildings collapse? The structure of a building also determines how long it can stand when it’s on fire. While steel is strong, it loses much of that virtue when it’s exposed to temperatures of 500° to 600° C. Without proper fireproofing, then, a building’s beams and columns can start sagging, pulling other elements out of alignment. In Madrid’s Windsor Tower in 2005, the concrete core and some protected elements withstood the heat but unprotected steel perimeter members failed, leading to a partial collapse of the structure. In 2017, Tehran’s Plasco Building — a high-rise with a steel frame and a significant fire load — the absence of sprinklers and low compartmentation allowed a fire to burn for long enough to cause a floor to collapse, which led to more failures around the building that eventually pulled the whole structure down. In 2001, at New York’s World Trade Centre, the aircrafts’ collisions with the Twin Towers stripped them of fireproofing, and large, multi-floor fires heated the floor trusses and columns until they buckled. The tragic result was the complete collapse of the towers despite their modern design. In most of these examples, the ignition was usually in the form of routine activity such as electrical faults, hot work, fireworks, cooking, etc. The main killers were subsequently the fast spread of the fire and smoke rather than exotic fuels. The rapid spread was facilitated by combustible façades, scaffolding, insulation, and materials indoors, which together created continuous fuel beds and chimneys.

How can building fires be prevented? When they design and construct a (reasonably well-funded) building, engineers and architects generally assume that small fires will occur, so much of the design is already invested in keeping an accidental fire in one place for a set period of time, thus allowing the occupants to leave before the conditions become lethal.

The central idea is, once again, to have compartments. The floors, walls, and ceilings are arranged to create fire compartments with a specific fire-resistance rating. To do that, builders build them with concrete, fire-resistant masonry and/or protected steel (which is steel that’s been given a fire-resistant coating or encasement that slows the transfer of heat). Fire doors and fire-resisting glazing are also used to close openings between compartments. The ultimate desired effect is for each such compartment to resist the spread of a fire for 60 minutes, 120 minutes or so on.

Modern building codes also attempt to prevent fires from racing upwards or across the outside of a building by restricting the use of combustible cladding and balcony materials and by forcing designers to break up continuous air gaps behind façades with interruptions. Architects and engineers may also select materials that prevent structural collapse in exchange for being damaged themselves. After the Grenfell Tower fire, for instance, the UK banned certain combustible materials in the external walls of high-rise housing and later extended this to hotels, hospitals, and other buildings. In fact there’s now a move to ban metal composite panels with a polyethylene core on many buildings altogether. Building codes in many countries, including India, also specify minimum separation distances between buildings and impose limits on the floor area per compartment to reduce the chances of an external fire spreading from one part of a city block to another.

No extension beyond March for IndiGo’s wet-leased planes from Turkey; its Turkish Airlines 777s to go back after February



IndiGo has the permission to use wet-leased aircraft from Turkey-based airlines only till March, and no further extension will be provided, India’s aviation regulator Directorate General of Civil Aviation (DGCA) said late Monday. Moreover, the lease on two wide-body Boeing 777 aircraft that are among the planes IndiGo has on lease from Turkish carriers is valid only till the end of February, and has not been extended. The clarification came amid speculation in a section of the media that IndiGo had received the DGCA’s nod for a six-month lease extension on the two Boeing 777s.

IndiGo has a total of seven aircraft on wet lease—taking the aircraft on lease along with the operating crew—from Turkish carriers—five Boeing 737 planes from Corendon Airlines till March-end, apart from the two Boeing 777 jets from Turkish Airlines till February-end. IndiGo also has the regulator’s permission to lease five Airbus A320 planes from another Turkish carrier Freebird Airways, but these are yet to be inducted by the Indian airline.

“M/s IndiGo has been permitted to operate aircraft on wet lease from Turkey with a last extension valid till March 2026 with a sunset clause that no further extension will be given. This is based on the undertaking submitted by IndiGo airlines in the instant case wherein they have sought last time extension, since their long-range aircraft (A321-XLR) are to be delivered by February 2026,” the DGCA said. A senior official said that while the lease validity for the narrow-body planes from Turkish carriers is there till March,

the Turkish Airlines’ Boeing 777s will have to go back after February.

IndiGo uses the two wet-leased Boeing 777s for its flights to Istanbul from Delhi and Mumbai. Amid backlash against Turkey in India due to the former’s public backing of Pakistan during Operation Sindoor, the DGCA had informed IndiGo that it would not allow lease extensions for the two aircraft beyond August. However, in August, the regulator allowed a one-time final lease extension till February-end upon IndiGo’s request, but stated that no further extensions will be given. DGCA approvals are mandatory for Indian airlines to wet-lease aircraft.

“Wet leasing of aircraft is a normal practice in the global aviation industry and recently due to grounding of aircraft because of engine related issues and the delays in delivery of aircraft against orders from the OEMs (original equipment manufacturers), many Indian carriers as a stop gap arrangement are resorting to wet lease from foreign companies in order to serve Indian passengers and also to utilize the rights provided to the Indian carriers under the bilateral service agreements with other countries,” the DGCA said, adding that wet lease arrangements have been allowed, including with Turkish carriers, keeping “passenger interest in mind”. According to data shared by the regulator, IndiGo has a total of 15 wet-leased aircraft in operation, with eight yet to be inducted. Apart from Turkey-based airlines, IndiGo has taken aircraft on wet lease from the likes of Norway-based Norse Atlantic Airways, Qatar Airways, and Latvia’s SmartLynx Airlines. The only other Indian airline operating wet-leased aircraft is SpiceJet, with 17 such planes in operation, all from operators in Europe. In a typical wet lease arrangement, the lessor provides the aircraft with crew, maintenance, and insurance, and retains operational control. Such arrangements are best suited for short-term capacity increases or to test new routes. Dry lease, on the other hand, includes just the aircraft, which means that the lessee airline is required to provide crew, look after the plane’s maintenance and insurance, and has full operational control. Dry leases are better for long-term use by lessee airlines.

‘MUFG deal a huge endorsement of India’s progress’: Shriram Finance

The deal between Shriram Finance and Japan’s MUFG Bank is a “huge endorsement” of India’s progress, Umesh Revankar, the vehicle financier’s Executive Vice Chairman, said on Monday, noting that a reduction in credit cost for all lenders is an indication of the economy being structurally healthier and the development of “financial discipline”. “That’s why I think more international institutions want to come to India and tie up with NBFCs (non-banking financial companies),” Revankar told reporters on Monday.

The board of Shriram Finance – India’s second-largest non-bank excluding housing finance companies – on Monday approved entering into definitive agreements with MUFG Bank to sell a 20 per cent stake for Rs 39,618 crore, or \$4.4 billion. This is the biggest overseas investment into the Indian financial sector and comes amid frenetic activity that has seen multiple Japanese firms put money in recent months, including Sumitomo Mitsui Banking Corporation buying a 24.2 per cent stake in Yes Bank and Mizuho Securities agreeing to buy more than 60 per cent in Avendus Capital with a view to increase its stake to 78.3 per cent for almost Rs 5,000 crore. Further, in October, the UAE’s Emirates NBD Bank agreed to buy a 60 per cent stake in RBL Bank for around \$3 billion.

The rush of foreign money into Indian lending comes at a time when foreign direct investment (FDI) into India has weakened, with 2024-25 seeing net FDI inflow of less than \$1 billion amid rising repatriation of funds by foreign investors and increasing overseas investments by Indian companies. In the first seven months of 2025-26, net FDI into India stood at \$6.20 billion. Shriram Finance’s stake sale to MUFG Bank – whose parent is the Mitsubishi UFJ Financial Group – is subject to shareholder and regulatory approvals. According to officials, the deal may be completed by April-May 2026. Revankar said the deal with MUFG “should change (the FDI trend). It’s a huge (sign of) belief in the Indian economy... Since it’s the fastest growing large economy, more capital will come to India”. According to Yasushi Itagaki, MUFG’s Senior Managing Corporate Executive and Group COO-I & Group Head, Global Commercial Banking Business Group, India is the Japanese firm’s “most strategically important key market” among Asian countries “given the strong potential for enduring economic growth”. The investment will help MUFG establish a “solid business foundation” in India’s Small and Medium Enterprises and retail sectors and “capture the country’s growing domestic demand”.

Although Reuters reported last week, quoting MUFG officials, that there is a chance “we may push our stake above 50 per cent” as Indian regulations permitted the same,



Revankar said on Monday that the Japanese bank wants to be a minority shareholder and “we have never discussed anything beyond that”. Itagaki, meanwhile, said MUFG first needs to “digest” its investment in Shriram Finance and for the time being it will be focused on ensuring “the delivery of this partnership into reality”. “Although we have a very long-term strategic view to support Shriram Finance, our priority is to stay focused on realising the value... as a minority stakeholder in Shriram Finance.” Apart from Shriram Finance, for the moment, “we have no appetite in further expanding our investment in India’s financial services segment”, Itagaki added.

While the MUFG investment offers plenty of money for growth to Shriram Finance – its capital adequacy ratio is expected to rise to around 31 per cent from 20.68 per cent once the funds are received – the Chennai-based lender is not looking to move away from its existing customer base and business segments, with Revankar saying there was no intention to get into new areas, something which MUFG appreciates. As at the end of September, Shriram Finance had almost 97 lakh customers and assets under management of Rs 2.81 lakh crore. Commercial vehicle loans made up 46 per cent of its book, passenger vehicle loans accounting for another 21 per cent and the share of loans to Micro, Small, and Medium Enterprises (MSMEs) being 14 per cent. It reported a net profit of Rs 2,307 crore for July-September, up 11 per cent year-on-year. When asked about applying to become a bank, Revankar said the subject was “not a discussion at all”. “Even MUFG, they want us to service our constituency, the underbanked and unbanked. We would like to remain there. We feel that there is enough opportunity for growth... in the constituency that we have built, which is vehicle (loans) and SMEs to expand our loan book... Right now, I don’t see any distinct advantage (in getting a banking licence) for serving our existing customer base.”

instructors, Indian chefs, and music teachers, as well as high-demand sectors including IT, engineering, healthcare, education, and construction, strengthening workforce mobility and services trade. The agreement is likely to be signed and implemented in about 7-8 months. The pact would help Indian exporters, reeling under the impact of 50 per cent tariffs imposed by the Trump administration on Indian goods, to diversify shipments in the Oceania region. India has already implemented a trade pact with Australia. Prime Minister Narendra Modi and his New Zealand counterpart Christopher Luxon on Monday announced the firming up of the pact. The two Prime Ministers held a phone conversation, following which the announcement on the FTA was made. With negotiations having been initiated during Luxon’s visit to India in March 2025, the two leaders agreed that the conclusion of the FTA in a record time of nine months reflects the shared ambition and political will to further deepen ties between the countries. The FTA would significantly deepen bilateral economic engagement, enhance market access, promote investment flows, strengthen strategic cooperation between the two countries, and also open up new opportunities for innovators, entrepreneurs, farmers, MSMEs, students and youth of both countries across various sectors. “Both leaders expressed confidence in doubling bilateral trade over the next five years as well as an investment of USD 20 billion in India from New Zealand over the next 15 years.”

India, New Zealand wrap FTA talks, aim to double trade in five years



AIMING TO double bilateral trade over the next five years, India and New Zealand Monday announced the conclusion of negotiations on a free trade agreement. Bilateral trade between the countries in 2024-25 was \$1.3 billion. Officials in New Delhi said while talks have concluded, the deal is expected to be signed in 2-3 months after “legal scrubbing”, a process where lawyers and trade experts from both sides finalise the agreement’s text. The implementation itself could take over six months once it is passed by the New Zealand Parliament. In India, the Cabinet has already given the deal a green light. In a post on X, Prime Minister Narendra Modi said, “Concluded in just nine months, this historic milestone reflects a strong political will and shared ambition to deepen economic ties between our two countries... The India-NZ partnership is going to scale newer heights. The FTA sets the stage for doubling bilateral trade in the coming 5 years.”

Formal negotiations on the FTA had commenced on March 16 this year when New Zealand Prime Minister Christopher Luxon met Modi in New Delhi. Describing the FTA as a “big deal”, Luxon said boosting trade would translate into more jobs, higher wages, and expanded opportunities for businesses. He also highlighted India’s scale and growth trajectory, noting that the agreement provides New Zealand exporters improved access to a market of over 1.4 billion consumers. India, New Zealand fta, india new zealand trade Describing the FTA as a “big deal”, Luxon said boosting trade would translate into more jobs, higher wages, and expanded opportunities for businesses.

Details released by the government showed that New Delhi has agreed to reduce tariffs on 95 per cent of products exported from New Zealand. Wellington would eliminate tariffs on 100 per cent of its tariff lines for all Indian exports. This alone may not result in immediate export growth since average tariffs in New Zealand are one of the lowest in the world, at about 2.3 per cent. Bringing some parity into the deal, New Zealand has “committed” \$20 billion investments into India over the next 15 years in exchange for receiving market access in a high-tariff (over 15 per cent) and fast-growing Indian consumer market. The lopsided nature of the tariff rates could result in higher gains for New Zealand than for India in goods trade, experts said. At a time when a bilateral trade agreement between India and its biggest export destination, the US, remains stuck, New Delhi has man-aged to conclude talks with New Zealand in a record nine months. So far this year, it has signed two deals, one with Oman last Thursday, and another with the UK in May. The FTA removes numerical caps on Indian students, guarantees a minimum of 20 hours per week work during study, and provides extended post-study work opportunities-up to three years for STEM Bachelor’s and Master’s graduates, and up to four years for Doctorate holders-creating clear pathways for skills development and global careers, the ministry said. “For the first time with any country, New Zealand has created a dedicated pathway for student mobility and post-study work visas with India,” the Commerce and Industry Ministry said.

Tamannaah Bhatia, 35, recently gave a glimpse of a slow morning as she “eased” into the day. “I didn’t rush my Monday. I eased into it. These minutes are private until now. Just me and tea and time,” she said in an Instagram video, where she can be seen relishing some milk tea after eating some soaked nuts.

Taking a cue from the Stree 2 actor’s morning routine, we asked an expert about pairing tea and some nuts. Starting the day with dry fruits and tea, as Tamannah Bhatia shares, can be a gentle and effective way to ease into morning routines while supporting both nutrition and energy balance, said consultant dietitian Garima Goyal. “Dry fruits such as almonds, walnuts, or pistachios are rich in healthy fats, pro-

He said these concerns have been conveyed to Indian External Affairs Minister S Jaishankar. Commerce Minister Piyush Goyal said, “This FTA opens doors for Indian businesses in the region through well-integrated directional exports and gives our youth choices to learn, work and grow on a global stage”.

Commerce Secretary Rajesh Agrawal, said, “India’s strengths are expanding exports, supporting labour-intensive growth and power services. New Zealand gains deeper, more predictable access to India’s large and growing economy. The movement of people, students, professionals, and skilled workers converges these strengths.” Apart from tariff liberalisation, the FTA includes provisions to address non-tariff barriers through enhanced regulatory cooperation, transparency, and streamlined customs, sanitary and phyto-sanitary (SPS) measures and technical Barriers to trade disciplines, the Commerce and Industry Ministry said. “All systemic facilitations and fast-track mechanisms for imports that serve as inputs for our manufactured exports ensure that tariff concessions translate into effective and meaningful market access,” it said. Cooperation has been agreed in AYUSH, culture, fisheries, tourism, forestry, horticulture and traditional knowledge systems, it said. “Tariff asymmetry has shaped the deal. New Zealand’s average import tariff is just 2.3 per cent, compared with India’s 16.2 per cent, and 58.3 per cent of New Zealand’s tariff lines are already duty-free. As a result, Indian exporters already enjoy wide access in New Zealand markets,” former trade officer and founder of think tank GTRI, Ajay Srivastava said.

Srivastava said an FTA alone is unlikely to unlock the full potential of India–New Zealand economic ties, as trade volumes remain modest. Business groups on both sides say the pact must be backed by practical steps to deepen commercial links. New Zealand could expand dairy and horticulture exports to India even at MFN (Most Favoured Nation) tariffs, while India could scale up exports of pharmaceuticals, textiles and IT services to New Zealand, he said. “For India, the agreement strengthens access to a high-income, rules-based Pacific market and supports its broader Indo-Pacific economic strategy. tein and micronutrients, which provide sustained energy and satiety without causing a sudden surge in blood sugar. Including a small portion of these nutrient-dense foods early in the day can help reduce mid-morning hunger and support metabolic steadiness, especially for people with busy schedules,” said Goyal.

Pairing dry fruits with tea adds another dimension to the morning ritual. “Tea, particularly when consumed without excessive sugar, offers antioxidants that support immunity and gentle stimulation without the intensity of strong coffee. For many individuals, this combination of light nourishment and antioxidant hydration can set a calm, balanced tone for the day ahead,” said Goyal.

However, it’s essential to be mindful of portion size and overall dietary balance. “Dry fruits are calorie-dense, so keeping the serving moderate, typically a small handful, ensures you get their benefits without overshooting daily energy needs,” Goyal said. Choosing wholesome, minimally processed tea varieties and incorporating whole-food meals later in the morning also ensures that nutrition remains comprehensive rather than limited to small morning bites, she added. So, a morning that includes dry fruits and tea can be both enjoyable and nourishing, especially when you enjoy it without rushing your system. When it fits within a well-structured eating pattern, Goyal mentioned.

FSSAI dismisses ‘misleading’ social media claims alleging link between eggs and cancer: ‘Rely on verified scientific evidence’

The Food Safety and Standards Authority of India (FSSAI), India’s food regulator, recently clarified that eggs available in India are safe for human consumption and dismissed social media claims alleging that egg consumption is carcinogenic or cancer-causing. In its official statement, FSSAI stated that linking eggs to cancer risk is “misleading, scientifically unsupported and capable of creating unnecessary public alarm”.

Recall that many social media posts claimed detection of nitrofuran metabolites (AOZ) — substances purportedly linked to cancer — in eggs sold in India. According to PTI, FSSAI officials emphasised that the use of nitrofurans is strictly prohibited at all stages of poultry and egg production under the Food Safety and Standards (Contaminants, Toxins and Residues) Regulations, 2011.

“The regulator explained that an Extraneous Maximum Residue Limit (EMRL) of 1.0 µg/kg has been prescribed for

nitrofuran metabolites — but solely for regulatory enforcement purposes. This limit represents the minimum level that can be reliably detected by advanced laboratory methods and does not indicate that the substance is permitted for use. Detection of trace residues below the EMRL does not constitute a food safety violation nor does it imply any health risk,” an FSSAI official said. In alignment with international practices, the European Union and the United States also prohibit the use of nitrofurans in food-producing animals. “No national or international health authority has associated normal egg consumption with increased cancer risk,” the regulator reiterated. In the strongly-worded statement, FSSAI urged consumers to “rely on verified scientific evidence and official advisories, reiterating that eggs remain a safe, nutritious, and valuable component of a balanced diet when produced and consumed in compliance with food safety regulations.”

From fighting hunger to winning World Cup for Blind: TC Deepika hopes inspiring story can drive change in her Andhra village and beyond

After winning the Women’s T20 World Cup for the Blind in November, the Indian team visited the Prime Minister’s residence, Rashtrapati Bhavan and the BCCI’s headquarters in Mumbai even as a steady stream of VIPs lined up to meet them.For captain T C Deepika, one interaction made a “real difference”.While meeting Andhra Pradesh Deputy Chief Minister Pawan Kalyan, Deepika raised an issue affecting her village, Tambalahatti, along the Karnataka border.The captain, who scored 246 runs in five games at the World Cup in Sri Lanka including a 91 from 58 balls against Australia in the semifinals, now hopes her team’s win will become a catalyst of change in her village – in more ways than one.

The Indian Express visited Deepika’s village of 45 families, almost all of them from the Yadav community primarily engaged in farming. It found that the roads were not the only problem there. “The families living there still follow regressive practices,” Deepika said, speaking to this newspaper separately over phone.“Women are still asked to sleep outside their homes, either in farms or under a tree, during their menstrual cycle. Pregnant women, too, are not allowed to stay at home. It is also quite common to see girls getting married at a young age,” she said, adding that these restrictions are due “lack of education”. “Class 4 is where education ends in our village,” Deepika’s brother Girish said.

Deepika’s own journey, her father Chakthamappa (60) said, started with a costly mishap when she was “five months old” leading to loss of vision in one eye. “She accidentally poked her finger into her right eye. Since there were no facilities nearby, we took her to two hospitals, one was 30 km away and another around 68 km. They kept her in the hospital for two months. They said they couldn’t do much. It cost Rs 3,000, but it was like Rs 3 lakh to us at that time,” he said.Chakthamappa and his wife Chithamma (45) were daily wage farm labourers, earning Rs 800 together on the days they got work. When they didn’t, sometimes “for a

few days in a row, the family went to sleep on an empty stomach”. Chakthamappa also grew tamarind on two acres of land he owned, but incurred losses and went into debt.“Many times when I was young, my brothers and I used to roam around the village searching for fruits fallen on the streets. If we found anything, we picked it up and ate it,” Deepika said.Girish said the financial situation was so dire that their “grandfather died of starvation” and their father “got food only once a day when he was young”.After studying till Class 4 at a school near her home, Deepika moved to the School of the Blind at Kunigal in Karnataka till Class 7, and later went to the Ranga Rao Memorial School for the Disabled in Mysuru till Class 10, where she picked up cricket. The school offered free education and hostel accommodation for visually-challenged children.

But the distance between her home and school meant that every time her father wanted to visit her, he had to borrow money and work on the moneylender’s farm. “He used to come and visit me once every six months. He used to borrow Rs 500-1,000. When I realised that, I told him there was no need to come. Whenever he visited, I used to check his pockets to see if he had money to go back home. When they gave me food in the hostel or any sweets or cake, I used to cry a lot, wondering if my brothers had eaten or not,” Deepika said.After completing Class 10, Deepika returned to her hometown and continued her education at Gnana Jyothi Education Trust’s school, a college about 7 km from her village. It was in 2019 that she received a call from Shikha Shetty, who is now the manager of the national blind women’s team, asking if Deepika wanted to participate in selection trials. The BCCI proudly congratulates the Indian Blind Women’s Cricket Team, who recently won the inaugural Women’s T20 World Cup for the Blind. The entire team visited the BCCI headquarters in Mumbai on December 19 and were welcomed by BCCI Hon. Treasurer Mr. Raghuram...

Deepika thought cricket could be a way out of poverty. A well-wisher from her school days, whom she refers to as “Mohan anna”, helped her with funds to get to the selection trials. Once she made the cut, Samarthanam Trust for the Disabled took care of her. “My life changed after that,” she said.Samarthanam was also the organiser of the six-team World Cup, which was hosted by Cricket Association for the Blind in India and co-hosted by Sri Lanka Cricket Association for the Visually Handicapped. India beat Nepal by seven wickets in the final in Colombo to emerge winners.Summing up the performance, BCCI secretary Devajit Saikia said, “It was a great effort from Deepika and her team and I would like to congratulate them for their brilliant run in the tournament, which has made the whole country proud.”

Pat Cummins ruled out of Ashes, Nathan Lyon to miss Boxing Day Test against England

Australian captain Pat Cummins was ruled out of the remaining two Ashes Tests in Melbourne and Sydney, head coach Andrew McDonald said on Tuesday. The 32-year-old had hinted after the win in the third Test at Adelaide that he could miss the Boxing Day Test, with a decision on his involvement in the New Year’s Test in Sydney meant to be taken later.“He won’t play any part in the rest of the series. That was a discussion that we had a long time out around his return. Yeah, we were taking on some risk. We’ve now won the series, and that was the goal. To position him for further risk and jeopardise him long term is not something that we want to do.”

“Pat’s really comfortable with that. If he had any setback in the build-in as well, we would have shut him down straight away,” McDonald told reporters on Tuesday.Off-spinner Nathan Lyon would also miss the Boxing Day Test, with Cricket Australia saying that the 38-year-old would need surgery after he tore his right hamstring during the Adelaide Test.The hosts have added Jhye Richardson and Todd Murphy to their squad as replacements for both players. Steve Smith, who led in the first two Tests at Perth and Brisbane, will return to captain the hosts in the fourth Test, starting on December 26.Richardson last played a Test match against England at Adelaide in the 2021-22 Ashes series. Murphy last played for Australia against Sri Lanka at Galle in January.“It’s always pretty robust around when you’ve got three, three potential candidates, or even four.



Todd’s been an important part of the key overseas series. England to probe reports of excessive drinking in Queensland

(AP Photo/James Elsby)The report further stated that: “The England party was hardly inconspicuous, drinking by the side of the road, with plenty wearing traditional Akubra hats that became the uniform of the holiday.”And speaking about the incident Key said, “If there’s things where people are saying that our players went out and drank excessively then of course we’ll be looking into that. I’m not a drinker. Drinking excessive amounts of alcohol for an international cricket team is not something that I’d expect to see at any stage. We’ve added security. We’ve got enough ways of finding out exactly what happened. And everything that I’ve heard so far is that they sat down, had lunch, had dinner and didn’t go out late and had the odd drink. I don’t mind that.”Before landing in Australia for the Ashes, England had already ticket off two players Harry Brook and Jacob Bethel after the duo were spotted drinking in New Zealand, the night before the final ODI. And Key said having a break in between the series is absolutely necessary.“Harry Brook is going to spend six days at home this entire winter. Jofra Archer will go through to the World Cup and the Indian Premier League. So I think it’s so important that these players, especially multi-format players, can get away and live a normal life. [But] if it goes into where they’re drinking lots and it’s a stag do, that’s completely unacceptable. I think a drinking culture doesn’t help anyone in any stretch whatsoever. [But] I have no issue with Noosa if it was to get away and just throw your phone away, down tools, go on the beach, all of that stuff.”

Virat Kohli likely to play Vijay Hazare Trophy behind closed doors in Bengaluru

Fans in Bengaluru will not get a glimpse to watch Virat Kohli featuring in the Vijay Hazare Trophy after the local authorities failed to give permission for crowd presence. It is understood that talks between the Karnataka State Cricket Association and the state government authorities is underway and there will be a clear picture as to whether Delhi’s first round match against Andhra takes place at M Chinnaswamy Stadium or not on Wednesday. If not, there is a strong likelihood that the fixture will be played in BCCI’s Centre of Excellence behind closed doors.

Virat Kohli, alongside Rishabh Pant, who is captaining Delhi in the tournament, arrived in Bengaluru on late Mon-

day evening. The Delhi team are scheduled to have their training session at the CoE on Tuesday as a decision on the match-day venue set to be taken by the afternoon.It is understood that KSCA which is headed by former India pacer Venkatesh Prasad, approached the state government seeking permission to host the match in front of 3,000 fans. However, with concerns still remaining about the crowd management and this being a festive season, and the presence of Kohli and Pant would attract huge number of fans. As it could again lead to chaotic scenes, the authorities are understood to have informed the KSCA to play behind closed doors.As far as the venue goes, a committee formed by the state government inspected the Chinnaswamy Stadium to inspect the ground and take a call. It is understood that the KSCA will be informed of the report later in the day. Since the stampede incident which led to 11 people losing their lives outside the Chinnaswamy Stadium premises in Royal Challengers Bengaluru’s victory celebrations on June 4, the stadium hasn’t been allotted any matches. It was scheduled to host the ICC Women’s World Cup opener and final, but those matches were moved out.And ever since Bengaluru was allotted the Elite D fixtures of the Vijay Hazare and it was confirmed that Kohli would turn up for Delhi, fans remained hopeful that they could watch him play Chinnaswamy. Earlier last week, the first two rounds of Delhi, which was scheduled to be played in Alur, was moved to Chinnaswamy.

Why reaching 2700 rating is arguably the hardest leap to make in chess

Wesley So remembers the four years he spent labouring away as a 2600-rated player. The leap from 2500 to 2600 for the Philippines-born American grandmaster had happened almost in the blink of an eye when he was just 15 years old. But breaking into 2700 would have felt like summiting Mount Everest from the Everest Base Camp.Among the sport’s more elusive clubs, the 2700 rating group in chess currently has a membership of 33 grandmasters. Call it the hardest club to leave in chess. Or a quicksand of a rating trap, one which allows you to get in easily, but pulls you in harder, clinging on to you when you try to graduate to 2700—the informal term the sport has for anyone rated over 2700 is ‘super grandmaster’.

“It’s one of the hardest things (in chess),” sighs Wesley So. “It takes time, for sure. It took me like four years to get to 2700 after becoming 2600 at 15. Moving from 2500 to 2600 is relatively smooth for most people. But 2600 to 2700 is really difficult. Because chess is very competitive and there are a lot of young kids who are trying to get to 2700. The thing is there’s also a lot of pressure involved, you know?”India has currently nine challengers—Karthikeyan Murali (2660), Pranav V (26341), Raunak Sadhwani (2638), Pranesh M (2627), Aryan Chopra (2626), Aditya Mittal (2624), Abhimanyu Puranik (2622), SL Narayanan (2616), Leon Luke Mendonca (2615)—fighting it out in the 2600 ratings club with dreams of making the leap to the 2700s some day.Some like Sadhwani already have a plan, drawn up after conversations with others who have breached that frontier.

“I’ve spoken to a few people and I think the solution is to play more tournaments. So first, you need to do some training (camp) for two or three months and then you need to play back to back tournaments to gain ratings. I think this is the way which might be interesting to try and I’m going to do it soon,” Sadhwani, who turned 20 on Monday, Currently playing in the Global Chess League for the Ganges Grandmasters, Sadhwani says that the pursuit of 2700 occupies considerable space in his mind.“Even before the GCL started, I was training (for breaching into 2700). So for me, the process has already started. I train about 6 to 7 hours daily for this.”Mendonca too has been picking the brains of other top players in his quest to raise his level.

(Photo: GCL)“I’ve actually asked many people (what the secret is to making it to the 2700 club). I have been in 2600 for the last two and a half years. In this phase, I have been trying a lot of things, changing a lot of things, talking to different people



like coaches. But finally you just have to do what works for you because what works for someone else may not work for you. So you have to find your own path and hopefully something clicks,” Mendonca, who plays for the Alpine SG Pipers with multiple 2700-rated players like Praggananandhaa, Fabiano Caruana, and Anish Giri tells So points out that there are plenty of perks involved with being a 2700 rated player: much more invitations from elite closed events like Norway Chess and so on. Simply put, it’s easier to make a living from the sport as a 2700-rated player than as a 2600-rated player.“I think the secret to reaching 2700 is just to keep improving. Obviously, not everyone can achieve 2700. But if you just try to keep improving, playing better, you’ll get it eventually. It depends a lot. Because obviously, if you reach 2700, you have a good chance to be a chess professional. You can make a living, good money if you reach 2700,” says So.

Frenchman Maxime Vachier-Lagrave, one of the permanent fixtures in the 2700-rating club, was one of the outliers, having breached the 2700 rating in a hot minute. But the bigger challenge was maintaining his position there.“For me, it was strange, because I jumped from 2600 to 2700 over the course of a summer. But when I got there, I still had to be consistent to stay there. It took me a few years to have a standout result as a 2700. I first made it to 2700 for the first time in 2008 and from there on it was always like being between 2680 and 2730 for like three to four years. The 2013 World Cup was really a breakthrough tournament where I reached the semis,” says Vachier-Lagrave.Ask the Frenchman, who is currently occupying the world no 15 spot in the FIDE rankings, what the difference between a 2600-rated player and a 2700-rated player is, and he replies with a smile: “In general we do everything a little bit better. 2600 players can do things extremely well. We saw at the World Cup that there were so many good results from 2600-rated players. But sometimes we are a bit better prepared, bit more experienced, better in endgames, better in handling nerves. There’s no one particular aspect. But whatever we do, we do a little bit better than 2600.”

In the recent five-match series against South Africa, Gill produced scores of 4, 0 and a run-a-ball 28 before picking up a toe injury that ruled him out of the last two games. In his absence, wicket-keeper Sanju Samson returned to the opening spot alongside Abhishek Sharma for the first time since January 2025 and made an

instant impression with his quick-fire 37.

Samson, who smashed a world record three centuries last year, was unveiled as the first choice opener and keeper in the squad that was unveiled a day later. Kaif blasted the selectors for their timid planning and wasting crucial preparatory matches over the last three months where they experimented with a completely different set-up, involving Gill as vice-captain

“They knew there were better players, I am talking about the T20 format. Just this one. There were better players than Gill. So it was the mistake of the selectors. They have made a mistake and Indian cricket has gone behind. For two to three months, you could have invested in Jaiswal, Samson, and Jitesh,” Kaif said on his YouTube channel.

Kaif said the return of Axar as vice-captain for the first time since January also meant the spin-bowling all-rounder lost crucial months to sharpen his leadership skills under captain Suryakumar Yadav.“It is a loss for Axar Patel who returns as vice-captain and for the Indian team as well. The squad is still solid and there is no doubt. But if Axar had continued as vice-captain, he would have been a part of this team meeting, and he would have gotten time to work on his leadership. Let’s assume Surya gets injured, then if Axar had had those two to three months as vice-captain, he would know more about his team and the players. If he has to captain, he would have been better prepared, so that opportunity was taken away from him,” remarked Kaif.“You carried Gill till the very end and then dropped him. I feel it is the right call. It came late, but it was right. The planning is zero. There is no planning. It has been a waste of time in the name of planning. You backed that player who is not ready now. There were better players than him who should have played. It was your mistake as selectors. Now you had no other choice but to remove him. This has happened very rarely.

Kaushik said, "Aditya narrated most of the film to me, and I felt that this is a good story, but will they be able to pull it off? When we were shooting in Bangkok, they had recreated Lyari there. 8 blocks had been transformed into Pakistan, with all the shops, houses, and alleys. That's when I realised that the scale of the film is huge."

He continued, "I mean, they were using actual houses that people could stay in. They told me that the crew stays in those houses when they aren't shooting. People were living on the set, and they could convert anything that they wanted for the film. For 40 days it was like an actual township. There was a restaurant and separate houses dedicated to the costume, makeup and action teams. That's when I was like, 'Iss film ka scale alag hai' (The scale of this film is something different)."Directed by Aditya Dhar, the cast of Dhurandhar includes Ranveer Singh, Akshaye Khanna, Arjun Rampal, R Madhavan, Sara Arjun, Sanjay Dutt and Naveen Kaushik.

Truth behind Govinda's cameo in Avatar Fire and Ash, years after actor claimed he was offered lead role by James Cameron

Some Govinda fans have been jumping with joy on social media in reaction to a new video that's being widely circulated. The video shows the actor, appearing as a Na'vi, decked up in a glittery, colourful Indian attire, and mouthing his popular "Hata sawan ki ghata" dialogue from David Dhawan's 1997 romantic comedy Deewana Masatana. The caption suggests that this is his cameo in James Cameron's Hollywood epic fantasy threequel, Avatar: Fire and Ash. However, that's not exactly the case.

What's the truth behind Govinda's 'cameo'?

Sorry Govinda fans, but in case you're wondering if there's any truth to Govinda's appearance in Avatar: Fire and Ash, let us break it to you that it's a fake video generated by AI (Artificial Intelligence). Govinda's close-up of speaking in local Mumbai dialect, as Jake Sully (Sam Worthington) and his family react in the background, is not there in Avatar: Fire and Ash. The AI-generated video, of course, stems from Govinda's years-old claims that he was offered to star in the first part of the Avatar franchise, which released in 2009, by director James Cameron. The actor claimed he even met Cameron, but rejected the part even though he was offered Rs 18 crore for it. One of the concerns was his unwillingness to "paint his body blue" to play a Na'vi, the humanoid native of the fantasy world of Pandora in the franchise.

"I had met a Sardarji in America and gave him a business idea that worked. Some years later, he made me meet James Cameron. He asked me to do a film with James, so I invited them for dinner to discuss it. James told me the hero in the film was handicapped, so I said I am not doing the film. He offered me Rs 18 crore for it and said I would be required to shoot for 410 days. I said that is okay, but if I paint my body, I will be in the hospital," Govinda claimed in a chat on Bheeshm International's YouTube channel ear-



lier this year. Govinda even claimed that he suggested Cameron the title of the film. He also added that he regrets the decision since Avatar went on to become one of the world's biggest hits, amassing \$2.92 billion at the global box office. Its sequel, Avatar: The Way of Water (2022) also earned \$2.3 billion.

The threequel, Avatar: Fire and Ash, witnessed an opening weekend of \$347 million. Govinda's longtime collaborator and producer Pahlaj Nihalani dismissed the actor's claims and suggested that he may be referring to their Bollywood sports drama Avatar, which they'd shot 40% portions of but was eventually shelved on Govinda's request. "Woh Avatar title se pata nahi uske dimaag mein kya aaya, baad mein claim karta raha ki main waha (Hollywood) ki Avatar kar raha hoon. Uske dimaag ka disc ghum gaya aur language Hindi se English mein chala gaya (I don't know what happened to him, but he started claiming that he was offered the Hollywood Avatar)," Nihalani told Friday Talkies in 2024.

James Cameron's film has a \$340 mil opening weekend, drops to single digits in India



Avatar 3 Movie Box Office Total Collection Worldwide: With the holiday season in full swing, James Cameron's Avatar: Fire and Ash made an impressive opening at the worldwide box office. In India, however, the opening was compromised because of the monstrous success of Dhurandhar, which continues to dominate the Indian box office. On its first day, Avatar Fire and Ash's collections were 50 percent of its predecessor, and on the 4th day, the film made only Rs 8.5 crore. Ranveer Singh's Dhurandhar, which has been in the theatres for nearly 3 weeks now, made twice that amount on the same Monday. As per the report in Sacnilk, Avatar 3 collected Rs 8.5 crore on Monday, taking its total domestic collection in India to Rs 75.75 crore. On Monday, the film had over 4,300 shows in the country, which is a lot considering Dhurandhar also still holds around 5,400 shows around the country. Avatar Fire and Ash will probably lose some screens after the release of Kartik Aaryan and Ananya Panday's Tu Meri Main Tera Main Tera Tu Meri. Avatar Fire and Ash's collection saw a massive drop after a seemingly successful weekend as the film earned around Rs 25.75 crore on Sunday, and dropped to Rs 8.5 crore on Monday, registering a 67 percent drop.

Globally, Avatar Fire and Ash was eyeing an opening day on \$60 million, and after finishing its first weekend, the film has collected a little over \$340 million (Rs 31.83 billion), as per Box Office Mojo. Avatar Way of Water, which released in 2022, collected over \$2 billion globally by the end of its theatrical run, after opening at \$257 million internationally. While the opening weekend figures for the new Avatar film are better than the previous

one, it is yet to be seen in the new film will also turn into a multi-billion earner for the studio.

Dhurandhar witnesses a significant drop in India On Monday (day 18), at the domestic box office, Dhurandhar added another Rs 16 crore to its overall haul. While the film hasn't dropped down to single digits even in its third week, the earnings on its third Monday were a massive drop, at about 58%, from those on its third Sunday (day 17), when the film amassed Rs 38.5 crore. Over its third weekend, Dhurandhar earned close to Rs 100 crore at the domestic box office, which is the highest in history for any Indian film

While Dhurandhar continues its unstoppable run at the box office, the film has also remained in the news for reasons both celebratory and controversial.
