Fresh influx of refugees into southern Mizoram reveals new complications in western Myanmar

The Mizoram Post, citing sources, reported that more than 40 Myanmar nationals had entered a village in southern Mizoram's Lawngtlai district on 30 April from Paletwa in southern Chin State. According to the report, the asylum seekers fled after the Arakan Army (AA), an ethnic armed organisation at war with the Myanmar junta, tried to forcefully conscript them into its ranks. While Mizoram's home department is yet to confirm the influx, the reported development shows how an increasingly messy conflict landscape in western Myanmar can affect India by aggravating the refugee crisis along its borders and destabilising its cross-border economic interests. Emerging frictions in south-

ern MizoramSince the military overthrew the civilian government in Myanmar in 2021, thousands have fled across the border into Mizoram. According to a recent Economic Times report, the recent arrivals have put the official refugee figures at 34,332. Unofficial estimates stand at some 50,000. Most of the refugees are Chins who share close ethnic ties with the Mizos, which is why they have been given shelter in Mizoram. However, the Mizoram government and civil society remain wary of the asylum situation, which has put additional stress on the state's limited finances and public service infrastructure, especially along the border districts. There are also local concerns around an upsurge in cross-

border narcotics smuggling because of the conflict next door. Beyond these, stray incidents of violence between Myanmar nationals and locals have sparked tensions in southern Mizoram. In March 2023, Mara Thyutlia Pi, a local civil society body representing the Mara tribe in Siaha district, decided to 'seal' the India-Myanmar border after accusing Chin armed groups of murdering three people from the adjoining Lawngtlai district who had crossed over and were found charred to death inside Myanmar.

Weeks later, they accused the Chin Defence Force (CDF)'s Mindat unit of committing the murders and directed the group to hand over the accused to India.

What Binance's \$4 billion fine and CEO resignation mean for crypto | Explainer

The story so far: The U.S. government this week slammed Binance, the world's largest cryptocurrency exchange, with a \$4 billion fine after confirming serious protocol failures as it frequently violated U.S. sanctions. On November 22, Binance's CEO and one of the crypto industry's most powerful players, billionaire Changpeng Zhao, announced his resignation. The crypto market is extremely susceptible to even minor shakeups; the latest update has shocked thousands of traders worldwide who rely on Binance (legally or illegally) to conduct their crypto trades.

Why is Binance's CEO stepping down?

Zhao announced he was stepping down, admitting he had made "mistakes" and that he was doing what he felt was best for the company. In Seattle, Zhao pleaded guilty to violating the Bank Secrecy Act by not maintaining an effective anti-money laundering programme. He will have to pay a \$50 million fine and his resignation is part of a legal deal. "Today, I stepped down as CEO of Binance. Admittedly, it was not easy to let go emotionally. But I know it is the right thing to do. I made mistakes, and I must take responsibility. This is best for our community, for Binance, and for myself," posted Zhao on X on November 22. He named Richard Teng, previously Binance's Global Head of Regional Markets, as the new CEO. Teng has over 30 years of financial services and regulatory experience spanning across Abu Dhabi and Singapore, Zhao said. The former Binance CEO stressed that U.S. agencies did not accuse the exchange of misappropriating user funds or engaging in market manipulation. Zhao also said he would probably be a passive crypto investor focusing on decentralised finance (DeFi), and perhaps train other upcoming entrepreneurs, apart from taking a break. However, he will continue to be a Binance shareholder who is available for company members to consult, Zhao confirmed. Legal experts have pointed out this still leaves the Canadian national with considerable influence over the company he founded in 2017.

What did Binance do to warrant the fine?

Binance was charged with not maintaining a working anti-money laundering programme, as well as running an unlicensed money transmitting business, and violating the International Emergency Economic Powers Act, per court documents dated November 14. U.S. Treasury Secretary Janet Yellen said that the exchange did not report suspicious transactions and it told employees to keep information from law enforcement bodies. That meant millions of dollars in crypto transactions involving criminal actors like the Russia-based dark net marketplace Hydra and users based in sanctioned nations such as Iran were not reported, "allowing illicit actors to transact freely, supporting activities from child sexual abuse, to illegal nar-

cotics, to terrorism, across more than 100,000 transactions." Transactions "associated with terrorist groups like Hamas's Al-Qassam Brigades, Palestinian Islamic Jihad, Al Qaeda, and ISIS" were also unreported. "Binance processed these transactions, but it never filed a single suspicious activity report. And it also allowed over 1.5 million virtual currency trades that violated U.S. sanctions," said Yellen in an official statement on November 21. The Treasury's Financial Crimes Enforcement Network settlement agreement assessed a \$3.4 billion penalty while the Office of Foreign Assets Control assessed a penalty of around \$1 billion, bringing the total to above \$4 billion. This marked the "largest enforcement action" in the Treasury's history, according to Yellen.

Has Binance faced legal issues before?

Binance has faced legal and compliance issues in a number of countries, but swiftly moved past most barriers under Zhao's audacious leadership style, with the company loudly expressing support for regulation while also pulling out of the jurisdictions which tried to regulate or probe its activities. However, the U.S. Treasury alleged that Binance had lied about exiting the U.S. years ago, and that it retained U.S. users as well as "significant" ties with the country. In June this year, the U.S. Securities and Exchange Commission (SEC) hit Binance with a lawsuit, claiming that it was comingling and diverting customer assets to a third party linked with Zhao, and that the exchange broke federal securities laws by "illegally conducting unregistered offers and sales of securities to U.S. investors." How will this affect crypto investors and the sector? While U.S.-based individuals are barred from using the Binance platform, it remains to be seen whether this policy will be strictly enforced under the company's next CEO. Binance has been ordered to completely exit the country and will be strictly monitored from here on.

BNB, the cryptocurrency that helps facilitate trades on the Binance exchange and is native to the BNB blockchain ecosystem, fell by more than 10% to a price of around \$234 as the news of Zhao's resignation broke. However, it slowly began recovering. As more crypto exchanges with U.S. customers come under regulatory pressure, they may decide to comply with the country's registration requirements (even if just on paper alone), or exit the country completely. Some exchanges try to evade legal action by basing their headquarters in foreign tax havens. However, crypto investors who do not want their transactions monitored by centralised authorities or the U.S. government may explore the riskier DeFi route or transact through non-regulated decentralised exchanges (DEXs).

What did Binance's CEO say about FTX?

On December 9 last year, Zhao fired off tweets criticising the collapsed FTX



crypto exchange headed by former billionaire and CEO Sam Bankman-Fried, who was found guilty of financial fraud on multiple counts this October. "You don't have to be a genius to know something don't smell right at FTX," Zhao said and called attention to the company's "reprehensible

misuse of customer funds." But almost a year later, Zhao apologised for his own actions and is leaving behind his crypto exchange which was condemned by U.S. regulators in the harshest terms for criminal practices. This is yet another case which illustrates just how quickly the illusion of stability can shatter in the crypto sector.

With looming TikTok ban in the US, the death of the global internet

The history of the global internet is the history of local apps that strove to become big, fulfilling promises of global connectivity. Our current spate of digital applications stands on the graves of a large number of platforms, applications, environments, products, and tools that were once in vogue. I remember the world before Google, where the only way to find credible information online was through a p2p network of carefully maintained links to discussion forums which were not just digital dumpster fires. There was a time before Facebook where we had just discovered blogging and were finding communities that were experimenting with user generated content. Before Twitter, there were enough spaces on the internet which were fuelled by rage and hate. We didn't have to wait for Instagram to go and get ourselves bullied, negged, and sexualised — there were enough spaces for whoever wanted it, where the most vulnerable people were constantly being violated and attacked. Our social media practices are so overwhelming and encompassing that we forget how new and temporary they are. Many of the legacy apps have already wrapped up. The more persistent ones have evolved so much that they bear almost no resemblance to their original versions. The breathless air of innovation and disruption and the desperate search for something new constantly bombard us with the next big thing which is going to make everything else obsolete. Once the hype dies, the initial curiosity falters and most of these disruptors find their space in the digital ecosystem, with things more or less scrolling along. If there is one unwritten rule of the internet that is rooted in information and

attention economies, it is that this too shall pass. Apps will come and go, with digital life cycles that are more akin to that of fruit flies than tortoises. Given the ephemeral nature of these apps, it does come as a surprise that so many governments around the world keep on trying to control one which has recently been on an upswing — TikTok. In India, we have already mourned the death of TikTok, and a slew of old and new apps have evolved to replace it, grabbing the mindless, repetitive, memetics-driven interactive video-platforming space that TikTok ushered in. The Indian users, devastated when the app first got banned, along with the hyperbolic analysts and speculators who warned us that it was the beginning of the end, have all survived the great loss. As the United States government now considers the banning of TikTok, the questions have come to the fore again — what is it about TikTok that seems to trouble so many people so profoundly? The usual arguments about the brokenness of the internet — misinformation, manipulative algorithms, immersive frivolous content that shapes political decisions, rampant hate and violence, radicalisation of young people on ideological grounds, exploitation of users by selling their data, targeted messaging that makes people vulnerable through AI analytics, and polarisation of societies intensified by filter bubbles — do not work. This is because TikTok doesn't have a monopoly or uniqueness on any of these. If these are the reasons why TikTok has to be banned, we might as well shut down the internet, wear tinfoil hats and wait for the rapture. There is nothing exceptional about TikTok and its policies around content curation, data brokerage and ownership.

Are gallstones linked to an increased risk of Gall-bladder Cancer (GBC)? Health expert answers

Gallstones have long been recognised as a significant factor associated with gallbladder cancer (GBC), particularly in regions like northern India where the incidence of both conditions is high but it involves a complex interplay of genetic predisposition, environmental factors and chronic inflammation. While gallstones serve as a risk factor for GBC, health experts reveal that it is essential to recognise that not all individuals with gallstones will develop cancer.

What are the factors associated with Gall Bladder Cancer?


In an interview with HT Lifestyle, Dr Shivendra Singh, Senior Consultant and Chief of GI Oncosurgery and Liver Transplant Services at Rajiv Gandhi Cancer Institute and Research Centre (RGCIRC), explained, "Gallstones are often detected during examinations for gallbladder cancer, and often, it remains a reason for misdiagnosis. Various studies in India have documented presence of gall stone in 70–90% of patients with GBC. The pathogenesis of GBC is influenced by various cofactors, including age, gender, socio-economic status, and comorbidities such as chronic infections with *Salmonella typhi* or *Helicobacter pylori*. Furthermore, environmental factors like exposure to pollutants, heavy metals, and dietary habits also play a role in carcinogenesis." He shared, "It has been observed that middle aged women around 40 and above with a demographic profile, often referred to as "fat, fertile, female over forty" are generally the subset which is mostly affected with gall stone disease. Additionally, the type of gallstones prevalent in different regions also contributes to the varying incidence of GBC. For instance, in northern India, where cholesterol/mixed stones are predominant, the association with GBC may be more pronounced compared to regions like South

India, where pigment stones are more common."

Should you opt for gallbladder removal due to fear of cancer?

Dr Shivendra Singh revealed, "It's important to note that gallbladder issues, including the presence of gallstones, do not always lead to gallbladder cancer. While gallstones are a known risk factor for cancer development, the majority of people with gallstones will not develop cancer. It's crucial not to generalize the need for gallbladder removal solely based on the presence of gallstones or fear of cancer. Each case should be evaluated individually, considering the patient's symptoms, medical history, and overall health." He asserted, "It's essential to weigh the risks and benefits on an individual basis, considering factors such as age, overall health, and the presence of red flag symptoms. Regular screening and surveillance may be warranted for individuals with known risk factors, especially those with a family history of GBC or other biliary tract malignancies. A comprehensive understanding of the underlying mechanisms, coupled with personalised risk assessment, is crucial for effective prevention and management strategies. Chronic irritation caused by gallstones has been linked to gallbladder cancer, presenting symptoms such as loss of appetite and stomach fullness. However, pain is uncommon in gallbladder cancer, typically occurring only during inflammation due to cholecystitis."

Pointing out that gallbladder cancer may not show much symptoms as such because it spreads very fast, Dr Shivendra Singh said that patients may face certain discomfort and while symptoms can vary, there are some common signs to be aware of: Warning signs include nausea, vomiting, weight loss, and discomfort in the right hypochondrium or lower right side of the



chest wall. In some cases, gallbladder problems can lead to jaundice, a condition characterized by yellowing of the skin and eyes. Jaundice occurs when bile flow from the liver is obstructed, often due to gall-

stones or inflammation of the gallbladder. Some individuals may notice a lump or heaviness in the right upper abdomen. This sensation can be accompanied by discomfort or a feeling of fullness.

Are you parenting your partner? Therapist drops truth bombs that we should be aware of

'Outstanding work': IIT-M team makes mineral nanoparticles with water

Water drops are ubiquitous around us and come in different sizes. They can be as large as a raindrop or as small as aerosol particles released from a spray can. They can be even smaller — invisible to the naked eye — when they come as microdroplets. The latter are just a thousandth the size of a typical raindrop. "We think that droplets are very tiny, and they are not important enough," Thalappil Pradeep, a chemist at IIT Madras, told *The Hindu*. Dr. Pradeep led a study recently published in the journal *Science* that showed microdroplets of water can break minerals down into nanoparticles. The team involved researchers from IIT Madras and the Jawaharlal Nehru Centre for Advanced Studies, Bengaluru. "This outstanding work adds significantly to the growing body of evidence that water droplets enable chemical transformations that bulk water does not make possible," Richard Zare, a chemist at Stanford University who wasn't involved in the study, told *The Hindu*. Eccentricity of water microdroplets In a bucket of water, water molecules at the surface can participate more easily in chemical reactions than those in the bulk. But even at the surface, they'll need to be supplied some energy before they can participate. The water molecules of microdroplets do one better: because they have so little room and are packed closely together, they're more eager to participate in chemical reactions. The water in microdroplets thus engage more readily in exotic chemical reactions that also proceed faster, up to a million-times in some cases. This isn't possible with water molecules in bulk.

For the same reason, microdroplets are also good carriers of electric charge. Dr. Pradeep said they're easy to encounter in this form. Go to the beach, and close to the shore, microdroplets from the spray of water could carry an excess of ions from the salt in the water and settle on your skin, he said. A microdroplet can also become electrically charged in other ways. For example, when a larger droplet loses some water by evaporation and shrinks, the water molecules left behind are pushed closer together, and establish (weak) hydrogen bonds between themselves. This often results in a water molecule shedding one of its hydrogen atoms and becomes a negatively charged hydroxyl ion (OH^-). The freed H^+ is essentially a proton. This process happens in bulk water as well — but because each molecule is surrounded by other water molecules, the protons can't move around much. In microdroplets, the protons easily reach the surface, rendering the surface more acidic and creating fertile ground for chemical reactions. Researchers have shown that amino acids use free protons on their surfaces as an intermediary to form peptide linkages. The new study reported microdroplets have yet another ability. An explosive experiment Dr. Pradeep & co. were interested in whether water microdroplets could break bonds in crystals like silica (SiO_2) and alumina (Al_2O_3) to create nanometre-sized pieces. Spoorithi Bhat, then a PhD student under Dr. Pradeep



and one of the paper's coauthors, set up an experiment to confirm this hypothesis in crystals of quartz (silica), ruby, and fused alumina. She pressed a battery terminal against the outside of a capillary tube. The terminal delivered a few thousand volts to mineral microparticles suspended in water inside the tube. The voltage elongated the suspension, squeezing it out of one end, and sending it flying through the air as a mist of microdroplets. They were still airborne when, in just 10 ms, the mineral microparticles broke up into nanoparticles.

The researchers had a few ideas about what could have caused this break up. The free protons could have squeezed themselves into crystal layers, which they scraped the mineral off from within if supplied some energy. The study suggests the electric fields produced by the charged surface could have provided this energy. Surface tension — the force that keeps droplets spherical — could have been involved as well. In the experiment, a contest between surface tension, which is attractive, and like charges on the surface repelling each other could have set off shockwaves that blew up the microdroplets. "This is a striking and non-intuitive result," Shashi Thutupalli, a biophysicist at the National Centre for Biological Sciences, Bengaluru, who was not involved in the study, said to *The Hindu*. "It seems quite plausible that the high electric field within the droplets could cause the particle breakup." He added that the findings could be useful to the study of protocells, the precursors to cells as we know them today. Scientists are interested in protocells because they could have played an important part in the processes that first created life on the earth. "For me personally, the relevance of these results to the context of the origins of life is very

exciting." He said the microdroplets could mimic proto-cells by being little compartments in which biochemical reactions play out. Making a green paradise The formation of nanoparticles from microparticles, Dr. Pradeep said, is "related to the origin of life, the problem of agriculture, ... to issues as large as water itself. Another problem as big as water is food. It is in this context that soil is probably an interesting thing."

Silica makes up half of sand. Plants absorb silica in the form of nanoparticles to help them become taller. The rice crop usually has high levels of silica. Supplying

soil with silica nanoparticles could thus have a positive impact on agriculture. "Here is a way to convert unproductive soil, unproductive fields or even desertified areas into productive areas," Dr. Pradeep said. He implored scientists to investigate whether water microdroplets react with minerals to form nanoparticles as part of atmospheric processes, in the form of 'microdroplet showers'.
