Rs 5,454 Crore Allocated for Development of Railway Projects in Telangana



“Indian Chronicle, Secunderabad, February 2:“Various railway infrastructure projects worth ₹47,984 crore are currently underway for the development of the rail network in Telangana state.“The Union Budget, with allocations for Railways, was presented in Parliament on February 1, 2026. On this occasion, Union Minister for Railways, Information & Broadcasting, and Electronics & Information Technology, Shri Ashwini Vaishnaw, held a virtual press conference from New Delhi on February 2, 2026, highlighting the key railway budget allocations for Telangana and Andhra Pradesh.“A press conference was also held at Rail Nilayam in Secunderabad, in which South Central Railway General Manager Sanjay Kumar Srivastava and other senior railway officials participated.“Speaking on the occasion, Shri Ashwini Vaishnaw stated that a record allocation of ₹5,454 crore has been approved for Telangana for the financial year 2026–27. He recalled that during the period 2009–14, the average annual railway budget allocation for the undivided Andhra Pradesh was only ₹886 crore. Compared to that period, the current allocation for Telangana has increased by nearly six times, he said.“The Minister further informed that railway infrastructure projects worth ₹47,984 crore



are being implemented in Telangana and that the railway network in the state has now been 100 percent electrified.“He announced that seven high-speed rail corridors have been proposed across the country. Out of these, three high-speed rail corridors will either originate from or terminate at Hyderabad, significantly enhancing passenger convenience. These three corridors will help substantially reduce travel time and together form a triangular network, functioning as an economic growth corridor supporting education, healthcare, business, and other sectors.“With the introduction of high-speed trains, the estimated travel time between Hyderabad and Bengaluru will be around 2 hours, Hyderabad and Chennai about 2 hours 55 minutes, and Hyderabad and Pune approximately 1 hour 55 minutes.“These continuous efforts aim to strengthen connectivity, improve passenger amenities, and support Telangana’s growth as a rapidly emerging industrial and economic hub, the Minister added.

Illegal Constructions Run Rampant in Mallapur

Works Continue Despite Notices
Illegal Constructions Accelerate on Holidays
Government Revenue Suffers Due to Official Negligence

““Nacharam Indian Chronicle, January 2: ““The negligence of Nacharam Circle officials has turned into a boon for illegal construction operators. Town Planning officials, who are expected to be the backbone of the municipal department, are allegedly allowing revenue sources to slip away. Due to non-compliance with rules from lower-level staff to senior officials, the government is reportedly suffering heavy revenue losses. In the Nacharam Circle limits, particularly in the Mallapur area, illegal constructions are in-



creasing day by day. Even though constructions are being carried out without proper permissions, the concerned officials have failed to stop the works, and builders continue construction despite receiving notices. The reasons behind the continuation of these works even after notices are known only to the officials. ““Officials Issue Notices and Wash Their Hands Off“Near Bhavani Nagar Kaman in Mallapur, an individual has undertaken construction of a cellar on a plot of around 80 square yards in violation of regulations. In addition to this, a G+1 structure has already been built, and preparations are underway to add more floors. Construction materials such as sand heaps and bricks have been dumped on the road, causing severe inconvenience to local residents. ““Residents have complained several times to municipal officials about these issues. Eventually, the officials responded by issuing notices, but limited their action to paperwork alone. Meanwhile, construction work is continuing at a rapid pace. ““Locals allege that illegal construction activities intensify on Saturdays, Sundays, and government holidays. Due to the careless attitude of officials who are supposed to take strict action against such violations, the government is losing substantial revenue. Public criticism is mounting, and residents are demanding immediate intervention by higher authorities to curb illegal constructions. ““Alleged Nexus with Illegal Builders““Residents further allege that planning staff and officials of the Nacharam Circle are hand in glove with illegal builders, working in a profit-driven manner. From chainmen to higher-ranking officials, there are allegations that money collection has become the primary objective. Locals have demanded a thorough inquiry and strict action against all those involved.



The World Needs Global Governance for AI—Before the Next Breach Defines Us

Hyderabad: Artificial intelligence has crossed a threshold. What was once a tool confined to research labs is now embedded in governments, corporations, hospitals, financial systems, and even military planning. AI models and autonomous agents increasingly make decisions that affect millions of lives—often invisibly, and often without meaningful oversight. Yet governance has not kept pace. Recent breaches and misuse of AI systems have exposed a dangerous truth: without transparency and global coordination, AI's power can easily turn into a global liability. A recent incident underscored this risk when researchers revealed that widely deployed AI models—many of them open-source and commercially adapted—had been released with weakened or removed safety controls. These models were rapidly repurposed for disinformation campaigns, fraud automation, and cyber-enabled crime. The breach was not a single hack, but a systemic failure: no clear accountability, no standardized safeguards, and no global authority to intervene. This was not a technical flaw alone—it was a governance collapse. At the heart of the problem lies opacity. Modern AI models and agents operate as "black boxes," trained on vast datasets with decision-making processes that are difficult to explain, audit, or challenge. When these systems fail—or are deliberately misused—it becomes nearly impossible to trace responsibility. Transparency is not a luxury in AI

development; it is a prerequisite for trust. Without disclosure of training data sources, safety mechanisms, risk assessments, and deployment boundaries, neither regulators nor the public can assess whether an AI system is safe, fair, or lawful. National regulations, while well-intentioned, are fundamentally insufficient. AI does not respect borders. A model trained in one country, deployed in another, and exploited from a third exposes the limits of fragmented regulation. Companies can simply relocate development to jurisdictions with weaker rules, while harmful impacts ripple globally. This regulatory arbitrage undermines safety efforts and rewards irresponsibility. The result is a race to the bottom, where speed and scale are prioritized over ethics and security. What is needed instead is global AI governance—coordinated, enforceable, and adaptive. This does not mean a single monolithic authority controlling innovation, but rather shared international standards: mandatory transparency requirements, independent model audits, clear liability frameworks, and minimum safety thresholds for high-risk AI systems and autonomous agents. Just as global aviation and nuclear technologies are governed by international agreements, AI—arguably more pervasive—demands similar seriousness. Equally important is the grouping of countries into regulatory coalitions. Forums such as the G7, G20, or newly formed AI-specific alliances can play a decisive role in harmonizing rules, sharing intelligence on emerging threats, and collectively responding to breaches. These coalitions can establish interoperable regulations that prevent bad actors from exploiting legal gaps, while



still allowing innovation within safe and ethical boundaries. Countries that lead in AI development carry a special responsibility to set norms that others can adopt, rather than exporting risk along with technology. Critics often warn that governance will slow innovation. History suggests the opposite. Clear rules create stable environments where responsible innovation can flourish. Transparency builds public trust. Accountability deters abuse. The absence of governance does not produce freedom, it produces chaos, exploitation, and eventual backlash that harms both society and the technology sector itself. The recent AI breach should be treated as a warning, not an anomaly. As AI agents gain autonomy and models grow more powerful, the costs of inaction will only increase. Global leaders, technologists, and policymakers must recognize that governance is not an obstacle to progress, it is the foundation that makes progress sustainable. The choice is stark: govern AI together, transparently and globally, or continue reacting to crises that could have been prevented. The future of AI—and the trust of the societies it serves—depends on making the right decision now.
