Junior Assistant Seen at His Desk for the First Time During Surprise Inspection Allegations of Illegal Patta on 3.00 Acres of Government Land Rock Rebbena Tahsildar Office

February, 08. “Rebbena: Serious allegations have surfaced against a Junior Assistant working in the Rebbena Tahsildar (MRO) Office, raising questions about administrative efficiency, illegal land occupation, and prolonged inaction by higher authorities. “During a surprise inspection of the Rebbena Tahsildar Office by the Asifabad Revenue Divisional Officer, locals reportedly noticed the Junior Assistant sitting at his desk for the first time, which has triggered widespread discussion and criticism among the public. “According to local residents, the Junior Assistant is allegedly incapable of performing basic office duties. There are strong allegations that he is unable to properly read, write, process files, or move official records forward. Locals claim that instead of performing clerical responsibilities, he has been doing work usually handled by an office attendant. These allegations have led to serious criticism regarding how such an individual continues to hold a clerical post. “Background of Appointment” Sources reveal that the Junior Assistant belongs to Kishtapur village. Following the death of his father, he was appointed as a VRA (Village Revenue Assistant) under the compassionate appointment scheme and later joined duties at the Rebbena MRO office. Subsequently, he reportedly completed Open Intermediate and Degree education. “As part of a Telangana Government initiative to regularize long-serving VRAs based on educational qualifications, he was promoted as a Junior Assistant in the Rebbena MRO office. However, public allegations state that despite holding the post, he lacks the minimum competency required to discharge official responsibilities. “Allegations of Corruption and Illegal Activities” Locals further allege that Durgam Janayya, the Junior Assistant, has been working in the same office for several years without transfer, facilitating corruption and irregularities. There are accusations that he has been involved in illegal income certificate issuance, possesses an unauthorized ration card, and has misused his official position.



tion for personal gain. “More seriously, it is alleged that he has illegally obtained patta rights over 3.00 acres of government land in Kishtapur village, a matter that has drawn widespread public outrage. “Complaints Submitted to Collector – No Action Yet” Srinivas, a young farmer and RTI activist, stated that he had earlier submitted a detailed complaint with documentary evidence to the District Collector, Asifabad, regarding the illegal land patta, misuse of ration card facilities, prolonged posting at a single office, and other irregularities involving the Junior Assistant. “He further alleged that despite repeatedly raising the issue during the Monday Praja Grievance (Public Grievance) program, the authorities have failed to take any concrete action. When enquired about the complaint status at the Collector’s office, officials reportedly responded that the matter is “under process.” However, more than four months have passed without any visible action, Srinivas alleged. “Public Demand for Immediate Action” Local residents and activists have expressed strong dissatisfaction over the delay and demanded immediate and impartial investigation into the allegations. They urged senior revenue officials and the district administration to take swift disciplinary and legal action, if the allegations are found to be true, to restore public confidence in the revenue system. “People have appealed to the authorities to ensure transparency, accountability, and strict enforcement of rules, stating that continued inaction would only encourage corruption and administrative negligence.

High Court: YouTube ID Holders Are Not Journalists; Court Pulls Up Fake Reporters, Stresses Qualifications

“Indian Chronicle (Taj Khan), February 8, “In a significant ruling, the High Court has clarified that individuals carrying microphones or operating with YouTube channel IDs cannot be considered journalists. The judgment is being viewed as a strong message to those falsely claiming to be reporters without proper credentials.” The Court emphasized that merely holding an ID card from an unregistered publication or running a YouTube channel does not qualify a person as a journalist. Publications without RNI (Registrar of Newspapers for India) registration cannot be recognized as legitimate newspapers and are to be treated as pamphlets. Consequently, individuals associated with such entities cannot claim journalistic status.” The ruling further underlines that appropriate educational qualifications are essential for working as a reporter. It noted concerns that many individuals without even basic academic credentials are functioning as journalists. According to observations cited in the report, a significant percentage of those presenting themselves as reporters lack the minimum qualifications and professional skills required for journalism, including the ability to write or identify public issues effectively.” The Court also raised concerns over the misuse of press identity cards. It pointed out that some unregistered publications and online platforms are allegedly issuing ID cards and recruiting individuals as “reporters” for financial gain. In several cases, people with no formal background in journalism have been claiming titles such as “CEO” of YouTube channels and using press identification for personal benefits.” The judgment is seen as a wake-up call for those misusing the title of journalist. It stressed that individuals claiming to be journalists must possess recognized credentials, institutional identification, and minimum educational qualifications, ideally at the degree level.” The Court further observed that journalism demands ethical standards and professional integrity. Allowing unqualified individuals to operate under the banner of journalism diminishes the credibility of the profession. There have also been instances where individuals allegedly used the title of journalist to intimidate government officials and others, leading to legal consequences.” In light of these concerns, there have been calls for stricter regulation. Suggestions include conducting written examinations under the supervision of concerned authorities and issuing accreditation



cards only to those who meet the prescribed qualifications.” The ruling has brought renewed focus on safeguarding the dignity, credibility, and professional standards of journalism.

Vishnumurthy stated that as per the orders of Yadadri Bhuvanagiri District Collector and District Election Officer Hanumantha Rao, a notification has been issued regarding the closure of liquor shops (Dry Days) in some areas of Yadadri Bhuvanagiri district to maintain law and order and to conduct free and fair elections. “As part of this, the details of the closure of liquor shops (Dry Days) are as follows: From 05:00 PM on 09.02.2026 until the completion of polling on 11.02.2026, all liquor shops within the limits of Bhongir, Pochampally, Choutuppal, Alair, Yadagirigutta and Mothkur municipalities will be closed, he explained. He stated that all liquor shops, bars, restaurants, toddy shops, and toddy depots within the limits of Bhongir Municipality will remain completely closed until the completion of the election counting on February 13, 2026 (the day of the election results). He added that during this period, liquor shops, bars & restaurants, toddy shops, and toddy depots must remain completely closed. According to the orders of District Excise Officer M. Krishnamurthy, strict action will be taken against those who violate these regulations, as per the relevant laws.


