Rajya Sabha ends Budget session with 110% productivity

New Delhi: The Rajya Sabha was adjourned sine die on Saturday, concluding the Budget session that began on January 28, with Chairman CP Radhakrishnan noting a remarkable 110 per cent productivity and thanking the members for their cooperation. The session witnessed the passage of several key legislations, including the Jan Vishwas (Amendment of Provisions) Bill, 2026, The Transgender Persons (Protection of Rights) Amendment Bill, 2026, The Central Armed Police Forces (General Administration) Bill, 2026, besides the election of Harivansh as the Deputy Chairman for a consecutive term.

CEC removal row: Opposition seeks broader support in Parliament

New Delhi: Undeterred by the rejection of their earlier notices, opposition parties are planning a fresh move to seek the removal of Chief Election Commissioner Gyanesh Kumar, sources said on Saturday.

According to highly placed sources, leaders from several opposition parties are in talks, and at least five senior MPs from different parties — including the Congress, the Trinamool Congress, the Samajwadi Party and the DMK — are working on drafting a new notice to initiate removal proceedings.

Opposition guilty of 'foeticide' of women's quota, will pay the price: PM Modi in address to nation

Sabha due to a lack of the required 66 per cent majority, the Prime Minister assured the women of India that the government would realise the reservation agenda and that it was only "a matter of time."

Beginning his remarks with an apology to women, the PM criticised the Congress for being anti-reform and for disrupting every attempt made to strengthen India. "Every challenge the nation faces today is rooted in this very negative approach and indecision of the Congress," he said, in a no-holds-barred attack on the principal opposition party.

The Prime Minister said women of the country were watching how the Congress and its allies thumped desks in jubilation after defeating a measure aimed at strengthening women's political rights. "They were not thumping desks; they were launching an assault on the dignity and self-respect of Indian women. And women can forget anything but not their insult," he said.

He went on to criticise the Congress, DMK, TMC and SP for stalling the Nari Shakti Vandan Adhiniyam amendments, alleging that these "family-based parties were afraid to share power and do not want women from outside their own families to rise in politics."

"These dynastic parties are insecure about emerging women leaders and therefore opposed the amendment," he added.

The Prime Minister also rejected as "falsehoods" the opposition's claim that the amendments would harm the interests of some states. "This amendment was not about taking anything from anyone. It was about giving more opportunities to everyone. The government repeatedly assured the Congress and its allies that every state would see a proportional rise in seats and benefit from the change. Yet they voted against the amendment," he said.

He accused Congress-led parties of depriving women of their rights for decades by citing illogical technicalities. "The country has now identified this pattern of these parties, whose primary reason for opposing women's reservation is the fear of losing family-based political dominance," he said.

The Prime Minister added that the Congress and its

allies had lost an opportunity to atone for delaying women's reservation for decades. "The people of India will never forgive the Congress and its allies for opposing women's reservation," he said, adding that these parties had been spreading misinformation about delimitation to create divisions.

"Congress has inherited the divide-and-rule policy from the British. It has consistently fueled sentiments that promote division. False claims were made that some states would suffer due to delimitation, whereas the government clarified that neither representation nor proportional share would decrease. This amendment was an opportunity for all states — Tamil Nadu, Uttar Pradesh, West Bengal, and Kerala — to see an increase in seats. However, due to selfish politics, these parties betrayed their own people," he said.

Sharing what he described as the collective anguish of Indian women who had hoped for the realisation of their rights, the Prime Minister said his government would remove all hurdles in the path of women's reservation.

"We did not have the required 66 per cent votes to pass the Bill yesterday, but I know we have the support of 100 per cent of the women of India," he said, pledging to fulfil the agenda in a matter of time.

Centre clears procurement of 20 Lakh MT potatoes in UP; Farmers in Andhra get added relief

New Delhi, APRIL 18

In a major relief for farmers, Agriculture Minister Shivraj Singh Chouhan has approved the purchase of a



substantial volume of 20 lakh metric tonnes of potatoes in Uttar Pradesh, at a predetermined market intervention price fixed at Rs 6,500.9 per metric tonne, it was announced on Saturday.

The government's projected financial contribution towards this initiative stands at Rs 203.15 crore, reflecting strong central support.

This timely measure will empower potato-growing farmers in Uttar Pradesh by securing them profitable returns on their investment and produce, while preventing forced sales at suboptimal prices amid market fluctuations, according to the Agriculture Ministry.

The government has formally approved the procurement of potatoes in Uttar Pradesh, alongside chana procurement operations in Andhra Pradesh, and an impor-

tant extension of the tur (pigeon pea) procurement timeframe in Karnataka.

The minister also extended chana procurement limit to 1,13,250 metric tonnes in Andhra Pradesh and tur procurement till May 15 in Karnataka.

These decisions effectively shield producers from the hardships of distress sales in volatile markets and contribute to overall stability and predictability in the agricultural marketplace, fostering a more secure environment for cultivation and trade.

Chouhan reaffirmed that under the dynamic leadership and visionary guidance of Prime Minister Narendra Modi, the Central Government remains steadfastly committed to protecting and advancing the interests of every farmer across the nation.

He elaborated that a core objective of the administration is to ensure that no farmer is compelled to offload their crops at undervalued rates due to market pressures or any unforeseen circumstances.

Chouhan highlighted the ministry's proactive approach, emphasising continuous and close coordination with state governments to deliver prompt, empathetic, and highly effective interventions tailored to farmers' needs.

He endorsed the Andhra Pradesh government's request under the Price Support Scheme (PSS), initially approving the procurement of 94,500 metric tonnes of chana, also known as Bengal gram.

The minister also elevated the maximum allowable procurement quota for Bengal gram under PSS during the Rabi Marketing Season 2025-26 to an enhanced limit of 1,13,250 metric tonnes.

Andhra Pradesh Intermediate Board Revises Improvement Rules for 2026 Supplementary Exams

AMRAVATHI, APRIL 18

The Board of Intermediate Education, Andhra Pradesh, headquartered in Tadepalli, has issued additional and revised instructions regarding the improve-



ment facility and fee payment for the Intermediate Public Advanced Supplementary Examinations (IPASE) May 2026.

According to the official communication dated April 18, 2026, the Government, after reviewing improvement practices followed by other State Boards, consulting stakeholders, and considering the academic interests of students, has decided to extend the improvement facility to all second-year candidates—both pass and failed—in the Intermediate Public Examination (IPE) March 2026. This provision is aligned with the existing system for first-year students and allows subject-wise improvement with the consideration of the best marks in a single attempt.

In continuation of earlier instructions, the following revised guidelines will be implemented for IPASE May

2026:

Candidates who passed or failed in the first year during IPE March 2026 are eligible to appear for improvement in the papers they have already passed. The best marks secured in each subject will be considered.

Similarly, candidates who passed or failed in the second year during IPE March 2026 are now permitted to appear for improvement in the papers they have passed. The best marks in individual subjects will be taken into account.

No improvement facility will be available for practical examinations.

Candidates who have failed in any subject, whether in the first or second year, may appear for those failed papers without any restriction on the number of attempts until they pass.

The fee for improvement is Rs.160 per passed subject, in addition to the prescribed examination fee. The examination fee is Rs.600 for either first or second year, and Rs.1200 for both years combined.

Applicants must use the same registration number assigned during IPE March 2026 while applying.

The payment window for examination and improvement fees for IPASE May 2026 is scheduled from April 20, 2026, to April 27, 2026.

Real challenge is jobs, incomes & productivity

INDIA's slide from the fourth spot to the sixth one in the latest IMF ranking of the world's largest economies has triggered predictable alarm and partisan point-scoring. But this needs perspective. It is less a story of economic decline than of currency exchange rates, statistical revisions and the limitations of rankings. When the rupee weakens, India's economy appears smaller in dollar terms even if domestic production remains strong. A country can therefore post robust real growth and still lose rank. That is precisely why India, despite remaining among the fastest-growing major economies, has slipped behind the UK and Japan. This should caution against treating rankings as badges of success or failure. Governments often celebrate a rise in position as proof of policy triumph, while critics weaponise a fall as evidence of mismanagement. Neither reaction captures economic reality. A nation's true progress is measured by the quality and distribution of growth. India's strengths remain substantial. The domestic demand remains resilient. The demographic potential is strong, infrastructure is expanding and digital economy growing. But these advantages will matter only if they translate into productive jobs, stronger manufacturing capacity, higher private investment and rising household incomes. A large economy with weak employment generation or stagnant wages cannot draw comfort from rankings alone. Policymakers must recognise that currency stability and macroeconomic credibility influence global perceptions. Persistent rupee weakness raises import costs and erodes GDP standing. Sound fiscal management, export competitiveness and productivity gains are therefore essential.

Farmers Demand Immediate Opening of Maize Procurement Center Near Pindiprolu Village



“KHAMMAM ,TIRUMALAYAPALEM, APRIL 18 (INDIAN CHRONICLE):”Farmers in Pindiprolu village and surrounding areas of Tirumalayapalem mandal are facing severe distress, as their concerns over maize crop sales continue to intensify. Around 8,000 acres of maize cultivation has been carried out in the mandal, but farmers are struggling due to lack of remunerative prices. “At a time when the crop is ready for harvest, the absence of a procurement center and the failure to secure fair prices have left farmers in deep concern. In response, farmers from Pindiprolu and

Keshavapuram staged a protest on the Khammam-Warangal highway near a Shiva temple, demanding the immediate establishment of an IKP maize procurement center. “Farmers expressed that they are forced to travel to distant markets to sell their produce, where they continue to suffer losses due to middlemen. They stated that the current market conditions are unfavorable, and the prices offered for maize are far below expectations, pushing them towards debt. “According to the farmers, even the Minimum Support Price (MSP) fixed by the government is not being implemented effectively, worsening their financial situation. They urged the Mandal Agriculture Officer to respond promptly, assess the crop yield in the region, and submit a report to the Khammam District Collector. “The farmers strongly demanded that a maize procurement center be set up immediately in Pindiprolu village itself. Villagers also emphasized that local authorities must act quickly as the agitation is intensifying day by day. “Farmers warned that if their issues are not addressed promptly, they will escalate their protests further. As the agitation continues, attention is now focused on what actions the government and concerned officials will take to resolve the issue.”

CM Relief Fund a Boon for the Poor: Uppal Congress In-charge Mandumula Parameshwar Reddy

Democracy Defeats Authoritarian Move, Says CPI Leader

Koonamneni Sambasiva Rao Calls Delimitation Bill a Threat to Federal Balance and Equal Representation” “MEDCHAL- MALKAJGIRI, Staff Reporter, April 18 (INDIAN CHRONICLE):” CPI State Secretary and MLA Koonamneni Sambasiva Rao stated that the proposed Delimitation Bill poses a serious threat to the democratic framework of the country. He said that democracy has prevailed over authoritarian tendencies, referring to the united opposition stance against the bill. He was speaking as the chief guest at the CPI Medchal-Malkajgiri district executive committee meeting held at Raj Bahadur Hall in Himayatnagar. Addressing the gathering, Sambasiva Rao alleged that the Central Government, led by Prime Minister Narendra Modi and Home Minister Amit Shah, attempted to introduce the Delimitation Bill in an authoritarian manner in Parliament. He said that opposition parties united and defeated the bill, thereby protecting democratic values. He criticized the bill as an attempt to distort the process of fair representation for political advantage. He explained that delimitation should be carried out based on population to ensure equal representation, but the current proposal may lead to injustice for certain states. He expressed concern that the bill could discriminate against southern states while politically favoring northern states. He emphasized that every vote in a democracy must carry equal value, and warned that implementation of such a bill could increase regional imbalances and weaken the federal structure. He termed the move as being against the spirit of the Constitution and strongly condemned it on behalf of CPI. He also criticized the lack of transparency and public consultation in taking such a crucial decision. On the Women’s Reservation Bill, he stated that it was already approved by Parliament in 2023, and alleged that attempts to revisit or dilute it under the guise of delimitation indicate a conspiracy to delay women’s reservation. He called on people to counter what he described as misleading propaganda by BJP. He expressed full support for the ongoing RTC workers’ strike in the state and urged local leadership to actively participate and ensure its success. He stressed the need for



strengthening the party by addressing local issues and working towards solutions. He also called for focused efforts in upcoming municipal elections, with assurance of support from the state leadership. He added that people are increasingly looking towards CPI, and urged party leaders to connect with the public, build confidence, and work towards organizational growth. ED conducts raids at AAP MP Ashok Mittal's residence, Lovely Professional University

The Enforcement Directorate (ED) on Wednesday conducted raids at the Jalandhar residence of AAP Rajya Sabha MP and Lovely Professional University (LPU) founder-chancellor, Ashok Kumar Mittal, along with premises linked to the university. Mittal, a prominent educationist-turned-politician who recently replaced Raghav Chadha as AAP's Deputy Leader in Rajya Sabha, is at the centre of the probe. Details of the case have not been offi-

cially disclosed yet.

Punjab Chief Minister Bhagwant Mann strongly condemned the raids, calling them a "typical Modi-style" political vendetta ahead of the Punjab elections. "BJP has started preparations for Punjab elections... ED raids at AAP Rajya Sabha MP Ashok Mittal's house and university... typical Modi style..." he posted on X as he wrote a couplet by a poet, saying the AAP would not get cowed down. The development has triggered a major political row in Punjab, with AAP alleging misuse of central agencies against opposition leaders. Further updates are awaited as the raids continue. ED has often raised AAP leaders in Punjab. They include Sanjeev Arora, when he was an AAP Rajya Sabha MP from Punjab. ED raided his residence in Ludhiana and other linked premises in October 2024 in a money laundering case related to alleged land fraud. Kulwant Singh (AAP MLA from Mohali) was raided multiple times, including in October 2023 and April 2025, in connection with the massive PACL Ponzi scam. AAP MLA Jaswant Singh Gajjanmaira was also raided and later arrested in 2023 in a money laundering case linked to a bank fraud. He had faced earlier ED action in 2022 as well.

Familiar men decamp with Rs 17 lakh while a Bengaluru resident was out for Yoga, 5 held

The Bengaluru police have arrested four men and apprehended a minor boy for allegedly stealing valuables worth Rs 17 lakh from a house in BEML Layout by exploiting their familiarity with the homeowner. The police have recovered 115 grams of gold ornaments and Rs 13,400 in cash. According to the police, the theft occurred on March 31, while the complainant was out for yoga practice. On returning, she found the lock of her house broken and gold ornaments and cash missing, following which a case was registered.

Acting on credible leads, the police apprehended two suspects near Dasarahalli on April 3 and first recovered Rs 8,100 in cash along with an autorickshaw allegedly used in the crime. Later the same day, another accused and a minor boy were secured near the Anmod village checkpoint on the Ramanagera-Goa road. The police said the accused were known to the victim and lived in the same locality. They had gained her trust by helping her with minor household chores. "This was not a random burglary. The accused were familiar with the victim's routine activities and had prior knowledge of the house and storage of valuables. They used this trust to plan and execute the theft," a police officer said. The arrested have been identified as Nandish,



Someshwara, Madhugowda, and Bhima, all aged in their early to mid-twenties. They were produced before a court on April 9 and remanded in judicial custody. During interrogation, the accused allegedly confessed to the crime. The minor boy was produced before the Juvenile Justice Board, while the others were taken into police custody. Further investigation revealed that part of the stolen gold had been kept at the accused's residence, while the gold was sold to known persons and at jewellery shops in Yadiyur and KP Aghara.

Blacklisting, scrapping licences: Noida admin sets tough rules for contractors after workers' protest

The Noida administration Tuesday evening stated that in case of 'disruptive conduct' or 'violence' by workers, their outsourcing agencies and contractors will also be held accountable. "If any disruptive behavior is carried out by an outsourcing agency or its employees/workers, the agency will also be held responsible. Such agencies may be black-listed, and action may be taken to cancel their licences," said Noida District Magistrate Medha Roopam.

This comes in the backdrop of a protest by thousands of workers in Noida on Monday demanding better wages, which turned violent, with demonstrations continuing into Tuesday. A total of 7 FIRs were registered while 396 people, including four women, were arrested. A meeting of outsourcing agencies and contractors of various industrial units was held late Tuesday evening, where all contractors were told to ensure payment of prescribed wages as per government guidelines, and were also asked to train their workers in a manner that maintains discipline and peace. Roopam said that industries, workers, and employers are complementary to each other. "Smooth functioning of industries safeguards employment opportunities, while stability of employers ensures the future of workers. If industrial activities are disrupted, it adversely affects all stake-



holders as well as the overall development of the state," she said. The Uttar Pradesh government Tuesday had increased wages of workers across categories as an interim measure. For Gautam Buddha Nagar and Ghaziabad, the interim monthly wages have been increased by 21%: Rs 13,690 for unskilled workers from the earlier Rs 11,313; Rs 15,059 for semi-skilled workers from 12,445; and from Rs 13,940 to Rs 16,868 for skilled workers. The meeting was attended by Additional District Magistrate (Finance & Revenue) Atul Kumar, DD Factory Brijesh, officials of departments concerned, and contractors from various industrial units.

Chikkamagaluru police weigh suicide theory in Kerala teen's death at tourist spot

The police in Karnataka's Chikkamagaluru said Wednesday they are considering suicide as a possible cause in the death of a 14-year-old girl from Kerala, whose decomposed body was found near a popular tourist spot, even as they await post-mortem and forensic reports to determine the exact circumstances. The police have ruled out foul play for now. Sreenanda went missing on the evening of April 7 while visiting the area with nearly 40 relatives, triggering panic among her family. Her body was found in a deep gorge near Manikyadhara Falls on April 10 after a search operation. Initially, the family, who are from Kerala's Palakkad, suspected abduction or foul play due to her sudden disappearance. However, the police said there is no evidence so far to support these claims. The police said an accidental slip appears less likely, noting that the area was crowded at the time with 60 to 100 people present, yet no one reported hearing screams or witnessing any disturbance. Investigators also pointed out that the terrain—filled with rocks, trees, and bushes—would typically slow or break a fall, raising questions about how the body ended up at such a depth. They suggested this could be more consistent with a deliberate jump. "Prima facie, no foul play is suspected. We are awaiting the post-mortem report and foren-

sic analysis to corroborate the findings and determine the exact cause of death," a senior Chikkamagaluru police officer said. According to Chikkamagaluru police sources, the girl, who was with nearly 40 relatives, crossed the safety barricades installed at the location and went missing around 5 pm on April 7. The barricades, consisting of three parallel grills about 5 feet high, are meant to prevent visitors from entering hazardous areas. Her father had scolded her for crossing the barricade shortly before she disappeared. At the time, around 60 to 100 people were present at the spot. "There were no reports of any commotion, arguments or screams that would suggest foul play," a police officer said. Search efforts were launched soon after she was reported missing, and her body was recovered in a decomposed state nearly four days later. They also pointed out that no mobile phone was recovered. The girl had been using her mother's phone to take photographs before she went missing. The Chikkamagaluru police added that the site is a popular tourist destination that sees around 1,000 visitors daily, and no similar incident has been reported there before.

SC, ST Commission chief alleges snub by Siddipet Collector

Surveillance at nakas, rising traffic hassles: Multiple barricades bring Chandigarh traffic to a near crawl

Chandigarh's heightened security crackdown marked by solar-powered cameras at naka points streaming live feeds to the Police Control and Command Centre — is tightening surveillance across the city, but the accompanying barricading within internal sectors is increasingly drawing criticism from residents over traffic congestion and daily inconvenience. The stepped-up checking follows recent incidents, including the daylight murder of Chamanpreet Singh, alias Chini, in Sector 9 and the grenade attack at the BJP office in Sector 37. Police have since expanded their naka network, setting up around 40 checkpoints in the morning and another 40 in the evening, with nearly 5,000 vehicles being checked on regular intervals.

Police officials said the naka locations and personnel deployment are being rotated regularly based on intelligence inputs to prevent predictable escape routes. The addition of solar-based cameras at these points has enabled real-time monitoring of vehicle checks and movement across the city. However, on the ground, the experience for commuters has been far from smooth. "I was crossing towards Mullanpur via the PGI-Khuda Lahora road when a major traffic snarl took place due to these nakas," Saurabh Sharma, a resident of Sector 39, said. "There was heavy congestion, and it didn't seem like traffic was being regulated alongside the checks," he added. Rajbir Kaur, another commuter, said the situation has become a daily ordeal. "The checking is intense, but there is no planning for traffic flow. During peak hours, vehicles pile up quickly, and people are left waiting for long stretches," she said. Concerns have been echoed by resident welfare bodies as well. Federa-

tion of Sector Welfare Associations Chandigarh (FOSWAC) president Baljinder Singh Bittu said the arrangement is leading to widespread inconvenience. "This barricading in the internal sectors of the city is leading to complete traffic chaos. After the recent crimes, while police have set up nakas in internal areas as well, vehicles have started piling up, especially during late evening hours when offices close and in the morning rush," Bittu said.

"After four to five cycles of the traffic light turning green, a commuter is able to move just one light point, and that is because of multiple barricading on the roads," he added. Bittu said he has personally witnessed long queues at several key junctions. "At Sector 21, the Sector 18-19 intersection, Sector 9, and many other places, people have been complaining. Even when children are heading to school, traffic in nearby areas gets piled up due to abrupt barricading. Is this the way crime prevention should be done? Commuters across the city are getting harassed," he said. Chandigarh Residents Association Welfare Federation (CRAWFED) chairman Hitesh Puri also questioned the approach. "With these multiple barricading points inside the city, unnecessary traffic is being blocked. Rather than deploying this level of heavy barricading, the police should increase beat policing and patrolling," Puri said. He added that strengthening existing surveillance infrastructure may yield better results. "The city police should focus on ensuring all CCTV cameras are functional. That will ultimately provide footage of criminals trying to escape," he said. Puri also cited the impact on daily routines. "One of my office staffers earlier used to leave Sector 47 at 9.30 am and reach Sector 22 by 9.50 am. Now he starts at 9.10 am and still reaches at 9.50 am because he gets stuck at five check points inside the city. There is no point in blocking roads with so many nakas," he said. Meanwhile, police officials maintain that the intensified measures are yielding results on the ground.

A senior UT police officer said increased barricading has led to the arrest of drug peddlers and other criminals who were moving around the city with weapons and allegedly planning offences. "The naka positions are changed based on intelligence inputs. This is helping in checking snatchers and other criminals effectively," the officer said, adding that the aim is to create a strong deterrent and plug gaps exposed in recent incidents where accused managed to escape.

Land acquisition for Aerotropolis project: Farmers end hunger strike after assurances from govt on key demands

Suresh Pakale Lifetime Achievement Award Emphasising the government's stance, Mundian said, "development cannot come at the cost of people's sentiments. The government respects public concerns above all". The hunger strike by farmers and landowners to protest the land acquisition for the Aerotropolis project in Mohali ended on Tuesday after the Punjab government accepted their key demands and offered assurances. The protest, which had been ongoing for several days outside the GMADA office, was formally called off after farmer leaders were offered juice, marking its conclusion. The state Housing and Urban Development Minister Hardeep Singh Mundian, along with Mohali MLA Kulwant Singh, led the negotiations, while GMADA Chief Administrator Sakshi Sawhney and Land Acquisition Officer Rohit Jindal were also present.

"The Punjab government is fully committed to safeguarding the interests of farmers and landowners. No decision regarding farmers will be taken without their consent," Mundian said while addressing the gathering. He clarified that land acquisition for Aerotropolis blocks E, F, G, H, I and J would be undertaken only with farmers' approval. The minister acknowledged the role of MLA Kulwant Singh in bringing the concerns of affected farmers to the Chief Minister's attention, which led to swift intervention and resolution. Before concluding the protest, Mundian read out and handed over a written document outlining the accepted demands. As per the decisions, the validity of the Sahulyat Certificate has been extended from two to four years, while the timeline for applying for tubewell connections has also

been increased to four years, with installation to be ensured within two months on priority. All plots, including those in preferential locations, will now be included in the draw of lots to address concerns of fairness. In view of legal proceedings and High Court directions regarding valuation, pending compensation in certain pockets will be deposited in the reference court, while development work will be expedited and payments for unaffected properties released promptly. The government has also committed to completing all development works within three years from the date of land possession. Under enhanced land pooling benefits, there has been a marginal increase in both residential and commercial entitlements per acre, while all eligible farmers will be issued trustee certificates and allotted plots as per their landholding. Additionally, conveyance deed charges have been waived for original landowners. The government has assured that essential village infrastructure such as government schools, parks and dispensaries will remain outside the acquisition ambit, while sewerage, water supply and stormwater systems will be integrated with GMADA infrastructure. Necessary development works, including roads, will be undertaken, with GMADA extending financial support wherever required. Houses located along the village 'phirni' will be exempted from acquisition, while those falling within agricultural fields under the planning area will be relocated appropriately. Emphasising the government's stance, Mundian said, "development cannot come at the cost of people's sentiments. The government respects public concerns above all". MLA Kulwant Singh expressed gratitude to the Chief Minister and the Minister for accepting the farmers' demands and thanked farmers and landowners for their cooperation.

Fully committed to uphold, advance Baba Saheb's ideals, Congress politically neglected him: Saini

He continuously fought against social discrimination and described education as the most effective medium for social upliftment. It is solely through education, awareness and unity that we can bring about positive change in society."

Emphasising his government's commitment to upholding and advancing Baba Saheb's ideals, Saini said the BJP government has launched numerous schemes for the welfare of every section of society, with the objective of ensuring that the benefits of development reach every section of society in keeping with the principle of 'Antyodaya'. Saini said the BJP government firmly believes that the holistic development of the state and the nation is impossible without empowering every section of society. "We are continuously formulating policies designed to uplift the weaker sections of society. The state government has implemented several welfare policies to ensure quality education, employment, social security and equality of opportunities," he said.

Criticising the Congress, Saini alleged, "In 1946, when the Constituent Assembly was being formed, the Congress tried its best to prevent him from entering it. But Baba Saheb reached there through his talent and struggle. Even then, he was never truly accepted by the Congress leadership. 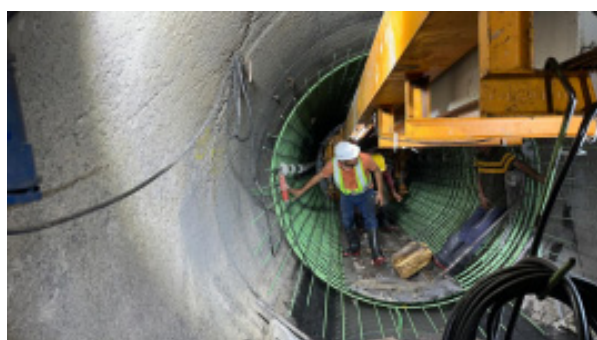

Tunnel Boring Machine (TBM) Nayak was launched last week for the Thane-Borivali tunnel, with a bullet train TBM assembly beginning simultaneously. Beneath the city, a network of tunnel boring machines (TBMs) has been steadily reshaping Mumbai, cutting through rock to build Metro lines, road tunnels and water networks. But one of them never made it back. Nearly 60 metres below Powai, a German-made TBM lies buried in volcanic ash and monsoon sludge, abandoned after a rare engineering failure. And no one is coming for it.

The machine had been deployed by the Brihanmumbai Municipal Corporation for a water conveyance tunnel from Veravali to Ghatkopar. In 2019, it got trapped in loose volcanic ash beneath the SCI establishment in Powai. For a civic body that has executed close to 100 km of water tunnels, this was an unprecedented setback. The project has since seen delays, a cost escalation of Rs 419 crore, and the deployment of a new machine to complete the remaining stretch, leaving the original one entombed beneath the city. Such incidents are rare not just in India but globally. In 2013, Bertha, then the world's largest TBM, stalled during a highway tunnelling project under Seattle and was eventually freed after four years. In Mumbai, repeated attempts to retrieve the machine failed. After heavy monsoon flooding in 2020, extraction became virtually impossible. As Mumbai launches two giant Tunnel Boring Machines, one lies abandoned 60 metres below Powai, and no one is coming for it. Since soil conditions along the stuck TBM were difficult to work with using TBM technology, the BMC deployed the NATM (New Austrian Tunneling Method) to bore nearly 420 metres of stretch. NATM involves manual excavation by provide continuous support through rock bolting, installation of steel liners etc. to stabilize the earth around the tunnels portion. About 50 metres away from the stuck TBM, the BMC has deployed the NATM method for 420 metres to avoid similar mishap.

The Brihanmumbai Municipal Corporation awarded work orders for the Veravali-Powai-Ghatkopar water supply tunnel project in January 2012. Estimated at Rs 263 crore, the project comprised two stretches: a 2.2-km tunnel from Veravali to Powai and a 4.4-km stretch from Powai to Ghatkopar. The aim was to improve water distribution in the eastern suburbs, particularly in L and N wards, covering Kurla, Ghatkopar and Vikhroli, by augmenting supply to Veravali and Ghatkopar's high level and low level reservoirs. For the tunnelling work, the BMC, through its contractor, procured a German-made tunnel boring machine from Herrenknecht. The machine had a diameter of 2.8 metres, length of 50 metres and a total weight of approximately 80 tonnes. In 2012, the TBM machine was procured at the cost of Rs 32 crore. As Mumbai launches two giant Tunnel Boring Machines, one lies abandoned 60 metres below Powai, and no one is coming for it. Floating a new tender, the BMC has procured a new TBM machinery to bore through the remaining stretch of 2.7 km.

A TBM operates through a rotating cutter head fitted with teeth, spokes and sharp protrusions that cut through soil and rock as the machine advances. During excavation of the 4.4-km stretch from the Powai shaft towards Ghatkopar, the machine faced repeated halts due to weak ground conditions. In August 2019, after boring about 1.2 km, it came to a complete stop after getting stuck in pyroclastic volcanic ash that is highly loose and unstable. The machine remains lodged about 60 metres below ground beneath the Shipping Corporation of India (SCI) establishment in Powai, still over 3 kilometres short of its destination. "What a TBM demands is a hard, rocky surface to provide external stability to the structure as it manoeuvres through the ground. If the soil is loose, it doesn't get the stability. At the SCI point, the soil condition was extremely bad. In fact, the soil was slushy, almost liquid-like. That made it impossible for the TBM to move and it got stuck," a BMC official, involved in the project during the period, told Officials said the soil conditions were confined to a small stretch that was not identified during the preliminary surveys conducted after every 800-metre stretch around the site of work. "Mumbai

lies in the Deccan area and as such, enjoys the advantage of rocky soil conditions that aids in tunnel boring. However, geological conditions at the Powai point were complex with slushy strata observed within a very small stretch. Typically, soil strata are not found anywhere in Mumbai, which predominantly has basalt rock strata," an official added. Another BMC official, privy to developments, said, "We have bored and executed over 100 kilometres of water tunnels across Mumbai. But this is the first time that we encountered such a problem."

Once the tunnel boring machine got stuck in volcanic ash, retrieving it became a major challenge for the BMC. "Our challenge was not only to extract the expensive machinery but also to do it safely, without causing any injuries or fatalities to the manpower operating it," a civic official said. A big hurdle, officials said, was posed in the restricted working space owing to the machine size. "The machinery had a diameter of 2.8 metres, along with lots of ancillary machinery and cables. At the bottom of the machine lay rails and grippers. The machine is huge, which left us with hardly any space to work manually. It was not even possible for workers to move towards the machinery as the entire portion was slushy," said the BMC officer.

As Mumbai launches two giant Tunnel Boring Machines, one lies abandoned 60 metres below Powai, and no one is coming for it. The machinery was so badly buried within slush that instead of moving horizontally, it started slipping into the ground. The situation worsened after a heavy monsoon spell in June 2020, which left the machinery completely Between 2019 and 2020, the civic body approached several tunnelling experts across the country to find a solution. It also set up an expert committee led by an IIT Bombay professor and sought advice from agencies such as Tata Consulting Engineers. Tunnelling experts from National Institute of Rock Mechanics (NIRM) were also approached to assist with solutions. However, officials said India has limited expertise in handling such machines, which are largely designed and operated with foreign support, especially from Europe and China. The BMC also reached out to international experts, including in Germany, but could not arrive at a solution.

The situation worsened during the heavy monsoon of June 2020 when continuous rain led to slush filling up the tunnel. The front portion of the TBM was buried in loose ash and the surrounding ground became unstable, making any attempt to pull it out nearly impossible. "Nearly 80 per cent of the machinery was buried and it became nearly impossible to prevent the seepage of water and access the machinery. The net result of every attempt by us was zero," said an official. With recovery efforts failing and costs of extraction mounting, the BMC in 2021 decided to scrap the earlier contract. After consultations with its engineers and experts from IIT Bombay, the civic body opted to deploy a new TBM and dig a fresh tunnel instead.

As Mumbai launches two giant Tunnel Boring Machines, one lies abandoned 60 metres below Powai, and no one is coming for it. Floating a new tender, the BMC has procured a new TBM machinery to bore through the remaining stretch of 2.7 km. Akin to the previous TBM, the new one has an external diameter of 2.8 metres and an internal diameter of 2.2 metres. In August 2025, the new TBM achieved breakthrough. With the original tunnel abandoned, the BMC floated a fresh tender to complete the remaining stretch from the SCI complex in Powai to Ghatkopar's high level and low level reservoirs. This time, stricter conditions were built into the tender while inviting bids. In December 2022, the contract was awarded to Patel Engineering at a cost of Rs 419 crore. A new tunnel boring machine was procured again from German manufacturer Herrenknecht, with a diameter of 2.8 metres. However, given the loose soil conditions where the earlier machine got stuck, the BMC adopted a different approach for part of the stretch. Instead of using a TBM, it deployed the New Austrian Tunneling Method for nearly 420 metres. This method is typically used in weak soil conditions and involves gradual excavation with continuous support to stabilise the ground. About 50 metres away from the stuck machine, contractors used this technique to reconnect with the earlier tunnel alignment over the 420-metre stretch. Beyond this, tunnelling resumed using the new TBM for a further 2.7 km. The work continued to face difficult ground conditions, including hard rock, fractured formations, cavities and water seepage. Despite these challenges, the new TBM achieved its breakthrough in August 2025, more than a decade after the project began. Speaking to The Indian Express, Abhijit Bangar, additional municipal commissioner projects, said the work is now nearing completion. "Boring by the Tunnel Boring Machine as well as NATM has been completed. The work on lining is progressing and work is expected to be completed by March 2027," Bangar said.

BJP washing CM's residence with Gangajal after I vacated it similar to Ambedkar's insult: Akhilesh Yadav

Samajwadi Party president Akhilesh Yadav on Tuesday said that BJP's move of washing chief minister residence with Gangajal in Lucknow after he vacated the house in March 2017, was similar to BR Ambedkar's insult in Maharashtra's Chavdar lake where the Dalit icon was assaulted by feudal forces for drinking water from a waterbody. In an appeal to people belonging to PDA (Pichhde, dalits and minorities) issued on Ambedkar's birth anniversary, Yadav said the entire nation knows about the incident that happened at Chavdar lake in Maharashtra. "Feudal people (samantvadi) had beaten Baba Saheb and his people with canes for drinking water from a talab (waterbody) where generally cattle of the elite section used to drink water," Yadav said.

He added, "That incident of Baba Saheb's insult in Maharashtra had happened on March 20, 1927. After 90 years of that incident, a similar insulting incident happened to me on March 20, 2017. When I vacated the chief minister's residence on March 20, 2017, BJP people get the CM residence washed with Gangajal because a person of PDA

community had been living there," former chief minister said in the appeal and added that mindset of feudal people has not changed even after so many year of insult of Baba Saheb.

India's first quantum computing testing facility launched

Andhra Pradesh Chief Minister N Chandrababu Naidu on Tuesday formally launched India's first indigenous quantum computing testing facility at SRM University in Amaravati. With this, the CM said, the Amaravati Quantum Valley will emerge as an international quantum computing hub. Naidu witnessed a live quantum system initiation with the cooling process of the processor on the Amaravati 1Q system being triggered virtually, as the system is housed at Medha Towers in Gannavaram. At the same time, the Amaravati 1S system functioned as an open-access setup fully visible to all attendees during the demonstration. With the setting up of the Amaravati Quantum Reference Facility, India now has open sovereign quantum infrastructure, officials said. The Andhra Pradesh government's flagship quantum technology hub under India's National Quantum Mission, the Amaravati Quantum Valley, will be hosting an IBM 133-qubit quantum computer and has engaged in 80-plus industry and academic partnerships, positioning it to be among the top five global quantum hubs. The launch of AQRF on World Quantum Day adds an indigenous hardware dimension to Amaravati Quantum Valley's portfolio, complementing its existing quantum cloud, skilling and innovation infrastructure, officials said.

3 bodies in 20 days, 4th on way: Another Haryana man dies fighting Russia's war

For Rakesh Kumar, a bus driver with Chandigarh Transport Undertaking, the wait is never ending. It has already been 10 days since he was told that his son Anshu is dead. The 25-year-old, hailing from Kathowas village in Rewari, went to Russia in April 2025 on a study visa, but was allegedly inducted into the Russian Army and sent to the front.

"On April 4, a former soldier who had served in the Russian army informed us that Anshu is dead. He told us the body would first be brought from Ukraine to Moscow and then to India within 10-15 days. Since then, we have

been waiting," said a distraught father. On March 26, the body of 22-year-old Anuj Sharma from Cijhora village in Karnal was brought to India. He had travelled to Russia in May 2025 on study visa, but was persuaded to join the army. His brother, Arjun Sharma, said, "He couldn't land a job there. Later, a few Russian soldiers persuaded him to get enlisted, assuring that he would only be required to dig bunkers. He enlisted on August 28, 2025... On October 20 he suffered bullet injuries. His body remained buried under snow for months before finally being brought back to India on March 26 this year."

Two more cases came to fore early April. On April 2, Ankit, 30, from Kurar Ibrahimpur village in Sonapat district, returned in a coffin. He had initially been working at a hotel in Moscow before being recruited into the Army. His last contact with his family was on October 12, 2025. On April 4, Ankit Jangra, 23, from from Kumharia village in Fatehabad was cremated after his body arrived from Russia. He had gone to Moscow on a study visa in February 2025 and was allegedly lured into getting enlisted. His friend Vijay Poonia, who had travelled with him, remains missing. Families across Haryana continue to wait for news of their sons. Aman, 24, from Madanheri village in Hisar, has been missing since September 2025. "Someone in Russia lured him with the promise of a Rs 2.5 lakh monthly salary and an advance of Rs 10 lakh," said his brother Aashish.

'Police intimidation of party candidates at BJP's behest': Congress files complaint with EC

Congress candidates from Vasna and Sarkhej wards may not contest the April 26 election to the Ahmedabad Municipal Corporation. Congress candidate Bharat Bharwad, who received the party's mandate for Sarkhej ward, withdrew his form on Monday. The last date for withdrawal of nominations is April 15. On the other hand, Congress candidate Falguniben Rawal did not reach the election office to submit her nomination despite the party's mandate to her for Vasna ward, an OBC reserved seat.

On Tuesday, Congress leaders led by Gujarat Pradesh Congress Committee president Amit Chavda submitted a memorandum to the State Election Commissioner S Murali Krishna alleging police intimidation of its candidates and supporters at the behest of the ruling BJP. "The withdrawal of the Congress candidate from Sarkhej ward of Ahmedabad Municipal Corporation is a serious issue. Two other candidates of the Congress have also been taken away by policemen. Such information is being received and they have been kept in unknown places. The Congress candidates should be released immediately. The husband of Kinjalben Shambhubhai Jadav, a candidate from Ward No. 4 of Tarapur Municipality in Anand district, is being taken to the police station and threatened by police to withdraw her nomination papers," Congress complaint alleged. The Congress has demanded that an impartial inquiry committee be appointed to probe the allegation of police intimidating Congress candidates across the state. "All those police officers who are working under political pressure should be immediately transferred and relieved from election duty, an FIR

should be immediately filed under election offenses and the CDR of their mobile phones should be collected so that the illegal activities done by them can be known," the party said in its memorandum to the SEC.

The Congress also accused BJP leaders of threatening Congress candidates to withdraw their forms and alleged that they are even using the government machinery for this illegal action. "A senior BJP leader is using social pressure along with other pressure tactics to disqualify Ramilaben's nomination. Till late last evening, she was being pressurised," Congress spokesperson Manish Doshi told. Ahmedabad City Congress committee president Sonal Patel said, "The BJP is also trying to get our candidates to withdraw in the western areas wards like Jodhpur, Thaltej, Chandlodiya, Bodakdev, which are BJP strongholds."

In the complaint to the SEC, the Congress demanded "adequate protection" to all its candidates so that they can contest the elections without any fear. They also urged the poll panel to instruct all election officials not to misuse the power and position they have been given. Citing some cases in its complaint, the Congress has listed instances from Kalol, Ahmedabad and Surat, Tarapur Municipality in Anand district among others, even naming police officials of LCB and SOG of these areas. "Despite this matter being brought to your attention, the police harassment has not reduced but has increased in the entire state. We have also come to know that the police are going to the party offices in Ahmedabad and Surat and District Congress Committees asking for information about the candidates and then pressuring them to withdraw their nominations. In one place, if the name is not in the electoral roll, the form is rejected, while in Veraval Municipality, the form is accepted even though the name of the BJP candidate is not in the roll. How can different decisions be made under the same rule?" the party sought to know in the complaint. "It has also been found that despite the names of BJP candidates appearing in two different places in the electoral roll, their forms have been approved despite our objections," the Congress said in its complaint to the poll panel. "Elections in a democracy is a sacred right of the people. If the police system itself intimidates the opposition candidates at the behest of the ruling party, then the State Election Commission's oath of holding elections in a 'free, fair and fear-free' environment will prove futile," Chavda said after submitting the complaint to the SEC office in Gandhinagar.

While a dispute occurred in Kasganj between groups of Dalit and Yadav communities over taking out a procession through a locality, two Dalit groups clashed in Lakhimpur Kheri over installing a statue, resulting in stone-pelting and burning of a police vehicle. In Kasganj, the dispute occurred at Chahak Gunar village after people purportedly belonging to the Yadav community tried to stop an Ambedkar procession, police said. The group blocked the road with tractor-trolleys and other vehicles, in an attempt to send the procession back. Ambedkar's followers insisted on taking the same route, saying they used it traditionally for the purpose, they added.

Officials rushed to the spot with police force and tried to convince people to clear the route. However, the villagers clashed with the police and threw stones at them. Kasganj Superintendent of Police (SP) Om Prakash Singh said they used a mild force to disperse the group and cleared the way for the procession. A police constable got injured in the stone pelting, he said. Police detained 23 people for creating the disturbance, it was learnt.

A case will be registered in this connection, said Additional Superintendent of Police Sushil Kumar Ganga Prasad.

The SP said the motive behind obstructing the procession by members of a community was yet to be ascertained and will become clear in the investigation. Video footage of the incident has been procured and further action will be taken accordingly, he added. In the Maigalganj area of Lakhimpur Kheri, two groups of the Dalit community clashed over putting up a statue of Ambedkar on a parcel of land and holding an event to garland it. Lucknow Range Inspector General (IG) Kiran S told The Indian Express that a group of youths reached the vacant plot belonging to the gram sabha (village panchayat) in the evening with an Ambedkar statue. When they were putting up the statue, a woman from

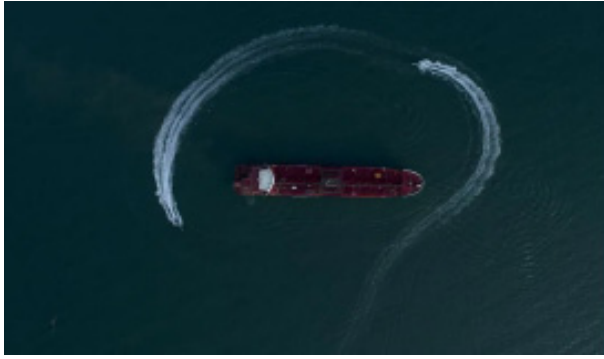

the same community living nearby objected, alleging the youths would later try to grab the land, he added. The argument between the two sides escalated and turned into a clash.

Police rushed to the spot and were also targeted by the warring groups by pelting stones, it was alleged. Some youths even set on fire a police vehicle, a Mahindra Bolero, parked nearby, the IG said. The miscreants, however, were dispersed using mild force, he added. Peace was restored in the area amid police deployment and efforts are being made to identify these miscreants, officials said. According to PTI, in Agra, a group of youths carrying blue flags climbed a platform where the structure of Lord Parshuram's weapon is built and put up the flags there. A video circulated on social media and a large group of people gathered at the spot objecting to putting up the flags.

London: At least two vessels transited through the Strait of Hormuz en route to Iranian ports after altering their Automatic Identification System (AIS) destination data, following a US blockade on ships entering and leaving Iran, British shipping media reported. The report by British shipping media Lloyd's List said that following the enforcement of the blockade, some vessels with intended calls at Iranian ports were observed adjusting their AIS destination signals while passing through the Strait of Hormuz, reports Xinhua news agency.

According to the report, shortly after the blockade took effect, at least two Iran-flagged container ships previously indicating sailing to the southern Iranian port of Bandar Abbas changed their AIS messages to the more general designation of "PG Ports," meaning "Persian Gulf ports." After successfully passing through the Strait, they continued their journey toward Bandar Abbas on Tuesday, said the report.

Citing analysts, the report said such actions could complicate the intelligence collection phase of the US blockade and require additional resources to track and identify vessels involved in maritime traffic to Iranian ports. The US Central Command said Tuesday that more than 10,000 troops are executing the mission to blockade ships entering and departing Iranian ports, targeting vessels of all nationalities without discrimination. Six merchant vessels have complied with the direction from US forces to turn around to re-enter an Iranian port on the Gulf of Oman, the command said on X. "During the first 24 hours, no ships made it past the US blockade," it said, noting that over 10,000 sailors, marines and airmen, along with over a dozen warships and dozens of aircraft, are executing the blockade.

The blockade covers Iranian ports and coastal areas, including all Iranian ports on the Arabian Gulf and the Gulf of Oman, it said. At least nine commercial vessels have crossed the strait since Monday, according to the maritime data firm Kpler. On Monday, CNN reported that there were at least 15 US ships in the region that could participate in the blockade, though it was unclear where specifically the ships were. US President Donald Trump threatened on Monday that the US military will "eliminate" any ship of Iran if it comes close to the US blockade in the Strait of Hormuz. "Warning: If any of these ships come anywhere close to our BLOCKADE, they will be immediately ELIMINATED, using the same system of kill that we use against the drug dealers on boats at Sea," Trump wrote on Truth Social. Daily traffic in the strait has fallen to below 10 per cent of pre-conflict levels, from more than 100 vessels before the United States and Israel launched joint military strikes against Iran on February 28.

Boat carrying 250 people, including Rohingya and Bangladeshis, sinks in Andaman Sea

Dhaka: At least 250 people, including Rohingya refugees and Bangladeshi nationals, were missing after a boat capsized in the Andaman Sea recently on the way to Malaysia, according to the United Nations' refugee and migration agencies. When the boat sank and the status of any search Wednesday were unclear. The UN High Commissioner for Refugees and the International Organisation for Migration in a joint statement said Tuesday that the trawler departed from Teknaf in the southern Bangladeshi district of Cox's Bazar carrying a large number of passengers to Malaysia. Overcrowding, strong winds and rough seas caused the vessel to lose control and sink, the agencies said.

UNHCR and IOM said the disappearance reflected the protracted displacement of Rohingya people and the absence of durable solutions. They said ongoing violence in Myanmar's Rakhine state has made the Rohingyas' safe return to Myanmar uncertain, and limited humanitarian assistance, restricted access to education and employment



in refugee camps, continue to push vulnerable Rohingya refugees to choose risky sea journeys, often based on false promises of higher wages and better opportunities abroad. UNHCR and IOM urged the international community to strengthen funding and solidarity to ensure lifesaving assistance for Rohingya refugees in Bangladesh, which has sheltered more than 1 million Rohingya from Myanmar.

Harvey Weinstein faces retrial in New York rape case

New York: After years of #MeToo infamy, legal peril and prison, Harvey Weinstein is again going on trial on a rape charge in New York City. Jury selection started Tuesday in the onetime movie mogul's latest retrial, where jurors will weigh — for the third time — whether he raped hairstylist and actor Jessica Mann in a Manhattan hotel in 2013. It's a more streamlined proceeding than the array of allegations that were aired at Weinstein's previous trials in New York and Los Angeles. The Oscar-winning producer denies all the accusations and declared in court this winter that he had "acted wrongly, but I never assaulted anyone." Still, the retrial is expected to last up to six weeks. Questioned about the length of the proceeding and whether they could be fair and impartial about the much-publicized case, more than 80 prospective jurors asked to be excused during initial screening Tuesday morning. About 60 others remained for further questioning in the afternoon.

A surprise move from prosecutors While Mann's accusation may be familiar, specifics of the case may differ. In a surprise move before jury selection began Tuesday, prosecutors suggested they might seek to introduce a new piece of evidence — a remark that Weinstein allegedly made to a court officer six years ago. According to Manhattan Assistant District Attorney Candace White, the officer told prosecutors last week that he was on hand for Weinstein's February 2020 sexual assault conviction — which was later overturned — and heard Weinstein say: "If you had seen these girls, you would have done the exact same thing." Weinstein's lawyers urged Judge Curtis Farber to keep any mention of the supposed remark out of his upcoming retrial.

"This sounds far-fetched," defense attorney Marc Agnifilo said, adding that "it's just too late" to introduce it. A subject that was explored in prior trials — a claims fund for women who said Weinstein sexually mistreated them — likely won't come up again. The defence team doesn't intend to raise the subject, Farber said. Agnifilo and his partners took on the case in February, when longtime Weinstein lawyer Arthur Aidala stepped aside from the retrial to focus on the former studio boss' appeals and civil matters. Both Aidala and Agnifilo are well-known New York defense attorneys, but their litigation styles differ. Aidala is folksy, while Agnifilo is more buttoned-up. Weinstein wielded significant clout in the entertainment industry, having built his reputation on such critical and popular hits as "Shakespeare in Love," "Pulp Fiction" and "Chocolat." He also became a prominent Democratic donor. Then a series of sexual harassment and sex assault allegations against Weinstein began to emerge in news media in 2017, propelling the #MeToo movement.

UN nuclear chief urges strict Iran checks in any deal to end war



N's nuclear watchdog said that "very detailed" measures to verify Iran's nuclear activities must be included in a potential US-Iran agreement to end their war in the Middle East. International Atomic Energy Agency (IAEA) Director General Rafael Grossi stressed the need for the thorough verification regime for Iran's nuclear programme, as US President Donald Trump said Tuesday that a second round of talks with Iran could happen over the next two days. The Trump administration has said that preventing Iran from gaining a nuclear weapon is a key war aim. Iran has previously said it isn't developing such weapons but rejected limits on its nuclear programme. Last weekend in Pakistan,

an initial round of talks between the two countries failed to produce an agreement. The White House said Iran's nuclear ambitions were a central sticking point. But an Iranian diplomatic official, speaking on the condition of anonymity because of the sensitivity of the closed-door talks, denied that negotiations had failed over Iran's nuclear ambitions.

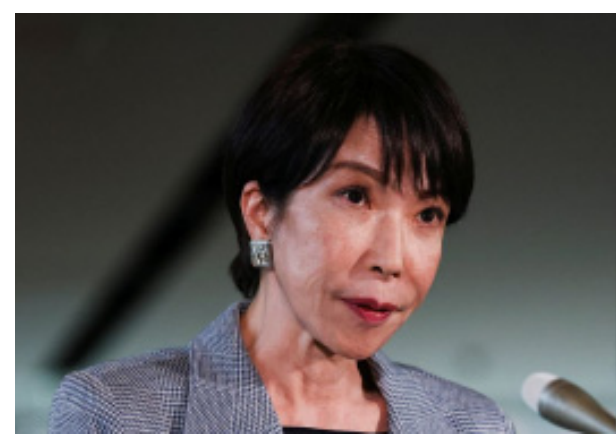
"Iran has a very ambitious, wide nuclear programme so all of that will require the presence of IAEA inspectors," Grossi told reporters in Seoul. "Otherwise, you will not have an agreement. You will have an illusion of an agreement." He said that any agreement on nuclear technology "requires very detailed verification mechanisms." Iran has not allowed the IAEA access to its nuclear facilities bombed by Israel and the United States during a 12-day war in June, according to a confidential IAEA report circulated to member states and seen by The Associated Press in February. The report stressed that it "cannot verify whether Iran has suspended all enrichment-related activities," or the "size of Iran's uranium stockpile at the affected nuclear facilities." Iran has long insisted its programme is peaceful, but the IAEA and Western nations say Tehran had an organised nuclear weapons programme up until 2003. The IAEA has maintained Iran has a stockpile of 440.9 kilograms of uranium enriched up to 60 per cent purity, a short, technical step away from weapons-grade levels of 90 per cent. That stockpile could allow Iran to build as many as 10 nuclear bombs, should it decide to weaponise its programme, Grossi said earlier.

West Asia tensions: Japan joins diplomatic push as backchannel efforts sustain truce

As tensions in West Asia remain dangerously elevated, a parallel and increasingly coordinated diplomatic push is underway to prevent a wider conflict, with multiple global actors working to sustain the fragile US-Iran ceasefire, and revive stalled negotiations between Washington and Tehran. At the centre of these efforts is Pakistan, which has positioned itself as a crucial intermediary following its hosting of high-stakes US-Iran talks in Islamabad.

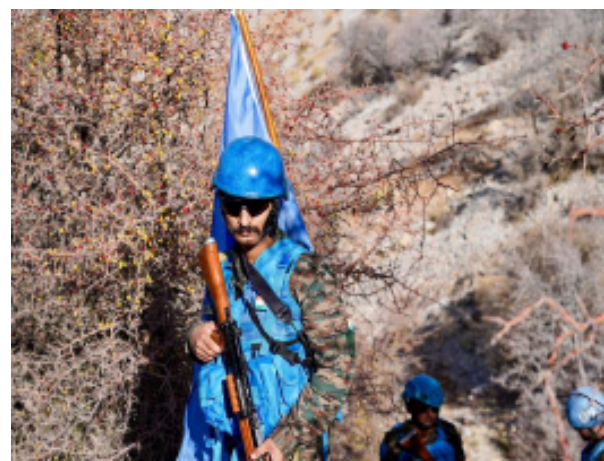
A special meeting of the federal cabinet chaired by Prime Minister Shehbaz Sharif on Monday unanimously adopted a resolution praising its political and military leadership's role in bringing the two adversaries to the negotiating table. Sharif asserted that the ceasefire between the United States and Iran "still stands", even as substantive issues remained unresolved. "As I am speaking, full efforts are underway to resolve the outstanding matters," he said, while alluding to sensitive backchannel negotiations. The Pakistani leader also revealed that the situation had, at times, come close to collapsing, before being stabilised through intensive behind-the-scenes engagement led by his military leadership, including Army chief Asim Munir.

The diplomatic momentum has found resonance beyond the immediate region. Japan has emerged as a key stakeholder, stepping up high-level engagement with both sides while aligning closely with Pakistan's mediation efforts. In a call with Sharif, Japanese Prime Minister Sanae Takaichi confirmed that Tokyo had been in active communication with both Washington and Tehran at the highest levels, signalling Japan's intent to play a constructive diplomatic role in defusing the crisis.



She also highlighted the urgent need to stabilise the Strait of Hormuz, describing it as a critical artery of global trade and an "international public good", while stressing that safe navigation must be restored at the earliest for all vessels, including those from Asia's energy-dependent economies. Calls for restraint and renewed negotiations also came from Europe. Germany's Foreign Minister Johanna Wadepuhl urged both sides to utilise the current ceasefire window to resume talks, warning that the opportunity for diplomacy must not be squandered. "The ceasefire is holding, and I can only urgently appeal to both sides to make use of this time," he said, stressing that continued engagement was in the interest of both the region and the international community.

10 countries issue statement condemning killing of aid workers in Lebanon, call for end to hostilities



Ottawa [Canada]: Ten countries, including Australia, Brazil, Canada, Colombia, Indonesia, Japan, Jordan, Sierra Leone, Switzerland and the United Kingdom, expressed deep concern over the worsening humanitarian and displacement crisis in Lebanon and called for the protection of humanitarian workers in conflict zones. In a joint statement issued on Tuesday (local time), the countries remained "deeply concerned by the worsening humanitarian situation and displacement crisis in Lebanon" and urged an immediate end to hostilities in the region.

"We welcome the ceasefire agreed between the United States, Israel and Iran. We call for an urgent end to hostilities in Lebanon," the statement added. The signatories stressed that civilians and civilian infrastructure must be protected at all times amid ongoing conflict, and emphasised the need to ensure the safety of humanitarian personnel working on the ground. "Humanitarian personnel, who dedicate themselves to protecting and assisting the most vulnerable, must be respected and protected," the statement added. The countries strongly condemned attacks that endanger aid workers and reiterated that international humanitarian law must be upheld by all parties under all circumstances. "Attacks that threaten the safety and security of humanitarian personnel must stop. International humanitarian law must be upheld by all parties to the conflict in all circumstances," they said. The statement further underlined that adherence to international humanitarian law is essential to protecting human dignity, reducing civilian harm, and ensuring continued humanitarian access. The countries also condemned the killing of UN peacekeepers and warned that the risks faced by humanitarian workers in southern Lebanon have increased significantly.

"We condemn in the strongest terms actions that have killed UN peacekeepers and significantly increased the risks faced by humanitarian personnel in southern Lebanon," the statement noted. They further stressed the need for accountability for violations of international law affecting humanitarian personnel or obstructing their operations. The signatories also referred to a declaration launched in September 2025 by over 100 countries aimed at strengthening the protection of humanitarian workers in conflict zones. "We will continue working together to ensure that those who work to save the lives of others do not have to sacrifice their own," the statement concluded. This comes after reports of the

personnel from the United Nations Interim Force in Lebanon (UNIFIL) getting killed due to the cross-border clashes between Israel and Hezbollah in Lebanon. Earlier on April 7, the Israel Defense Forces (IDF) briefly detained a UNIFIL peacekeeper after stopping a logistics convoy. Following swift and direct intervention by UNIFIL's Head of Mission and Force Commander, along with its Liaison Branch, the peacekeeper was released within an hour. Any detention of a United Nations peacekeeper constitutes a clear breach of international law. Similarly, any obstruction of peacekeepers' duties amounts to a violation of Resolution 170 (This content is sourced from a syndicated feed and is published as received. US, Israel and Lebanon hold rare talks as Iran tensions escalate

Washington: Lebanon and Israel were holding their first direct talks in decades as fighting between Israel and Hezbollah militants rocks southern Lebanon. US Secretary of State Marco Rubio joined the Israeli and Lebanese ambassadors for Tuesday's discussions in Washington. Hezbollah says it will not abide by any agreement, a high-ranking member of the group's political council told AP. The US military claimed Tuesday that it has successfully begun to enforce a blockade of Iranian ports, as the stand-off between the US and Iran deepens. Tehran threatened to strike targets across the region, a day after Trump warned on social media that any Iranian warships nearing the blockade would be destroyed in a "quick and brutal" strike. With Pakistan racing to bring the sides together for more talks, US President Donald Trump said Tuesday that a second round "could be happening over the next two days". The first round ended without an agreement on Iran's nuclear ambitions, which the White House says is a sticking point. The formal injury count, provided by Capt Tim Hawkins, spokesman for US Central Command, says three service members have been seriously wounded. Central Command said two weeks ago in a previous update that 348 troops were wounded, six of them seriously. However, the military command does not provide any further details about the wounded, so it is unclear whether anyone's status has improved or worsened. Hawkins said that of the total wounded to date, 354 service members have returned to duty. Since the Iran war began, 13 US service members have been killed in combat. Guterres said this was the indication he had after a meeting Tuesday with Pakistan's deputy prime minister, who is also the country's foreign minister. The UN secretary-general expressed "enormous admiration" for Pakistan's initiative to bring peace to the Middle East. "I consider it essential that these negotiations go on," Guterres told UN reporters, explaining that it would be "unrealistic" for long-lasting and complex problems between the US and Iran to be resolved in a first negotiating session.

Indian women's ovaries age faster compared to Caucasian women: why?



(PCOS), which alters follicular dynamics and AMH measures, is highly prevalent and complicates the interpretation of "reserve" versus "function." Insulin resistance and chronic inflammation may blunt ovarian responsiveness and accelerate clinically apparent decline. Recent Indian studies link reproductive and metabolic markers to AMH trends.

The third component is societal change. Women in India are progressively postponing childbirth for education and careers; as a result, there has been an increase in women who come to fertility clinics at older ages or after years of subfertility; thereby, clinics are becoming more aware of cases of diminished reserves. Besides that, the differential limitations in access to nutrition, healthcare, and early detection lead to the manifestation of ovarian ageing being mostly at the stage when fertility is already compromised. International commentary in 2024 on AMH testing in India emphasises that there is a necessity for population-specific reference ranges and that the public should be more aware, so that over-diagnosis as well as under-diagnosis can be avoided. Nevertheless, a warning should be placed at the forefront: AMH is a worthwhile clinical tool - in particular, for the purpose of assisted reproduction - however, it is not a miraculous predictor of a woman's capability of conceiving naturally or the time of menopause. Women need to stay wary of the heavy interpretation of AMH as a consumer "fertility test" without counselling; the hormone refers to the number of small follicles, not necessarily the quality of eggs or other aspects of fertility. Healthcare providers recommend that the AMH level be accompanied with other criteria such as: age, ultrasound, menstrual history, and metabolic screening together, in order to provide a comprehensive picture of fertility.

What can be done?

At a public-health level, researchers recommend establishing robust, region-specific AMH/AFC nomograms so that clinicians and women have realistic, population-appropriate expectations; tackling environmental exposures, reducing air and water pollution, and monitoring heavy metals should be made a priority; addressing metabolic health early through lifestyle and primary care is crucial; and improving access to fertility counselling and timely testing for women who plan pregnancy will also help. On an individual level, awareness matters: earlier fertility planning, metabolic health optimisation, and early discussion with a reproductive specialist can preserve options. In short, the observation that ovarian reserve declines earlier in many Indian women is supported by studies and expert consensus, but it is not reducible to one cause or a single number. It is a multifactorial reality at the intersection of biology, environment, and social change, and it demands both better population-specific research and practical public health responses so women can make informed reproductive choices.

It's a striking claim that's been repeated in clinics and headlines: ovaries in some Indian women appear to show signs of "ageing" earlier than in many Western peers. Put simply, markers that clinicians use to estimate ovarian reserve — most commonly serum anti-Müllerian hormone (AMH) and antral follicle count (AFC) — tend to decline earlier in many Indian cohorts. Recent studies from 2024 and 2025 do not claim that there is a single simple cause; rather, they point to a complex mix of genetics, environment, metabolic health, and social change that together may explain why a sizable subset of Indian women show lower ovarian reserves at younger ages.

Where did the "six-year" figure that is being touted about come from? Older comparative work and clinic-based observations popularised the idea that the ovarian age in Indian women can appear roughly several years "older" than age-matched Caucasian women. More recent Indian population studies don't aim to pin a single universal number on that gap; instead, they show consistent patterns of earlier AMH decline in multiple regional cohorts, supporting clinical observations, while calling for population-specific age nomograms and careful interpretation of AMH across ethnicities.

What could be behind this phenomenon? To start with, genetics and developmental factors are probably major contributors. Variability in the number of follicles one is born with as well as genes that regulate DNA repair in oocytes can determine the amount of ovarian reserve left at birth - these biological origins can be different for different populations. Next, a lot of evidence is gradually coming in that points to lifestyle and environmental stresses as major factors - increased exposure to endocrine-disrupting pollutants, heavy metals, and oxidative stressors can not only expedite follicular depletion, but can also cause damage. Several recent articles on premature ovarian insufficiency and ovarian ageing focus on the main cause of the environmental insults, together with genetics. Metabolic health and reproductive disorders also matter. Rising rates of metabolic syndrome, obesity, and insulin resistance — paradoxically coexisting with undernutrition in parts of India — influence ovarian function. Polycystic ovary syndrome

India tops global doping list for the third consecutive year



260 positive cases in 2024, as many as 76 came from athletics, followed by weightlifting (43) and wrestling (29). Boxing and powerlifting recorded 17 cases each, while kabaddi accounted for 10 cases. These figures reflect a pattern that has held over several years, with endurance and strength-based sports dominating the list of violations. In July, under-23 wrestling champion and Paris Olympics quarter-finalist Reetika Hooda tested positive for banned substances and was provisionally suspended, drawing attention to doping risks even among elite athletes. At the grass-roots level, enforcement itself appears to be a deterrent. During India's University Games earlier this month, there were reports of several athletes skipping track and field events after anti-doping officials arrived at venues, in some cases leaving only a single competitor to participate.

India's National Anti-Doping Agency (NADA) has defended its record, arguing that higher numbers reflect improved detection rather than rising drug use. In a statement issued on Wednesday, the agency said India had "significantly strengthened" its anti-doping framework in recent years. However, global comparisons suggest that India's problem is not merely one of testing volume. Several countries with comparable or higher testing numbers continue to report far lower positivity rates.

The WADA report comes months after the International Olympic Committee (IOC) expressed concern over the widespread use of performance-enhancing drugs in India and urged authorities to "set their house in order". In response, the Indian Olympic Association constituted a new anti-doping panel in August. The government has also moved to tighten the legal framework. Parliament recently passed the National Anti-Doping (Amendment) Bill, 2025, incorporating changes sought by WADA to bring India's anti-doping regime in line with global standards. The Bill prohibits doping in sports, and provides a framework for testing, enforcement, and adjudication of violations. Note: Adverse Analytical Findings (AAF) is a laboratory report identifying the presence of a Prohibited Substance or its metabolites or markers (including elevated quantities of endogenous substances) or evidence of the use of a Prohibited Method, in line with WADA standards.

India has recorded the highest number of doping offenders globally for the third consecutive year, according to the latest World Anti-Doping Agency's (WADA) report. According to the WADA's 2024 report, India recorded 260 positive doping cases from 7,113 samples — a 3.6% positivity rate as shown in below charts. This figure is more than double of any other nation's numbers, as no other country exceeded a 1.75% positivity rate in 2024.

Norway documented the second-highest proportion of positive cases at 1.75%, followed by the U.S. at 1.15%. In terms of absolute figures, France registered the next highest volume of violations in 2024 with 91 cases, followed closely by Italy with 85. Russia and the U.S. reported 76 cases each, while Germany and China recorded 54 and 43 cases, respectively. Crucially, these nations recorded fewer positive results in both absolute and percentage terms than India, despite maintaining much more rigorous testing regimes. China, for example, conducted over 24,000 tests in 2024, more than triple India's volume, yet reported fewer than one-fifth of the violations. The findings have come at a time when India is positioning itself as a credible global sporting host. The country is preparing to host the 2030 Commonwealth Games, seen as a stepping stone towards its larger ambition of hosting the 2036 Olympics.

Sport-wise data from India shows that athletics recorded the most positive results in absolute terms. Of the

Bombay HC tells Vijay Mallya to return to India before challenging Fugitive Offenders law

The Bombay High Court on Tuesday (December 23, 2025) declined to hear absconding businessman Vijay Mallya's petition questioning the constitutional validity of the Fugitive Economic Offenders Act (FEO Act) unless he first returns to India and submits to its jurisdiction. Mr. Mallya has moved two petitions before the High Court — one challenging the special court's 2019 order declaring him a fugitive economic offender, and another questioning the constitutional validity of the FEO Act. A Division Bench of Chief Justice Shree Chandrashekhar and Justice Gautam Ankhad observed that he cannot pursue both pleas simultaneously while remaining abroad. "First submit to court's jurisdiction. You will have to make a statement as to when you will return to India; only then we will hear the petition challenging the vices of the FEO Act," the Bench said, directing him to file an affidavit indicating his timeline. "Come back to India, we are here to provide you with a solution," the judges added. The Court clarified that while his appeal against the special court's declaration can proceed even if he stays overseas, the constitutional challenge requires his presence. "How does one wipe out criminal liability without submitting to the jurisdiction of the Court?" the Bench re-

marked. Senior advocate Amit Desai, appearing for Mr. Mallya, argued that the law does not mandate physical presence for such challenges. "The statute permits a person to question the validity of the Act without being in India. My client has cooperated and his assets worth ₹14,000 crore have been attached against an alleged liability of ₹6,000 crore," Mr. Desai submitted. Solicitor General Tushar Mehta, representing the Enforcement Directorate (ED), opposed the plea, citing Section 14 of the Act, which bars fugitives from contesting proceedings while evading Indian courts. He also noted that extradition proceedings in the United Kingdom are at an advanced stage and should not be stalled by these petitions. Mr. Mallya left India in March 2016 amid investigations into alleged loan defaults by Kingfisher Airlines. He was declared a fugitive economic offender by a Mumbai special court in January 2019 under the FEO Act. Enacted in 2018, the law empowers authorities to confiscate the properties of individuals accused of economic offences involving ₹100 crore or more if they refuse to return and face trial. The matter has been adjourned to February 12 for Mr. Mallya's response on whether he will withdraw one petition or indicate a date for his return.

A bittersweet Test for Australia's Lyon-hearted spinner



Nathan Lyon knew immediately. As soon as he dived at full stretch to his right at fine-leg to prevent Jamie Smith's pull from reaching the boundary in the 77th over of England's second innings at the Adelaide Oval on Sunday, a slight grimace betrayed the sense that he wasn't quite right. He threw the ball back to wicketkeeper Alex Carey whilst still on his knees and instantly clutched his right hamstring. When he did get back up on his feet, he couldn't do much more than limp a couple of steps before signalling towards the dressing room for help and hobbling outside the field of play. As Marnus Labuschagne, who went up to the 38-year-old to check on him, disclosed to the host broadcaster later, Lyon knew then and there that he would play no further part in the game. "I think I have done my hammy," Lyon told Labuschagne grimly.

By the time Australia took the final wicket of Josh Tongue later in the afternoon to retain the Ashes in just 11 days, Lyon was on crutches. Having made a quick visit to the hospital for a scan, he returned to the venue in time to witness the winning moment and willed himself back onto the park to congratulate his euphoric teammates. As chuffed as he would have been about Australia getting over the line, it was cruel for the Test to end the way it did for Lyon personally. Having very much helped set up the win with his exploits on the penultimate evening — this is his fourth consecutive Ashes series victory at home — he would have dearly loved to be on the outfield to soak in the moments leading up to victory. Moreover, this was the Test that saw him surpass Glenn McGrath's tally of 563 wickets to go up to No. 2 in the list of Australia's highest wicket-takers. To have accomplished the feat at the Adelaide Oval, a venue that he tended to as a groundsman before his Test debut, ought to have been a highlight not marred by his injury. In the final session of the fourth day, Lyon had been the wrecker-in-chief, removing Harry Brook, Ben Stokes and Zak Crawley in the space of six overs to essentially ensure that the hosts had one hand on the urn. Until Lyon's dismissal of Brook, England had done reasonably well to get to 176 for three in 47 overs in pursuit of a record target of 435. Brook and Crawley had negotiated Lyon effectively, sweeping and reverse-sweeping routinely to throw the off-spinner off his lines and lengths. His figures in the fourth innings were unflattering before his opening breakthrough: 10-1-49-0.

But there is a reason why Lyon has been snaring Test wickets for a living for 14 years. Off the second ball of a new spell to Brook, he altered his line a tad wider of off-stump and had the 26-year-old reaching out for one reverse sweep too many. Adding to his catalogue of ungainly dismissals in this series, England's impetuous No. 5 lost his balance and looked back in disbelief once the ball hit his leg stump.

Just four overs later, it was the turn of Stokes to look on in disbelief. As is often his reaction when the stumps are dislodged, the England skipper couldn't quite believe his eyes when Lyon produced a ball that spun past his defence and clattered off-pole. It was a ripper alright, but truth be told, Stokes was neither forward nor back, a fallibility in his footwork versus spin that has now brought about 10 dismissals against the Australian in 23 encounters. If at all he was disputing Lyon's propensity to produce such deliveries, all he had to do was to hark back to the first innings of this Test when the wily tweaker dismissed his namesake, Ben Duckett, in similar fashion. The ball to the England opener will likely be etched in Lyon's memory for a long

time, for it was the breakthrough that took him past McGrath. With Crawley's stumping late on day four being the last of his five wickets across the two innings, Lyon has moved along to 567 wickets in 141 Tests. Second to Warne

Remarkably now, only the late Shane Warne, whose 708 scalps came in 145 Tests at an average of 25.41, stands above Lyon in the pantheon of Australia's most prolific wicket-takers. It is worth remembering that in the period between Warne's exit in 2007 and Lyon's entry in 2011, Australia went through spinners with the frequency of a chameleon changing colour, yearning desperately to find a worthy successor to the irreverent genius from Victoria. While Lyon isn't Warne — no one can fill those proverbial big shoes — he has optimised his attributes to carve a career that will be just as hard to emulate for the men to follow. Looking back, Lyon's first two years were riddled with bumps, and when he was dropped for the opening Ashes Test of the 2013 series in England, he seemed set to go down the path of his immediate predecessors. But Australia was shrewd enough to realise its folly and bring Lyon back for the third Test of that series against Alastair Cook and Co. The turning point for the spinner came in the reverse Ashes just a few months later, where he proved to be an able foil to the Mitchell Johnson-led pace battery and claimed 19 wickets in a 5-0 whitewash at home. Starting from the middle of the English summer in 2013, Lyon has evolved into a near-permanent presence in Australia's playing XI, with the Lord's Test in 2023 marking his 100th successive appearance in whites. Not dissimilar to the mishap in Adelaide, it was only a calf injury while fielding during England's first innings at Lord's that curtailed his incredible streak and prompted a premature end to his series two years ago. Lyon's success over a long Test career is proof that there is still a place for an off-spinner in the classical mould in the modern game. While he is one of three off-spinners with more than 500 wickets in Test history, he doesn't possess Muttiah Muralitharan's big-spinning off-break or deadly doosra. Neither does he have the repertoire to experiment as R. Ashwin did. But what he does have is a stock ball, armed with overspin and drift, that he backs himself to deliver at a desired spot at any given juncture. It has held him in good stead in a land usually unforgiving to his tribe: his record of 273 wickets in 74 Tests at 31.08 in Australia is in marked contrast to a host of visiting off-spinners of repute who have travelled to those shores. Unusually, though, he has been dropped from a couple of Tests in recent months. Having claimed a match haul of six for 117 in the second Test against West Indies at Grenada in July, Lyon was benched for the third Test in Jamaica as the Aussies opted for an all-pace attack with the pink ball. Australia's selector on tour, Tony Dodemaide, described Lyon's omission as a "one-off". But when the team had to be picked for the second Ashes Test in Brisbane two weeks ago — another day-night affair — Lyon was again left out. It will be all the more infuriating, then, that just as he had begun getting back into his groove in Adelaide, the injury has thrown another curve ball. On Tuesday, Lyon underwent surgery as Cricket Australia confirmed that he will be sidelined for an "extended period". In Lyon's place, the bespectacled Todd Murphy, who has played seven Tests so far, has been drafted into the squad for the next two games in Melbourne and Sydney. Coach Andrew McDonald weighed in on Lyon's road to recovery. "The surgeon will give us a report and a rough length of time. It is going to take a lot of hard work with that type of injury. It is going to be a hard period for him to get back to where he was," he told the Australian media on Tuesday. At the same time, McDonald knows that Lyon's will to keep going hasn't dimmed in the slightest. A five-Test tour of India, where Lyon has never won a series, in early 2027 is a target that the offie had long identified. "Lyon still wants to do it. That's the main thing. India is on the horizon. He will be a key part of that," McDonald added. "In Adelaide, it was probably the best I had seen him bowl for a little while in terms of the shape and energy he had on the ball. He will get through this rehab and then look forward to what it looks like."

How Indian States are following a pro-incumbency trend



The recently concluded Bihar Assembly election highlights an interesting point: that Nitish Kumar, who has taken oath as Chief Minister for the 10th time, has been able to retain the government even after almost two decades of ruling the State. This shows us a contrast between global and Indian State-level patterns of (anti) incumbency. In many major democracies across the world, voters displayed a strong sense of anti-incumbency. The defeat of the U.S. democrats, the U.K. conservatives, Japan's Liberal Democratic Party and South Africa's African National Congress reflect that people in these countries were willing to use their elections as an instrument to address perceived non-performance of the government and demand an alternative in power. Senegal's election similarly captured youth anger and a generational push against elites.

A pro-incumbency trend

Indian State assembly elections held over the last few years indicate a trend in the opposite direction. Many governments during this period got re-elected, indicating a strong pro-incumbency sentiment. The incumbent Bharatiya Janata Party government got re-elected in Bihar, Haryana, Madhya Pradesh and Maharashtra, despite spirited opposition campaigns. These governments were re-elected, beating anti-incumbency, because the ruling party anchored its election campaign pushing narratives of stability, "double engine ki sarkaar" (the idea that the Centre and the State is ruled by the same party) for faster development, welfare delivery and strong leadership, which triumphed the narrative propagated by opposition parties. In Gujarat, the BJP extended its record to a seventh straight term, while Naveen Patnaik's Biju Janata Dal (BJD) in Odisha converted personal credibility and targeted schemes into multi-term mandates. West Bengal's 2021 mandate for Mamata Banerjee's Trinamool Congress, against a highly contested BJP challenge, highlights pro-incumbency in a polarised contest. These examples may look like isolated cases of States being voted back to power, with the recent Bihar Assembly election being one of them, but Indian elections since 1952 had witnessed periods of pro and anti-incumbency.

The first few years (1952-1966) were a period of pro-incumbency. Out of the 39 assembly elections held during this period, almost 85% governments got re-elected. But the periods of 1967-79 and 1980-1988 witnessed both pro

and anti-incumbency trends. During 1967-79, out of 82 assembly elections, 54% of governments got re-elected, while 46% of them got voted out. Similarly, during the 1980-88 period, of 53 assembly elections, 51% governments got re-elected while 49% governments got voted out. However, the periods of 1989-98 and 1999-03 witnessed a very strong trend of anti-incumbency. During 1989-98, of 63 assembly elections, 71% of incumbent governments were voted out. The trend continued during the 1999-03 period, where of the 31 assembly elections, 61% of incumbent governments were voted out. The trend changed again during the 2004-15 period, which witnessed a mix of anti and pro-incumbency. In this period, nearly 55% incumbent governments got re-elected, while 45% governments were defeated. The 2016-2018 period has seen a strong anti-incumbency trend where nearly 75% of incumbent governments got defeated. This is understandable, for when the BJP-led National Democratic Alliance government came to power at the Centre in 2014, many Congress-ruled States lost in subsequent State elections.

We are again witnessing a strong pro-incumbency trend. Many BJP ruled States have witnessed governments being re-elected. It is true that many of these governments were re-elected riding on the popularity of the welfare schemes, but it also has to do with general infrastructural improvement which the State and its people have started benefiting from. While politics of welfare has helped the ruling party mobilise the votes of the poor and the lower middle classes, infrastructural developments have especially helped in mobilising the votes of the upper middle-class voters.

Crude oil prices rose 7% after the announcement to around \$102 a barrel, putting pressure across global markets. Most Asian markets are lower on Monday. While both parties have kept the possibility of future talks open, market participants across the world will remain cautious due to the volatile nature of the conflict. "The energy crisis triggered by the conflict in West Asia, the potential impact of the crisis on Indian economy and sustained depreciation of the rupee kept the FPIs on sell mode. Other markets like South Korea and Taiwan are considered more attractive from the FPI perspective since these markets are expected to deliver much superior earnings growth when compared to the modest earnings growth expected in India in FY27," according to VK Vijaykumar, chief investment strategist at Geojit Financial Services. While foreign investors (FIIs) have continued to pull out money from the Indian markets, the pace has slowed as the month of April has gone on. On Friday, data from the National Securities Depositories Ltd. showed FIIs pulled out \$223 million. They had pulled out \$144 million and \$743 million in the two sessions before that. In comparison, these players had pulled out \$2.2 billion and \$1 billion, respectively, in the first couple of sessions of the month. In India, all sectoral indices are deep in the red in early trade. The India VIX, which had fallen 8% on Friday, has risen 14% on Monday as investor sentiment has turned volatile again due to geopolitical uncertainty. All broader market indices also declined, showing a broad-based fall in the market. Looking ahead, market direction will remain sensitive to geopolitical developments and their implications for India's macro environment. Corporate earnings will also be in focus as market participants assess the impact faced by India Inc due to the uncertain geopolitical conditions. Any positive surprises on that front may again help turn the mood regarding Indian equities.

Benchmark stock indices lost steam after last week's rally and were down nearly 2% in early trade on Monday as peace talks between Iran and the US collapsed, heightening the risk of renewed conflict in West Asia. The NSE's Nifty 50 index was down 1.8% at 23,625.95 points at around 09:50 AM. The BSE's Sensex index was also down 1.8% at 76,171.40 points. The fall comes after last week's 6% rise, with the indices rallying 4% following the interim ceasefire announcement between the two countries on Wednesday. That led the benchmark indices to break a six-week decline last week.

Mutual fund SIP stoppages exceed registrations despite inflows hitting record high in March

Systematic investment plans (SIPs) in mutual funds were discontinued in March, more than they were registered by investors. The trend comes as the West Asia crisis has rattled the markets, making retail participants nervous. However, despite the sell-off, SIP inflows scaled a record high, reflecting some resilience in mutual fund participation even as volatility weighed on the sentiment.

This divergence suggests that weaker-handed investors exited their SIP commitments, while more conviction-driven participants stepped up contributions, seeing the market correction amid war-related fears as an opportunity to invest, fund managers said. In March, around 52.82 lakh new SIPs were registered, while about 53.38 lakh SIPs discontinued, according to data from the Association of Mutual Funds in India. This pushed the SIP stoppage ratio, calculated as discontinued SIPs divided by those that were added, to 101. While the number of SIPs discontinued was broadly within the range seen over the past three months, new SIPs registered lagged the three-month average of around 66.76 lakh, reflecting the nervousness among retail investors. "The market sell-off has sharply eroded the value of investors' holdings in schemes, triggering panic and prompting many retail investors to discontinue their SIPs. My sense is that the bulk of SIP contributions through SIPs in March likely came from high-net-worth individuals and family offices," said an analyst with a research firm. Since the conflict began, the benchmark indices fell 11% from their pre-war levels due to high crude oil prices and persistent selling by foreign investors. However, Venkat Chalasan, Chief Executive of AMFI, said a higher stoppage ratio is not a major concern, as it may reflect investors reallocating across schemes or exiting upon achieving their financial goals.

"When it comes to SIPs, our focus is on the number of contributing accounts and the monthly inflows, as these provide a clear view of retail investor behaviour," he said in an interaction with The Indian Express. The more important indicators are the growth in overall contributions and the expanding base of contributing investors, he said. SIP stoppage Despite the higher SIP stoppage ratio, contributions through SIPs rose to a record of Rs 32,087 crore in March, up 7.5% month-on-month. (Another argument is that a surge in discontinued SIPs often does not reflect declining sentiment in retail investors, as the data includes people who have shifted to other products or people who have missed three straight instalments, or it could also be caused



by a cleanup in the system to get rid of inactive accounts. Thus, the number of contributing SIP accounts may be a better benchmark in such cases, said an expert.

Despite the higher SIP stoppage ratio, contributions through SIPs rose to a record of Rs 32,087 crore in March, up 7.5% month-on-month. While SIP assets fell by 9.2% to Rs 15.11 lakh crore during the month due to the underperformance of the equity market, it constituted 20.5% of the total industry's AUM, compared to 20.3% in February. The count of contributing (active) SIP accounts rose by 3% to 9.72 crore in March, AMFI said in its monthly note. The higher stoppage ratio in March may have been due to new investors being cautious about starting SIPs during volatile market conditions, while existing investors possibly saw the correction since the war started as an opportunity to make returns. "My sense is since the market is volatile, some people who are well seasoned or are informed in terms of how the market behaves would have increased their contribution. To initiate new SIPs in such an environment could be difficult, since there is always a bearing of trailing returns on new investors," said George Thomas, equity fund manager at Quantum Asset Management Company. While the stoppage ratio crossing 100 on a single occasion is not particularly concerning, retail investors may turn cautious if the markets remains range-bound for an extended time, leading to lower returns, Thomas said. Markets have been broadly range-bound since the bull run seen back in August 2024, with the Nifty 50 roughly cycling between 22,000-26,000 points during that period. Equity mutual funds saw good participation in March, with net inflows into such funds rising 56% month-on-month to Rs 40,450 crore, the highest level since July 2025. This was led by segments such as flexi-cap, mid-cap, and small-cap. Equity funds are, by far, the biggest category in the industry, constituting 43% of the total AUM of the industry.

Consumer prices rose 3.4% in March, early signs of West Asia war's impact

The war in West Asia has pushed up energy prices globally, with the price of India's crude oil basket surging more than 60% in March compared to February. India's headline inflation rate rose to 3.4% in March, as the impact of the war in West Asia was only felt in small pockets and to a limited extent, according to data released by the Ministry of Statistics and Programme Implementation (MoSPI) on Monday. At 3.4%, the March inflation rate as per the Consumer Price Index (CPI) is only slightly higher than February's 3.21%. However, food inflation rose at a faster clip of 3.87%, up from 3.47% in February. Inflation measures the change in price in one month compared to the same month last year. While the March headline inflation numbers are fairly similar to those of February and along expected lines, there was a sharp rise in a key underlying number, with the inflation print for the 'electricity, gas and other fuels' category at 1.65% from 0.14% in February. And while petrol and diesel have not become dearer for consumers at petrol pumps due to the oil marketing companies leaving their prices unchanged, the government increased the price of domestic LPG cylinders by Rs 60 in early March. Kerosene prices have also been raised. With consumers being shielded by the higher energy prices being caused by the US and Israel's war against Iran, the in-

flationary impact is likely to be far more visible in Wholesale Price Index (WPI) data for March, which will be released by the commerce ministry on Tuesday. In February, WPI inflation stood at 2.13%, with 'fuel and power' prices 3.78% lower compared to February 2025. According to Union Bank of India economists led by Kanika Pasricha, India's wholesale inflation likely jumped to 3.08% in March. This would be the highest in almost two years. Increases in wholesale prices usually feed into consumer prices with a delay. And even if oil marketing companies don't raise pump prices of petrol and diesel, companies across various sectors such as consumer durables, paints, and fast-moving consumer goods have already started passing on the higher costs to consumers. These higher costs arise from not just more expensive fuel but also by-products of petrochemicals, such as plastics used for packaging and other purposes, that are inputs. "We expect the impact of higher energy prices to gradually percolate over the coming months, as replacement supplies arrive with a lag. At the same time, we continue to monitor the risk of a fuel price increase in the weeks ahead," Radhika Rao, Senior Economist at DBS Bank, said. Debopam Chaudhuri, Chief Economist at Piramal Finance, noted that while OMCs have so far absorbed the higher import costs, "this cushion may be nearing its limits unless crude prices correct meaningfully." While the small increase in CPI inflation in March will be of comfort to policymakers, they will be keeping a close eye on how prices evolve going forward, especially in the wake of peace talks in Islamabad failing.

Does a normal blood pressure mean all is well? This is a common and dangerous misconception: the belief that a healthy blood pressure reading is a clean bill of health for the entire cardiovascular system. While blood pressure is a vital metric, it is only one piece of a complex puzzle. To get an insight into a similar Quora query — "How can you check if you have a heart blockage? My blood pressure is always good, but aren't there blood tests that can give us clues?" — we consulted an expert. Dr Saumya Sekhar Jenasamant, a consultant cardiologist and vascular surgeon at KIMS Hospitals, Thane, said that while normal blood pressure is reassuring, "it doesn't rule out blockages in the heart arteries." "Many people with coronary artery disease have normal blood pressure readings. Blockages develop due to plaque buildup, which includes cholesterol, fat, and calcium. This process can remain silent until it becomes significant. That's why relying on just blood pressure can be misleading," said Dr Jenasamant. Any early warning signs to watch for? Yes, but they're not always obvious,

mentioned Dr Jenasamant. "Subtle symptoms often get ignored, such as chest heaviness during physical activity, breathlessness when climbing stairs, unusual fatigue, or discomfort in the jaw, neck, or left arm. Some people, especially those with diabetes, may have silent symptoms or no symptoms at all. If something feels new, lasts a while, or is related to activity, it's worth getting checked out."

What tests can help detect heart blockage early?

There isn't a one-size-fits-all test, but a step-by-step approach works best, according to Dr Jenasamant.

— CT Coronary Angiography: A non-invasive scan that can visualize blockages in coronary arteries.

— Coronary Calcium Score: Helps identify early plaque buildup, even before any symptoms start.

— Coronary Angiography: This is the gold standard for diagnosing blockages in coronary arteries. In this procedure, a contrast dye is injected directly into the arteries to precisely identify any narrowing or obstruction.

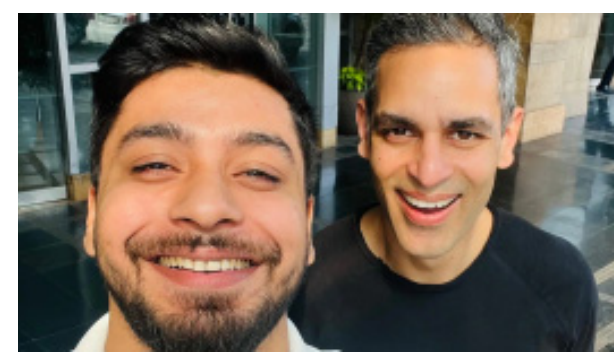
Who should consider getting these tests done? Dr Jenasamant said that anyone with risk factors, such as diabetes, high cholesterol, smoking, obesity, a sedentary lifestyle, or a family history of heart disease, should think about screening, even if they feel fine. "Age also matters, especially for men over 40 and women after menopause," said Dr Jenasamant. Heart blockages often build up quietly. "Waiting for a major symptom can be risky. If you have risk factors or unexplained symptoms, don't ignore them. Early screening, timely diagnosis, and lifestyle changes can significantly help prevent serious heart issues."

Ankur Warikoo's fitness coach, Sagar Ahuja, on his transformation: 'He maintains a six-pack without anyone's help'

Entrepreneur Ankur Warikoo has been training extremely hard to keep fit. And the man behind his current transformation is coach Sagar Ahuja, who believes that maintaining a six-pack all year round is actually possible with the right guidance and mindset. "He is now leaner and stronger, he lifts more weight than most 20-year-olds going to the gym. Bodyweight went from 82 kgs to 69 kgs, waist went from 36 to 29.5 inches, chubby fat to chiselled six-pack abs at 43. More importantly, better energy, improved posture, and higher consistency in daily routine," he told indianexpress.com in an exclusive interview.

When someone like Warikoo shares his transformation publicly, it sets a standard. An excited Ahuja, who started working with Warikoo in 2023, expressed, "It feels great, but more than validation, it's a responsibility. People don't just see results — they see what's possible. We started working together in 2023 when he wanted to specifically target belly fat and overall conditioning, without compromising his lifestyle. I connected with him via email first, and then we had a Zoom call. My main goal was not only to help him achieve his best physique but also to improve his eating habits so that he stays in shape year-round."

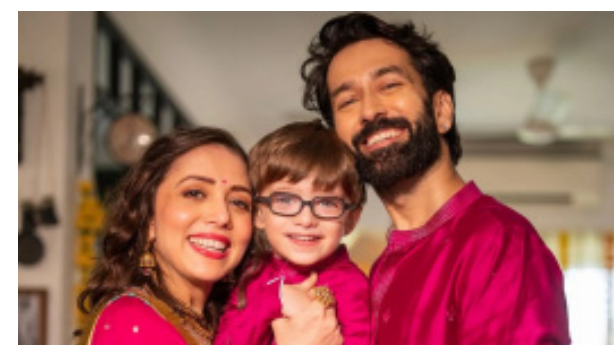
Ahuja, who has coached more than 4,000 men, including founders of companies like Urban Company, Zomato, MakeMyTrip, and Eazydiner, apart from CEOs and creators, talks about his mission to help men become sharper physically and mentally, not just lose weight—the main reason why he started Alphamen, a wellness company focused on men's health. "Early on, I realised most fitness advice fails because it doesn't fit real lives. Busy professionals don't need perfect plans; they need sustainable systems. Over the last few years, I've coached many, helping them lose fat, improve energy, and build discipline that carries into every area of life," Ahuja said. The duo went on to achieve "shredded physique in 10 months". "Through his improved eating habits and awareness, now he maintains a six-pack year-round without anyone's help. Once in a couple of months, I check on him regarding things, that's it," Ahuja shared. The goal was kept "simple": "Lose fat till he achieves six pack abs, improves strength, and makes it sustainable."



And the approach? "No crash dieting; no overtraining; flexible workouts as he travels a lot; focus on habits, systems, not motivation; and build a routine that fits his calendar. While initially, it was about fat loss, now it's about maintenance, longevity, and performance — staying fit despite a demanding schedule. "He trains typically 4-5 days a week, and his focus areas are strength training (hitting two muscle groups a day); daily one hour tennis, and light cardio," mentioned Ahuja, who also coached Warikoo's parents, who are over 70. Notably, Warikoo's current wellness routine is a mix of warm-up and mobility, strength training (major lifts), and core work and lasts 45-60 minutes, he apprised. What's his diet like? "I did design his diet, but not a restrictive one. The principles we followed were high protein intake, balanced carbs and fats, and a no-ban list of foods—he even ate chole bhature occasionally. Flexibility for travel and work," shared Ahuja. What's special about Warikoo? "Fitness is not about abs—it's about becoming a more disciplined version of yourself. Once that changes, everything else follows—business, relationships, mindset. Honestly, motivation isn't the focus. We build systems so he doesn't need motivation, and he is himself a system-driven person. He treats workouts like meetings—non-negotiable. That's the biggest differentiator," said Ahuja. "Don't chase perfection—chase sustainability." "Consistency wins every time. An average plan followed for 6 months beats a perfect plan followed for 10 days," reflected Ahuja.

Nakuul Mehta says wife Jankee is the ultimate advocate for a second child: 'Jin couples ko lagta hai nahi karna...'

On a podcast, 'What not to do as a parent,' actor Nakuul Mehta shared that his wife, Jankee Mehta, can convince anyone to have a second child. Elaborating further, Jankee explained, "Jo couples hote hein, jinko lagta hai second baby nahi karna hai, kyun ki first baby bahut hectic tha, unko waapis wahi stress hoga. I just want to tell you all that the second time is much calmer, much easier. The thing is that challenges will happen, your child will get fever, your child will have choleric... or health issues, but it will all pass. Aur woh pass wali feeling jo hai, woh first child ke baad hi aati hai, kyunki pata chal jaata hai ki woh hone wala hai pass, you know fever aayega, woh 3-2 din ka cycle hai..."



While the sentiment resonates with many parents, is the second child actually easier? According to Dr Vikas Kumar, the answer lies more in the parental mindset than in the child itself.

Is the second child really easier? "The second child is not necessarily easier in terms of actual care," says Dr Kumar. "What changes is the parent's emotional preparedness." He explains that first-time parenting comes with a steep learning curve. "Everything—from feeding to sleep patterns—feels new and stressful. By the time the second child arrives, parents have built confidence and practical skills," he says. Experience vs actual parenting demands

"A large part of the reduced stress comes from experience rather than a decrease in parenting demands," explains Dr Kumar. "In fact, managing two children can increase responsibilities, especially in terms of time and attention." What shifts is perspective. "Experienced parents are better at prioritising, setting routines, and letting go of perfection," he says. "They are less likely to panic over minor issues."

Does confidence increase, or does emotional load double?

Parenting a second child can bring both confidence and complexity. "Having a second child often improves a parent's ability to handle uncertainty because they've already faced many unpredictable situations," says Dr Kumar. "This familiarity builds emotional resilience and problem-solving skills." However, there's another side. "It can also increase the emotional load, as parents now have to balance the needs of two children," he adds. So while anxiety may decrease, responsibility certainly doesn't.

What should couples consider before planning a second child?

Before taking the plunge, experts recommend a reality check. "Couples should think about their emotional readiness, physical energy, financial stability, and support systems," advises Dr Kumar. He highlights practical concerns: "It's important to consider how you'll divide time between two children, maintain your relationship, and handle increased responsibilities." External factors matter too. "Career demands, family support, and mental health all play a key role," he notes. Most importantly, he cautions against relying solely on reassurance. "Rather than just believing that tough phases will pass, couples should assess whether they truly have the bandwidth for another child."

How CSK's Noor Ahmad out-bowled KKR spinners

SYNOPSIS: In the battle of spinners, Noor Ahmad and Akeal Hosein outshine Sunil Narine and Varun Chakaravathy as Chennai defeat Kolkata. The Chepauk pitches have long moved on from the time when spinners licked their lips at the prospect of playing here. The low bounce has made way for good carry. There are hardly any dry patches for spinners to get the ball to grip and turn like a spitting cobra. However, on Tuesday, the Chepauk of old resurfaced much to the liking of the hosts, who had to overcome the choke slam applied by Sunil Narine and Varun Charavathy, both of whom did a splendid job in the middle overs. Defending 192, Chennai Super Kings spinners Noor Ahmad and Akeal Hosein delivered a masterclass of their own to fashion a 32-run win and keep Kolkata Knight Riders winless. A chase that never started

Having witnessed their own spinners dictate the game, Kolkata were proactive in their thinking. With runs against the new ball crucial to stay in the chase, and CSK bringing on Hosein as their Impact Player, the visitors tried to spice it up with what they thought was a favourable match-up. They promoted Narine to open alongside Finn Allen in the hope of finding some quick runs, which would allow them to play risk-free cricket against spinners. Instead, Anshul Kamboj and Khaleel Ahmed removed both of them before they could inflict any sufficient damage, setting up the ideal entry for the spinners. If Narine and Varun had excelled in pulling CSK's run rate down with well-executed defensive lines, Akeal and Noor had the scoreboard pressure to operate with. With KKR in no position to play them out safely and the pitch providing enough assistance despite the onset of dew, the two left-armers — one orthodox and the other a wrist-spinner — closed out the game in their eight overs. Varying pace and trajectory to good effect, they denied both room and air needed for batsmen to get underneath the ball as they conceded just two boundaries between them, con-

ceding only 47 runs. They bowled as many as 15 dot balls. In a four-over period when they bowled in tandem, they gave away 12 runs and took three wickets, killing the chase. Choke by spin

Even when Sanju Samson and Ayush Mhatre were scoring effortlessly in the Powerplay, there were signs of what this pitch could turn into shortly. Considering that aspect and how well Narine and Varun operated in the middle overs, KKR skipper Ajinkya Rahane erred in not introducing them early as CSK racked up 72 runs in the first six overs, losing two wickets. That made a huge impact on the outcome. When brought on eventually, the two mystery spinners dictated the tempo of the innings. With conditions to their liking, Narine and Varun, who had struggled off late, operated in contrasting ways. The wily Caribbean mixed up his variations while bowling to defensive fields — at one point bowled around the stumps to Samson to cramp him for room, with the leg-side boundary heavily manned.

Varun appeared a bit restless to start with. But unlike his previous outings, he did something different here. Like Narine, he attacked the stumps, denying room to batsmen and more importantly, hitting his favourite 6m length. Unlike his senior teammate, he bowled a lot quicker, with his fastest delivery being 110kmph. It was one reason he didn't manage as much purchase as the others, but for a bowler searching for rhythm, Tuesday's spell was a relief. CSK batsmen — Samson, Dewald Brevis, Sarfaraz Khan — tried hard to break the shackles, but seldom succeeded. Between 7-11 overs, CSK managed only 33 runs which resulted in Samson giving away his wicket to Kartik Tyagi, who perfectly complemented the spinners with his slow deliveries and wide-of-off-stump defensive channel. Runs dried up, but KKR didn't get the wickets they would have wanted. However, they still managed to keep the hosts below 200. In the 10 middle overs, CSK managed only 90 for the loss of one wicket. Twenty of those came in Vaibhav Arora's 16th over.

Beyond their two ace spinners, left-arm tweaker Anukul Roy too played his part as the trio had combined figures of 10-0-68-2. And more importantly, they bowled 26 dot balls amongst them that choked CSK. That sort of job meant that, even at the death, the home team struggled to inject momentum, and managed just three boundaries and 30 runs in the last four overs. 'My body is telling me to stop': Why 2-time Olympic gold medalist Viktor Axelsen has been forced into sudden retirement at 32

Two-time Olympic champion and two-time world champion Viktor Axelsen has announced his retirement from badminton due to a persistent back injury. The 32-year-old Axelsen said that he did not want to retire but was being forced to make the decision after nerve pain in his back prevented him from doing even basic training on court. In an emotional post on his Instagram account, Axelsen wrote: "Today is not an easy day for me. Due to my recurrent back issues, I am no longer able to compete and train at the highest level. Accepting this situation has been incredibly difficult. "Since the day I picked up a racket, I knew my dream was to become the best in the world. I have given everything to this sport. It has never been just a career to me. It has been my life and I have left no stone unturned... I have accomplished everything I once dreamed of, and more," Axelsen added. Over the span of a rampaging career, Axelsen claimed Olympic gold medals at Tokyo 2020 and then Paris 2024. He also has a bronze from Rio 2016 besides two World Championships titles (2017 and 2022). His dominance of men's singles is marked by him staying world No. 1 for 100 consecutive weeks. On the Instagram post, Axelsen noted that after he had undergone endoscopic surgery he had tried taking multiple injections and new training methods and treatments in order to be able to play.

"After basically trying everything to become pain-free for a long time now, I have been advised to focus on my long-term health," Axelsen wrote. "To be honest it's not me making the decision. It's my body making the decision for me. That's the hard part," Axelsen said on The Average Not Average Podcast where he announced his retirement. "It's not that I want to retire, it's simply because I'm not able to do the training required. But it is very tough for me not to



be able to say stop or have one last dance. But that's just how my story is, I guess." Axelsen also spoke at length with Badminton Europe, where he detailed his injury and rehab timeline. "As most people know, I have been struggling with my back for quite some time. After I had surgery in April last year and went through a long rehabilitation process, I unfortunately had a setback in October. Since those tournaments, I have not been able to play or train at the level required. I have not been able to play or train due to pain, and that is why I am unfortunately forced to make this extremely difficult decision."

Axelsen told Badminton Europe. "The decision has been made in consultation with the surgeon who operated on me last year, as well as the doctors I have been working with. They say that with the pain I am experiencing now, it could potentially require another surgery, and if that does not go well, even a more serious procedure might be necessary. In any case, it would mean I would not be able to compete at the level required. So, it is simply my body telling me to stop, and I have to follow the advice of my doctors," Axelsen said.

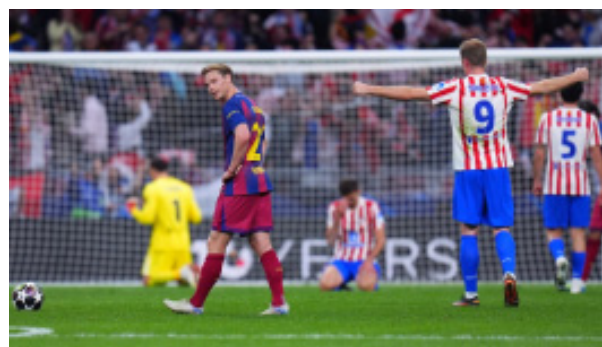

'This was a robbery': Raphinha lashes out at referees as Barcelona's Champions League dream ends in red card chaos

Barcelona's Champions League dreams went up in smoke after the Catalan giants lost their second leg of the quarter-final by 2-1 against Atletico Madrid on Tuesday night. Giving voice to the resentment in the iconic club's dressing room, Barcelona forward Raphinha accused the referees of "robbing" them after both games between the two clubs saw a Barca player red carded. Raphinha's ire was aimed at referee Clement Turpin, who officiated the second game, and Istvan Kovacs, who was in charge of the first clash.

"As far as I'm concerned, it was a robbery, not just this match but the other one (the first leg) as well," Raphinha,

who missed both games due to injury, told reporters. "I think the refereeing is going really badly; the decisions he (Turpin) makes are unbelievable... ?! ?really want to understand why they're so afraid ?that Barcelona will come and win." According to a report on Reuters, Raphinha was seen making repeated 'grabbing motion with his hands' after the game had ended, which is commonly interpreted as a gesture to indicate "stealing". "It was tough, especially when you realise you have to work three times as hard to win the match," Raphinha added. "I think this tie was quite misleading, in my view. I think everyone can make mistakes; everyone is human. But when the mistakes keep repeating themselves in exactly the same way, I think ?that's something we need ?to pay attention to."

Why was Raphinha angry? In the first leg of the Barcelona vs Atletico Madrid quarters, Kovacs had sent off Pau ?Cubarsi in the ?42nd minute after a VAR review for hauling down Giuliano ?Simeone as he raced clear on goal, upgrading ?an initial yellow card. What made matters worse for the Catalan giants was that Atletico Madrid then scored a goal from the resulting free kick with Julian Alvarez slotting the ball past Joan Garcia. In the second leg too, Barcelona would have felt a strong sense of deja vu after Turpin sent off ?defender Garcia after a VAR review for holding Alexander Sorloth from behind while he ran through on ?goal. Media reports said that Barcelona had made their anger known by lodging a formal complaint over an incident early in the second half of the first leg. Barcelona's complaint was based on an incident where Atletico keeper Juan Musso appeared to put ?the ball ?back in play from a goal kick before Marc Pubill handled inside the six-yard box to retake it. Kovacs waved ?play on and VAR did not intervene, prompting angry reactions from the Barcelona bench. The complaint was rejected by ?UEFA.

How MS Dhoni's advice helped Noor Ahmad deliver a Player of the Match performance against KKR

Prior to Tuesday's IPL 2026 outing against Kolkata Knight Riders, Noor Ahmad had endured a tough few months. Since January, he had just one wicket to his name, which came in the previous home match against Delhi Capitals. But on Tuesday, he bounced back to form, picking up 3/21 in four overs in Chennai Super Kings' 32-run win over Kolkata and walked away with the Player of the Match award for his spell.

On a pitch that assisted the spinners, Noor didn't try anything extraordinary. And more importantly, didn't overuse his googly and relied on the one that comes back into the right-hander. As he roared back to form, CSK's bowling coach Sridharan Sriram credited MS Dhoni for having a crucial chat with Noor, where the former captain emphasised not to overuse the googly.

"I think it was good, the wicket helped today. There was a little bit of help for him. The other wickets were quite flat. Today, I think he was a little bit slower through the air; there was more side spin on the ball, and there was more drop. So that's something he's been working on. Even MS (Dhoni) had a long chat with him in one of the practise sessions, getting his leg break to go. So I think it was very helpful for him and the results were there to show," Sriram said in the post-match press conference.

On the eve of the match, when Noor had a long net session, head coach Stephen Fleming and Dhoni watched him from close range. While the New Zealander was stationed behind Noor, Dhoni kept a close tab from behind the nets. And towards the end of the session, the two had a long chat with the Afghanistan spinner, who had an outstanding IPL 2025, where he took 24 wickets. However,



coming into this season, Noor had been battling for form, which meant he didn't even start in any of Afghanistan's matches in the T20 World Cup. In a combination where Noor is expected to play a critical role in the middle-overs for CSK, he had been guilty of erring in his line and lengths. Often operating at a quicker speed, he had been bowling with a flat trajectory and giving room for batsmen to swing in the arc. But on Tuesday, there was a significant change in his speed, and Sriram said Noor has to find ways to get deviations to be aggressive to stay effective rather than be defensive. "I think to be able to get some deviation off the surface is very important. I think that is what he's been working on. Everybody accepts there are going to be days when the wickets are going to be very flat. But still looking to be aggressive, putting revs on the ball and getting the ball to spin will definitely help him a lot. And that's where you can induce mistakes. Because once you start to get defensive, then the batters are going to get on top of you," he said.

The rebel who was also a winner; a stomping attacker on court who surprised unsuspecting Chinese by speaking to them in their tongue

Lin Dan and Lee Chong Wei were a tough act to follow. But Viktor Axelsen built a bridge to Asia by learning Mandarin, picking brains of Asian contemporaries and coaches. He worked incredibly hard on tall agility to form a seamless succession — where the twice Olympic champion from 2021 Tokyo and 2024 Paris, became one of the greatest men's singles shuttlers to play the sport. It was quite poetic that his announcement to retire came in the week following the emergence of similarly 6'4" Ayush Shetty of India, making finals of the Badminton Asia Championships. Wracked by injuries to the ankle and prominently the back that made even training normally impossible, let alone reaching former heights, Axelsen would tell the Average Not Average podcast that he had always been Viktor, a badminton player, but now that part of him was eating into rest of him. Carolina Marin had announced her own retirement speaking of similar struggles to return to court while battling pain, a fortnight ago. Besides his two Olympic gold medals, Axelsen dubbed the 'alien' for his extraordinary dominance in his prime, also took bronze at Rio Olympics where Super Dan and Chong Wei were fading out, i.e. still making semis but not claiming titles. The Super Dane would pick up the mantle, and pick two World titles in 2017 and 2022. He could've had a third, but India's HS Prannoy masterfully took him apart in 2023 in a tactical masterclass showing up the fading features of his power. Bitter losses like those compounded his physical struggles.

Still, Axelsen loomed large at the net and soared high into the backcourt horizon unleashing attacks that were steep, almost curt in their impact and capable of cutting bustling opponents to shreds as power combined with canny court craft. It's not like he was unbeatable, Lakshya Sen had defeated him at German Open once. But Axelsen was better than most of his contemporaries at acing the big moments, raising his levels to go from a struggling 0 to 100 in two rallies, like Sen learnt at the Olympics. Delhi. (He was singularly responsible for keeping the Chinese at bay for nearly a decade, though nobody knows how the badminton scene would've panned out had Kento Momota not suffered the accident. But Axelsen stepped into the niche gloriously, remaining respectful towards his Asian peers.

Not only would he learn Mandarin sincerely, in part to figure what Chinese coaches spoke, but also out of a genuine interest in Chinese culture. There was that funny episode of two Chinese fans giggling about his height in a lift, while he kept a poker face, and then responding with something witty in Chinese as they all stepped out. But Indonesian fans were no less charmed, as they would leave him plushies and teddies for his daughters, at the hotel, to express their admiration.

His selfies with a small espresso cup ahead of his matches wherever he travelled, became a social media post to look forward to. On the court, he was less cute. He could snarl, argue, scream at opposing coaches, fight and then calmly go about controlling the shuttle and sending down his attack. He trained with most upcoming talents, inviting them to Dubai, sharing tips and collecting cues alike, supporting independent players like Lee Zii Jia who did not wish to align with national federations. At his home in Odense, his father would speak about the need to grow the sport in America and take it into the next orbit commercially. Viktor never quite endeared himself to the badminton suits, and though he won the Thomas Cup with Denmark in 2016, he was keen to move out and build his set-up in Dubai. His run-ins with the Badminton World Federation were legendary, and quite staggering given the Federation was headed by another Dane, and Barcelona Olympics champion, Poul Erik-Hoyer Larsen. Axelsen's greatest legacy might well be fighting for players' rights. To ease up the schedule, demanding breaks between matches, spacing out tournaments even as they kept fining him for withdrawals and he kept sharing medical reports and X Rays in snipey back-and-forths. He was also livid about changing badminton to a 15-point scoring system from 21, going against the tide of European preference and opinions. Ultimately, when the BWF did weave in almost all his suggestions, his back was too shot to resume playing again at 32. "It took up a lot of my time and mental energy

'Dhurandhar a perfect film after Sholay': Sooraj Barjatya says 'hats off' to Aditya Dhar after advocating family-oriented content



Sooraj Barjatya has always advocated for family-oriented films. He's made a career out of that genre, right from his 1989 directorial debut *Maine Pyar Kiya*, starring Salman Khan and Bhagyashree, to his upcoming release, *Yeh Prem Mol Liya*, starring Ayushmann Khurrana and Sharvari Wagh. In fact, he reveals that he makes a phone call to any filmmaker who comes up with a family-oriented subject in the otherwise violent cinema landscape of today. "All subjects should get made but this type of content is very important," says Barjatya on *SCREEN Spotlight*, adding, "So that we can tell the younger generation to trust, hope, and support each other otherwise we're all getting divided. Why should there be any loneliness?" He himself has served as a showrunner to a family-oriented show *Sangamarmar* on JioHotstar.

He confessed that despite it not being a family-oriented film, he also loved watching Aditya Dhar's "superb" blockbuster spy thriller *Dhurandhar*, starring Ranveer

Singh. He explains why: "As a filmmaker, whatever's good is good. I think *Dhurandhar* is a perfect picture after *Sholay*. Every character is so well done. Hats off to Aditya." In an earlier edition of *Screen Spotlight*, actor Rakesh Bedi had also hailed *Dhurandhar* as a "perfect ensemble" after Ramesh Sippy's 1975 seminal blockbuster *Sholay*.

Besides *Dhurandhar*, another film that really impressed Barjatya was Mohit Suri's *Saiyaara* last year. Like *Maine Pyar Kiya* launched Salman and Bhagyashree, *Saiyaara* was also a romantic drama that launched newcomers Ahaan Panday and Aneet Padda. "When *Saiyaara* released, I was so happy for Adi and Mohit," reveals Barjatya. Aditya Chopra, like Barjatya and his own protégé Karan Johar, is a second-generation filmmaker who's now headlining a studio founded by his father/ancestor. All three of them made their debut within the same decade, and achieved overnight success with films that somewhere bridged the gap between family-oriented films and young romance.

Barjatya is all praise for both Chopra and Johar, both his juniors. "As a filmmaker, Adi is one of the best, if not the best. We keep pressurising him to direct one more. According to me, his *Rab Ne Bana Di Jodi* is so beautiful. If you go with the dialogues, I don't think anyone writes better than Adi," says Barjatya. Chopra's last successful directorial was the 2008 romantic comedy *Rab Ne Bana Di Jodi*, starring Shah Rukh Khan and Anushka Sharma. He hasn't directed a film after his 2016 setback, *Befikre*, starring Ranveer Singh and Vaani Kapoor. "I remember Karan came to me with the script of *Kabhi Khushi Kabhie Gham* (2001)... I was floored with his narration, his honesty, and the way he extracts work from everyone and yet provide every ras," adds Barjatya. He claims that he continues to learn from younger filmmakers even today, another example being Amit R Sharma, who helmed the 2018 family drama *Badhaai Ho*. "When I watch *Badhaai Ho* even today, I learn so much. It's an ongoing process," says Barjatya.

In the mid 90s, when "Tanha Tanha" and "Rangeela Re" hit the airwaves, as kids we mimicked Urmila Matondkar's moves, but it was Asha Bhosle's voice that gave the song its sass. Who can forget the high-octane energy of "Le Gayi Le Gayi" from *Dil To Pagal Hai*? It was the quintessential dance-off song at every colony party. These were the kind of songs that made the 90s feel bright, glamorous. We didn't know Asha Bhosle, we didn't care about legacy, we understood energy. For us the voice meant fun. It meant colour. It meant life, it had rhythm. Asha Bhosle, then in her 60s, sounded younger and more vibrant than the actresses on screen.

That is the thing about Asha Bhosle. She enters childhood not like a chapter from the past, but like the coolest person in the room.

And then there was MTV, our window into what felt like a cooler, bigger world. *Indipop* was arriving, music videos were redefining what glamour looked like. And right there too was Asha Bhosle, with "Raat Shabnami Bheegi Chandni". We had our teenage crushes on Milind Soman but weeks later, it was her voice that kept coming back, humming itself into your head on the school bus, in the middle of other thoughts. She proved that *Indipop* isn't just for the youth, but a space she could inhabit just as effortlessly and completely make her own. Collaborative gems like "Kabhi To Nazar Milao" and "Kahin Kahin Se Har Chehra" became the literal background score for our first real crushes, playing somewhere between stolen glances and unspoken feelings. Discovering RD Burman-Asha And then we grew up a little and started digging through our parents' cassettes, discovering that the woman who sang "Rangeela" was the same one who defined an era with R.D Burman. That phase of growing up is full of half-understood feelings. You don't yet know much about love, but you are already drawn to songs that seem to know more than you do. This wasn't a shy emotion anymore—this was romance in full colour. "Chura Liya Hai Tumne", "O Mere Sona Re", "Kitne bhi Tu Kar Le Sitam", songs that were more confident, more expressive, almost teaching you what love was supposed to look and feel like, even before you fully understood it. Then comes youth, the years of intense relationships. This is when her songs change again. Or perhaps they don't change — you do. Songs like, "Pyar Ke Mod Pe", "Jahaan Mein Aisa Kaun Hai" felt as if they had been written inside your chest. "Roz Roz Aankhon Tale" has that same ache of intimacy which was quietly consuming. 'After Ramayana': Namit Malhotra confirms Brahmastra 2 timeline and a production shift for Ranbir Kapoor's Astraverse



Ramayana producer and DNEG CEO Namit Malhotra is currently in Las Vegas for the ongoing CinemaCon, and his latest update has reignited excitement among fans. During a brief interaction, Malhotra confirmed that *Brahmastra 2* is very much on track and will go on floors after *Ramayana*, with Ranbir Kapoor set to return for the next chapter. A franchise that started with big ambitions for the unversed, Malhotra was one of the producers of *Brahmastra Part One: Shiva* (2022), alongside Karan Johar's Dharma Productions, director Ayan Mukerji, Ranbir Kapoor, and others. The film introduced audiences to a unique mythological-fantasy universe, generating significant buzz for its concept and visual effects. However, while the film's scale and VFX were widely appreciated, the love story between Ranbir Kapoor and Alia Bhatt drew criticism. Alia's character Isha, in particular, became the subject of memes, with her repeated references to "Shiva" going viral for unintended reasons. *Brahmastra* was a passion project for Ayan Mukerji, nearly a decade in the making. Pre-production began in 2014, with filming kicking off in 2018. Interestingly, this timeline also coincided with Ranbir Kapoor and Alia Bhatt's real-life relationship, which later became a key part of the film's promotions. Ahead of its 2022 release, the makers leaned into this narrative, launching the song *Kesariya* around the time of the couple's wed-

ding. Alia even participated in promotions while pregnant with their daughter, Raha, adding to the film's media buzz. The trilogy plan and star-studded cast conceived as a trilogy, the franchise includes *Brahmastra Part One: Shiva*, the upcoming *Brahmastra Part Two: Dev*, and a third yet-to-be-titled installment. The first film also featured an ensemble cast including Amitabh Bachchan, Nagarjuna, Shah Rukh Khan, and Dimple Kapadia, with Deepika Padukone making a brief but crucial cameo. The climax teased the next chapter, hinting at the mysterious character *Dev* and a larger storyline involving Deepika's role, sparking widespread speculation about casting—ranging from Ranveer Singh to Vijay Deverakonda. Mounted on a massive budget of Rs 350–400 crore, *Brahmastra Part One: Shiva* collected around Rs 431 crore worldwide gross, with an India net of approximately Rs 267.20 crore, according to *Sacnilk*. While the numbers were substantial, questions around profitability led to uncertainty about the sequel's future. In the meantime, Ayan Mukerji moved on to other projects like *War 2*, while Ranbir Kapoor remained busy with films such as *Animal*, *Tu Jhoothi Main Makkar*, *Ramayana*, and Sanjay Leela Bhansali's *Love & War*. Social media reacts with Malhotra's fresh confirmation, *Brahmastra 2* is once again trending across social media platforms like *Reddit*, drawing mixed reactions. Some users questioned the viability of the sequel, pointing to the first film's mixed reception and profitability concerns. Others criticised the screenplay, calling it confusing despite strong visuals. A section of fans, however, expressed cautious optimism, urging the makers to focus on stronger writing and direction for the sequel. "Get better writer and director", wrote a fan. "Wasn't *Brahmastra* a flop?", asked another. The renewed buzz has also revived casting rumours. Reports suggest that Ranbir Kapoor himself may step into the role of *Dev*, with Deepika Padukone as his leading lady. Meanwhile, many fans are rooting for a high-voltage face-off between Ranbir Kapoor and Ranveer Singh, especially after their recent intense performances in films like *Animal* and *Dhurandhar*. Ranbir Kapoor had already dropped a hint interestingly, Ranbir Kapoor had earlier hinted at the sequel's progress. During a fan interaction on February 14, he confirmed, "*Brahmastra 2* is in the works. We shall start shooting the movie sooner than you expect."

Man gatecrashed Anushka Sharma-Virat Kohli's Italy wedding dressed as a maharaja, says security head: 'He came in a BMW'

Anushka Sharma and Virat Kohli's 2017 wedding was one of the best kept secrets of recent memory in the movie business. They tied the knot in Tuscany, Italy with only 40 guests in attendance, including their family members and close friends. However, there was a gatecrasher who managed to make his way into the wedding, thanks to what Aamir Khan's character in *3 Idiots* (2009) would describe as a "costume". A gatecrasher, dressed exactly like a maharaja, arrived in a BMW, accompanied by two bouncers in a Safari, revealed Yaseen Khan, founder of the security firm that provided its services to the high-profile wedding. "I wasn't present at the gate. I was at the main floor where the wedding was taking place. My team was there. We know the gatecrashers by face. My supervisor had a doubt so he flagged it to the event management team," added Khan.

However, the event management team, full of young trainees fresh out of college, assumed the gatecrasher is a guest, given the BMW. So, they let him in. "When I got my eyes on him, he would stay only in the corner. His security guards would click his picture with a celebrity, after which he'd retreat into the corner. If you're a guest, you'd mingle with others at the wedding," said Khan.

When Khan enquired his background, the gatecrasher claimed he's the nephew of a high-profile guest who couldn't make it to the wedding in Italy. "So, I went to Virat's manager and asked him if that guest is invited. He told me no, he's invited only for the Delhi wedding reception. So, I went back to the gatecrasher and told him only invited guests are allowed. He threw some attitude before making his way out," recalled Khan. Khan recalled another high-profile celebrity wedding that got difficult to manage — Deepika Padukone and Ranveer Singh.
