Kavitha Launches New Political Party, Attacks KCR and BJP

New Delhi, April 25

In a major development in Telangana politics, Kalvakuntla Kavitha today announced the formation of her new political party, the Telangana Rashtra Sena (TRS), unveiling the party flag during a public event.

Addressing the gathering, Kavitha proclaimed that a new revolution has begun in Telangana, emerging as a fresh political force born out of immense struggle. She described this day as unforgettable and called for collective participation to secure the state's future. Kavitha reflected on the hardships endured and the fierce battles fought for Telangana's cause, highlighting the sacrifices made, including lives lost during the movement.

She recounted her efforts during the movement, travelling from village to village with the cultural symbol Bathukamma, which she credited with helping gain momentum for the movement. She criticised the fact that,

spite 12 years since Telangana's formation, the dreams of its people remain unfulfilled. Kavitha lamented that the movement's "chariot," led by KCR, has lost its way, and expressed disappointment that the poor continue to suffer while expectations of emancipation remain unmet.

She also criticised the ruling family of Telangana, stating she was ashamed to be part of the family that ruled the state for ten years, and promised to make amends by stepping before the public with the TRS. Kavitha asserted that the BRS has lost the soul of Telangana and expressed her desire to serve as a maternal figure to the people, working towards a socially just Telangana.

Kavitha also took aim at the BJP, accusing the party of opposing Telangana's formation and comparing the bifurcation to the partition of Pakistan. She condemned



BJP MPs in the state as obedient to the Central government and demanded the return of five villages merged into Andhra Pradesh.

She criticised KCR, claiming he failed to realise the vision of a "Social Telangana" and accused him of

betraying the movement, describing him as a "robot" who is absent when the public faces hardships. Kavitha questioned why KCR remains silent while the homes of the poor are demolished, asserting that he has lost his political maturity.

Election Commission tightens security for second phase of Bengal polls

The Election Commission of India has directed enhanced security measures for the second phase of Assembly elections in West Bengal on April 29. Over 2,300 companies of central forces will be deployed, with the highest concentration in North and South 24 Parganas.

Kolkata, April 25

Following instructions from the Election Commission of India (ECI), special scanning is being carried out at unfenced stretches along the international border with Bangladesh in districts of West Bengal that will go to the polls in the second phase of the two-phase Assembly elections in the state on April 29.

"Special checking is taking place near the unfenced borders ahead of the polls. The Border Security Force is on high alert. The intensity of naka checking is also very high in these areas. All precautions have been taken to ensure free, fair and peaceful polls," Chief Electoral Officer (CEO), West Bengal, Manoj Kumar Agarwal, said.

He added that since the number of Assembly constituencies going to polls in the second phase, the geographical spread and the number of polling booths are lower than in the first phase on April 23, surveillance and security arrangements will be tighter in the second phase. In the first phase, polling was held at 45,000 booths across 152 Assembly constituencies spread over 16 districts. In the second phase, polling will be held at 40,000 booths across 142 constituencies spread over six districts and Kolkata.

Moreover, the number of police observers in the second phase is 95, which is 11 more than the 84 deployed in the first phase.

"So naturally, the extent of security coverage and surveillance will be higher in the second phase than in the first phase," the CEO said.

A total of 2,348 companies of central forces — including the Central Armed Police Forces (CAPF), India Reserve Battalion (IRB) and armed police units from other states — will be deployed in the second phase, in addition to personnel from West Bengal Police and Kolkata Police.

The highest deployment of central forces will be in North 24 Parganas district with 507 companies, followed by South 24 Parganas with 409 companies.

Meanwhile, an insider from the CEO's office said coastal patrolling has been intensified in the Sundarbans region spread across South 24 Parganas and North 24 Parganas districts due to the extensive coastal boundary with Bangladesh.

People object to Minister Vivek's Kaleshwaram remark

: Labour Minister G Vivek Venkat Swamy had to face embarrassing moments on Saturday when people objected to his comments on the Kaleshwaram project being totally useless and that the former BRS government had spent one lakh crore rupees on a futile project. The BRS legislator V Sunitha Laxma Reddy took serious objection to his comments and buttonholed the minister about the failure of the Congress government in fulfilling its electoral promises.

Pandemonium prevailed in the meeting hall where the Minister was to distribute Kalyan Laxmi scheme cheques, as supporters of both the minister and the legislator raised slogans and counter slogans. Uniformed policemen moved into the hall to control what appeared to be an explosive situation. The minister and the MLA were locked in a verbal duel on the stage over the failure of the government in implementing its electoral promises.

He highlighted that the Polavaram Left Main Canal is the main conduit for transporting water to the region and assured that major industries in Anapalli would receive sufficient water supplies.

During his inspection of ongoing works on the Polavaram LMC at the Pampa Aqueduct in Annavaram, Kakinada district, the Minister also oversaw the construction of highway crossing bridges near Arempudi and Gavarayya Koneru. Later, at a review meeting at the R&B Guest House in Tuni, officials and agencies discussed progress. Naidu stated that Chief Minister Chandrababu Naidu has directed the completion of the first phase by June and the flow of Godavari waters up to Anapalli.

He urged officials to expedite bridge construction at highway crossings, warning that delays would not be tolerated. Reiterating the vital role of the Polavaram canal, he assured the waters would meet the needs of agriculture, drinking, and industry in North Andhra, preventing water scarcity in the region.

Banks missing glaring red flags

TWO recent headline-grabbing frauds — the Rs 20-crore crypto con in Ludhiana and the Rs 22.9-crore digital arrest scam in Delhi — clearly indicate that India's cybercrime problem is systemic, scalable and increasingly sophisticated. In Ludhiana, an industrialist was lured through a fake crypto ecosystem and drained of Rs 19.84 crore, routed through 76 forged accounts across 15 banks. In the digital arrest case, fraudsters impersonating law enforcement officials weaponised fear, isolating the victim, coercing compliance and extracting Rs 22.9 crore through staged urgency and intimidation. In a rare intervention, the Reserve Bank of India ombudsman directed five banks to pay Rs 1.3 crore for lapses in due diligence in the digital arrest case.

Significantly, both cases expose a common fault line: banking channels that fail to detect the abnormal. The scale alone raises uncomfortable questions. How do dozens of fraudulent and mule accounts slip through multiple banks' KYC filters? How does a network sustain itself long enough to move unusually large, rapid transfers without triggering red flags? Compensation, when it comes, is partial and belated. It is hardly a deterrent in a high-reward fraud economy. Today's scams are behavioural operations. Fake dashboards simulate profits; fake officials simulate authority. Victims are not just deceived; they are managed, monitored and manipulated over time. Cryptocurrencies sit in a grey zone. Coercion-based frauds lack clear response protocols. Inter-bank coordination is weak. Enforcement chases money already dispersed across layered accounts. These cases once more underscore the reality that cyber fraud in India has evolved into an organised enterprise.

Kondamadugu Narasimha ““(Yadadri Bhuvanagiri District Bureau..Indian Chronicle..April 25):- Telangana Agricultural Labor Union District General Secretary Kondamadugu Narasimha criticized the rulers and officials for failing miserably in providing even minimum facilities to the laborers sweating in the scorching sun. They demanded that the government immediately cancel the face-based attendance system, saying that workers are facing many problems due to technical issues due to taking photos twice a day through the face-based NMMS app at the workplace. On Saturday, a “dharna” program was organized in front of the Bibinagar MPDO office under the auspices of the Telangana Agricultural Workers' Union Mandal Committee to resolve the problems of employment guarantee workers. Narasimha participated as the chief guest of this program and said that since the Modi government at the center came to power, it has been making many conspiracies to lift the employment guarantee and bringing new and new JIOs, repealing the Mahatma Gandhi National Rural Employment Guarantee Act and bringing the G Ram Ji scheme, which has hurt the workers. Mechanization has replaced manual labor, leaving many without jobs or shelter, forcing families into migration and poverty. ““400,000 Population, Yet Ignored in Records””Despite having an estimated population of over 400,000 across the state, official caste census data shows their numbers in mere thousands. Due to lack of awareness and literacy, many in the community are unable to register their identity, resulting in denial of welfare schemes and reservation benefits. ““Key Demands from the Community””Share in Mining Leases: The government must ensure employment opportunities for local Pathar Podu workers in quarry lease areas. “Special Financial Package: Immediate financial assistance of 70 lakh for each affected family. “Educational Support: Establish residential schools and provide special scholarships for children under prom-



ised schemes. “Revised Caste Census: Update official records to reflect the true population and ensure rightful benefits. “In a strong warning, Sheikh Jameel stated, “Our hammer can break stones, but when our hunger rises, it can shake governments. If our voices are ignored now, we will launch statewide protests. ““

District Legal Services Authority holds awareness programme on child marriage prevention.



Karimnagar April 25 (Correspondent) : The District Legal Services Authority (DLSA) organised a legal awareness seminar on preventing child marriages, emphasising the need for stronger social awareness and strict enforcement of laws to protect the future of girl children. The programme focused on the "ASHA-2025" (Awareness, Support, Help, Action) guidelines formulated by the National Legal Services Authority (NALSA). Conducted under the directions of K. Rani, Secretary, DLSA, and Senior Civil Judge,

the seminar was part of an ongoing legal literacy initiative.

Members of the DLSA and panel advocates said child marriage was not merely a legal violation but a grave social issue that undermined the aspirations and development of girls. They stressed that eliminating the practice required both legal intervention and community participation.

Explaining the ASHA framework, the speakers described it as a structured mechanism aimed at spreading awareness, providing support to victims, enabling timely intervention through helplines, and ensuring prompt legal action. They noted that the initiative was being implemented nationwide through standard operating procedures to strengthen grassroots-level response. The speakers highlighted the adverse consequences of child marriages, including health risks due to early pregnancies, threat to life, and loss of educational opportunities. They reiterated that, under the Prohibition of Child Marriage Act, 2006, marriages involving girls below 18 years and boys below 21 years are punishable offences, with stringent action against those facilitating such unions. Calling for greater societal responsibility, they urged parents and community members to prioritise education and empowerment of girls instead of early marriages. Participants were informed that incidents of child marriage could be reported through toll-free helplines 1098 (Childline) and 15100 (Legal Aid), with assurances of confidentiality for informants. Free legal services are also available at the DLSA office in the district court. Advocates A. Kiran Kumar, Peruku Rangaiah, and Chitti Chandraprakash Reddy, along with MEPMA Project Director G. Swarooparani, attended the programme. Over 100 women participated.

Eco-sensitive zone around Himachal Pradesh national park quashed: What the high court said and why it matters

On April 16, the Himachal Pradesh High Court quashed a 2022 notification that had declared areas around Col Sher Jung National Park, also known as Simbalwara National Park, in Sirmour district as eco-sensitive zones (ESZs). The court held that both the state and central governments had "miserably failed to follow the procedure" required for issuing such a notification. The notification had been issued in January 2022 by the Ministry of Environment, Forest & Climate Change (MoEFCC), on recommendations of the Himachal Pradesh government. Here's a look at what the notification said, the activities it prohibited, regulated and promoted, the issues raised against it, the high court ruling, and what it means going forward. Col Sher Jung National Park and its history

Col Sher Jung National Park is located in Himachal Pradesh's Sirmour district, next to the Kala Amb-Paonta Sahib-Dehradun National Highway-7. It is spread over an area of 27.88 sq km. Initially a protected forest and later a wildlife sanctuary, it was notified as a national park on June 7, 2013. The park holds ecological significance due to its strategic location at the confluence of three major biogeographic zones—the Himalayan region, the Gangetic plains, and semi-arid areas. As per a 10-year management plan for this national park, its unique positioning results in a rich mix of flora and fauna, reflecting characteristics of the Western Himalayas, the Punjab plains, and the Upper Gangetic plains. Geographically, the park is defined by the Shivalik Hill ranges, forming a bowl-shaped valley intersected by seasonal streams locally known as "khala" or "rau". The main stream system is the Nimbuwala khala and its tributaries. Vegetation in the park is dominated by species such as sal, sain, mahua, jamun, amla, and amaltas. The park supports diverse wildlife, including leopard, sambar, barking deer, nilgai, wild boar, jackal, and langur. It also hosts rich birdlife typical of the Shivalik and Himalayan regions, along with around 70 species of butterflies. Historically, the area was part of elephant migratory routes, though such movement has now reduced due to habitat fragmentation caused by infrastructure projects such as the Yamuna barrage.

In January 2022, the MoEFCC issued a notification declaring an area around Col Sher Jung National Park as an ESZ. The ESZ covered an area of 31.24 sq km, encompassing 19 villages across three Gram Panchayats, Bhatanwali, Patalia, and Behral. The objective was to create a buffer zone to protect the park's fragile ecosystem by regulating human activities. The notification imposed a ban on several environmentally harmful activities, including commercial mining, stone quarrying, and crushing units; establishment of polluting industries (red category); hydroelectric projects; brick kilns and saw mills; use or handling of hazardous substances; discharge of untreated waste into natural water bodies, etc. However, limited extraction of resources for local domestic needs was permitted. Certain activities were allowed but subject to strict regulation: Construction activities, especially near the park boundary; establishment of hotels and resorts; tree felling (with prior permission); and small-scale industries. No new commercial construction or hotels were allowed within 1 km of the park boundary, except for limited eco-tourism structures. The demand for exclusion from the ESZ came primarily from residents and elected representatives of areas falling within the notified zone. Representatives of Bhatanwali, Patalia, and Behral approached the Himachal Pradesh High Court,

seeking exclusion from the ESZ. They argued that it adversely affected residential, agricultural, and livelihood activities, and no proper procedure was followed for declaring the area as an ESZ.

The demand was also supported by local Congress MLA Ajay Solanki from Nahana and BJP MLA Sukhram Chaudhary from Paonta Sahib. In their representations to the state government, they sought implementation of a reduced ESZ boundary of 1 km in line with the Supreme Court's 2022 directions, along with the application of the 2023 provision allowing site-specific relaxation. A key concern highlighted was the industrial importance of the Paonta Sahib sub-division, which hosts several industries providing employment and contributing significantly to state revenue. Some industrial units, including stone crushers, also sought relaxation or extension, citing a lack of clarity regarding ESZ boundaries at the time of their establishment. In November, 2025, Mohkam Singh, proprietor of Mohkam Singh Stone Crusher at Surajpur village, submitted a representation to the state government demanding a three-year extension, stating that at the time of granting permission, neither the unit nor the officials concerned appeared to be aware of the precise ESZ boundary and its overlap with the unit's location. In its April 16 order, a division bench of the Himachal Pradesh High Court highlighted serious procedural lapses, possibly including inadequate stakeholder consultation, improper demarcation, or non-compliance with statutory requirements.

Many villages were included in the ESZ when the recommendations were prepared in 2012, but many were later excluded when a draft notification was issued in 2015—without any reasons cited for the exclusion and inclusion of villages. The court also took cognisance of the record placed by MoEFCC that the draft ESZ notification was considered in the 18th meeting of the Expert Committee for Eco-Sensitive Zones, where the committee requested the state government to provide a detailed justification for the proposed zero ESZ extent and to submit a revised proposal. The state government, however, did not submit the information sought or a revised proposal. The notification could not be finalised within the stipulated 725 days and lapsed. Thereafter, the state government submitted a fresh proposal and a new draft notification was issued on December 24, 2020. The court said no committee, comprising the wildlife warden, an ecologist, an official from local self-government, and the revenue department of the concerned area, was ever formed to reinstate the process after the previous notification lapsed in 2015. There was a complete disregard of the procedure prescribed for declaring the Eco-Sensitive Zone, the court noted. The immediate impact of the judgment is that the ESZ notification ceases to operate, effectively removing the regulatory restrictions imposed around the park. A senior wildlife officer attached to the national park said, requesting anonymity, "Industries will not come out within a day or two. Our main concern is the mining-related activity and the possibility of rampant construction around the national park. Many rivulets, etc., pass through the national park. Mining cannot take place inside the park, but if mining takes place outside and near the park, that too will have an adverse impact." The withdrawal of the notification has also increased the risk of unregulated development around the park, potential threats to wildlife habitat and ecological balance, and possible disruption of wildlife corridors connecting nearby protected areas.

What next?

"We are studying the judgment. We will definitely take a decision on it shortly," Sanjay Sood, Himachal Principal Chief Conservator of Forests-cum-Head of Forest Force, said. Senior Advocate Deepak Kaushal, who represented the Gram Panchayats, said, "At present, the notification declaring the area as ESZ has been quashed and set aside. The government will need to follow the entire process laid down for declaring an area as an ESZ. It is the responsibility of the state government to follow the procedure." "The MoEFCC only constitutes an Eco-Sensitive Zone Committee. Consultation with local representatives, field inspections, etc., is the work of the state government. The state and central governments are at liberty to challenge the decision before the appropriate forum," he added.

Crowds swell for pind clinic vacancies in state, spotlight on Punjab's job crisis

Many candidates turned up at the Civil Surgeon office in Punjab's Sangrur Monday for just 117 'pind clinic in-charge' vacancies underlining the prevailing unemployment and highlighting the stark gap between demand and supply of jobs in the state. The rush was particularly striking because the job is temporary and the candidates will only be paid Rs 620 per day. The candidates at the venue, meanwhile, alleged lack of basic arrangements such as drinking water despite the scorching heat. Looking at the heavy turnout, Civil Surgeon (Sangrur) Dr Amarjeet Kaur said, "Hundreds have turned up for the vacancies of pind clinic in-charge and we are busy attending to them... we will continue tomorrow... (as we could not attend all the candidates today)." As per the eligibility criteria, candidates must have one of these: a B.Sc in Nursing, a diploma in General Nursing and Midwifery (GNM), Auxiliary Nursing and Midwifery (ANM), be a pharmacist with a diploma or degree in pharmacy. Preference will be given to GNM/B.Sc Nursing candidates, followed by ANM candidates and then pharmacists. Similar scenes also took place on April 17 reported from other districts.

In Mansa, around 500 candidates turned up for just 11 posts of pind clinic in-charge and nearly 450 appeared for interviews. Sources said many also left due to the heavy rush. In Ludhiana, nearly 1,500 candidates reportedly appeared for around 200 temporary posts. Reacting to the situation, Union Minister of State Ravneet Singh Bittu posted on X, "The Real face of 'Badlav' — Punjab's youth forced onto the streets... The massive flood of unemployed youth is a stinging reality check for the Punjab government's hollow claims of providing jobs. When thousands of qualified candidates are forced to scramble for a mere 117 posts, it exposes the dire state of unemployment in the state. Where are the tall promises of 'Har Ghar Naukri'? Is this the 'Rangla Punjab' you envisioned — where our youth are left to despair?"

The 'pind clinic' initiative is an extension of the state government's Aam Aadmi Clinics aimed at expanding primary healthcare coverage in rural areas. On January 23, the Chief Minister's Office had made the formal announcement of pind clinics. The post on social media said: "Punjab Government, led by Chief Minister Bhagwant Singh Mann,

has announced the launch of 2,500 'pind clinics' to ensure that no villager has to travel to the city for primary healthcare. These clinics will be opened across every corner of rural Punjab within the next 4 to 5 months."

In the first phase, the government plans to open 1,100 pind clinics, which will later be expanded to 2,500. At present, the state has already operationalised 881 Aam Aadmi Clinics, where doctors, nurses and pharmacists are engaged on a per-day wage basis depending on patient footfall. Under the model, one pind clinic in-charge will cater to two clinics — operating from 8 am to 11 am at one location and from 12 noon to 3 pm at another nearby clinic. Rs 120 per day will be the travel allowance as well to commute between two clinics on working days. Officials said the Punjab health department advertises these posts online district-wise, following which candidates report directly to the respective Civil Surgeon offices for interviews. The selection process is still underway, with the health department expected to prepare a merit list after interviews to declare results, they said.

As poor-quality wheat piles up, procurement agencies seek waiver of storage gain norms

The committee pointed out that the Centre, through the Ministry of Consumer Affairs, Food and Public Distribution, has already relaxed procurement norms for Fair Average Quality Flagging serious concerns over the quality of wheat, the Joint Coordination Committee of State Procurement Agencies, Punjab, has written to the state Department of Food, Civil Supplies and Consumer Affairs urging it to take up the matter with the Centre for a complete waiver of 'storage gain' norms for the 2026-27 procurement season.

In its letter, a copy of which is with The Indian Express, addressed to the Secretary of the department, the committee said that extreme weather conditions—including heatwaves during February-March and unseasonal rains and hailstorms during harvesting—have severely damaged wheat crop. As a result, the state is witnessing a sharp rise in shrivelled and broken grains, damaged kernels, and loss of lustre, along with higher moisture content. The committee pointed out that the Centre, through the Ministry of Consumer Affairs, Food and Public Distribution, has already relaxed procurement norms for Fair Average Quality (FAQ) wheat. The permissible limits have been increased to 15%

for shrivelled and broken grains and up to 70% for lustre loss, while damaged grains have been allowed up to 6%.

However, it added that even with these relaxations, the wheat being procured falls under Uniform Relaxed Specifications (URS) and is of significantly inferior quality compared to normal FAQ wheat. "Applying the existing storage gain formula, which is based on ideal FAQ conditions, to such substandard wheat is neither scientific nor practical," the letter mentioned. Citing a study by the Indian Council of Agricultural Research, the committee said that storage gain norms are derived from wheat stored under ideal conditions, which is not the case this year. Instead of gaining weight during storage, the current crop is likely to lose weight due to moisture evaporation, grain damage, and structural deterioration.

The letter also highlighted that the situation is worse than the 2015-16 crop, when the Centre had reduced storage gain norms by 50%. This year, however, the extent of damage is higher, warranting a complete waiver rather than partial relief. Another major concern flagged was the acute shortage of scientific storage space in Punjab. With state godowns already filled with previous stocks of wheat and rice, agencies may be forced to store the new crop in open and substandard conditions, increasing the risk of infestation, spoilage, and further quality loss. The committee warned that enforcing current norms could lead to financial losses and operational difficulties for procurement agencies, as they would be held accountable for weight variations that are beyond their control. Calling the situation unprecedented, the committee urged the government to act swiftly. "The current wheat crop is neither comparable to standard FAQ wheat nor suitable for application of conventional storage norms. A complete waiver of storage gain is essential to ensure fair handling of this year's crop," the letter stated. The issue comes at a time when Punjab is expecting over 120 lakh tonnes of wheat procurement, making it critical to address storage and handling challenges in a timely manner. It has been signed by the officials of state procurement agencies, including Markfed, PUNSUP Pungrain, and Warehouse.

NRI woman says IDFC First Bank scam 'mastermind' Ribhav Rishi defrauded her of Rs 2.5 cr

One of the main accused in the IDFC First Bank scam, Ribhav Rishi, has found himself in another case after a 77-year-old NRI woman alleged that he duped her of around Rs 2.5 crore. According to the police, an FIR has been registered at the Sector 17 police station in Chandigarh, under Sections 316(5), 318(4), 338, 336(3), 340(2), and 61(2) of the Bharatiya Nyaya Sanhita (BNS) on the complaint of a woman residing in the UK. The accused include Ribhav, former manager at IDFC First Bank, Sector-22/B, Chandigarh, along with other bank officials. The investigation is currently in progress.

The complainant, Taranjit Kaur Bains, said that she and her husband reside in Greater London. She came in contact with retired Punjab National Bank officer R K Rishi in 2020 during the sale of her house, who later introduced her to his son, Ribhav. At the time, Ribhav was working as a manager at IDFC First Bank. He allegedly persuaded her to open an NRI account by promising attractive returns and subsequently convinced her to deposit large sums of money.

Climate change reshaping carbon storage in India's forests: IITM-Pune study

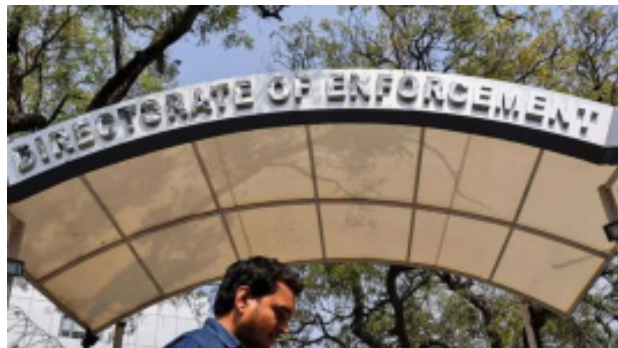
India's forests are an important carbon sink, helping remove carbon dioxide from the atmosphere and store it in living vegetation such as trunks, branches, leaves, and roots. But how this carbon storage will change in a warming world has remained unclear. A new study at Indian Institute of Tropical Meteorology (IITM), Pune shows how climate change is reshaping carbon storage across India's forests. The study led by Fitha Fathima, Mareena Mathew, and Roxy Mathew Koll from IITM-Pune has been published in Environmental Research: Climate and explores how forest carbon may change across the recent past, near future, mid-century, and late century under low, medium, and high fossil fuel emissions pathways.

The study finds that the carbon stored in India's living forest vegetation is projected to increase across all major forest regions of the country, but not evenly. The largest gains are projected in the Desert and Semi-Arid zones followed by the Trans-Himalaya, Indo-Gangetic forest belt and the Deccan Peninsula, while the Western Ghats, North-east, and Himalayan forests also increase, but more modestly. Across India's forested regions, the study projects that average living forest carbon rises from 7.74 kilograms of carbon per square metre in the historical period to 10.24 under low emissions, 11.76 under medium emissions, and 13.67 under high emissions by the late 21st century. That corresponds to increases of about 35%, 62%, and 97% by 2100. The three futures remain broadly similar until around 2030, then begin to separate, with the divergence becoming clear by about 2050. It also shows that rainfall variability plays a stronger national-scale role than temperature in shaping changes in forest carbon, with rainfall effects often unfolding over several years rather than instantly.

Fitha Fathima, lead author of the study said that climate change is not just about rising temperatures — it is

silently rewriting every sector, including our forests. "Even where gains appear, they may mask deeper stresses, raising concerns about the stability of today's dense forests and the risk of releasing large stores of carbon, thereby accelerating emissions. If we undermine our forests today, we risk amplifying emissions tomorrow and weakening long-term environmental resilience," the researcher said. According to IITM Pune's climate scientist Prof Koll, India's forests are not responding to climate change in a uniform way. "Some regions may store more carbon in living biomass, but that does not mean climate change is helping forests. A warmer world is also bringing greater risks from drought, fire, and other disturbances and the study according to researchers shows most clearly that rainfall matters deeply, and that future forest planning must be regional, climate-aware, and rooted in risk prevention," he said. "Rainfall has the strongest overall influence on changes in forest carbon across India, while temperature has a stronger influence within many individual regions, especially under higher emissions. Rainfall effects appear with a lag of about two years under low and medium emissions, and about four years under high emissions. Temperature shows a more consistent lag of about two years. The paper detects this lag statistically. A likely explanation is that forests do not respond instantly to a single wet or dry year. Water availability can build or weaken across seasons, and woody biomass changes slowly over time," Pramit Deb Burman from IITM added. According to Rajiv Chaturvedi, BITS Pilani, this is one of the first forest dynamics modelling efforts from India, utilising a second generation Dynamic Global Vegetation Model (DGVMs). "The study generally projects increases in vegetation carbon under different climate change scenarios. However we need to remember that the models in its present form do not include limitations for nutrient availability. Hence this modelling effort needs to be followed up with further modelling

ED raids Congress MLA NA Haris's sons in bitcoin-linked money laundering case

The Enforcement Directorate (ED) conducted simultaneous raids at 12 locations across Karnataka on Monday, targeting the sons of Congress MLA NA Haris and prime accused Srikrishna Ramesh alias Sriki in connection with the high-profile bitcoin case. Mohammed Haris Nalapat and Omar Farook Nalapat — sons of Shantinagar Congress MLA NA Haris — were named by ED as close associates of Sriki and alleged primary beneficiaries of proceeds of crime under the Prevention of Money Laundering

Act (PMLA), 2002.

A team of ED officials and security personnel conducted searches at the family's residence on Magrath Road in Bengaluru, as well as at other locations. The raids also covered Aqeeb Khan, the grandson of former Union minister K Rahman Khan and nephew of Congress leader Mansoor Ali Khan, whom ED alleged was another direct beneficiary of the crime proceeds. According to investigators, the accused operated through a well-structured network that involved hacking websites and cryptocurrency wallets to steal virtual digital assets (VDAs), siphoning sensitive data and funds, and selling stolen crypto assets through trading platforms to disguise their origin. The proceeds were then allegedly routed through multiple bank accounts for layering before being used for personal gain. ED's investigation is based on multiple FIRs and charge sheets filed by the Karnataka Police, which allege offences including hacking of national and international websites, theft of bitcoins, extortion, and violations of the NDPS Act. The raids mark a significant escalation in the Bitcoin case, which has drawn political attention due to the involvement of family members linked to a sitting Congress legislator.

With the first phase of the West Bengal Assembly elections just days away, a Public Interest Litigation has been filed before the Calcutta High Court, fearing "arrests" of Trinamool Congress party leaders and workers prior to the polls.

The matter was listed Monday before the Division Bench of HC Chief Justice Sujoy Pal and Justice Parthasarathy Sen, which allowed the petition filed by advocate Md Danish Farooqi. TMC Member of Parliament and senior counsel Kalyan Banerjee appeared in the court on behalf of the party. The matter is likely to be heard on Wednesday. Party workers alleged that the Election Commission of India has sought the names of around 800 workers, including MLAs, councillors and party workers across constituencies, through the state police. "There is a fear of their arrest. The court should immediately intervene in this matter," the petitioner argued.

The plea, a copy of which was obtained by The Indian Express, states: "This list purportedly designates certain individuals, referred to within as 'trouble makers' and has been surreptitiously disseminated among the cadre of recently appointed Police Observers and General Observers deployed throughout the state of West Bengal for election-related duties." "Accompanying this clandestine list... is



an explicit directive issued to the said observers to ensure that all individuals named as alleged "trouble makers" are identified, located, and subjected to arrest and/or preventive detention prior to the commencement of polling in their respective Assembly constituencies. The objective... appears to be pre-emptive removal of these individuals, irrespective of whether there are any pending criminal proceedings or established grounds under law for such drastic actions... (and) to interfere, in an impermissible manner, with the integrity of the electoral process," it further claimed. The said list includes the names of Cabinet Minister Udayan Guha, MLAs Paresh Chandra Adhikari, Hamidul Rahaman, Gautam Paul, Amirul Islam, Imani Biswas, Ratna Chatterjee, and former MLA Manirul Islam, among others. Over the last few days, Chief Minister Mamata Banerjee has repeatedly alleged during the campaign that a "conspiracy" was underway to "arrest TMC workers" ahead of the polls.

Punjab Congress poses question: 'will culprits of 2015 sacrilege face action'

On a day the Punjab government notified the Jaagat Jot Sri Guru Granth Sahib Satkar (Amendment) Act, 2026, the Congress asked the AAP government whether the culprits of the 2015 sacrilege incidents and police firing at the anti-sacrilege protesters will face the law. State Congress chief Amrinder Singh Raja Warring said the AAP government has enacted the law months before the state goes to polls to "befool the people". "The question is whether the culprits of the Behbal Kalan and Bargari incidents will get punishment. People want justice in the Behbal Kalan and Bargari incidents. If it (justice) is not being delivered, then there is no use of this act. After four years, you (AAP government) enacted this law to fool people," said Warring. The PCC chief, was accompanied by Congress MP Sukhjinder Singh Randhawa, was addressing the media.

According to the new law, any person who commits sacrilege shall get a minimum of seven years of imprisonment, extendable up to 20 years, along with a fine of Rs 2 lakh to Rs 10 lakh. Any person who in criminal conspiracy, commits sacrilege with an intention to disrupt peace or communal harmony, shall get a minimum of 10 years of imprisonment, extendable up to life imprisonment, along with a fine of Rs 5 lakh which may extend to Rs 25 lakh, according to the law.

Randhawa, while thanking the Governor for giving assent to the Bill, asked the state government whether old cases related to sacrilege would also be brought under the ambit of the new law so that victims can get justice. He also asked whether cases that have been transferred to Chandigarh would come under the purview of the new law. The congress leaders were referring to the theft of a 'bir' (copy) of the Guru Ganth Sahib from Burj Jawahar Singh Wala gurdwara, putting up handwritten sacrilegious posters in Bargari and Burj Jawahar Singh Wala and torn pages of the holy book found scattered at Bargar in Faridkot in 2015. These incidents had led to anti-sacrilege protests in Faridkot. In the police firing at anti-sacrilege protesters in October 2015, two persons were killed in Behbal Kalan while some persons were injured at Kotkapura in Faridkot. Randhawa also targeted the AAP government over the law and order situation in Punjab alleging that "gangsters and terrorists, under the protection of the government, are working together to disturb the state's atmosphere". Citing Gurdaspur as an example, Randhawa said that recently a jeweler was robbed of approximately Rs 8 crore, during which the attackers fired openly. Following public protests, police arrested two accused and showed a recovery of around Rs 1.75 crore, but the main accused is still absconding and the full amount has not been recovered, he said. He added that this was the fourth major robbery in Gurdaspur city. Randhawa further claimed that during his visit from Amritsar to the Gurdaspur border, he did not see a single police checkpoint, and in many police stations, even officers were absent. He alleged that police stations have been turned into "bunkers," with high walls, barbed wire, and even electrified fencing, creating an atmosphere of fear among the public.

KU Professor hailing from Adilabad selected as Royal Society of Biology Council fellow

As Punjab notifies stringent anti-sacrilege law, AAP questions 'SAD, SGPC silence'

The Punjab government on Monday notified the Jaagat Jot Sri Guru Granth Sahib Satkar (Amendment) Act, 2026 — a stringent anti-sacrilege law that provides life imprisonment and a fine of up to Rs 25 lakh, for any act of 'baedbi' against the Guru Granth Sahib. The notification, in the official gazette, came after Governor Gulab Chand Kataria on April 17 gave his assent to the Bill that was unanimously passed by the Punjab Vidhan Sabha during a special session on April 13. With the entire process, from tabling of the Bill and its passage, to gubernatorial assent and notification being completed in eight days, the ruling Aam Aadmi Party said it reflects "the strong political will of the government". "This reflects the firm commitment of the Bhagwant Mann government to uphold the supreme honour and dignity of Guru Sahib. Those involved in any act of sacrilege or dishonouring Guru Sahib will face the strictest consequences," Finance Minister Harpal Singh Cheema said. It provides for a minimum imprisonment of seven years, extendable up to 20 years, along with a fine ranging from Rs 2 lakh to Rs 10 lakh along with a fine of Rs 2 lakh to Rs 10 lakh for desecration. It further provides for a minimum of 10 years of imprisonment, extendable up to life imprisonment, along with a fine of Rs 5 lakh which may extend to Rs 25 lakh for sacrilege carried out as part of a conspiracy to disturb communal harmony. It makes offences non-bailable and cognisable. The new law also introduces the term "Saroop" instead of "Bir", mandates a centralised register of all Saroops printed by the Shiromani Gurdwara Parbandhak Committee (SGPC) with unique identification numbers, and defines sacrilege in clear terms, covering physical damage as well as spoken, written or electronic acts that hurt religious sentiments. Following its notification, awareness campaigns are likely to be rolled out soon to help stakeholders, including gurdwara managements, custodians and the public understand the new provisions clearly.

While announcing the notification, AAP spokesperson Baltej Pannu targeted Shiromani Akali Dal (SAD) and its president Sukhbir Singh Badal questioning their silence on the new law. "While the AAP-led government has fulfilled its

commitment by bringing a strict law to prevent 'beadbi', those who earlier politicised such sensitive issues are now choosing to remain silent. This silence is politically telling," said Pannu. He said, when the AAP government announced its intention to introduce a stringent law against 'beadbi', opposition parties dismissed it as political rhetoric. "They said, 'bring the law, then we will see'. Today, the law has come into force, and those very people have gone quiet," said Pannu. Chief Minister Bhagwant Mann had introduced the Bill during a special session of the Vidhan Sabha on April 13. The opposition parties, including Congress, SAD, BJP and BSP, supported it without any dissent and the House passed the Bill unanimously.

Pannu, however, said that even though the Bill was passed, the "doubts were repeatedly raised by Opposition leaders" that the Governor would not approve it or that it would be stalled for Presidential assent. "Contrary to all such claims, the Governor signed the Bill promptly, and it has now officially become law. The notification has also been issued, and the law is fully implemented in Punjab." Taking aim at previous governments, he said, "Both the Akali-BJP regime and the Congress dispensation under Captain Amarinder Singh failed to enact effective legislation on beadbi by bringing Bills that were never intended to become law. They ensured the issue remained alive for political gains. Some people baked their political rotis on this issue and wanted it to continue".

Referring to past incidents, he added, "Be it 2015, 1986 in Nakodar, or 1978, everyone knows who was in power and how they failed to take decisive action. During the 2015 beadbi incidents, despite repeated provocations and threats, the then government failed to act effectively. Posters with offensive language appeared for months, yet no concrete action was taken." Pannu also criticised the handling of investigations by previous regimes, saying reports of commissions like the Justice Zora Singh Commission and the Justice Ranjit Singh Commission were neglected. He added that serious findings were trivialised and copies were distributed publicly at throwaway prices. He said, "Even after the law has been enacted, neither the SAD nor its leadership has issued any official statement supporting or opposing it. Sukhbir Singh Badal's silence shows that he is more focused on protecting personal and political interests rather than standing firmly for Punjab and its religious sentiments. The silence of SGPC president Harjinder Singh Dhali is equally concerning. The absence of a press interaction after the SGPC meeting reflects political pressure and lack of clarity." He said, "The lone Akali Dal MLA did not even attend the special Assembly session where the Bill was passed. This will be recorded in history, who stood for protecting the sanctity of Guru Granth Sahib and who chose to stay absent."

Mann invites NXP Semiconductors to set up R&D centre in Mohali

'Scripted, staged drama': Mamata pokes 'holes' in PM's viral jhalmuri moment

"It's all drama. How come a camera was fitted inside the shop when the Prime Minister suddenly made an unscheduled stop during the campaign? The entire episode was scripted. The SPG prepared the jhalmuri for him... He (Modi) was seen carrying a Rs 10 note in his pocket. Is it believable?" Banerjee said as she addressed a TMC election rally in Murarai Assembly constituency in Birbhum district. On Sunday, PM's video of stopping at vendor Vikram Shaw's stall after addressing a BJP rally in Jhargram for jhalmuri became viral. It featured Modi having a light banter with Shaw about eating onions. In the video, Shaw is heard asking the PM, "Aap pyaaz khaate hain (Do you eat onions?)," to which the PM replied, "Haan, pyaaz khaate hain. Dimag nahi khaate bas".

The vendor later told mediapersons that the PM coming to his stall to have jhalmuri made him feel "special", and insisted that it was "not political". The TMC, however, remains unconvinced. "I am feeling special that the PM came here and had jhalmuri. He also paid. He asked my name, how qualified I was, and how much I earn. I told him that I managed to run my home... I just made one mistake. I didn't take his autograph," Shaw told mediapersons. Meanwhile,

FBI Director Kash Patel sues Atlantic for \$250 million in defamation

Washington: FBI Director Kash Patel has filed a \$250 million defamation lawsuit against The Atlantic and one of its journalists, alleging the magazine published a "sweeping, malicious, and defamatory hit piece" aimed at damaging his reputation and forcing him from office. In his complaint, filed in the US District Court for the District of Columbia, Indian American Patel accuses The Atlantic Monthly Group LLC and staff writer Sarah Fitzpatrick of publishing false claims about Patel's conduct, including allegations of "excessive drinking" and "unexplained absences" while leading the Federal Bureau of Investigation. Patel's legal filing states the article was "replete with false and obviously fabricated allegations designed to destroy Director Patel's reputation and drive him from office." The lawsuit seeks at least \$250 million in damages, along with other relief.

According to reporting by The Washington Post, the article relied on accounts "attributed to anonymous people" who alleged Patel engaged in inappropriate conduct during his tenure. The Post noted it "has not independently verified the Atlantic's reporting." Patel's complaint disputes those

claims, asserting that several incidents described in the article — including allegations that meetings were rescheduled due to drinking or that security staff requested "breaching equipment" to access him — "are false." The filing further argues that the publication acted with "actual malice," a legal standard required in defamation cases involving public officials. It states the claims were "so demonstrably and obviously false, or easily refuted," that publishing them was reckless.

Patel's lawyer, Jesse Binnall, said: "Defamatory speech is not free speech, and it is an honour to represent Kash Patel in this lawsuit seeking accountability for The Atlantic article's malicious falsehoods." In response, The Atlantic defended its reporting. Anna Bross, a spokeswoman for the publication, said: "We stand by our reporting on Kash Patel, and we will vigorously defend The Atlantic and our journalists against this meritless lawsuit." The dispute comes amid heightened scrutiny of Patel's leadership.

Separate reporting cited by Newsweek noted that nearly 30,000 people had signed an online petition calling for an investigation into his conduct, following allegations raised in recent media reports. Patel has denied the allegations and maintains that the article relied on anonymous sources "with axes to grind and are not in a position to know the facts." Under US law, public officials must prove that a publication acted with "actual malice" — meaning it knowingly published false information or acted with reckless disregard for the truth — a standard established in the landmark Supreme Court case *New York Times v. Sullivan*. Patel, who has led the FBI since February 2025, is not new to litigation over media coverage. His current lawsuit is at least the second defamation claim he has filed since taking office, including a separate case linked to statements made on a television news programme. The case is expected to proceed in federal court in Washington.

Vance likely to travel to Islamabad

GNS News Agency, April 25 Washington: US Vice President JD Vance is likely to travel to Islamabad on Tuesday for peace talks with Iran to end the seven-week war, according to a media report. On Monday, US President Donald Trump told The New York Post that the Vance-led delegation was already en route to Islamabad, while other media outlets reported that the vice president was very much in Washington. Vance is expected to reach Islamabad as the two-week ceasefire, agreed to between the US and Iran on April 8, ends amid threats by Trump to bomb bridges and power plants in Iran if both sides fail to reach a deal. With Vance expected to reach Islamabad late Tuesday, Trump has effectively extended the ceasefire by a day till Wednesday.

"Vice President Vance is expected to depart for Islamabad by Tuesday morning for talks with Iran over a potential deal to end the war," American news outlet Axios reported, quoting three US sources. Special envoy Steve Witkoff and Jared Kushner are expected to join Vance. The fragile ceasefire between the US and Iran was tested once again on Sunday when a US guided-missile destroyer fired on and seized an Iranian cargo ship after it tried to get past the US naval blockade in the Gulf of Oman, further angering the Iranians. The Iranian team was urged to join the meeting by mediators from Pakistan, Egypt, and Turkey, Axios reported, but, according to the source, didn't leave until they received approval from Iran's supreme leader. The Iranian delegation's plan to travel to Islamabad was also reported earlier on Monday by the New York Times, citing two Iranian officials. Iranian Parliament Speaker Mohammed-Bagher Ghalibaf is expected to lead the delegation. Axios, quoting a source with knowledge, said the Iranians were stalling amid apparent pressure from the Revolutionary



guards on the negotiators to hold a firmer line — "no talks without an end to the US blockade." The United States has never been closer to a good deal with Iran, unlike the horrible deal made by the Obama Administration, thanks to President Trump's negotiating ability," White House press secretary Karoline Leavitt told Fox News. "Anyone who cannot see President Trump's tactics to play the long game is either stupid or willfully ignorant," she said Monday night. During the first round of talks on April 11, American negotiators proposed a 20-year pause on Iran's enrichment of uranium, a source familiar with the discussions was quoted as saying by CNN. Iran responded with a proposal for a five-year suspension, which the US has rejected, according to a US official. Trump insisted Monday he wasn't feeling pressure to reach a deal, despite the war's rising unpopularity among the American public and the role it's played in higher gas prices. "I am under no pressure whatsoever, although it will all happen relatively quickly!" he wrote on Truth Social.

5 things to know as massive blast, fire shake Nacogdoches County near Etoile; videos emerge



Authorities in Nacogdoches County, Texas, are responding to a reported explosion and fire at an oil well site. The Nacogdoches County Sheriff's Office has confirmed the explosion in a Facebook post. Details are also emerging on social media. "Deputies along with numerous other first responders are arriving on scene in the 15000 block of FM 226 just north of Etoile. There is currently a fire at an oil well site. Early reports indicate that all workers at the site

are accounted for and have been evacuated. First responders are still arriving on the scene to evaluate the totality of the situation. From ancient legend to K-pop: Modi highlights India-Korea connect

New Delhi: Prime Minister Narendra Modi on Monday invoked the legend of Ayodhya princess, Suriratna, and Korean king Kim Suro to emphasise the ancient cultural links between India and South Korea. In his remarks at a joint press meet after wide-ranging talks with South Korean President Lee Jae Myung at the Hyderabad House here, Modi said K-pop and K-drama are becoming very popular in India today, and similarly, in South Korea, Indian cinema and culture are getting more recognised. "The story of Princess Suriratna of Ayodhya and King Kim Suro of Korea, dating back two millennia, is a part of our shared heritage," he said.



The official website of 'Incredible India' carries a descriptive piece on this ancient cultural link. In her adopted land in Korea, she was known as Queen Heo Hwang-ok, and a memorial to her, built in 2001 through a collaborative effort between the Uttar Pradesh government and South Korea's Gimhae city, stands as a living testament to the enduring bonds forged by Queen Heo Hwang-ok's legendary journey. "As chronicled in the venerable Korean text Samguk Yusa, this daughter of Ayodhya — known in her adopted land as Queen Heo Hwang-ok, embarked on a perilous sea voyage guided by divine decree," reads the piece on the 'Incredible India' website.

"The Gods themselves, it is said, orchestrated her union with King Kim Suro of the Karak Clan, making her the first queen of Geumgwang Gaya. This ethereal command, delivered through dreams, set in motion a remarkable saga of cross-cultural unity, forever intertwining the destinies of Ayodhya and Korea in a tale of shared heritage and royal legacy," it adds. Many members of the Karak clan visit Ayodhya every year to pay tribute at the Queen Heo Memorial Park, which was set up on the banks of Sarayu river in the holy city.

"When you stand in front of the Memorial of Heo Hwang-ok, you are transported to an era of legendary unions and transcontinental journeys. This serene sanctu-

ary pays homage to a remarkable tale that spans centuries and continents. Legend speaks of Princess Suriratna, a young maiden whose extraordinary journey from the banks of the Sarayu to the shores of Korea would forever alter the course of history," the piece reads. In November 2018, the then First Lady Kim Jung-sook visited Ayodhya and celebrated Diwali in the holy city. Kim had begun her tour of Ayodhya by offering tributes at the Queen Heo Memorial. Accompanied by Uttar Pradesh Chief Minister Yogi Adityanath, she attended the ground-breaking ceremony for the upgrade and beautification of the memorial dedicated to the legendary Ayodhya princess, who went to Korea and married the king there in 48 AD. On Monday, India and South Korea also signed several MoUs, including on cooperation in cultural and creative industries, in the presence of the two leaders. "In culture and creative industry, through mutual cooperation, we will establish new avenues in areas of film, animation, and in gaming too," Modi said. "We are delighted that President Lee himself is an admirer of Indian cinema. To further strengthen this cultural connect, we will organise the India-Korea Friendship Festival in 2028," he said. He added that to boost people-to-people ties, education, research cooperation and tourism will be promoted. "We are laying the foundation stone of the success stories of the next decade."

India steps up Gulf diplomacy as Doval visits Riyadh amid Strait of Hormuz tensions, firing at vessels -

India has stepped up high-level diplomatic outreach in the Gulf, with National Security Adviser Ajit Doval visiting Riyadh amid escalating tensions in the Strait of Hormuz and growing concerns over maritime security. On the direction of Prime Minister Narendra Modi, the Ministry of External Affairs said engagement with key regional partners had been intensified.

According to the MEA, during his April 19 visit, Doval held talks with Saudi Energy Minister Prince Abdulaziz bin Salman, Foreign Minister Prince Faisal bin Farhan and National Security Adviser Musaed Al-Aiban, focusing on bilateral ties and the evolving regional situation.

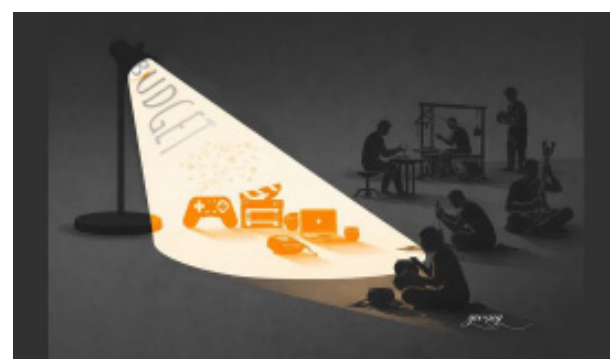
Foreign Secretary Vikram Misri said India was "deeply disturbed" by the firing at Indian-flagged vessels and had taken up the matter with Iranian authorities. He underscored the need to uphold maritime security and ensure unimpeded passage through international waterways. "We have very, very clearly maintained that international waterways must remain free and open for all categories of shipping, including energy trade and commercial traffic," Misri said, pointing to the wider economic implications. He warned that the impact of the ongoing West Asia tensions was already being felt beyond the immediate conflict zone, particularly in energy availability, even as India closely monitors the safety of its diaspora — nearly 10 million citizens living and working



across the Gulf. India has also pressed for de-escalation, with Misri reiterating the need to respect sovereignty and territorial integrity, and to avoid targeting civilian infrastructure. Doval's visit is being seen as part of a calibrated strategy to reinforce regional partnerships while navigating the fallout of the crisis, with India positioning itself to secure its strategic and economic interests amid a rapidly evolving security landscape.

India's Budget still undervalues orange economy

All Union Budgets speak the language of growth, innovation and jobs. The 2026 Union Budget has gone further by explicitly mentioning the so-called orange economy. This is a unique occasion when culture, creativity, and content creation are recognised as economic forces rather than ornamental accessories. However, more broadly, India's fiscal policy still underestimates the creative economy as a legitimate source of growth and job creation (Government of India, 2026). Previously regarded as soft power or leisure activity, creative industries are now being marketed, at least rhetorically, as engines of growth, jobs and global competitiveness.



The orange economy broadly encompasses domains in which value is created through creativity and intellectual property: film, music, animation, gaming, design, fashion, publishing, advertising, and digital content (UNESCO, 2022; UNCTAD, 2024). Globally, these industries have proven to be resilient and fast-growing, especially in digitally networked economies. The promise is particularly high for India, given its demographic dividend and rich cultural capital. The cultural and creative industries, including arts and crafts, design, media, heritage, fashion, gaming, and digital content, employ millions silently, generate soft power, and sustain local economies. Yet, they continue to remain on the margins of fiscal policy and economic planning. As India emerges as a global cultural and digital powerhouse, there is a striking lack of a coherent vision for the creative economy in the Budget. The orange economy is no soft sector, but a serious economic force, which should be supported with hard policy.

Unemployment and automation-induced disruptions are putting pressure on India's growth (Government of India, 2025). In contrast, creative industries are labour-intensive and youth-driven. They offer employment across a wide range of skills — from artists and writers to coders, editors, sound engineers, designers and platform managers. These industries rely on talent, ideas and networks, unlike capital-intensive manufacturing. The prioritisation of Animation, Visual Effects, Gaming and Comics (AVGC) in Budget 2026-27, including the development of creative technology labs in schools and colleges, indicates the efforts to build a future-ready talent pipeline (Government of India, 2026; FICCI-EY, 2023). Government projections suggest that the AVGC sector alone may require about two million professionals by the end of the decade. Creativity, therefore, is no longer a niche aspiration but a mainstream employment strategy. The orange economy also generates significant spillover effects. Tourism depends on film and music, manufacturing and export benefit from design, and platform economies and advertising revenues depend on digital content. Cities with thriving creative clusters often experience ur-

ban regeneration and enhanced global visibility. Creative industries thus can be seen as economic infrastructure, less visible than a road or a port, but equally catalytic. Besides, cultural exports promote India globally in ways traditional trade cannot. Creativity in the form of soft power, with real economic payoff, can be seen in the cinema and streaming content, and even gaming stories rooted in local mythology. The 2026 Budget is only a beginning. Without credit access, social protection, IP safeguards, and export support, India's creative workforce will remain economically insecure. However, this potential cannot be realised through budgetary recognition alone (UNCTAD, 2024; UNESCO, 2022). Much of India's creative workforce is informal, lacking contracts and social security as well as regular income. Access to funding remains limited, as creative projects do not conform to the standard lending procedures. Regulatory complexities, fragmented data and inadequate measurement systems imply that the real contribution of the orange economy has been underrated in national accounts. The threat of over-concentration also exists: prioritising the most noticeable industries such as gaming and digital content over traditional arts, local crafts, publishing, and local cultural ecosystems that support livelihood beyond metropolitan centres. Recent Union Budgets have acknowledged culture and creativity more through visibility-driven interventions than structural economic planning. For example, the 2024-25 Budget increased allocations for museum development, cultural digitisation and heritage tourism, while the 2025-26 Budget continued investments in tourism circuits and global cultural showcases. Broader initiatives, such as increased investment in digital public infrastructure, the PM Vishwakarma scheme for traditional artisans, and MSME credit programmes, indirectly support the creative industries. However, a key gap remains: the lack of clear recognition of creative work as productive labour, situated at the intersection of culture, business, and technology.

Apple's Tim Cook to step down as CEO in September

Tim Cook will step down as Chief Executive Officer of Apple Inc. and take over as executive chairman of the company's board, with John Ternus set to become the new CEO from September 1, the company announced on Monday. The decision was approved by Apple's Board of Directors as part of a long-planned leadership transition. Cook will continue as CEO through the summer and work closely with Ternus to ensure a smooth handover.

Currently serving as Senior Vice President of Hardware Engineering, Ternus has been a key figure in developing Apple's major products and will now take charge of leading the company. After stepping into his new role as executive chairman, Cook will continue to support the company, including engaging with policymakers around the world. In a community letter to the company, Cook wrote, "For the past 15 years I've started just about every morning the same way. I open my email and I read notes I received the day before from Apple's users all over the world. You share little pieces of your lives with me and tell me things you want me to know about how Apple has touched you. About the moment your mom was saved by her Apple Watch. About the perfect selfie you captured at the summit

of a mountain that seemed impossible to climb. You thank me for the ways Mac has changed what you can do at work and sometimes give me a hard time because something you care about isn't working like it should." "Today we announced that I'm taking the next step in my journey at Apple. Over the coming months I will be transitioning into a new role, leaving the CEO job behind in September and becoming Apple's executive chairman. A new person will be stepping into what I know in my heart is the best job in the world. That leader is John Ternus, a brilliant engineer and thinker who has spent the past 25 years building the Apple products our users love so much, obsessed with every detail, focused on every possible way we can make something better, bolder, more beautiful, and more meaningful. He is the perfect person for the job," the letter read. Tim Cook joined Apple in 1998. He became CEO in 2011 and has overseen the introduction of numerous products and services, including new categories like Apple Watch, AirPods, and Apple Vision Pro, and services ranging from iCloud and Apple Pay to Apple TV and Apple Music. He was also instrumental in expanding existing product lines.

ing them to associate light with high-energy food sources. Habituated elephants, for instance, may be attracted to night glows/halos originating from distant towns and cultivated fields, increasing the likelihood of negative interactions with people. High-beam headlights from vehicles can also startle animals, escalating stress and conflict. Such incidents are routinely observed on roads that pass through our forests. Growing light pollution is likely contributing to human-wildlife negative interactions in landscapes such as Wayanad.

Light pollution policy For a sustainable transition to a "low glow" Kerala, a comprehensive state policy on light pollution is essential, as no regulations currently mandates correlated colour temperature (CCT) limits based on ecological sensitivity. Regulations supported by a mix of mandates and incentives, can bring about systematic reduction in CCTs, and promote the use of full-cut-off, shielded, and low-intensity lighting for outdoor applications, including streetlights and public illumination. Establishing ecological lighting standards (ELS) by zone-based limits and prescribing appropriate spectral quality standards (in CCTs) based on ecological sensitivity offer a practical way to address this issue, from protected areas to urban centres. In general, regulations requiring downward-facing, low-kelvin LED lights, and light curfews, particularly on commercial advertisements, can significantly reduce sky glow and glare. Additionally, innovations such as adaptive dimming, midnight intensity reduction, and motion-triggered lighting systems using passive infrared or advanced microwave sensors, while reducing power consumption, also improve the quality of ecosystems around them. Regular monitoring using light meters and Sky Quality Meters, remote sensing, ecological surveys, and citizen science initiatives is essential to track progress and compliance. Critical ecological zones, from protected areas to high-value biodiversity areas, must shift to deep amber (1,800 K), amber (2,200 K) lights and reduce unnecessary illuminations. In surrounding interface zones, warm lighting (up to 2,700 K) is recommended. Across the rest of the state, wherever possible, lighting should be limited up to 3,000 K or warmer, favouring dim, low-intensity white light to reduce ecological impact. Establishing dark corridors can help reconnect fragmented forests by reducing lighting durations, dimming or switching them off after midnight, thereby facilitating the movement of wildlife, from elephants to tiny moths. A single brightly lit road cutting through a traditional migratory path can cause fragmentation. Without the corridors, these patches become biological prisons, leading to inbreeding and local extinction. Creating dark zones around high-value biodiversity areas can prevent sky glow that otherwise spills into the night and acts like welcome sign for habituated wildlife. By doing so, they can preserve true darkness as an asset, supporting conservation while attracting niche, high-value tourism. At the same time, targeted incentives for individuals, LSGDs and government agencies that comply with these standards can accelerate its adoption and acceptance. Introducing these measures also reduce the likelihood of light-induced behavioural changes in wildlife that contribute to human-wildlife conflict.

It is time to recognise ALAN as a legally defined form of disturbance in the Environmental (Protection) Act, 1986, and mandate light impact assessment for all development activities in and around key ecological zones as well as high value biodiversity areas. Individual habits, culture and preferences are driving this problem. People celebrate with light, often turning night into day and illuminating the surroundings with artificial brightness, from buildings to towering trees. In doing so, they are reshaping the natural world, without realising the cost. The solution to this crisis is simple, and does not require a massive budget or decades of efforts. It takes only the humility to admit that not everything needs to be seen all the time. The night is not a void to be filled; it is a heritage to be protected. Preserving its sanctity safeguards human health, while allowing wilderness and wildlife to remain truly wild. The courage to ask



Of all the memories from my schooldays, one regret stands out sharply: I did not ask enough questions. Like most of my classmates, I listened quietly, scribbled notes, and accepted whatever was taught as settled truth. We were obedient learners, not curious ones. At the time, silence felt like discipline. With hindsight, it was a missed opportunity. This realisation returned to me recently at a seminar on the India-Pakistan war of 1947-48 — the first major military operation fought by the Indian Army after Independence. I had prepared thoroughly, revisiting books and archival accounts. Yet, despite extensive reading, several doubts lingered in my mind. I was looking forward to the interactive session mentioned in the programme — a rare opportunity to engage eminent panellists and seek clarity.

The schedule clearly allotted 30 minutes for questions and answers. On the day of the event, I listened intently, waiting for that session. To my surprise, it was quietly dropped. During the tea break, when I asked the organiser about it, he casually replied that it was not really required; it had merely been included in the printed programme as a formality. That moment was disappointing, but it was also revealing. It underlined a deeper issue in our culture — we often undervalue inquiry. We speak, we lecture, we deliver presentations. But we rarely encourage dialogue. I have noticed a curious pattern in many gatherings. After a lecture, when someone gathers the courage to ask a question, the entire audience shifts in their seats, craning their necks to see who is speaking. The attention shifts from the substance of the question to the identity of the questioner. It betrays a subtle discomfort with curiosity. Yet questions are the lifeblood of progress. Without them, knowledge becomes static.

Groaning under information overload



A significant yet rarely acknowledged downside of social media is the overconsumption of information. We are not an information starved society any more, and in ideal terms, this should have been a great victory for humanity, but social media has somehow managed to spoon-feed opinions. Our ideas, standards, opinions and taste are dictated by reels. Short-form content is ruling our lives, and we are slaves to endless scrolling. Our time holds less value than it has ever held before, and instead of remedying it, we are rather happily sinking ourselves. For the longest duration, society has struggled with scarcity of knowledge, information and opportunity. Today this anxiety has shifted, replaced by an excess of information, its instantaneousness, and aggressive and infinite availability.

We as a society have become gluttons for content. We have trained ourselves to reach for our phones and scroll in hopes of filling a void, we are stuck in this endless loop where even the slightest form of inconvenience pushes us to chase this dopamine high. More often than not, this content stays with us long after we have already consumed it. Our lives are full of opinions, rants, preaches and commentaries, we are rarely uninformed, yet one has to ask if we are truly informed or just inundated?

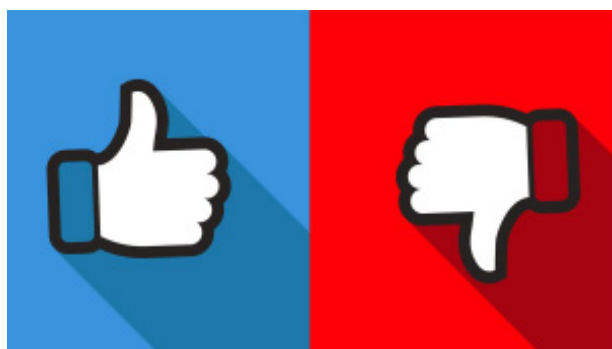
This short-form content feels rewarding to watch; one does not have to put in any form of mental labour to reach the point. Our ideas are formed for us, our opinions dictated,

With them, it evolves. In every profession — be it education, the armed forces, medicine, or administration — learning does not end with instruction. It deepens through discussion. Particularly in the military, lessons from past operations must be examined threadbare within the system. While operational secrecy must always be preserved, critical analysis and candid questioning strengthen institutions. They prevent complacency. Open discussion

I witnessed this culture first-hand during my tenure in Lebanon in 2007 while commanding 15 Punjab. I attended a military seminar in Israel, and what struck me most was not the sophistication of the presentations, but the openness of the discussion. Junior officers — men and women — confidently questioned senior Generals. Their queries were sharp, thoughtful, and sometimes challenging. No one looked around to identify who was speaking. All ears were tuned to the merit of the idea. Rank did not silence curiosity, but welcomed it. That experience left a lasting impression. It showed me that professional excellence thrives in an environment where questioning is not seen as defiance but as engagement. We, too, must cultivate that spirit — beginning at home and in schools. Curiosity should not be mistaken for indiscipline. Children who ask questions are not being difficult; they are learning to think. Parents must resist the temptation to silence persistent queries with impatience. Teachers must tolerate even the so-called "irritating" questions. Often, those are the ones that push boundaries. The habit of questioning should extend beyond classrooms. In daily life, we must ask why things are done a certain way, whether there is a better alternative, whether established practices still serve their purpose. Progress comes not from blind agreement but from thoughtful examination. There is a simple metaphor that captures this idea. We can choose to be like a pond — still, contained, and eventually stagnant. Or we can be like the ocean — constantly moving, renewing itself with fresh currents. Questions are those currents. They keep institutions vibrant and individuals intellectually alive. The courage to ask is as important as the ability to answer. It begins in childhood but must be nurtured throughout life. When we encourage enquiry, we cultivate independent thinkers rather than passive recipients of information. In the end, societies that question grow stronger. Those that remain silent risk stagnation. The choice, like the question, is ours.

we are merely told what to think. This content also governs a huge part of our social life, it decides what is chic and what is cringe, what one should have, to fit in and what makes one odd. We react before we understand. Here the distinction between what nourishes our mind and what merely stimulates it, becomes blurred. Social media pumps us up with dopamine while failing to add any value in our lives. Much of the digital space revolves around four main spheres: gossip, memes, politics, and influencing. Gossip offers fleeting amusement, memes generally reduce complex issues into instantly digestible fragments, political content instead of cultivating civic understanding rewards outrage, and influencing packages consumption as aspiration. None of this content is inherently harmful, yet when these forms dominate our intellectual intake our mind starts to mirror it making us restless, reactive, and fragmented. It shifts our thoughts and opinions of self; we simply need to have an aesthetic picture-ready house, we have to buy this expensive Korean skincare, we need to try this new drink, and we simply need to post about it and communicate to the world that finally we are a part of the cool club. Yet after all this overconsumption and overexertion, we are left with a void, we fall in this consumption and comparison cycle that rarely keeps up with us — by the time we complete one trend, five others pop up and we are left with the feeling of inadequacy. Hence in a world that is obsessed with counting calories, count your thoughts and ideas and when you do, remember to hold on to them. So put yourself in an information diet, and be intentional about your content consumption. Just like a balanced diet that includes variety, moderation and quality, your information diet should prioritise depth over immediacy, substance over stimulation. I started my information diet in the beginning of this year and I can attest that I have been calmer. In addition to being mindful about content consumption, I have also managed to reduce my screen time. Something that has worked for me is always asking myself why I am opening a certain app and just sticking to that one task. In the end, I can vouch for the fact that this diet will not disappoint.

Thumbing through emojis



sarcastic, or faintly hostile. One thumb can trigger an overthinking marathon. Did they mean okay-okay, okay-noted, or okay-stop-texting-me...? Emoji study truly merits a Ph.D. and a research grant. The thumb itself has a longer story. In the Mahabharata, Ekalavya gave up his thumb as an offering to his unseen guru. Today, we give ours away freely, multiple times a day, to unseen audiences, as if devotion has been replaced by convenience. I once tried an experiment. For one full day, I replied to every message with just the thumb. By evening, one friend asked if I was upset, another if my phone had failed, and my brother if I was unwell. The thumb had spoken. Loudly. The thumbs-up is efficient, not lazy. It saves time and emotional exposure. Yet, by simple thumb rule, it should supplement, not supplant, words. Still, I tap it often. On certain days, my thumb seems wiser than my vocabulary, quietly handling life one gesture at a time.

Lessons from the Mahabharata

"What is found in the Mahabharata can be found elsewhere, but what is not found in the epic can seldom be found in the universe." This line perhaps had me hooked to the epic for a lifetime. I have read it several times and listened to many great scholars speak on the subject. I have marvelled at the plethora of situations in the epic which have served as reference points to various aspects of life across time and space. My involvement with the epic grew to a point where I started sensitising young and not so young audience to the relevance of the classic. It began with a series of talks and later on I started conducting sessions where people would call out a random word and I would connect it to one of the episodes of the epic. With each passing session, the words got quirkier and were mostly sourced from contemporary lingo. To keep it short, I would like to recollect the ones that captured my imagination the most. For instance, once a young man came up with addiction and I narrated the instances from Yudhishtira's life where his love for gambling led to crisis every single time he succumbed to his addiction. Then there was this time when someone gave the word "Face Time" and I drew the attention of the seeker to the famous scene in a famous South Indian movie called Maya Bazaar where Abhimanyu and his lady love would have a rendezvous by talking to each other on a mirror which would transform into a screen.

Never stop asking why



Over time, children learn something dangerous. Knowledge is something others decide, not something they can explore themselves. Asking questions becomes hesitation. Curiosity feels inconvenient. I noticed the aftermath in university.

From the very first day of school, we are taught certainties. Cars have four wheels. Chairs have four legs. The sun rises in the east. Water boils at 100 degrees Celsius. Facts go into notebooks in neat lines. But somewhere in this long parade of correct answers, one thing quietly disappears: the habit of asking why. Why four wheels? Why not three or five? Why is a chair shaped this way? If a child dares to ask, the answer is often: It is like that. And just like that, curiosity is shut down.

Over time, children learn something dangerous. Knowledge is something others decide, not something they can explore themselves. Asking questions becomes hesitation. Curiosity feels inconvenient. I noticed the aftermath in university. In school, memorising earned marks and praise. In

college, the same approach often fails. Textbooks are full of abstract concepts. Students are expected to understand, analyse, and apply them, but we were never trained to question or explore on our own. Most of the time, we follow instructions in books. Any attempt to think beyond them is ignored or unrewarded. The system rewards what is written, not what is understood. The world hides questions everywhere. Why do we still use QWERTY keyboards when ABCDEF might make more sense? It was designed for typewriters, but we keep using it today simply because no one stopped to ask. Most of us never notice. Curiosity allows us to see the hidden logic behind ordinary things. Even technical concepts can seem frightening. A textbook might say: Encryption ensures confidentiality by transforming plaintext into ciphertext using cryptographic algorithms and keys. In simple terms, it just means you lock a message with a secret password so only the right person can read it. The idea is simple. The language makes it intimidating.

This gap between simplicity and understanding is no accident. It is cultivated over years of education that prioritises memorisation over comprehension. Should practical learning not come first? If students see how things work in real life, theory follows naturally. When you watch electricity flow through a circuit, Ohm's law is no longer a formula to memorise. It becomes a story you already know. Even beyond science and technology, the pattern persists. History is taught as dates and events. India gained independence in 1947. But how often are students encouraged to ask why not earlier? What conditions made it possible then? What if certain movements had failed? History becomes dates instead of dilemmas. Education should not just give facts. It should make children curious, restless, and eager to understand the world. A child who asks why is not being difficult. That child is rehearsing for innovation. Every discovery, every breakthrough, every reform began with someone refusing to accept it is like that. capital outflows continue, and markets remain battered?

The rupee briefly crossed 95 to the dollar before recovering, aided in part by RBI measures to curb arbitrage opportunities in the offshore NDF market. Beyond oil prices, several other factors are exerting pressure on the currency — tightened fiscal conditions, RBI's liquidity operations, and relatively low domestic interest rates. Importantly, the rupee had been weakening even before the Iran conflict, driven by capital outflows. Going forward, additional pressure may come from a widening current account deficit due to higher crude prices, lower remittances and weaker exports. The current account deficit, which was around 1% of GDP in FY26, could plausibly widen to around 2% this year. While the RBI has adequate reserves to address excessive volatility, there is a strong case for minimalist intervention.

Allowing a gradual real depreciation would improve export competitiveness and apportion the burden of adjustment across sectors, giving greater flexibility to both fiscal and monetary policy. A gradual, managed depreciation is preferable to burning reserves to defend a level. There has been some discussion around issuing NRI bonds to bolster reserves. This appears premature. Such a move could send adverse signals about external stability. Besides, it may not be effective given low interest differentials, unless offered at a significant cost.

What's your overall assessment on the economy and growth outlook?

India imports about 80-85% of its crude requirement, making it highly vulnerable to oil shocks. RBI estimates suggest that every 10% increase in oil prices could raise inflation by about 50 basis points and reduce growth by 25 bps. Similarly, a 5% depreciation in the rupee could add roughly 40 bps to inflation and shave off 25 bps from growth. This is essentially a supply shock that simultaneously affects growth and inflation. As higher oil prices percolate through supply chains, stress will spread across a wide range of sectors. On baseline assumptions of crude at \$85 per barrel and an exchange rate of ₹94 per dollar, RBI projects GDP growth for this fiscal year at 6.9%. Outcomes could worsen if the conflict is prolonged or intensifies. Importantly, if disruptions force business closures, restarting activity could entail disproportionate costs, amplifying the growth impact.

With the conflict in West Asia continuing, what do you think is the outlook for energy prices and crude oil?

Crude oil is likely to remain elevated and volatile, even with a temporary ceasefire. The geopolitical risk premium — particularly around the Strait of Hormuz — is unlikely to dissipate quickly. For India, this is a critical vulnerability. Sustained high crude prices would widen the current account deficit and feed directly into inflation. Even without an actual supply disruption, uncertainty alone can keep prices elevated. The more realistic scenario is one of moderately high and volatile oil prices, rather than a return to earlier benign levels.

What are the risks to the banking system as several sectors are facing headwinds?

The banking system is in a stronger position than in previous cycles, with improved asset quality and capital buffers. The risks now are more sector-specific than systemic. Stress could emerge in MSMEs due to cost pressures, while rising yields may lead to mark-to-market losses on bond portfolios. If growth slows, asset quality risks could re-emerge at the margin. The appropriate response is continued vigilance through stress testing, close supervision and ensuring adequate liquidity, rather than broad-based intervention. What macroeconomic strategies and policy measures are necessary for India to effectively manage external shocks while sustaining investor confidence and long-term economic stability? Managing shocks of this nature requires strong macro buffers — stable growth, contained inflation and adequate foreign exchange reserves. India's current position reflects some of this preparedness. Going forward, reducing dependence on imported energy, diversifying supply chains and maintaining policy flexibility will be critical. A coordinated fiscal and monetary response, along with clear communication, will be essential to anchor expectations and sustain investor confidence.

What's the impact of West Asia conflict on various sectors, investment and margins?

The shock is largely cost-driven and uneven across sectors. Input-intensive industries — fertilisers, textiles, chemicals and MSMEs — are facing margin compression due to higher freight and raw material costs. This comes at a time when private capex was beginning to gain traction. With uncertainty around both input costs and demand, firms are likely to defer investment decisions, even if they do not cancel them outright. Stronger corporates may be able to absorb the shock and even consolidate market share, but smaller firms are more exposed to working-capital stress. Overall, the investment cycle remains intact, but momentum could soften in the near term due to profitability pressures.

Given the current uncertainties, what policy options does the government have?

The government has already reduced excise duties on petrol and diesel to cushion the impact on consumers. Going forward, it faces a difficult trade-off. One option is to continue absorbing higher oil prices, thereby protecting consumers. However, this would worsen the fiscal position, tighten financial conditions, and eventually weigh on consumption and investment thereby hurting growth. The alternative is to allow prices to pass through to consumers. This would raise inflation but impose a relatively smaller drag on growth. Neither option is benign. However, from a balance-of-payments perspective, there is a stronger case for allowing greater pass-through. Higher prices would dampen demand and help contain pressures on the current account deficit. Some price pass-through may actually be the more sustainable option.

Do you foresee interest rate action by the RBI to tackle an expected rise in inflation?

At its April meeting, the Monetary Policy Committee kept the repo rate unchanged at 5.25% and maintained a neutral stance. The policy signals suggest that the RBI is balancing growth risks against emerging inflation pressures. India entered this episode with relatively strong macro fundamentals — robust growth, moderate inflation, a manageable external account, and healthy bank and corporate balance sheets. This provides some policy space. Going forward, the RBI is likely to remain on hold over the next few policy cycles. The case for rate cuts is limited due to upside risks to inflation from oil prices and potential weather-related food shocks. At the same time, the case for rate hikes is also weak, as inflation remains within the target band. Additionally, premature easing could widen interest rate differentials with the US and add pressure on the rupee. Overall, policy is likely to remain data-dependent with a cautious bias towards checking inflation. The bar for both rate cuts and hikes is high: expect an extended pause.

20–40 ng/mL. Levels above 40 ng/mL provide no added benefit and may raise calcium levels."

What are the risks of taking high-dose vitamin D long-term?

"High-dose, long-term use can cause hypercalcaemia, kidney stones, vascular calcification, and even cardiac arrhythmias," warns Dr Shivane. "Since vitamin D is fat-soluble, toxicity develops gradually and presents with nausea, thirst, muscle weakness, and confusion." Dr Pahuja agrees, adding that toxicity often happens unintentionally. "It is not always the case, but inadvertently, a few patients keep on taking daily supplements rather than weekly. Or they may continue it for a longer duration than prescribed, as they may feel 'better' with supplements."

How long can one safely take high-dose vitamin D?

"One should take Vitamin D supplements only as per their Doctor's advice. Do not continue these supplements for longer than as advised," says Dr Pahuja. "Once low levels of Vitamin D has been normalised, ask the doctor for regular maintenance dose of Vitamin D. Usually in India we need 1000 IU to 1500 IU per day as maintenance dose for Vitamin D."

What are the early signs of vitamin D toxicity?

"As stated above increase frequency of urine, increase thirst, pain in abdomen, Bone and body pains may be the early signs of toxic levels of vitamin D," says Dr Pahuja. "One should check and confirm these levels at earliest and in some cases concomitant tests of Blood Calcium and Phosphorus are required to detect excess of calcium in the blood."

How often should vitamin D levels be tested?

Dr Shivane recommends, "Testing is advised before starting supplements and again after 8–12 weeks; once stable, annual monitoring is adequate." Dr Pahuja adds that after initial correction with weekly 60,000 IU doses for 10–12 weeks, one can continue with a maintenance dose and "Annually you can check whether these supplements are optimum enough to maintain your Vitamin D in normal ranges." He also highlights the role of sunlight: "Daily sunlight exposure of 45–60 minutes between 10 am to 12 pm may be helpful. Sunlight should be available to maximum body surface area like both hands below elbows, both legs below knee, neck and face etc. It is advised not to apply sunscreen or lotions on these parts to get maximum benefit of sunlight."

A Quora user recently asked, "What are the potential risks of taking high-dose vitamin D supplements for an extended period of time? How long can one safely take high-dose vitamin D before experiencing negative side effects?" It's a relevant question, especially in India, where vitamin D deficiency is rampant and self-supplementation is common. To clear the confusion, we spoke to Dr Vyankatesh Shivane, Consultant Diabetologist and Metabolic Physician, Department of Endocrinology, Jaslok Hospital & Research Centre, Mumbai, and Dr Vimal Pahuja, Associate Director, Internal Medicine and Metabolic Physician, Dr LH Hiranandani Hospital, Powai.

What counts as a "high dose" and when does it become toxic?

"Vitamin D is also called the Sunshine Vitamin, as it is available in abundance in sunlight. India, in spite of being a sunny country, most of the Indian population is either Vitamin D insufficient or deficient," says Dr Pahuja. "Normally, a level of Vitamin D more than 30 ng/mL is considered a sufficient level, as at this level, the level of Parathyroid hormone is stable without causing any harm to the bones." He explains that vitamin D levels above 100–150 ng/mL are considered harmful to the body. "At these levels, more calcium is excreted in the urine, making someone at risk of kidney stones. Vitamin D supplements of more than 50,000 IU per day for many weeks are considered to be toxic," he says. According to Dr Shivane, "In India, vitamin D deficiency is widespread, but excess supplementation has become a new concern." He notes that the Endocrine Society of India (ESI) and ICMR-NIN recommend 600–800 IU/day for adults, with an upper safe limit of 4,000 IU/day. "For optimal bone and muscle health, the adequate serum 25(OH)D range is

Trainer shares glimpse of Hardik Pandya doing Pilates, says 'most men think it is easy'

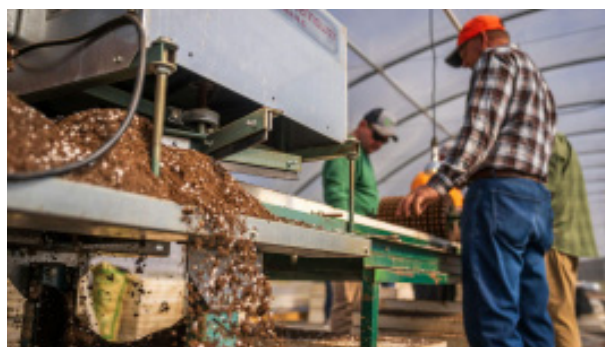


Trainer Yasmin Karachiwala recently shared a glimpse of Hardik Pandya doing Pilates on the reformer. "Most men think Pilates is easy, until they try it," she wrote on Instagram Stories. Taking a leaf out of the cricketer's wellness diary, we asked an expert why Pilates is not just for women. Affirming that it's "so true", consultant dietitian and fitness expert Garima Goyal said, while Pilates looks slow, controlled, almost effortless, with no heavy weights, no loud grunts, no sweat-dripping intensity like a typical gym session, the reality is completely different. "The kind of strength Pilates demands is deep, internal, and brutally honest," said Goyal.

What Hardik is working on here is core control, stability, and muscle coordination. "Pilates doesn't just target visible abs; it activates the deeper core muscles that support your spine, posture, and overall movement. That's why even elite athletes include it in their routine," shared Goyal. The biggest shock for most men is that Pilates exposes their weak links. "Tight hips, poor balance, weak lower back, lack of flexibility... everything shows up within minutes. And since the movements are slow and controlled, you can't cheat your way through reps," Goyal continued.

Unlike high-impact or heavy-weight-lifting routines, Pilates emphasises controlled movement, core engagement, alignment, and spine stabilisation. Over time, it helps strengthen deep muscles around the back and pelvis, improve posture, correct movement patterns, and reduce compensatory stress that aggravates pain. "Because the exercises focus on precision and slow muscle activation, they're less likely to trigger flare-ups yet offer meaningful improvement in functional strength," said Goyal. From a fitness and recovery perspective, Pilates improves mobility, reduces injury risk, and enhances performance. "For someone like Hardik, who needs explosive power on the field, this kind of training actually helps him move better, not just look strong," said Goyal. So, Pilates is not easy. "It's just a different kind of hard. The kind that builds real strength from the inside out," said Goyal.

Output of key industries fell 0.4% in March, fertiliser production slumped 25%



Strait of Hormuz and attacks on Gulf nations, having led to sharply higher energy prices and disruptions in the supply of key inputs for the petrochemicals sector. Data released last week showed the wholesale price of ammonia gas in India was 22% higher in March compared to February — the highest month-on-month rise as per data going back till 2012. Ammonia is used to make fertilisers.

The fourth industry to see lower production in March was electricity, with its output down 0.5%. Coal output and electricity generation in March likely suffered due to the above-normal rains during the month. Data from the India Meteorological Department shows that, in March, the country as a whole saw 14% more rainfall than normal. Of the four eight core industries that reported a rise in production, petroleum refinery products posted a minor year-on-year increase of 0.1%. Steel and cement output rose 2.2% and 4%, respectively. However, the production of natural gas surged 6.4%, the most in 22 months. This is the first time since June 2024 that India's natural gas production has increased.

Mega steel project set to boost India's manufacturing push

Seoul: South Korea's POSCO Group said on Monday it has signed a final agreement with India's JSW Steel to jointly invest 10.7 trillion won (\$7.3 billion) to build a steel plant in India, as part of its strategy to establish a production hub in the South Asian country and strengthen its global supply chain.

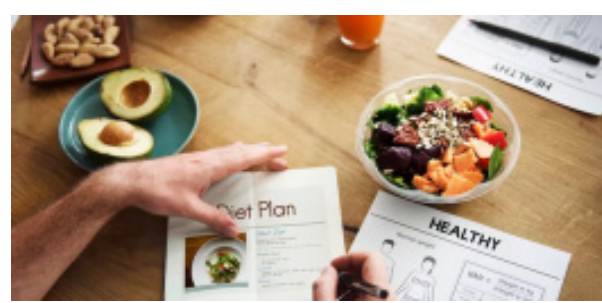
The two companies signed a joint venture agreement in India, attended by POSCO Group Chairman Chang In-hwa and JSW Steel Chief Executive Officer (CEO) Jayant Acharya, according to POSCO Group, reports Yonhap news agency.

Under the agreement, POSCO and JSW Steel will each hold a 50 percent stake in the project to build an integrated steel mill encompassing the entire production process at a single site.

War impact: Output of key industries fell 0.4% in March, fertiliser production slumped 25%. Production of fertiliser suffered the most, dropping 24.6% compared to the same month last year. In one of the first signs of the impact of the West Asia war on Indian industries, the output of the eight core industries contracted by 0.4% in March, the Ministry of Commerce & Industry said on Monday. Production of fertiliser suffered the most, dropping 24.6% compared to the same month last year. This is the first time since October 2025 that the output of the eight core industries has fallen compared to a year ago, with the fall in output being the most since August 2024, when it had declined by 1.5%. In February, output of the eight core industries had risen 2.8%.

For 2025-26 as a whole, the output of India's eight core industries rose a mere 2.6%, marking the worst performance since the pandemic-hit year of 2020-21, when production had fallen 6.4%. Of the eight core industries — coal, crude oil, natural gas, refinery products, fertilisers, steel, cement, and electricity — half of them witnessed lower production in March compared to a year ago. Apart from fertilisers, crude oil output fell 5.7% — the seventh month in a row it was down on a year-on-year basis. Meanwhile, coal production declined 4%, the first such fall in five months. This is the first time in data going back till April 2012 that India's coal output has fallen on a year-on-year basis in March. The 24.6% fall in fertiliser output in March is the largest on record, with the US and Israel's war with Iran and the latter's subsequent retaliation, including the closure of the

Dt Amreen Sheikh, chief dietitian, KIMS Hospitals, Thane, said a calorie deficit, where you consume fewer calories than your body burns, is a key principle of weight loss. "When done correctly, it can be effective and sustainable. However, how you create the deficit matters. Extreme restrictions can lead to fatigue, poor focus, hormonal imbalances, and even muscle loss. A well-planned calorie deficit should be moderate, nutritionally balanced, and suited to an individual's lifestyle and energy needs rather than being overly restrictive," she said.

What to consider?

One of the biggest mistakes is mixing up 'eating less' with 'eating right'. "People often cut calories significantly without considering nutrient intake. Skipping meals, cutting out entire food groups like carbohydrates, or following fad diets can backfire. Another common mistake is inconsis-

tency, being very strict for a short time and then going back to old habits. This pattern can slow down metabolism and complicate long-term weight management. Hydration, sleep, and stress management are often overlooked but are important for overall results," said Sheikh. Consistency doesn't mean perfection. It means making mindful choices most of the time. "In situations where tempting food is readily available, portion control and balance are crucial. For instance, enjoying a small portion of a favourite dish instead of avoiding it completely can help prevent feelings of deprivation. Planning meals, keeping healthy snacks on hand, and sticking to a regular eating schedule can also support consistency. Most importantly, flexibility is vital; occasional treats won't hinder progress if overall habits stay in check," shared Sheikh. Sustainable weight loss isn't about restriction; it's about building a healthy relationship with food, where enjoyment and nutrition go hand in hand.

India's OG golfing cricketer, or cricketer golfer, talks about the similarities.

Timing: The most crucial common link

The timing and grip is most important in cricket and golf. If you don't have timing, you end up hitting the ball too hard. If your grip is proper, then the impact is beautiful, and things change. The second most important thing is the belief within the players that they can do that (hit sixes). In our time, the belief wasn't there. A 15-year-old boy doesn't have that much strength to do that (hit sixes), but he has belief. Their equipment is ready, and then on top of that, timing is important. You don't have to be Chris Gayle to hit very big sixes. Today, because of technology, bats have become much more refined.

Body balance crucial when making impact In golf, it's much more technical because it's a stationary ball. I played cricket, and I played golf. The balance of the body is very important. When you make an impact, your body should be ready. There are some players who hit through cover, but their legs are in the air. But Virender Sehwag could hit with ease and Sachin Tendulkar too, because their base was very strong. For a cricketer or a golfer, if the base is strong, the impact is much harder. If there is balance of the feet, then the hips, shoulders, arms everything comes into play. Some people's arm swing is bigger, some people's body swing is bigger. Yashasvi Jaiswal has a full body swing.

Follow through not essential in cricket There has to be a follow-through in cricket and golf. But some cricketers can hit without a full follow-through, too. Yuvraj (Singh) played two types of shots, one in which he stops his bat after impact and one with the full follow-through. If your hip, body and shoulder are in rhythm, then controlling the bigger muscles is easier. The hip, the shoulder and the back are all big muscles. The forearm is a smaller muscle. In golf, you need a full swing, but they also say the point of impact is important. The two games are different, but eye-hand coordination is important in both. Over the years, when you play cricket, your hand-eye coordination improves. You don't need to be Dara Singh. See Hardik Pandya hit the ball, and you know he has strength and hand-eye coordination. Hockey players have a swing that is closer to golf than a cricketer. Because the hockey ball is also on the ground and so is the golf ball. Benefits for a cricketer I played golf after I stopped playing cricket. But even cricketers in the past would play golf. Gary Sobers used to play all the time. Don Bradman used to play golf. There is a photograph of Bradman playing golf. Indians never used to play, I don't know why. They liked to sit in the room. Golf can 100 percent help a cricketer. Had I played golf when playing cricket, I would have scored another 2,000 runs minimum. Because it improves focus, coordination and timing. I don't have words to express the amount of pleasure golf has given me. Challenges for a cricketer playing golf Hitting accurately is a very big challenge in golf. Because in golf, your target is very small and you have to hit towards the target. So you have to be very steady with your body, your mind, your hand-eye coordination, all the time. Everybody can hit a stationary ball if they have the timing and the right swing. But hitting where you exactly intend it to go becomes difficult in golf. In cricket, you can hit 360 degrees, if not over cover then over mid-off. Golf is not about 360-degree hitting. You have to hit it perfectly. Heavy cricket bat, lighter golf club you have to adjust to the weights but I don't think it is a very big challenge. Certain people can write well in Hindi and English or certain people can sing well, be it Classical or rock music. Certain people have the ability to play different sports well and it depends on your natural ability. The one challenge I see is that if you have played cricket for India and think you will play golf in the same manner it is not going to happen. Your mindset is that 'I represented the country in cricket' but if you take up golf and think you will do the similar thing, it is not possible.

'World of difference between PSL and international cricket': Basit Ali puts Babar Azam's century in context

Peshawar Zalmi's commanding 118-run victory, built on a Babar Azam century, drew warm praise from former Pakistan cricketers Basit Ali and Kamran Akmal on YouTube channel Game Plan — but both men were equally firm that the performance should not be used to settle debates about Babar's international record. Basit called the innings among the finest in PSL history, citing the quality of the attack Babar had dismantled. "He faced two spinners and Alzarri Joseph — and Joseph is no ordinary spinner, he is a mystery spinner who has kept every batter under pressure in this tournament. That is the kind of century this was." He added simply: "I was loving watching that batting." The pair were particularly enthusiastic about Babar's partnership with Kusal Mendis, which they said had transformed how Babar plays in the format. "When Mendis scored his hundred, Babar gave him big support. This time Babar scored the hundred and Mendis gave him big support," Kamran said. "This combination is suiting Peshawar Zalmi very well."

Basit went further, arguing that the partnership had unlocked a version of Babar fans had long wanted to see. "In the last two or three years, there was no batter alongside him, the team was not built in a way that allowed him to play his own game, to take himself towards the modern-day style of batting. Mendis has made a big difference." He also credited Harris Rauf's explosive starts at the top of the order, saying that within the first over or two, "he releases all the pressure of batting first." But when fans on social media pointed to the performance as proof that Babar had silenced his critics, both analysts pushed back firmly. "There is a world of difference between international cricket and PSL," Basit said. "What has happened to Pakistan cricket over the last six or seven years — that is the conversation." He added: "If Babar shows even fifty percent of this standard



in international cricket, we will praise him. The problem is our ICC event performances in 2023, 2024, 2025, 2026 — where did we stand? You cannot mix PSL with that. This is not top bowling. Kamran echoed the point, tracing the problem back to team composition rather than Babar alone. "In the Pakistan team there is no batting lineup like this. Sometimes they send him at four, sometimes at three — it hurts him and it hurts the team." He noted that at Zalmi, Babar always had cover: "If Mendis gets out, Bracewell is there. Samad is there. Faran Yousuf is there. That support is what any good player needs." On the broader tournament picture, Basit said he saw very few teams capable of living with Zalmi in their current form. "In my view, only Multan or Islamabad can give them a fight — and they already beat Multan in a one-sided match." He then raised eyebrows by suggesting Zalmi's form was so dominant they would arguably test Punjab Kings, currently setting the IPL alight, if the two sides were somehow to meet.

The power required to clear boundaries in the T20 cricket has resulted in batters using bat swing instead of footwork to achieve the desired result. Here are six batters in IPL who use the bat swing like golf to hit sixes.

In modern-day T20 cricket and specially a league like IPL, batters are increasingly generating power through bat swing instead of using footwork to clear boundaries. A stable base and a clean extension of the hands are allowing them to access various scoring zones and score four and sixes at will, without needing to step down the pitch often. Here are six IPL batters who have been successful using more bat swing than footwork: India and SRH opener Abhishek Sharma's six-hitting has evolved, with help from Yuvraj Singh

and Brian Lara, with the left-hander altering his grip and hitting shape. Sharma swings freely across the line, with most of his maximums coming towards long-on and down the ground, while also accessing lofted drives over cover without excessive footwork.

Vaibhav Sooryavanshi RR opening batsman Vaibhav Sooryavanshi's power comes more from his bat speed than movement. The left-hander uses a free swing to generate power, while staying balanced at the crease. The 15-year-old has largely hit sixes in the long-on to square leg arc with a clean downswing of the bat rather than expansive footwork. Heinrich Klaasen Klaasen's six-hitting technique is based on a repeatable bat swing and a strong base. He uses hand speed and hip drive to generate power, staying deep in his crease and hitting through the line against spin. Most of his sixes come between long-on and midwicket, where his extension allows him to hit good length balls consistently.

Priyansh Arya The PBKS opener's method is built on a clean bat swing, which allows him to hit through the line without the need for big strides. He generally hits sixes on the on-side, consistently looking to clear square leg and mid-wicket regions of the ground and occasionally uses the pick-up flick, relying more on his extension over footwork. The RR opener's six-hitting is based on early reading of length and bat flow. Jaiswal relies on a high backlift and powerful downswing to stay balanced and hit through the line, with his strong backfoot game allowing him to get back quickly and pull over midwicket. Samson's improved game, especially against spin, is based on a method involving minimal movement and maximum bat speed. The right-hander trusts his base and lets his hands dominate, generating power without over-committing forward. Samson can hit sixes on both sides of the ground, clearing boundaries with timing and a free-flowing swing.

"While I struggled to study by travelling all that distance," Vikram recalls, "Prince would later struggle with the game itself." Vashisht's academy sat walled by jamun trees, a cosy ground where Prince bowled for hours. "Then the Delhi Premier League started in 2024," Ram Niwas says, and something shifts in his voice. "DPL. If not for that tournament, he would still be playing in the village. Khel raha hota. This IPL season, Prince emerged as LSG's seam lieutenant. 11 wickets in six games. Ahead of Mohammad Shami in the franchise's wicket-taker list. "I was wrong," Ram Niwas says simply. "I told him cricket would leave him with nothing. I didn't believe the dream was possible from a village like ours." Last month, Prince was called up for India A for the T20 World Cup warm-ups in February. He had to forfeit due to a knee injury. Ram Niwas knows this. He watches the trophies that line the living room wall now—a collection that didn't exist three years ago. "An India shirt," he says. "That's what I want for him now. I want him in an India shirt." His wife Santosh moves past him toward the kitchen. She doesn't say anything. She doesn't need to—she'd been saying it for years. Ram Niwas sets down his empty cup. The trophies line the wall.

From training in canvas shoes to repeating IPL heroics, Mumbai Indians' pacer Ashwani Kumar restarts once again



Last year, when Punjab pacer Ashwani Kumar had played in his maiden IPL match for Mumbai Indians, the pacer from Jhanjhari village near Mohali had ended up with four wickets including wickets of Kolkata Knight Riders captain Ajinkya Rahane, Rinku Singh, Manish Pandey and Andre Russell in the match against the Kolkata side. On Monday evening, the 24-year-old once again ended up with four wickets in an IPL match with his spell of four for 24 during Mumbai Indians' 99-run win over Gujarat Titans, Monday's match was Kumar's first match of this IPL season for the Mumbai side Kumar removed Titans' batsmen Shubman Gill, Rahul Tewatia, Rashid Khan and Shahrukh Khan in his spell and Kumar spoke about how he was thinking big ahead of his first match this IPL season and how he had the same performance last season too.

"I was thinking of doing big in this match too. My thought was whatever match I will get, I will do better. Last year also, I did the same and this year too I have done the same. It feels good," Kumar said post the match while speaking with commentator Ravi Shastri. Last season, Kumar had hogged limelight with his four wickets in his maiden match for Mumbai Indians against Kolkata Knight Riders at Wankhede Stadium. The pacer would often cycle or take shared autos to practice at the 11 Km far IS Bindra PCA International Stadium in Mohali early in his career. "Rain or hot sun, Ashwani would never hesitate to go to PCA at Mohali or later at the new stadium at Mullanpur. Sometimes, he would cycle to PCA academy or take lifts or would go in shared autos. I remember he would take Rs 30 from me for the fare and when he was picked up for Rs 30 lakh by Mumbai Indians in the mega auction, I knew his worth was every penny. After each wicket today, I would think about those days when he would return at 10 pm after his training and again wake up the next day at 5 am to head back" Kumar's father Harkesh Kumar had told

The pacer, who had played with Abhishek Sharma, Arshdeep Singh and Ramandeep Singh in his earlier days, would play often with canvas shoes in local tournaments before he made his senior debut for Punjab in 2019. His brother Shiv Rana had shared how Ashwani would spend hours playing club cricket and would also be supported by his friends from the village in his dream. "Ashwani would tell me and other youth of the village to reach early in the morning at the school ground no matter what and most of

us would bat against him at the school ground. Sometimes, he would go to other cricket grounds near the village to play for local teams and would again call us in the evening to play. He would bowl pace wearing normal canvas shoes and friends like Chahat Rana, who is now in Italy, and others would support him with cricket balls and spikes. His passion was to play cricket and make us proud and today he has done that for all of us," Kumar's elder brother Shiv Rana had told Kumar, who was picked up for Rs 30 lakh by Mumbai Indians in the IPL mega auction in 2024, did not get the chance to play in Indian's first five matches in this year's IPL. With the Indians losing four matches out of five matches prior to Monday, the Indians' management opted for the pace of Kumar in Monday's match against Shubman Gill led Gujarat Titans at the Narendra Modi Stadium at Ahmedabad. With Jasprit Bumrah removing Sri Sudarshan off the first ball of the innings and Hardik Pandya removing Jos Butler in the second over, Kumar bowled his first over of the match in the fifth over of Titans' innings. The Punjab pacer picked up the wicket of Titans' captain Shubman Gill off the second ball of his first over with a length ball with Naman Dhir taking a catch at deep square leg. Kumar then removed Rahul Tewatia with a length ball pitched outside off with wicket-keeper Quinton de Kock taking an easy catch before he removed Rashid Khan and Shahrukh Khan in the third over of his spell. Kumar later spoke about how he had planned for this wicket in consultation with captain Hardik Pandya. "When we entered the ground, the thought was the length ball is better on this kind of pitch and we were backing that. I was planning with Hardik Bhaiya about bowling. And the plan was to bowl according to the wicket and that the situation demanded. The planning was good. The wicket of Shahrukh Khan was with a short ball and it was the wickets demand," shared Kumar.

Sunrisers Hyderabad look to use home advantage against inconsistent Delhi Capitals

Hyderabad: Sunrisers Hyderabad will look to make home advantage count when they take on inconsistent Delhi Capitals in a mid-table clash of the Indian Premier League here. Both teams sit on six points, though fourth-placed Sunrisers Hyderabad are marginally ahead, having played a game more and boasting a superior net run rate. When Mohanlal and Mammootty made us believe they would take a bullet for each other



A jovial, fun-loving, and mischievous guy interacts with a laconic, commanding, and distinguished man who exudes a big brother persona. While we could easily be talking about an occasion when Mohanlal and Mammootty were together in real life, this can also be seen as a description of any scene in which the two share the screen in legendary director Joshiy's No 20 Madras Mail (1990). A comedy-thriller revolving around the murder of a young woman on a Chennai-bound train from Kerala, No 20 Madras Mail remains one of the most celebrated Malayalam films where the two superstars appeared together. With a slight Agatha Christie touch, veteran screenwriter Dennis Joseph wrote the film, placing equal emphasis on comedy, mystery, and thrills. However, what stood out the most was its brilliant utilisation of Mohanlal and Mammootty's on-screen chemistry, which almost felt like an extension of their real-life selves and camaraderie.

Although the movie isn't extraordinary, it stands as a testament to both actors' individual and combined capabilities, as well as how far a movie can soar if the cast and crew share a solid bond. The high rewatch value of No 20 Madras Mail isn't just due to Mohanlal and Mammootty, but also to Joshiy's master craftsmanship, Dennis' remarkable screenwriting, Jayanan Vincent's impeccable cinematography, Ouseppachan's hit songs, SP Venkatesh's impressive background score, the other cast members' exceptional acting talent, and, above all, the rapport they all share.

With the aim of watching a cricket match live in Madras (now Chennai), Tony Kurishalingal and his two friends — local politician Kumbalam Hari (Jagadish) and detective novelist "Hitchcock" Kanjikkuzhi (Maniyanpilla Raju) — board the No 20 Madras Mail (now known as the Thiruvananthapuram-Chennai Superfast Mail). On board, they come across a young woman, Devi (Suchitra), who is travelling to Madras with her parents, Geetha (Jayabharathi) and RK Nair (MG Soman). Ever since then, a drunk Tony has been disturbing the family, constantly trying to woo Devi and harassing her. On the way, film actor Mammootty (the actor playing a fictionalised version of himself here) boards the train, and Tony starts pestering him from that point on. However, Mammootty finds him adorable and tolerates him and his friends. But they are all left shocked upon reaching Madras when they discover Devi's body in the washroom. As all fingers point to Tony and his friends, they flee the scene. The remainder of No 20 Madras Mail follows their efforts to prove their innocence and find the culprit.

The character of Tony Kurishalingal, a spoiled young brat who lives by the philosophy of "celebrate every moment to the fullest (with liquor)," appears tailor-made for Mohanlal even now. While he comes across as annoying, prying, and irreverent to others, those who love him find Tony's antics cute. Only an actor capable of making even Tony's most irksome behaviours seem endearing could pull it off. And, even today, there's no one quite like Mohanlal who can achieve that effortlessly. Hailing from an affluent family, Tony mostly spends his time with Hari and Kanjikkuzhi, living a carefree life. The main reason he has nested between them is that he belongs to a dysfunctional family in which his stepmother loathes him. Once the movie reveals this, we feel extra sympathy and affection for Tony, realising that all his shenanigans are to conceal his scarred self. Since Mohanlal can ace layered performances and ensure that the emotions his characters experience hit the audience square in the chest with minimalist acting, Tony is a cakewalk for him. From Tony's naughtiness and playfulness to his emotional, tense, and recalibrating moments, the actor nails it in No 20 Madras Mail.

What adds to the brilliance of the performance is his mind-blowing ability to act drunk on screen. Without sticking to a single metre throughout the first half, mapping his journey from Kottayam to Madras, Mohanlal pays proper attention to Tony's buzz level at different junctures and switches accordingly. When he leaves the bar for the railway station at the start, Tony is heavily blitzed. But by the time he arrives at the railway station, he has slightly sobered up. As soon as Tony and his friends enter the train, they start drinking again, and Mohanlal increases the drunkenness and decibel level in his performance accordingly.

On the other hand, Mammootty maintains restraint throughout the movie. Although he enjoys Tony's high spirals and smiles with joy at all his naughtiness, he doesn't let go of his big brother persona and even looks out for the

gang after a certain point. From his body language and responses, it's clear that he, too, once celebrated life the same way but has since matured and would rather lie back and see kids having fun now. Mammootty knows Tony is jealous of no longer being everyone's centre of attention. He knows Tony's ego is slightly hurt when all others start talking only about him after he enters the train. Hence, he gives Tony the attention he yearns for, and here a brotherly bond between Mohanlal and Mammootty becomes all the more evident through their interactions. When Tony asks to touch Mammootty and then kisses his cheek, Mammootty smiles warmly, almost as if Tony were his younger brother he once raised.

Writer Dennis Joseph and director Joshiy utilised not just aspects of Mohanlal and Mammootty's public personas in No 20 Madras Mail but also amplified certain facets of their actual selves. When RK Nair finally loses his cool and lashes out at Tony, it's Mammootty who steps in to diffuse the situation, reminding the former, "Weren't we too once their age?" After Tony and his friends become embroiled in the Devi murder case, Mammootty goes above and beyond to help them prove their innocence, even though he knows his involvement could affect his public image. Towards the end, Mammootty even embraces his Vallyettan persona for Tony and his friends and negotiates with the actual murderer, without even considering his own safety. In the climax, he also lets go of his calm, composed demeanour, embraces his braveheart self, and even gets into a physical altercation with the villain and his gang for his little brother. Thus, writer Dennis and director Joshiy utilised not just aspects of Mohanlal and Mammootty's public personas but also amplified certain facets of their actual selves, thereby authentically fictionalising the real. The 'cute' Mohanlal and 'caring' Mammootty gelled so well on screen that it almost made one feel they would even take a bullet for each other in real life. Although No 20 Madras Mail became a massive success, Dennis Joseph completed its script under immense pressure. Firstly, he was fixed as the writer just one day before Joshiy and the team had to commence filming, as the project the director had planned for this period had to be postponed for various reasons. Furthermore, Dennis had to write the scenes set in Chennai first, which begin only towards the middle of the movie, and complete writing the second half before moving to the former. Interestingly, Dennis and Joshiy's initial idea was to cast a smaller star like Jagathy Sreekumar as the celebrity who helped Tony and his friends, since it was just a cameo role and the narrative was clearly headlined by Mohanlal's character. But as the scripting progressed, Mohanlal suggested to Dennis that they consider Mammootty for the role. Although impressed by the idea, Dennis felt it would be too much to ask Mammootty, an equally strong superstar in Malayalam cinema as Mohanlal, to play an extended cameo in the latter's movie. While Joshiy also liked the idea of casting Mammootty, he too felt it would be a big ask, Dennis revealed during an appearance on Safari TV's "Charithram Enniloode" programme. Nonetheless, Dennis gathered courage and approached Mammootty, who agreed immediately, much to everyone's surprise. Not only that, but the megastar also provided them with immediate dates so that the movie's production, already underway, wouldn't be affected.

However, this doubled Dennis' struggles as a writer, as he had to ensure proper weightage for Mammootty's role as well. What helped him in the process was his experience travelling on the Madras Mail umpteen times over the years. During that era, most film professionals used the Madras Mail for their frequent commutes to Chennai, which was the unofficial capital of South Indian cinema. Hence, Dennis had many anecdotes he could include in the script, and even a tipsy Tony's constant, hilarious query to Mammootty — "Am I being a disturbance to you?" — had actually happened to the writer once during a journey on the same train. Dennis got the idea for the story from his friend Harikumar, who is credited in the movie's opening. No 20 Madras Mail marked his reunion with Joshiy after several notable collaborations, including Nirakkoottu, Aayiram Kannukal, Shyama, Nyayavidhi, New Delhi, Thanthram, Sangham, and Nair Saab, among others.

However, during its production, they had a professional fallout after the director allegedly had other writers make changes to the second half of Dennis' script for No 20 Madras Mail without informing him. This pained Dennis greatly. Although they maintained a strong personal bond until Dennis' demise in 2021 and collaborated again on the Suresh Gopi-starrer Bhoopathi (1997), the professional rapport they once had disappeared forever.

Nevertheless, No. 20 Madras Mail remains one of their most iconic collaborations, as it does for Mohanlal and Mammootty. Now that the two superstars are gearing up to share the screen in Mahesh Narayanan's Patriot — marking their on-screen reunion in lead roles after 17 years since Twenty:20 (2008) — will we see the magic that transpired in No 20 Madras Mail once again? We will have to wait until May 1, 2026,

Fahadh Faasil was paid Rs 4 lakh, 1.6% of film's budget, for 22 Female Kottayam that changed his career



Fahadh Faasil's cinematic journey pretty much sums up what Shah Rukh Khan told us in Om Shanti Om (2007): "Agar kisi cheez ko dil se chaho, toh puri kinaat usse tumse milane ki koshish mein lag jaati hai (If you want something with all your heart, the whole universe conspires to bring it to you)." Despite a flop debut, he currently ranks among the most talented actors of his generation in the country, much to everyone's surprise. However, that didn't happen overnight; it has been a work in progress ever since the start of his second innings in 2009, seven years after his debut.

No matter which film family they hail from or which superstar's child they are, if one doesn't possess the necessary acting skills and manage to impress the audience with them, they don't stand a chance in Malayalam cinema. Interestingly, this isn't a new phenomenon; it's been the case for the longest time, which is why some of the biggest star kids never made it big in the industry and were phased out soon after their debuts. The most intriguing aspect is that even the industry doesn't try to force these star kids on the audience after a point, because it knows about Malayalees' decisiveness. The nepo kids who survived have, over time, proven their skills and still try their best to outdo themselves and push their boundaries. Among all of them, Fahadh Faasil stands apart as an exceptional case who, despite being initially written off by the audience as hopeless, made a majestic comeback after years.

Although helmed by his father, ace filmmaker Fazil, Fahadh's debut film, Kaiyethum Doorath (2002), bombed at the box office. For Fazil, renowned for gifting the industry

with massive blockbusters such as Manjil Virinja Pookkal, Ente Mamattikkuttiyamakku, Nokketha Dhoorathu Kannum Nattu, Poovinu Puthiya Poonthennal, Pappayude Swantham Appoos, and Aniyathipravu, this dealt a major blow. The audience was also shocked to see such a poor-quality film from the man who introduced Mohanlal to Malayalam cinema through his Manjil Virinja Pookkal and also made the iconic Manichitrathazhu, widely regarded as one of the finest Indian movies of all time. While the movie itself was poor, Fahadh's performance received significant backlash for being far worse. He subsequently moved to the US to pursue his studies. However, his life and experiences there brought about a change in Fahadh, and he eventually reconciled with cinema, making a comeback through a segment in the anthology film Kerala Cafe (2009).

His subsequent movies, such as Cocktail and Chaappa Kurishu, helped him grab the audience's attention and slowly change their opinion about him. But it was director Aashiq Abu's thriller 22 Female Kottayam (2012) that catapulted him to great heights. Unlike the clueless, seemingly uninterested youngster he was while doing Kaiyethum Doorath, Fahadh displayed extraordinary skills here, delivering a layered, chilling, and strong performance as the antagonist, Cyril C Mathew, who hoodwinks the young nurse Tessa Abraham (Rima Kallingal) into falling in love with him, only to exploit her sexually for his personal gains. Fahadh's performance in 22 Female Kottayam received widespread acclaim and became one of the stepping stones to the lofty heights he stands on now. However, did you know that the actor made only a nominal amount for the movie? Interestingly, his remuneration in the film was just about 1.6 per cent of its total budget.

Recently, 22 Female Kottayam's producer, OG Sunil, revealed how much he paid the actor back then. "Fahadh must be earning crores today. Back then, I paid him Rs 4 lakh. Now, I think he might be charging Rs 40 crore. I don't know exactly how many crores he earns," Sunil said while sharing memories related to the movie on his YouTube channel. Although he played an anti-hero in it, 22 Female Kottayam was the first film in which Fahadh acted as the solo male lead following his comeback. According to an old IANS report, the Aashiq Abu directorial was mounted on a budget of Rs 2.5 crore and ended up collecting Rs 5.2 crore, which means that Fahadh earned just 1.6 per cent of the movie's total cost. Although his remuneration was low, considering that he had almost no market value back then, 22 Female Kottayam marked a turning point in his career and washed away the bad reputation from his abysmal debut performance.

Aneet Padda pens moving note as grandfather passes away after Alzheimer's battle: 'You held on to love'



Dealing a major heartbreak to Aneet Padda, her grandfather, whom the actor refers to as "the only love of my life," passed away recently. He had been battling Alzheimer's disease for quite some time. Following his demise, the Saiyaara star took to social media to share a monochrome picture of them holding hands, accompanied by a heartfelt message that highlighted just how much he meant to her.

"You were drifting away, but you didn't forget makhan (his nickname for her). You held on to love, even when you couldn't hold on to memory," Aneet wrote, adding that she, however, will hold on to both: the love and the memories they shared. The actor continued, "I will carry all our years together. I will be a good person. I will carry your jokes and repeat them every chance I get. I will carry your kindness

In an interview last year, Aneet had opened up about her grandfather's battle with Alzheimer's, painfully revealing that he had even forgotten her name. However, when he watched scenes from her musical romantic drama Saiyaara, he recognised her, much to her delight. For the unversed, Aneet's character in Saiyaara, Vaani Batra, also deals with the same condition, connecting the movie even closer to her heart.

"My Dadu has Alzheimer's, which is why the film was even more emotional for me. He's at a point now where he doesn't remember most things, but I believed in this story because it says, 'Dimaag bhool jaata hai par dil kabhi nahi bhoolta (the mind forgets, but the heart never does)'. That's very true for my dadu," she shared during a conversation with The Hollywood Reporter India. Aneet added, "He doesn't remember my name; he doesn't remember much. But he still calls me 'Heeraput' or 'Makkhan.' The last few times I visited, he was okay with me sitting next to him — familiar but unaware of who I am. When my film was released, he couldn't go to the theatre since he's bedridden. So my parents showed him videos, and he smiled, saying, 'Heeraput' and 'Makkhan di movie.' That was very special."

Helmed by Mohit Suri, Saiyaara featured Ahaan Panday as the male lead, and the movie emerged as the third highest-grossing Hindi film of 2025, earning a whopping Rs 570.33 crore worldwide against a budget of Rs 60 crore, according to industry tracker Sacniik.
